(57) **CLAIM**

The ornamental design for a swaddle blanket as shown, and described.

DESCRIPTION

FIG. 1 is a perspective view of the swaddle blanket with the flap in an open position.

FIG. 2 is a perspective view of the swaddle blanket with the flap in a draping position.

FIG. 3 is a top view of the swaddle blanket.

FIG. 4 is a side view from the head end of the swaddle blanket.

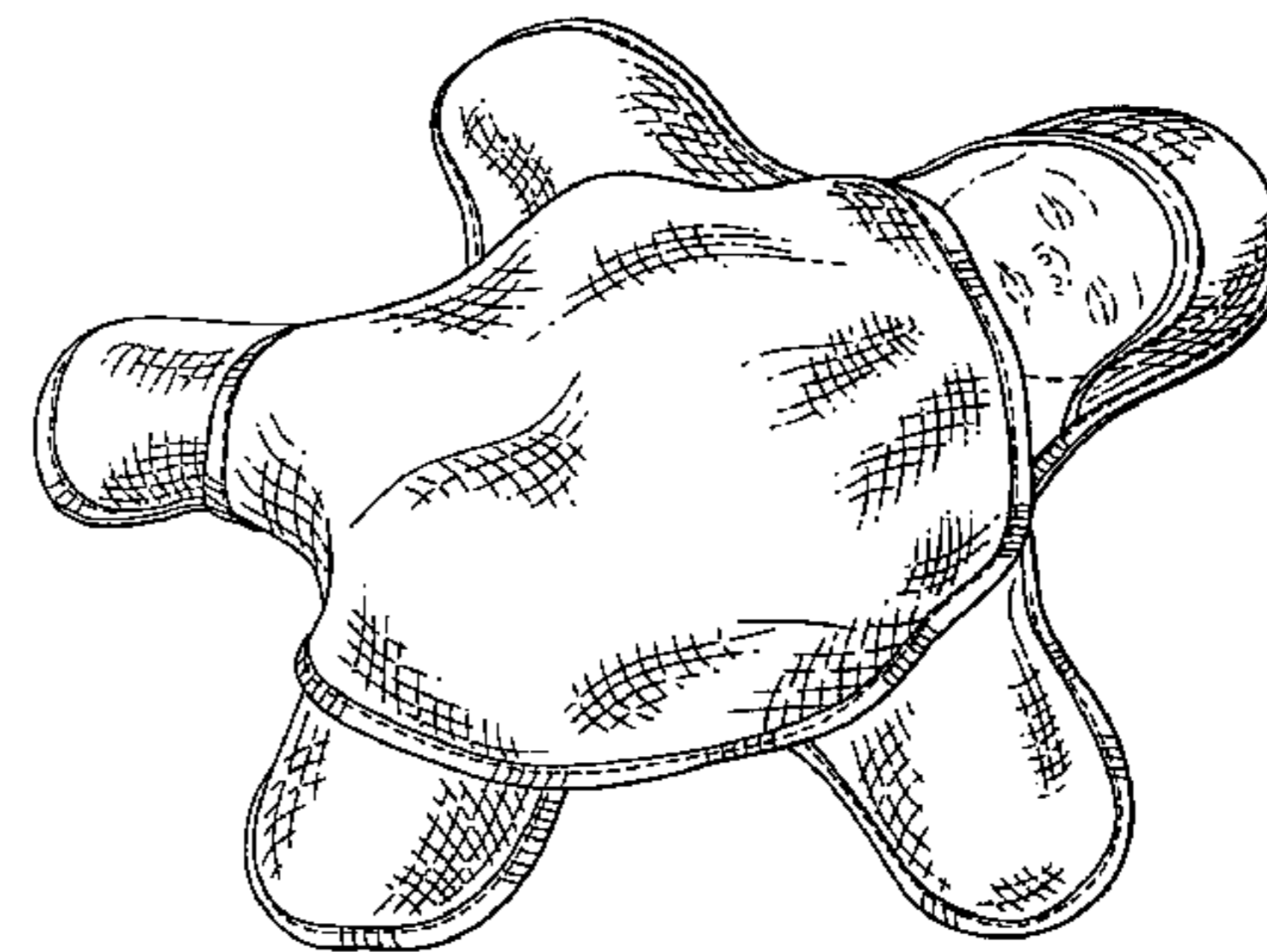
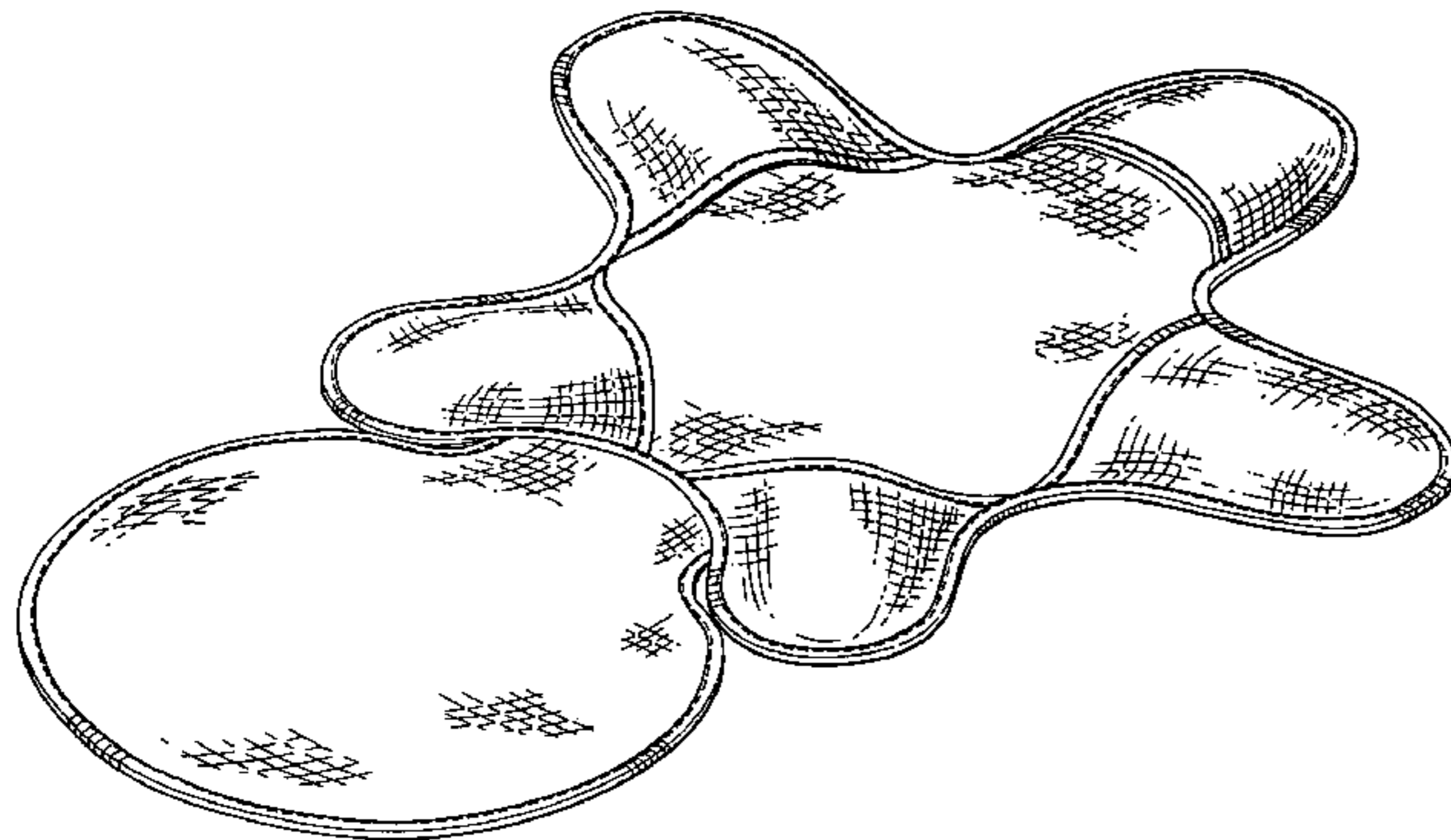
FIG. 5 is a side view from the feet end of the swaddle blanket.

FIG. 6 is a side view of the swaddle blanket; and,

FIG. 7 is a bottom view of the swaddle blanket.

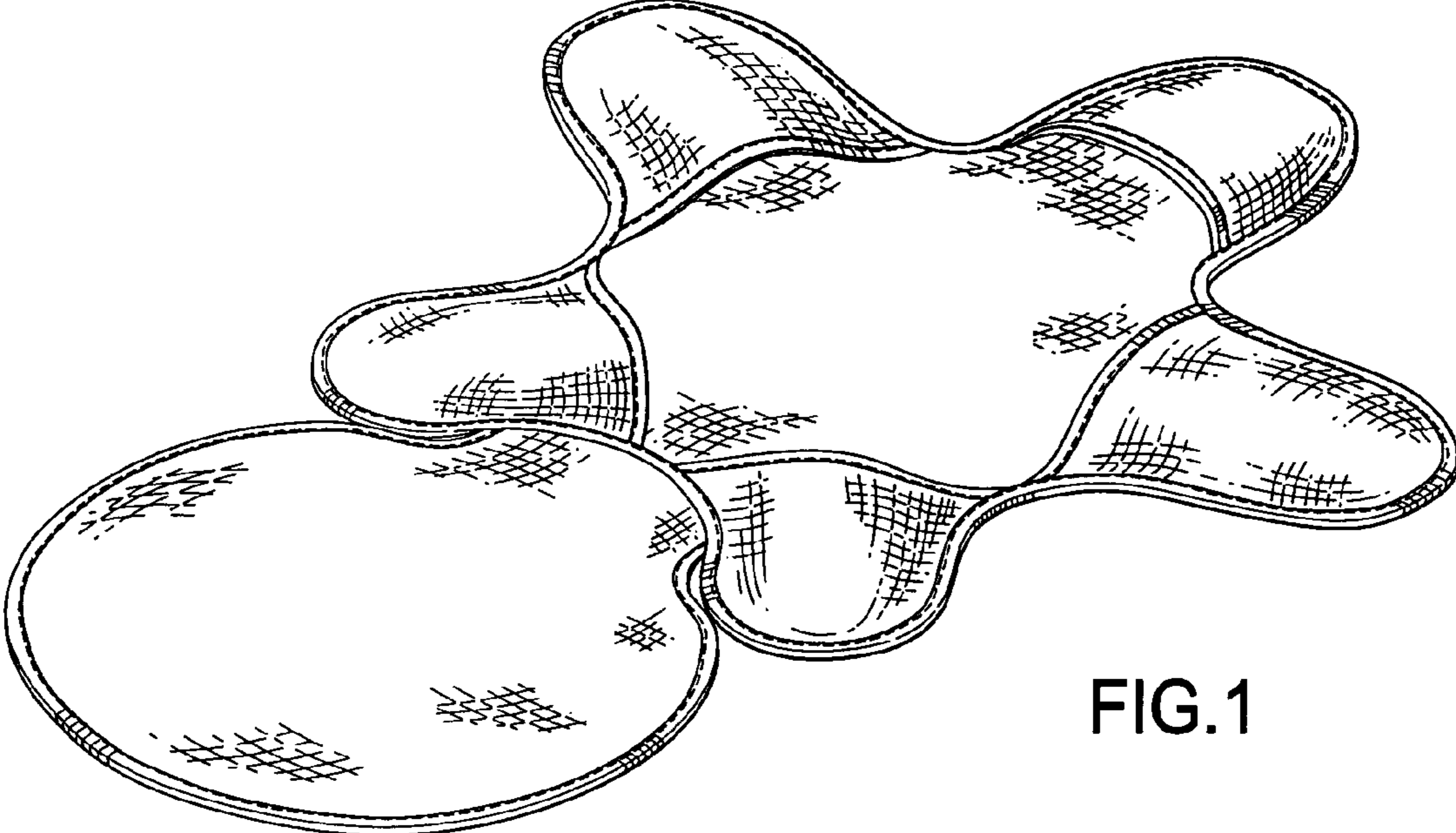

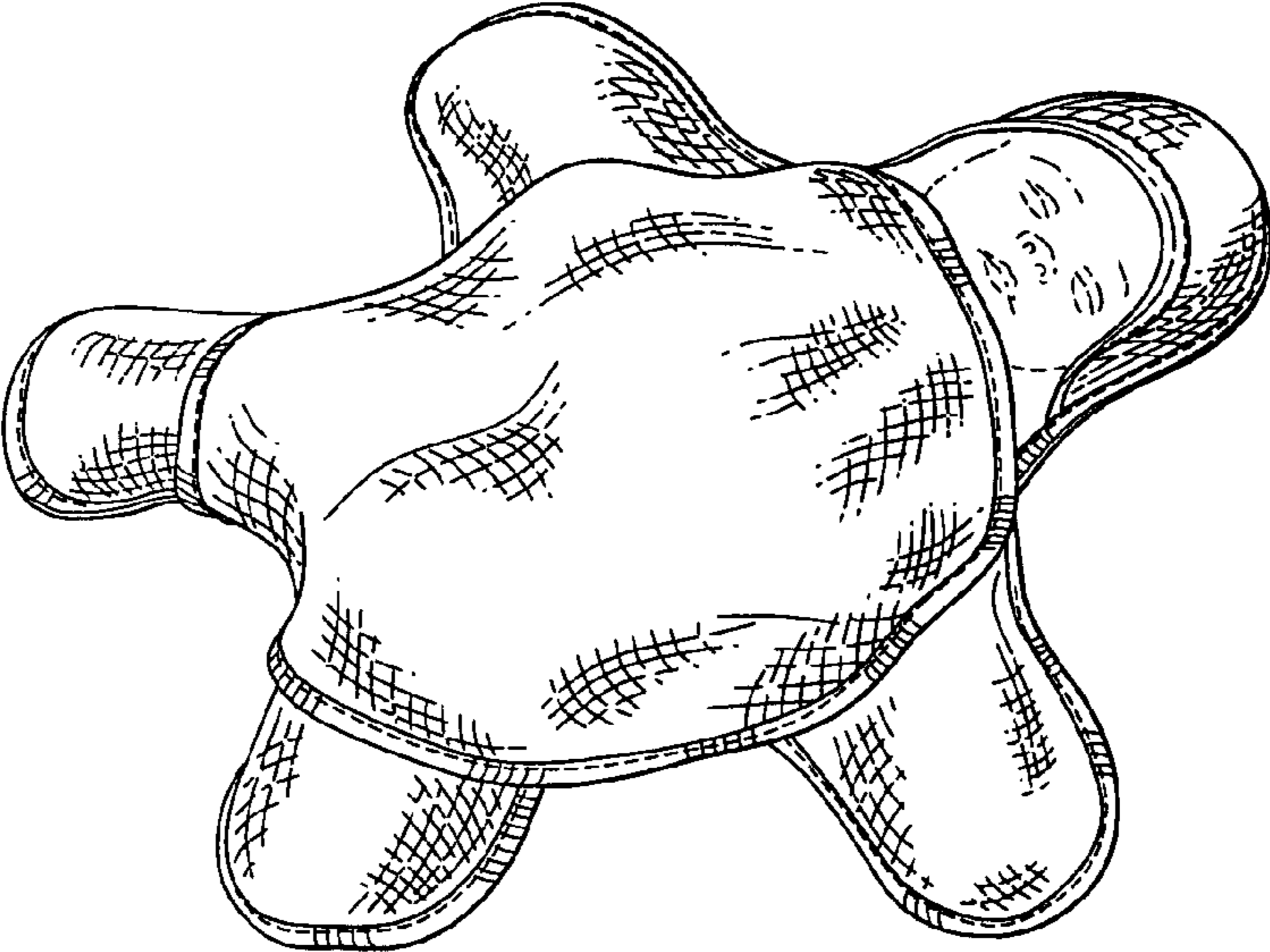

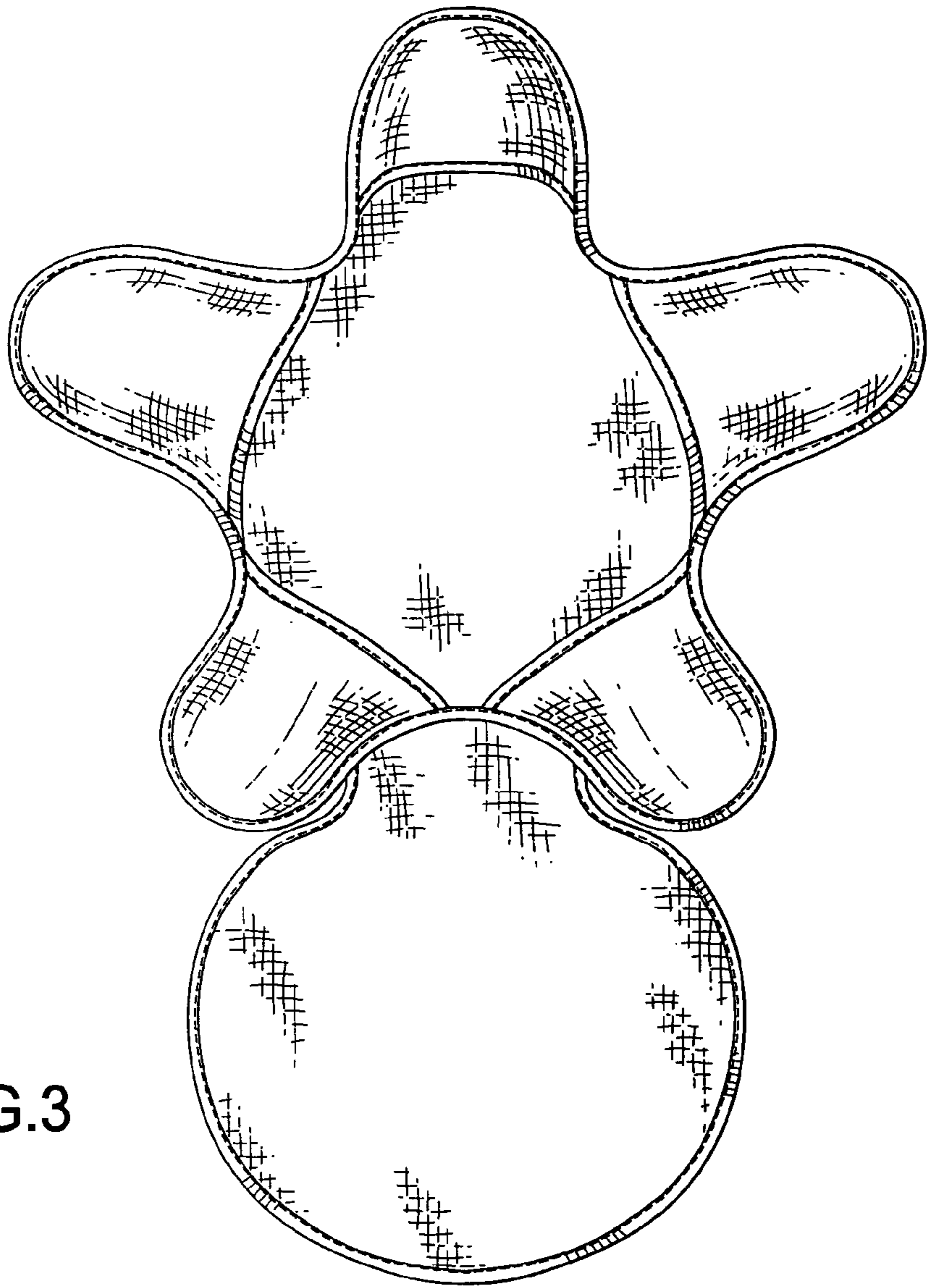

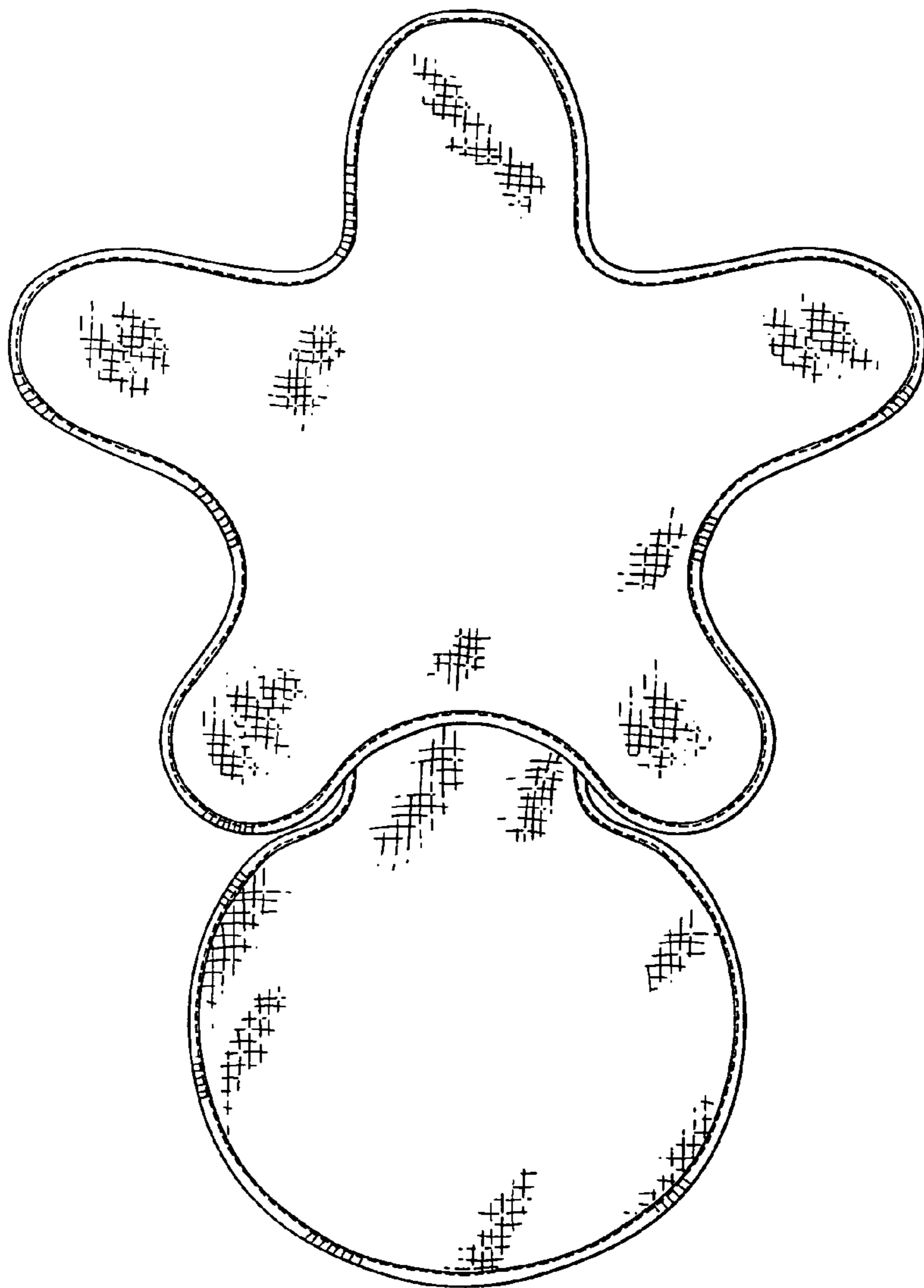
