FIG. 2 is a rear perspective view of the heel shown in FIG. 1;

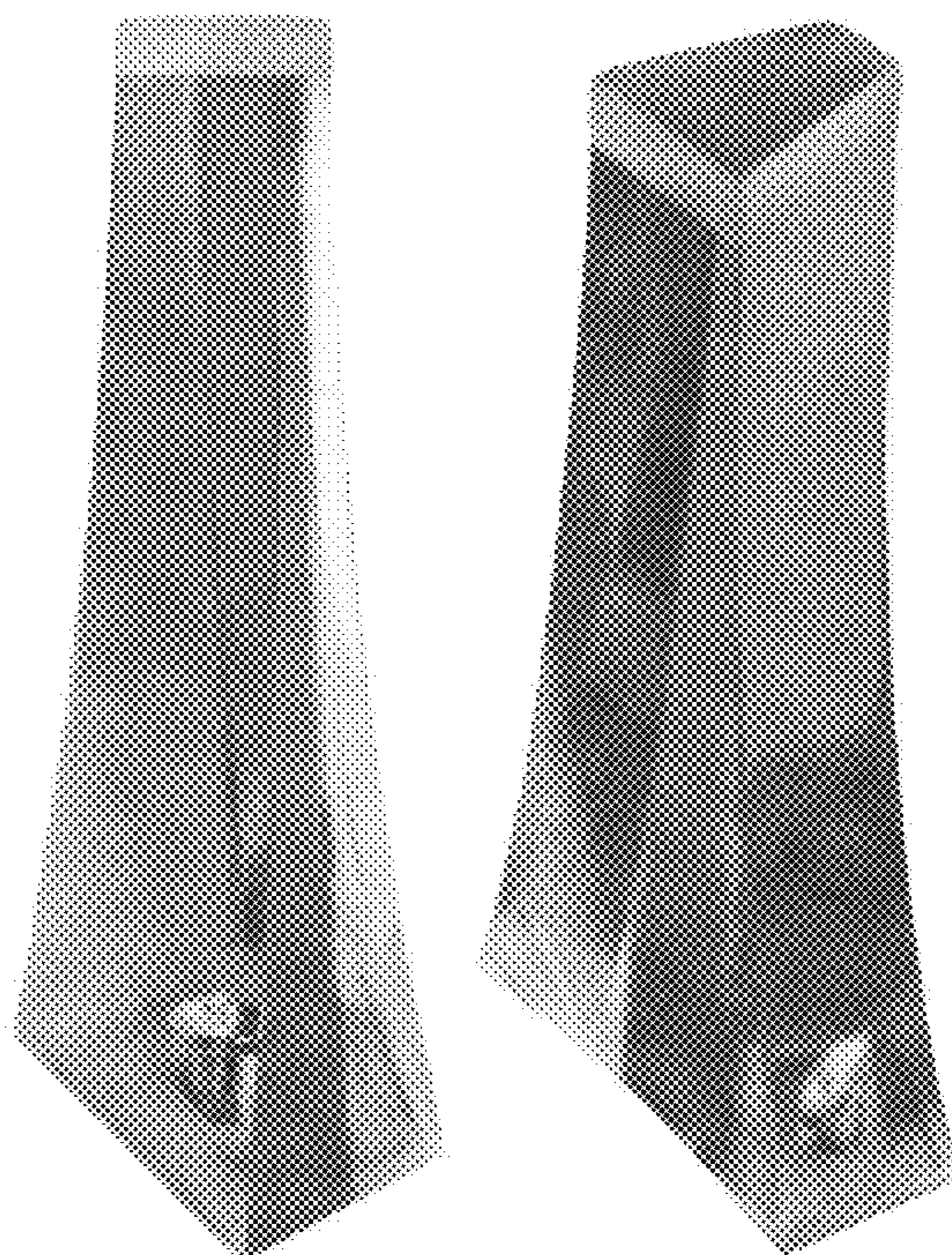
FIG. 3 is a side view of the heel shown in FIG. 1 (with the other side view being a mirror image thereof);

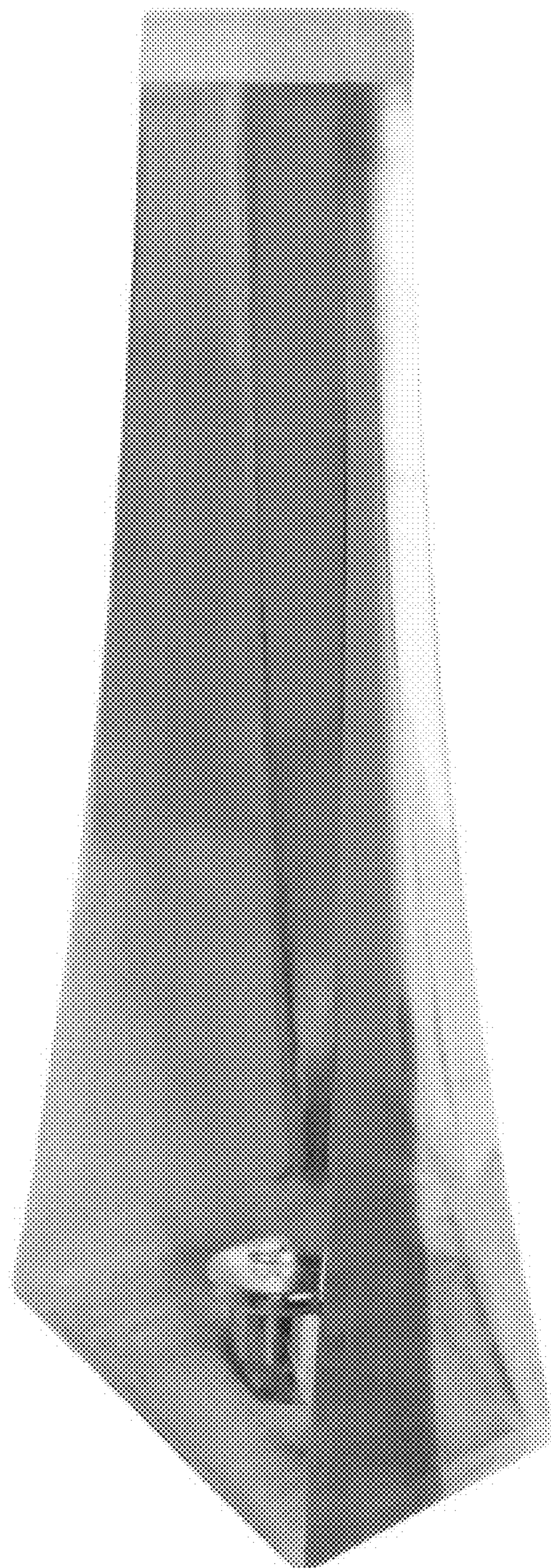

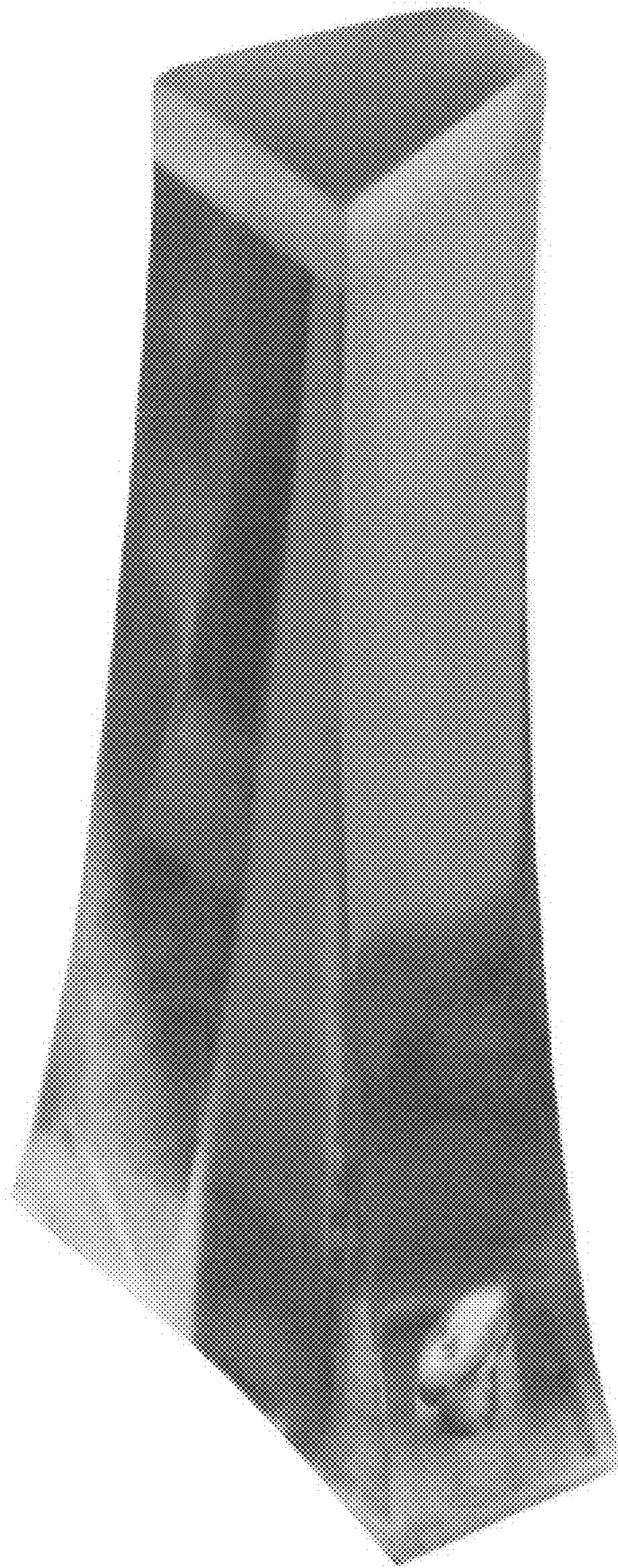

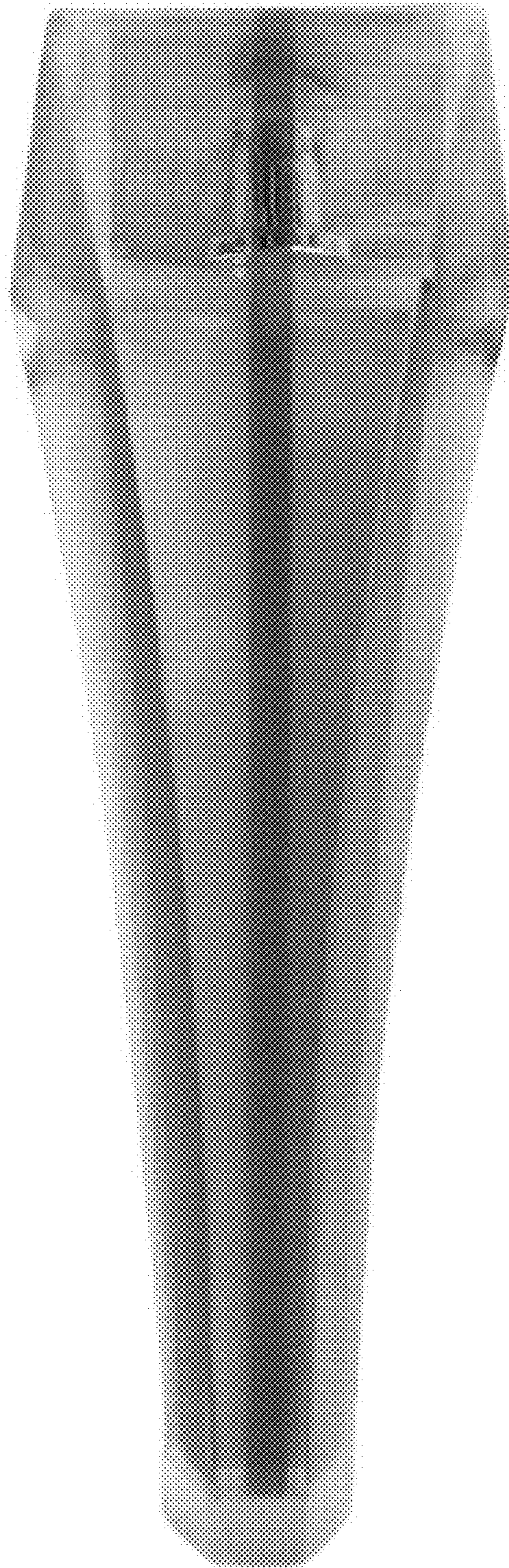

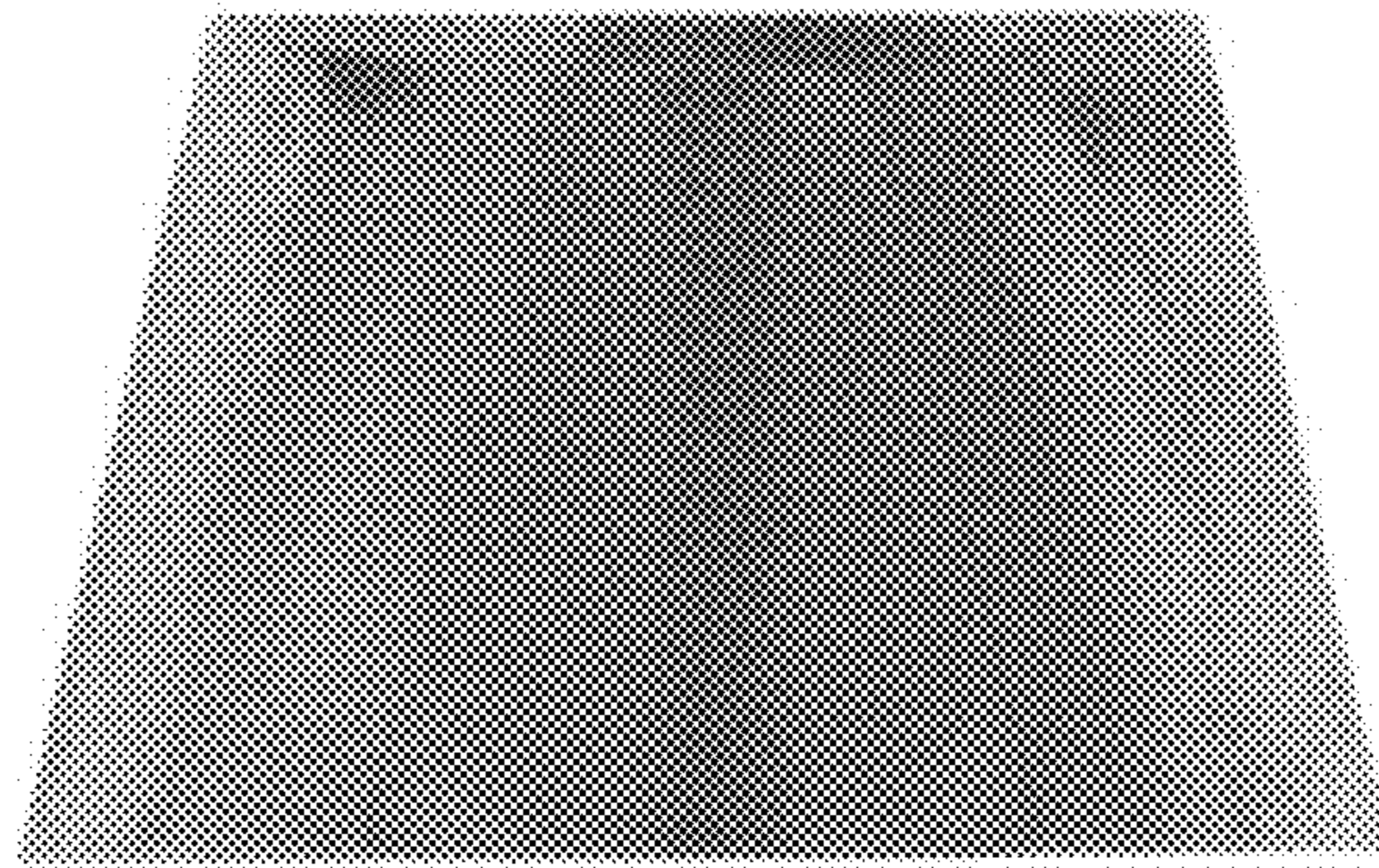
