(57) **CLAIM**

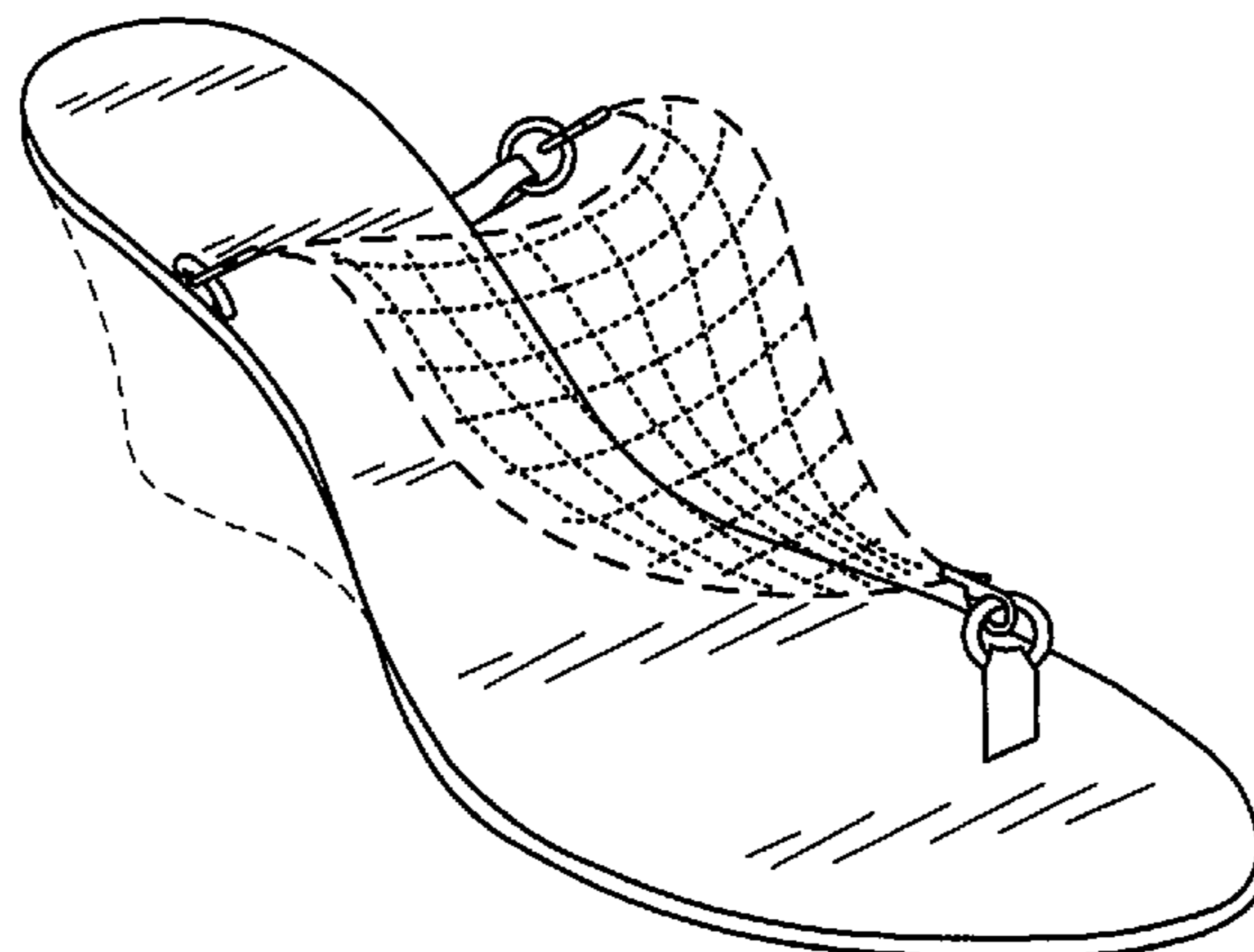
The ornamental design for a portion of a sandal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a sandal, showing my new design;
FIG. 2 is a right side elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view of another embodiment of a portion of a sandal, shown in FIG. 1;
FIG. 9 is a right side elevation view thereof;
FIG. 10 is a left side elevation view thereof;
FIG. 11 is a front view thereof;
FIG. 12 is a rear view thereof;
FIG. 13 is a top plan view thereof;
FIG. 14 is a bottom plan view thereof; and,
FIG. 15 is a close up view of the fastener shown in FIGS. 1-14.

The broken line showing of the heel, interchangeable top, and thong top is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

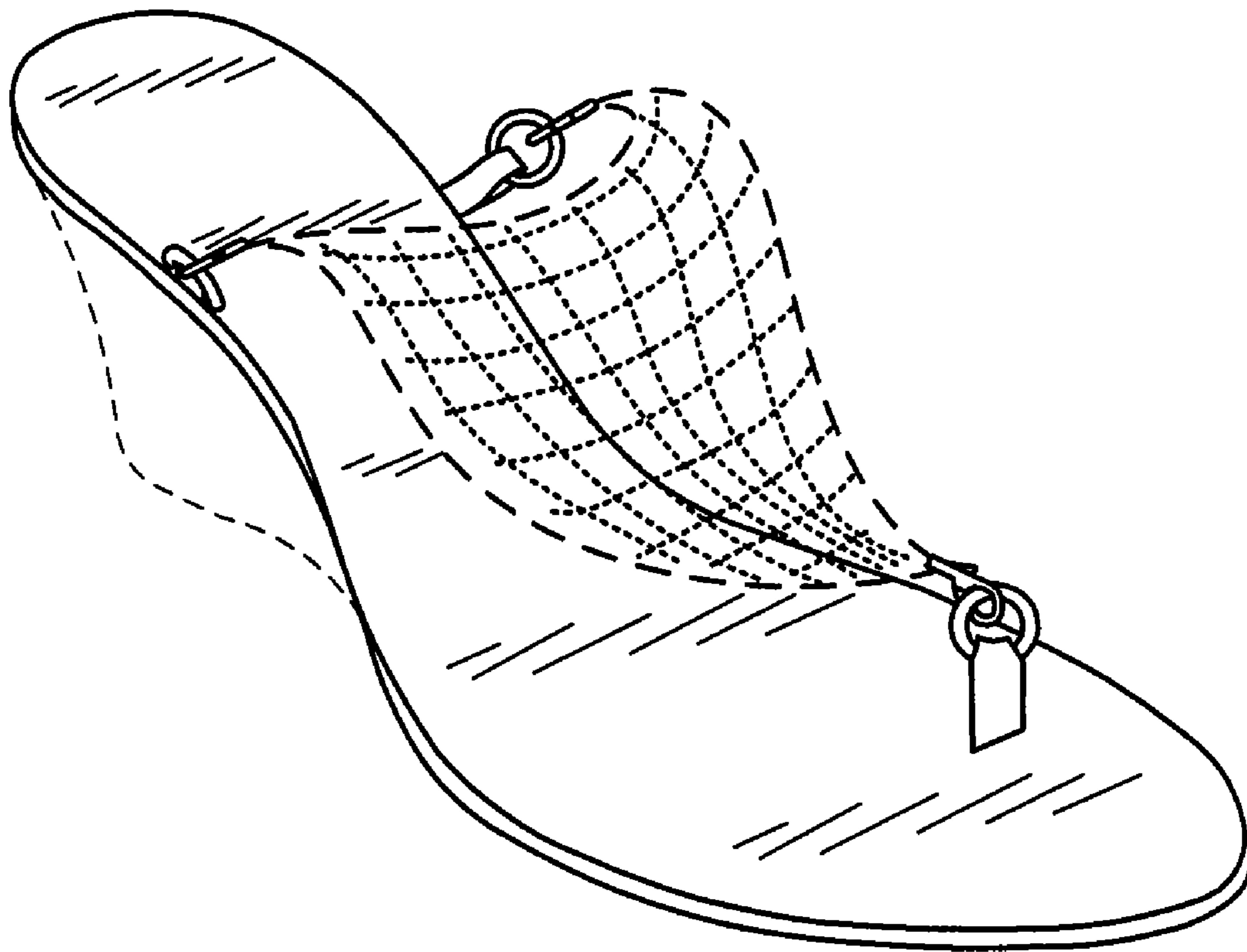

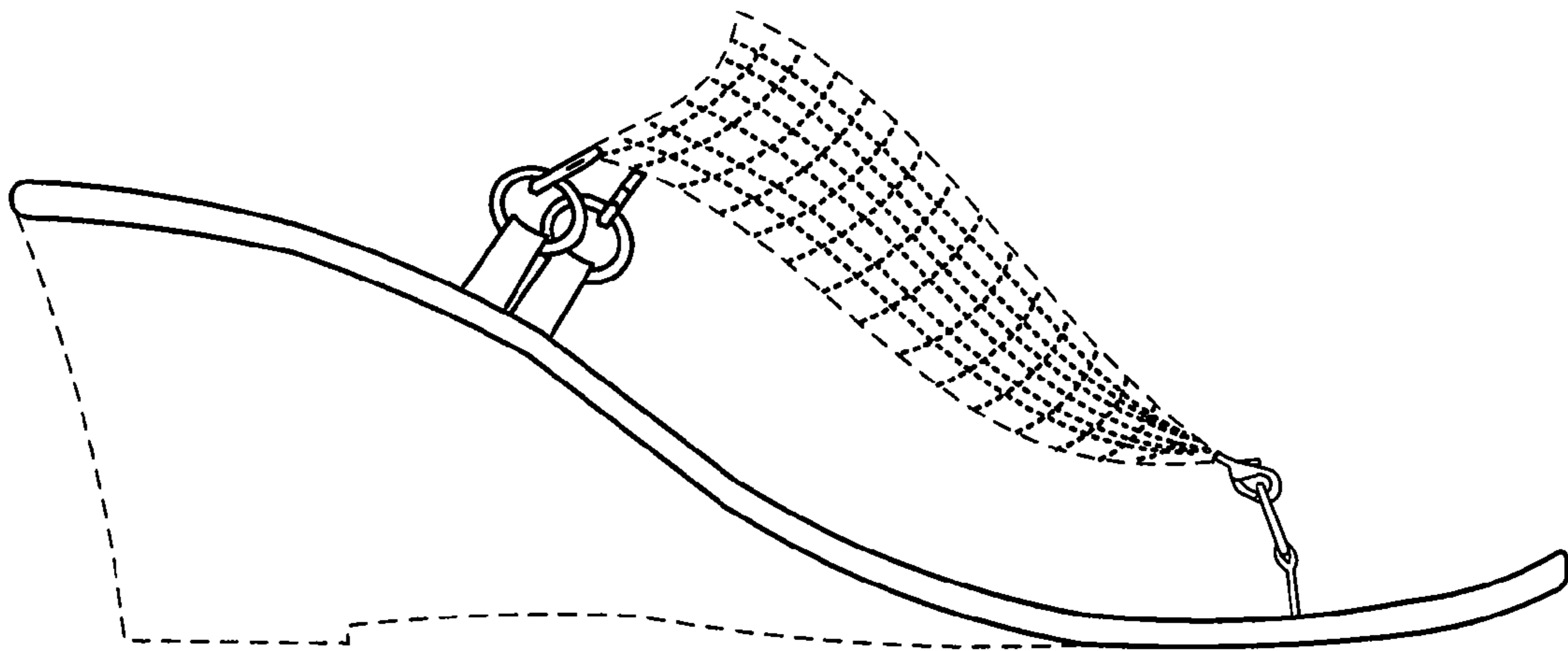

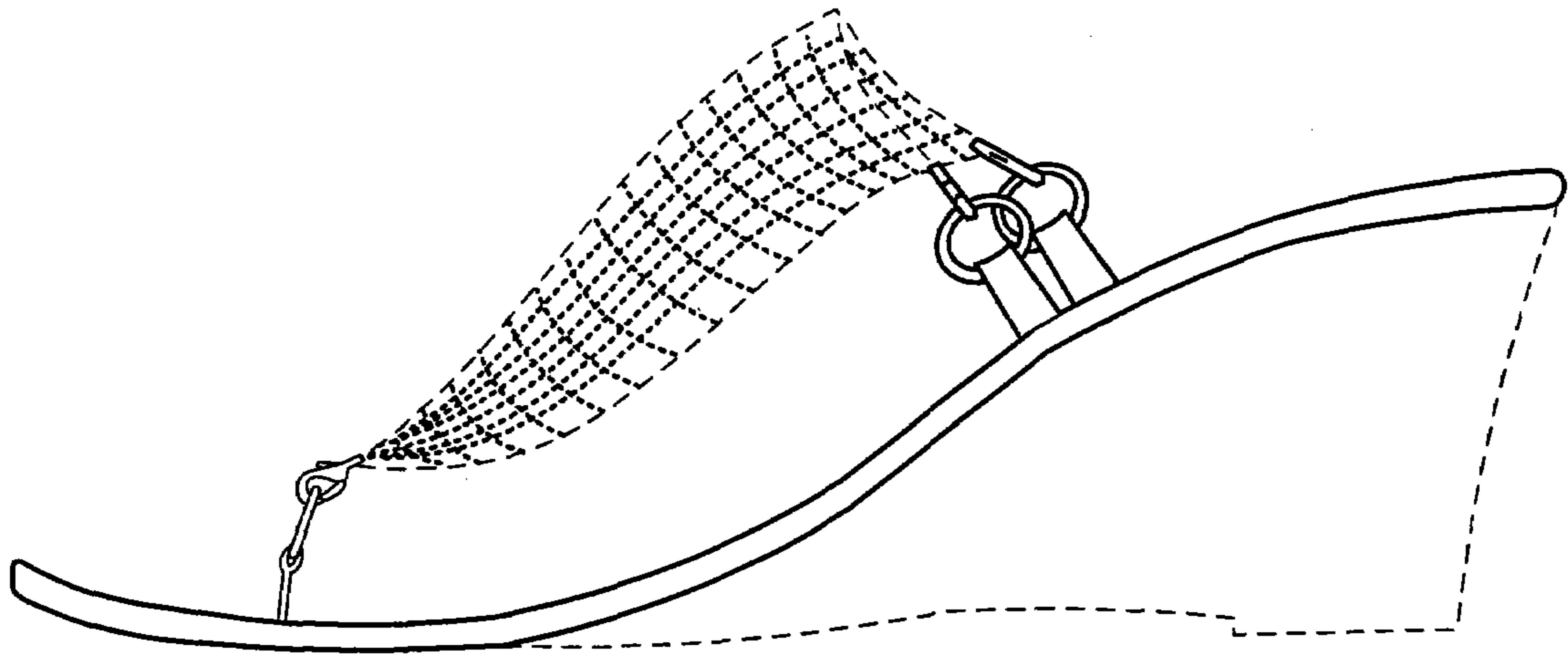

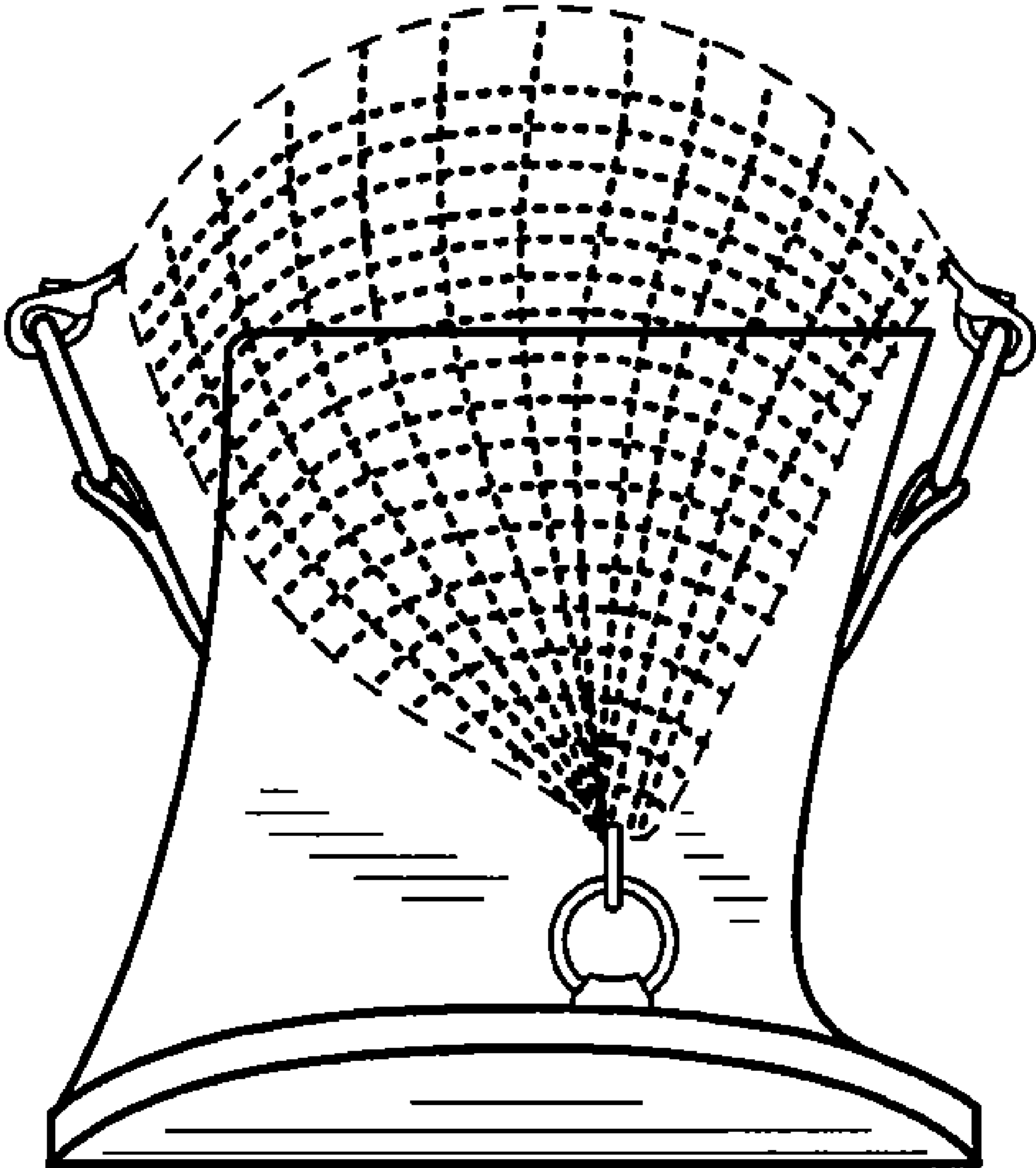

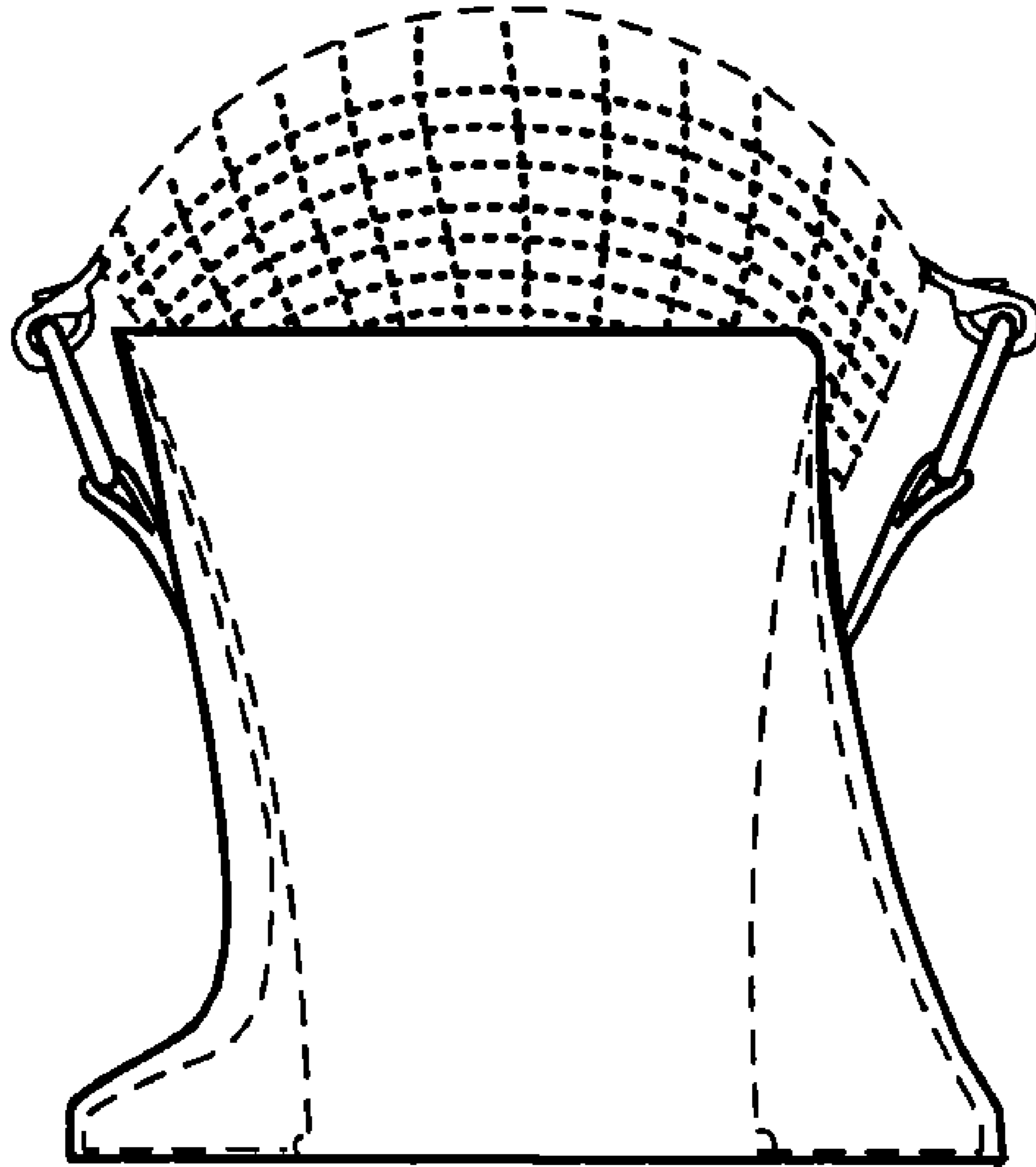

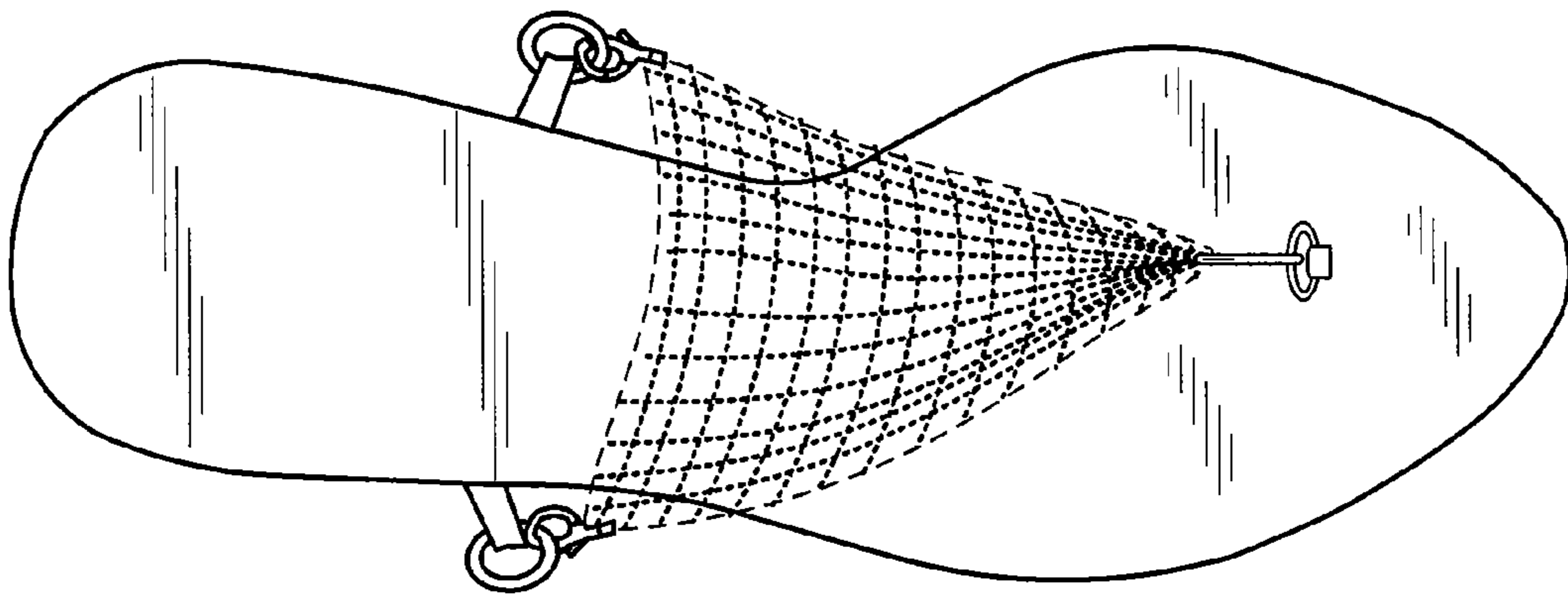

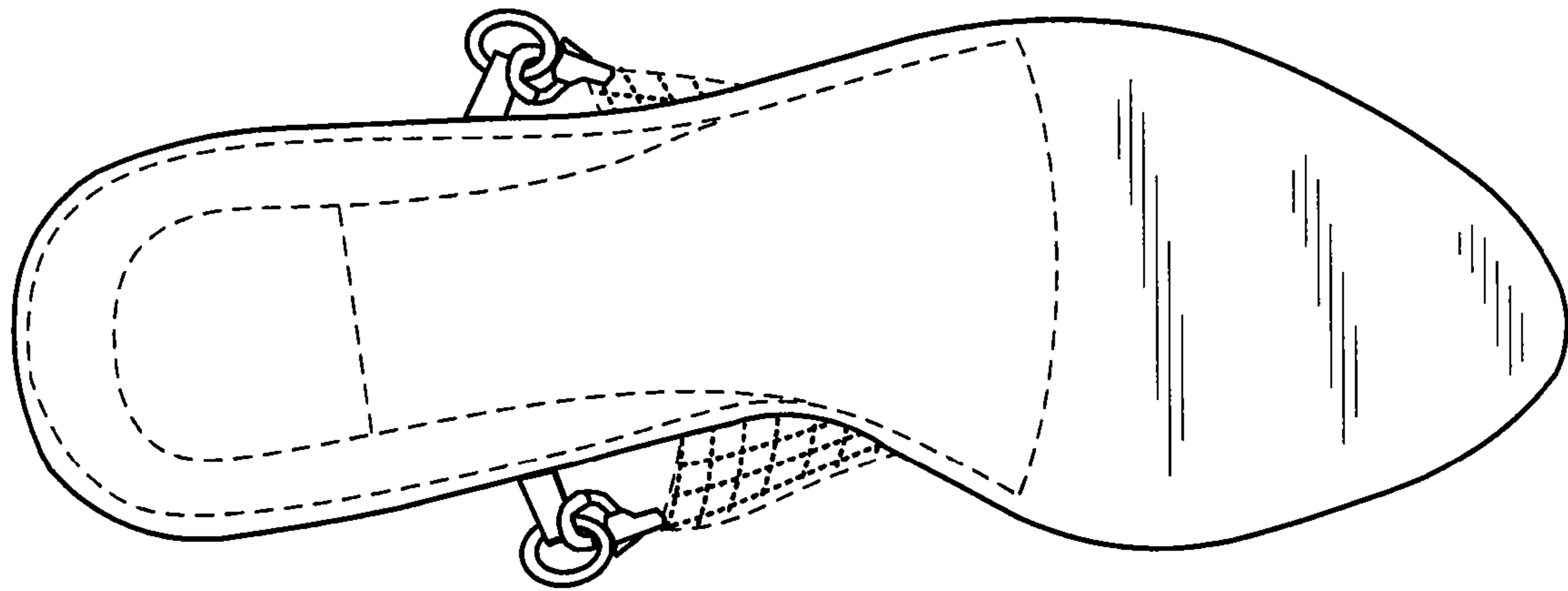

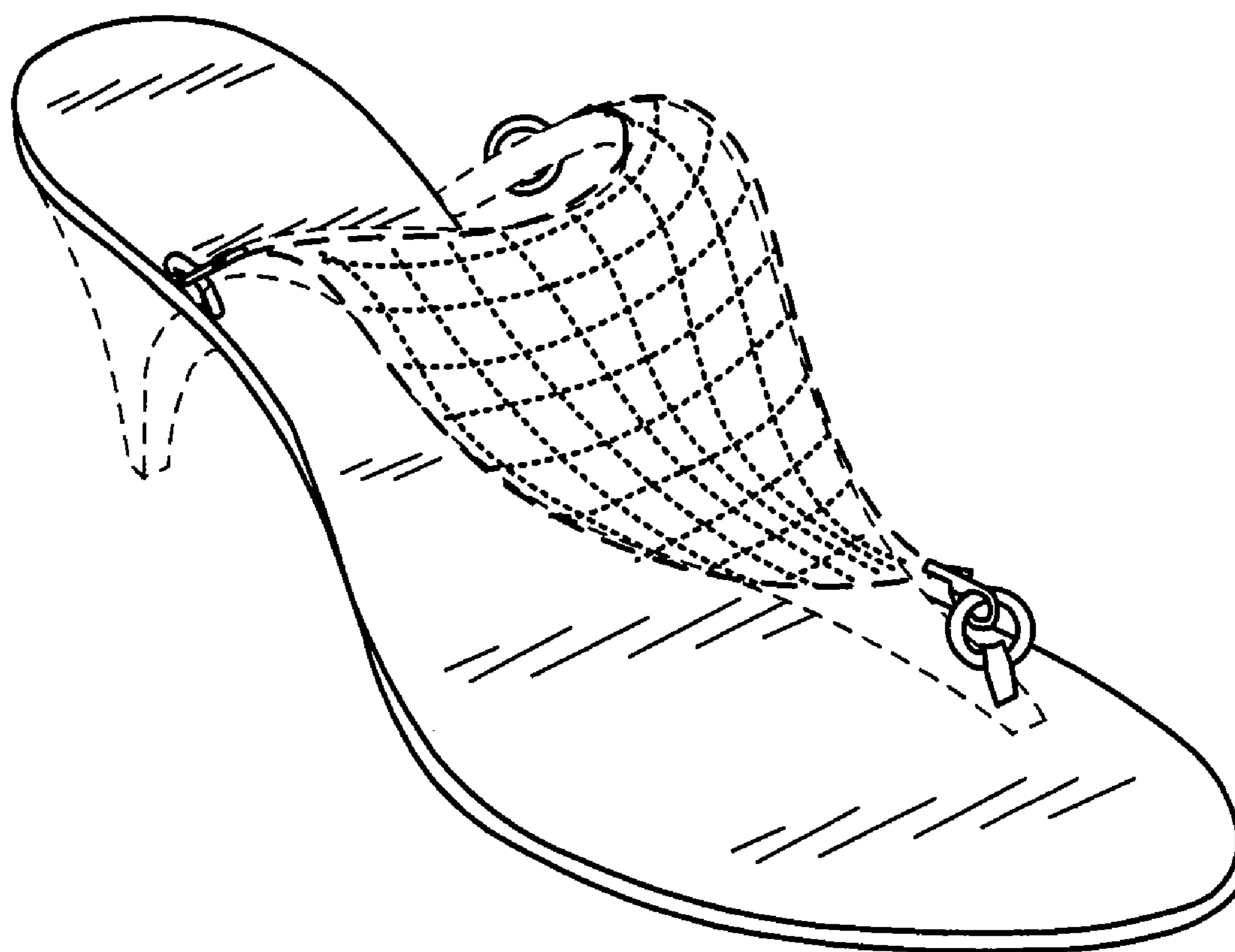

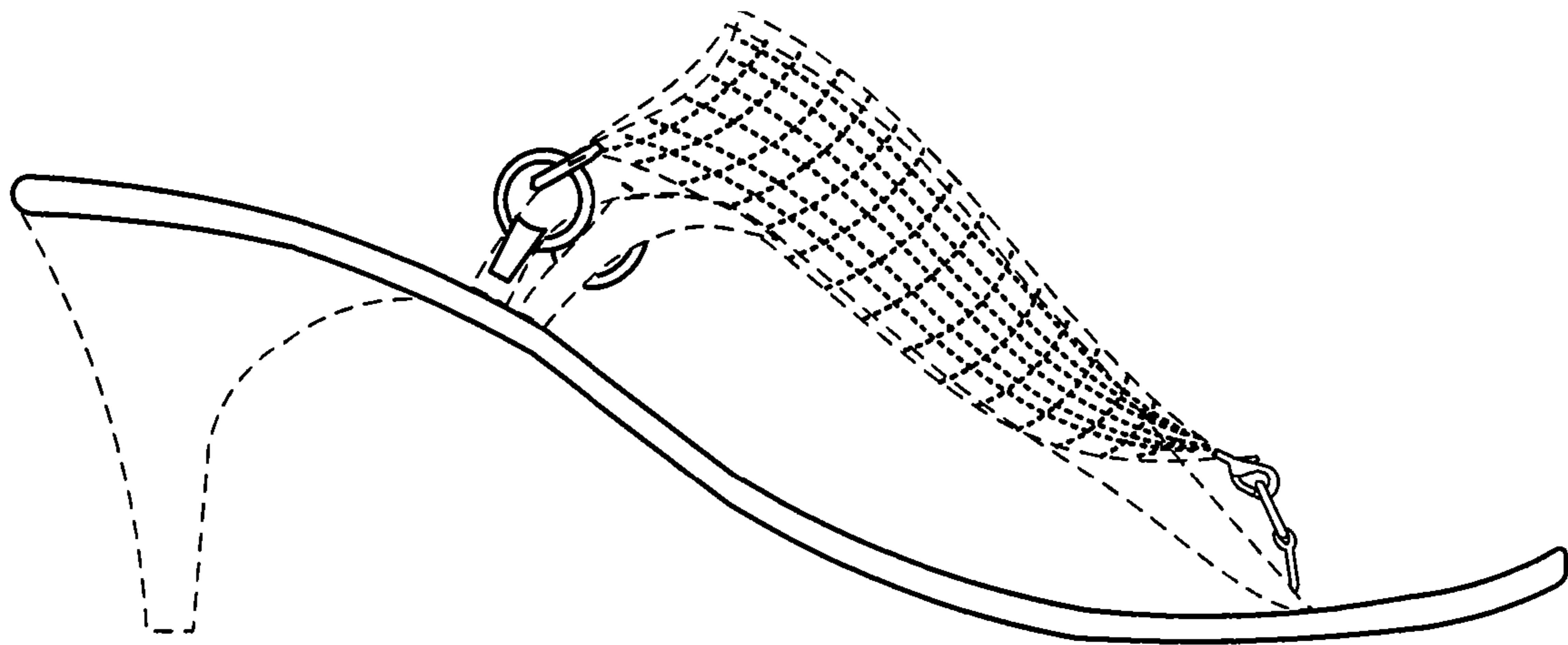

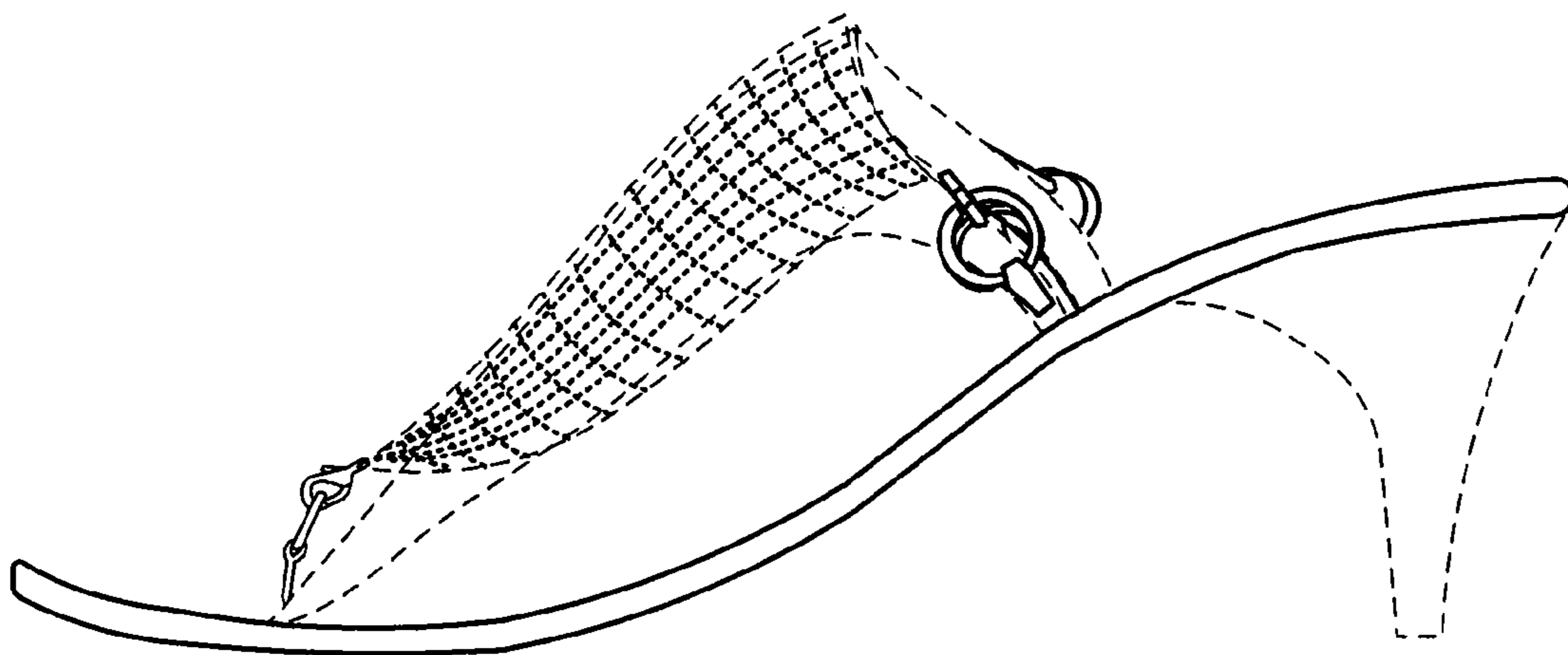

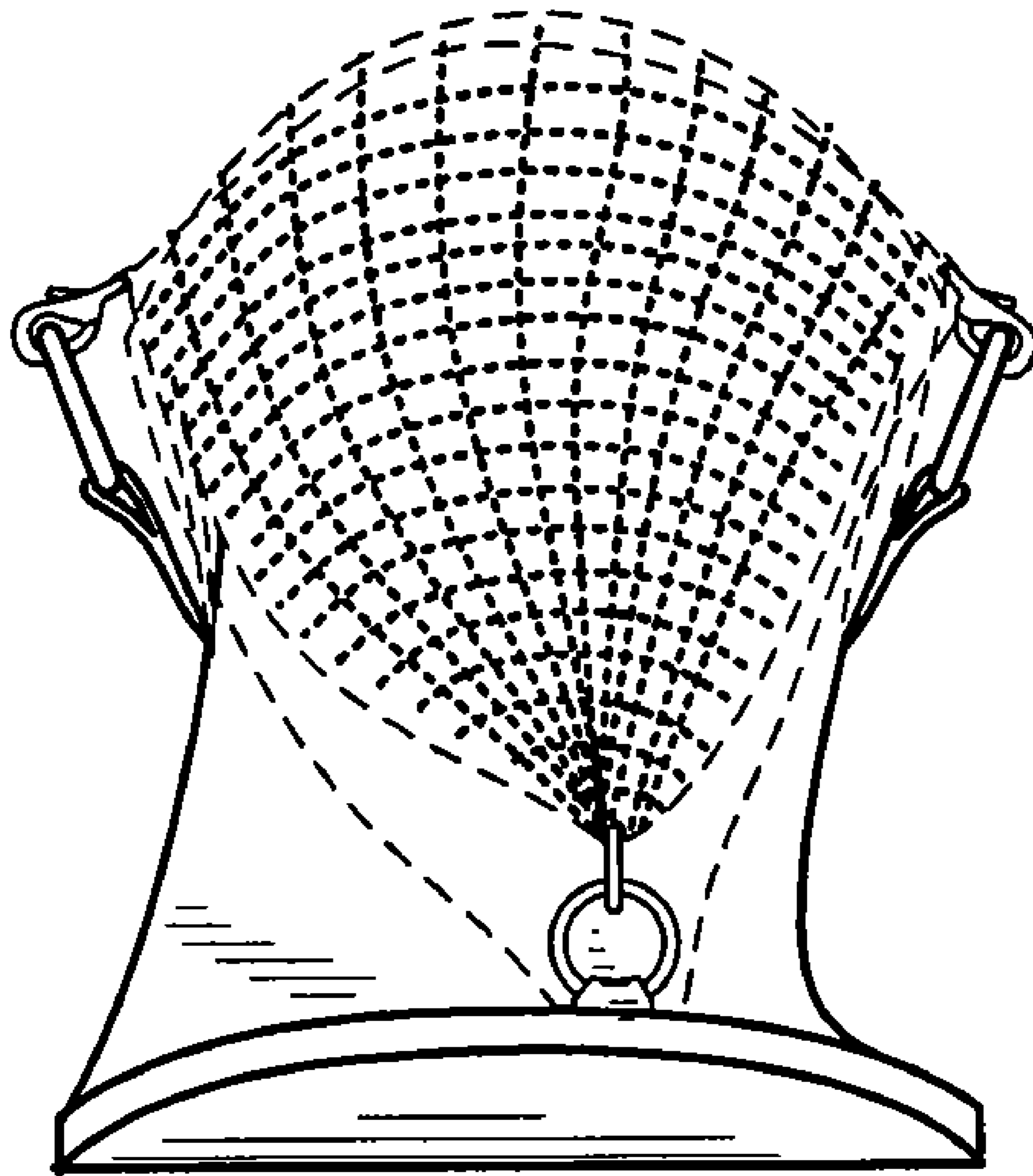

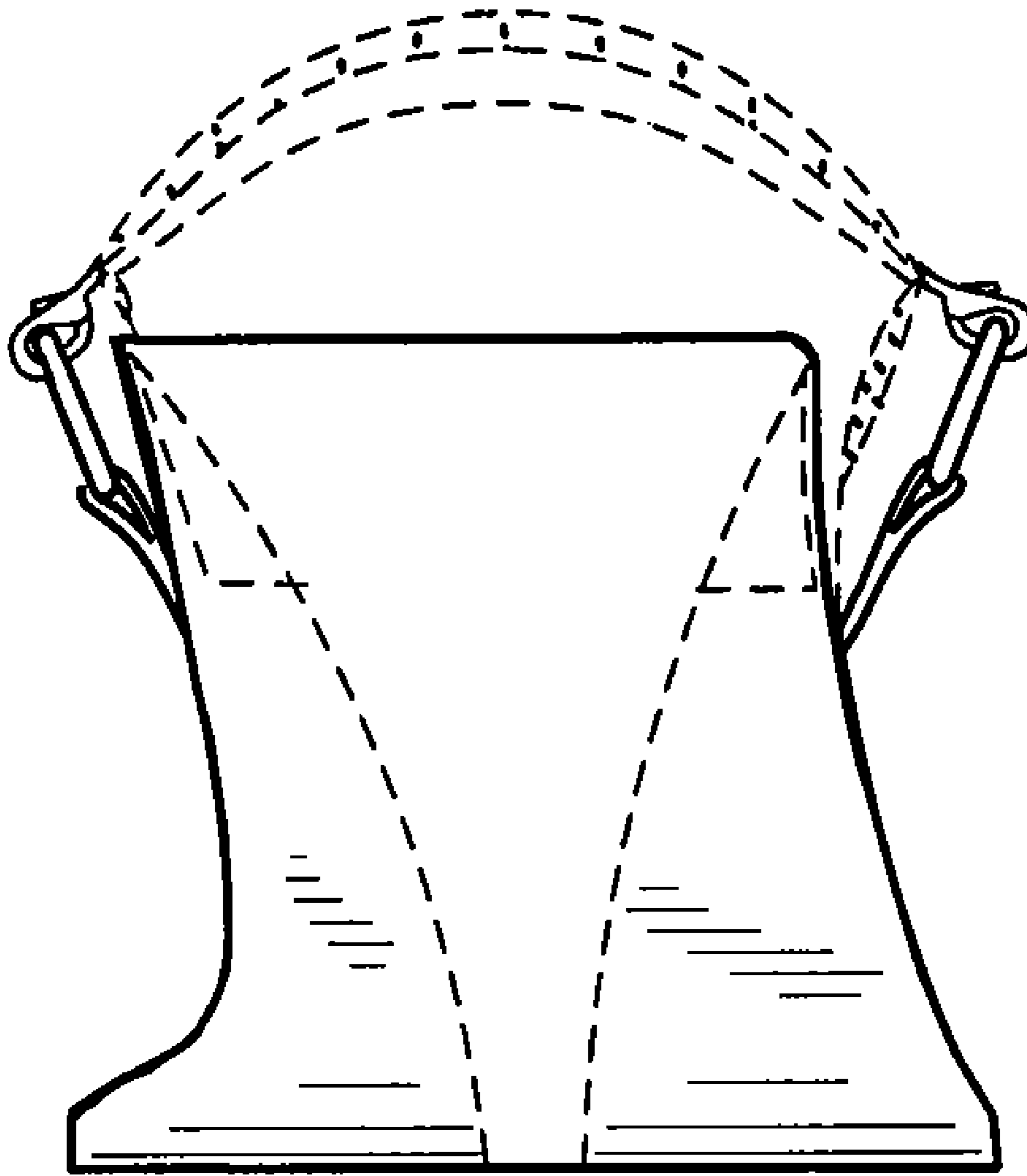

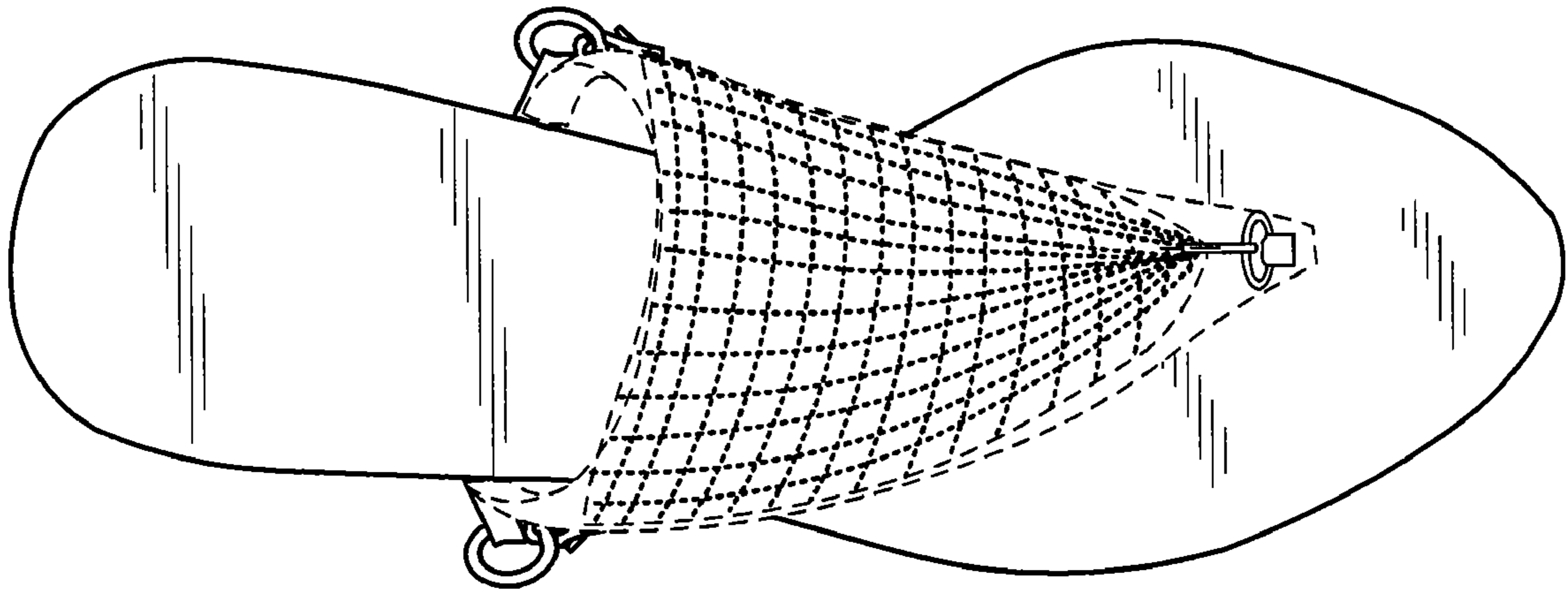

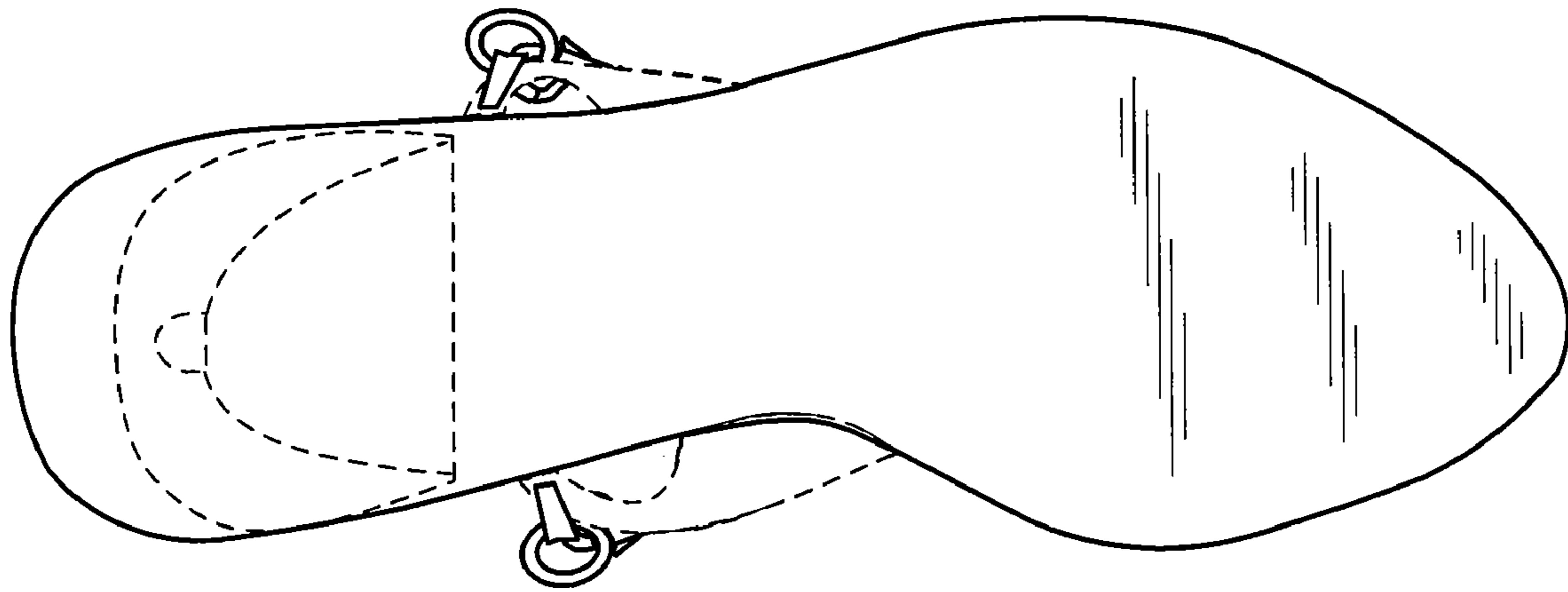

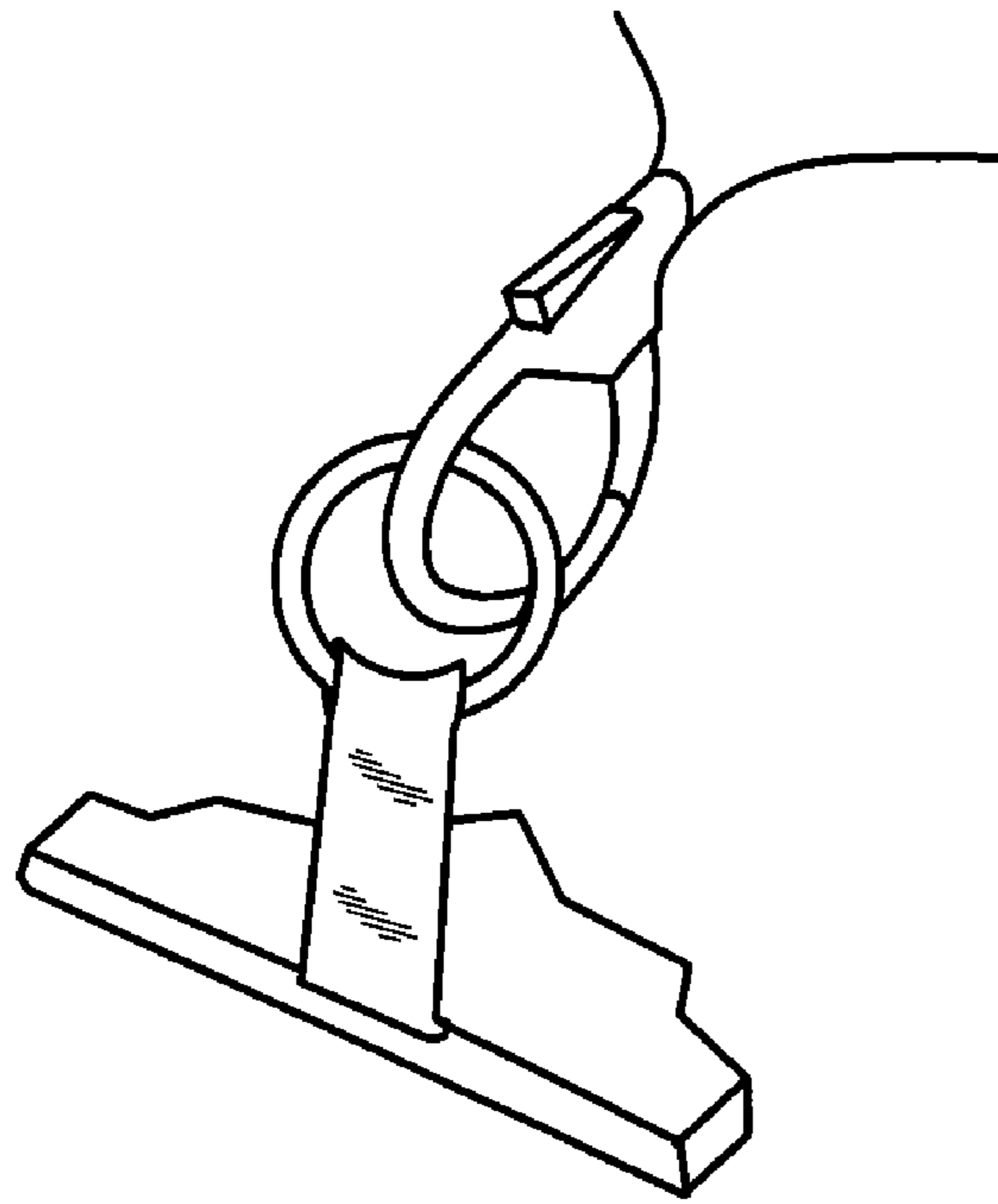
