FIG. 6 is a side view of the present invention;

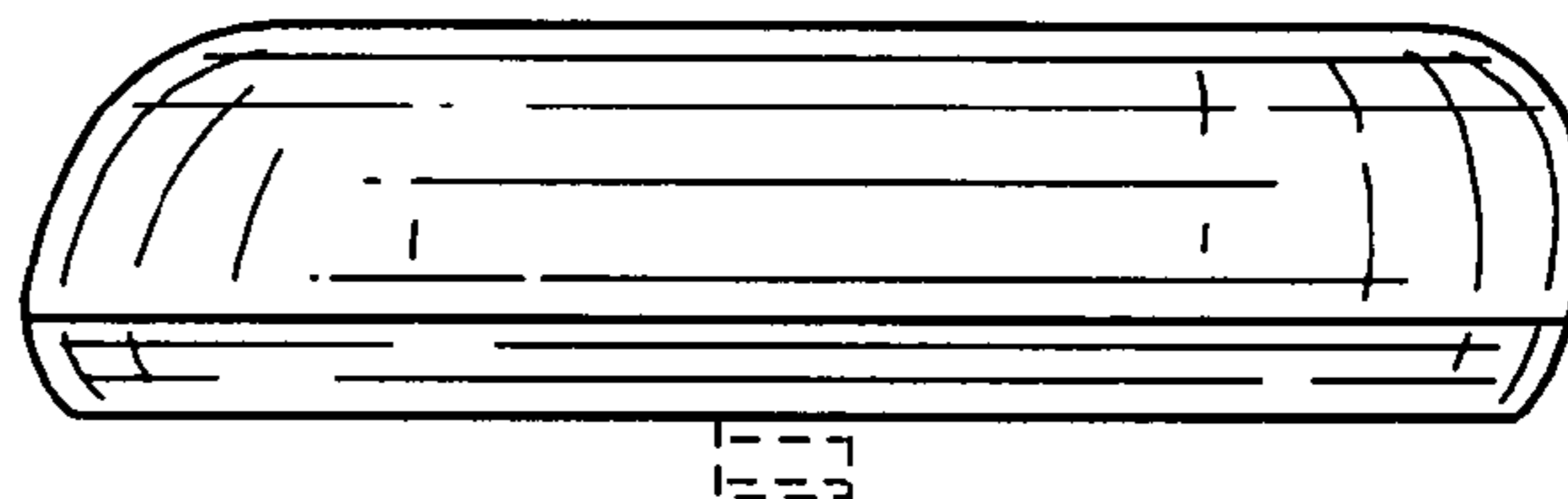
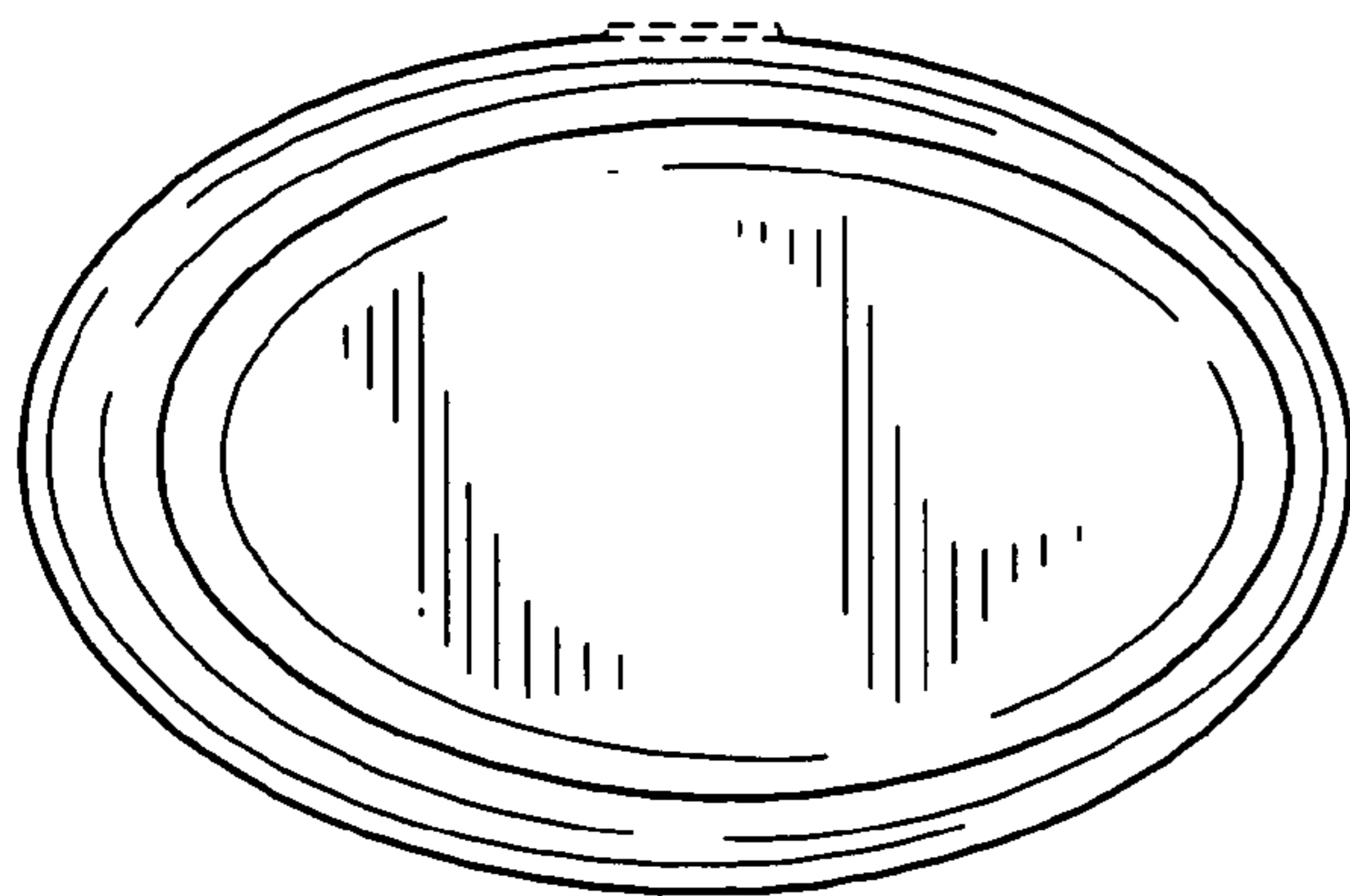
FIG. 7 is a side view of the present invention;

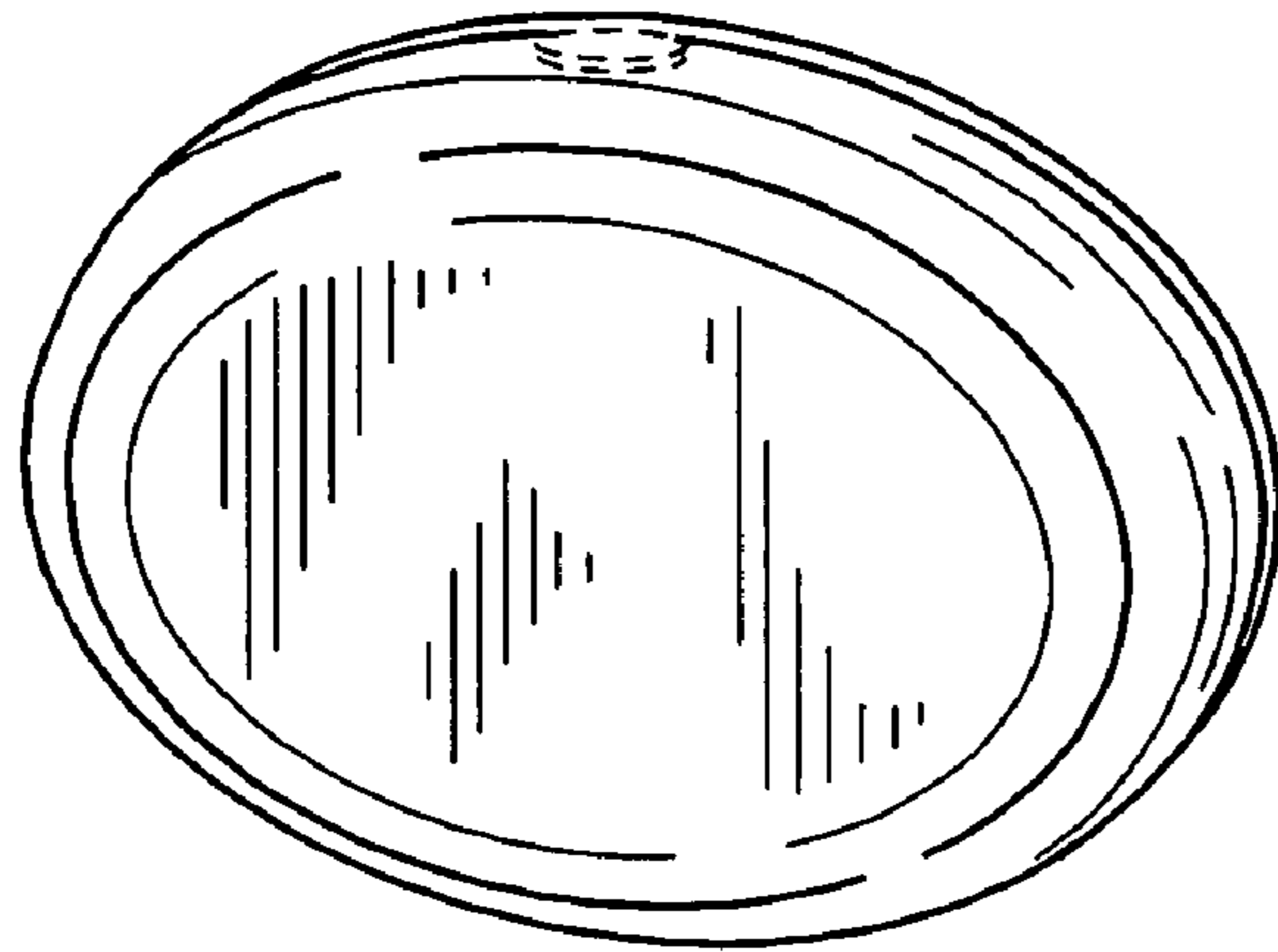

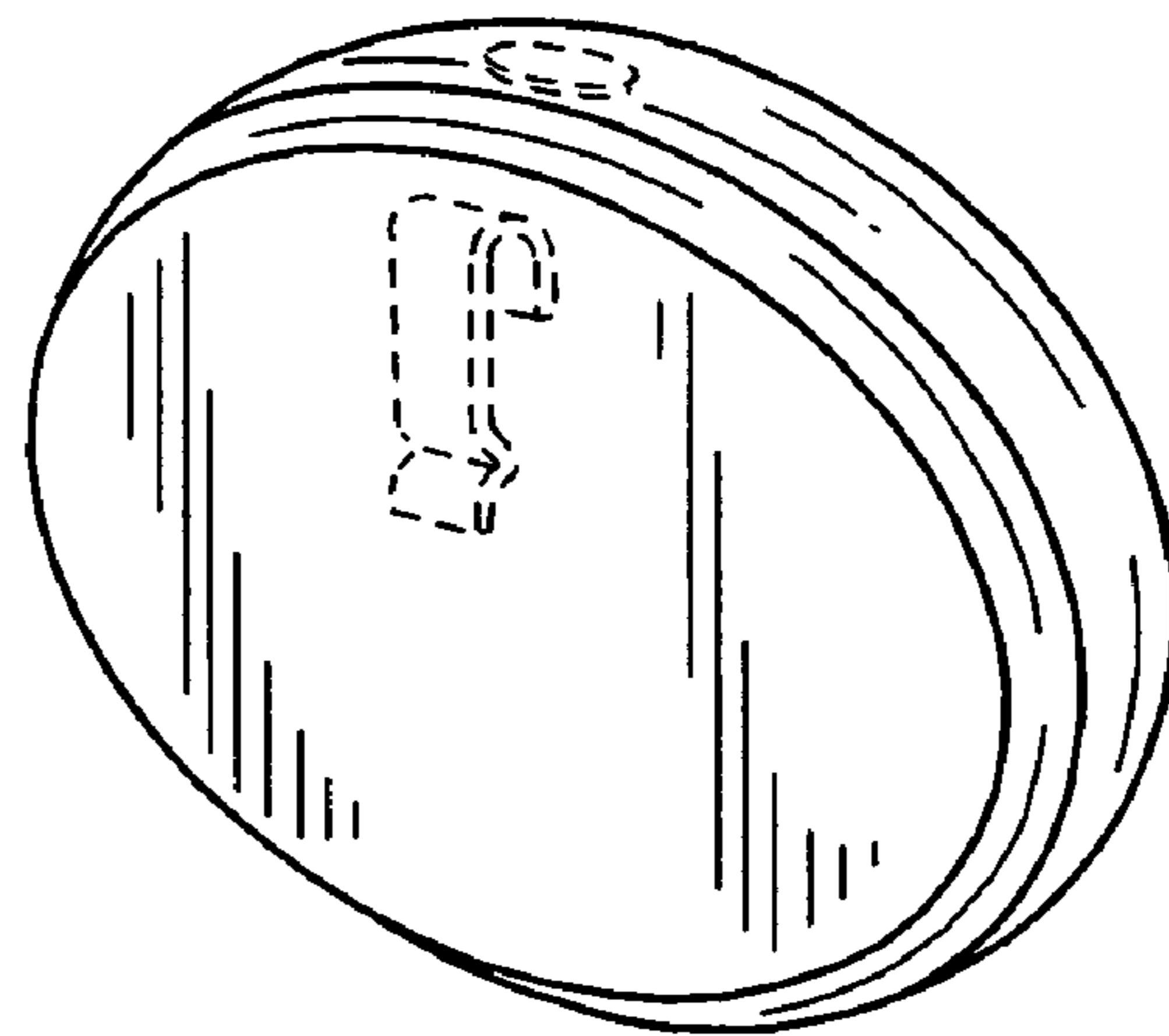

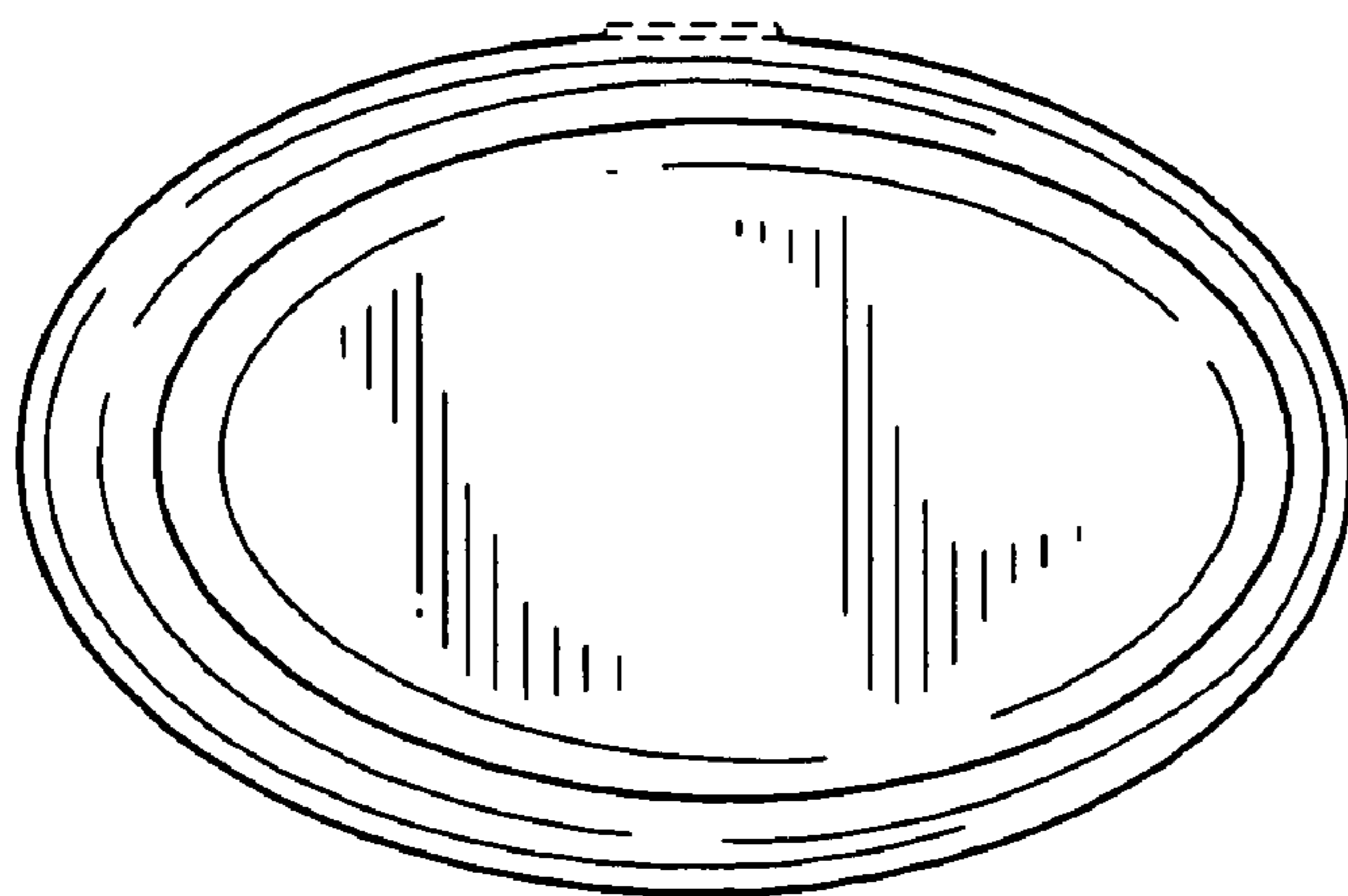

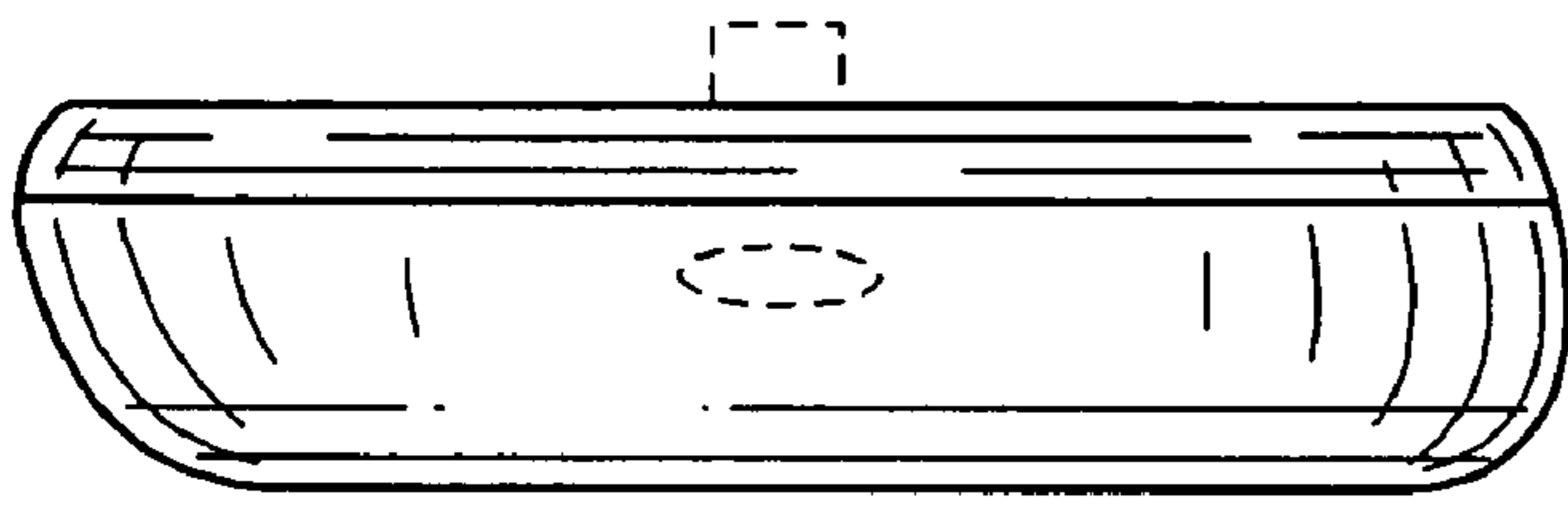

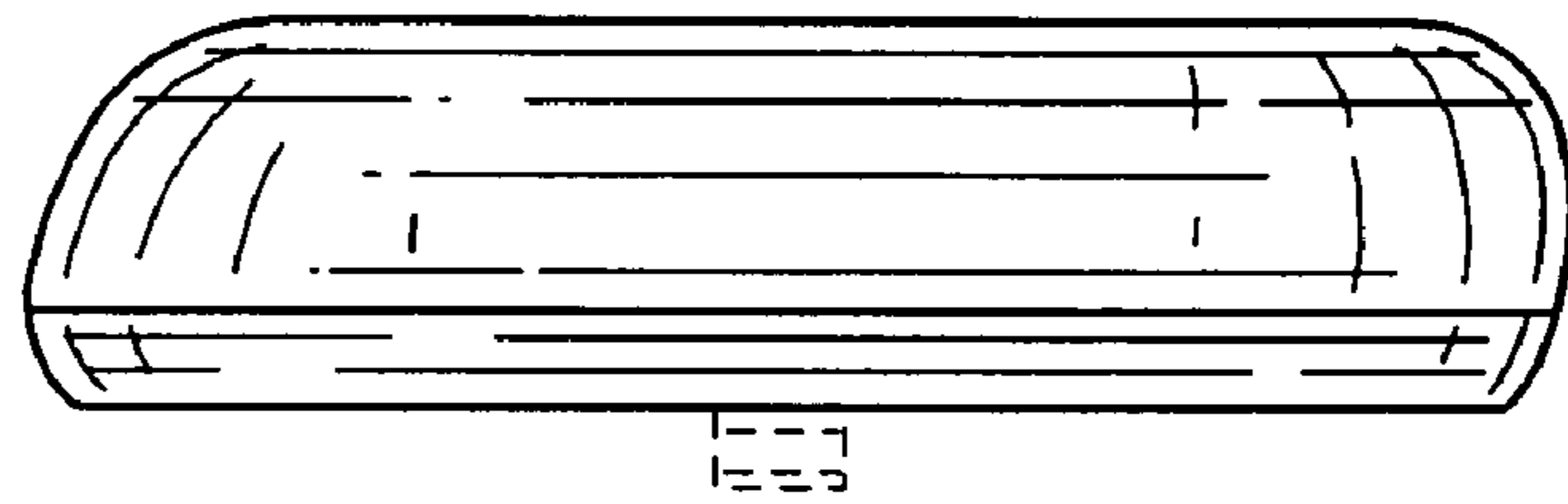

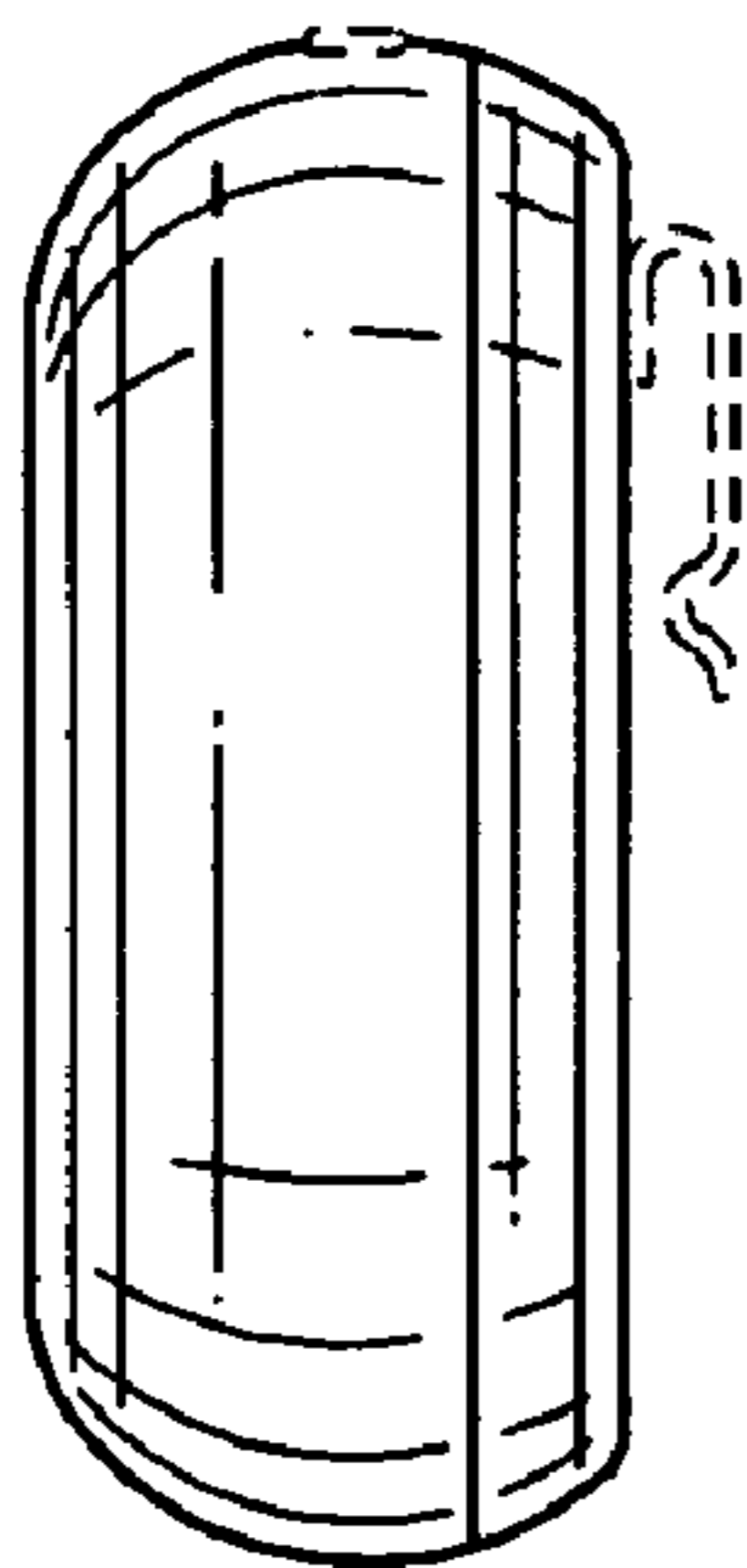

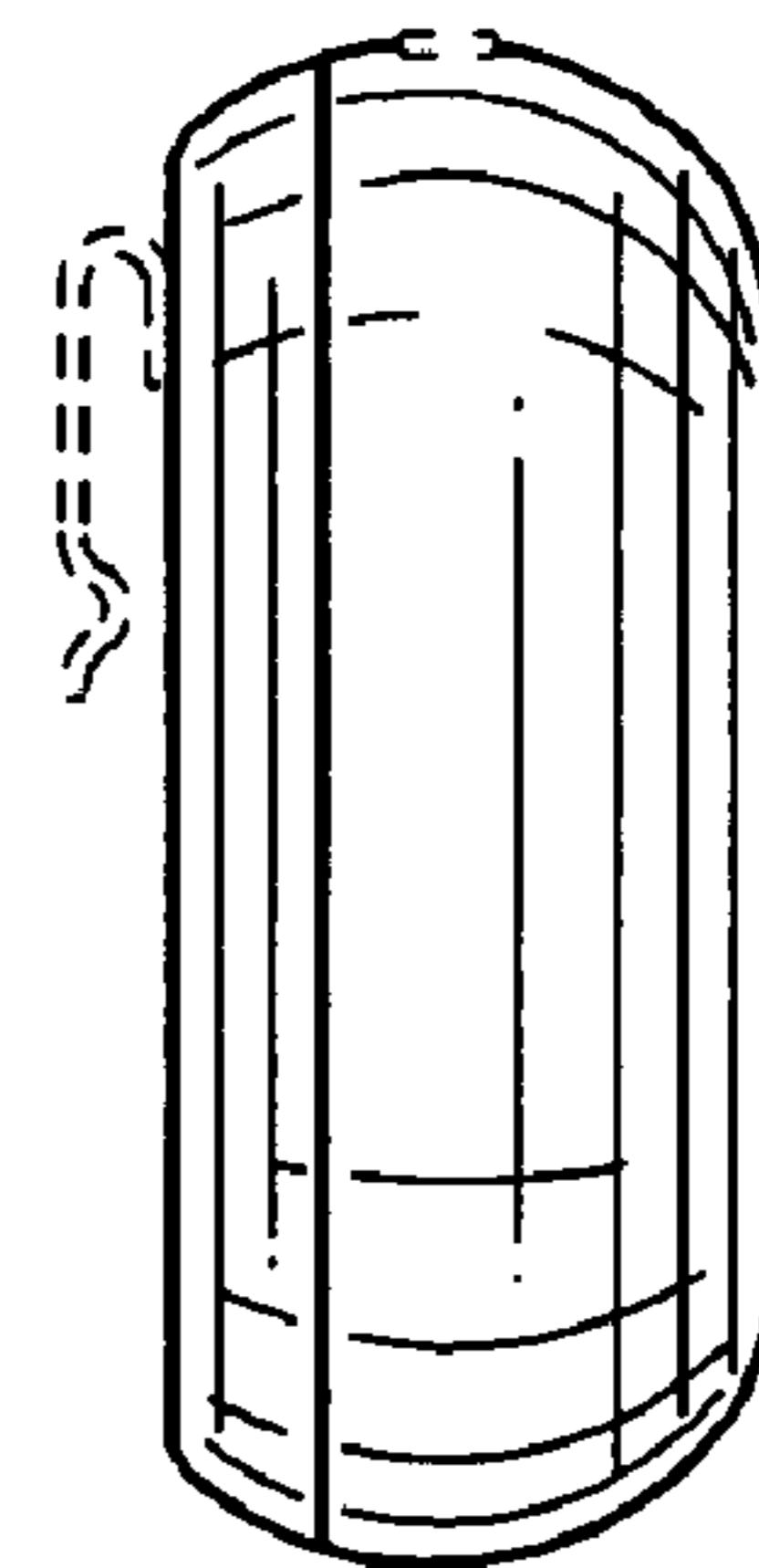

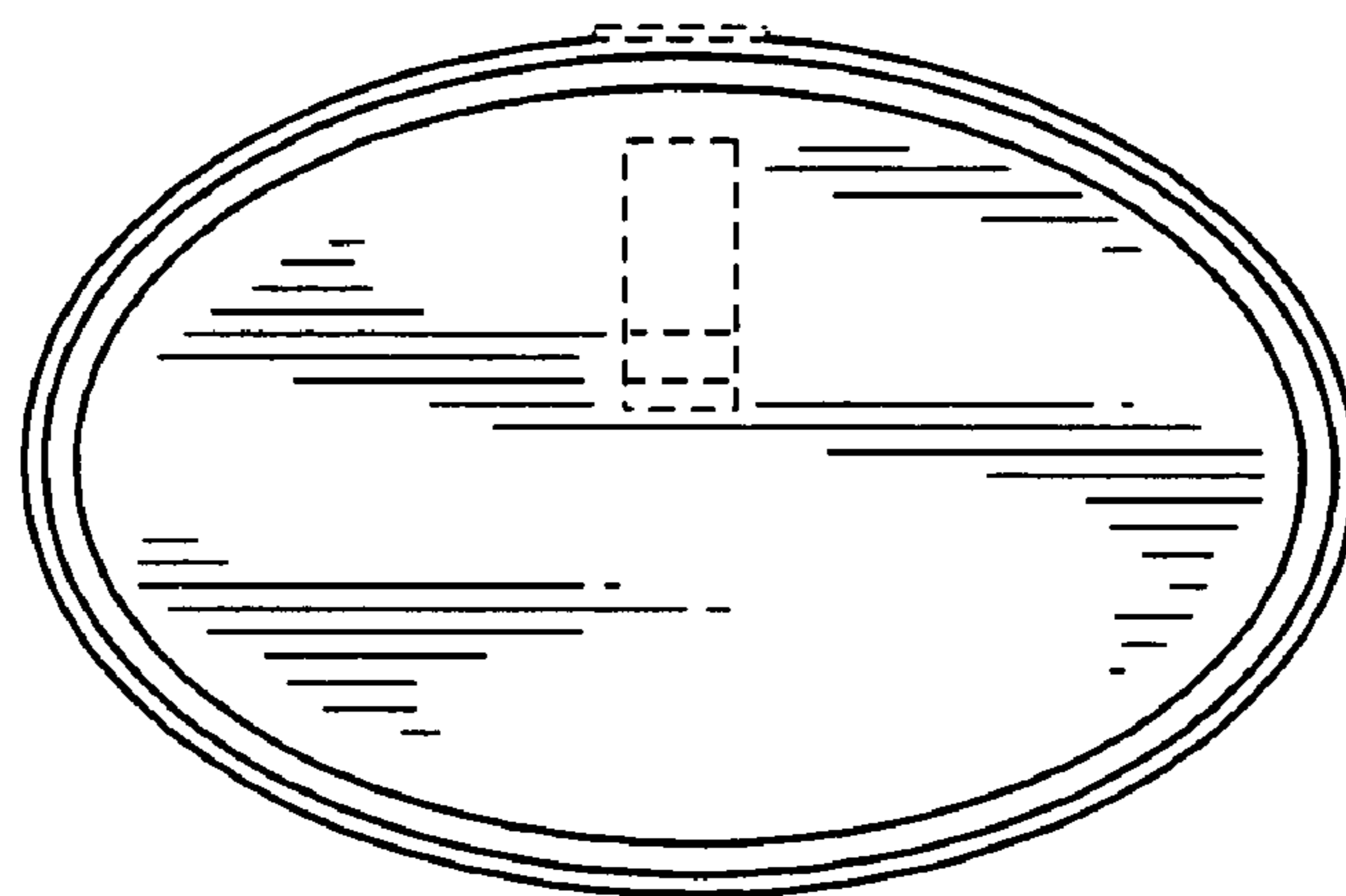

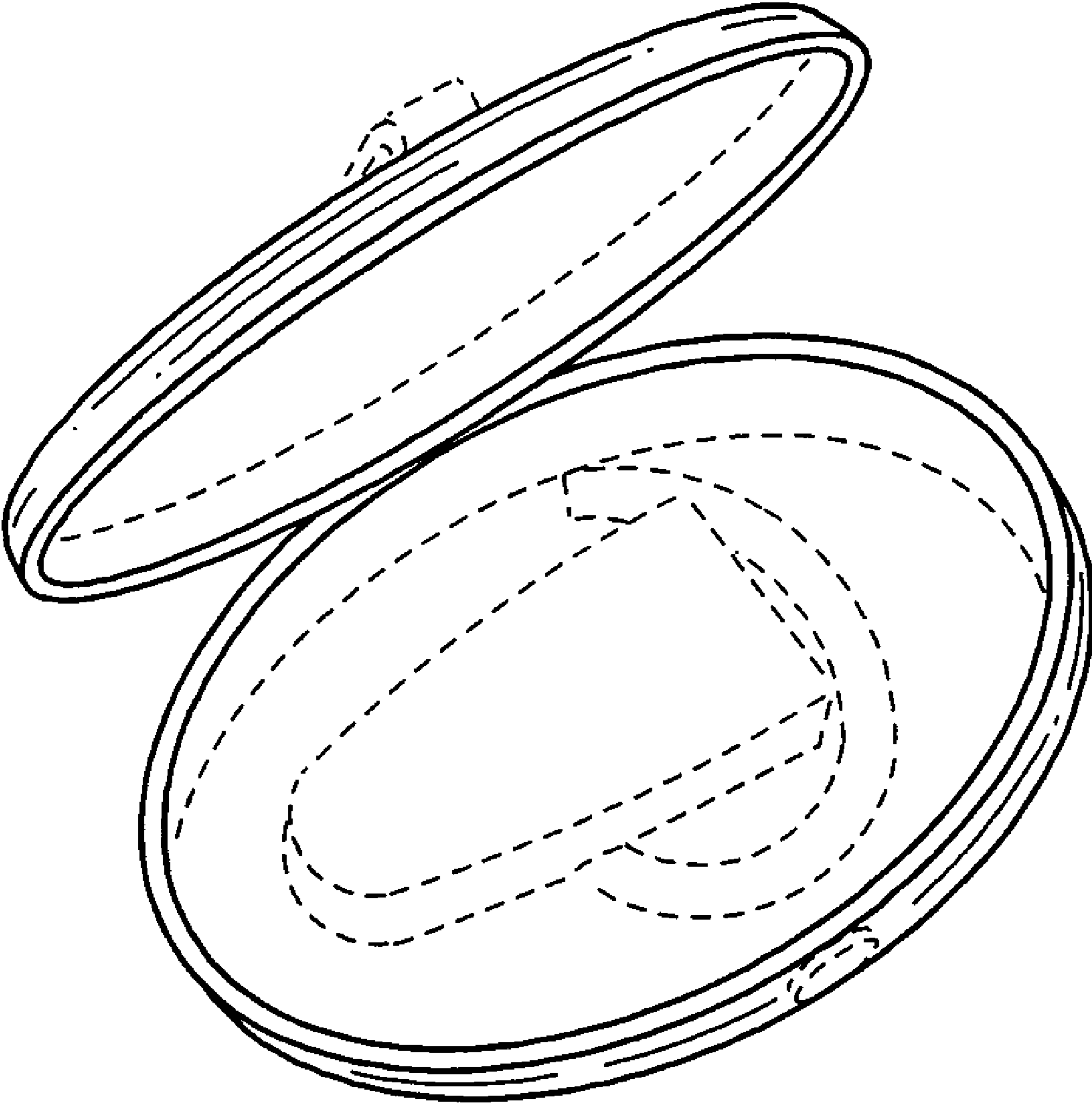
