DESCRIPTION

FIG. 20 is a top plan view of a sixth embodiment of a handbag with the state of Washington, showing our new design.

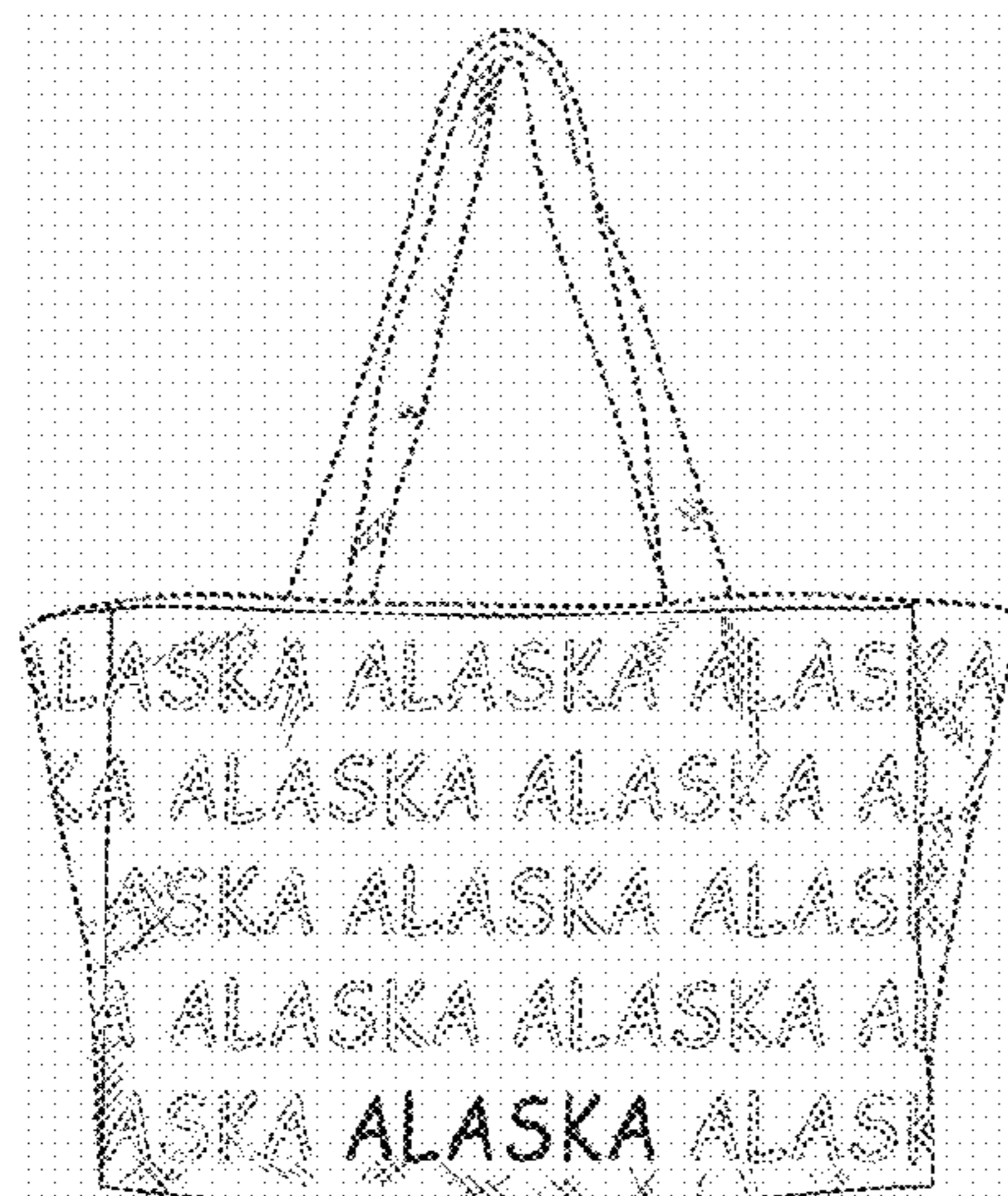


FIG. **21** is a top plan view of a first embodiment of a handbag with the state of New Mexico, showing our new design;

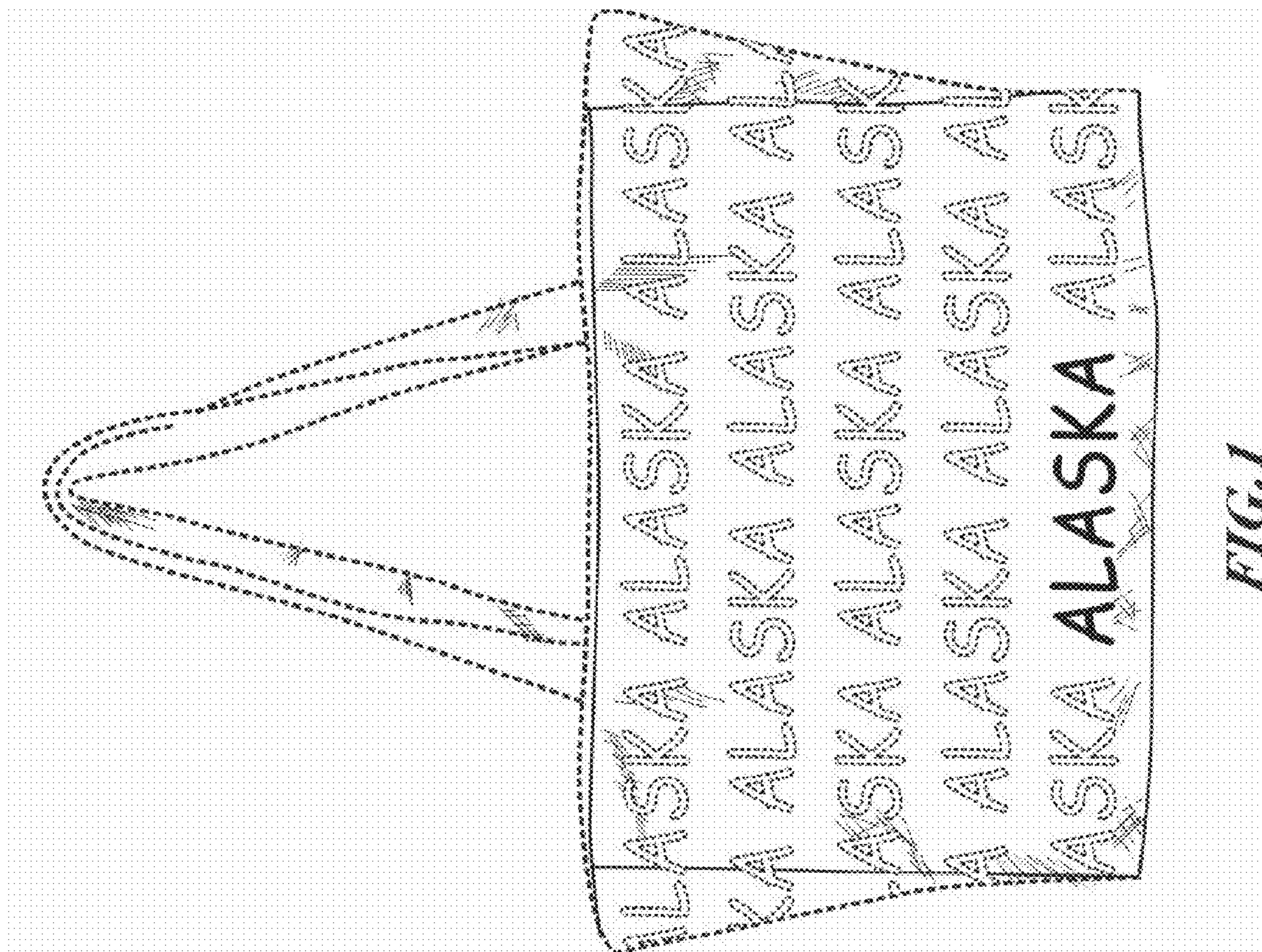

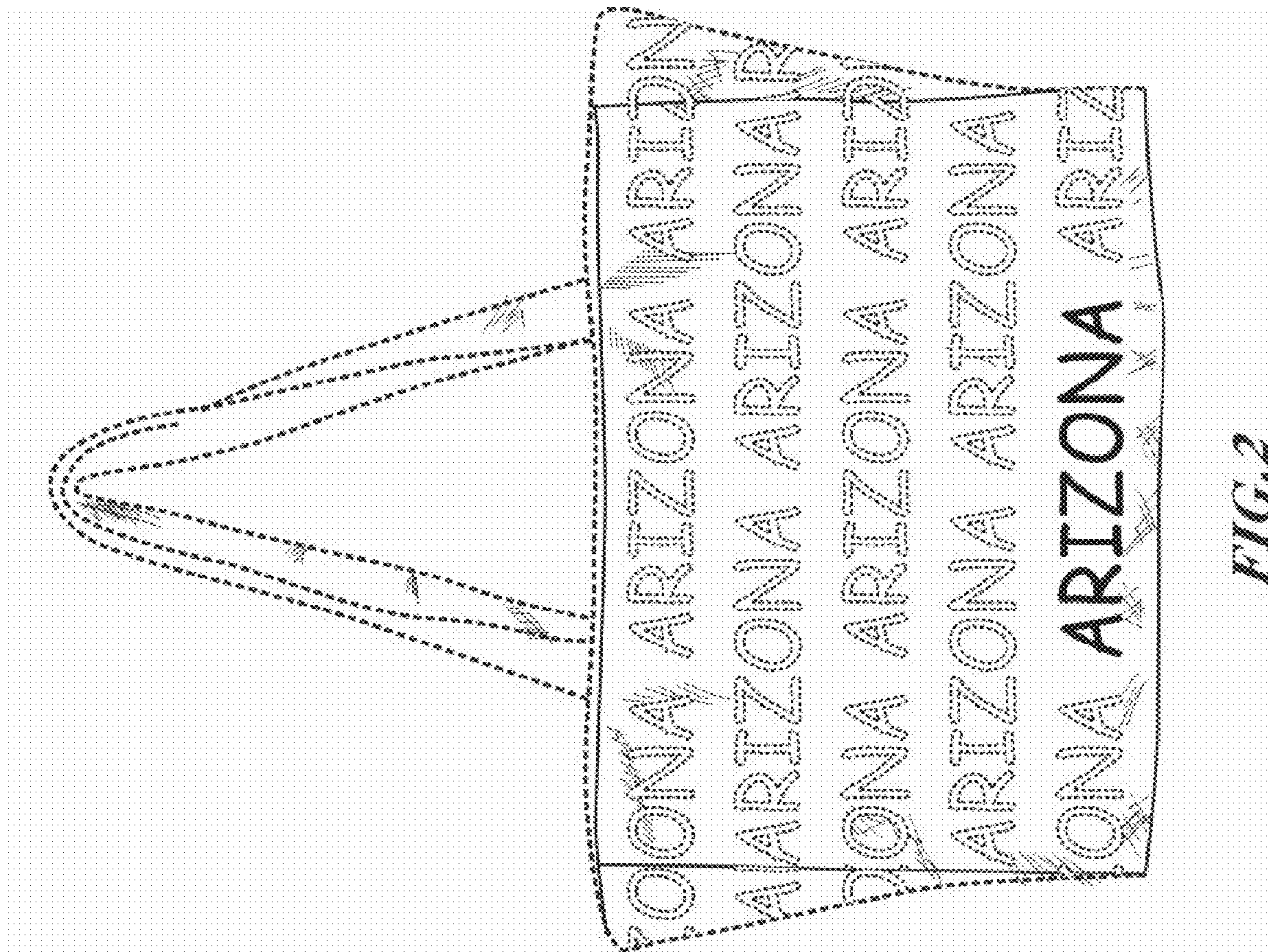

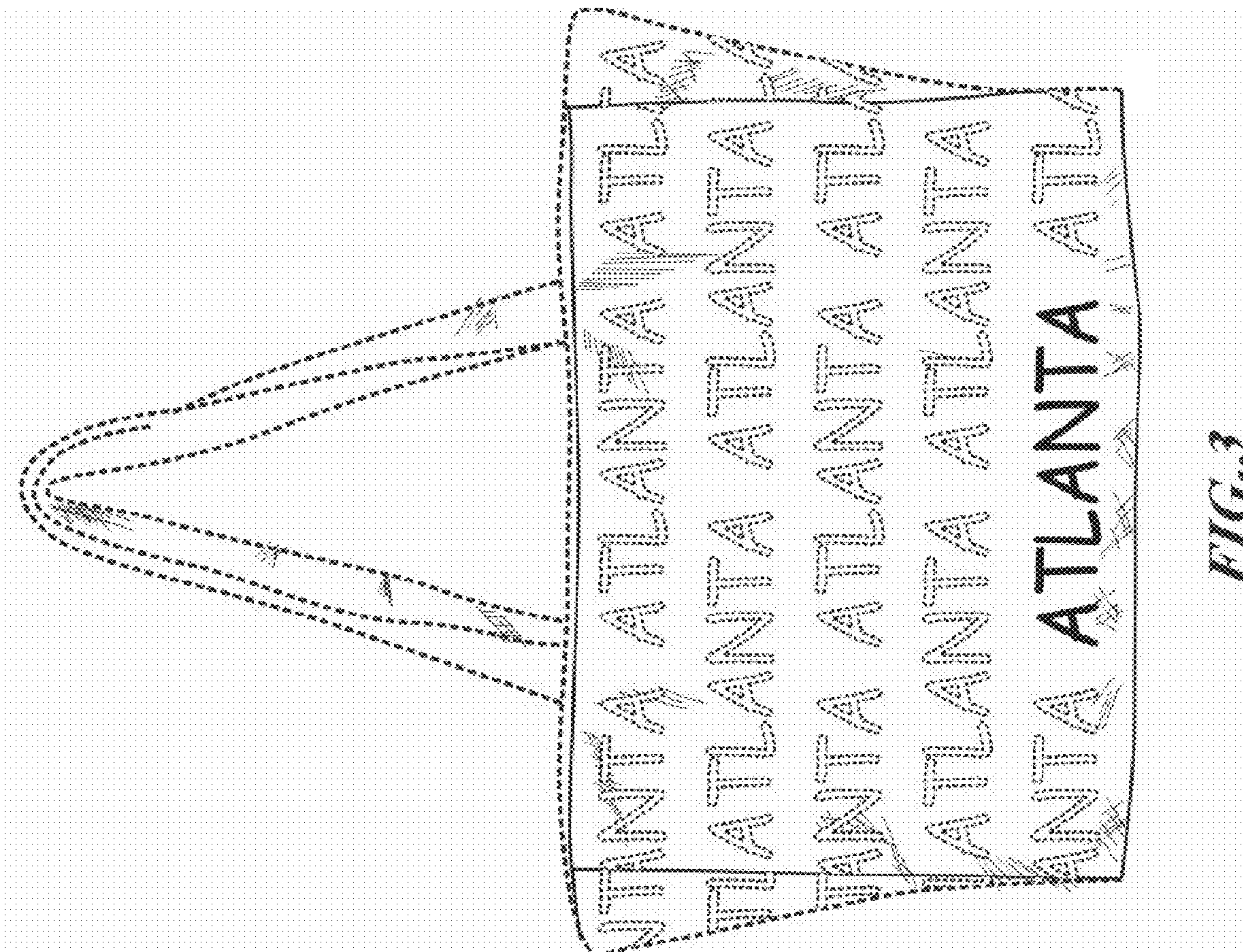

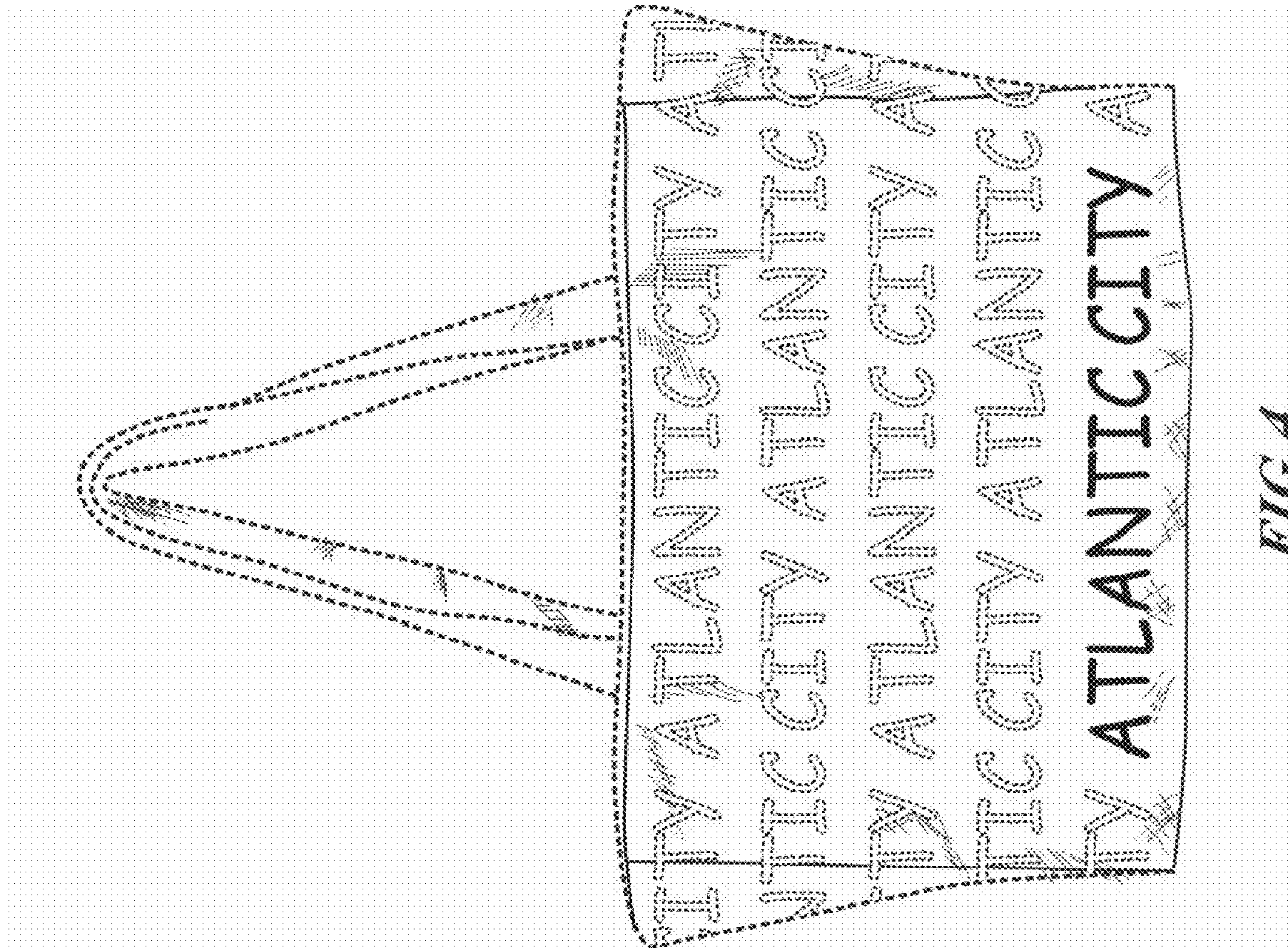

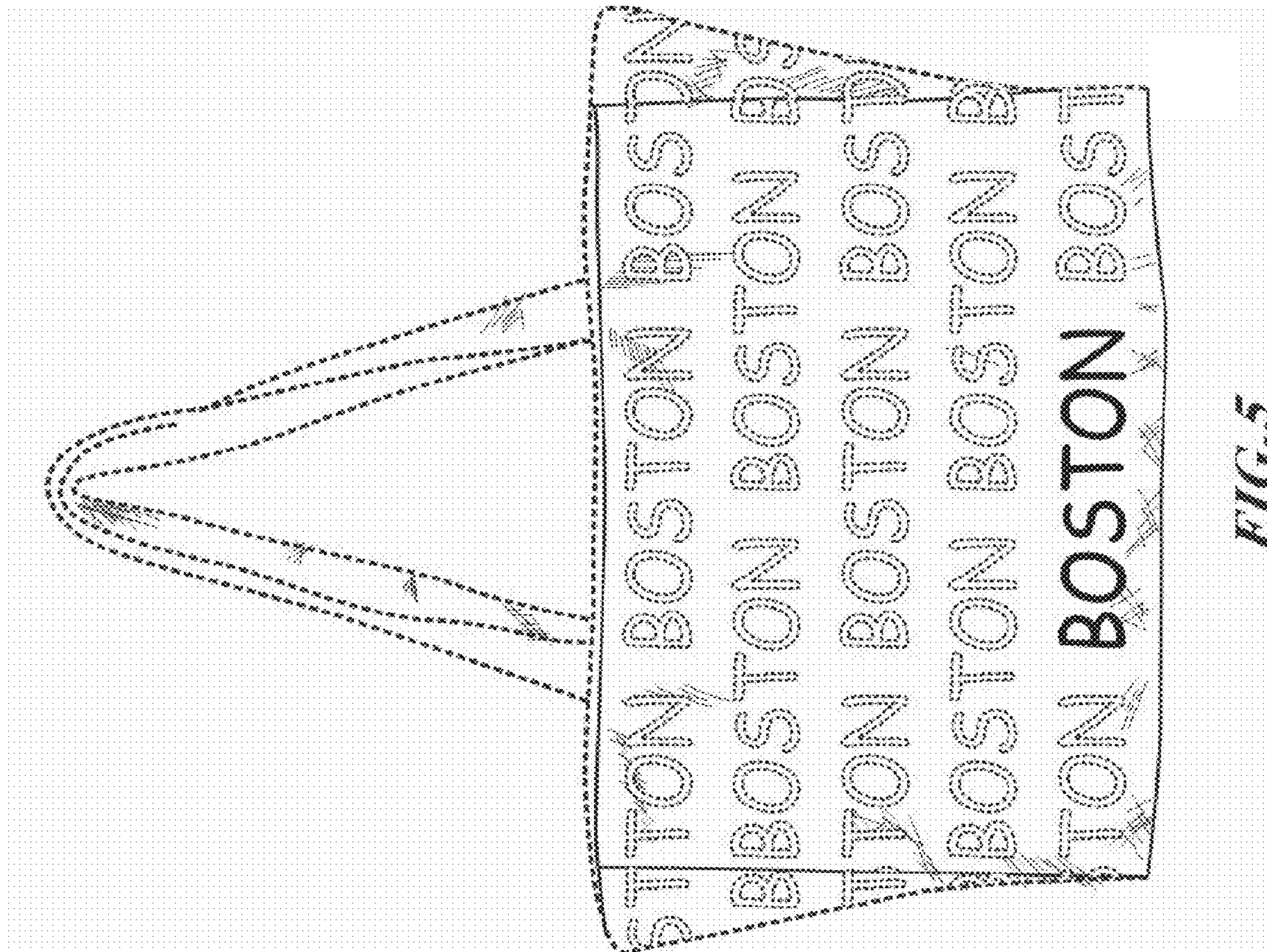

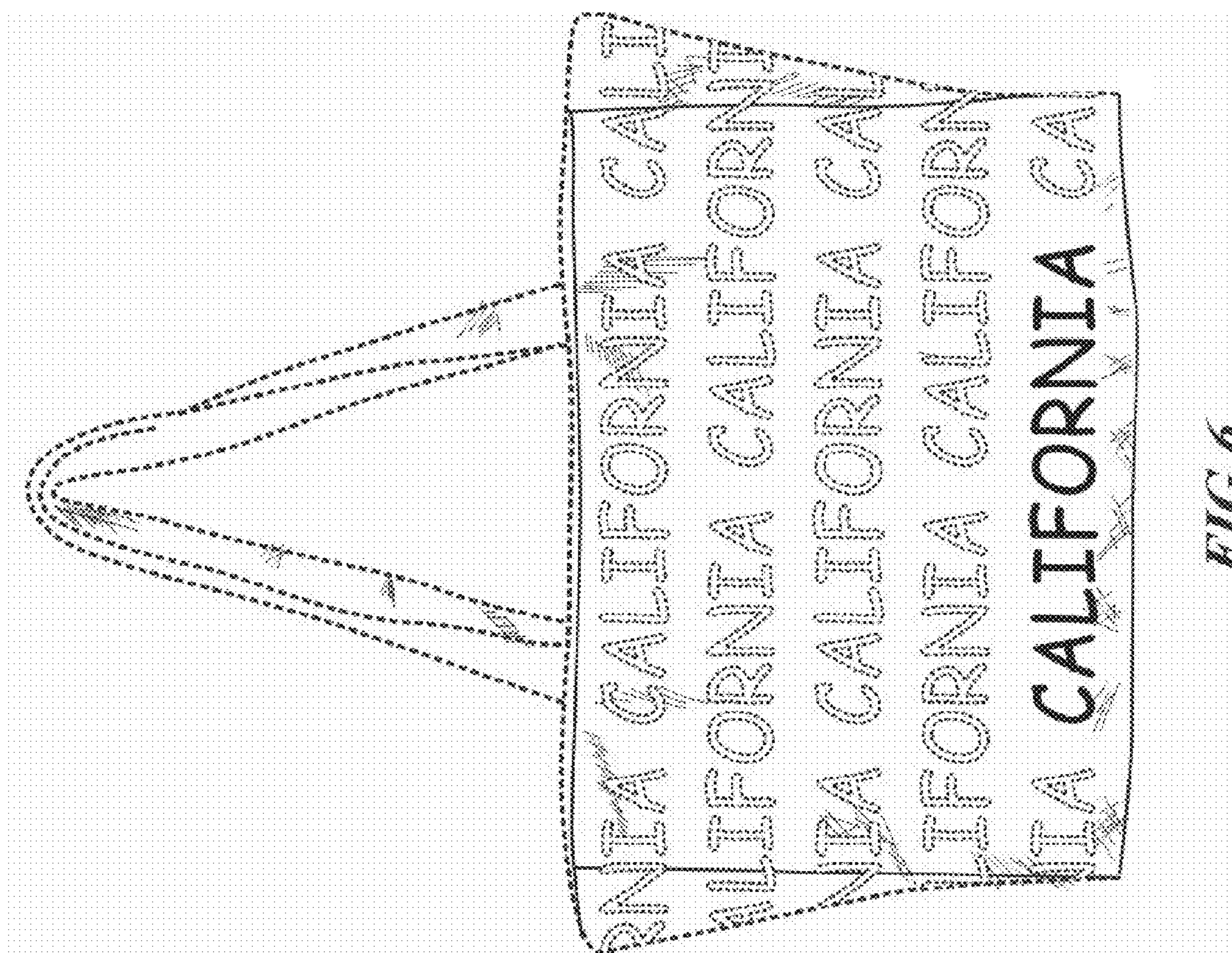

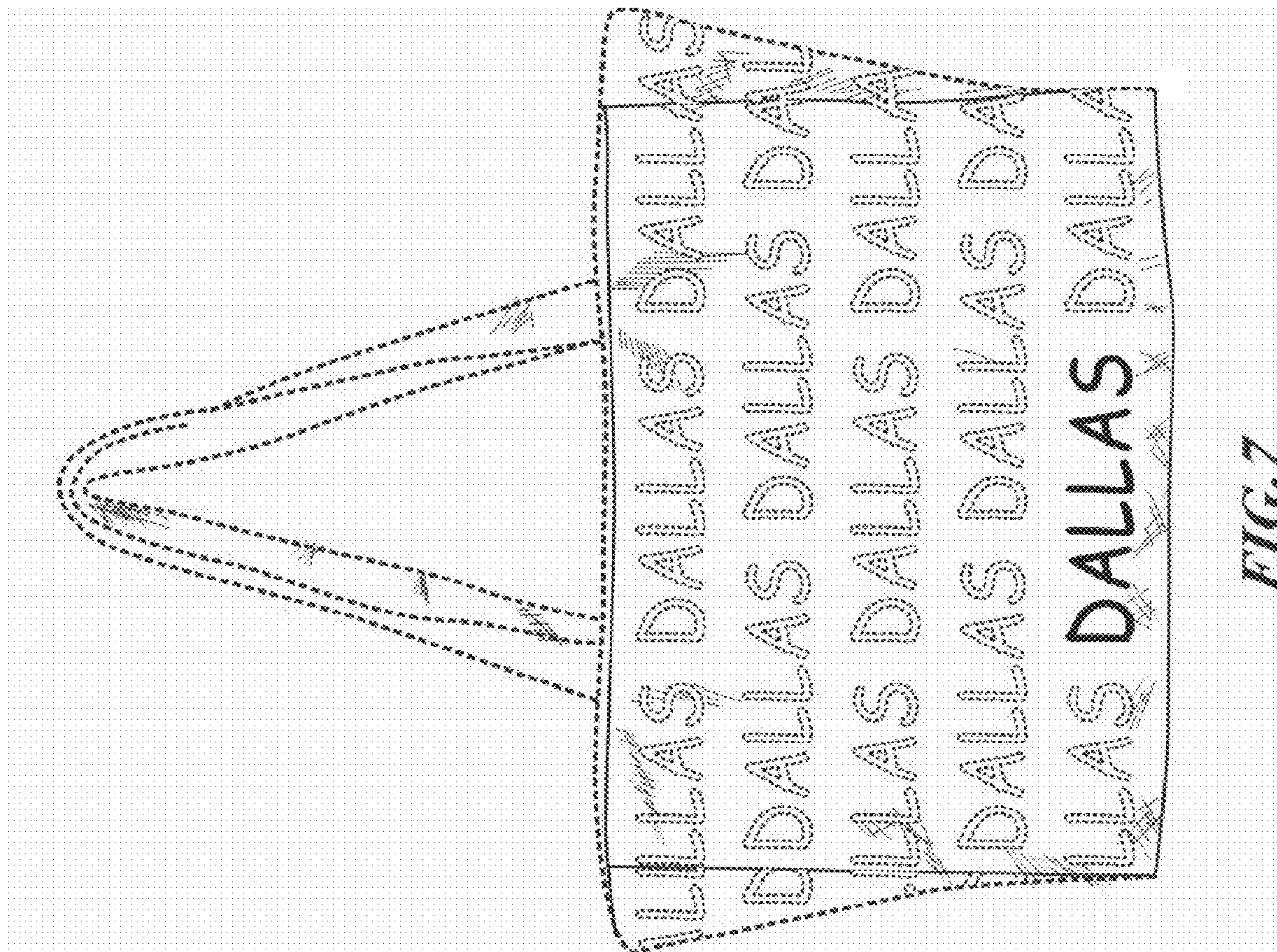

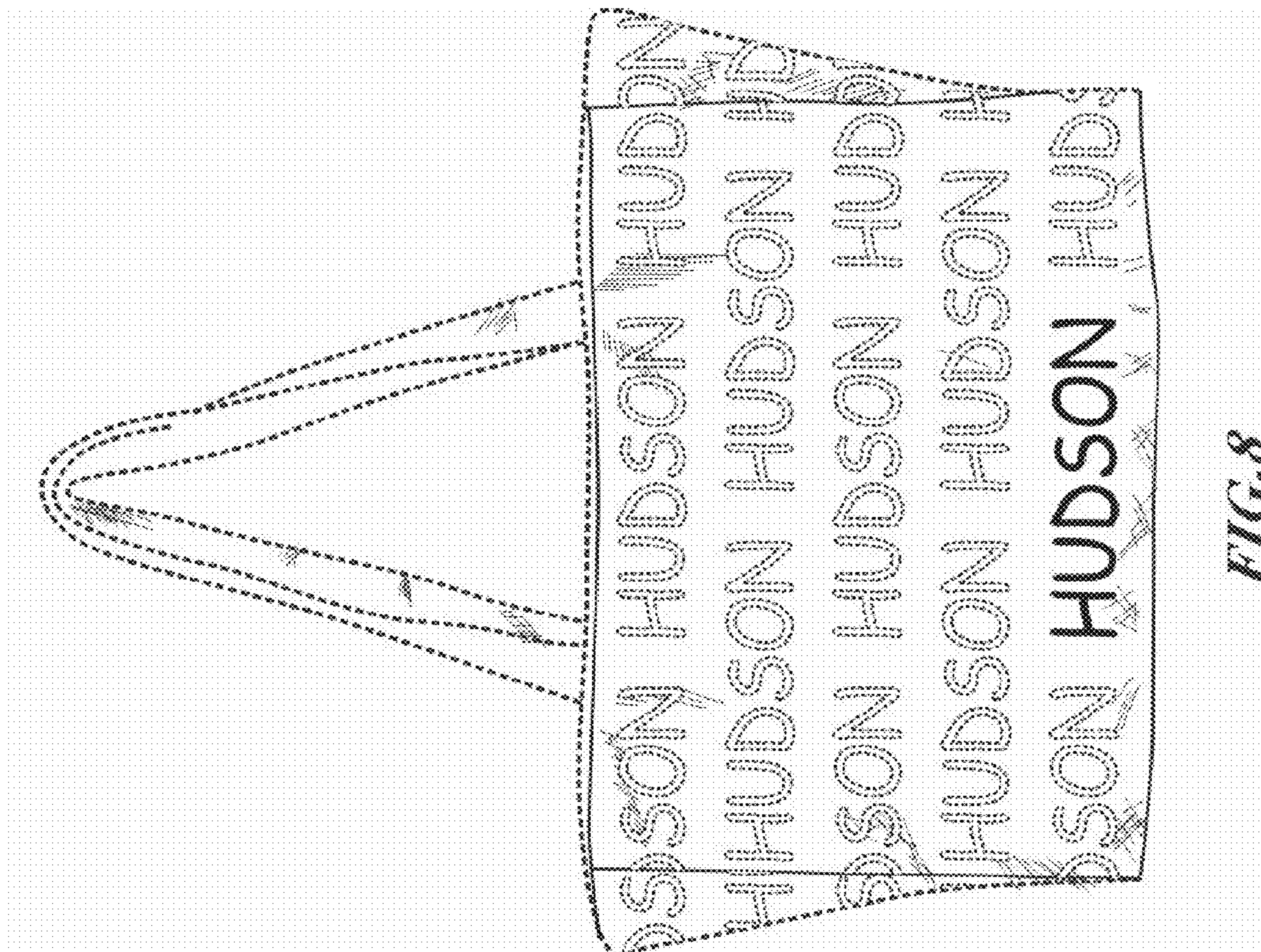

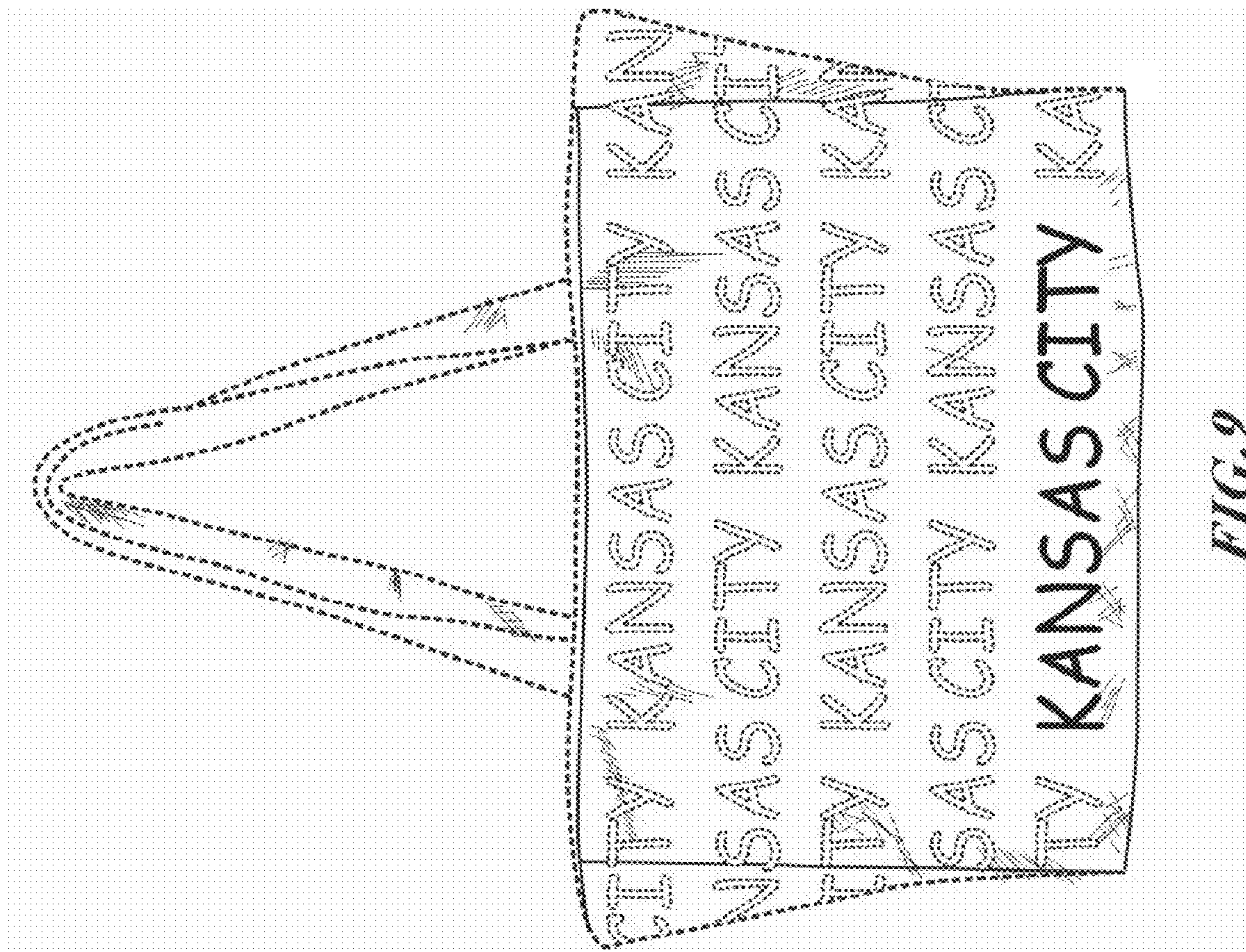

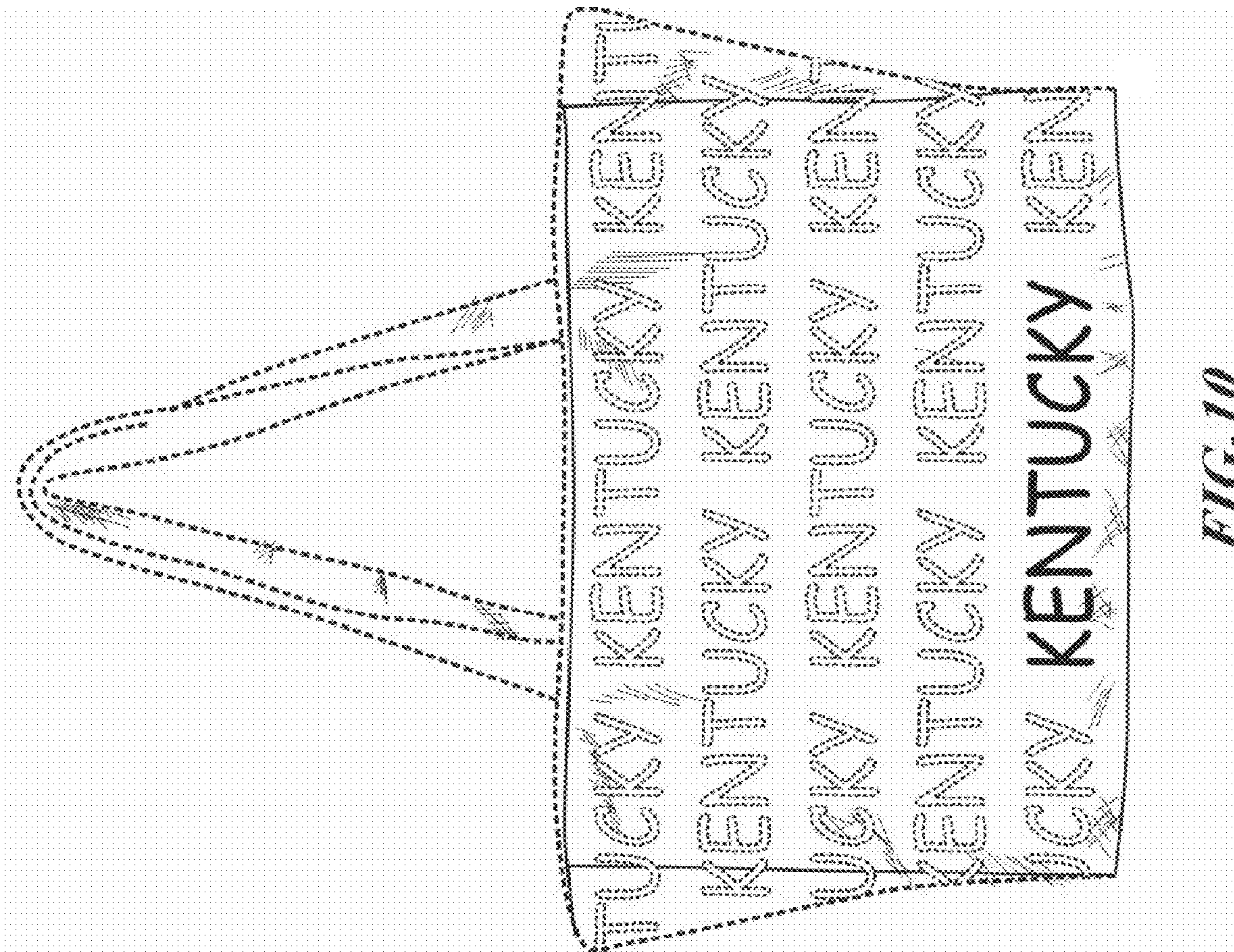

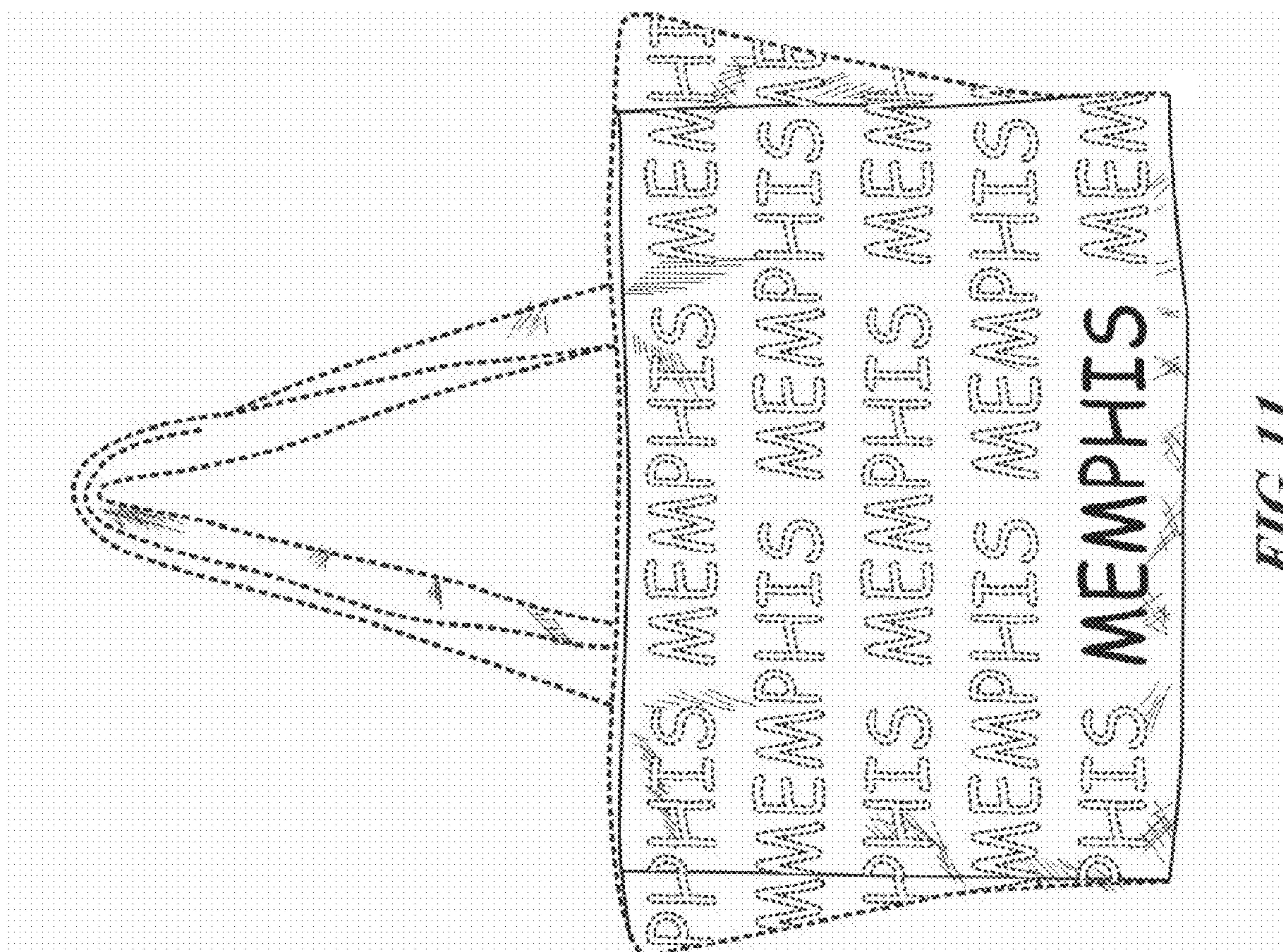

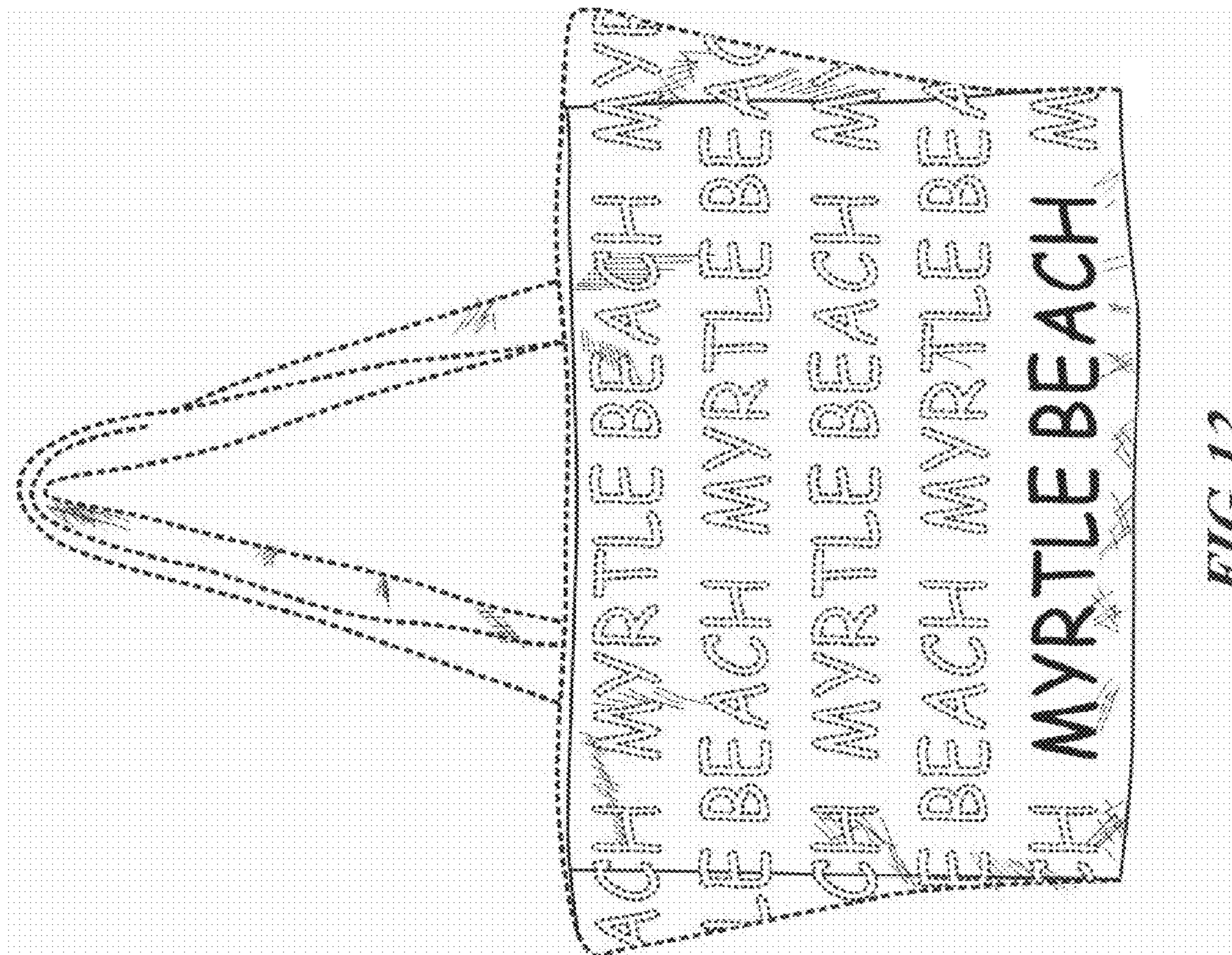

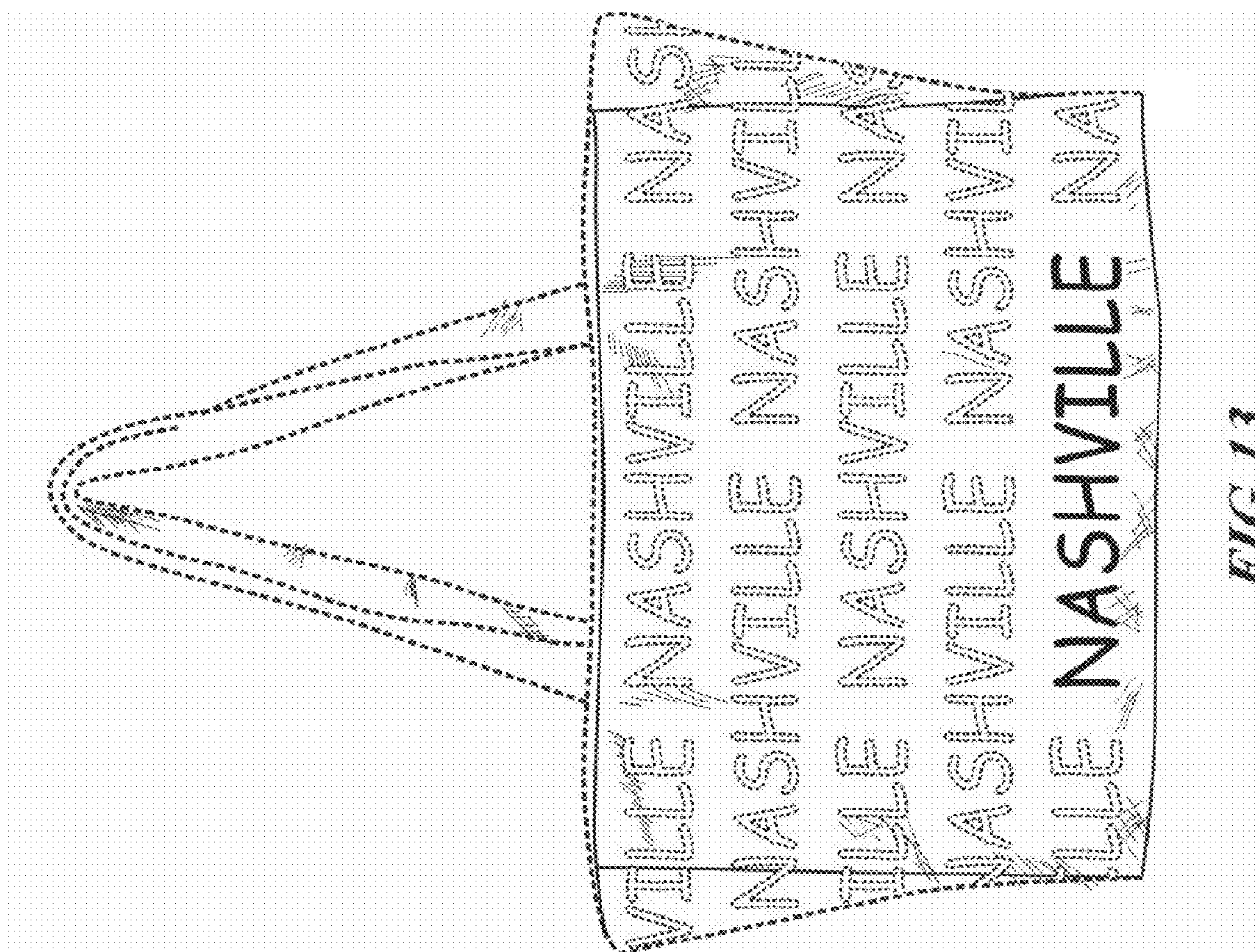

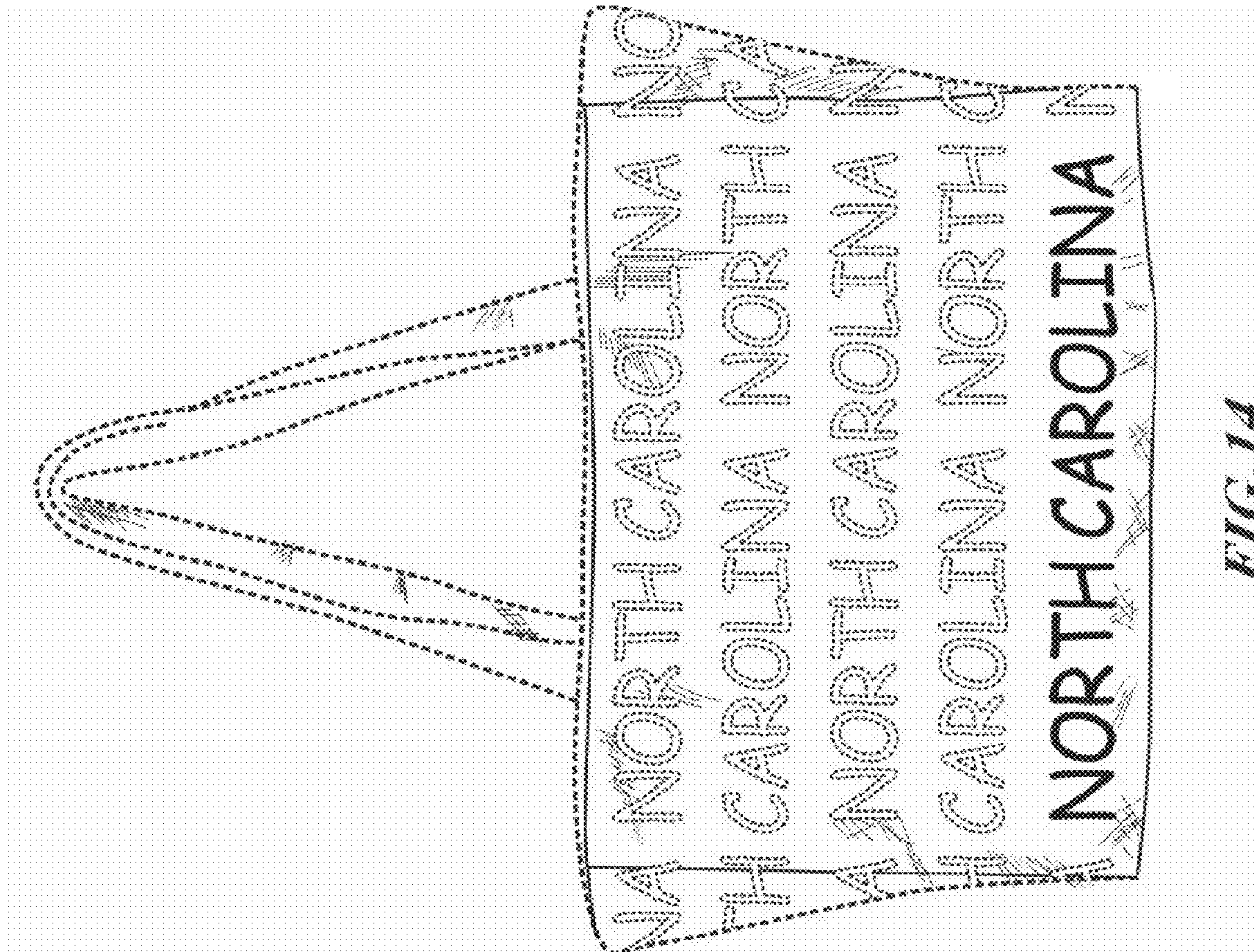

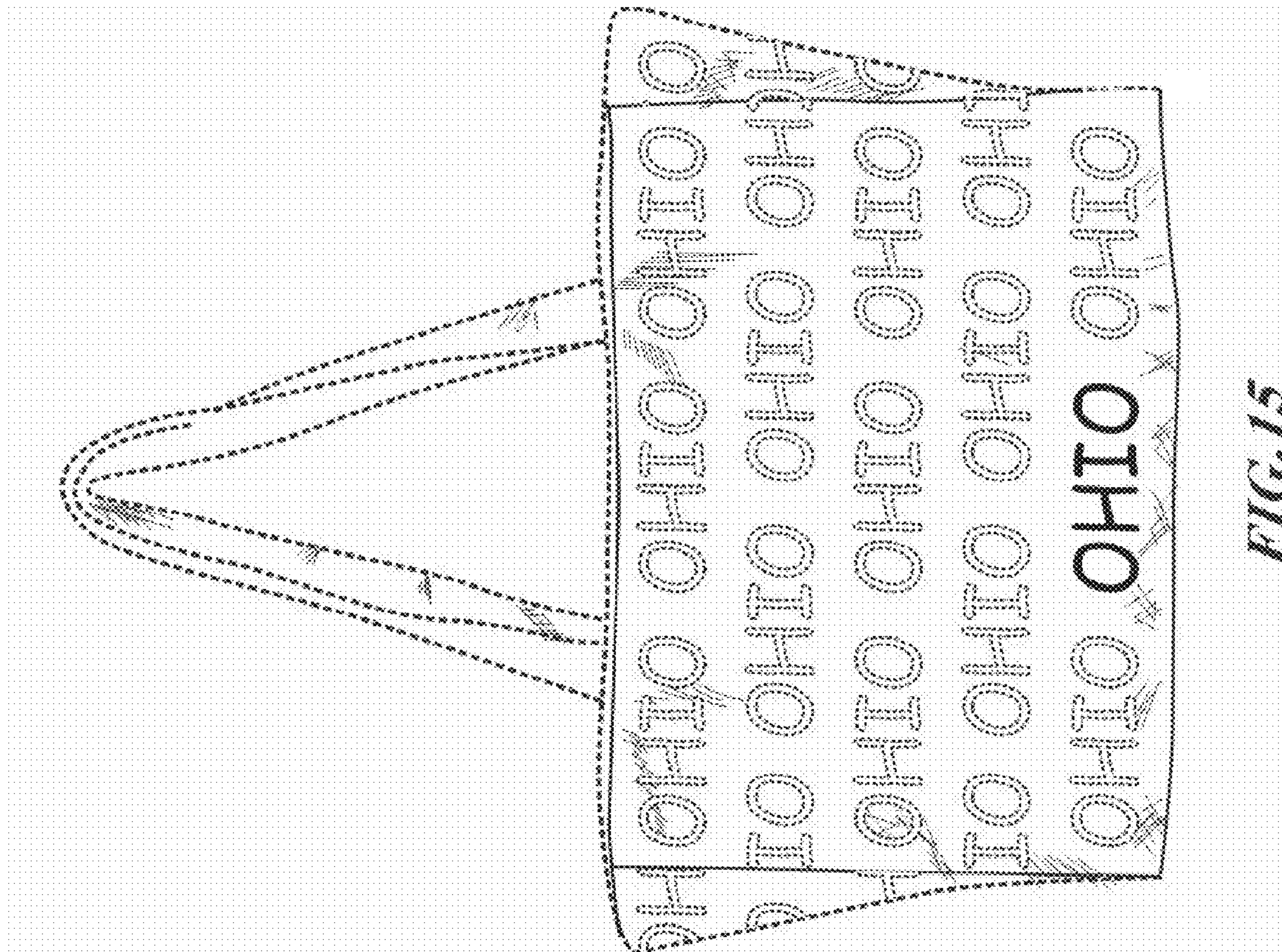

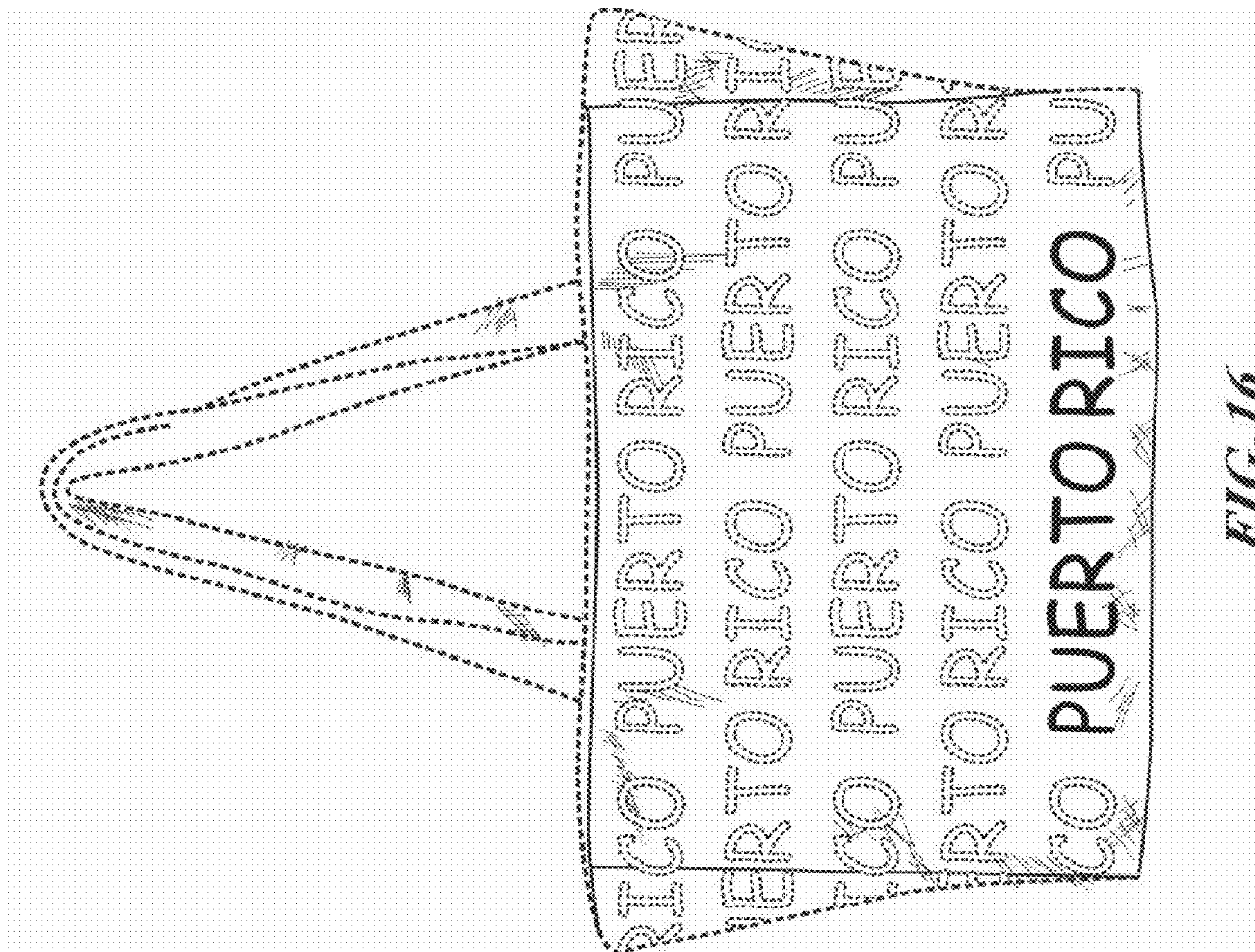

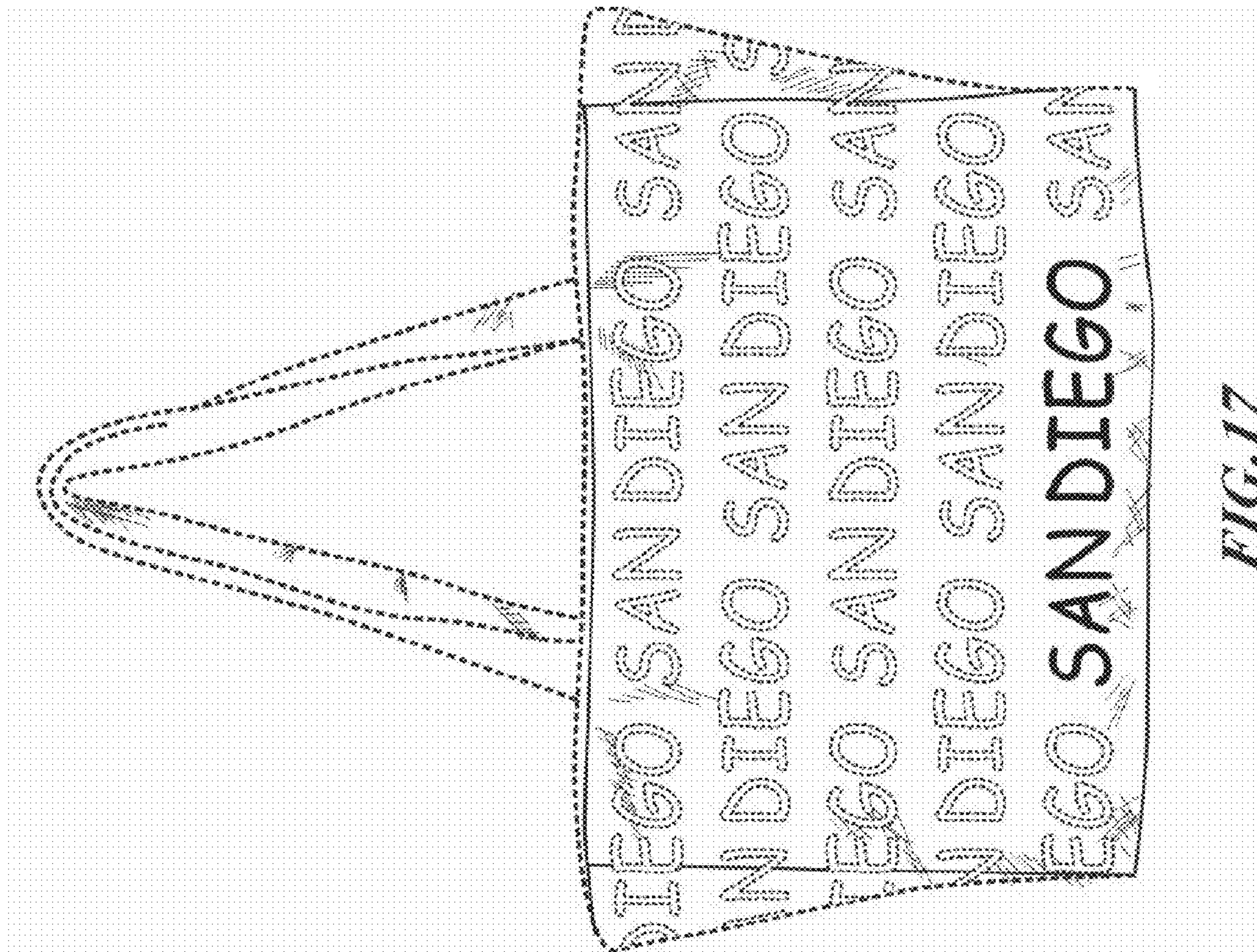

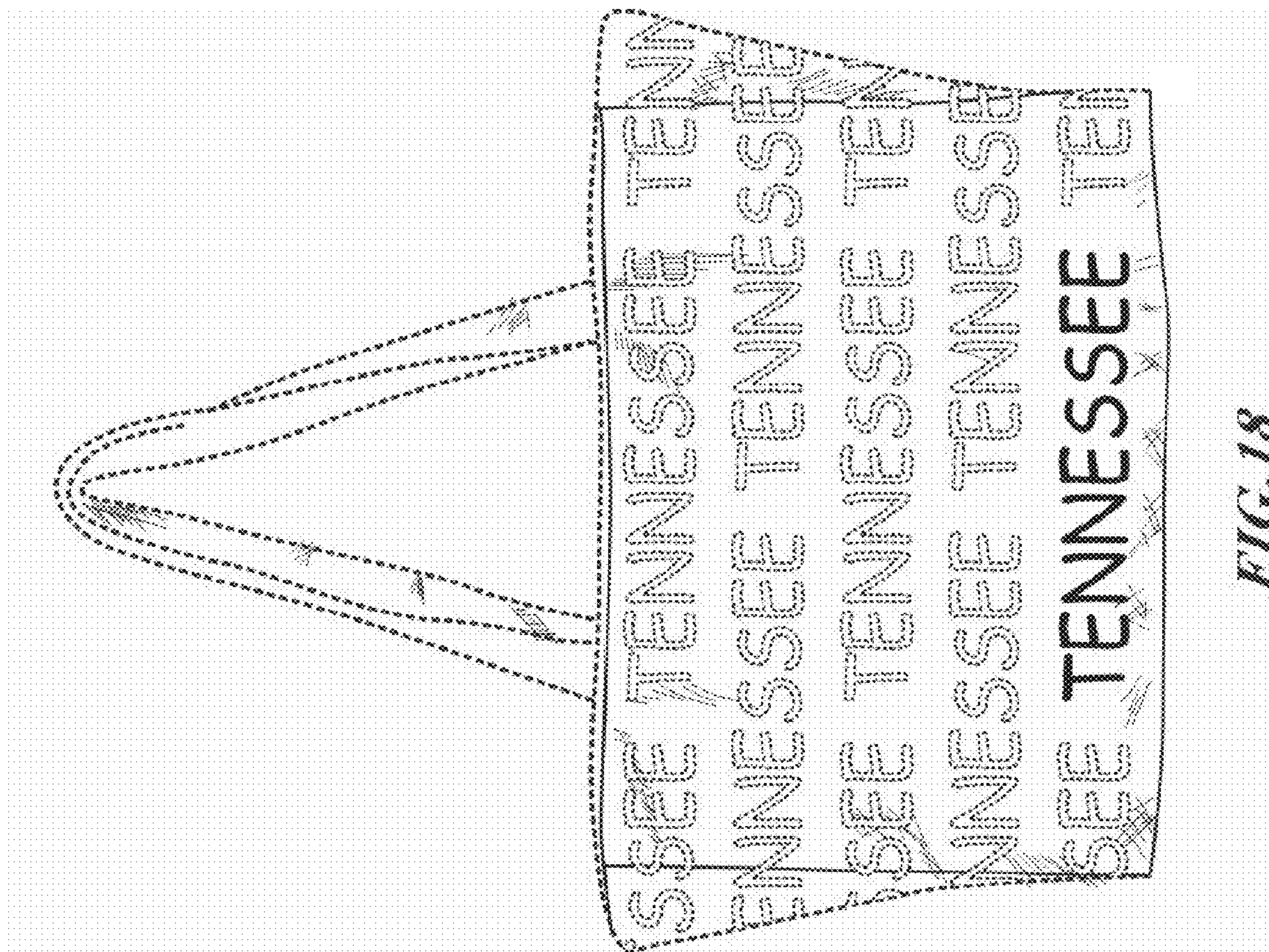

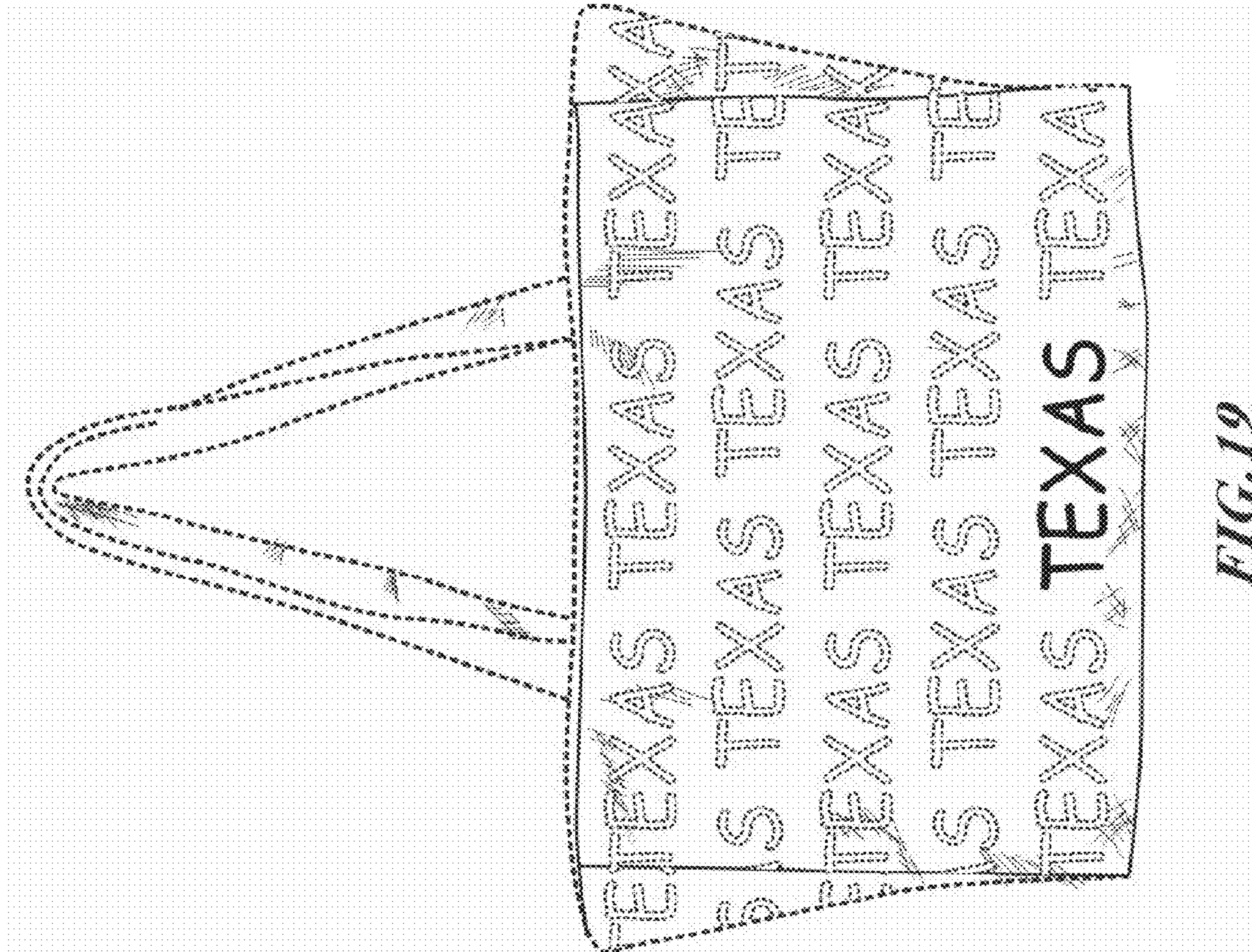

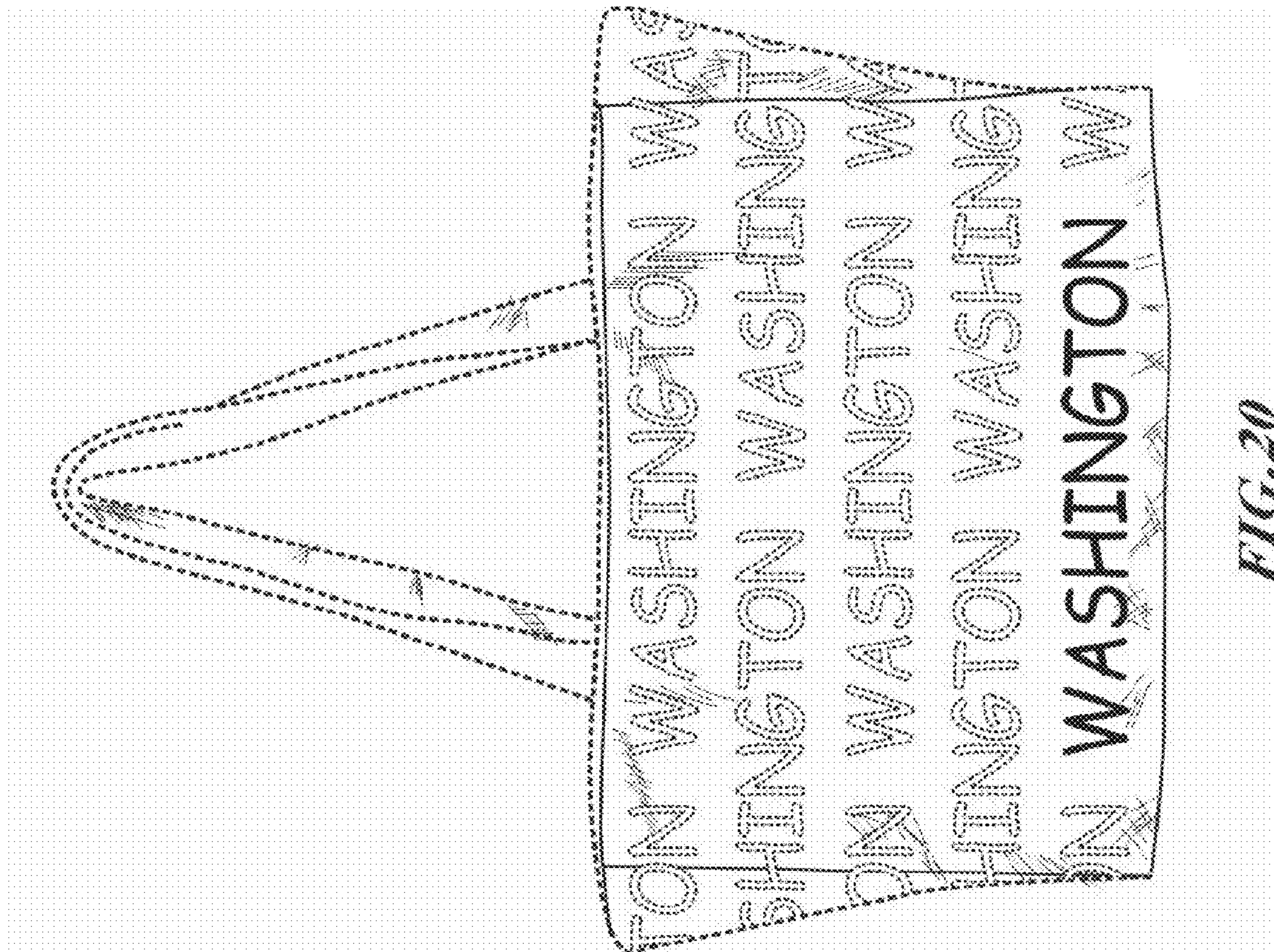

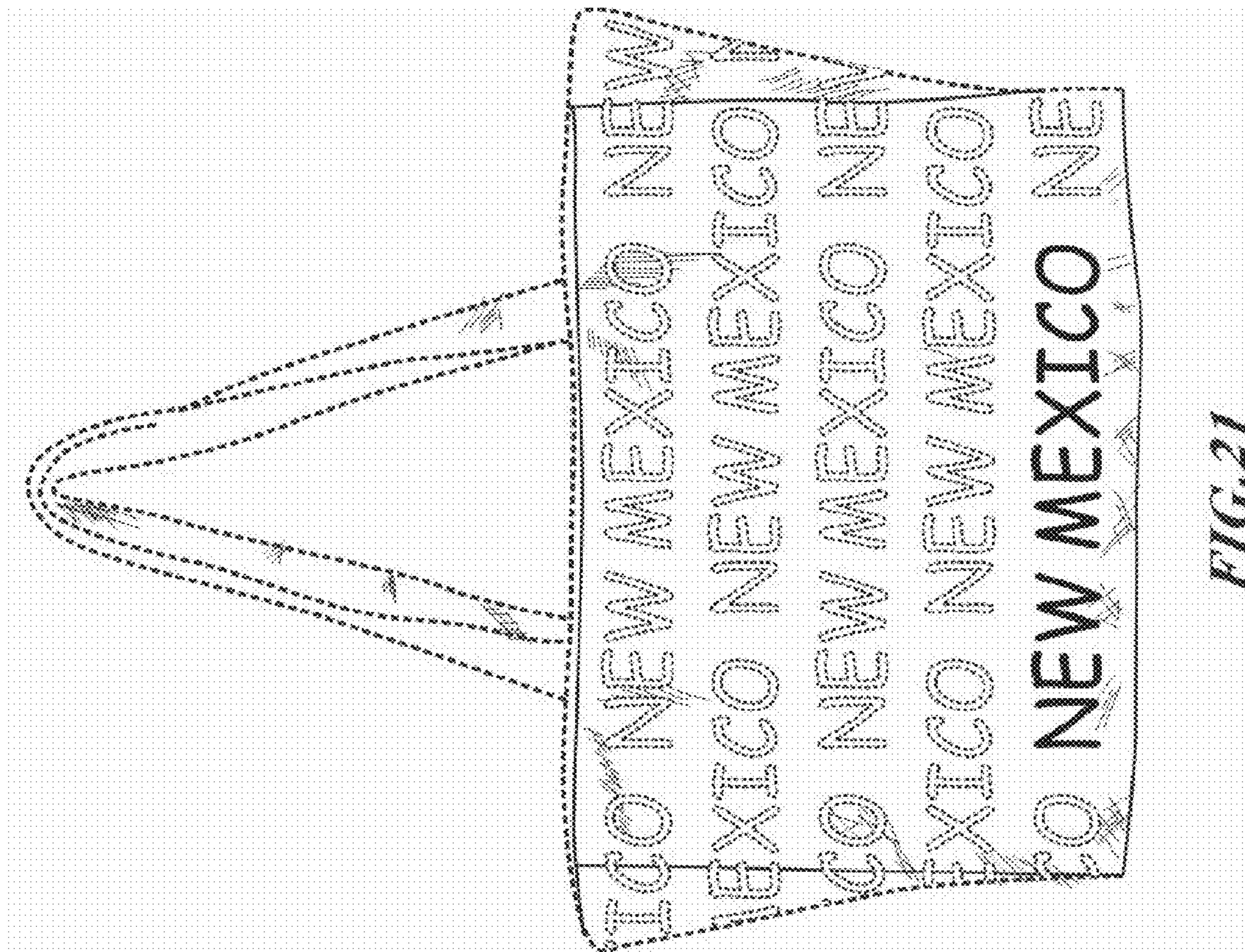

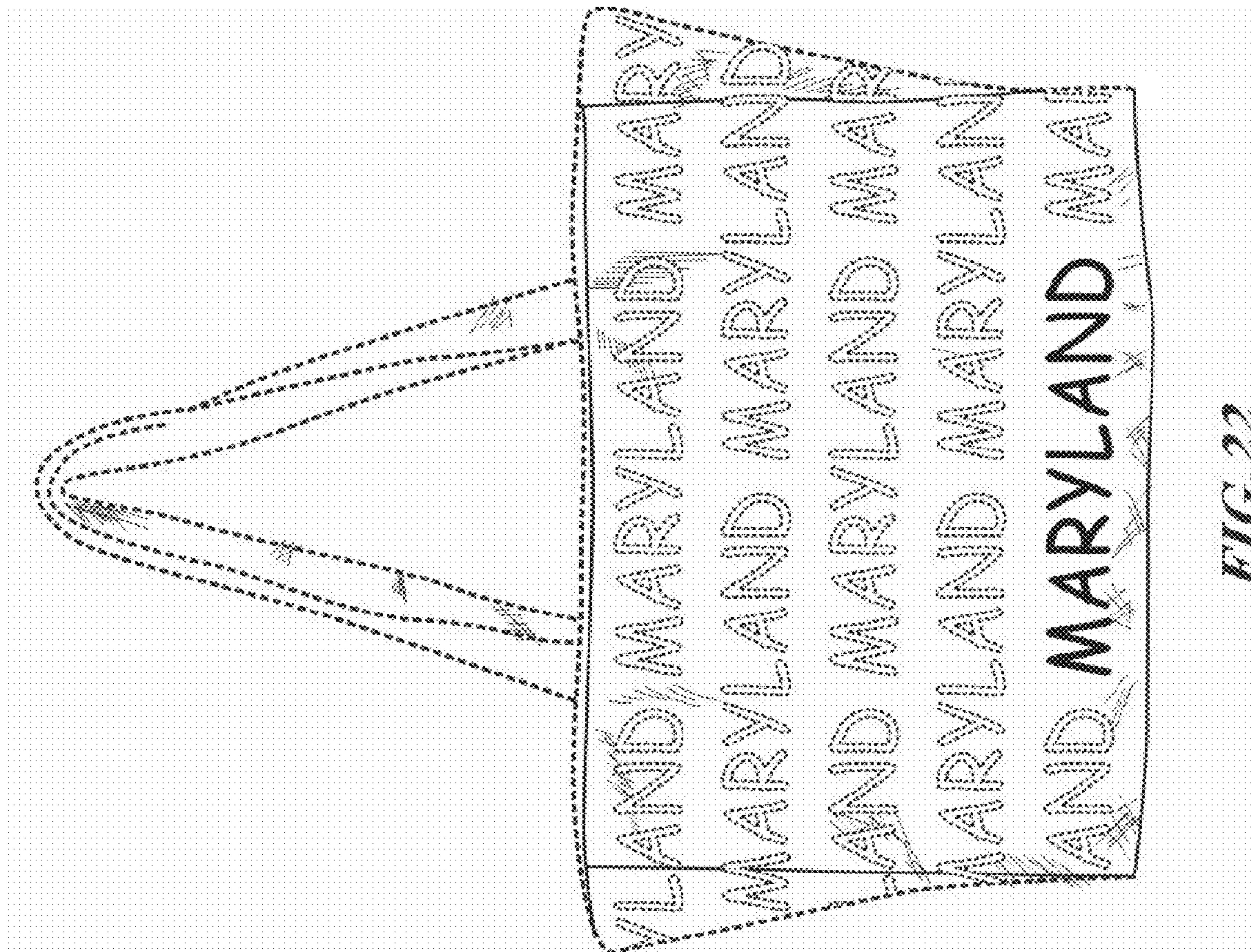

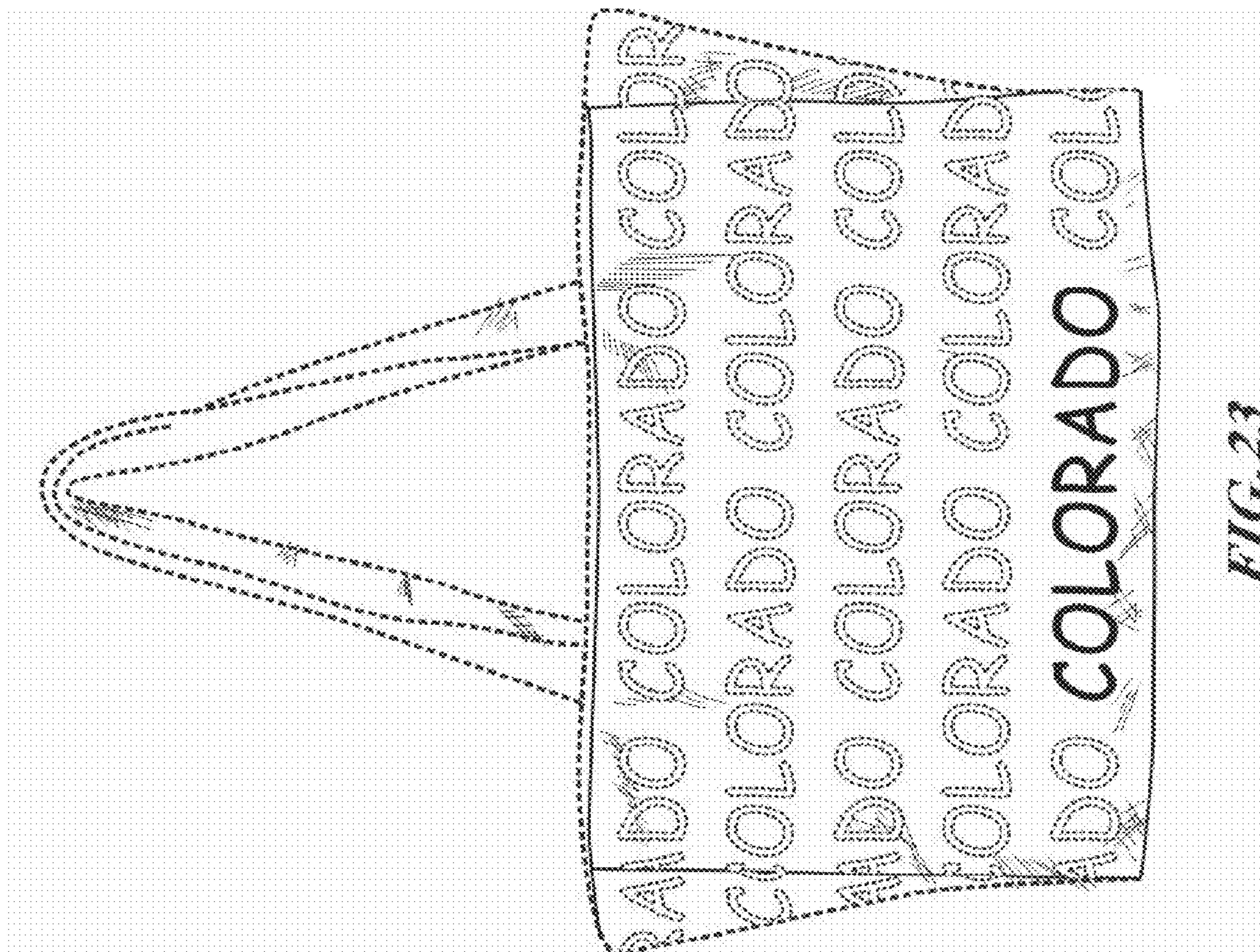

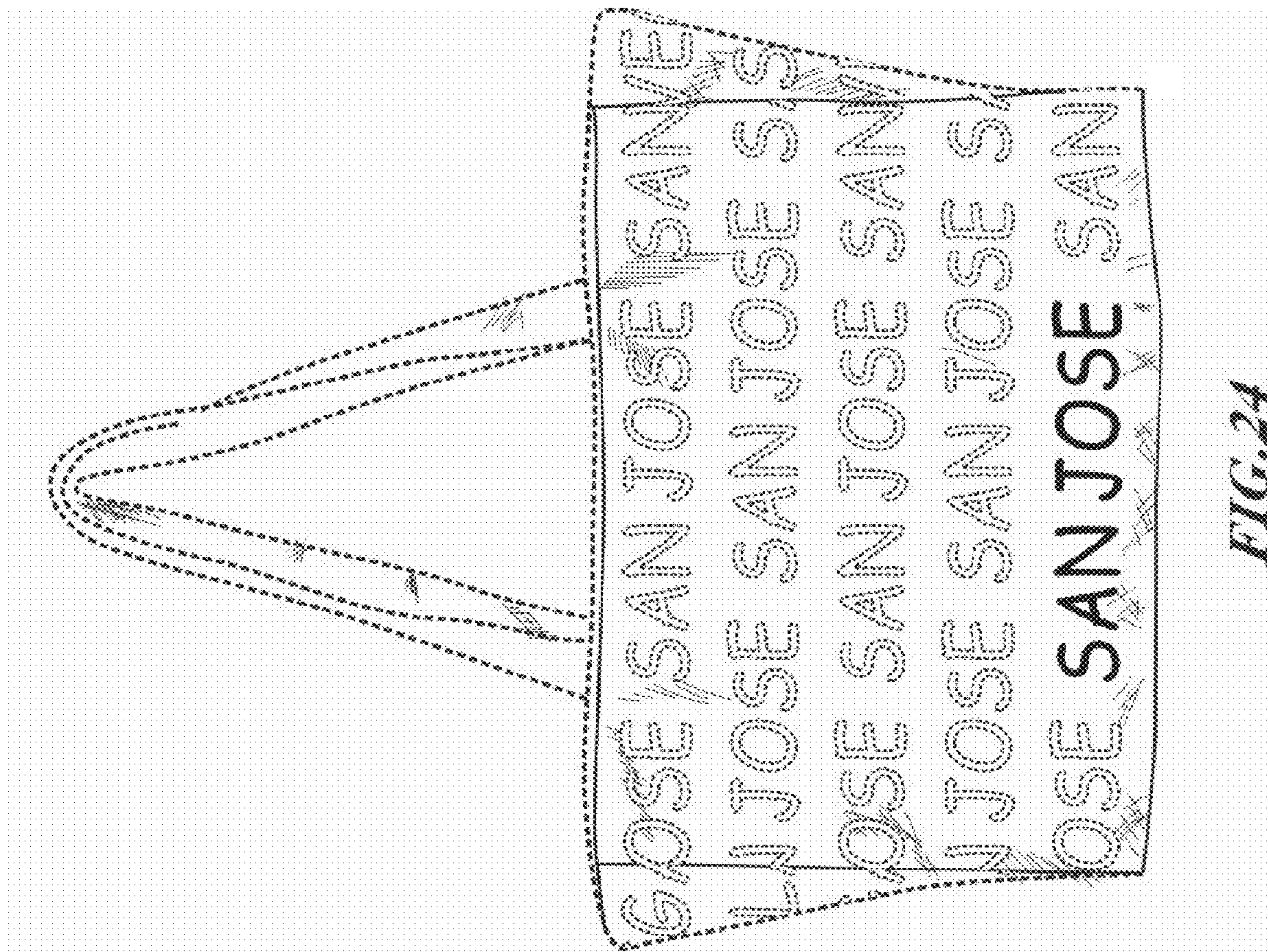

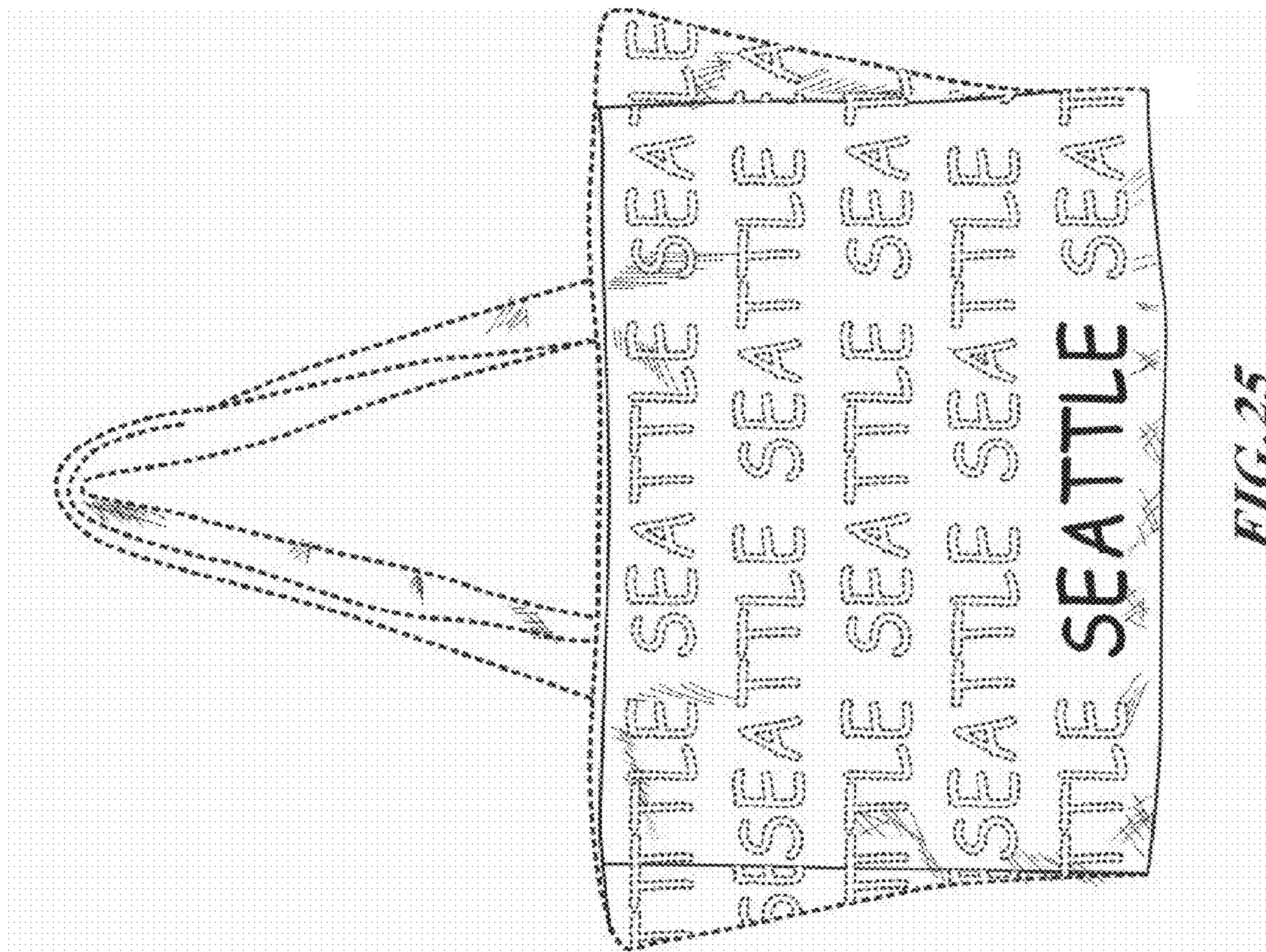

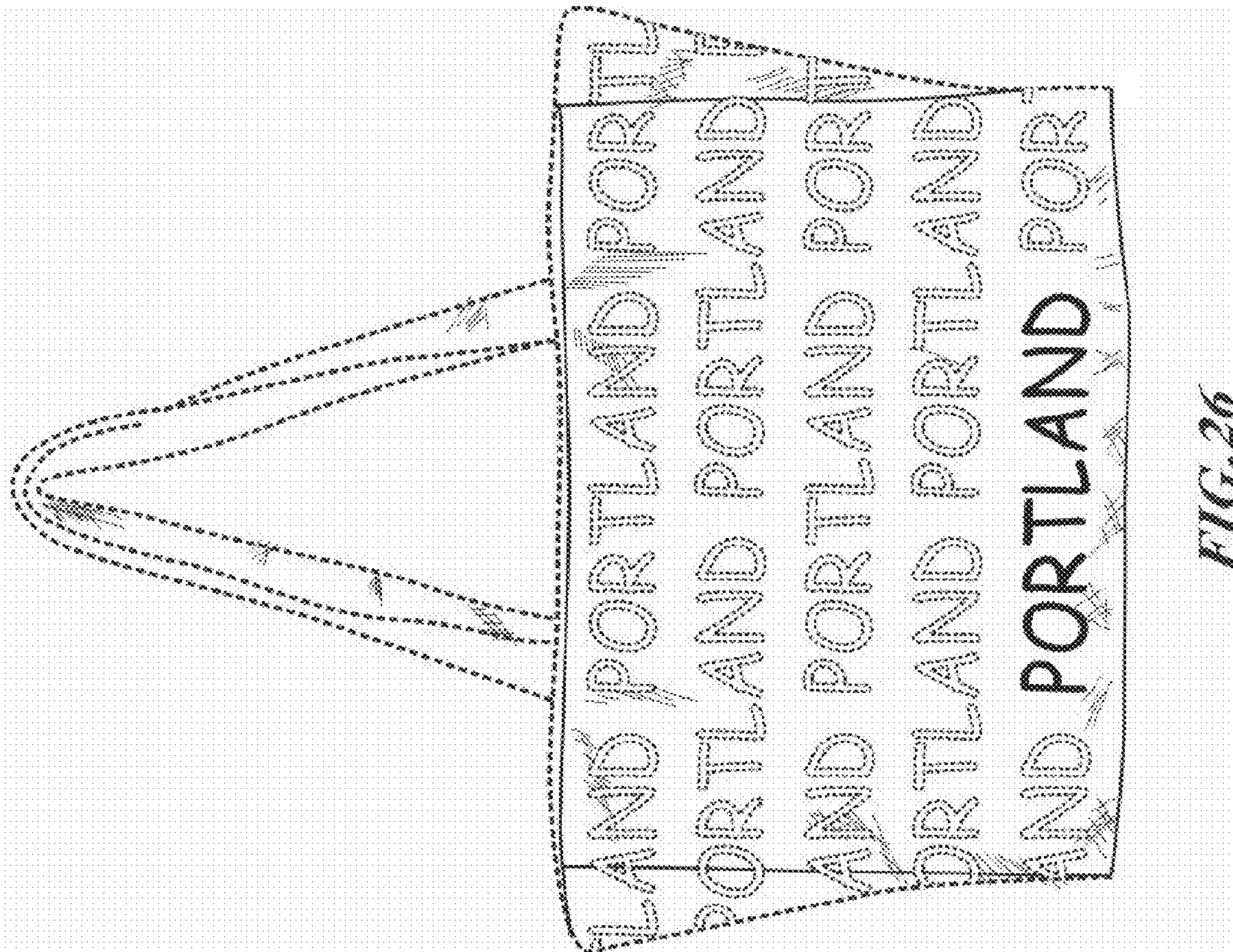

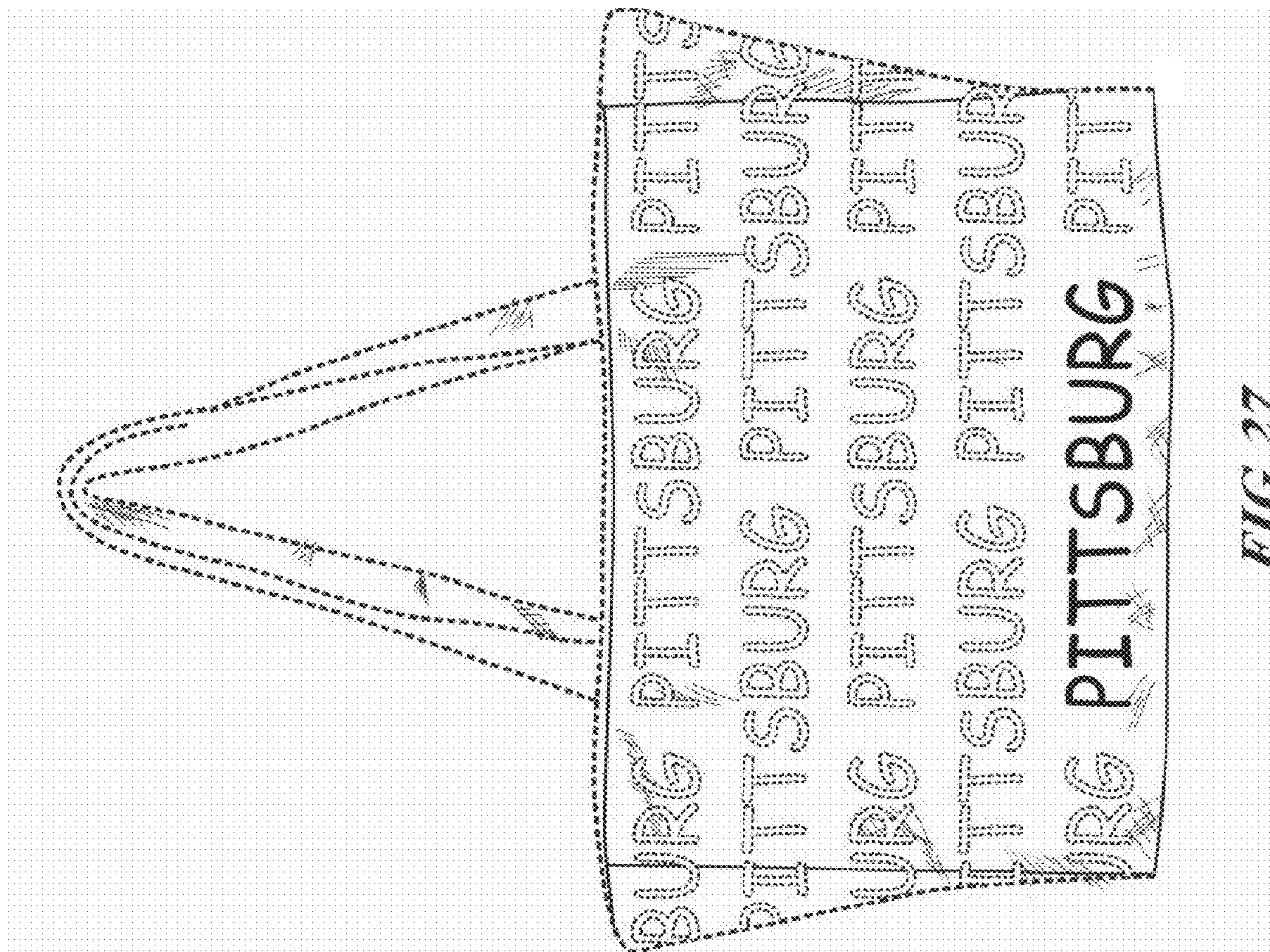

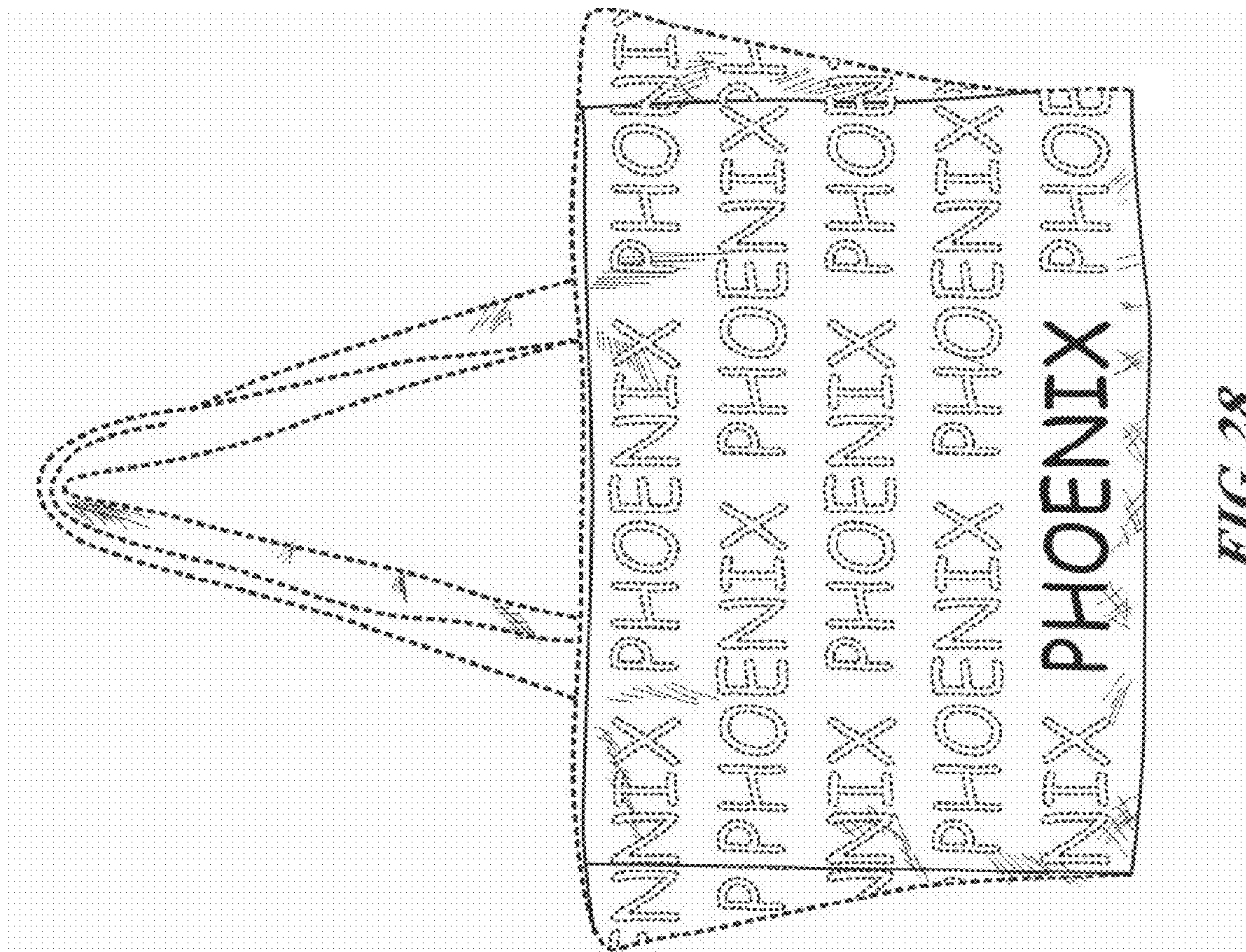

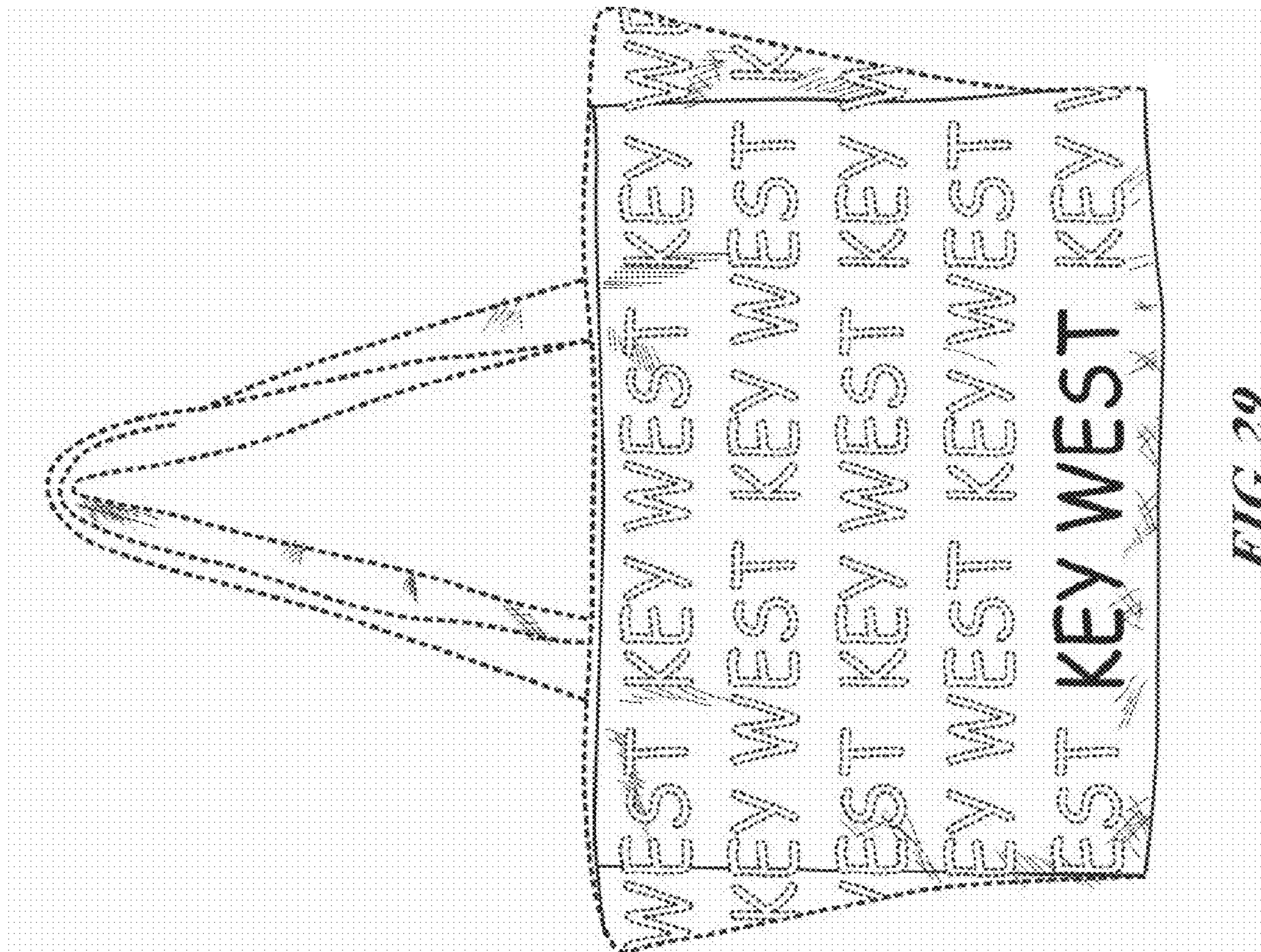

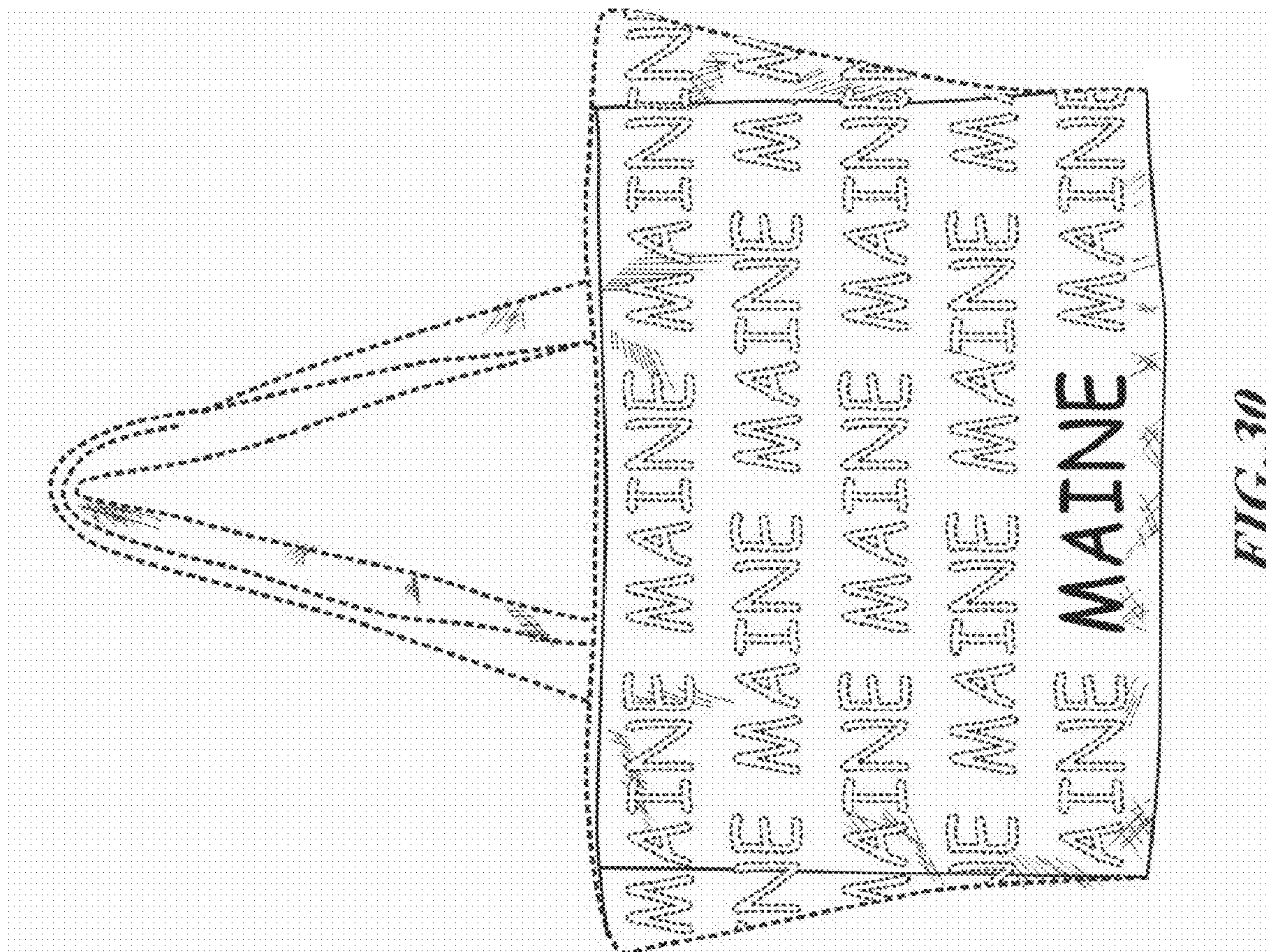

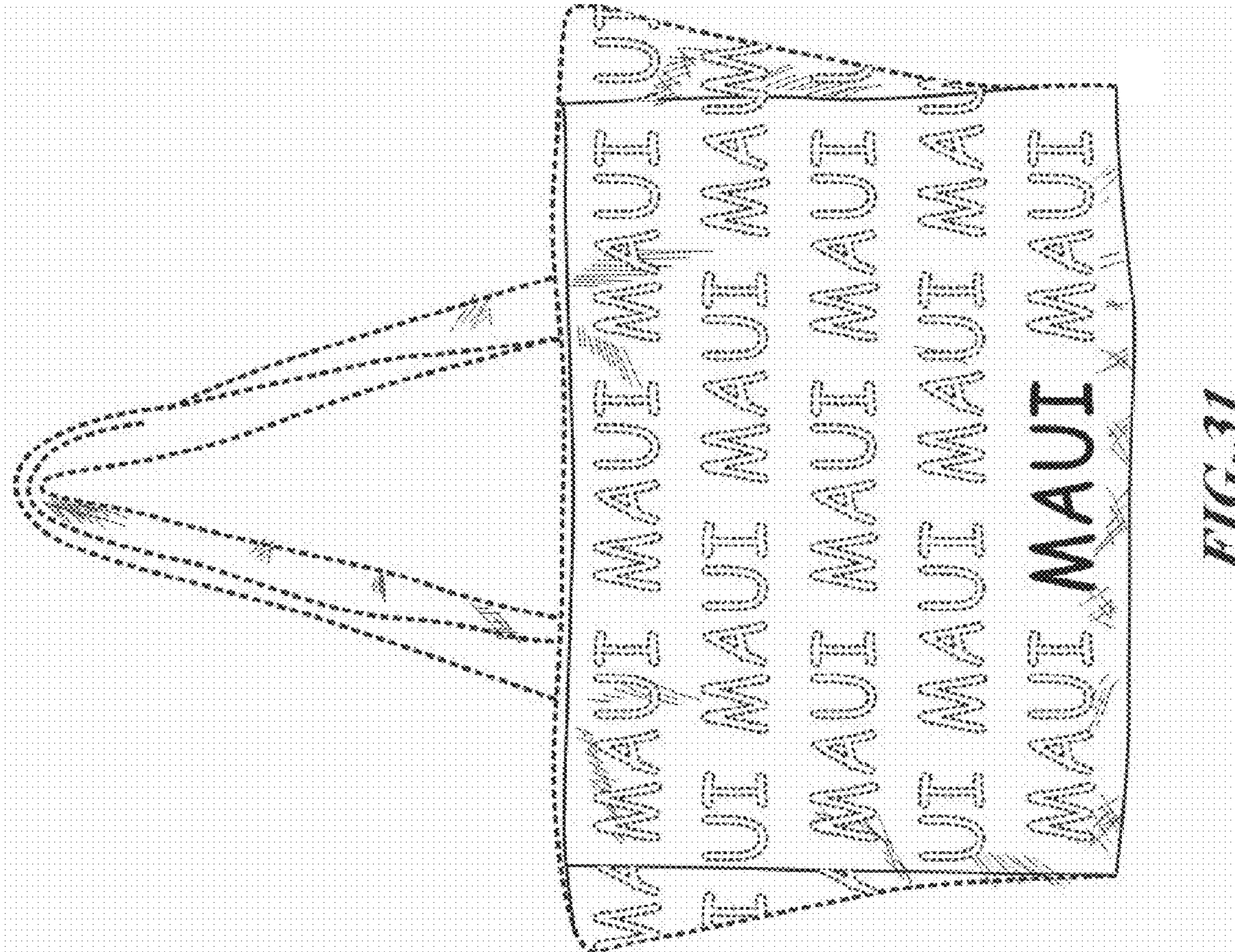
