DESCRIPTION

FIG. 1 is a right side view of our DSLR camera wrap in a wrapped position;

FIG. 2 is a left side view of our DSLR camera wrap in a wrapped position;

FIG. 3 is a front view of our DSLR camera wrap in a wrapped position;

FIG. 4 is a rear view of our DSLR camera wrap in a wrapped position;

FIG. 5 is a top view of our DSLR camera wrap in a wrapped position;

FIG. 6 is a bottom view of our DSLR camera wrap in a wrapped position;

FIG. 7 is a back right perspective view of our DSLR camera wrap in a wrapped position;

FIG. 8 is a right side view of our DSLR camera wrap in a wrapped position with the front portion of the wrap in an extended position;

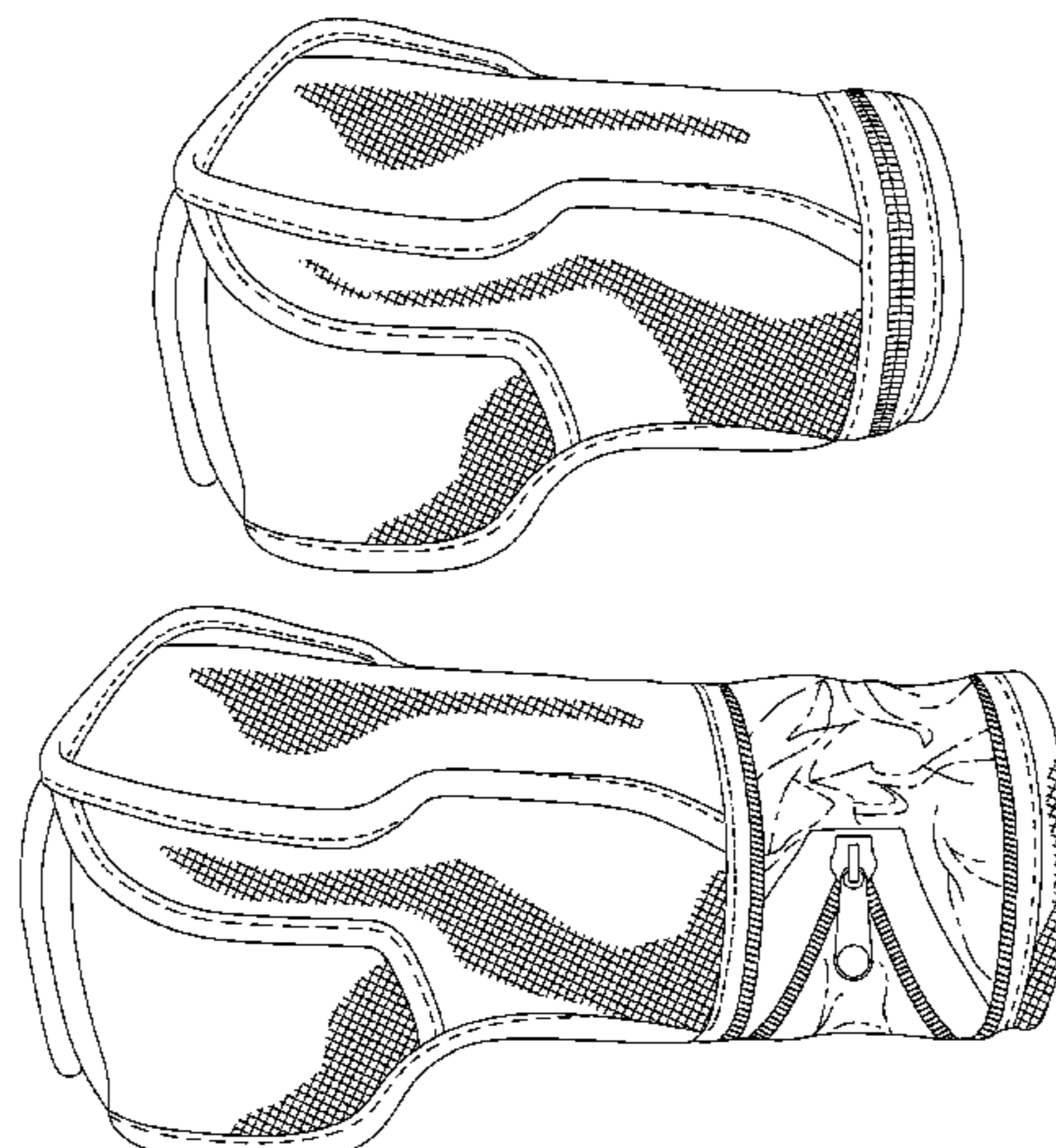
FIG. 9 is a top view of our DSLR camera wrap in an unwrapped position showing the interior of the DSLR camera wrap; and,

FIG. 10 is a right view of our DSLR camera wrap in an unwrapped position showing the exterior of the DSLR camera wrap.

Straps are shown in dotted line in FIGS. 5, 6 and 7 and forms no part of our design.

The broken lines on the surface of the design throughout the views are understood to represent stitching. The broken lines showing the straps, on the other hand, are understood to represent a portion of the design that forms no part of the claim.

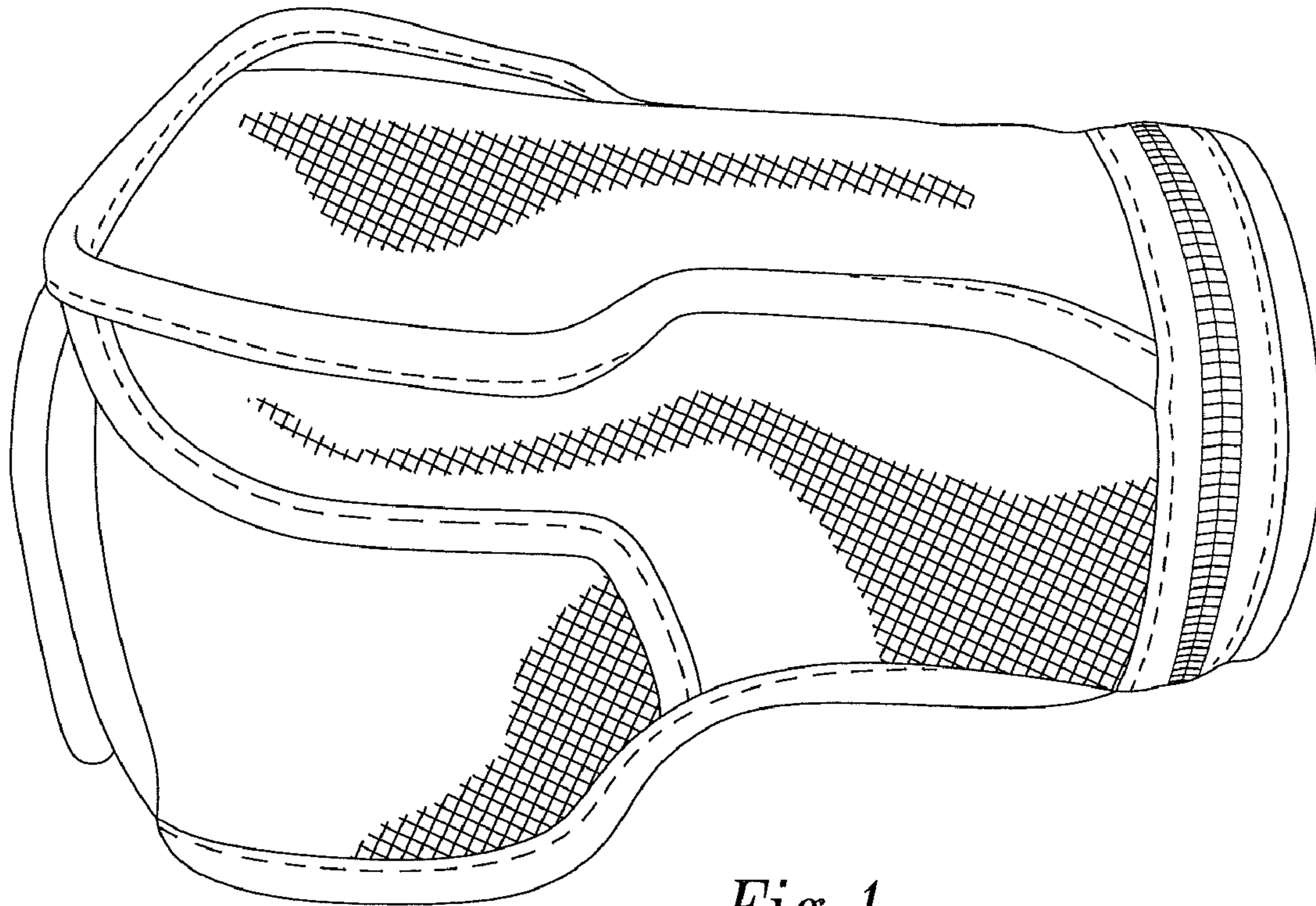

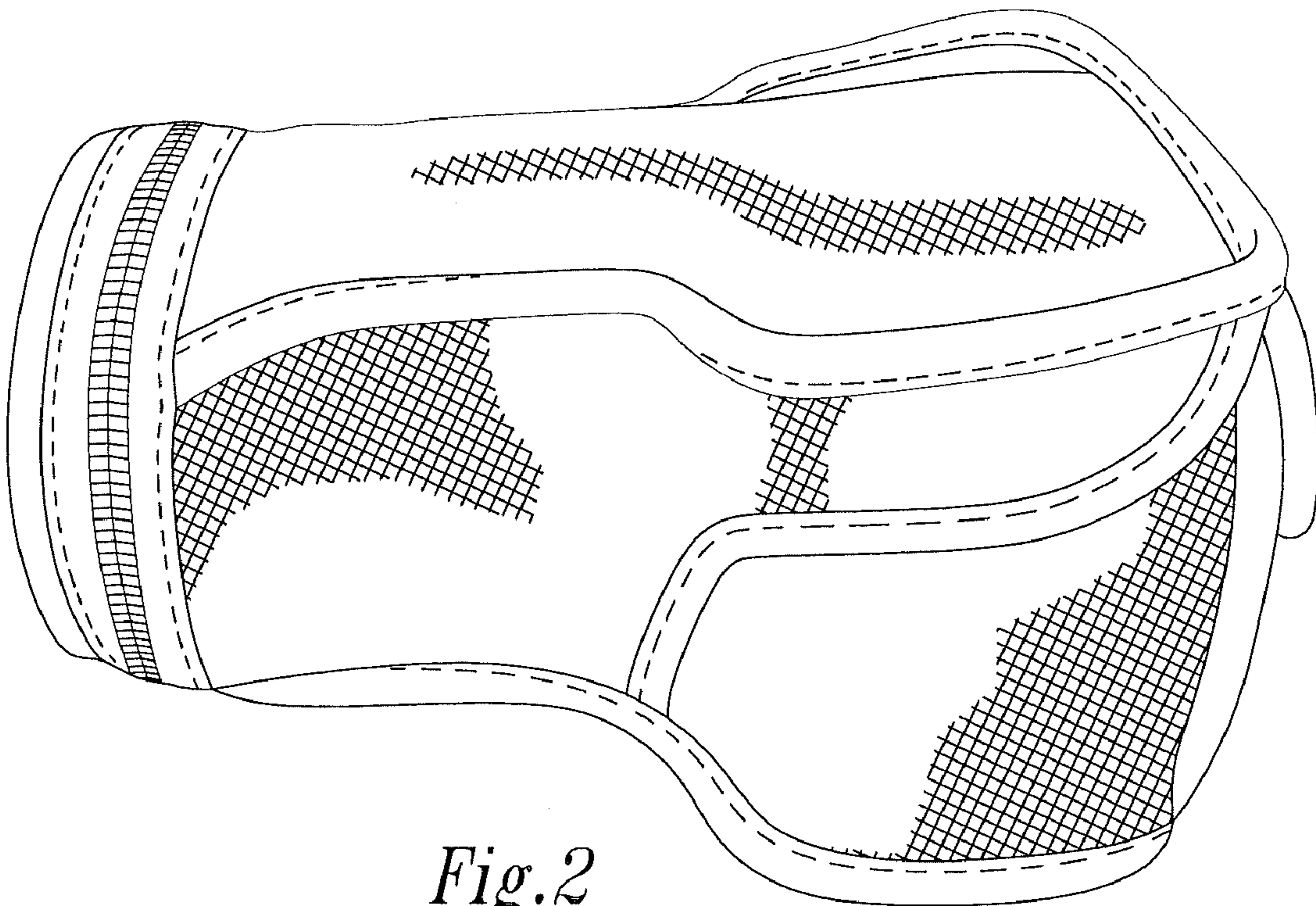

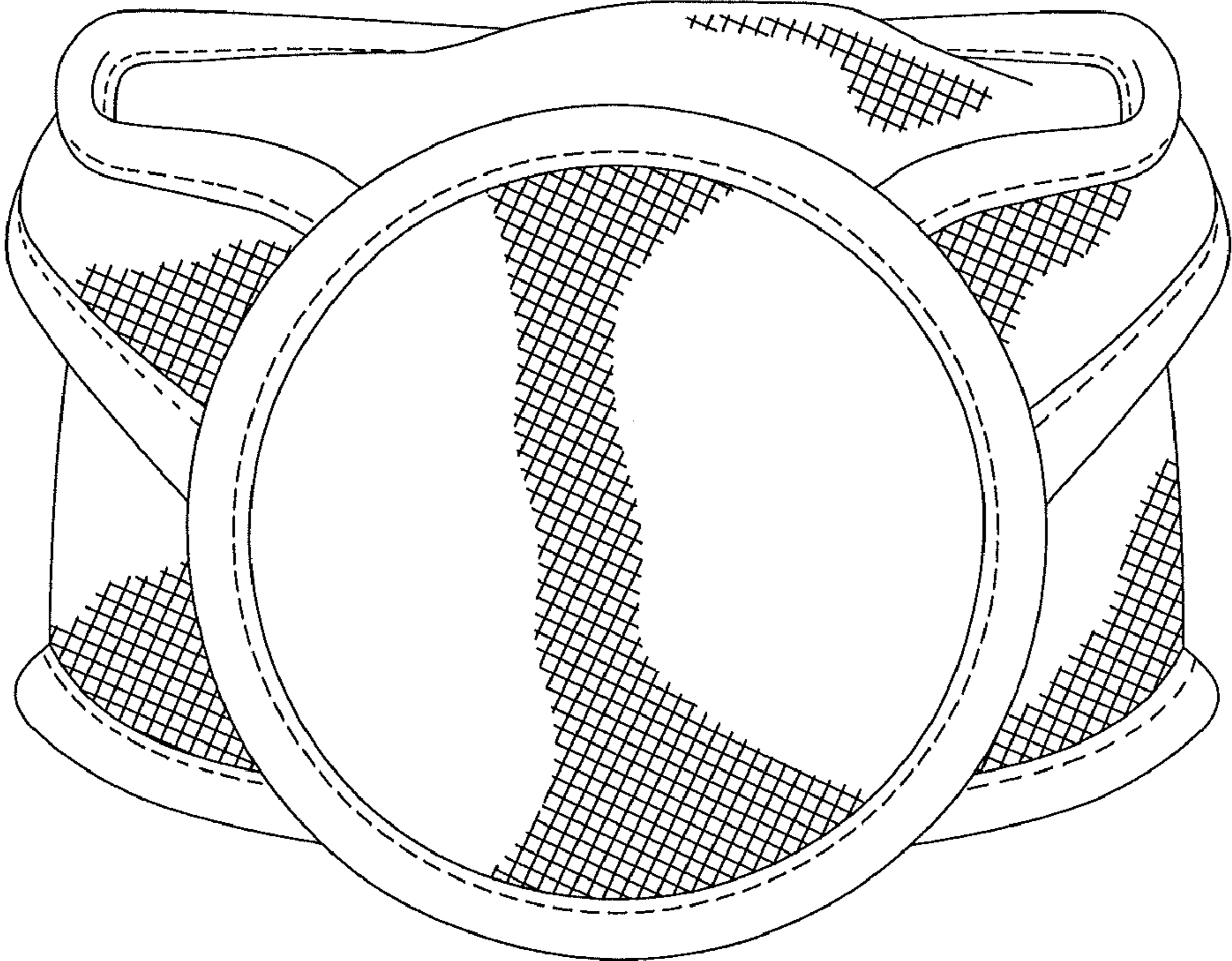

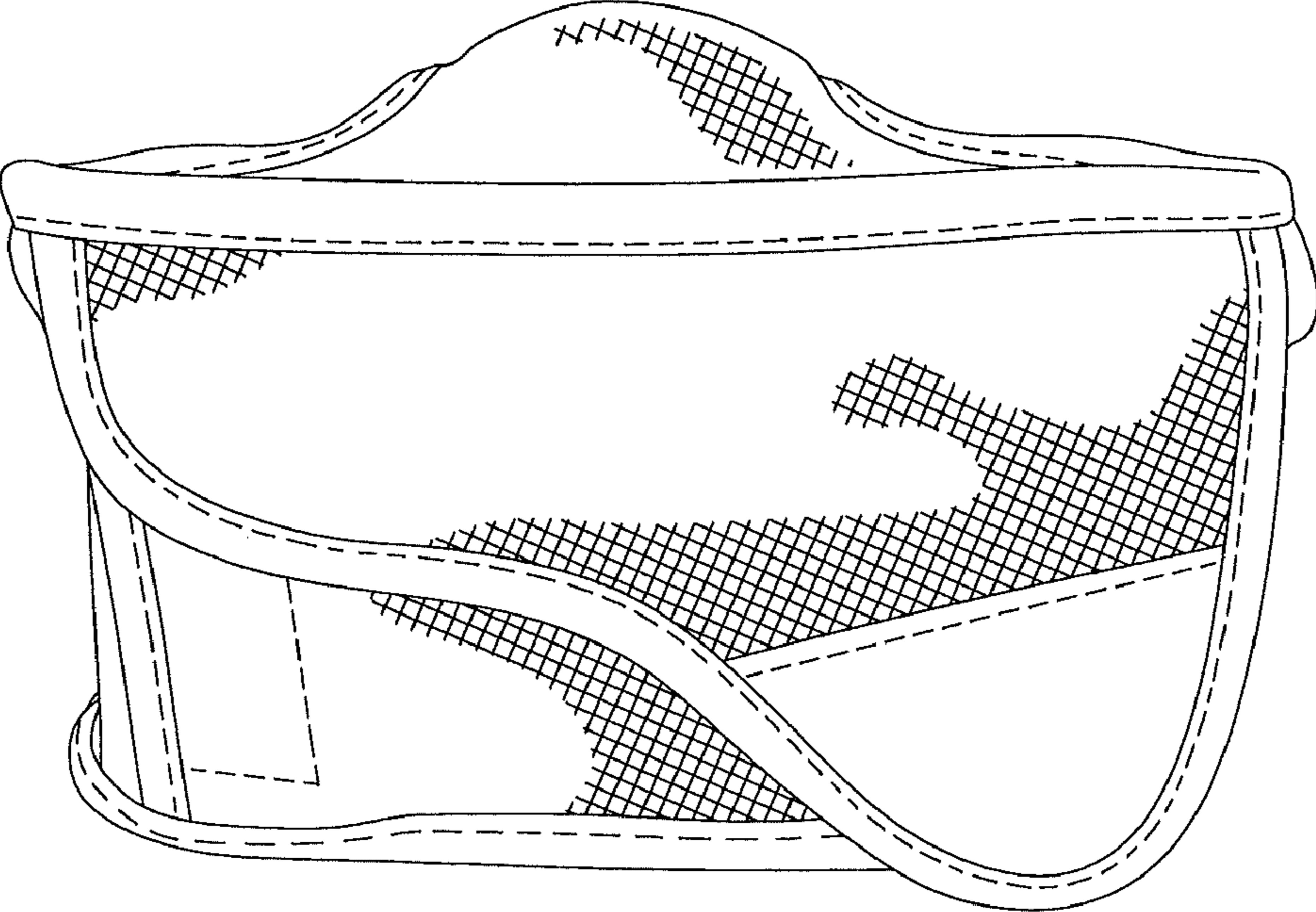

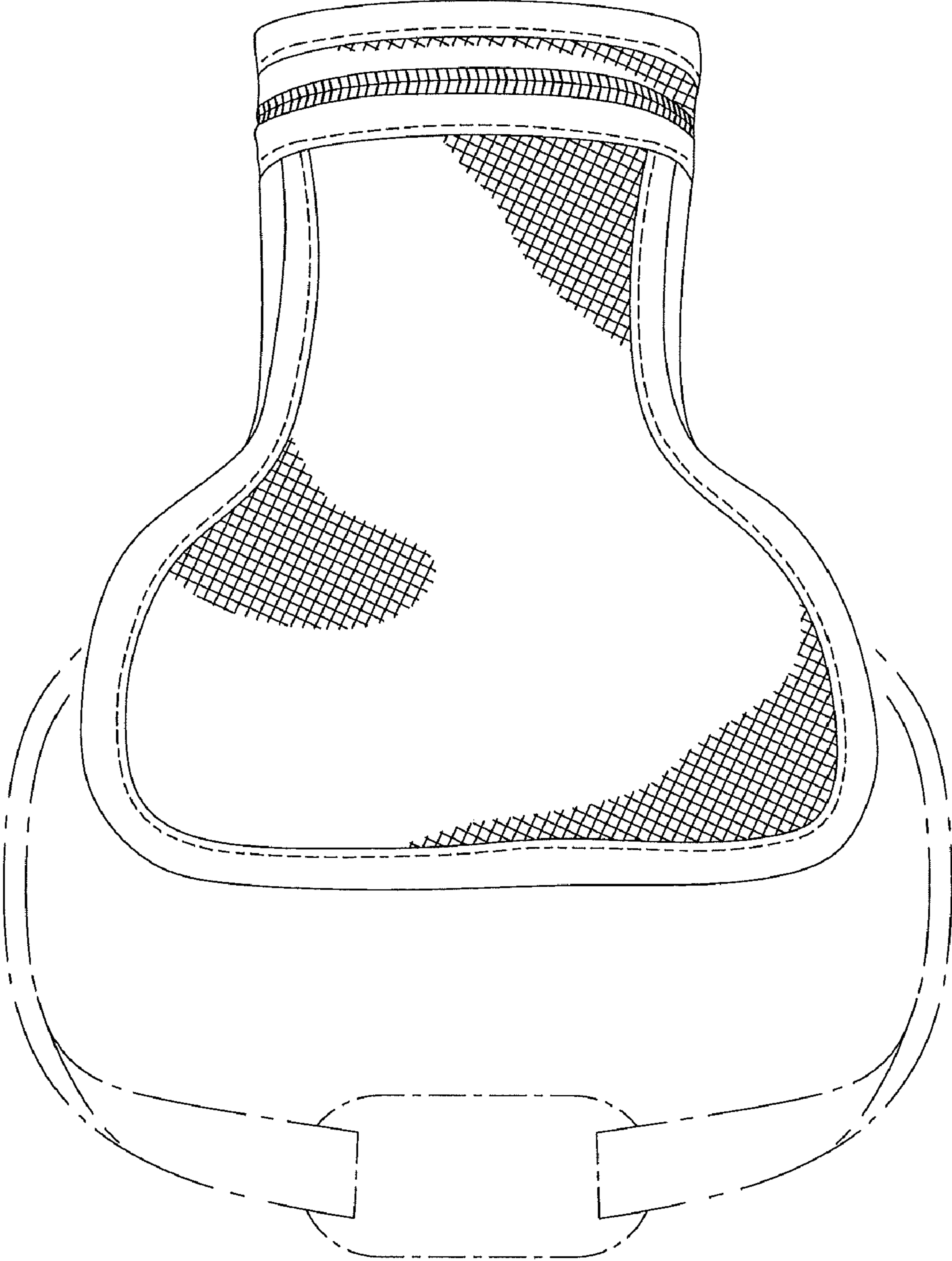

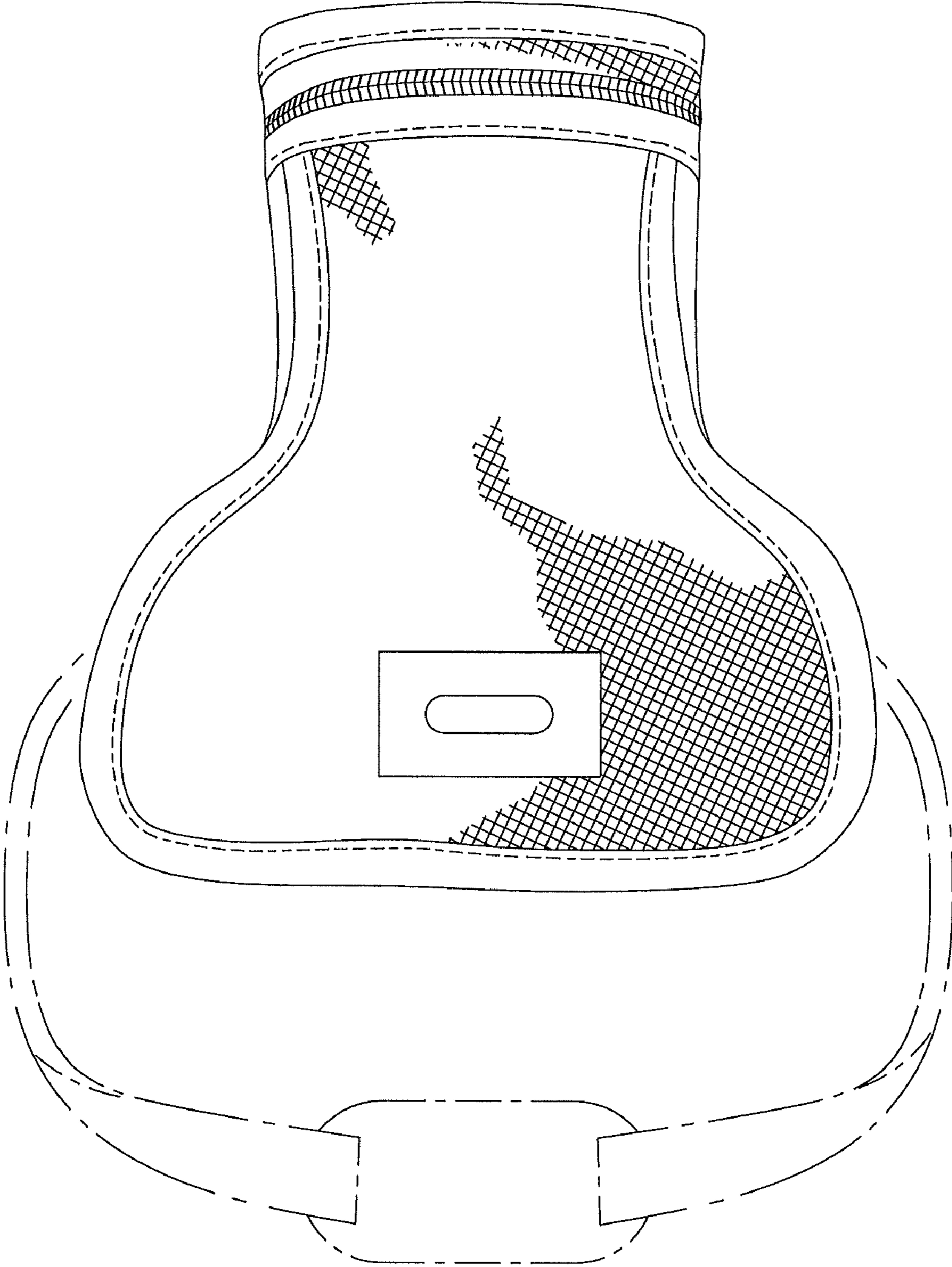

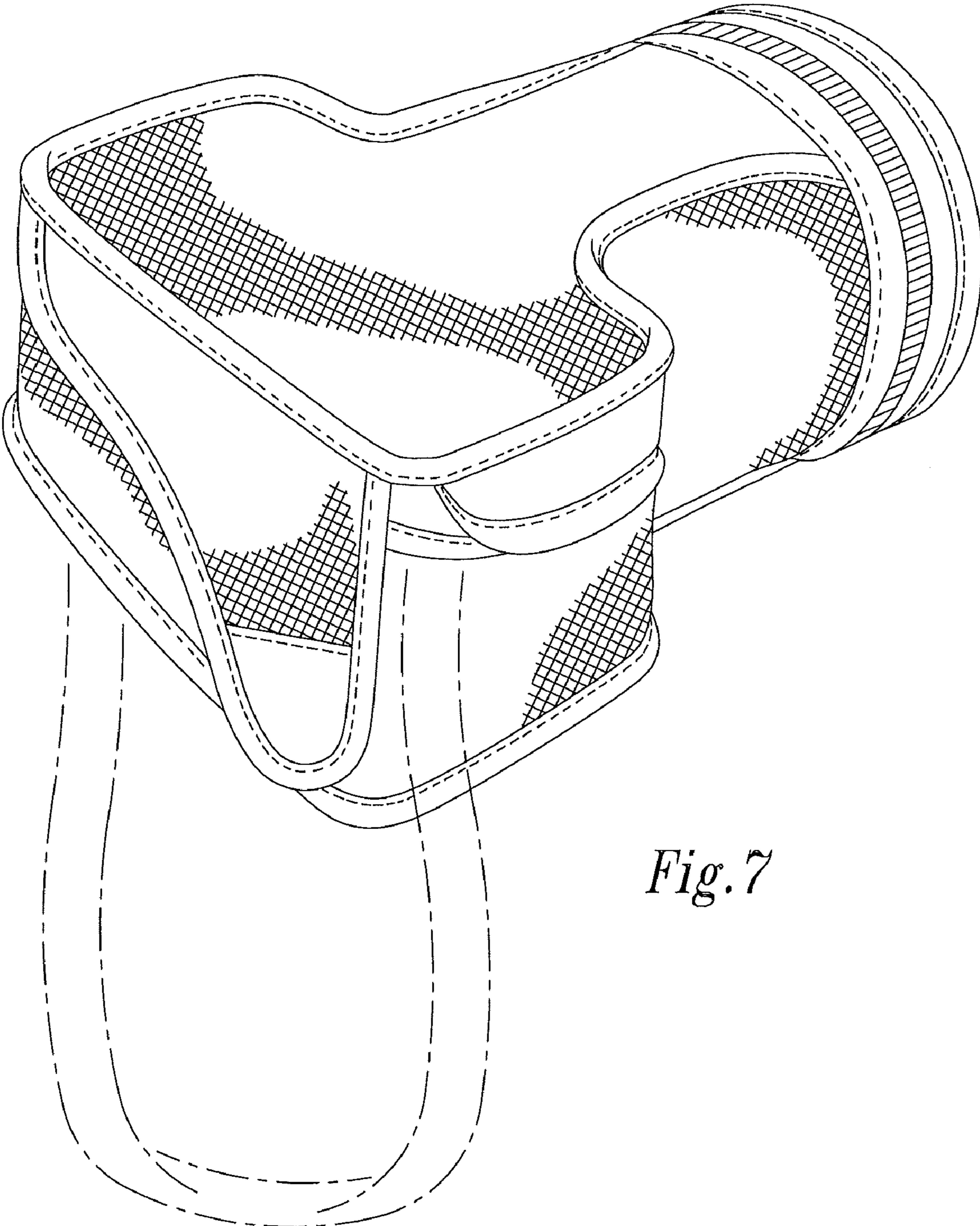

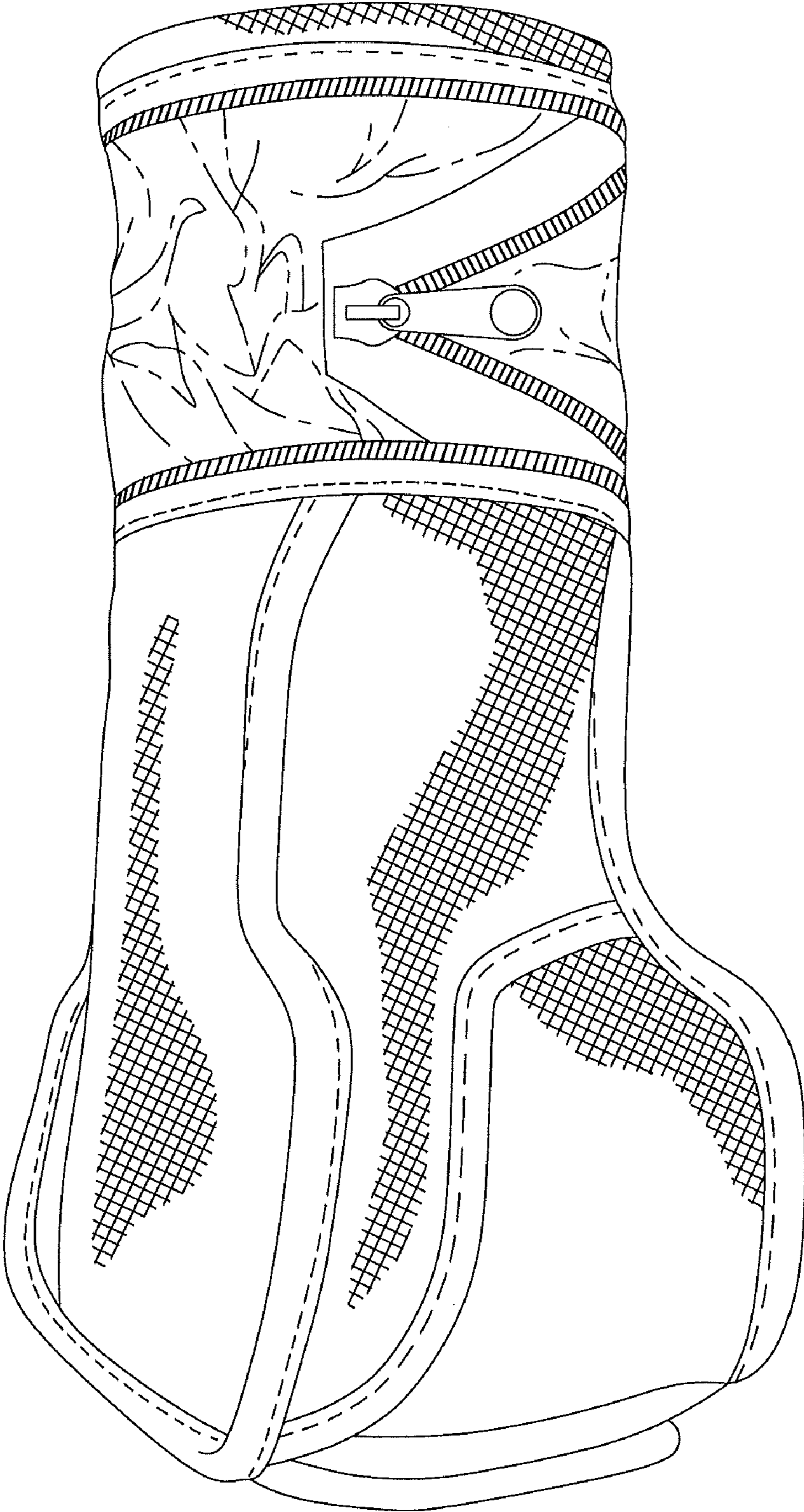

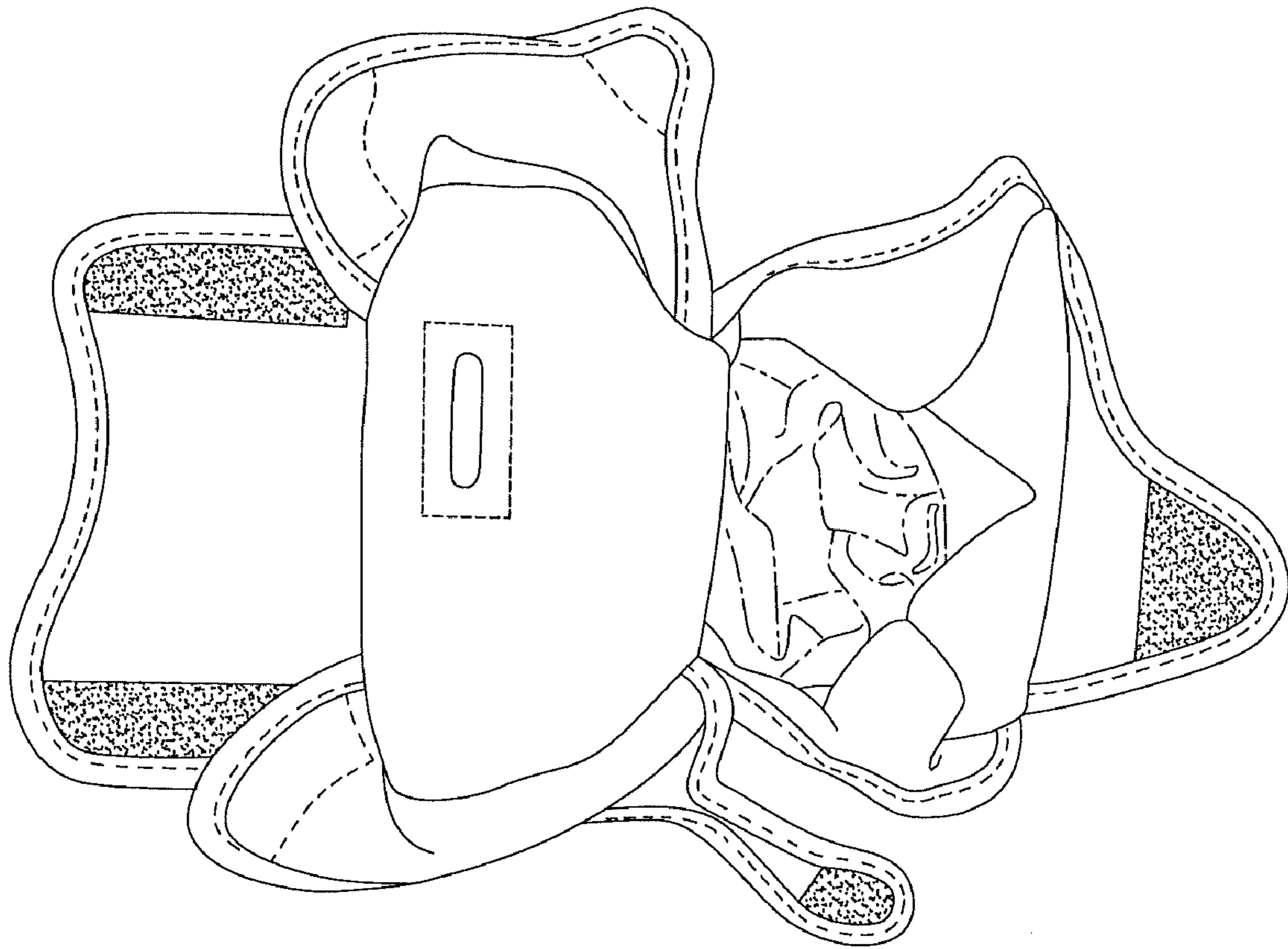

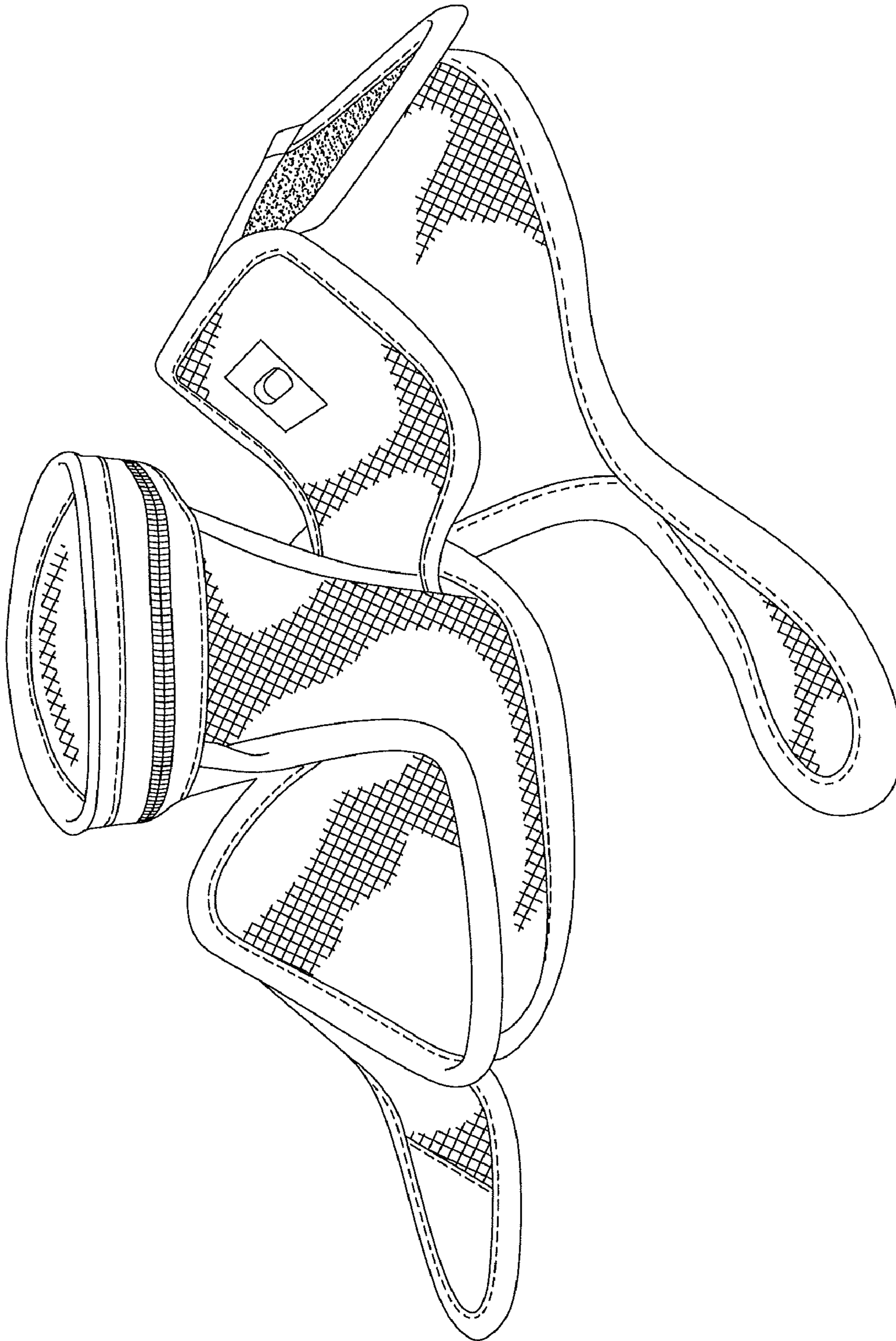
