FIG. 4 is a right plan view of the inflatable bed with headboard of the present invention;

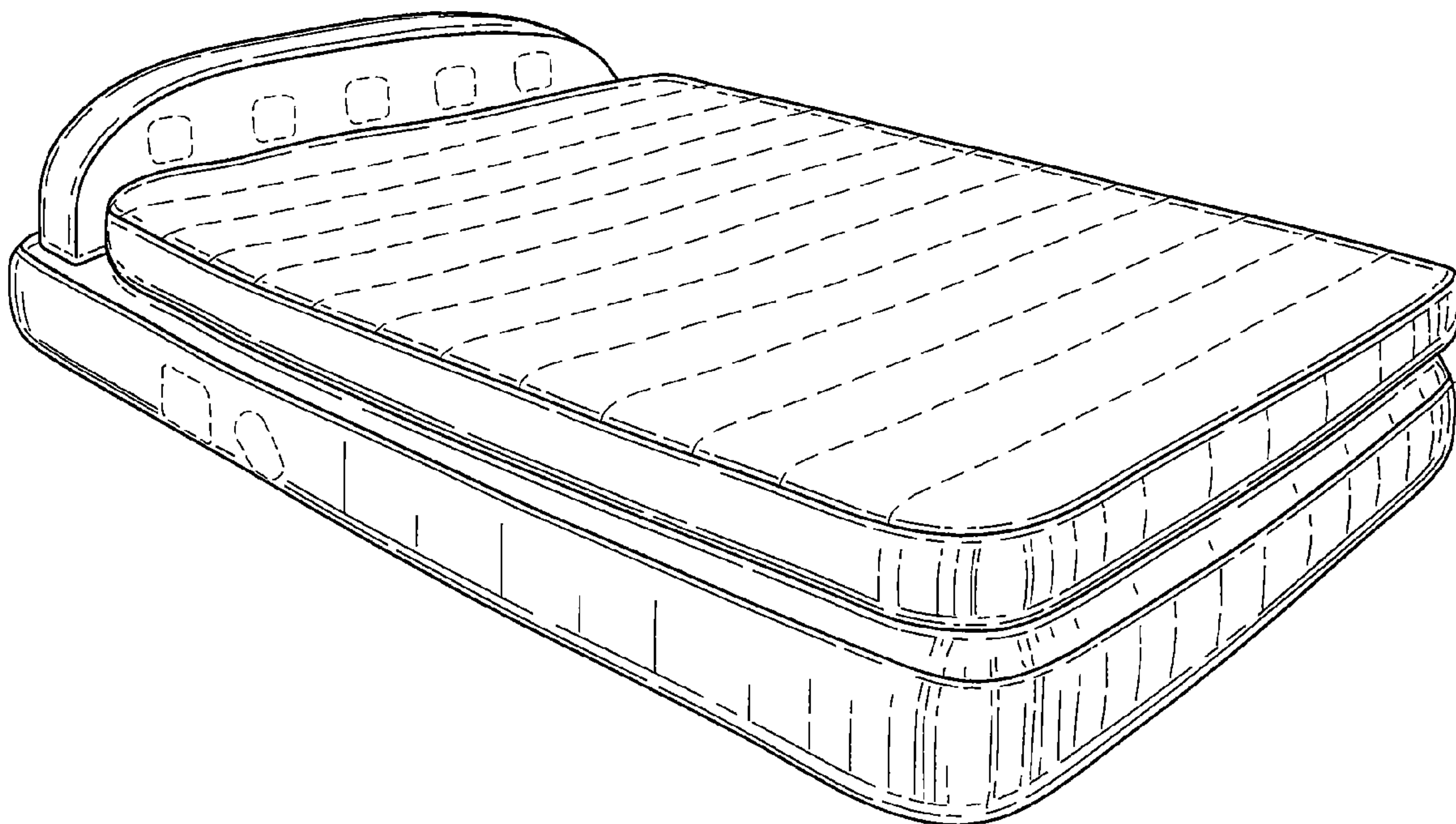
FIG. 5 is a left plan view of the inflatable bed with headboard of the present invention;

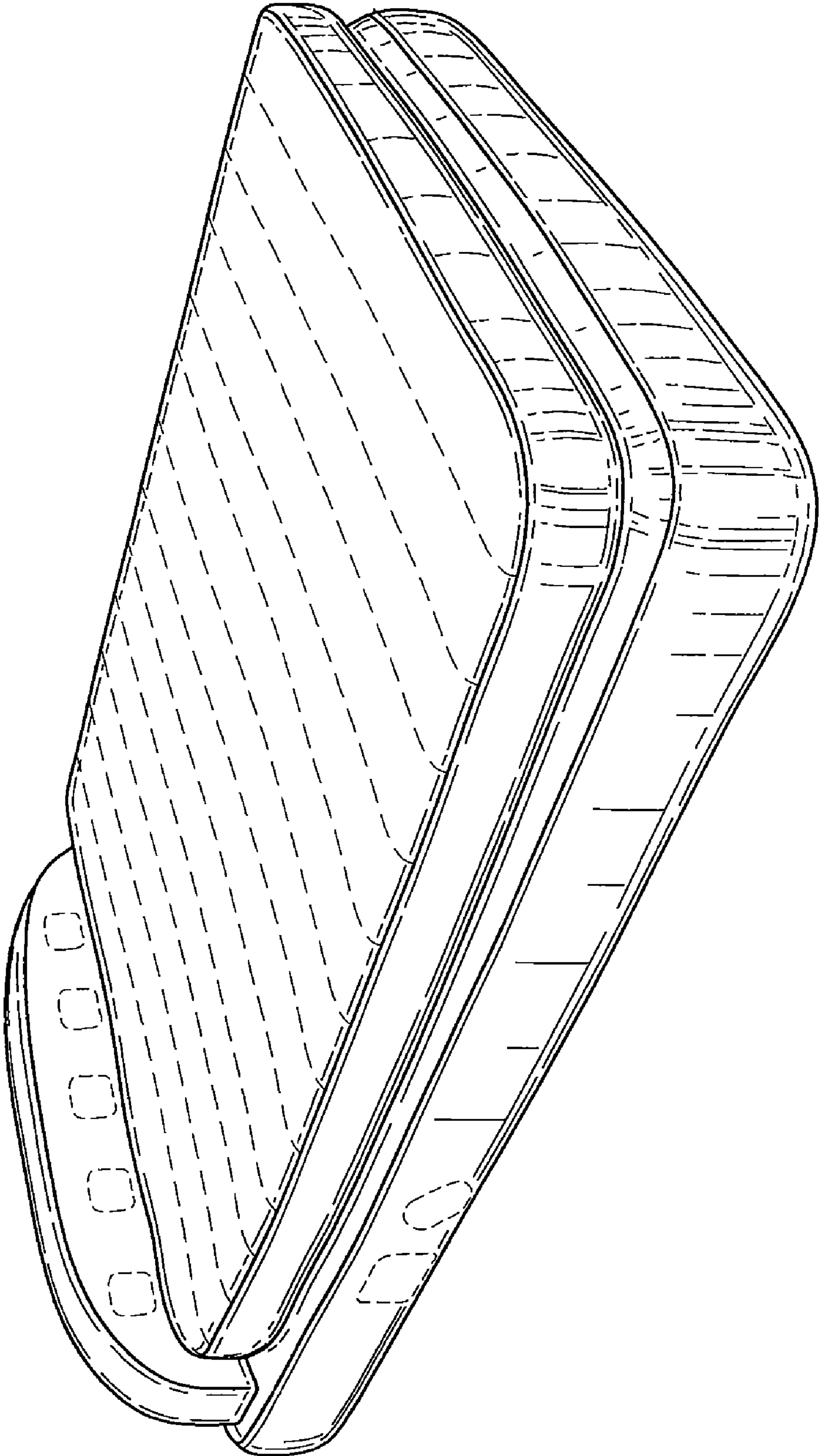

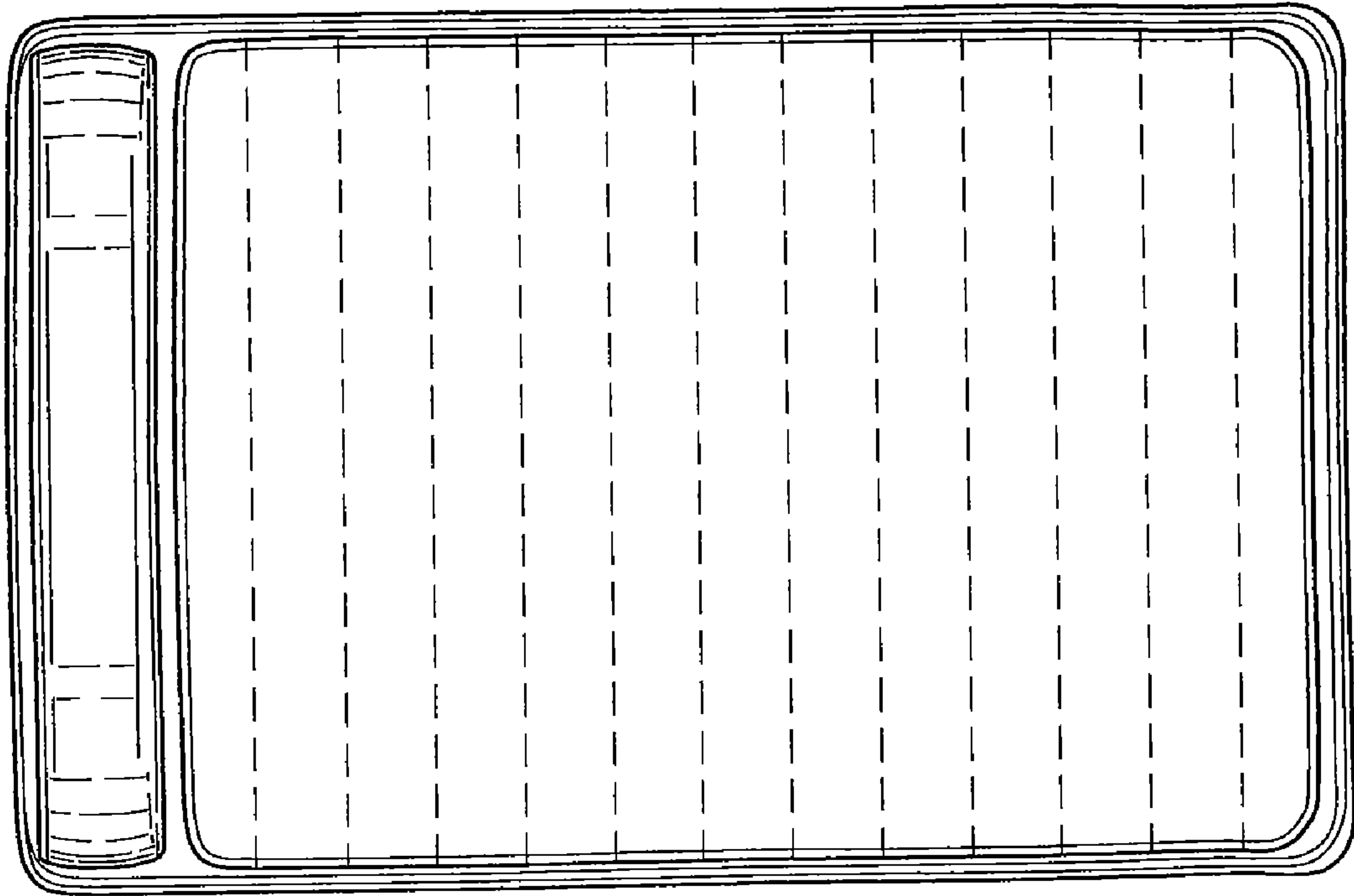

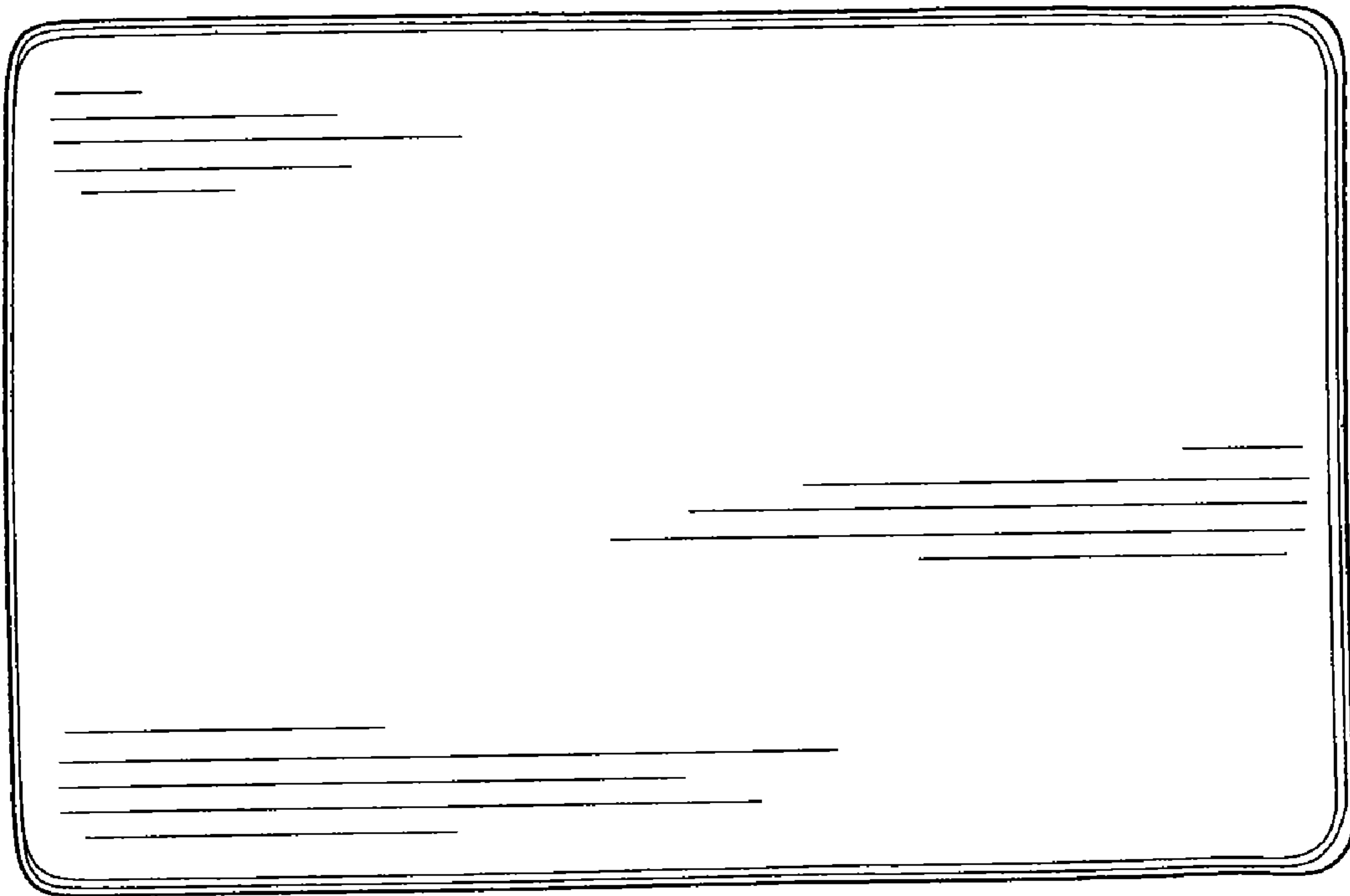

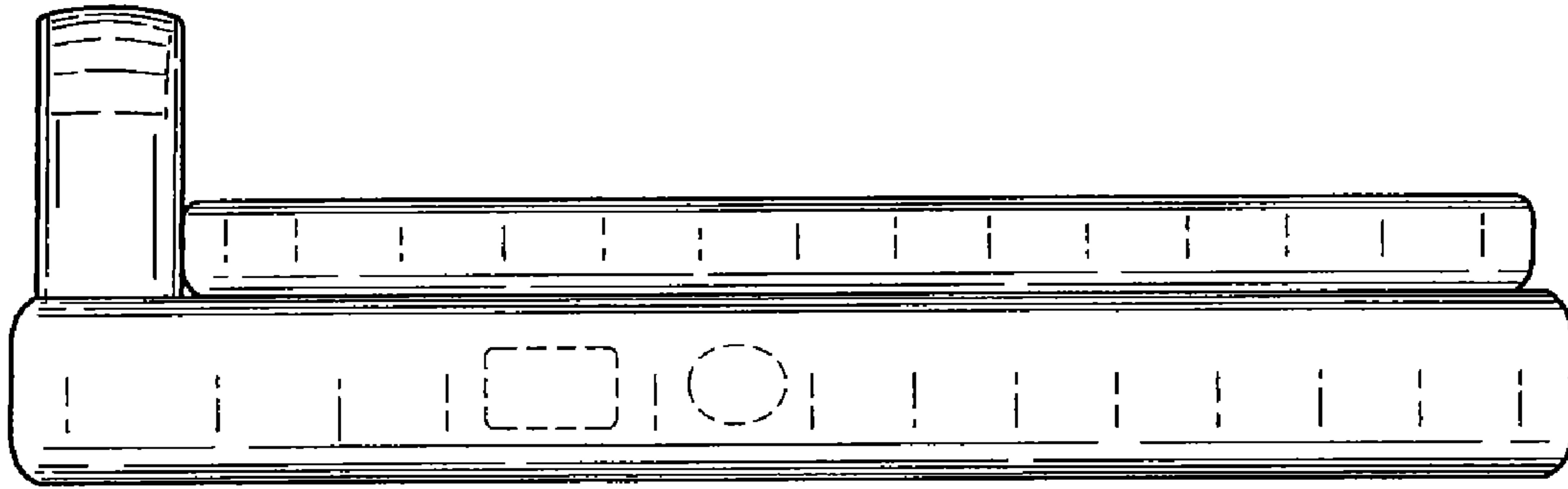

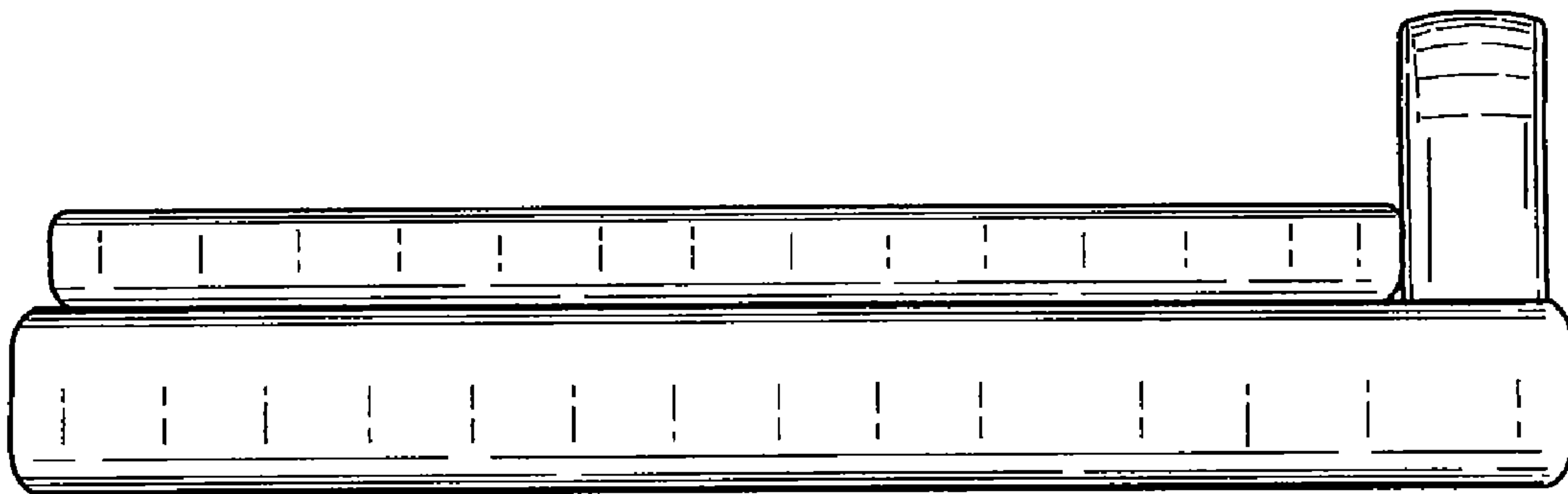

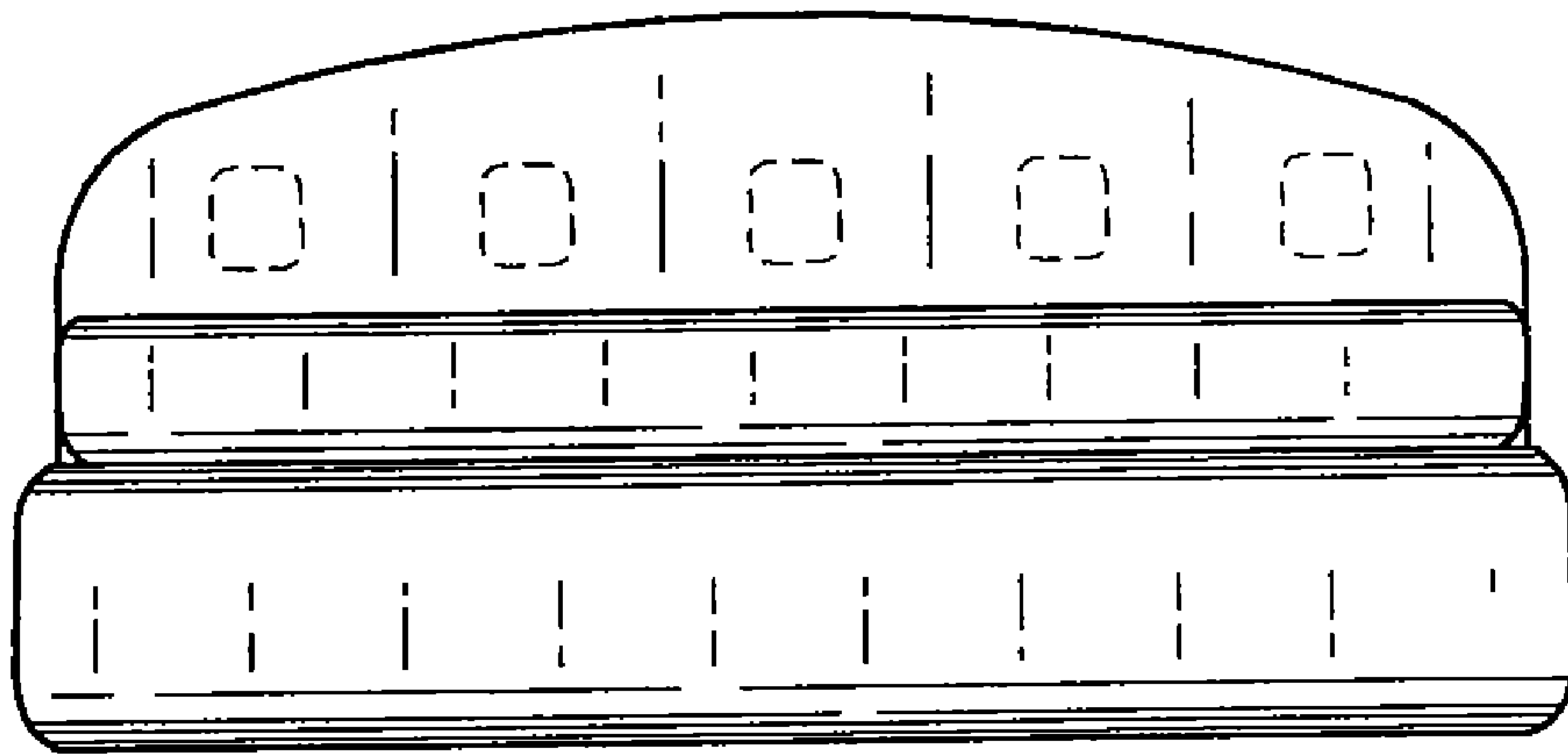

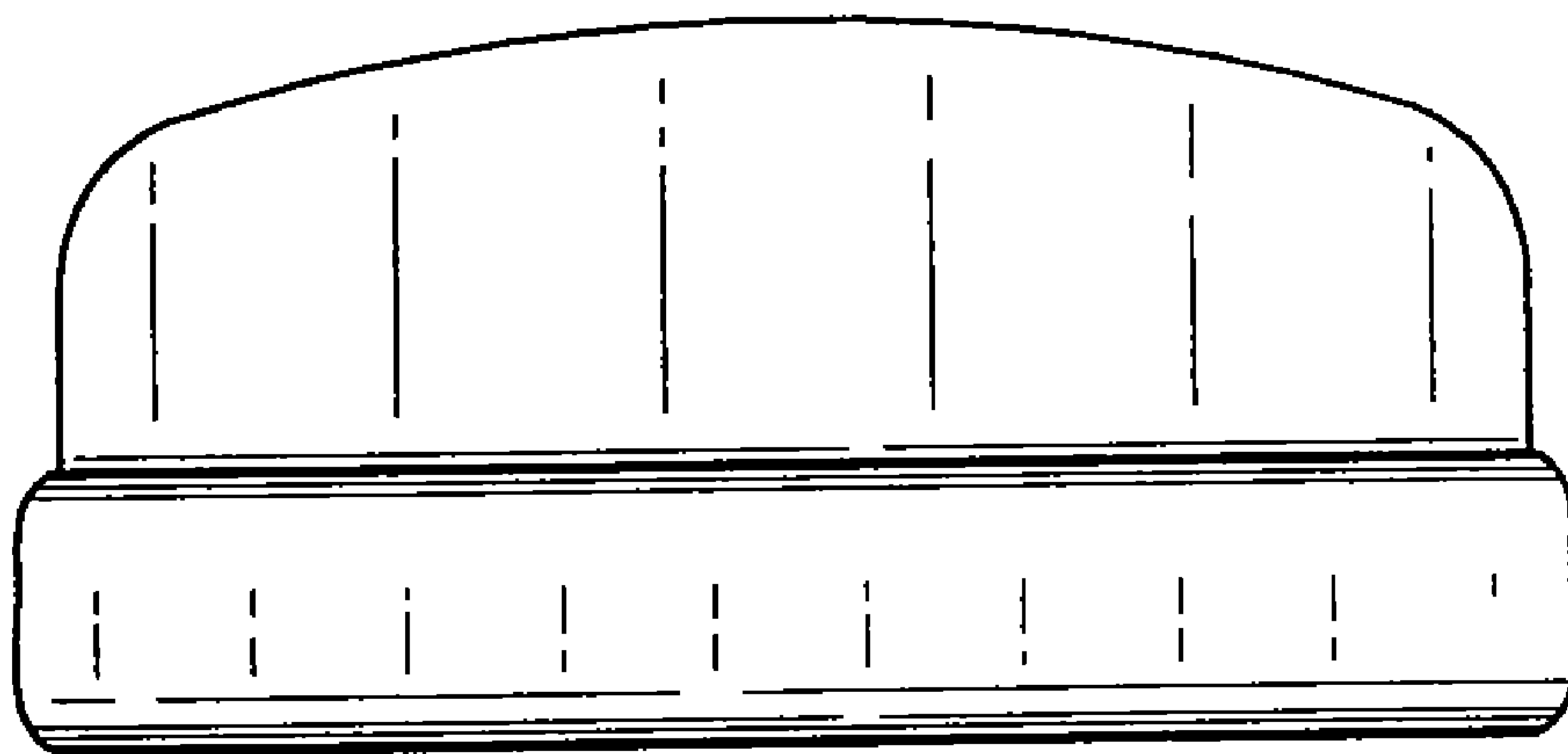
