DESCRIPTION

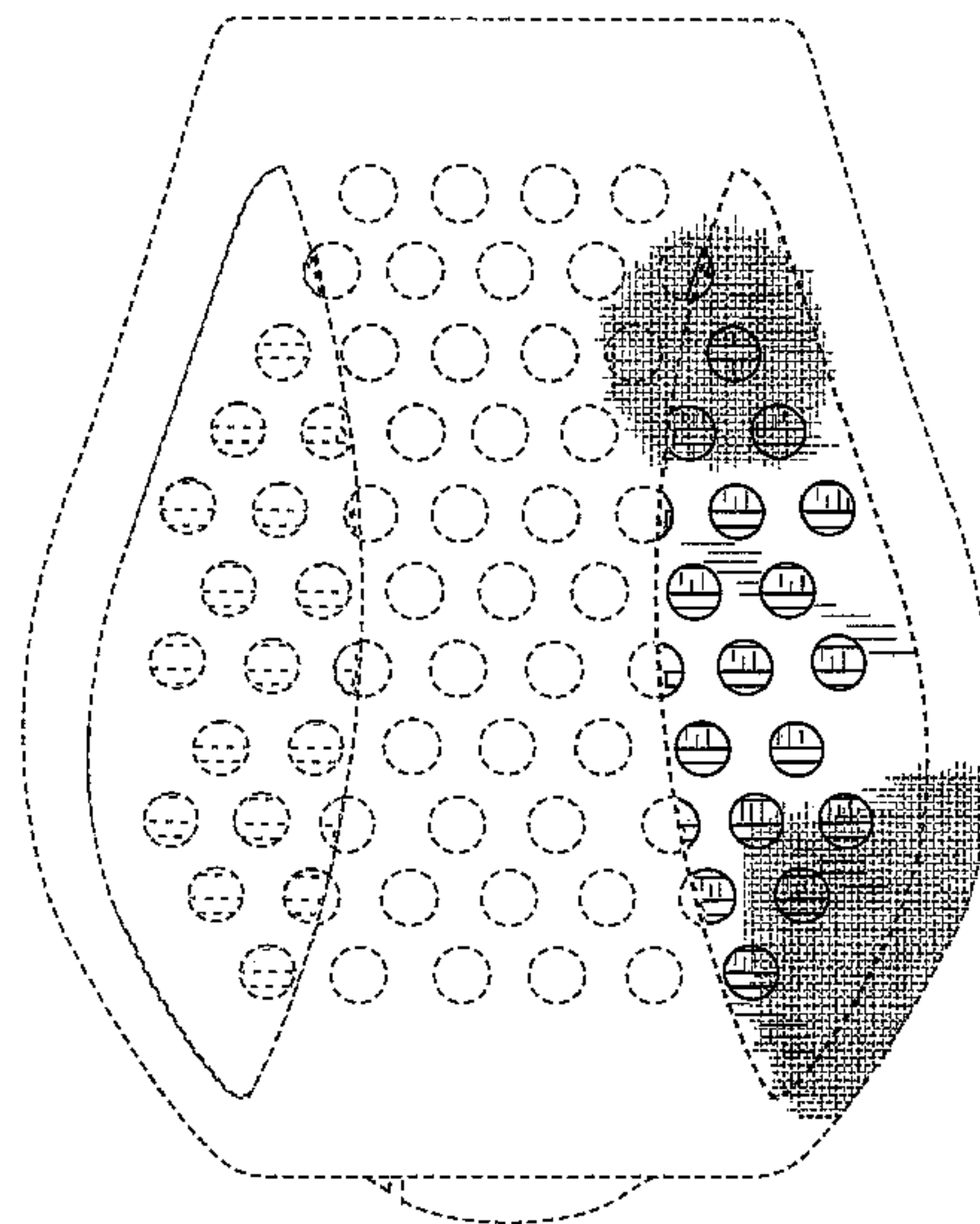
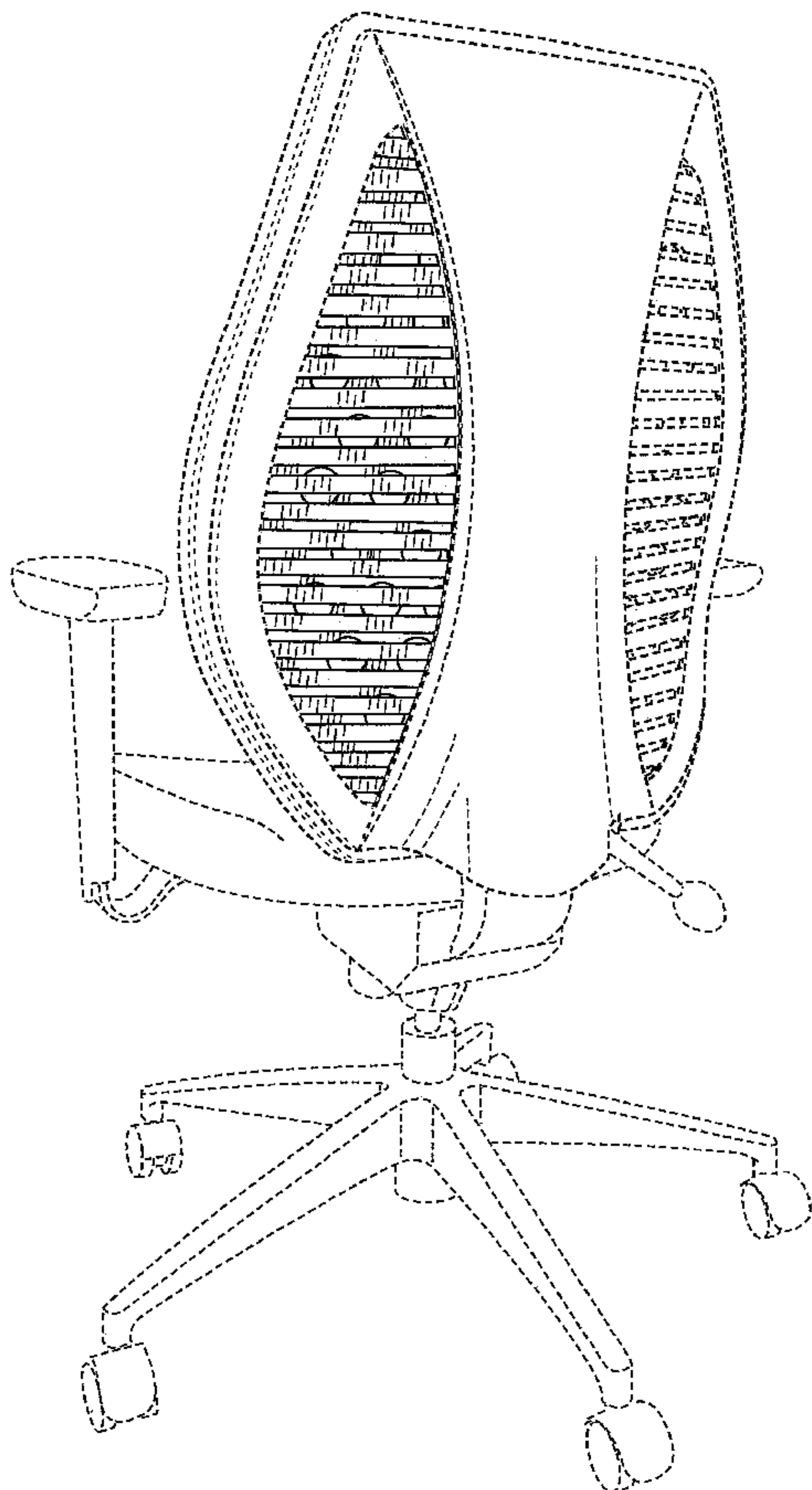
FIG. 1 is a perspective view of the design taken from the back showing the chair in phantom lines for illustrative purposes only.

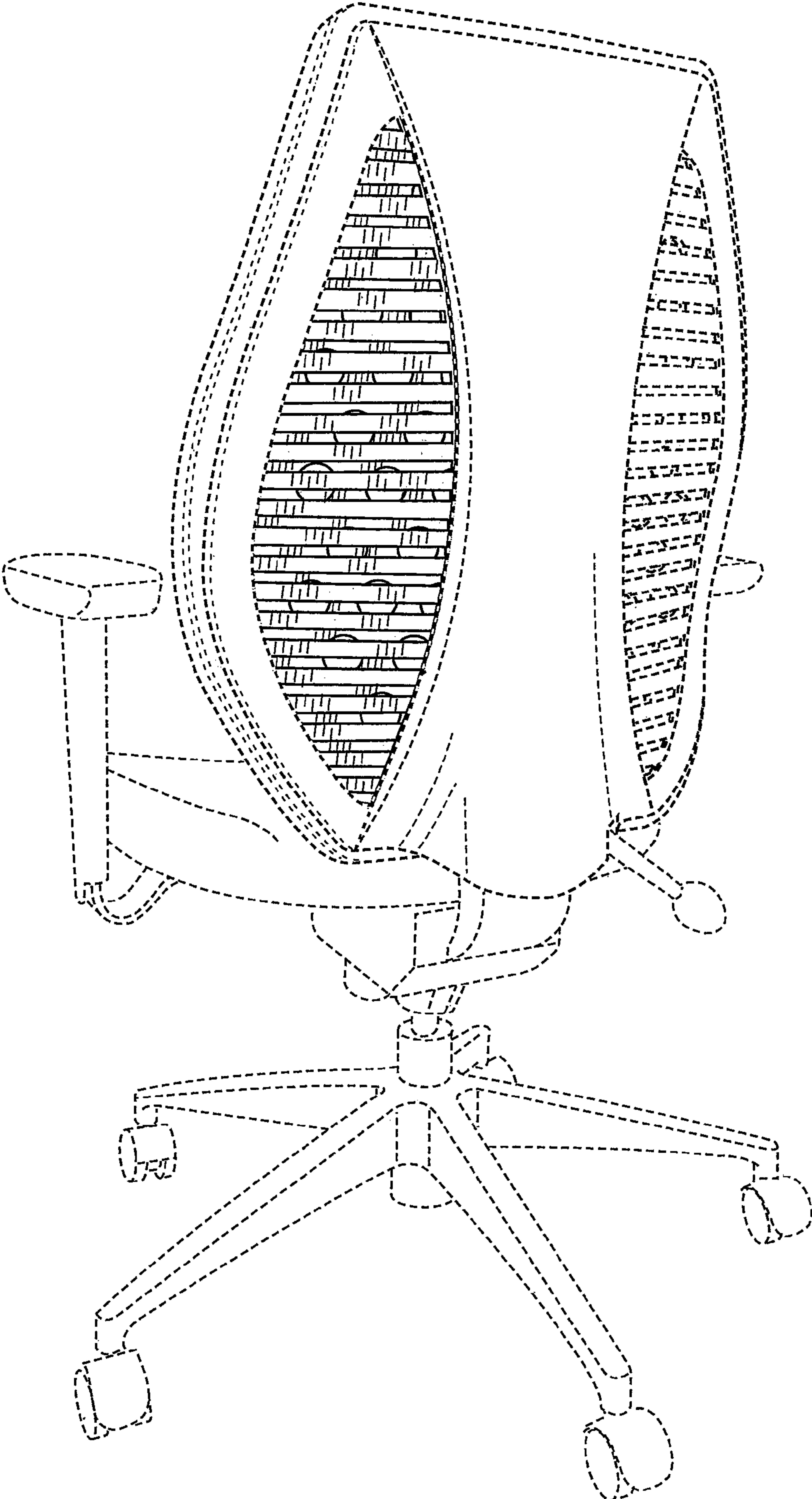

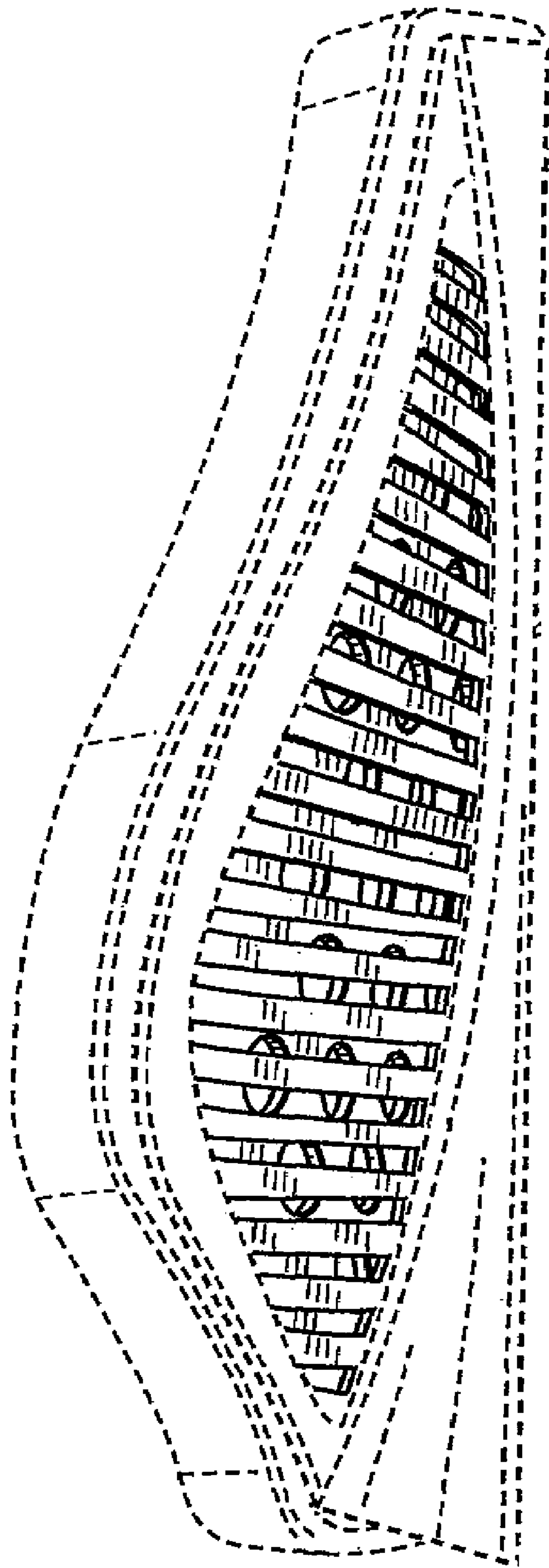

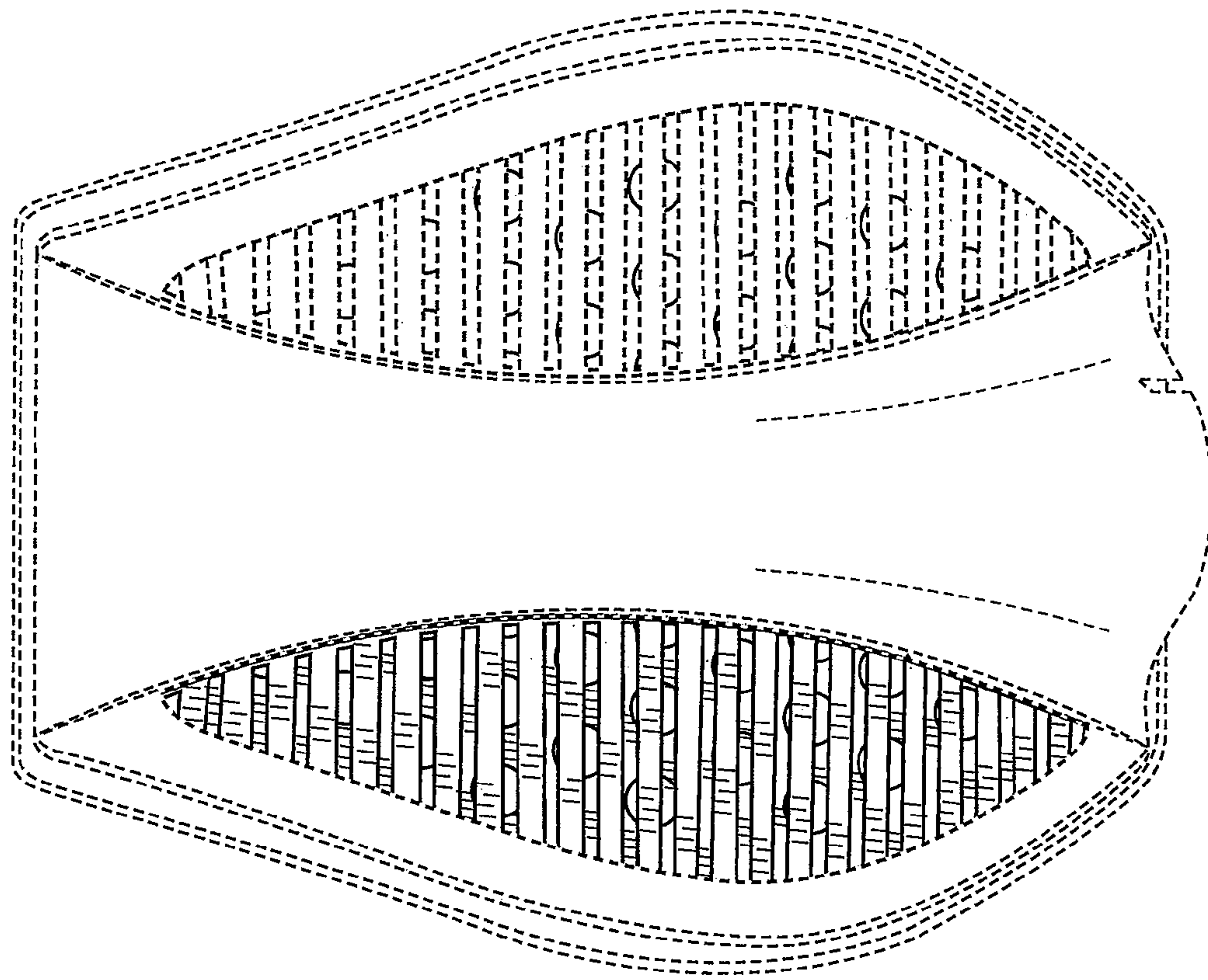

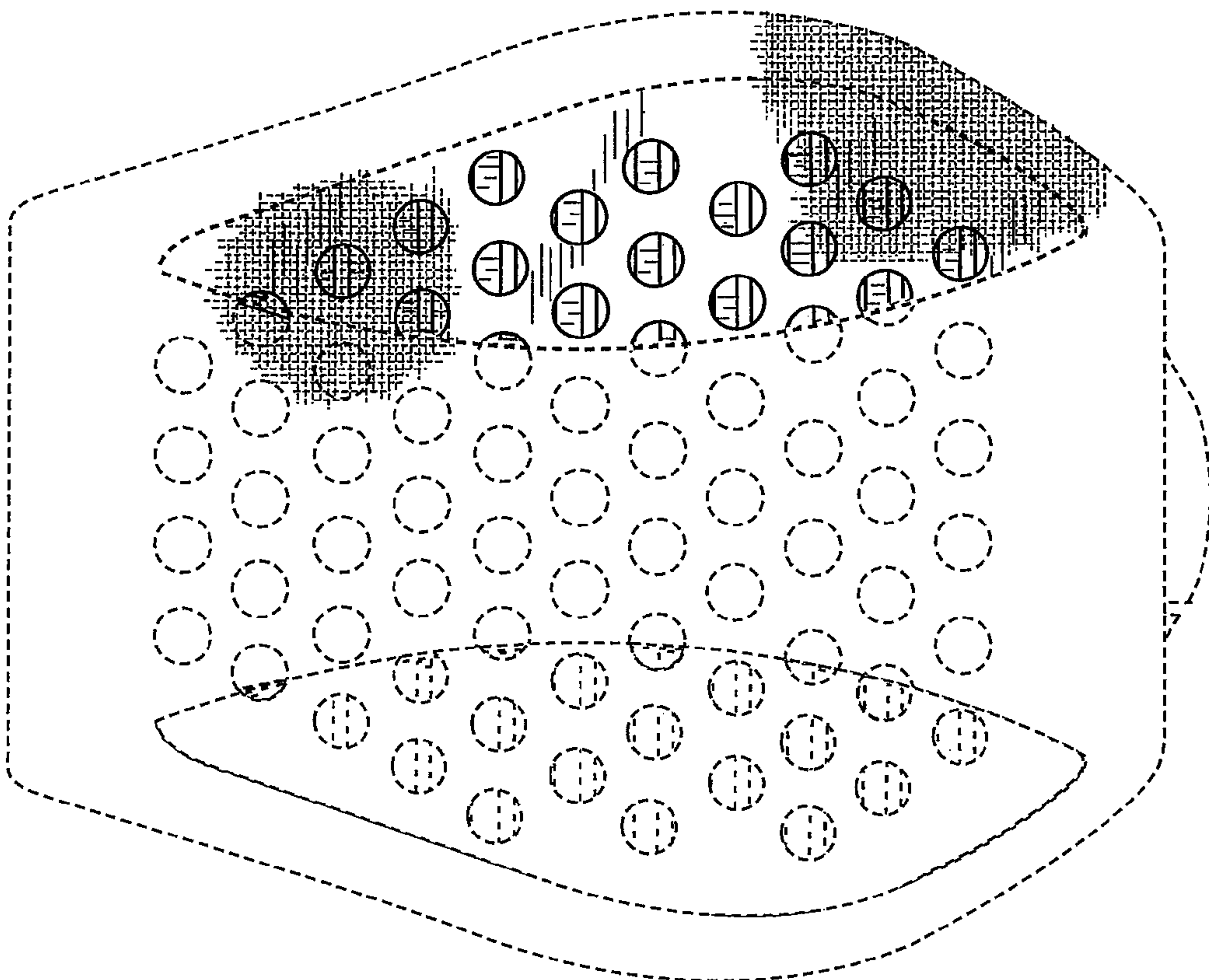
