FIG. 10 is a rear view thereof;

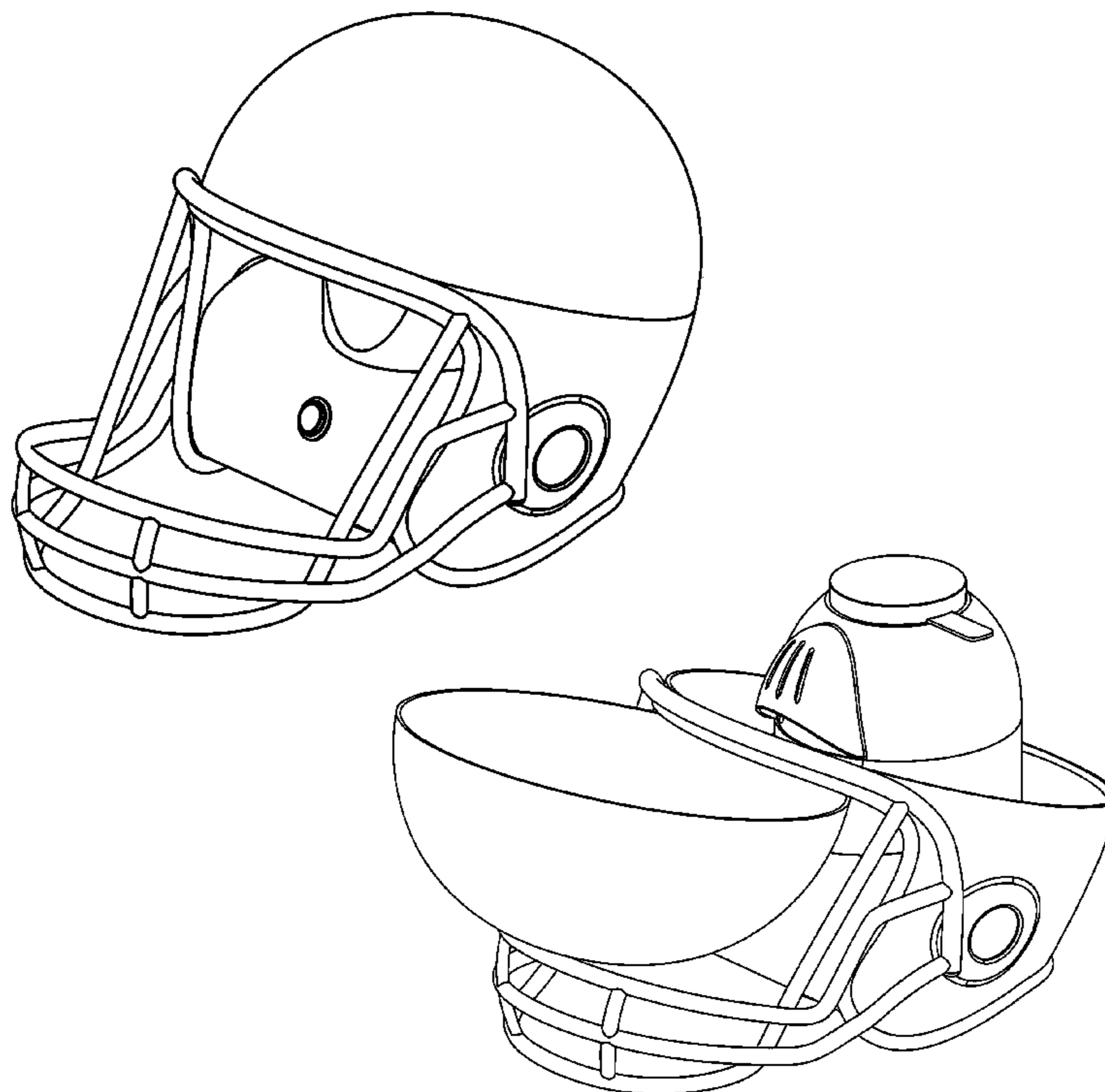
FIG. 11 is a left side view thereof;

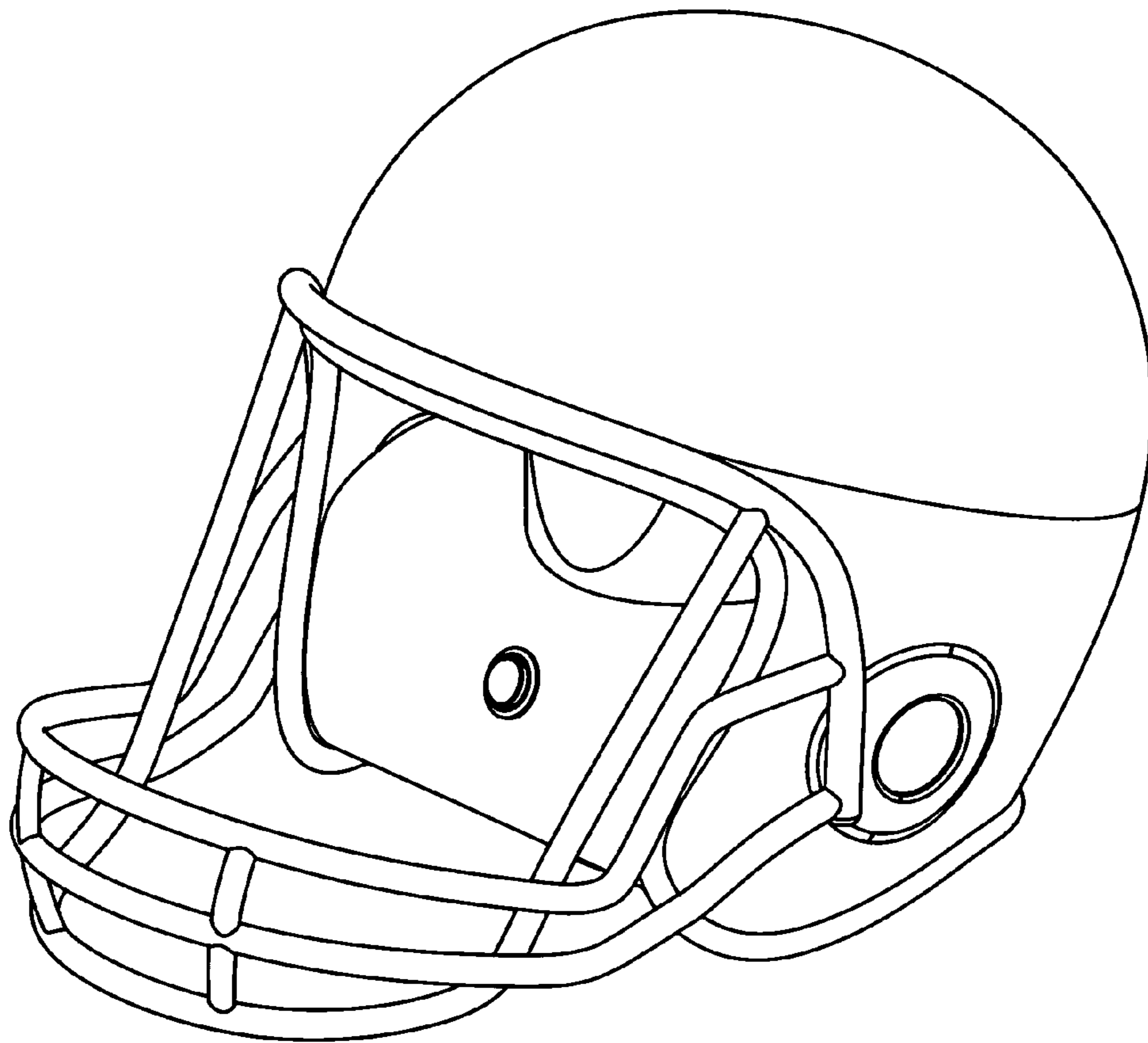

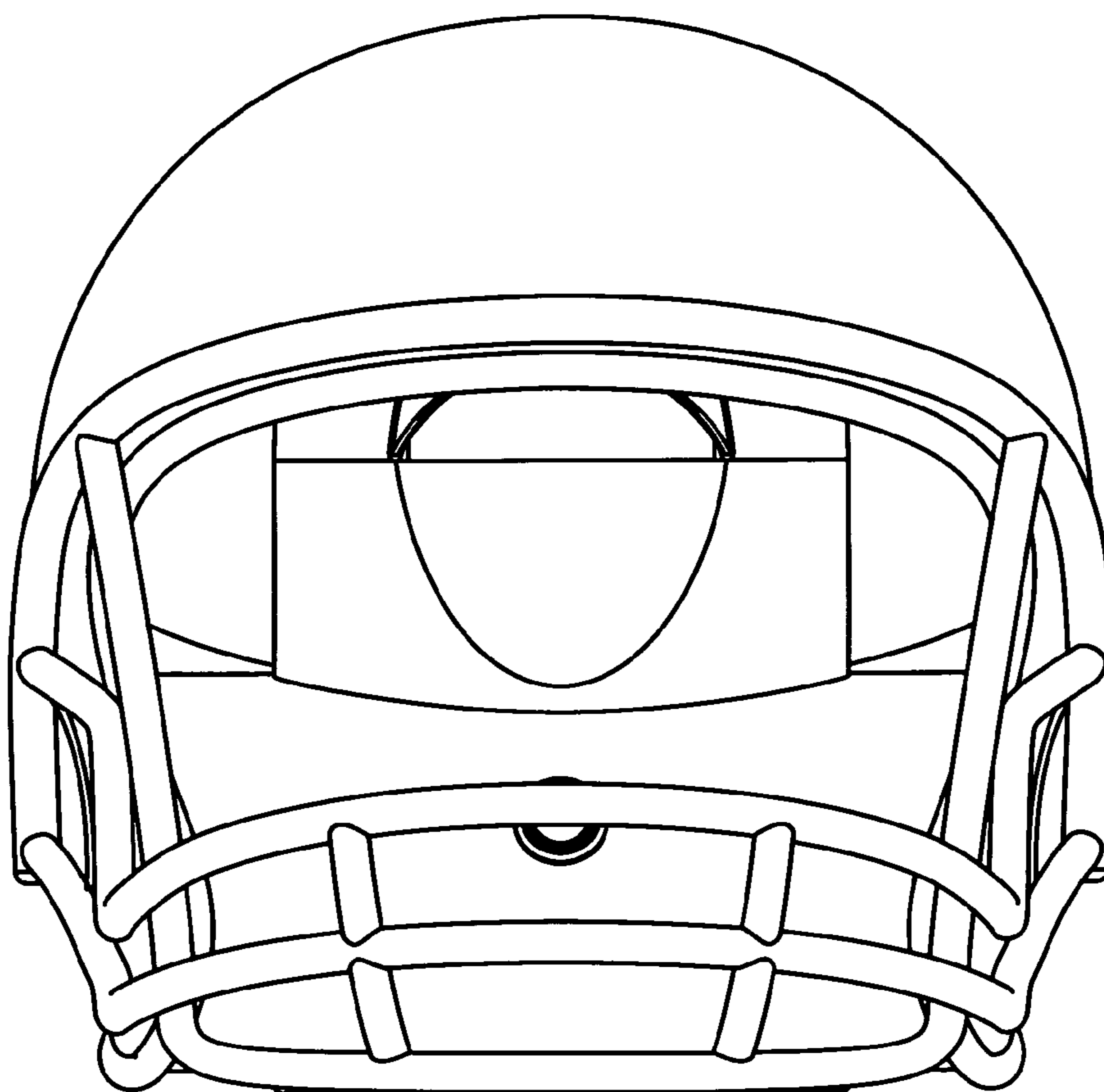

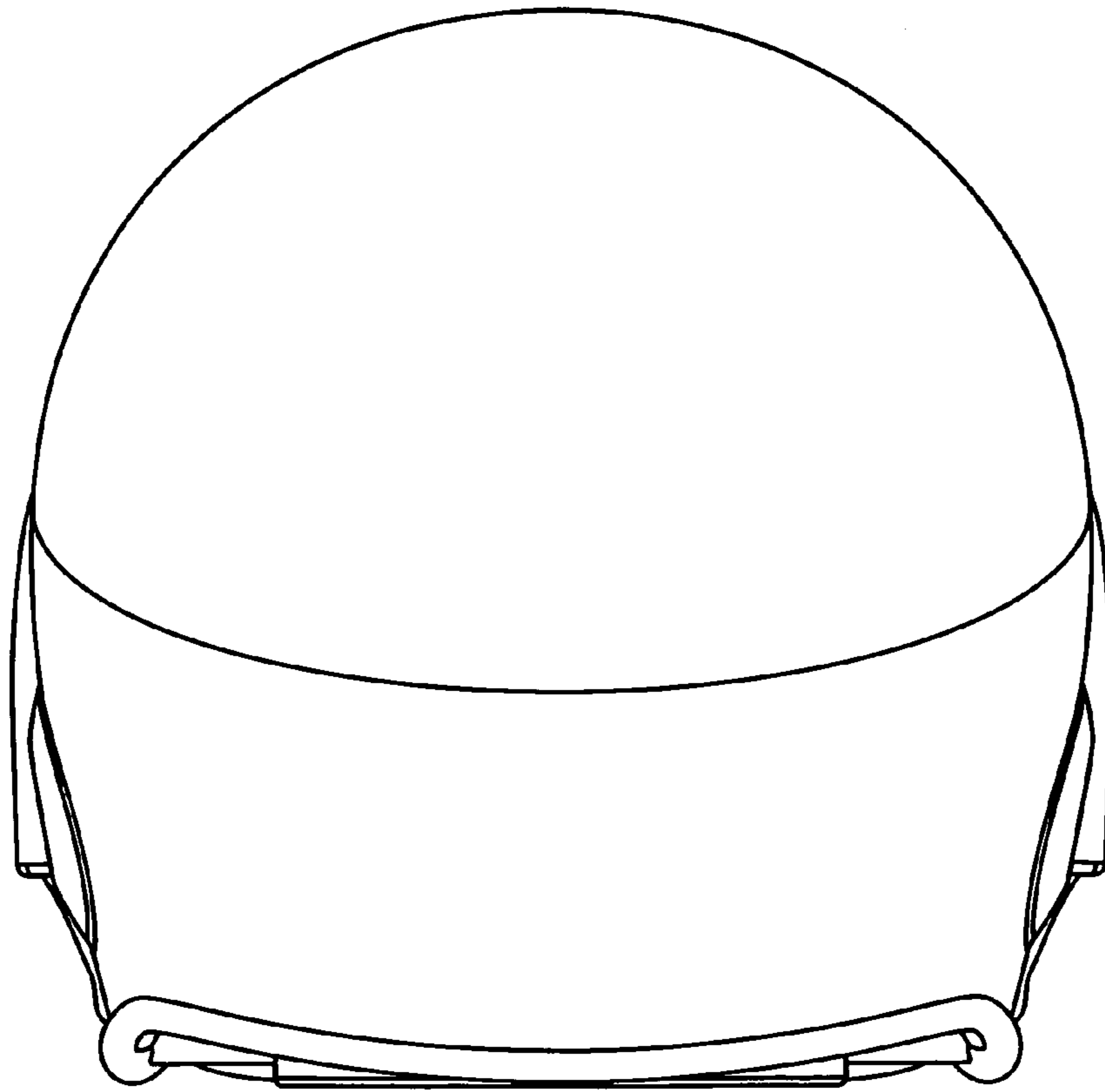

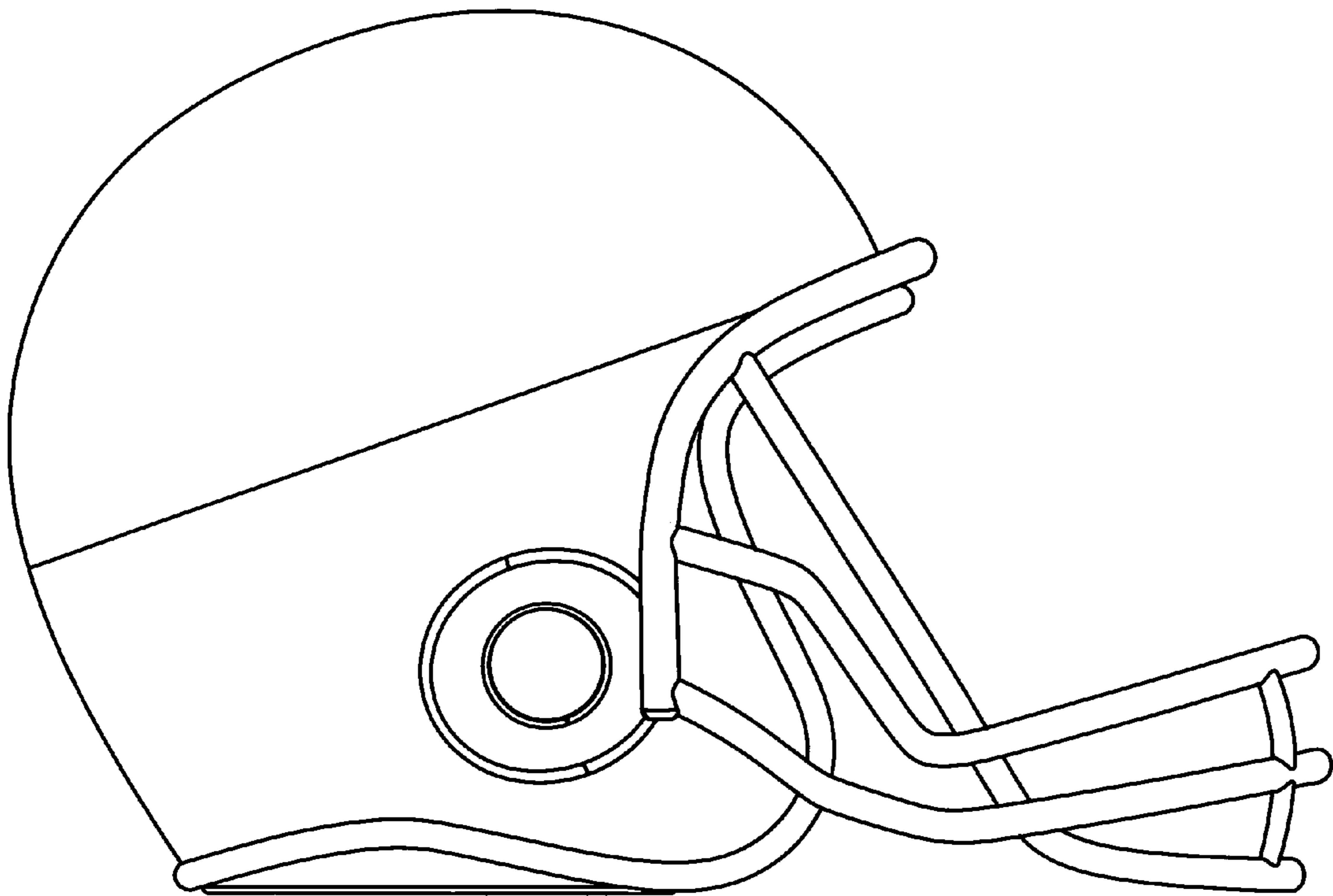

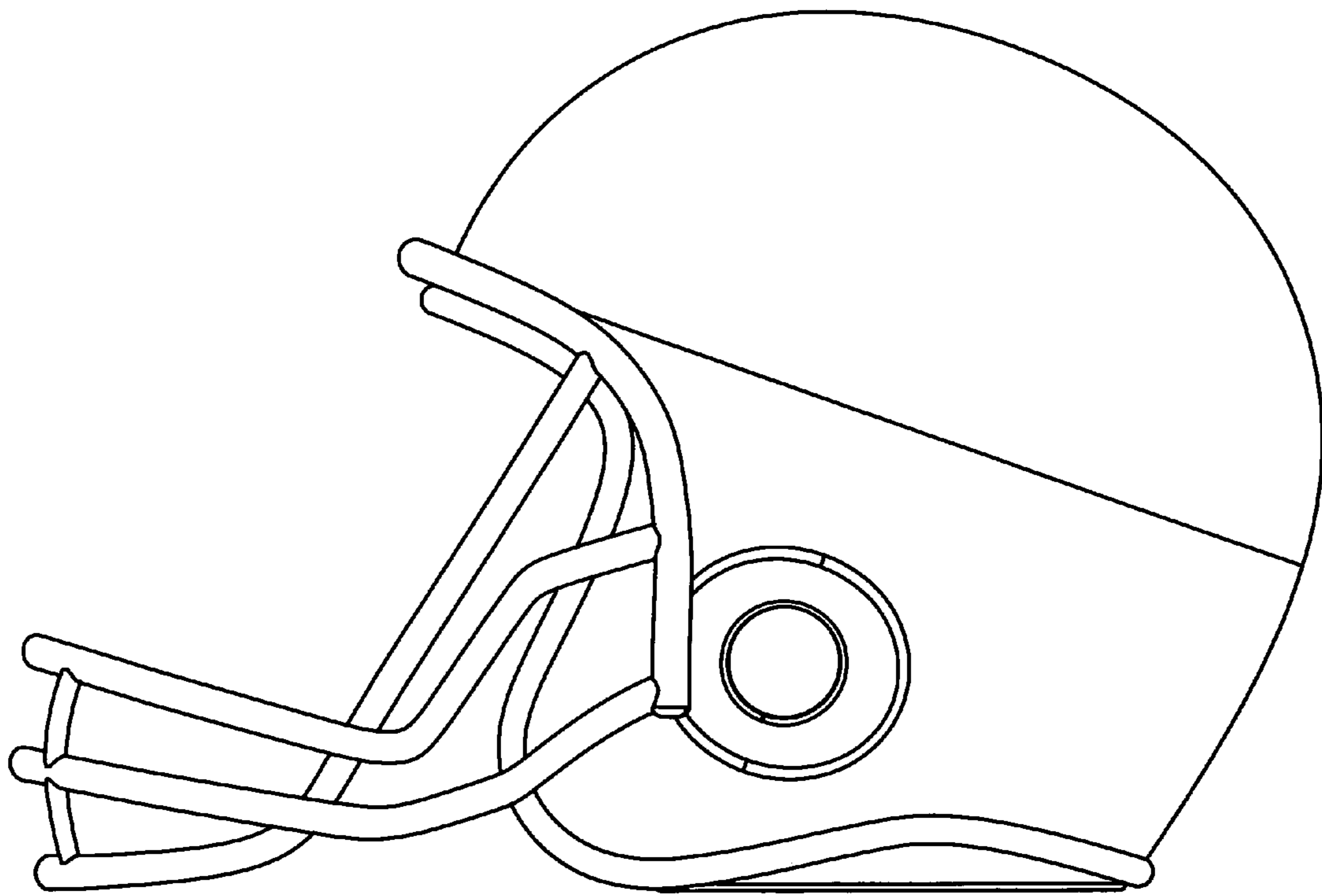

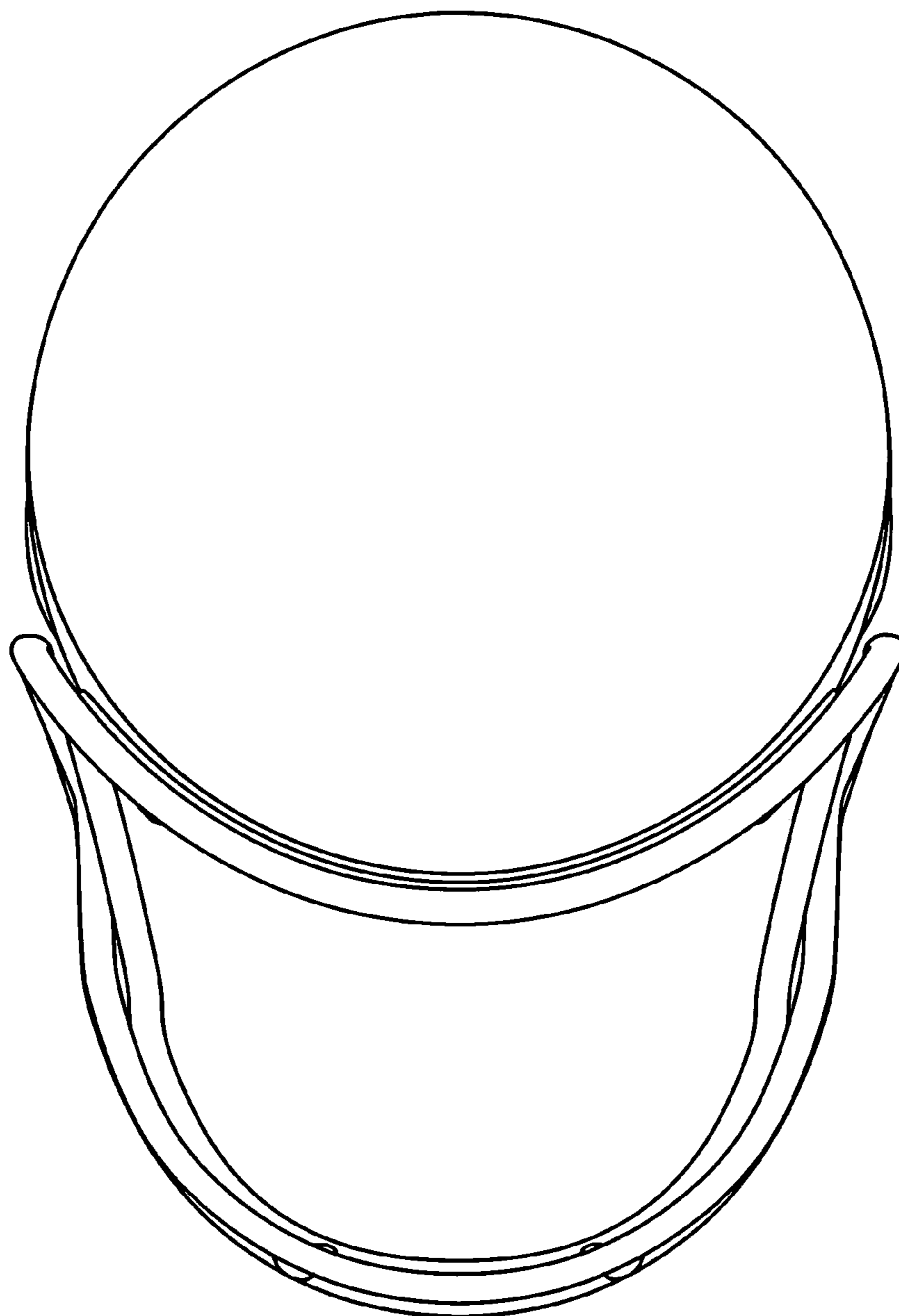

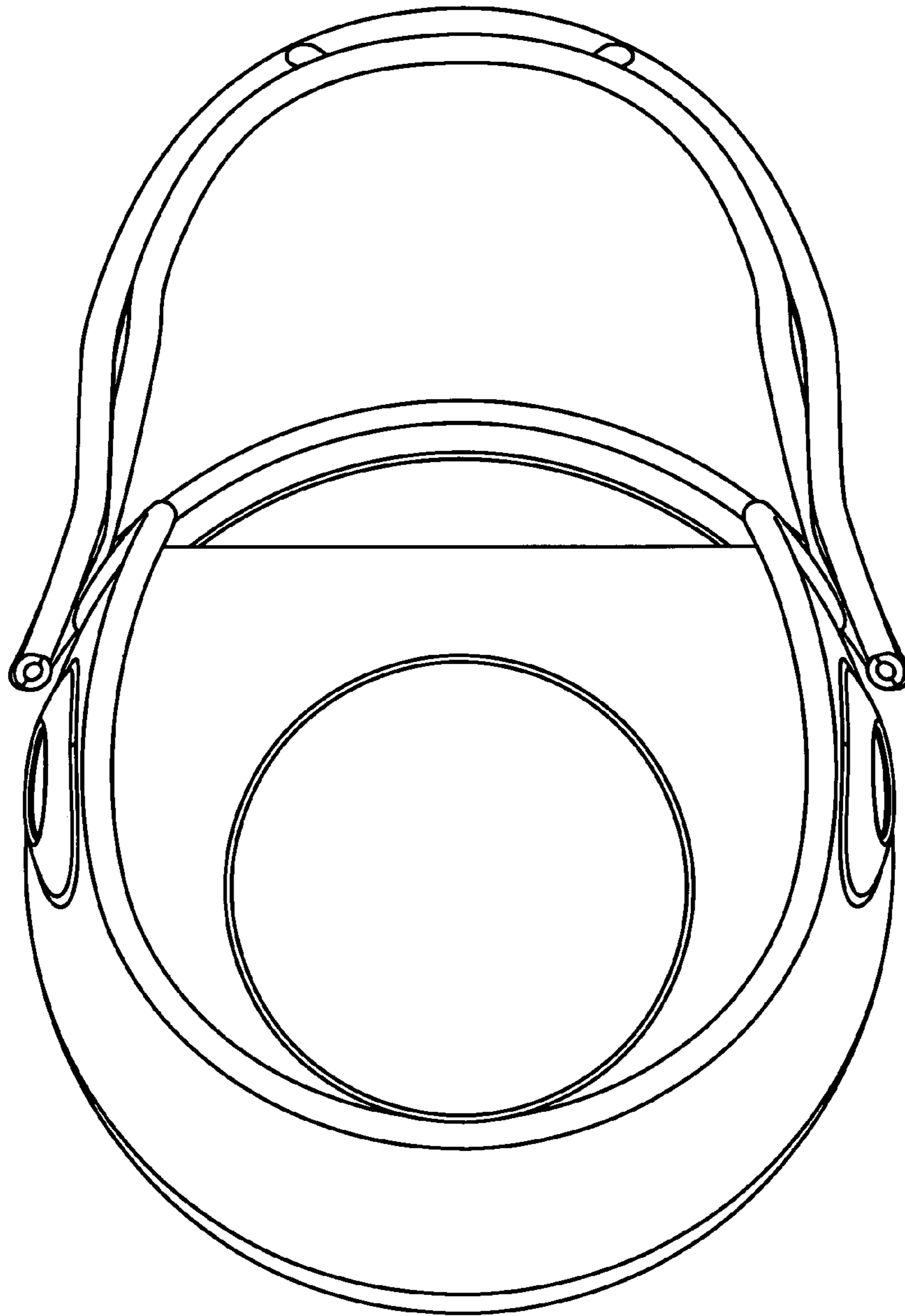

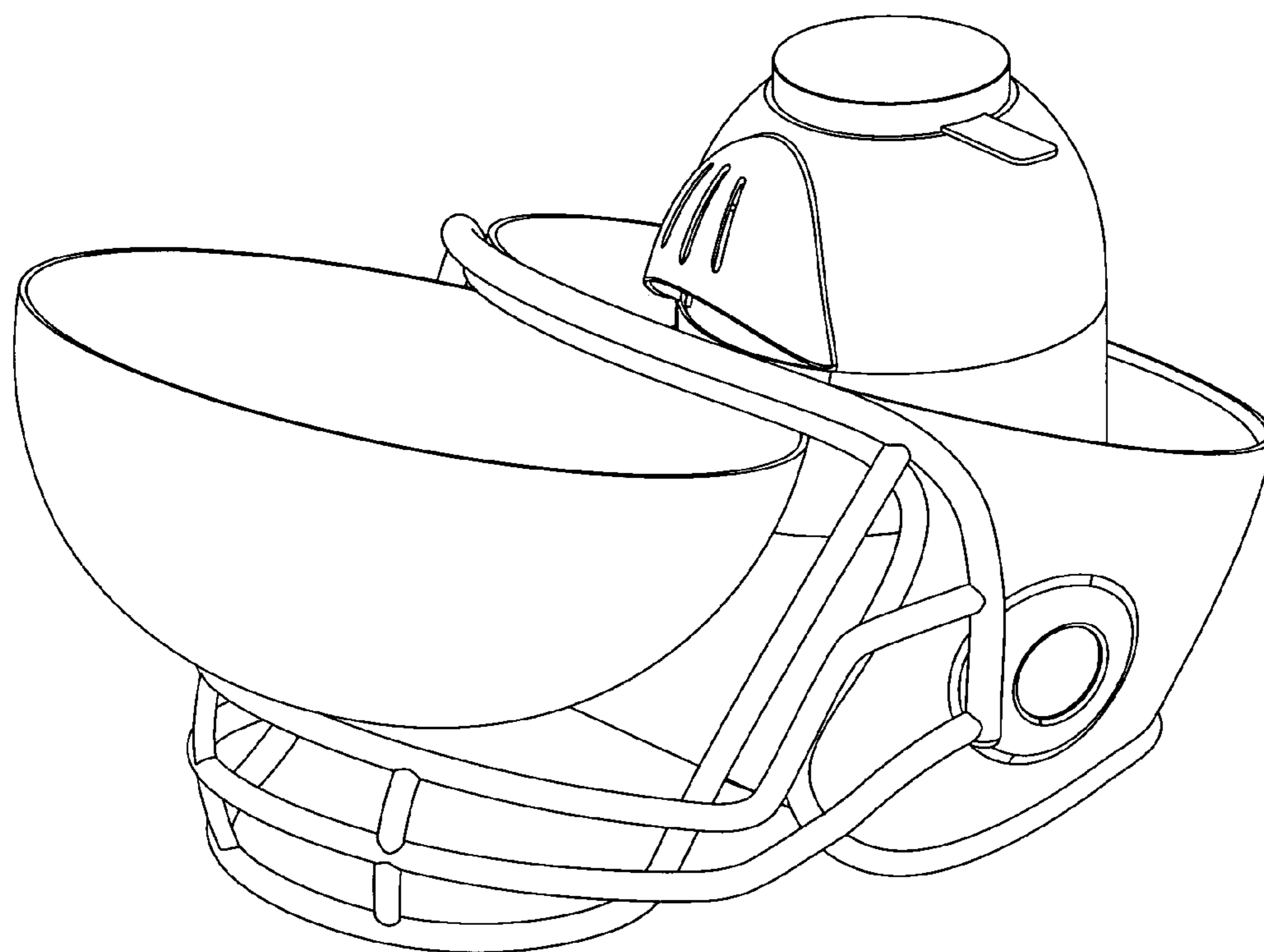

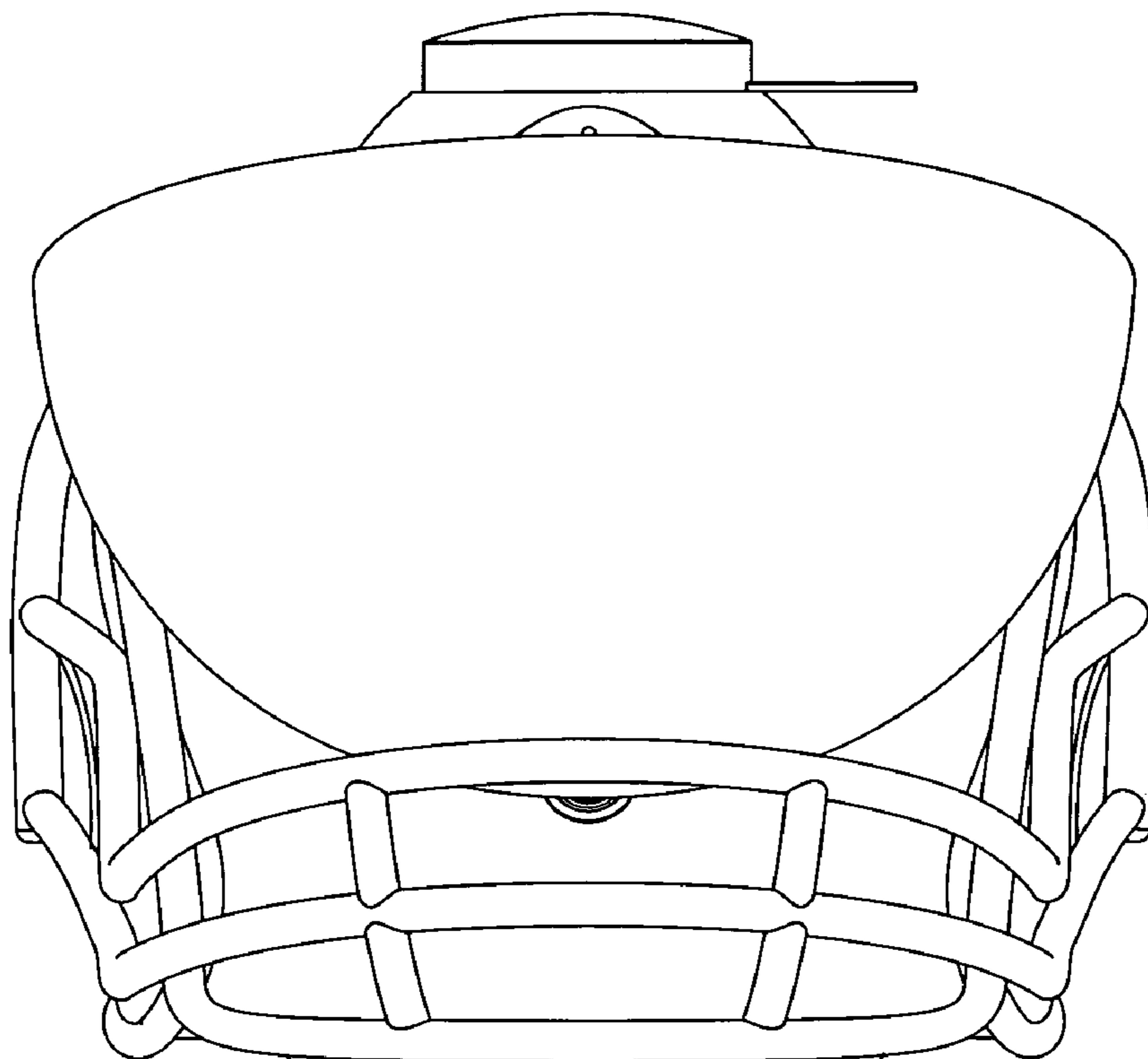

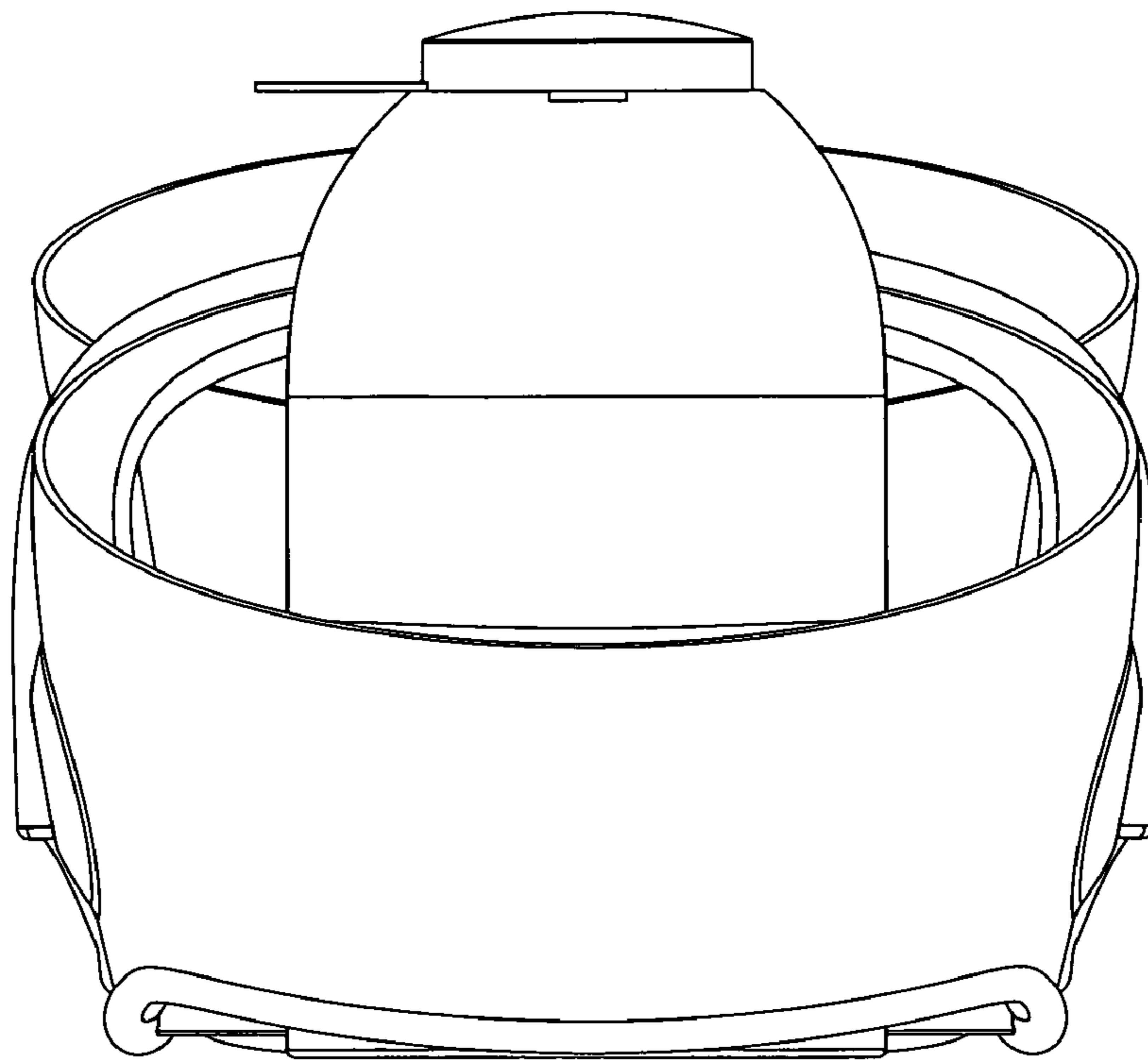

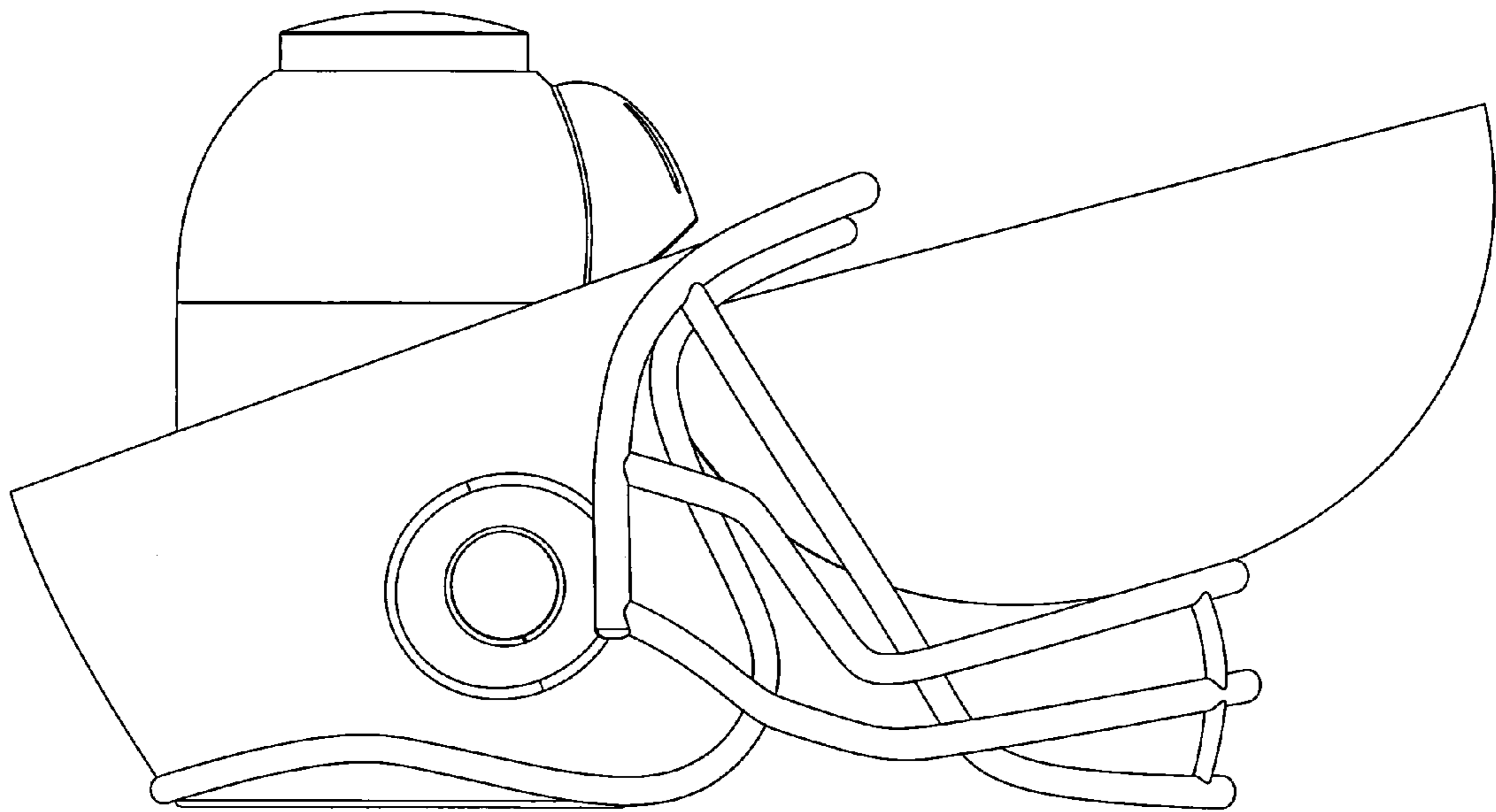

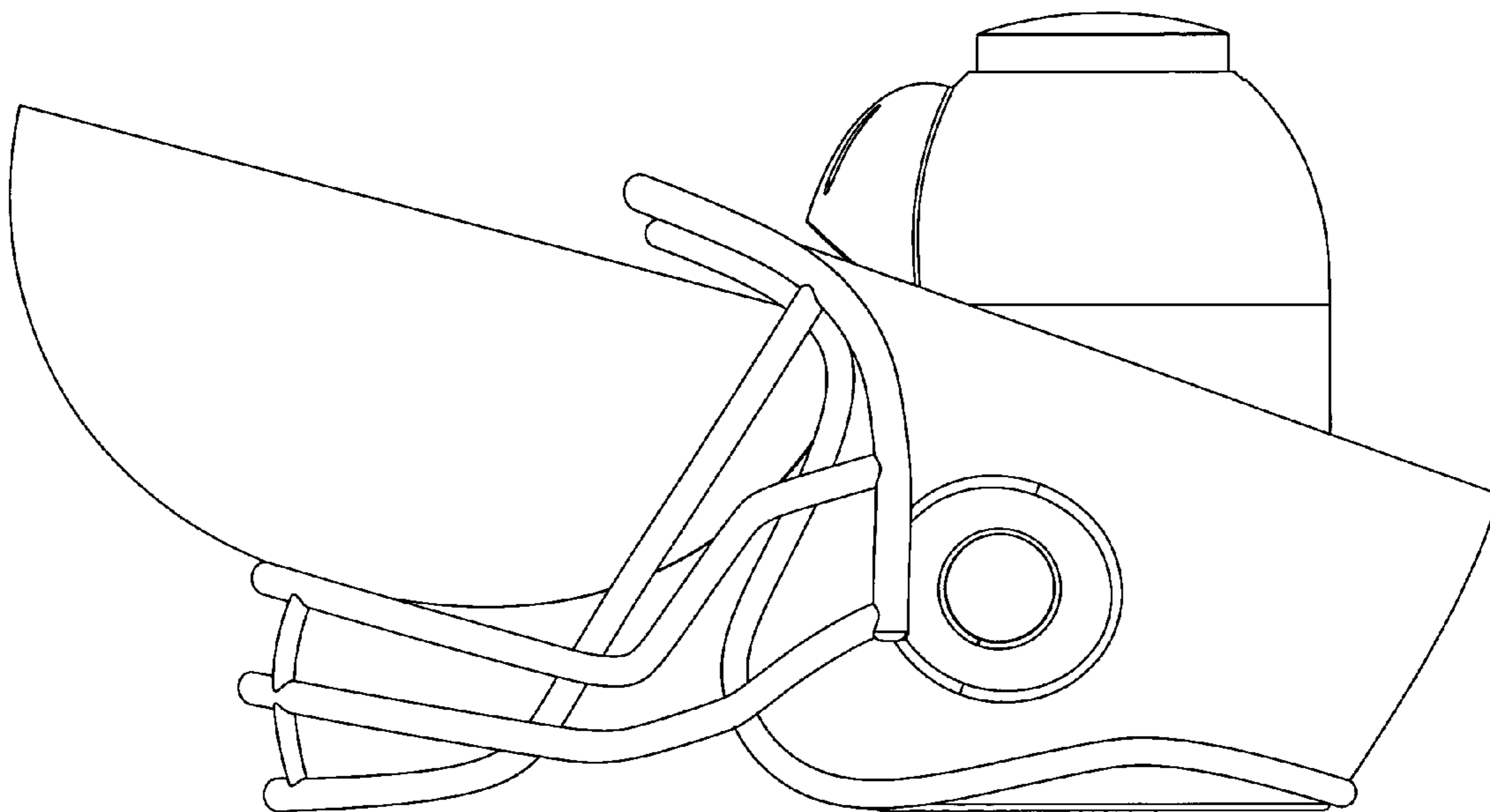

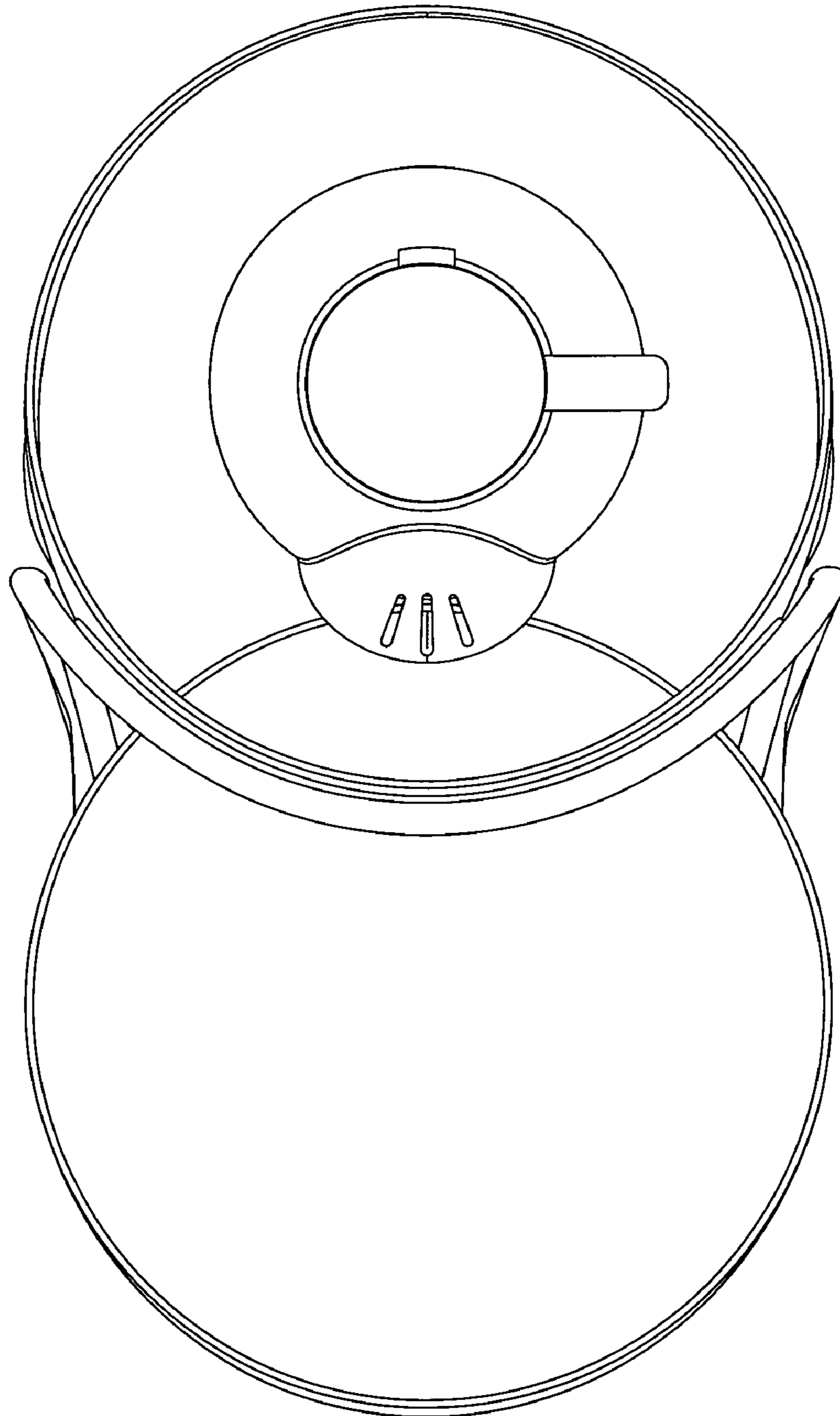

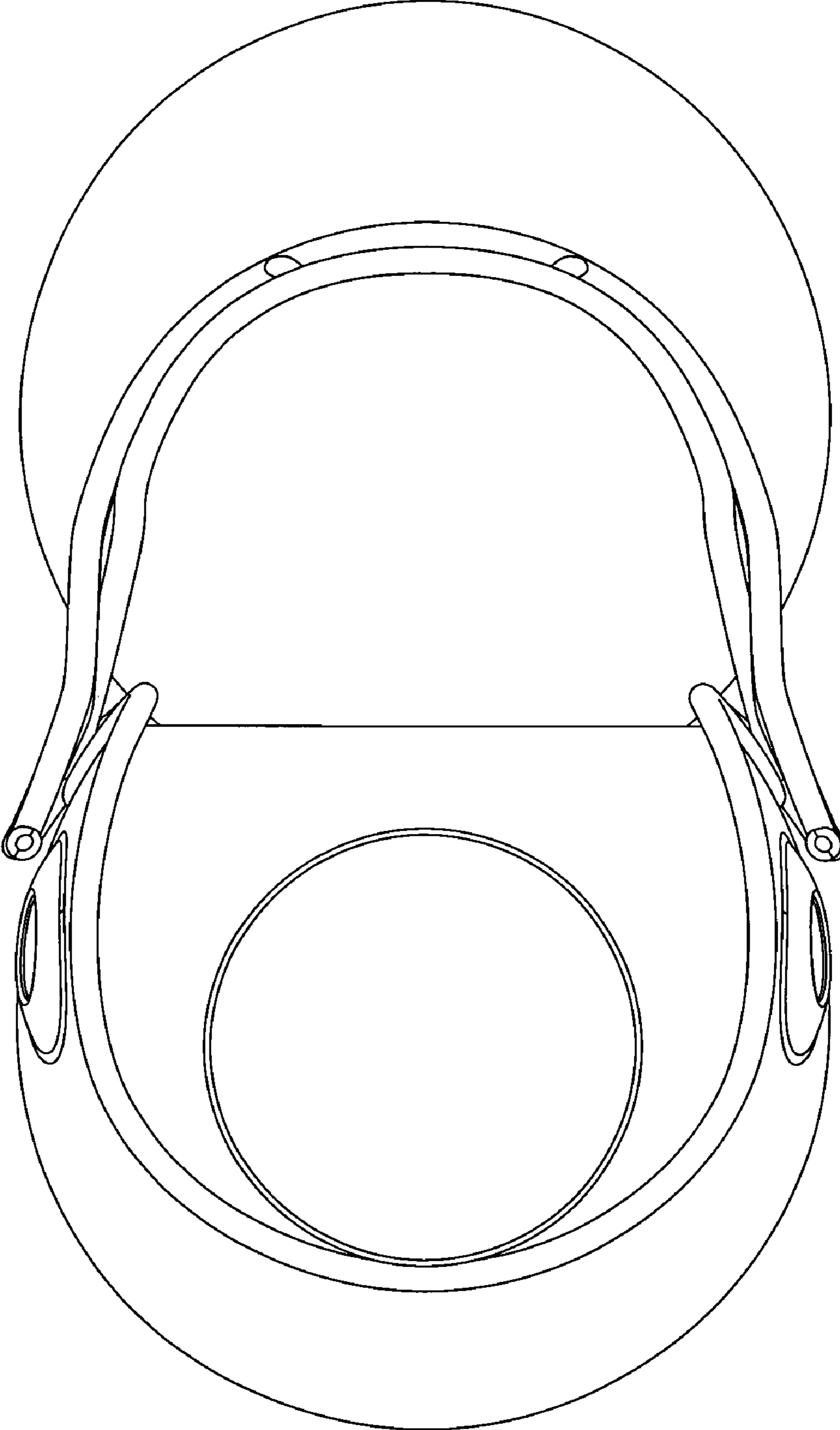
