(57) **CLAIM**

I claim the ornamental design for a rim for bakeware, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rim for bakeware according to the new design;

FIG. 2 is a top view of the rim for bakeware shown in FIG. 1;

FIG. 3 is a cross-sectional view of the rim for bakeware shown in FIG. 1 as taken through line 3—3;

FIG. 4 is a perspective view of a rim for bakeware showing a second embodiment of the new design;

FIG. 5 is a top view of the rim for bakeware shown in FIG. 4;

FIG. 6 is a cross-sectional view of the rim for bakeware shown in FIG. 4 as taken through line 6—6;

FIG. 7 is a perspective view of a rim for bakeware showing a third embodiment of the new design;

FIG. 8 is a top view of the rim for bakeware shown in FIG. 7;

FIG. 9 is a cross-sectional view of the rim for bakeware shown in FIG. 7 as taken through line 9—9;

FIG. 11 is a top view of the rim for bakeware shown in FIG. 10;

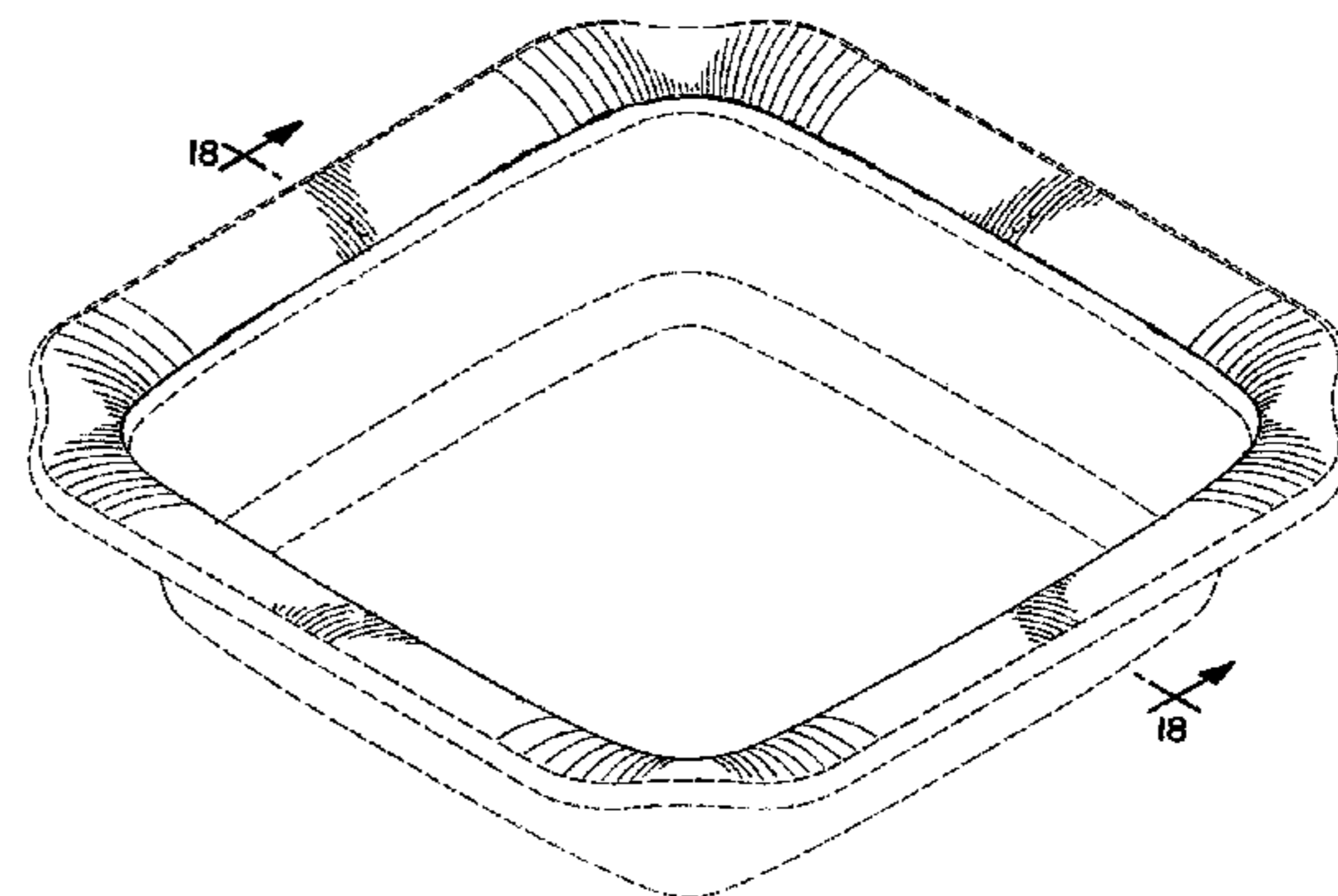
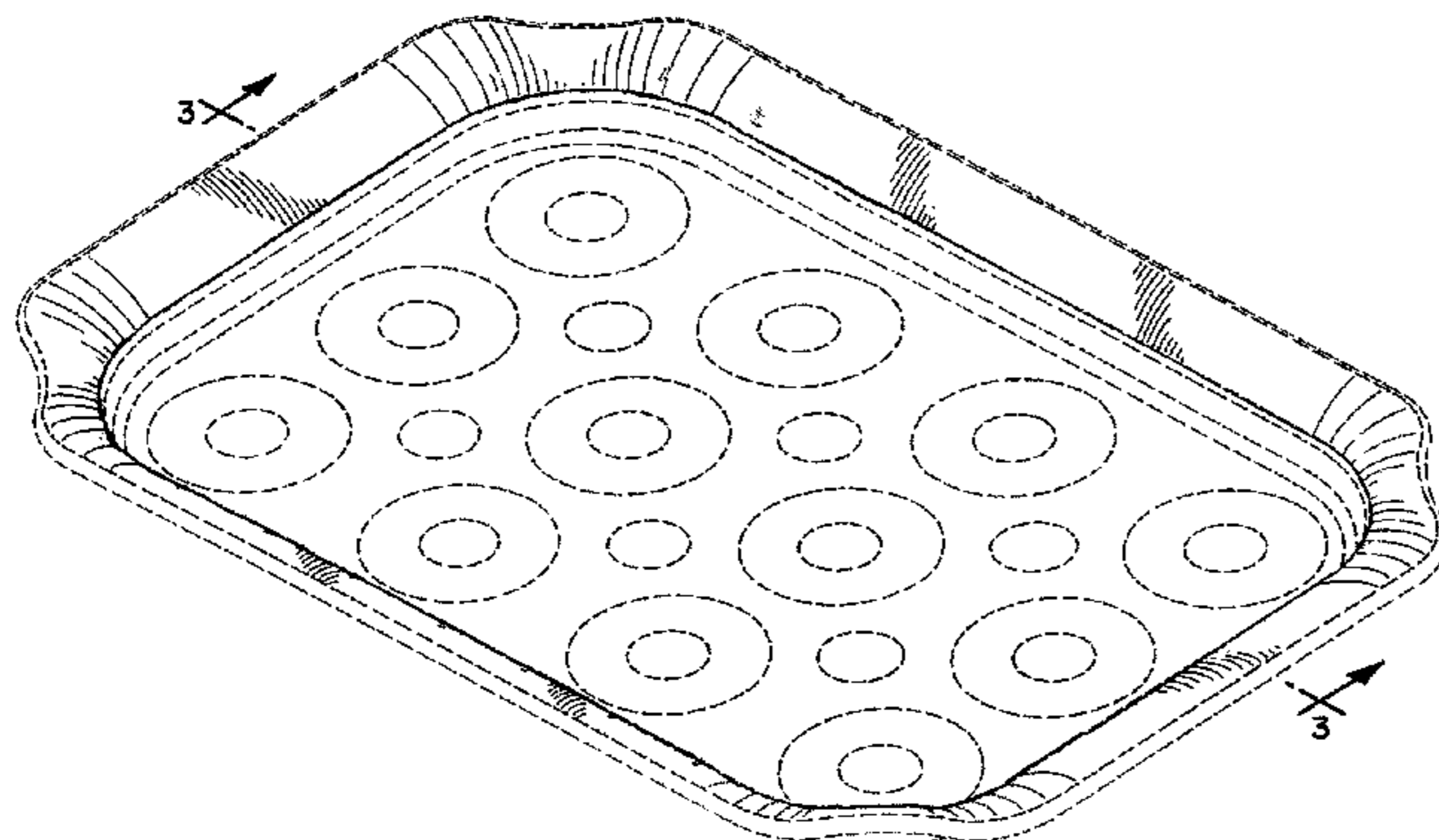


FIG. 12 is a cross-sectional view of the rim for bakeware shown in FIG. 10 as taken through line 12—12;

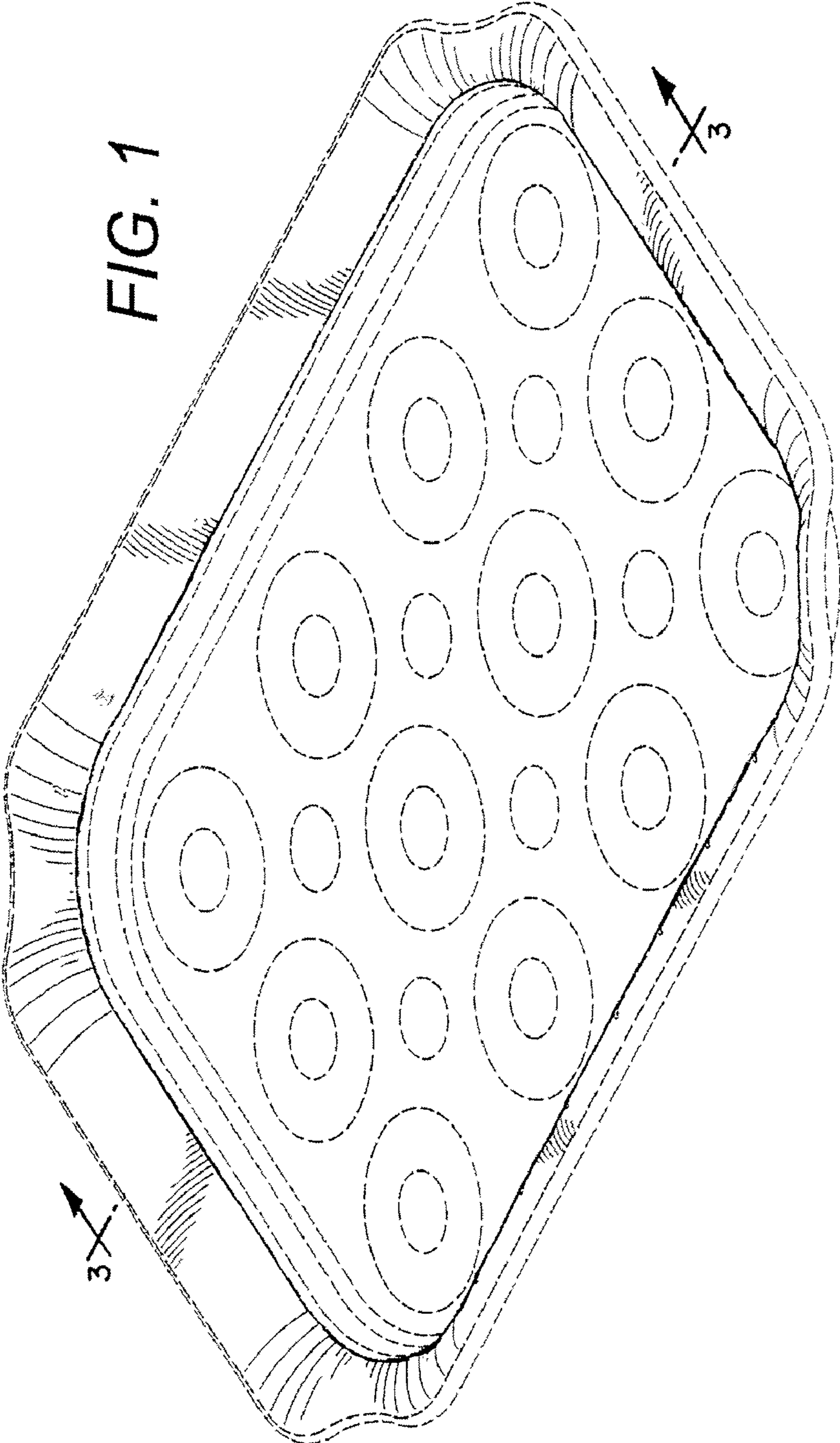

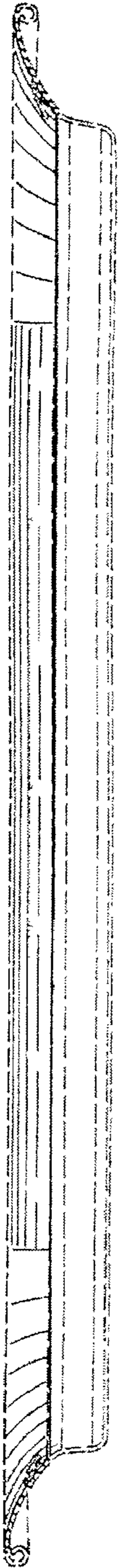

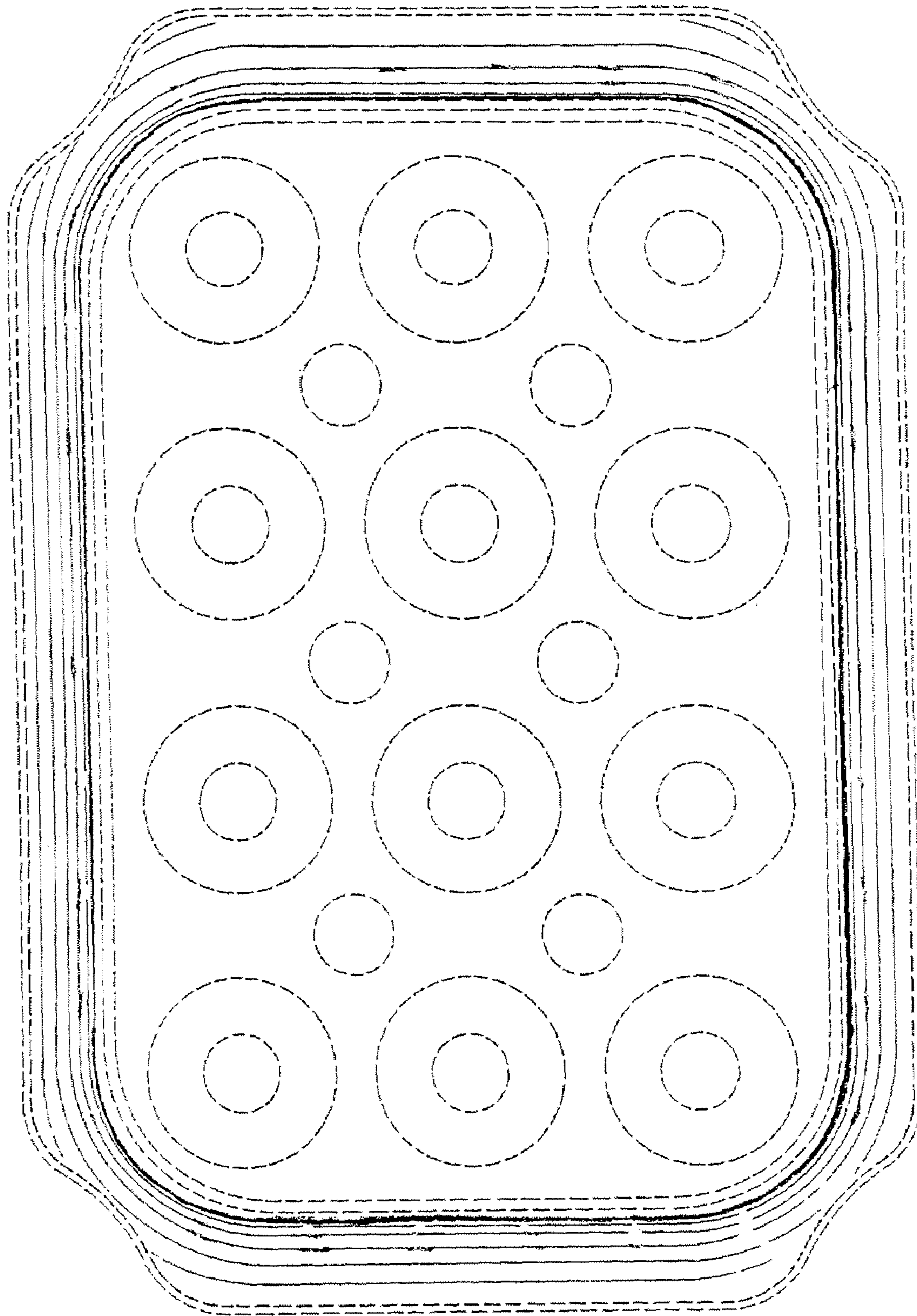

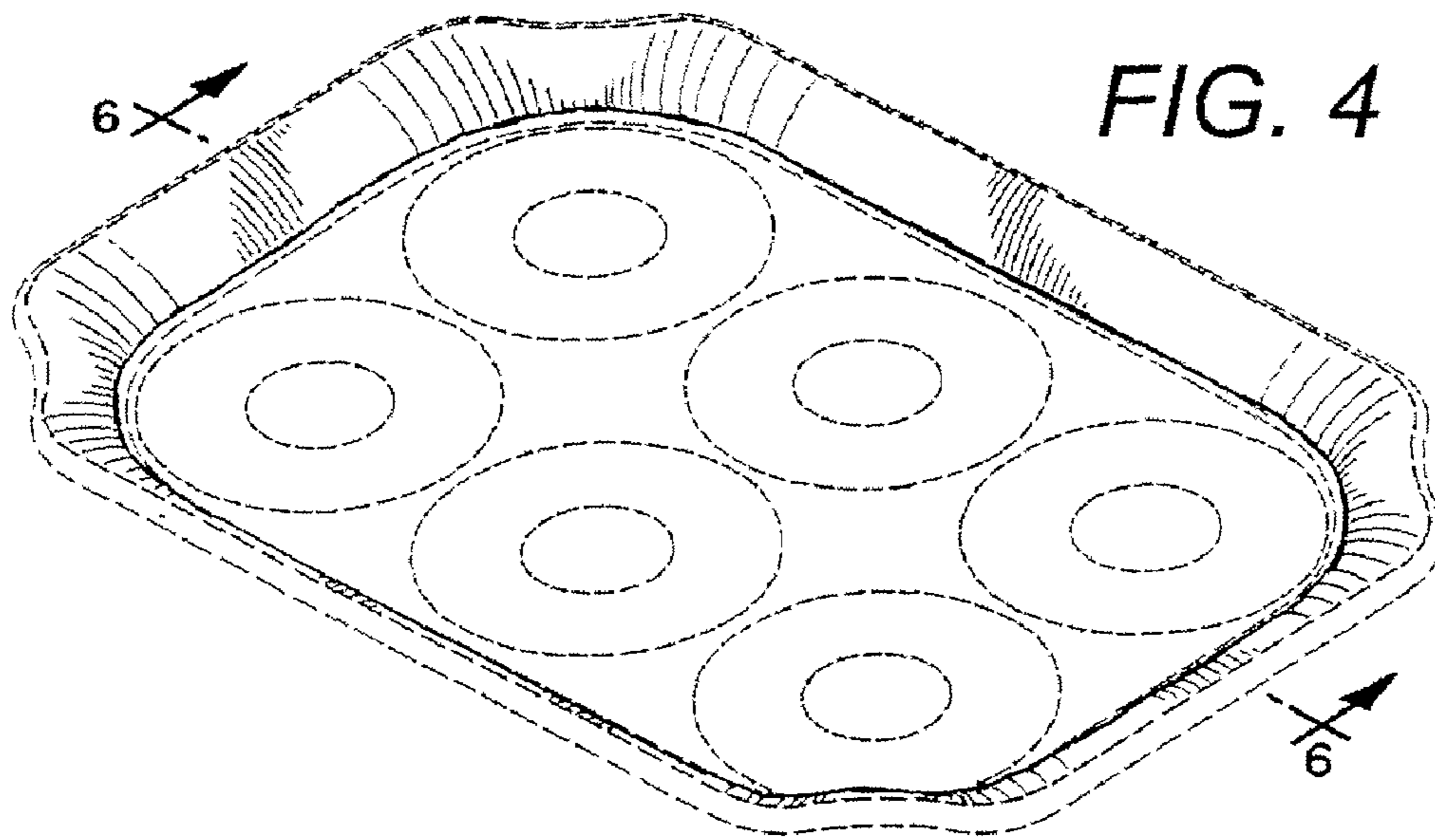

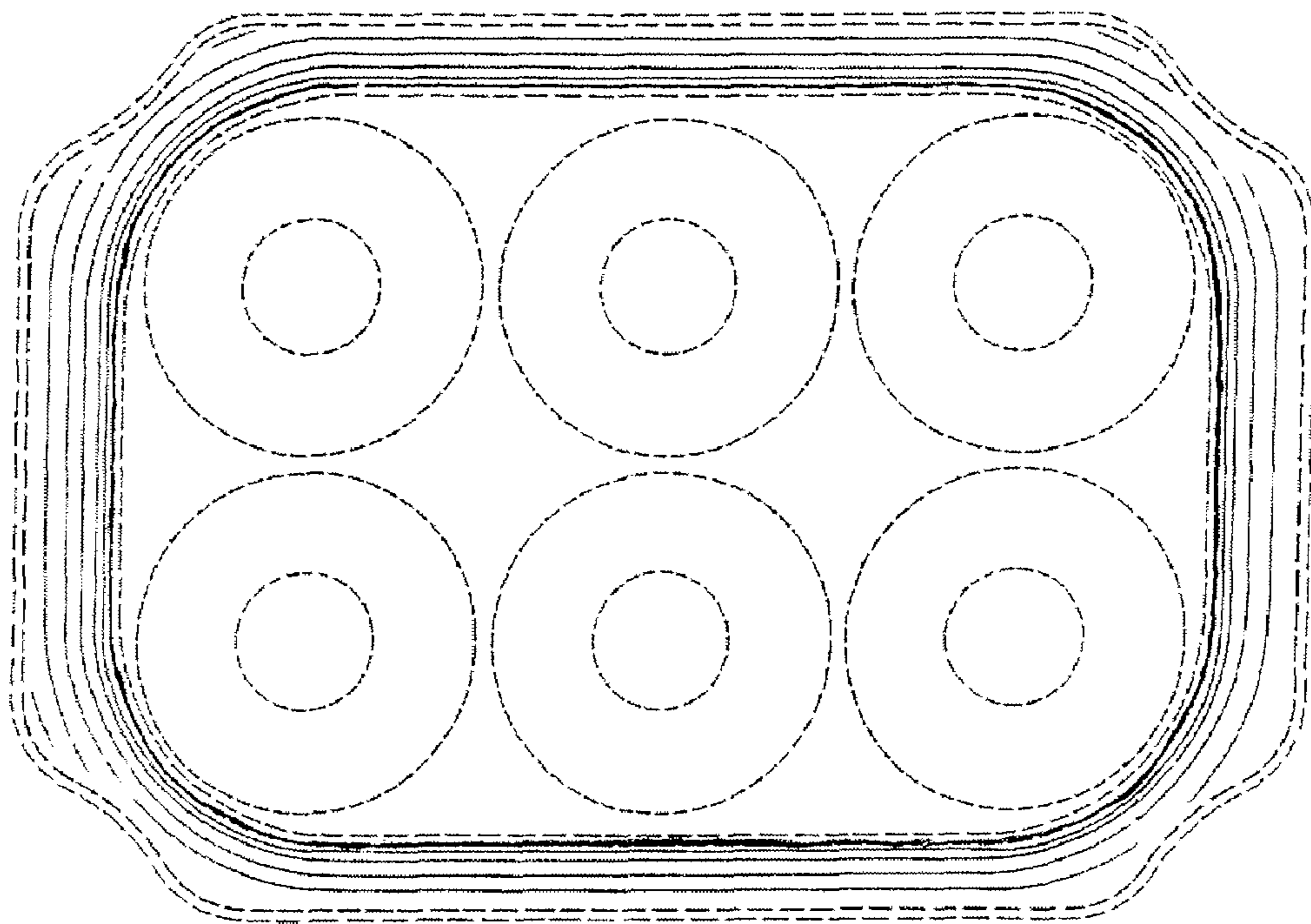
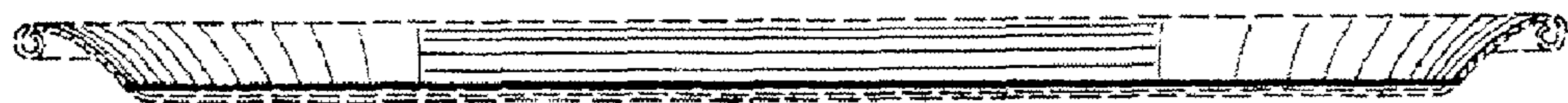

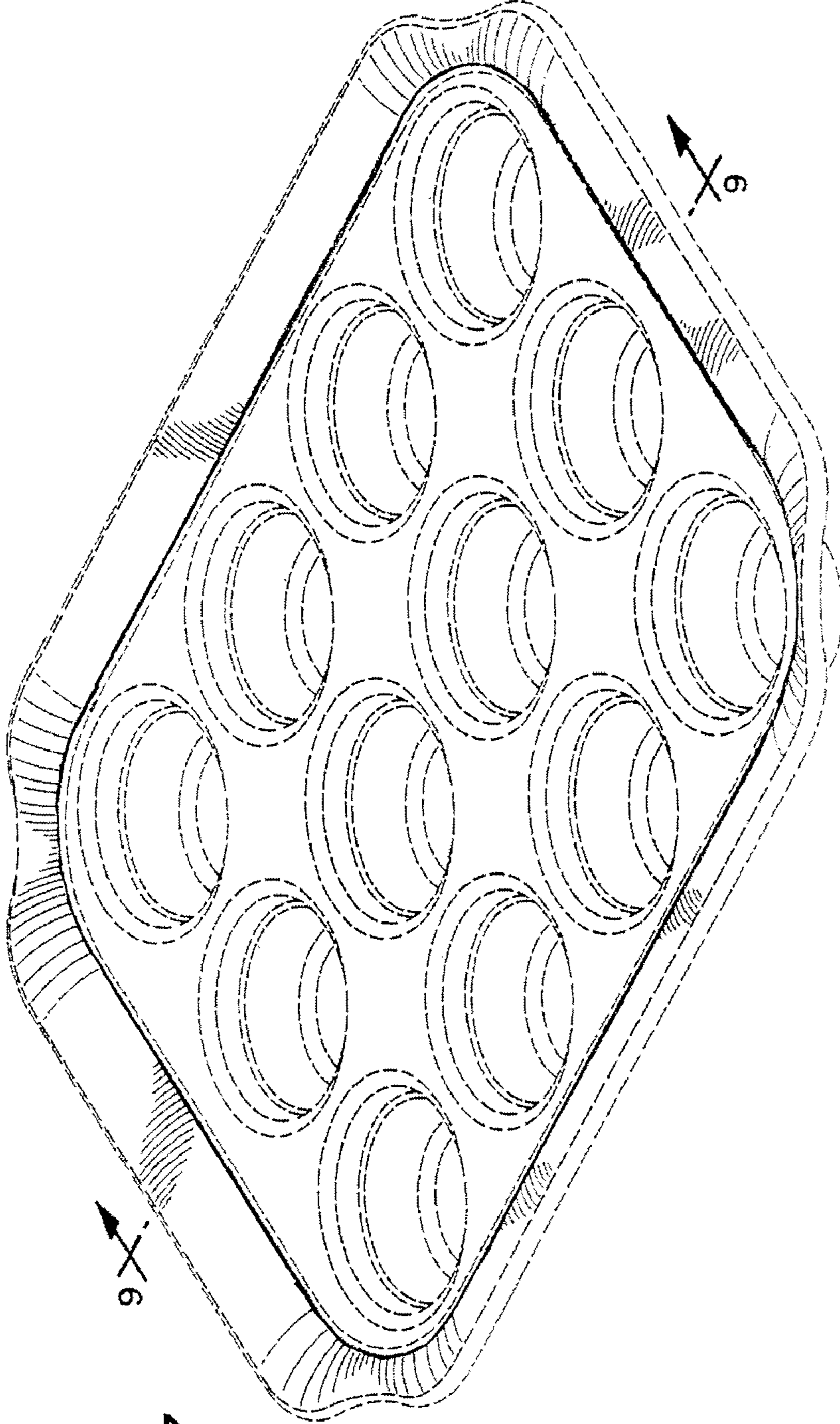

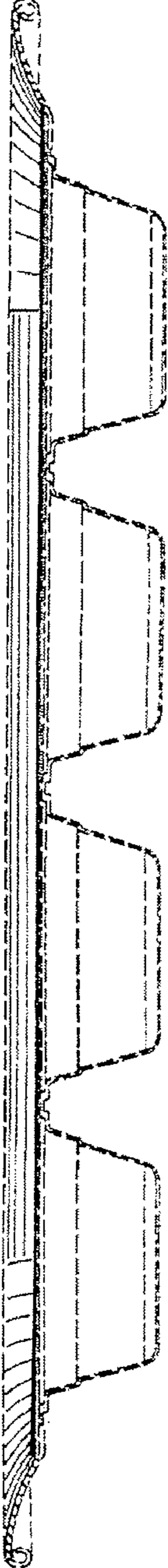

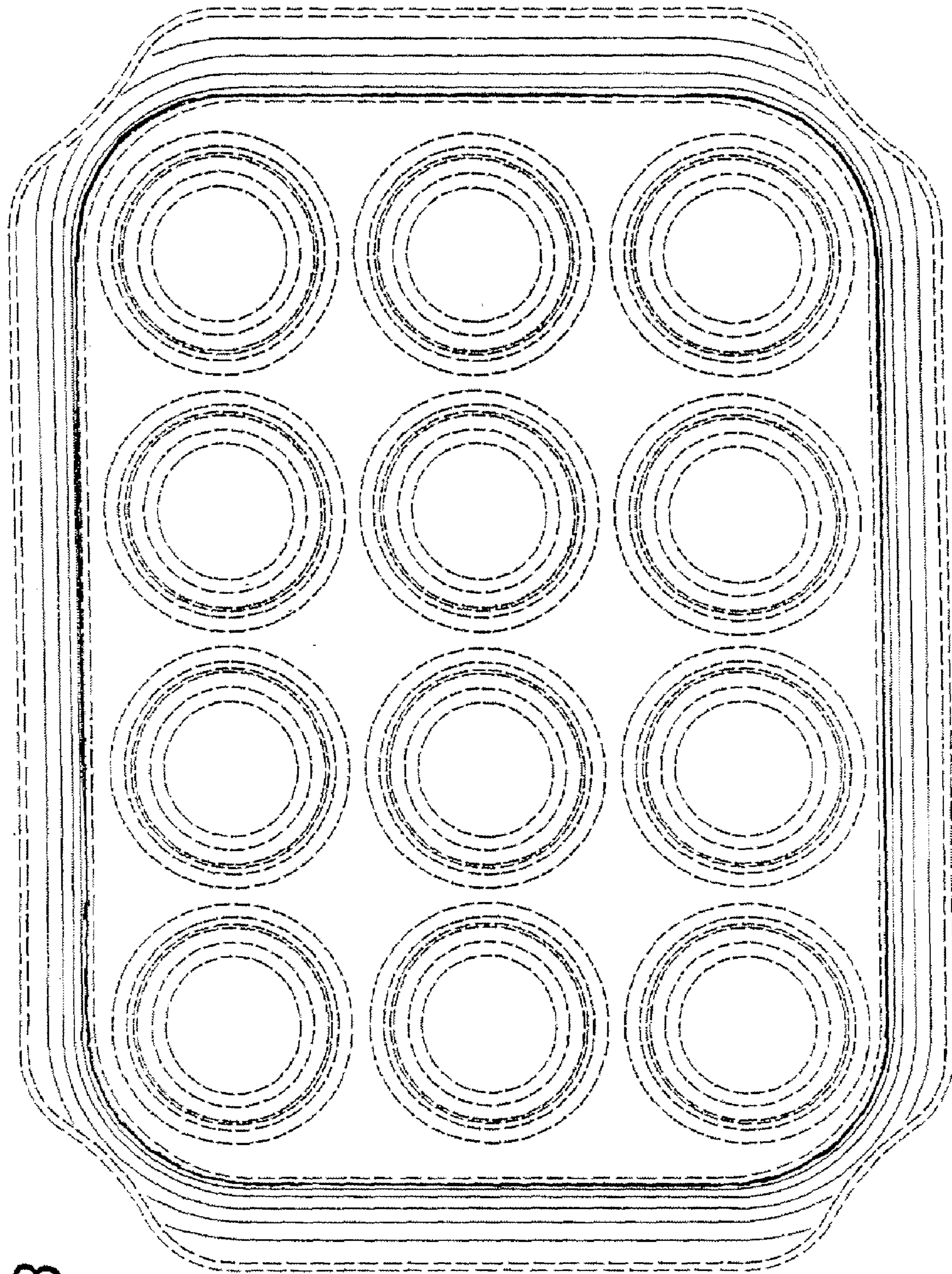

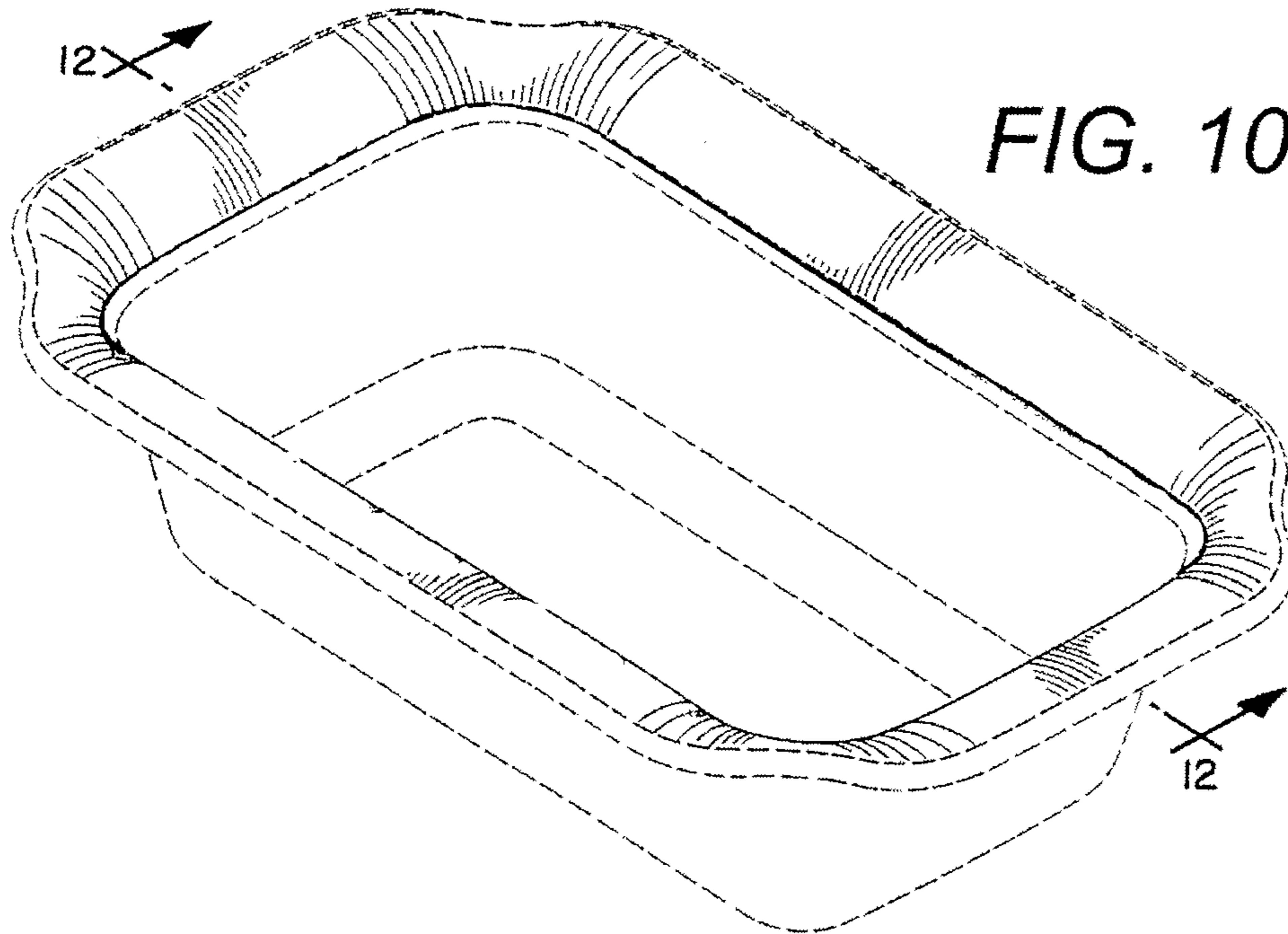

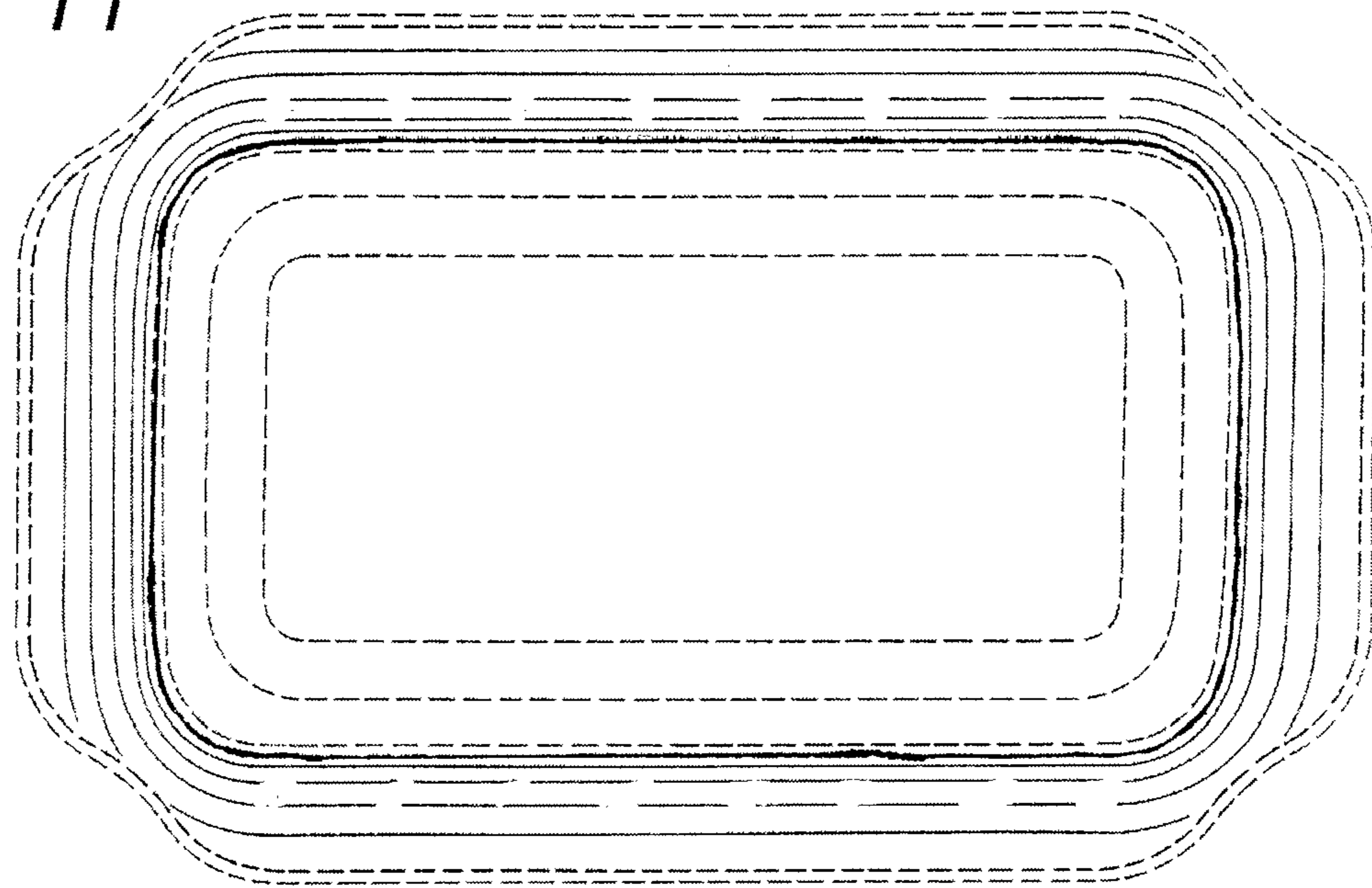

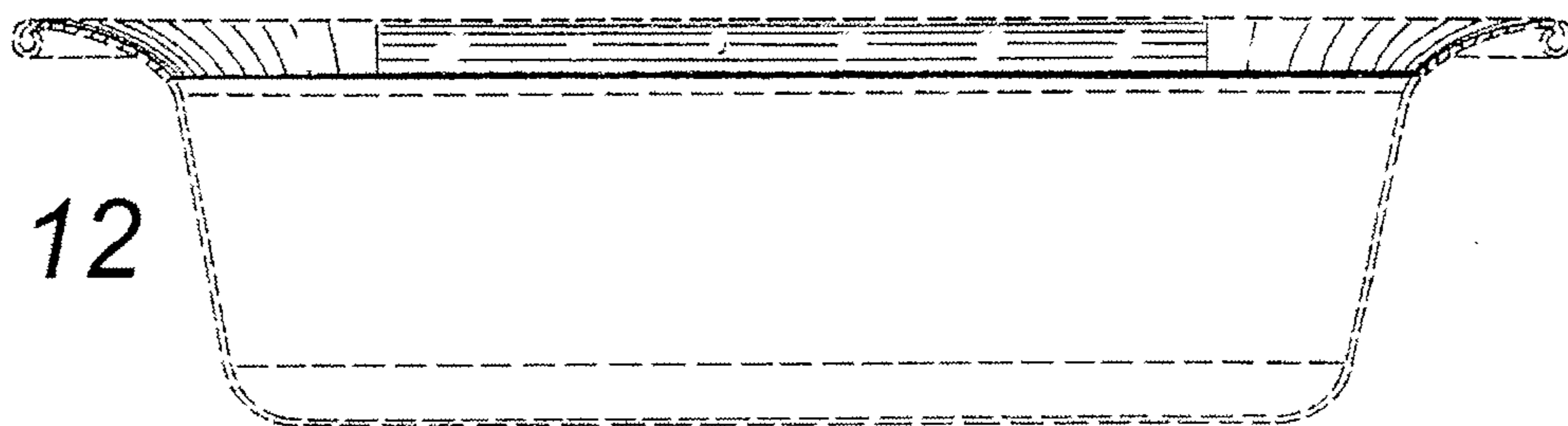
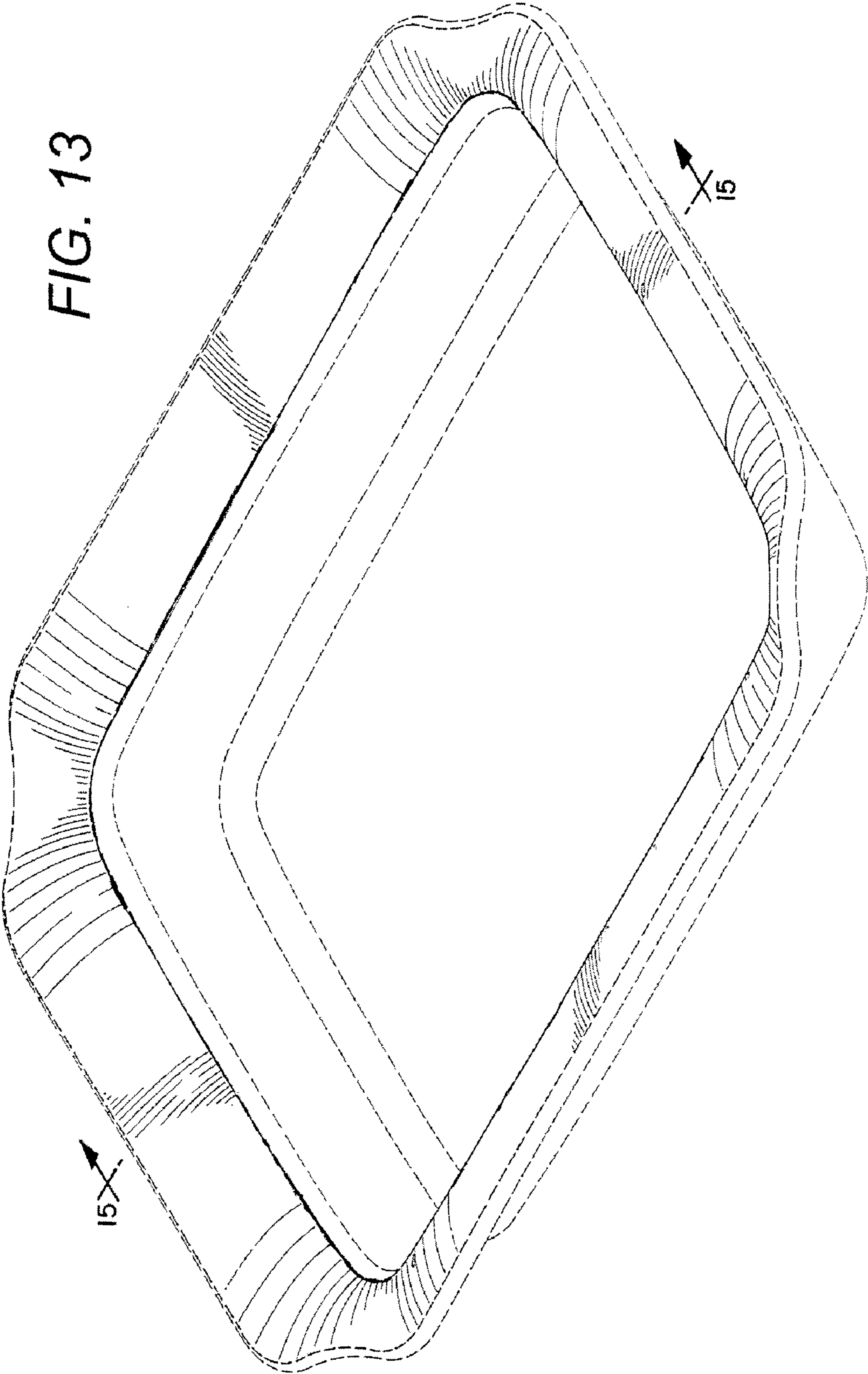

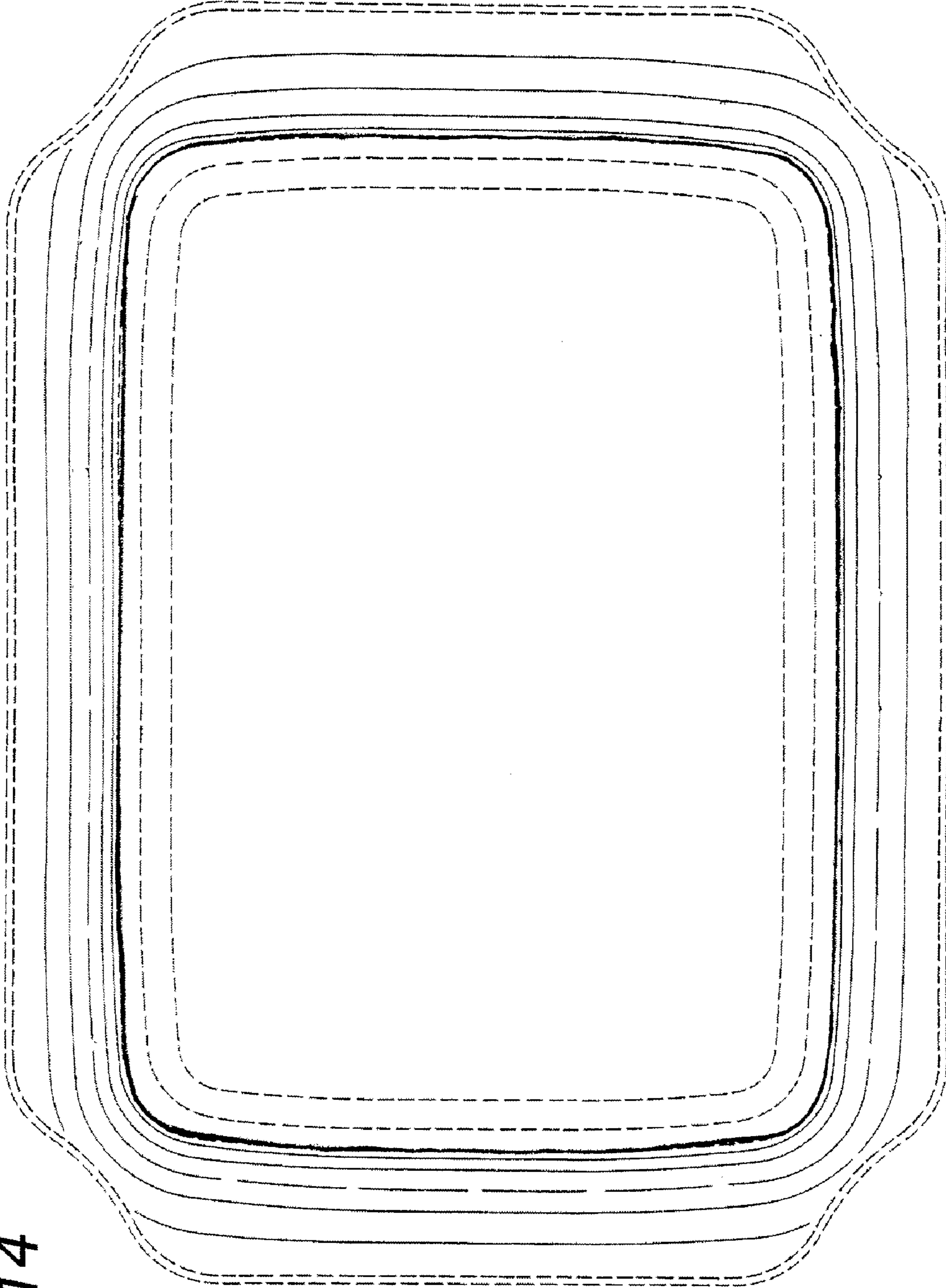
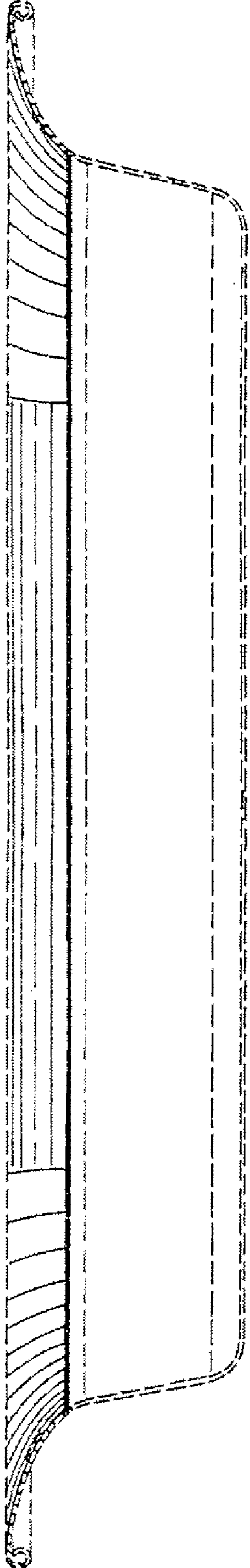

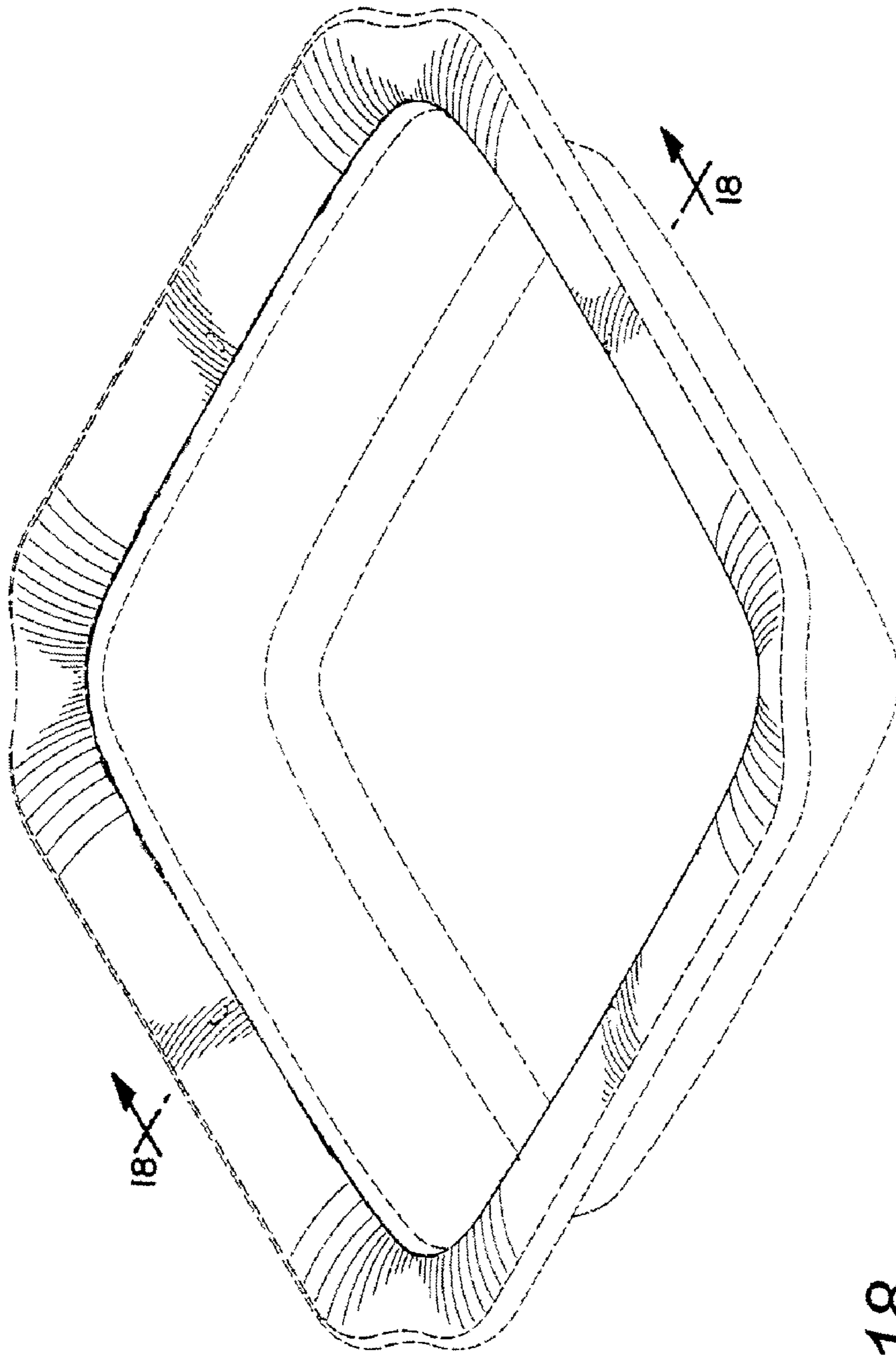
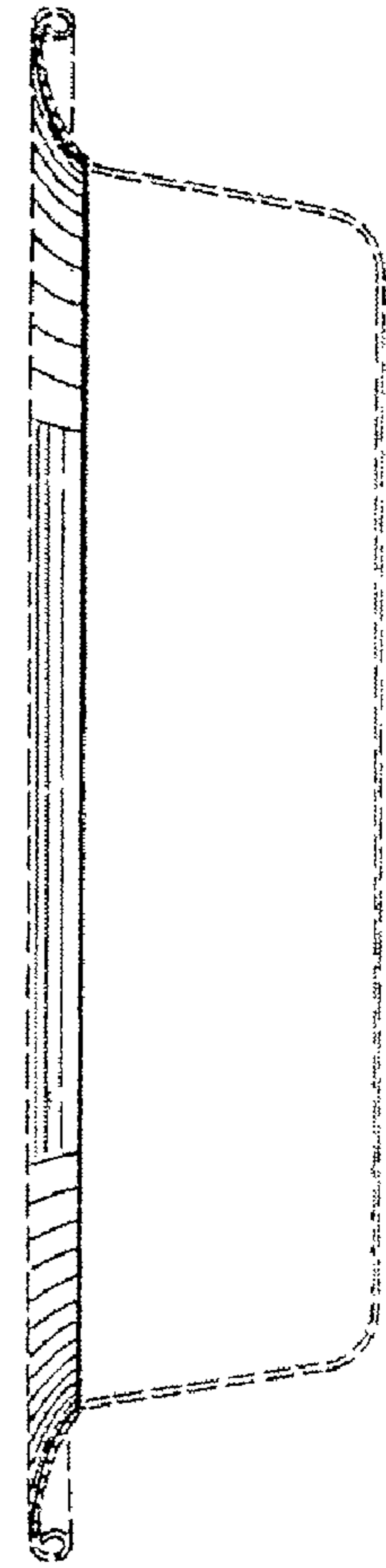

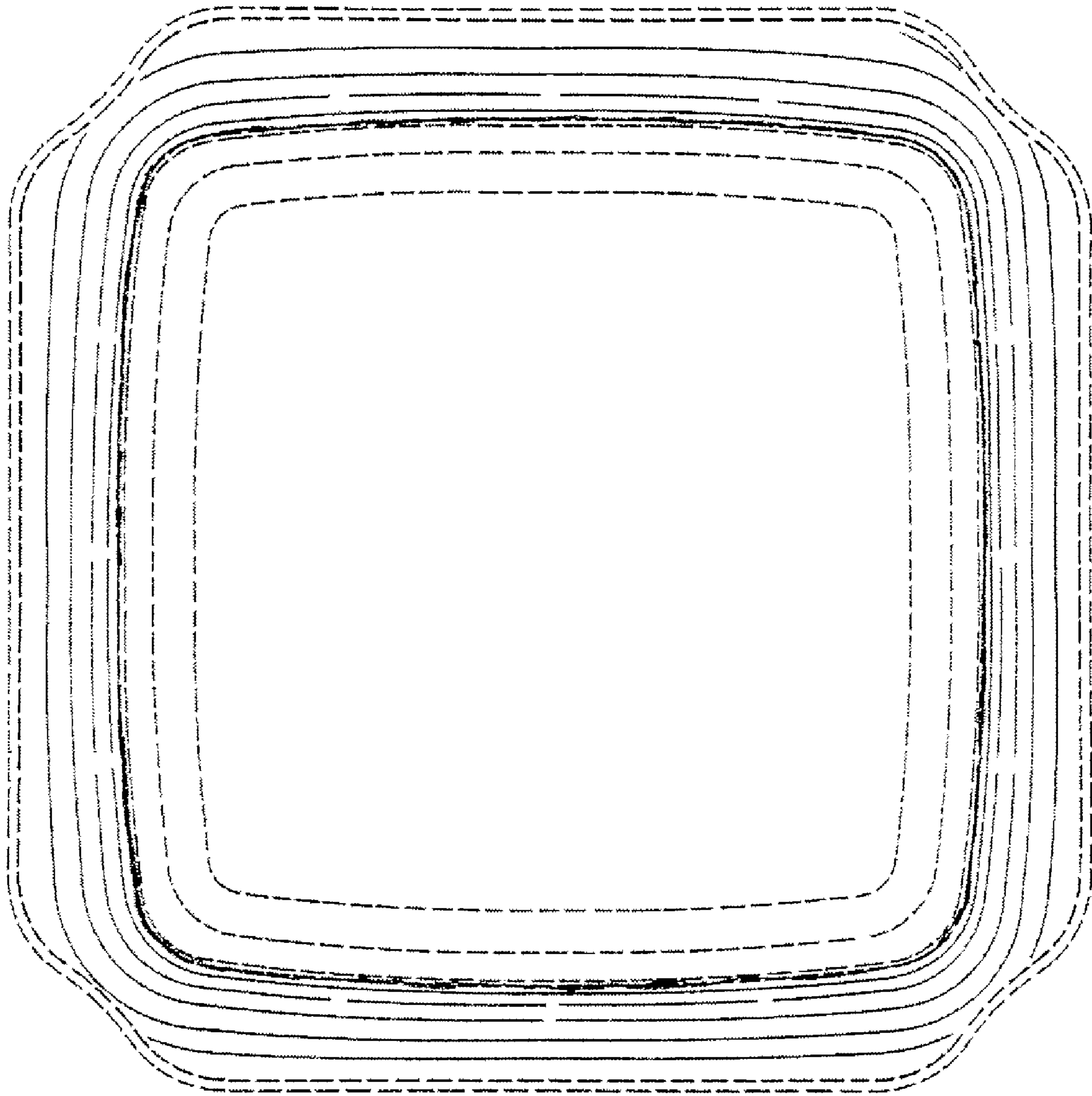

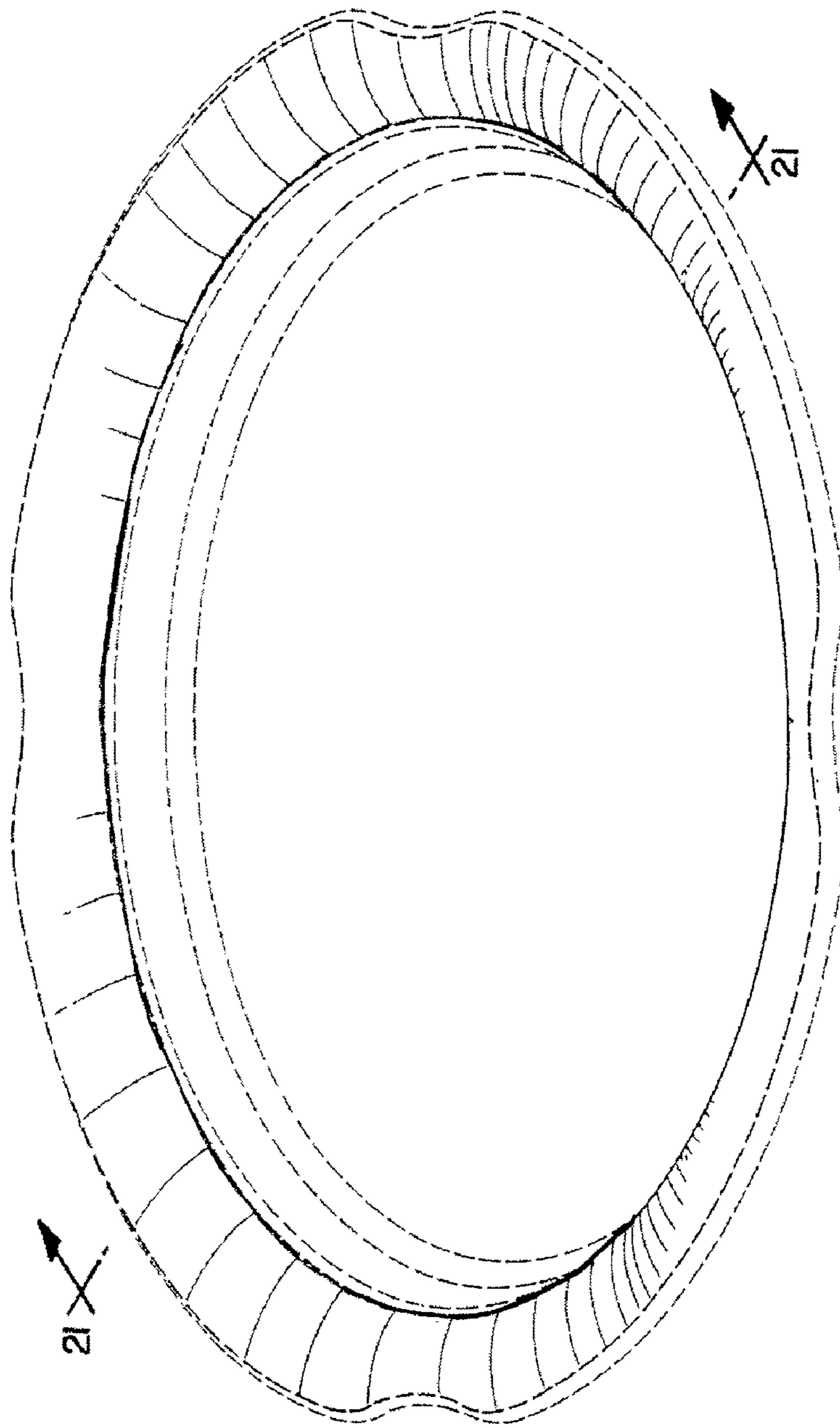
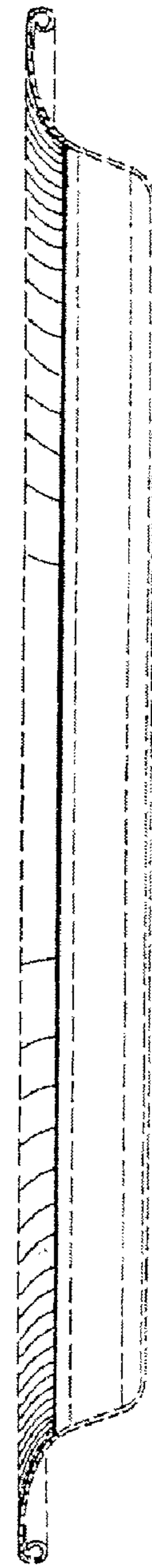

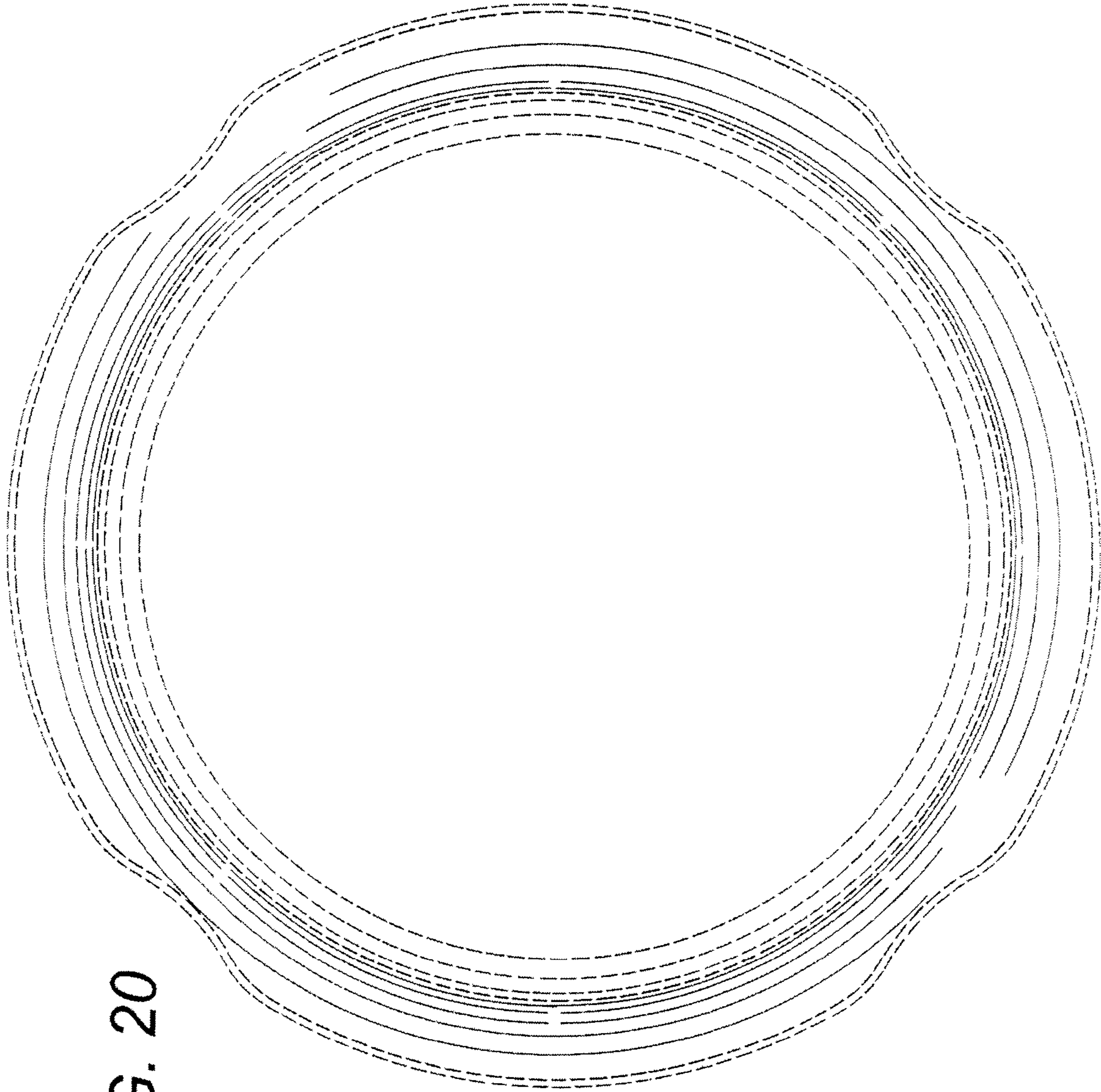

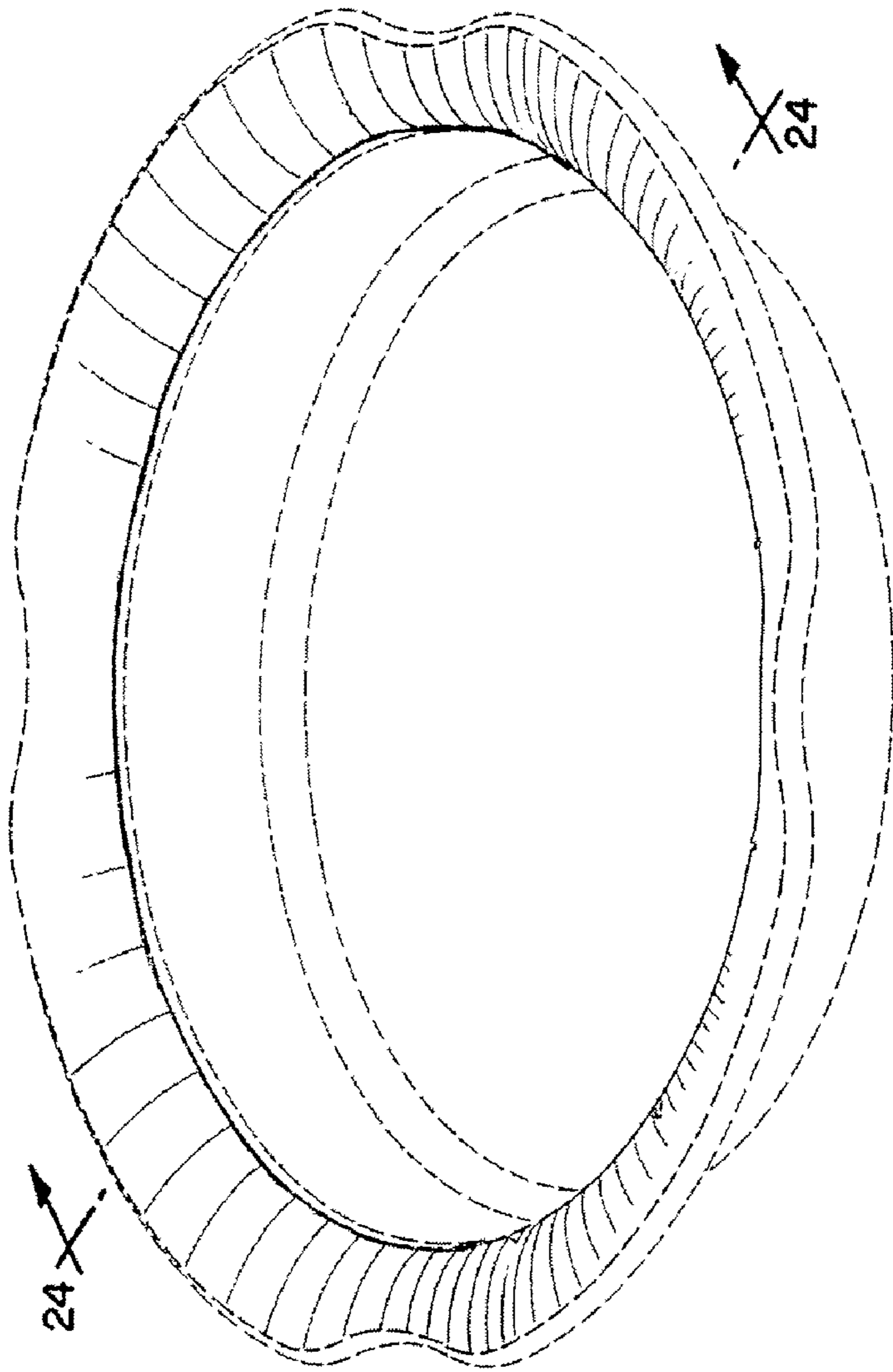

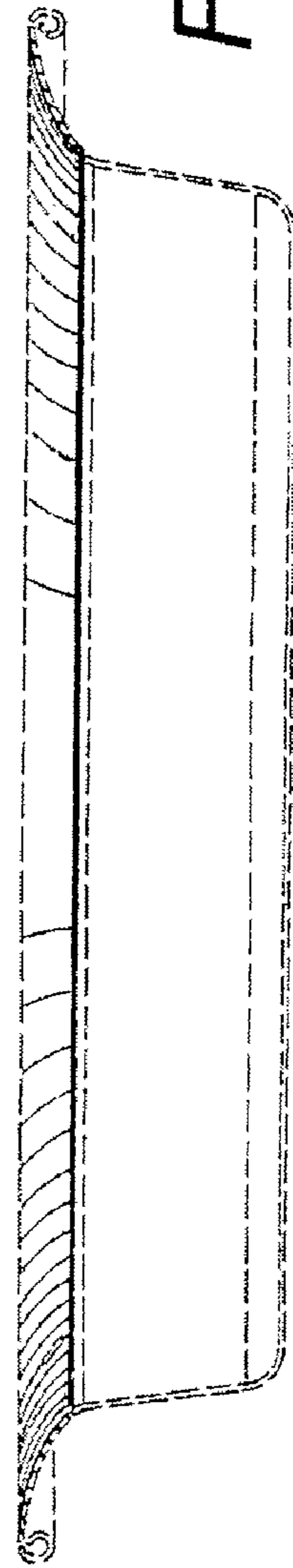

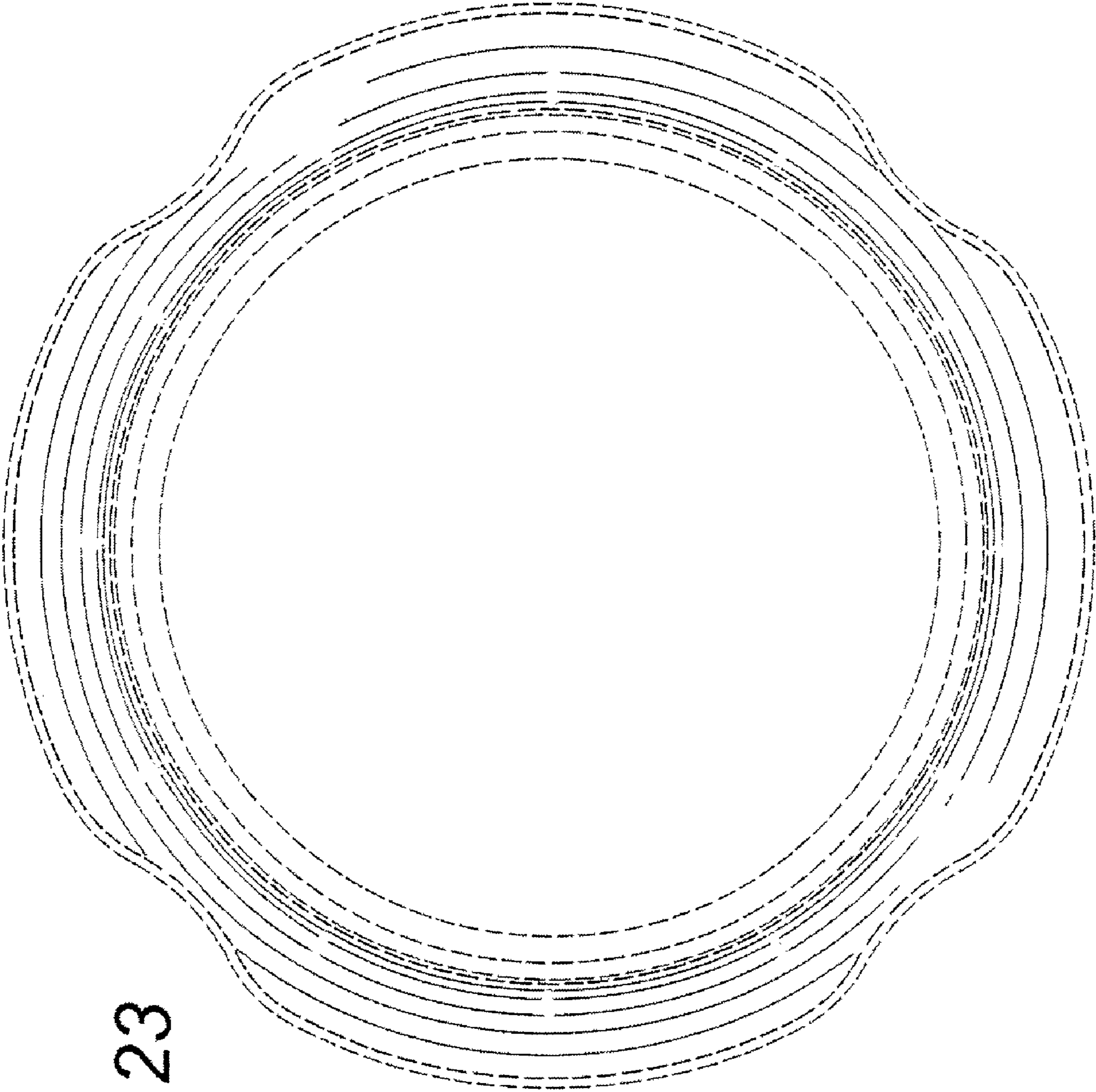
