(57) **CLAIM**

I claim the ornamental design for a cup holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cup holder, the elements shown in phantom forming no part of the claimed design;

FIG. 2 is a left side view of the cup holder, the elements shown in phantom forming no part of the claimed design;

FIG. 3 is a right side view of the cup holder, the elements shown in phantom forming no part of the claimed design;

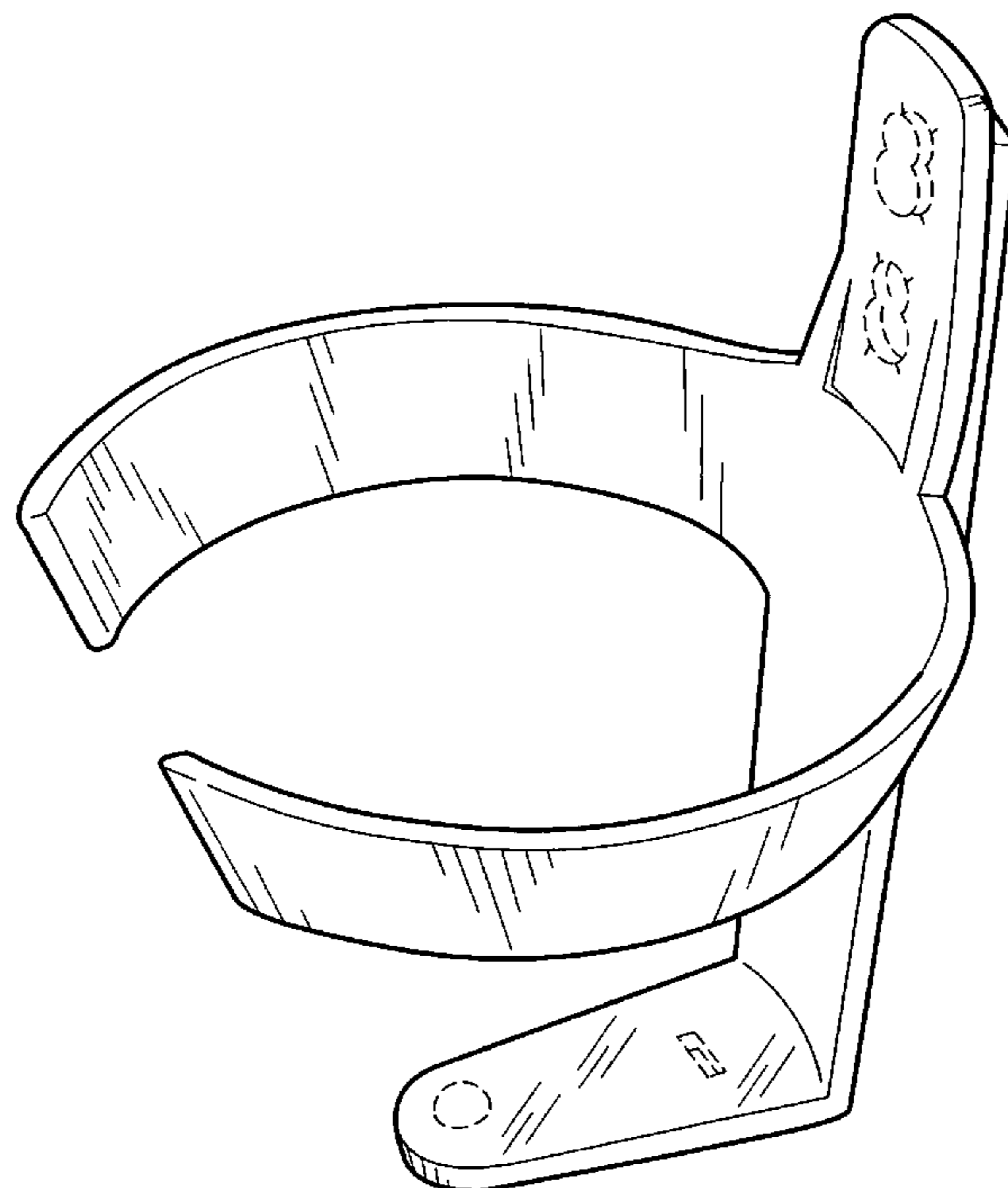
FIG. 4 is a front view of the cup holder, the elements shown in phantom forming no part of the claimed design;

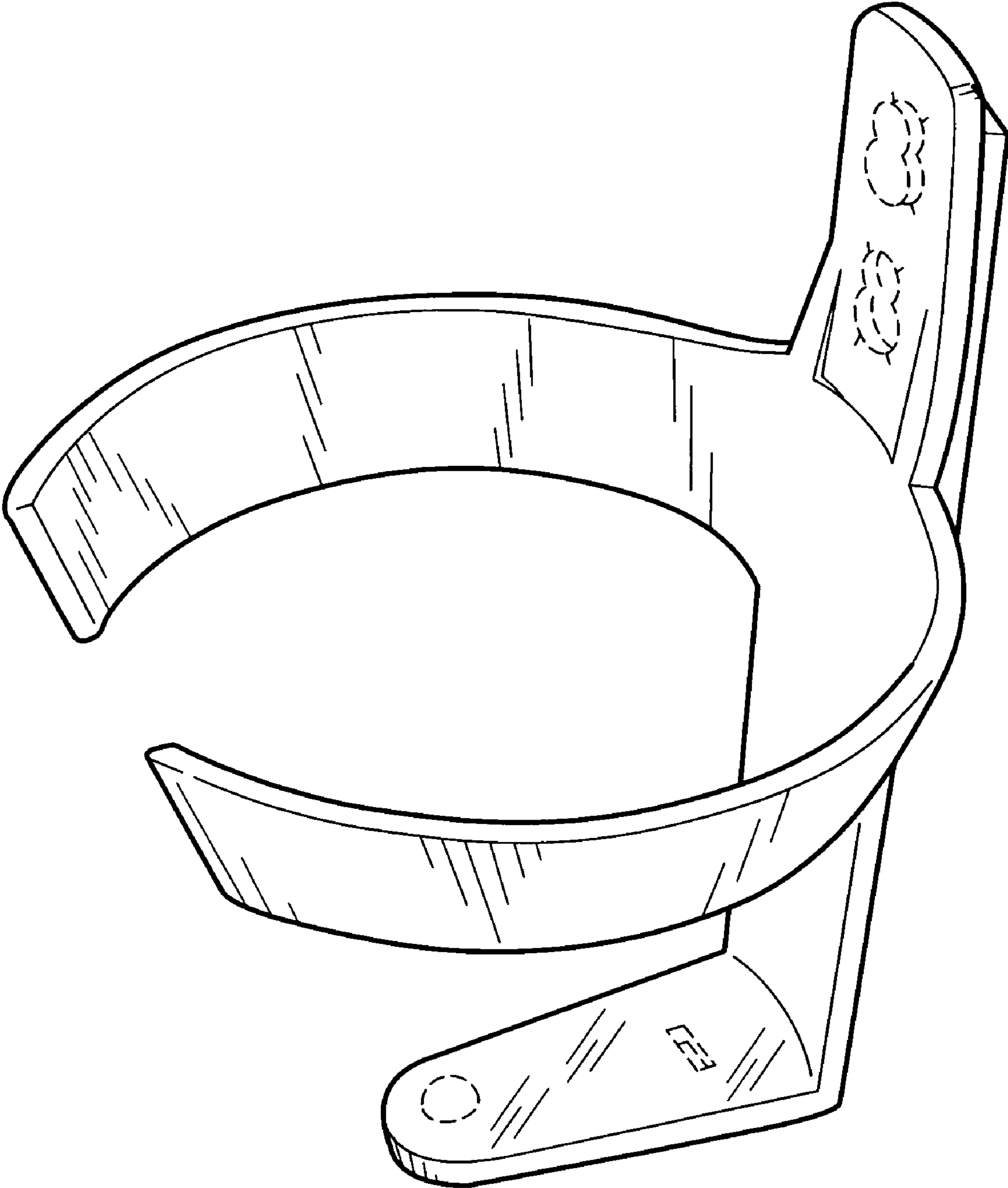

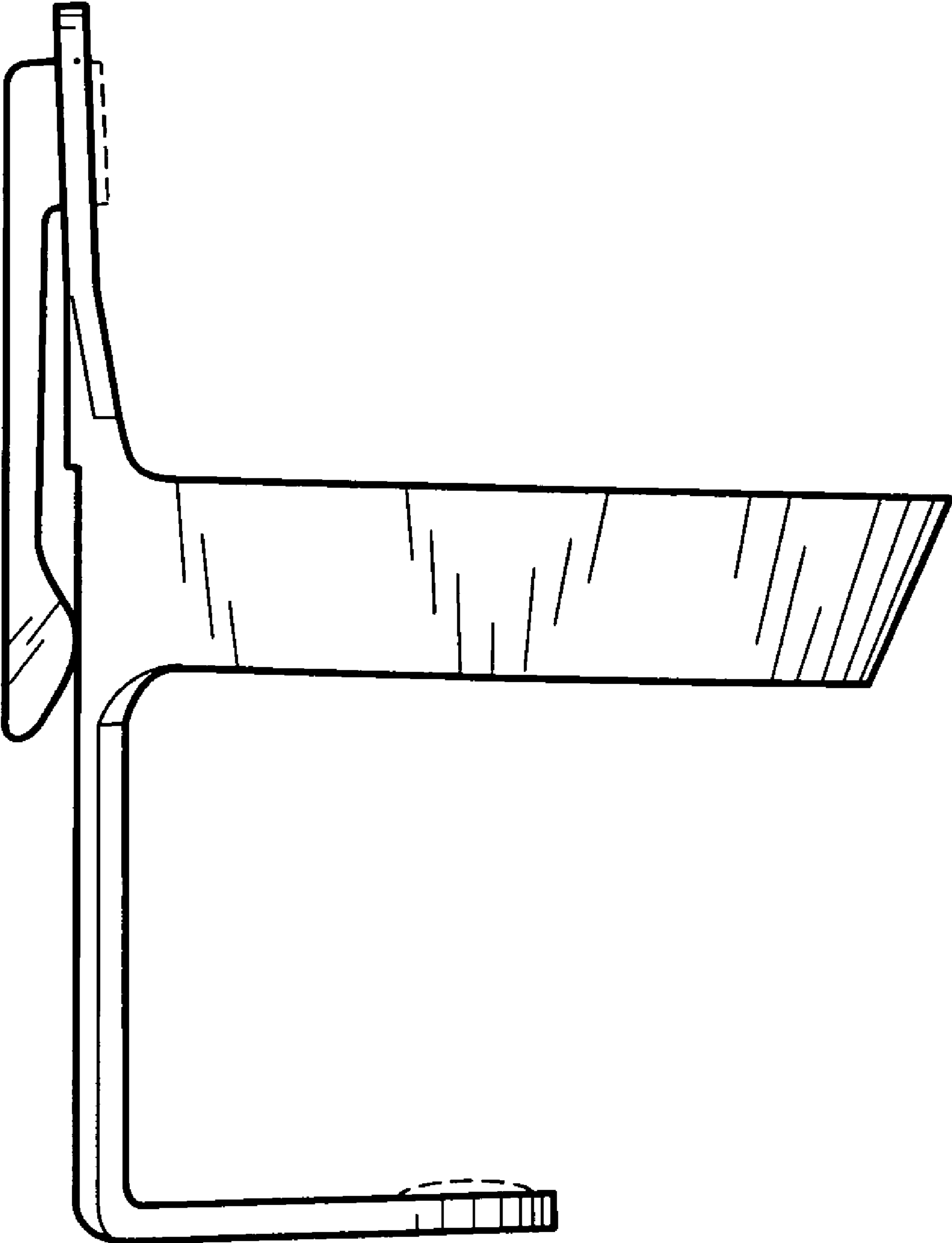

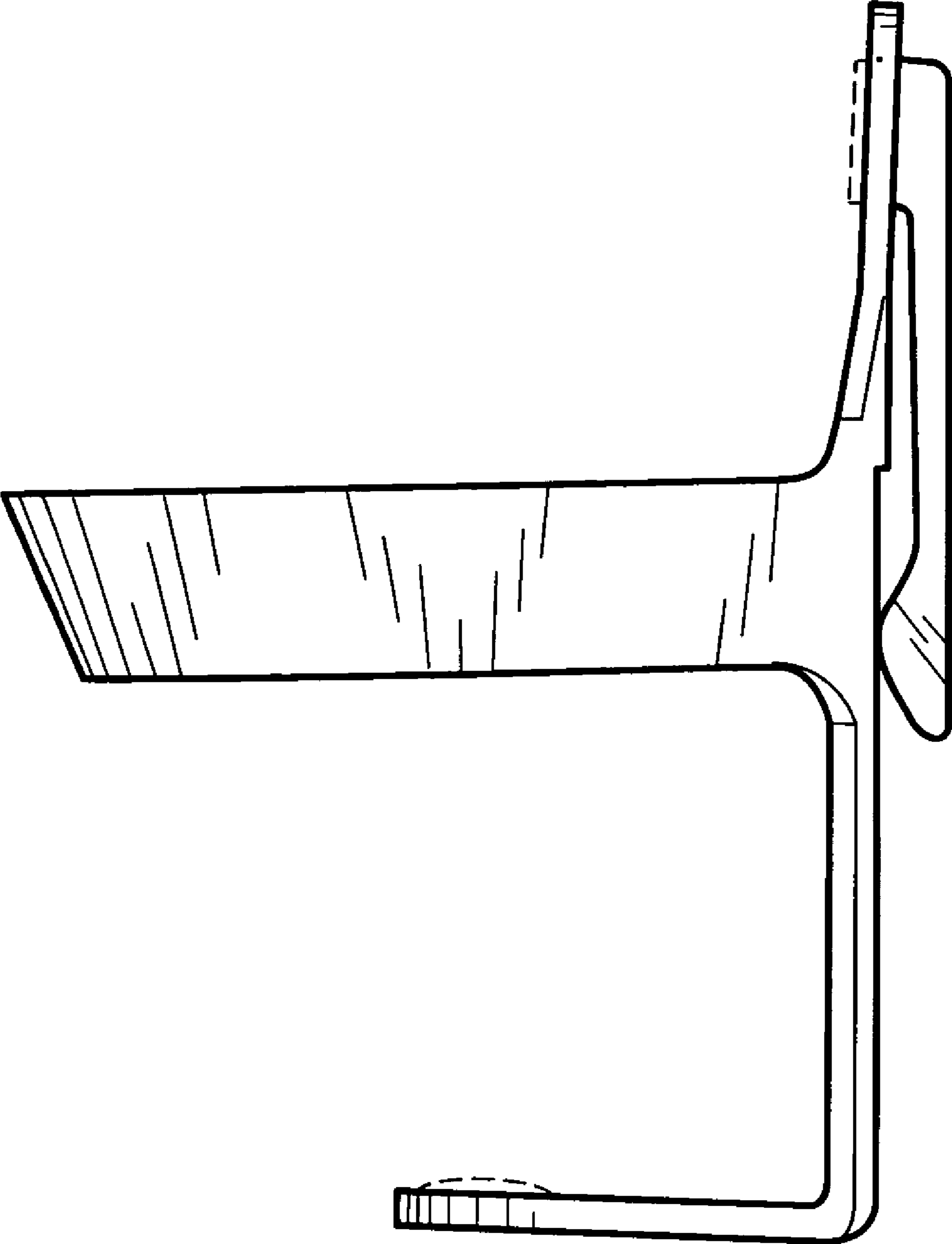

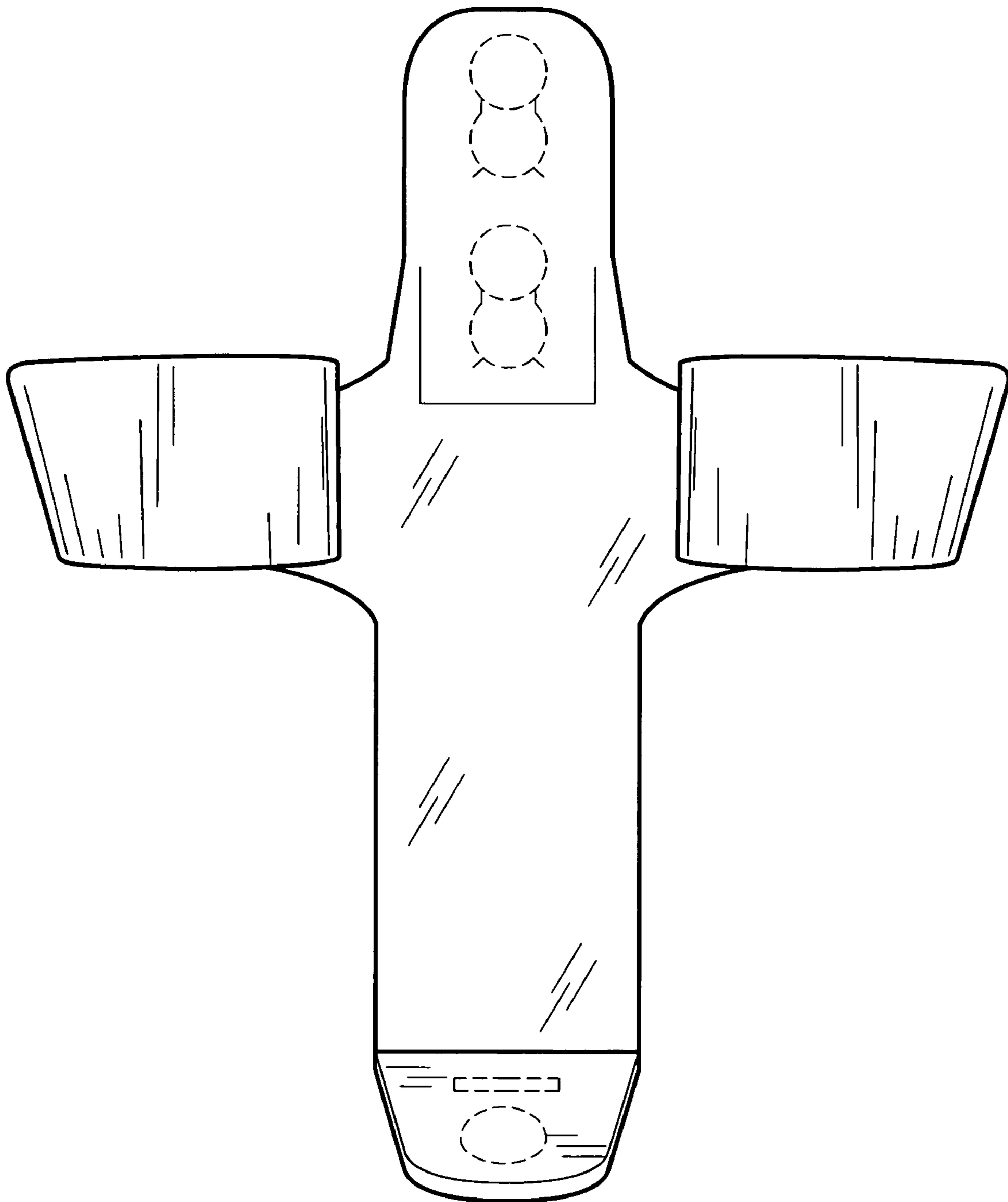

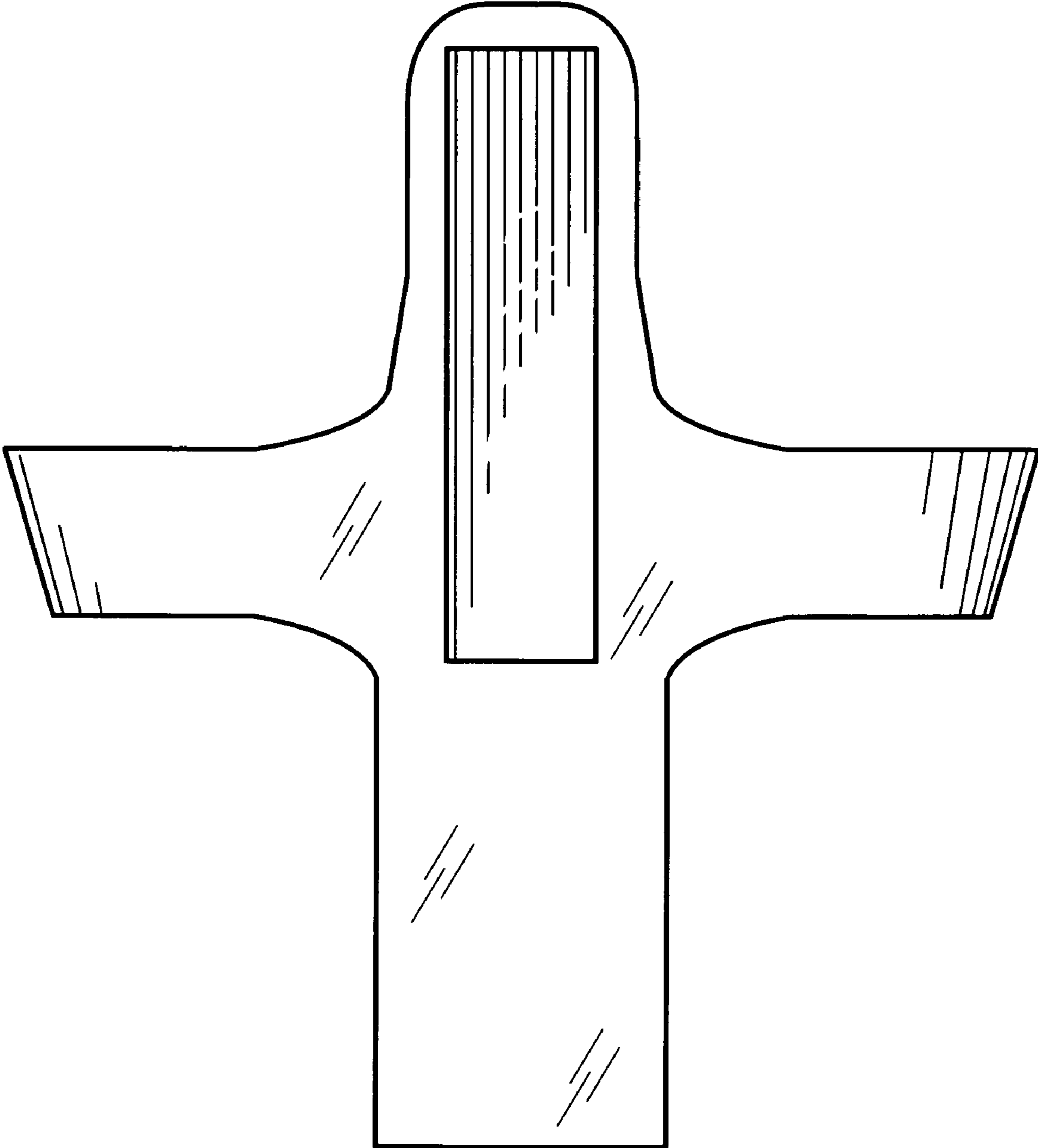

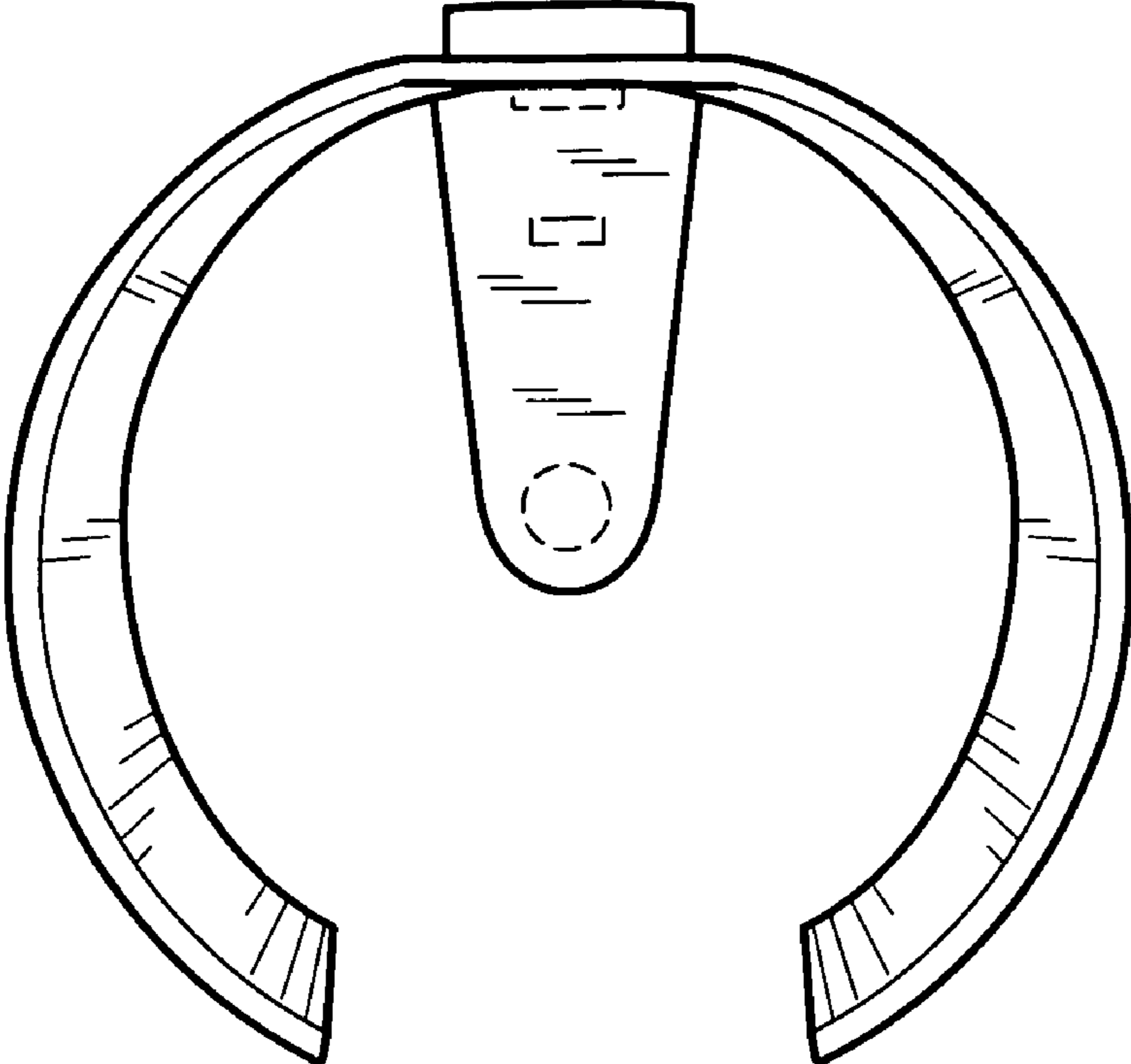

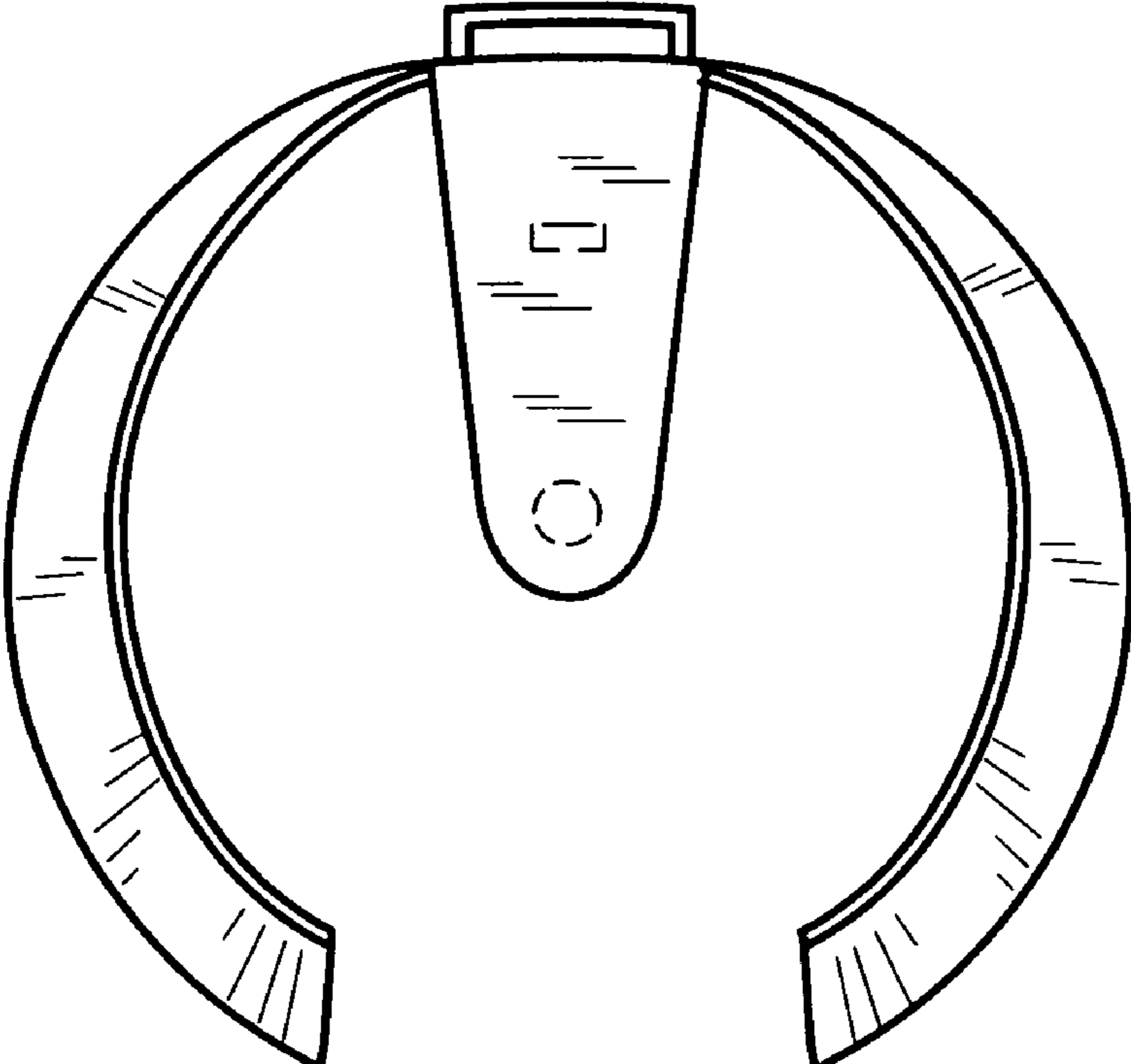
