(57) **CLAIM**

The ornamental design for a surface-preparation-tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a right and front side perspective view of a first embodiment of a surface-preparation-tool handle showing the new design, the left and right sides being mirror images of one another and the front and back sides being mirror images of one another;

FIG. 2 is a right side elevational view of the handle of FIG. 1;

FIG. 3 is a front side view of the handle of FIG. 1, the front and back sides being mirror images of one another;

FIG. 4 is a front end view of the handle of FIG. 1;

FIG. 5 is rear end view of the handle of FIG. 1;

FIG. 6 is a right and front side perspective view of a second embodiment of a surface-preparation-tool handle showing the new design, the left and right sides being mirror images of one another and the front and back sides being mirror images of one another;

FIG. 7 is a right side elevational view of the handle of FIG. 6;

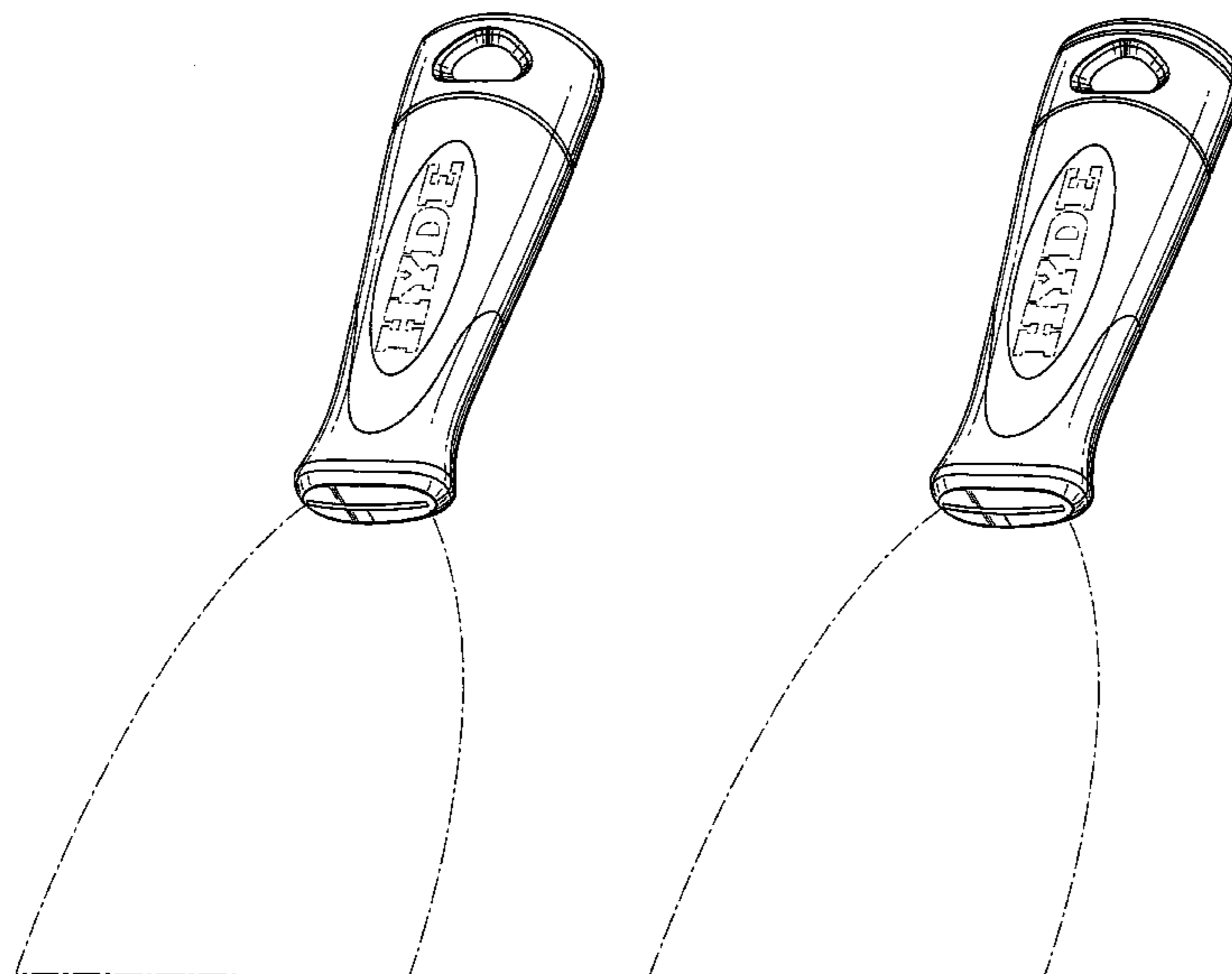
FIG. 8 is a front side view of the handle of FIG. 6, the front and back sides being mirror images of one another;

FIG. 9 is a front end view of the handle of FIG. 6; and,

FIG. 10 is rear end view of the handle of FIG. 6.

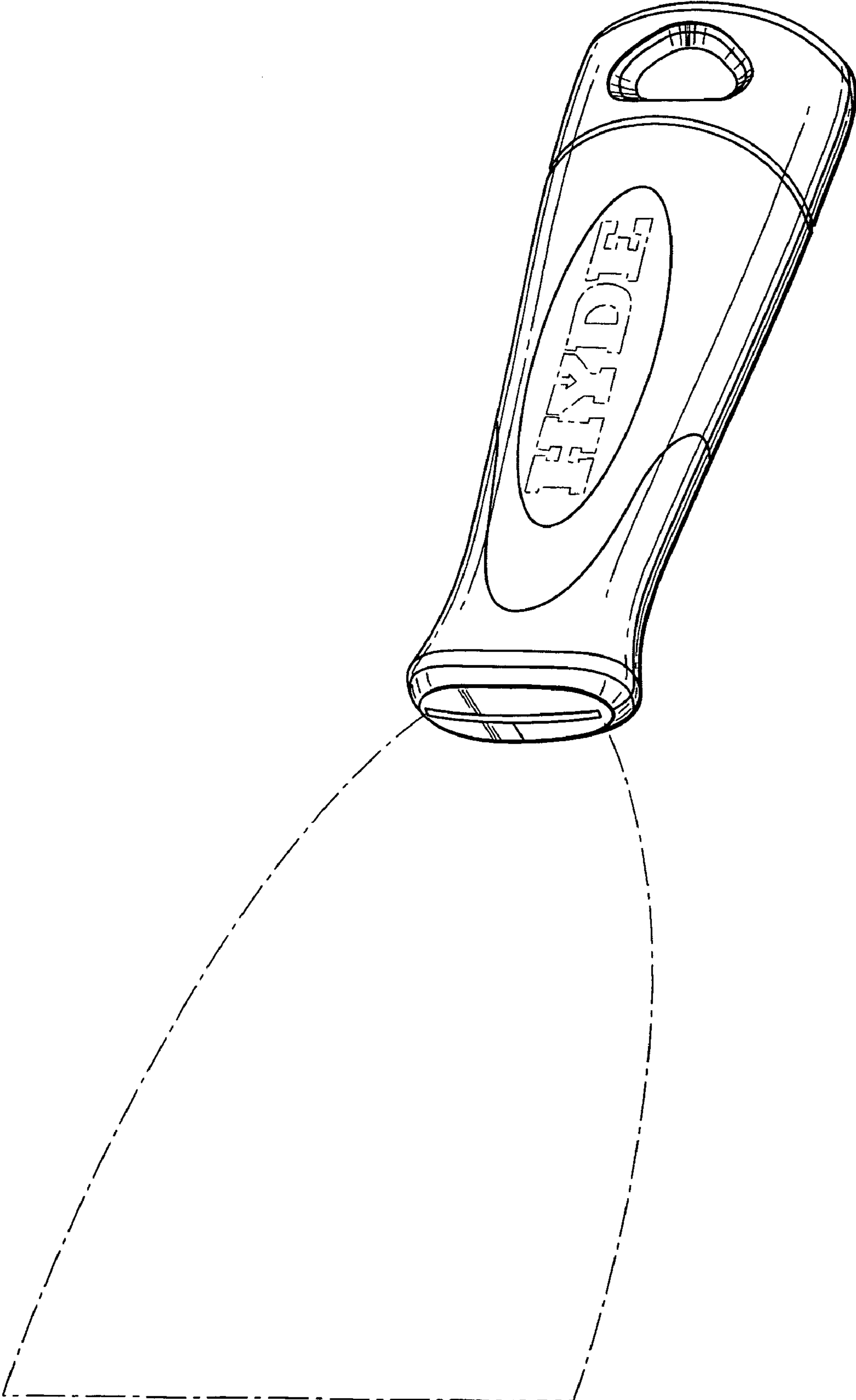

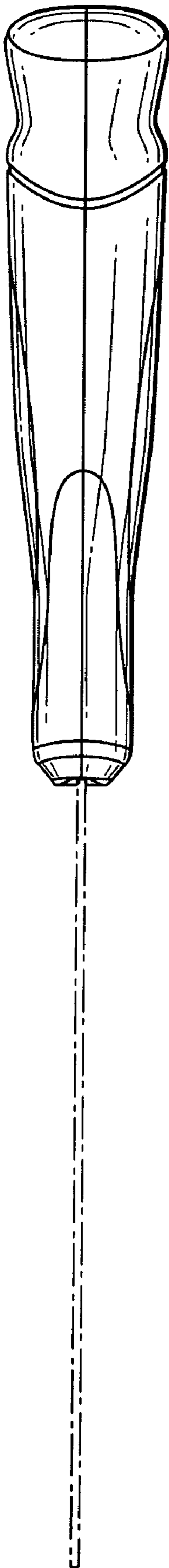

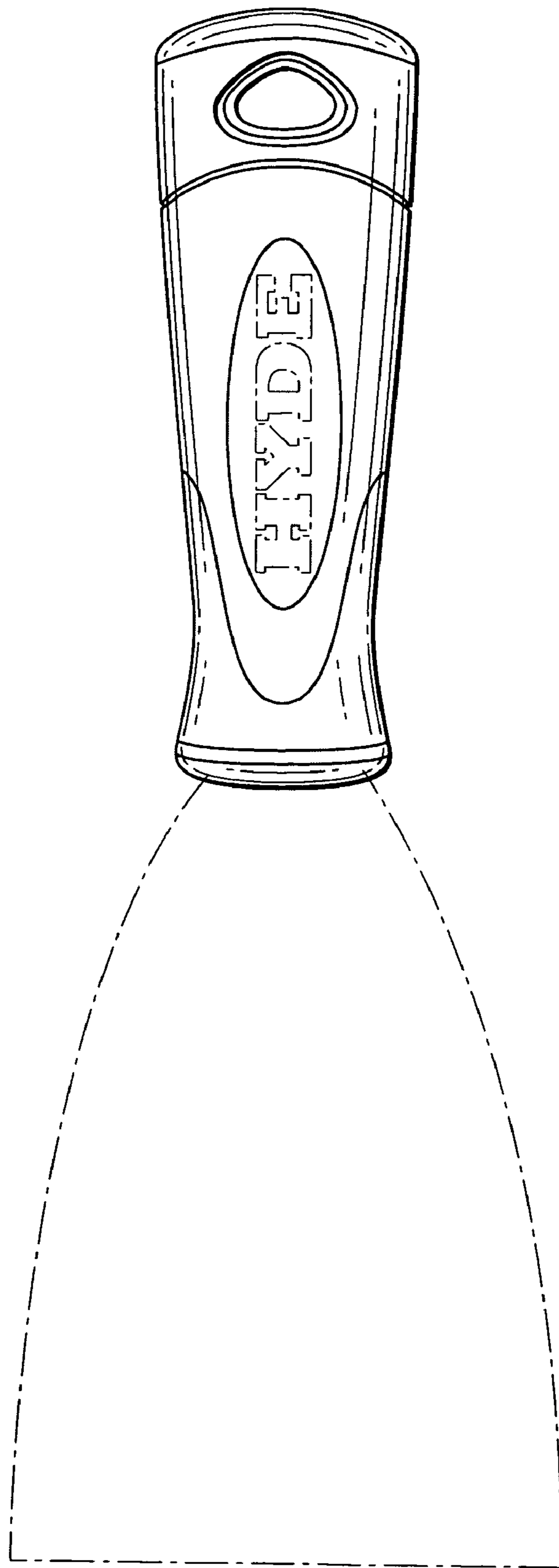

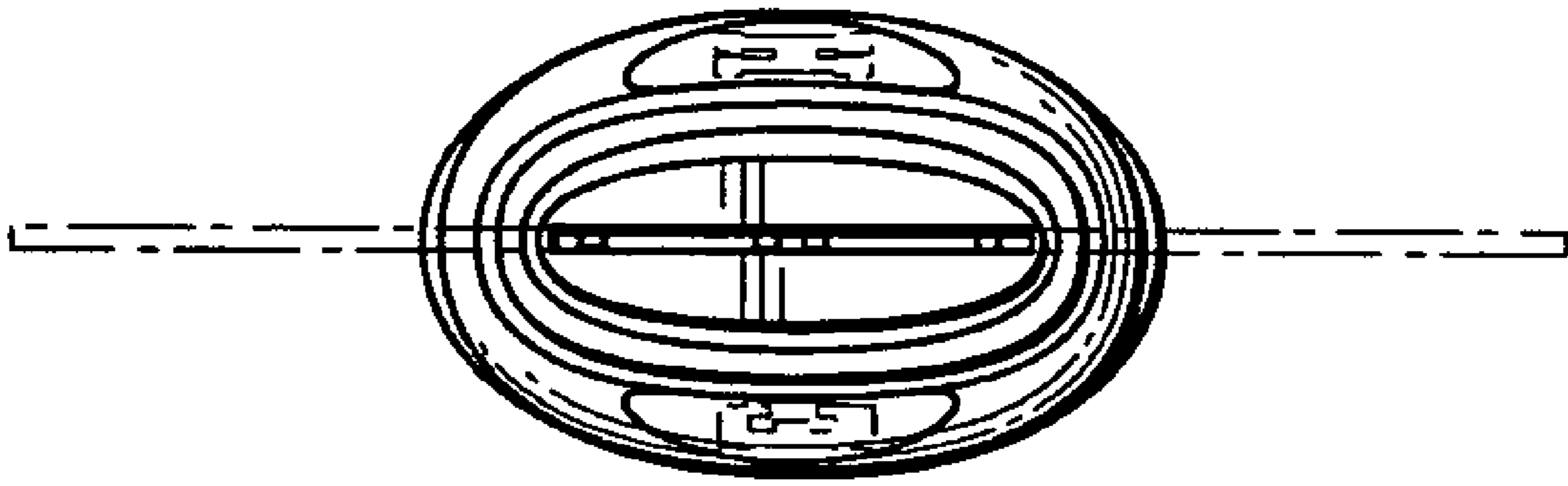

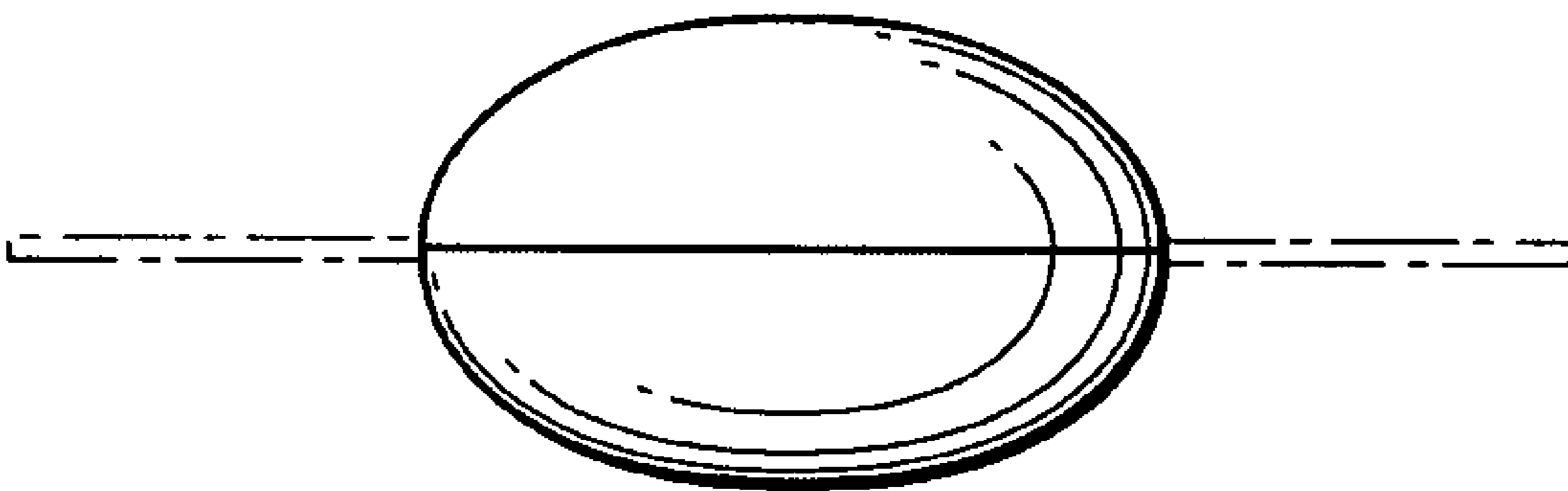

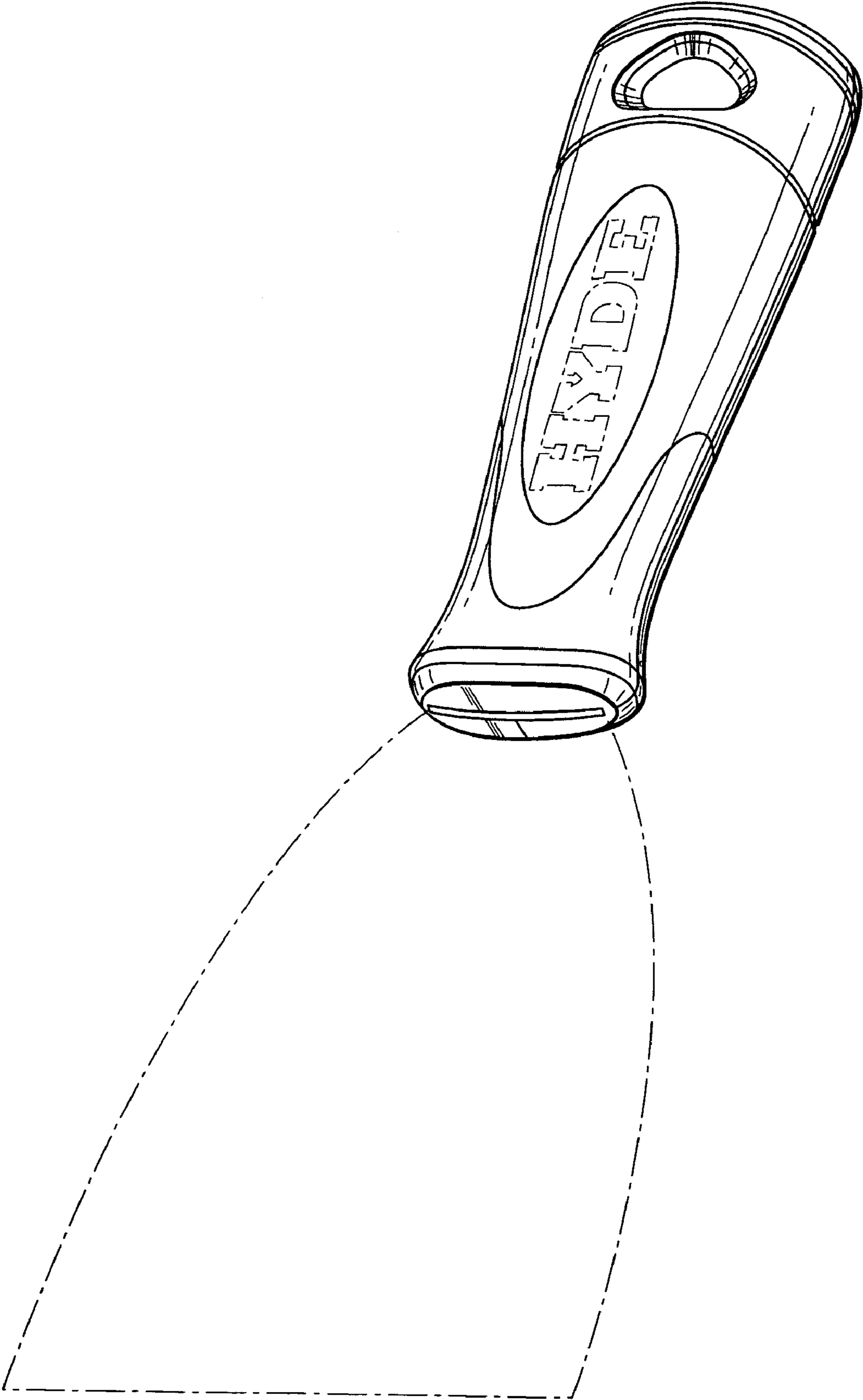

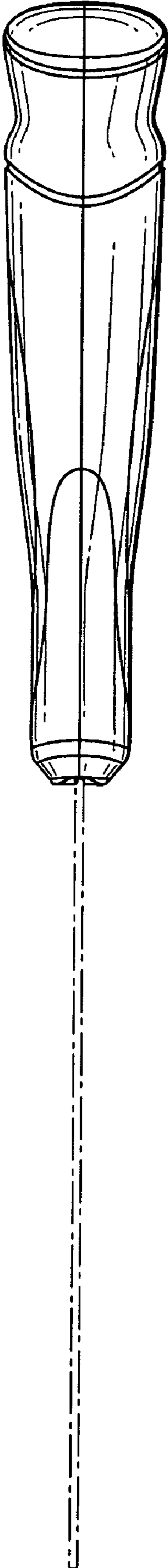

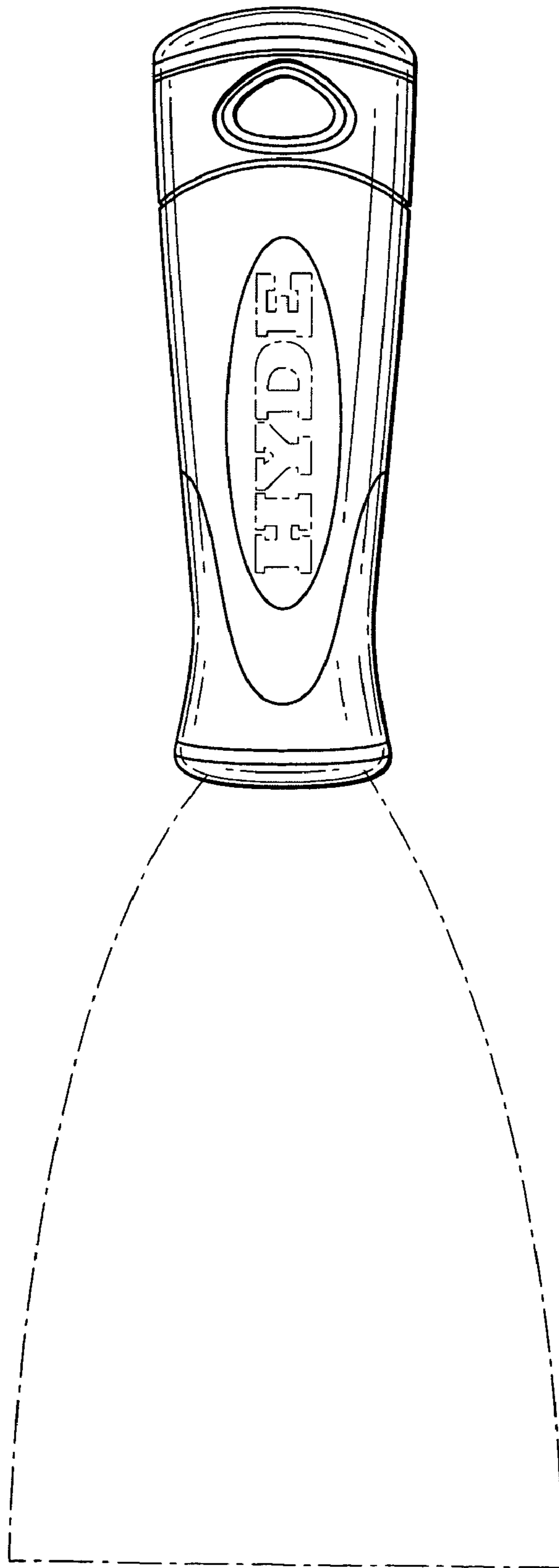

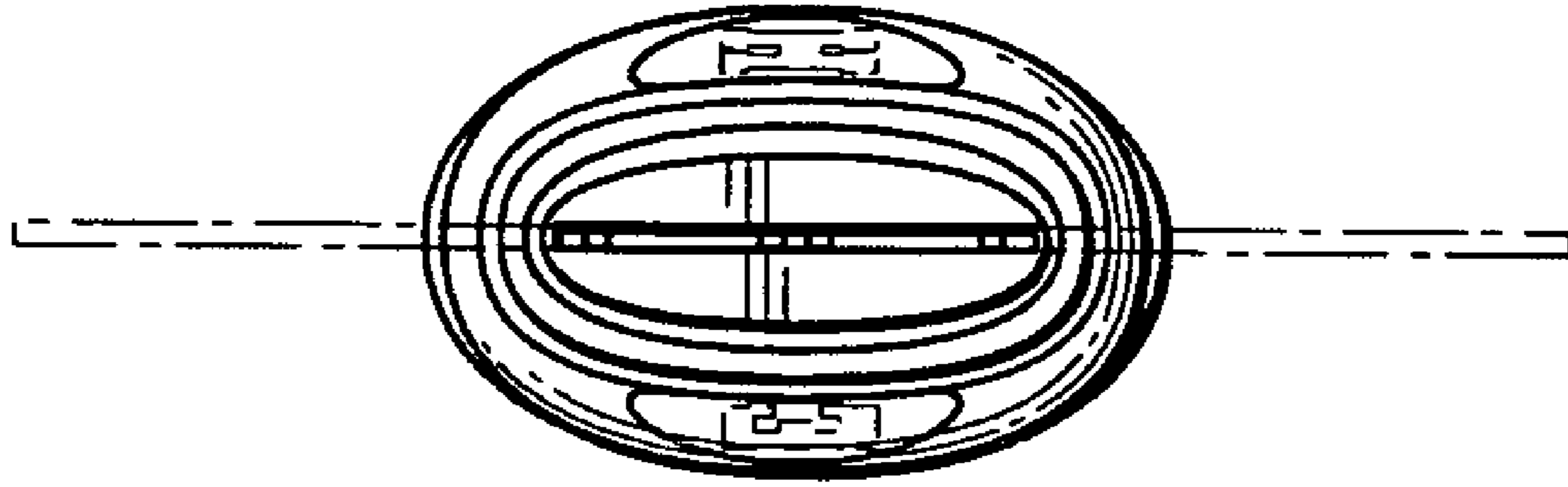

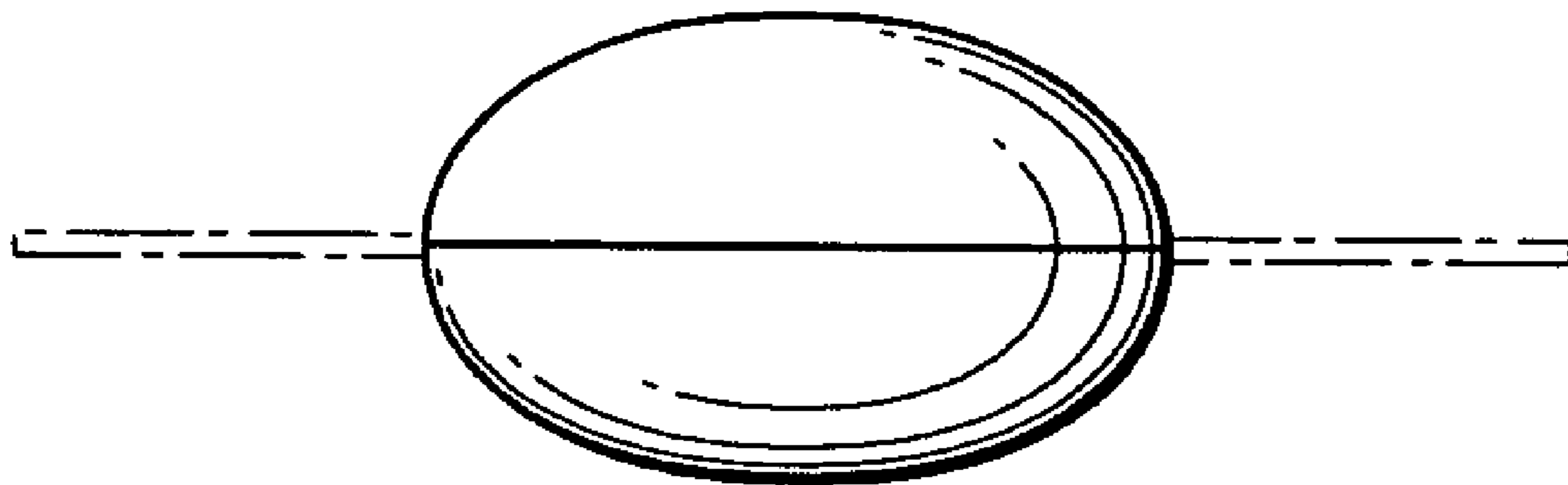
