(57) **CLAIM**

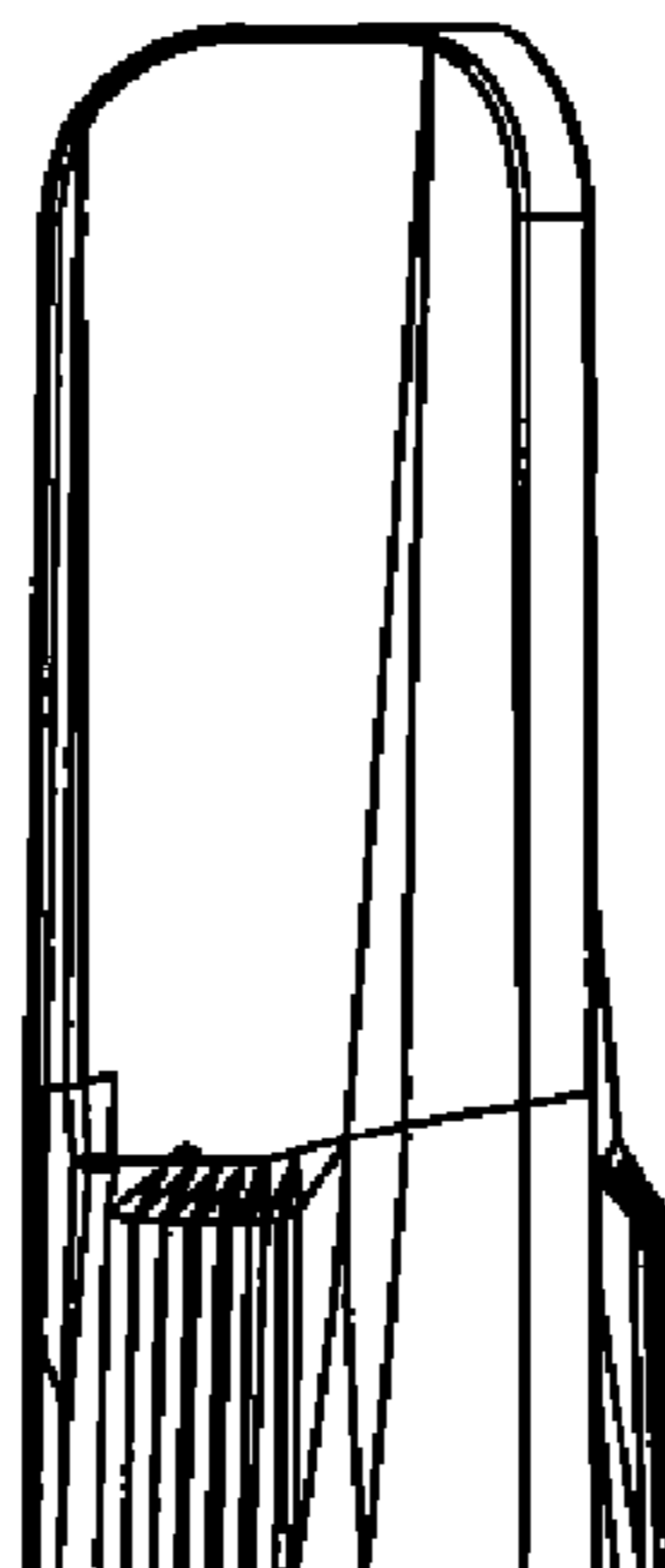
The ornamental design for a cap with nozzle, as shown and described.

**DESCRIPTION**

- FIG. 1 is a front elevation view the new design;
- FIG. 2 is a side elevation view thereof;
- FIG. 3 is a rear elevation view thereof;
- FIG. 4 is a side elevation view thereof opposite from FIG. 2;
- FIG. 5 is a top plan view thereof;
- FIG. 6 is a top and side perspective view thereof; and,

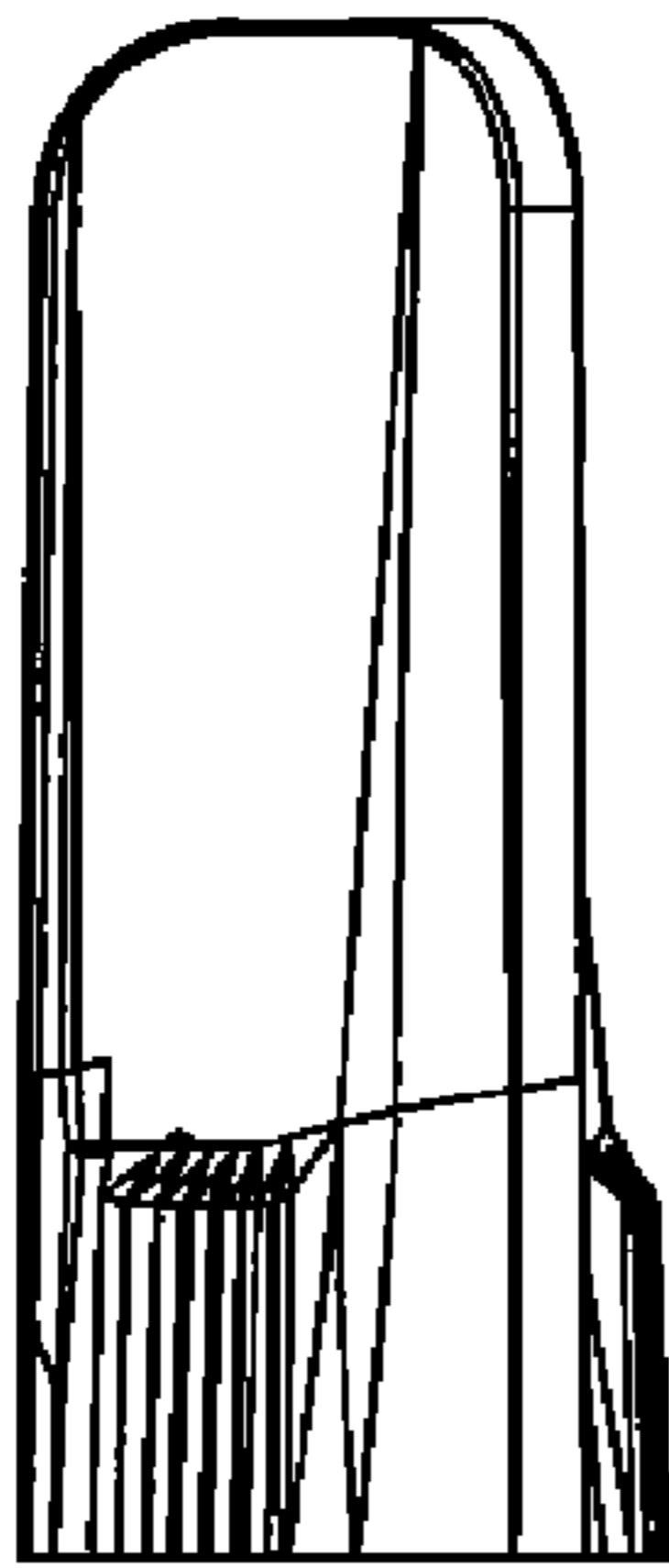

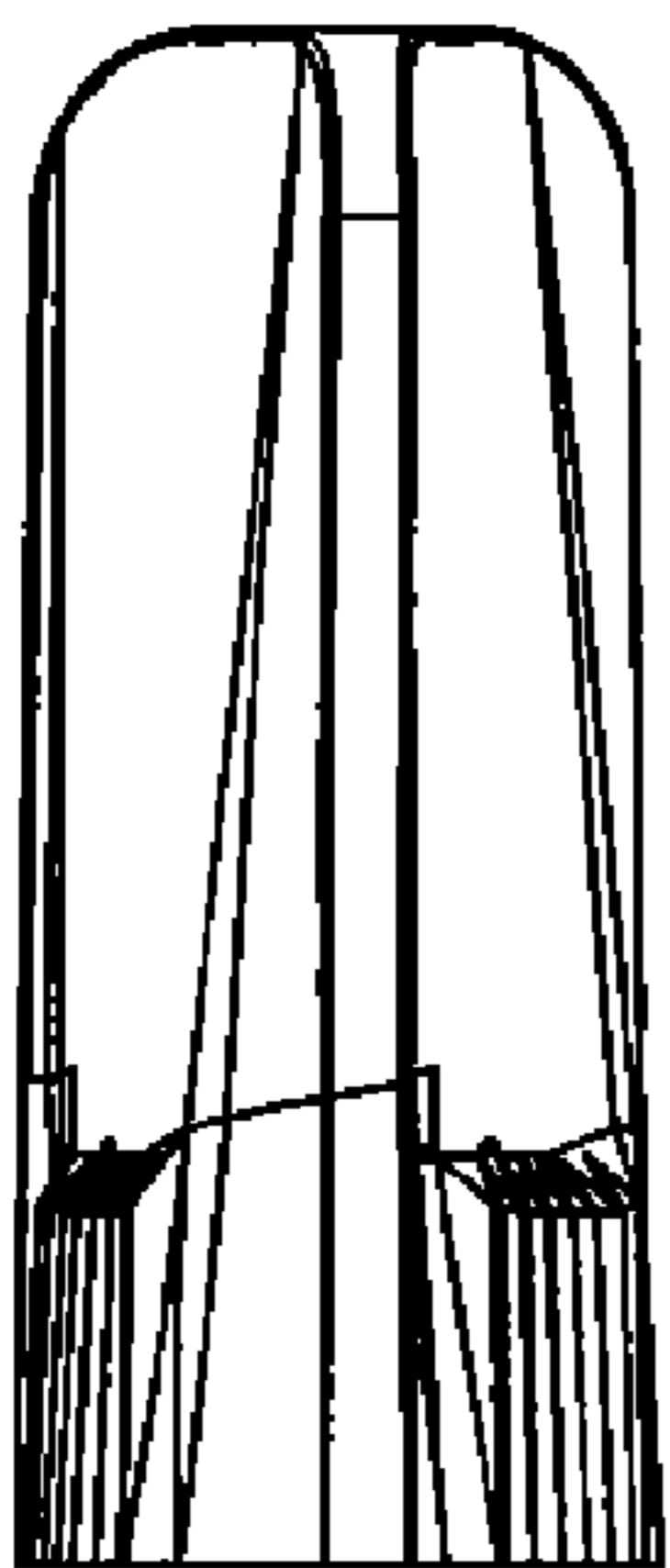

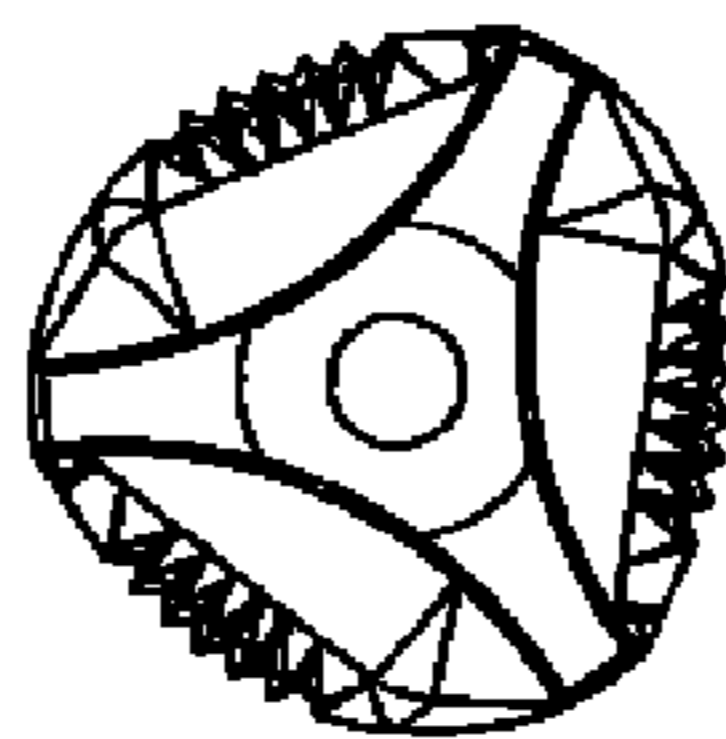

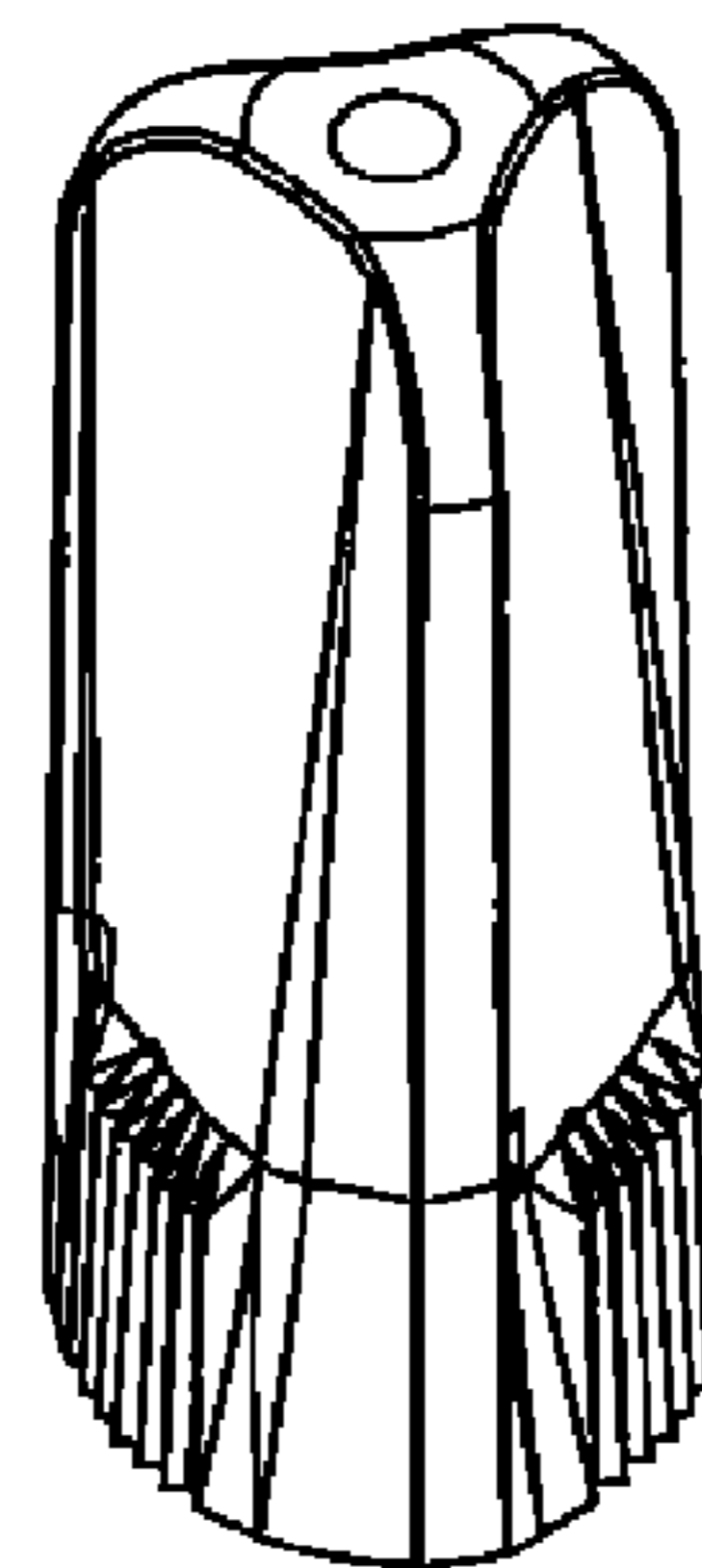

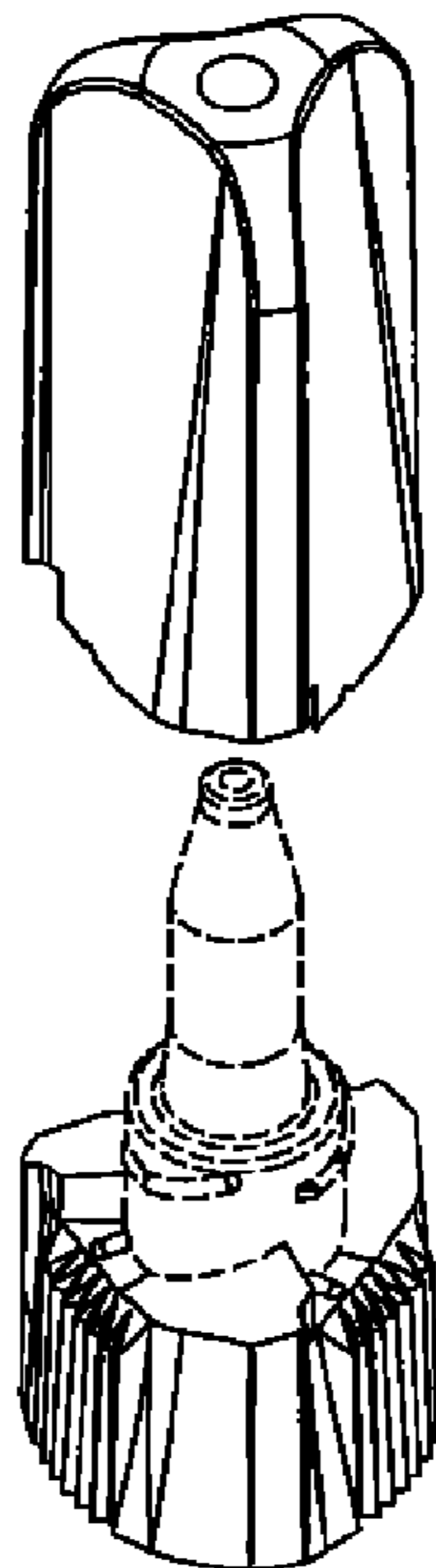
