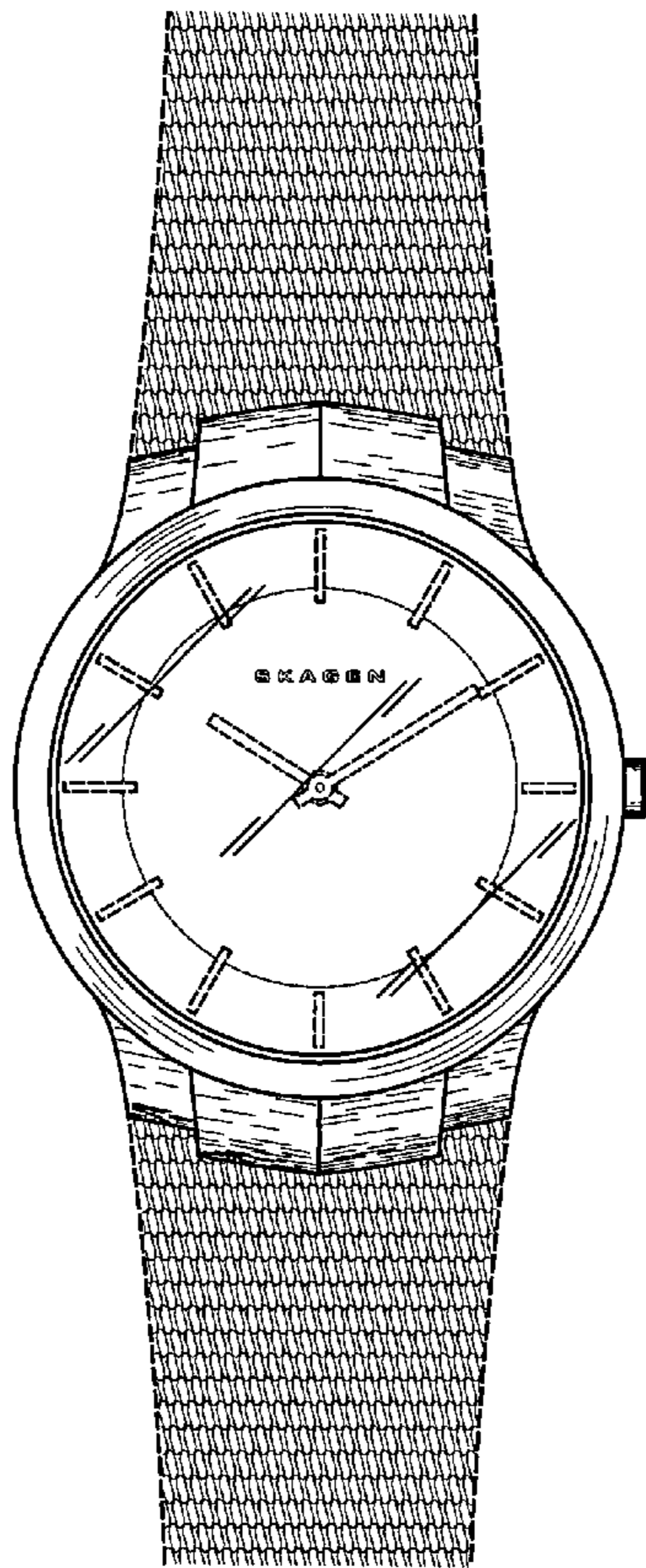
The ornamental design for the watch, as shown and described.

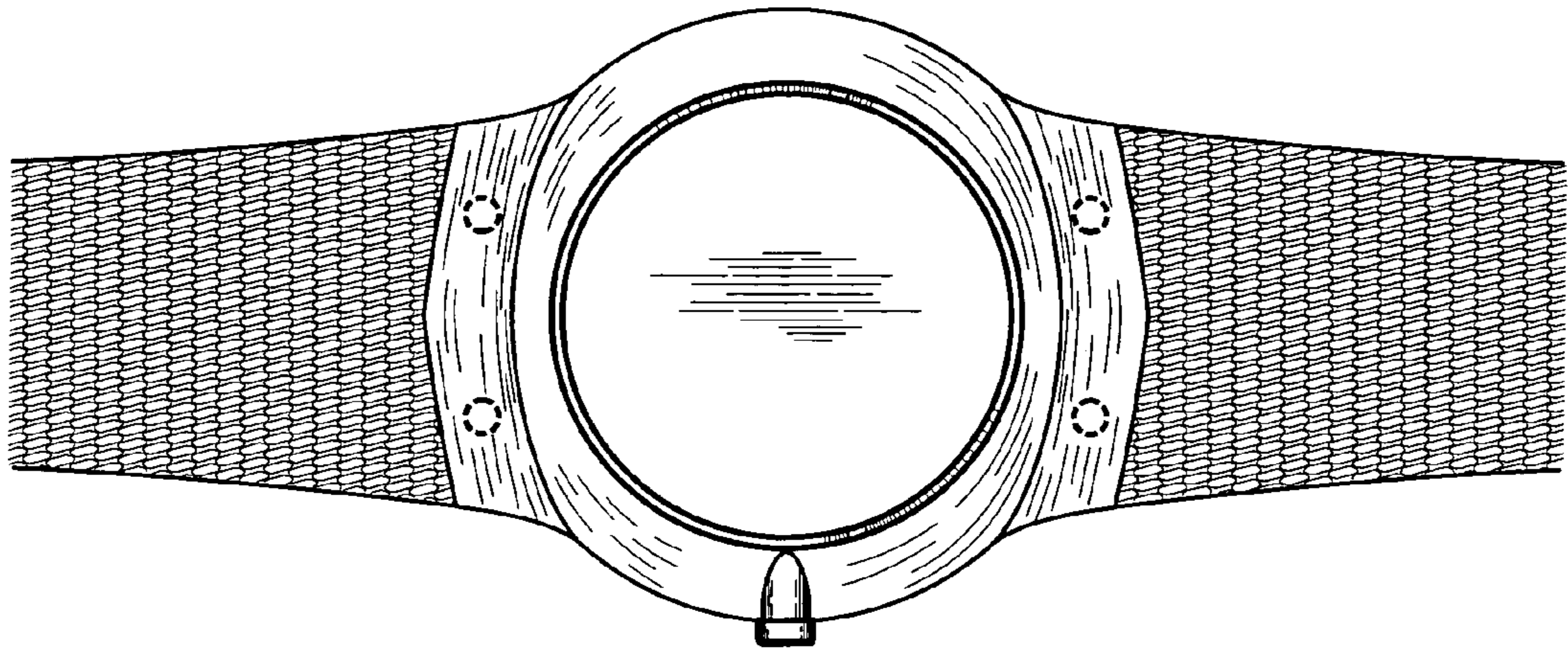

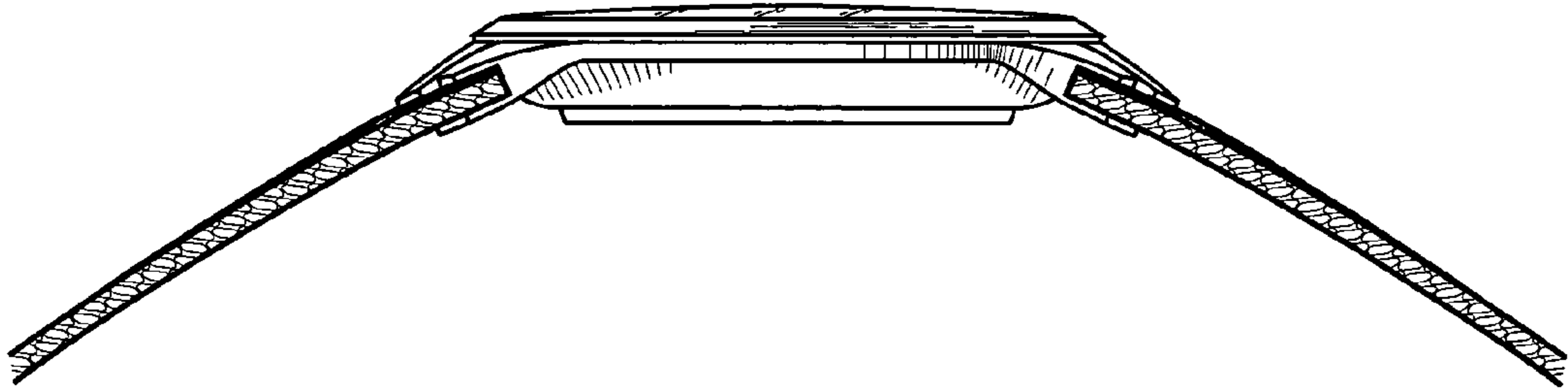

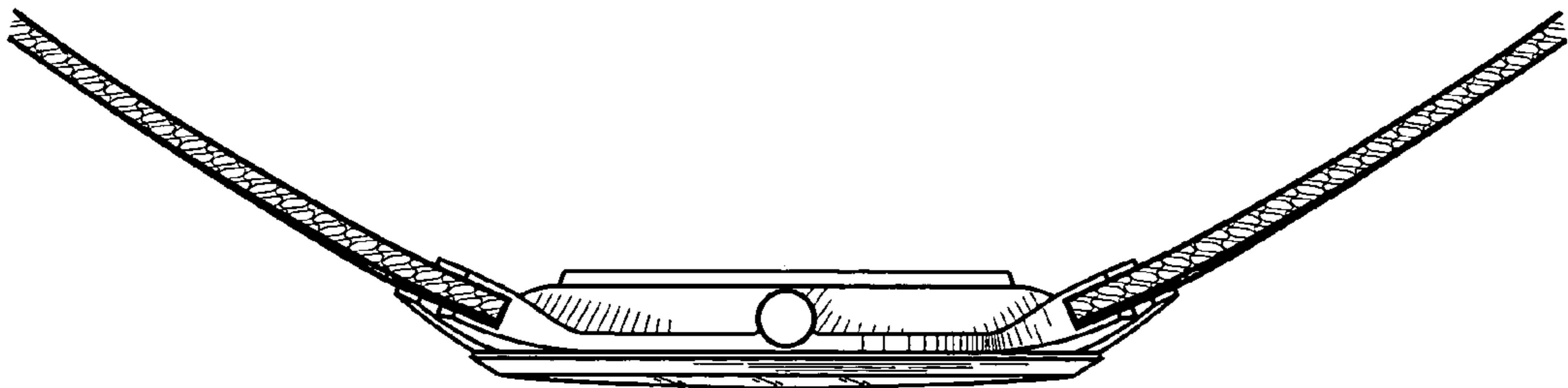

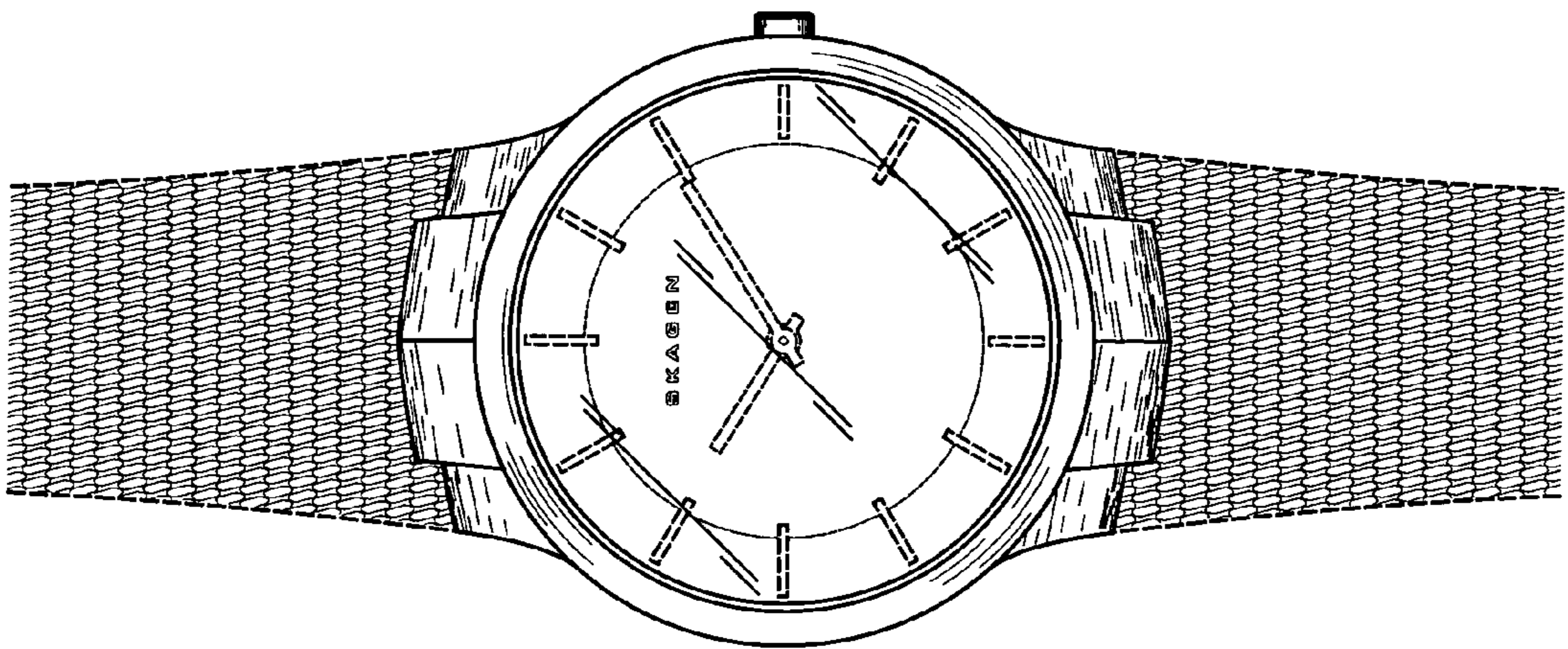

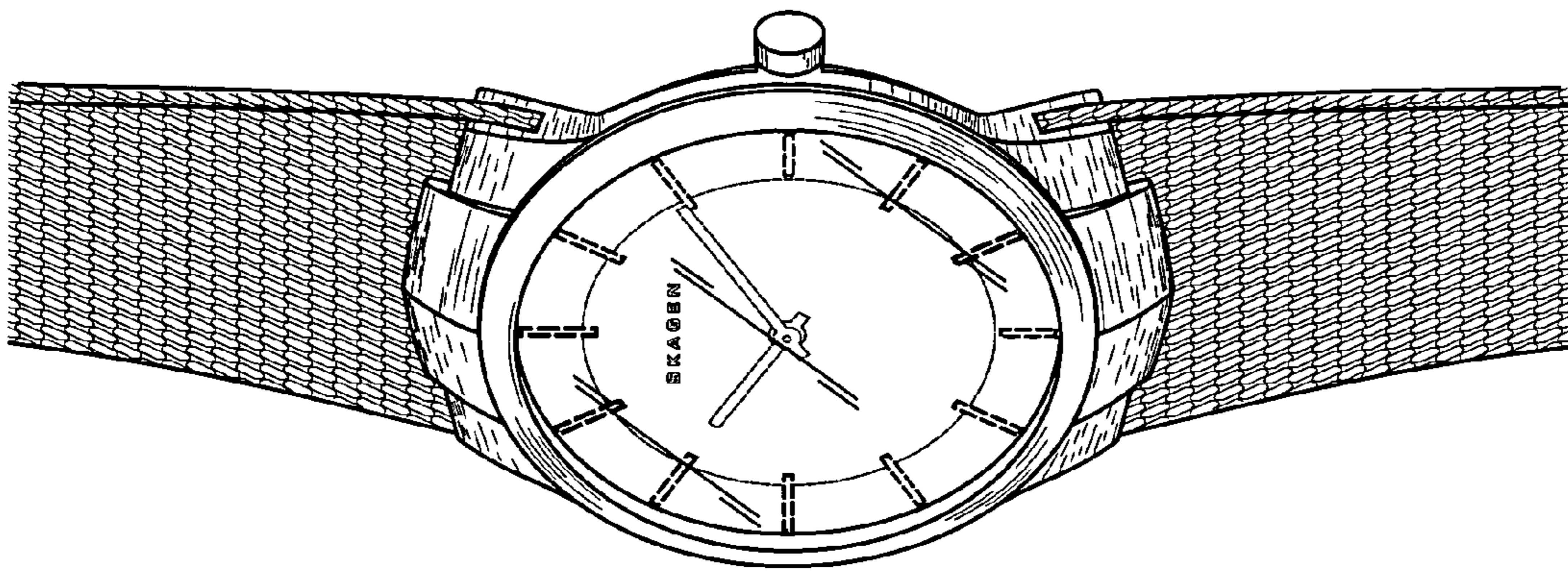

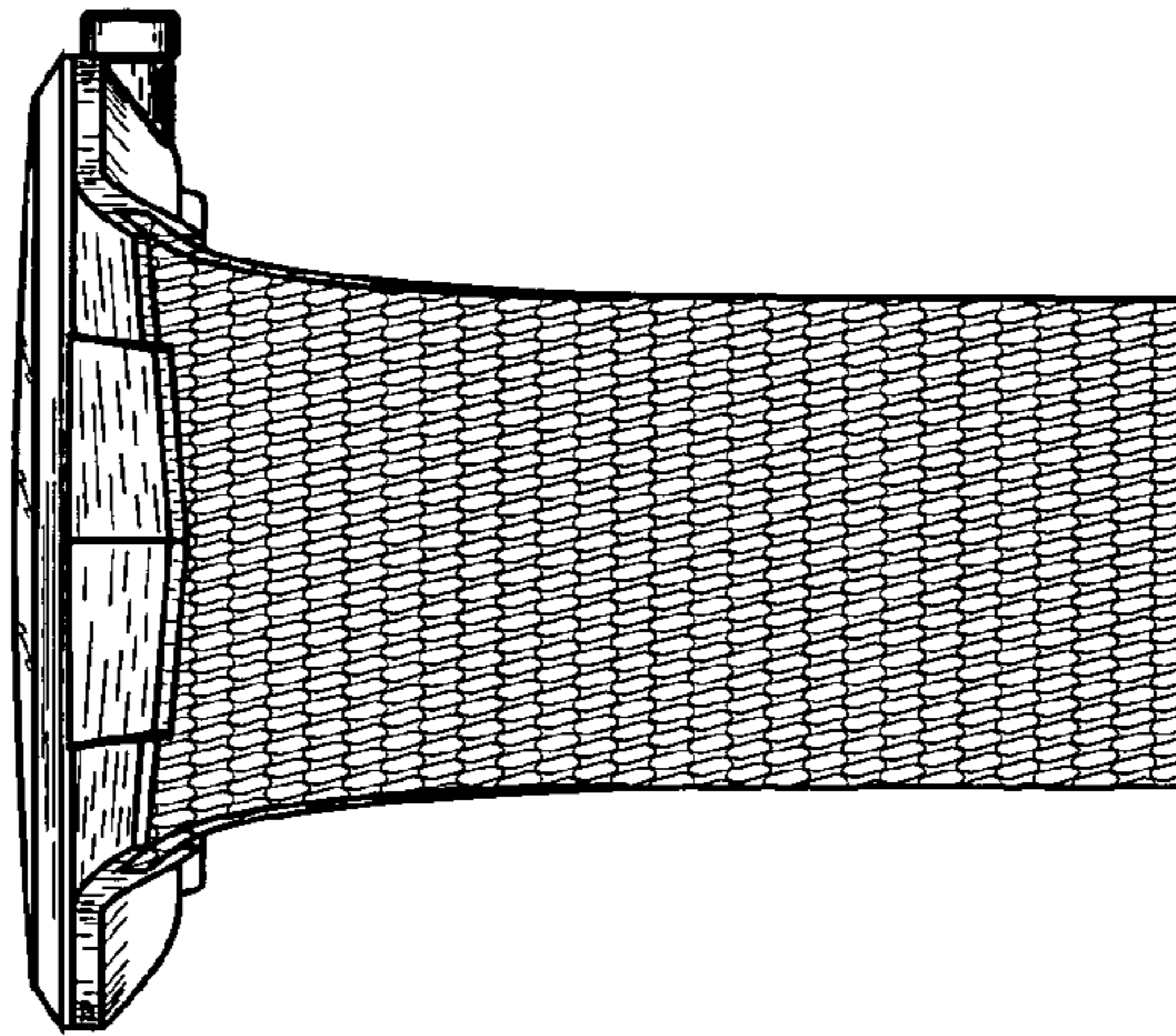
