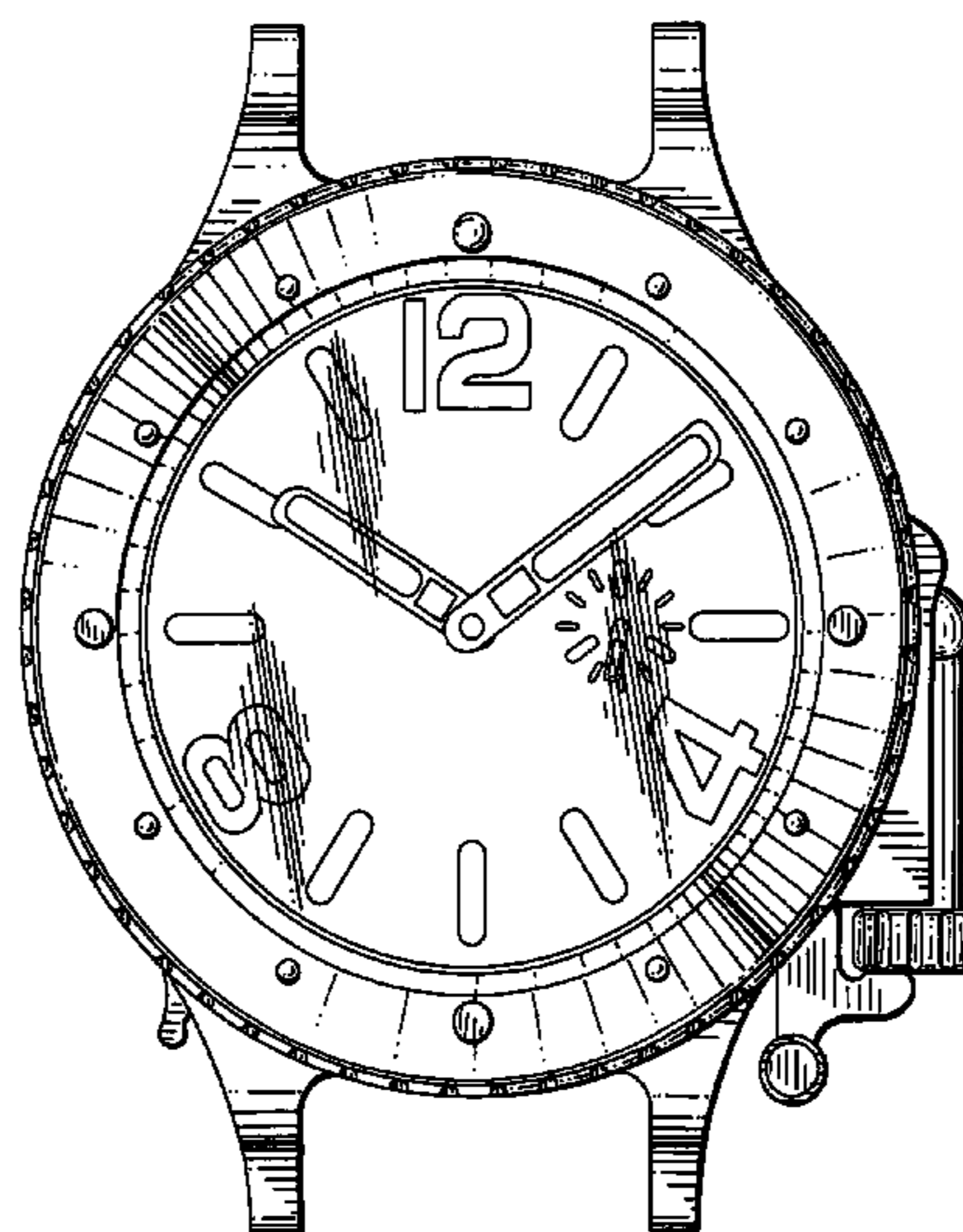
(57) **CLAIM**

The ornamental design for a watch, as shown and described.

DESCRIPTION

FIG. 1 is a front view showing my new watch design;
FIG. 2 is a right-side elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is another front view of the embodiment of FIG. 1 with the spindle and latch in their extended positions.
FIG. 8 is a front view of another embodiment of my new watch design;
FIG. 9 is a right-side elevational view thereof;
FIG. 10 is a top plan view thereof;
FIG. 11 is a left-side elevational view thereof;
FIG. 12 is a rear view thereof;
FIG. 13 is a bottom plan view thereof; and,
FIG. 14 is another front view of the embodiment of FIG. 8 with the spindle and latch in their extended positions.
The broken lines in the drawings are used to show portions of the watch that do not form part of the claimed design.

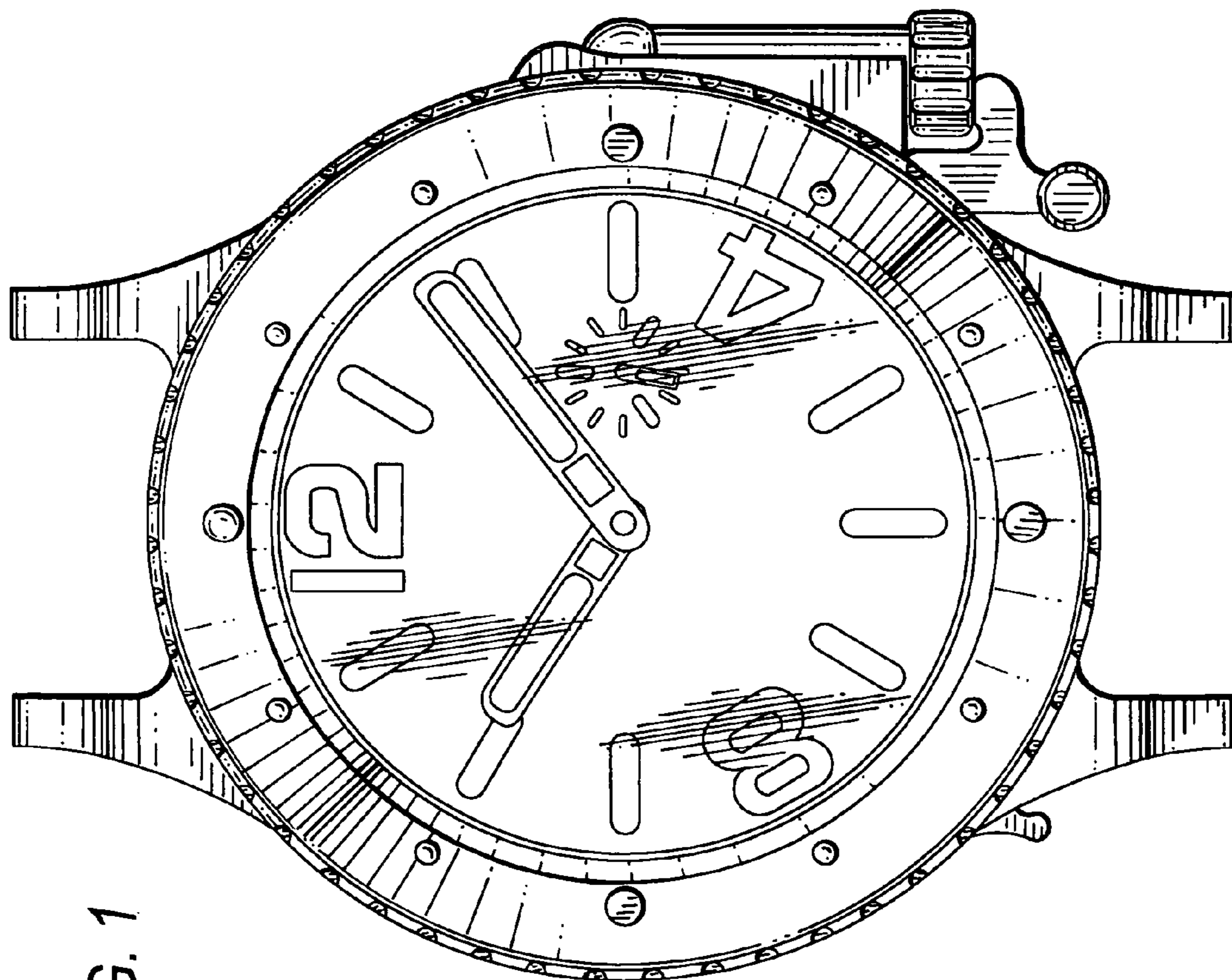

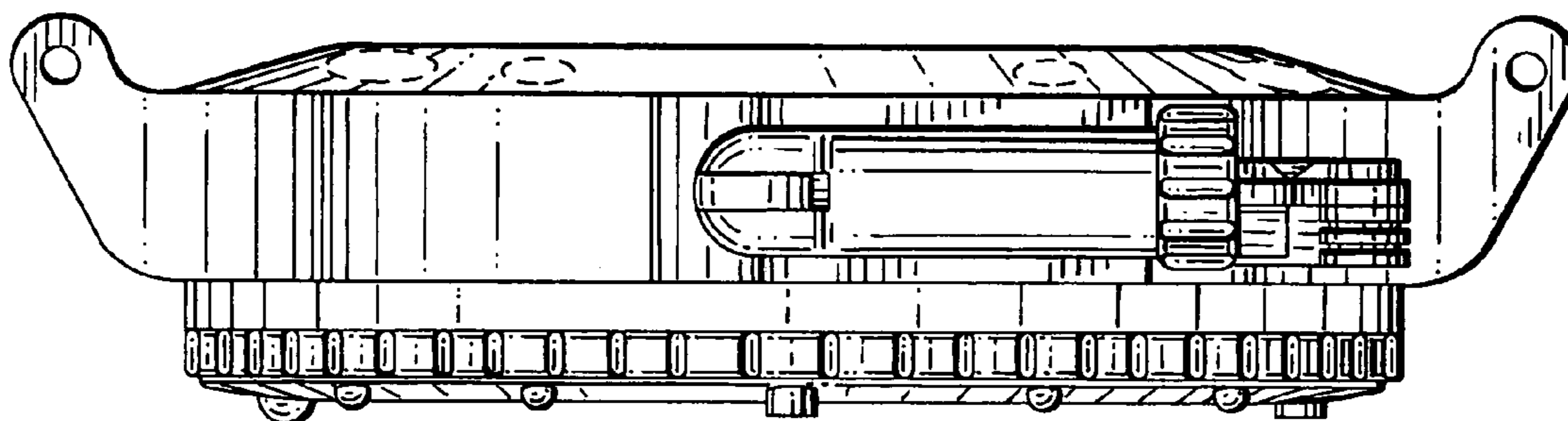

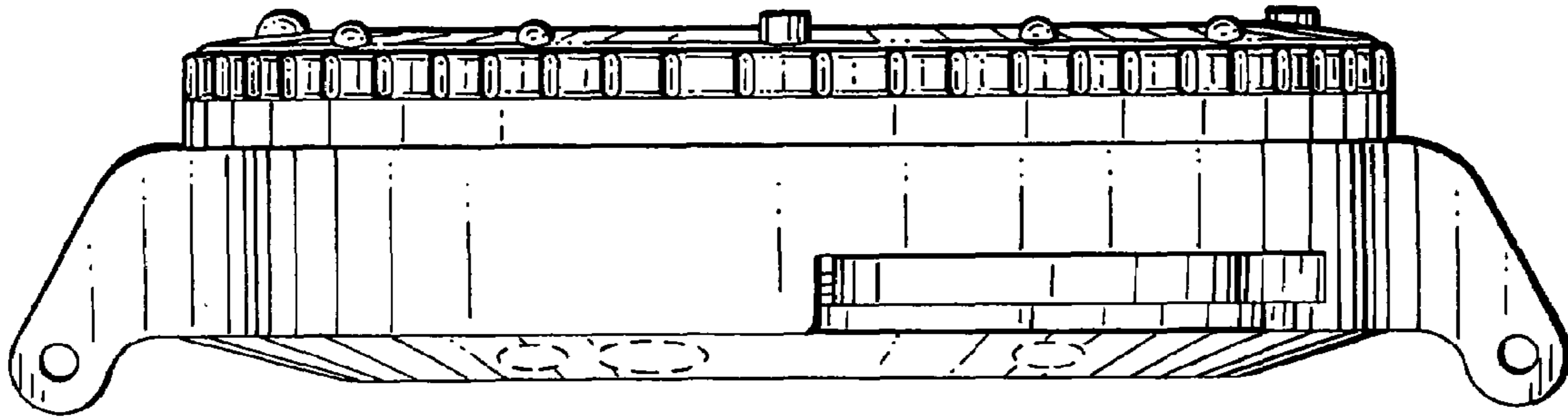

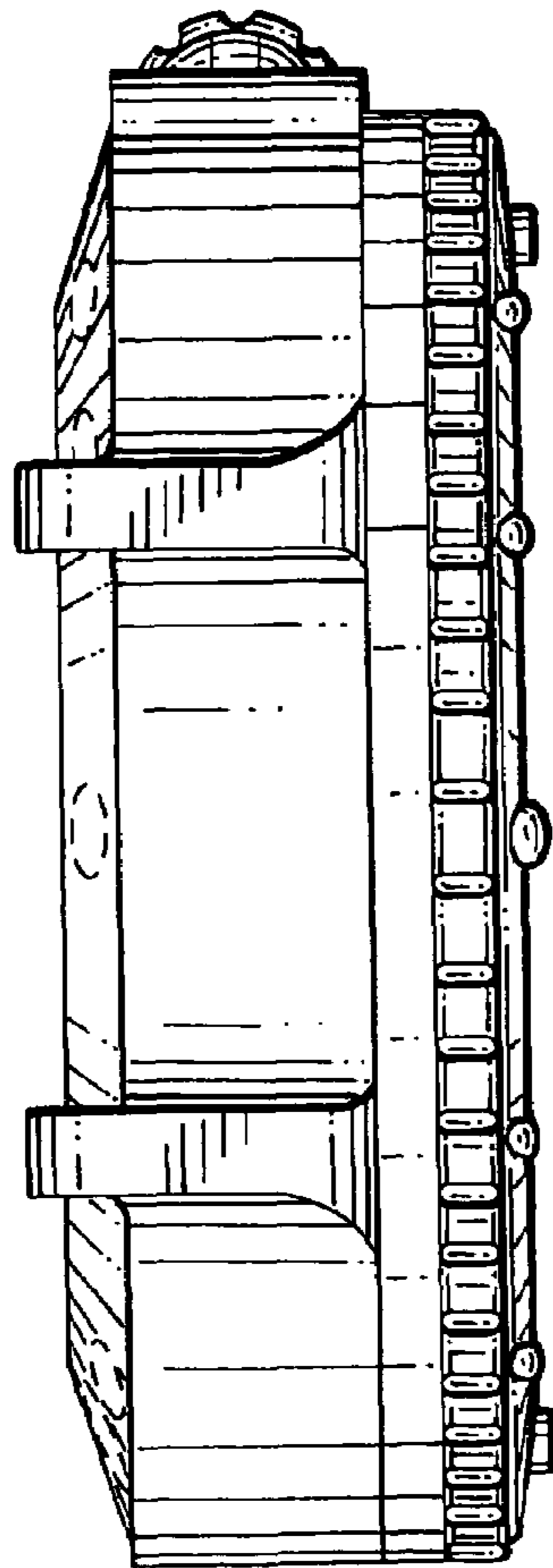

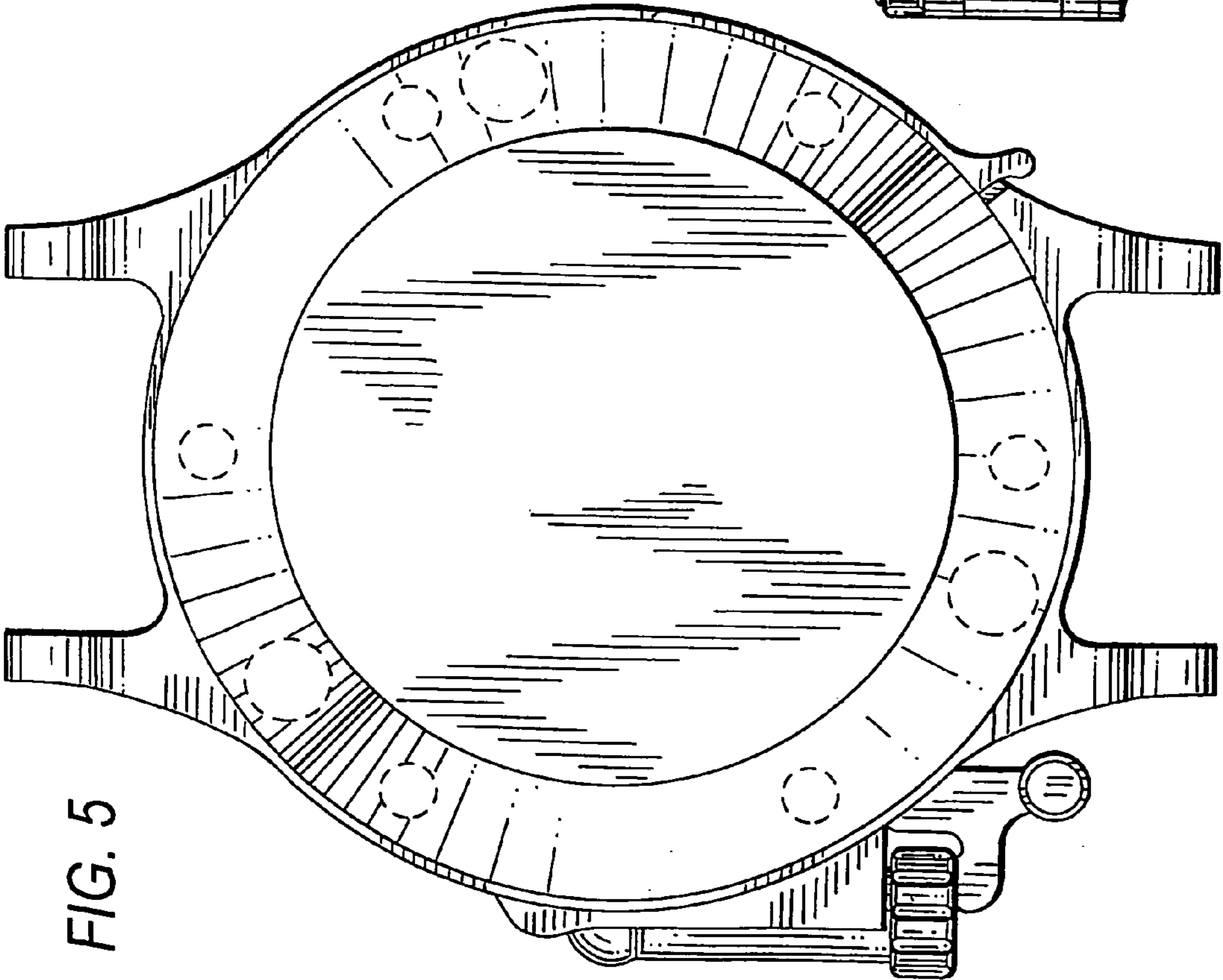
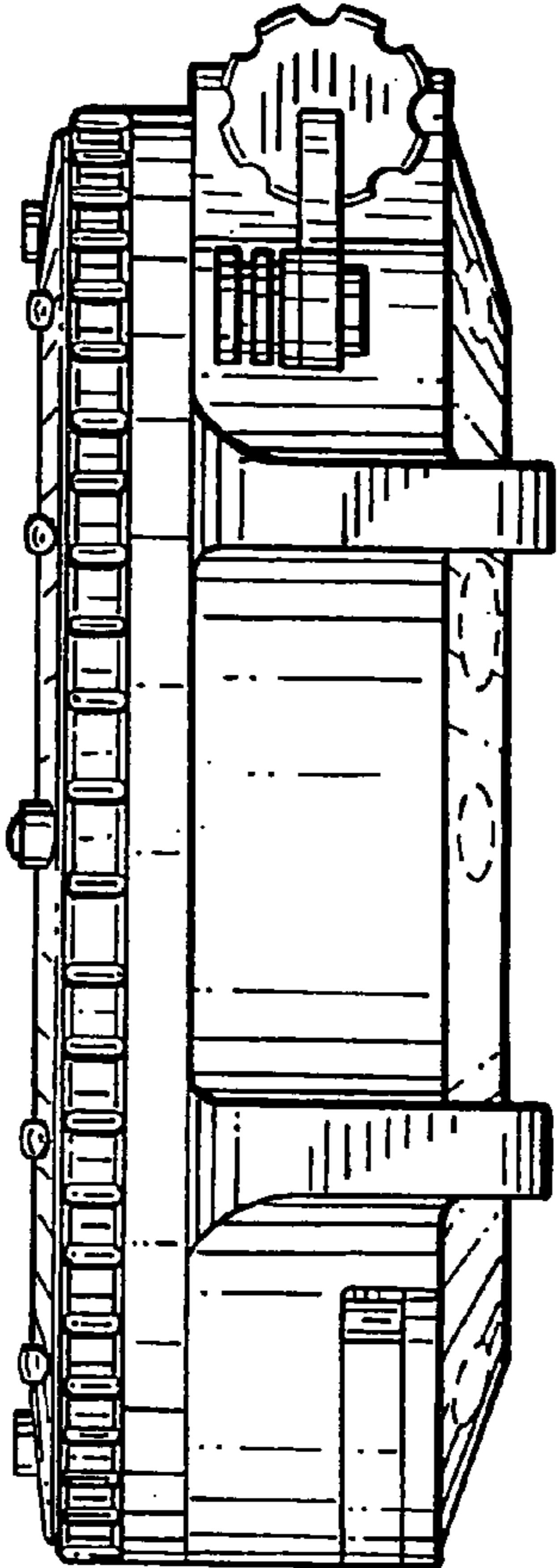

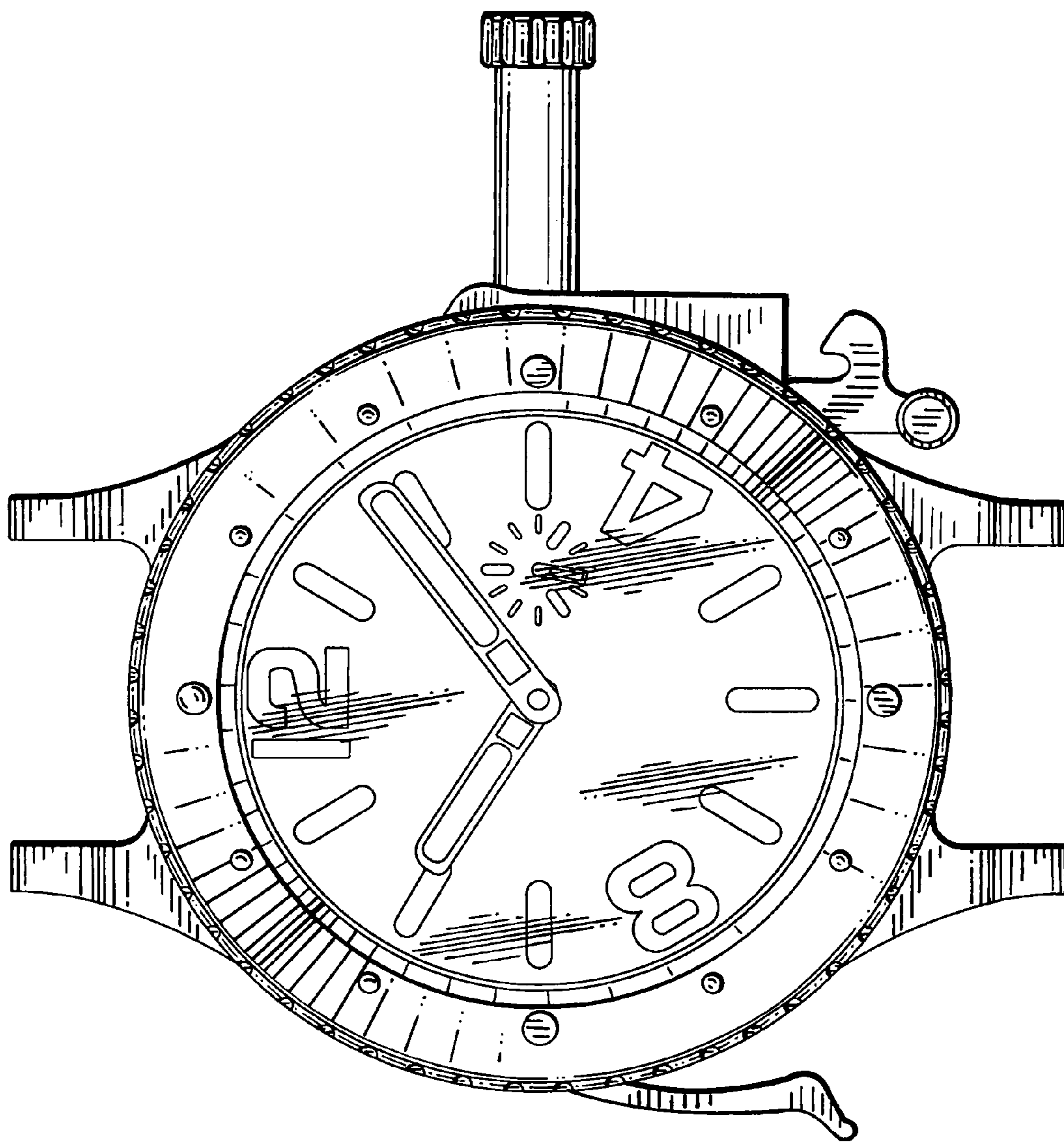

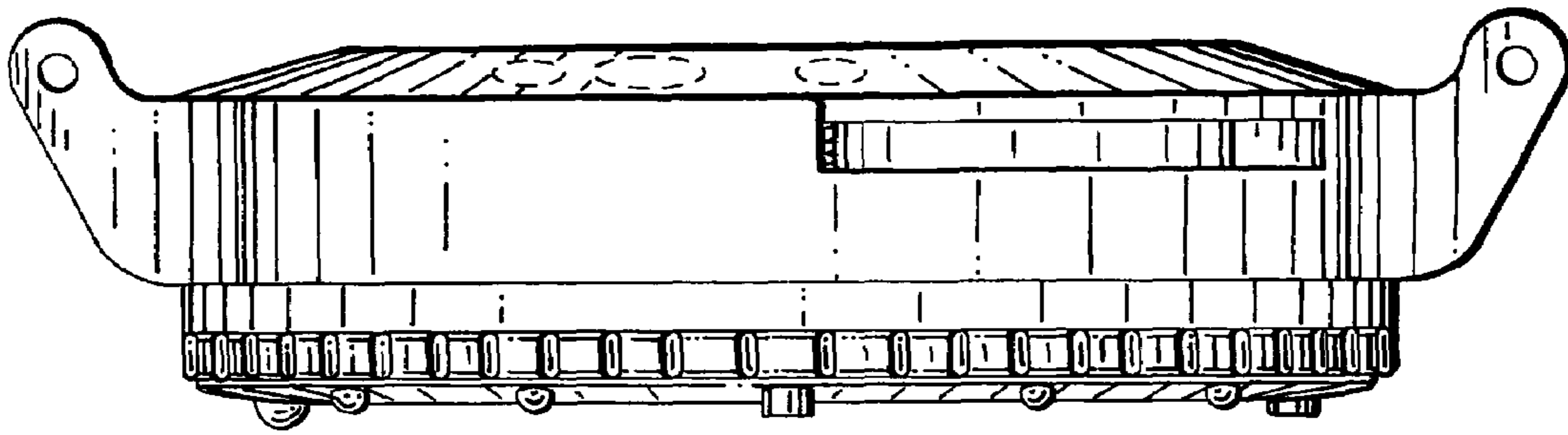

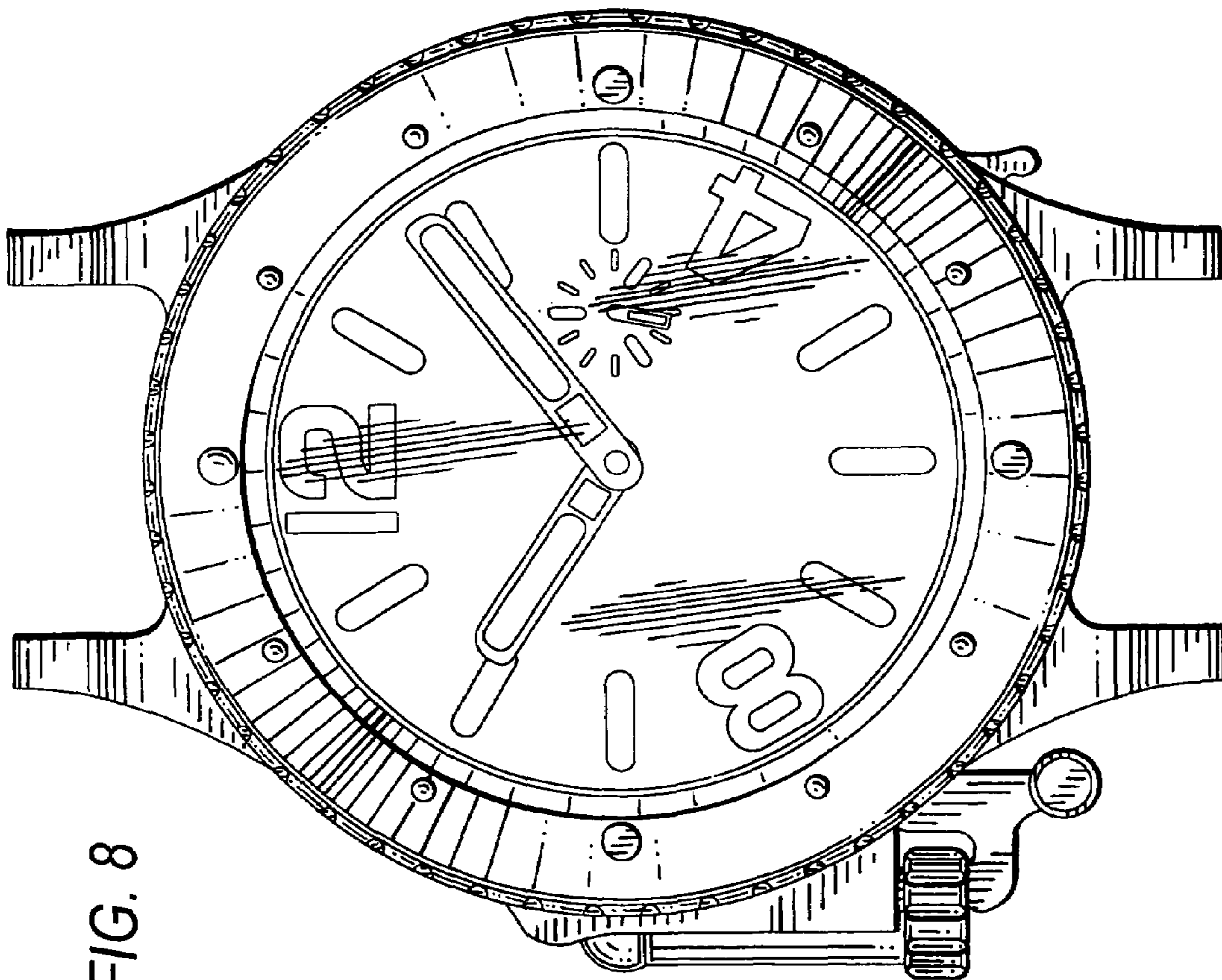

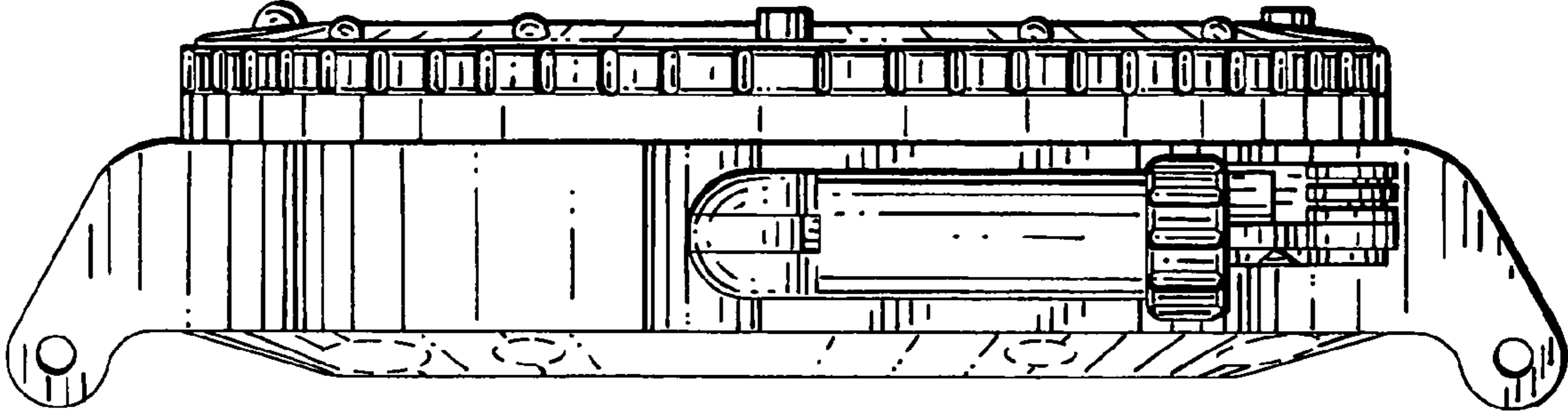
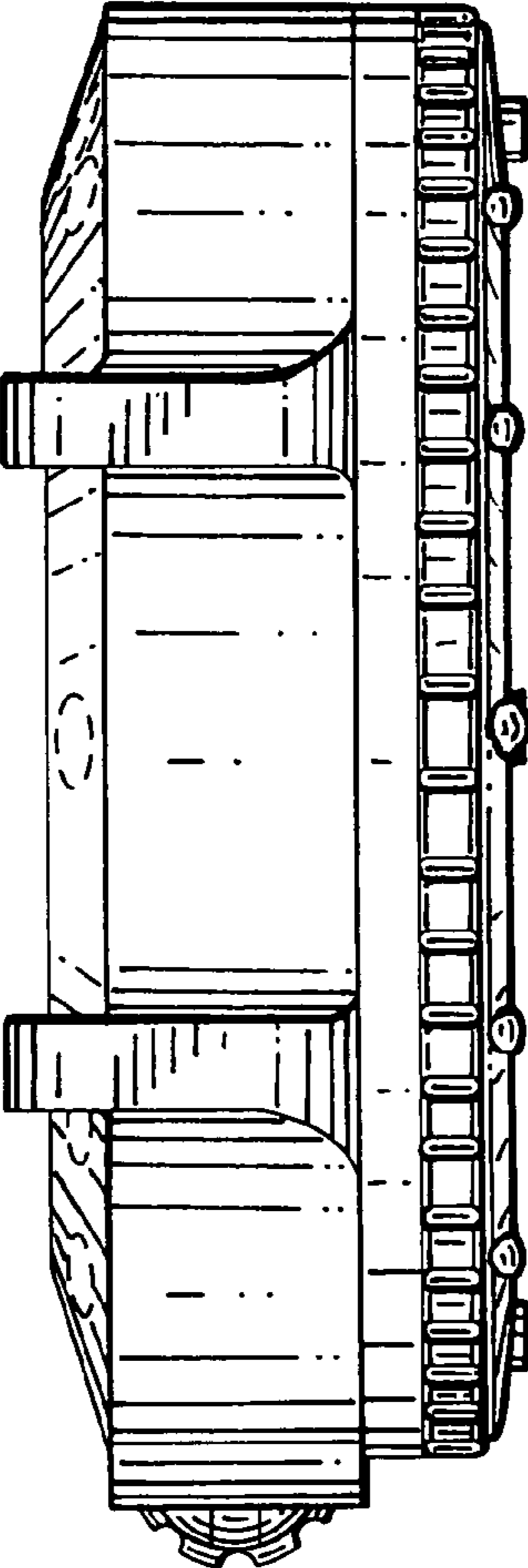

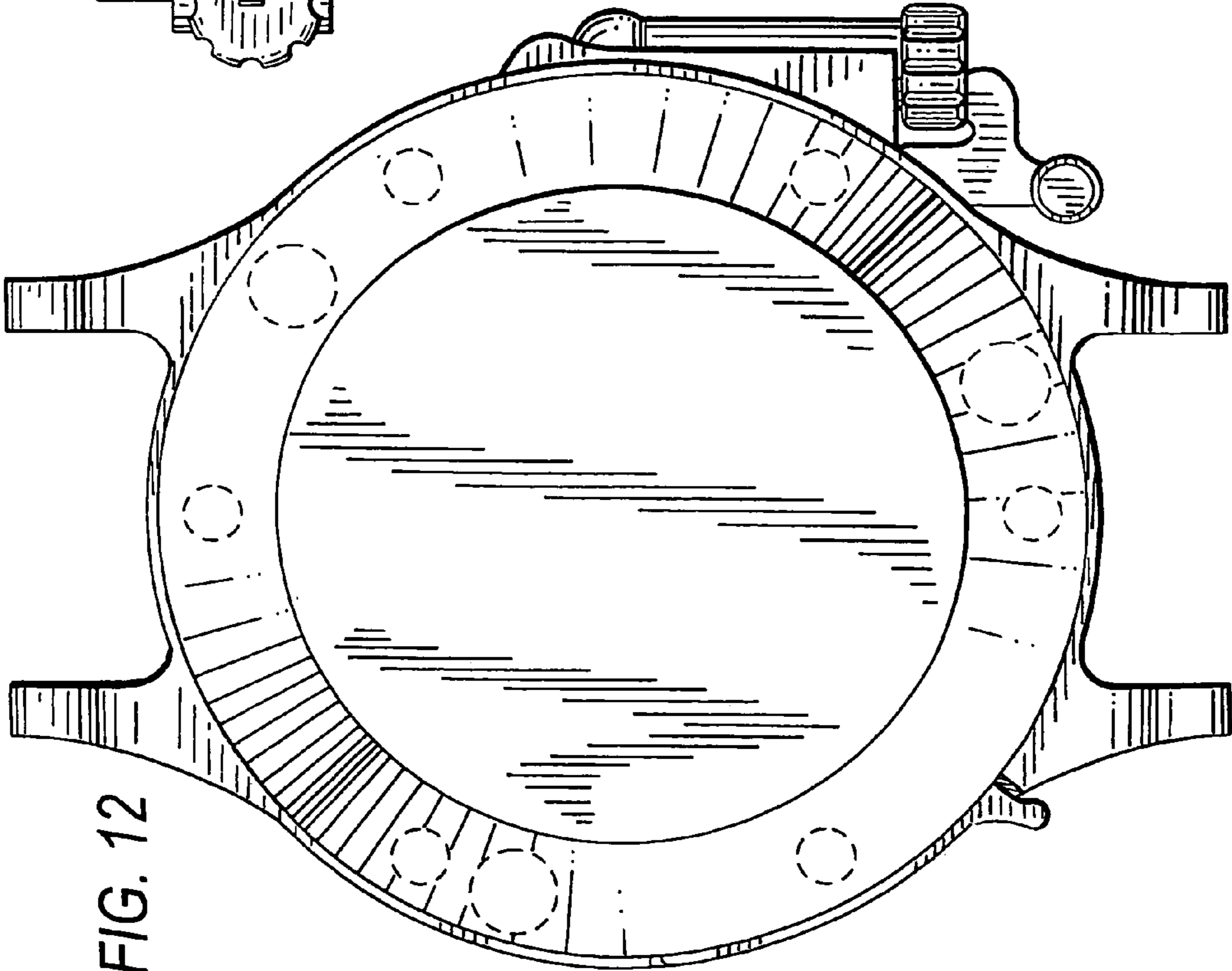

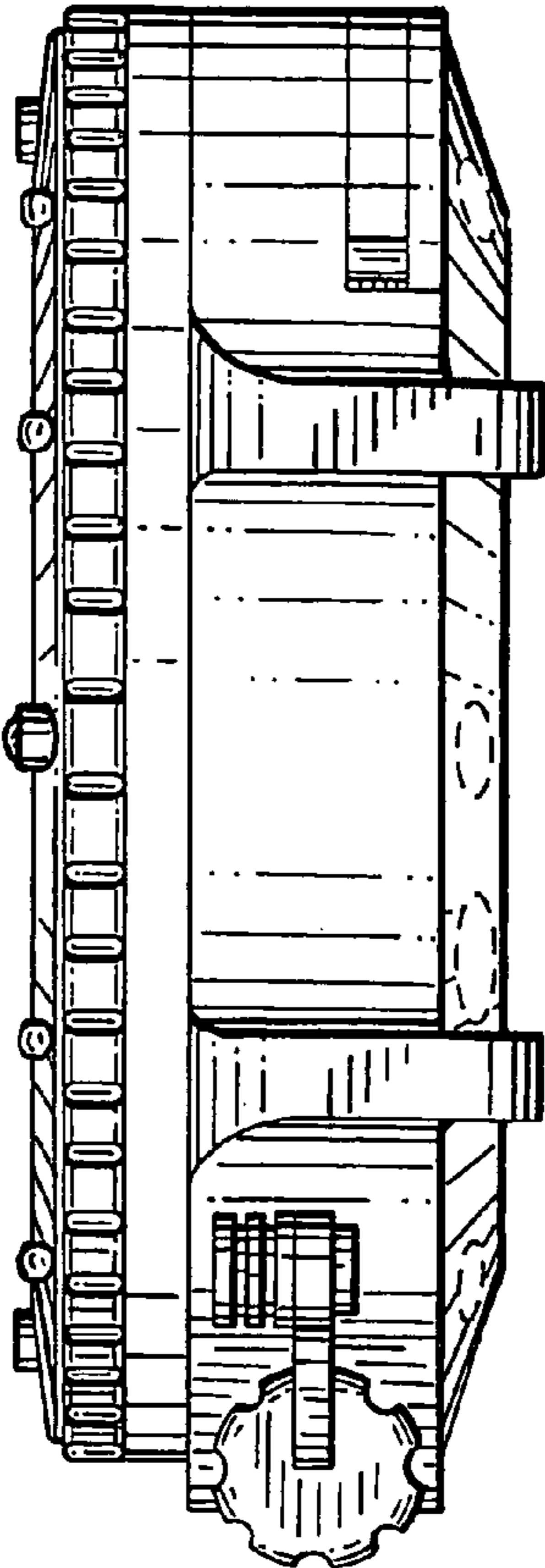
