**DESCRIPTION**

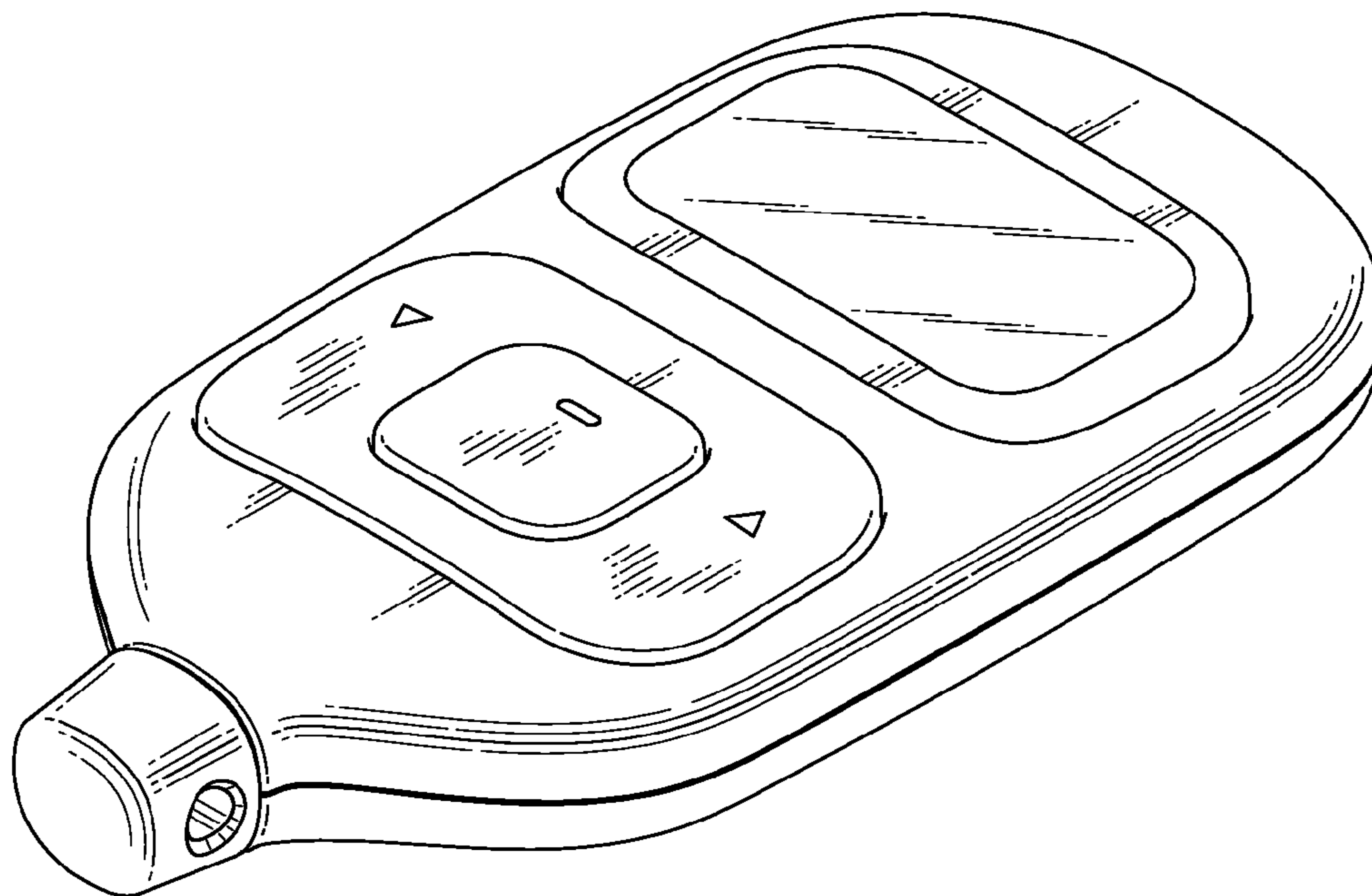

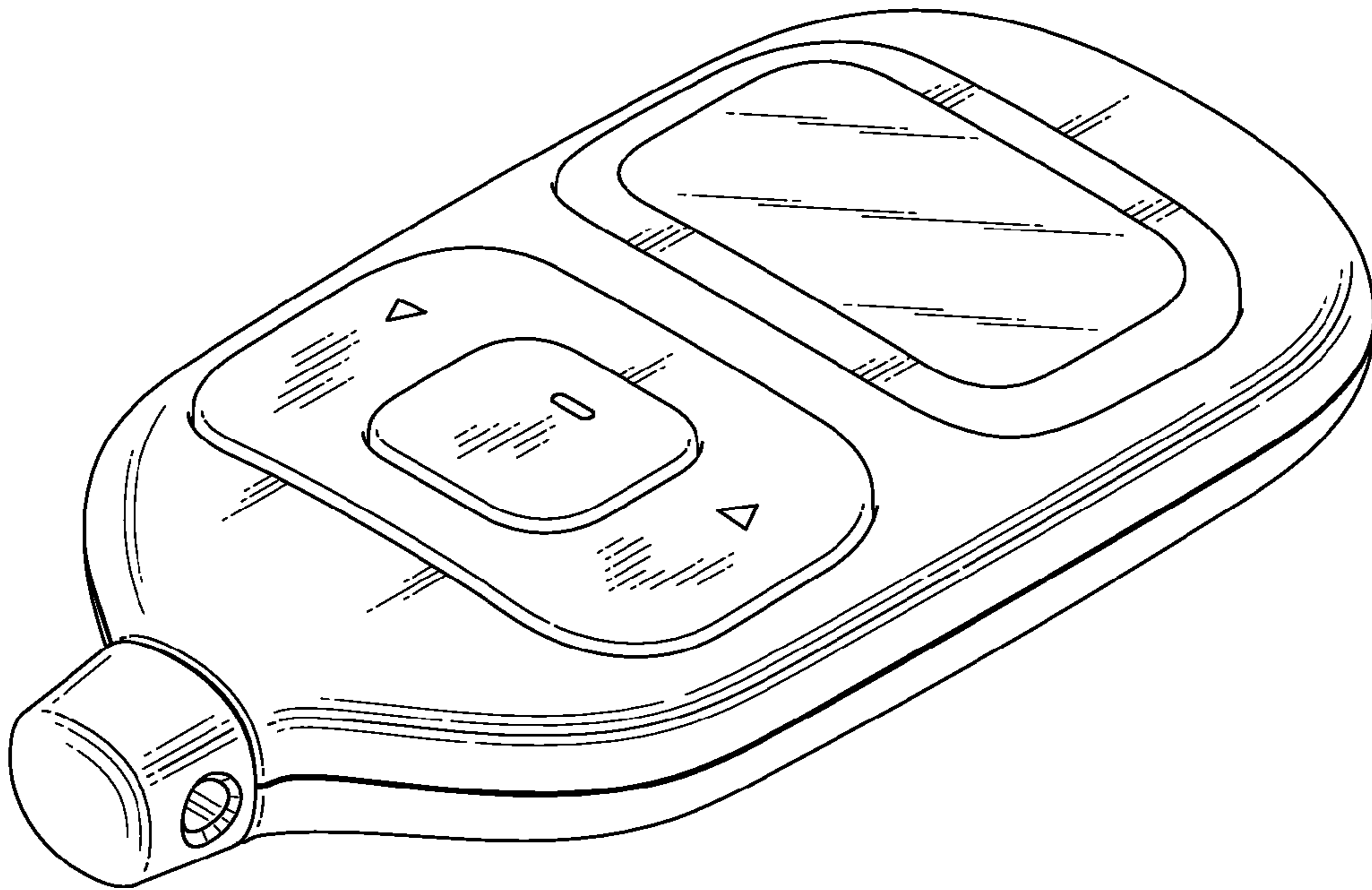

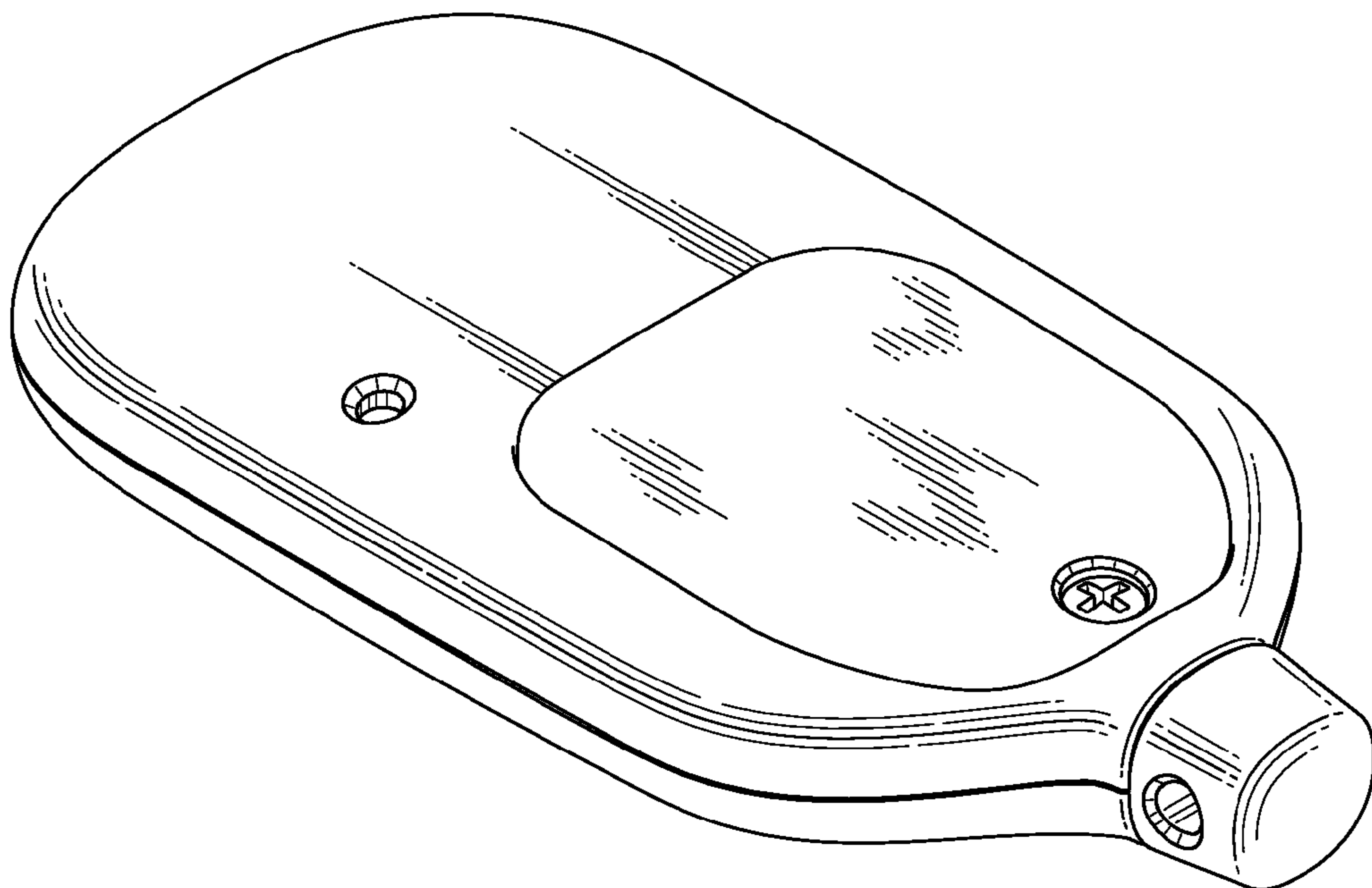

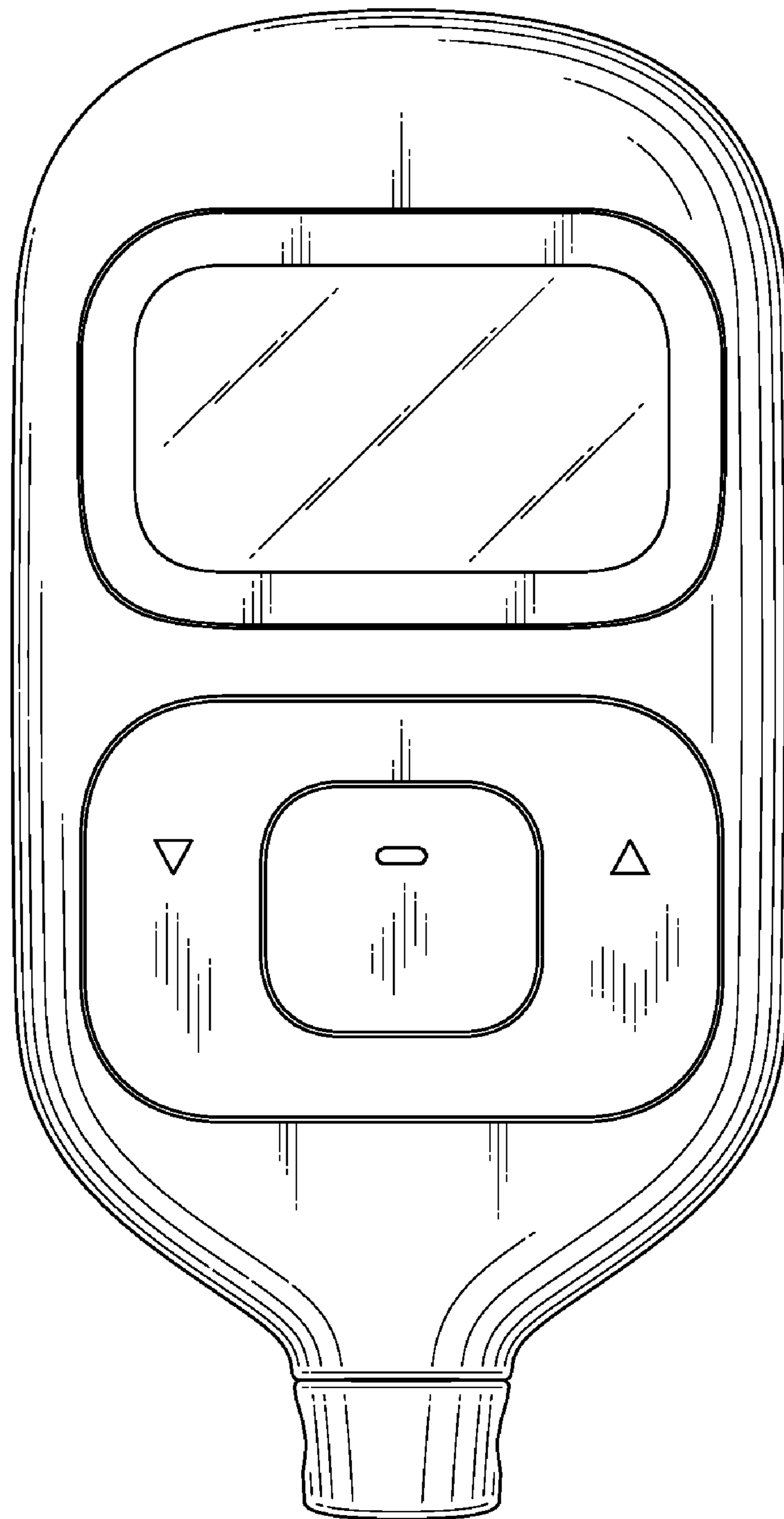

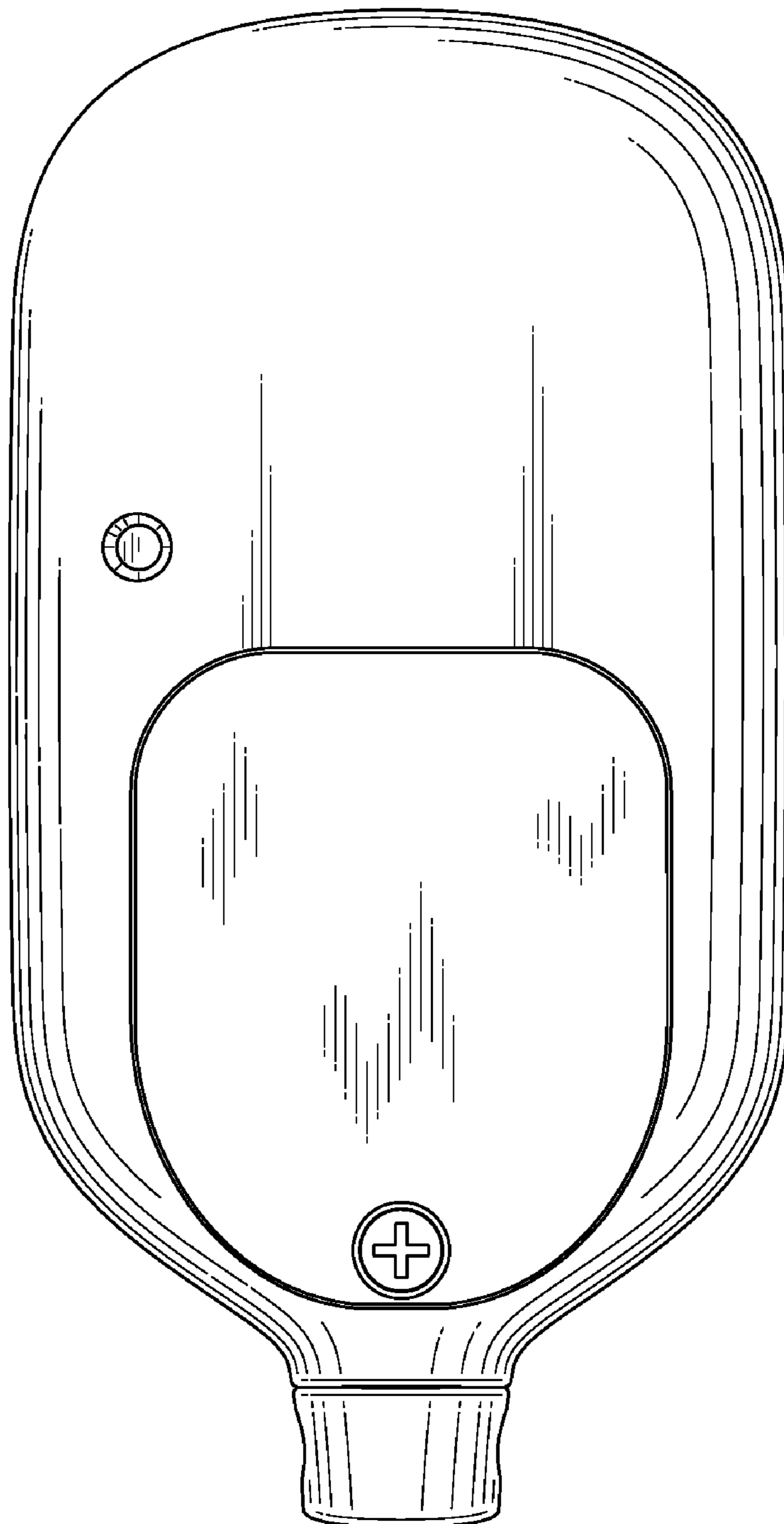

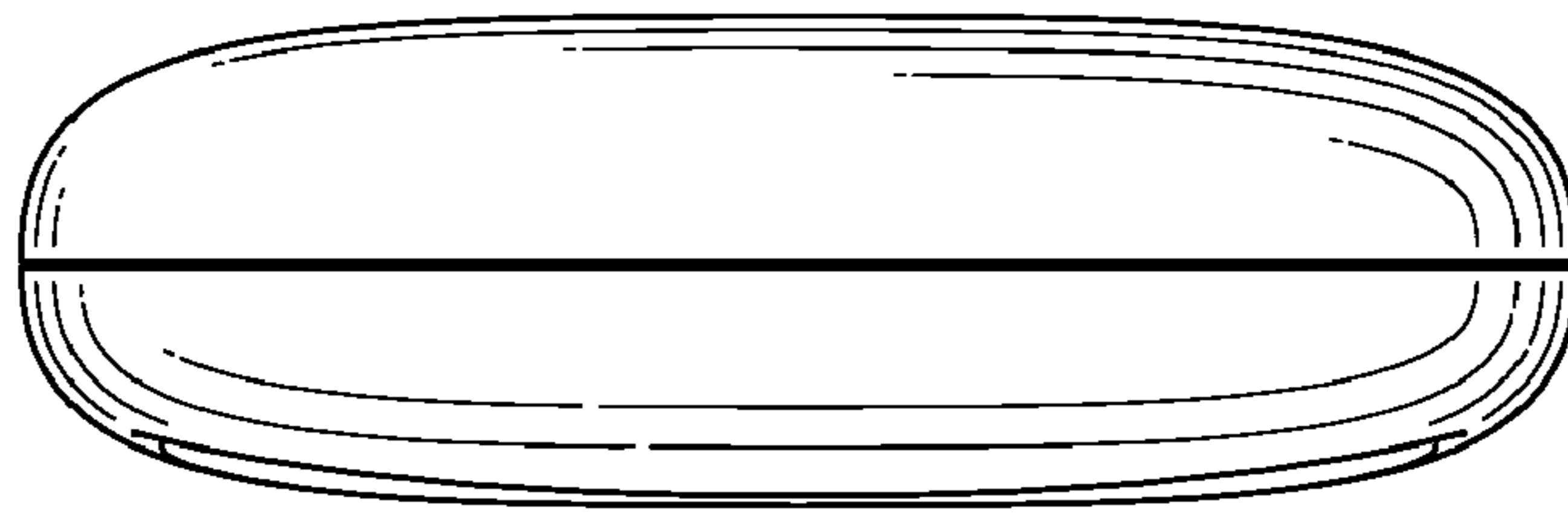

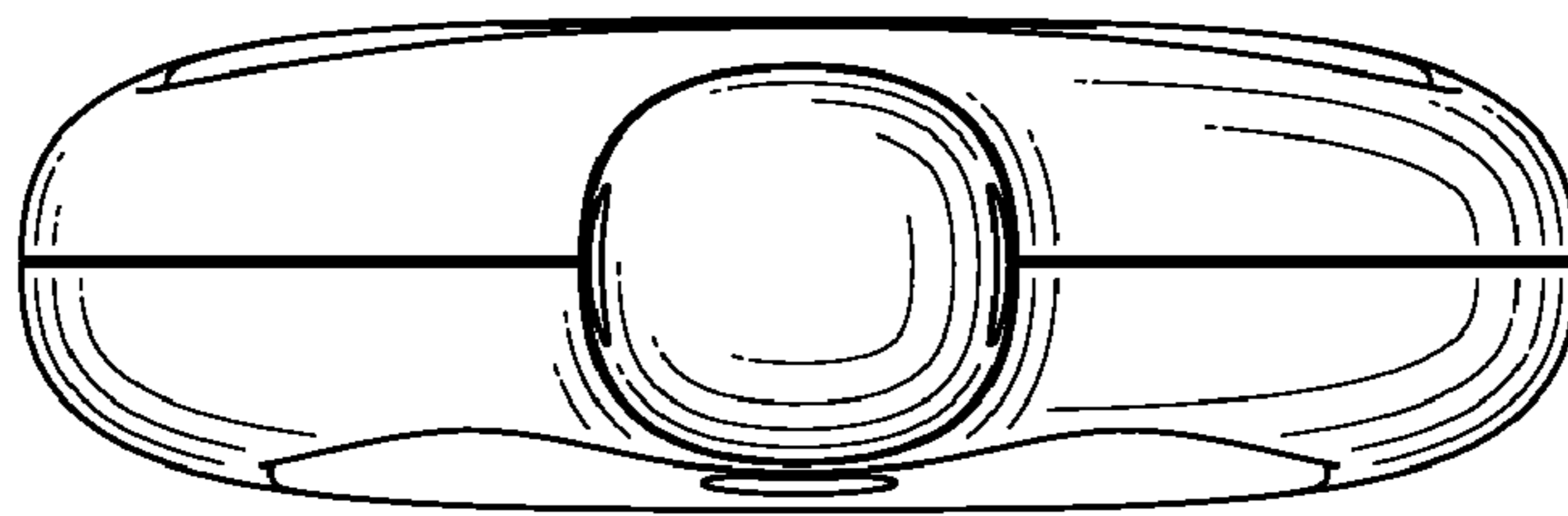

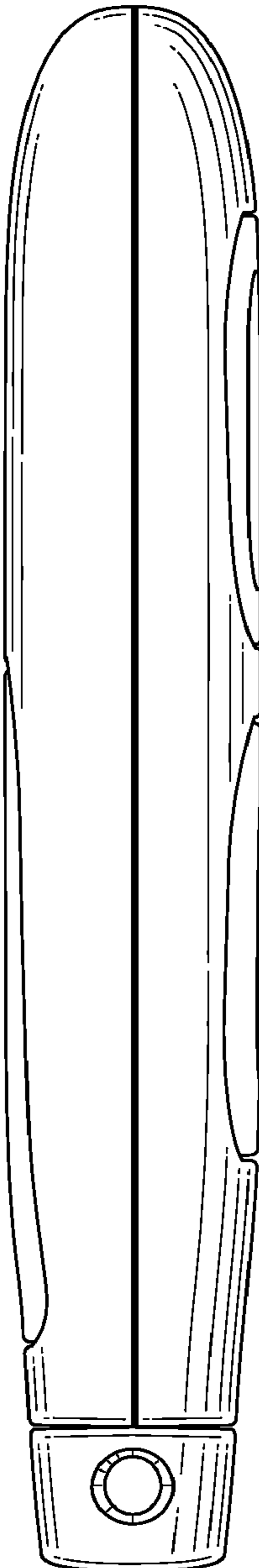

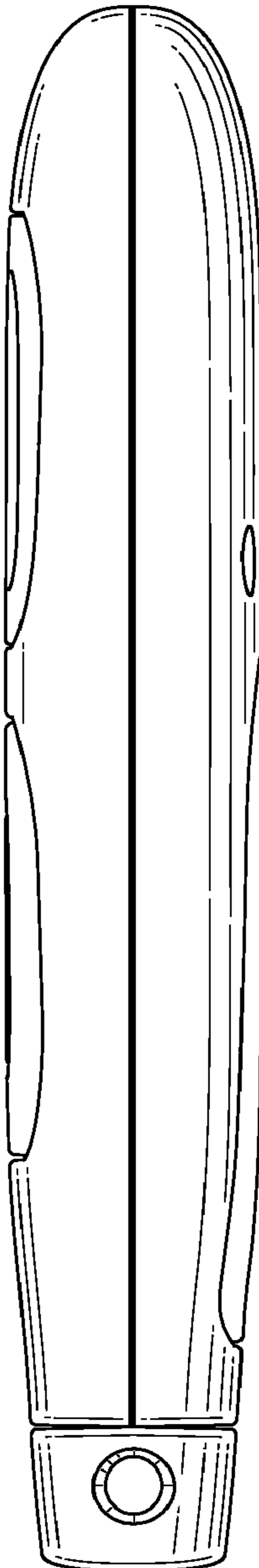

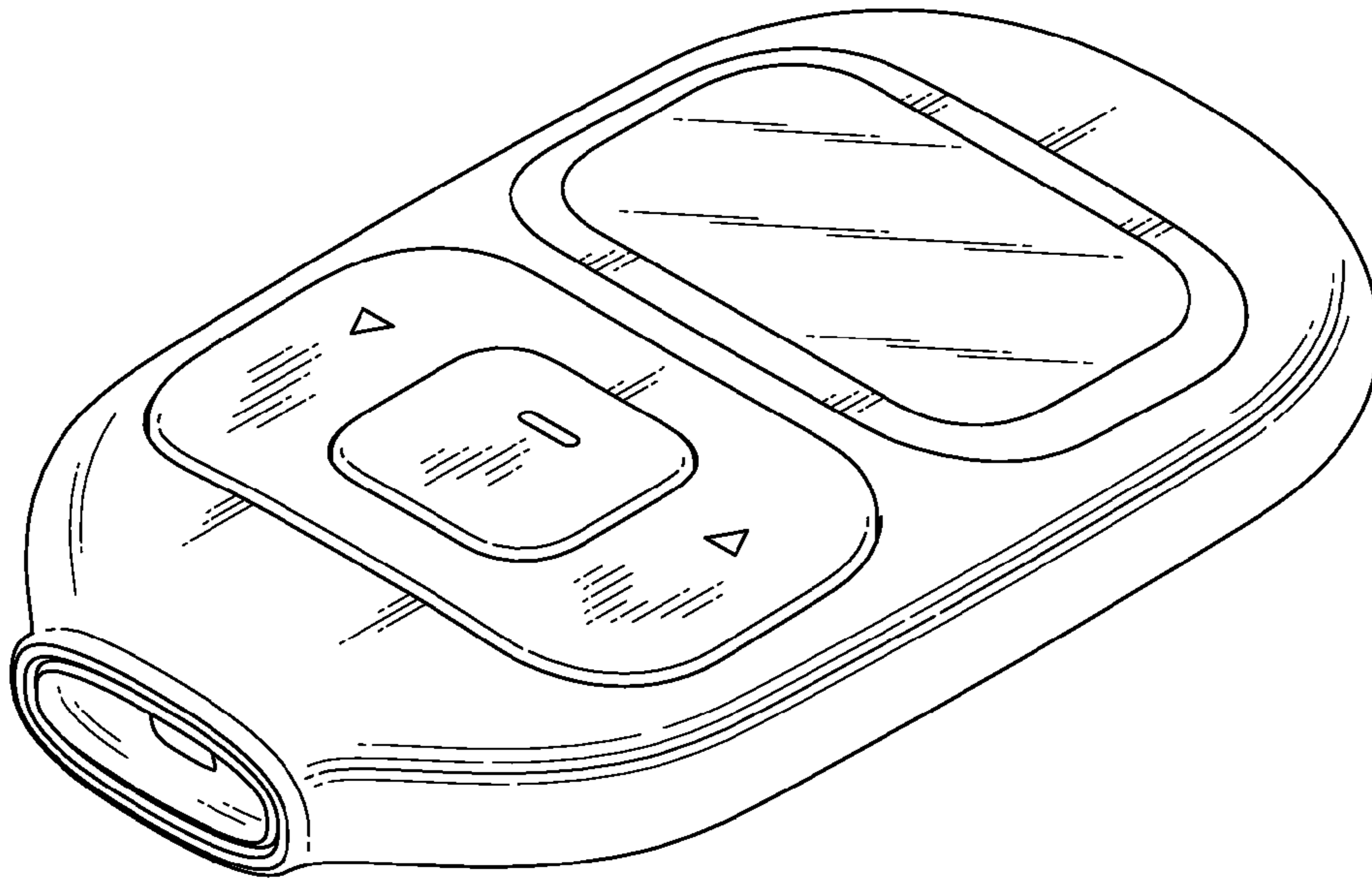

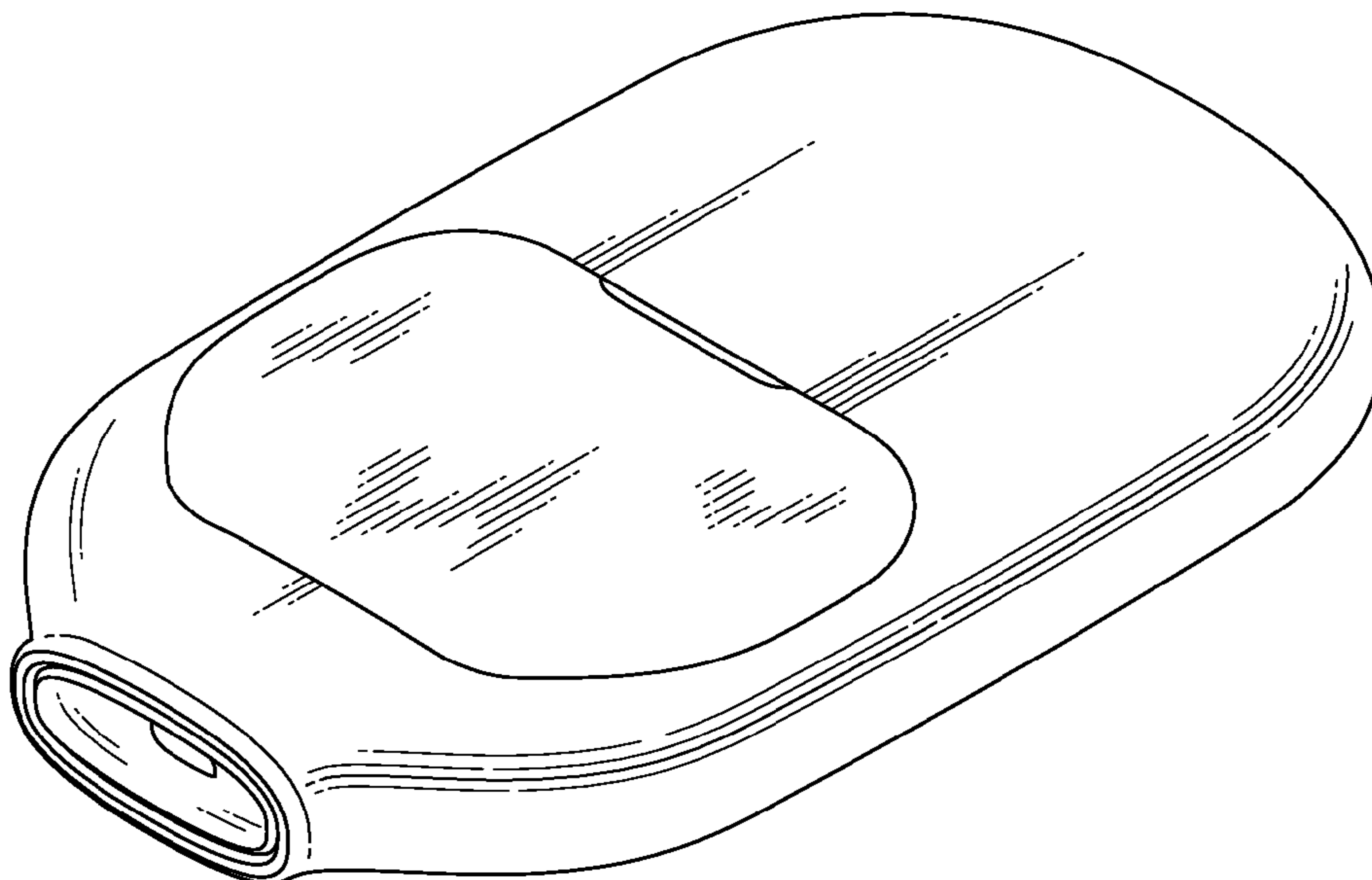

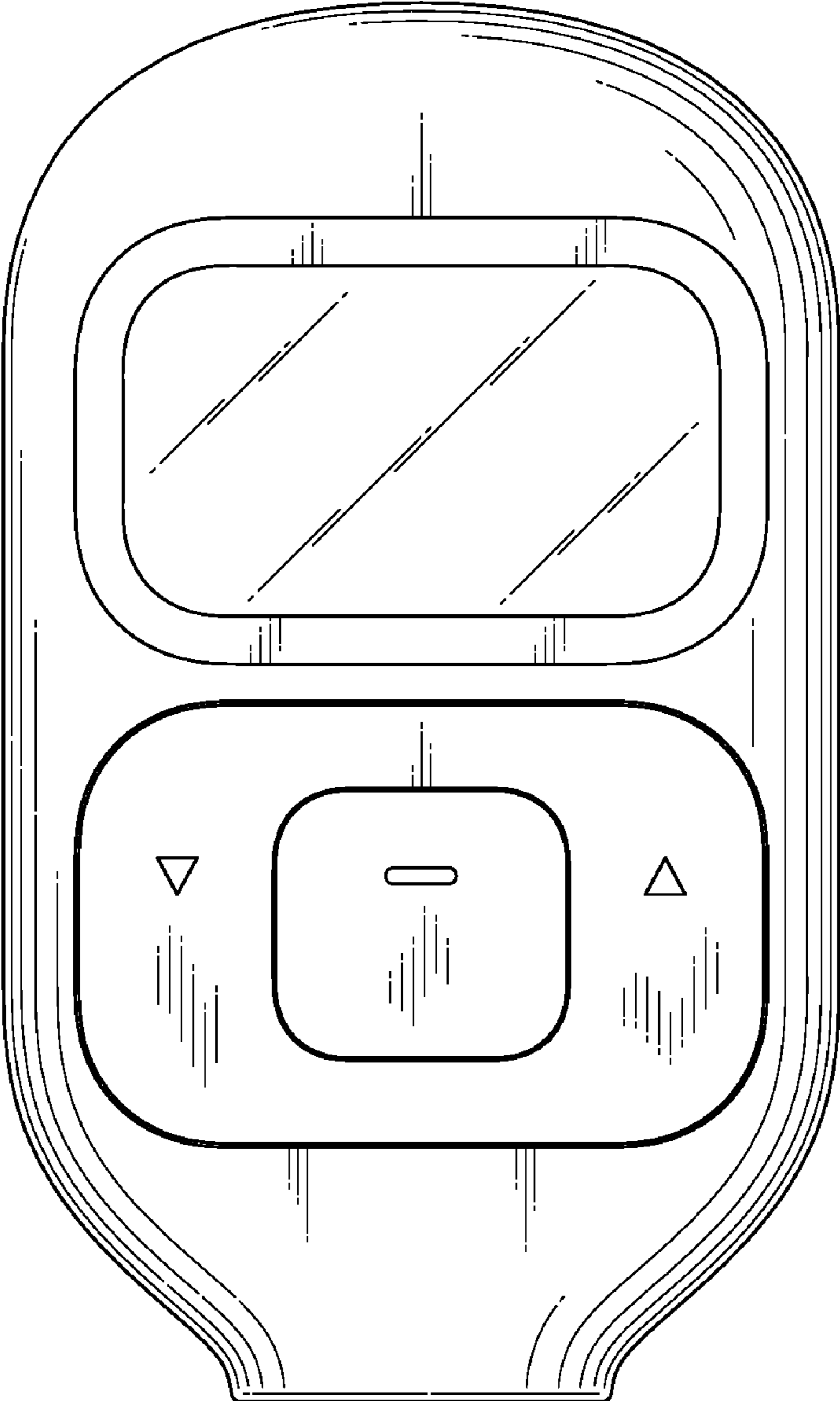

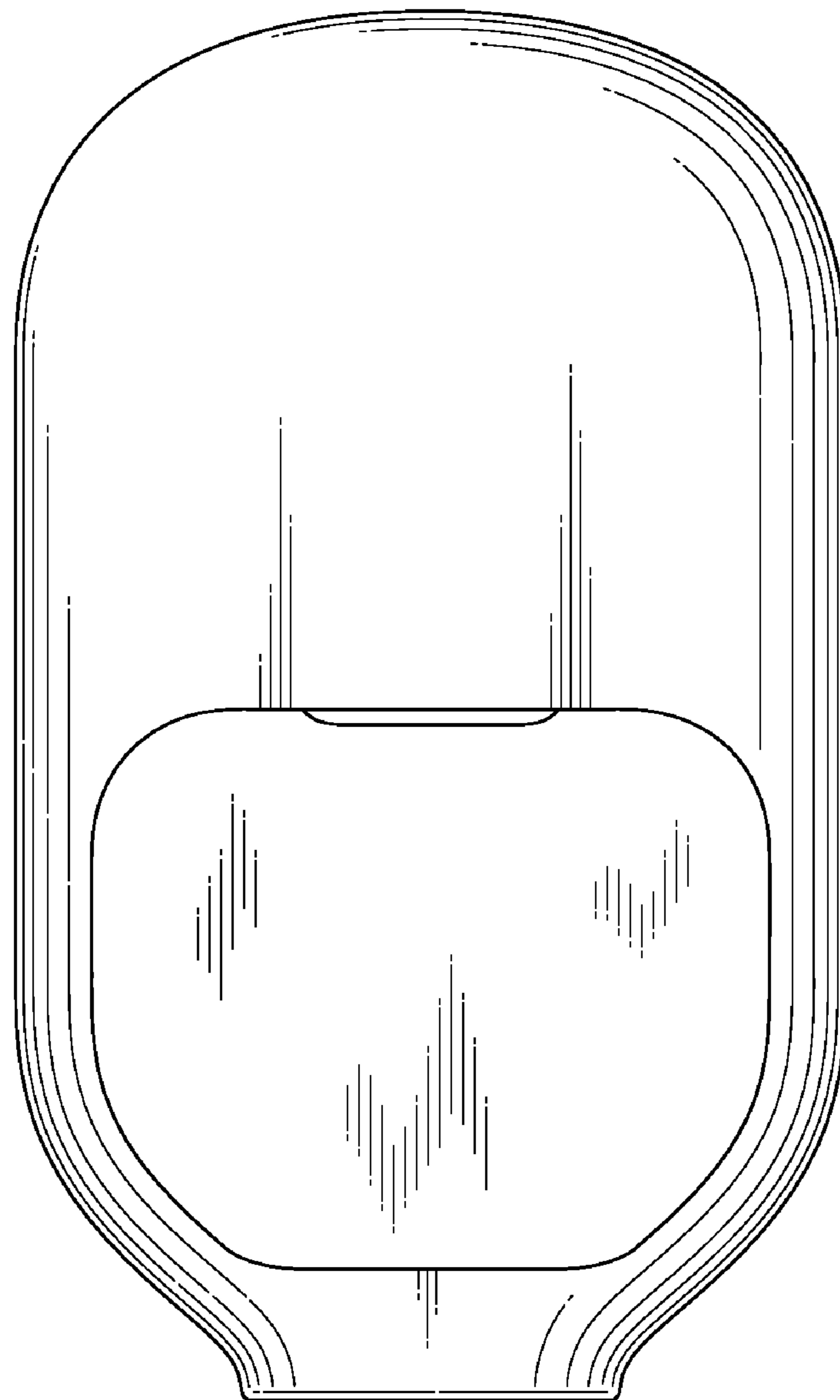

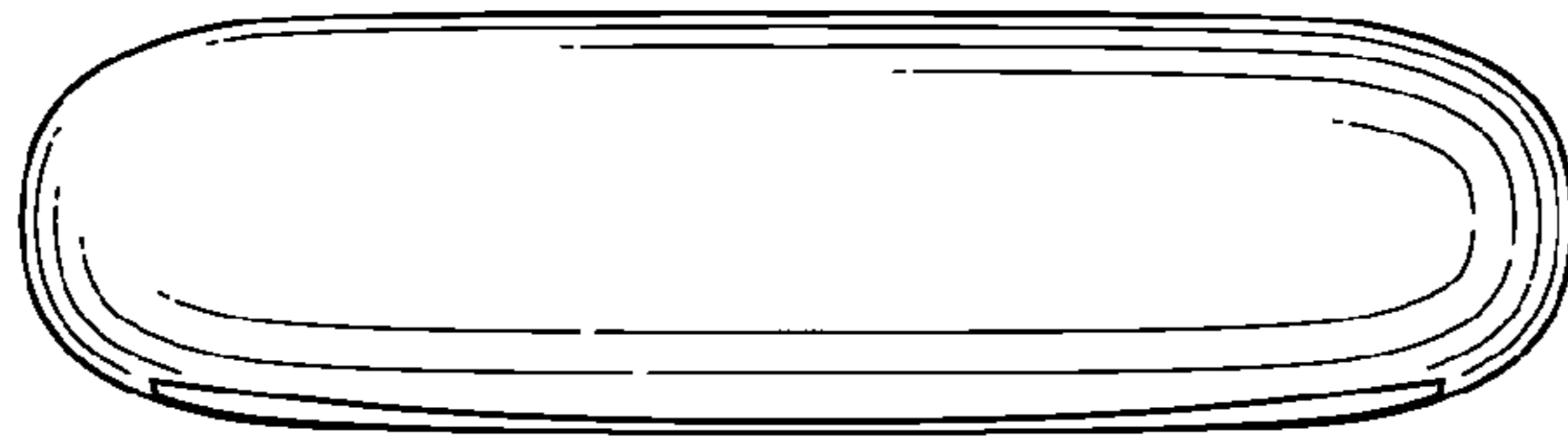

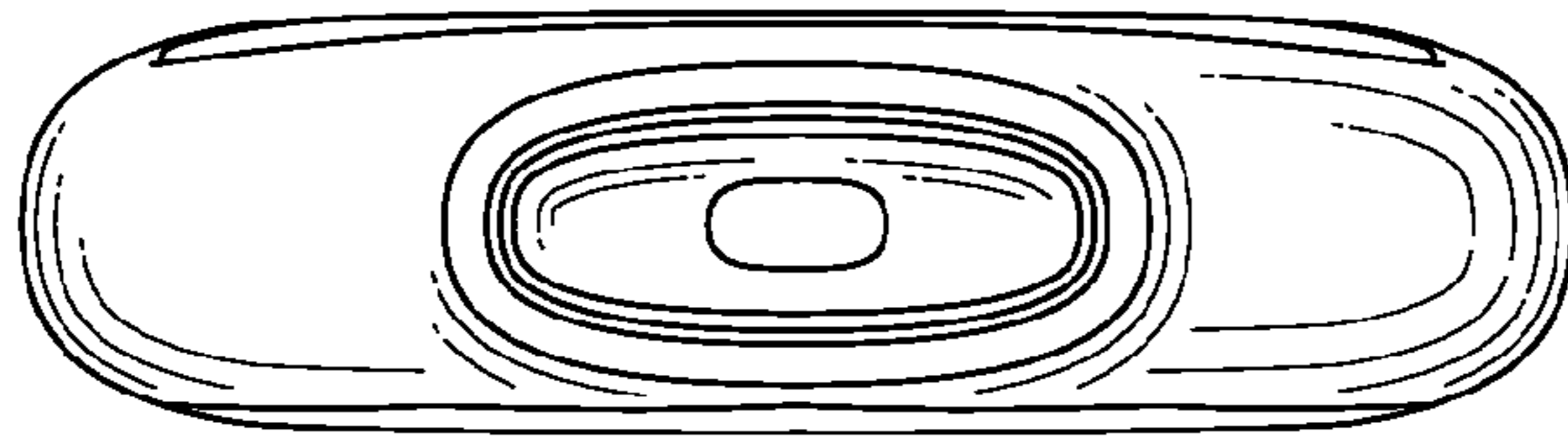

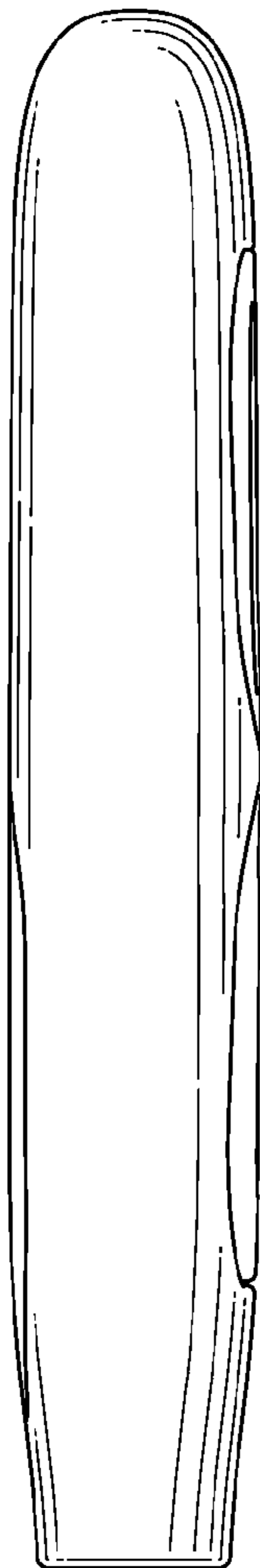
