The ornamental design for an automotive exterior, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of an automotive exterior in accordance with the present invention;

FIG. 2 is a right side perspective view of the automotive exterior of FIG. 1;

FIG. 3 is a rear end/left side perspective view of the automotive exterior of FIG. 1;

FIG. 4 is a rear end/right side perspective view of the automotive exterior of FIG. 1;

FIG. 19 is a rear elevational view of the automotive exterior of FIG. 12;

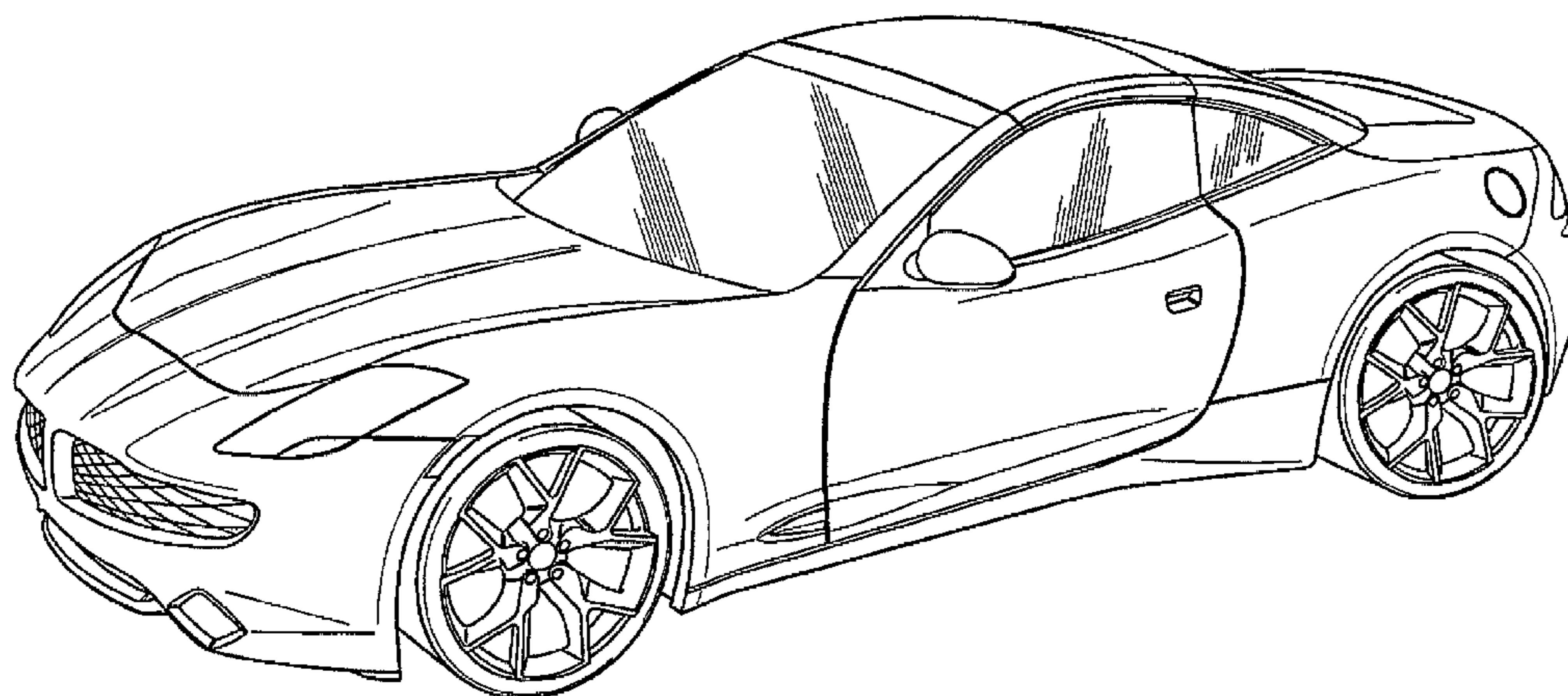
FIG. 20 is left side perspective view of the automotive exterior of a fourth embodiment automotive exterior in accordance with the present invention;

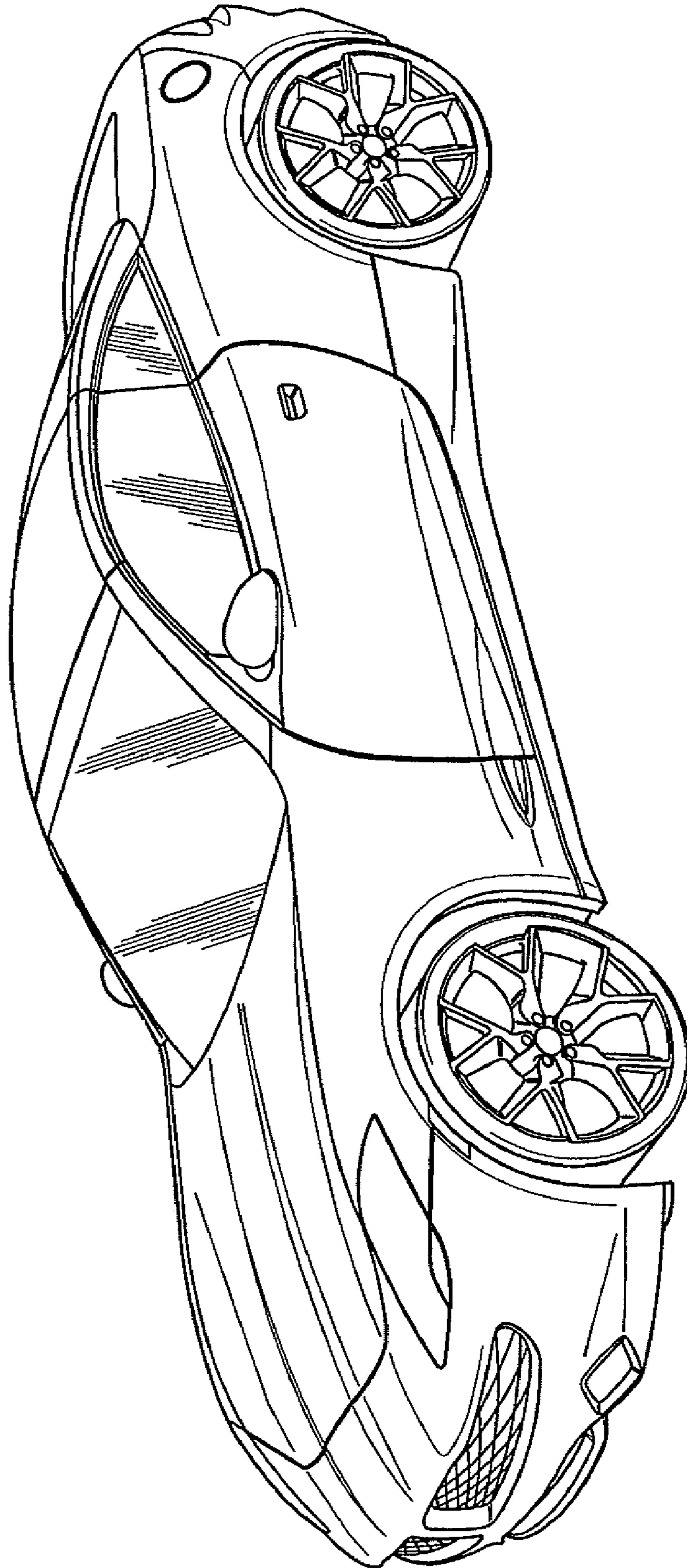

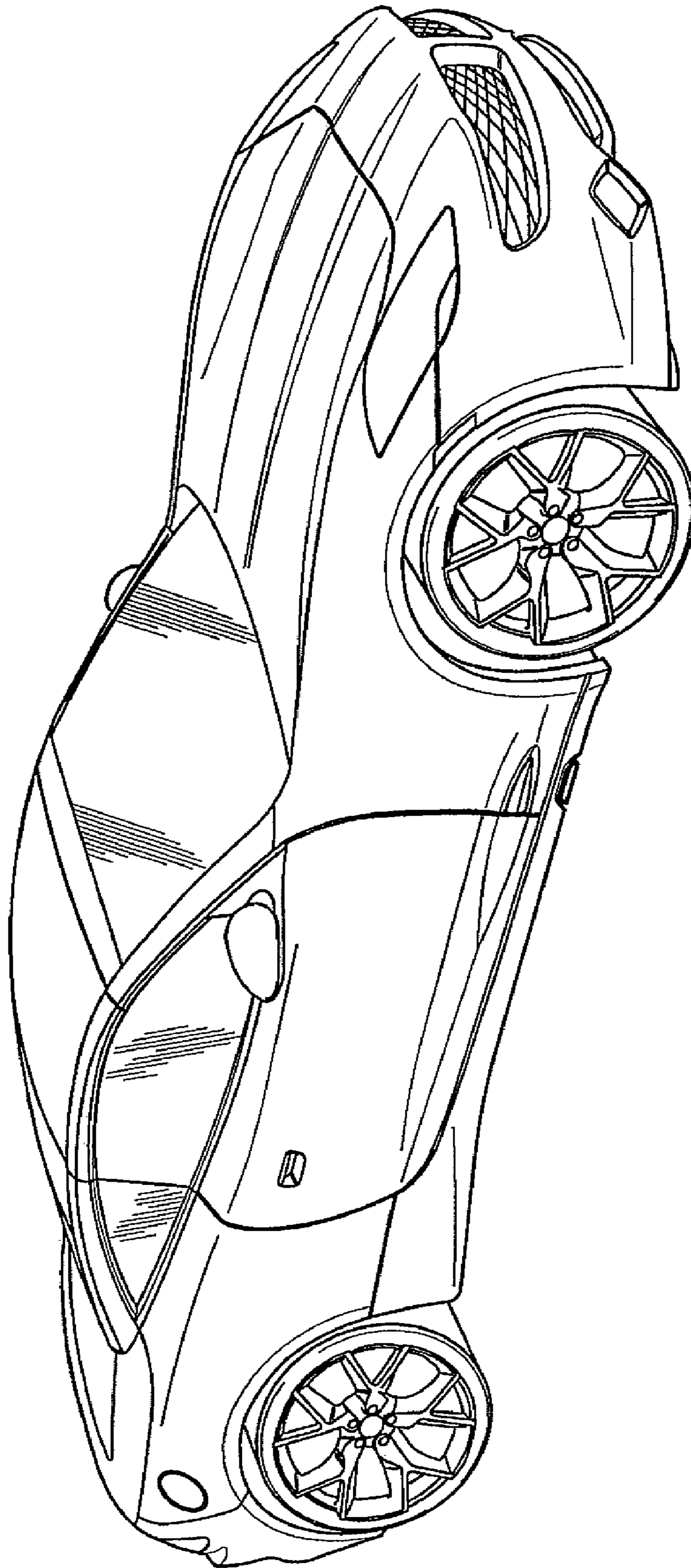

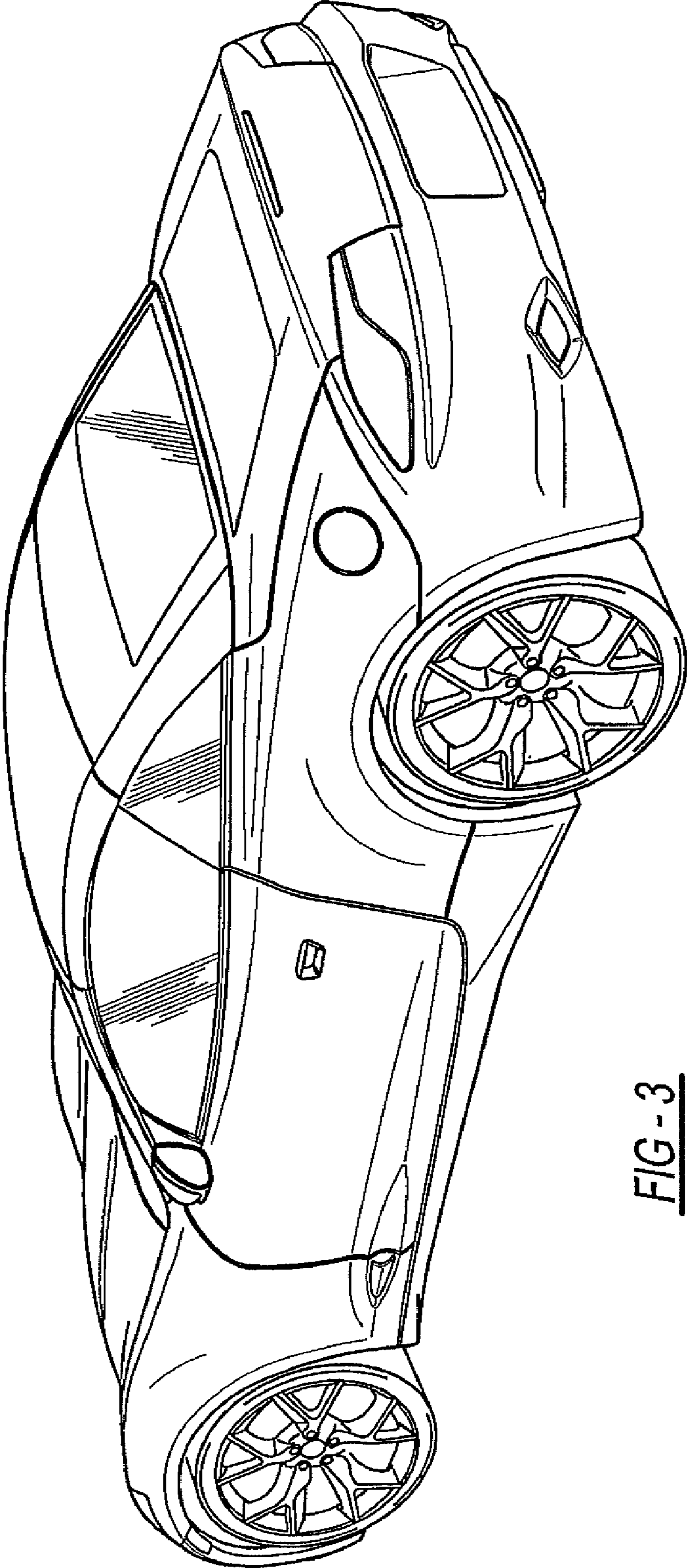

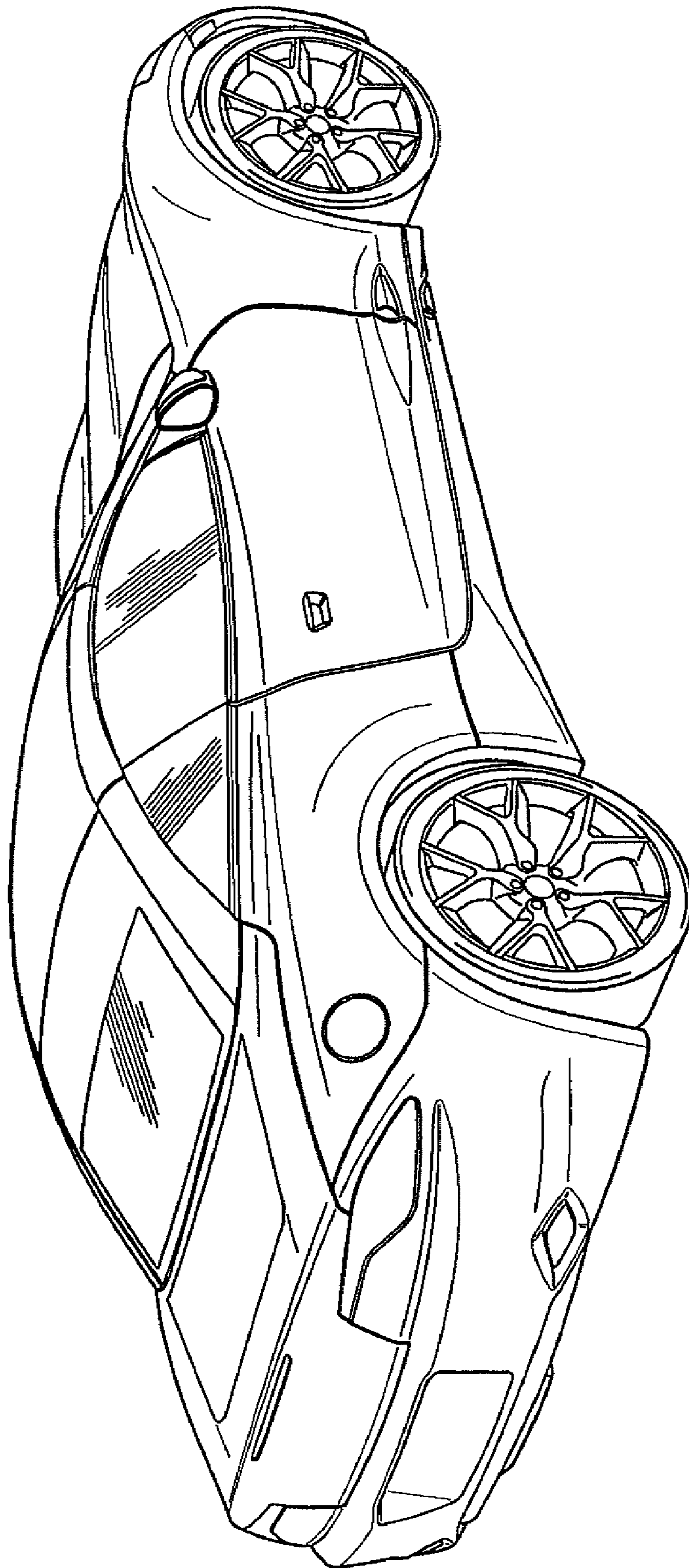

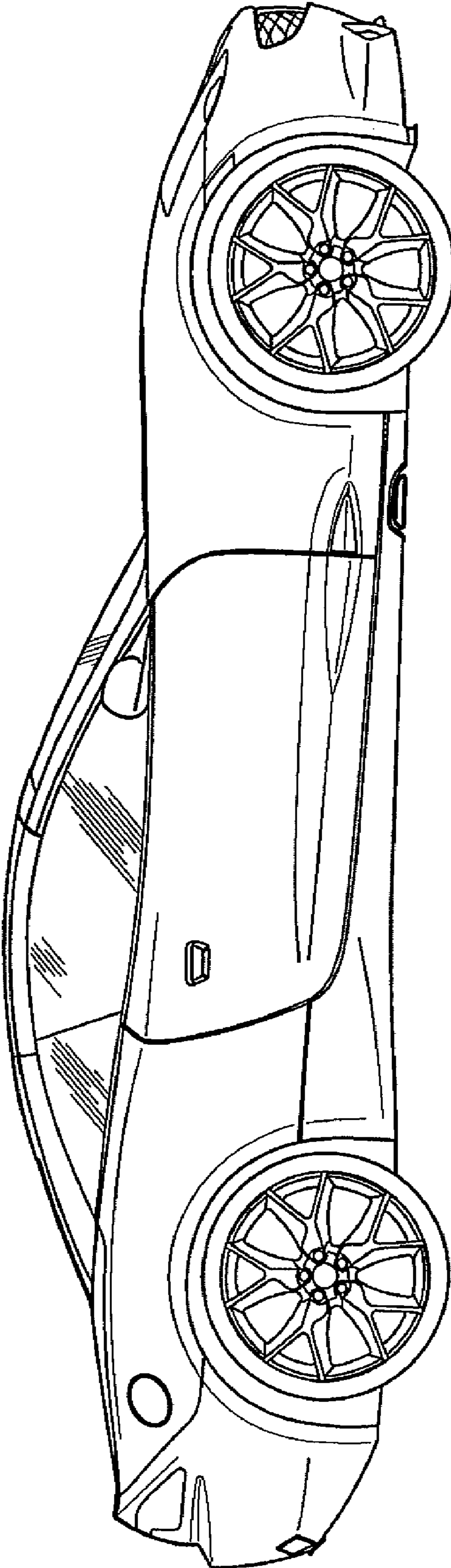

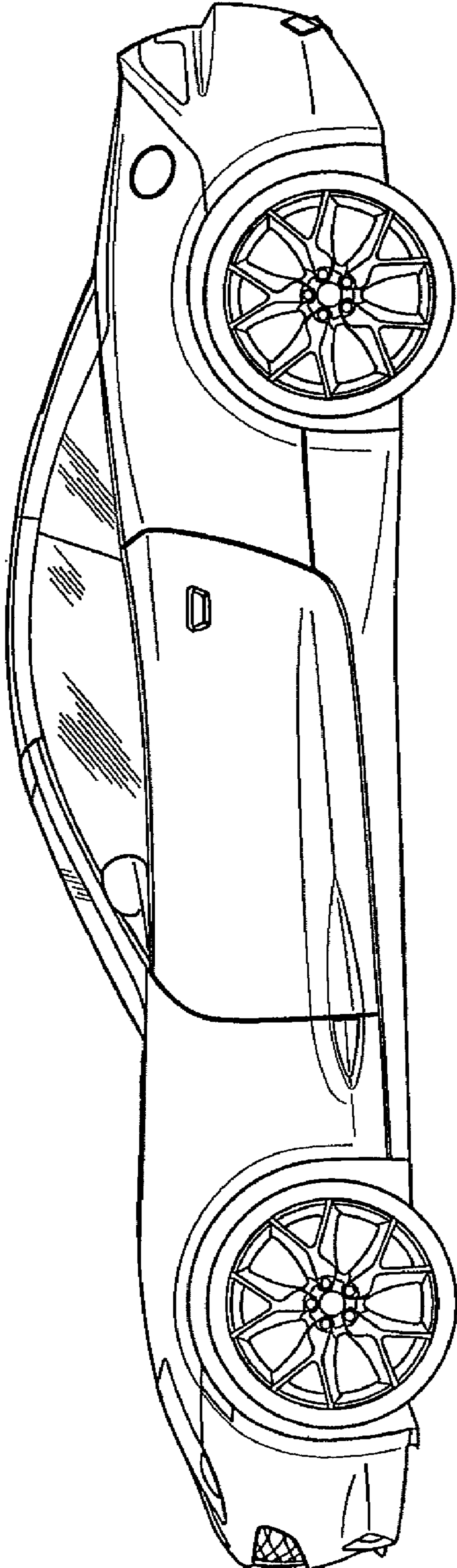

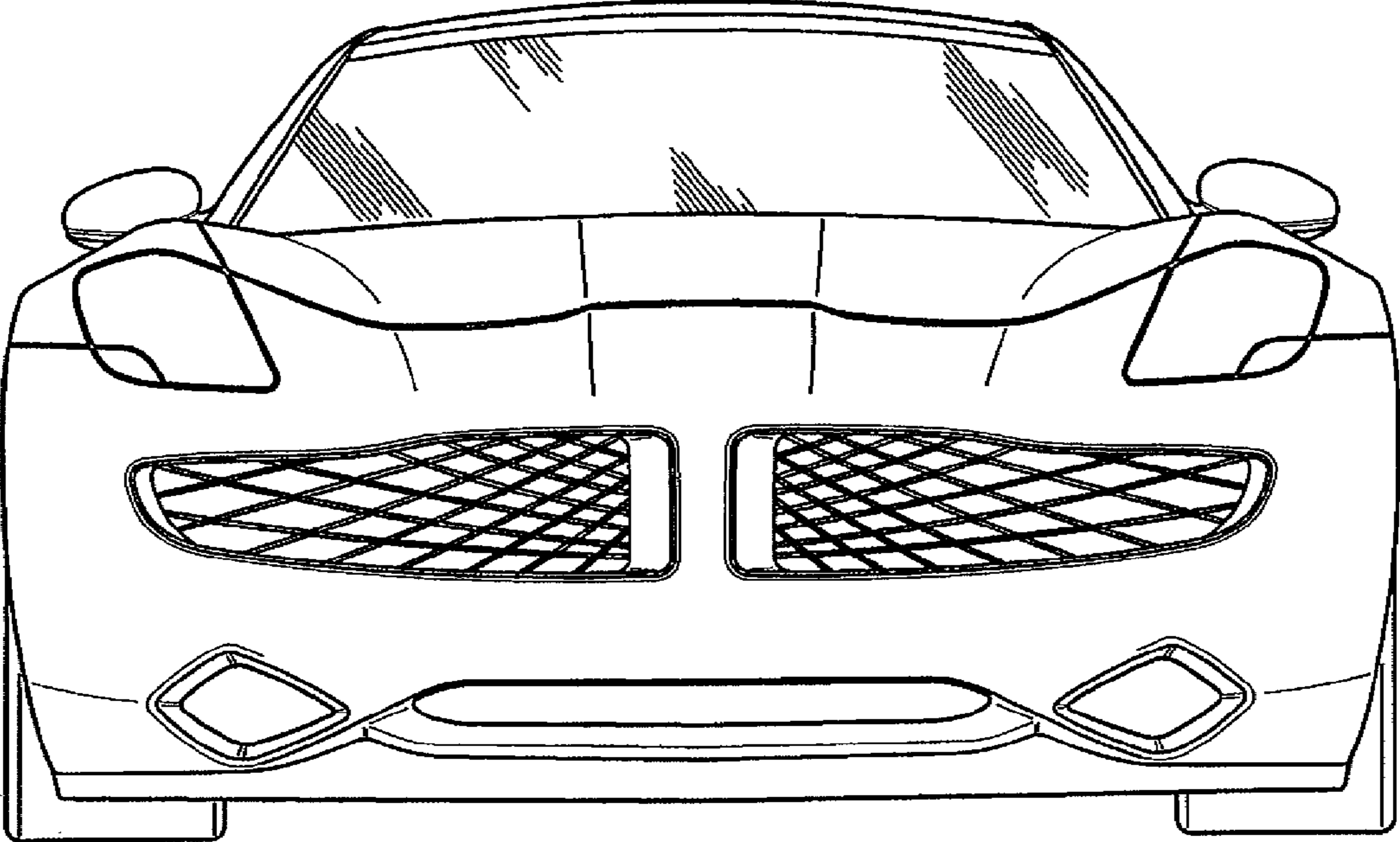

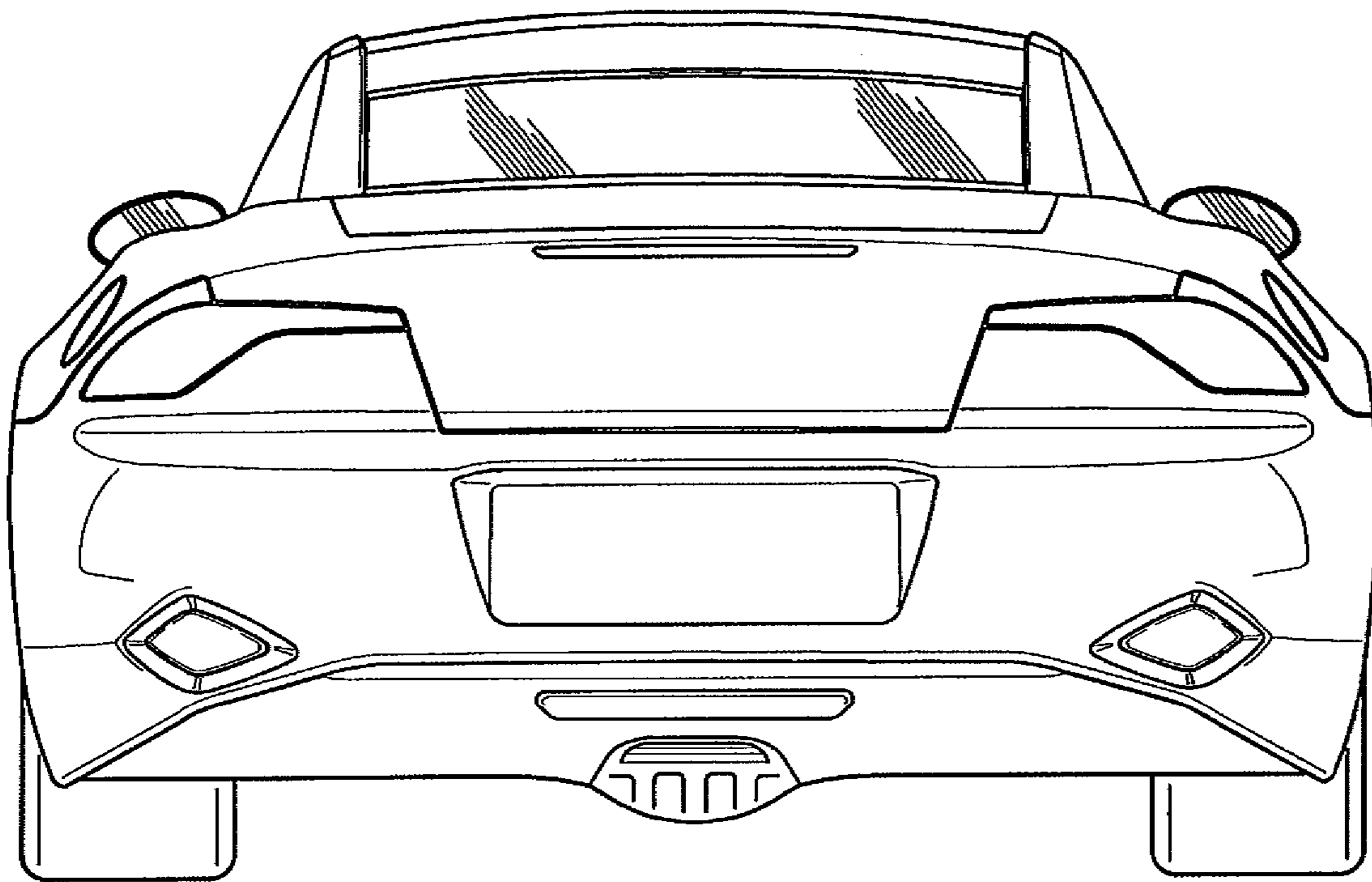

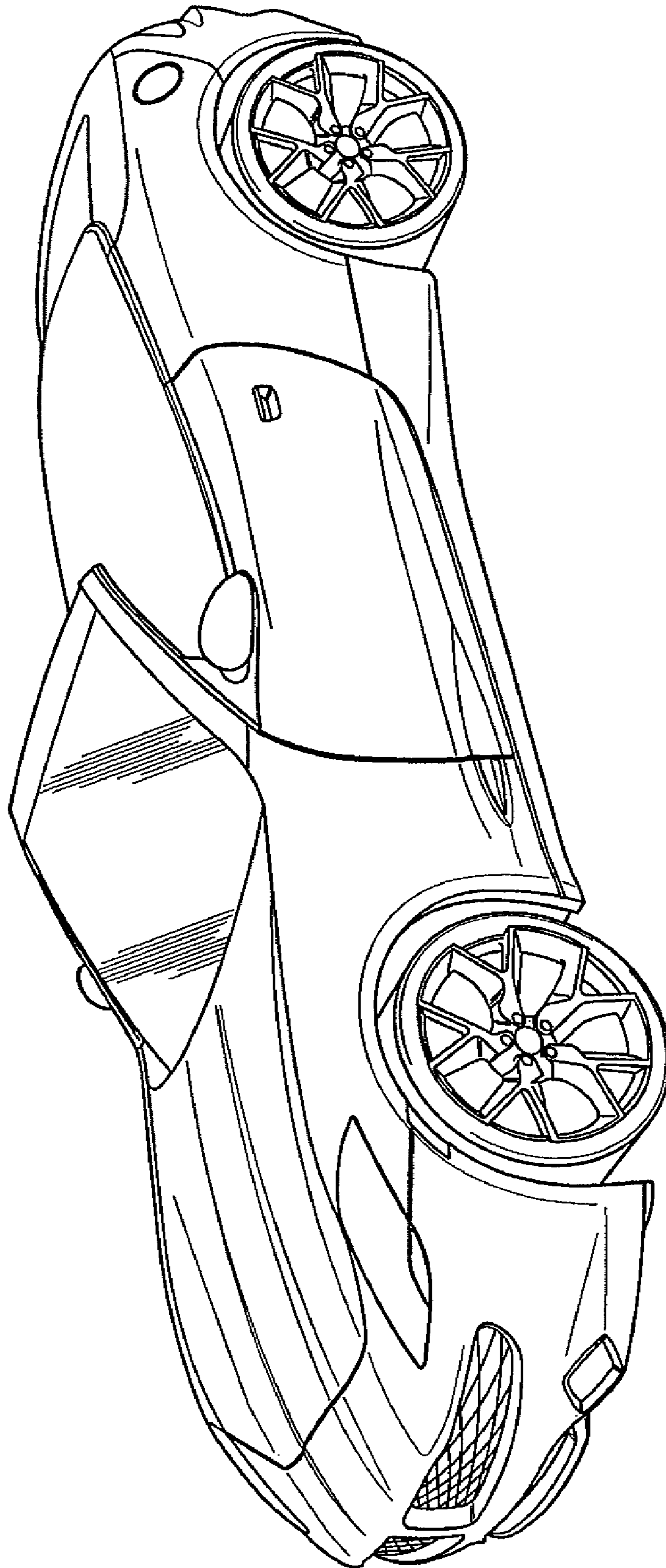

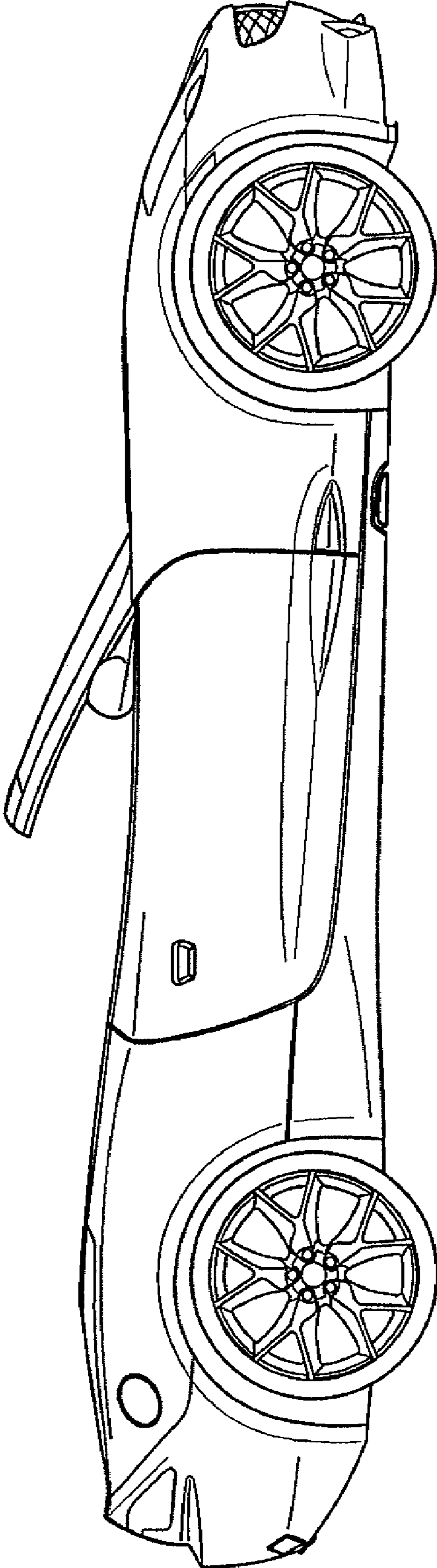

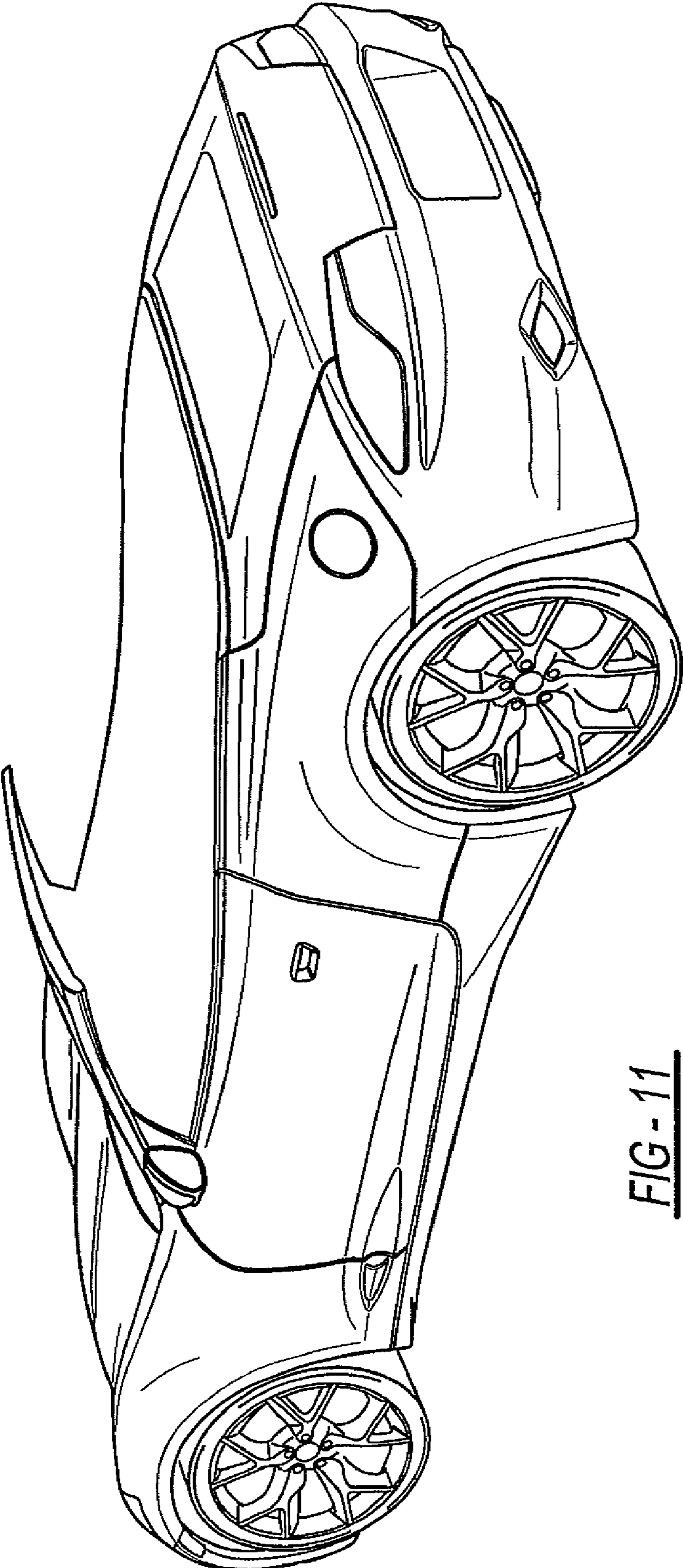

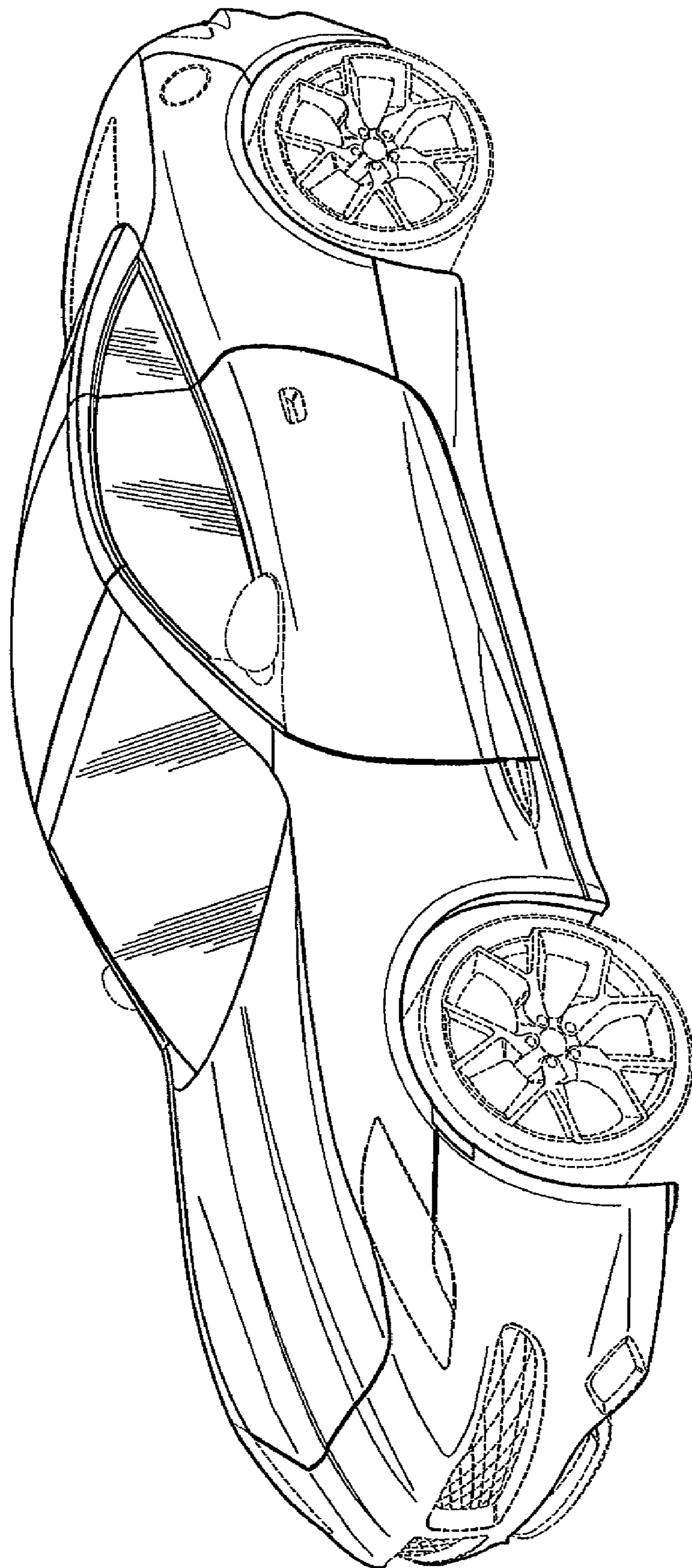

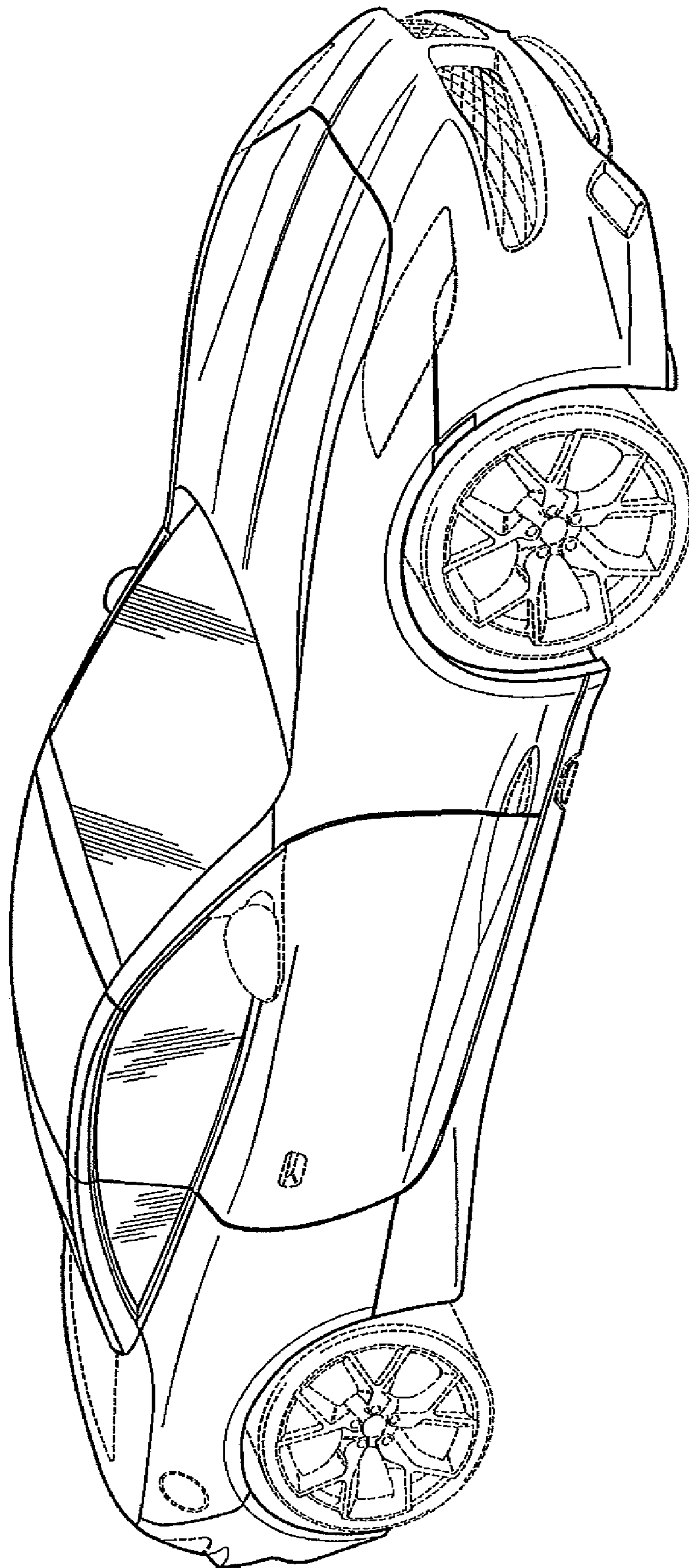

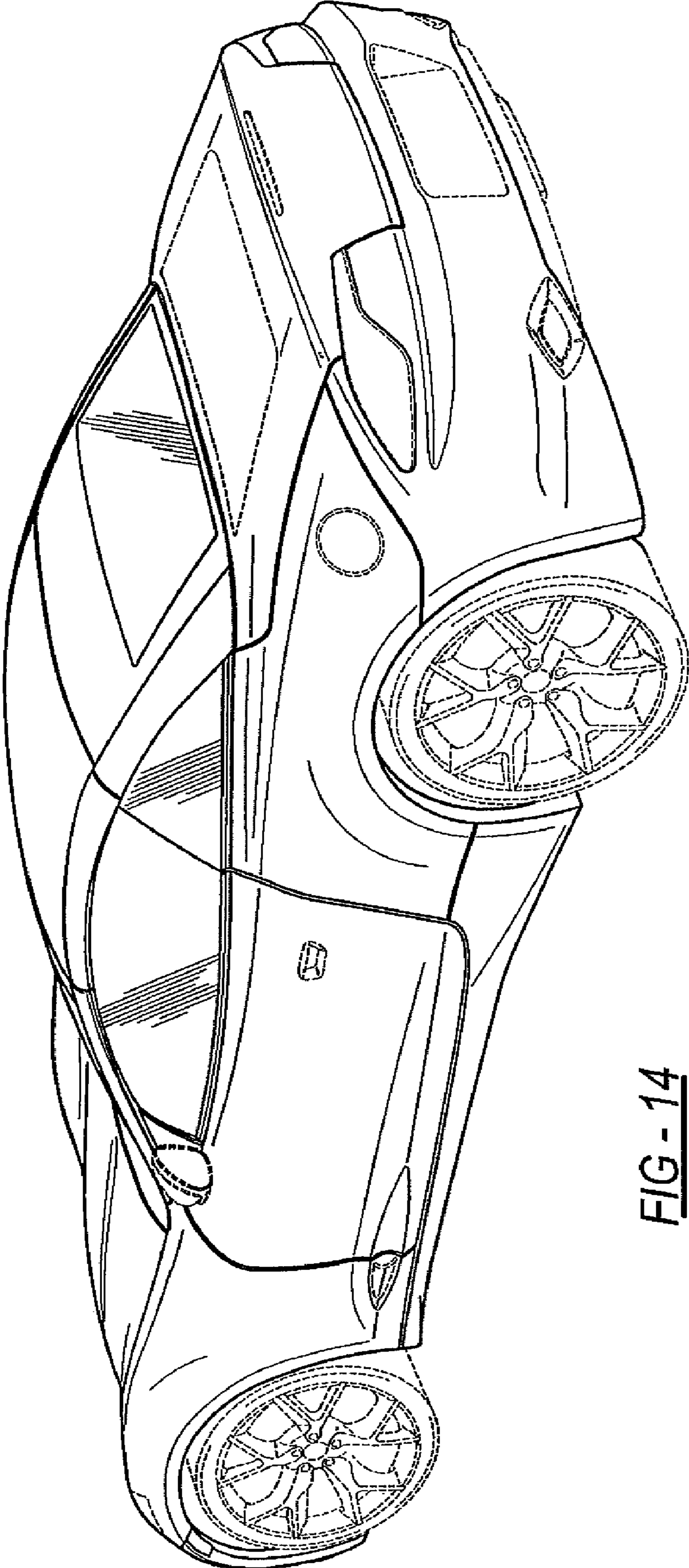

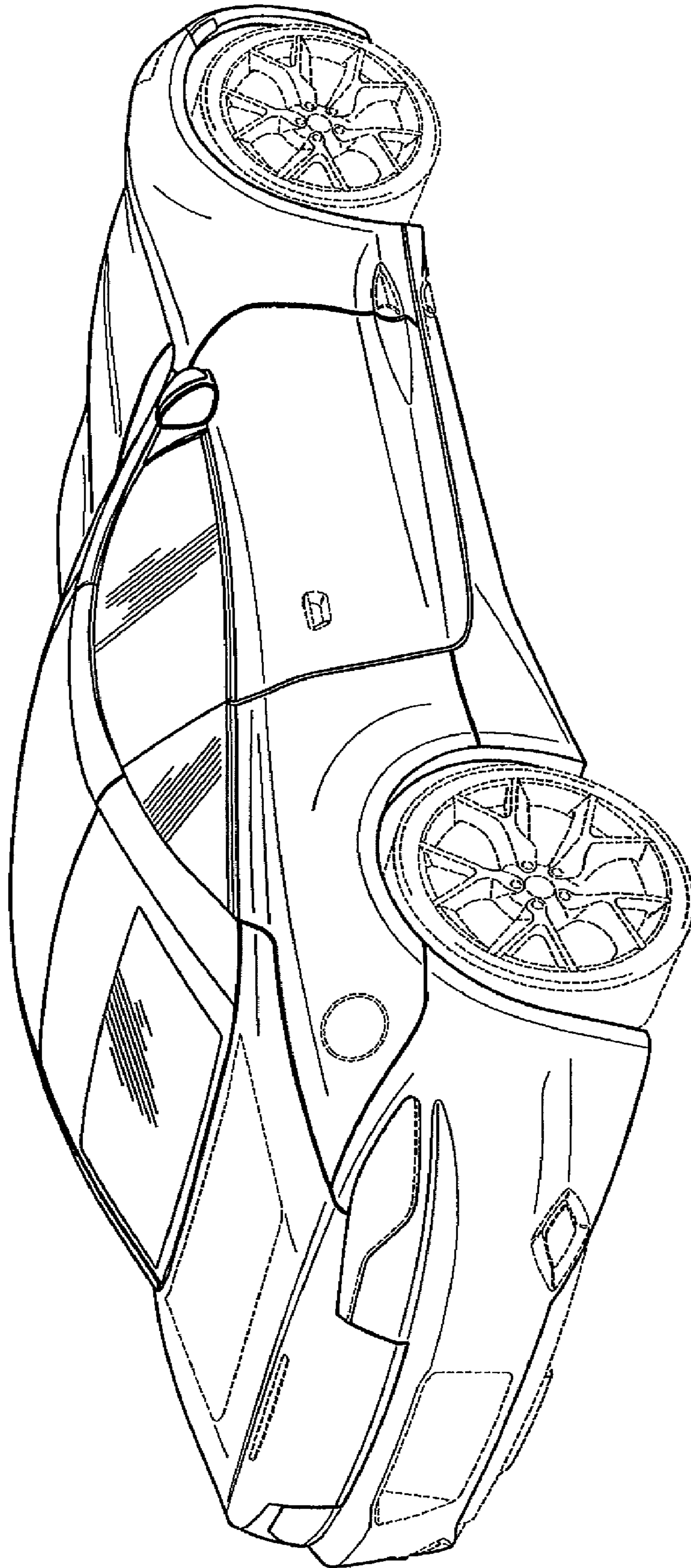

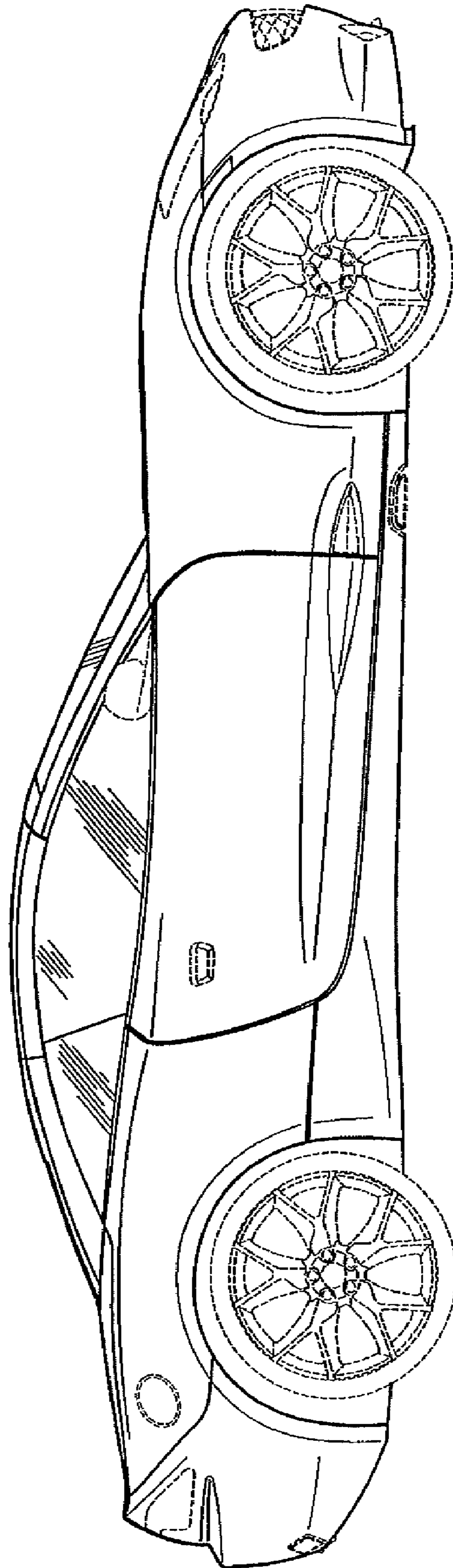

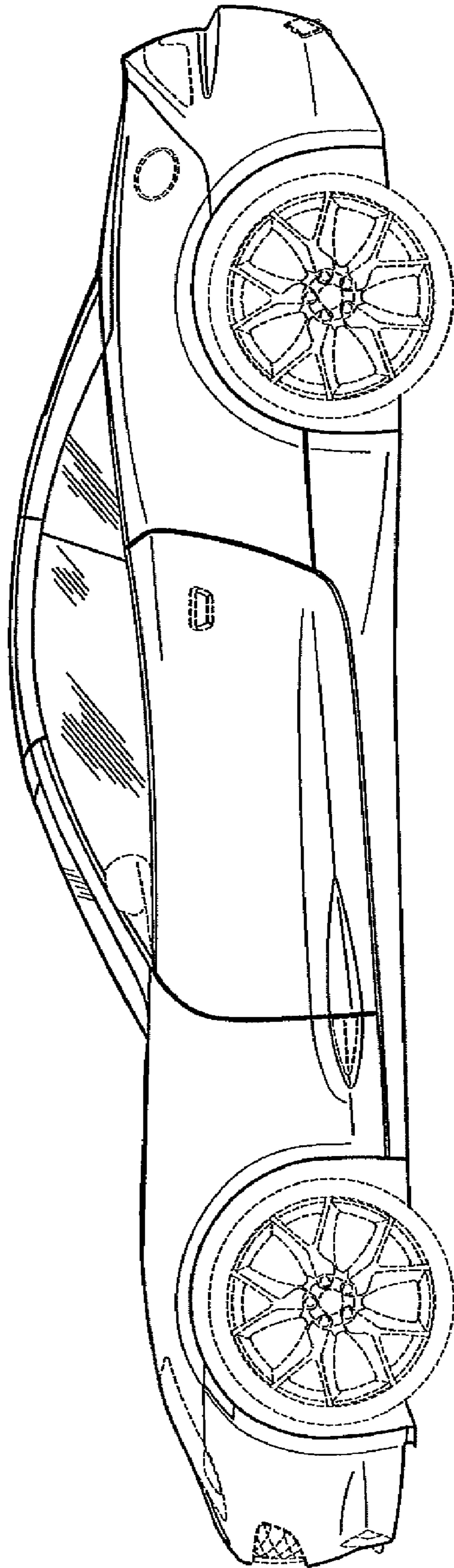

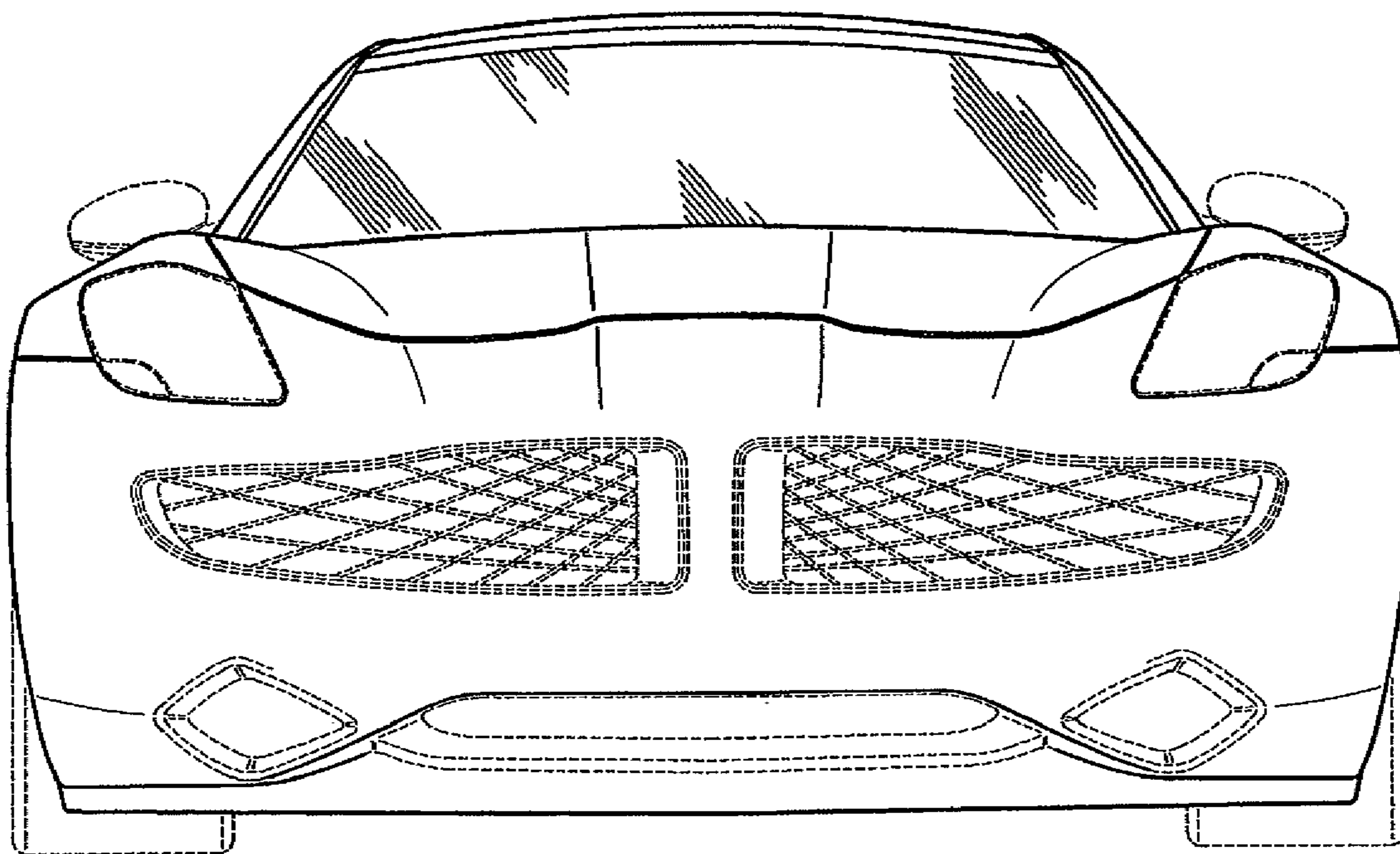

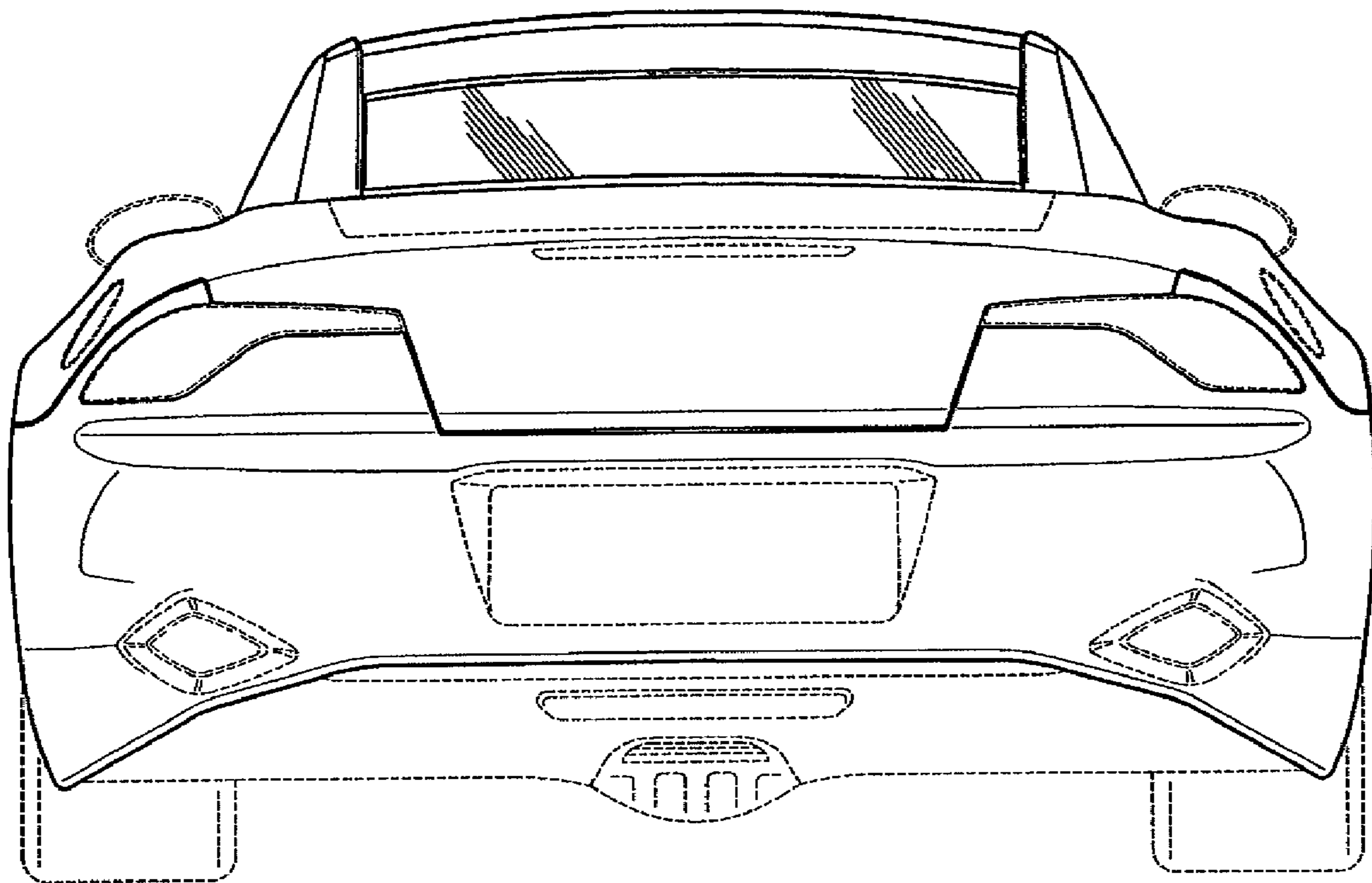

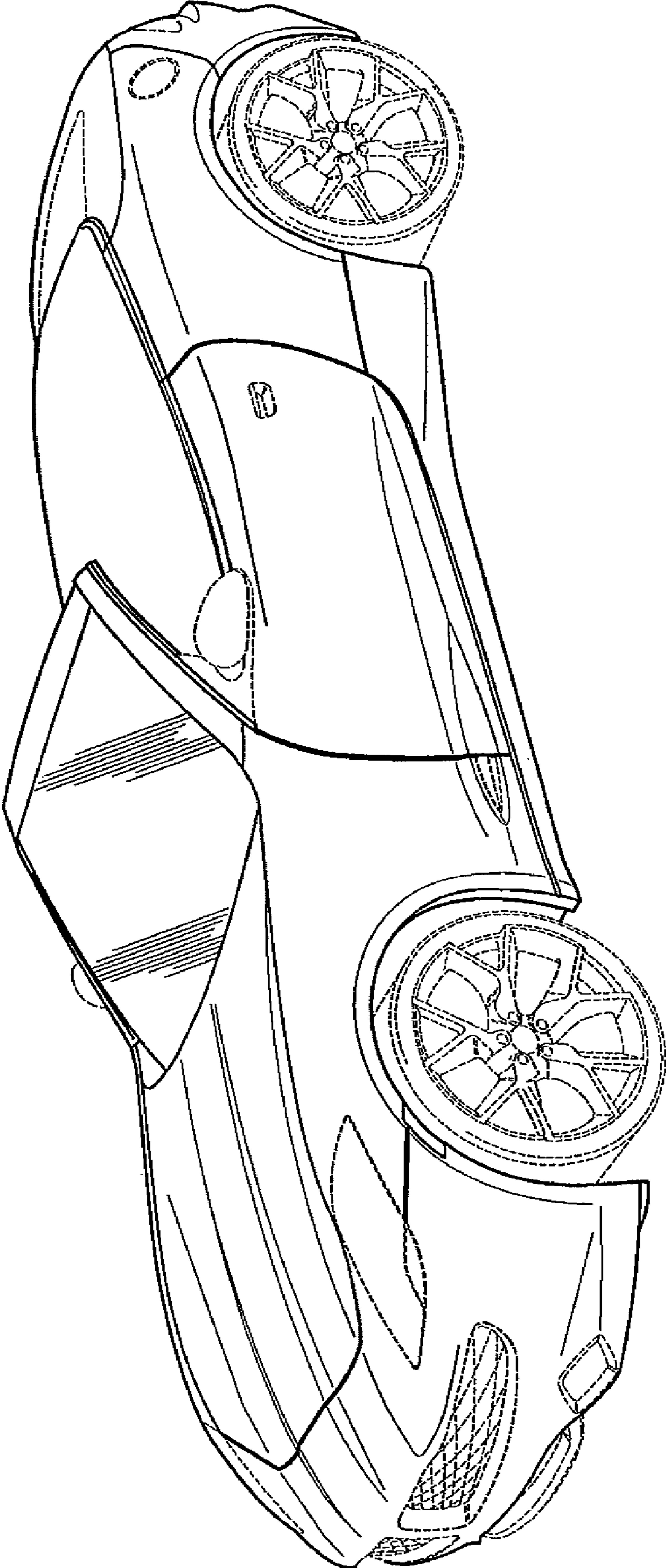

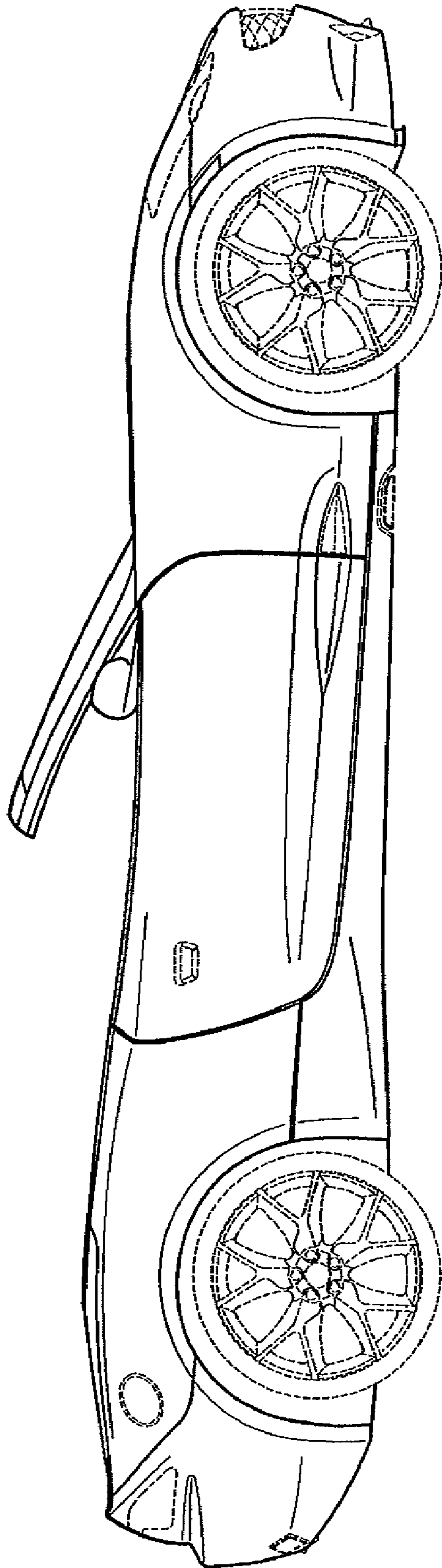

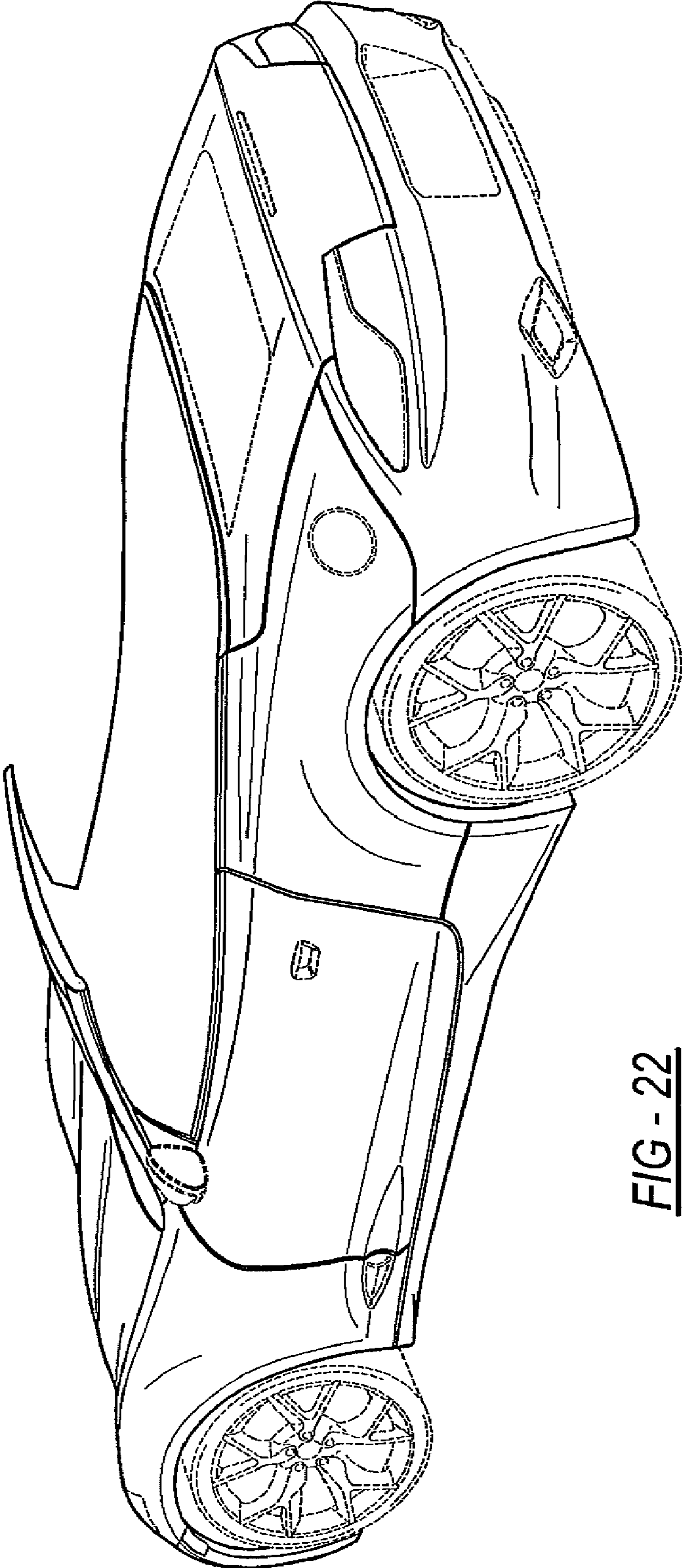
