(57) **CLAIM**

We claim the ornamental design for a pin and pin retainer for tow bar, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective side view of a pin and pin retainer for tow bar showing our new design;

FIG. 2 is a side elevational view thereof, the elevational view of the opposing side being a mirror image thereof;

FIG. 3 is an end elevational view thereof;

FIG. 4 is an elevational view of the opposing end thereof;

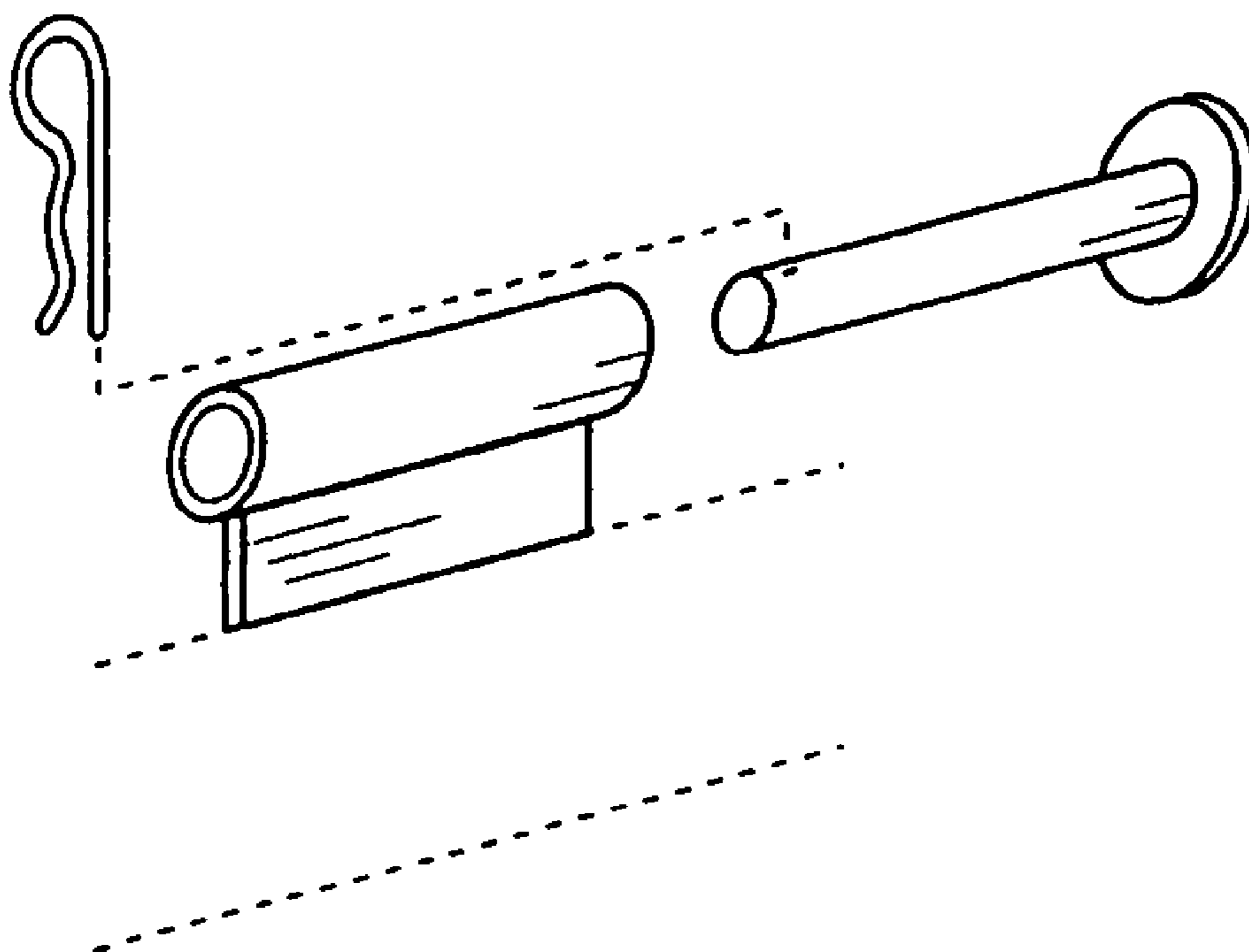
FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a reduced side elevational view showing the pin and pin retainer for tow bar in use.

The broken line showing of details in FIGS. 1-7 is included for the purpose of showing environmental portions of the pin and pin retainer for tow bar and forms no part of the claimed design.

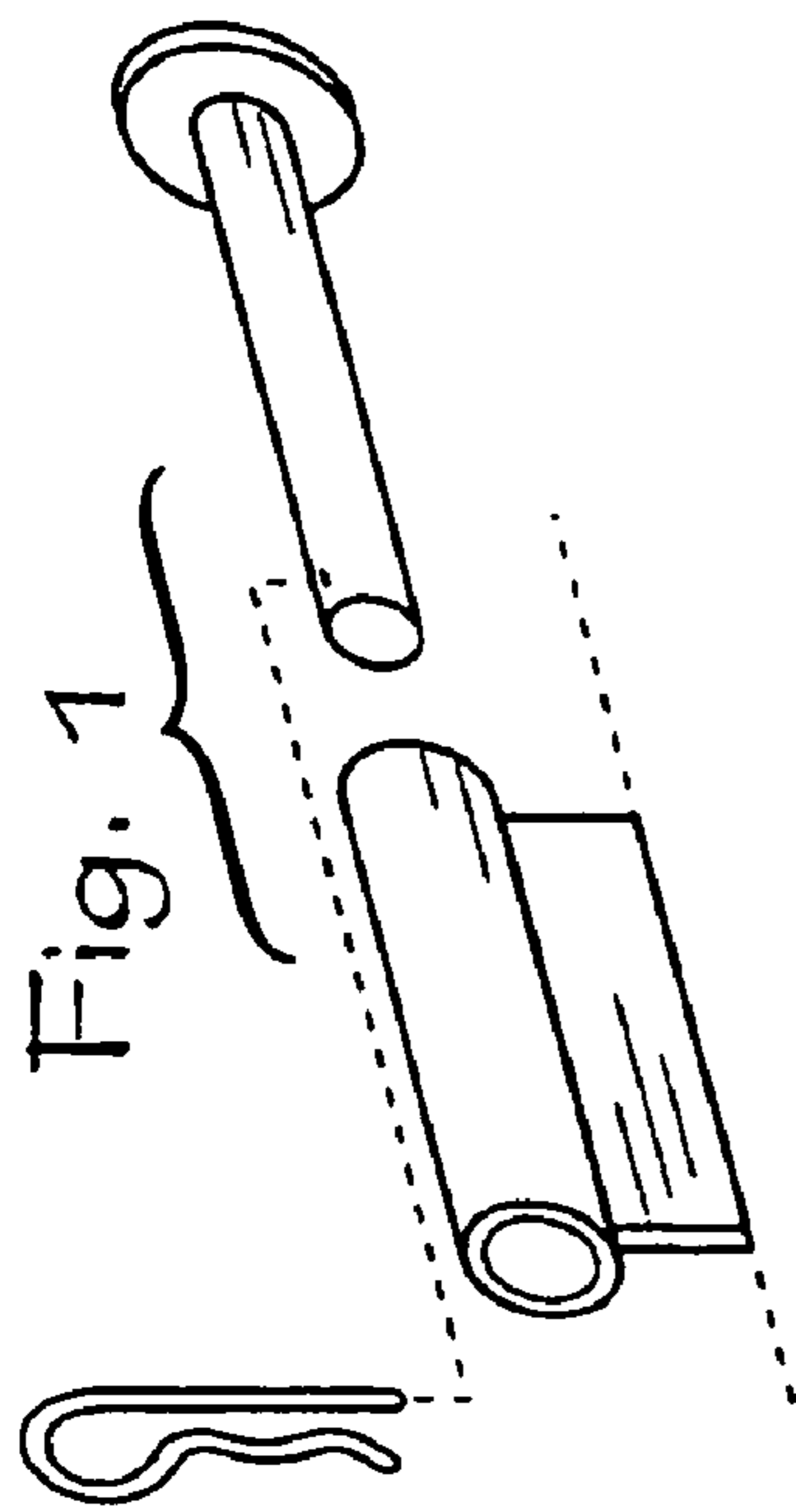

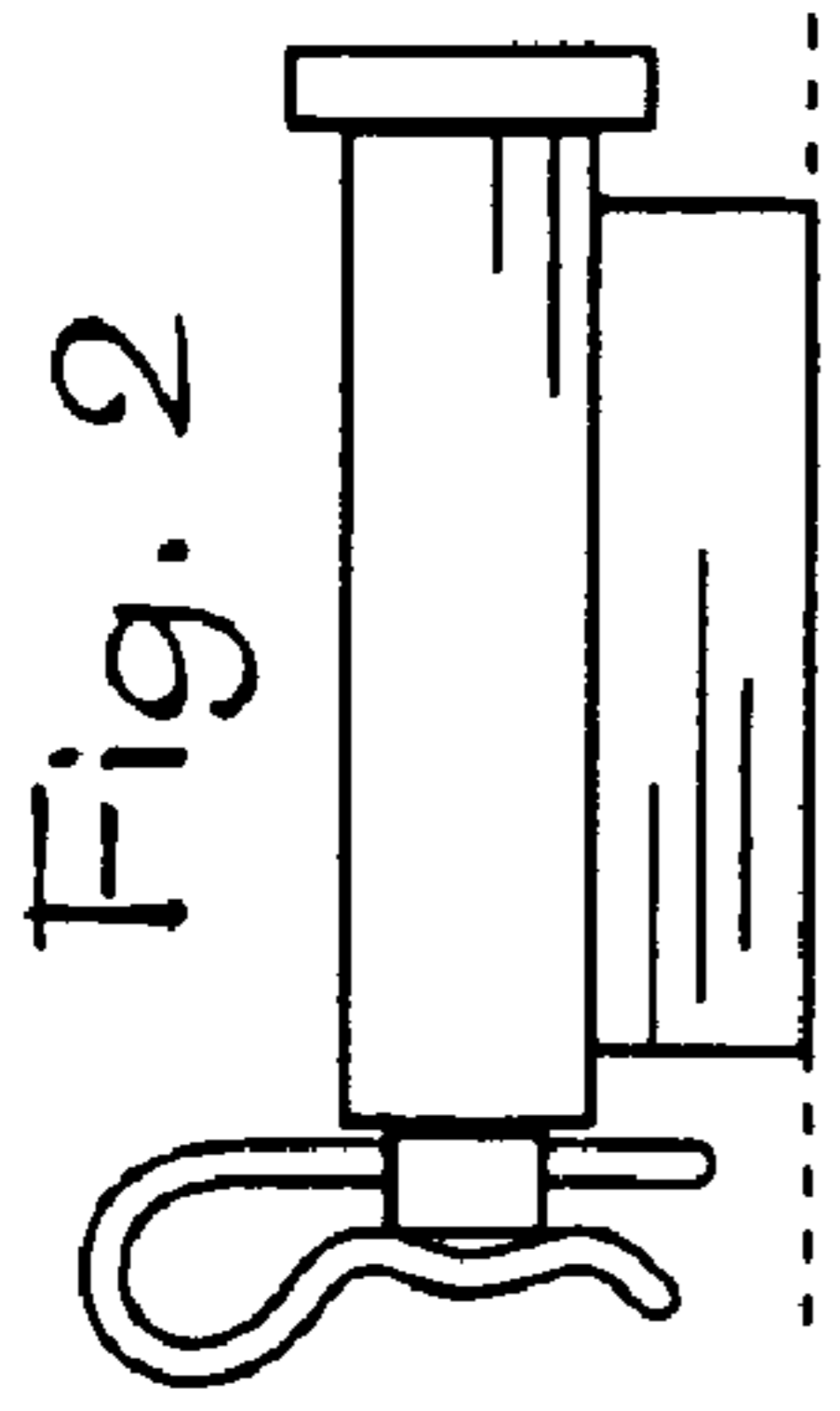

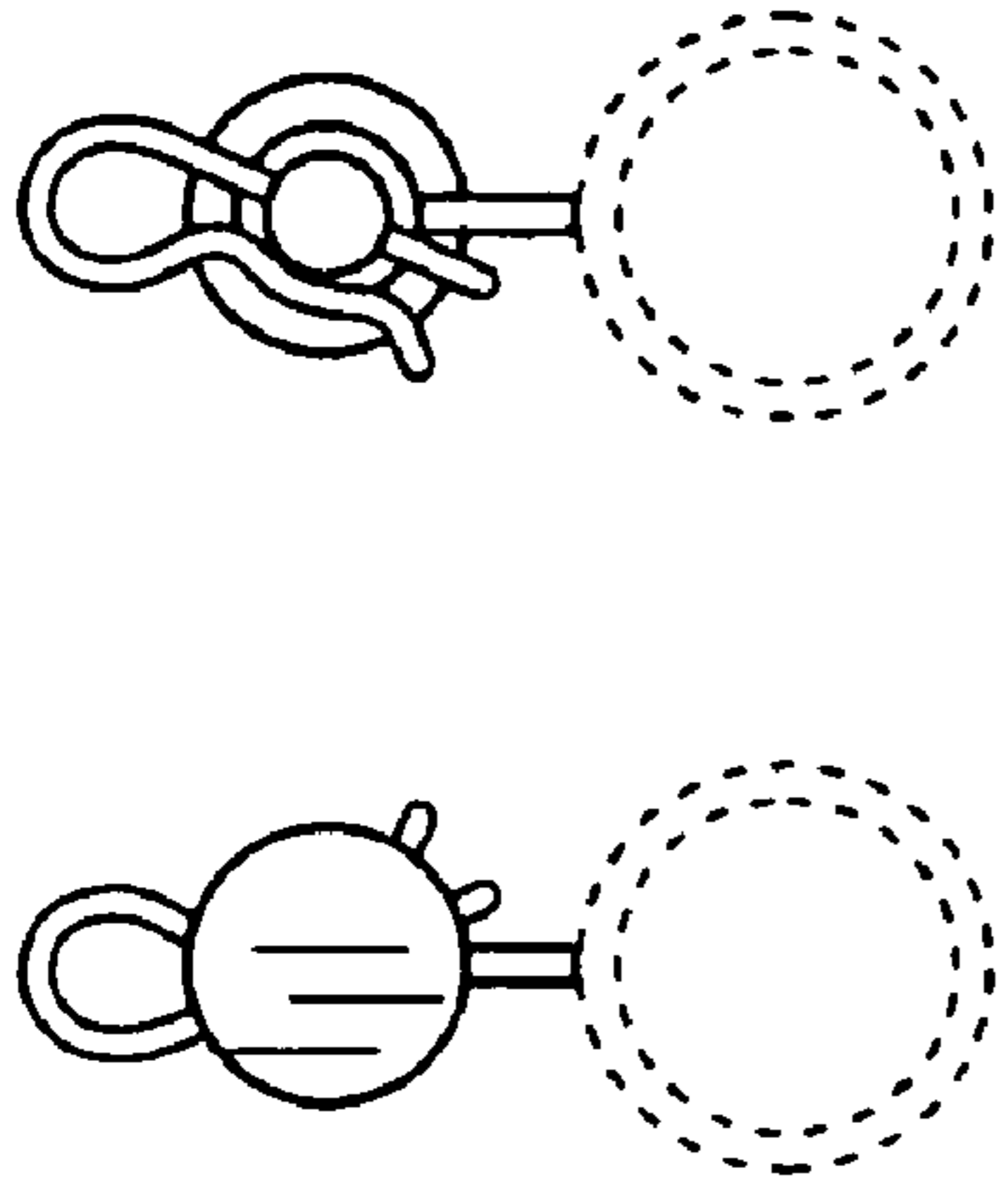

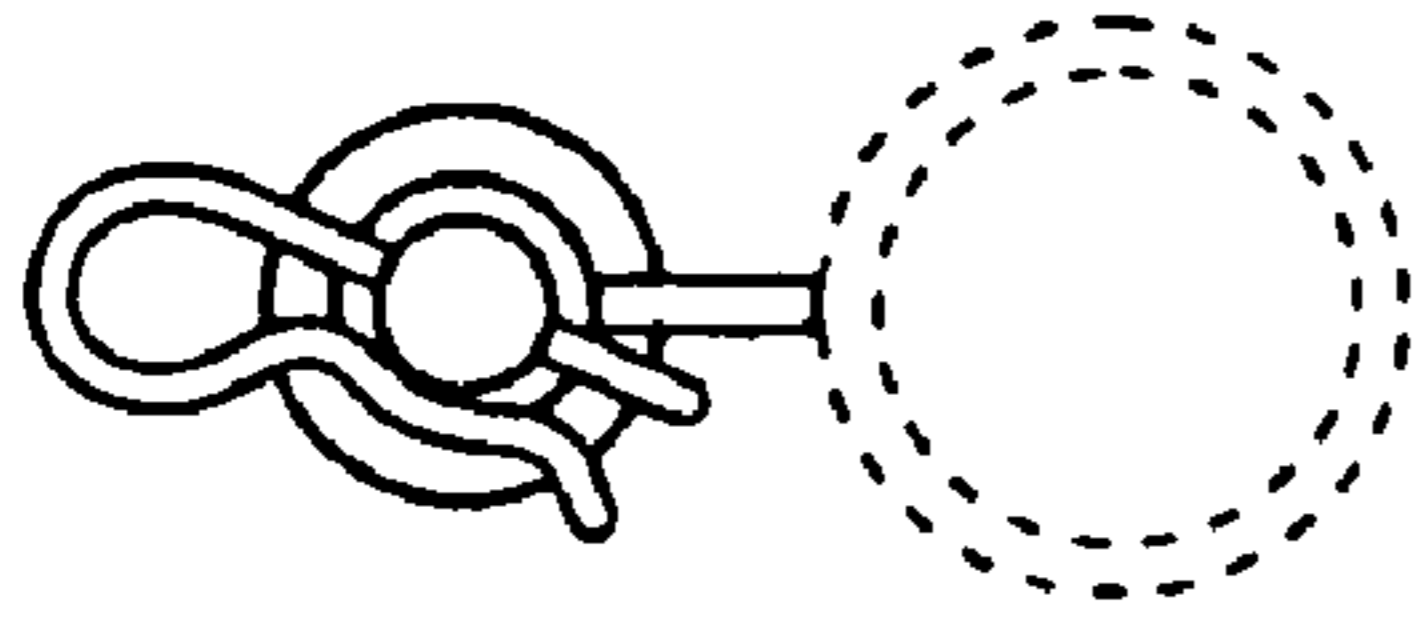

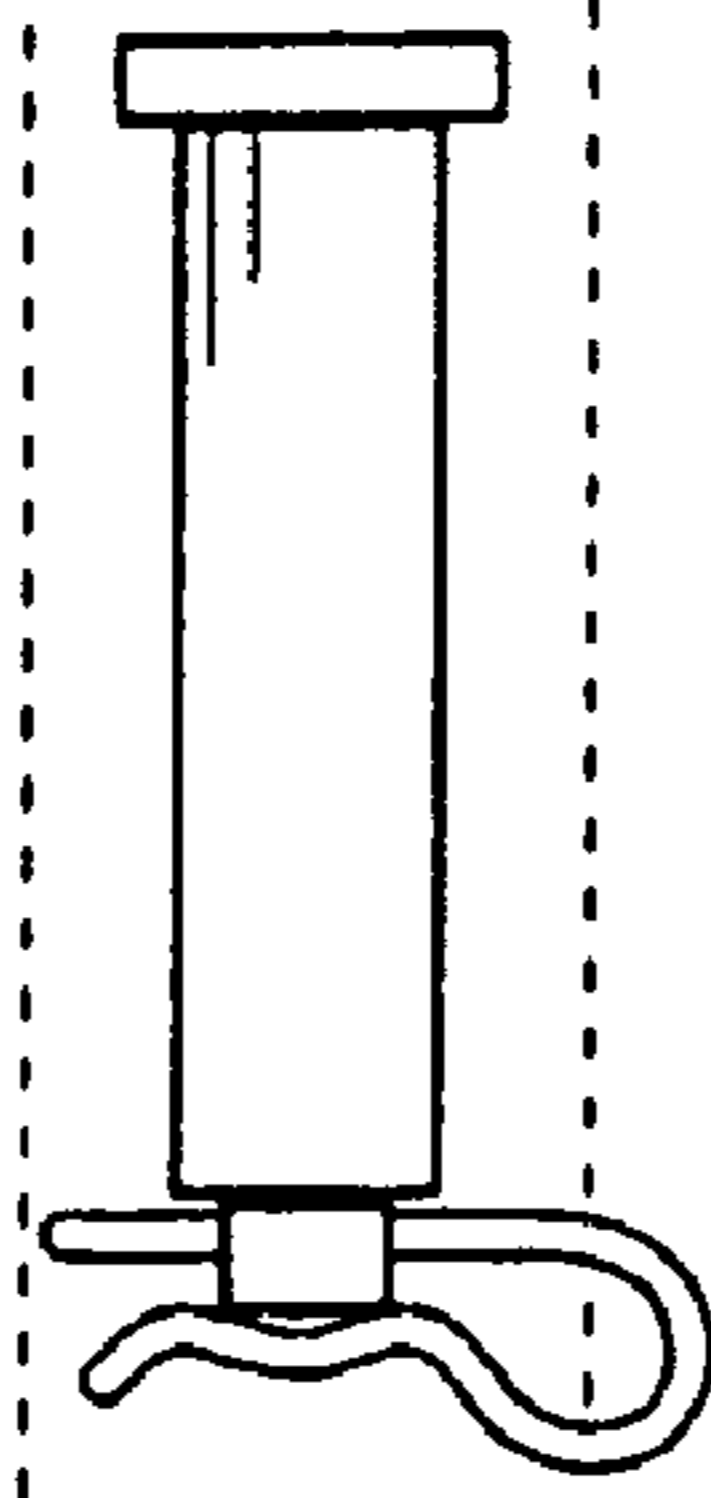

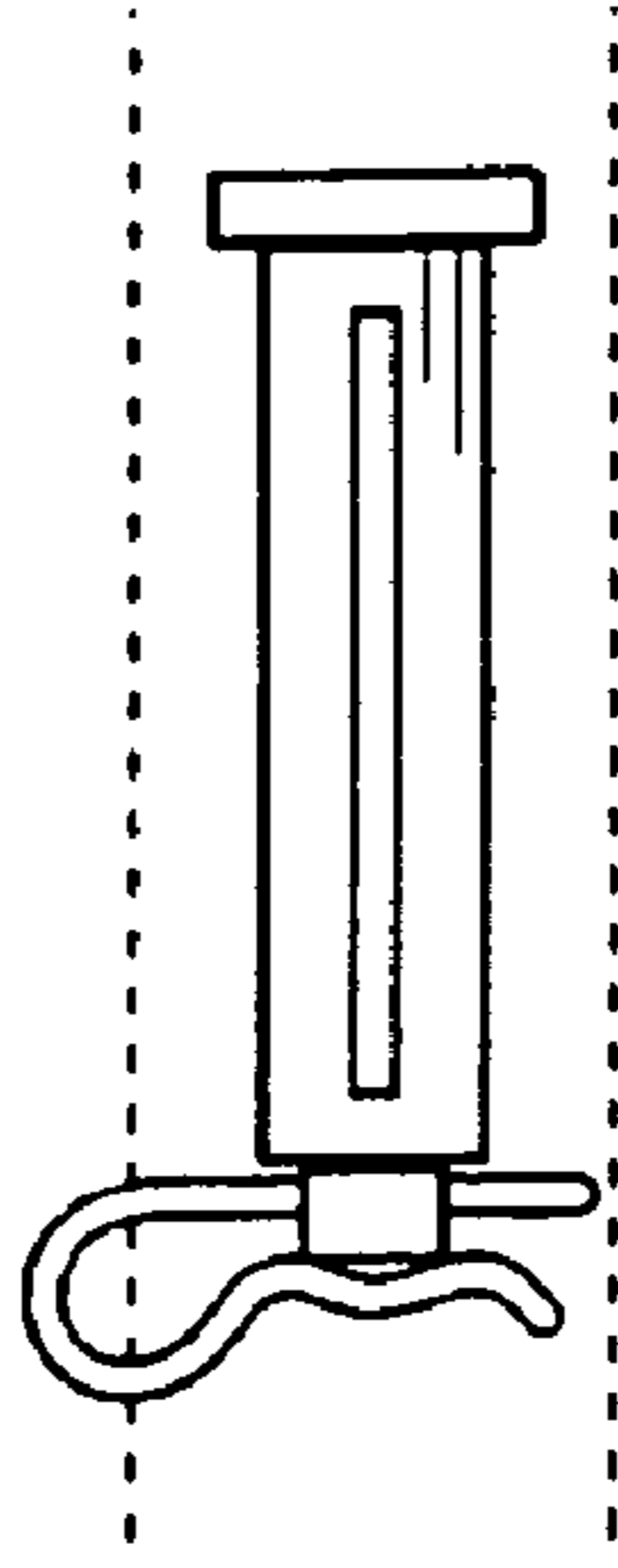

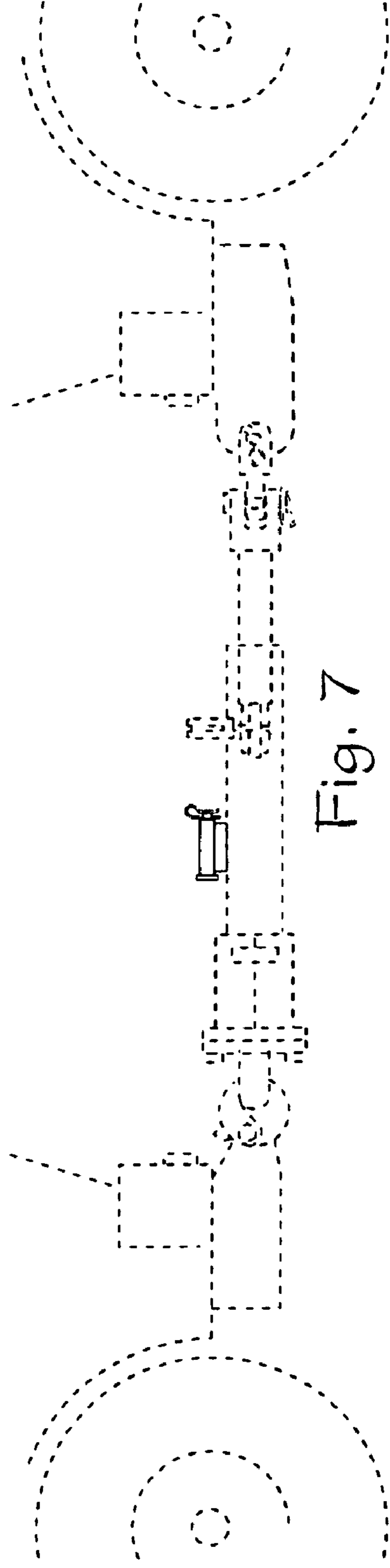
