(57) **CLAIM**

The ornamental design for a resonance chamber disposed about a conduit contour of an emission system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a resonance chamber disposed about a conduit contour of an emission system of the present invention;

FIG. 2 is a front side elevation view thereof;

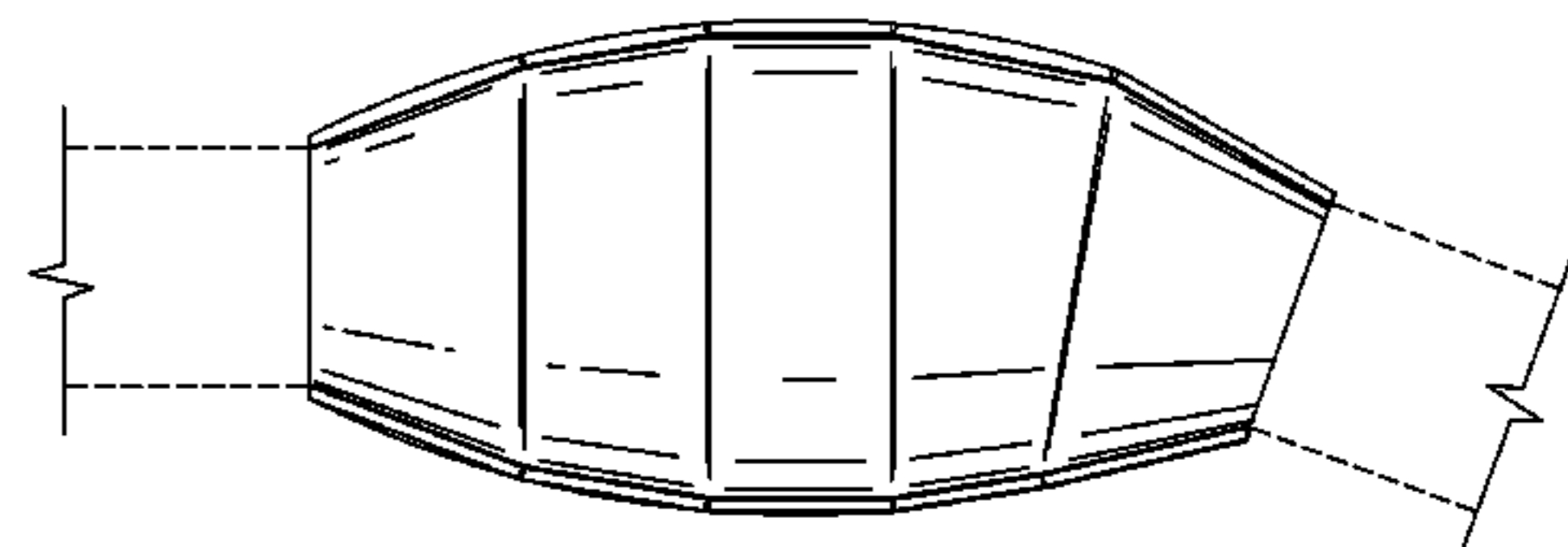
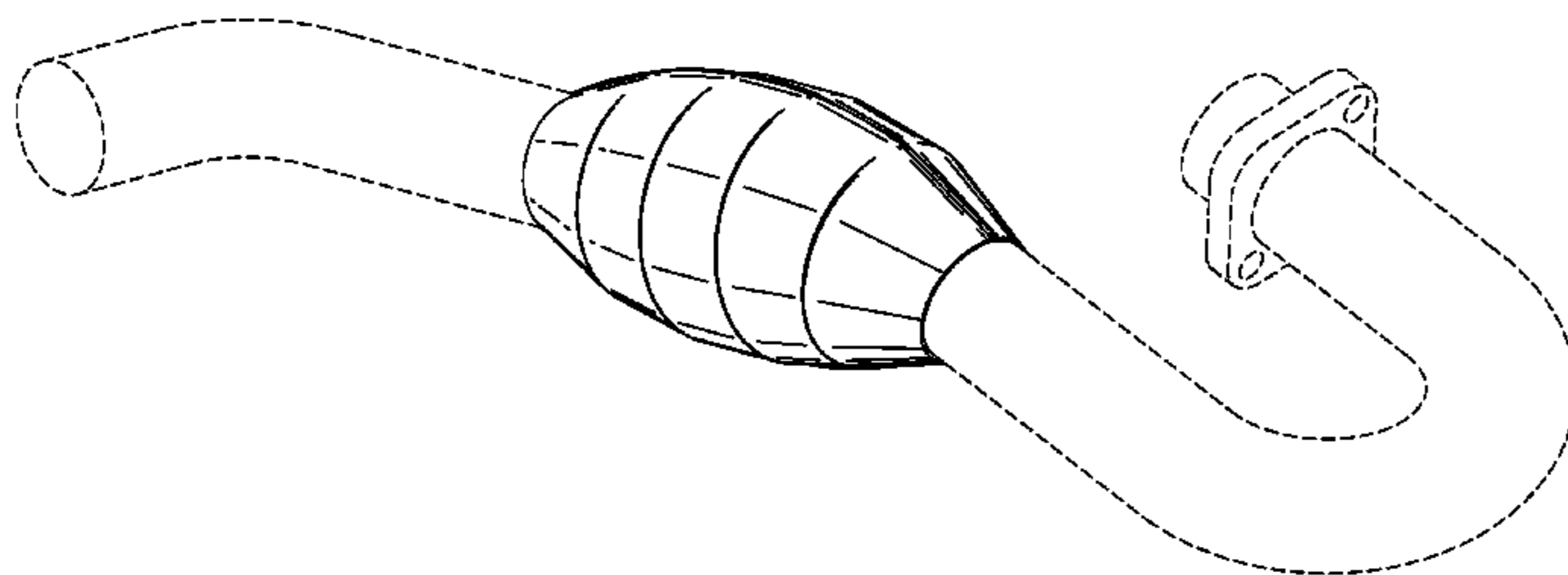
FIG. 3 is a back side elevational view thereof;

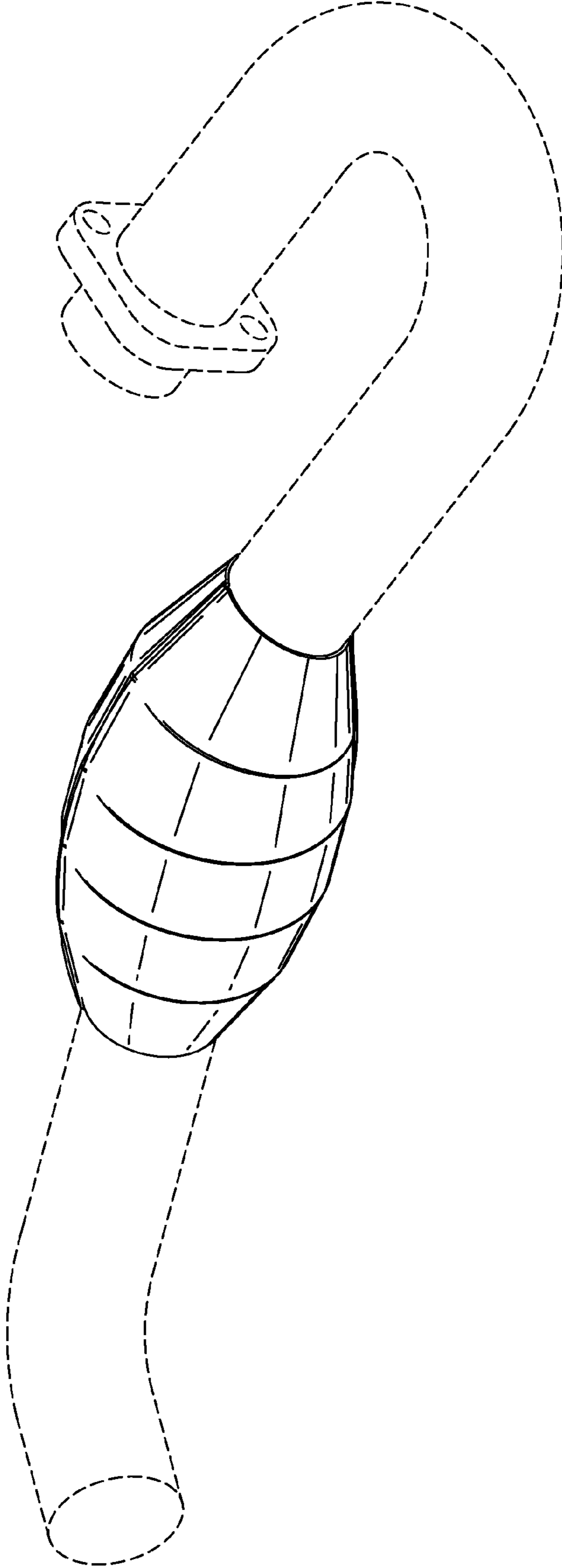

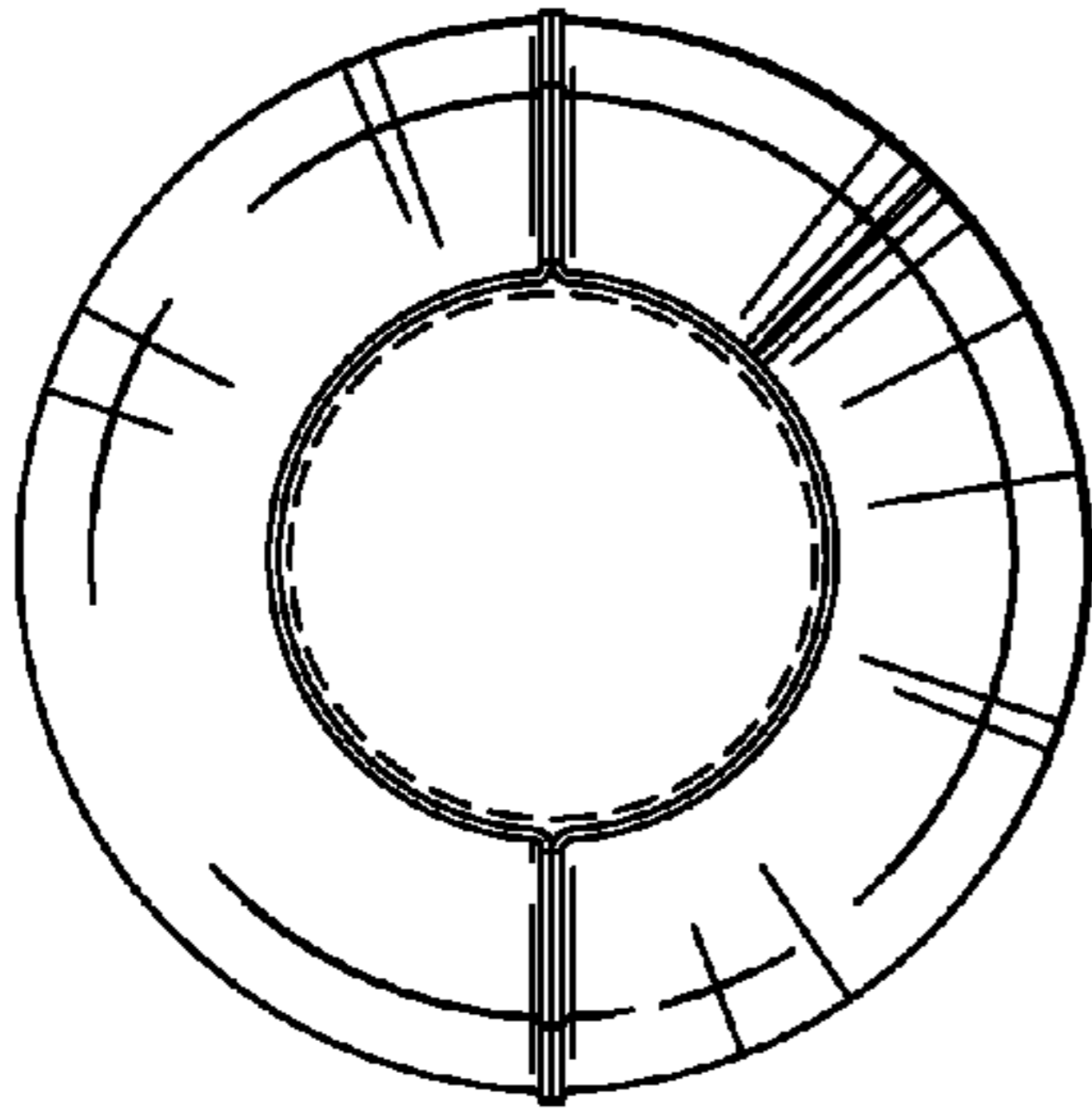

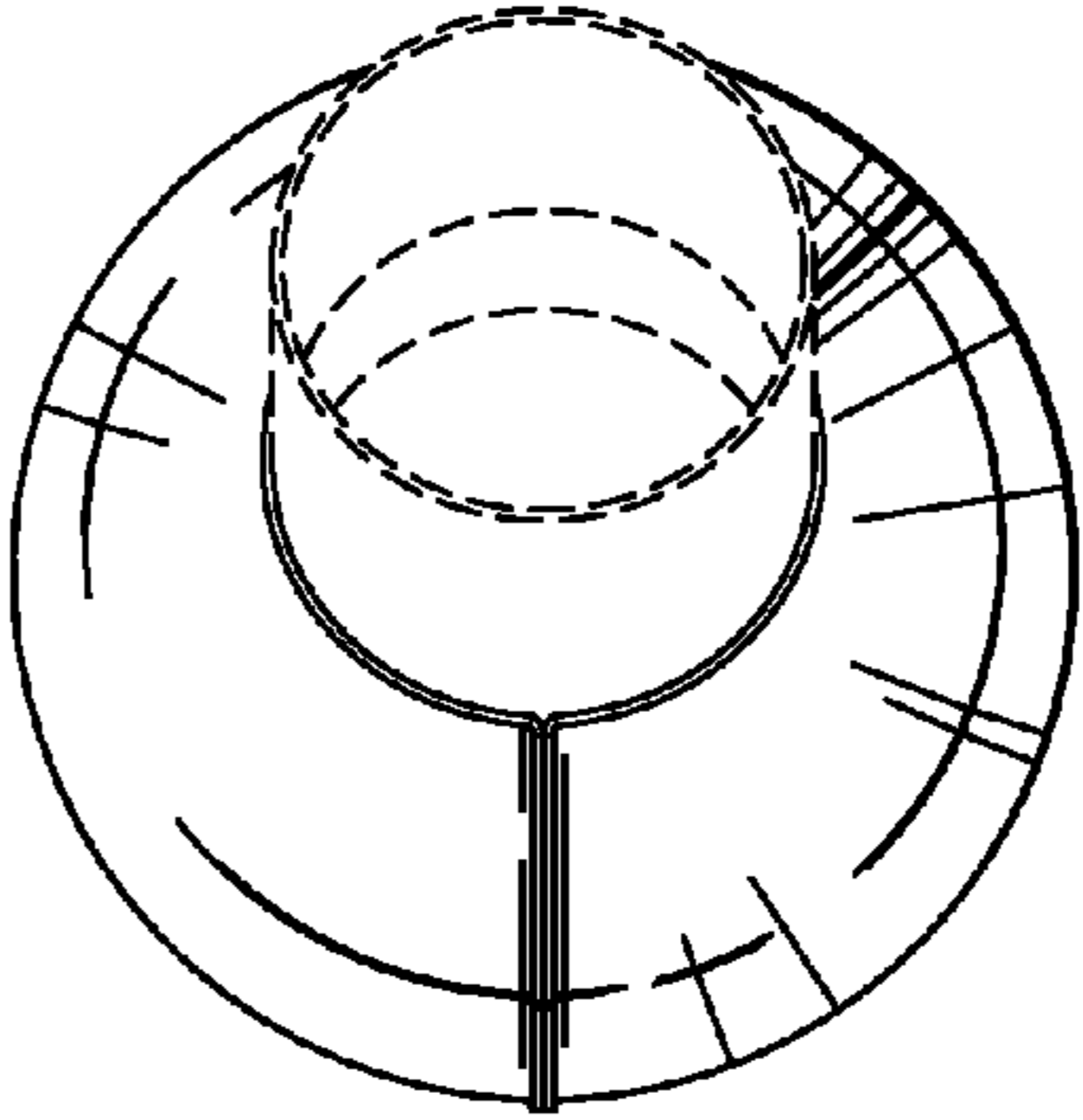

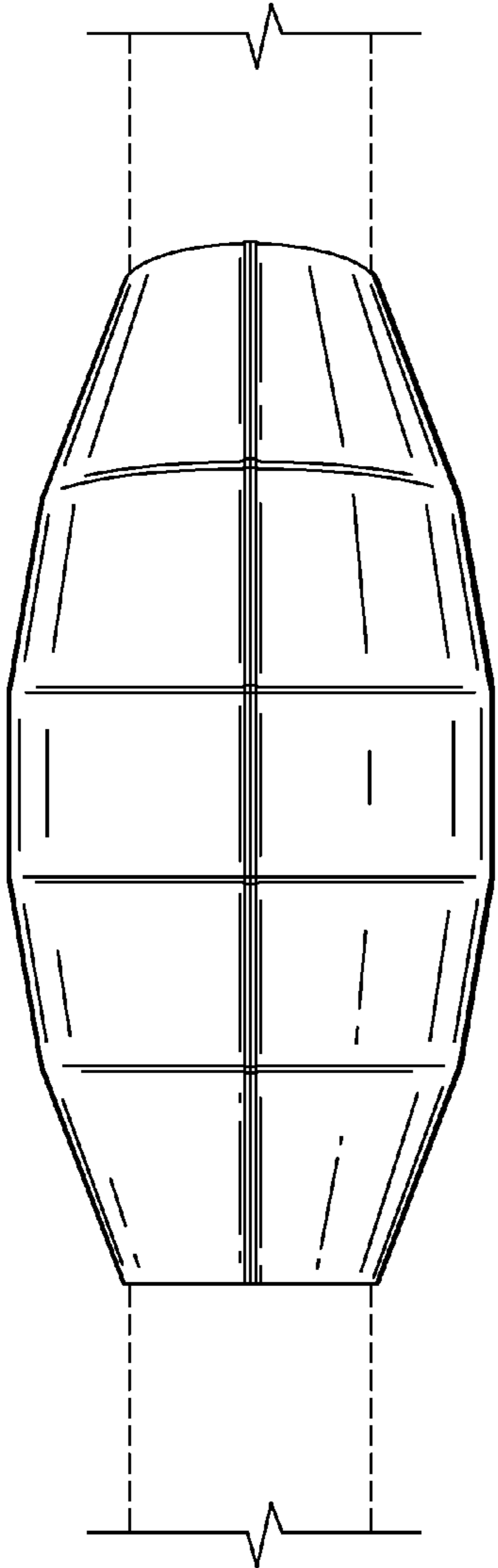

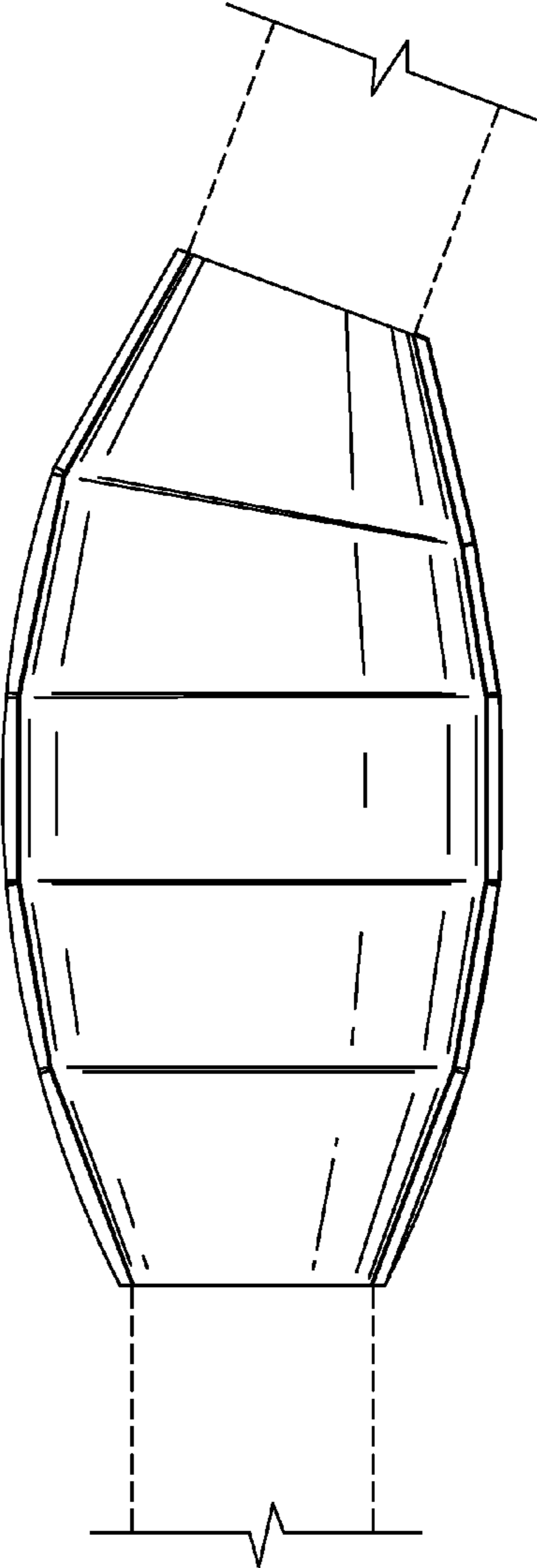
