FIG. 7 is a front elevational view of the right side thereof, the opposite side being identical thereof;

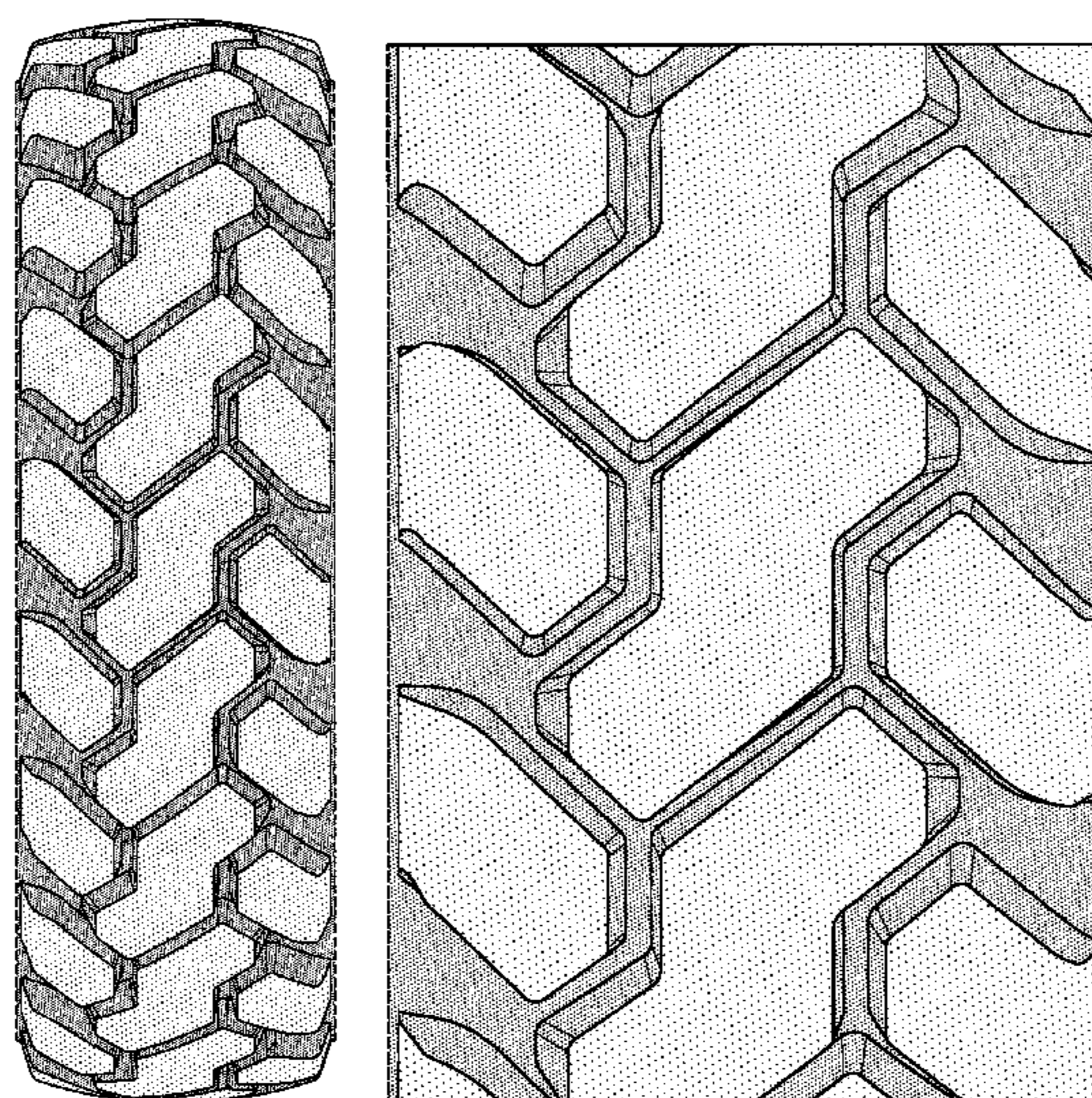
FIG. 8 is a side elevational view of the right side thereof;

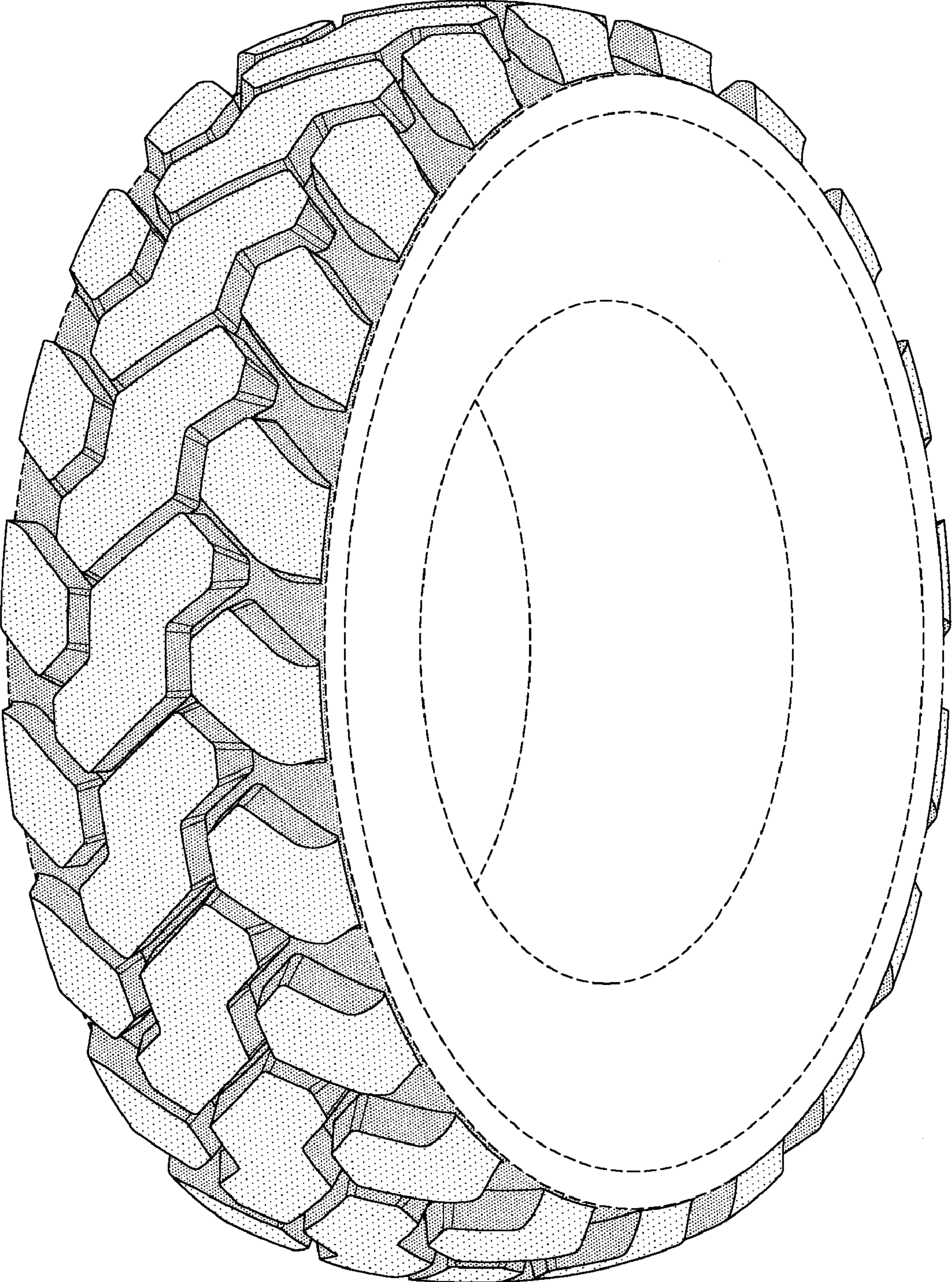

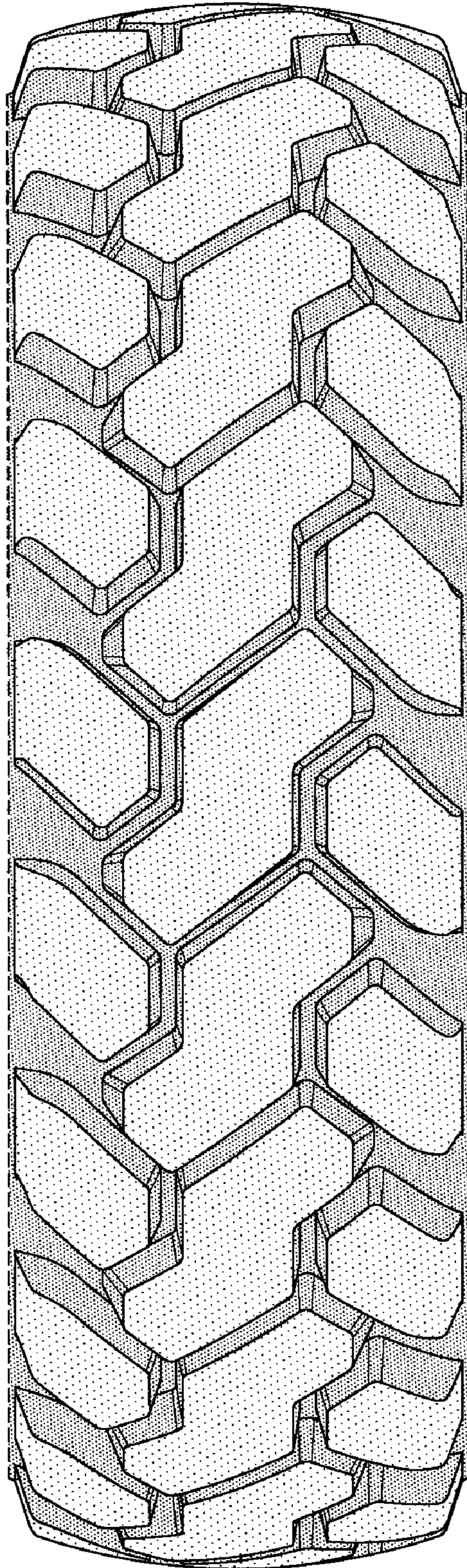

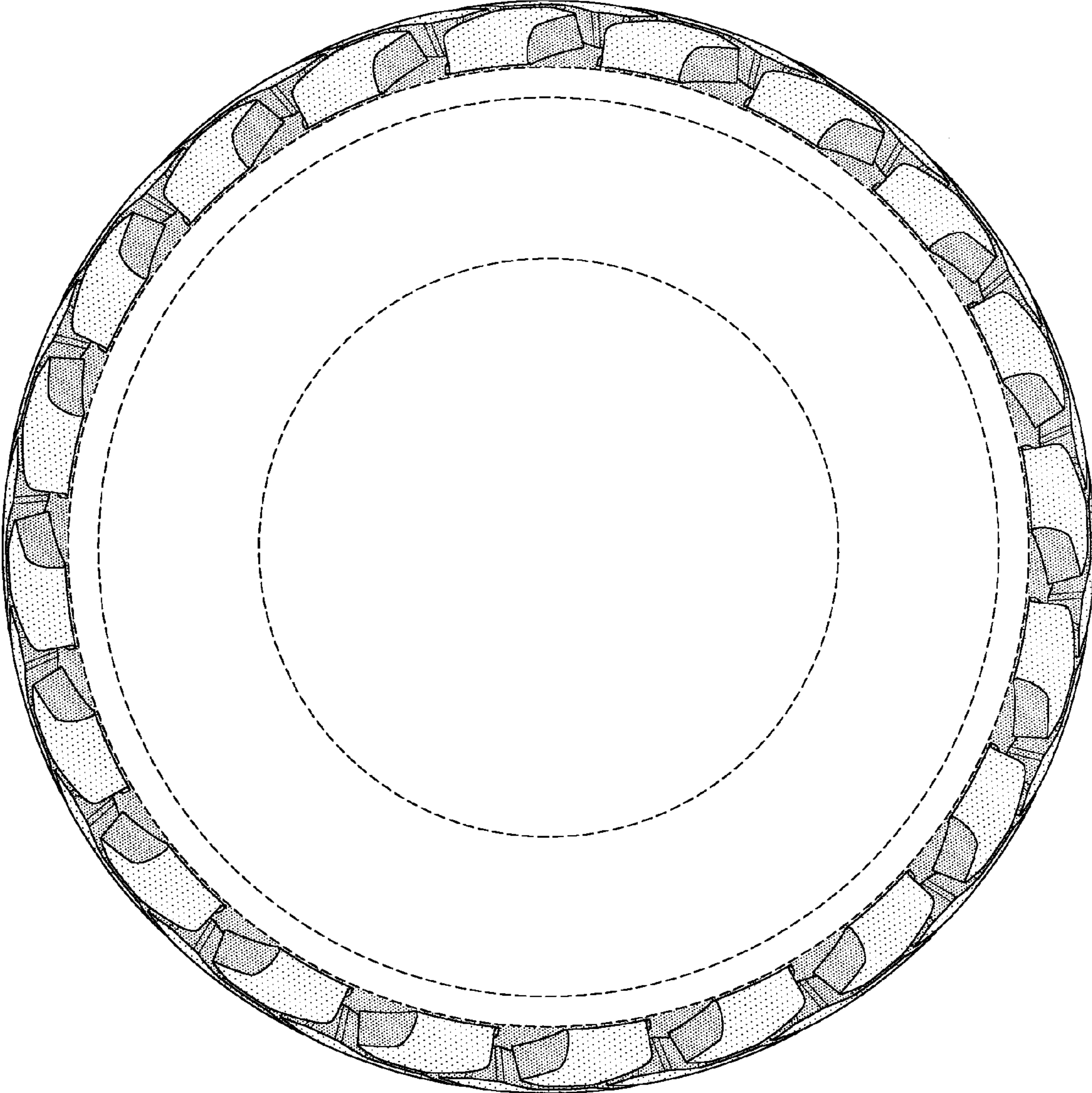

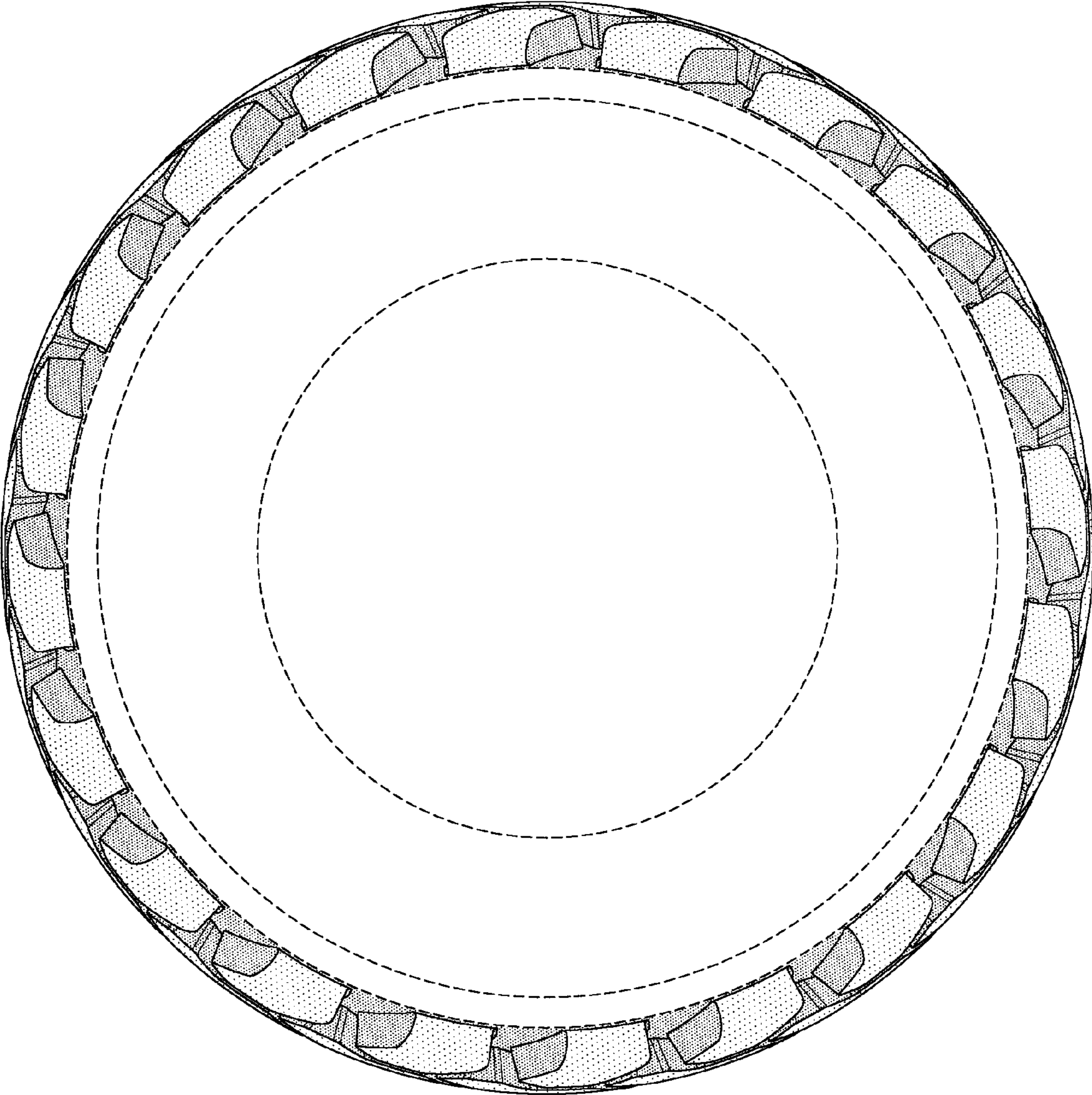

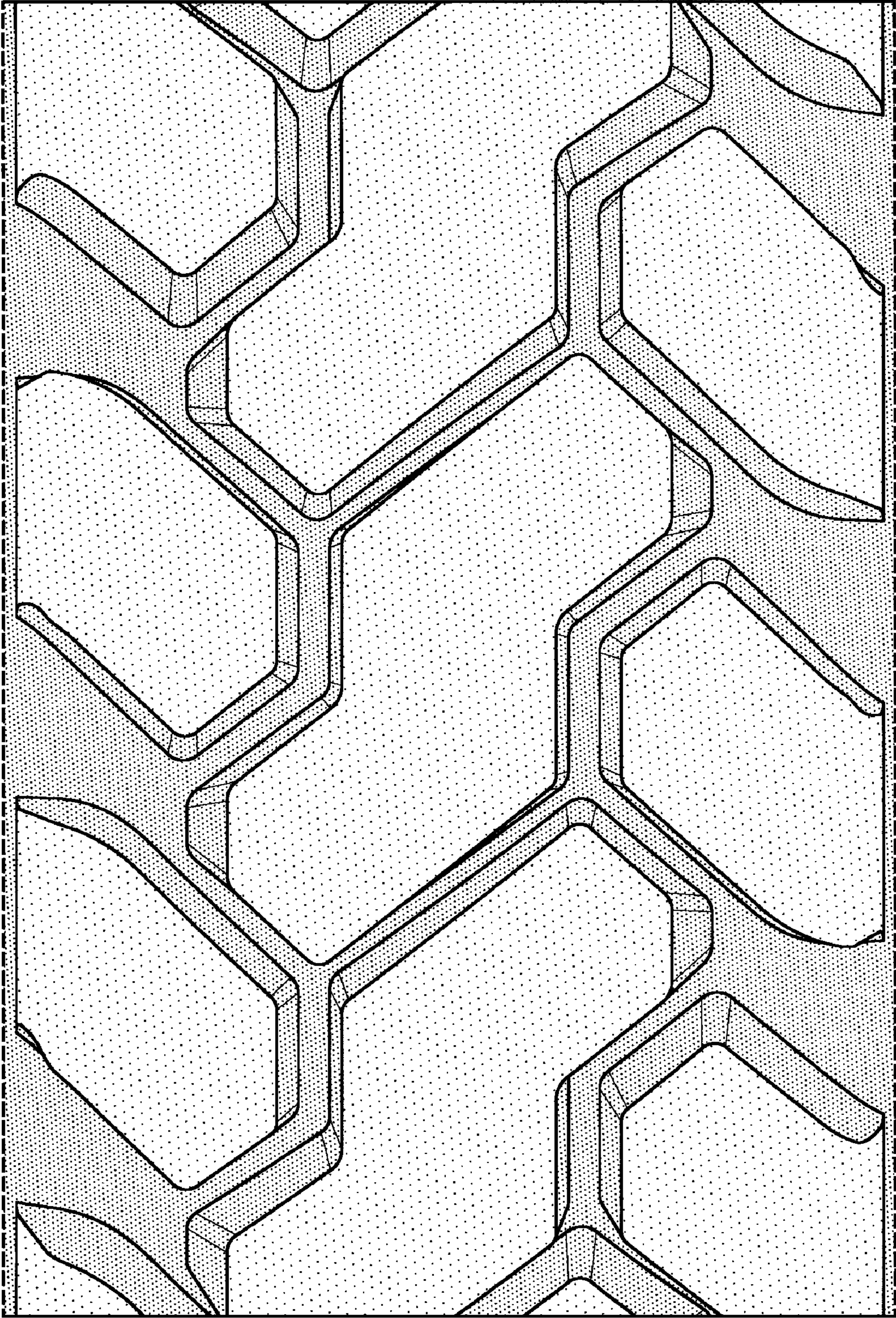

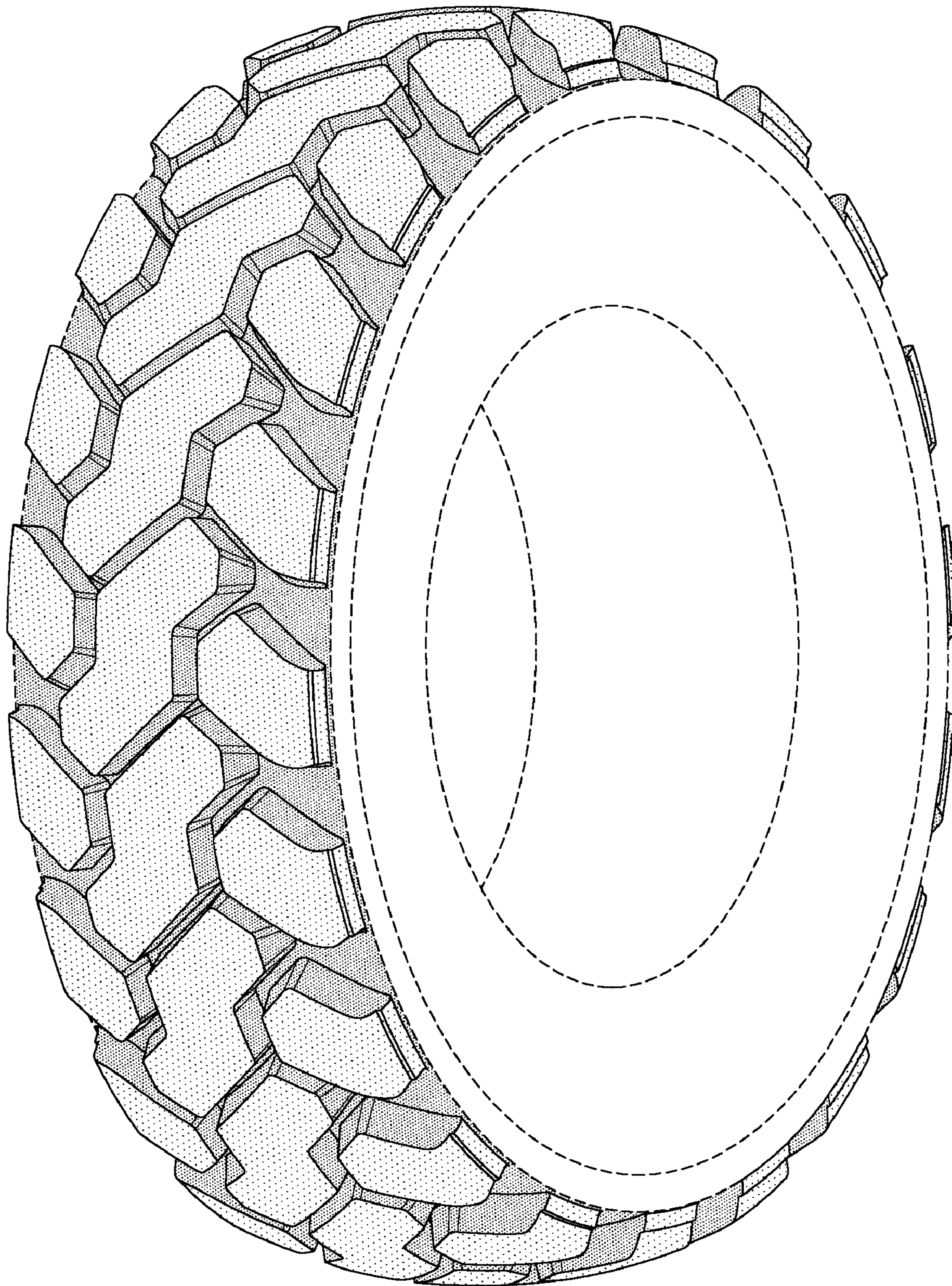

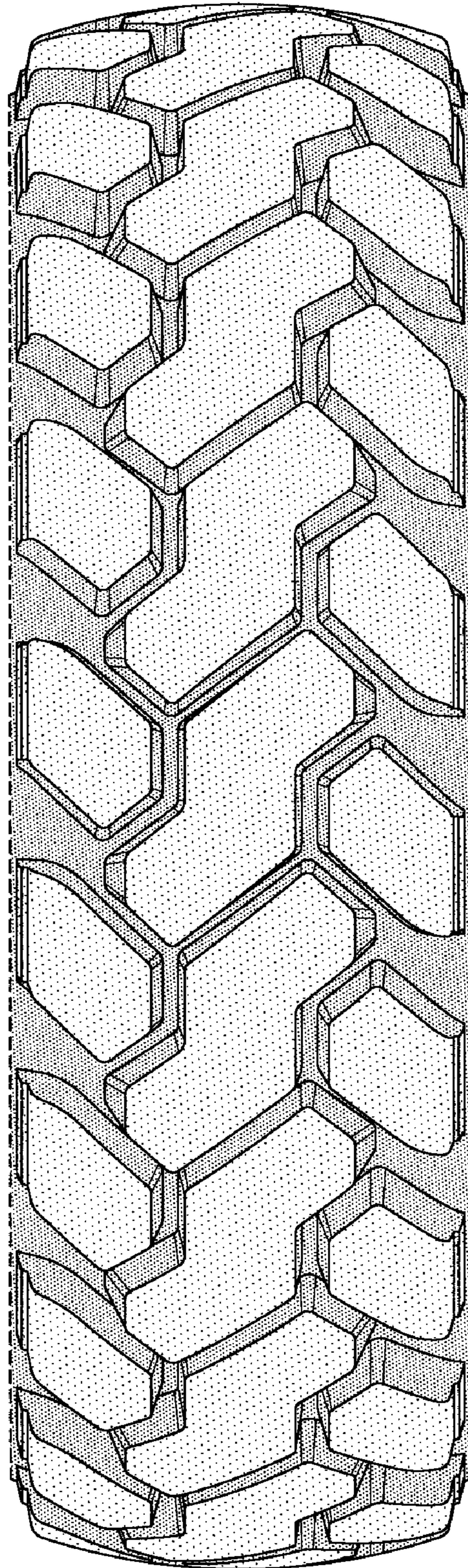

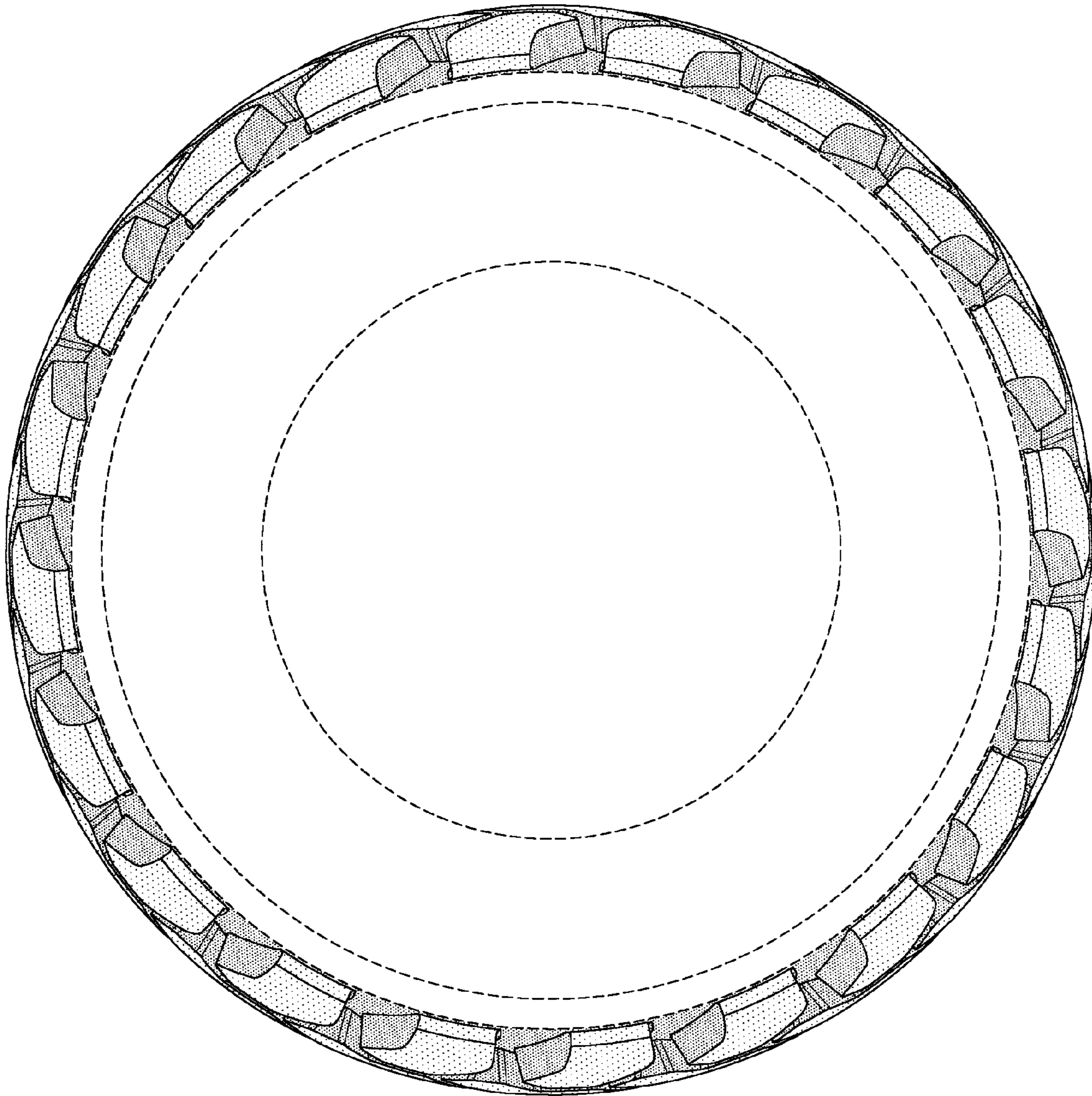

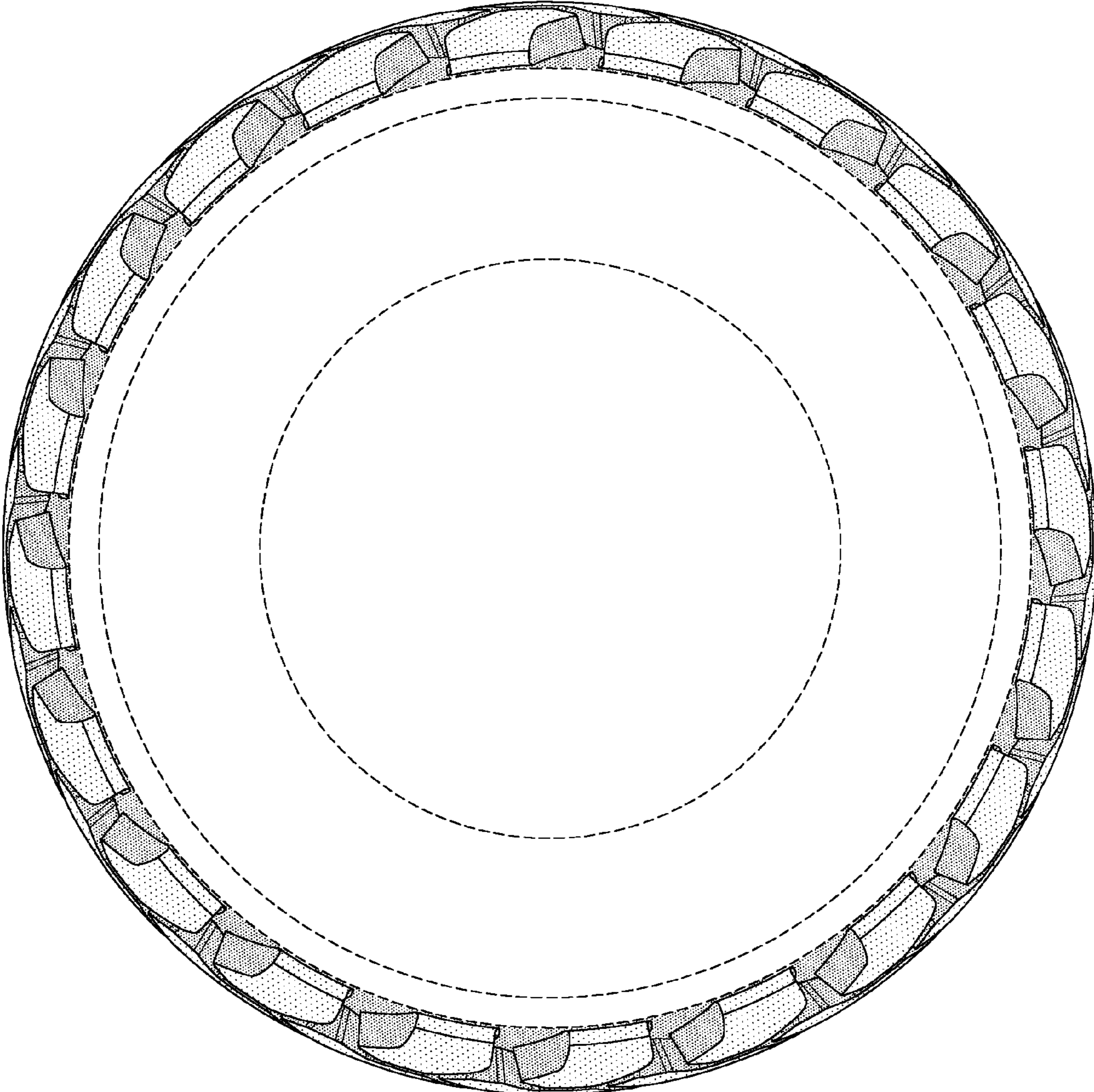

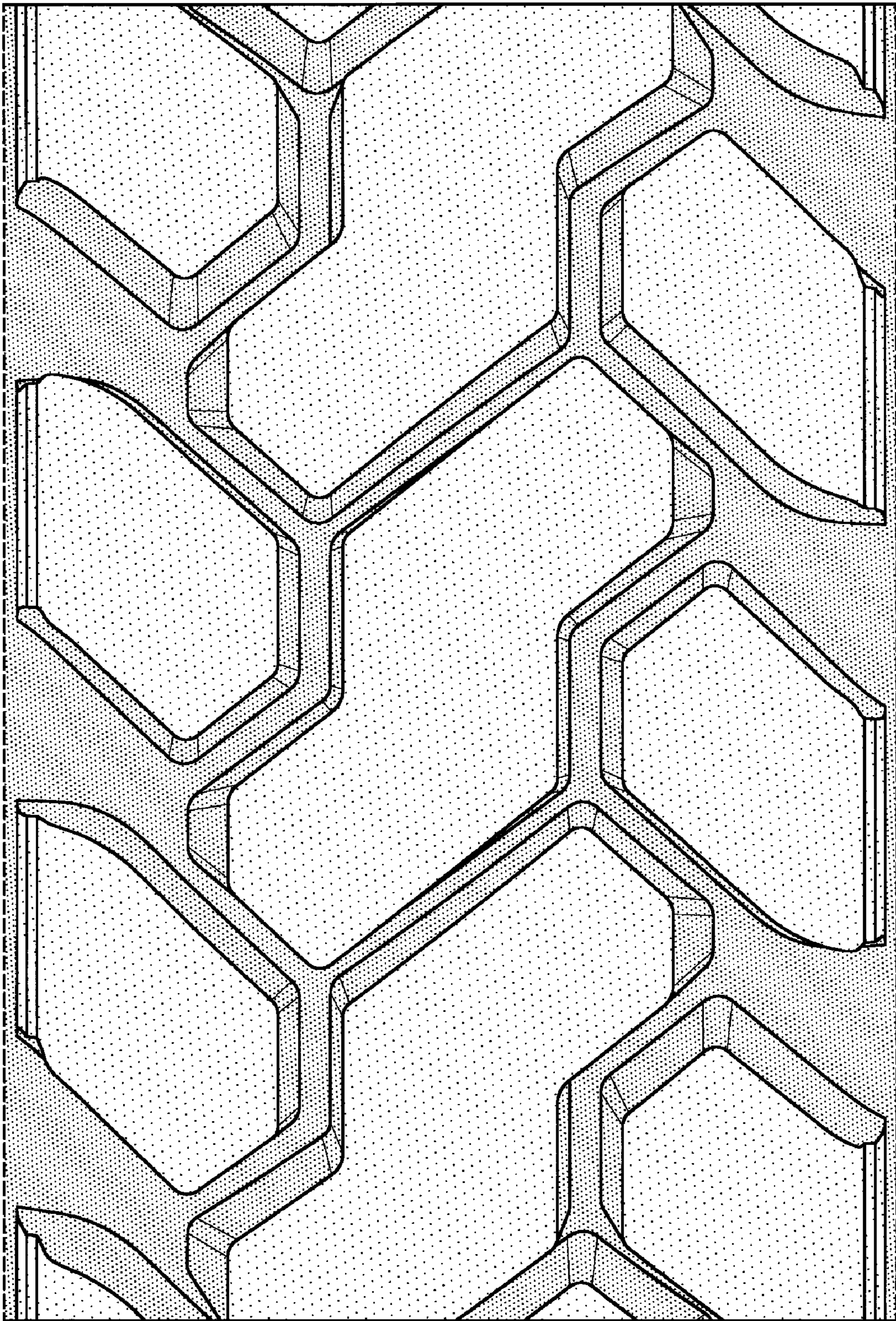
