The ornamental design for a television screen protector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a television screen protector showing our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a right side view thereof; the left side being a mirror image of the shown.

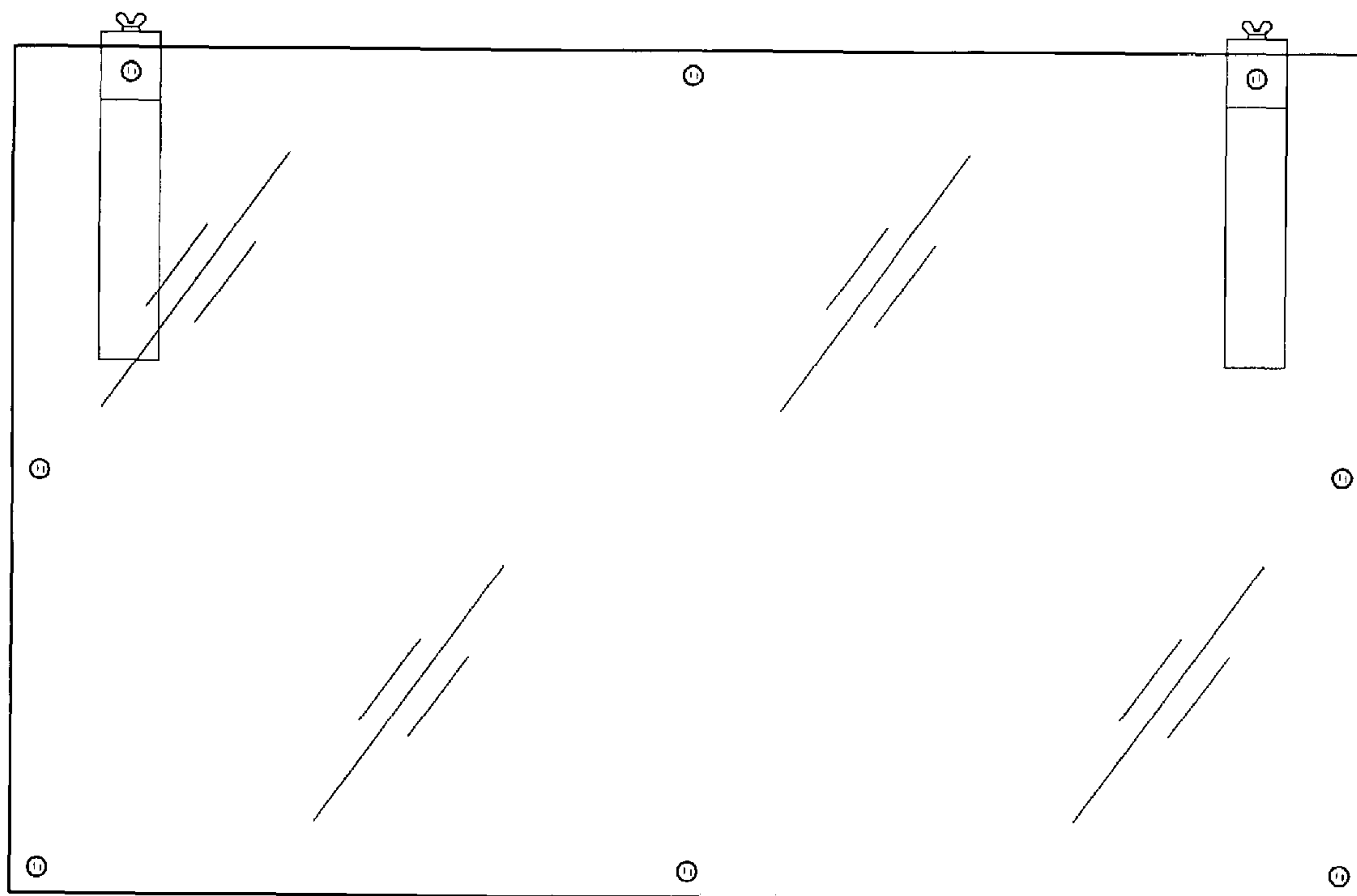
FIG. 4 is a top plan view thereof;

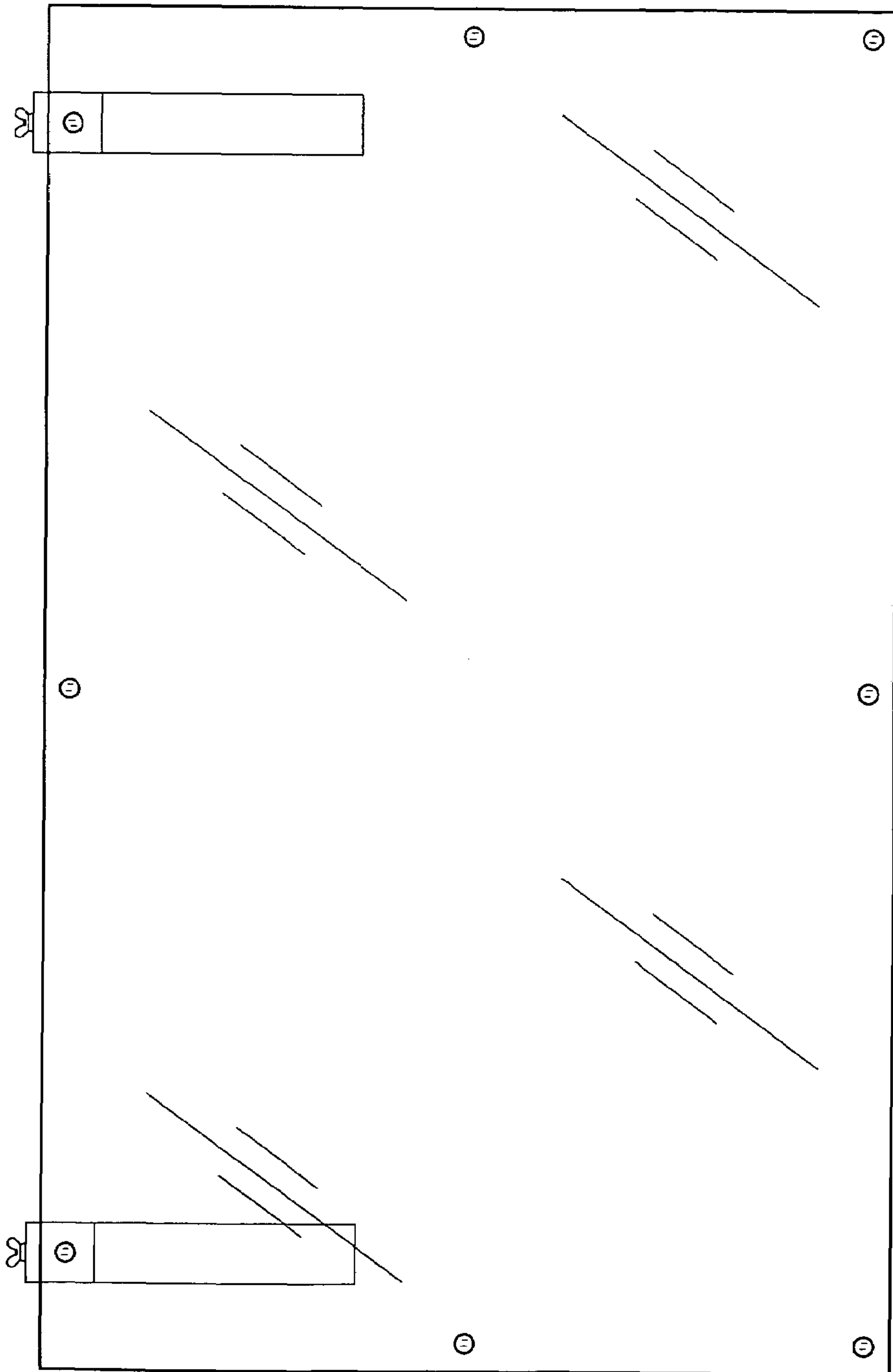

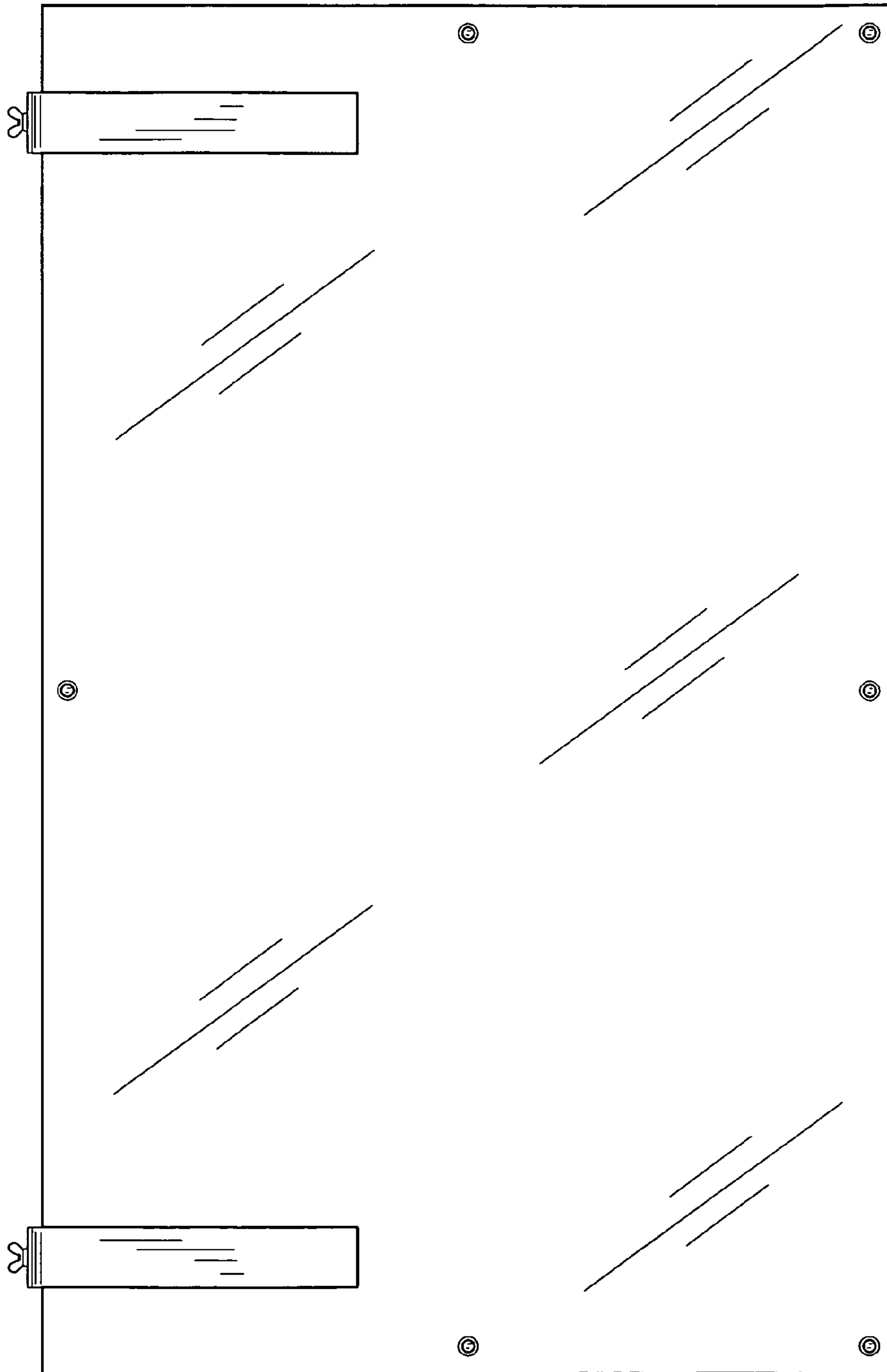

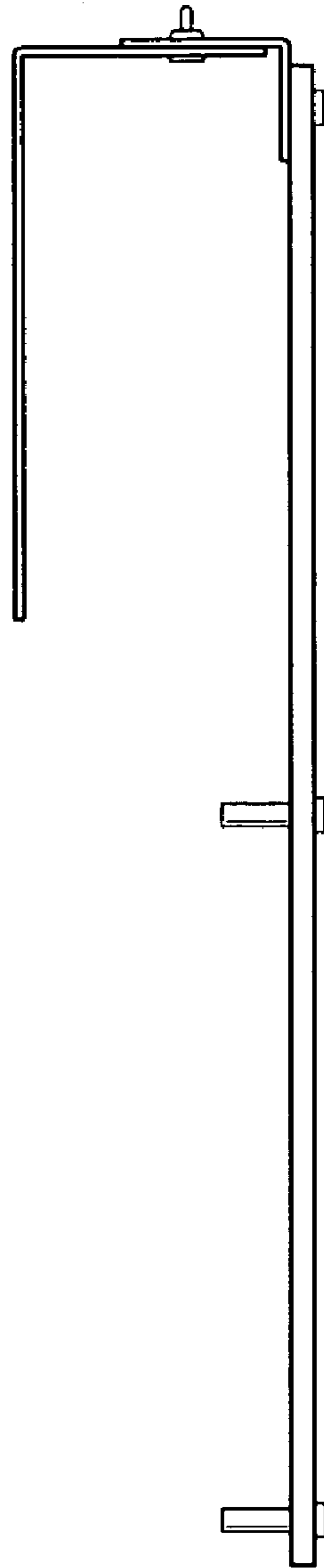

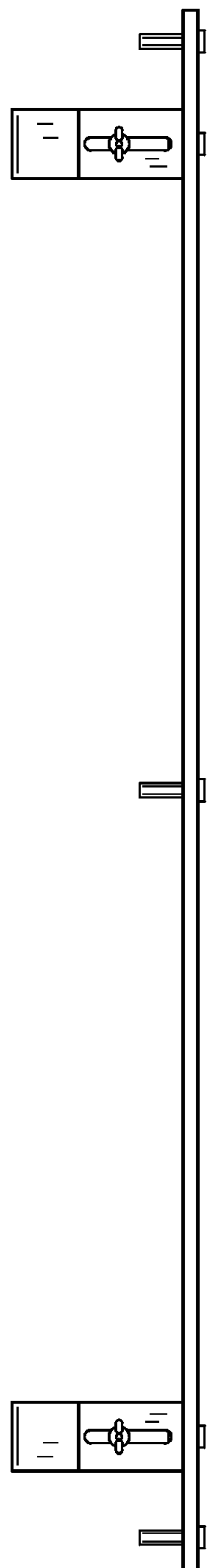

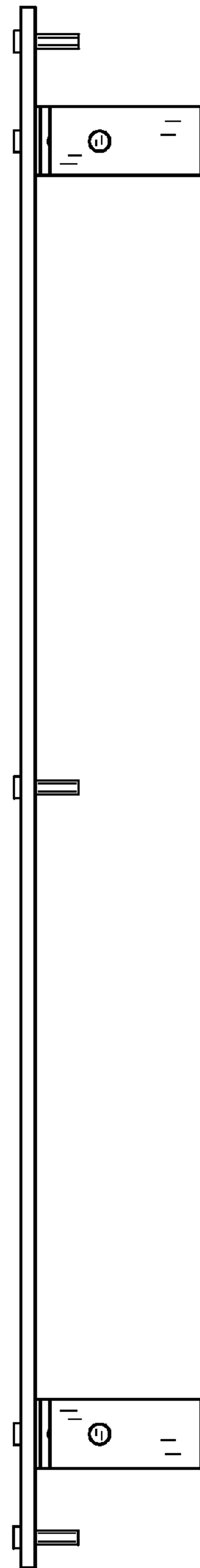

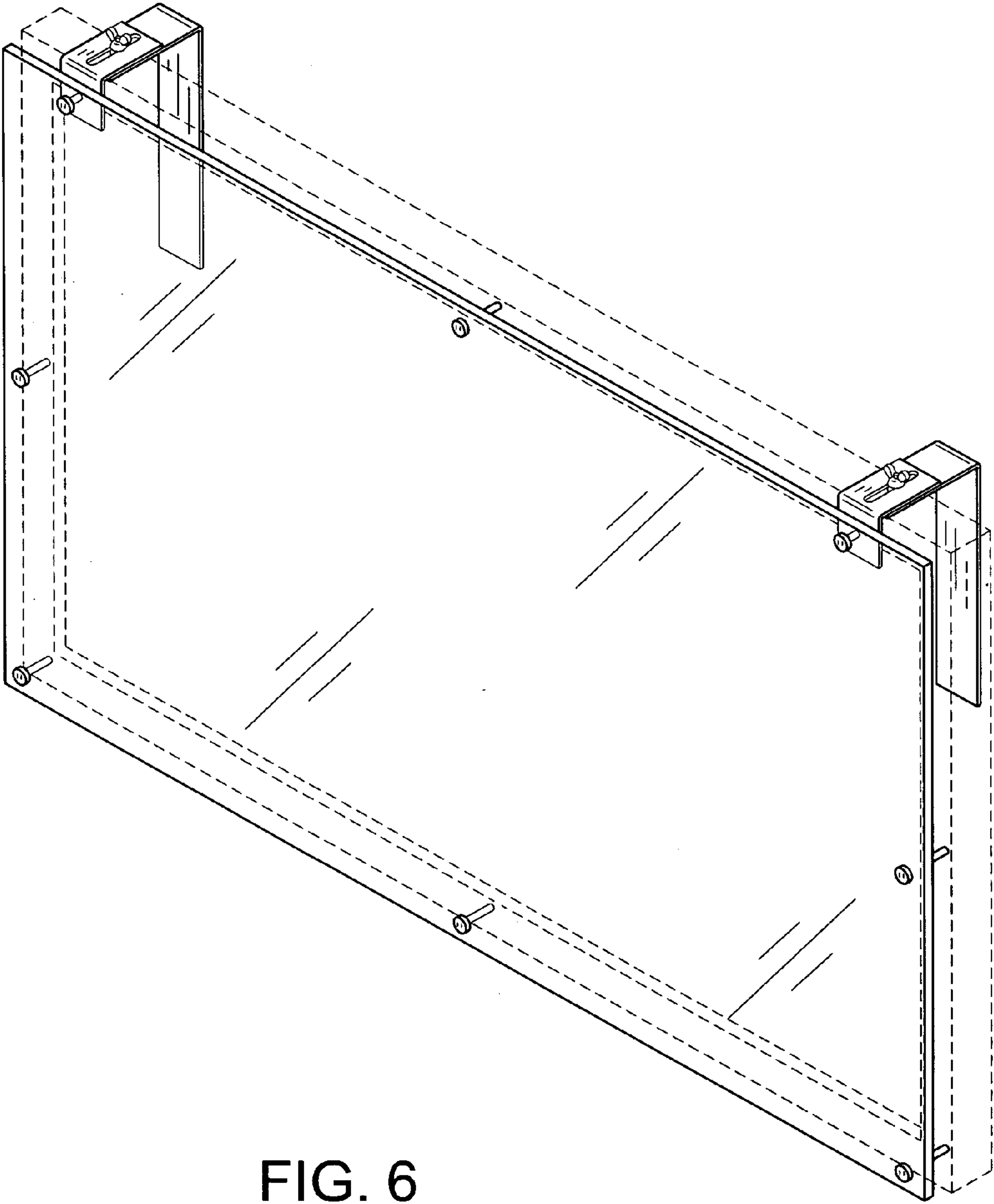
