(57) **CLAIM**

The ornamental design for a portable communications device, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged front perspective view of the portable communications device showing my design;

FIG. 2 is front view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is an opposing side view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is an top view thereof;

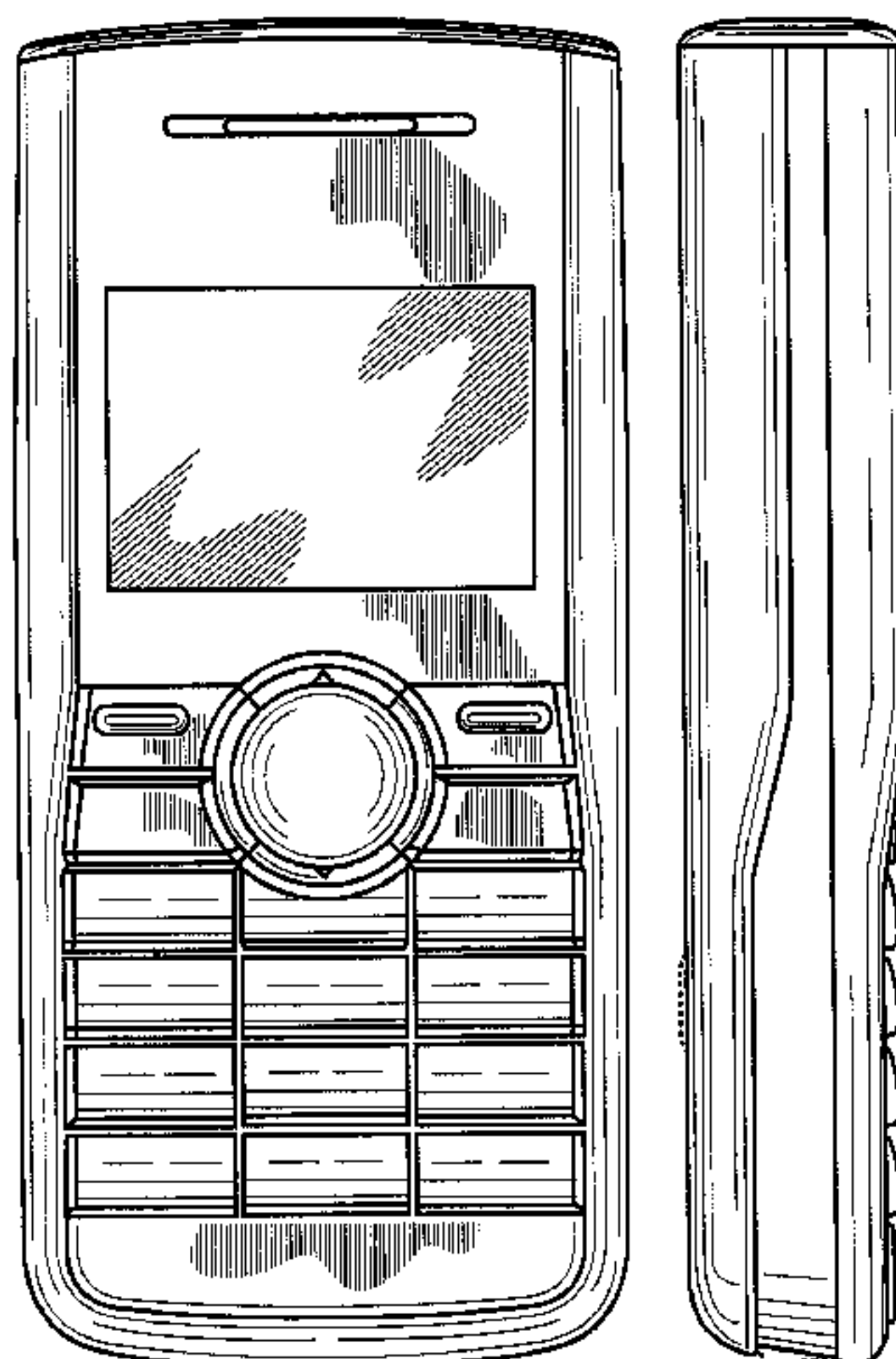
FIG. 8 is a front perspective view of a second embodiment of the portable communications device showing my design; and,

FIG. 9 is a front view thereof.

The remaining views of the embodiment shown in FIGS. 8 and 9 correspond to FIGS. 3-7 above.

The broken lines shown herein are for illustrative purposes only and form no part of the claimed design. As shown in the embodiment of FIGS. 8 and 9, selected surfaces of an outer edge portion of a navigation key on the device include a stippled shading to indicate contrast.

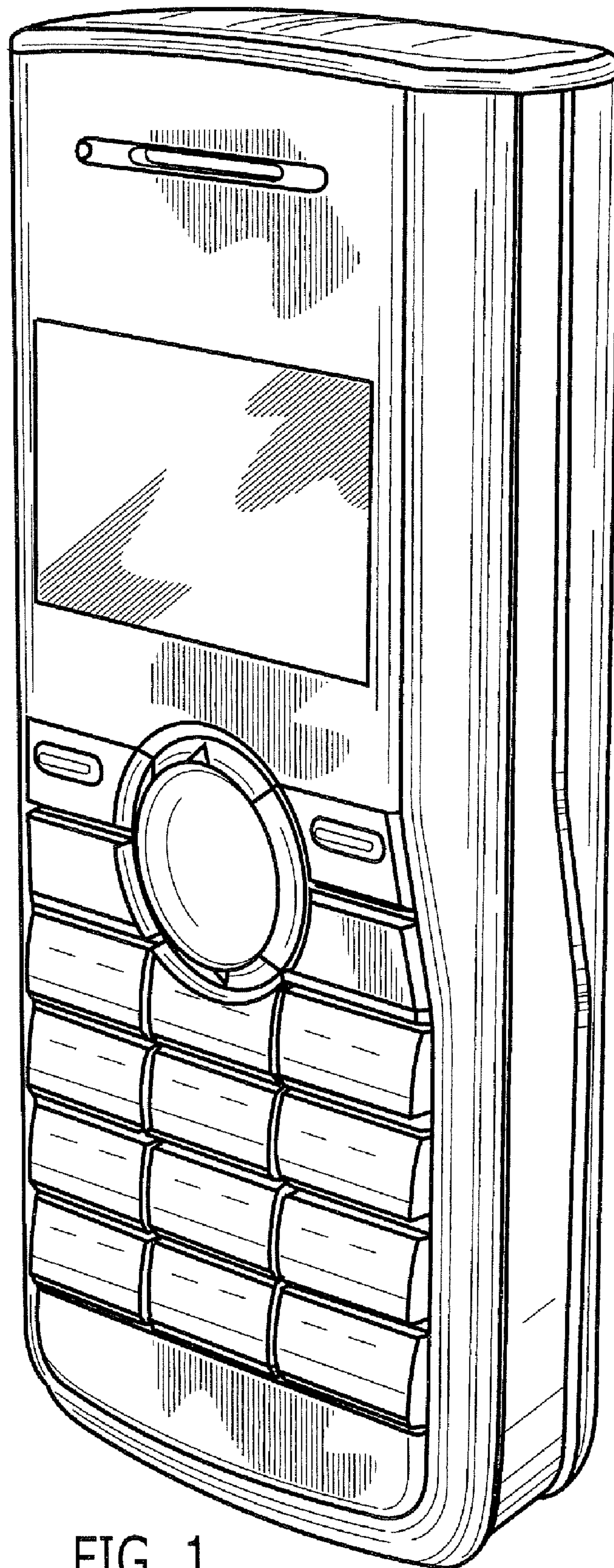

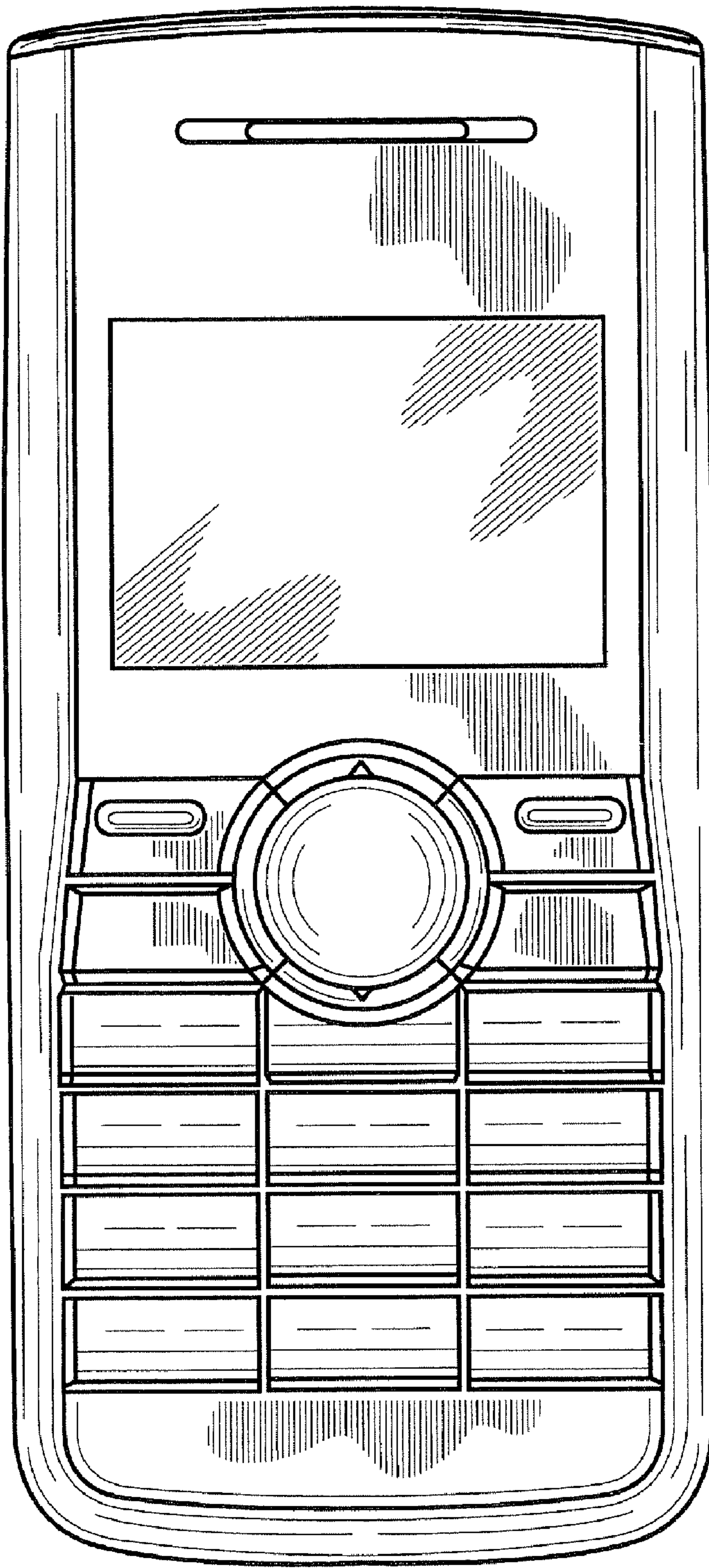

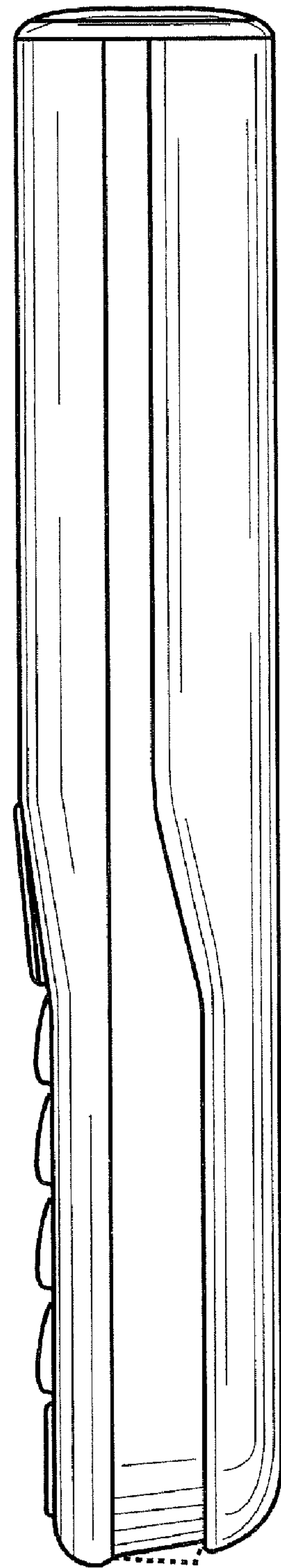

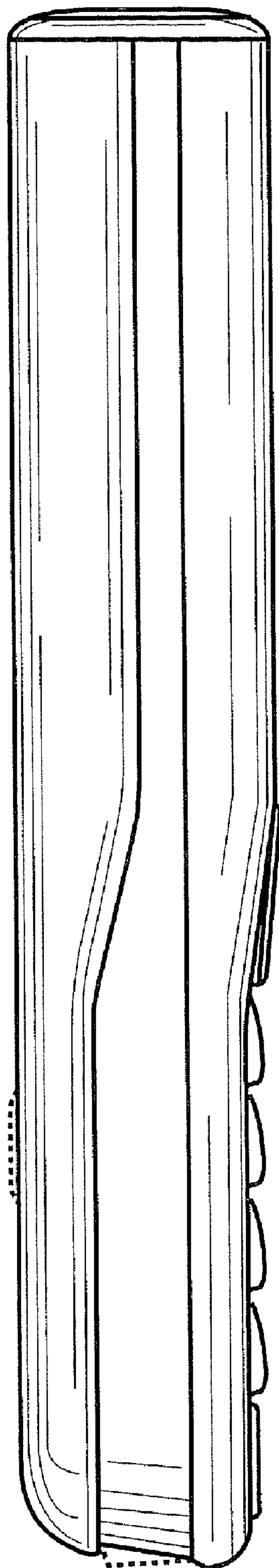

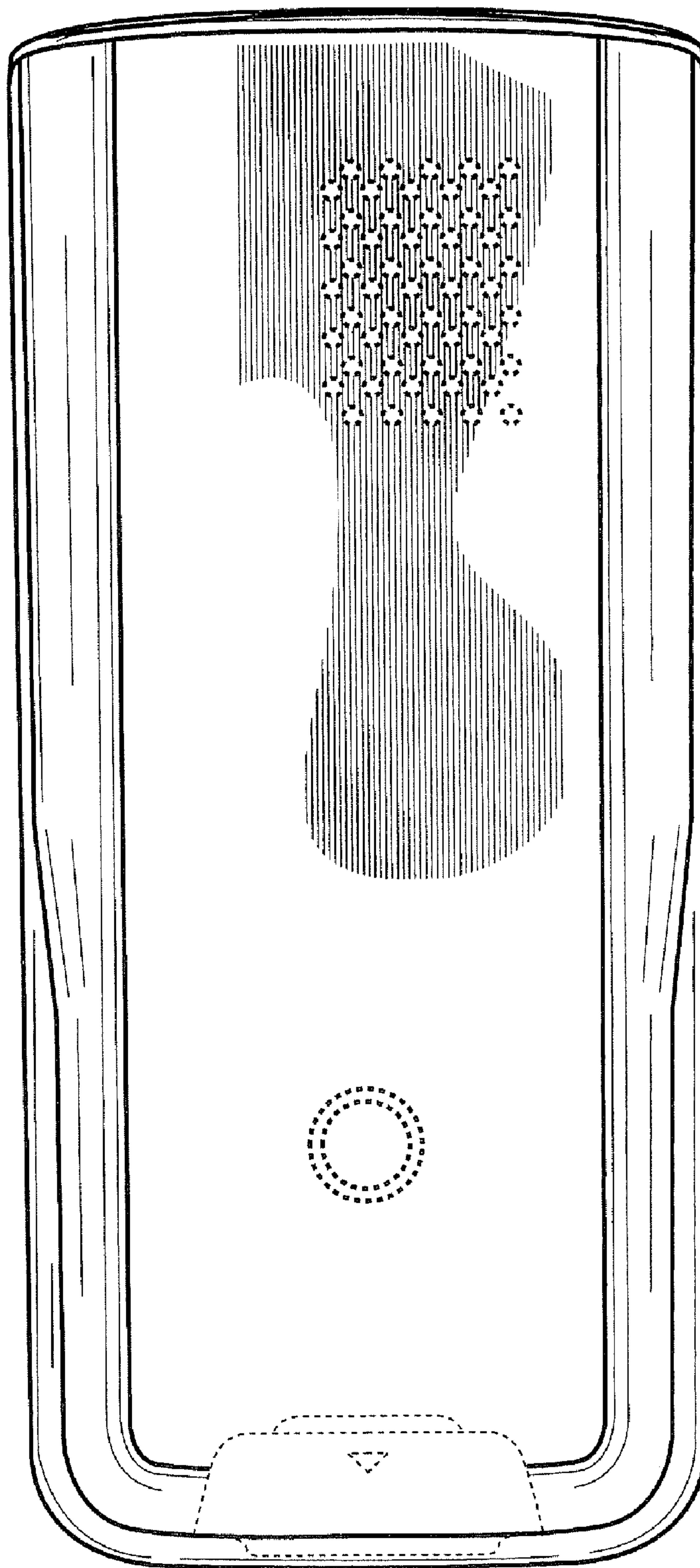

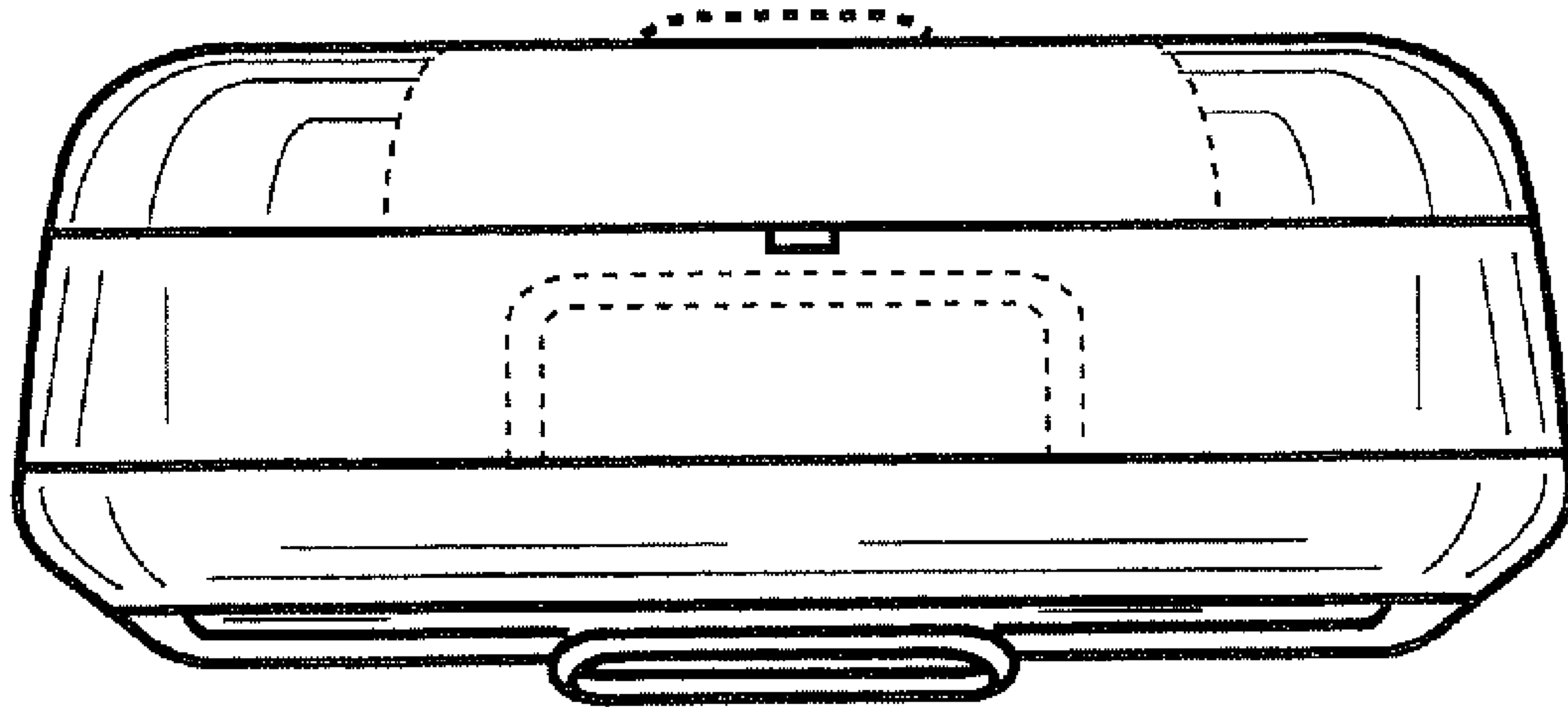

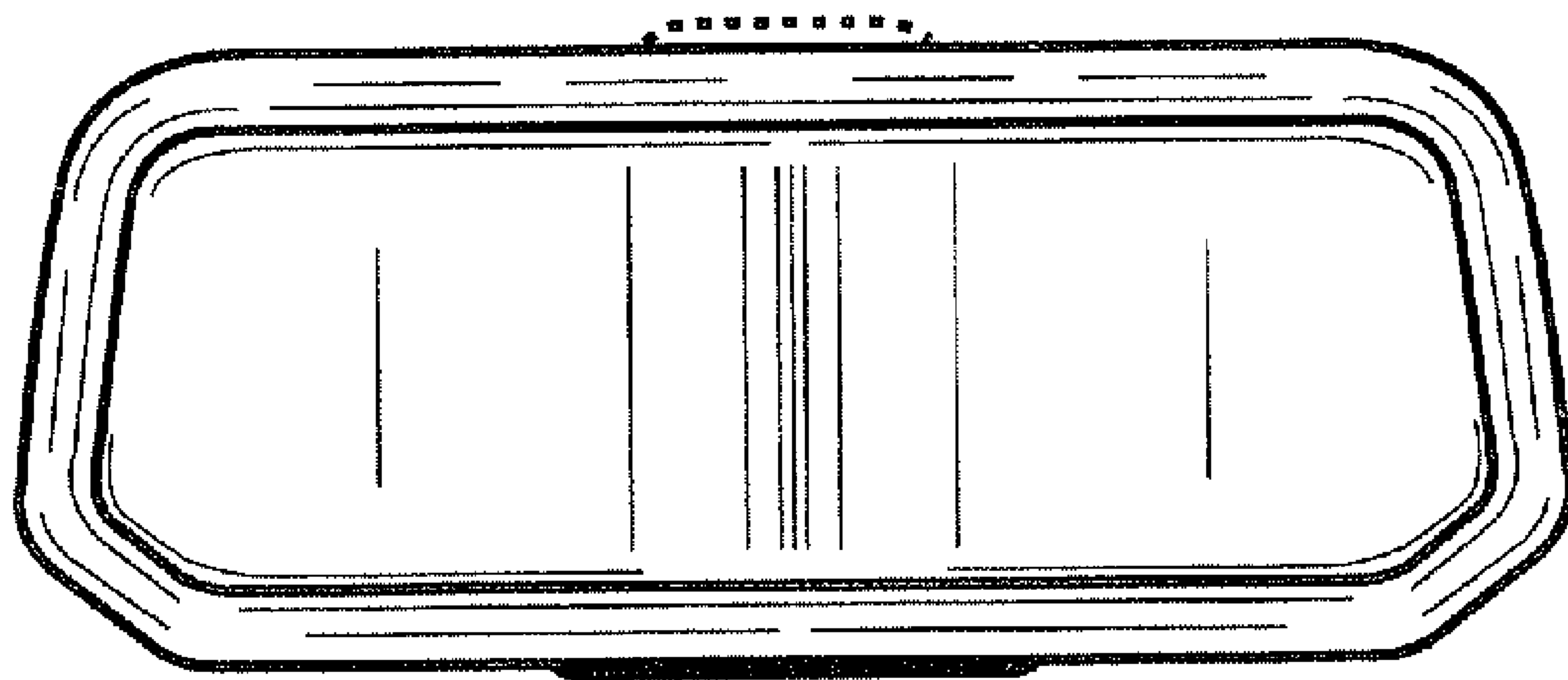

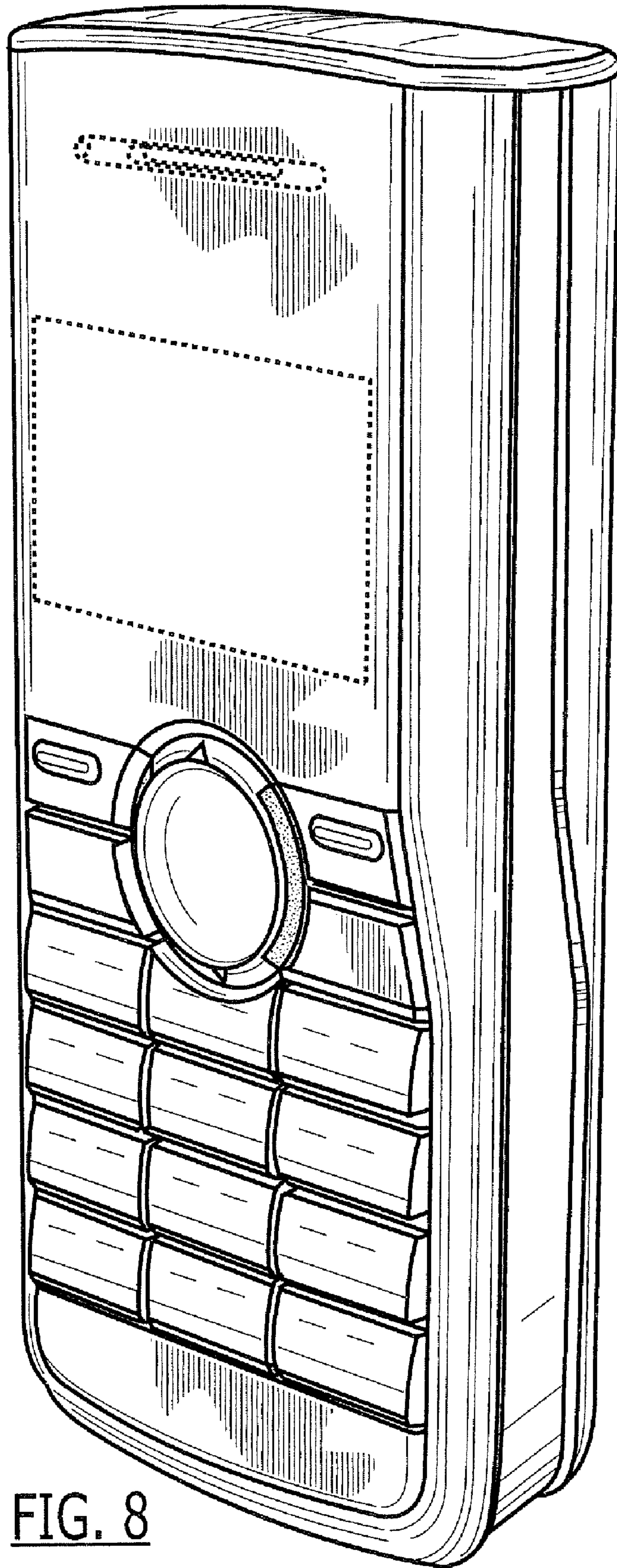

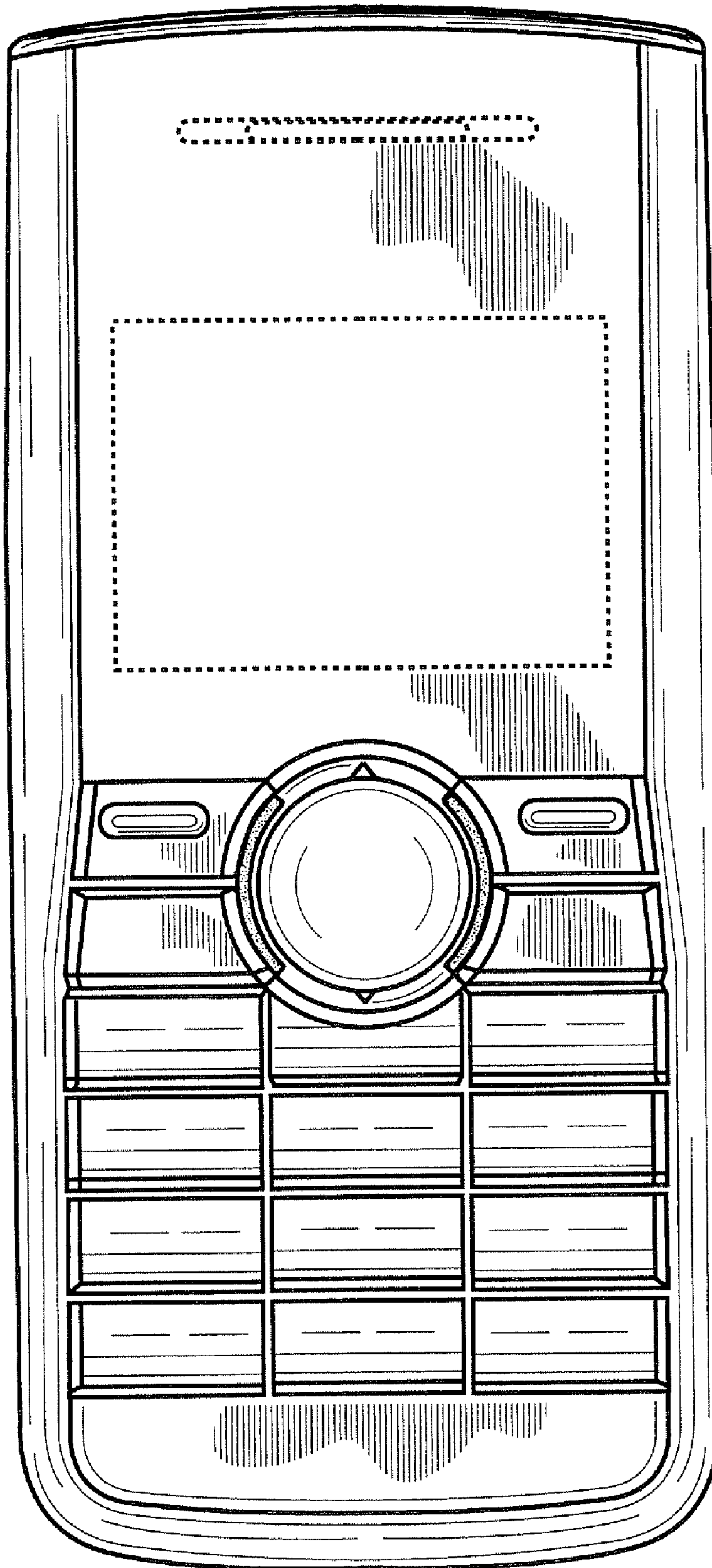
