FIG. 3 is a rear side view of the remote controller for visual presenter.

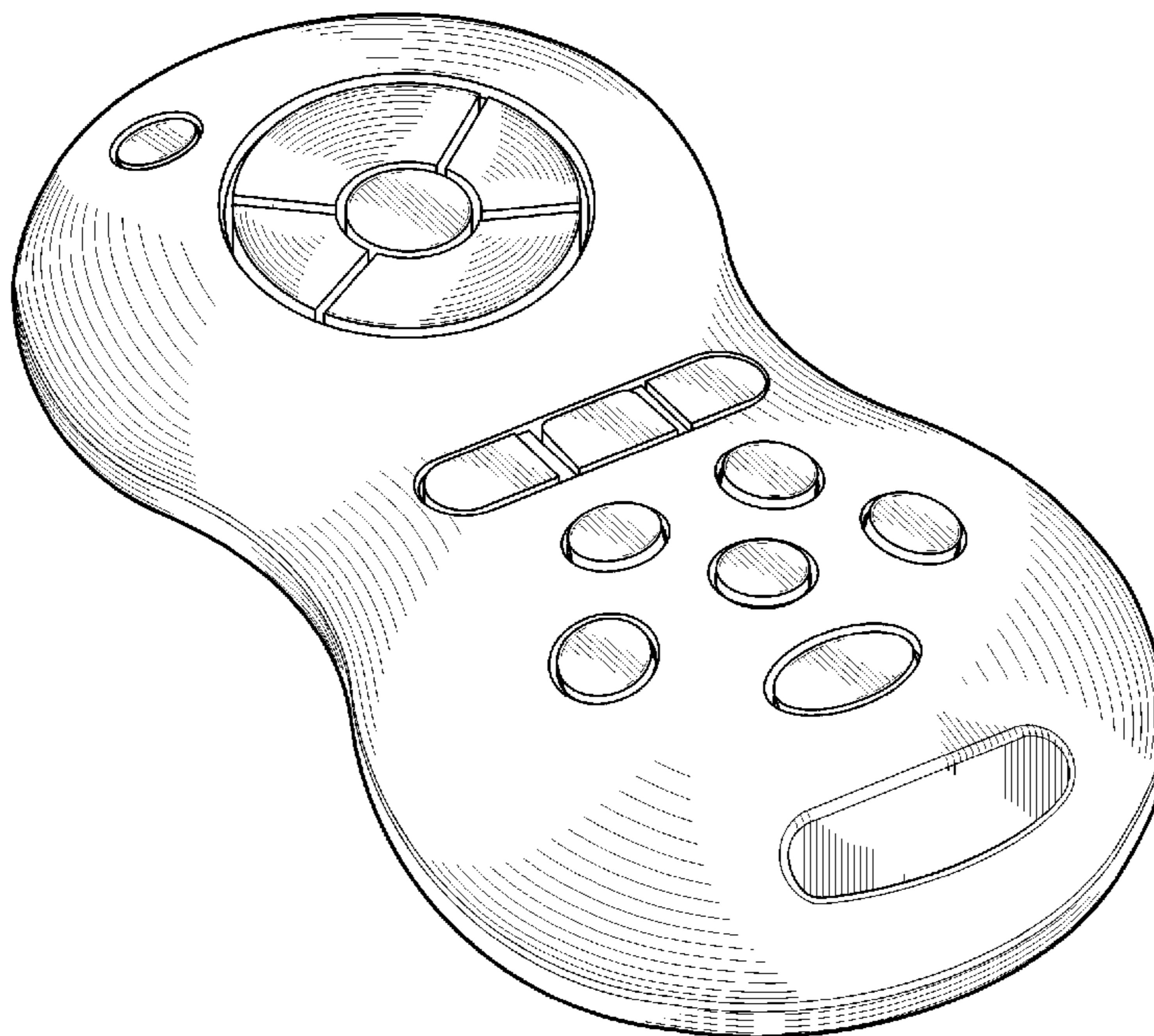
FIG. 4 is a left side view of the remote controller for visual presenter.

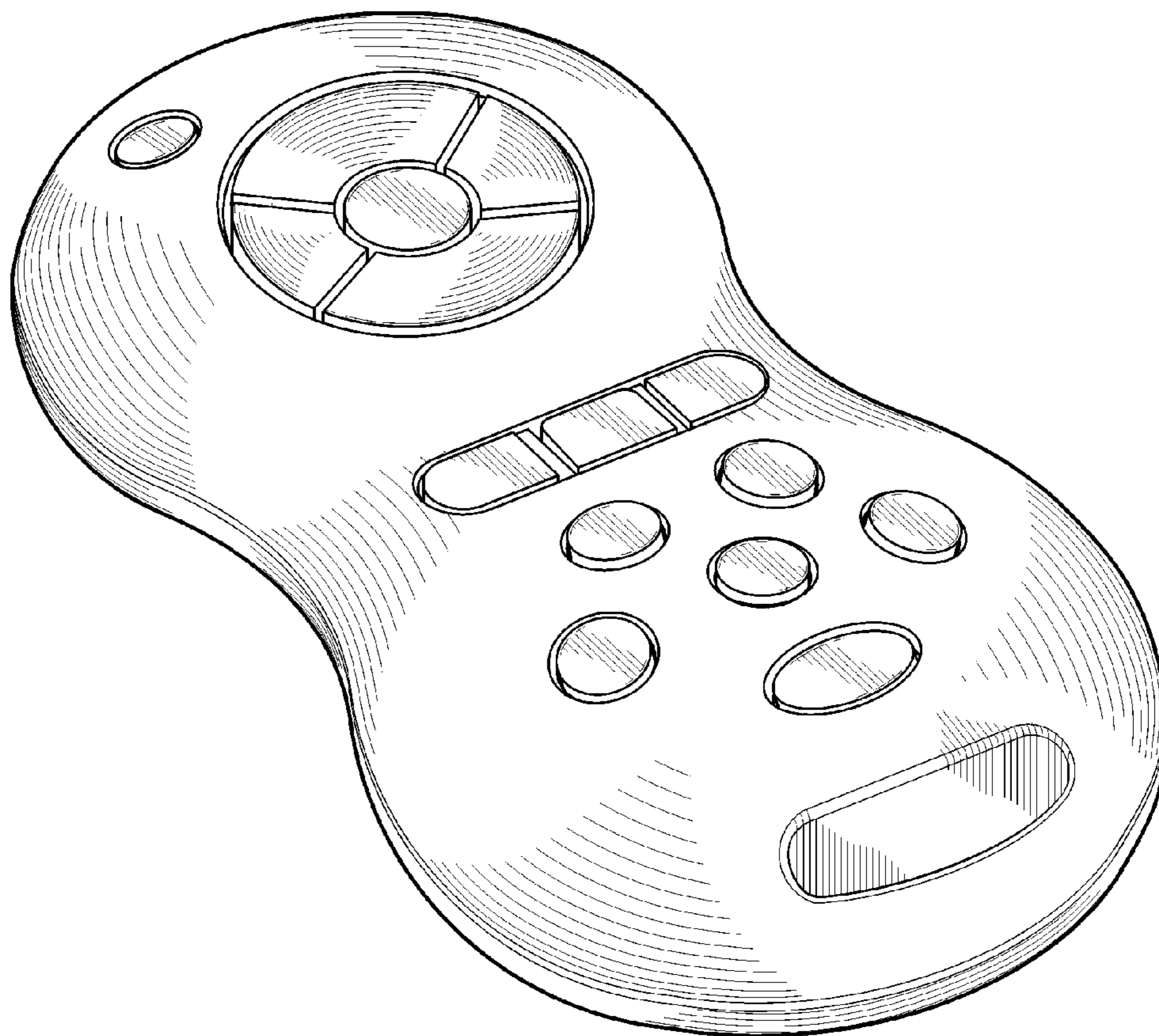
FIG. 5 is a right side view of the remote controller for visual presenter.

FIG. 6 is a top view of the remote controller for visual presenter; and,

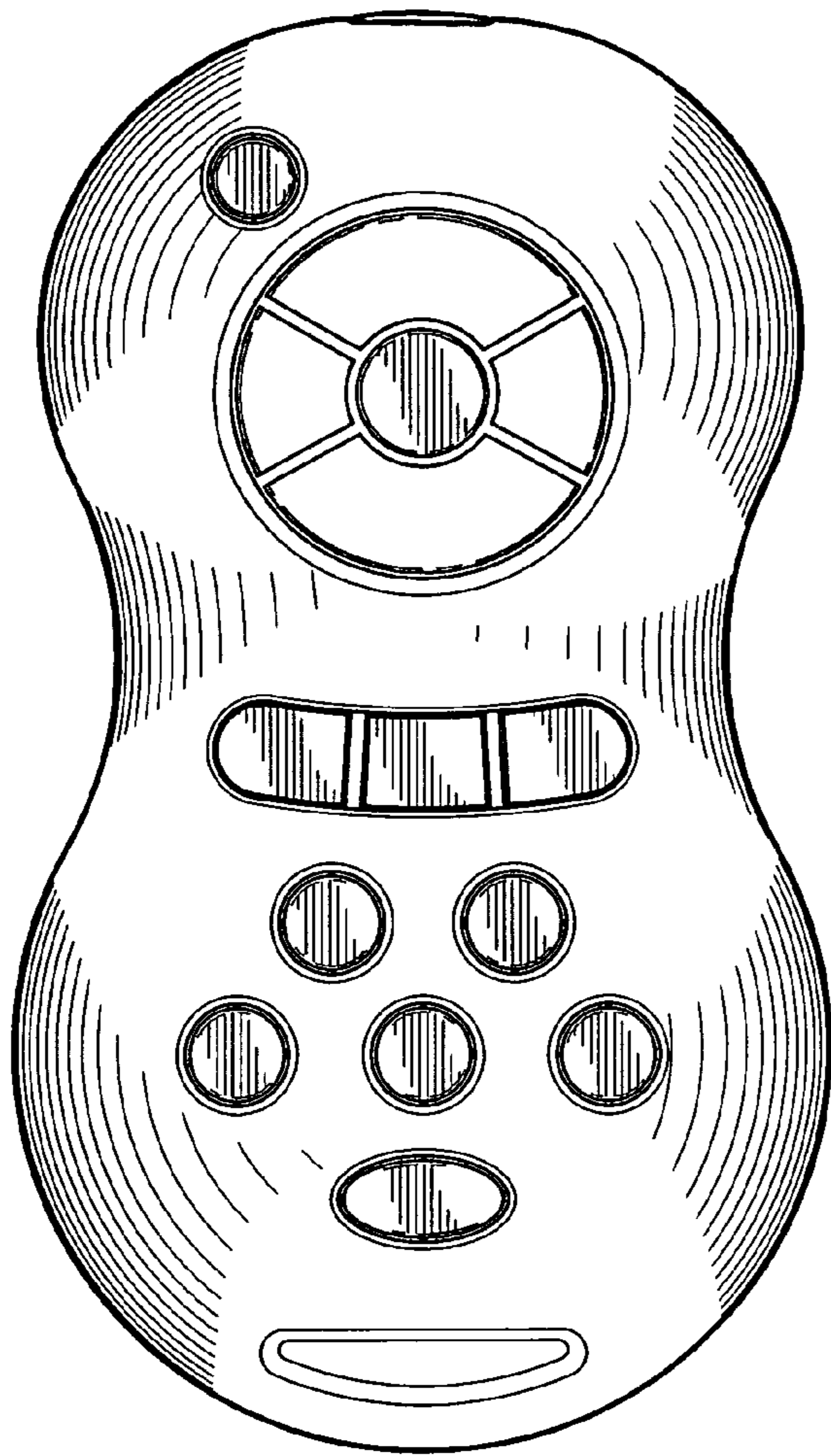
FIG. 7 is a bottom view of the remote controller for visual presenter.

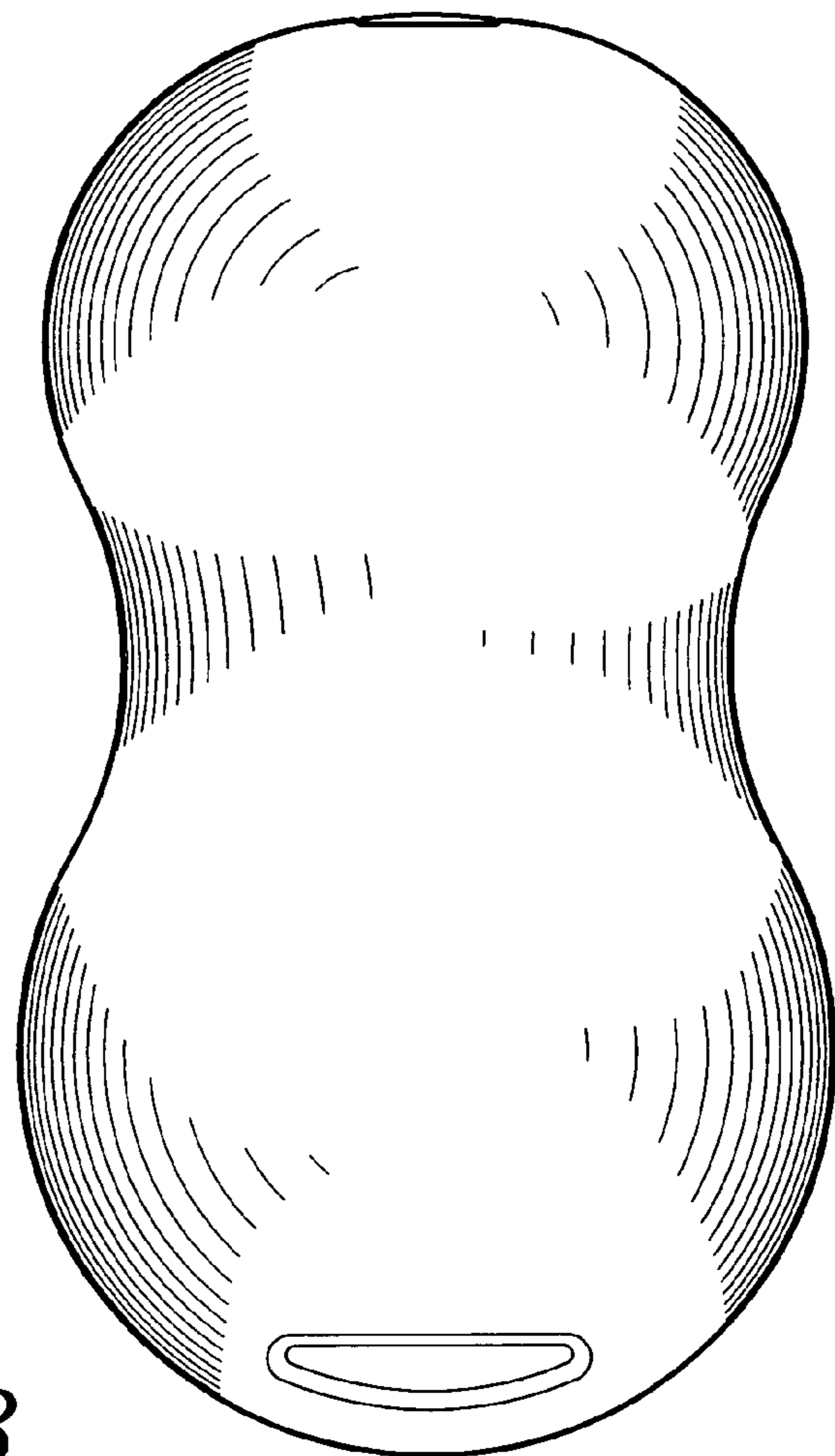




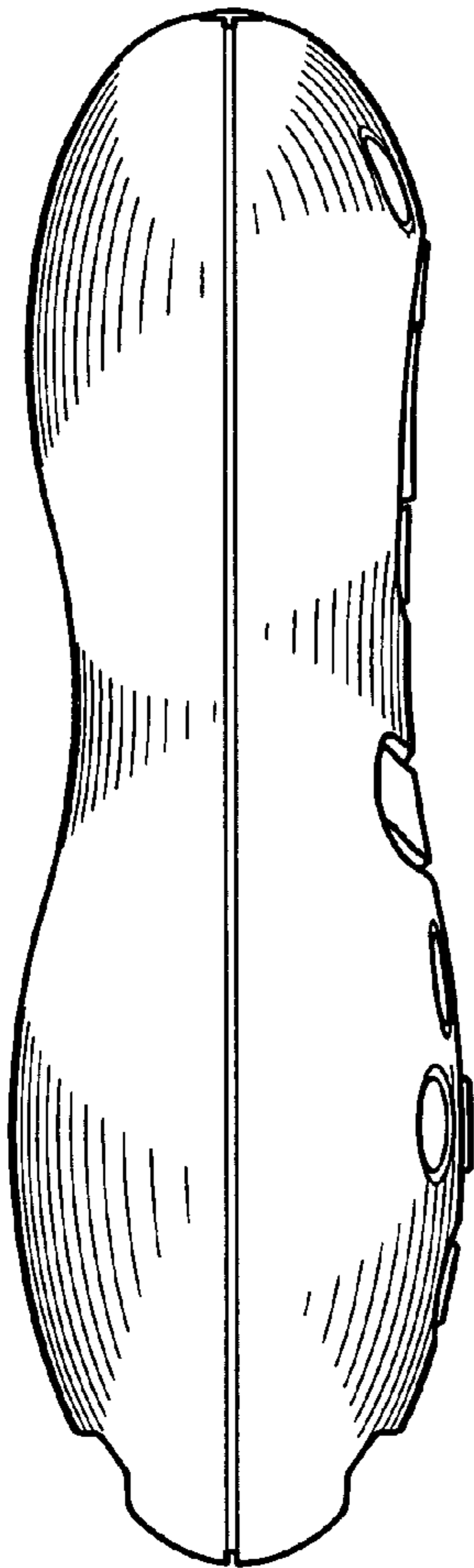

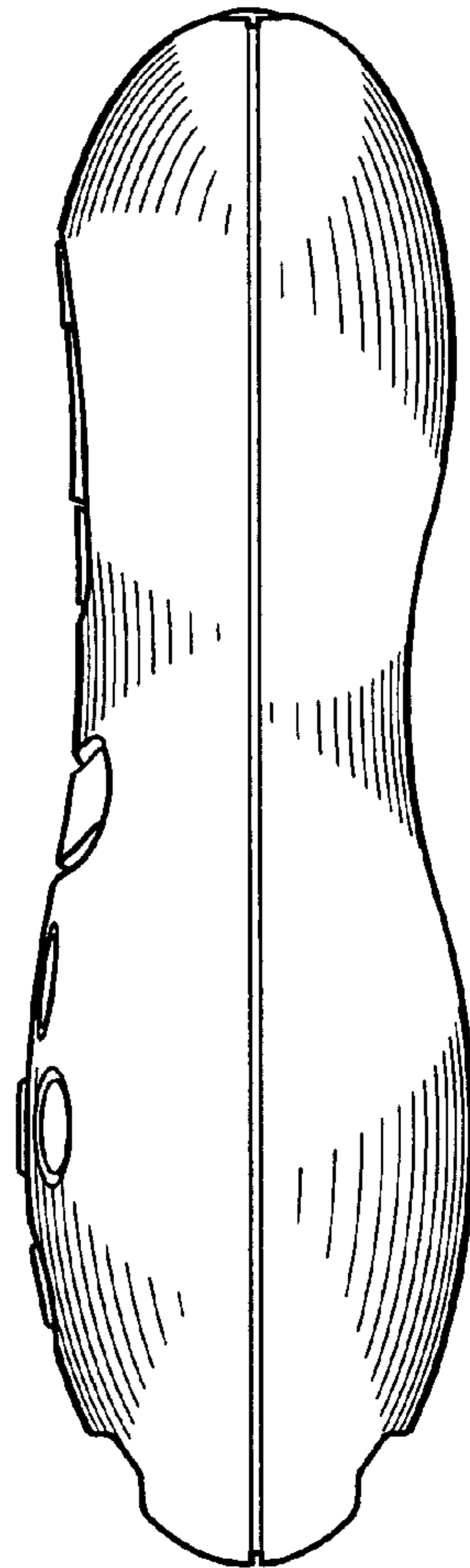

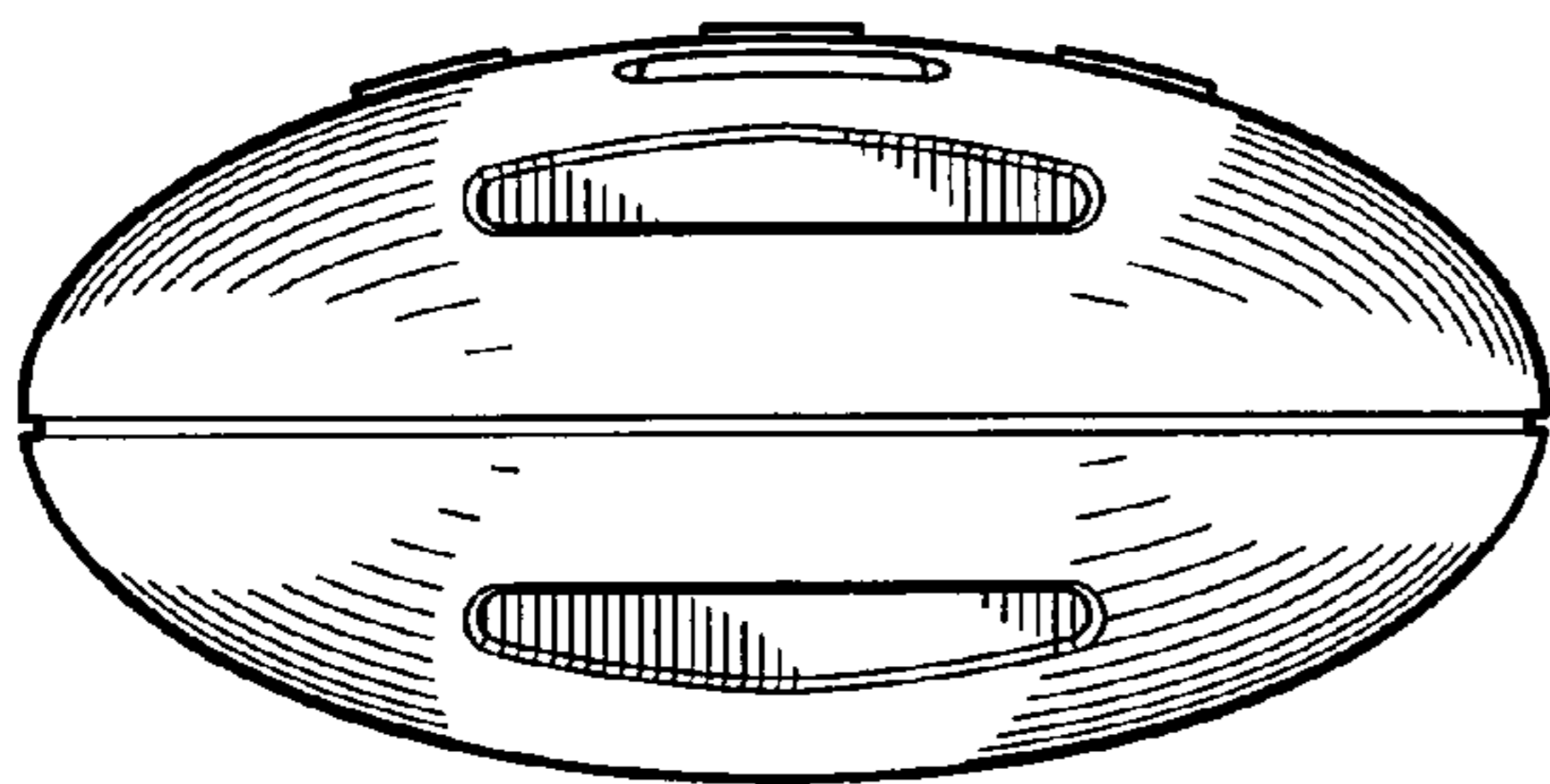

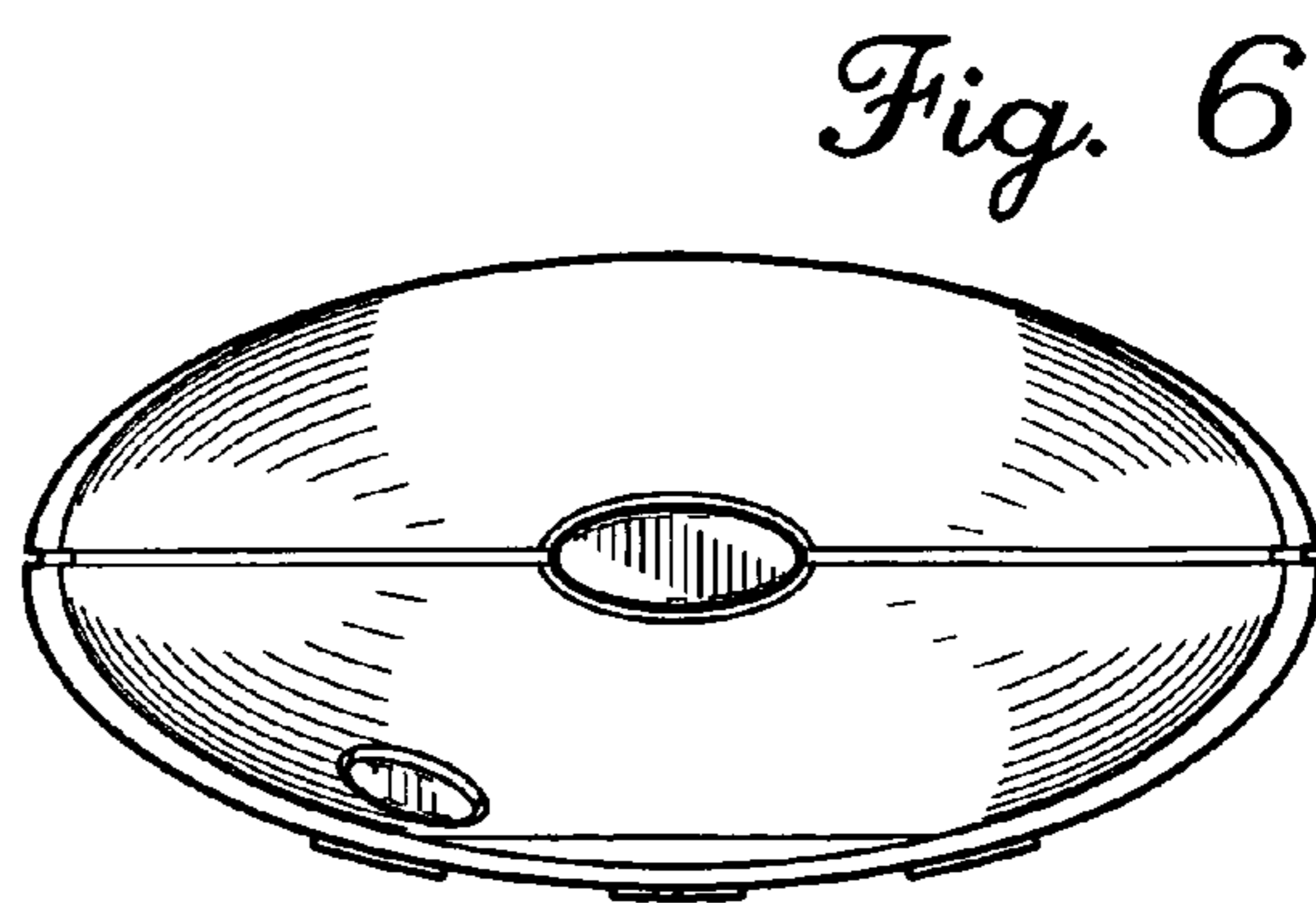
