FIG. 4 is a side view thereof;

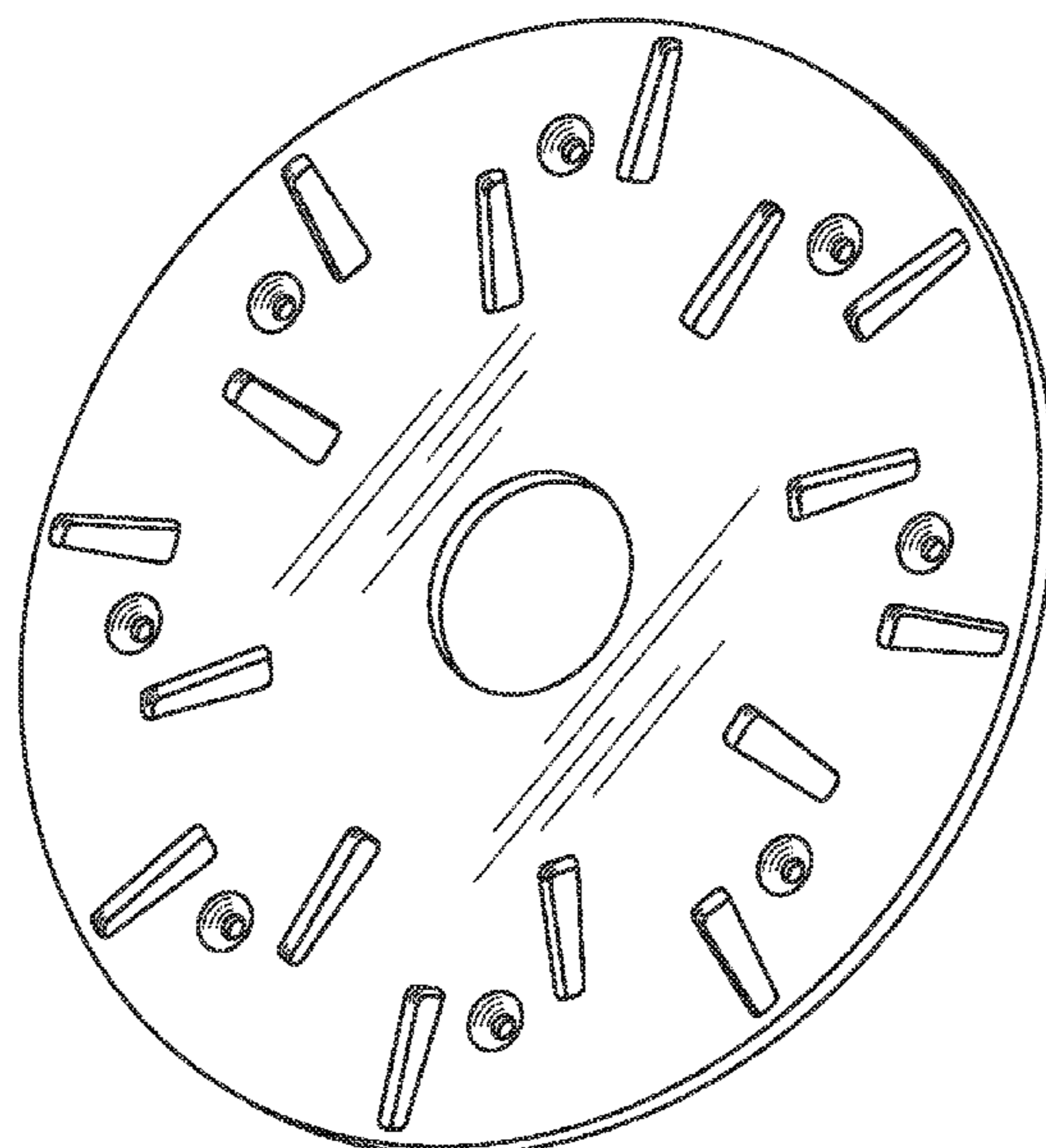
FIG. 5 is front perspective view of a second embodiment of the abrasive disc holder;

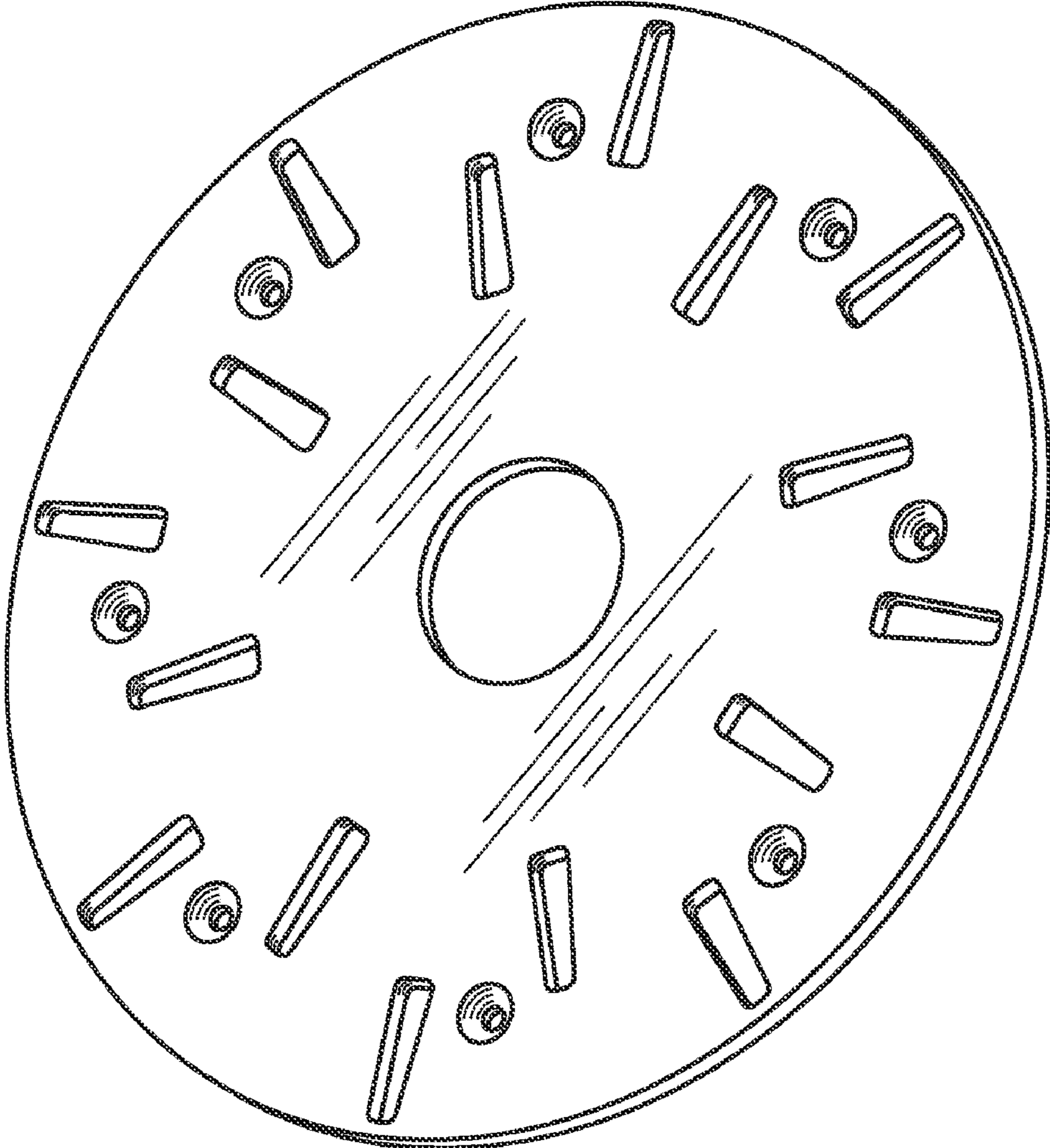

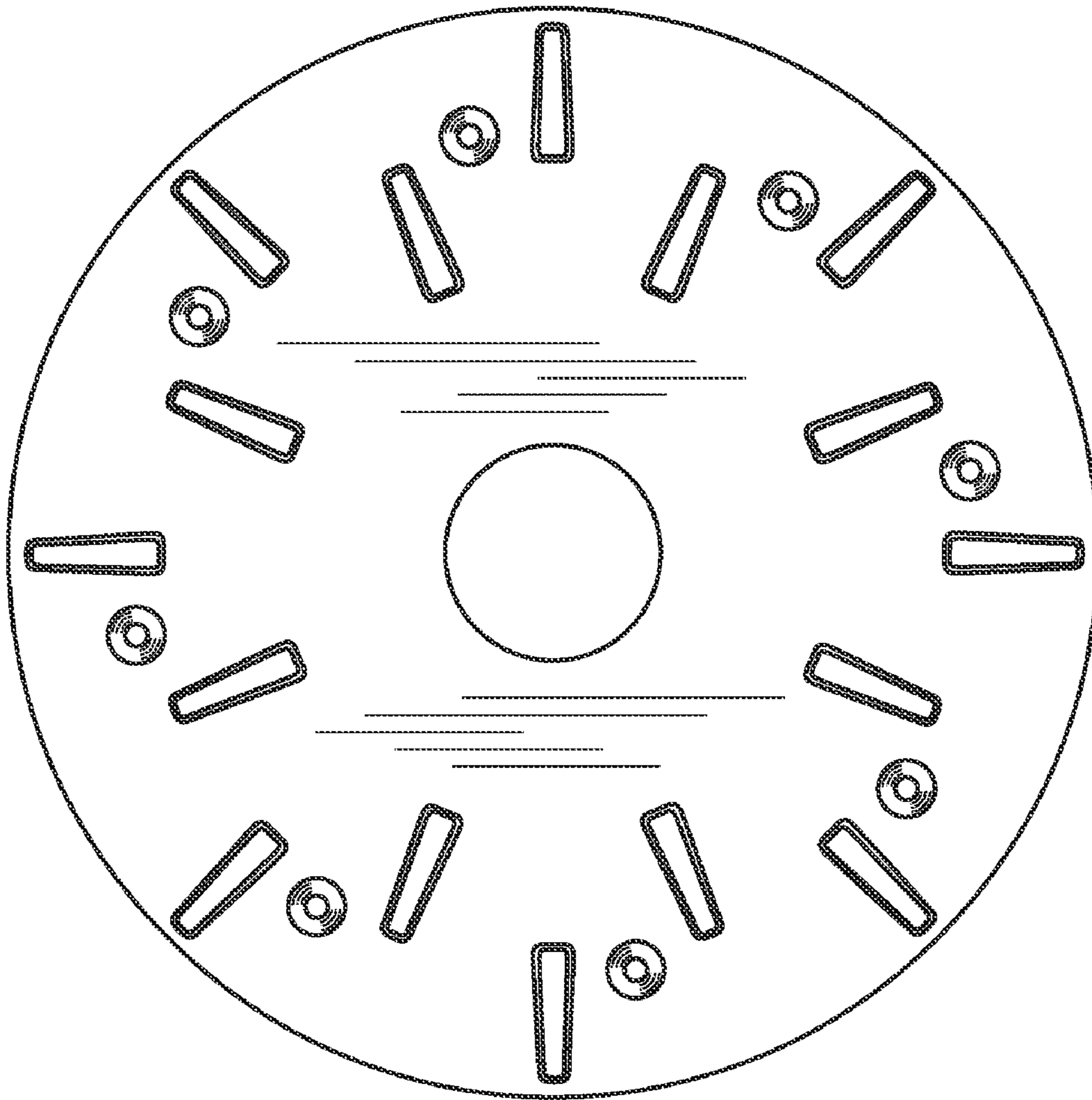

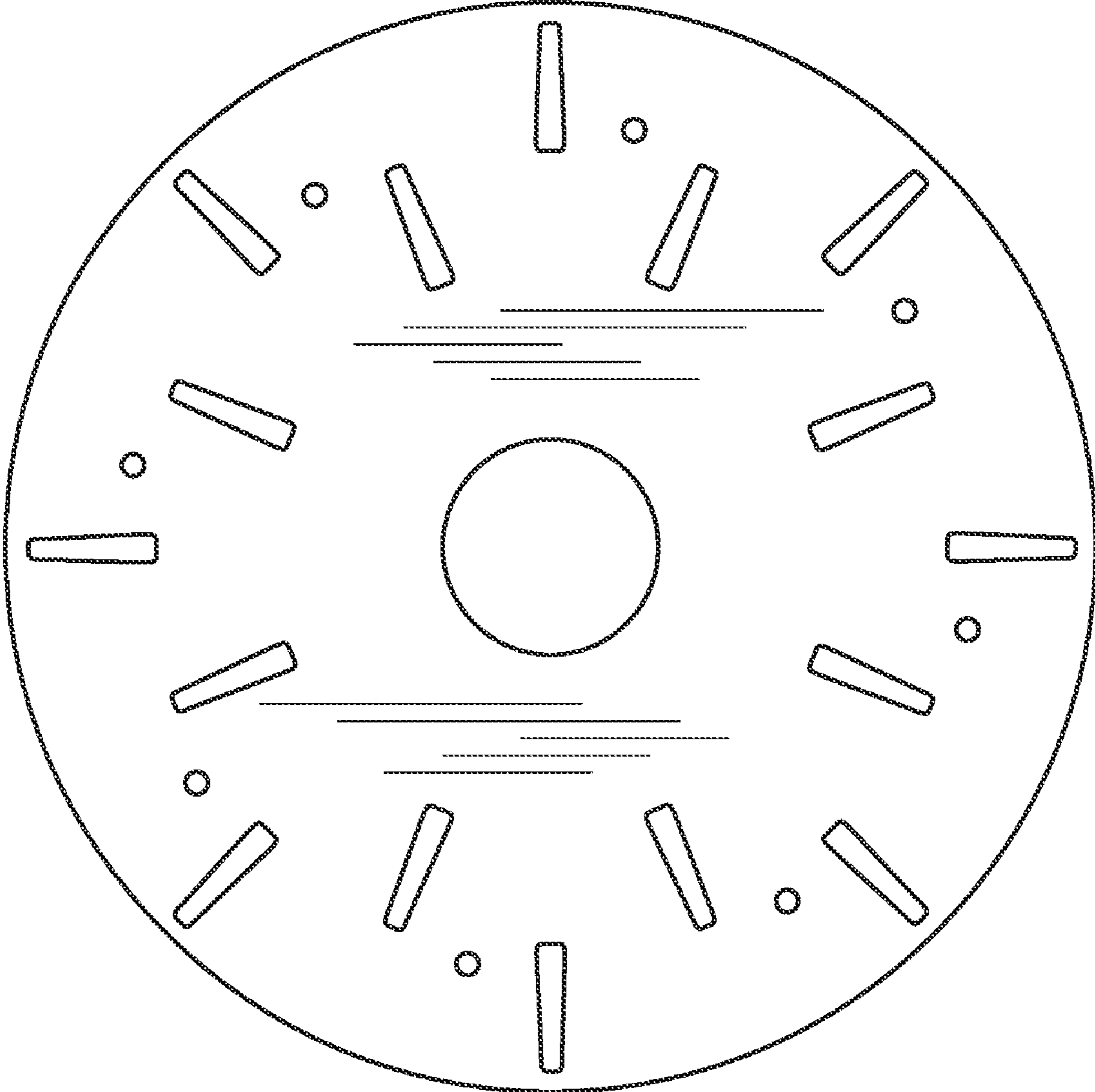

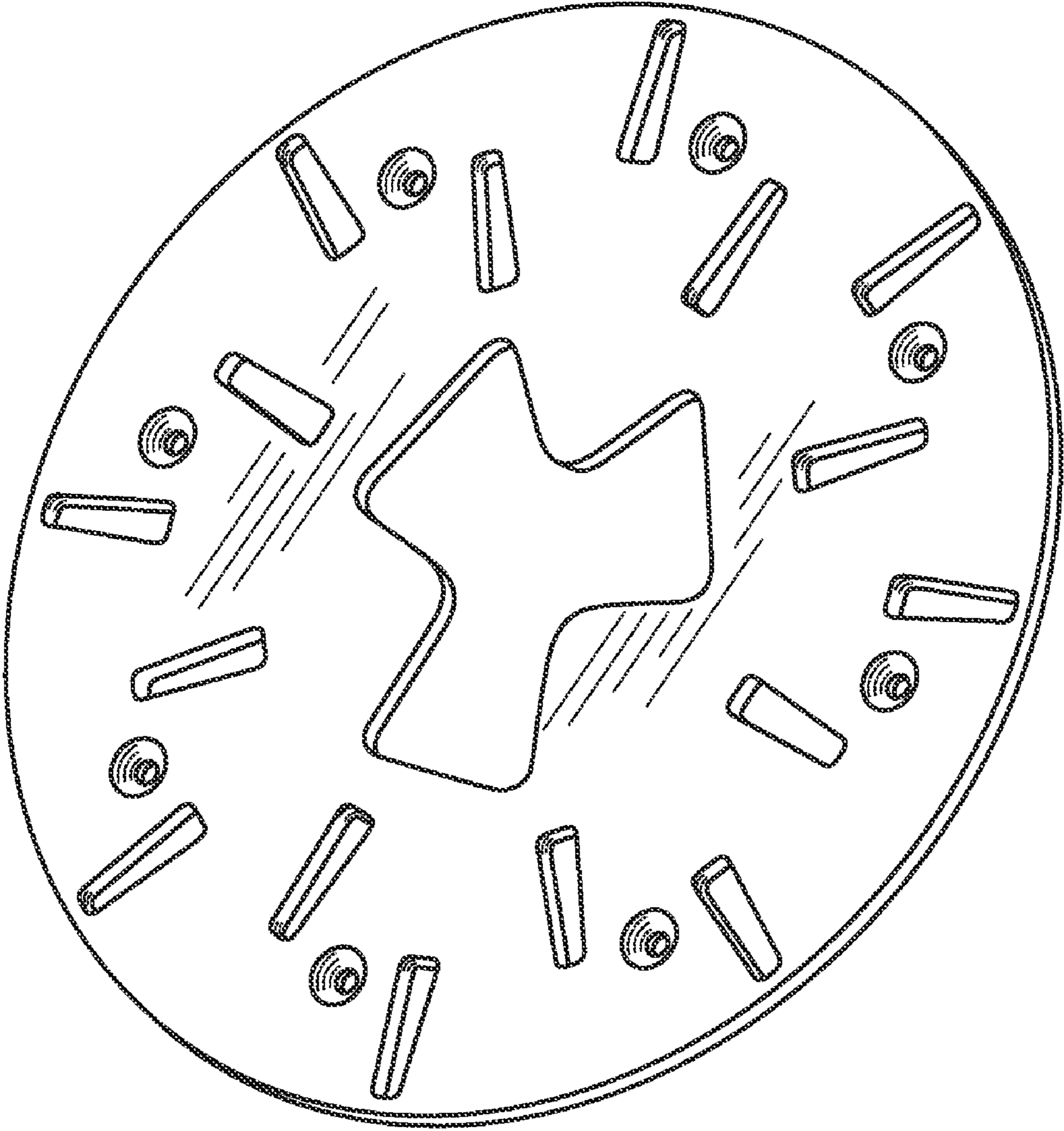

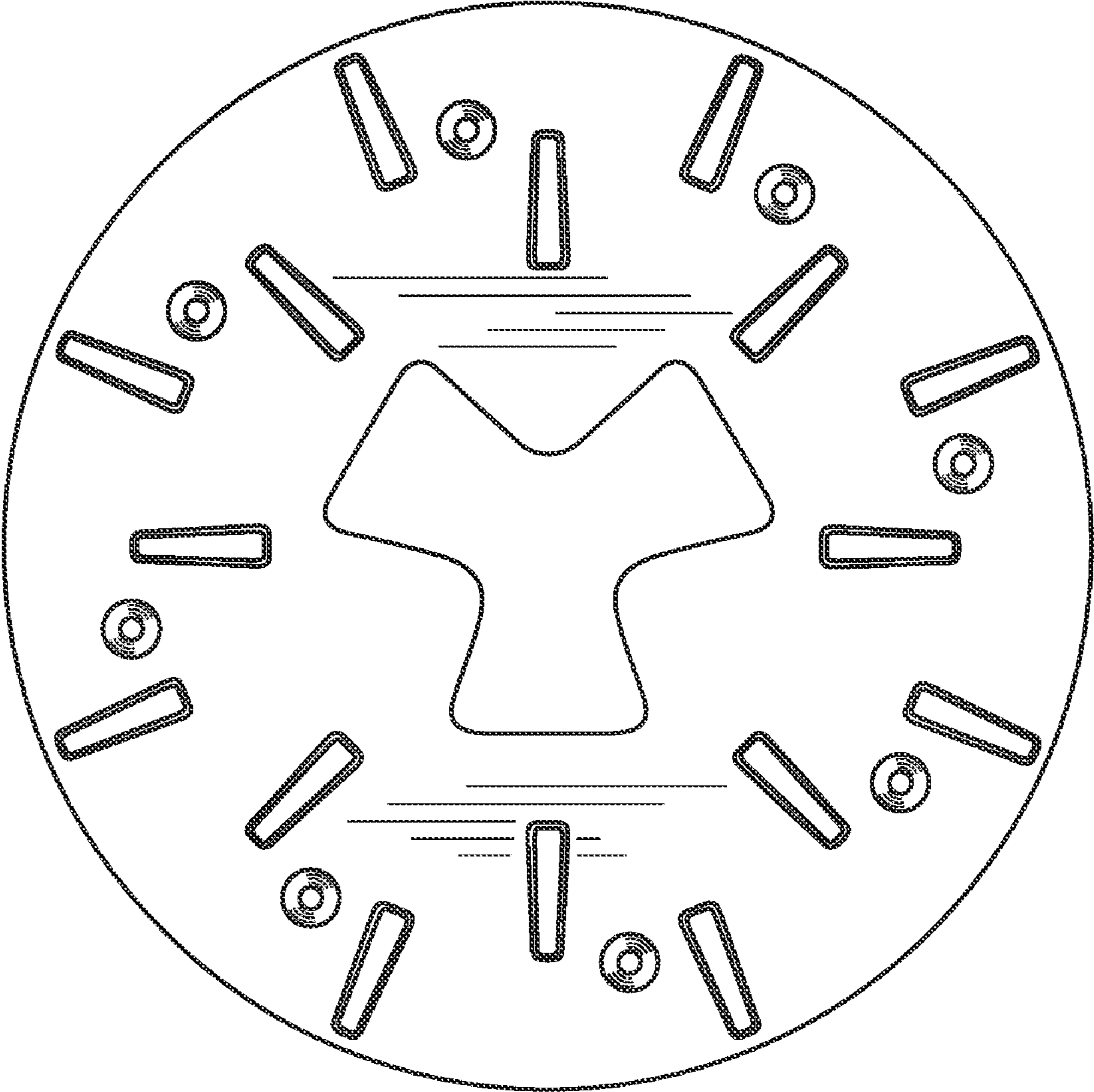

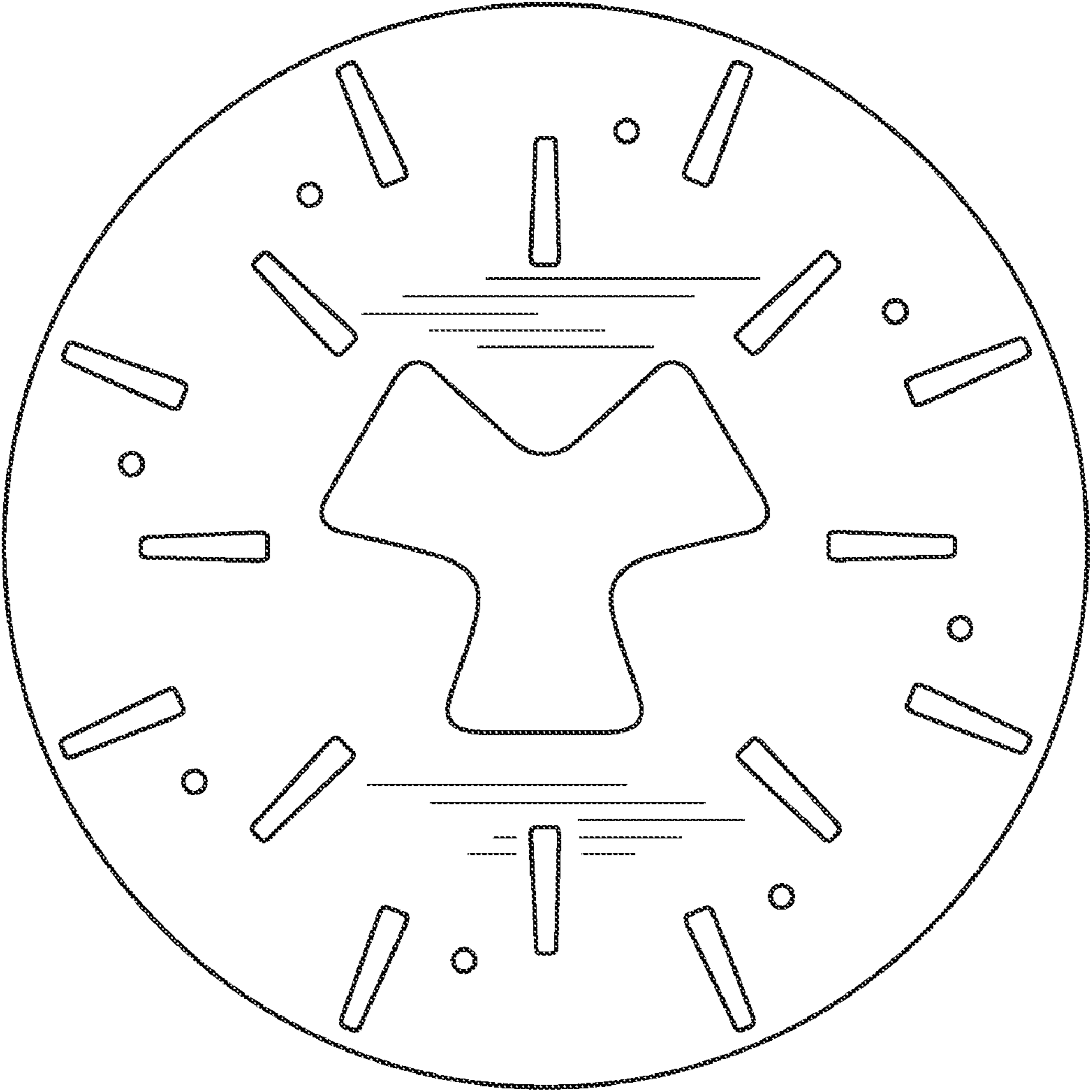
