FIGS. 1–70 are top views of cards for a combinations cards and board game showing our new design;

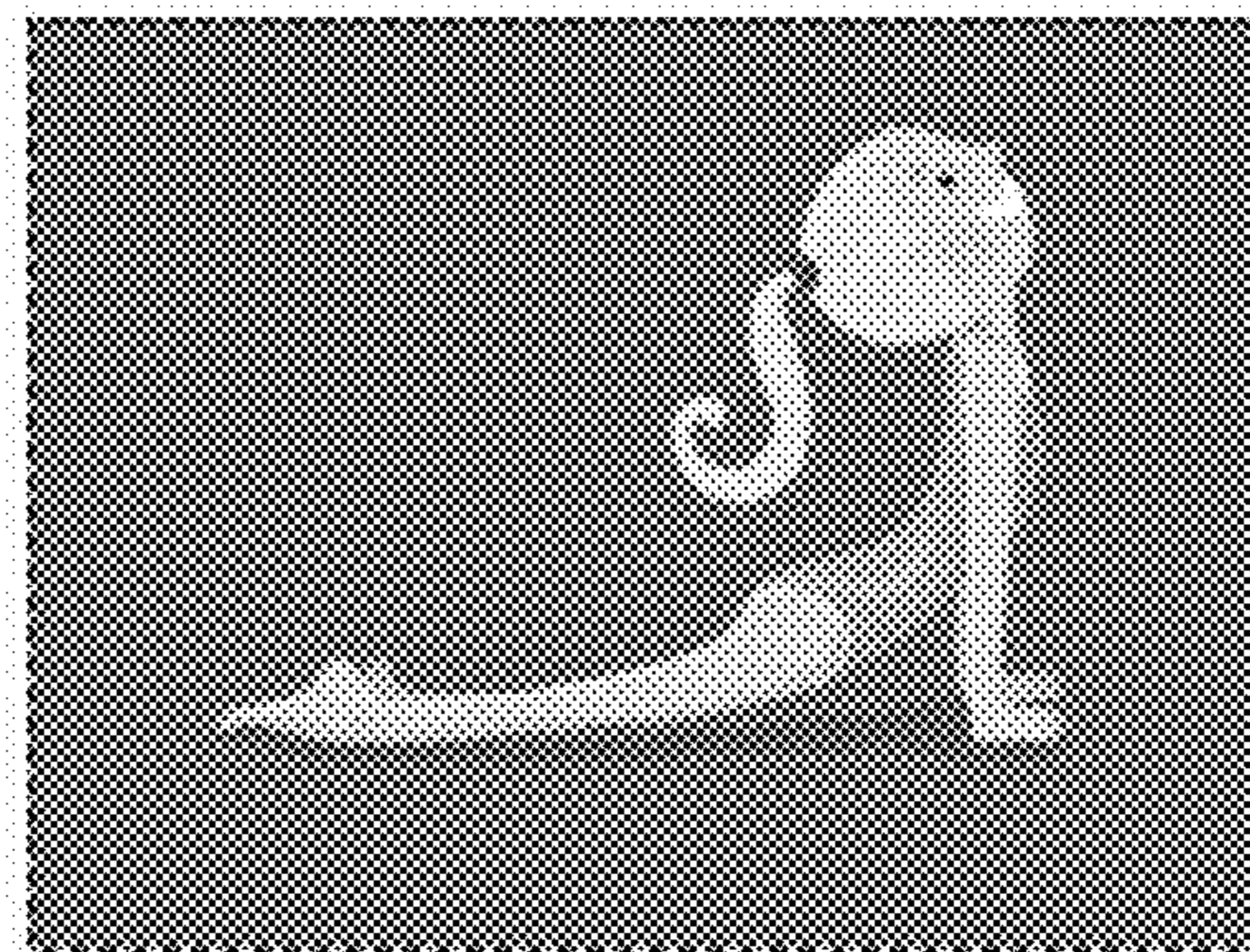
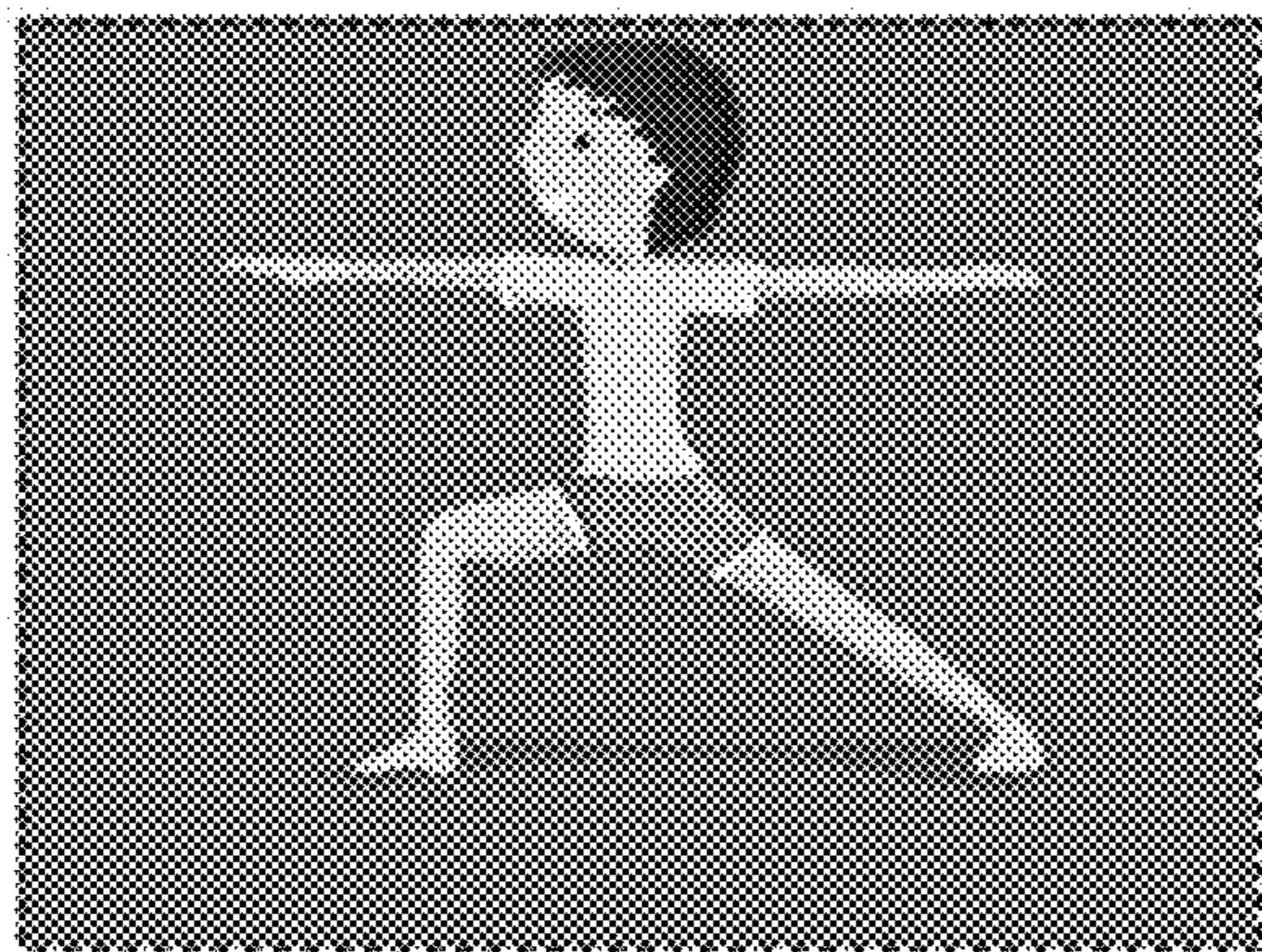
FIG. 71 is a bottom view of each of the cards of FIGS. 1–70; and,

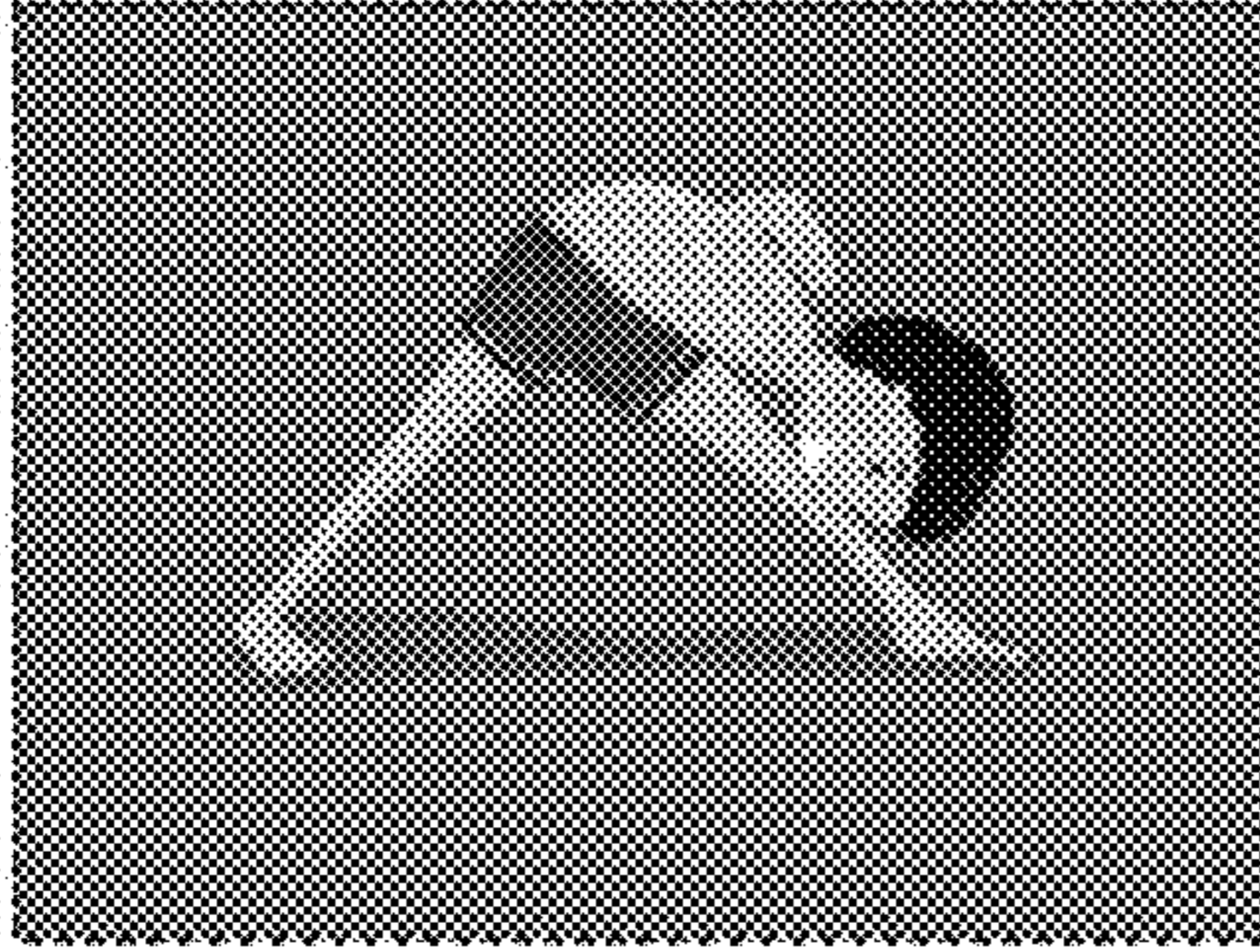

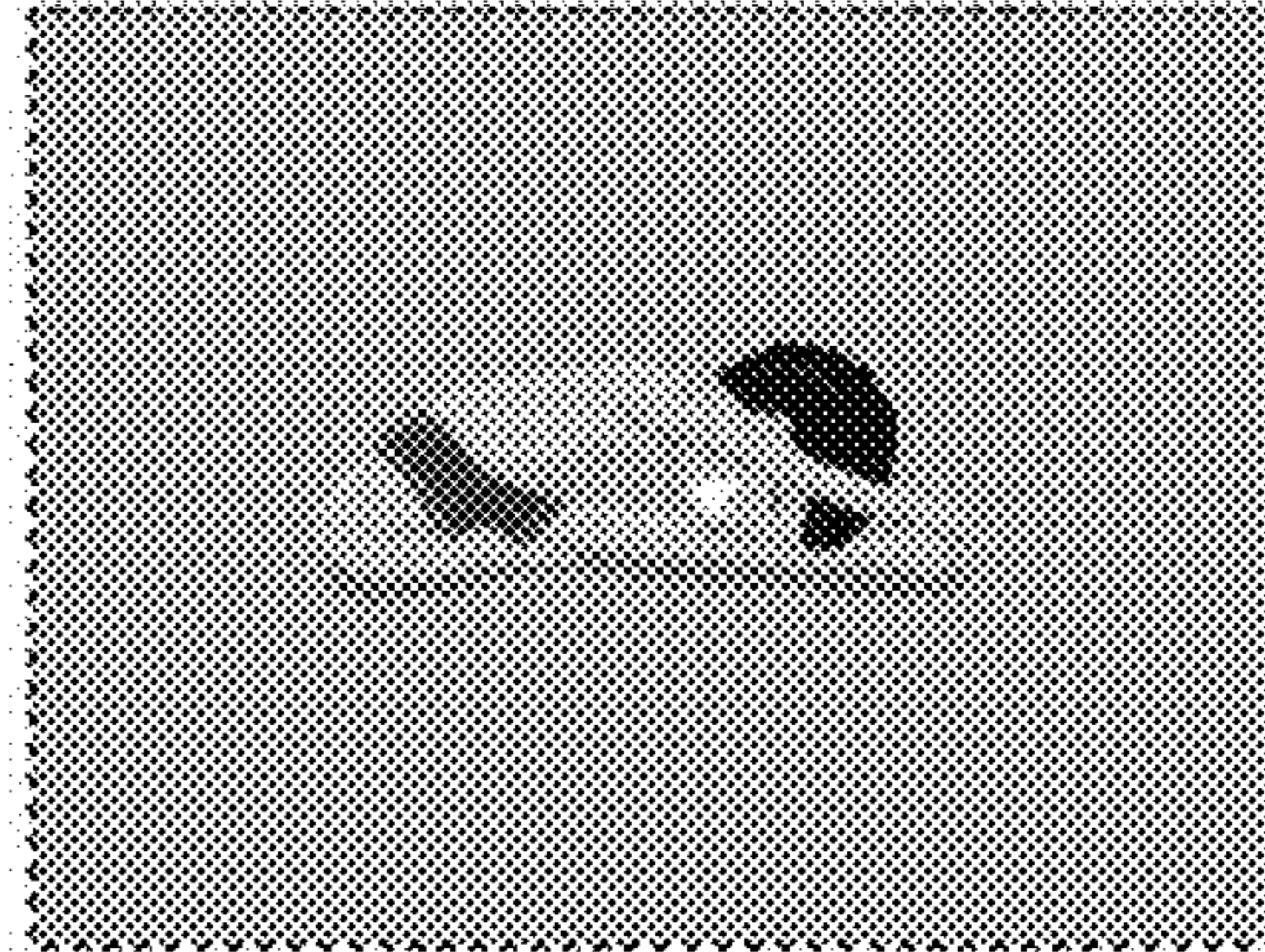

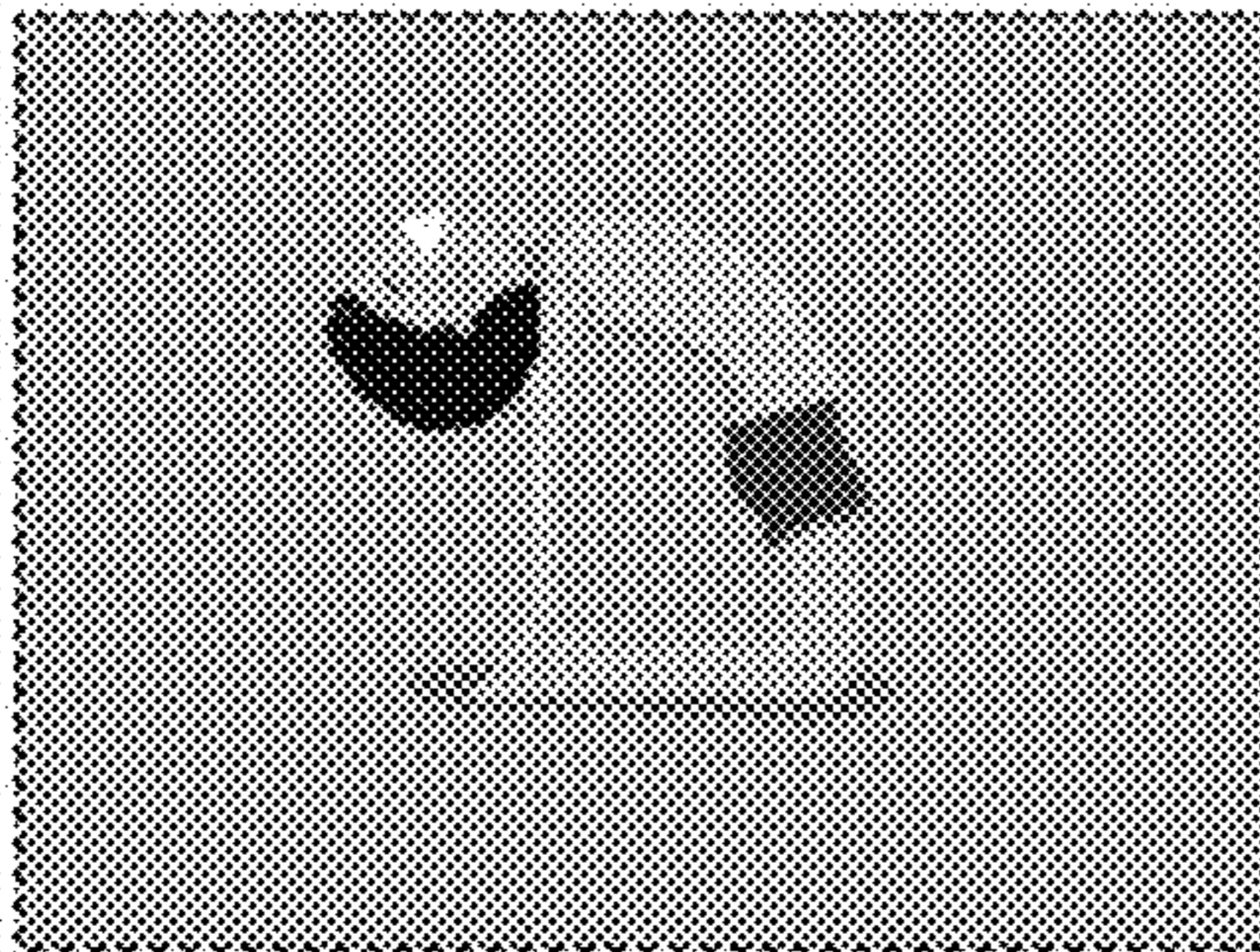

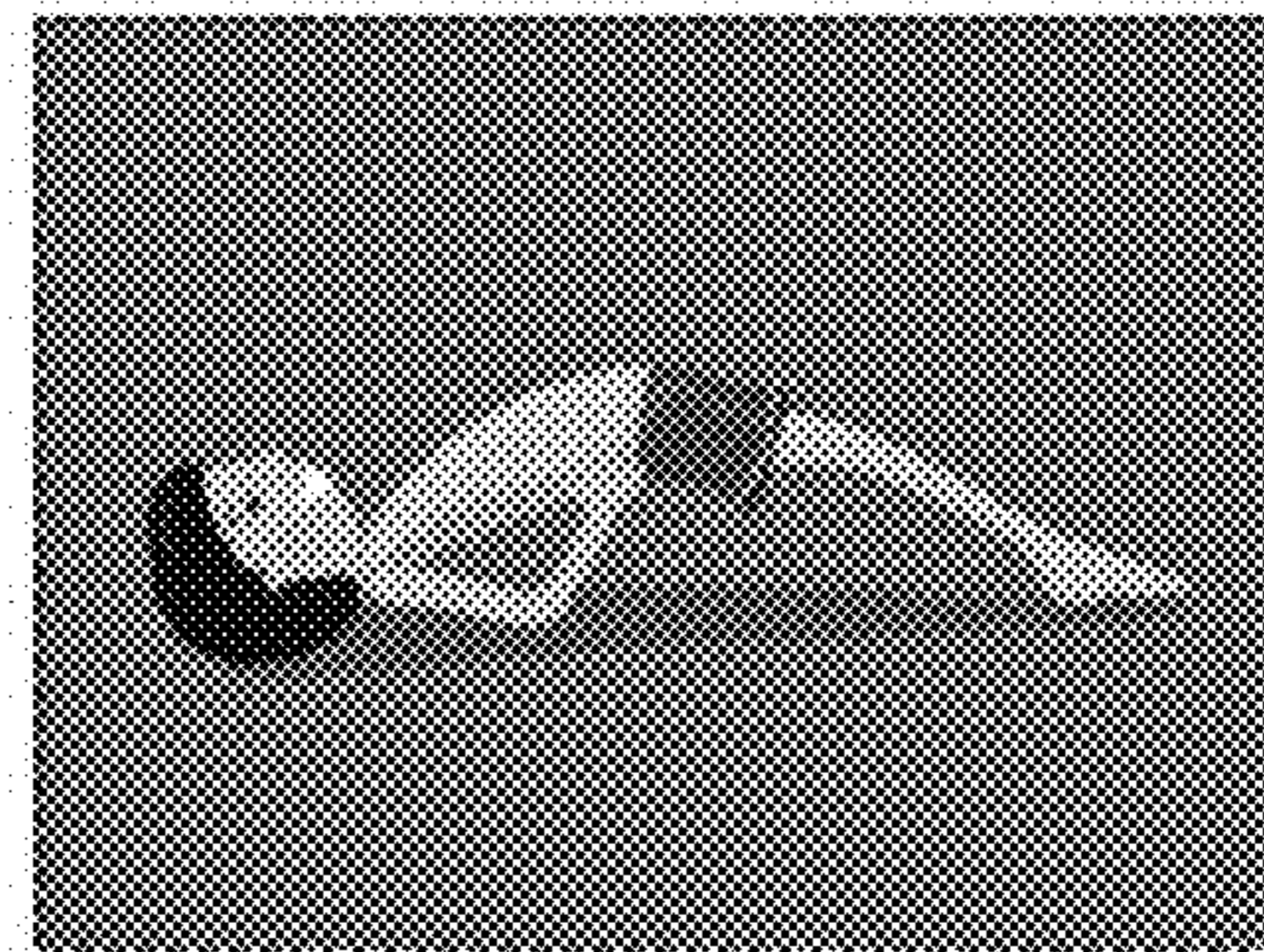

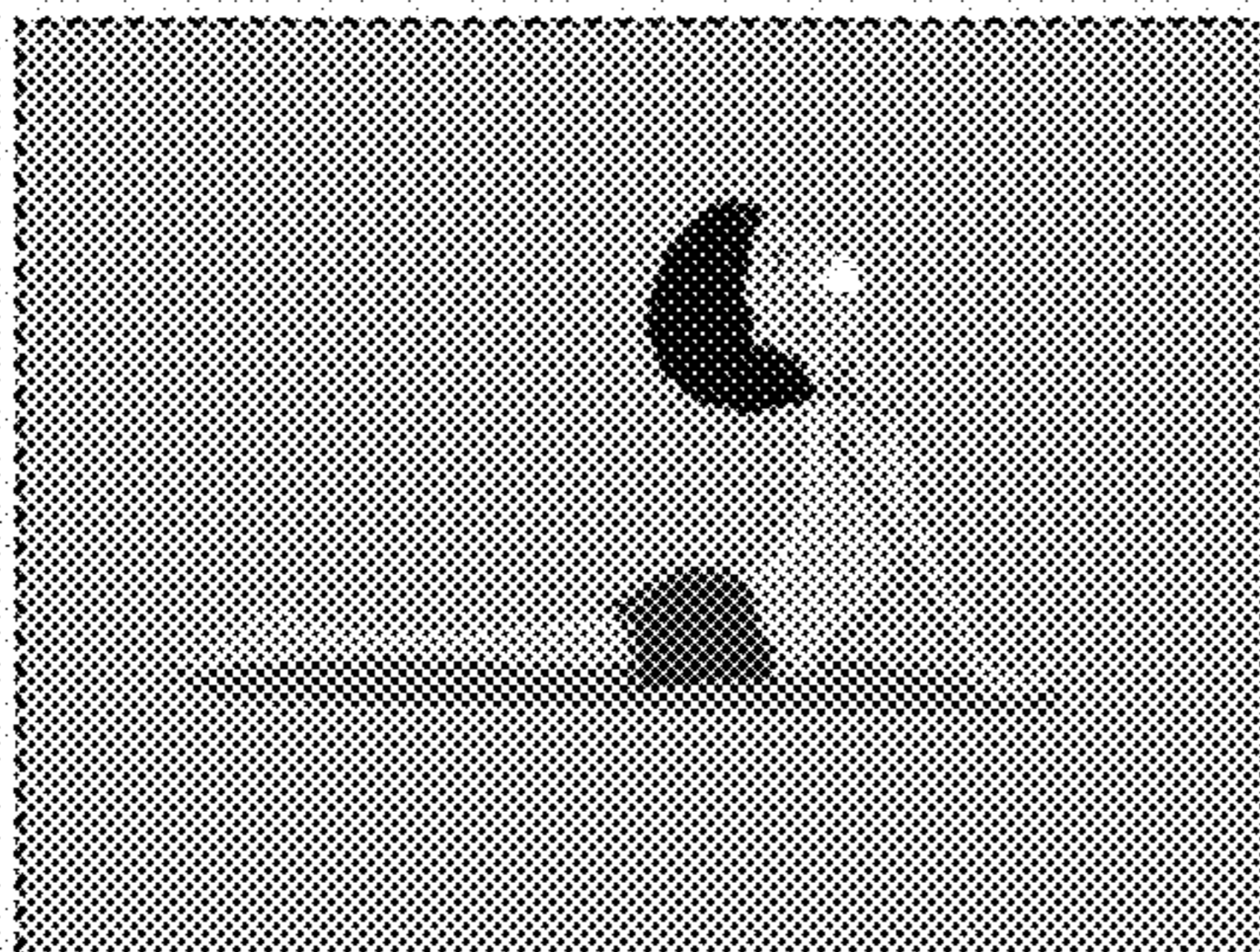

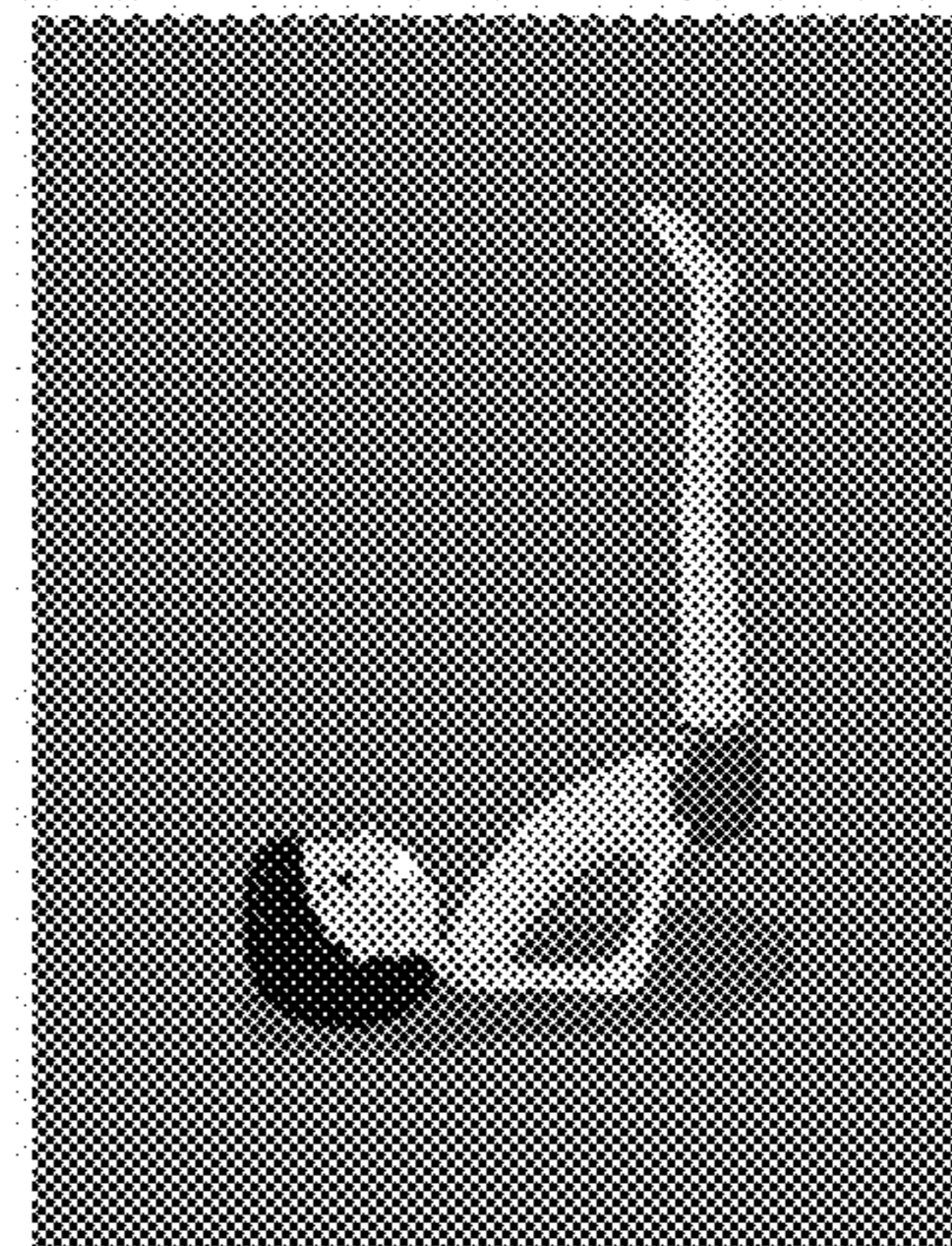

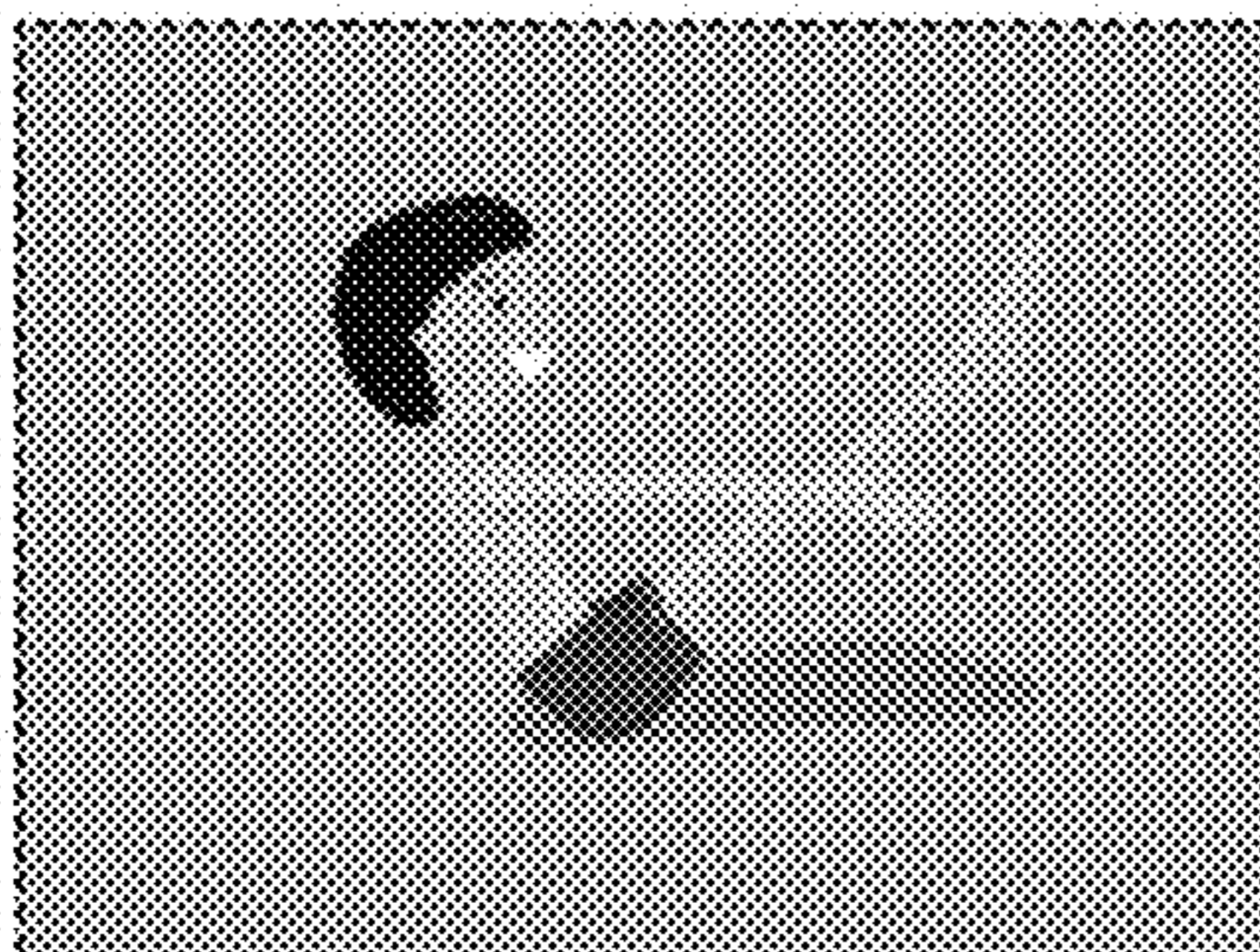

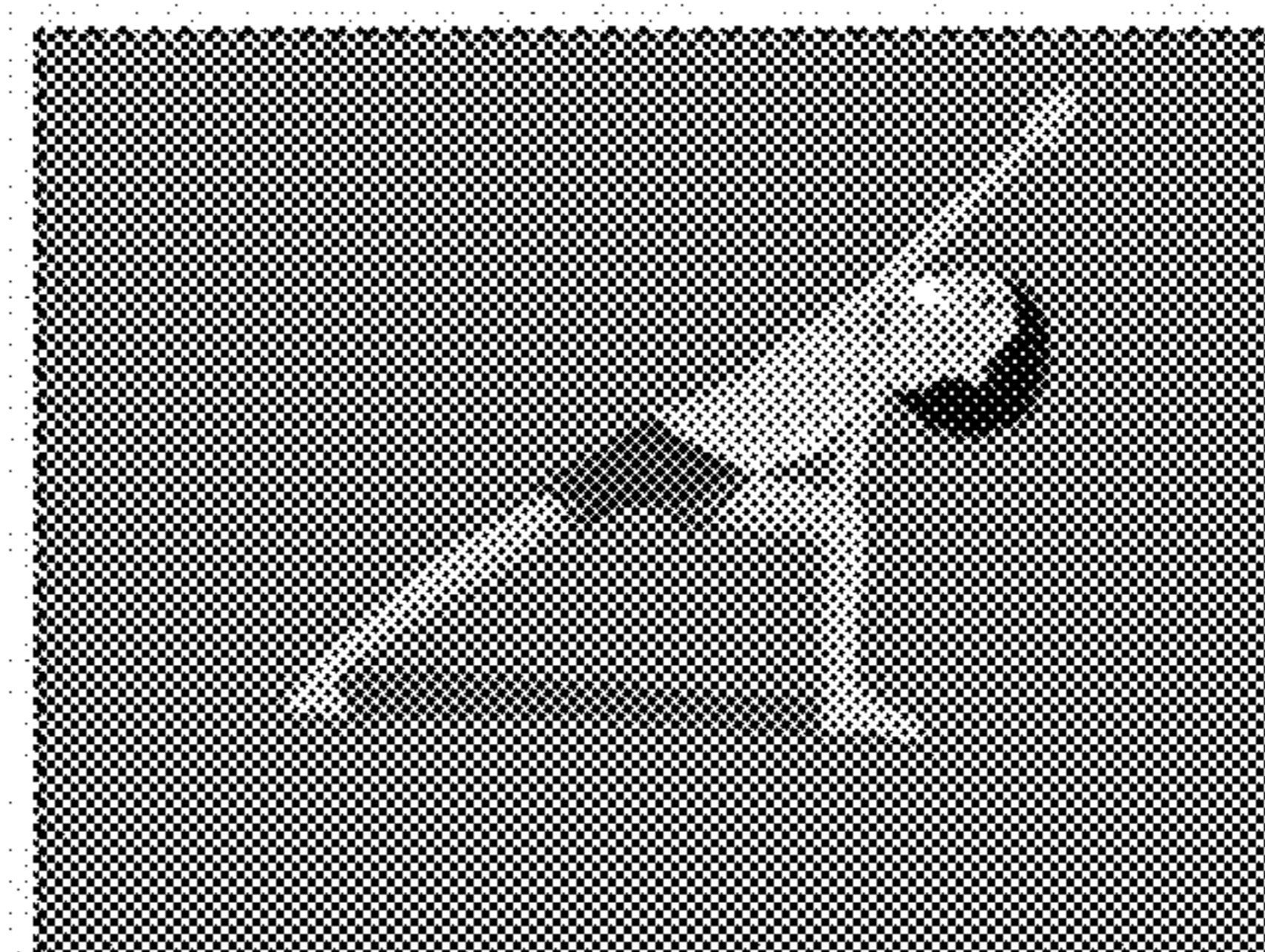

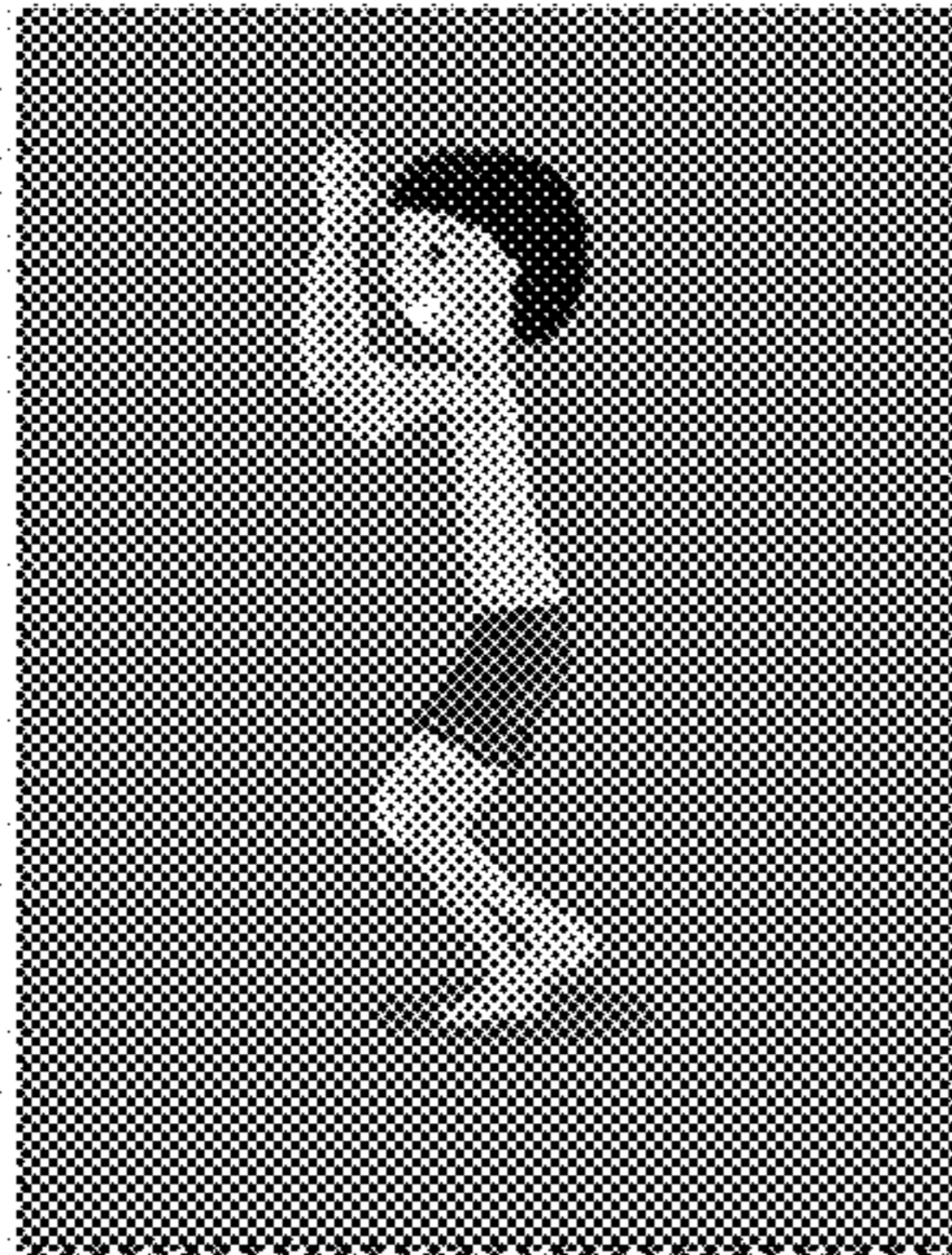

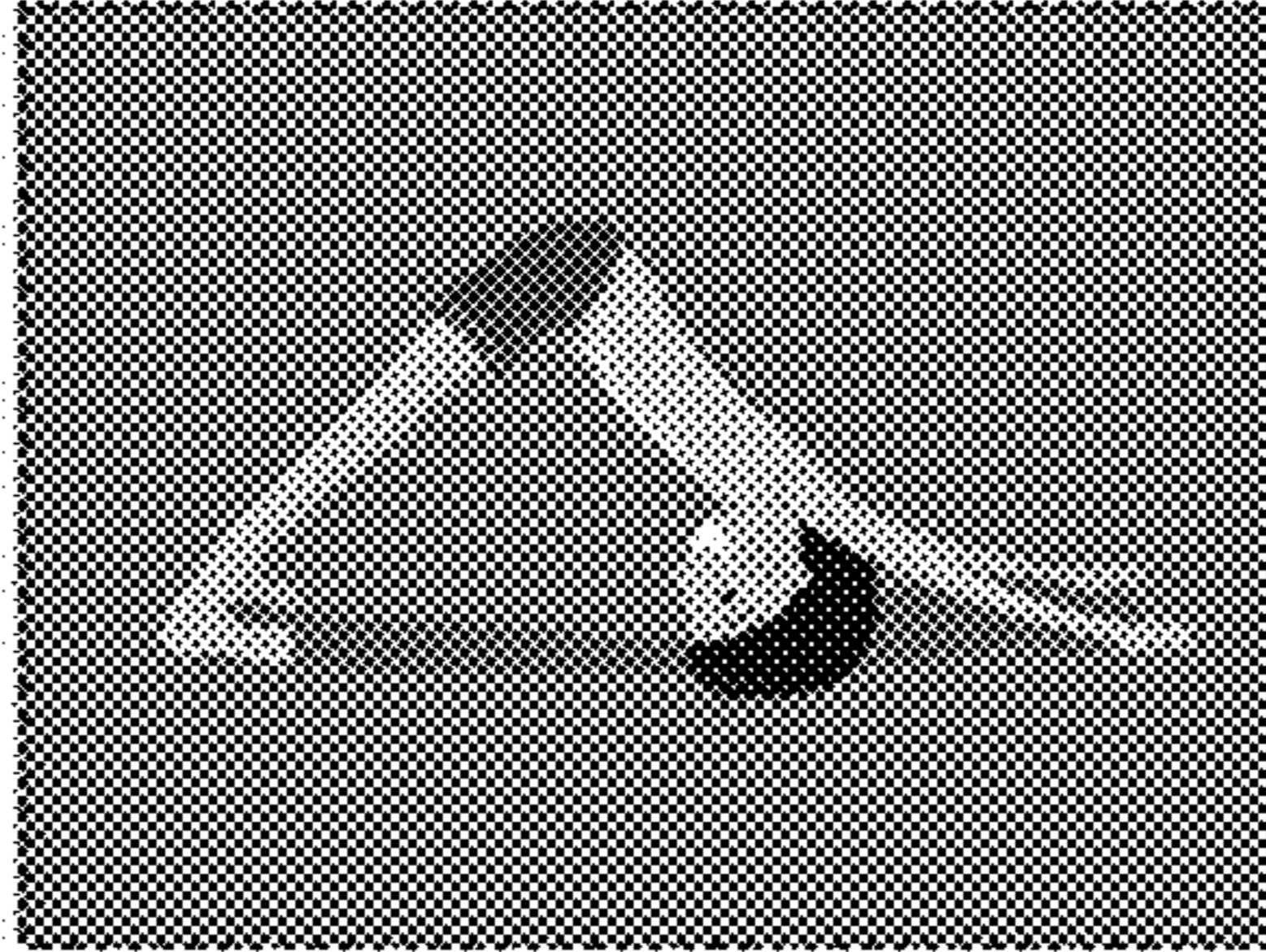

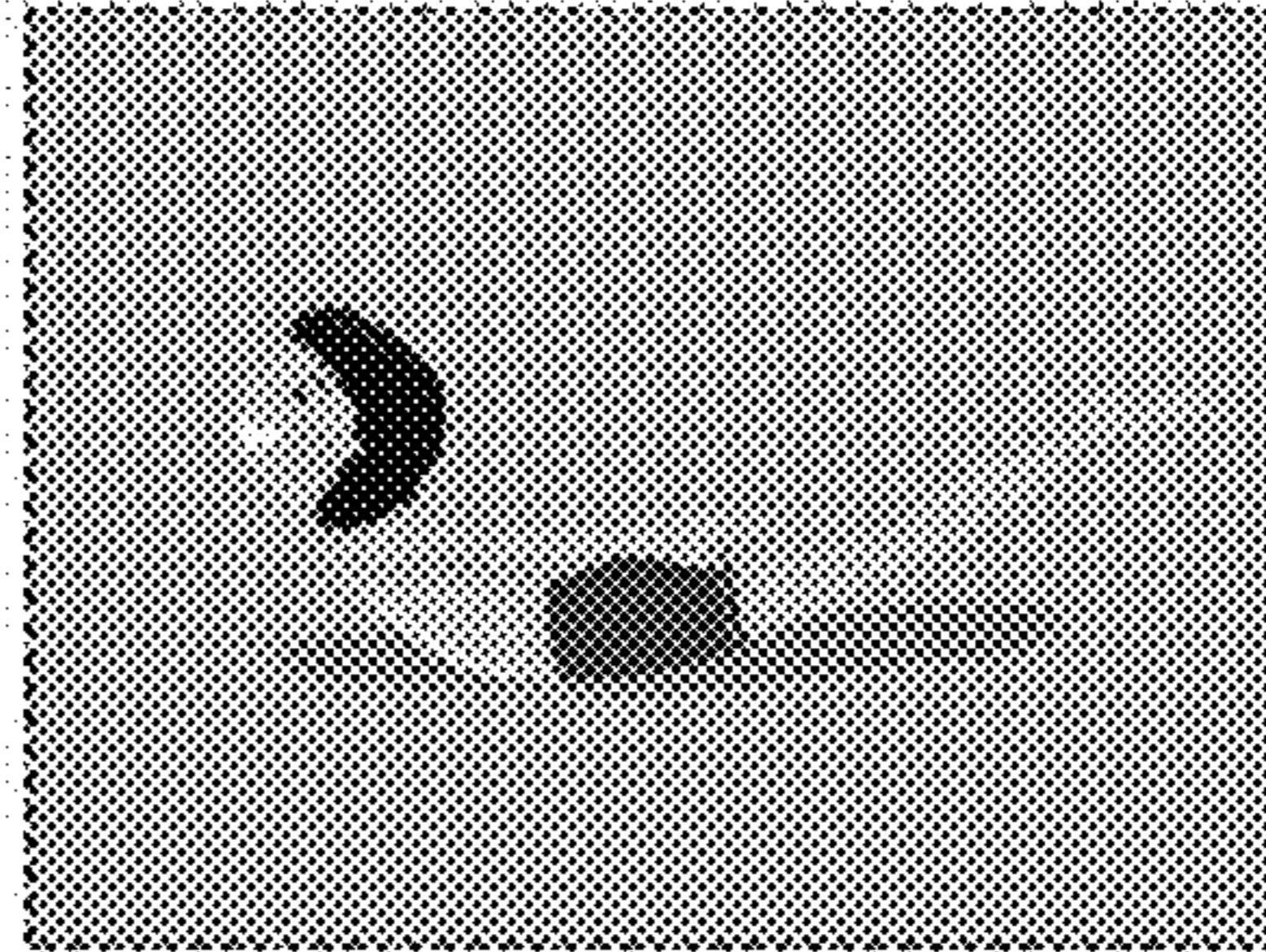

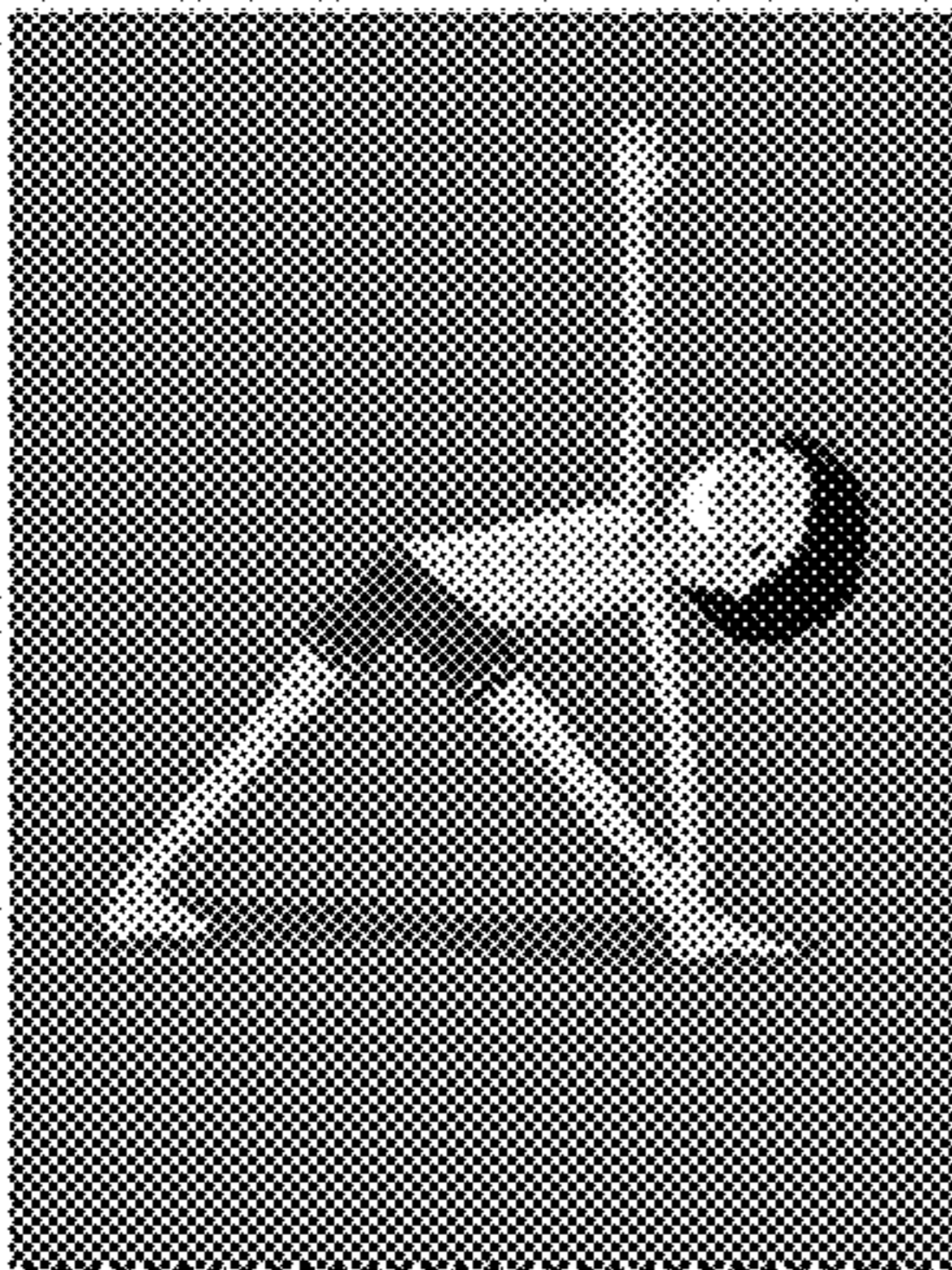

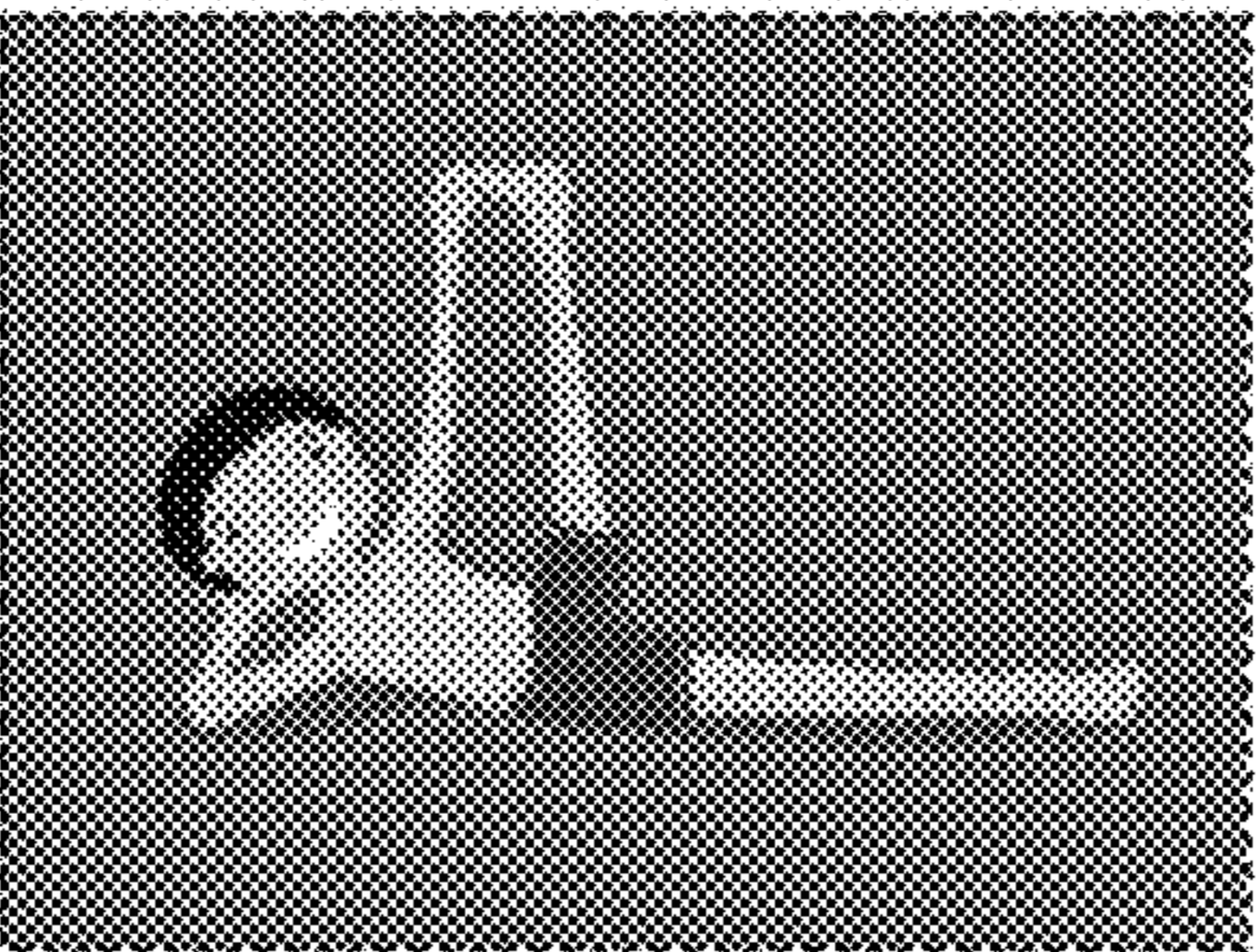

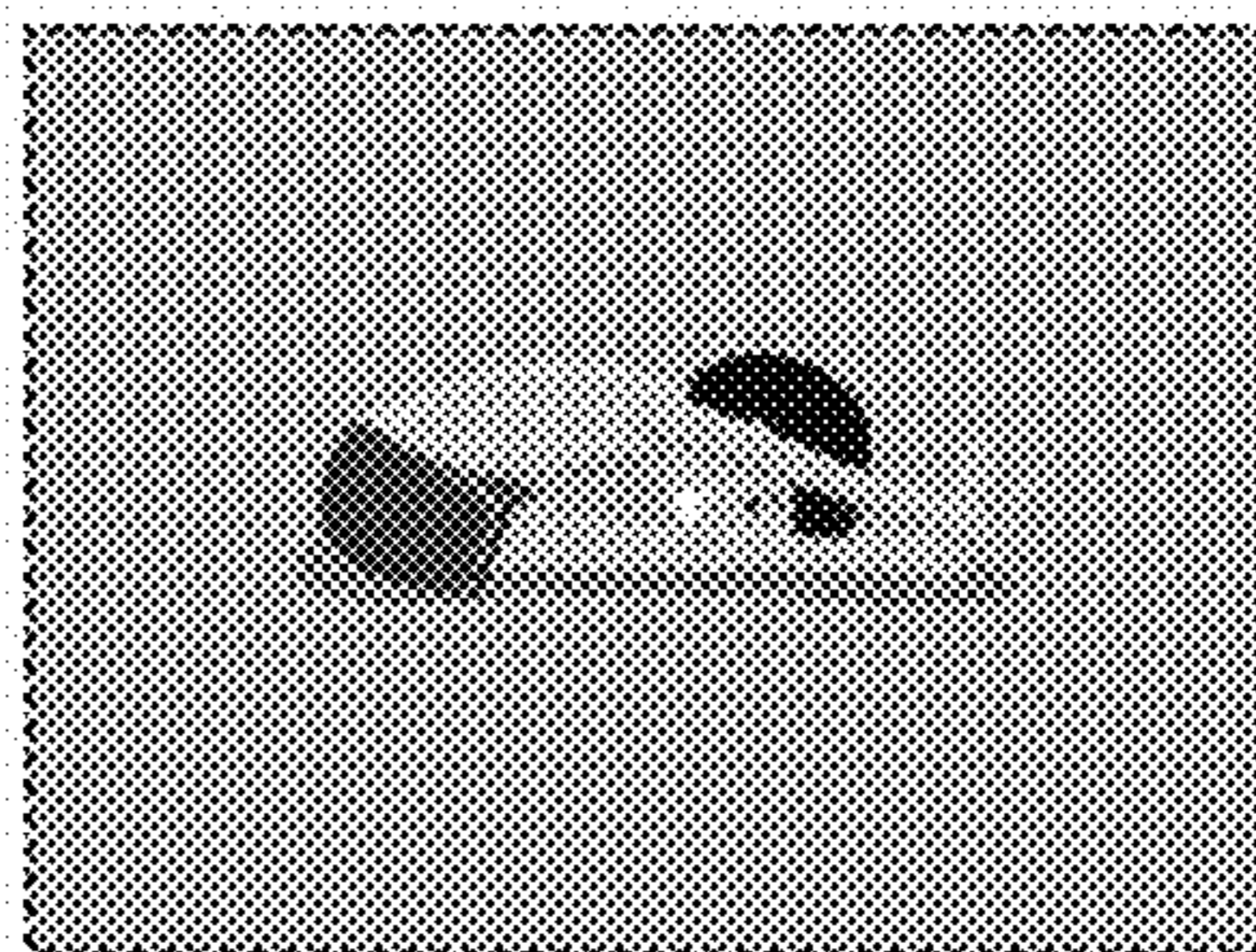

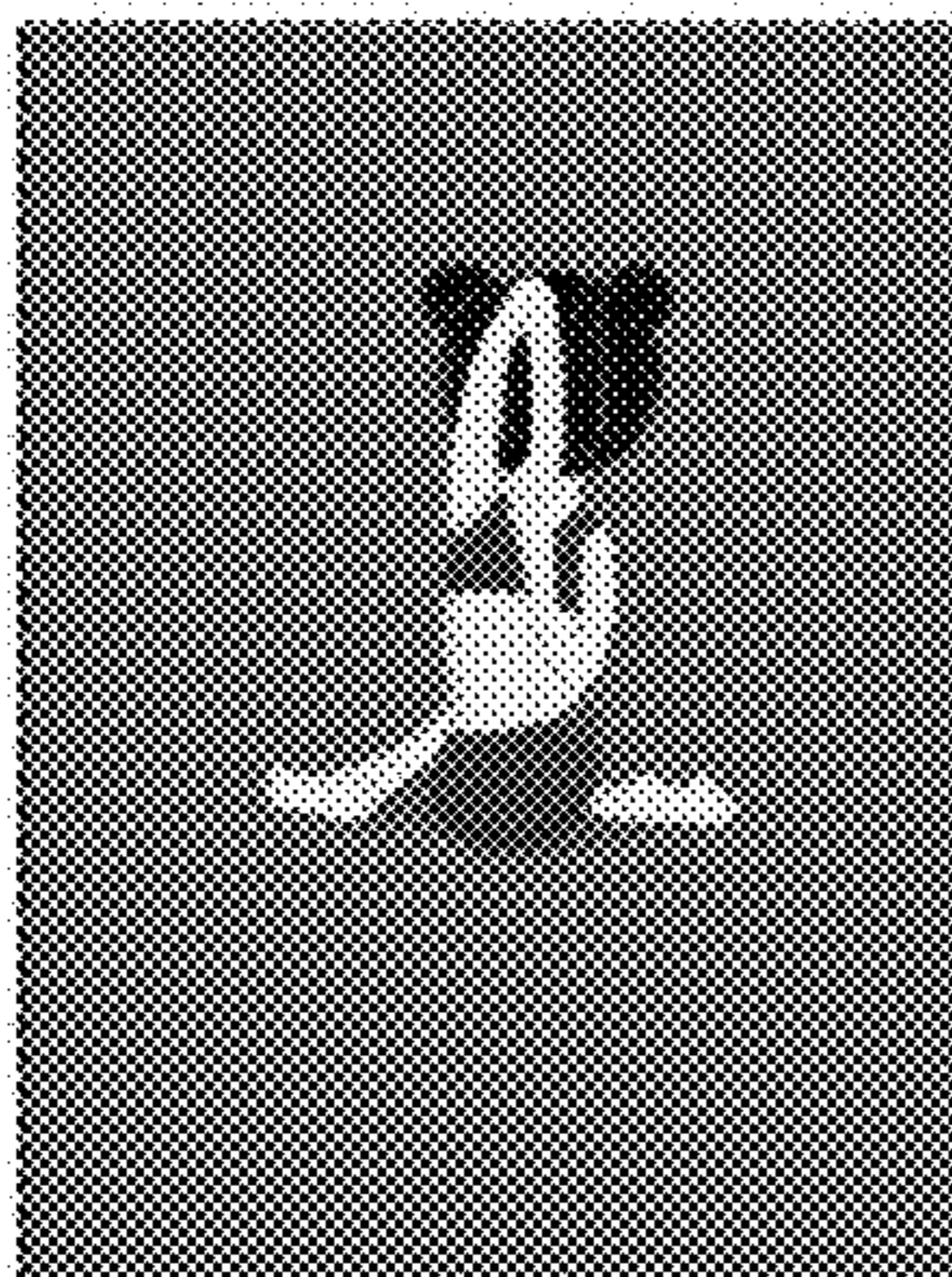

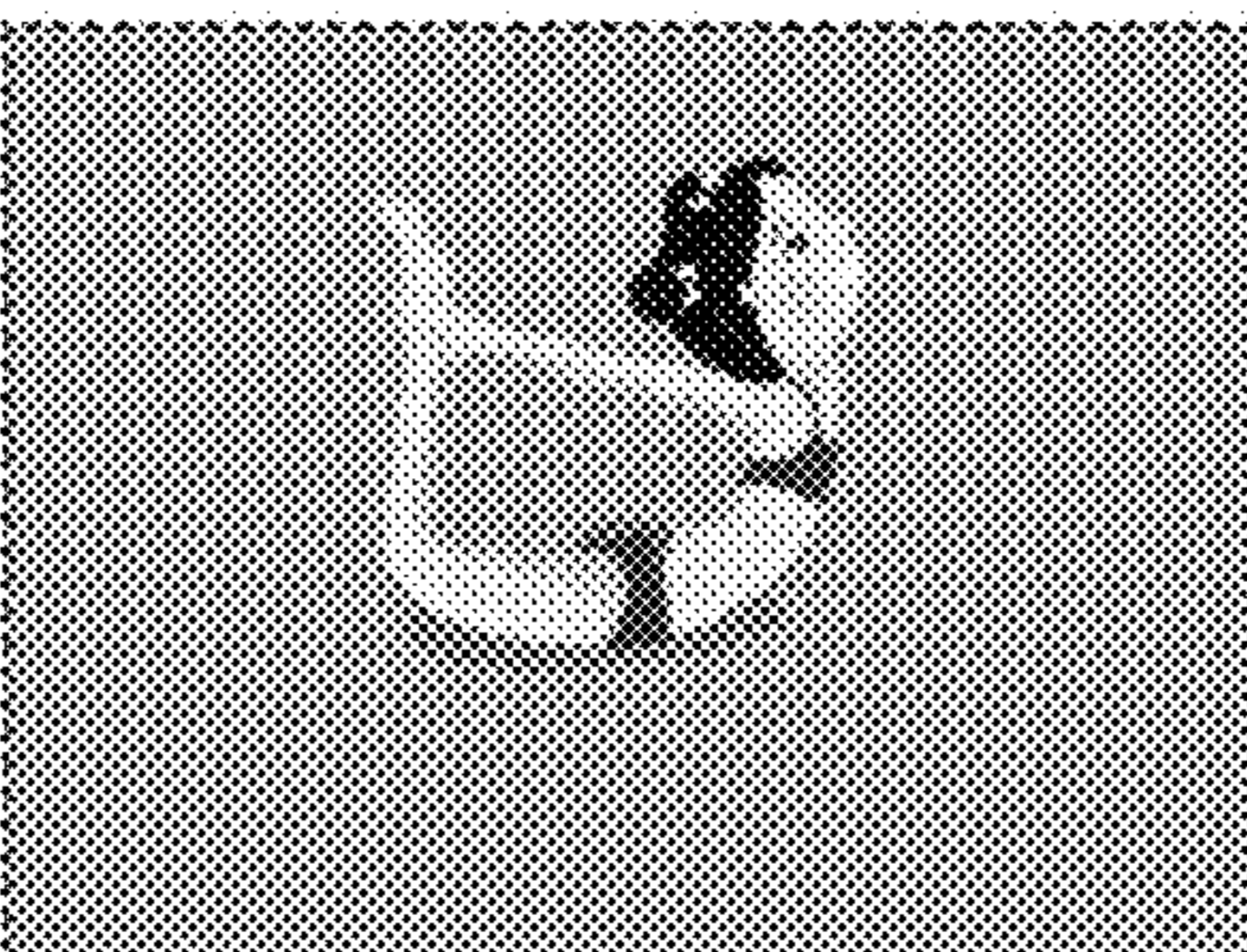

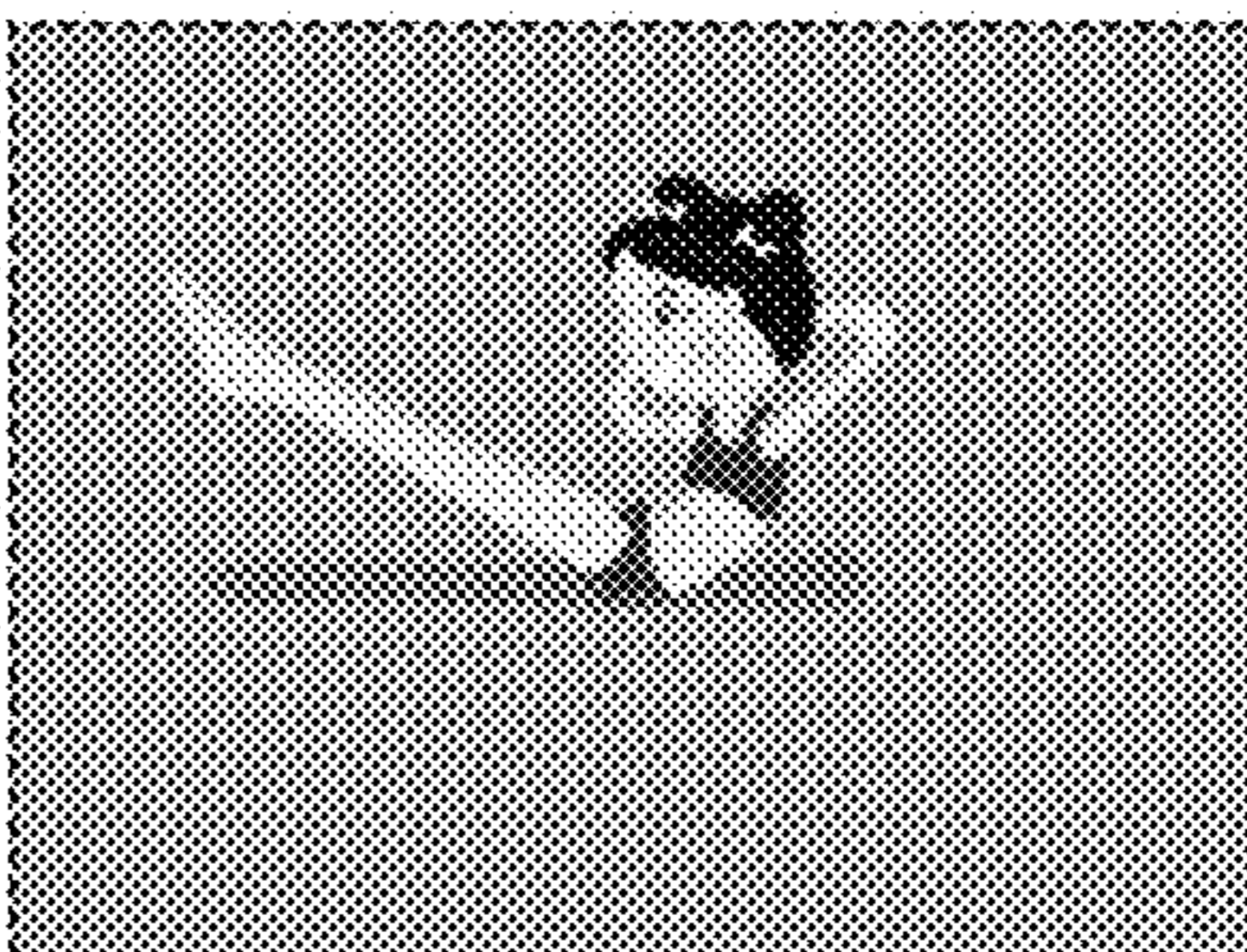

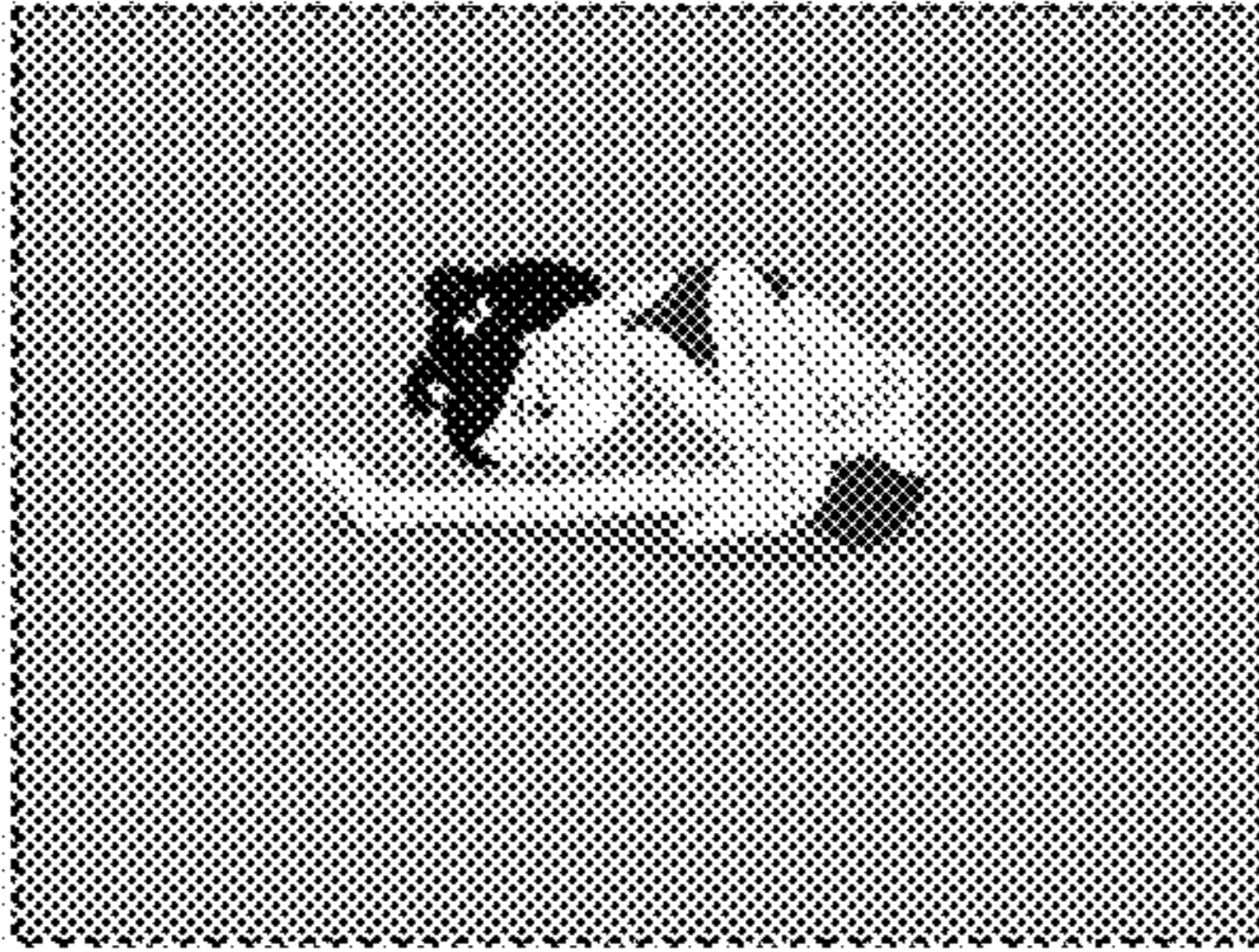

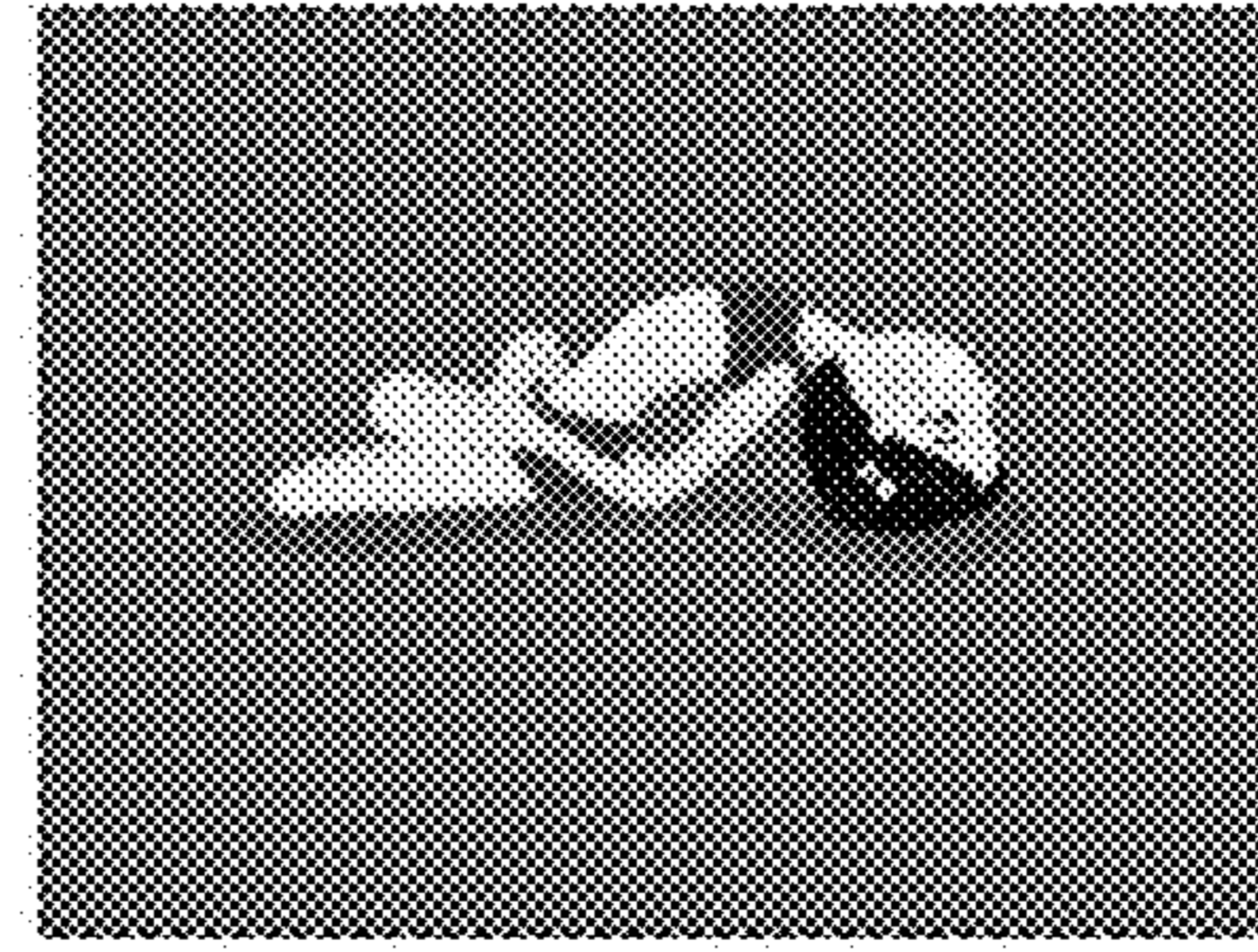

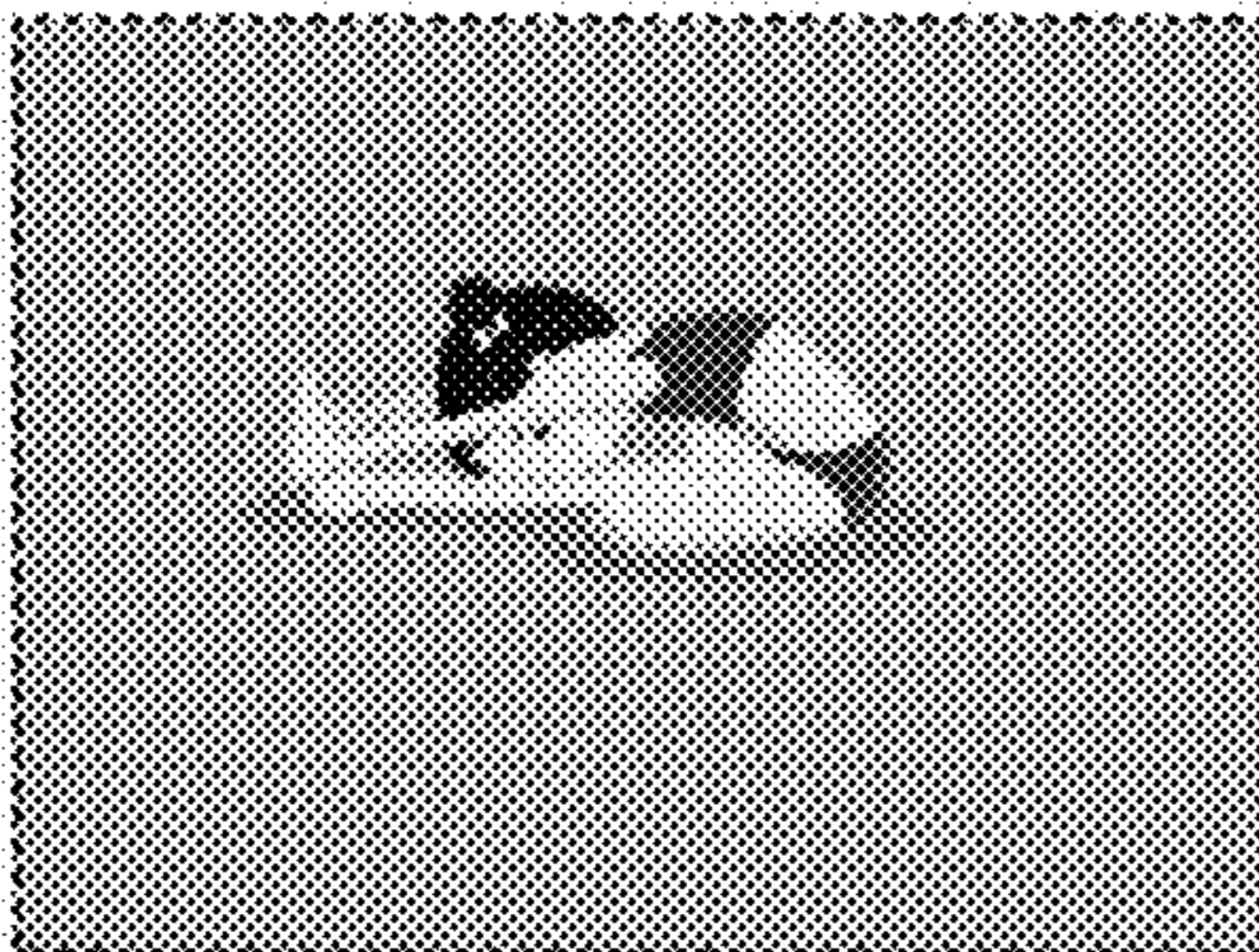

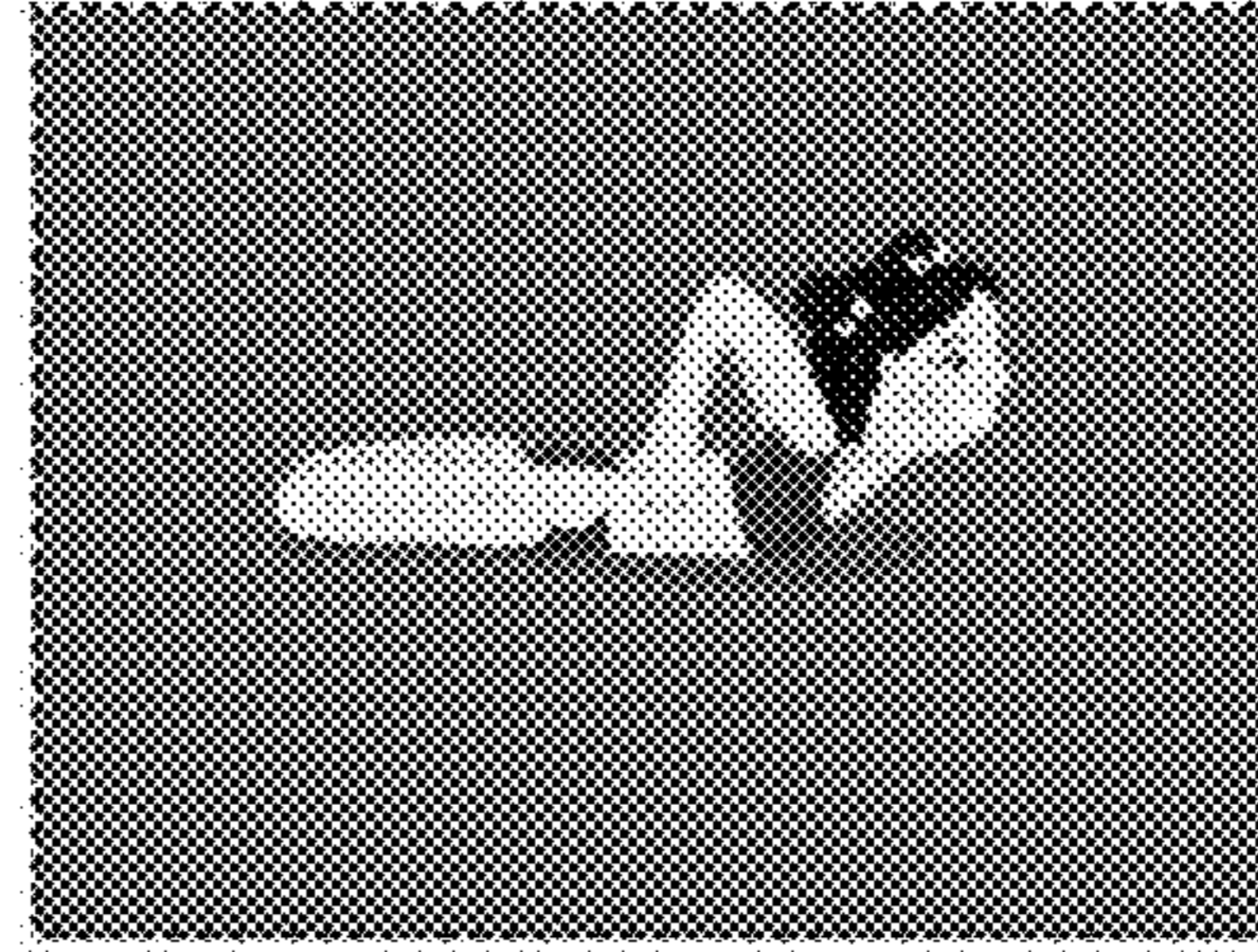

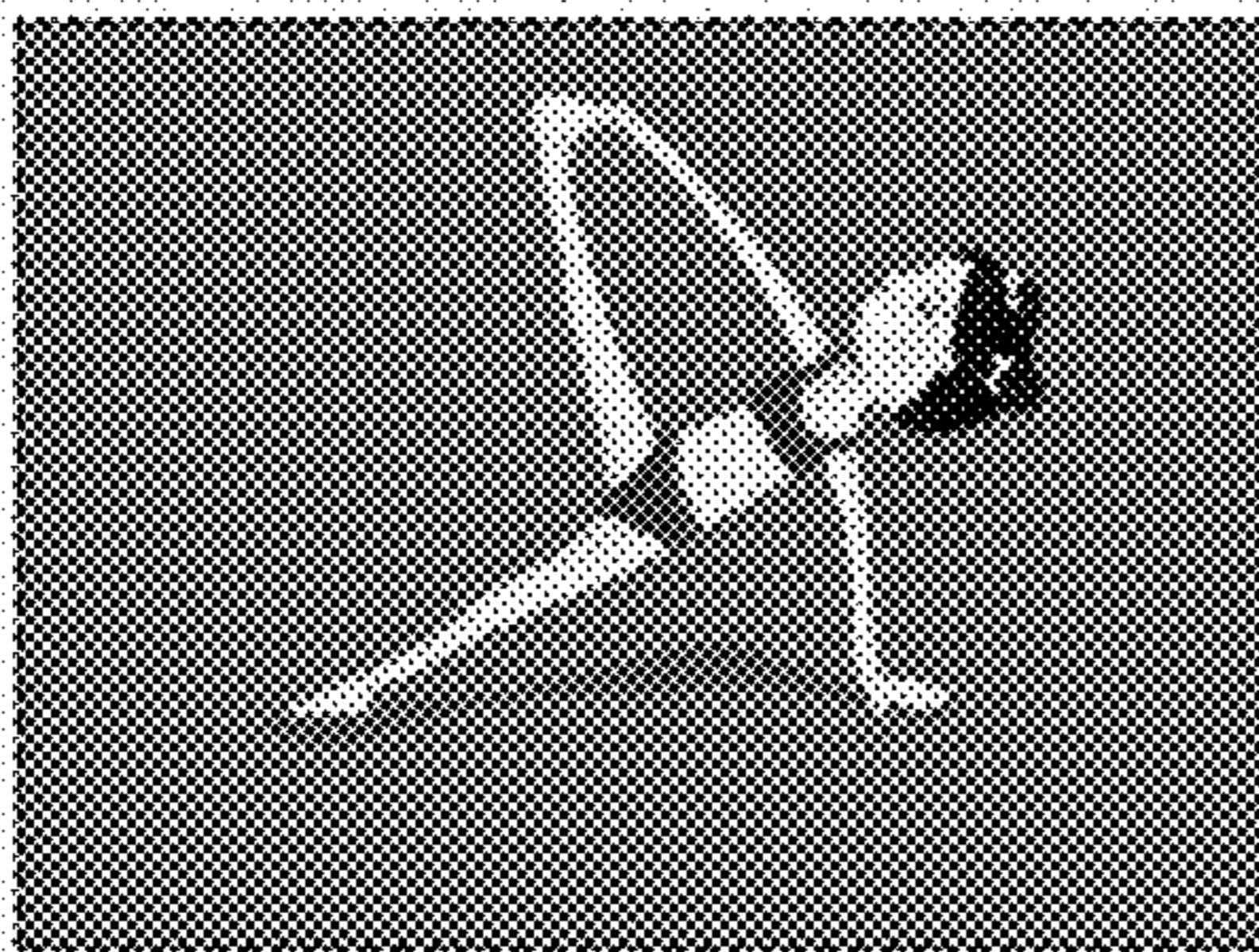

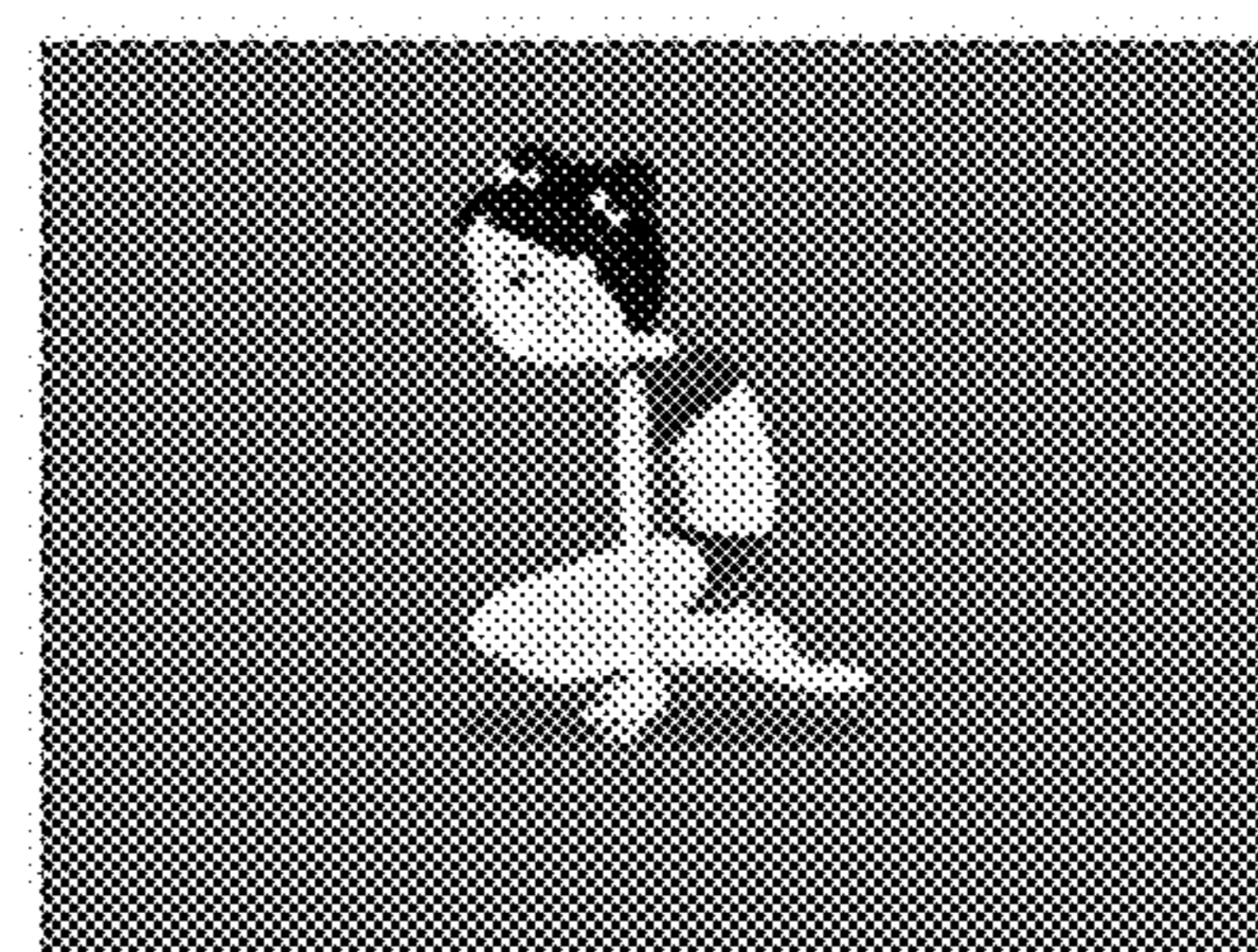

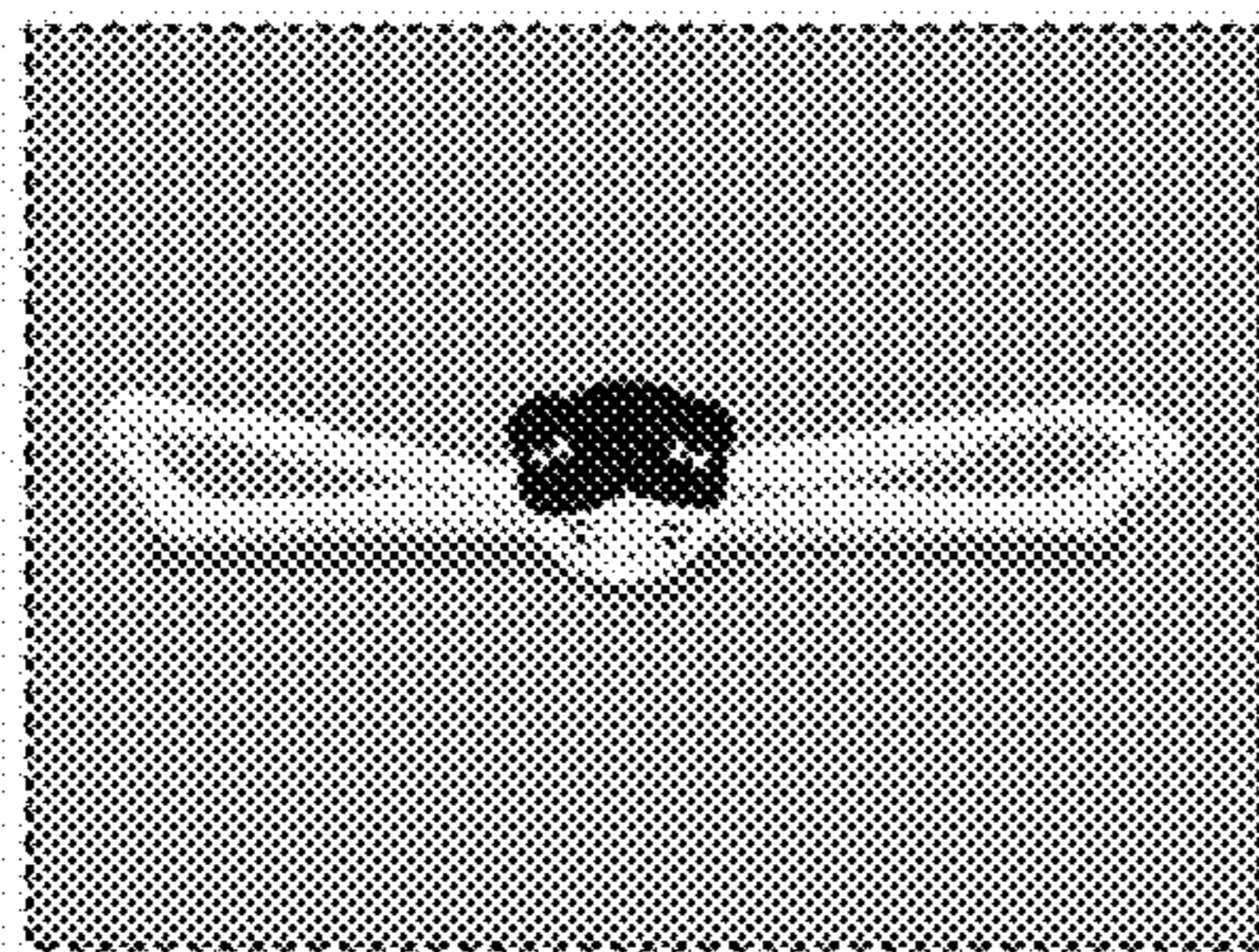

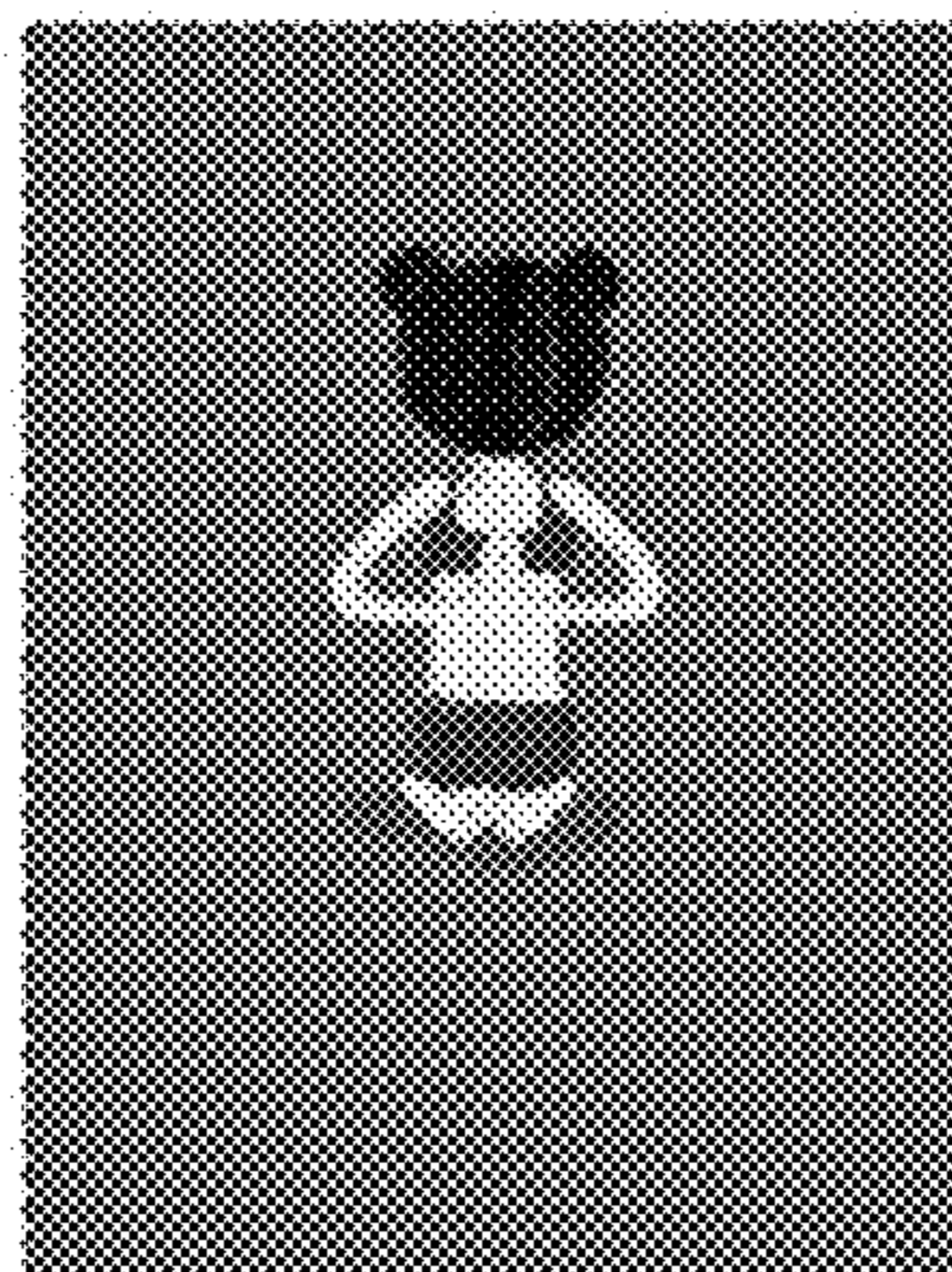

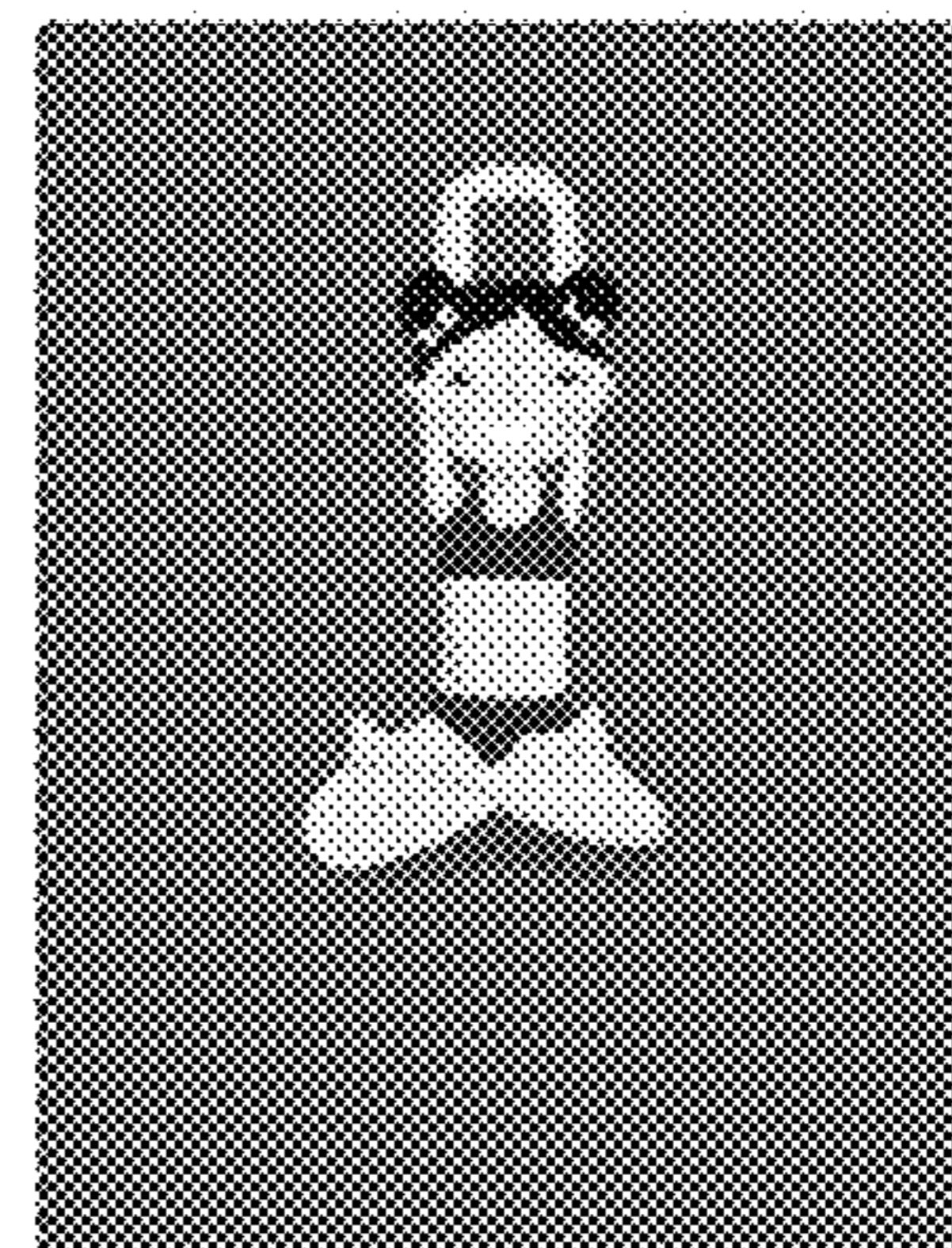

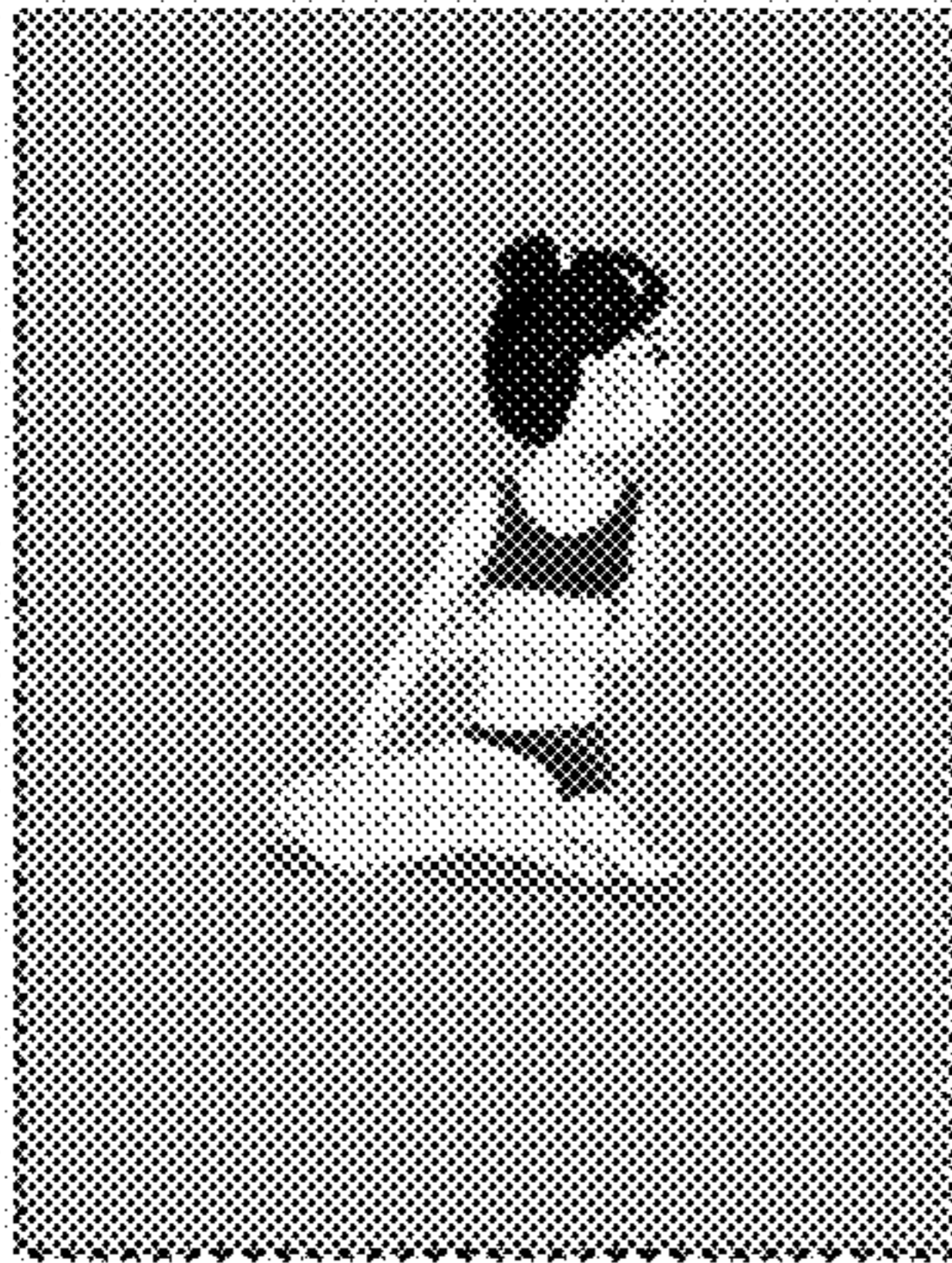

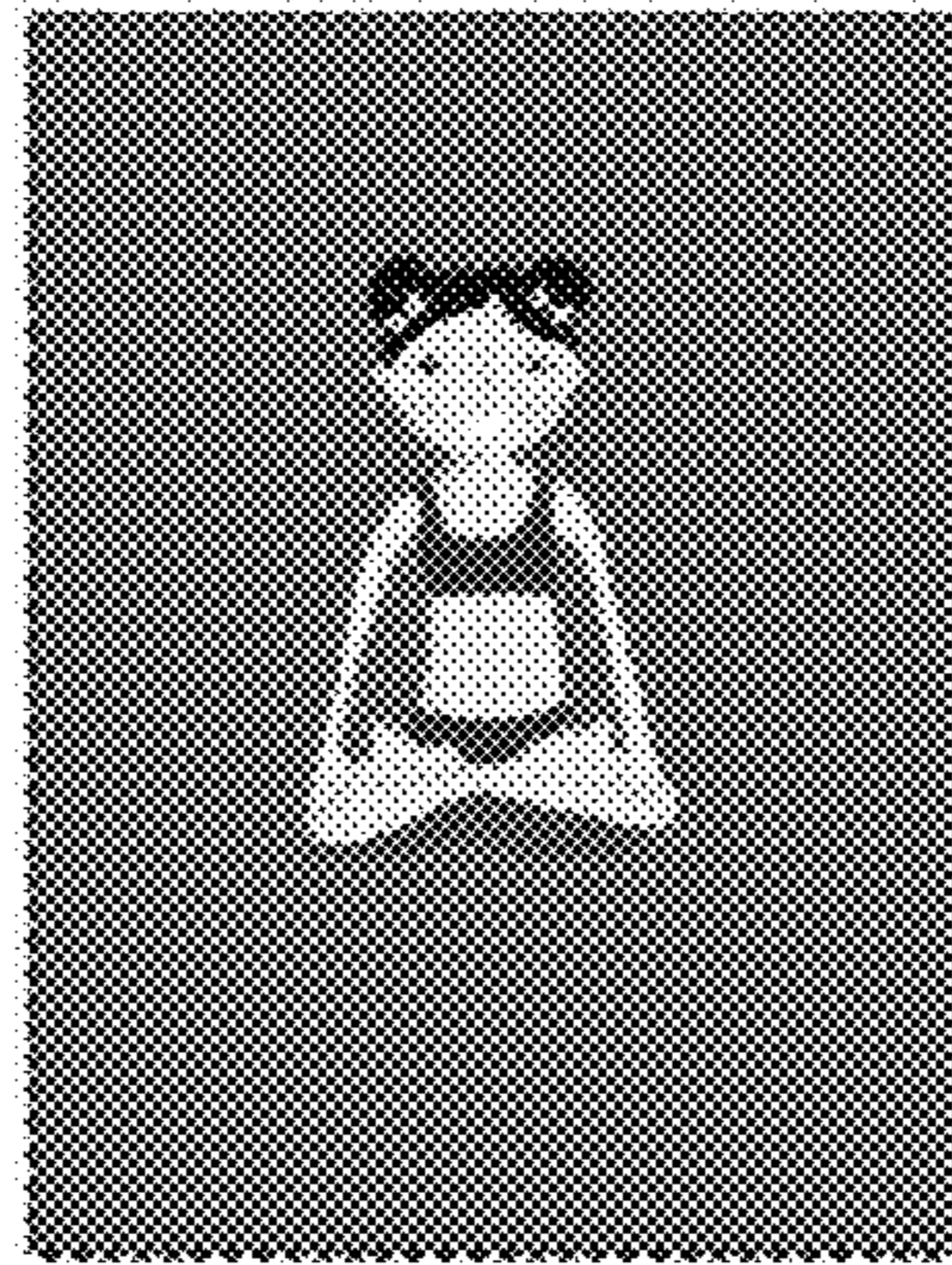

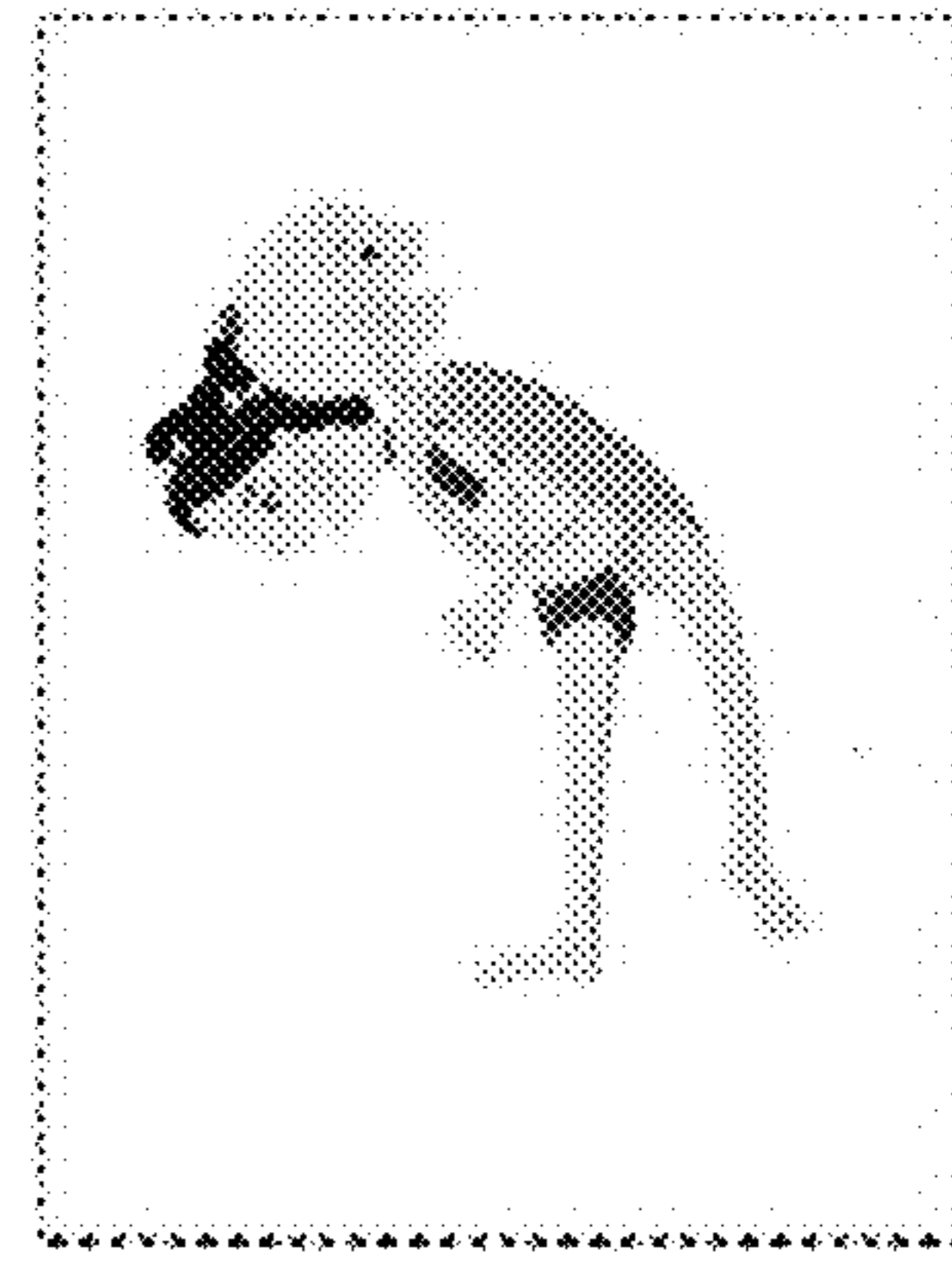

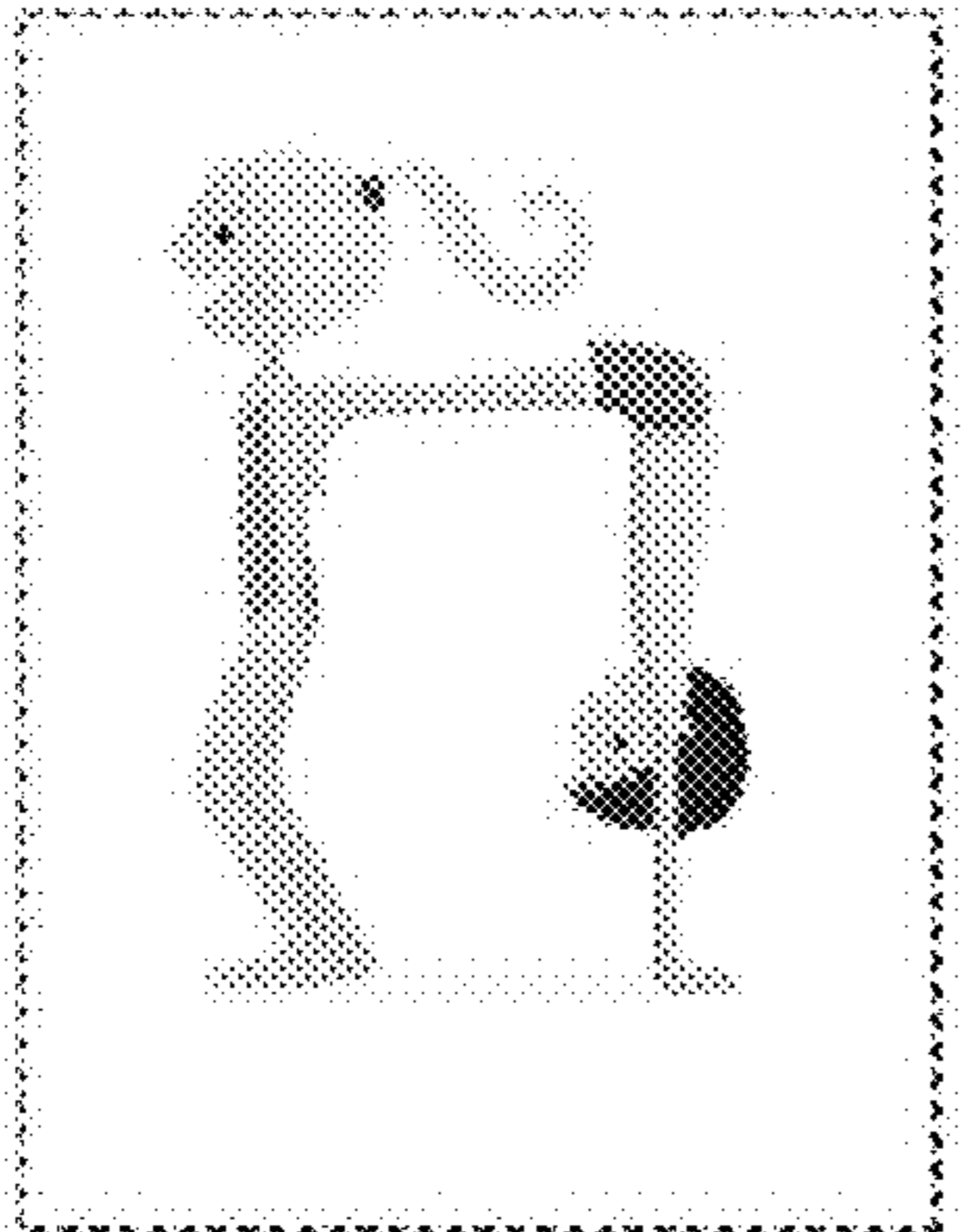

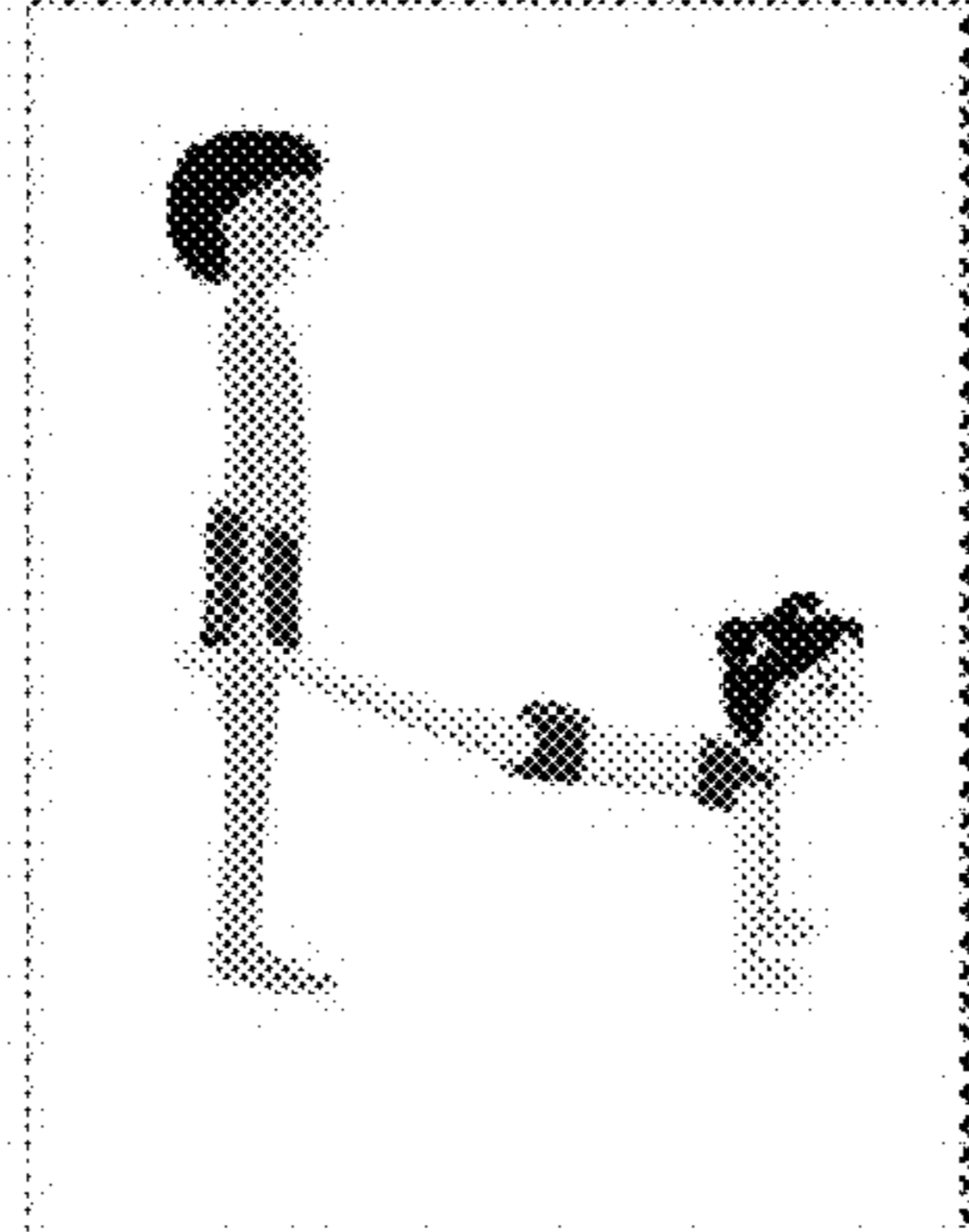

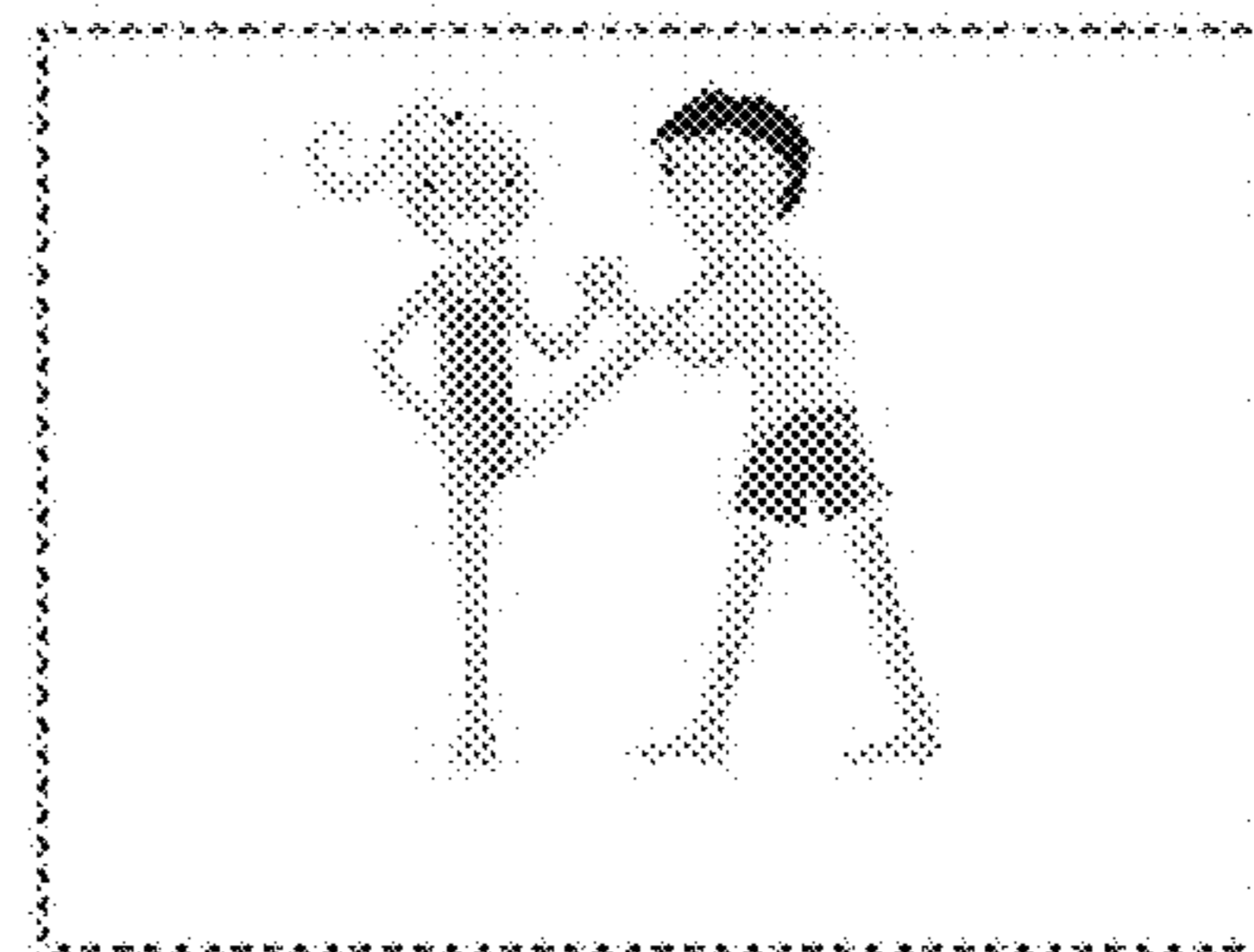

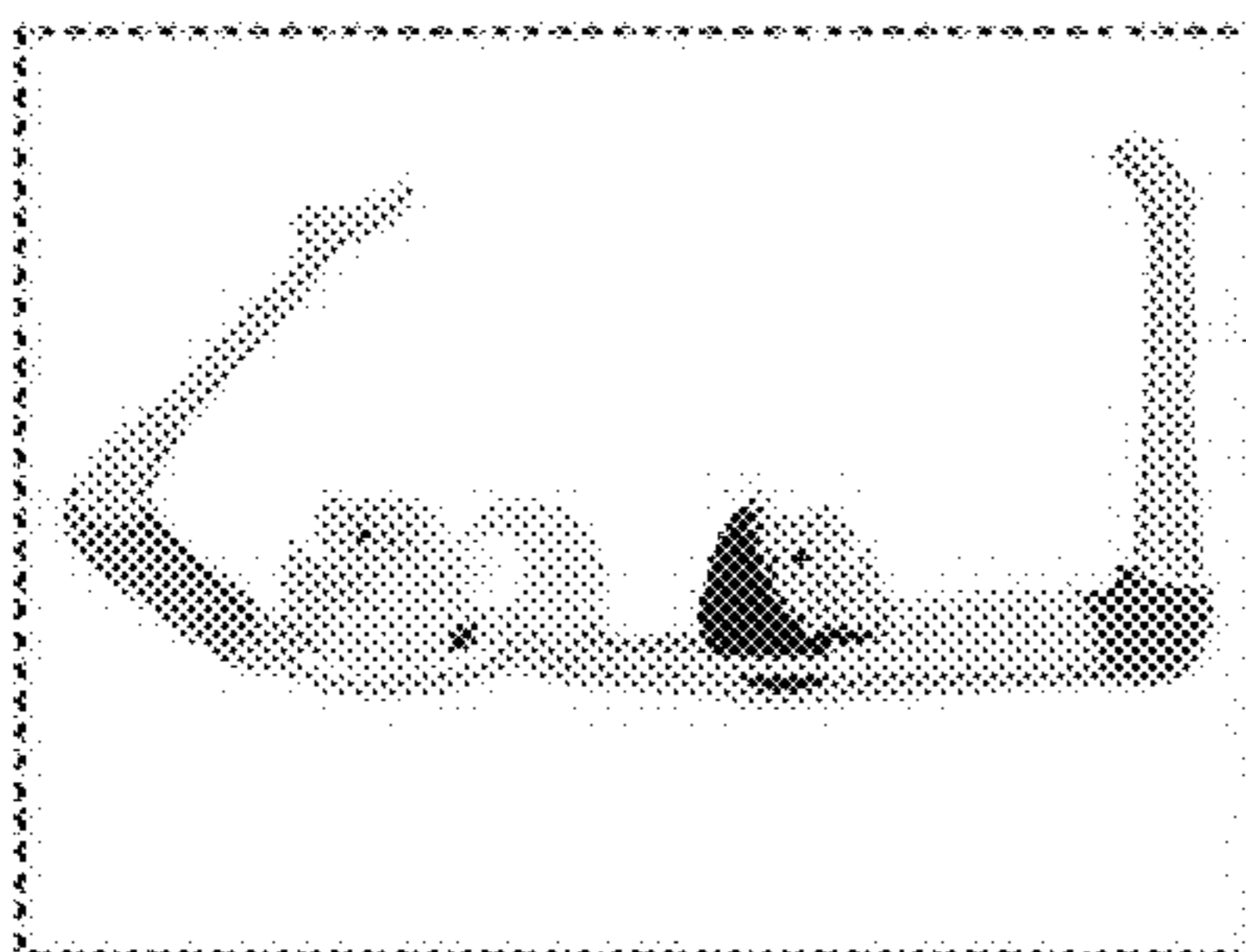

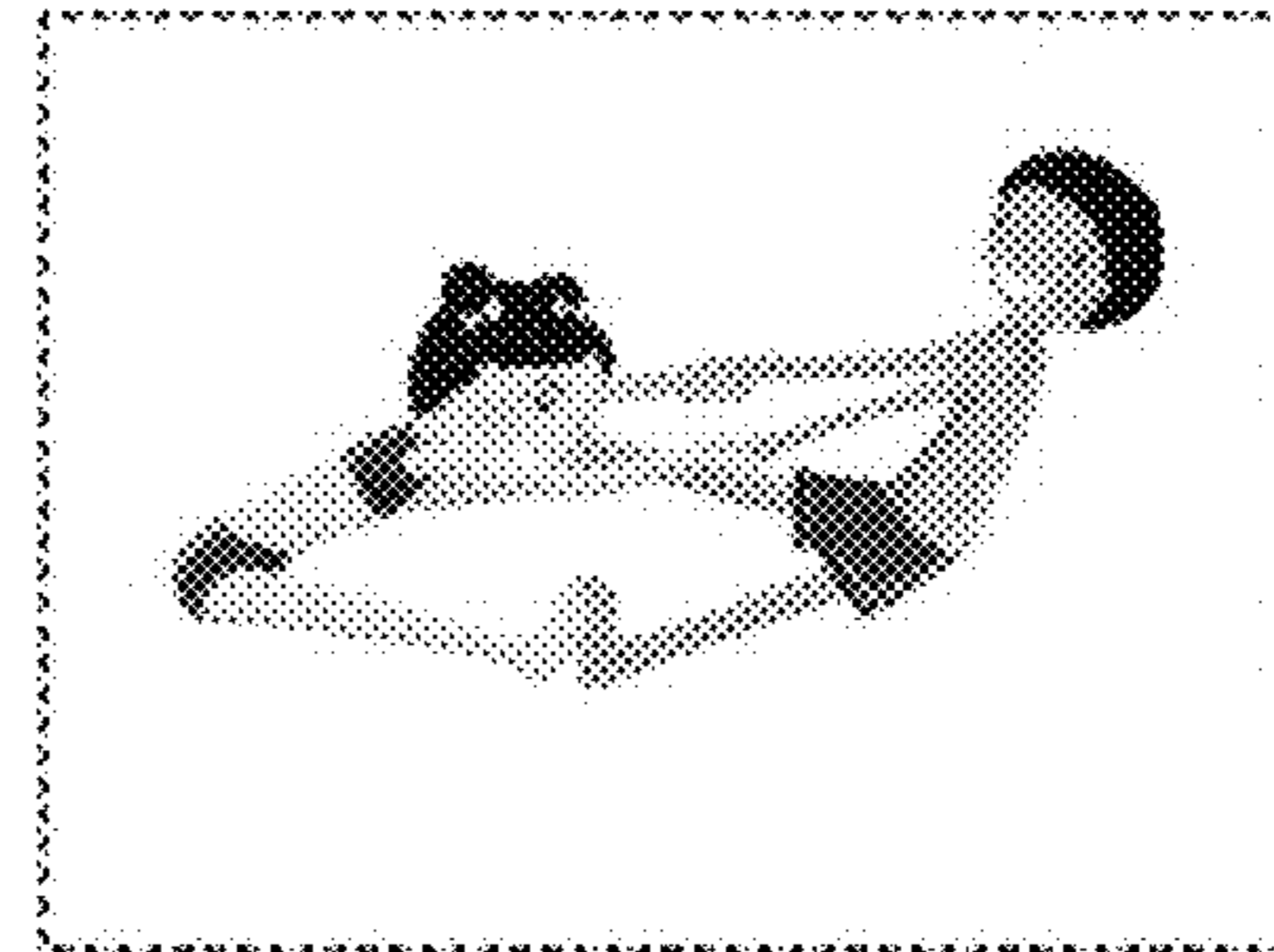

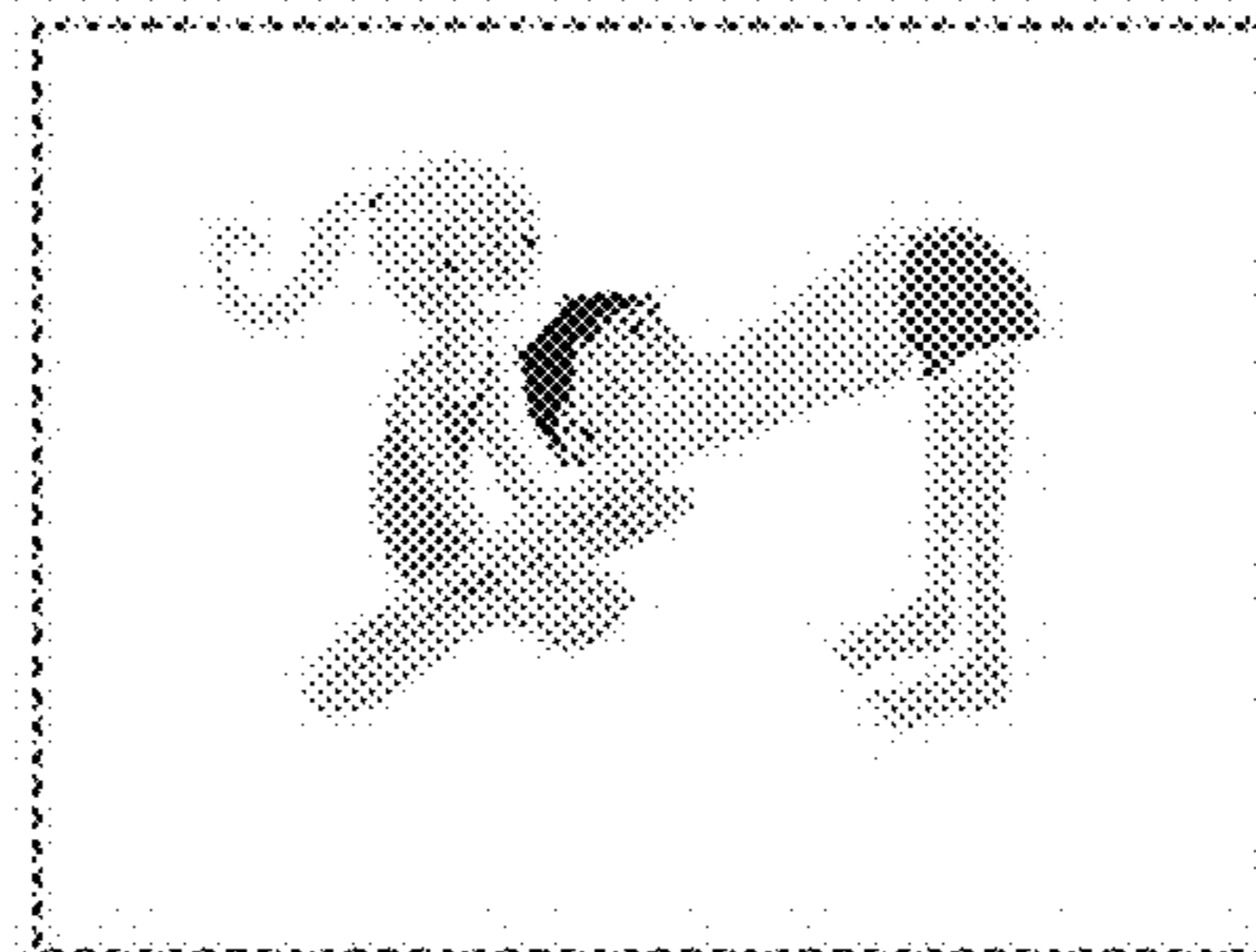

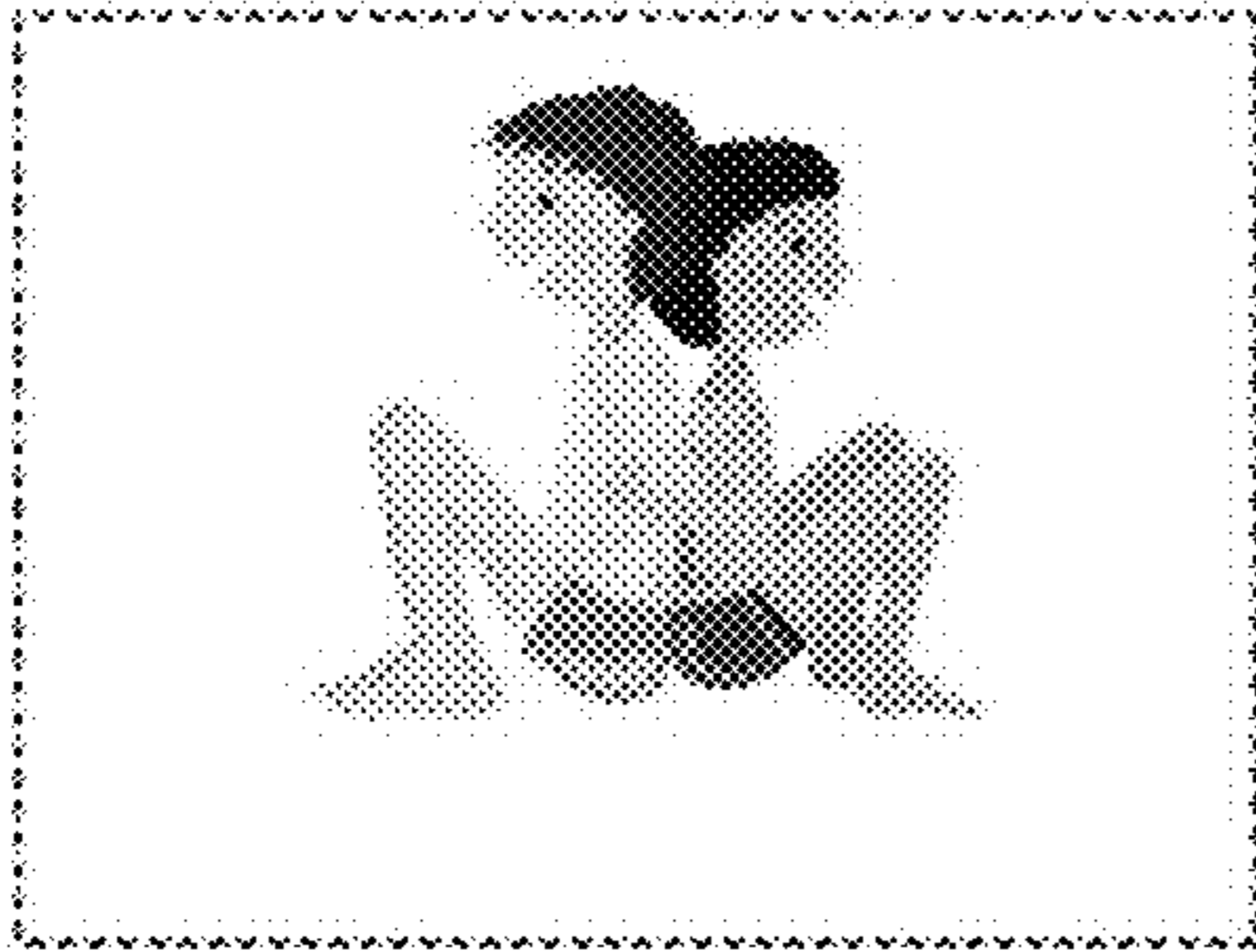

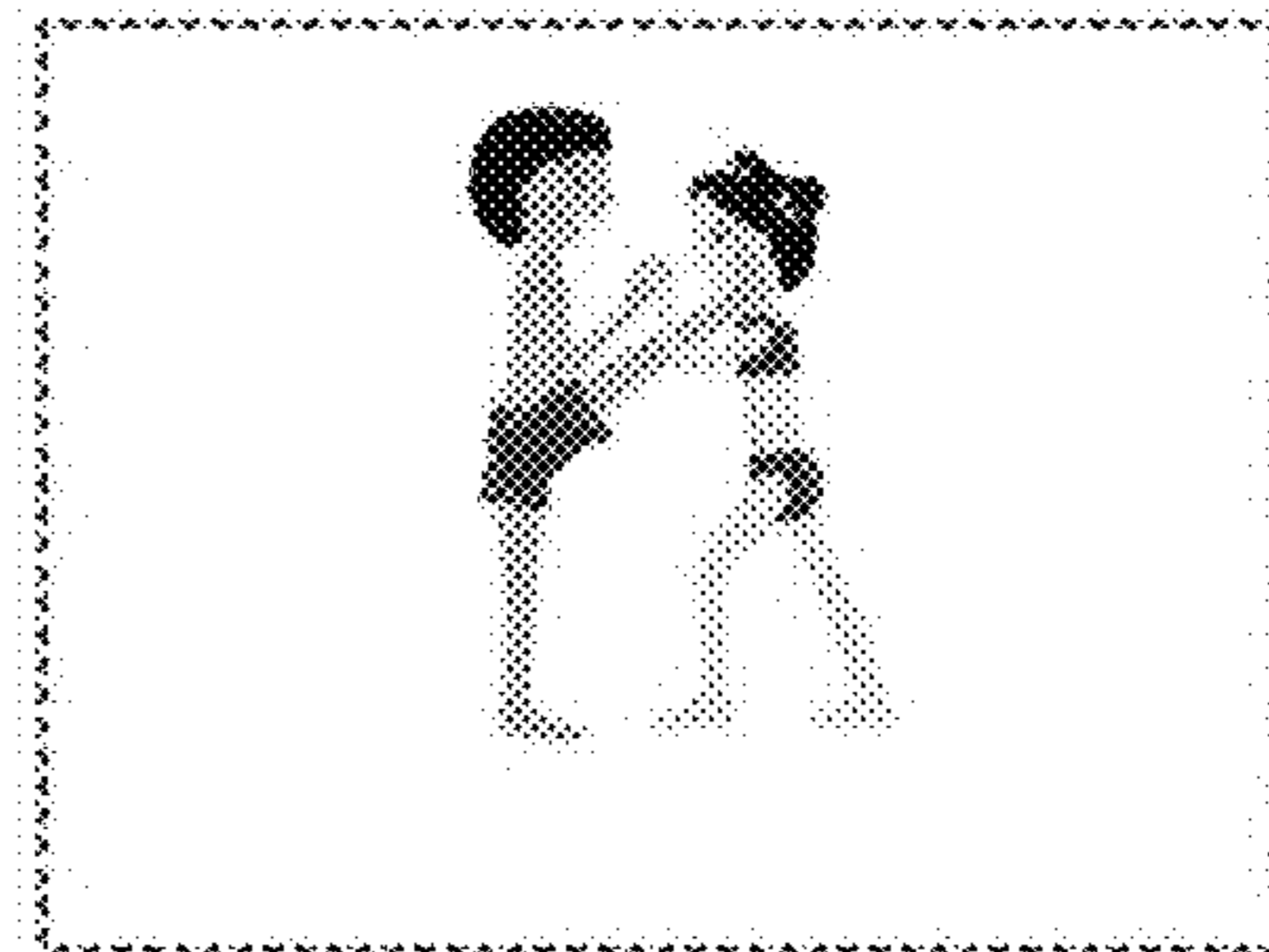

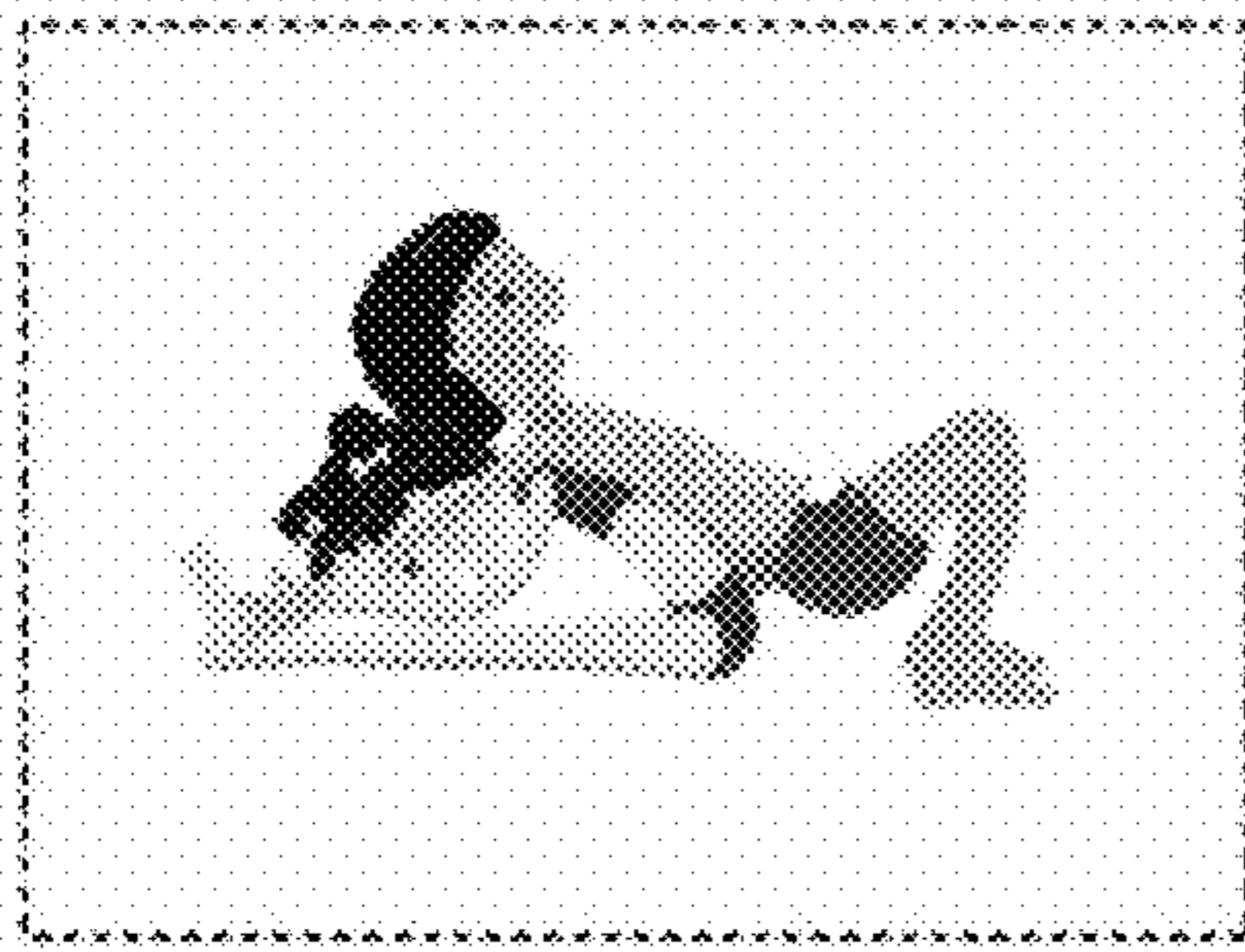

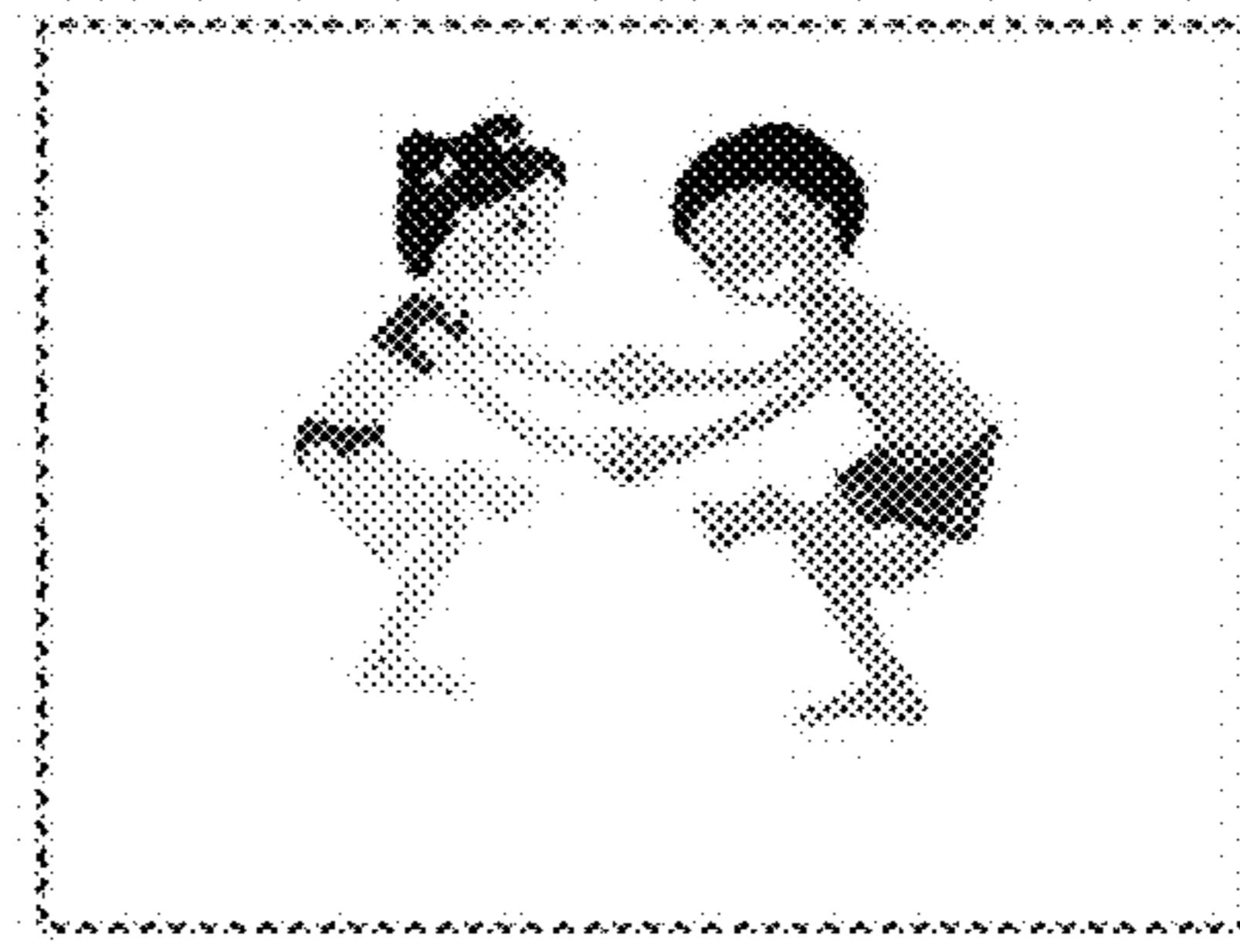

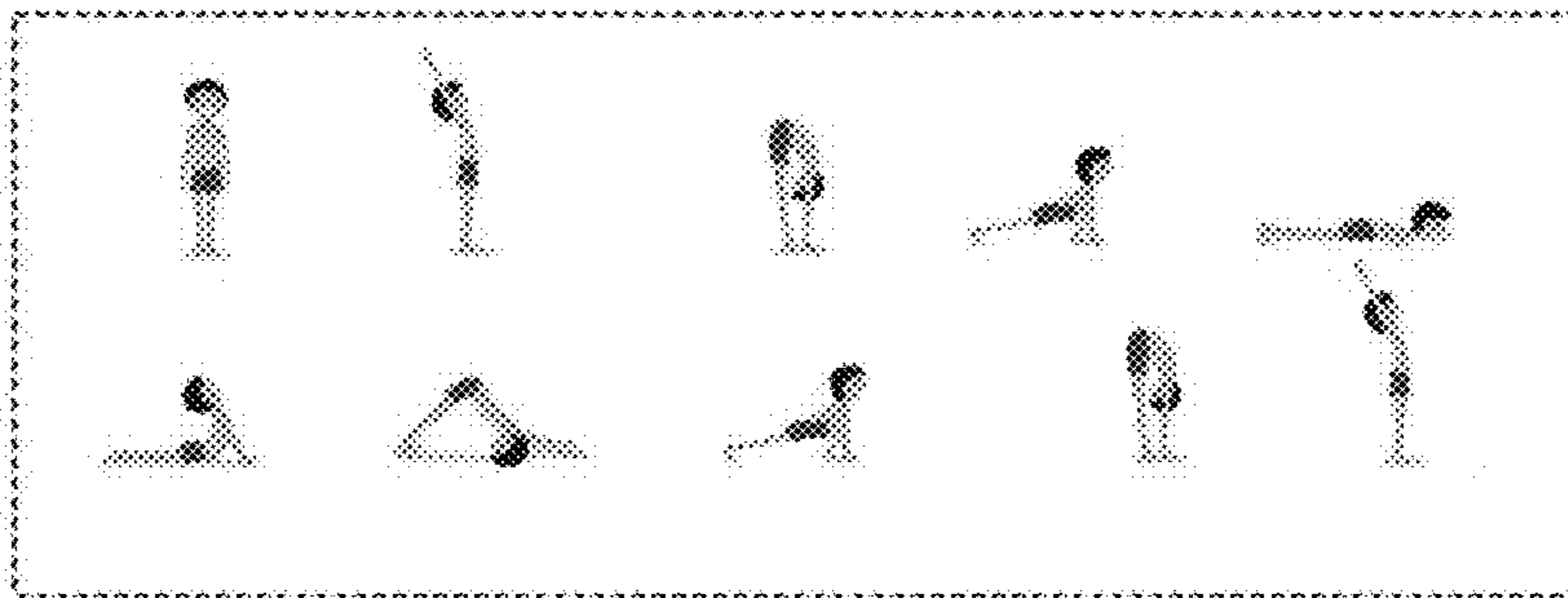

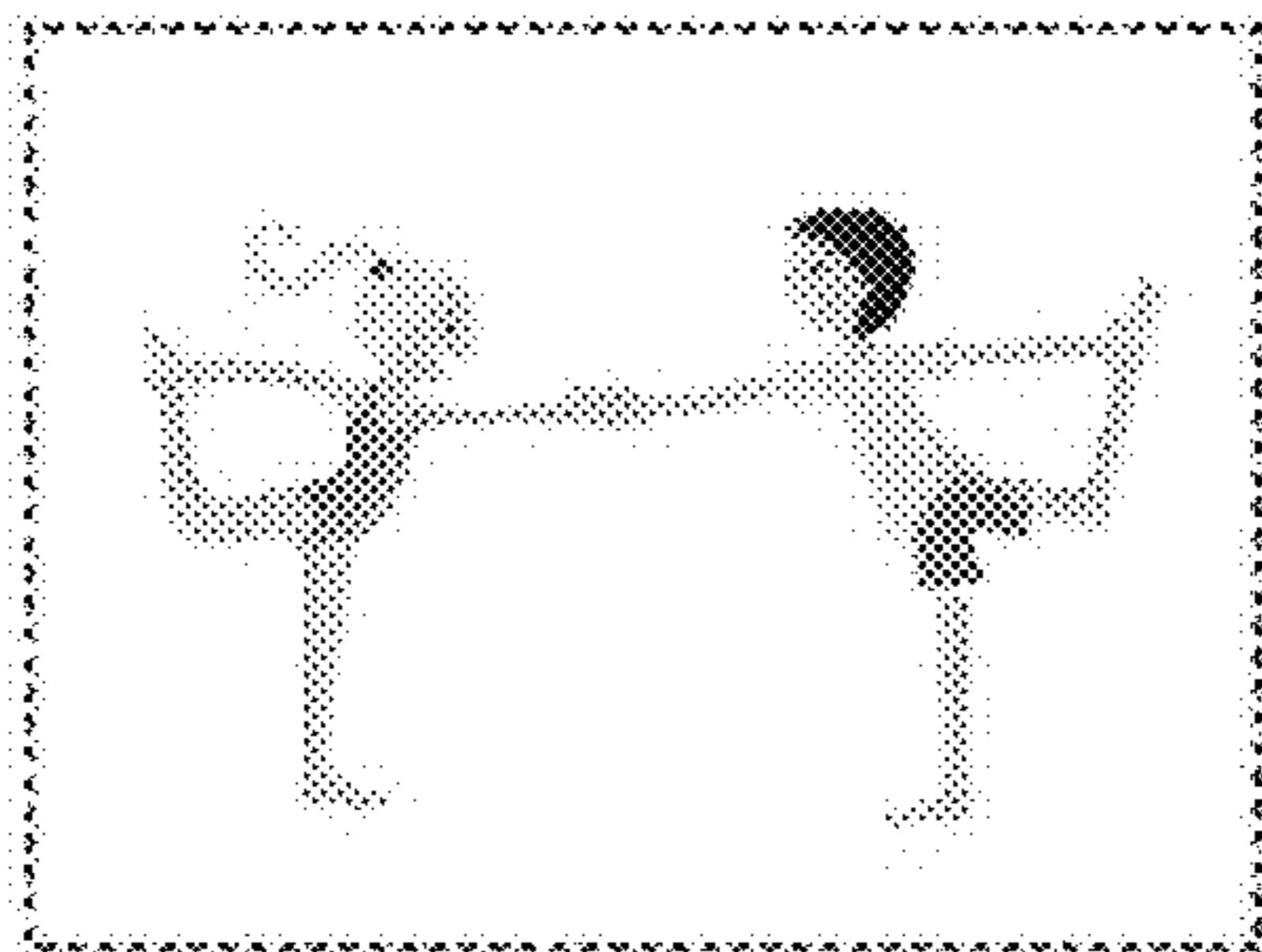

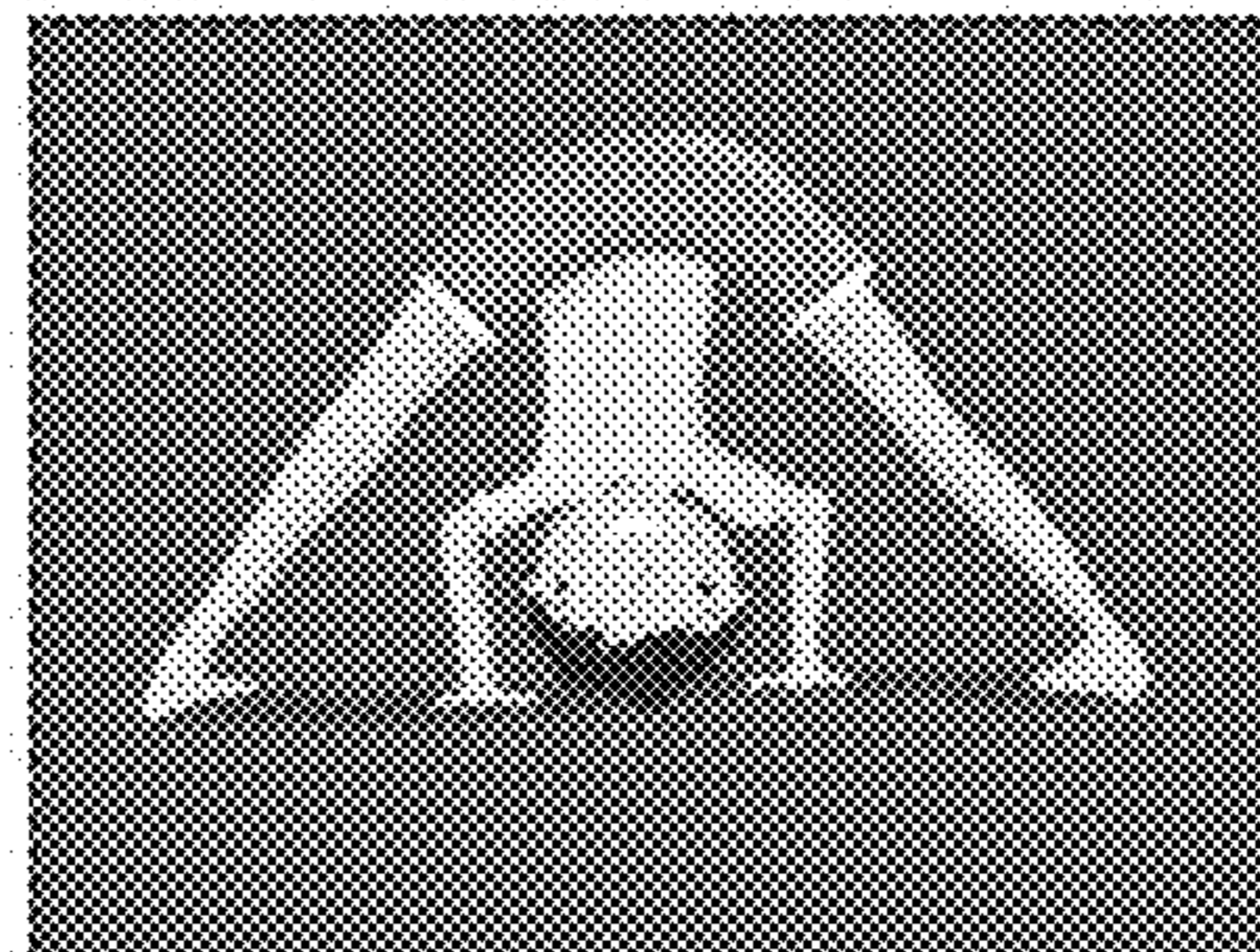

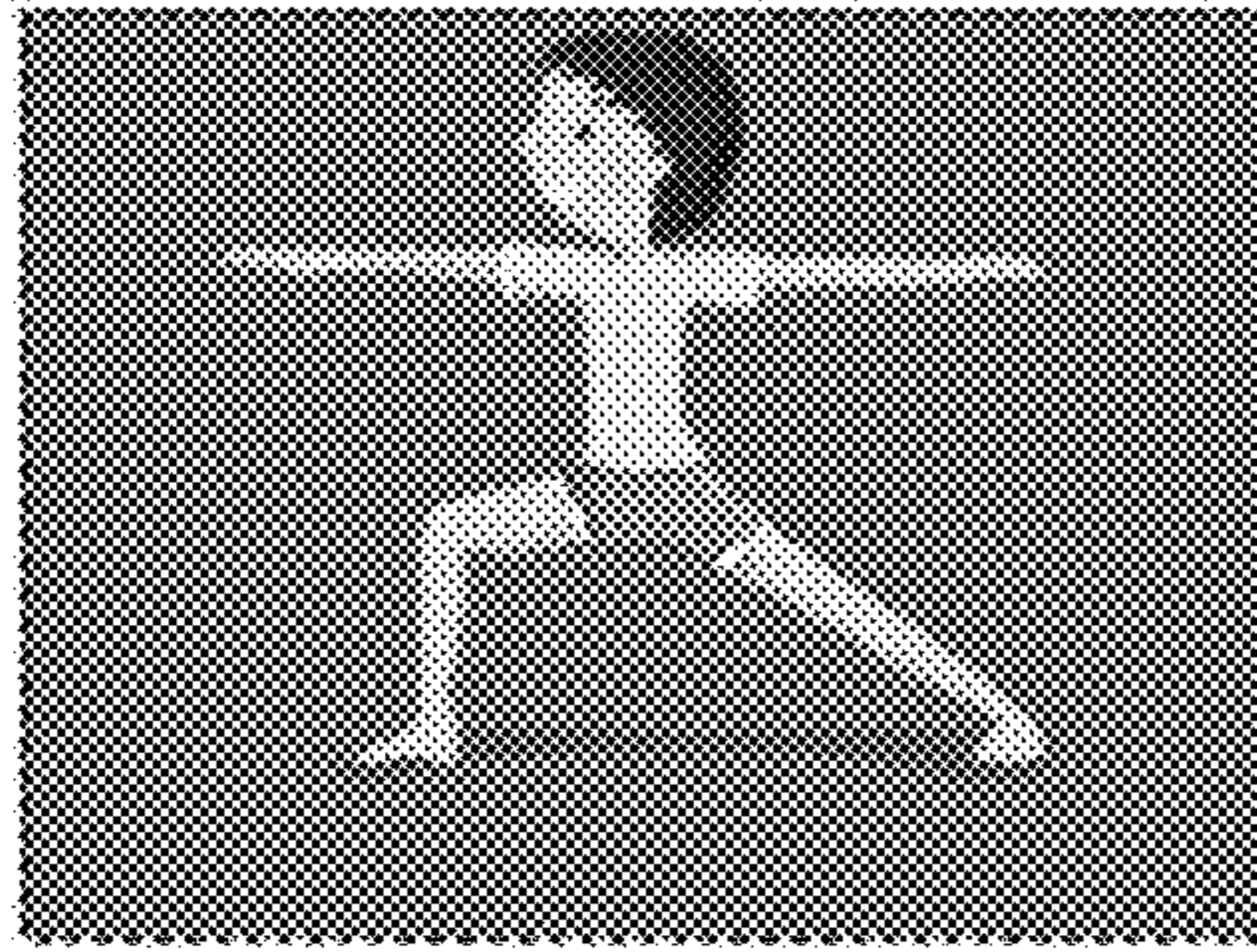

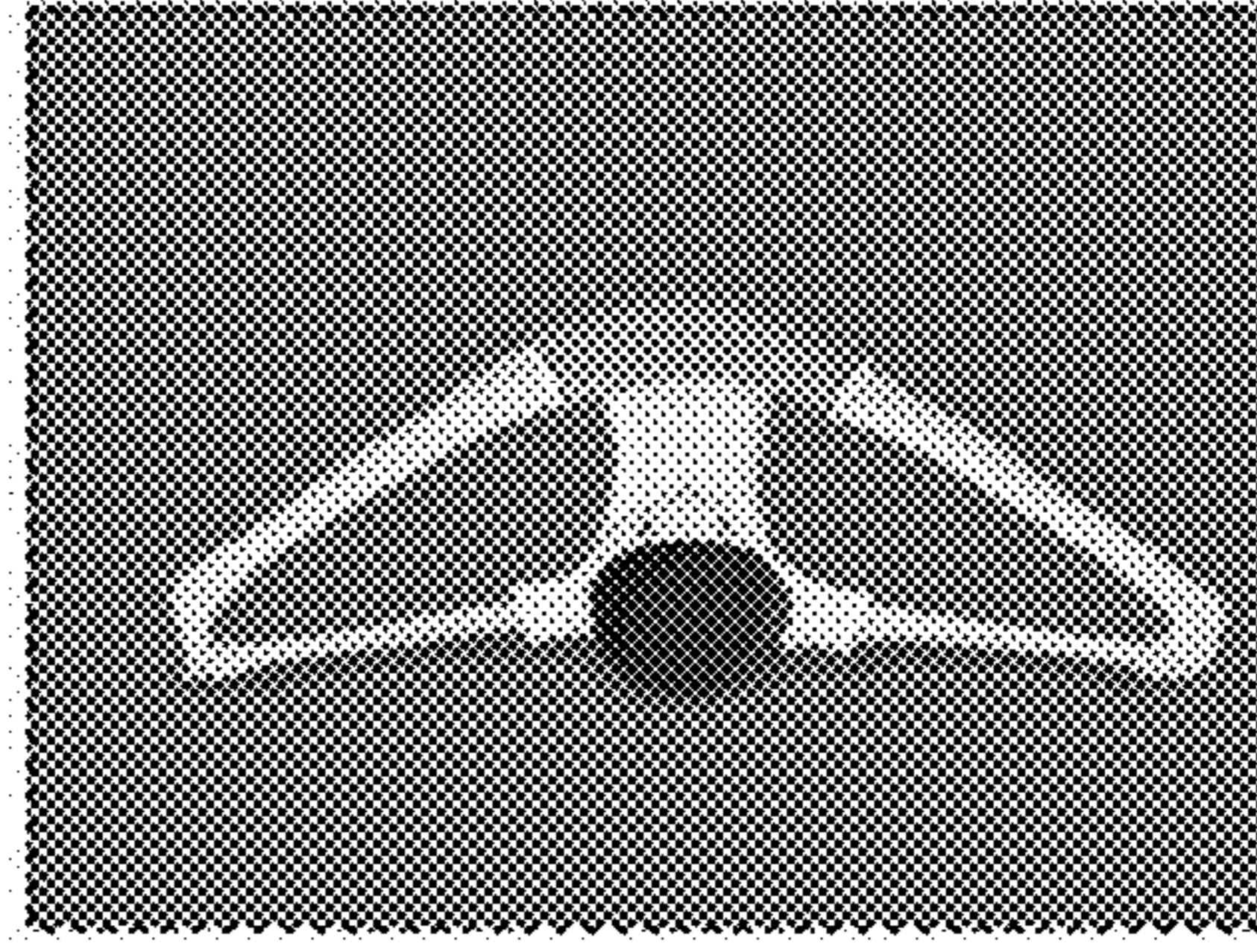

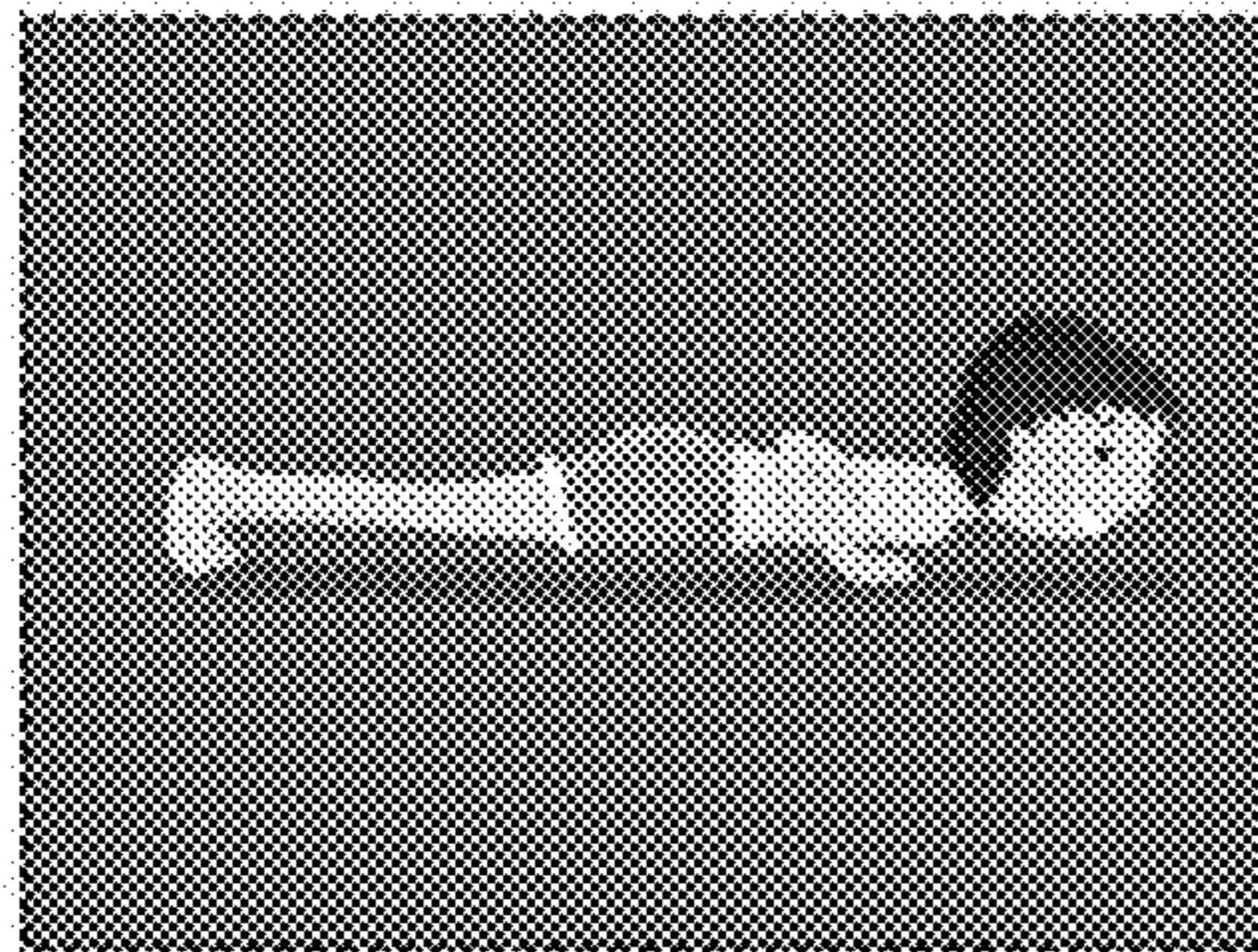

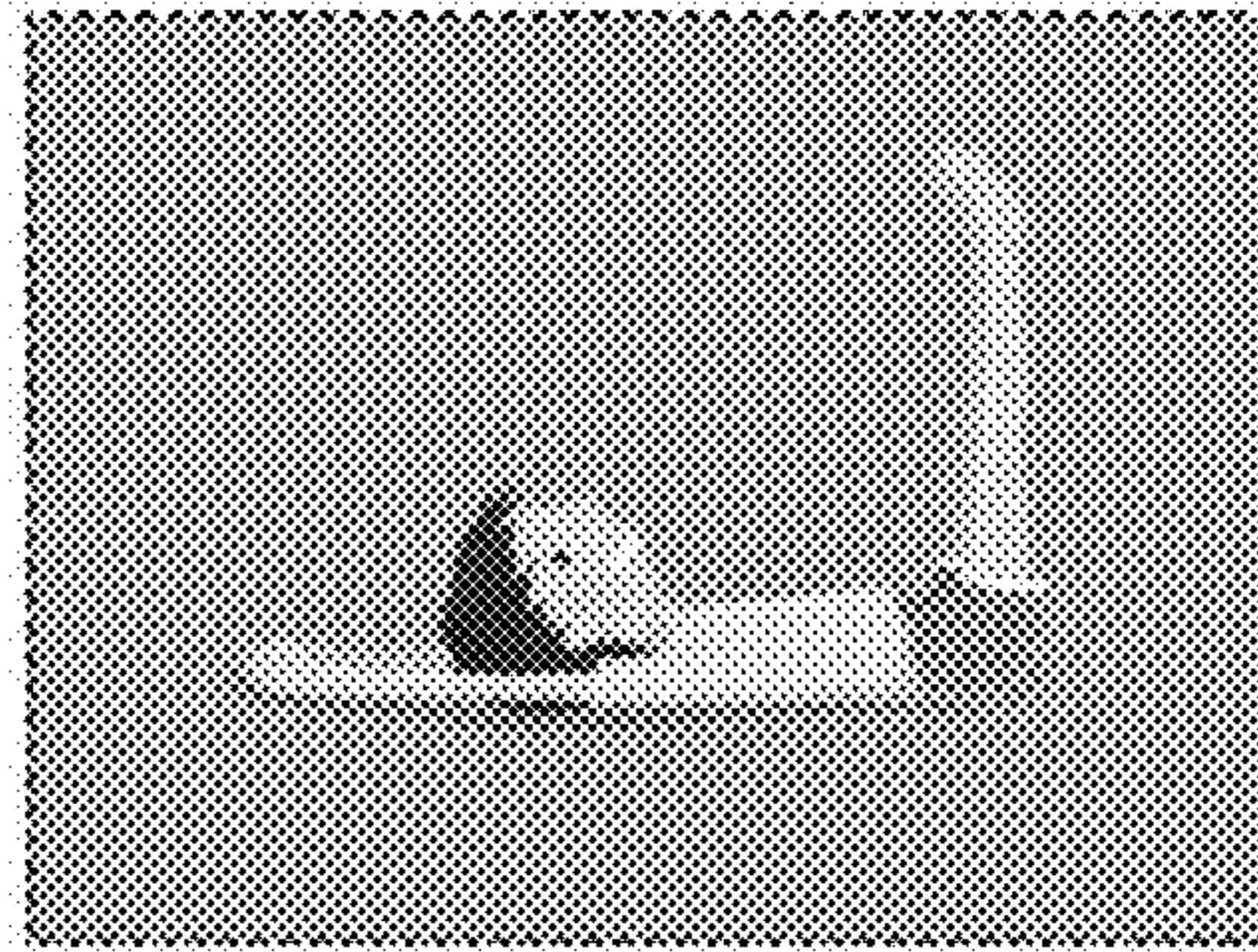

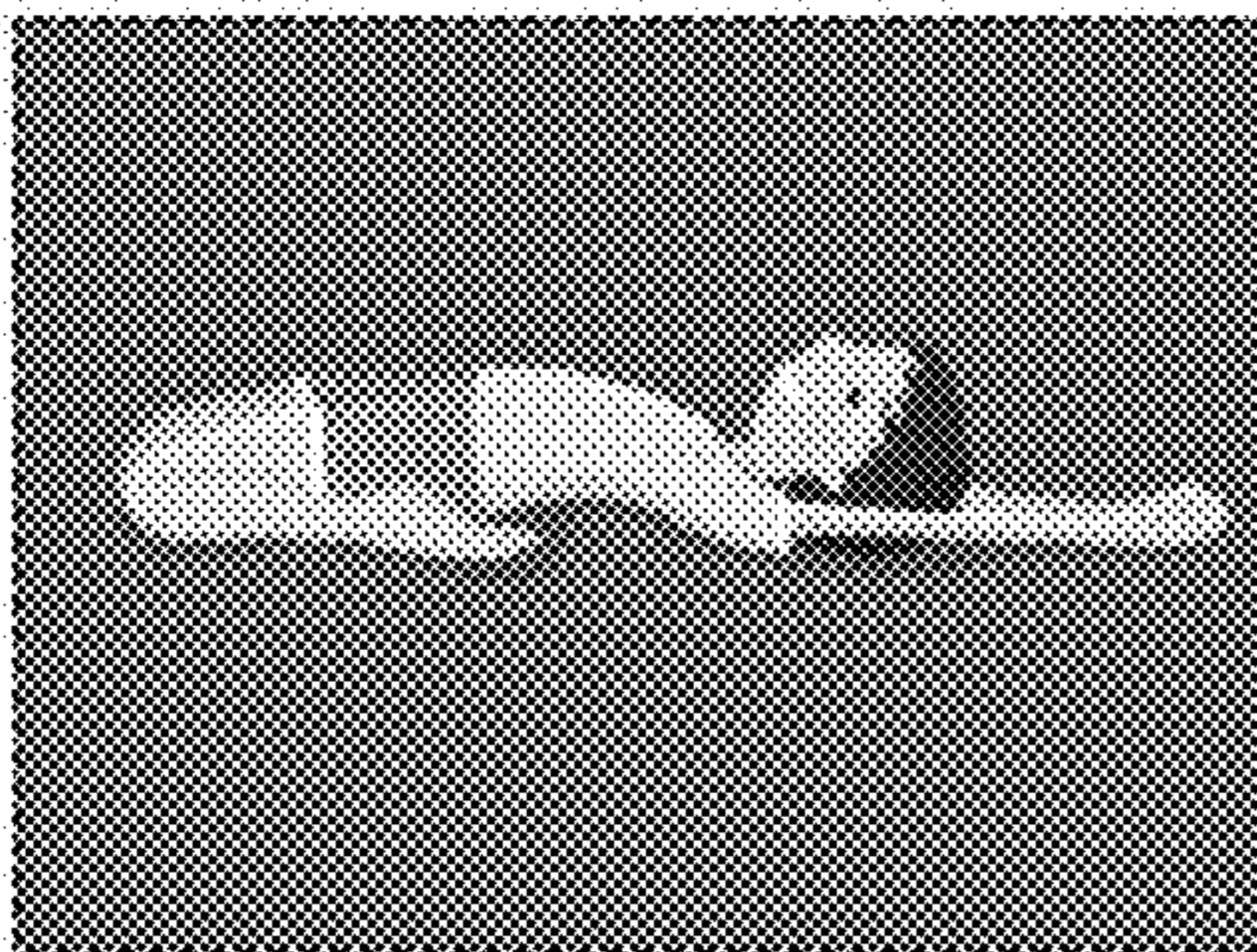

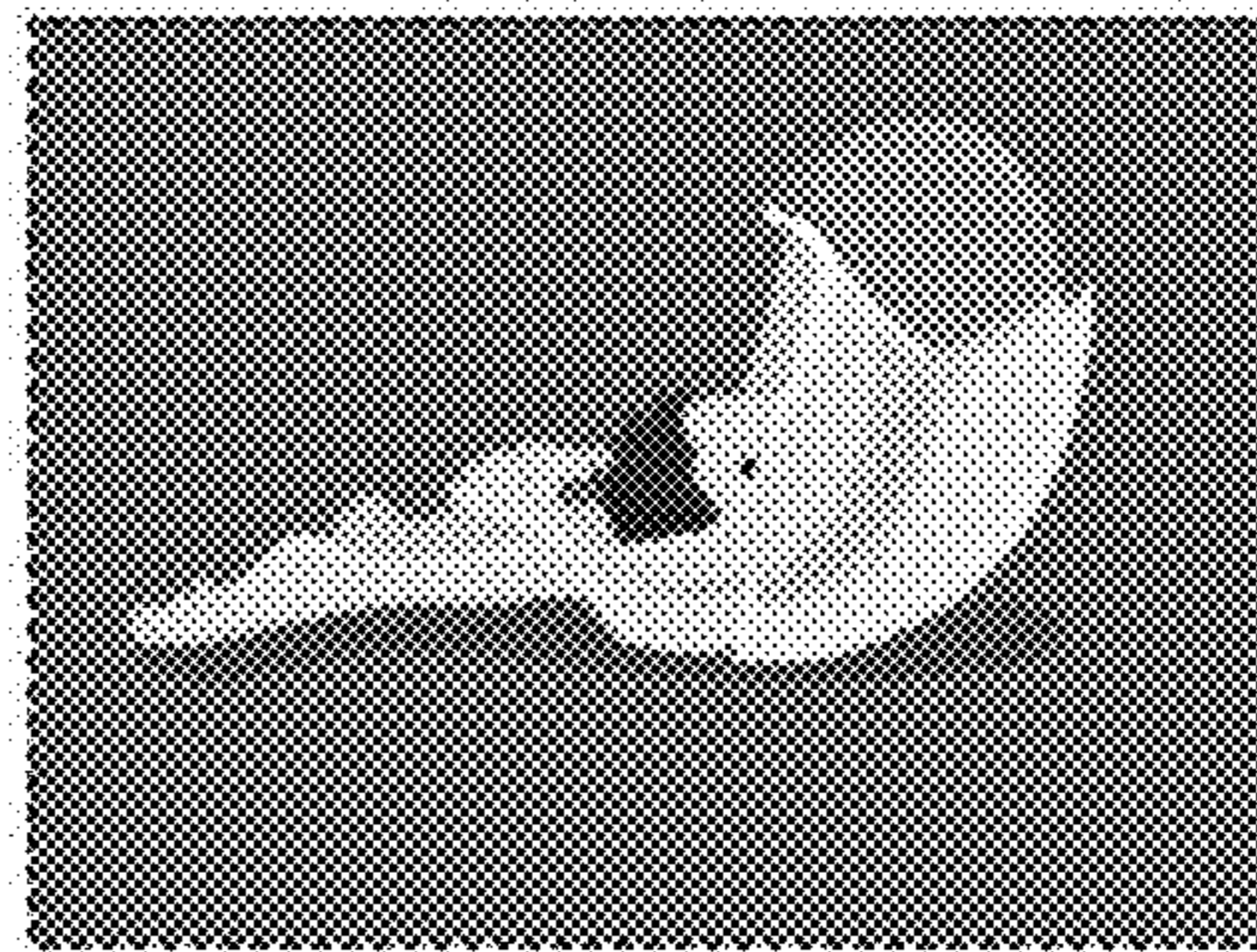

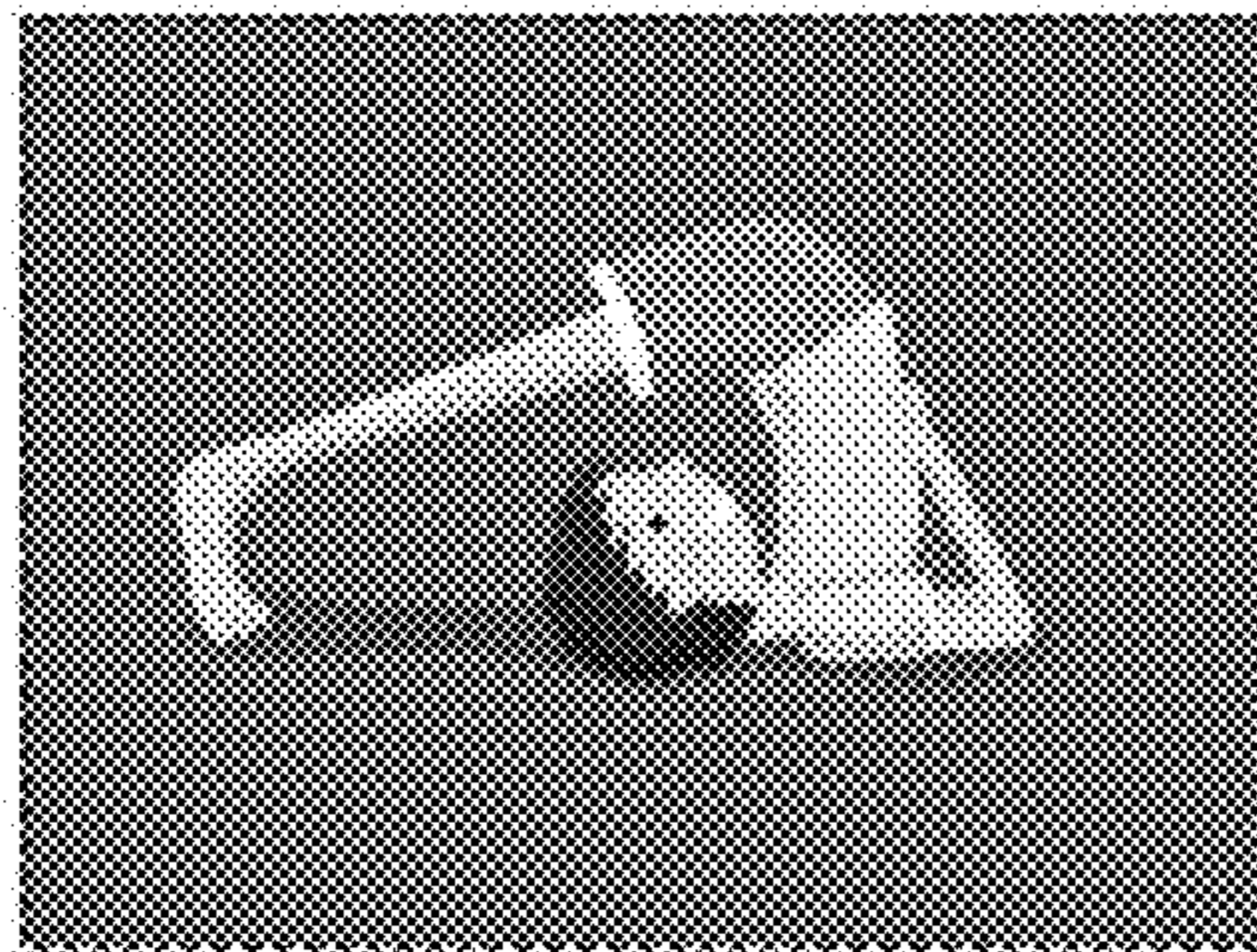

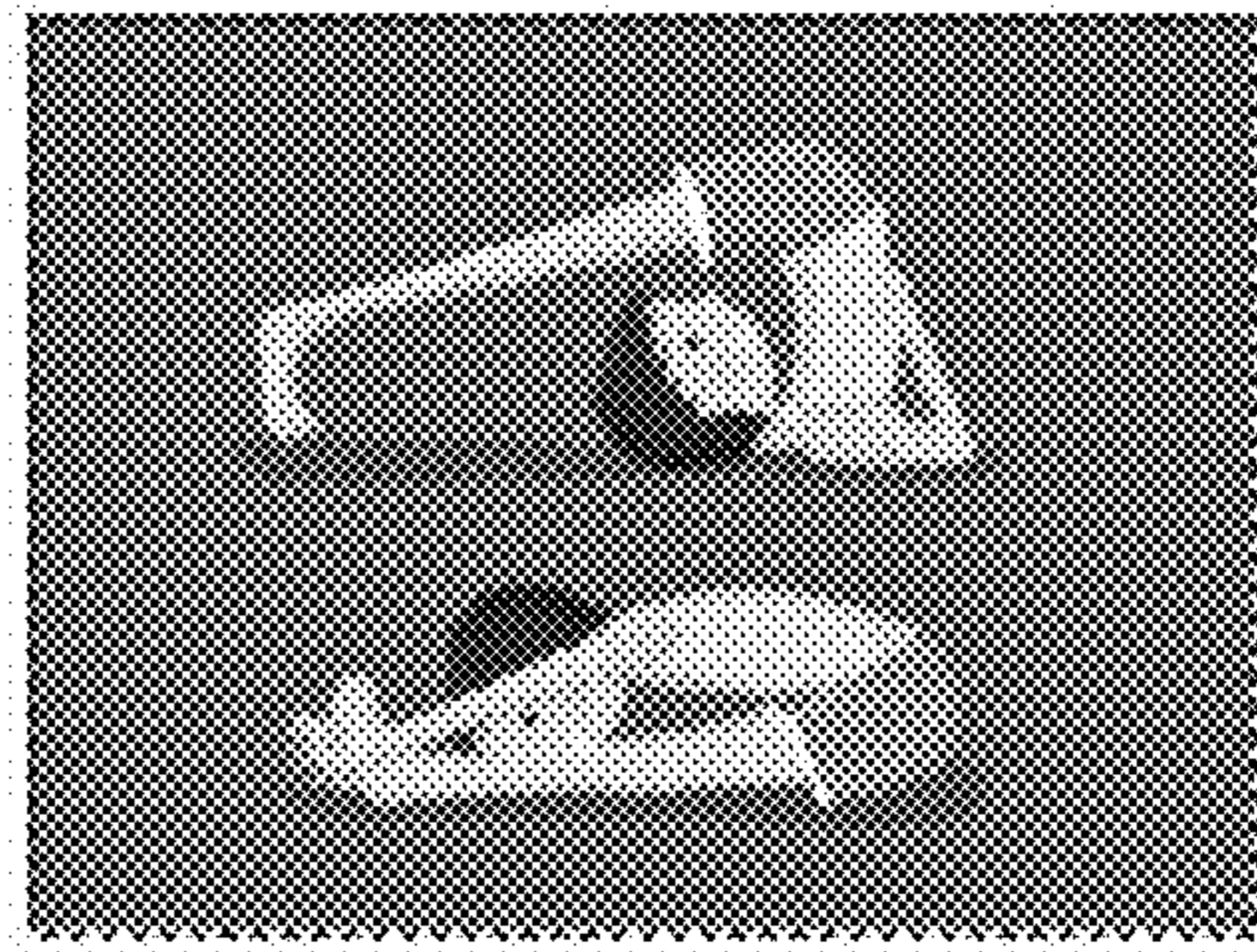

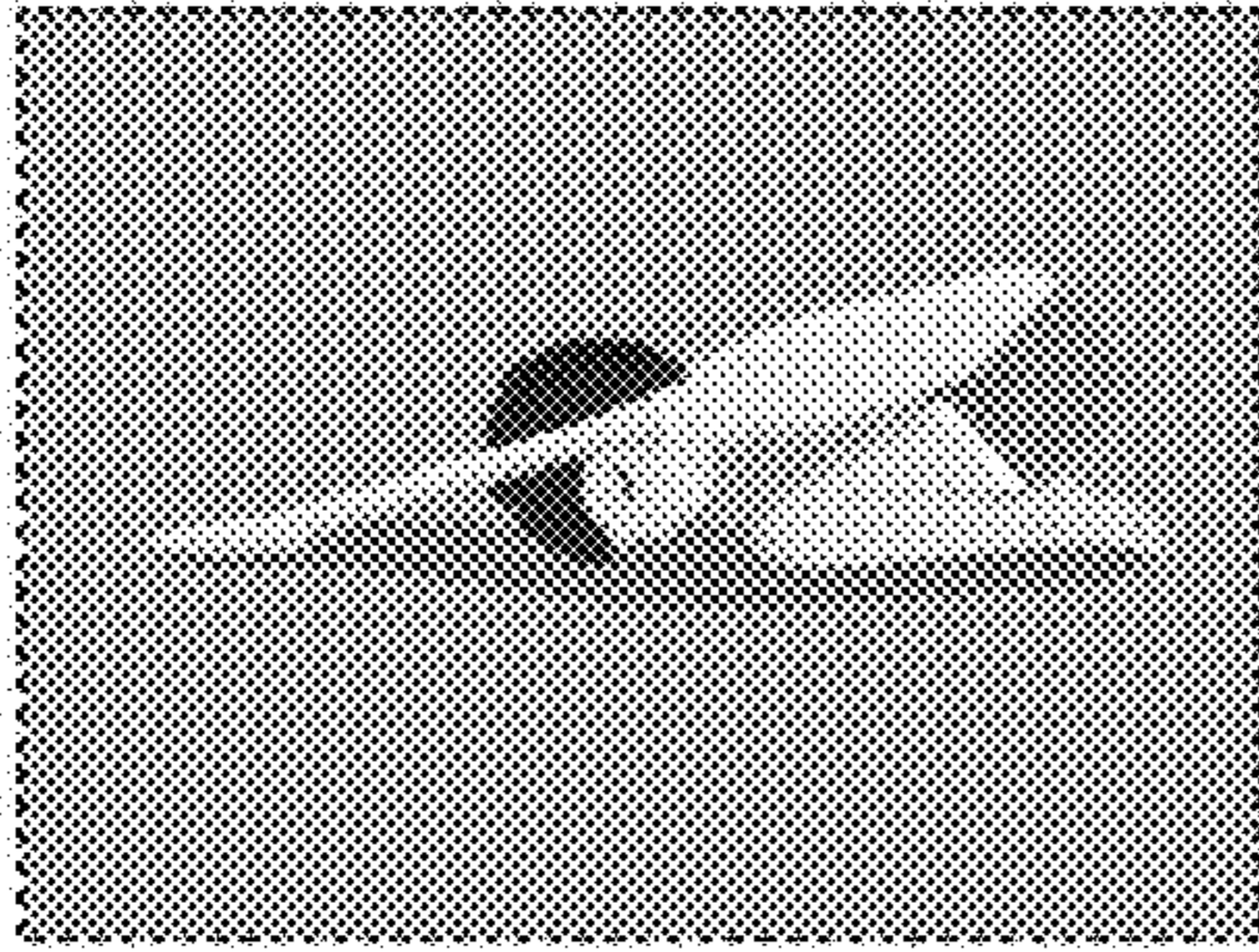

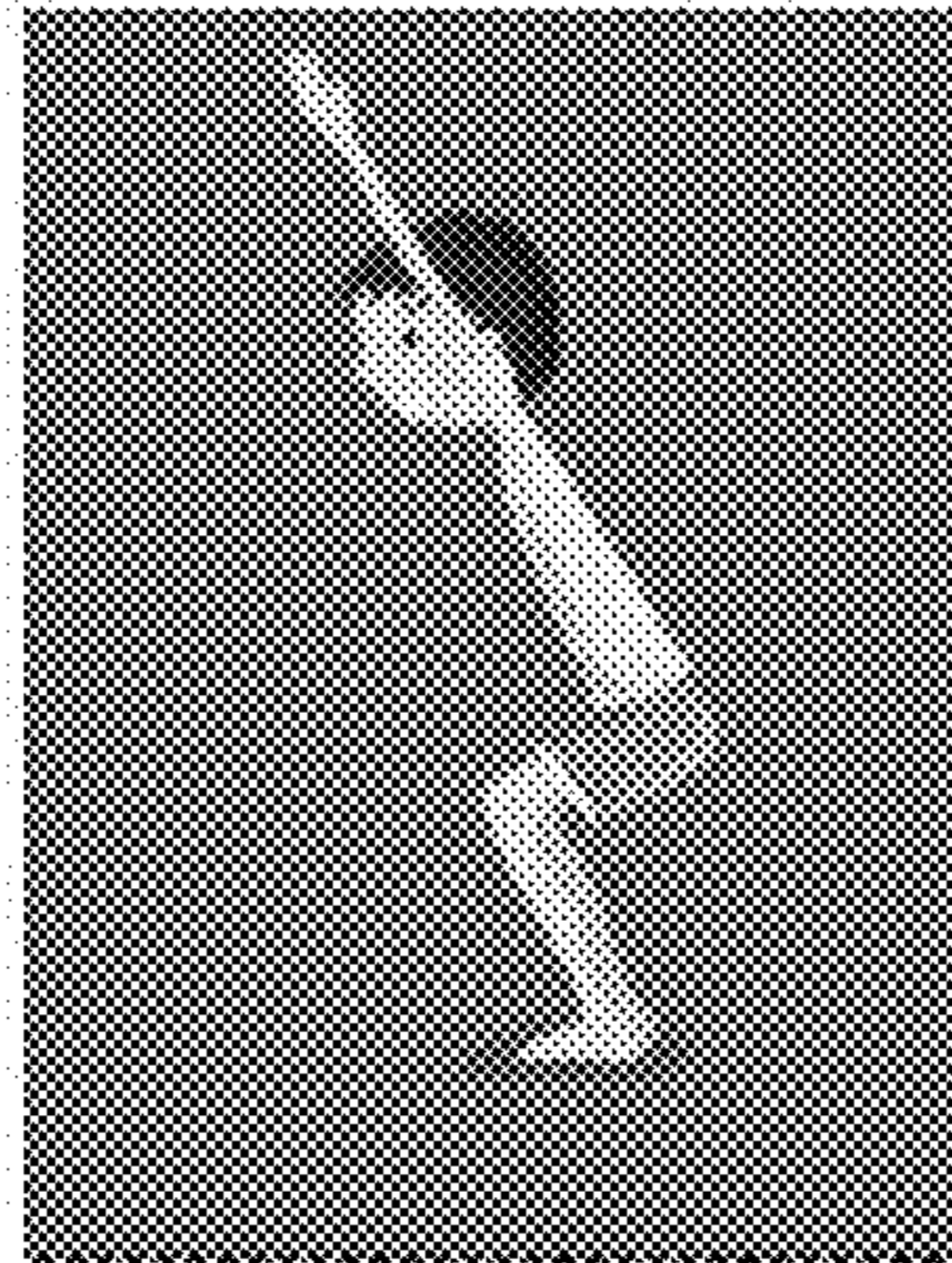

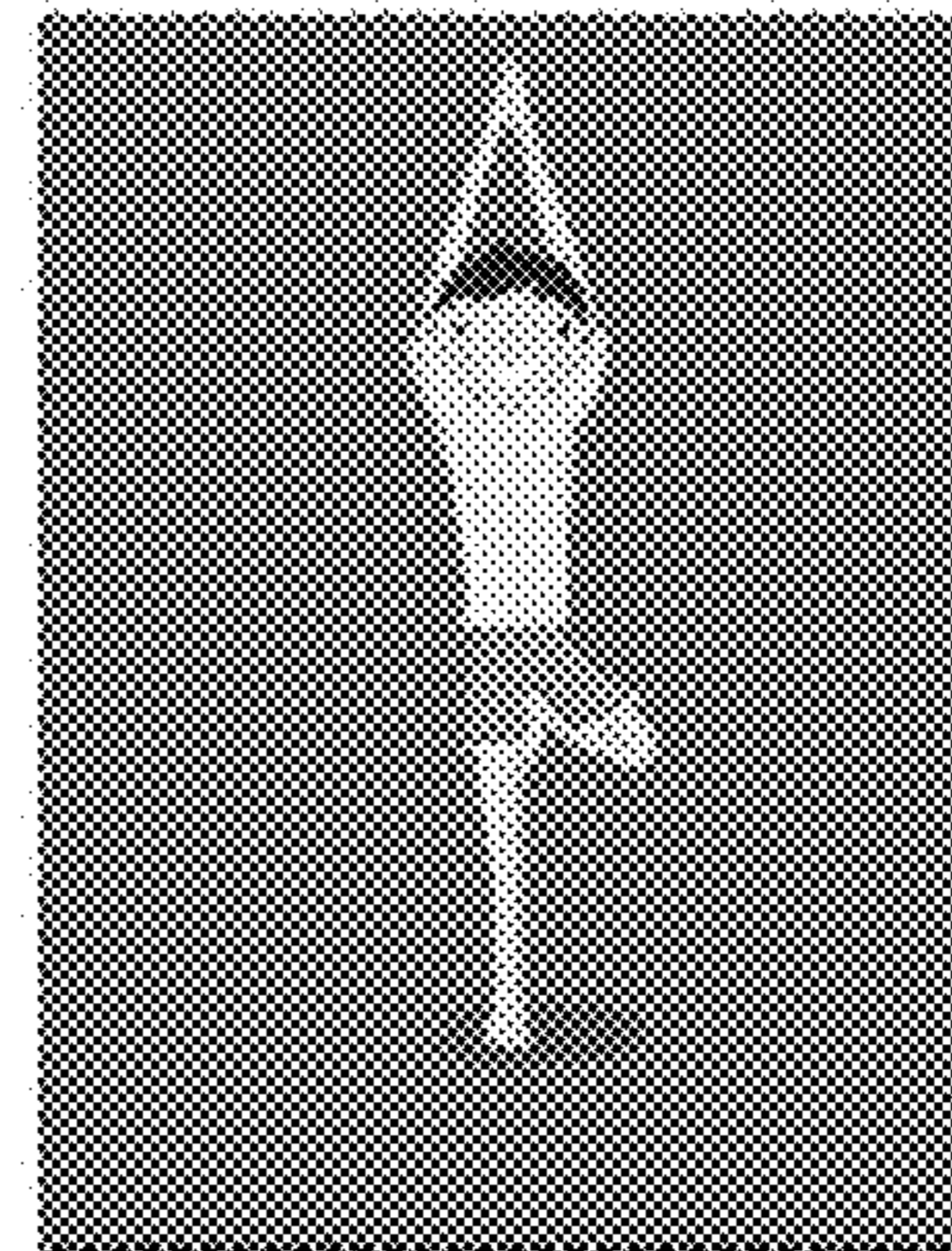

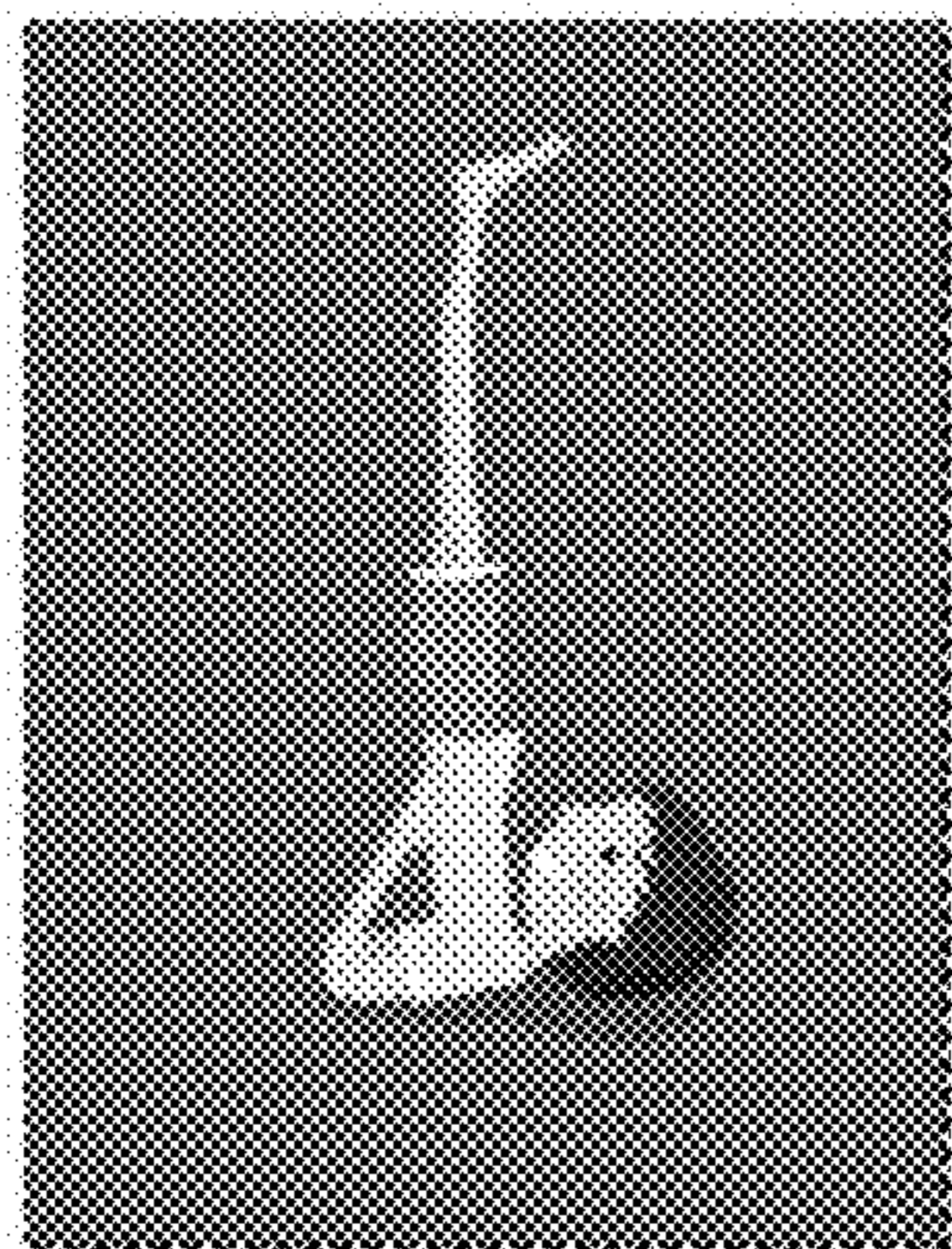

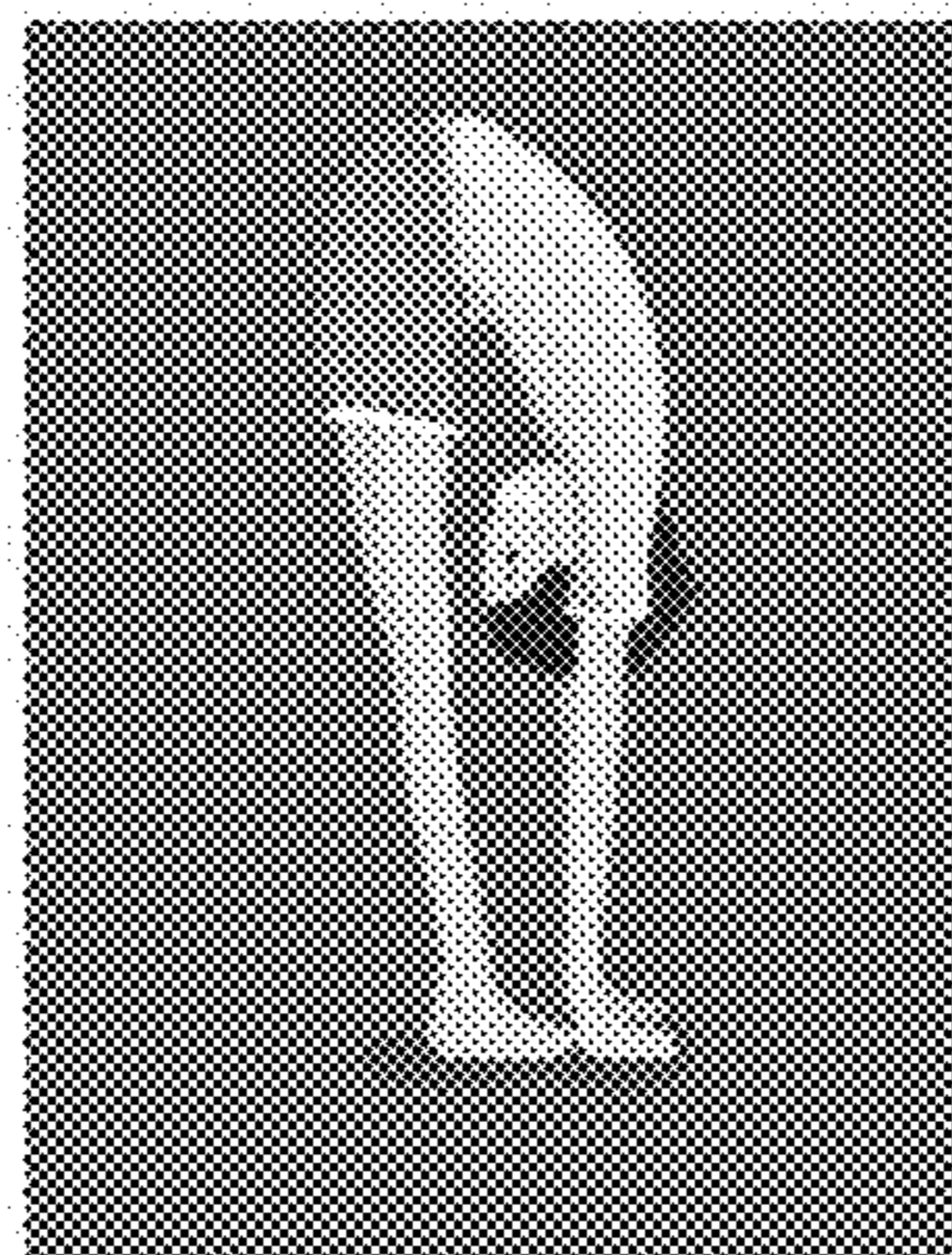

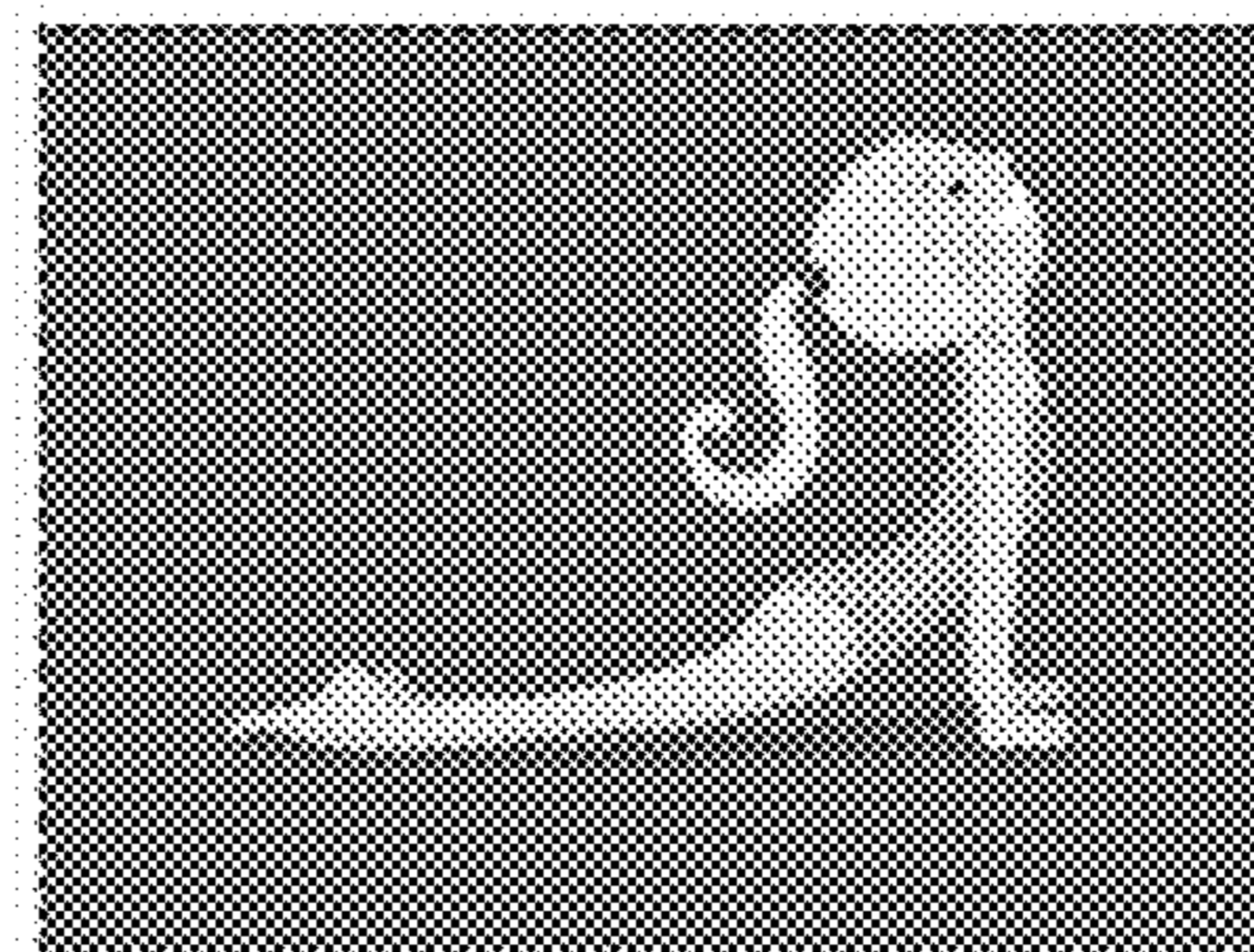

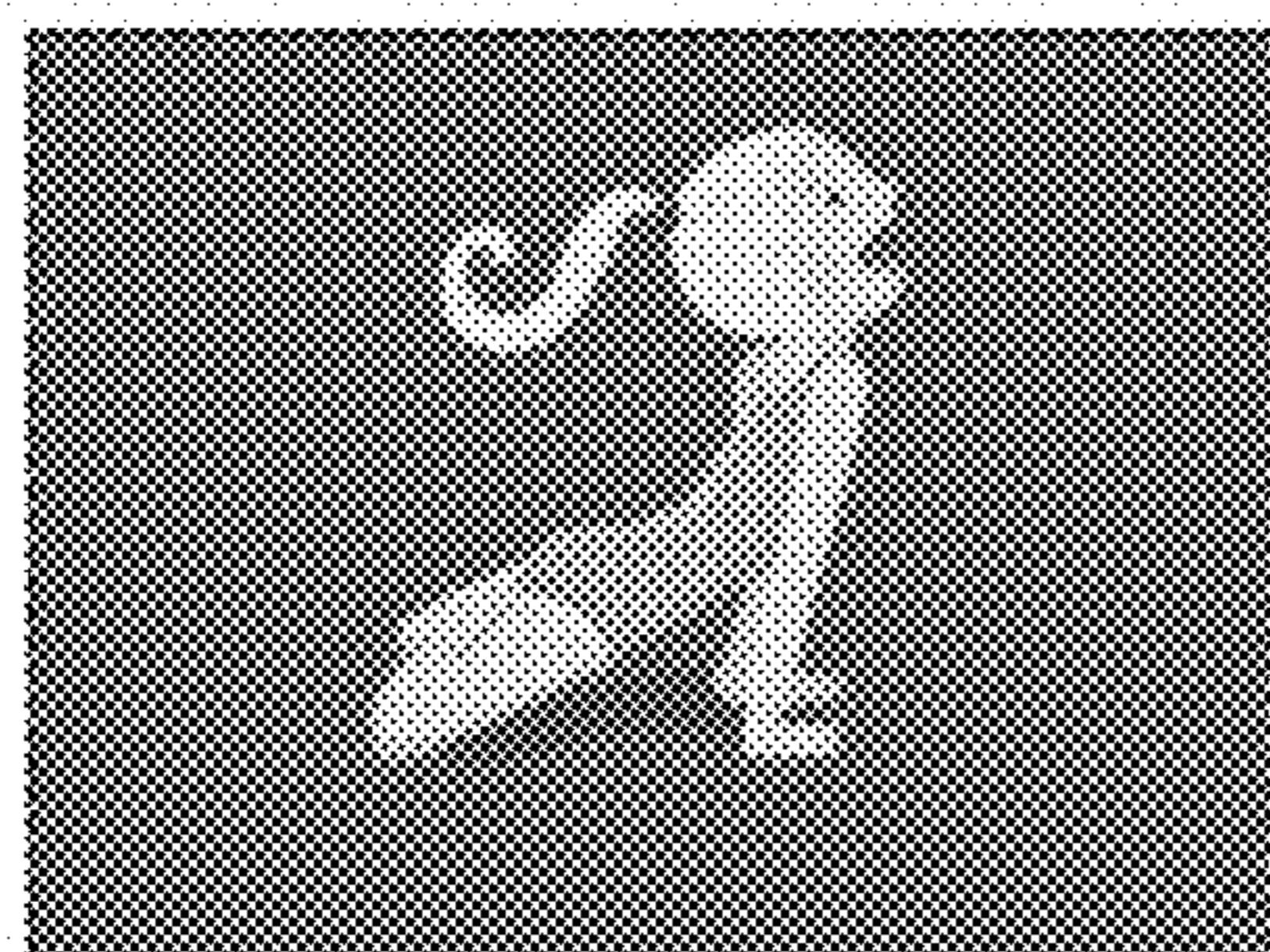

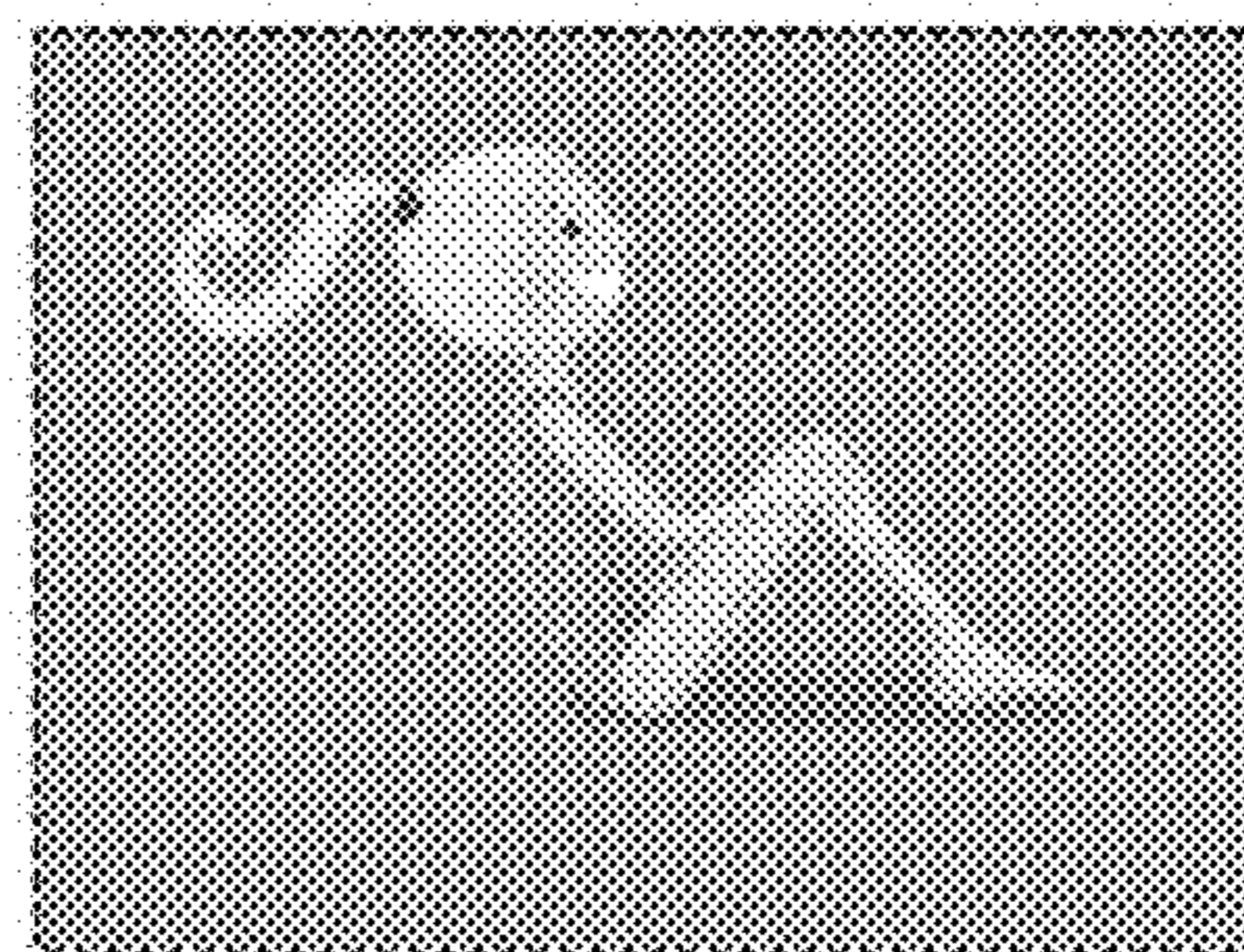

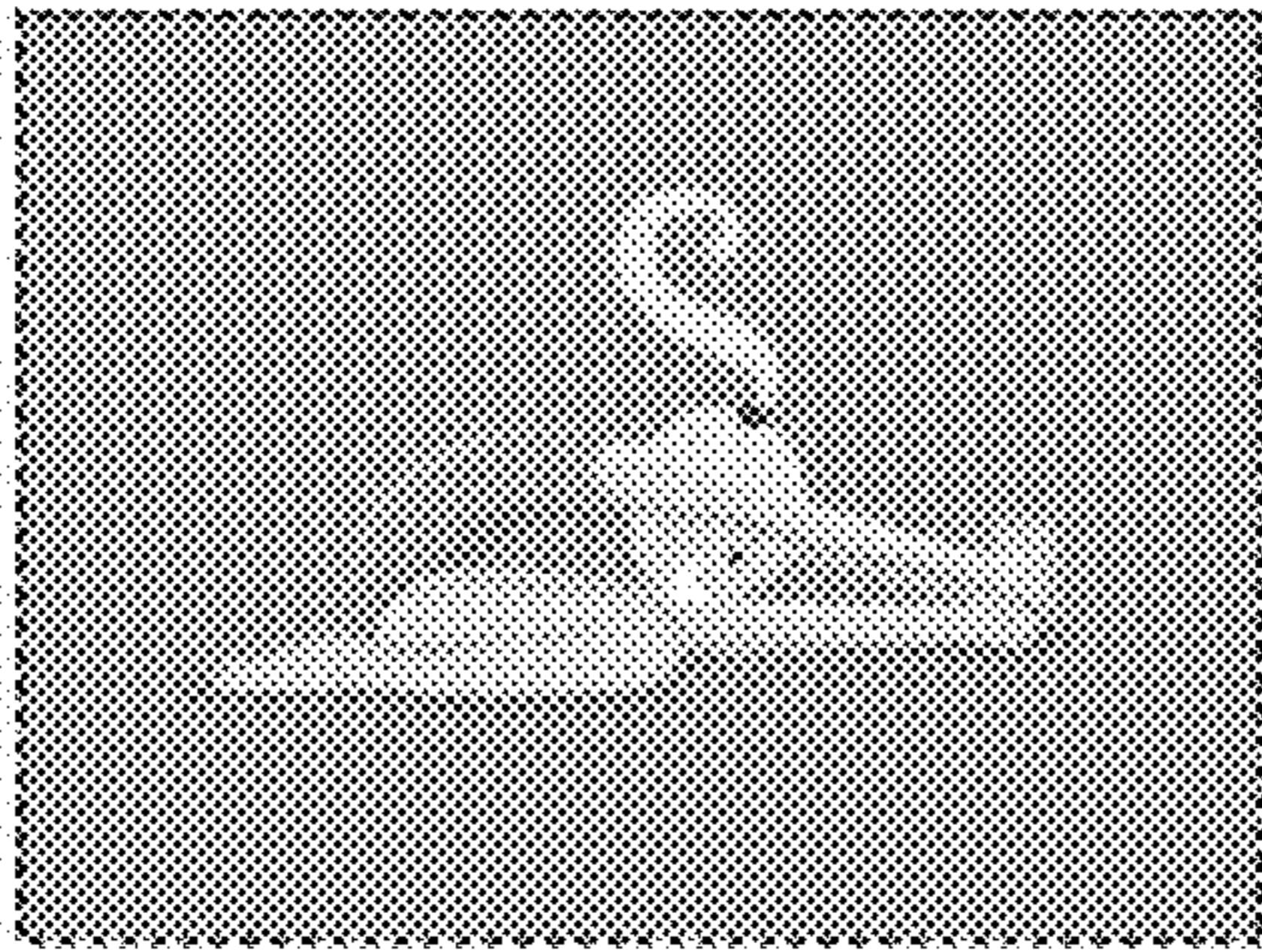

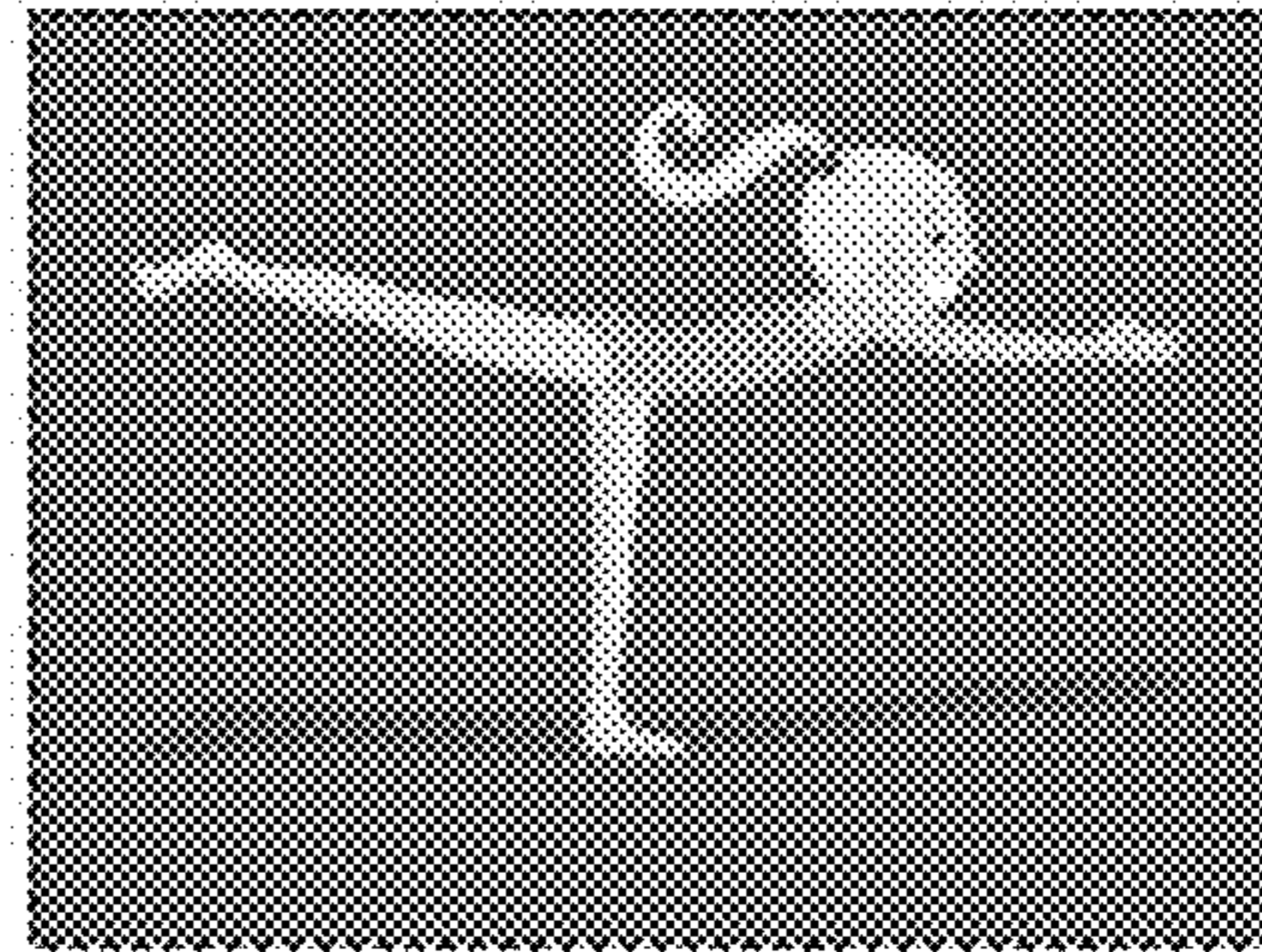

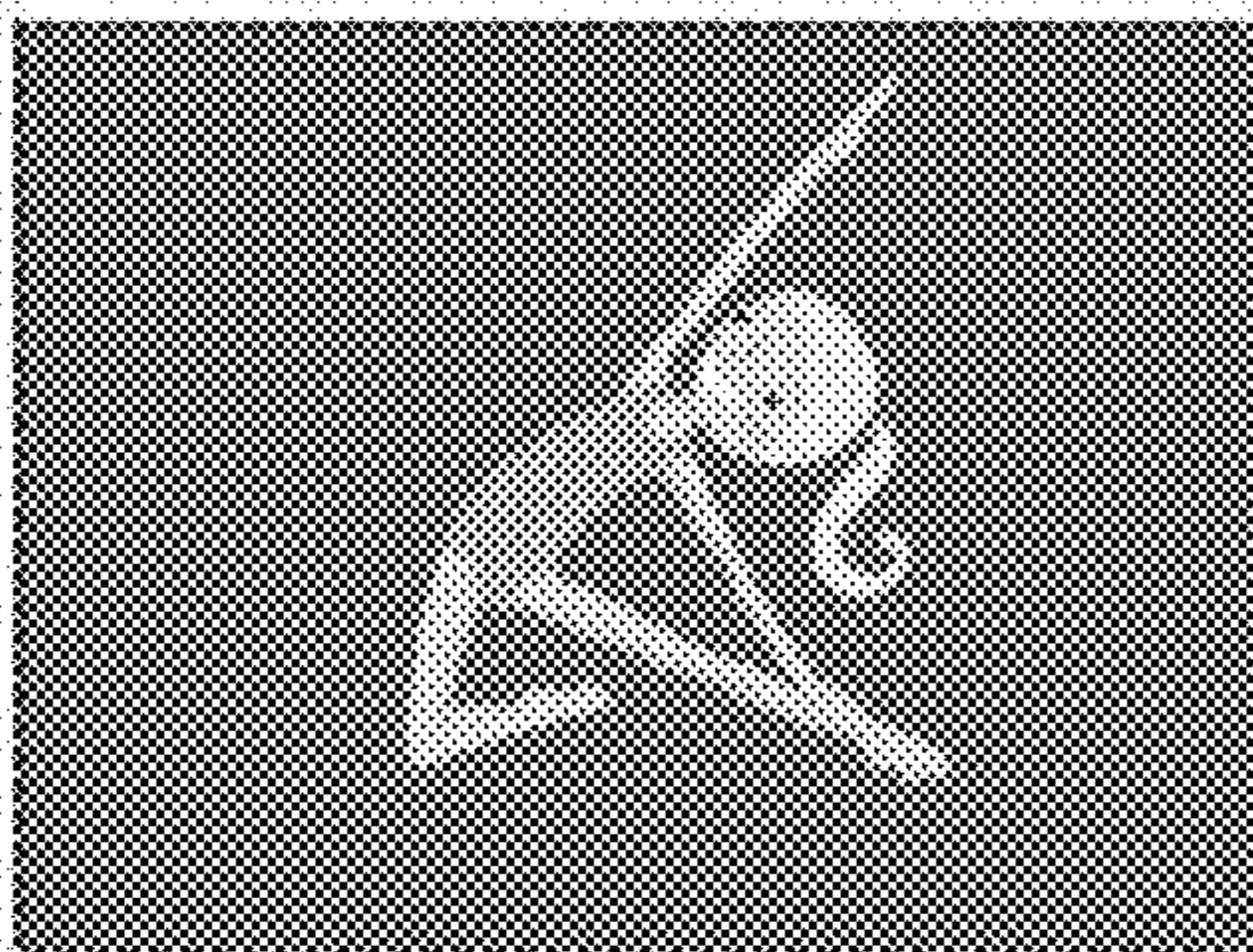

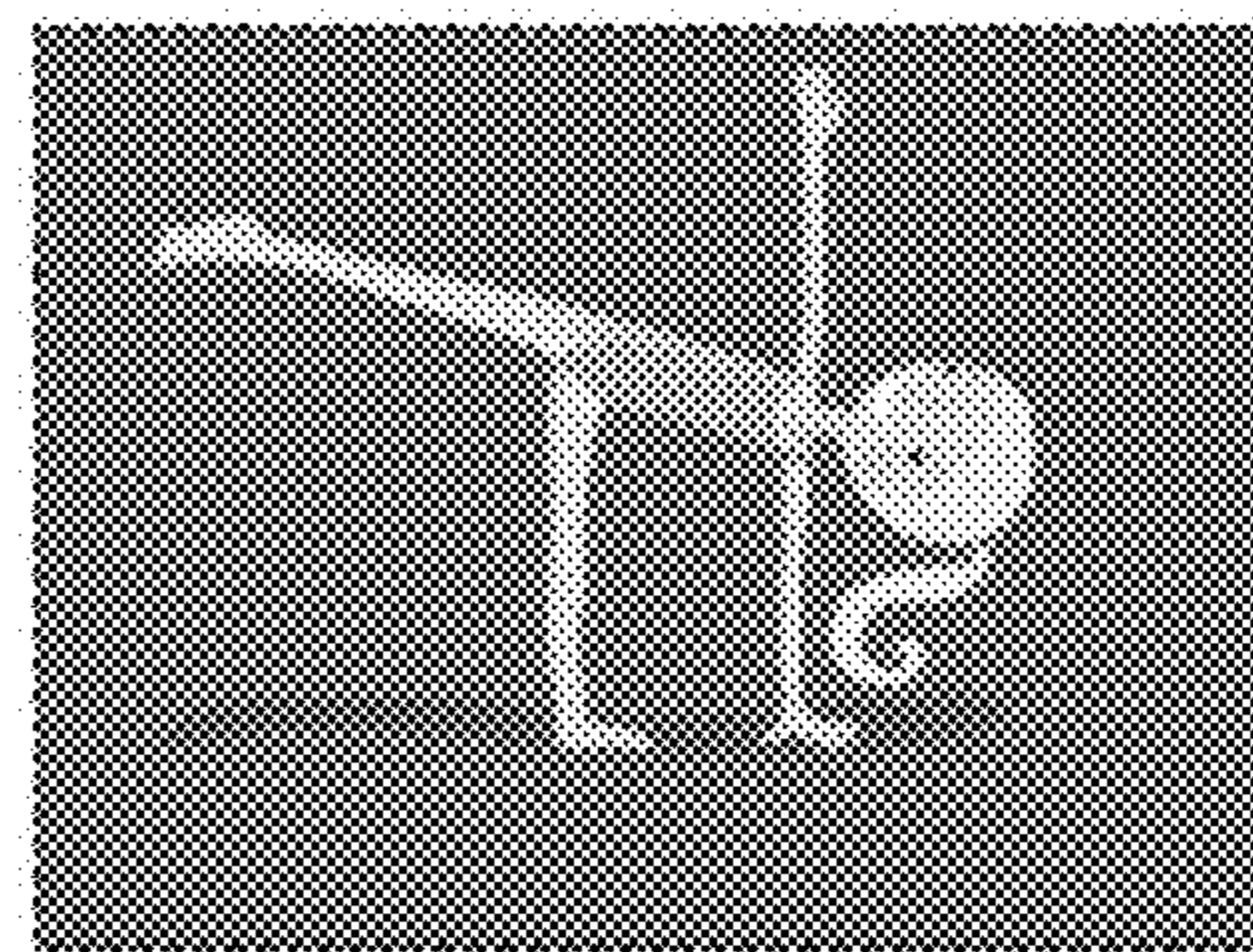

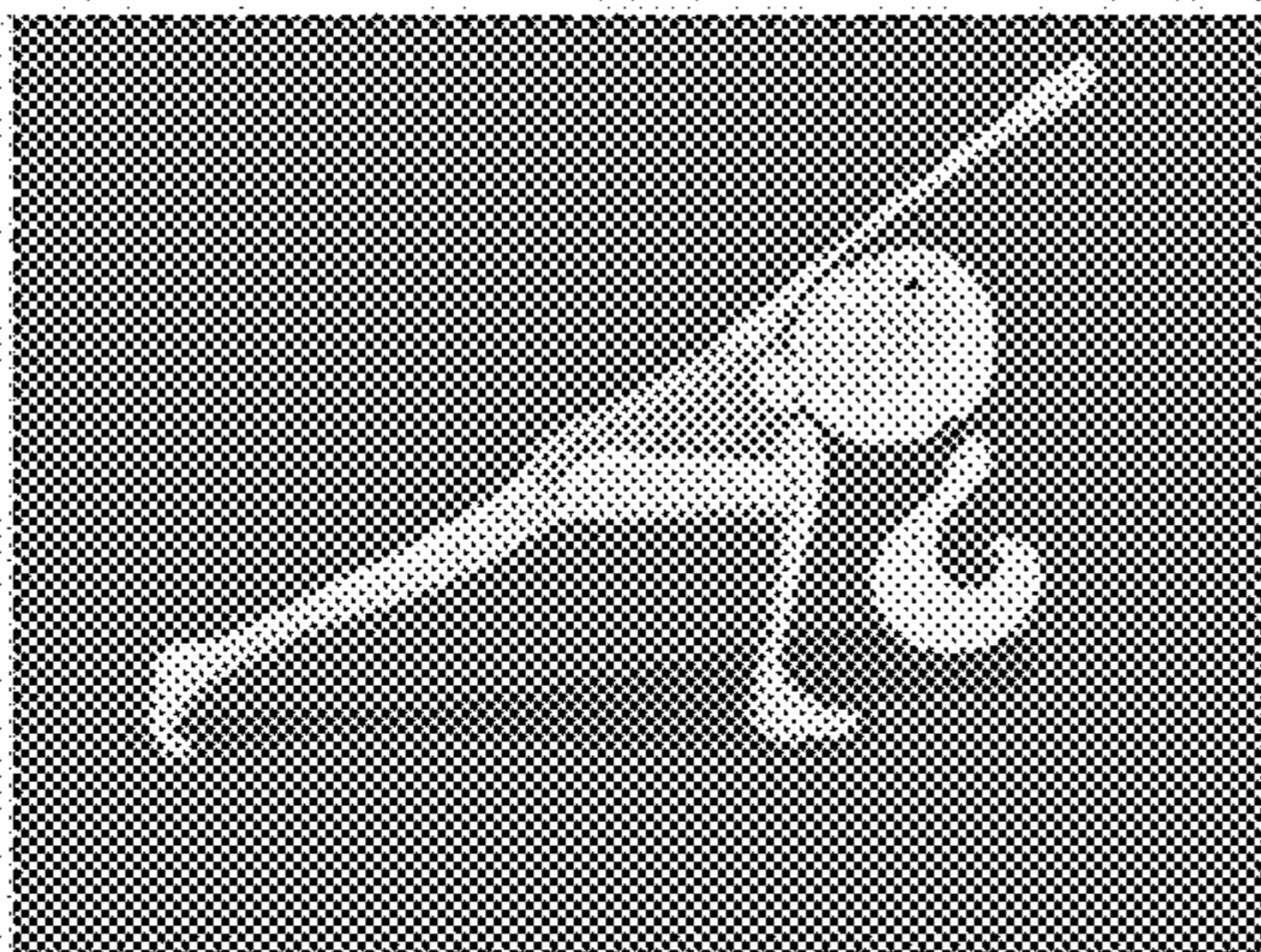

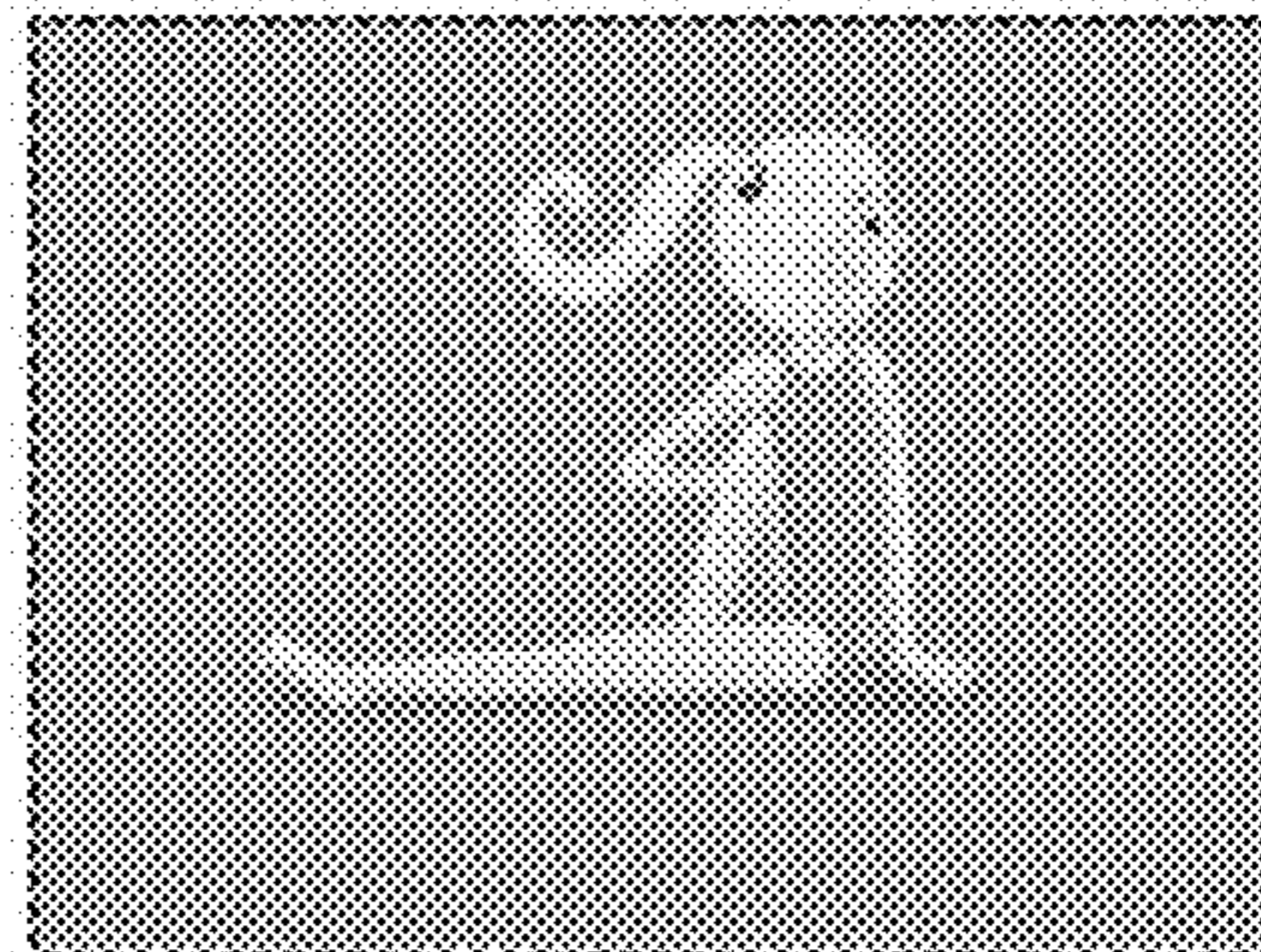

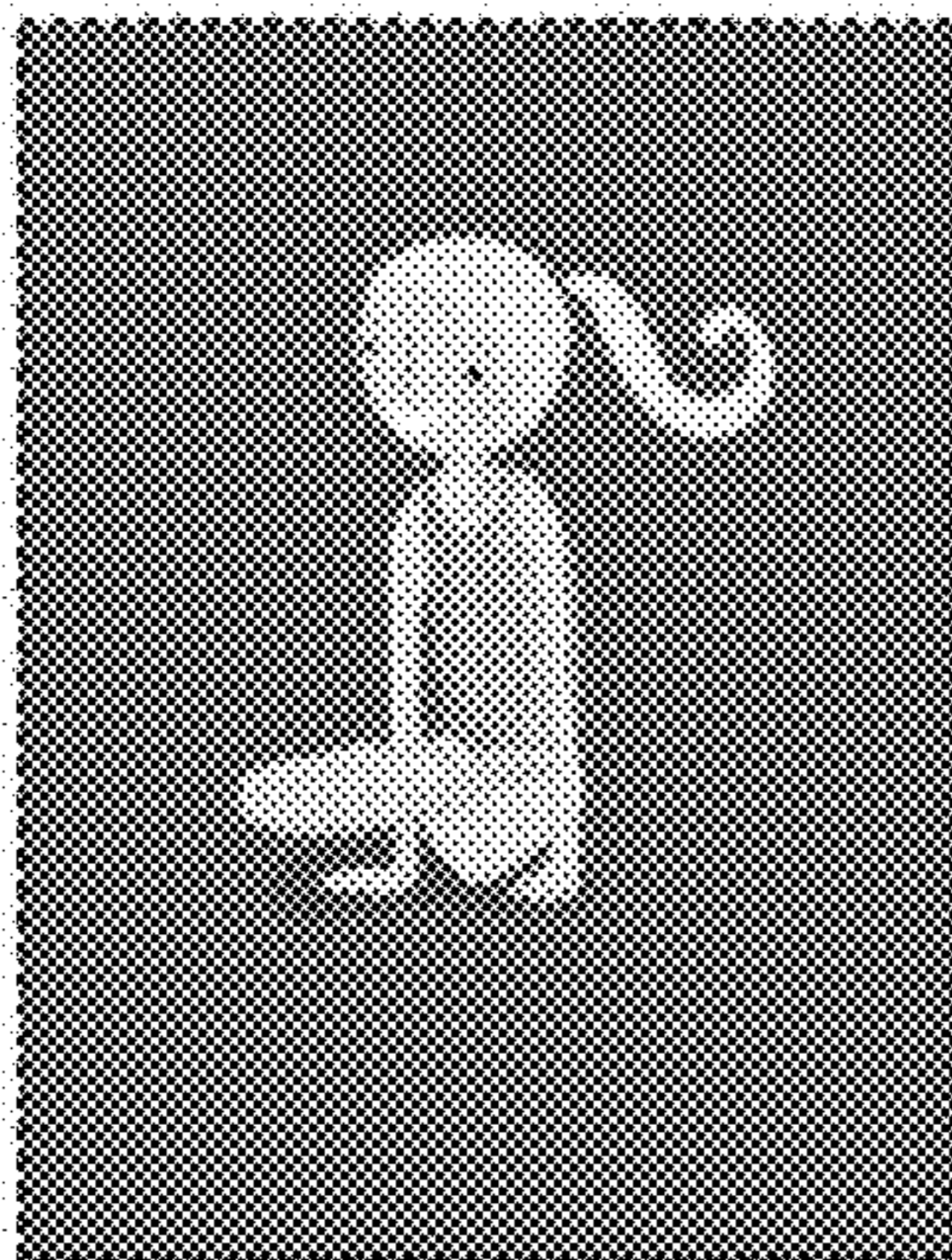

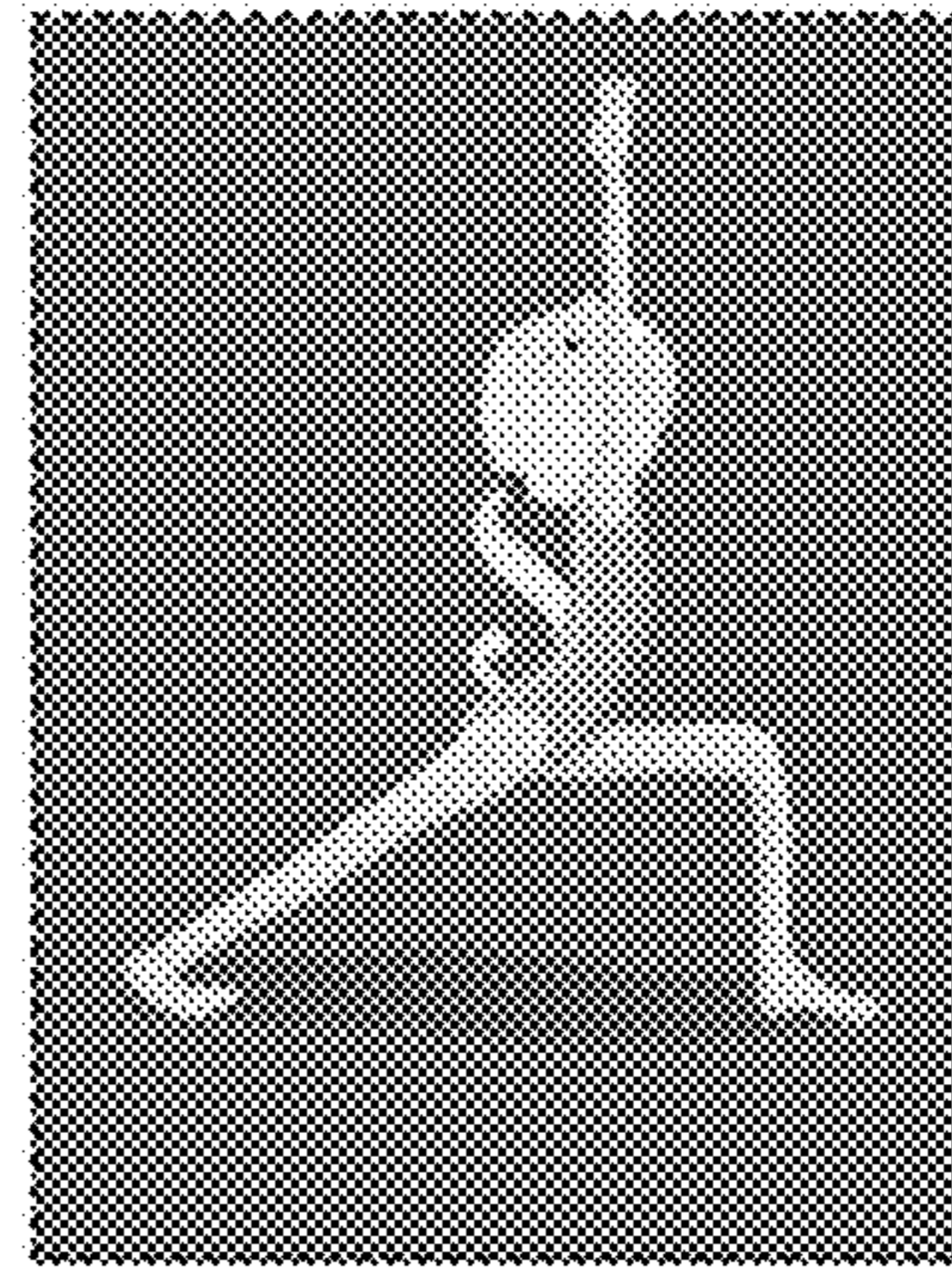

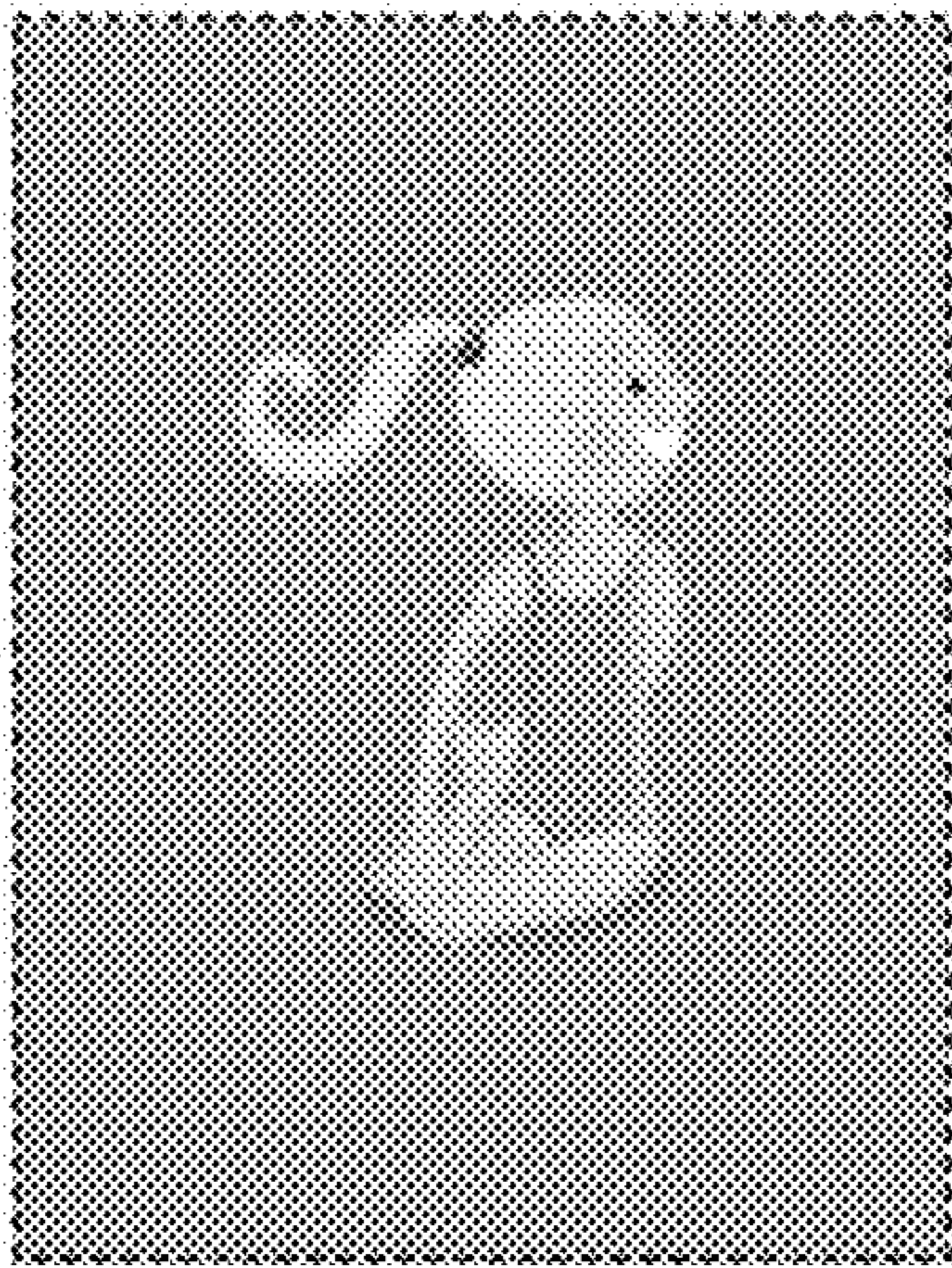

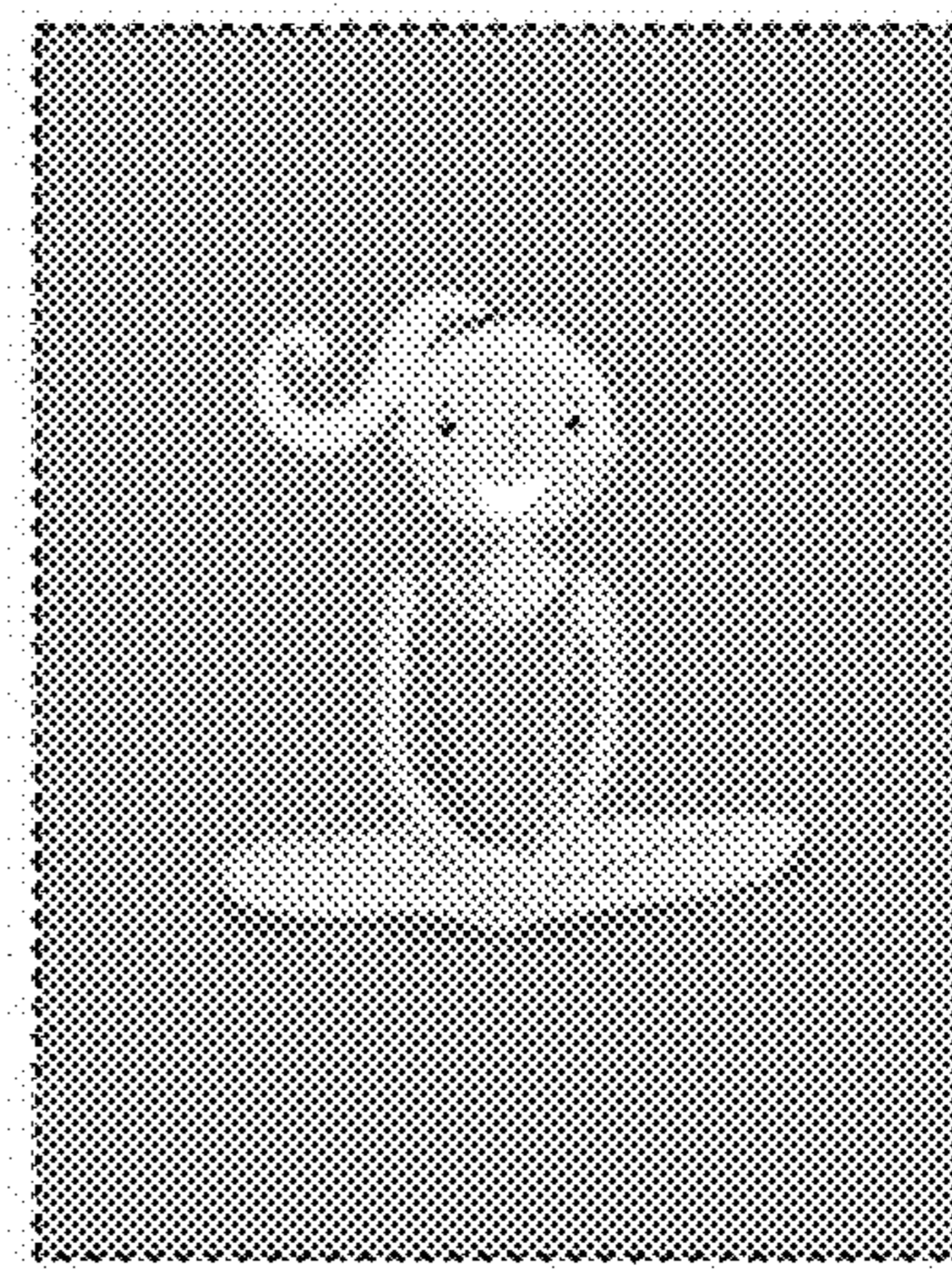

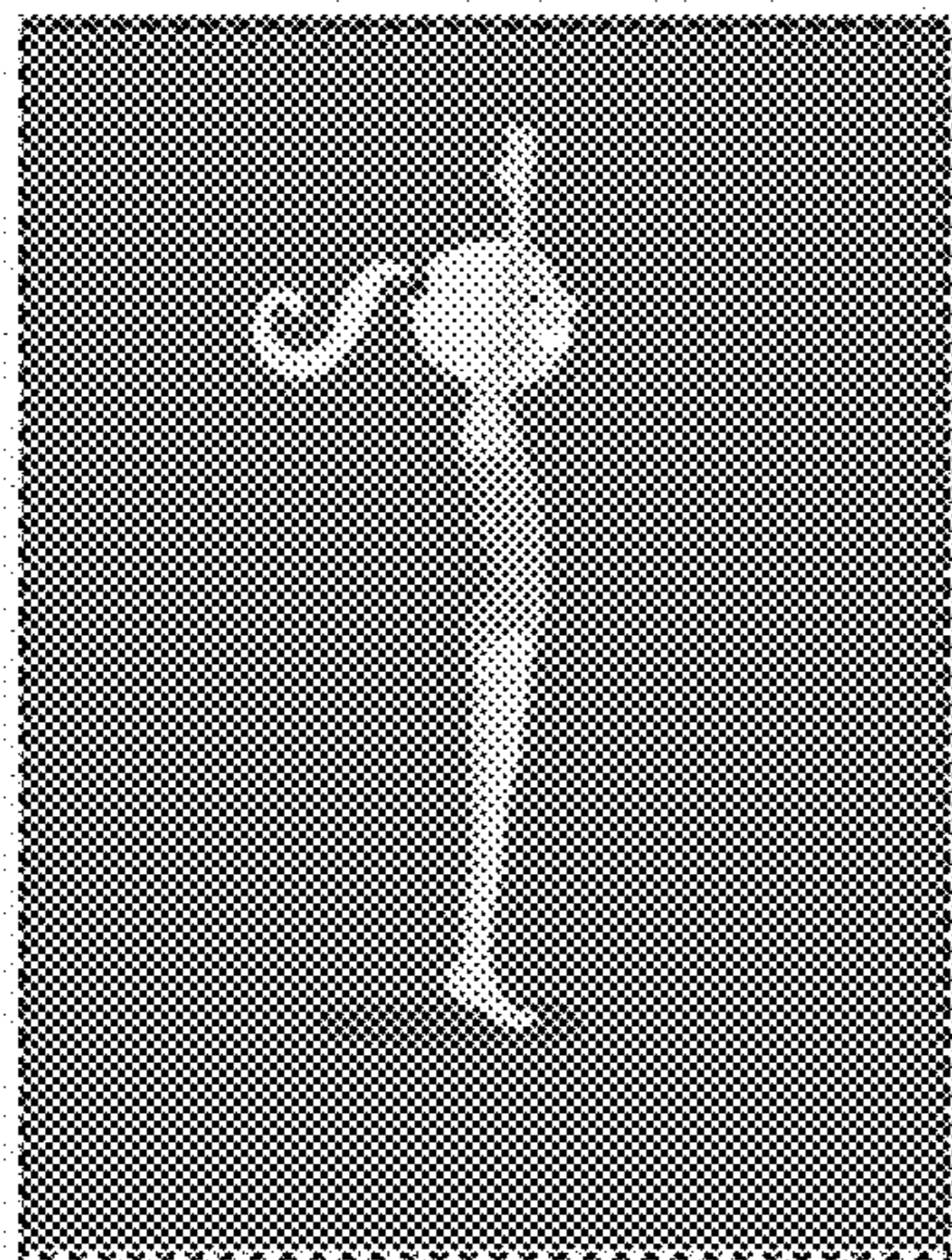

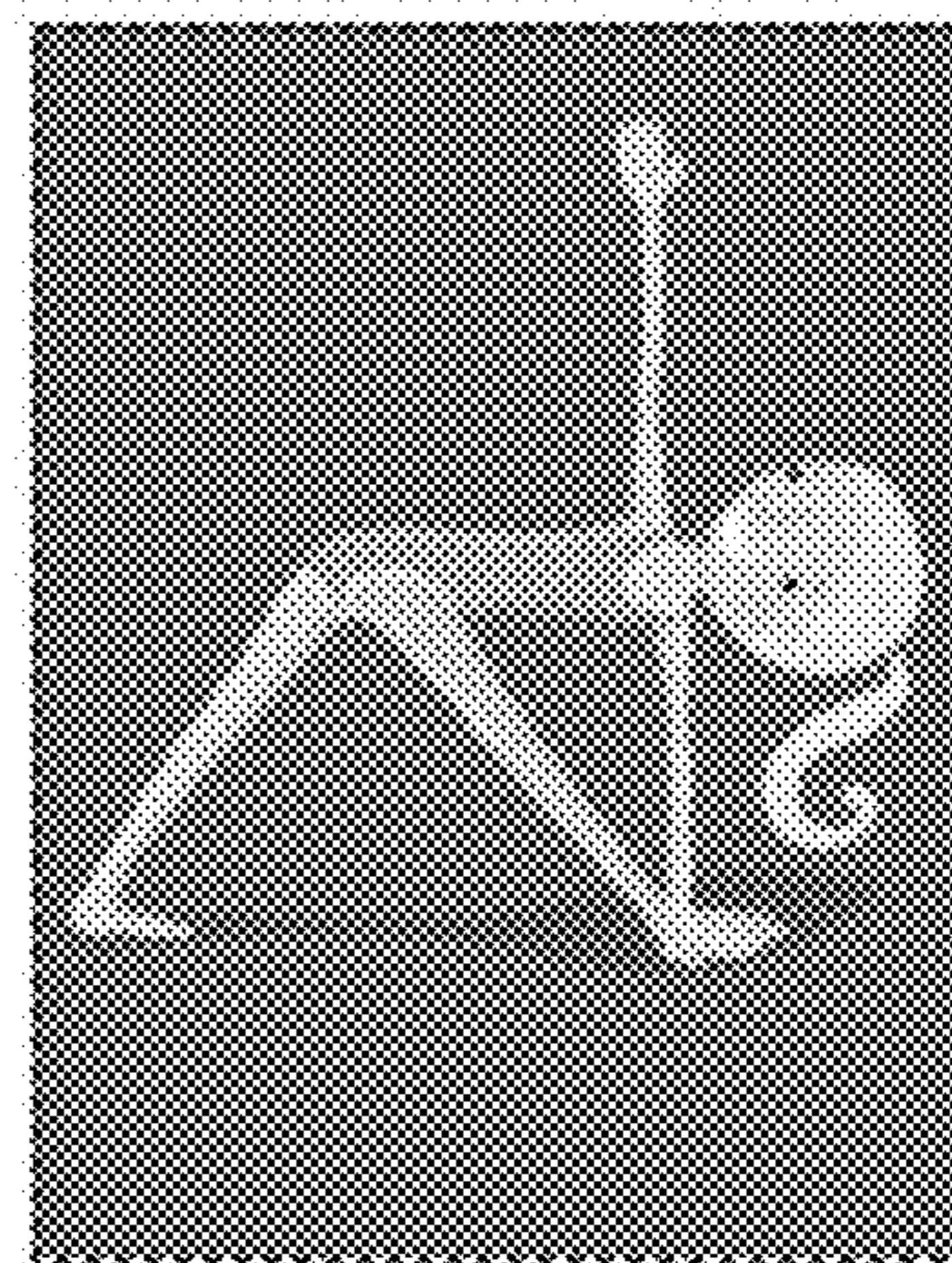

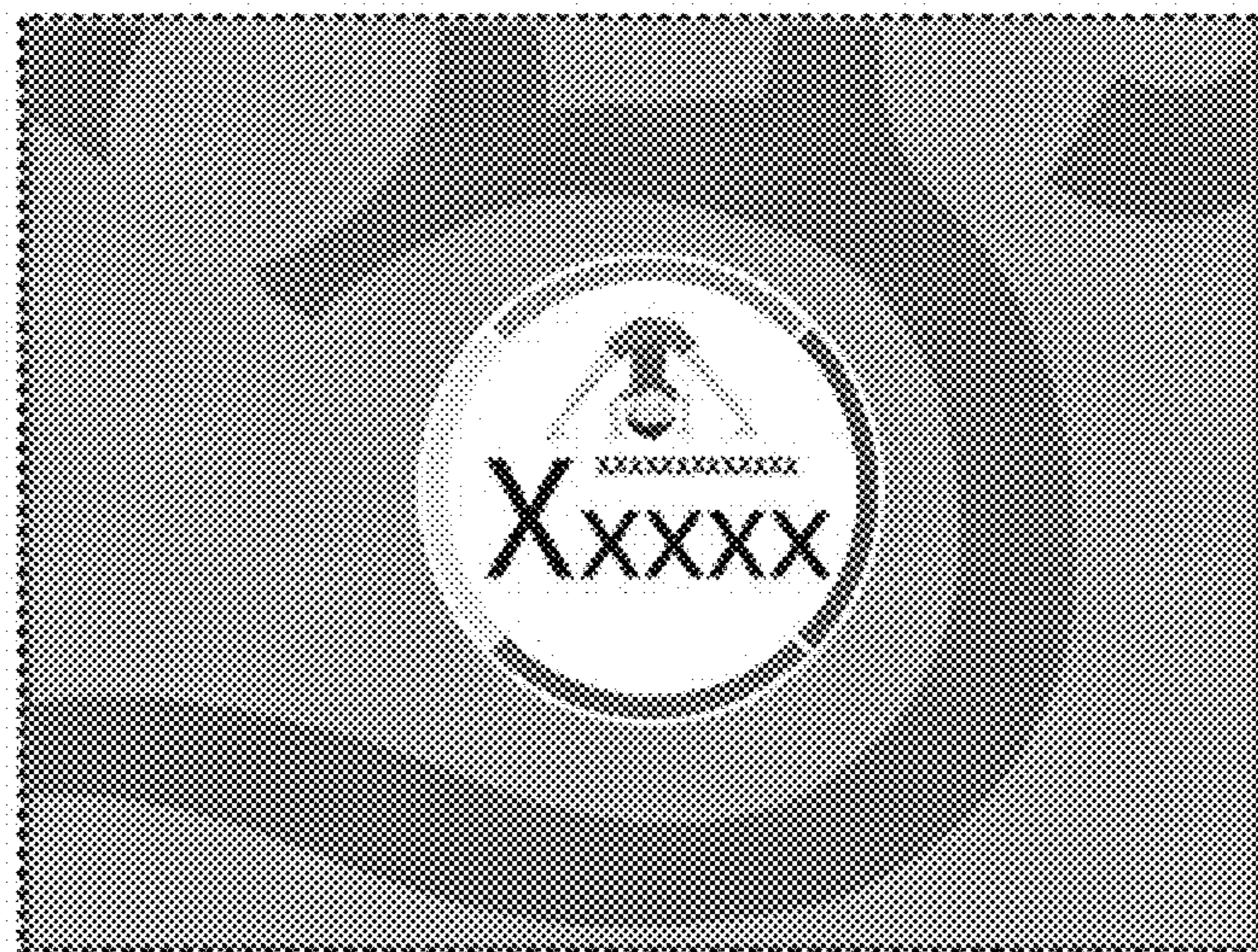

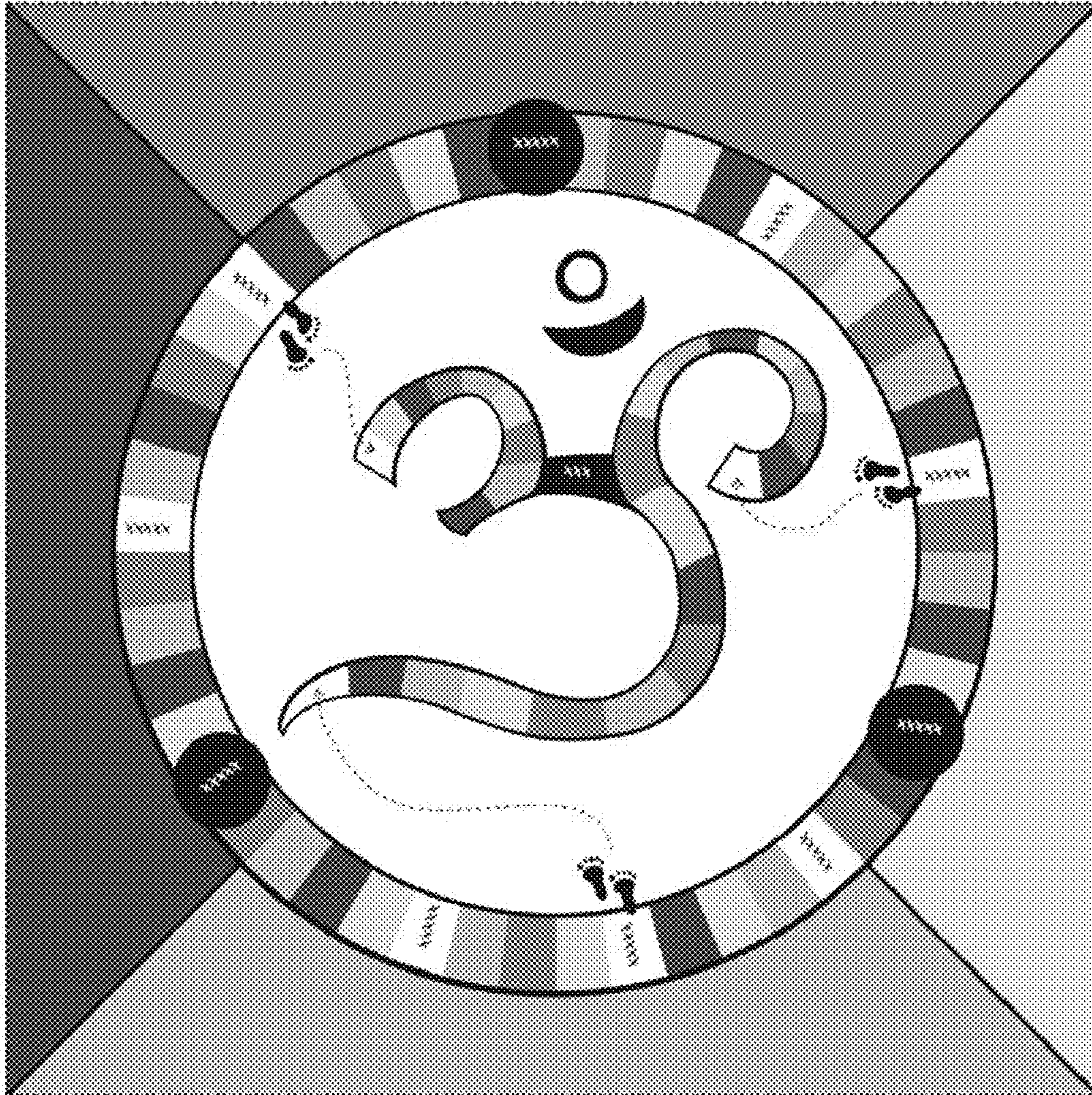
