(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a golf club head showing my new design;

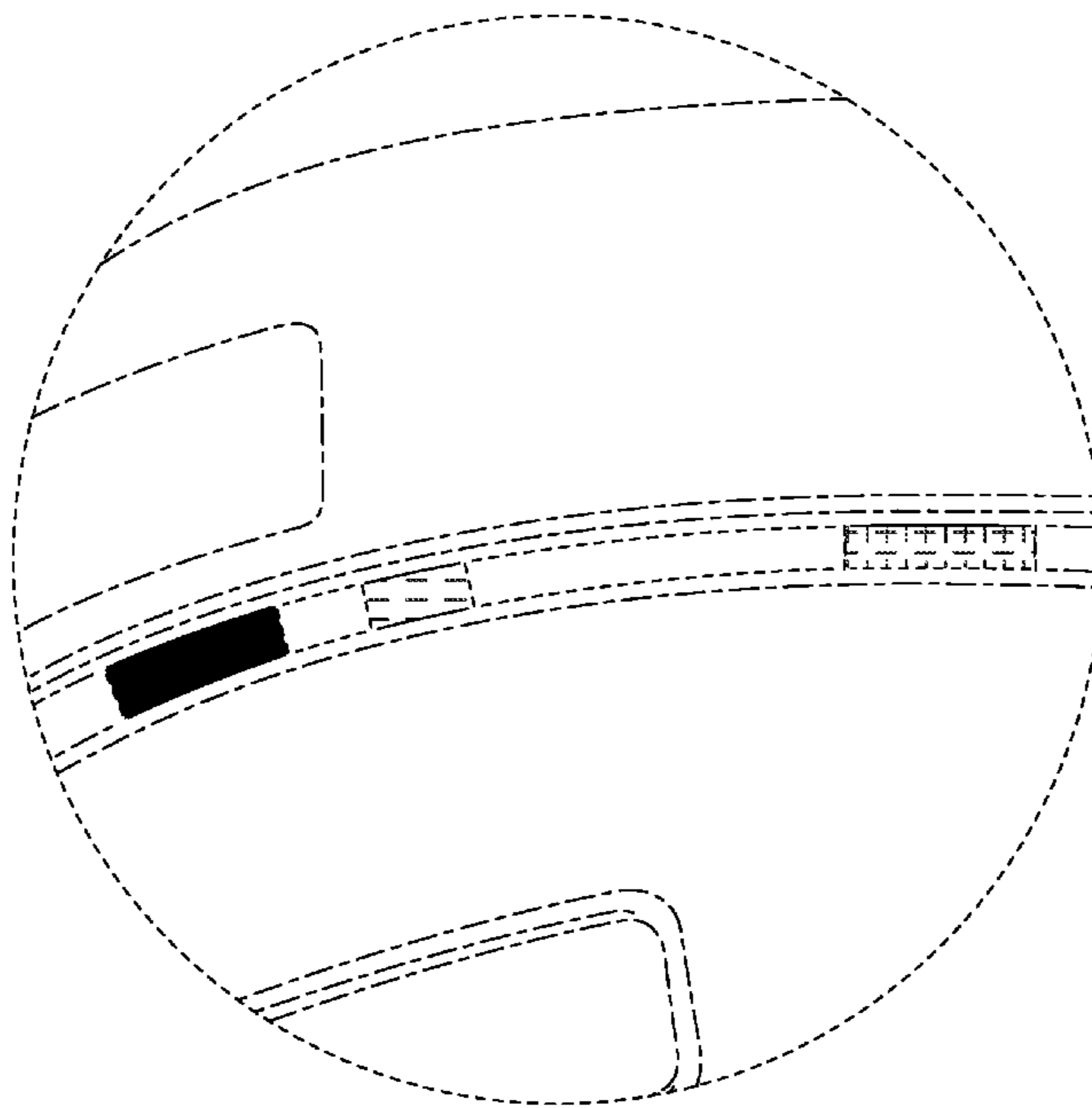
FIG. 2 is a bottom view thereof;

FIG. 3 is a toe end view thereof; and,

FIG. 4 is an enlarged view of FIG. 2 that shows the claimed design.

The uneven broken lines immediately adjacent to the shaded area represent unclaimed boundaries and form no part of the claimed design. The remaining uneven broken lines are shown for the purpose of illustrating environmental structure and form no part of the claimed design. The shading in the three claimed regions is shown for the purpose of depicting color in accordance with office regulations. Specifically, the three claimed regions in the figures are illustrated with color designations. The claimed region closest to the heel of the golf club head is shaded for yellow. The claimed region closest to the toe of the golf club head is shaded for black. The claimed region between the claimed yellow and black regions is shaded for grey or silver.

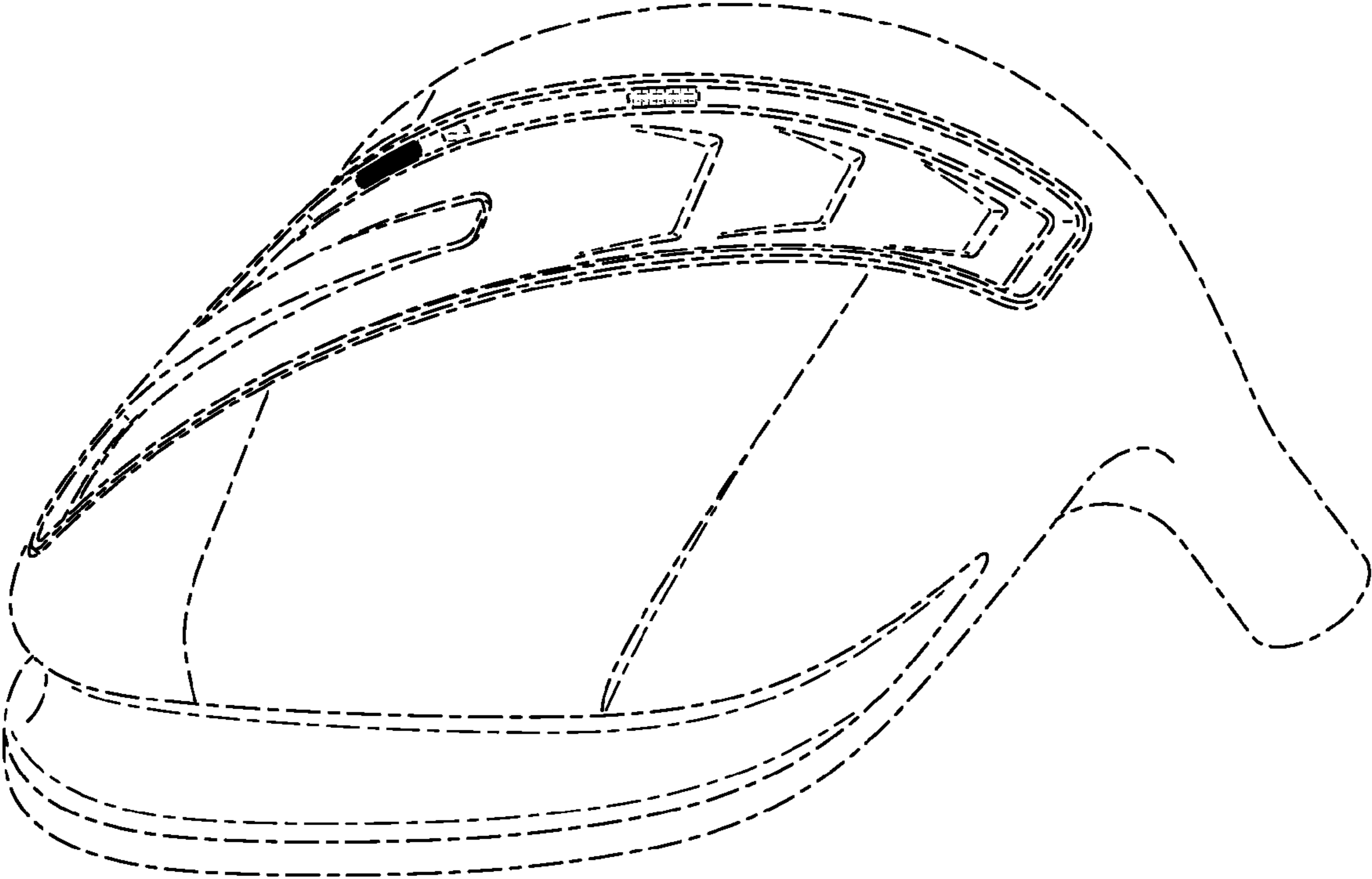

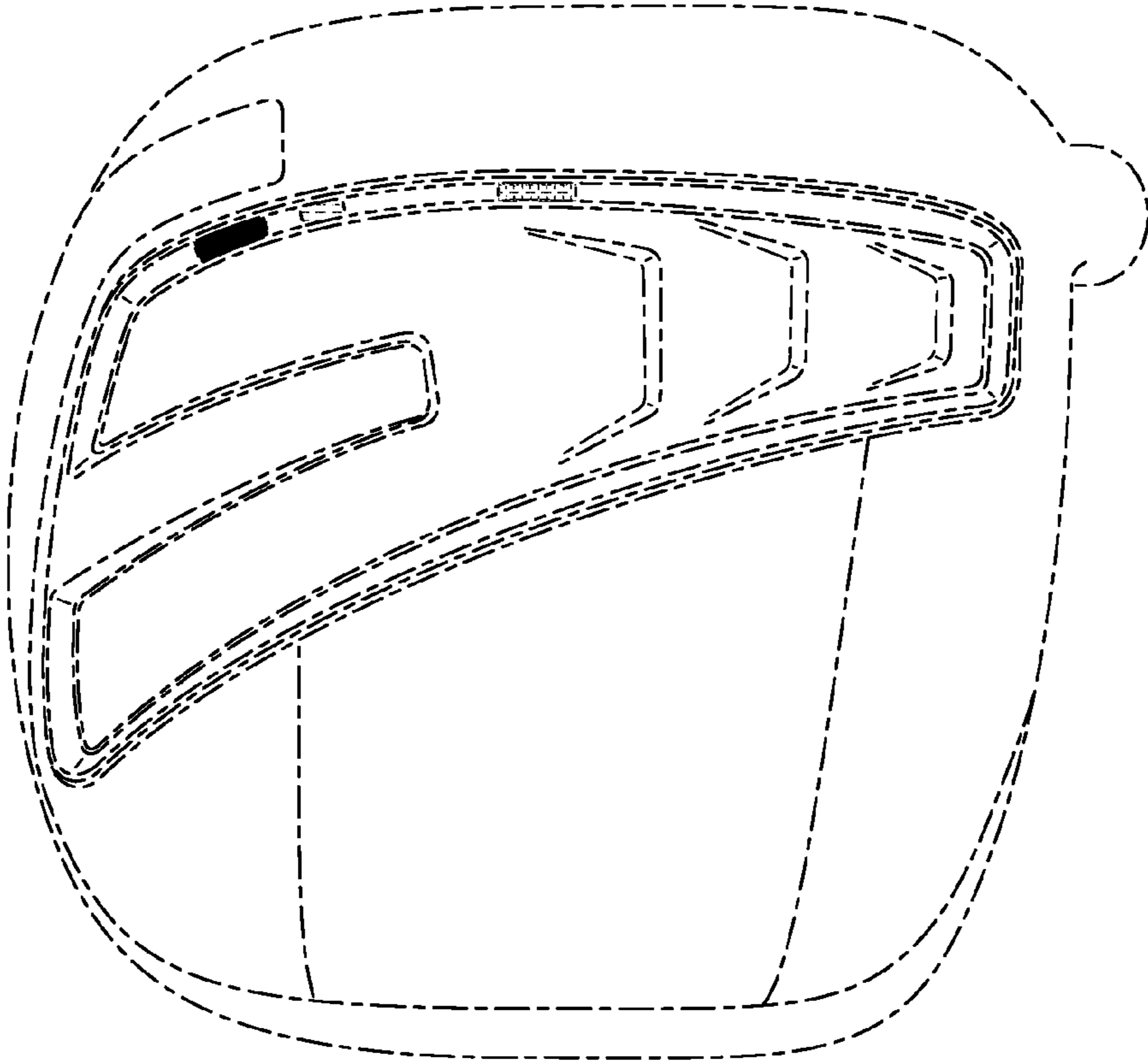

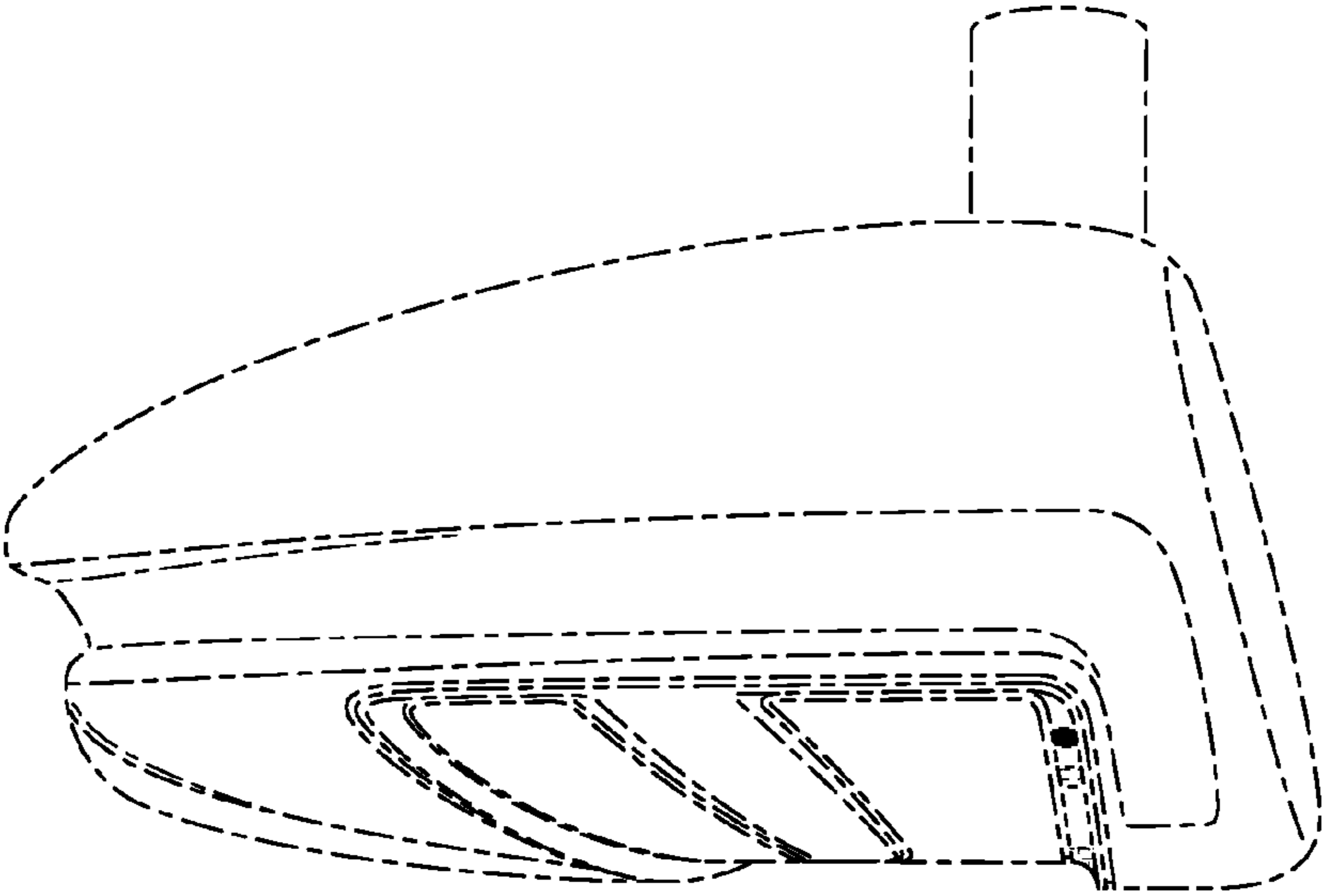

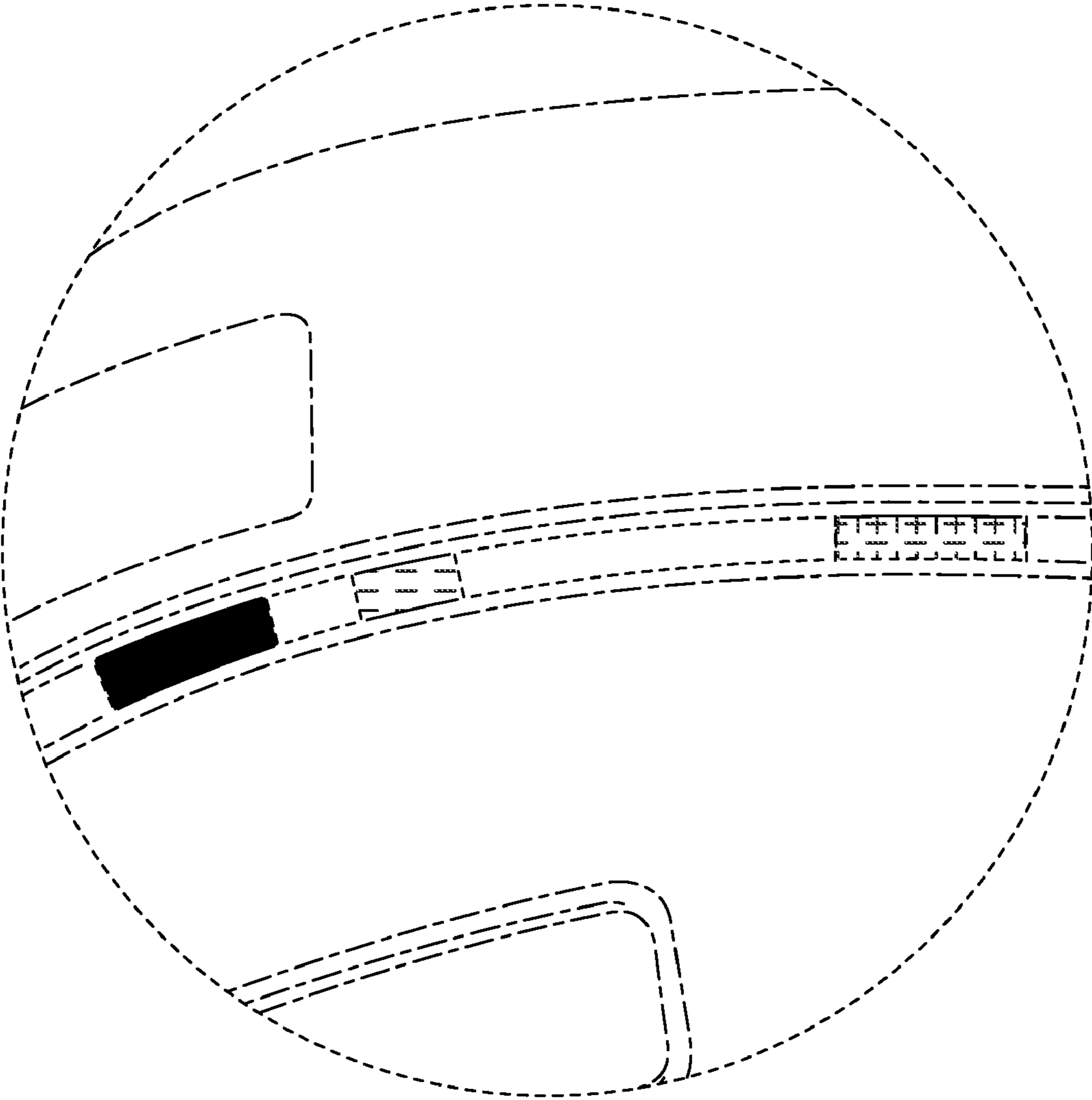
