The ornamental design for a urinal screen, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a preferred embodiment of the urinal screen, showing my design.

FIG. 2 is a front elevational view;

FIG. 3 is a rear elevational view;

FIG. 4 is a bottom plan view;

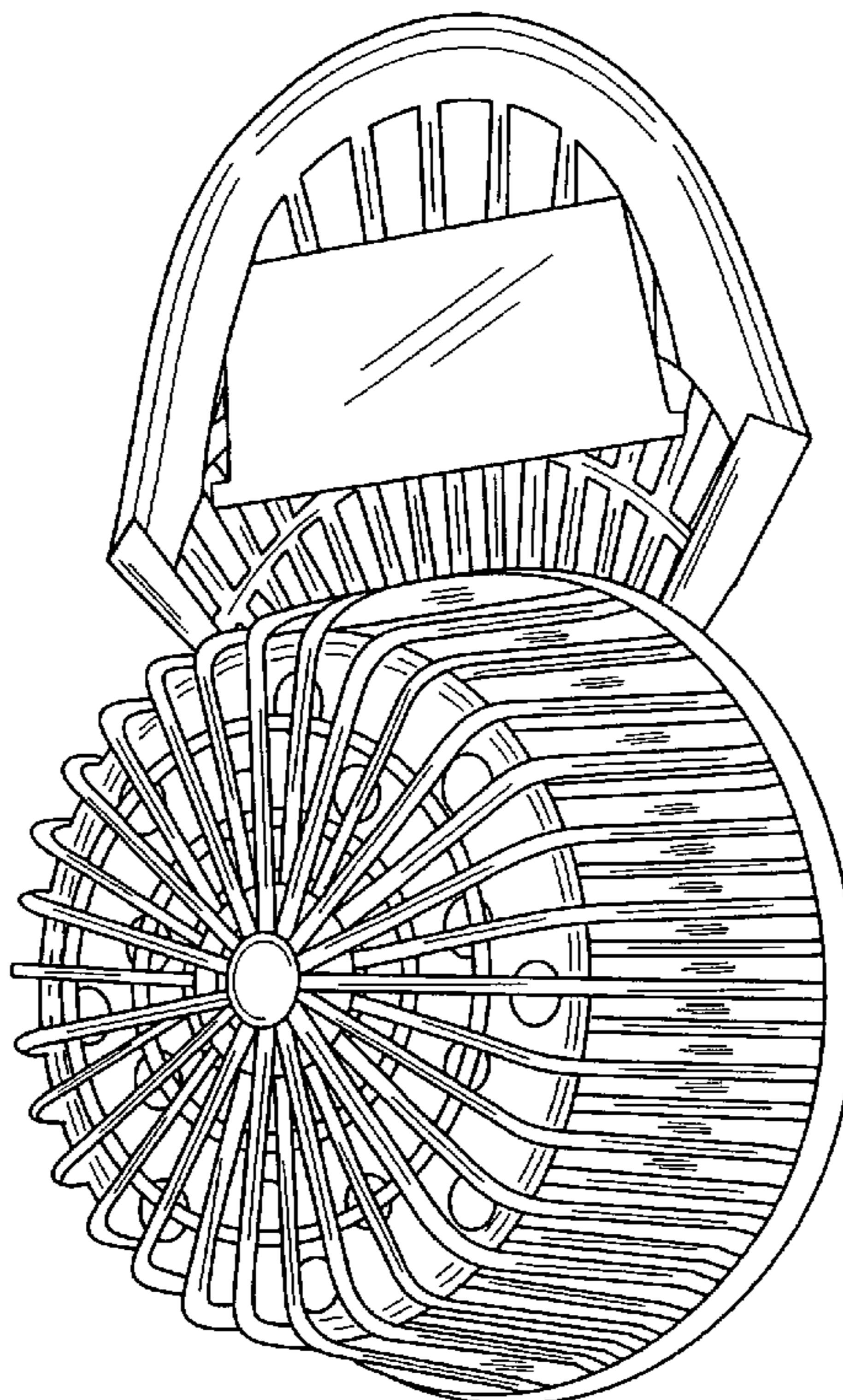
FIG. 5 is a top plan view;

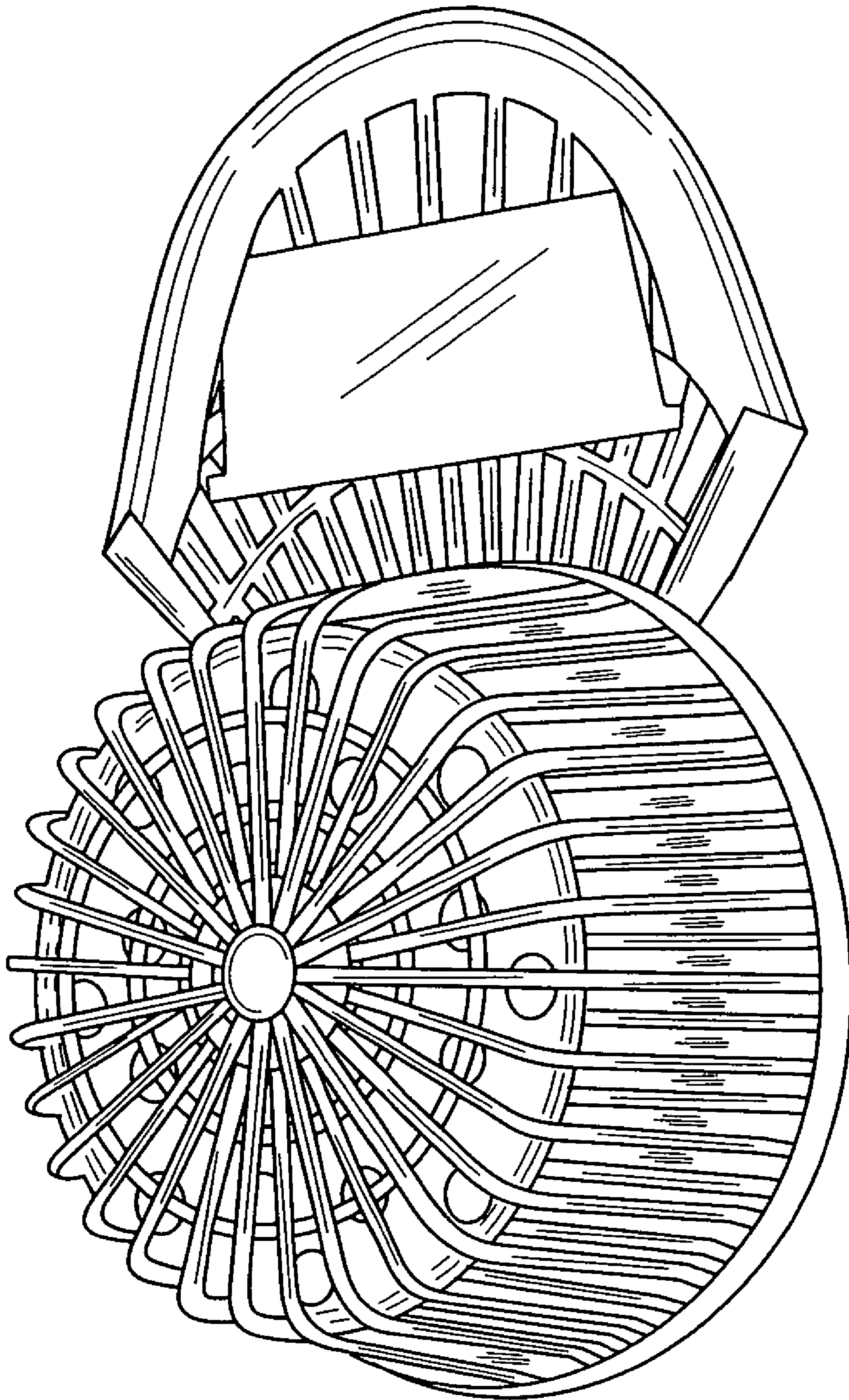

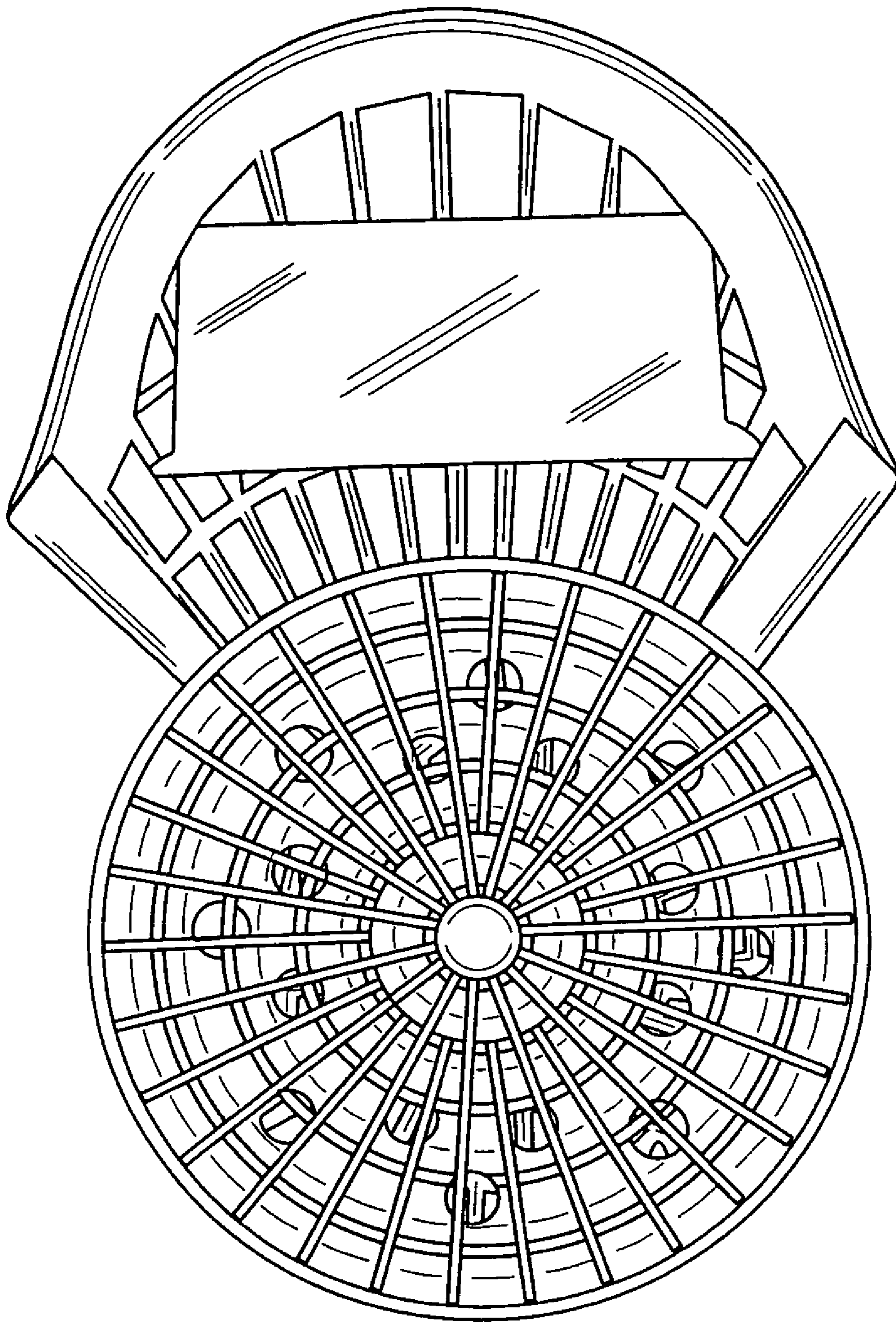

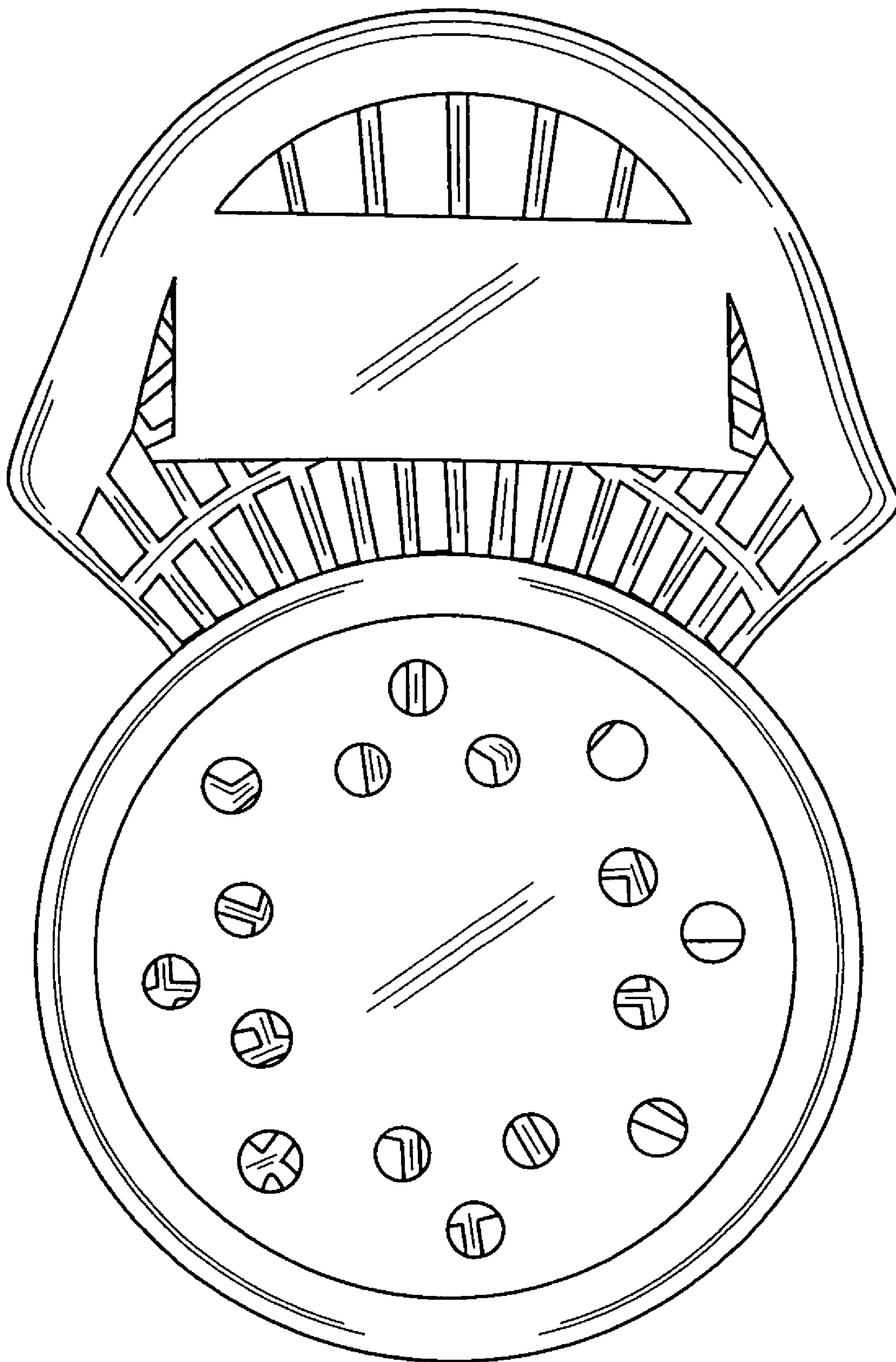

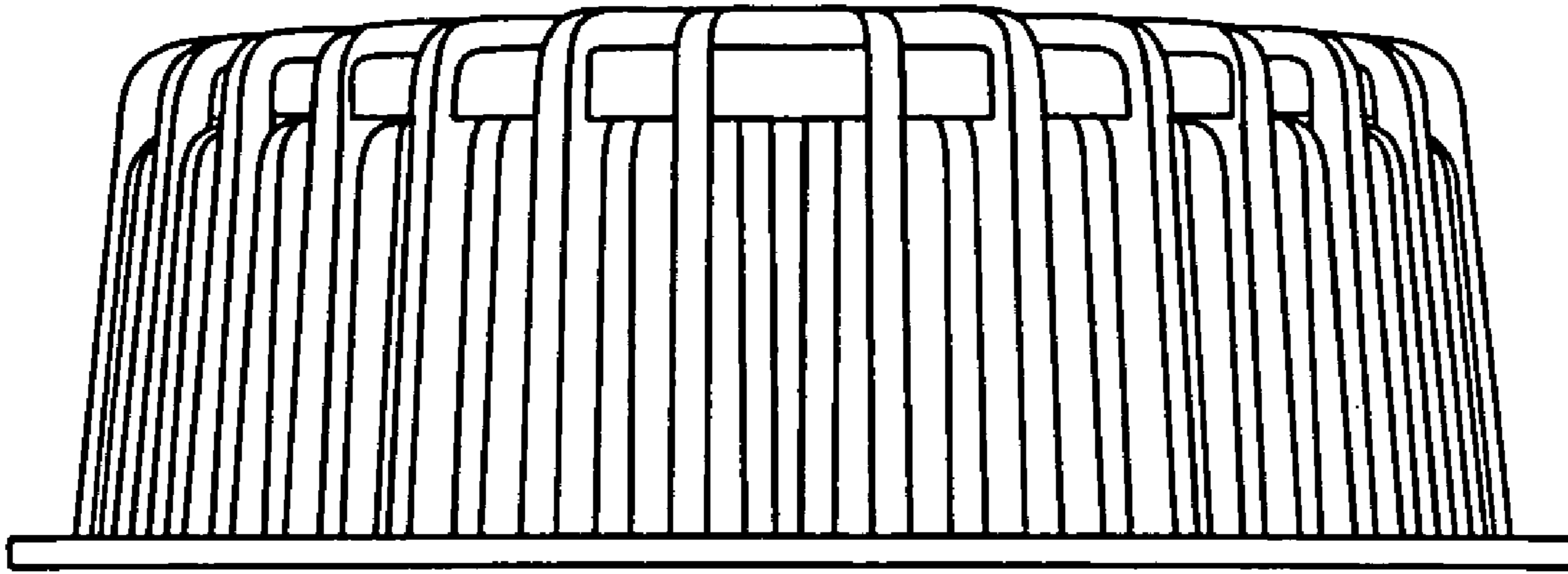

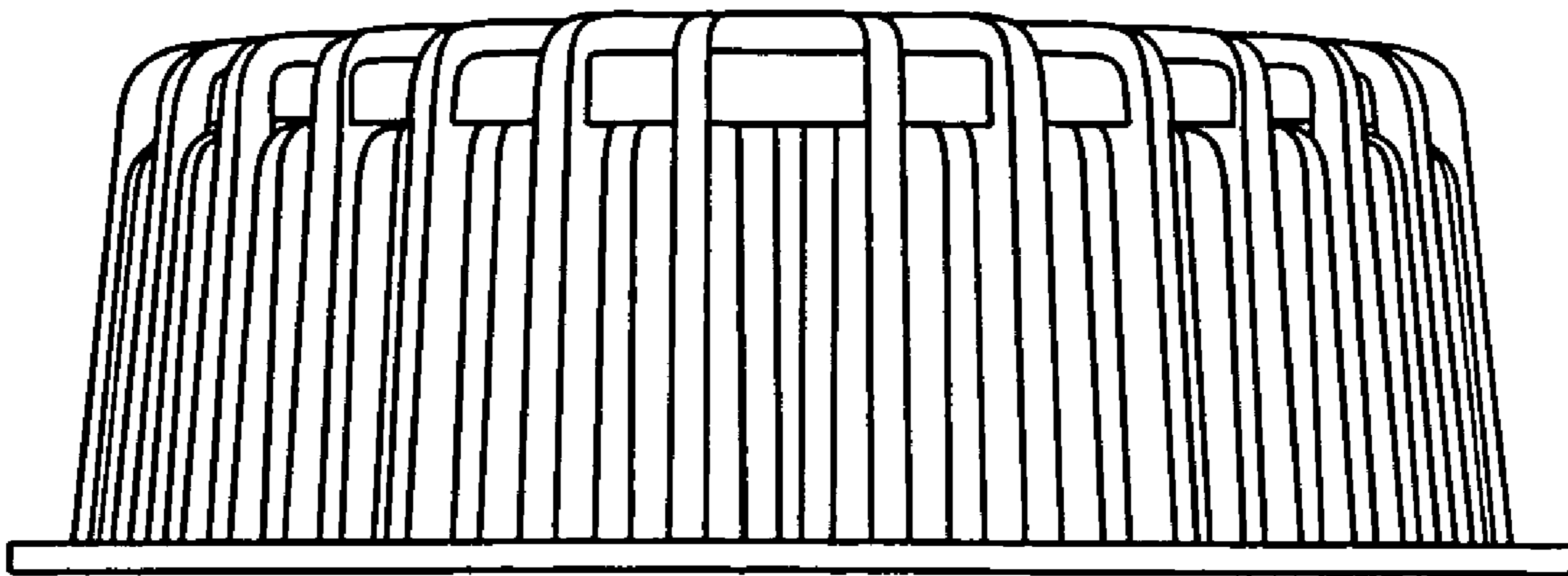

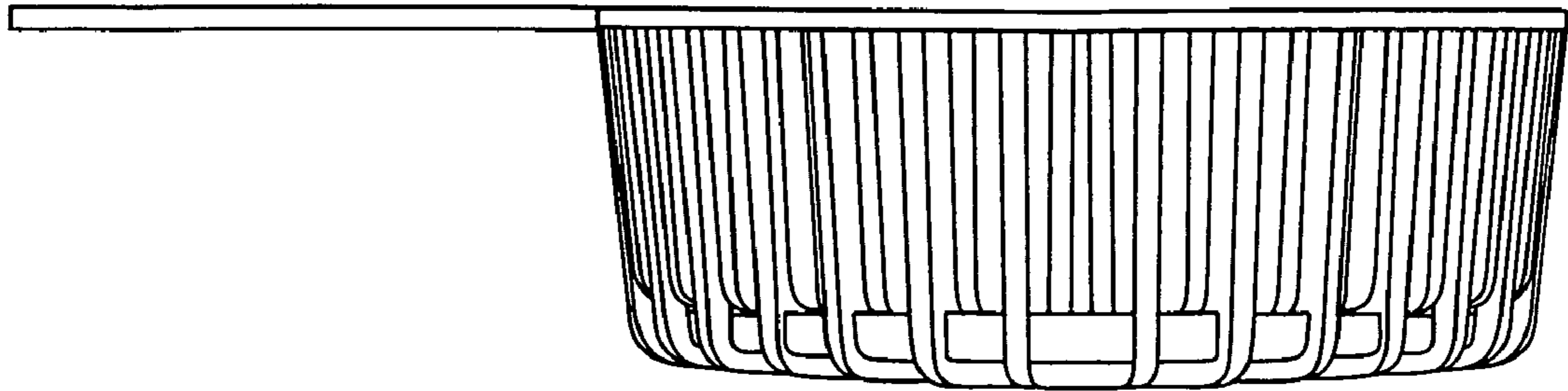

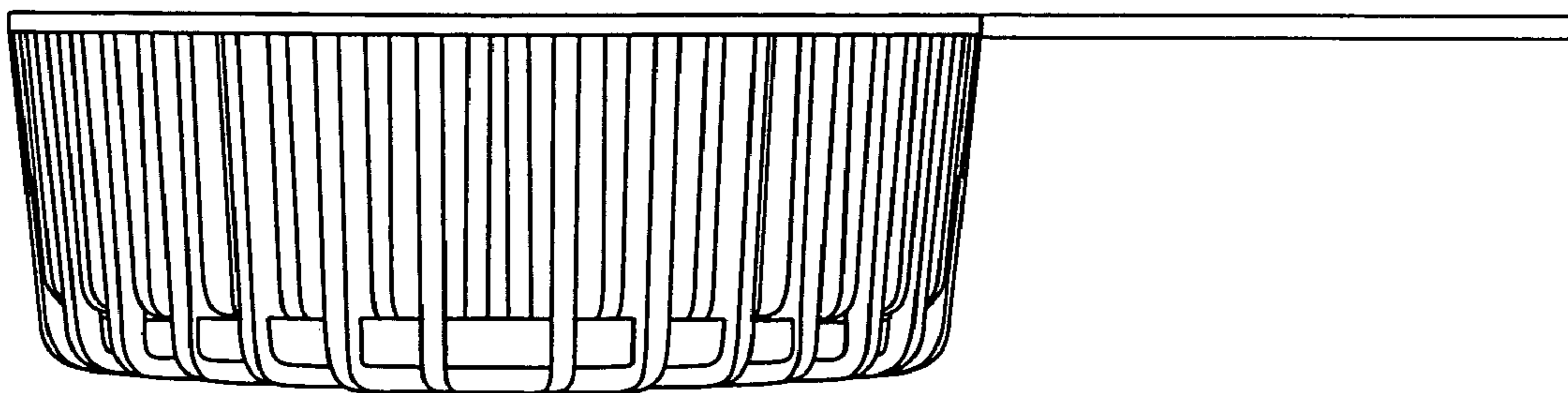

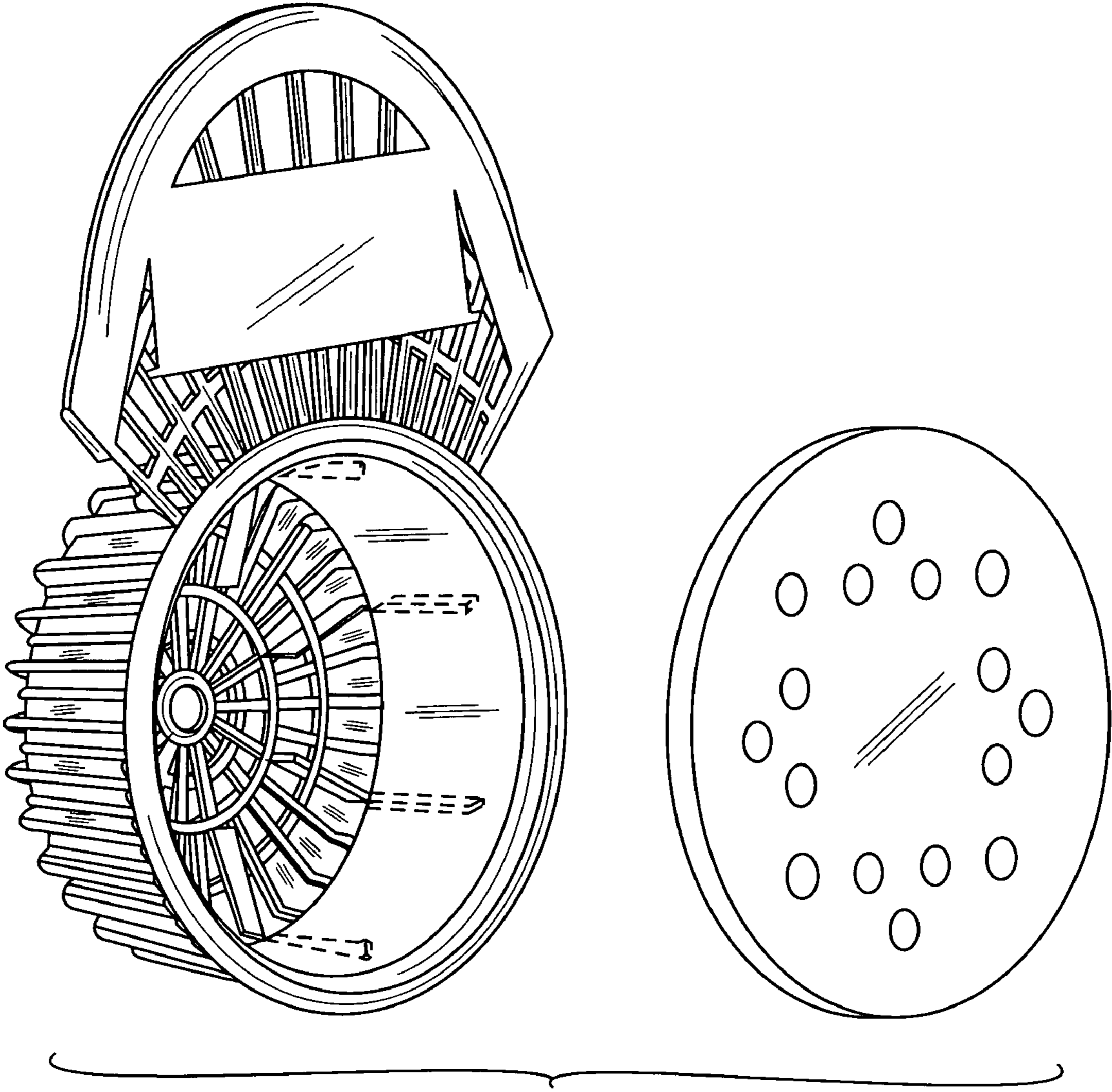
