FIG. 5 is a bottom view.

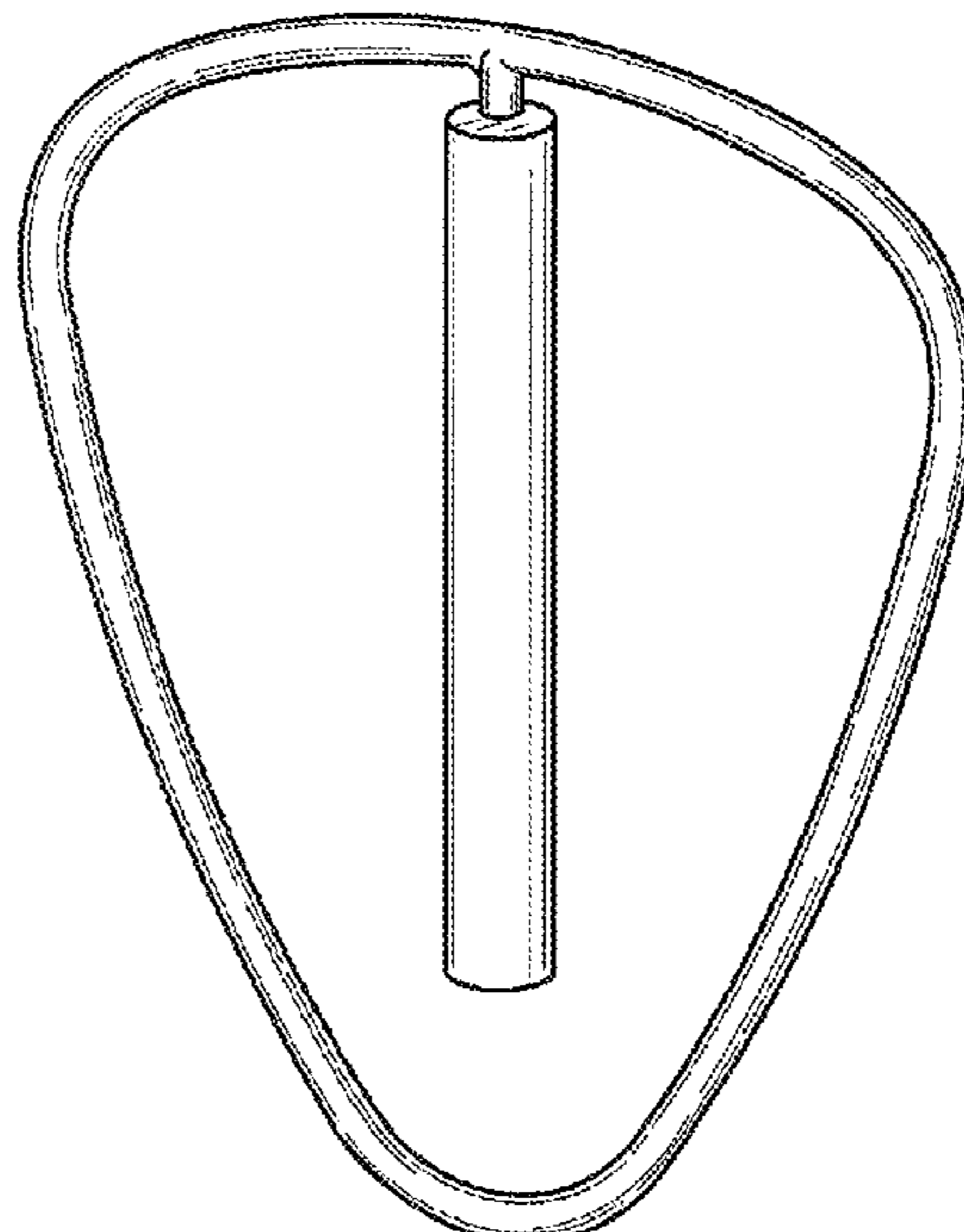

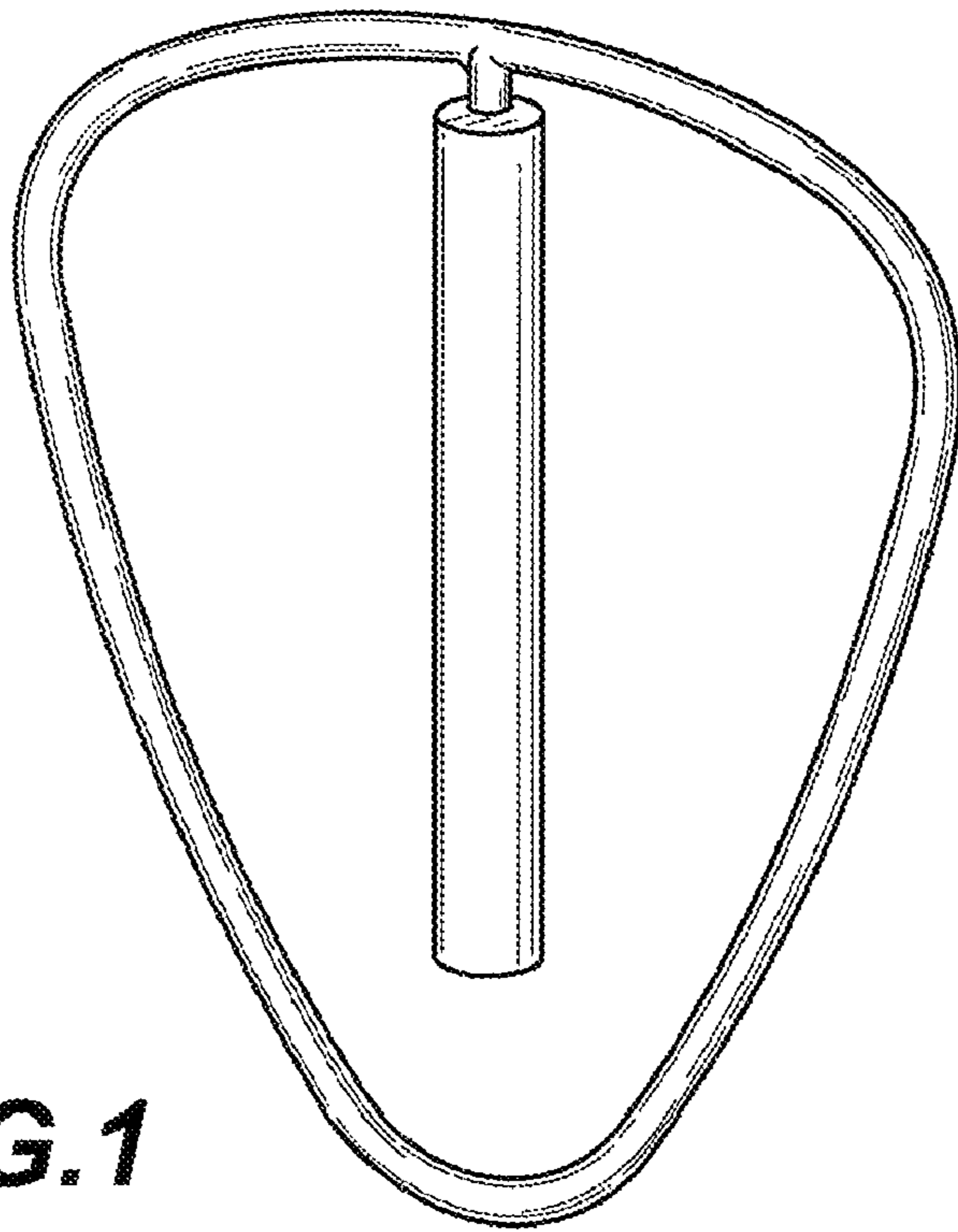

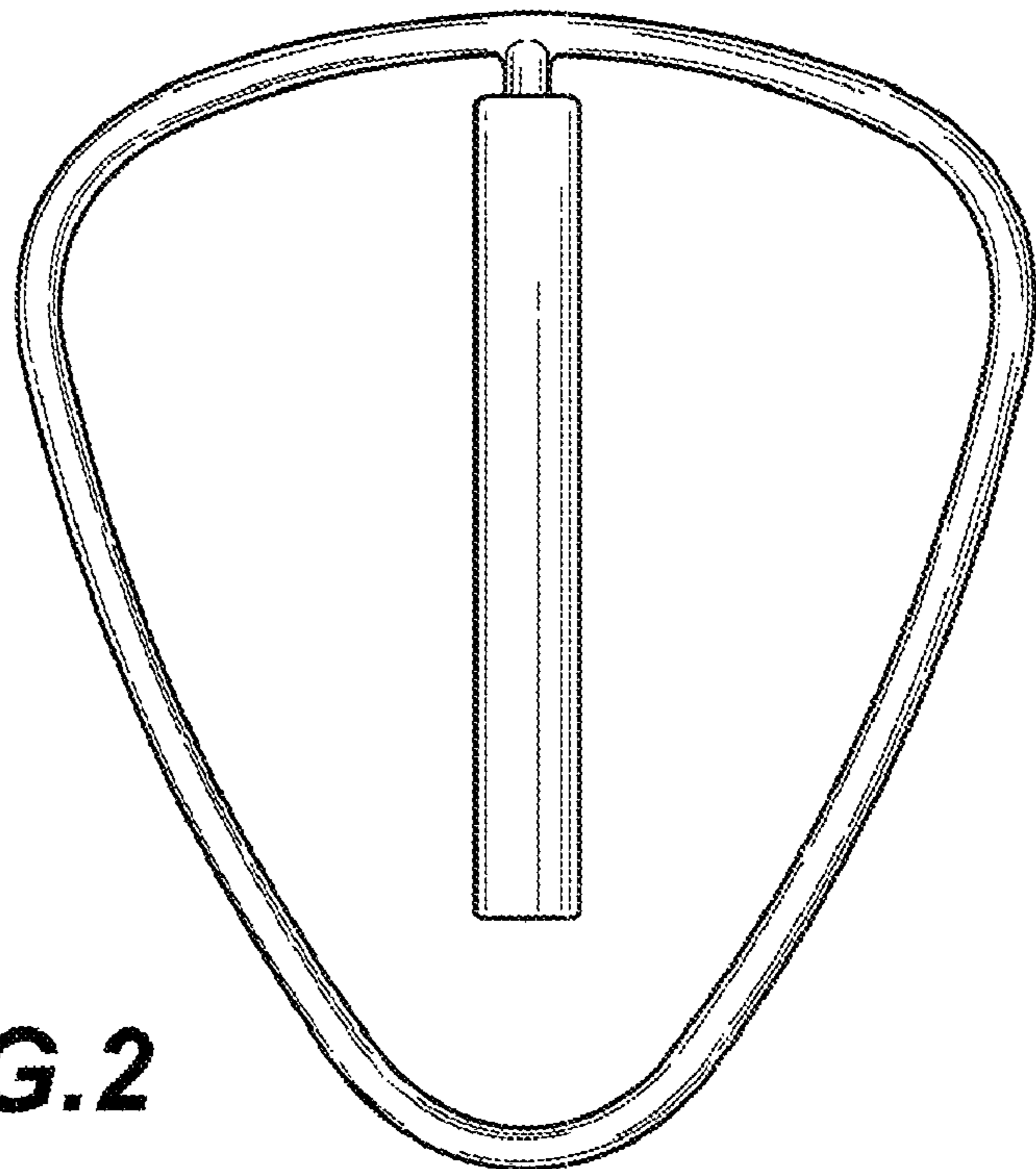

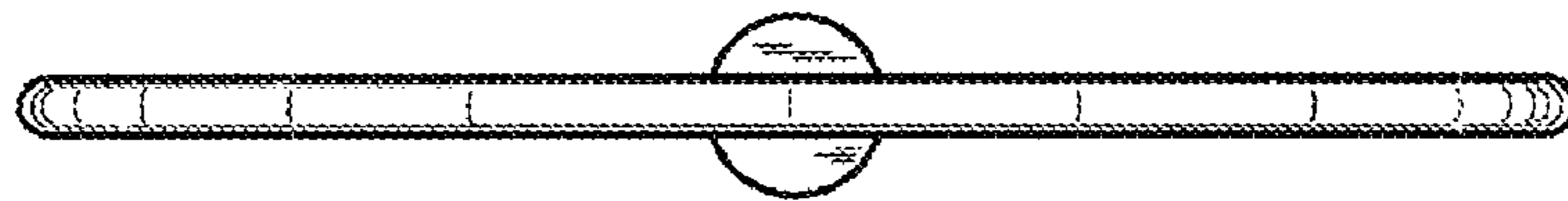

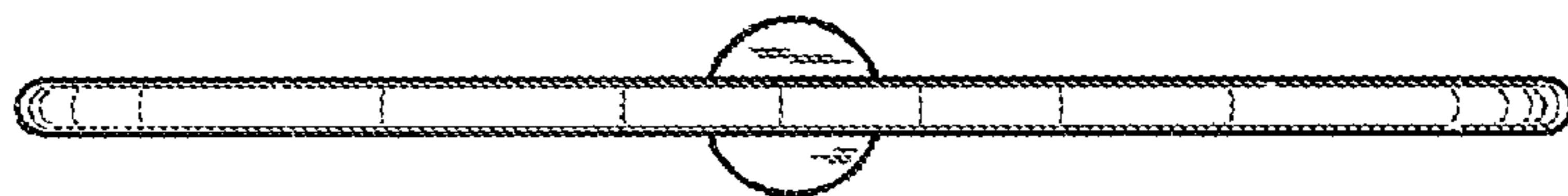
