FIG. 4 is a first side view thereof;

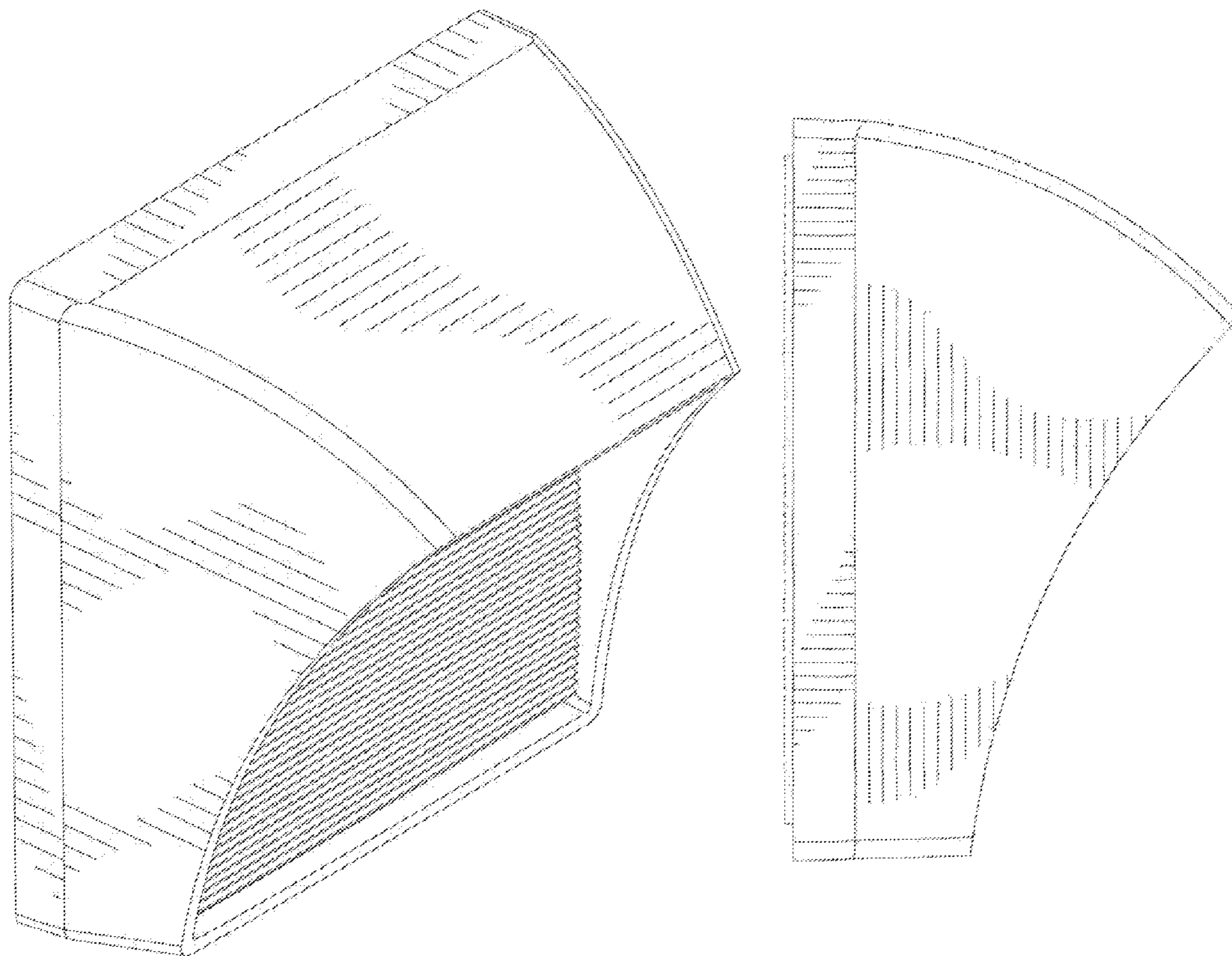
FIG. 5 is a second side view thereof;

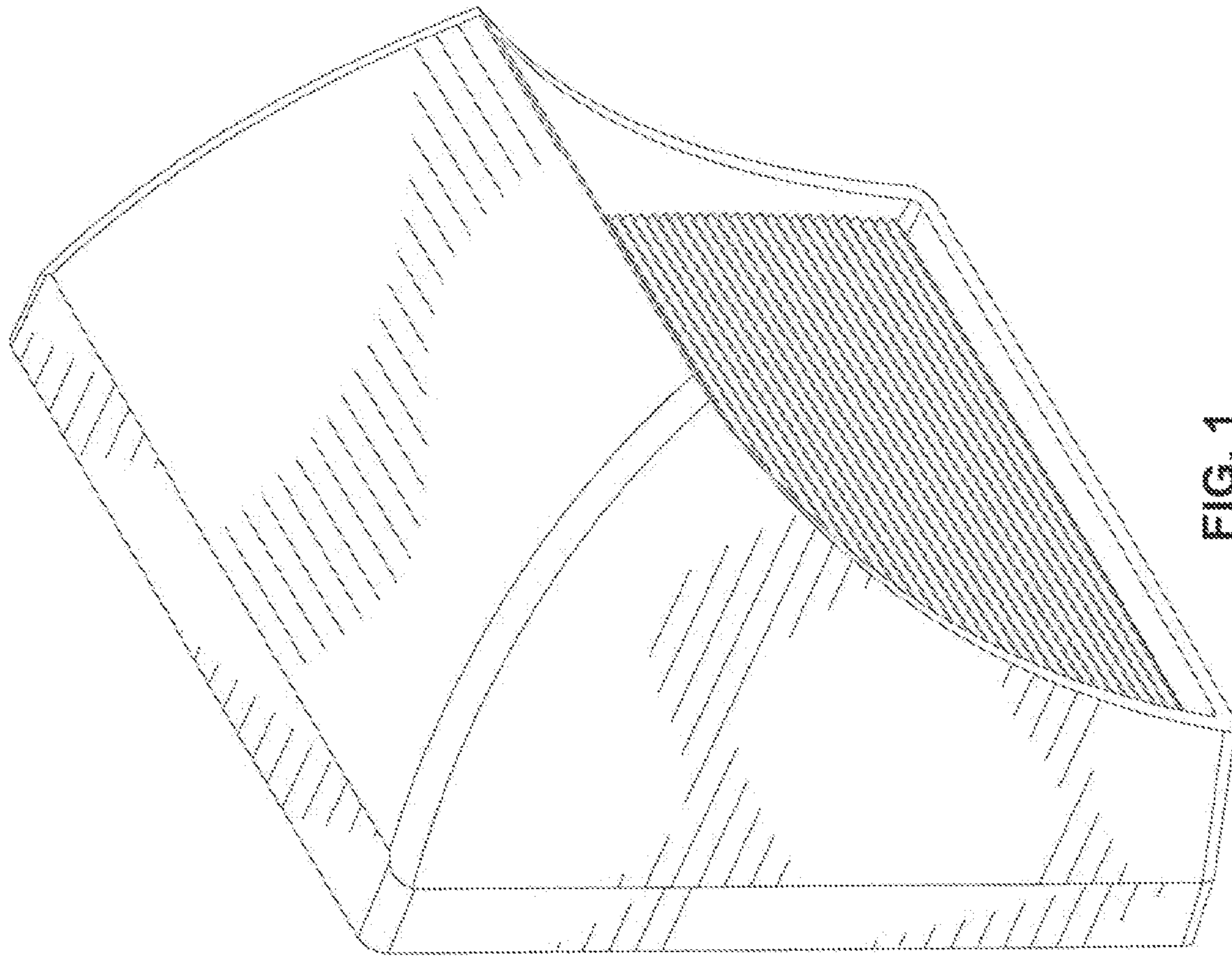

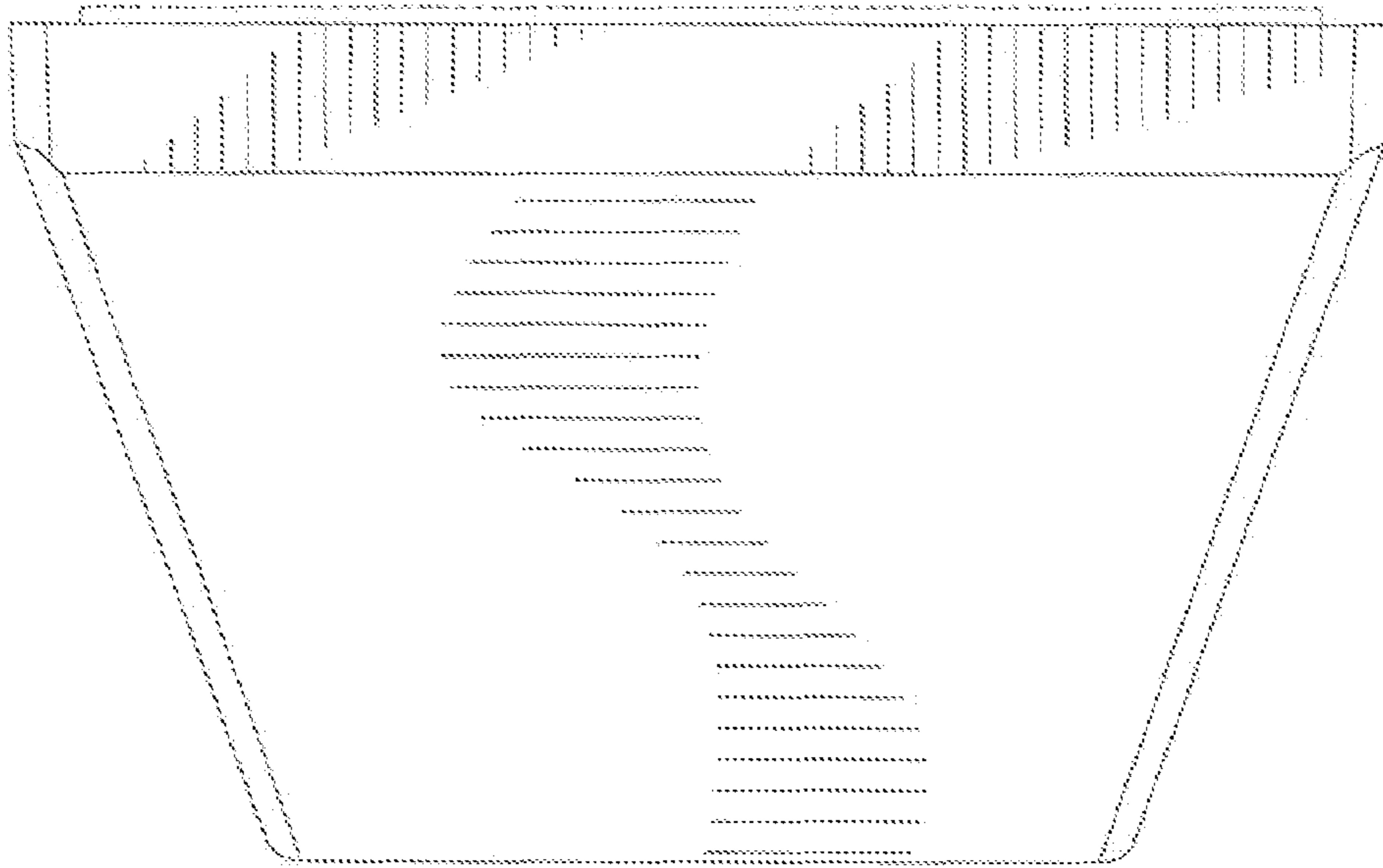

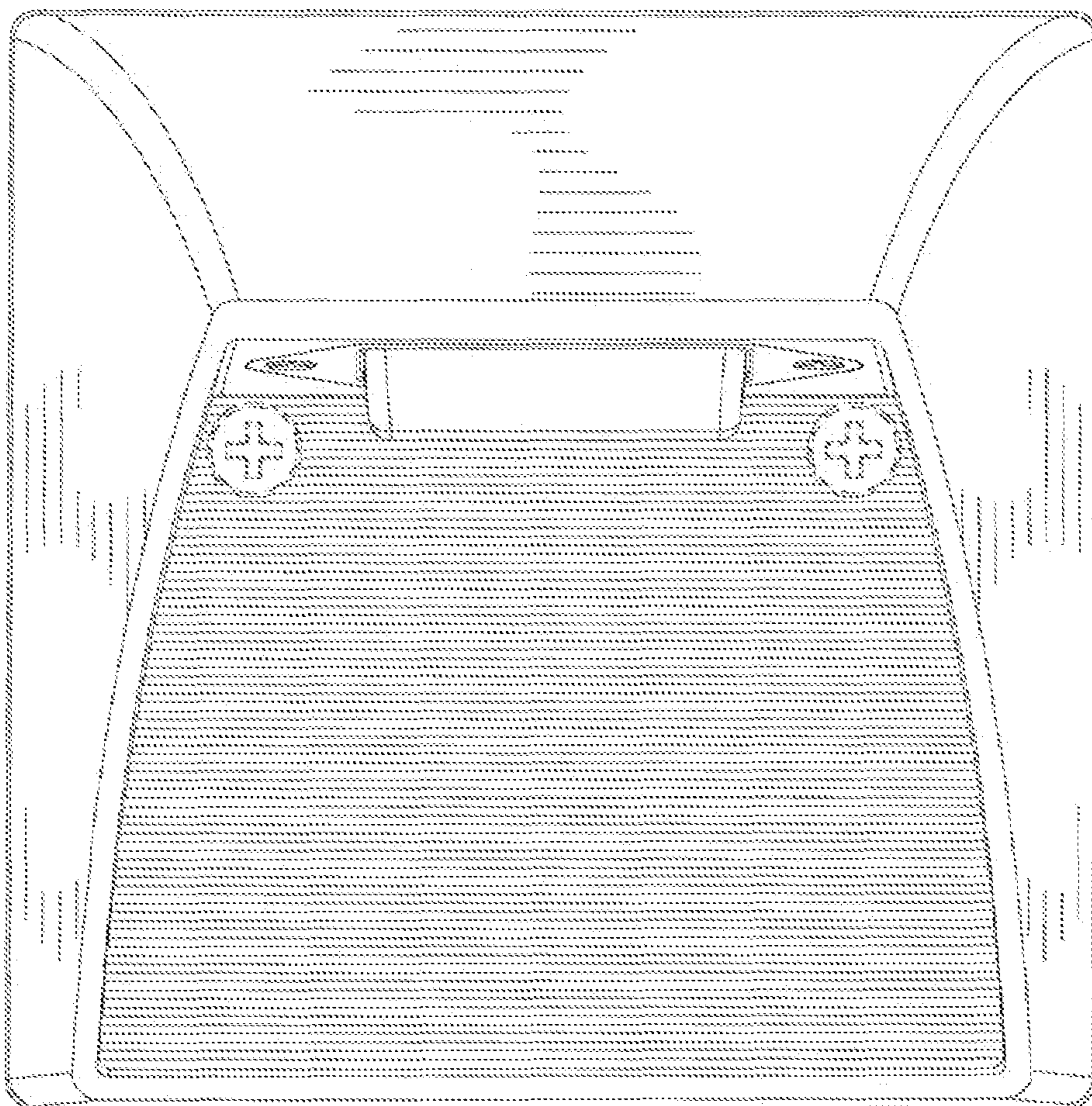

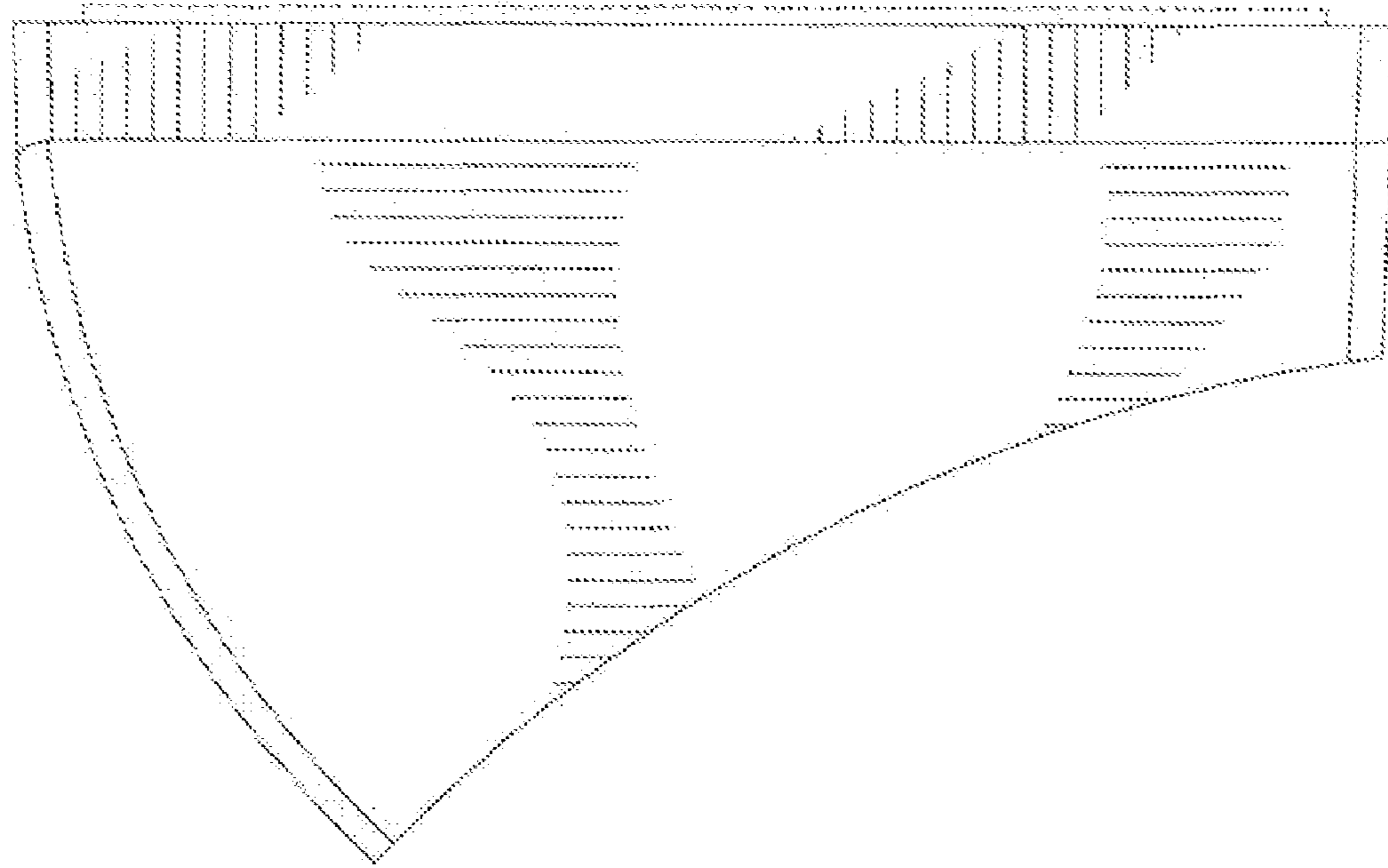

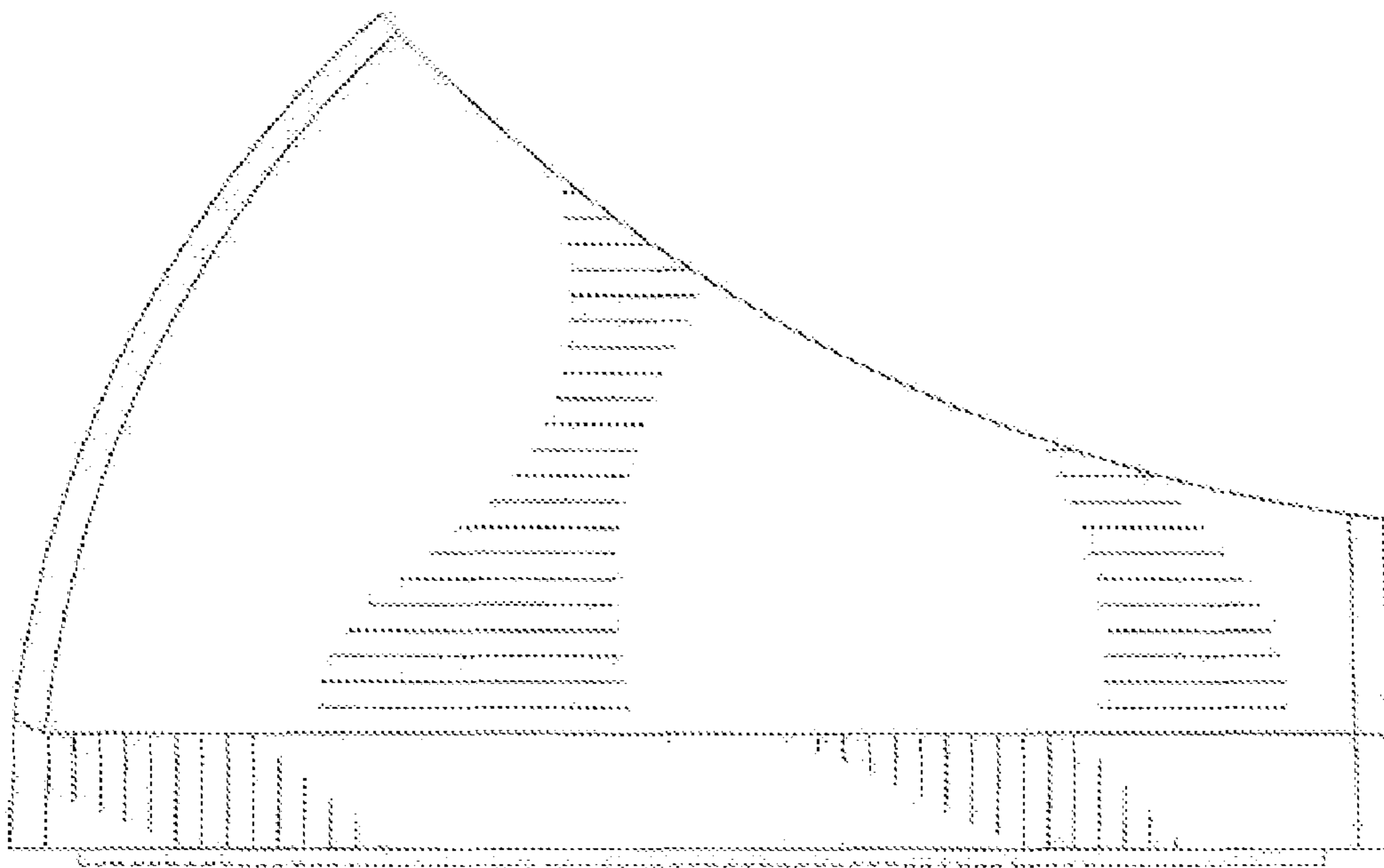

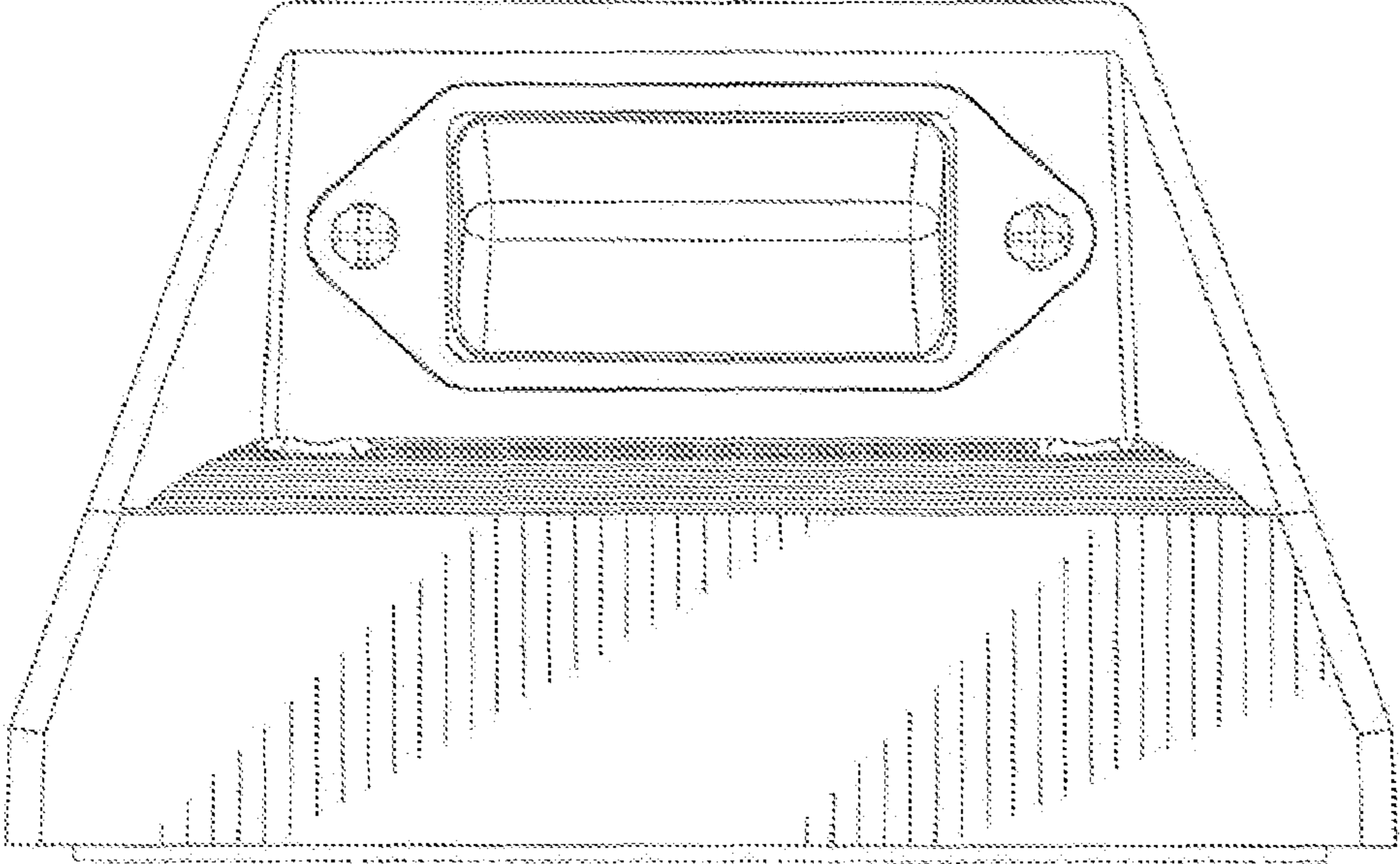

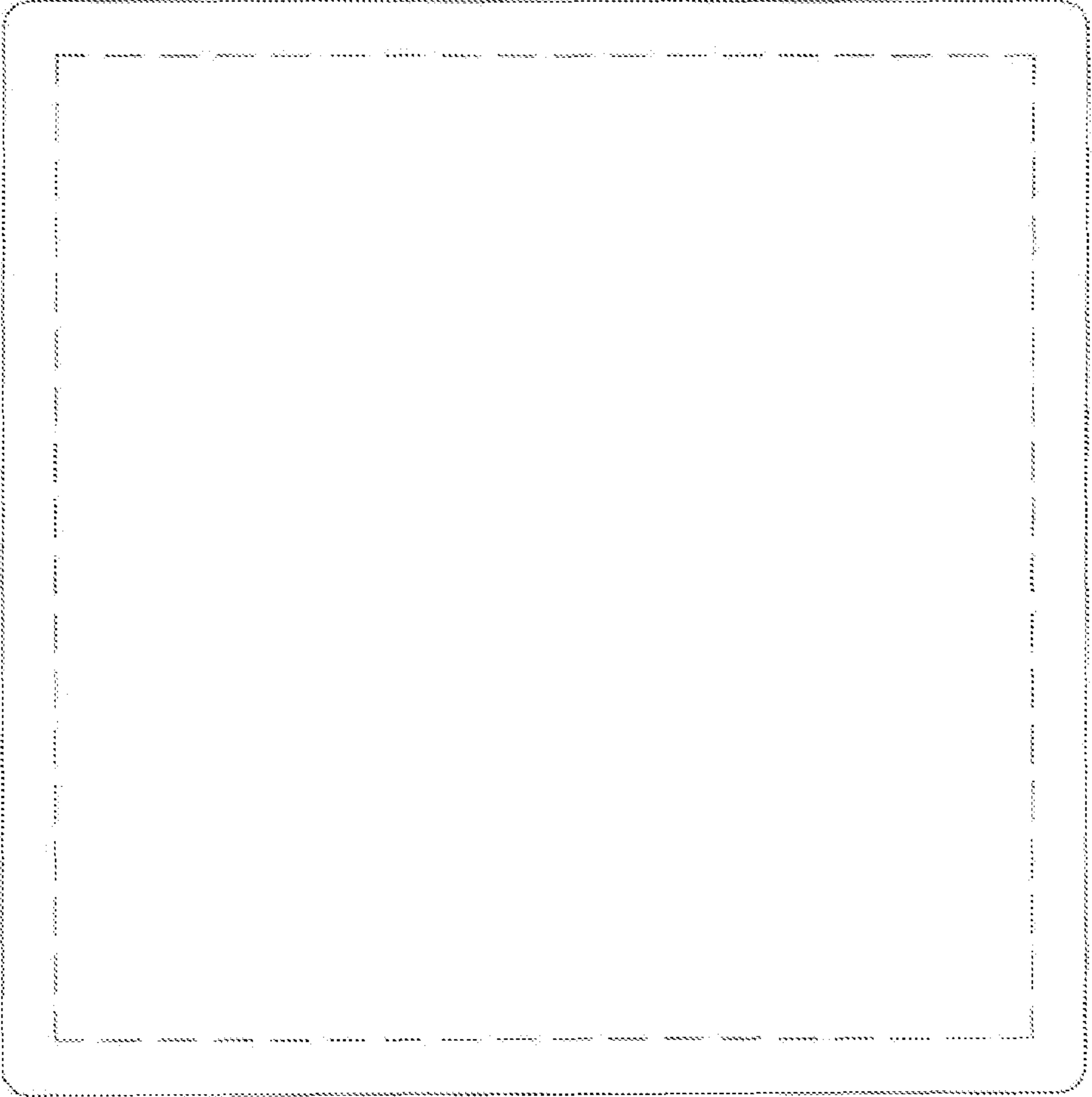
