(57) **CLAIM**

The ornamental design for a drawer divider device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a single unit of the device;

FIG. 2 is a rear perspective view of the device from FIG. 1;

FIG. 3 is a top plan view of the device from FIG. 1;

FIG. 4 is a front elevational view of the device from FIG. 1;

FIG. 5 is a right side elevational view of the device from FIG. 1;

FIG. 6 is a rear elevational view of the device from FIG. 1;

FIG. 7 is a left side elevational view of the device from FIG. 1;

FIG. 8 is a bottom plan view of the device from FIG. 1;

FIG. 9 is a front perspective view showing a plurality of single units attached end to end;

FIG. 10 is a front perspective view showing the separation of units along the square wave seam;

FIG. 11 is a perspective view showing the assembly motion for assembling the units of FIG. 10 along their respective notches;

FIG. 12 is a perspective view showing the finished assembly of the units of FIG. 10 and 11;

FIG. 13 is a front perspective view showing the separation of units along a notch seam using a first motion;

FIG. 14 is a front perspective view showing the units from FIG. 13 once separated;

FIG. 15 is a perspective view showing the separation of units along a notch seam using a second motion;

FIG. 16 is a perspective view showing the units from FIG. 15 once separated;

FIG. 17 is a perspective view showing an assembly motion for assembling the unit from FIG. 14 into a notch seam of another piece;

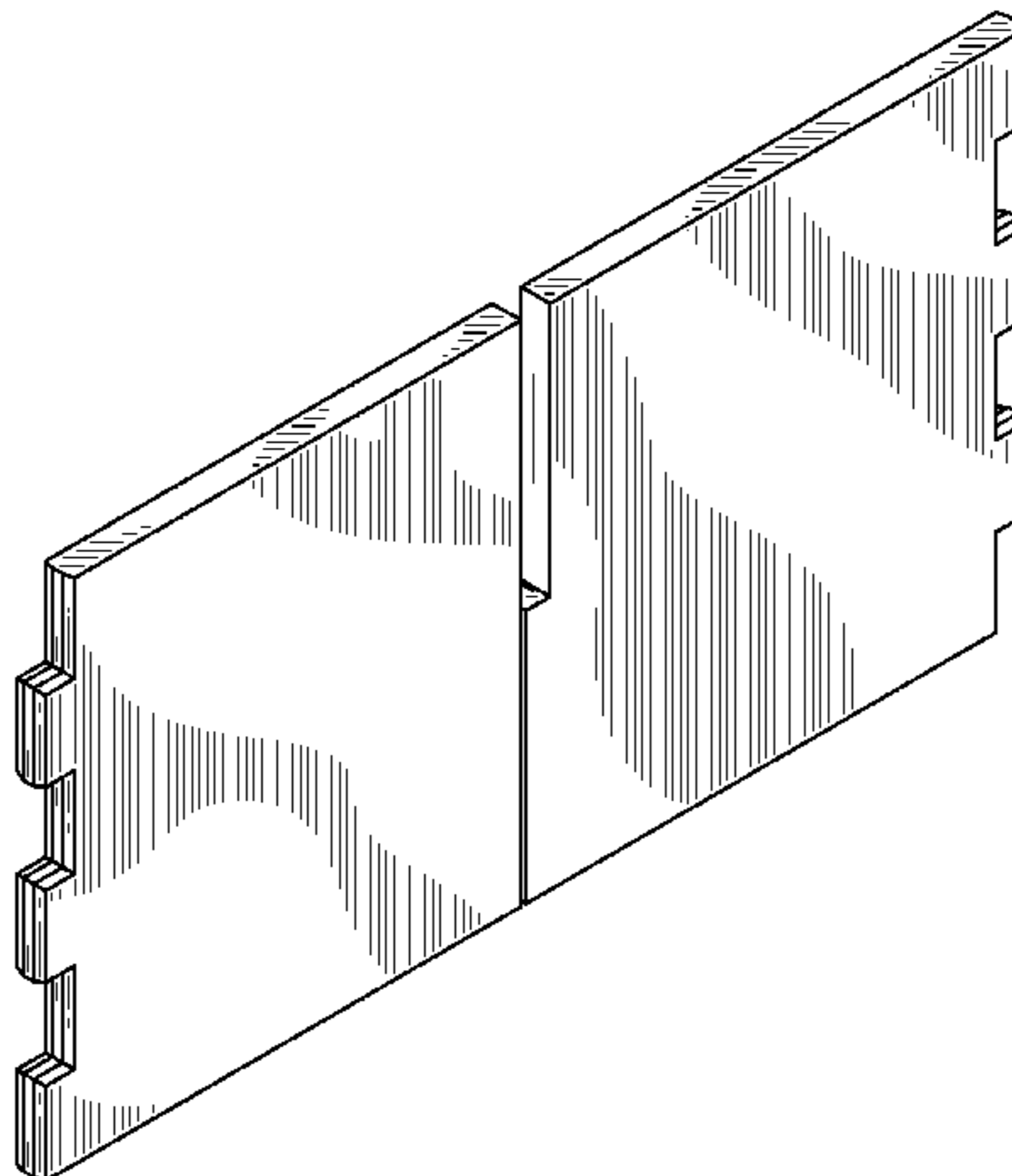
FIG. 18 is a perspective view showing the completed assembly from FIG. 17;

FIG. 19 is a perspective view showing the completed assembly of a plurality of different pieces;

FIG. 20 is a perspective view showing the re-connection of a square wave seam making an angle greater than 90 degrees; and,

FIG. 21 is a perspective view showing the re-connection of a square wave seam making an angle less than 90 degrees.

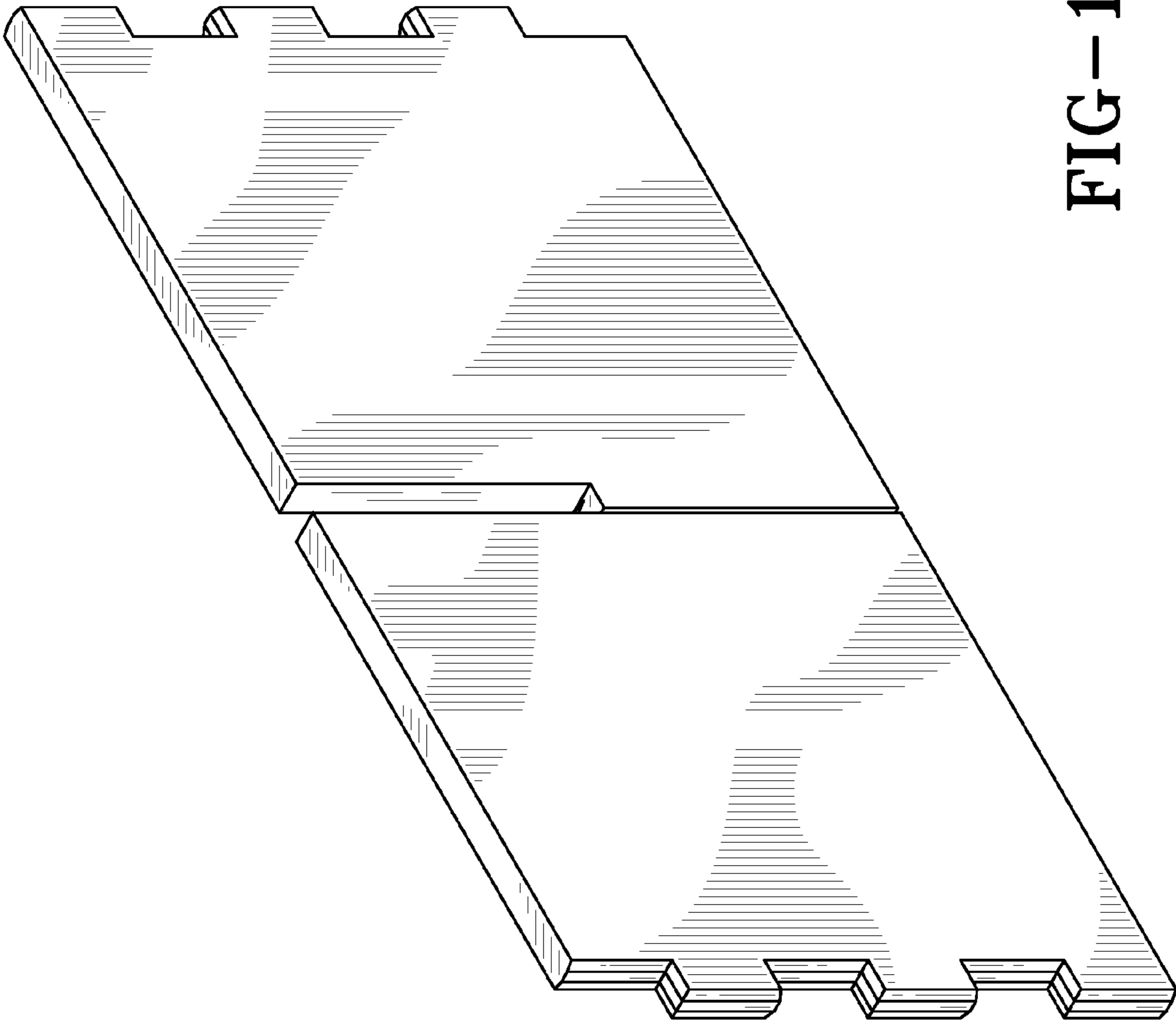

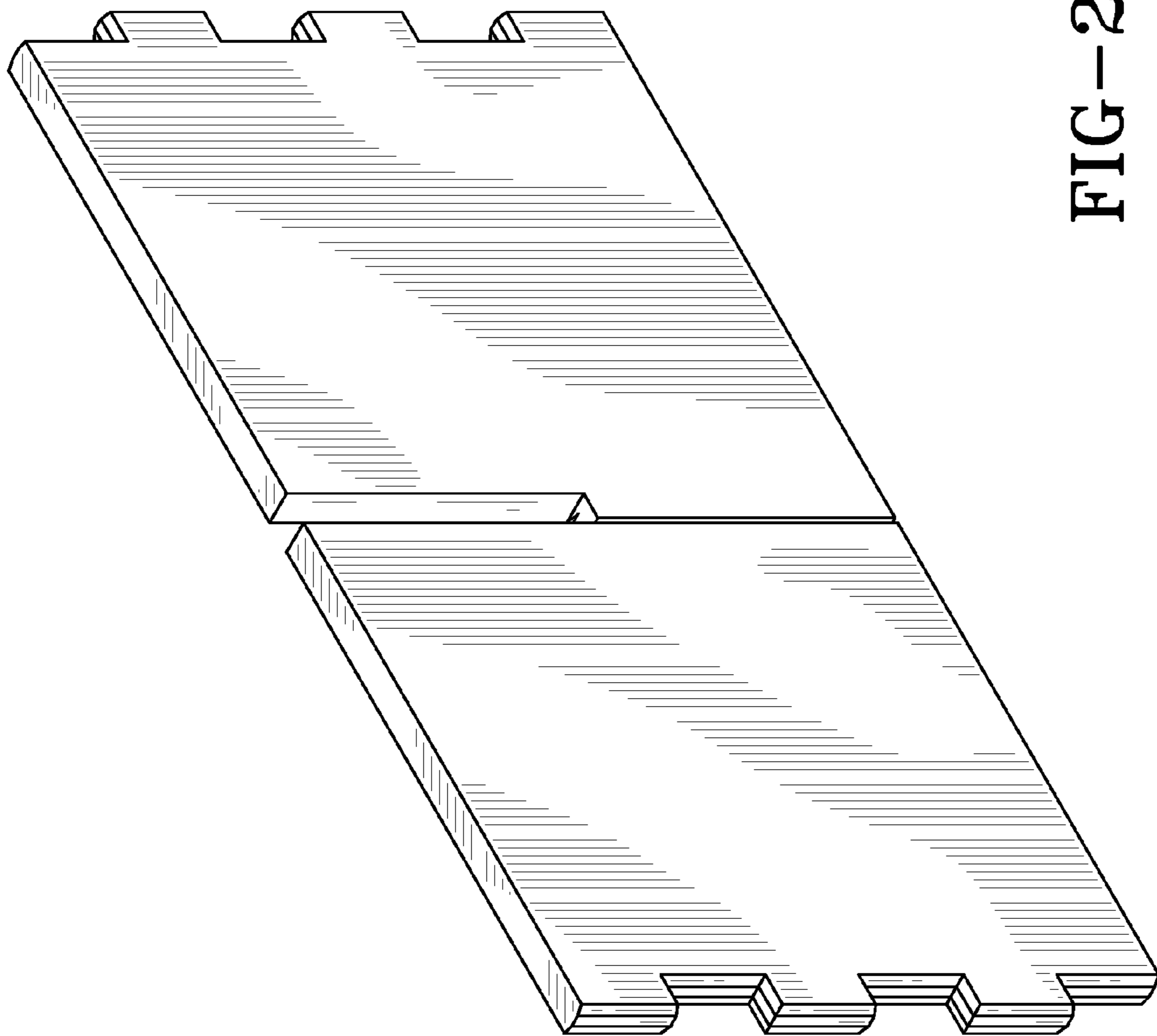

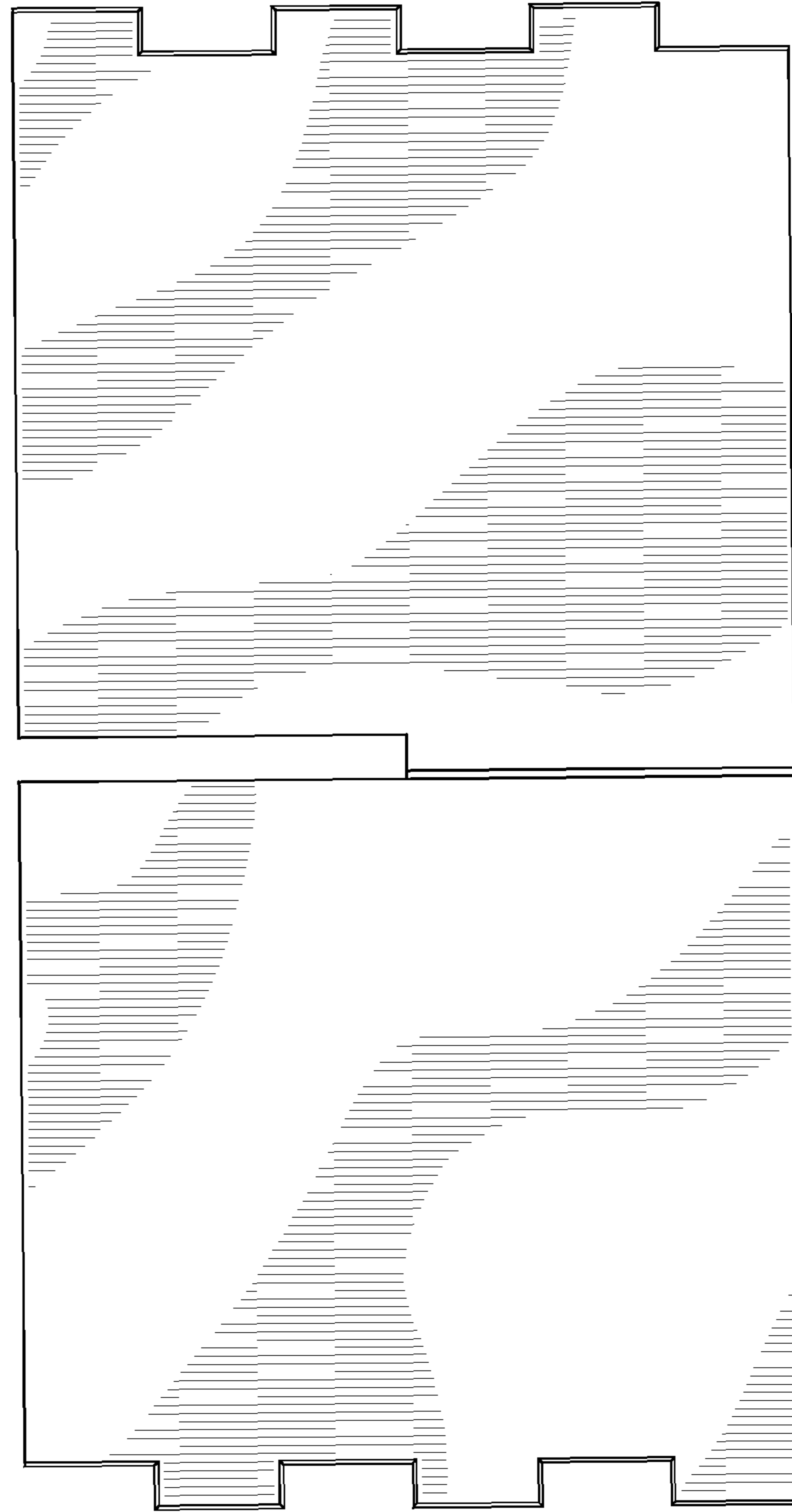

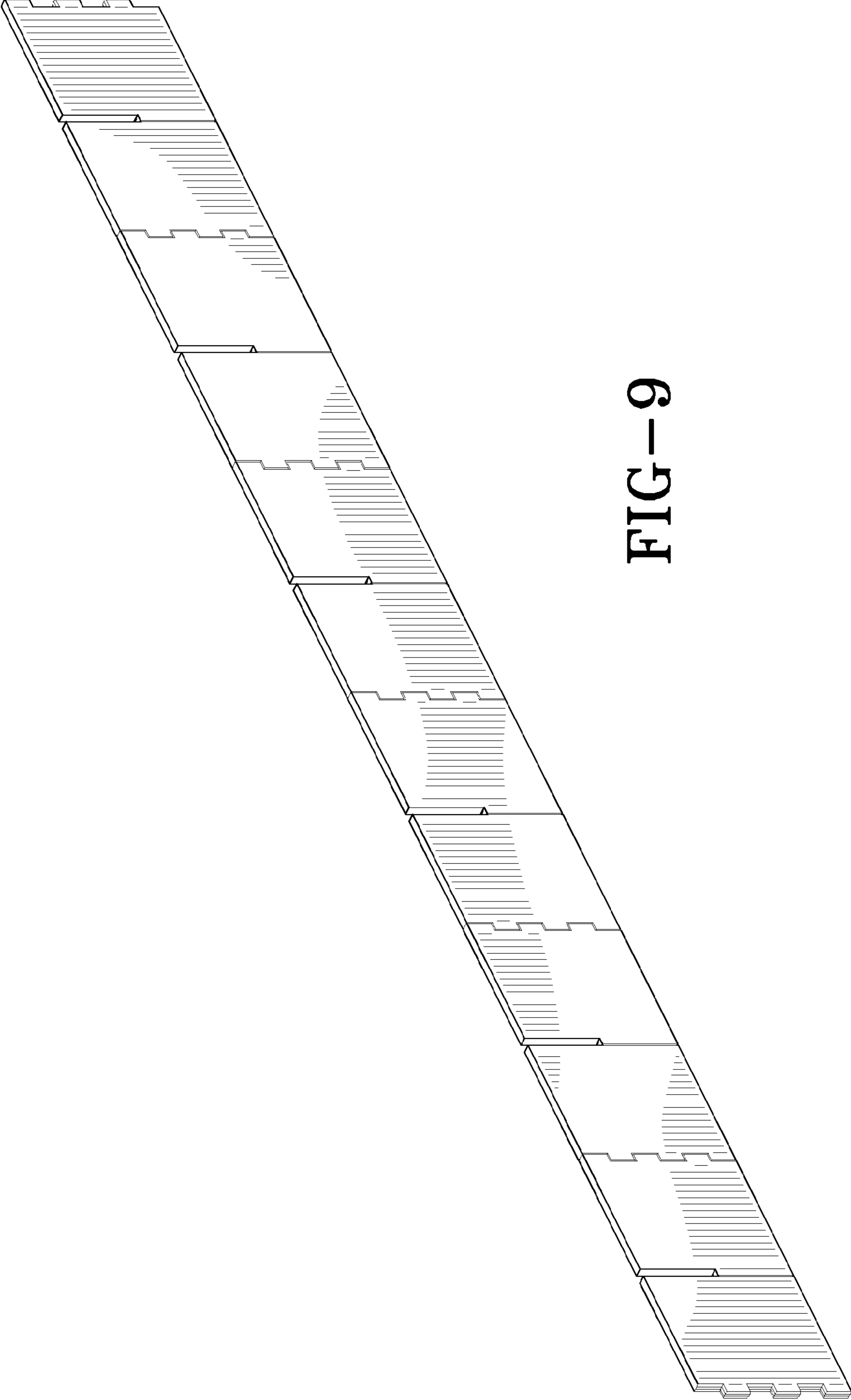

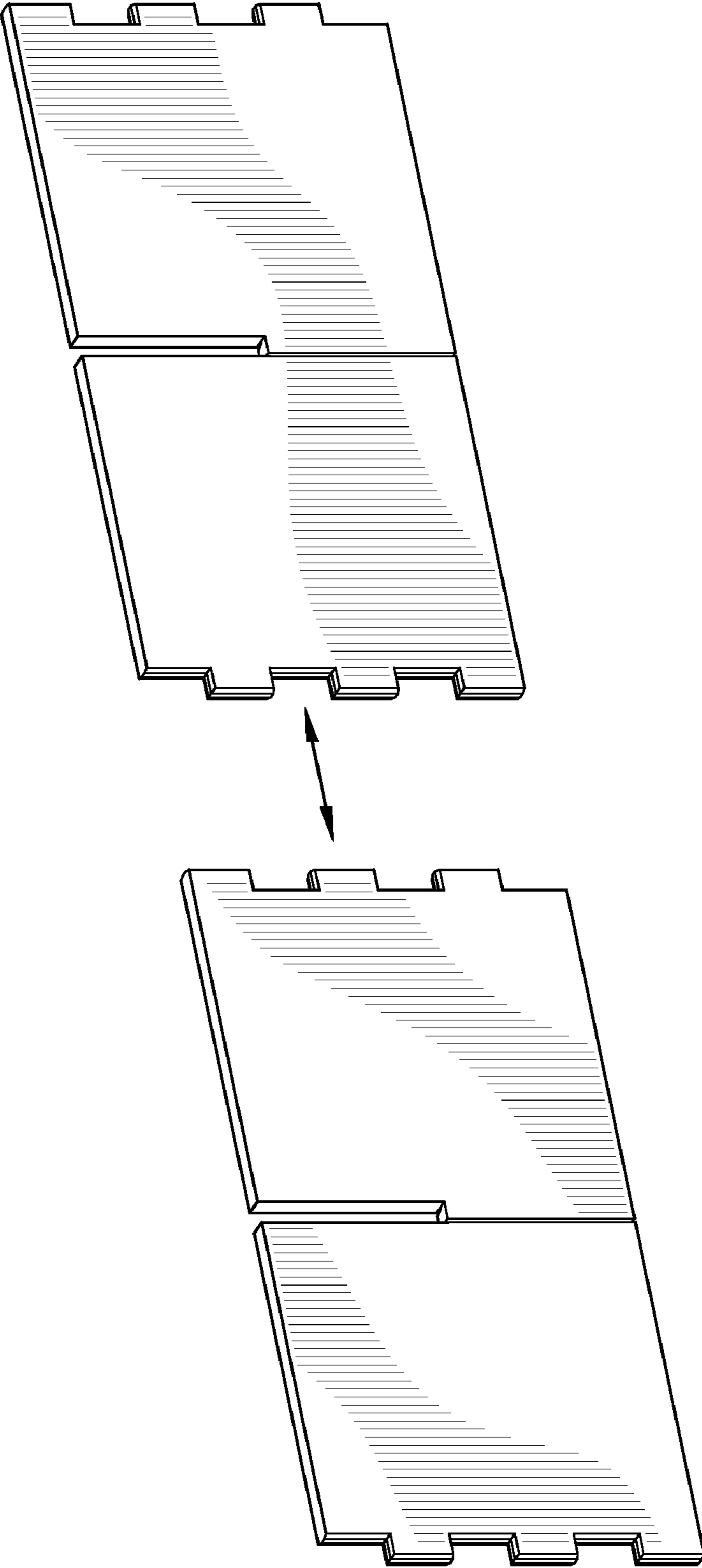

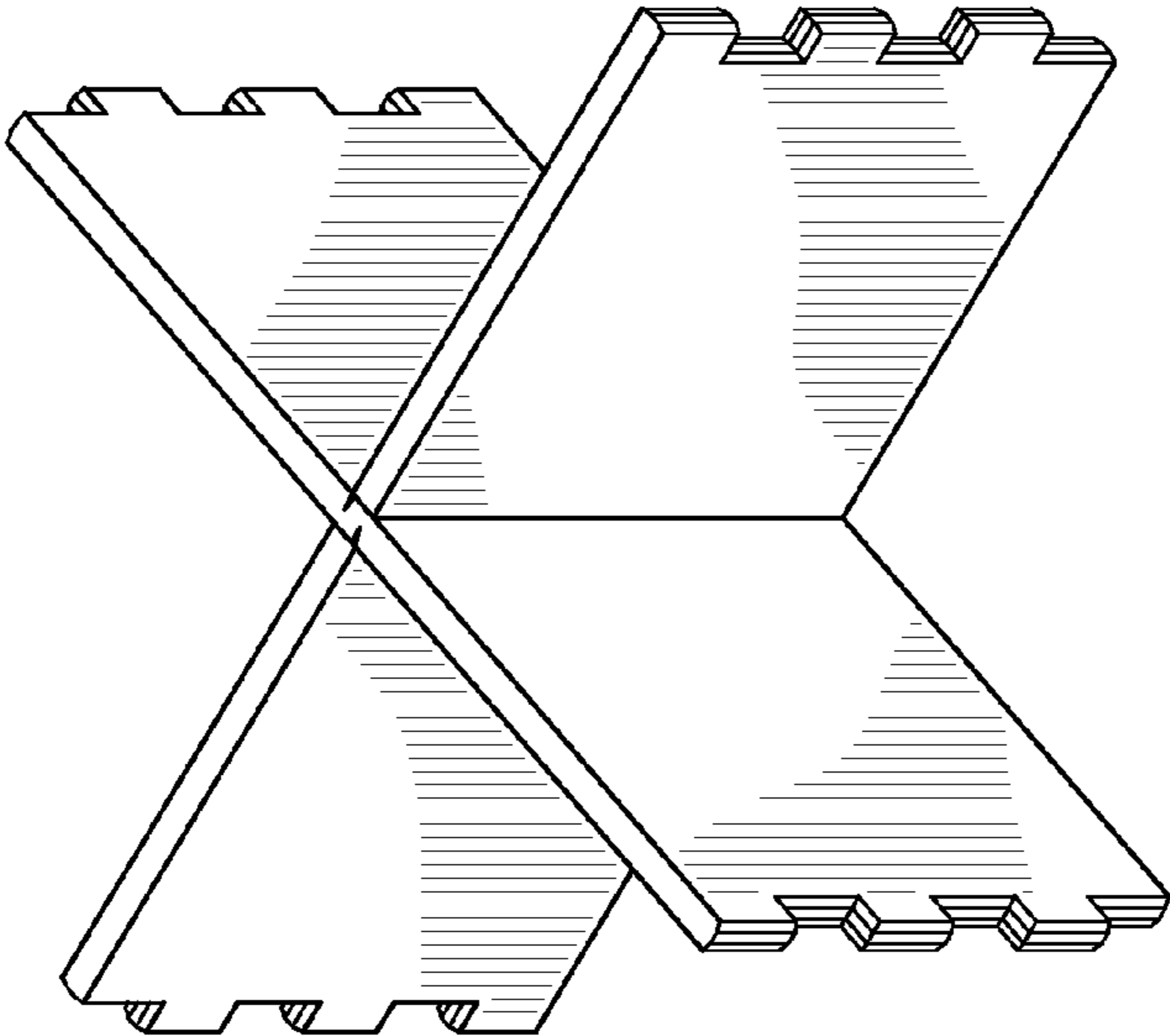

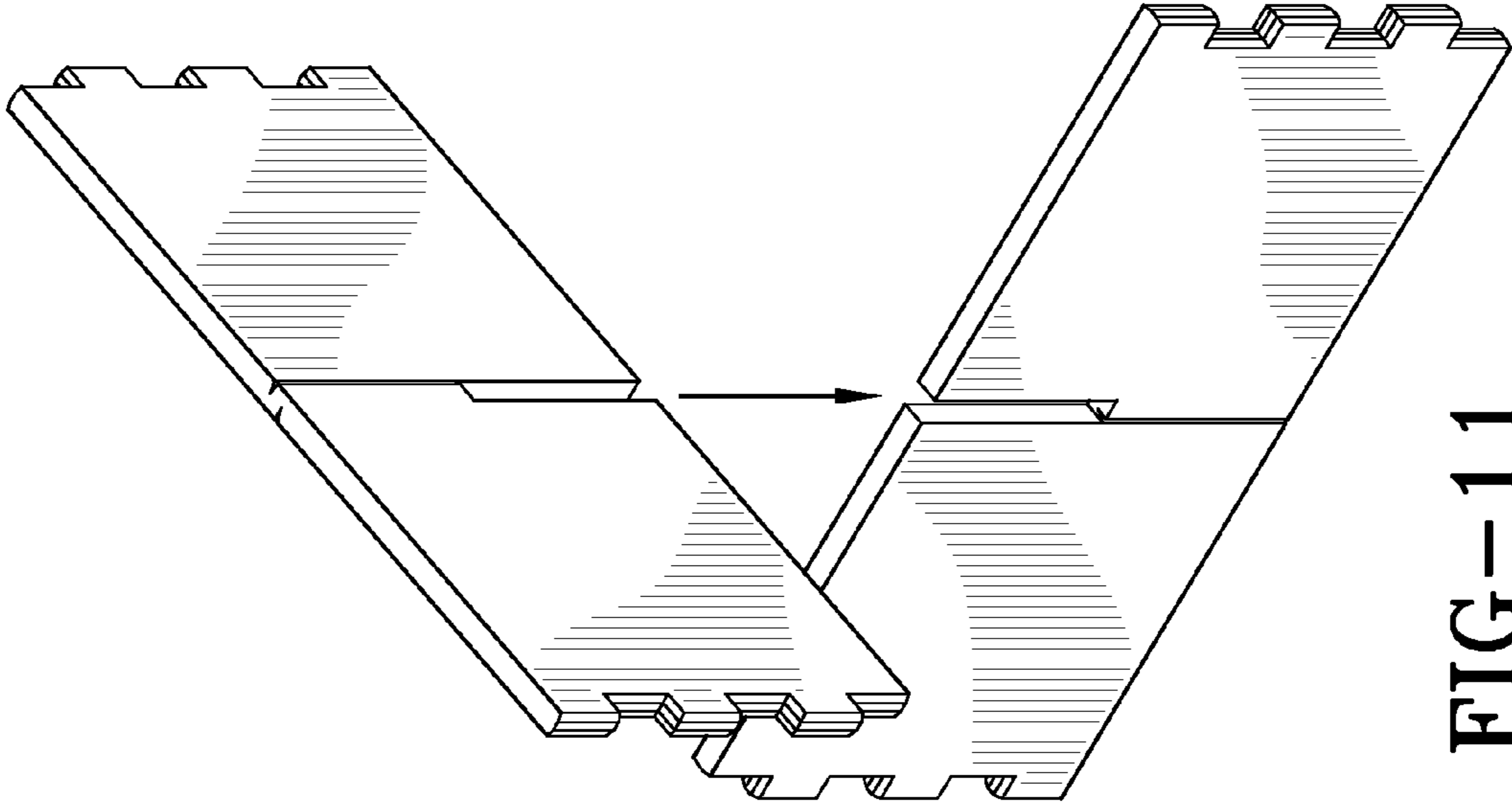

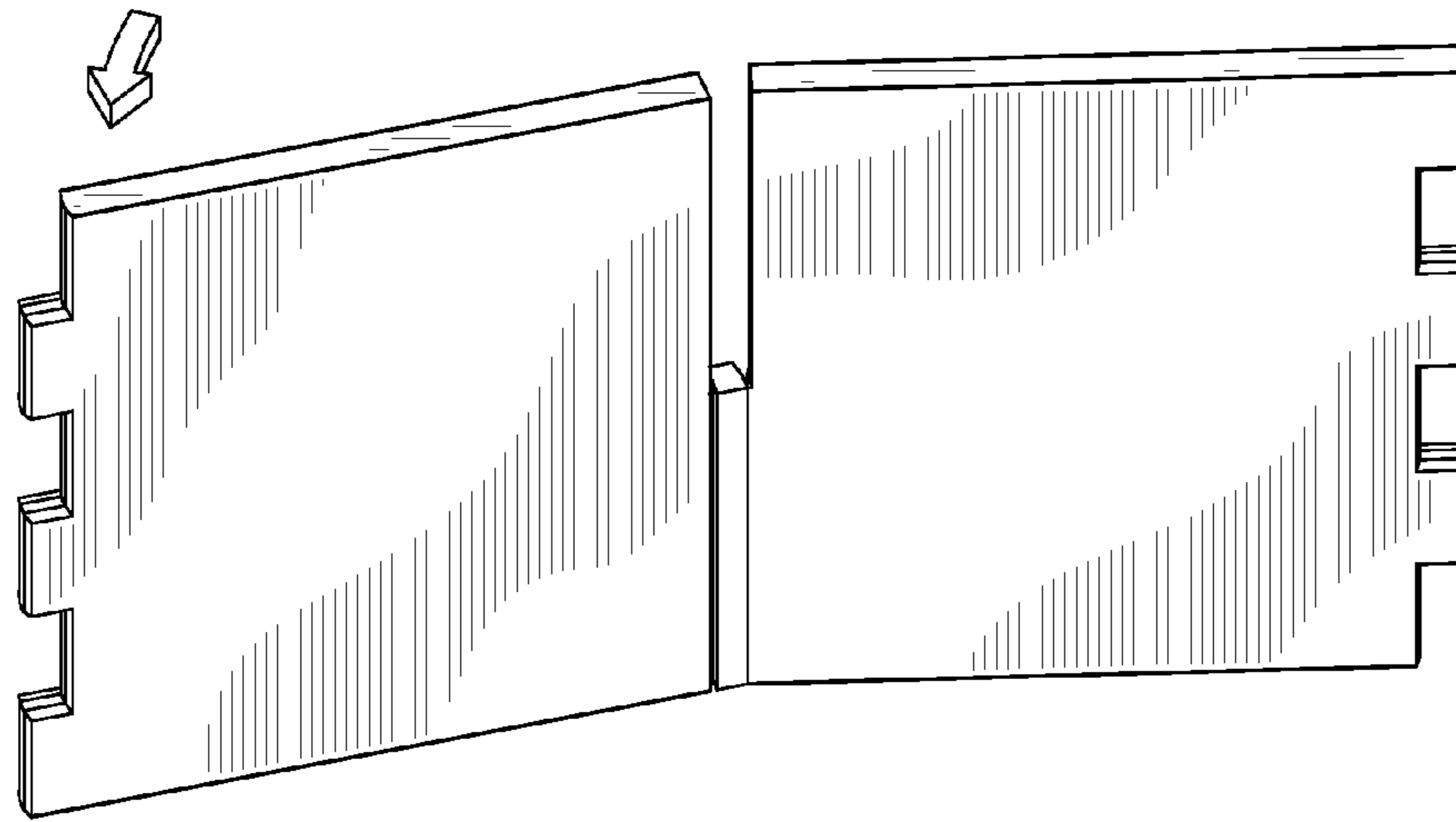

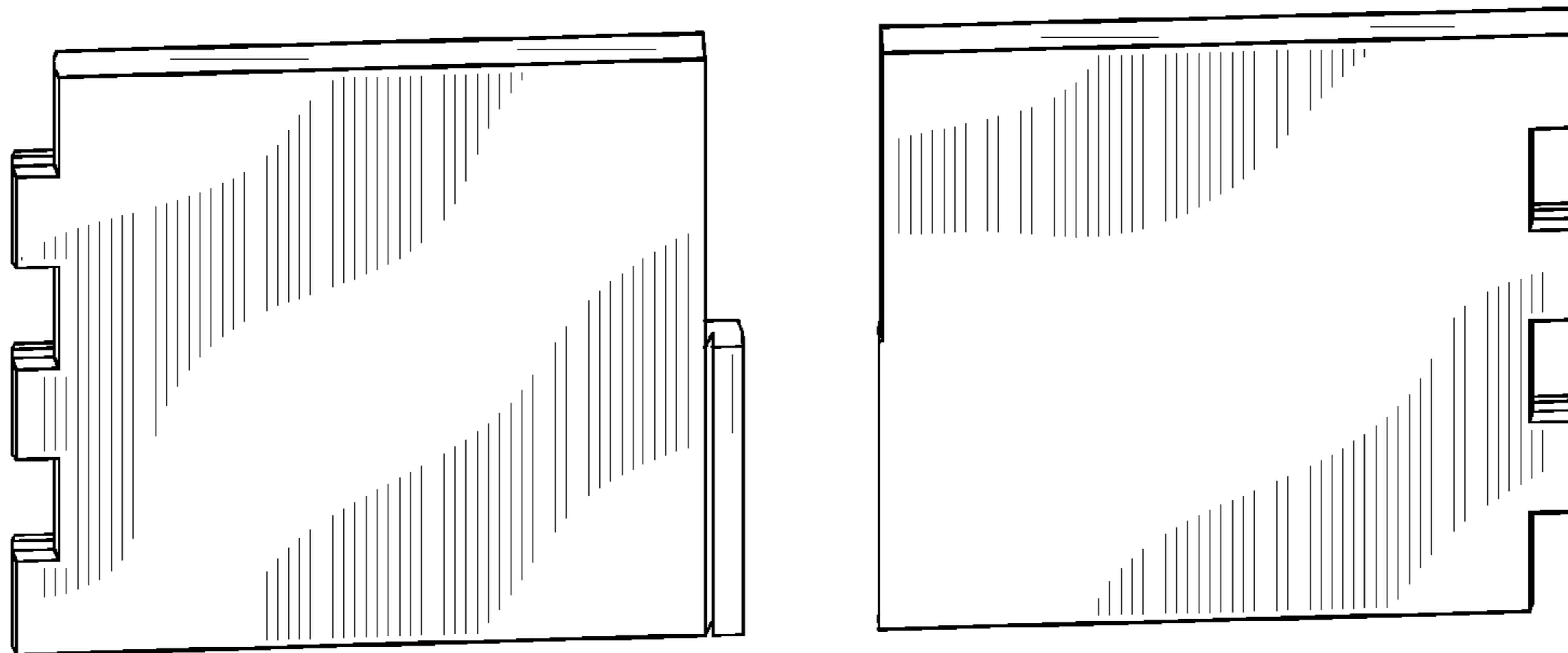

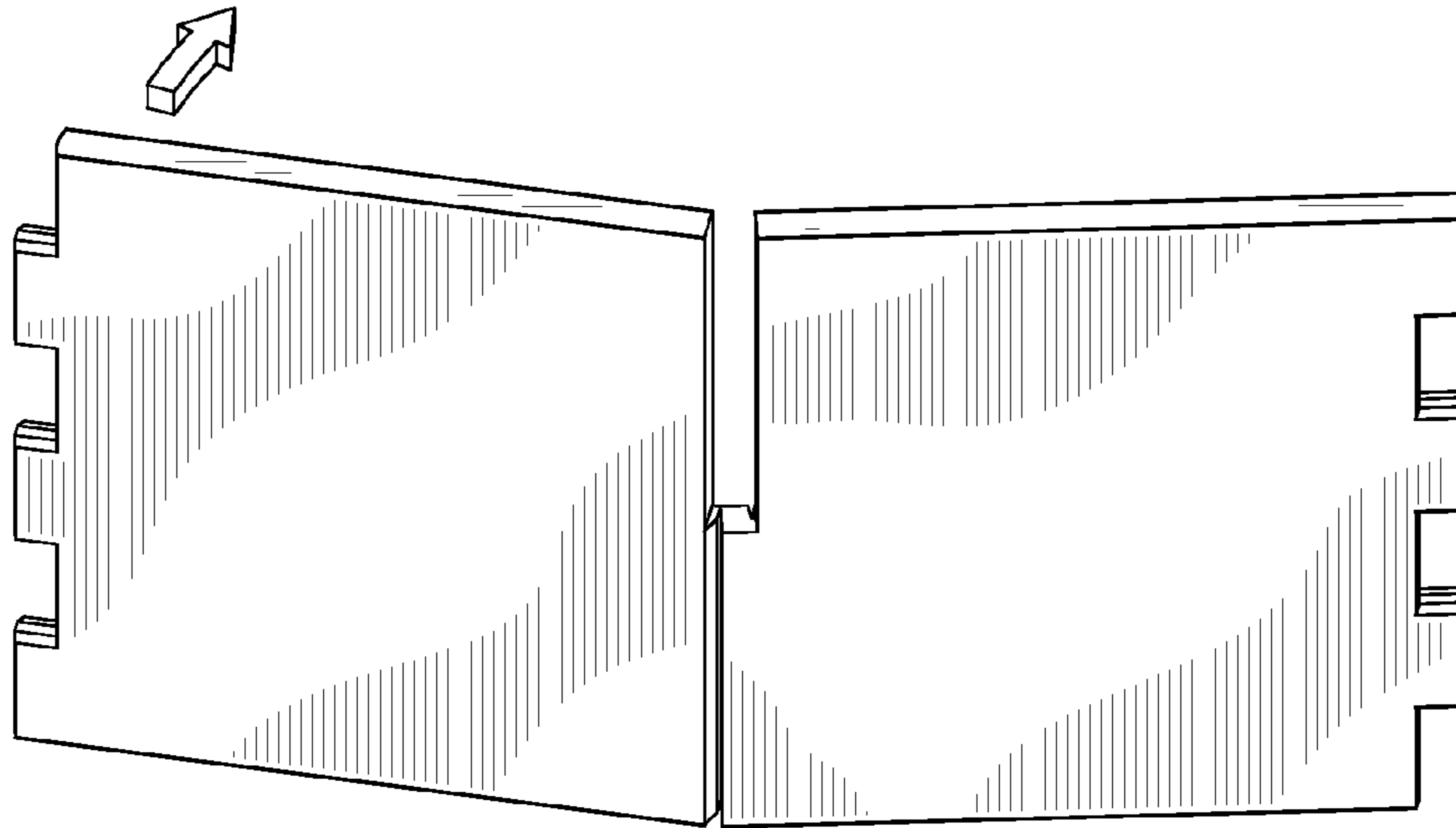

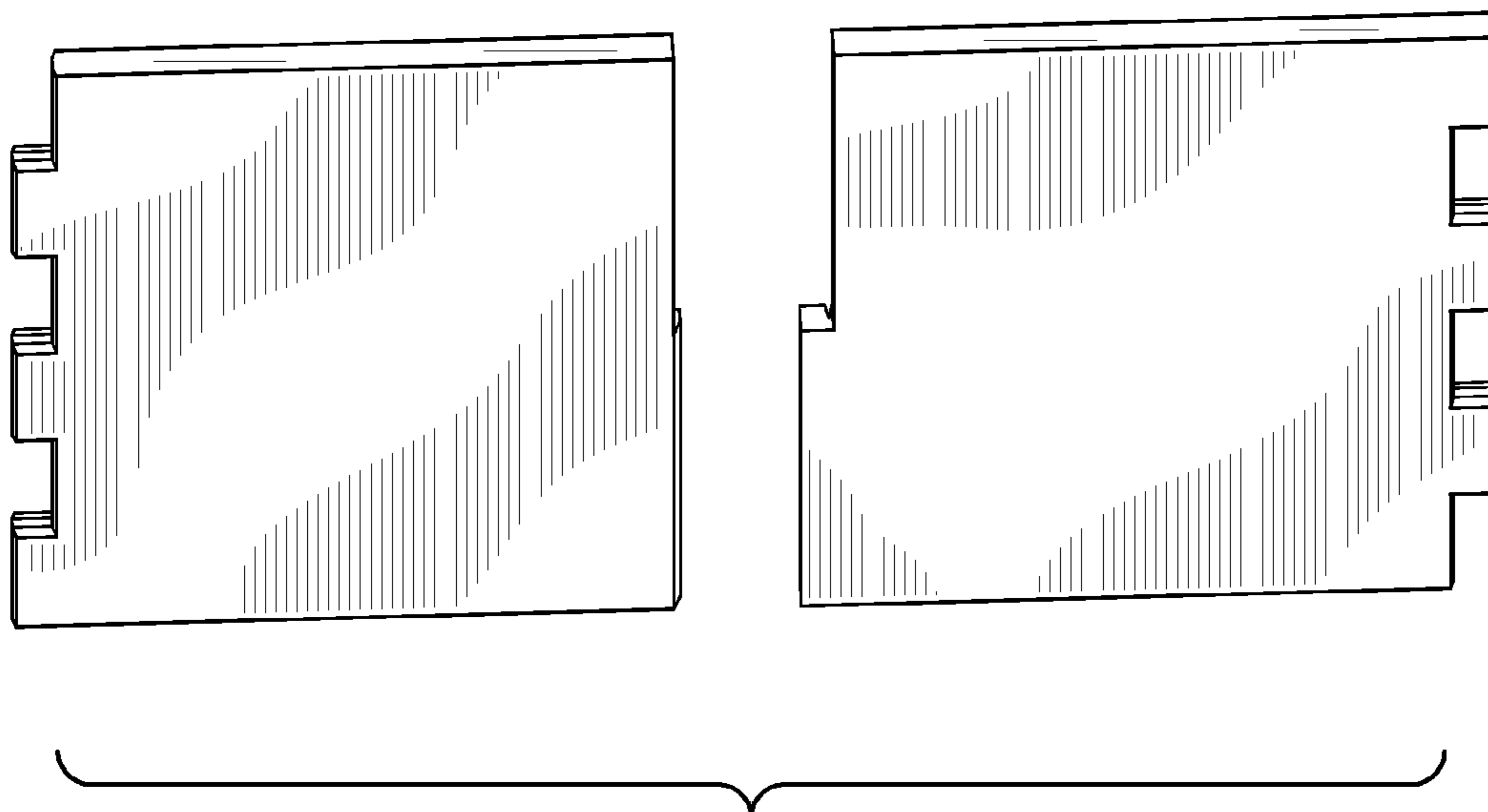

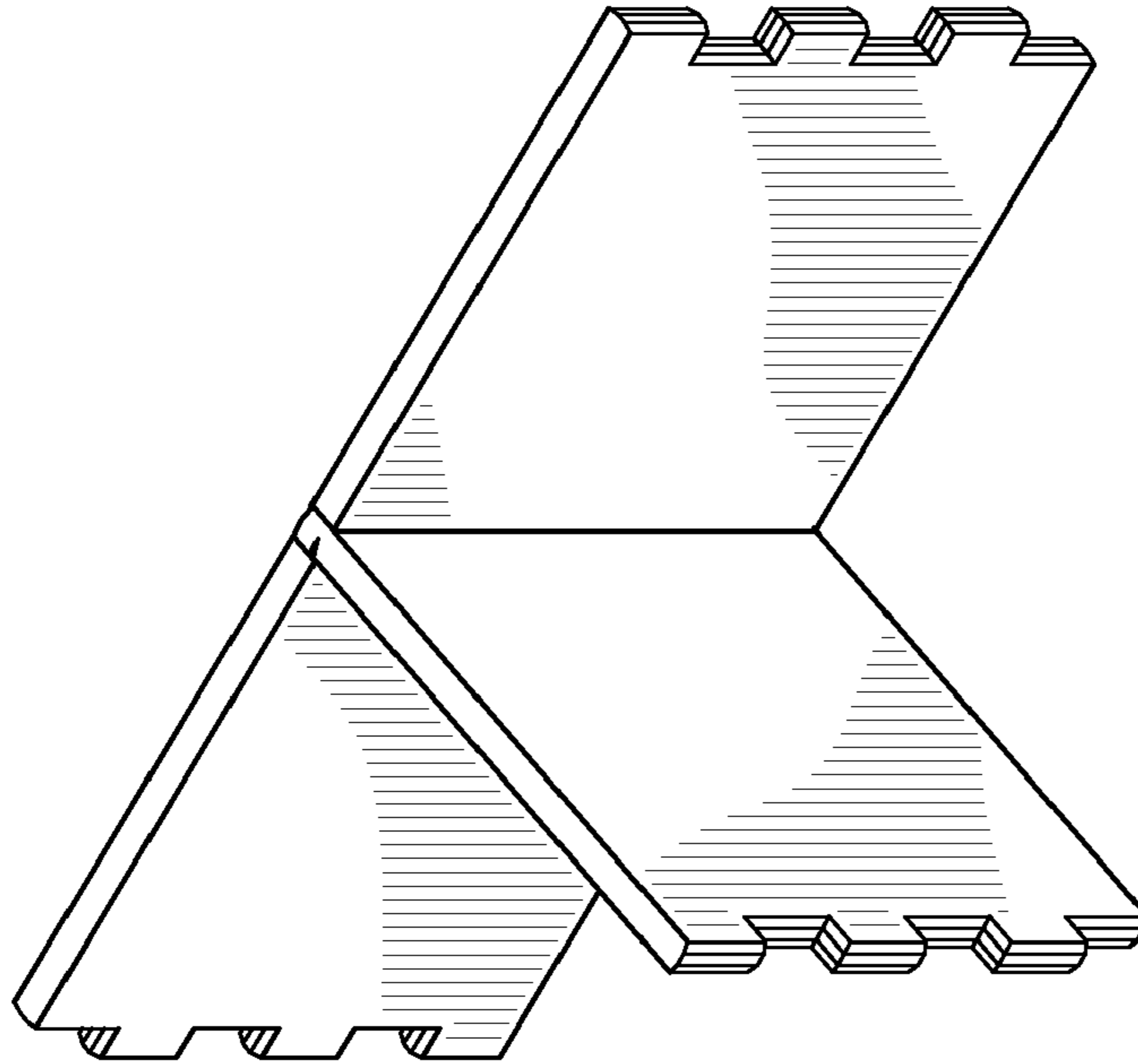

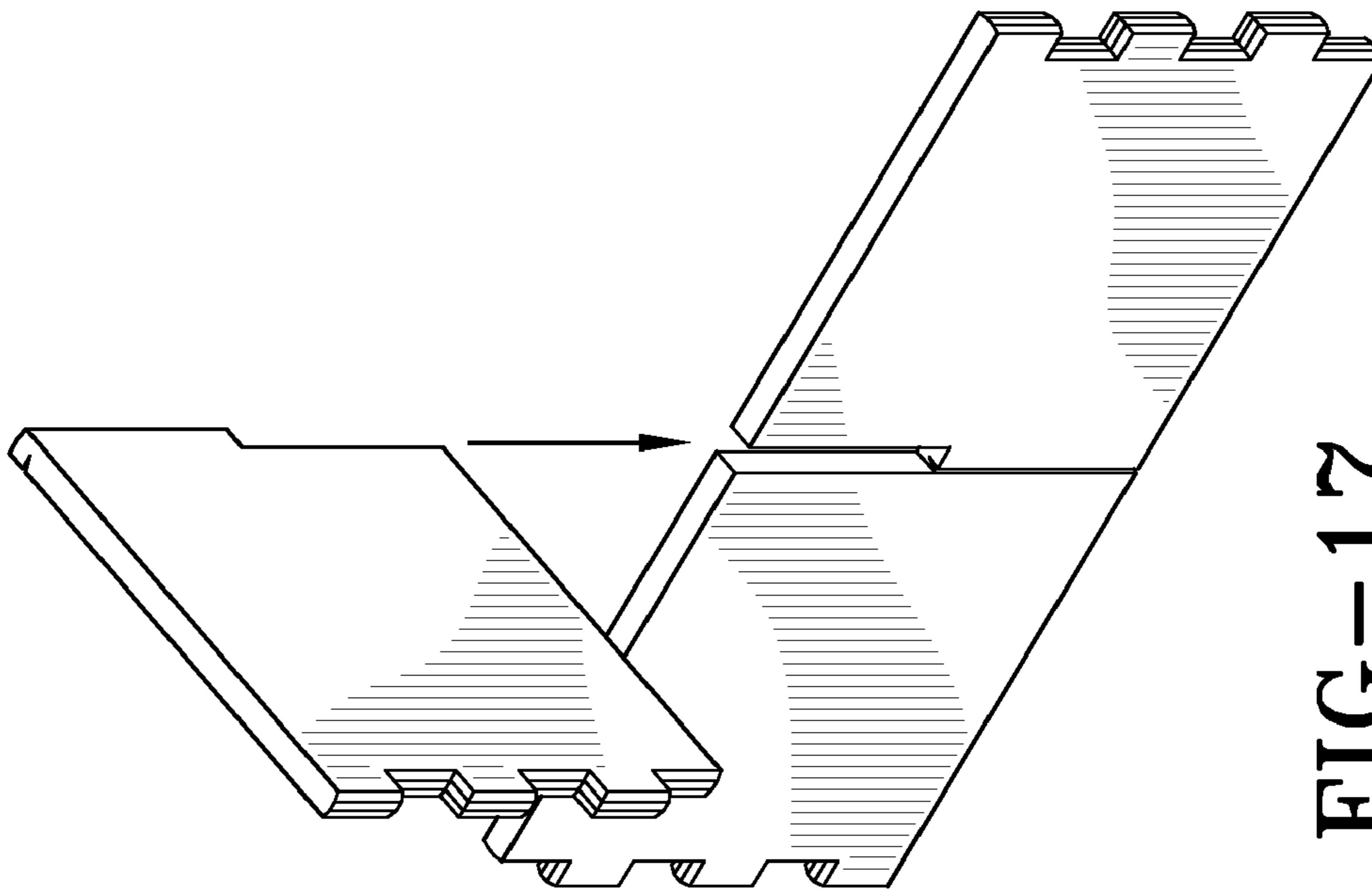

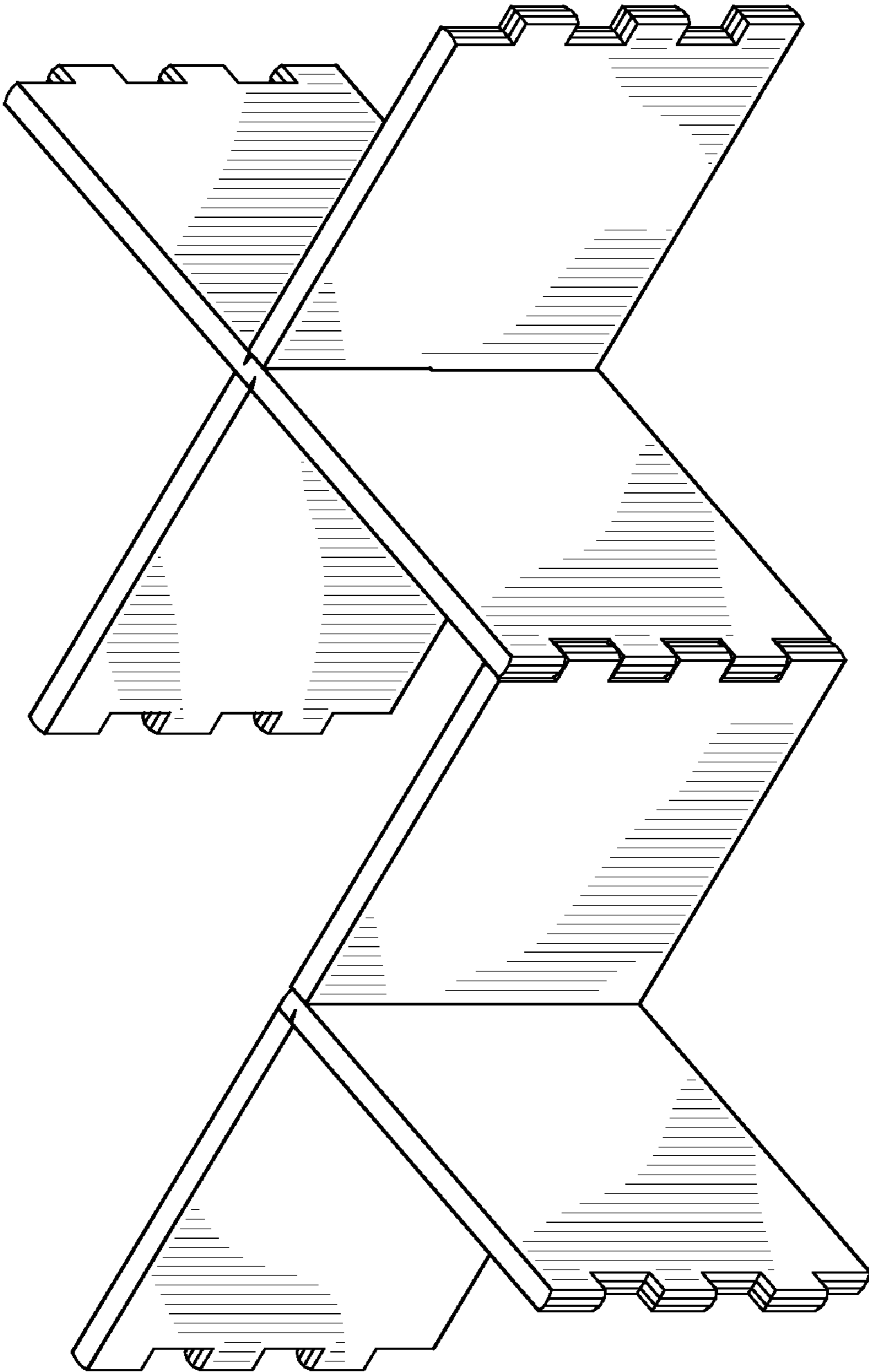

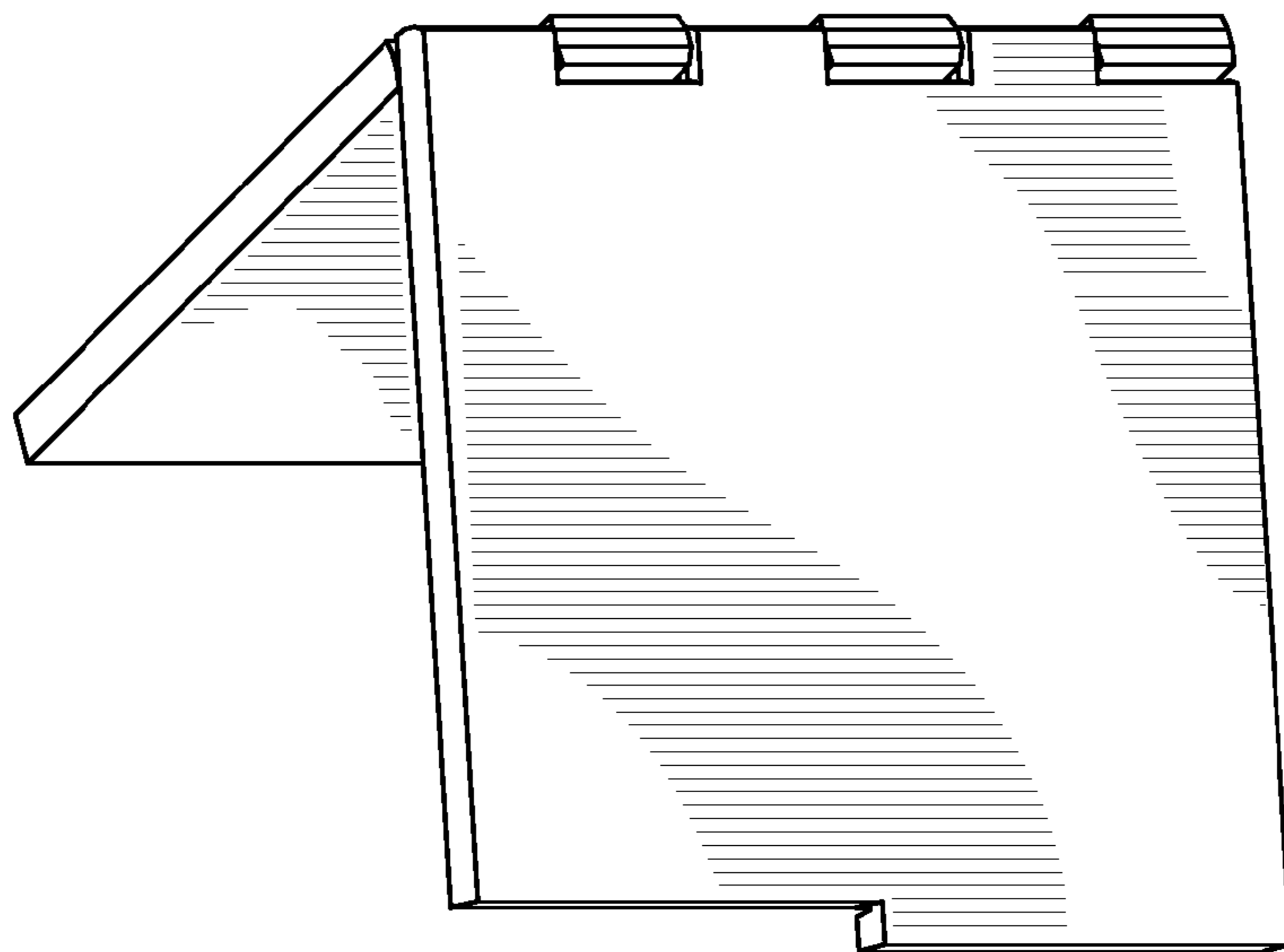

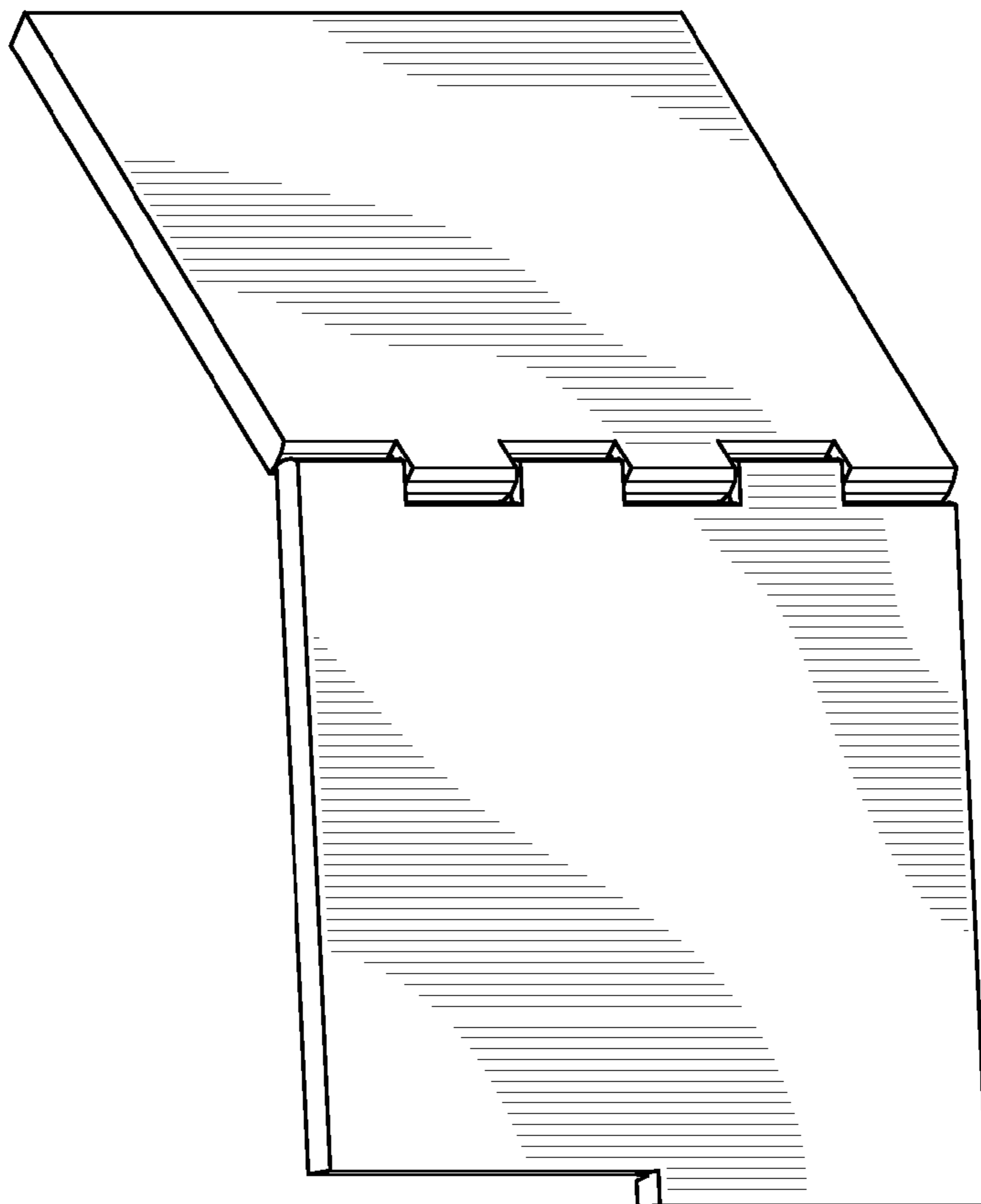
