FIG. 3 is a top plan view thereof;

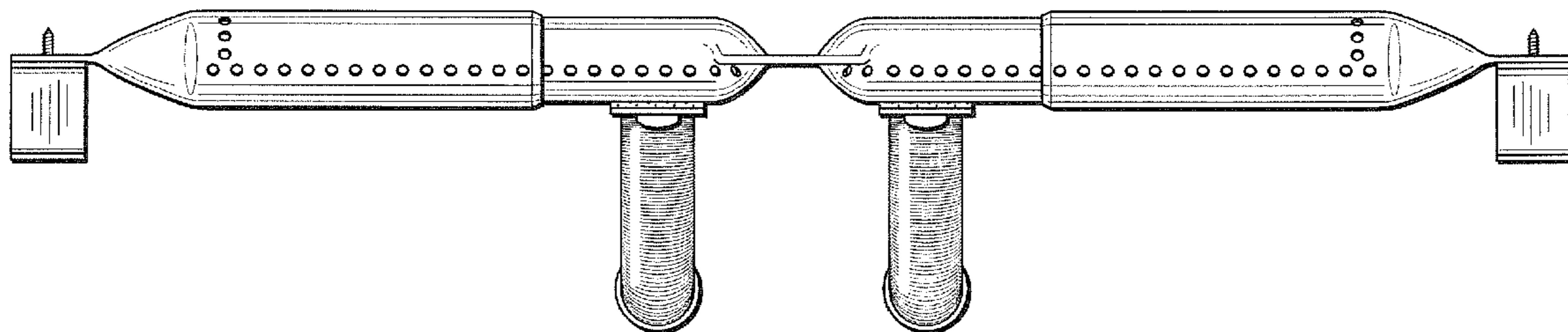
FIG. 4 is a right side elevational view thereof at an enlarged scale;

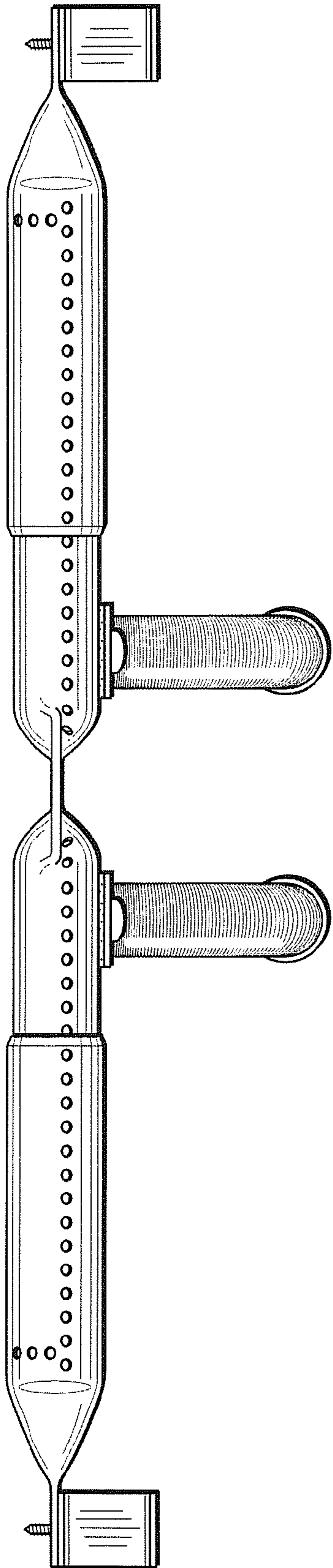

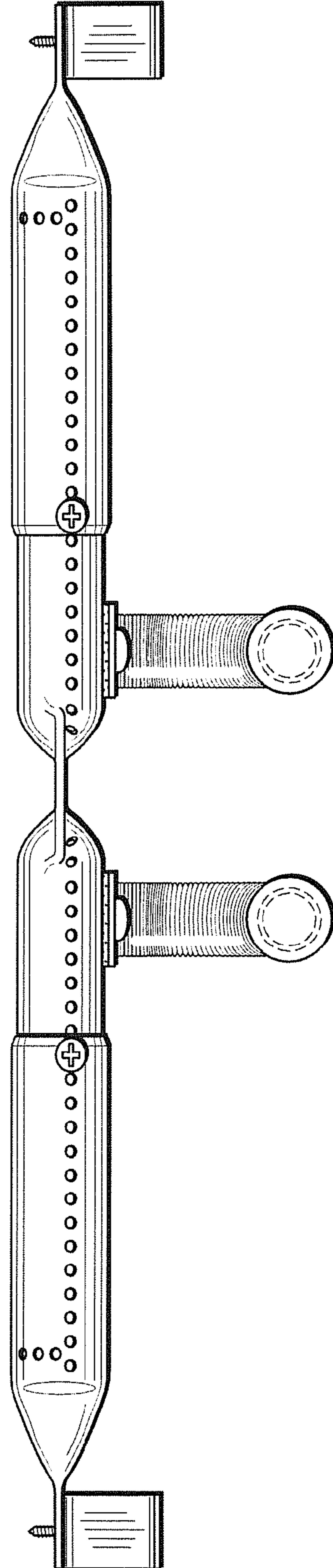

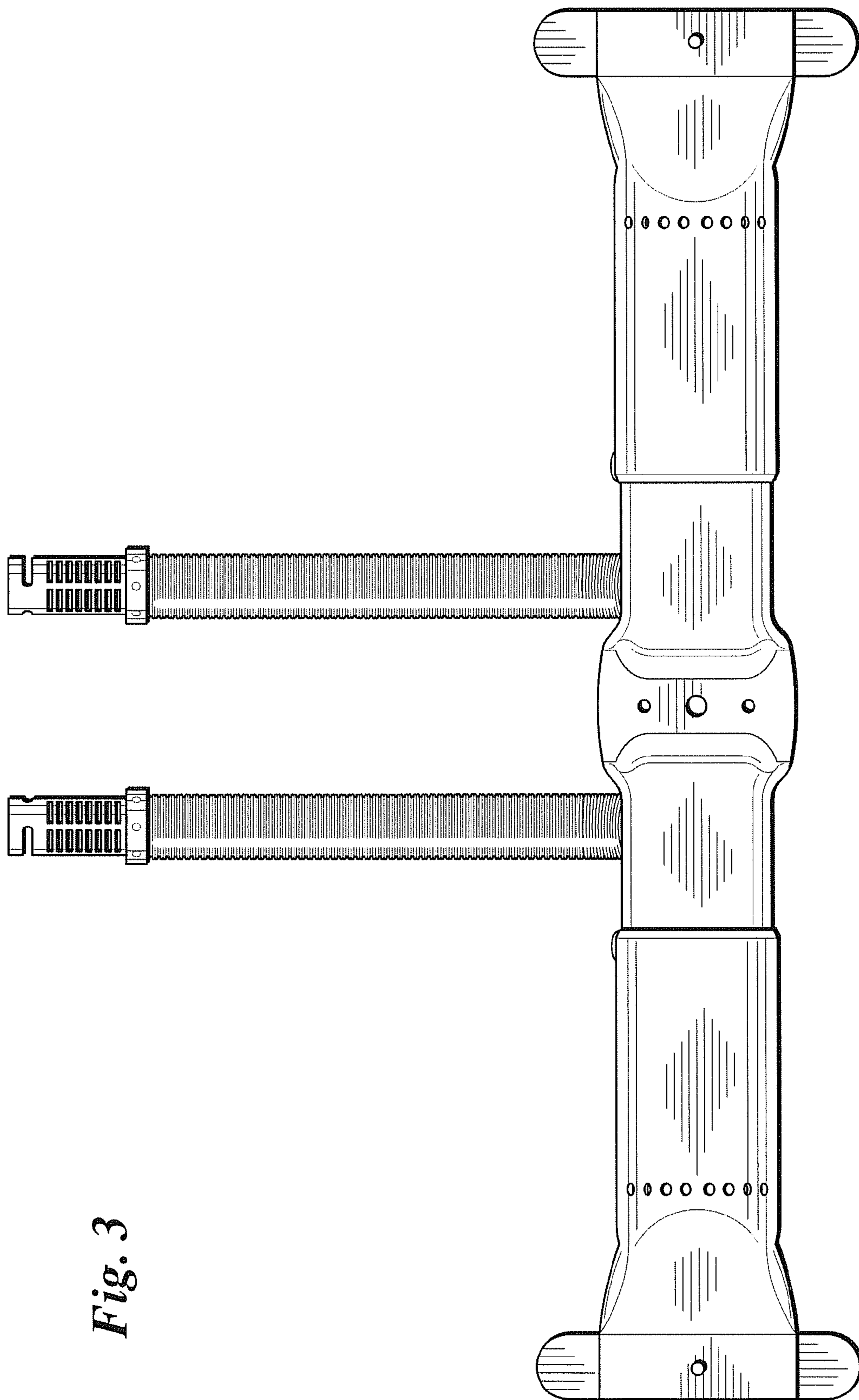

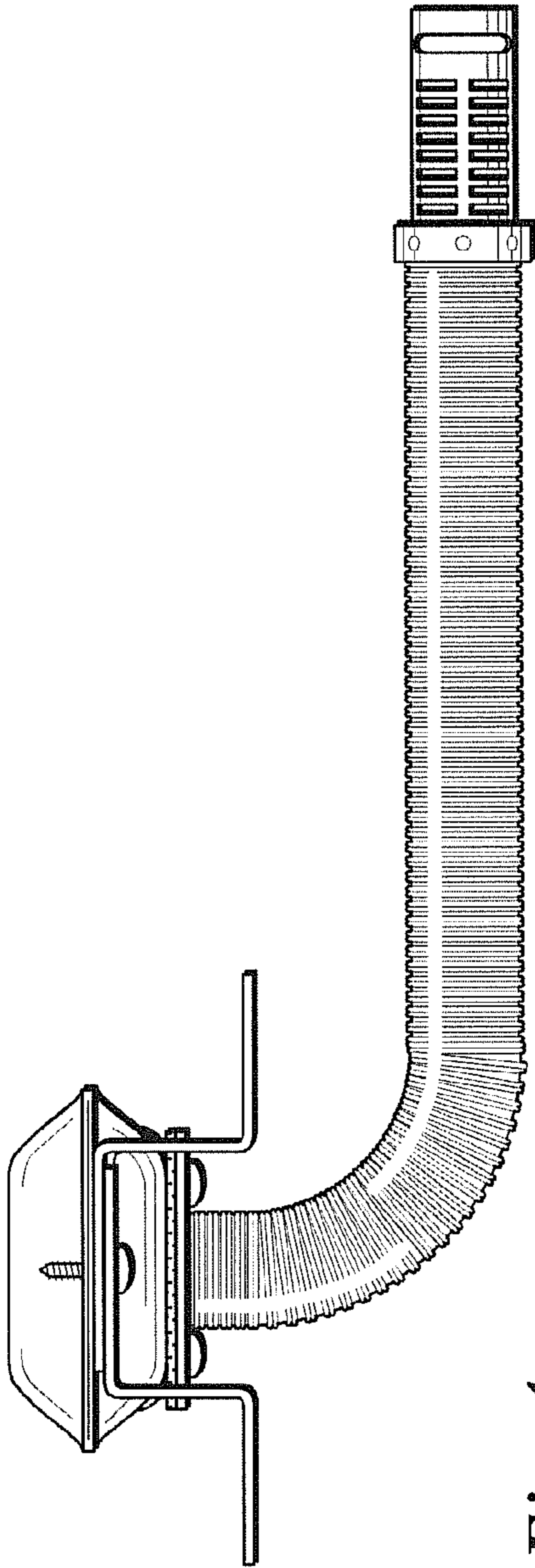

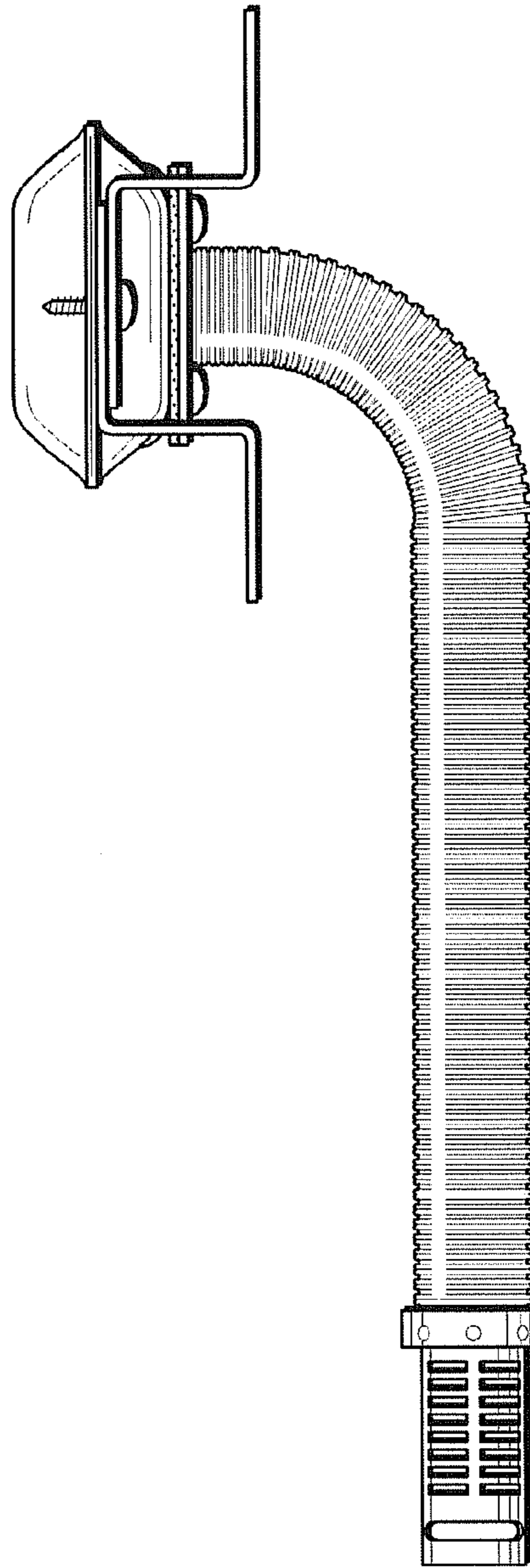

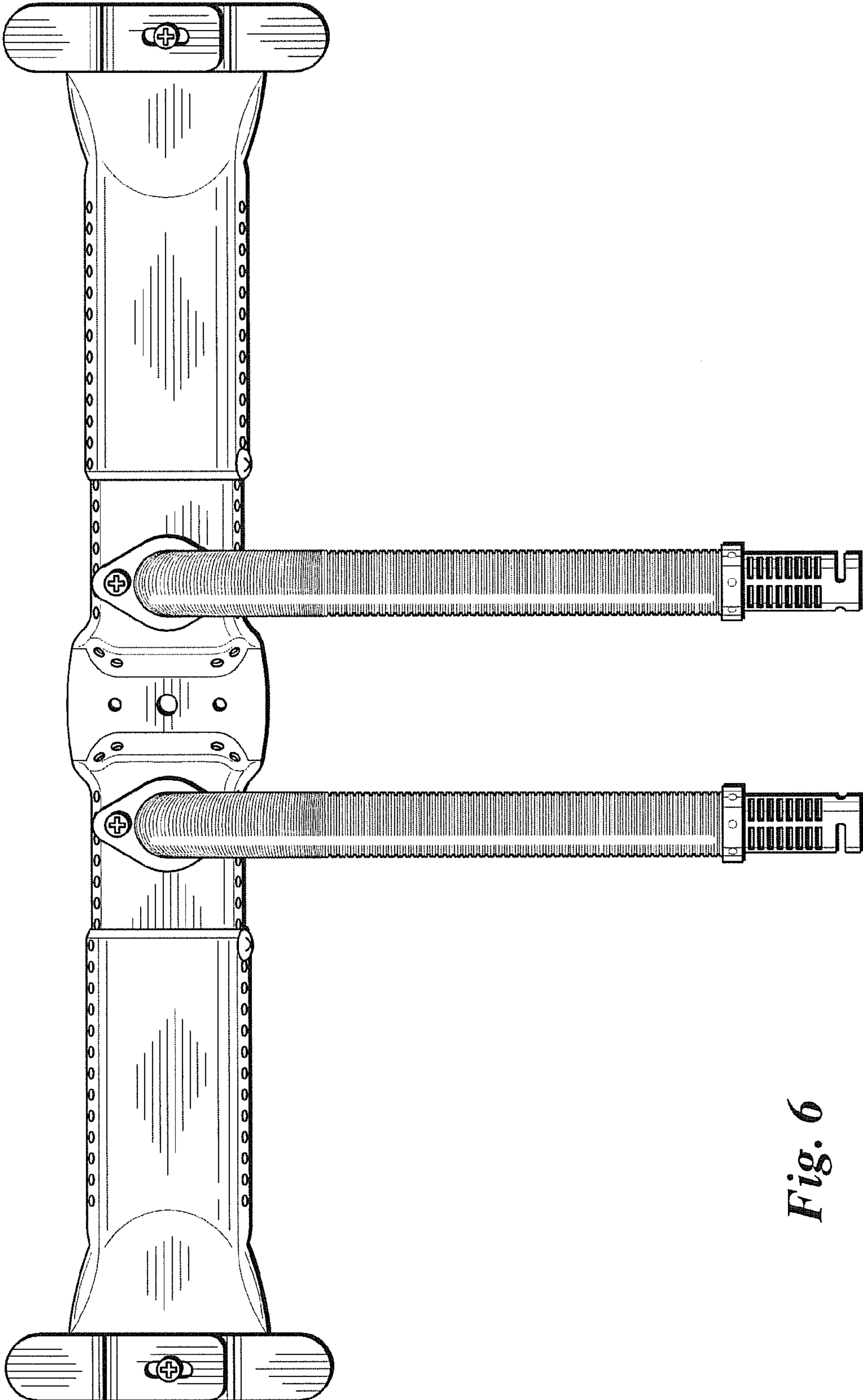
