FIG. 1 is a top perspective view of a bowl of the present disclosure;

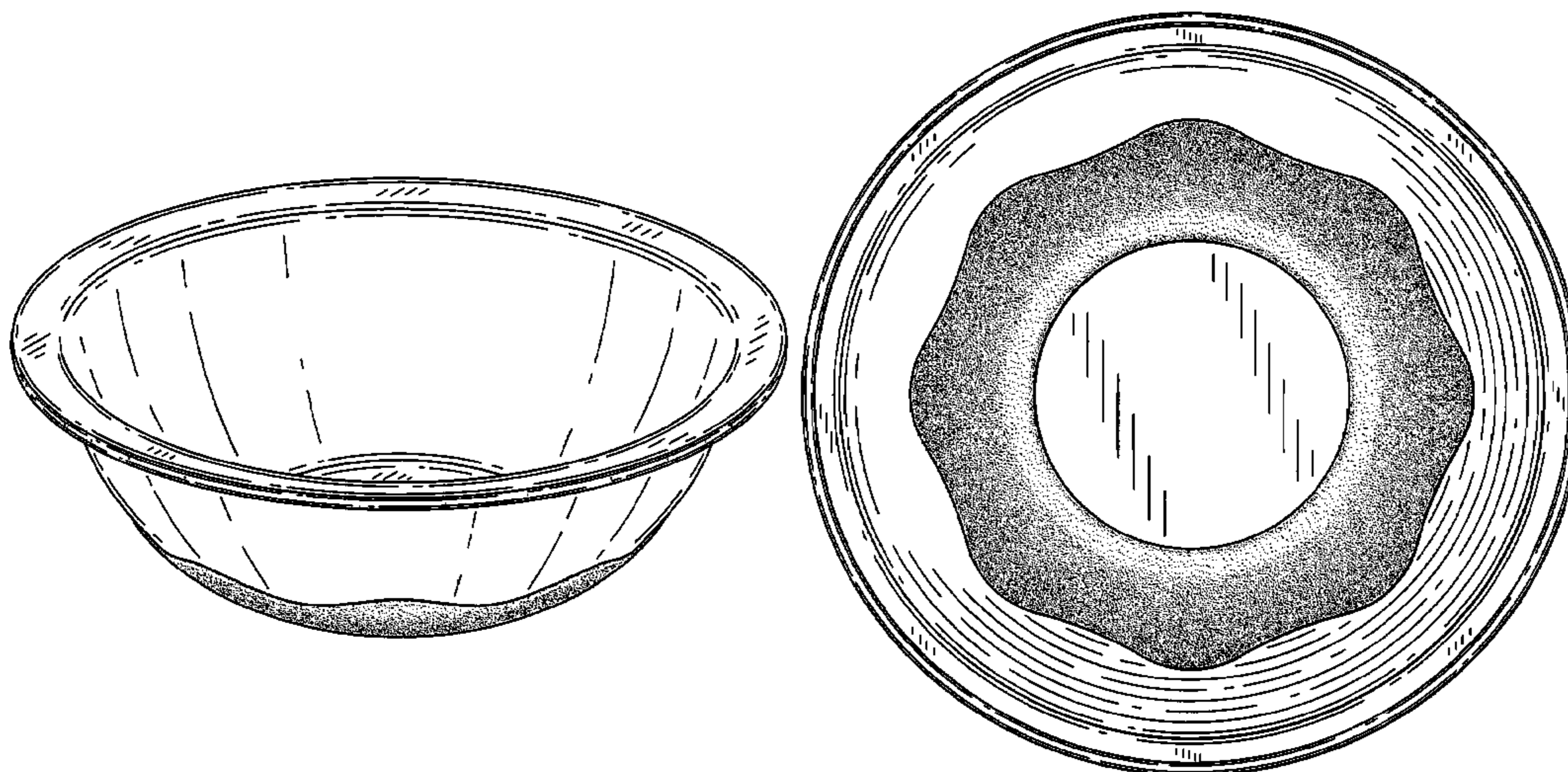
FIG. 2 is a bottom perspective view of the bowl of FIG. 1;

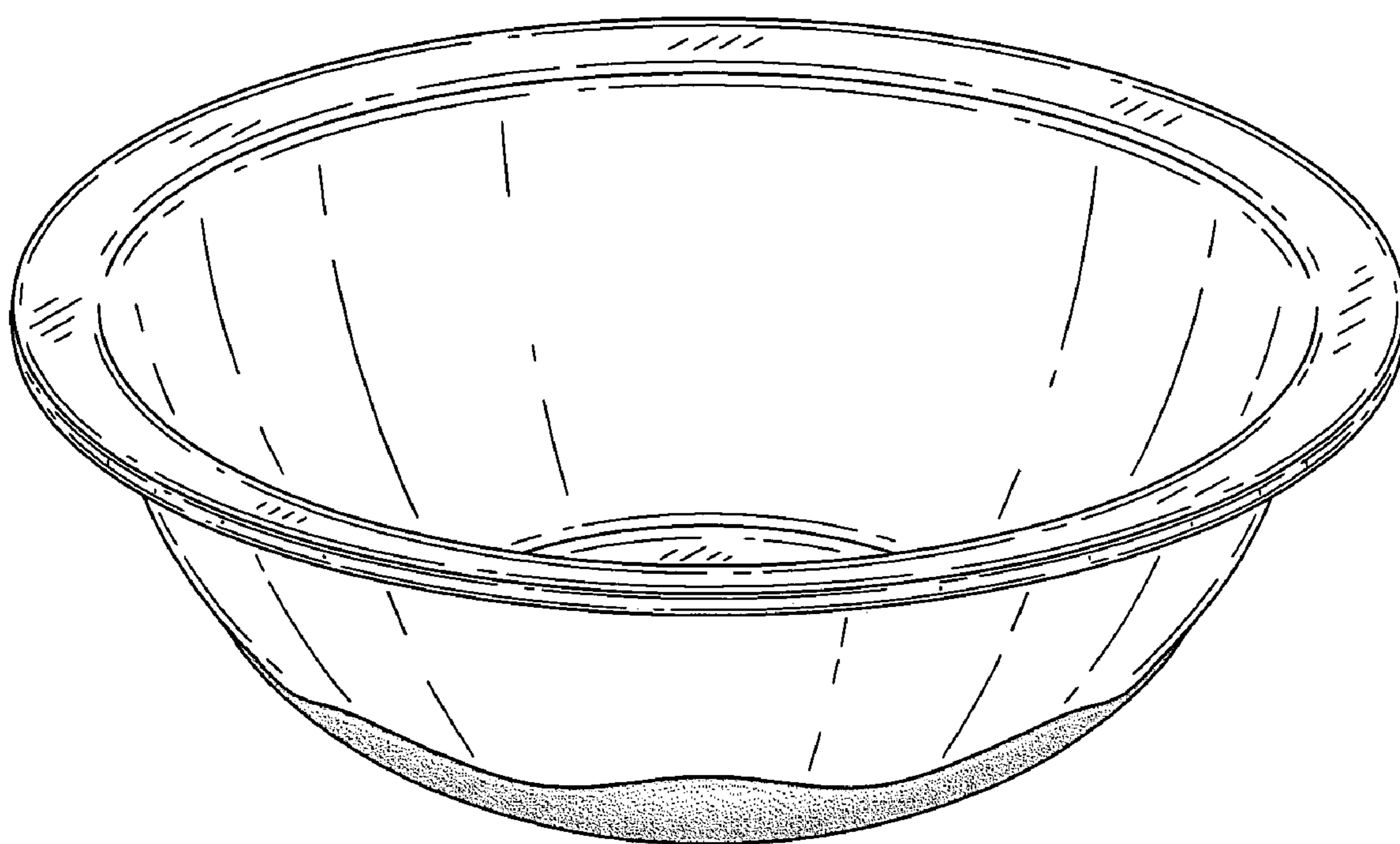

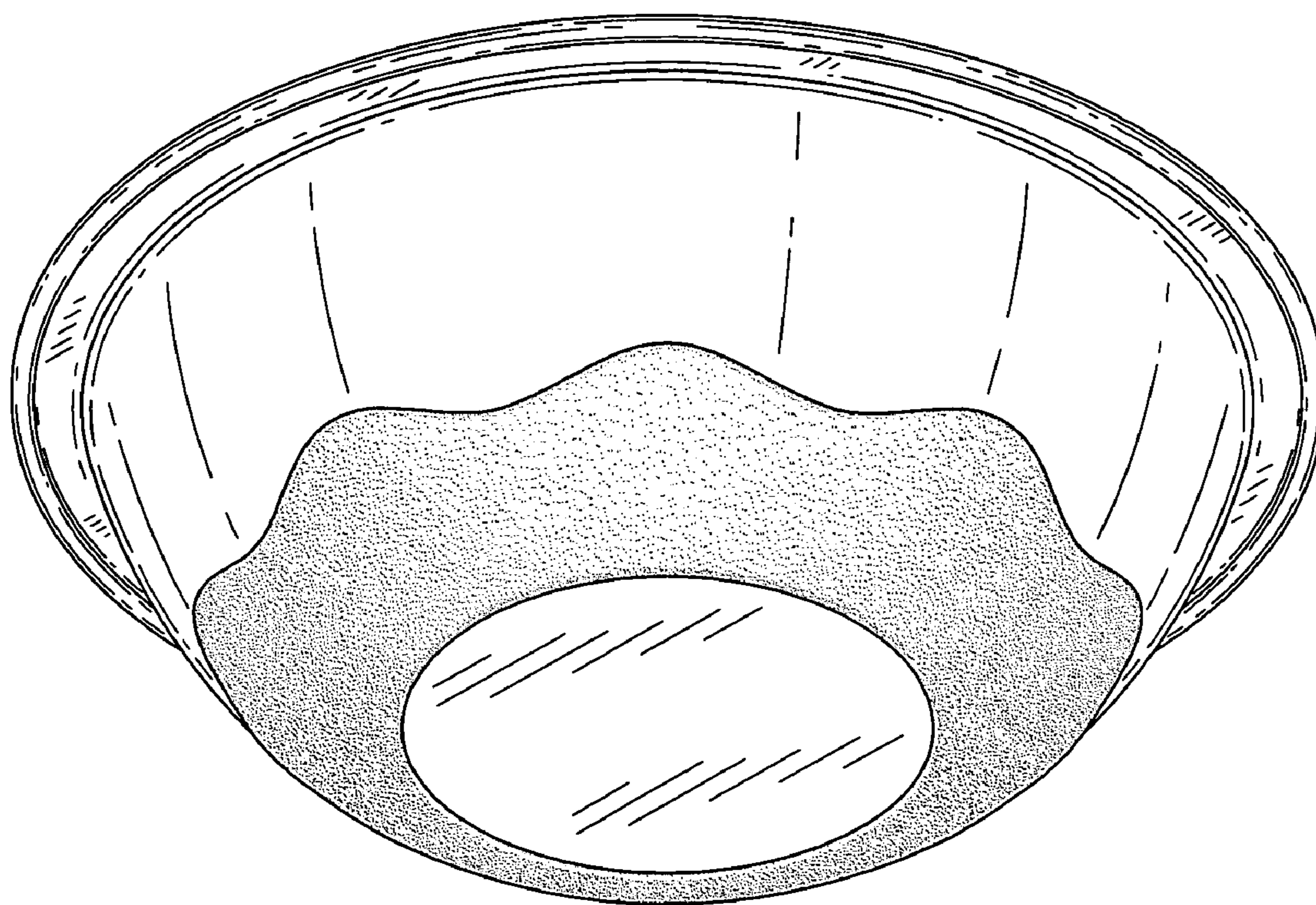

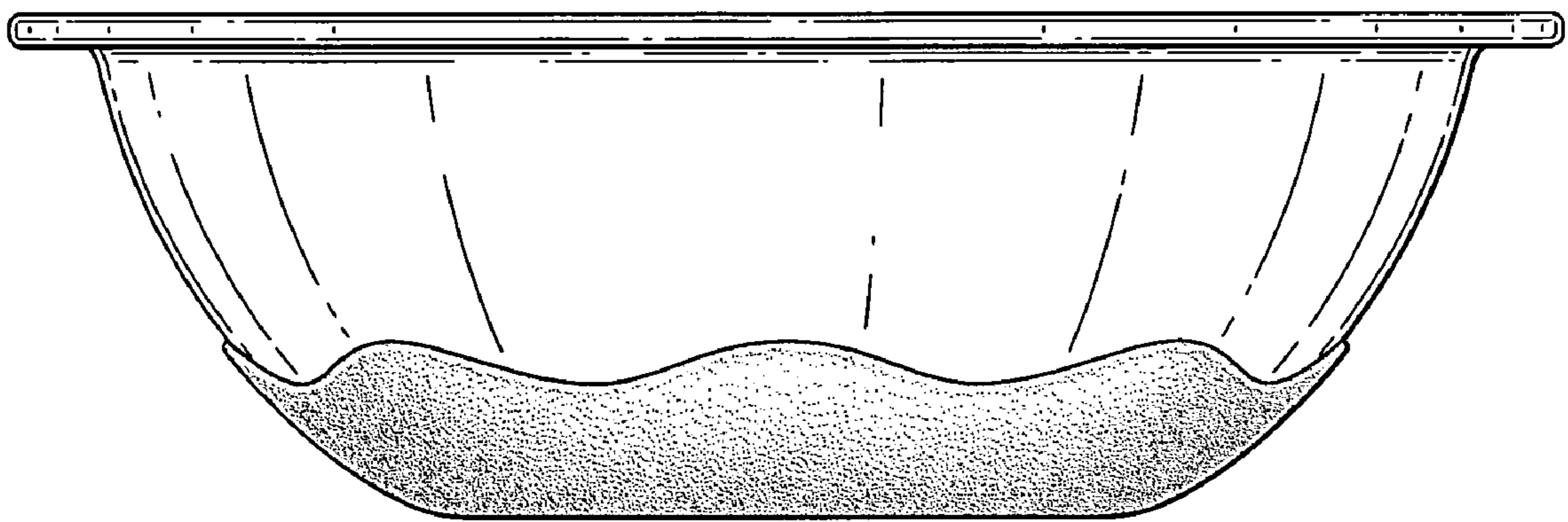

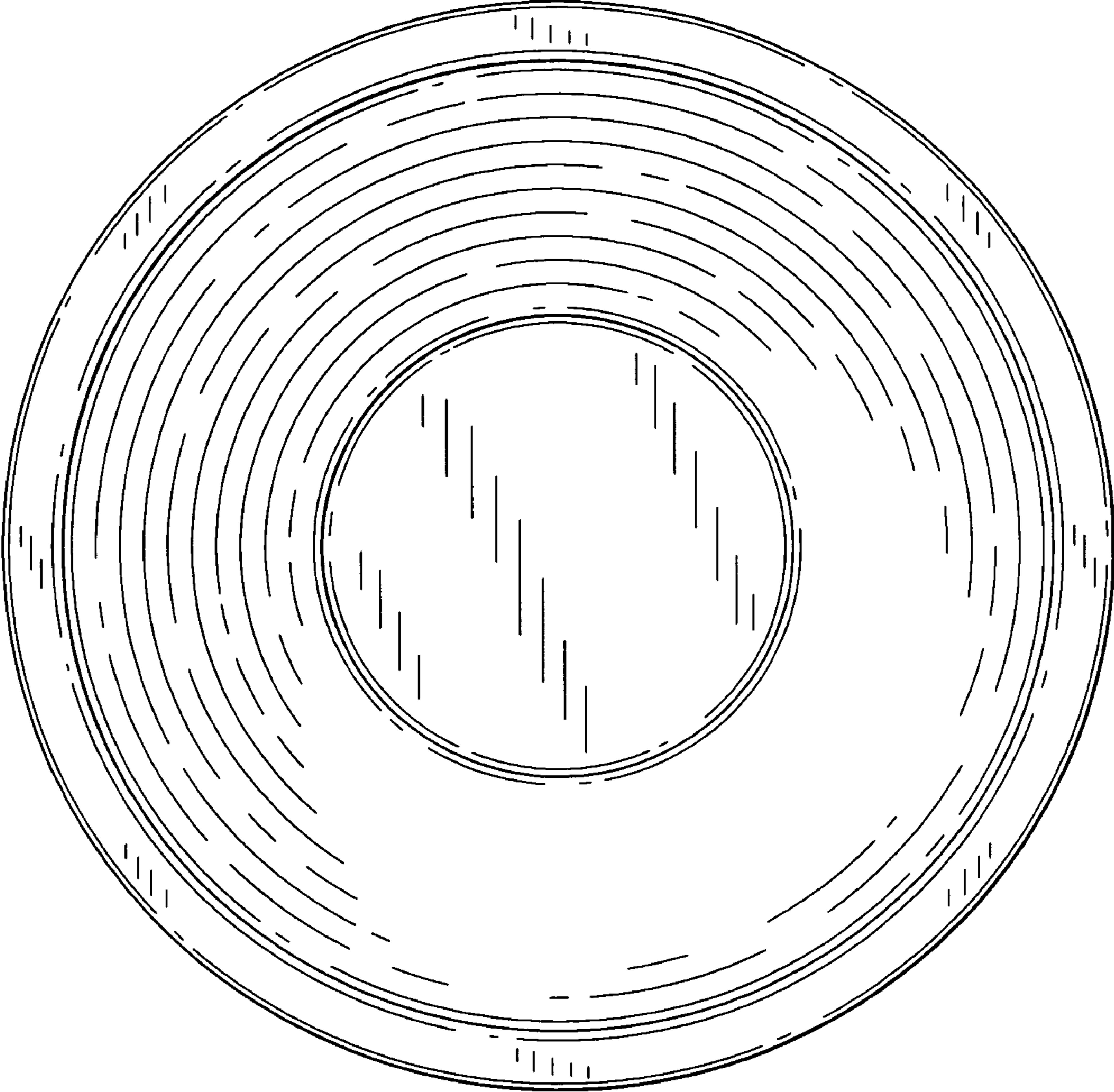

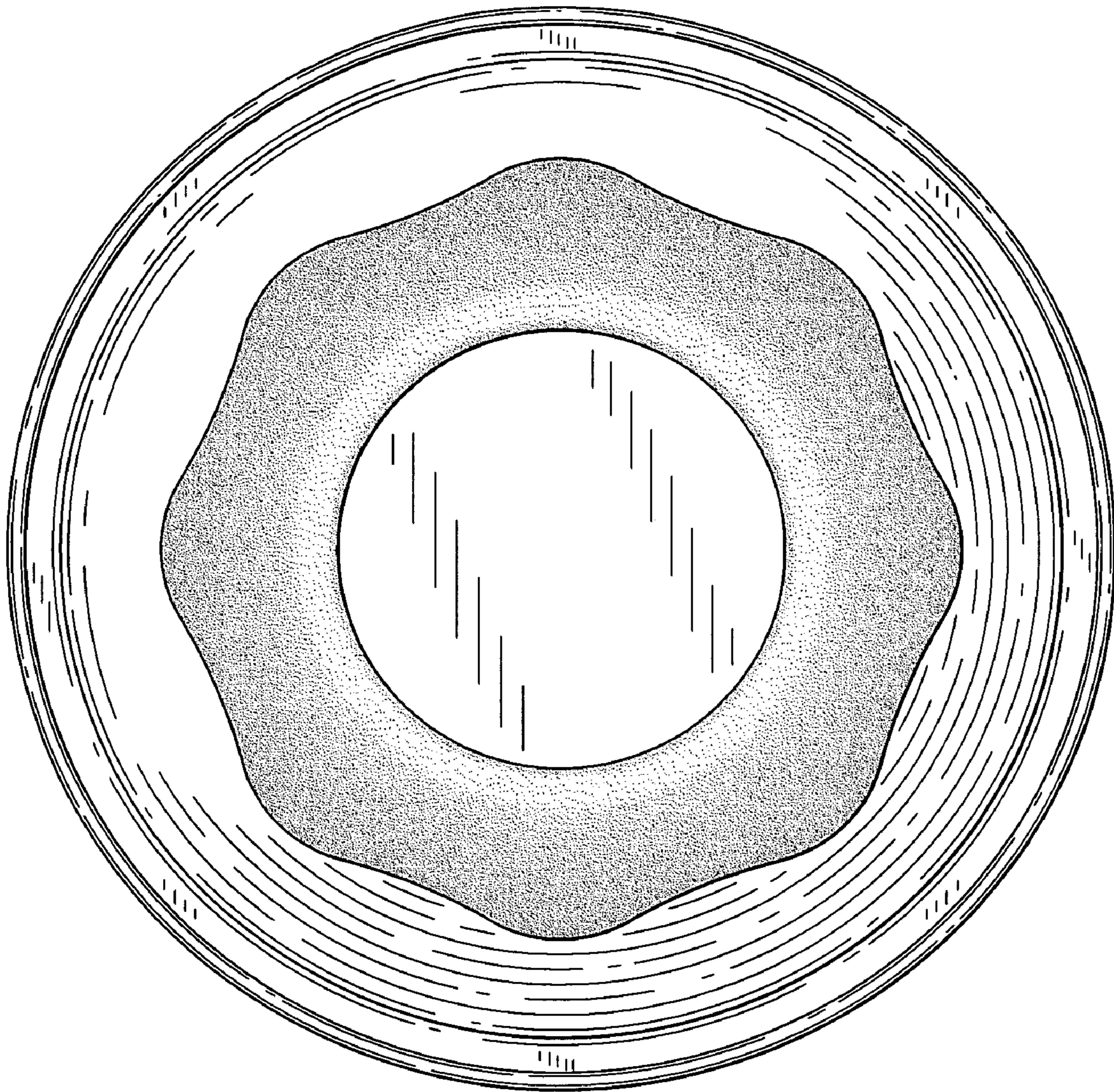
