FIG. 1 is a top perspective view of a canister showing our new design;

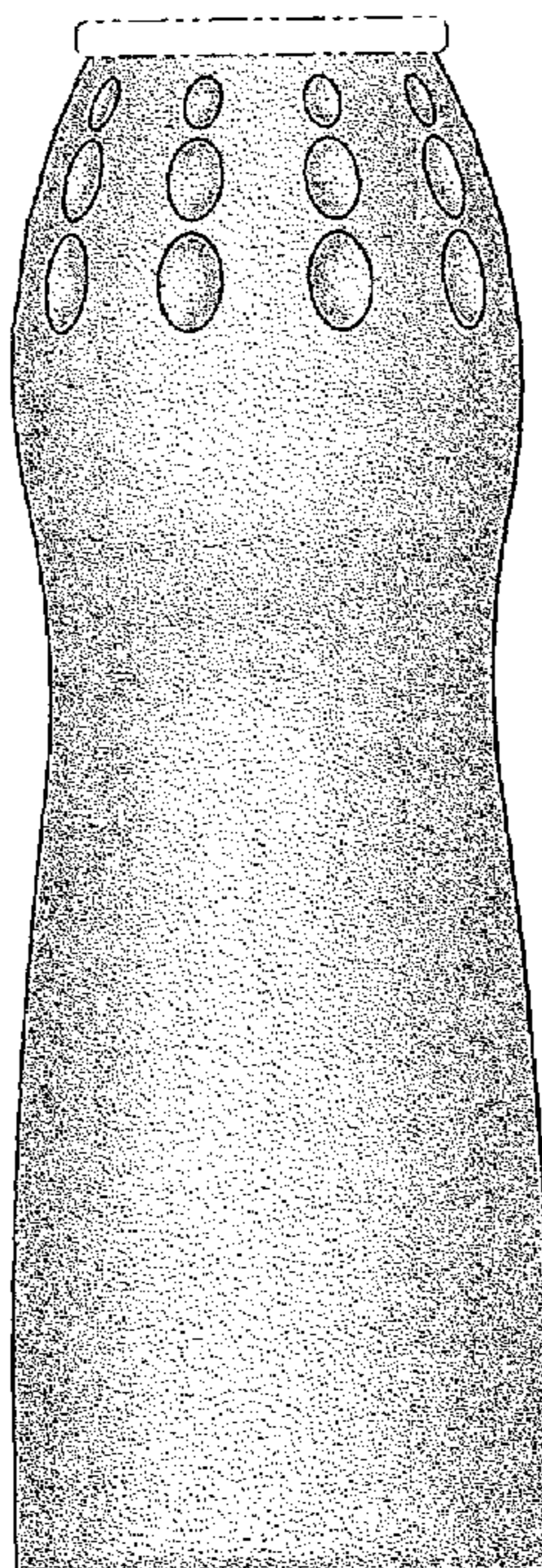
FIG. 2 is a side elevation view thereof;

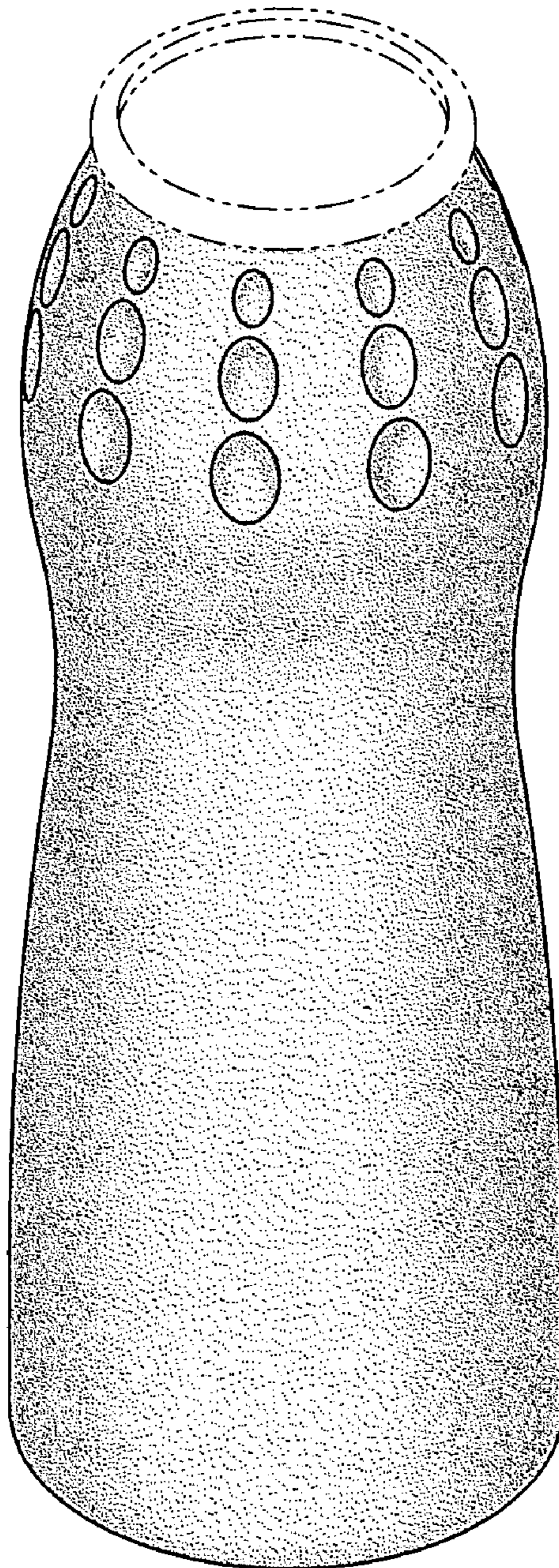

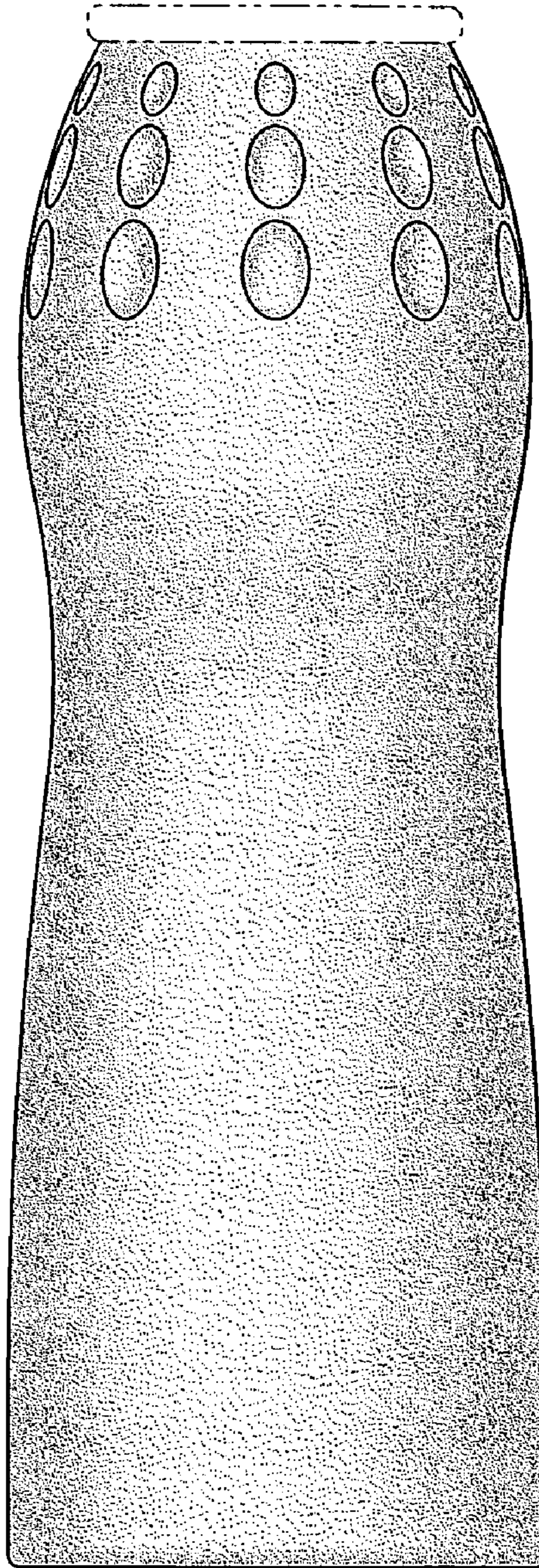

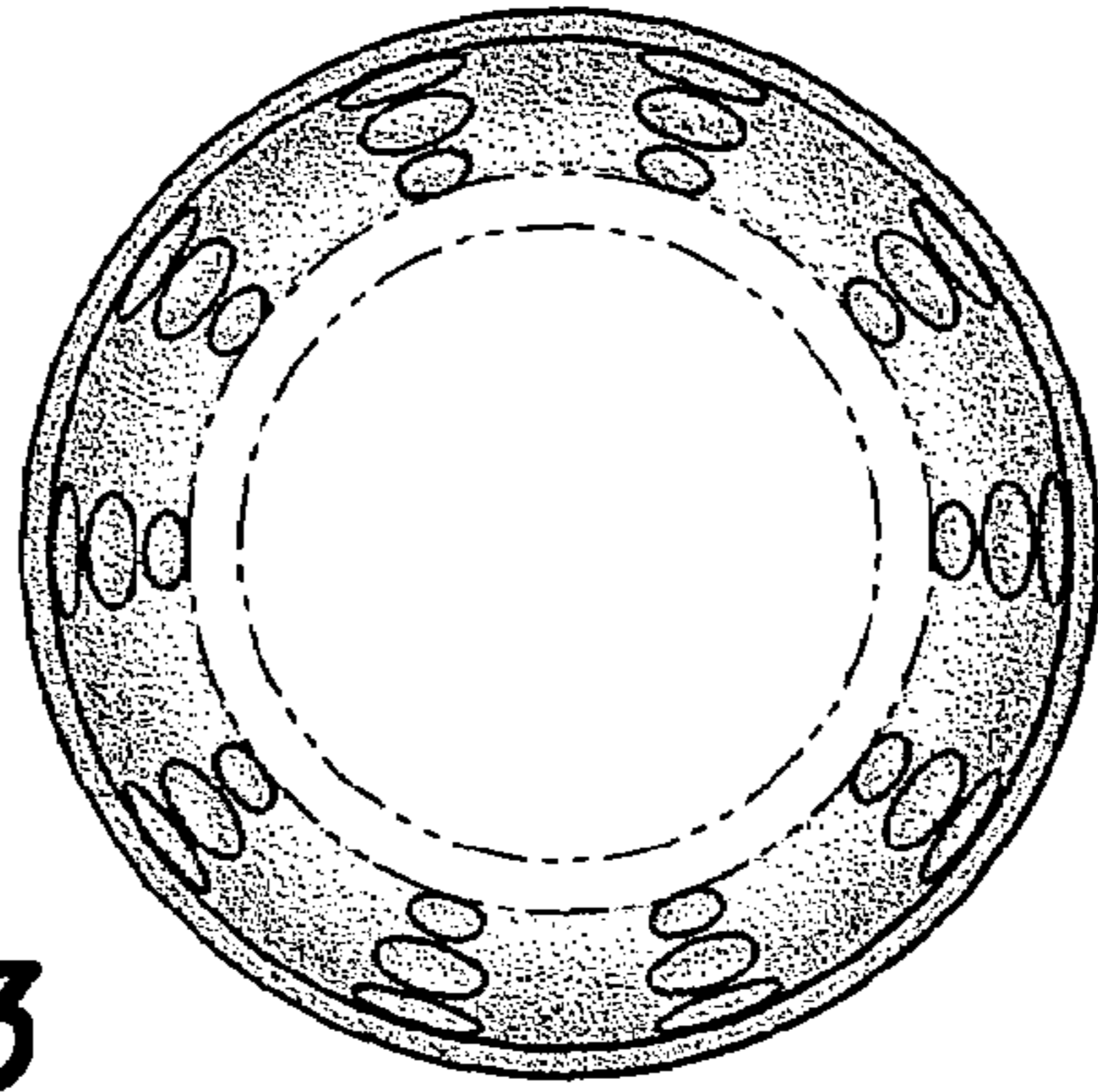

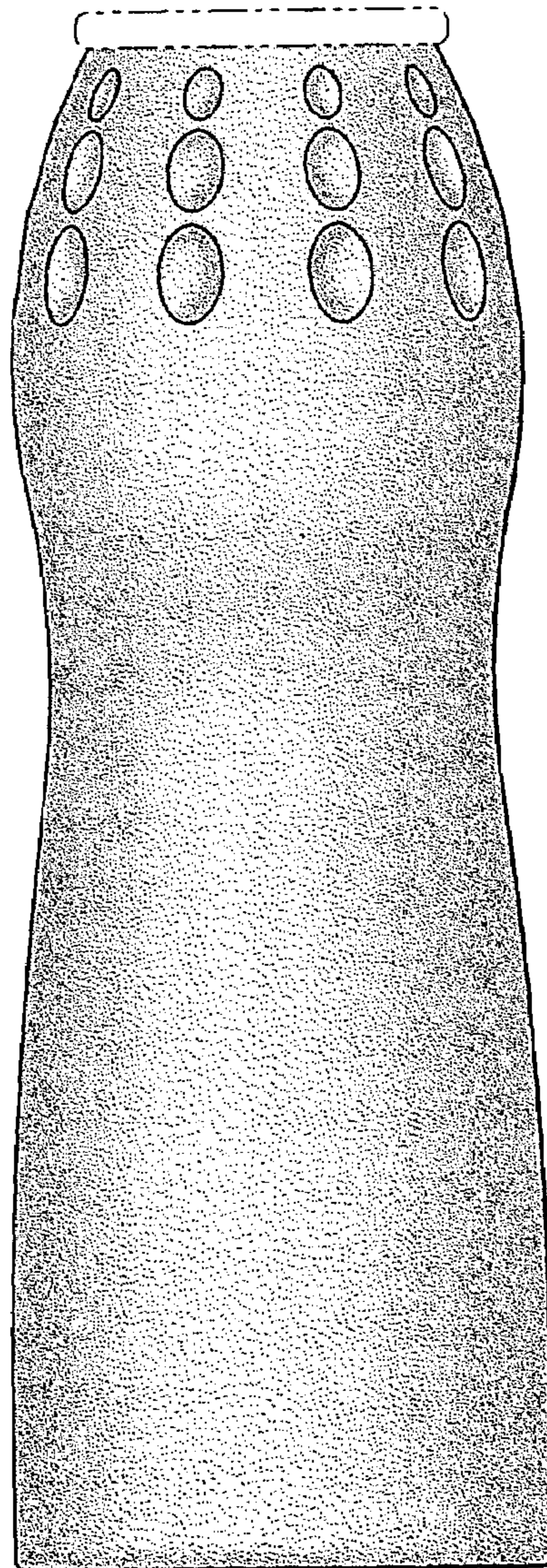
