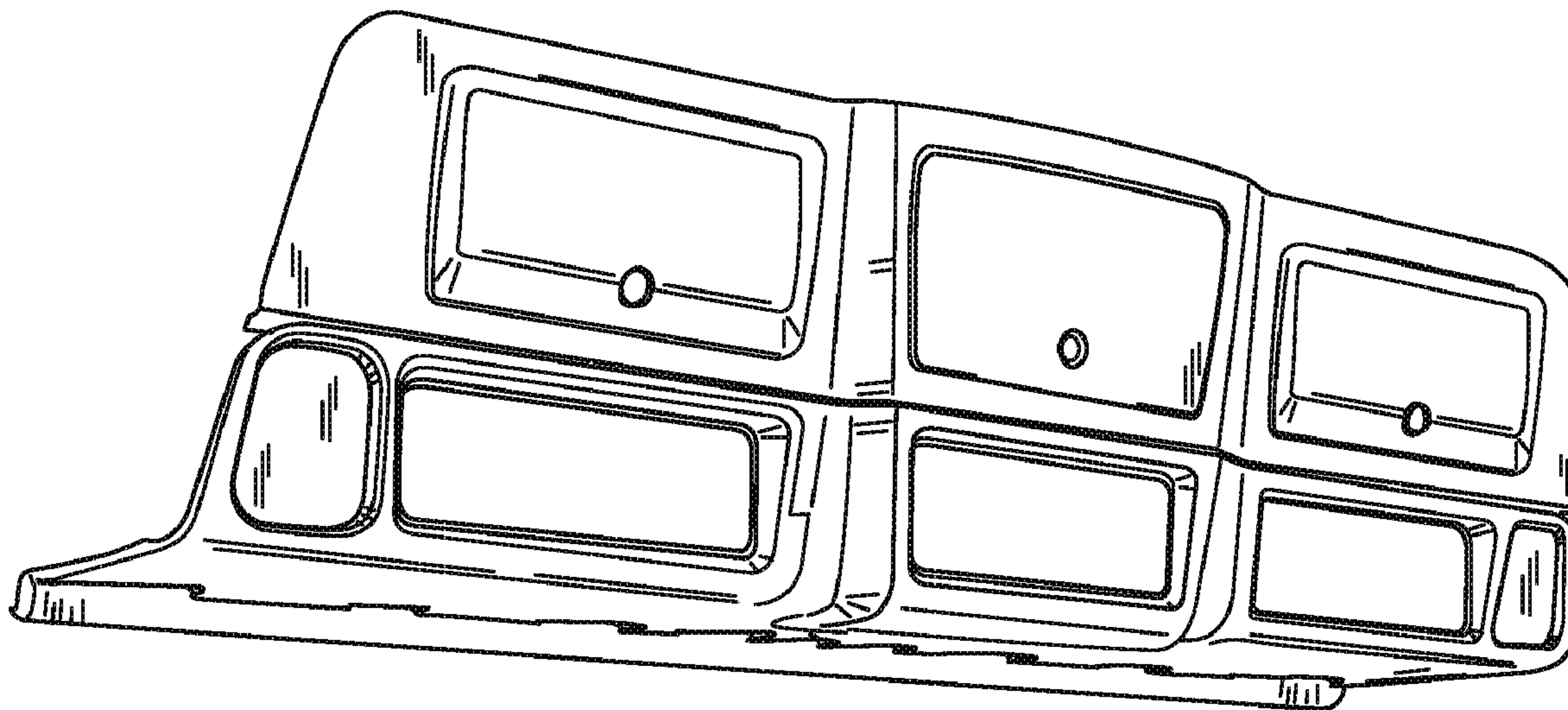
(57) **CLAIM**

The ornamental design for a high dome overhead console of a truck vehicle, as shown and described.

**DESCRIPTION**

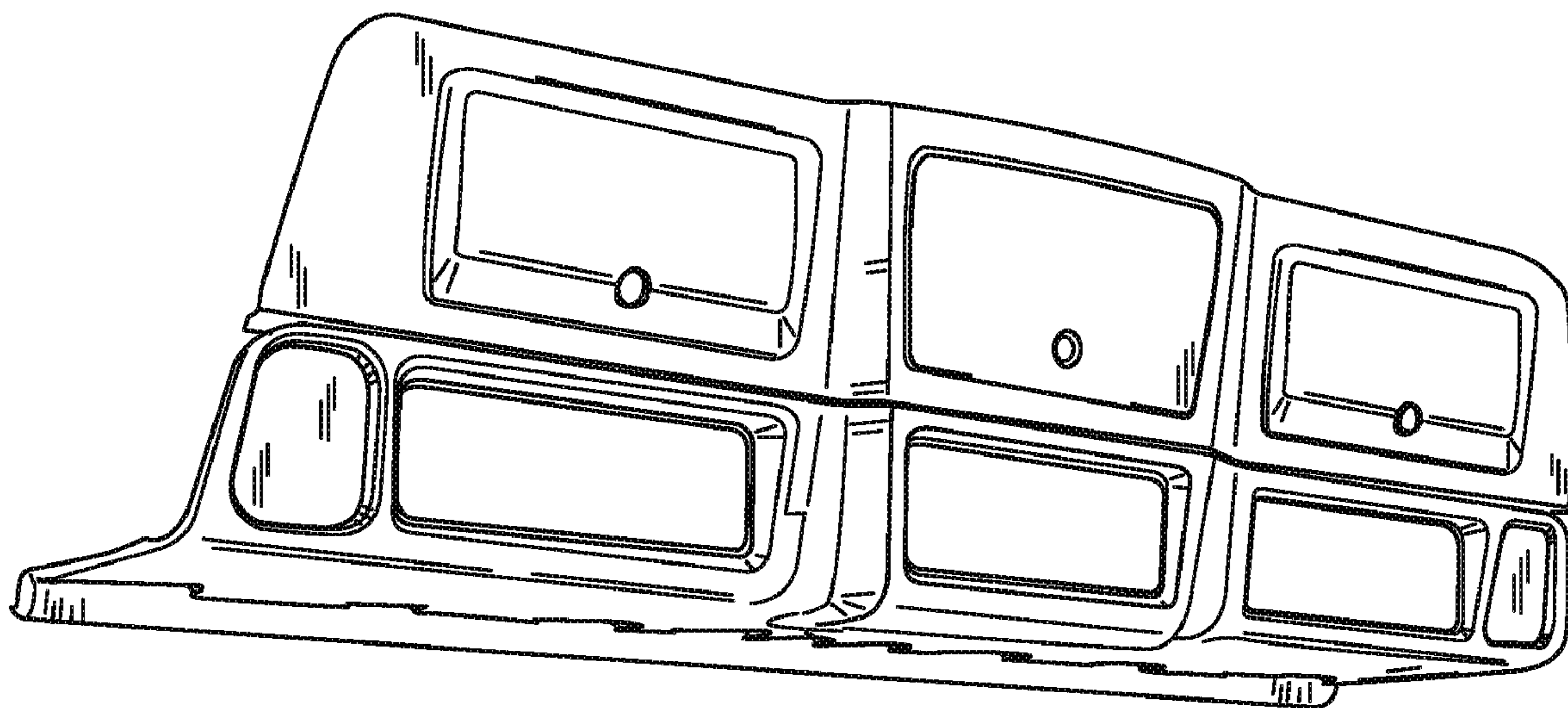

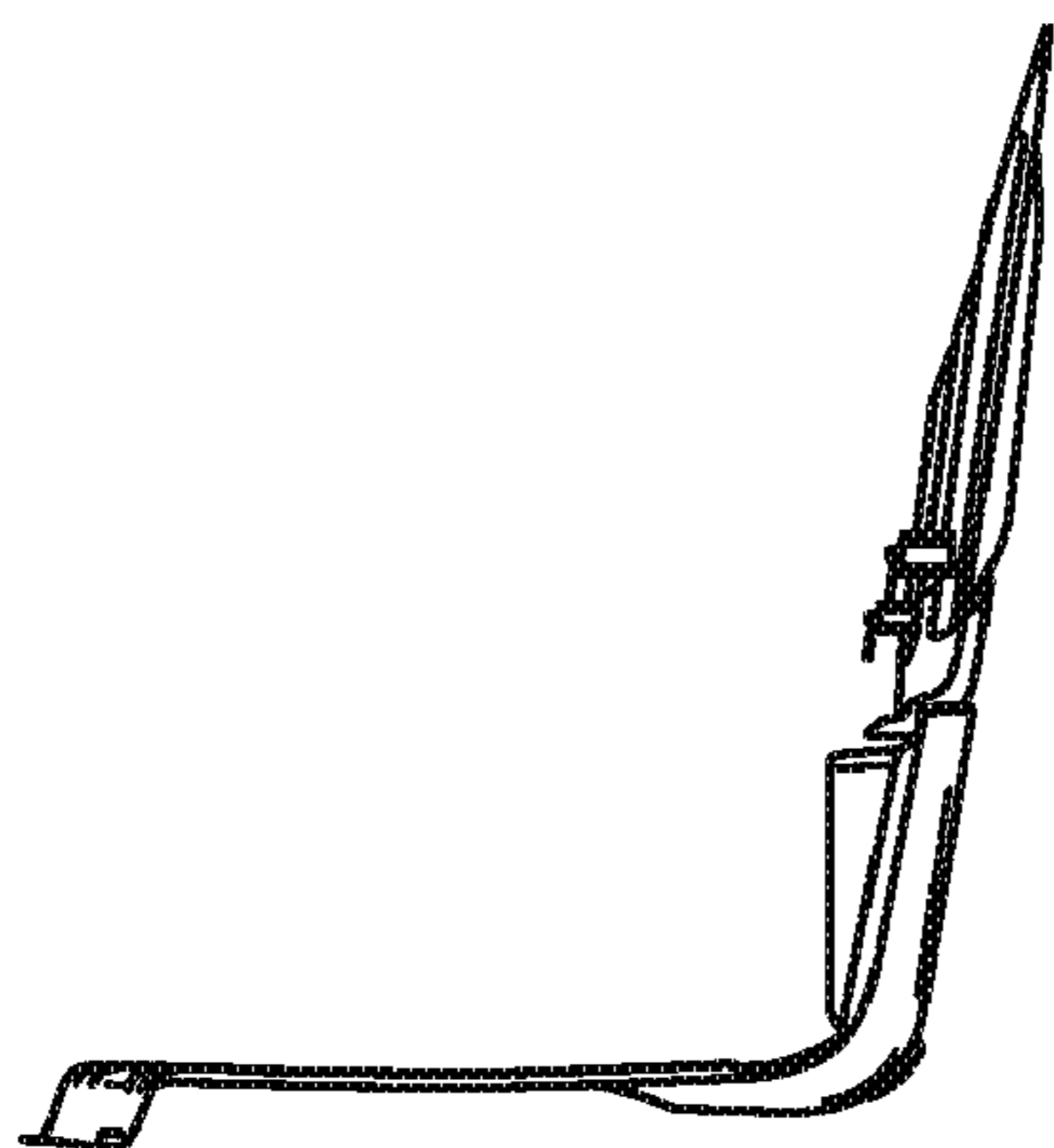

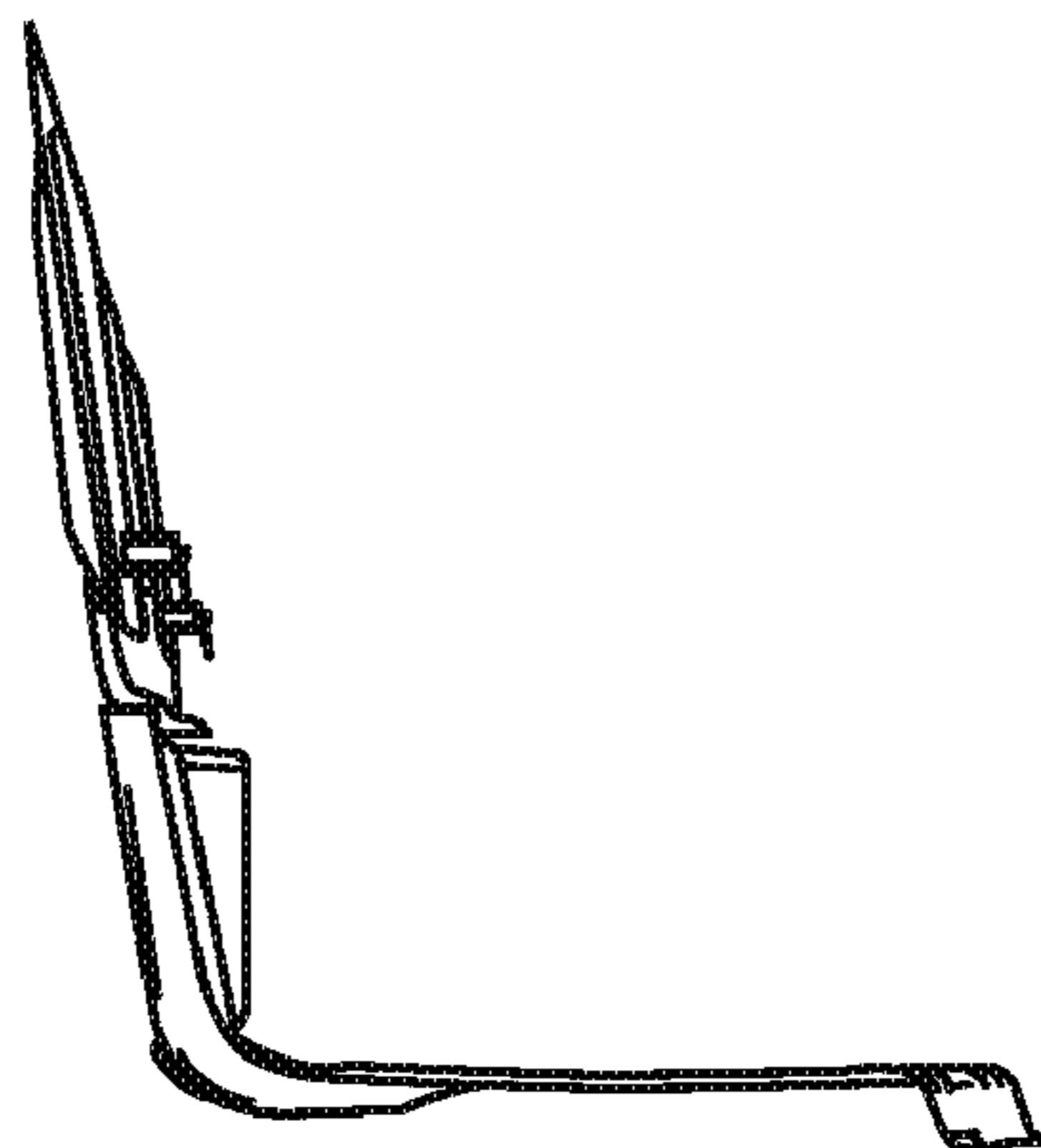

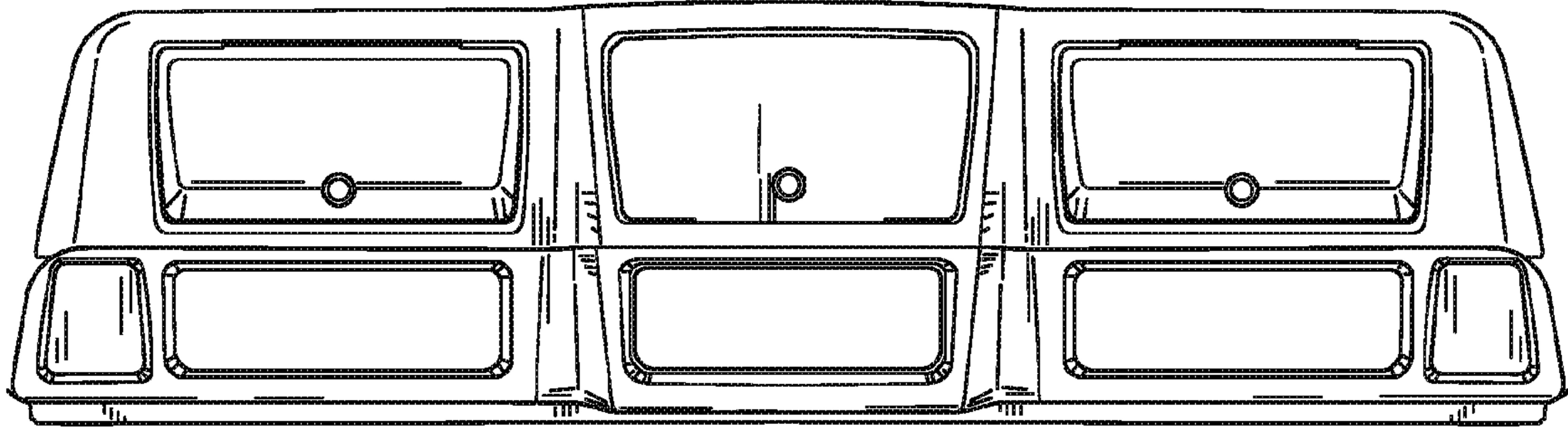

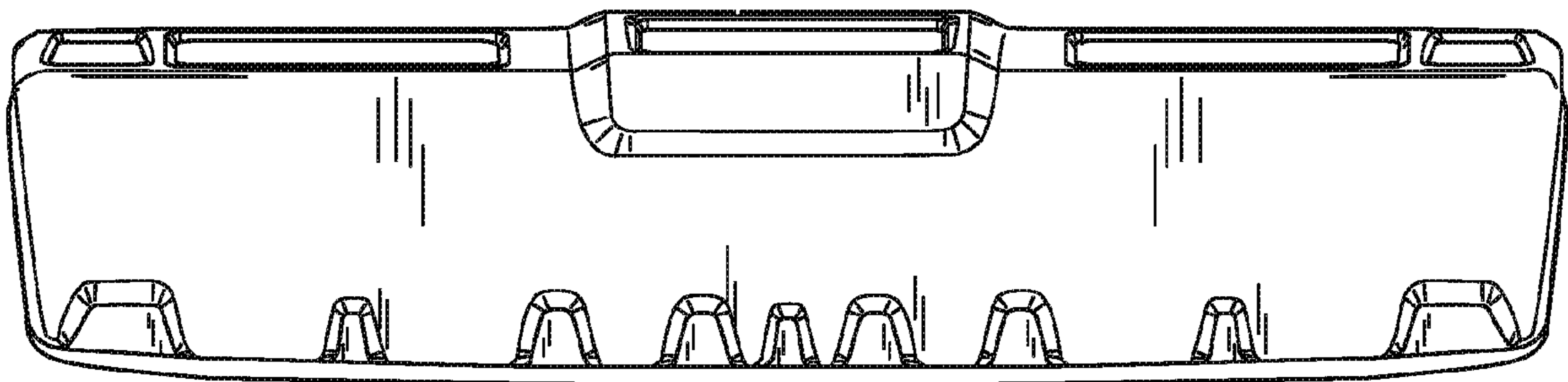
