(57) **CLAIM**

The ornamental design for a mobile phone with floral surface pattern, as shown and described.

**DESCRIPTION**

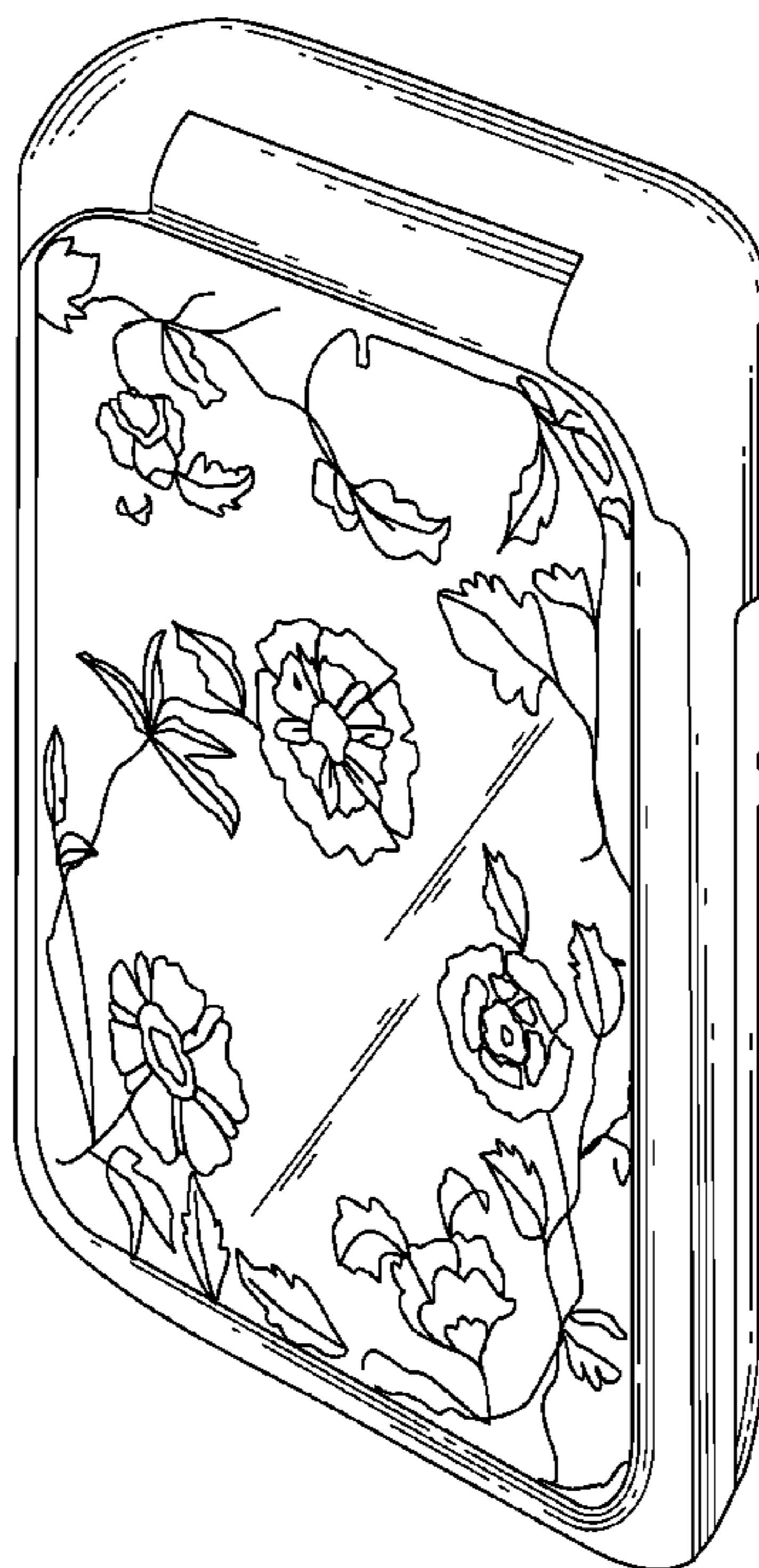

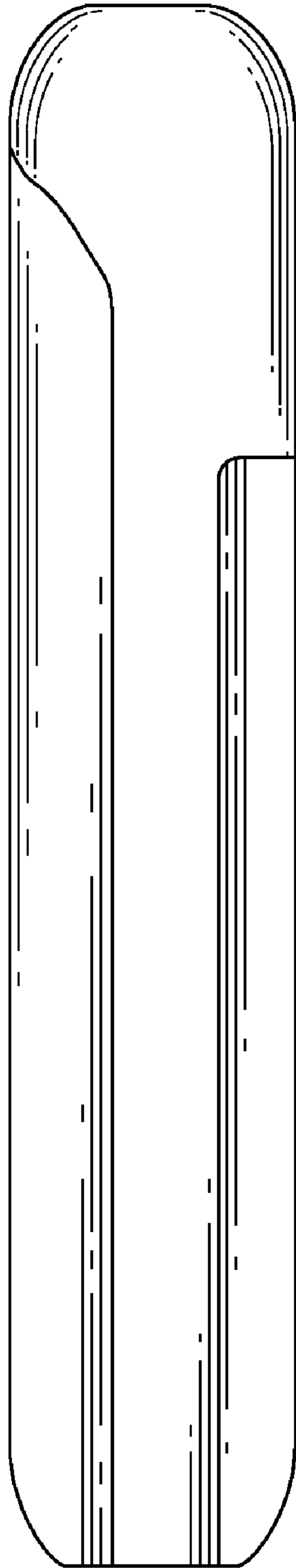
