electronic device accessory showing the new design;

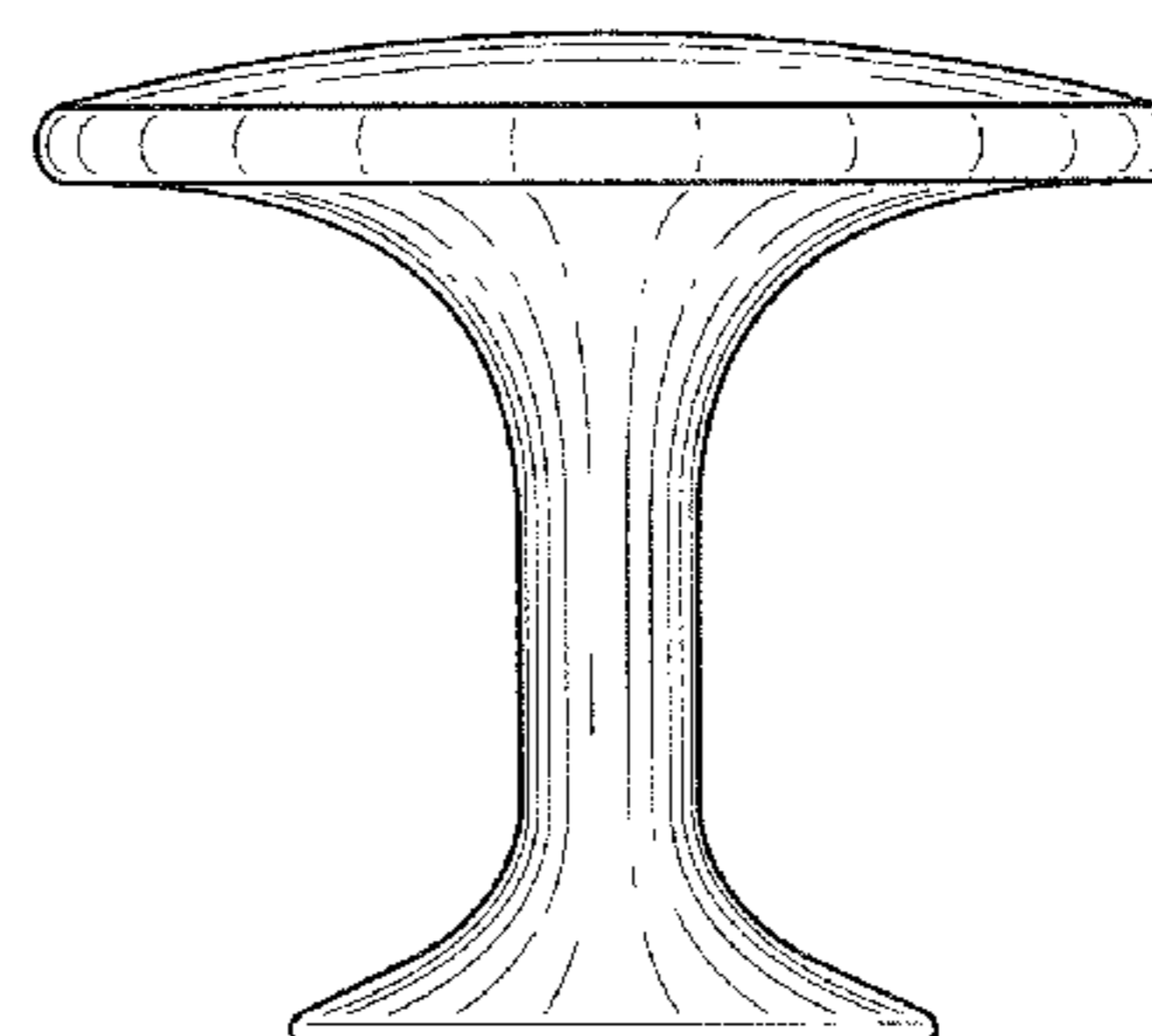
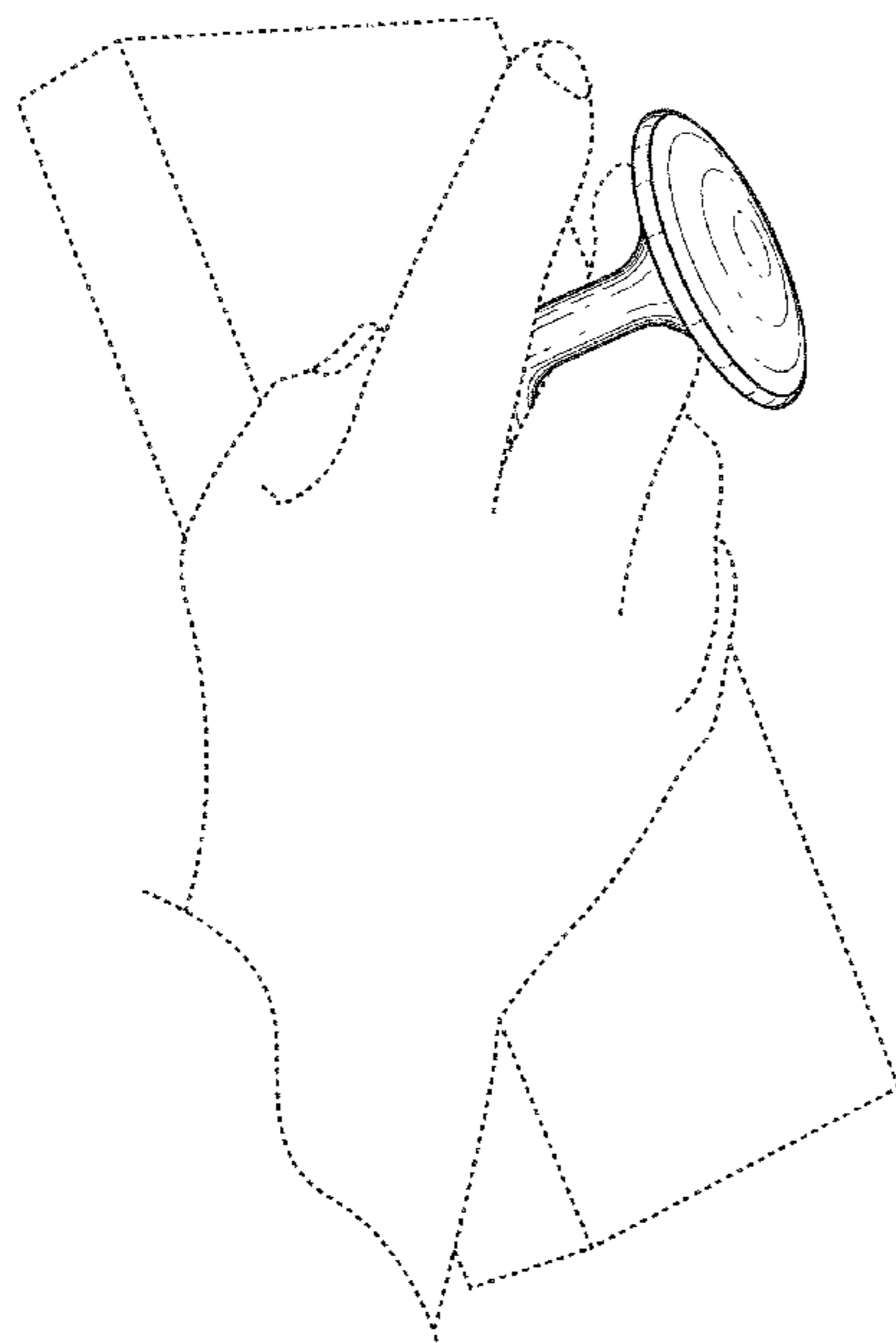
FIG. 2 is a side view thereof, with views from all sides being  
the same;

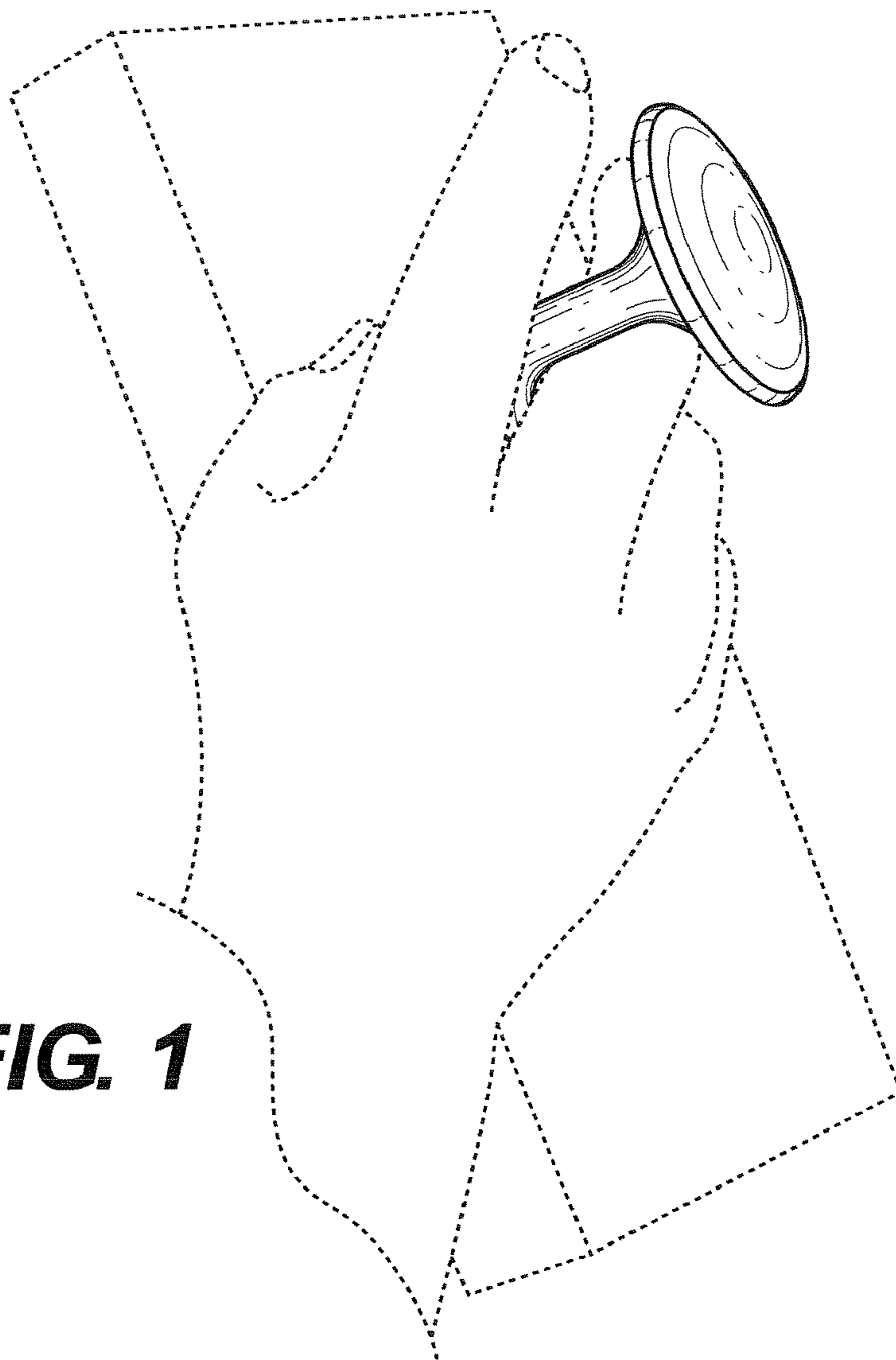
FIG. 3 is a top view thereof; and,

FIG. 4 is a bottom view thereof.

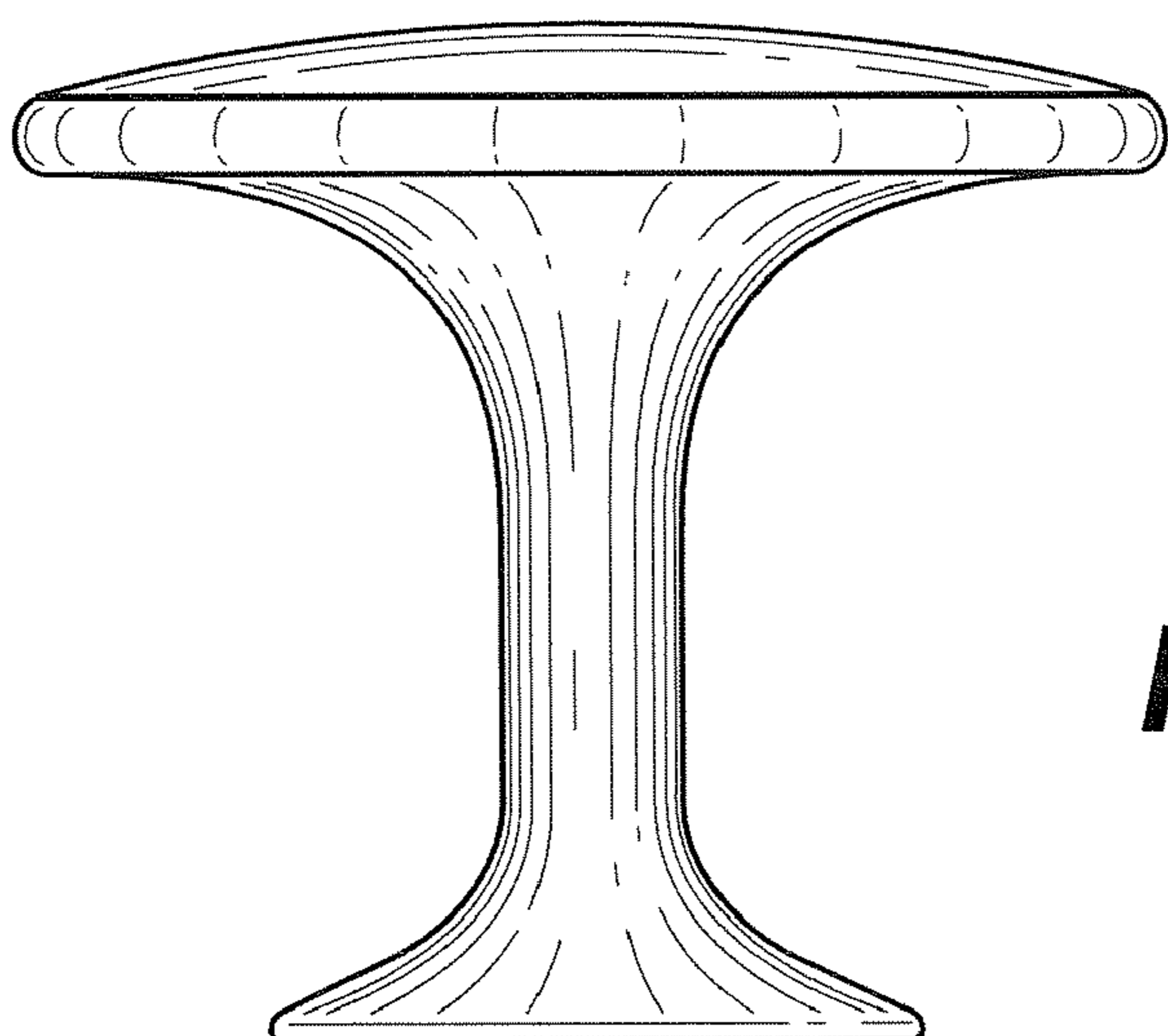
The environmental features illustrated in broken lines in FIG.

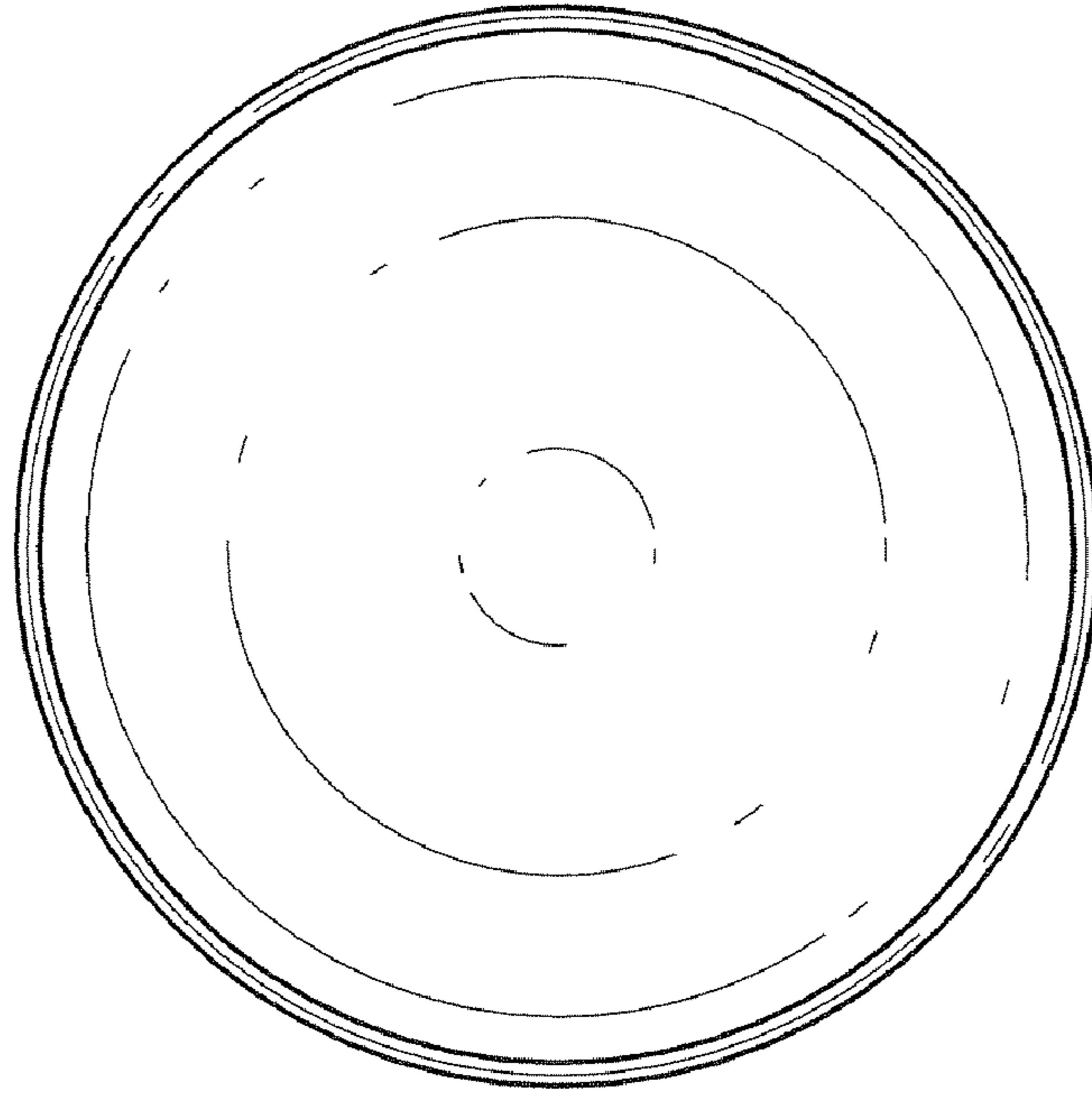




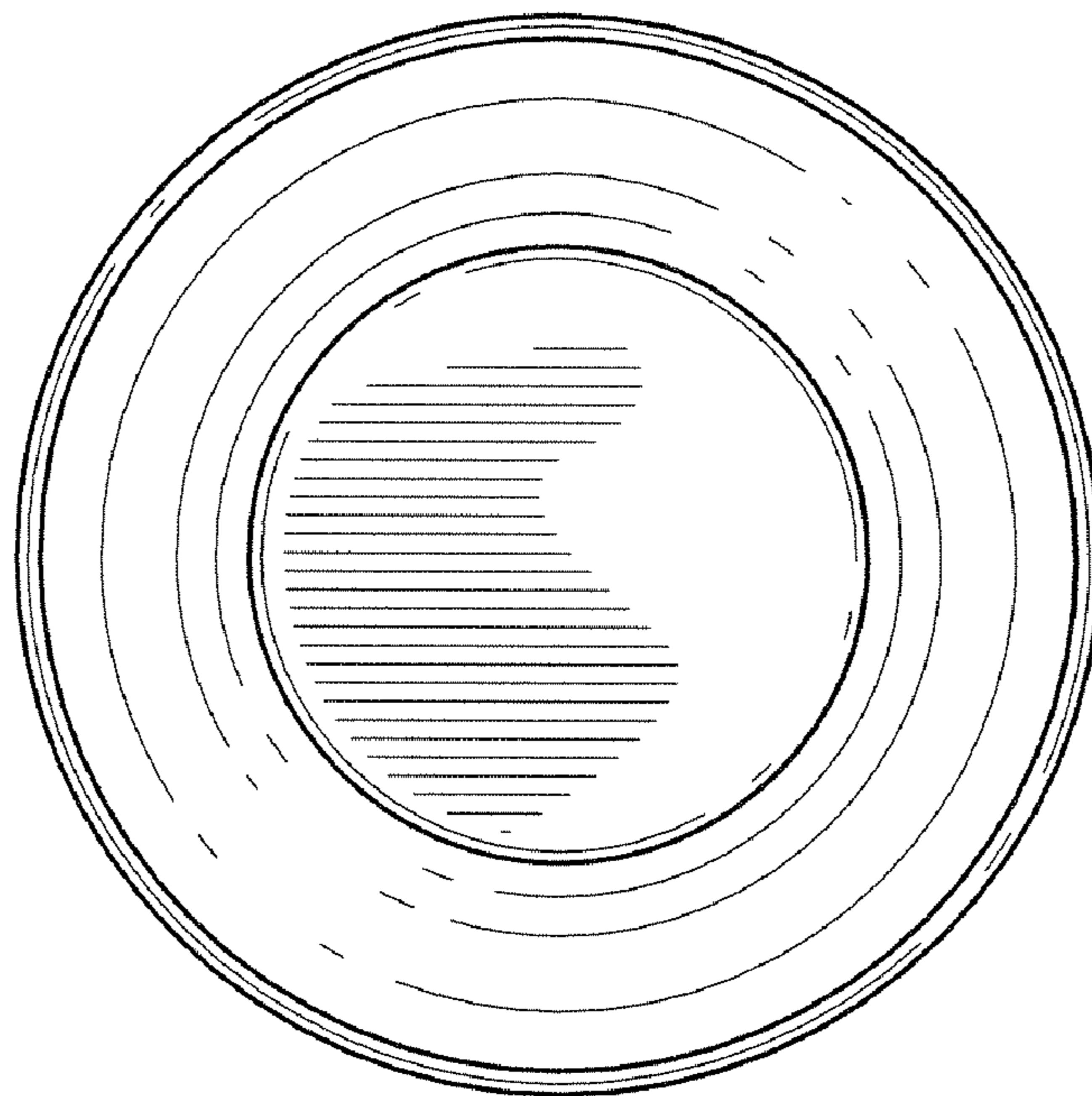
