DESCRIPTION

FIG. 11 is a rear view of the marker of FIG. 8;

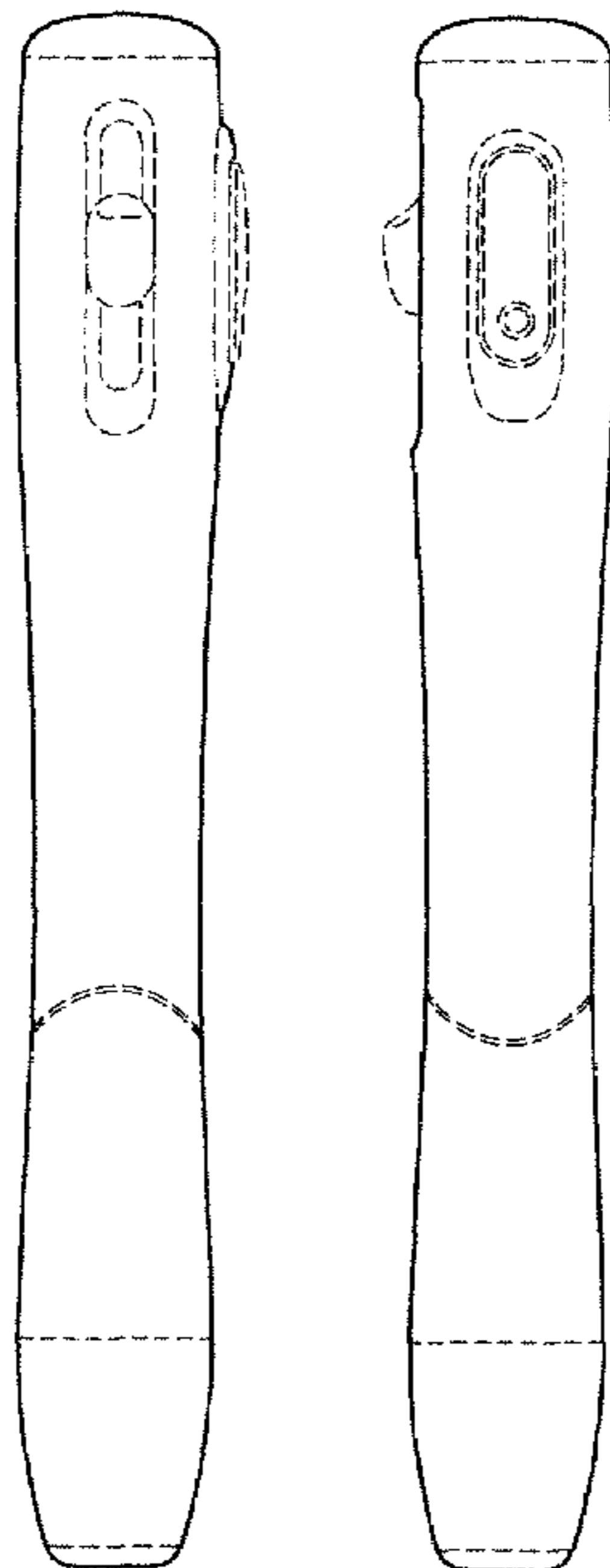
FIG. 12 is a left side view of the marker of FIG. 8;

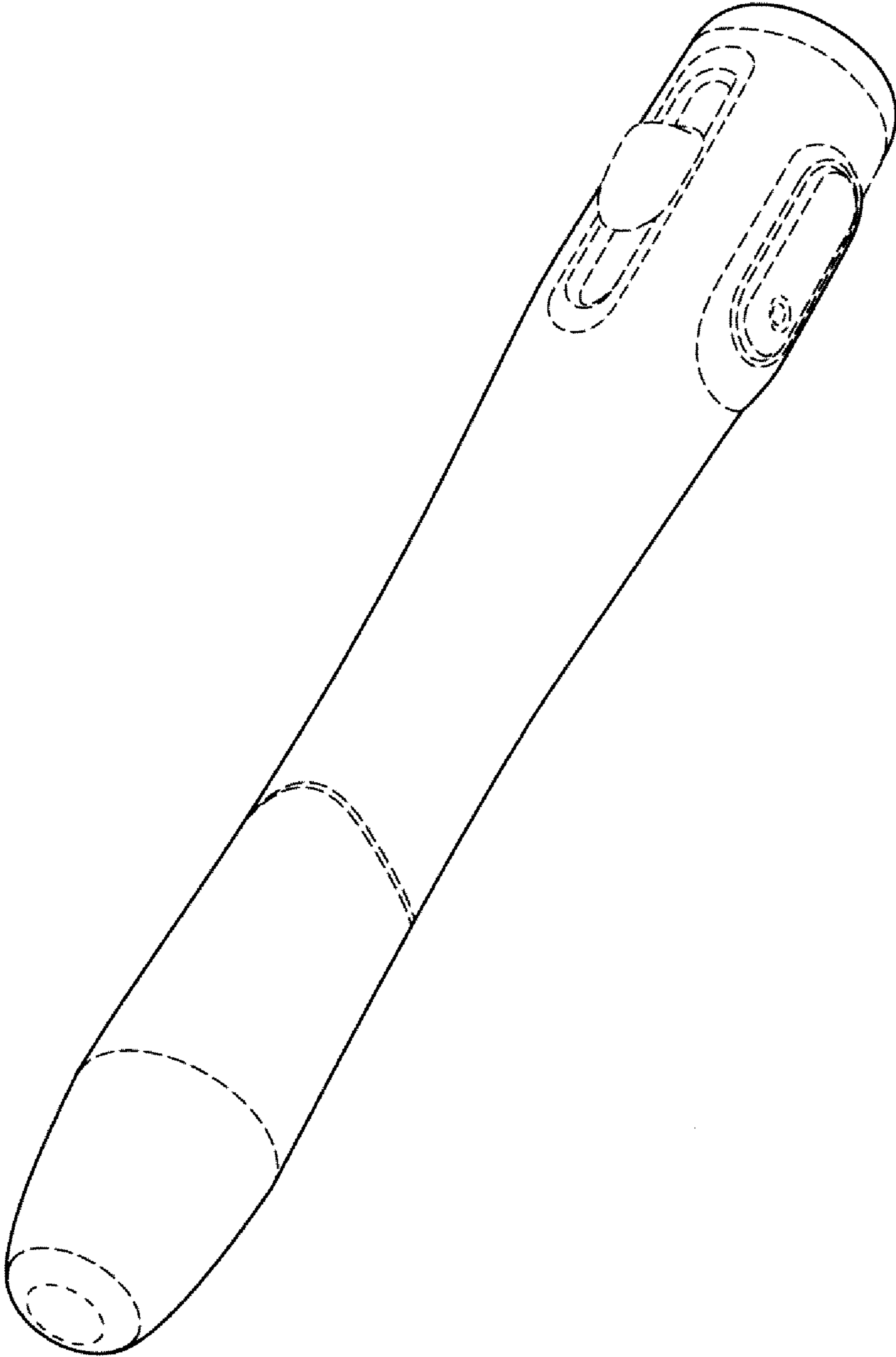

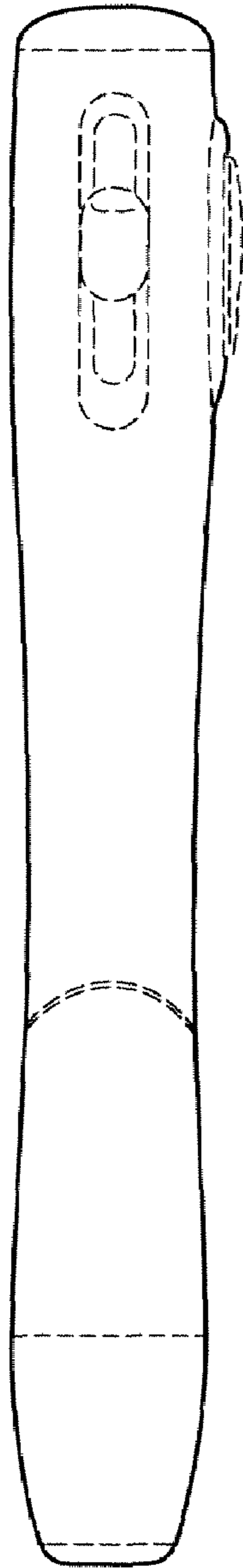

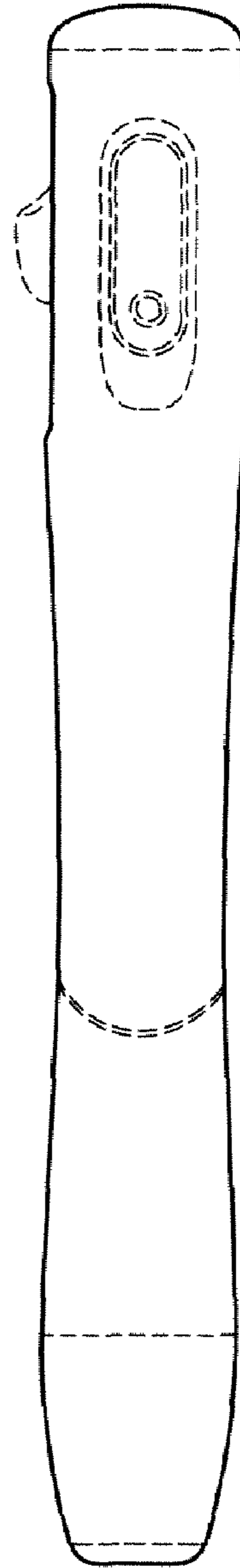

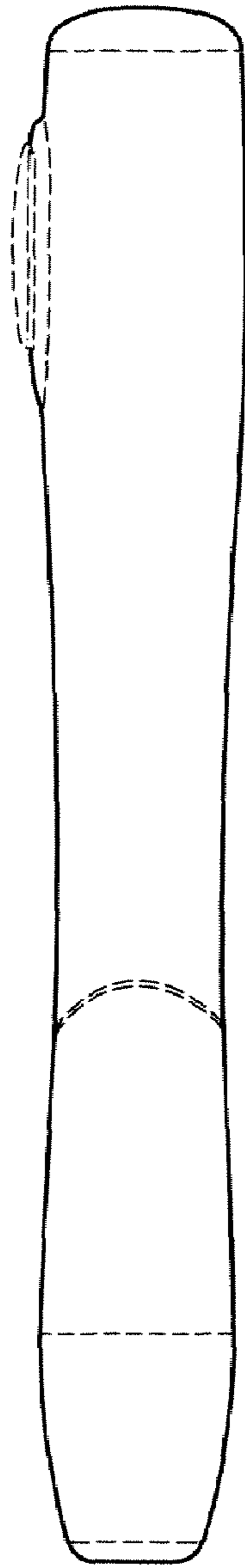

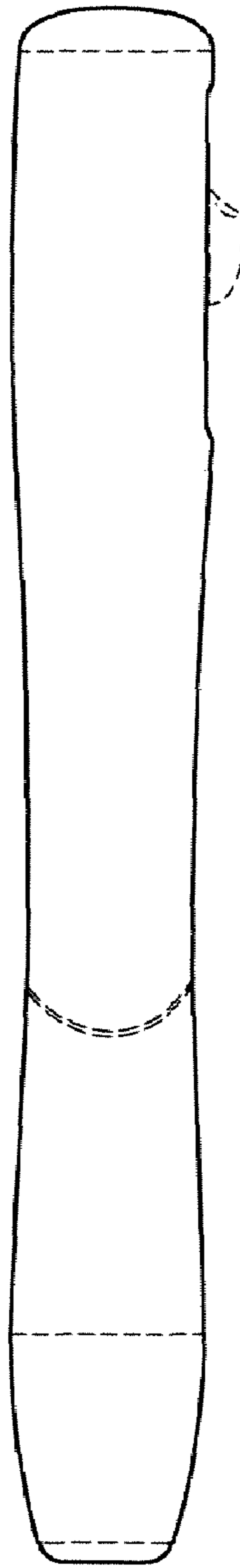

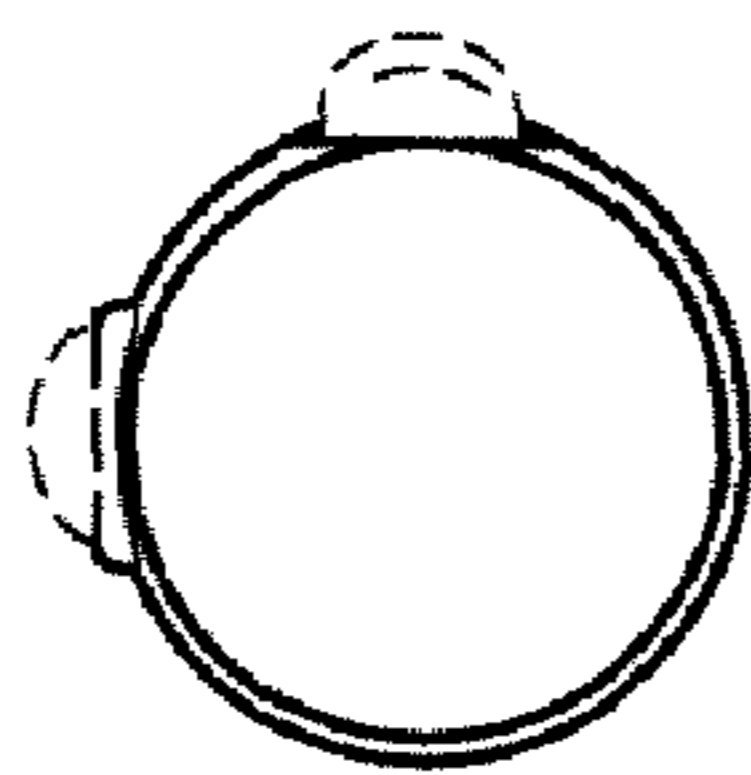

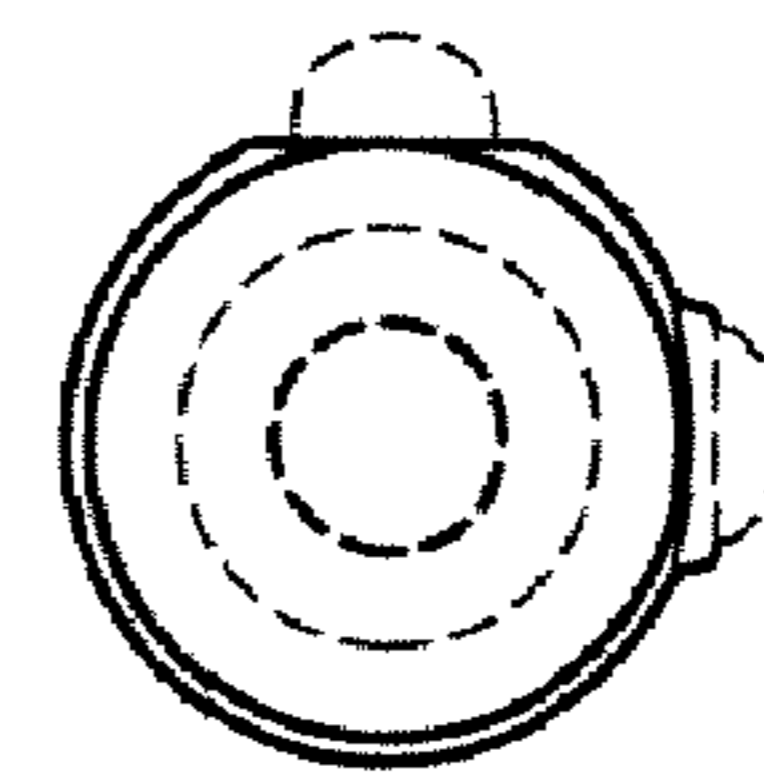

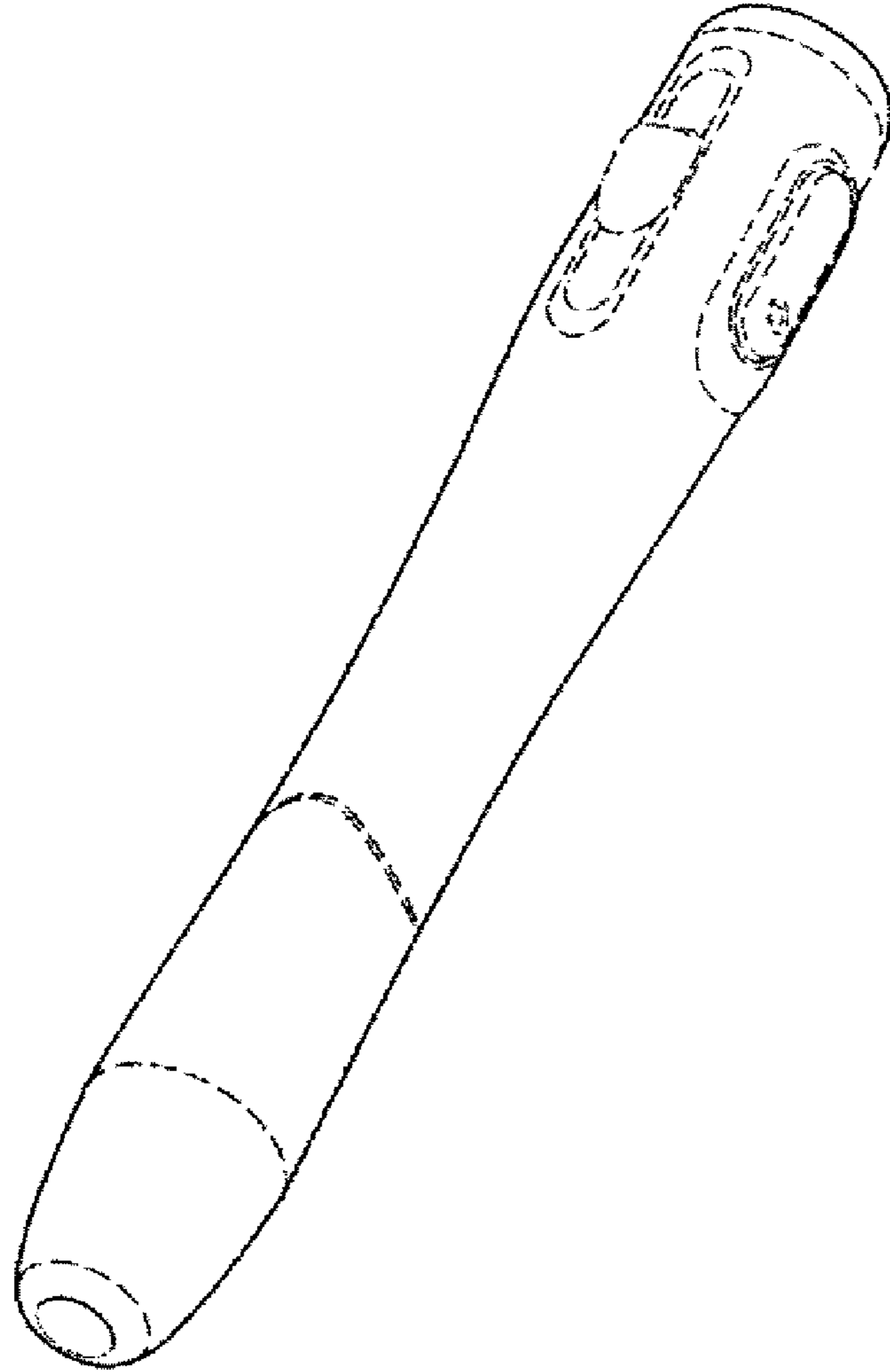

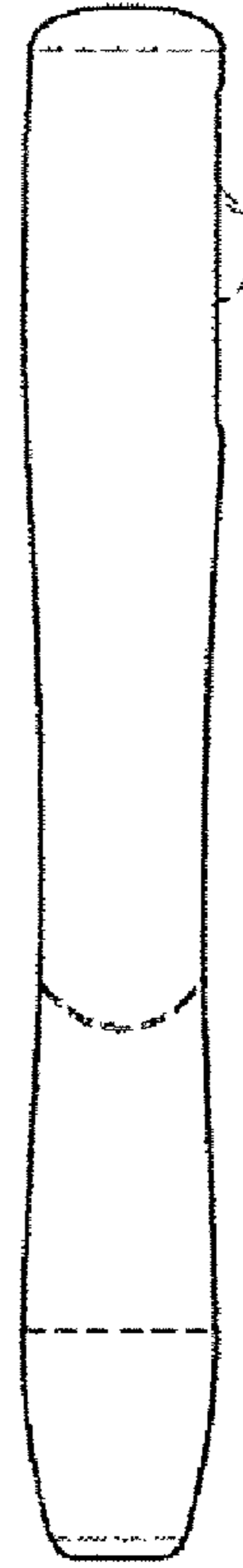

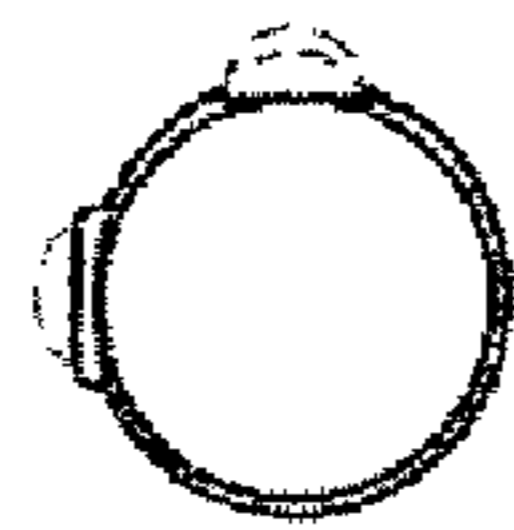

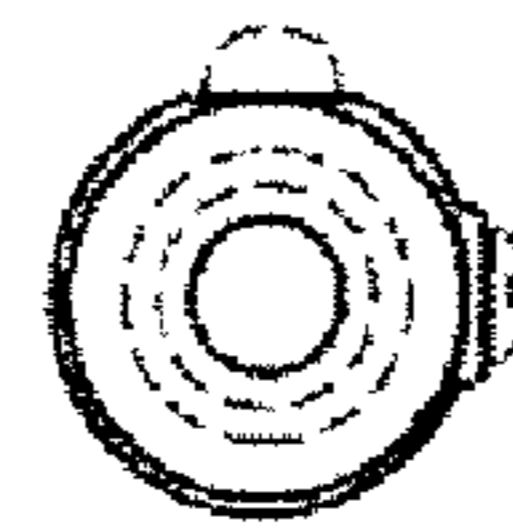
