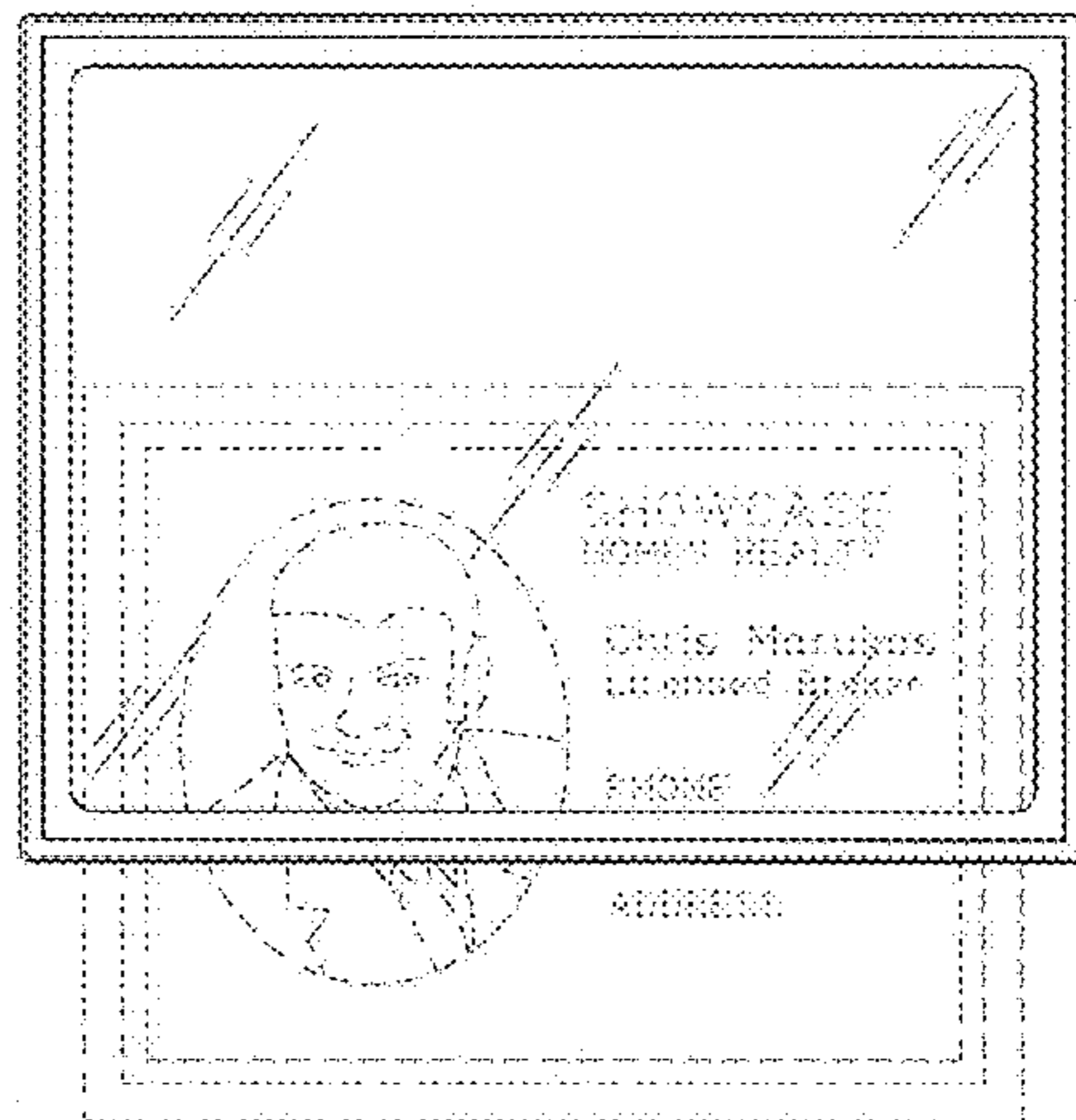
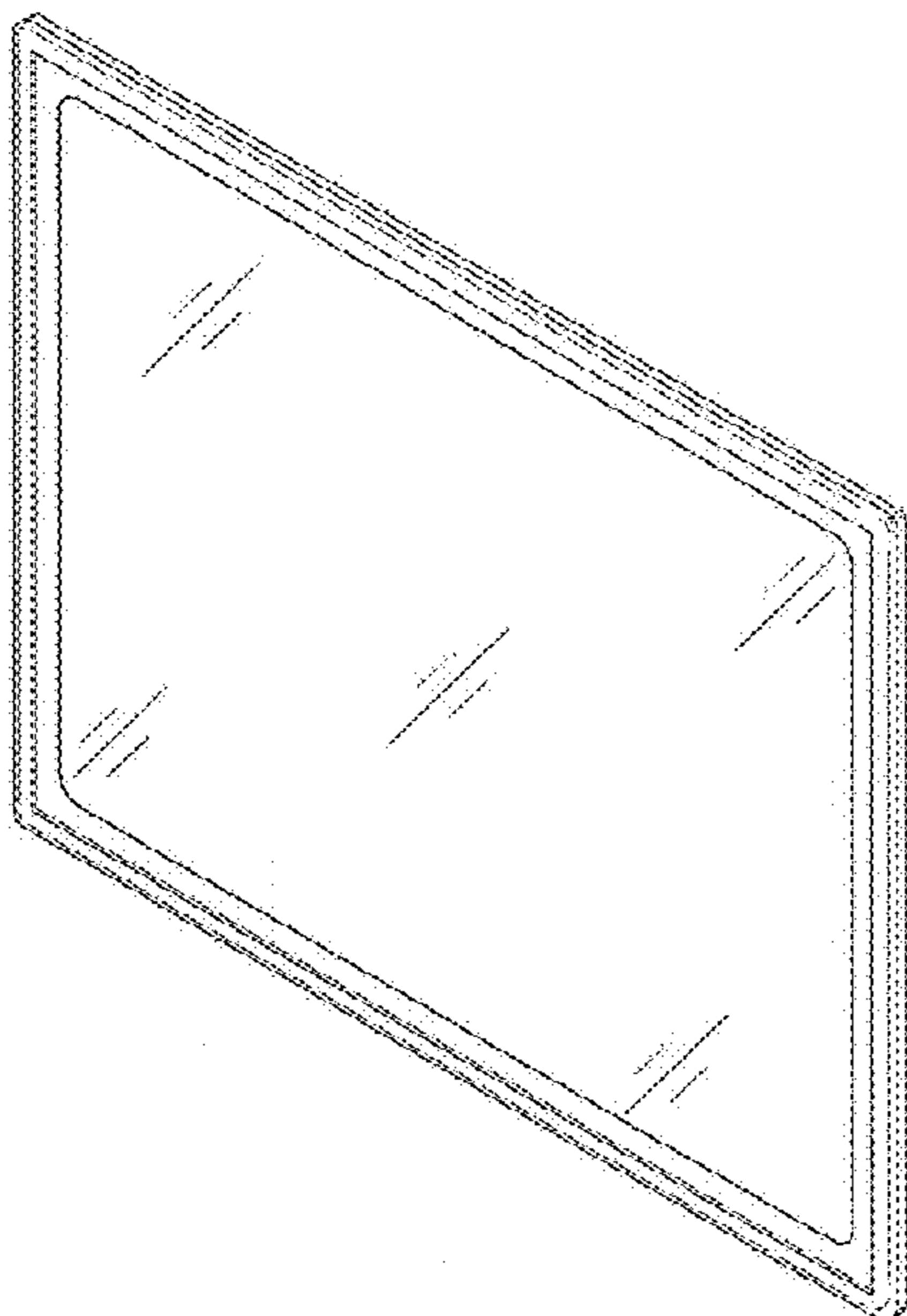
(57) **CLAIM**

The ornamental design for a interchangeable advertising sign, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the interchangeable advertising sign. FIG. 2 is a rear view of the interchangeable advertising sign. FIG. 3 is a side view of the interchangeable advertising sign. FIG. 4 is a top view of the interchangeable advertising sign. FIG. 5 is a bottom view of the interchangeable advertising sign. FIG. 6 is an isometric view of the interchangeable advertising; and, FIG. 7 is an isometric view of the interchangeable advertising sign having an advertisement placed inside. In the drawings, the broken lines represent features which form no part of the claimed design.

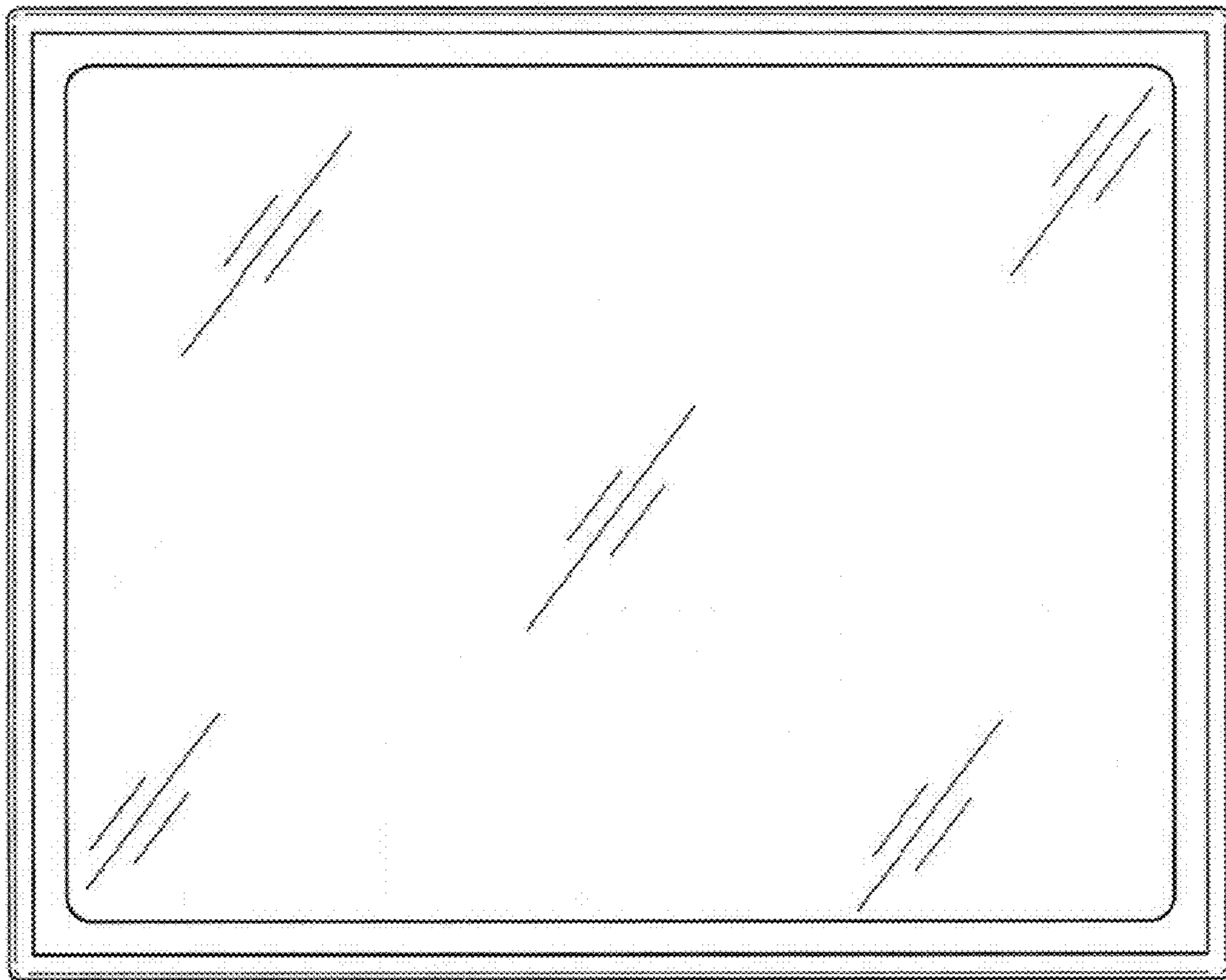

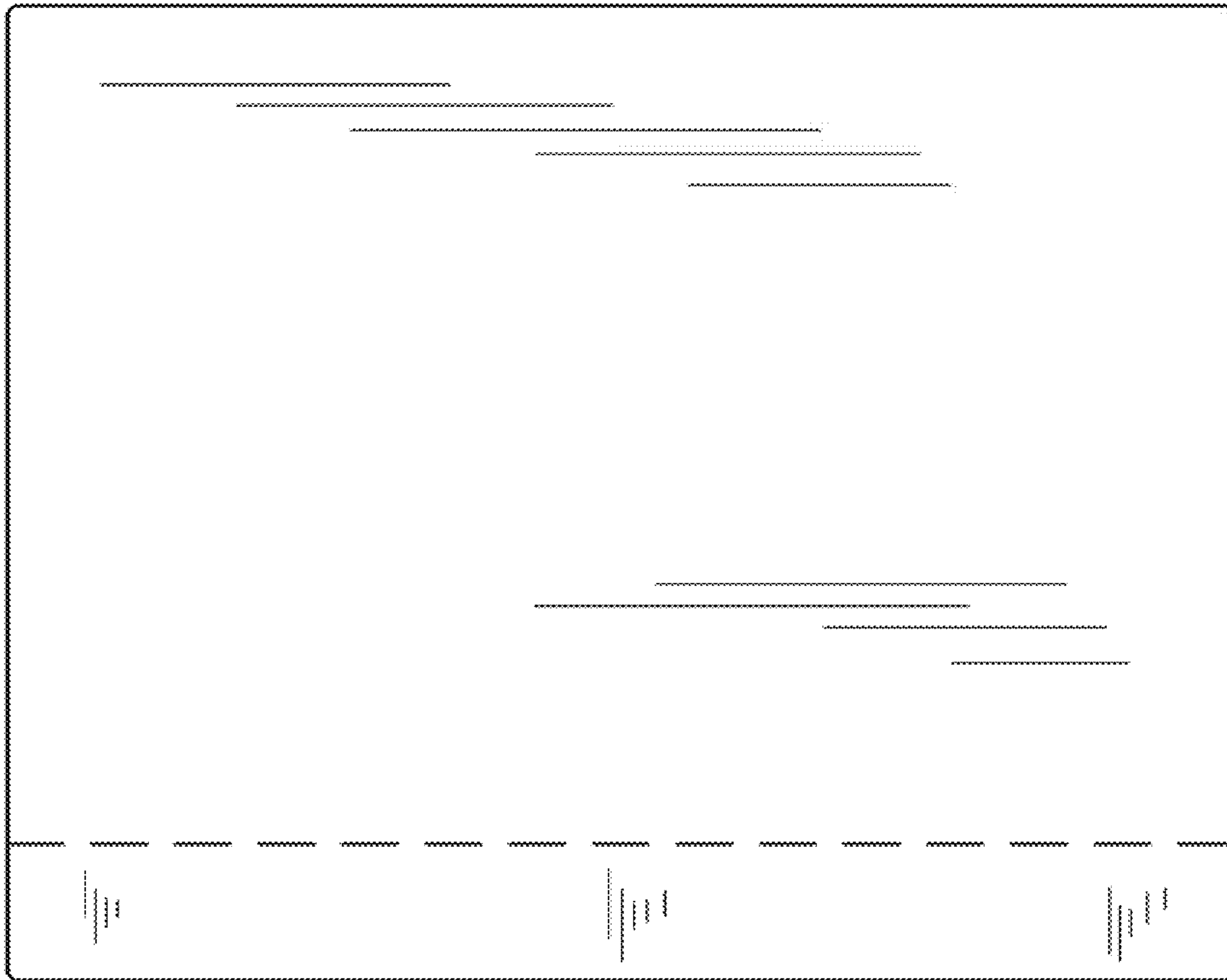

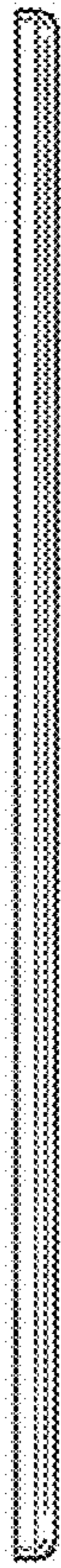

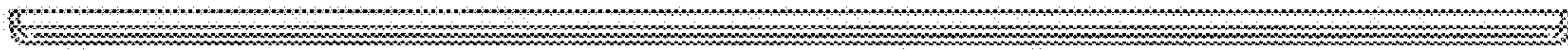

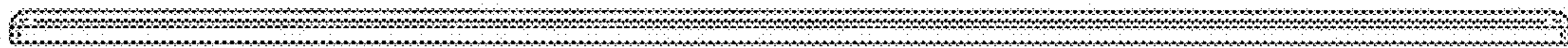

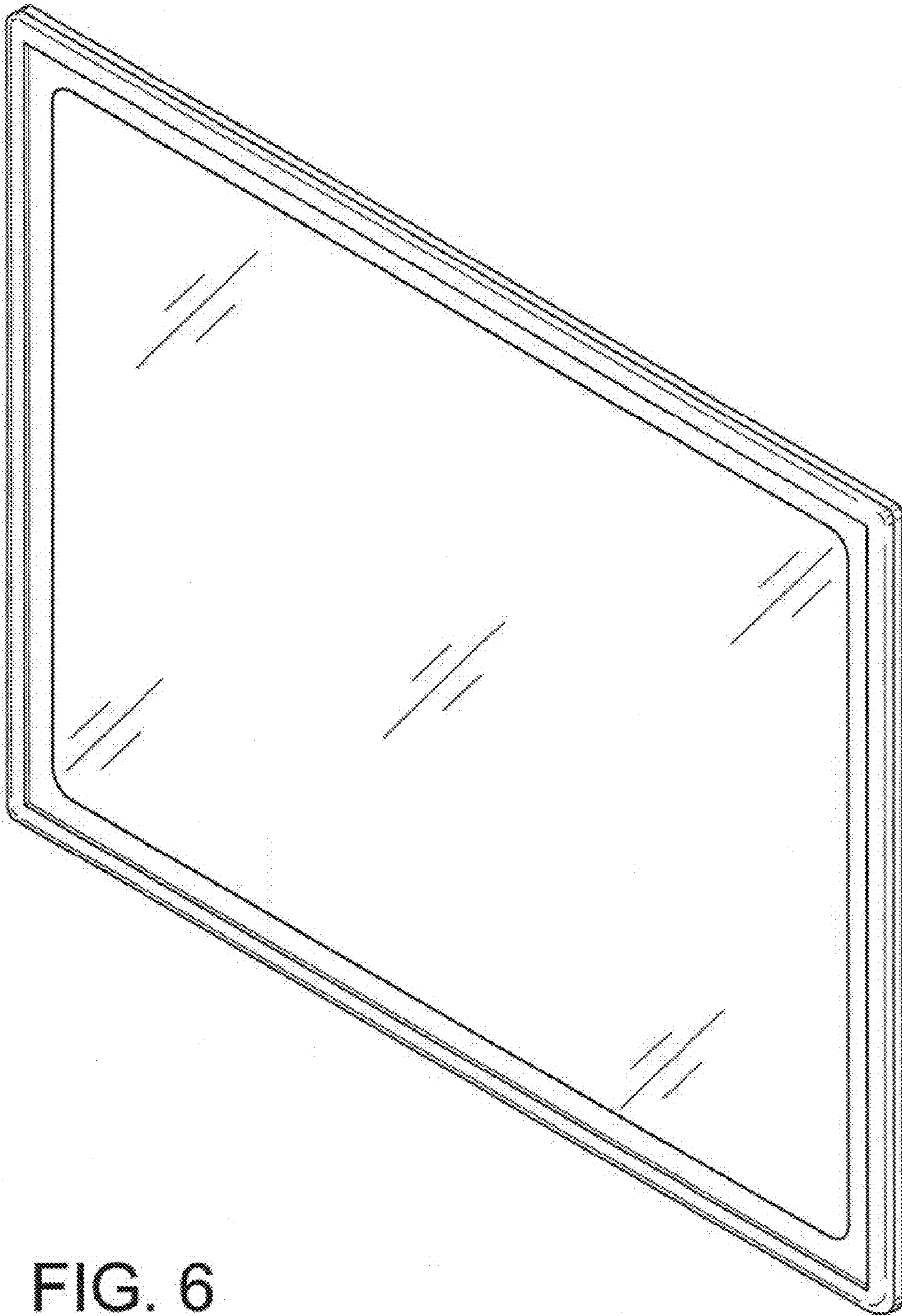

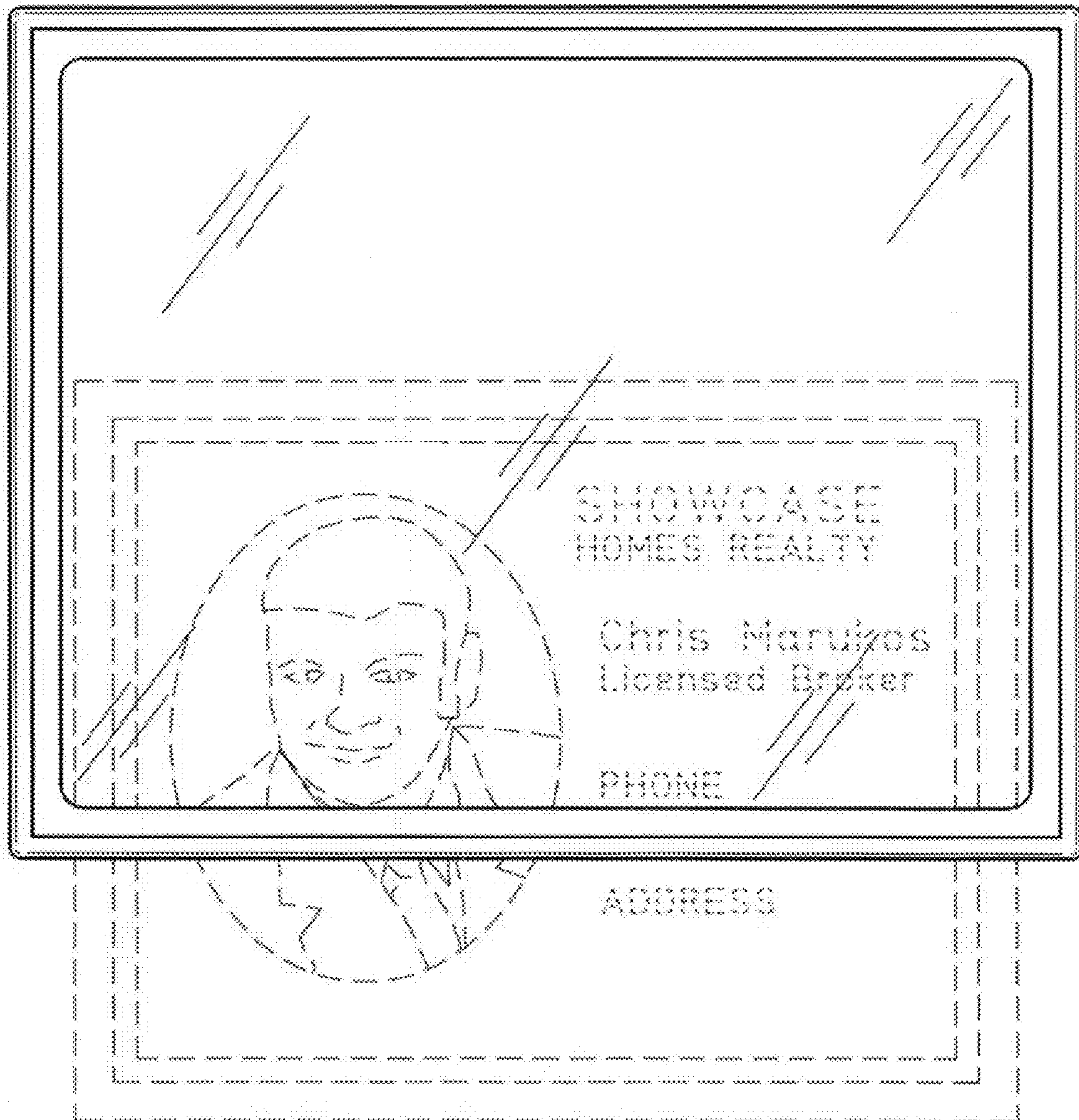
