The ornamental design for a multi-purpose body-sail with swallow tail, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a multi-purpose body-sail with swallow tail, showing my new design in use;

FIG. 2 is an alternate perspective view of the invention in another position of use;

FIG. 3 is an alternate perspective view of the invention in another position of use;

FIG. 4 is an alternate perspective view of the invention in another position of use;

FIG. 5 is a front elevational view of the invention;

FIG. 6 is a rear elevational view of the invention;

FIG. 7 is a left-side elevational view of the invention;

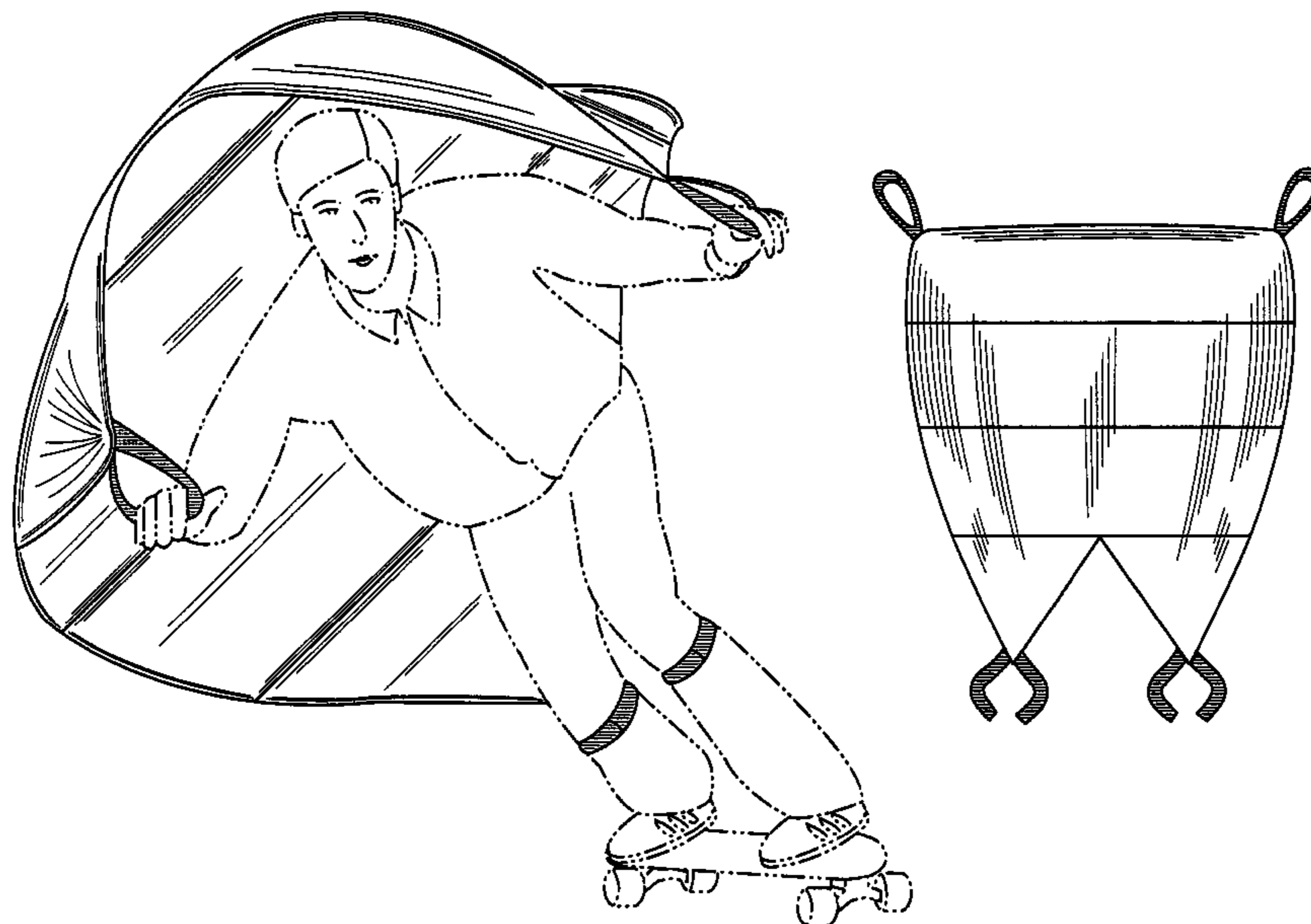
FIG. 8 is a right-side elevational view of the invention;

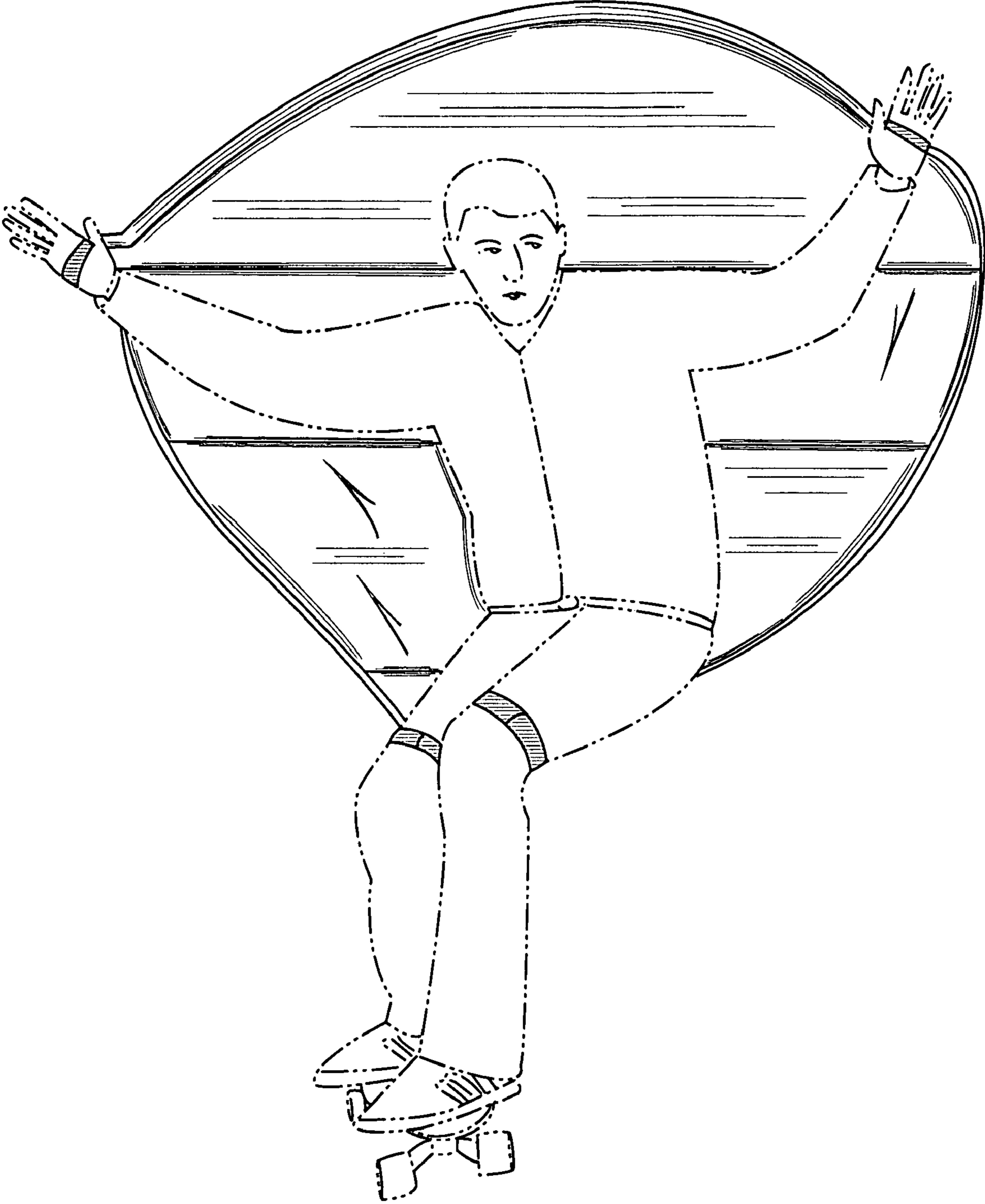

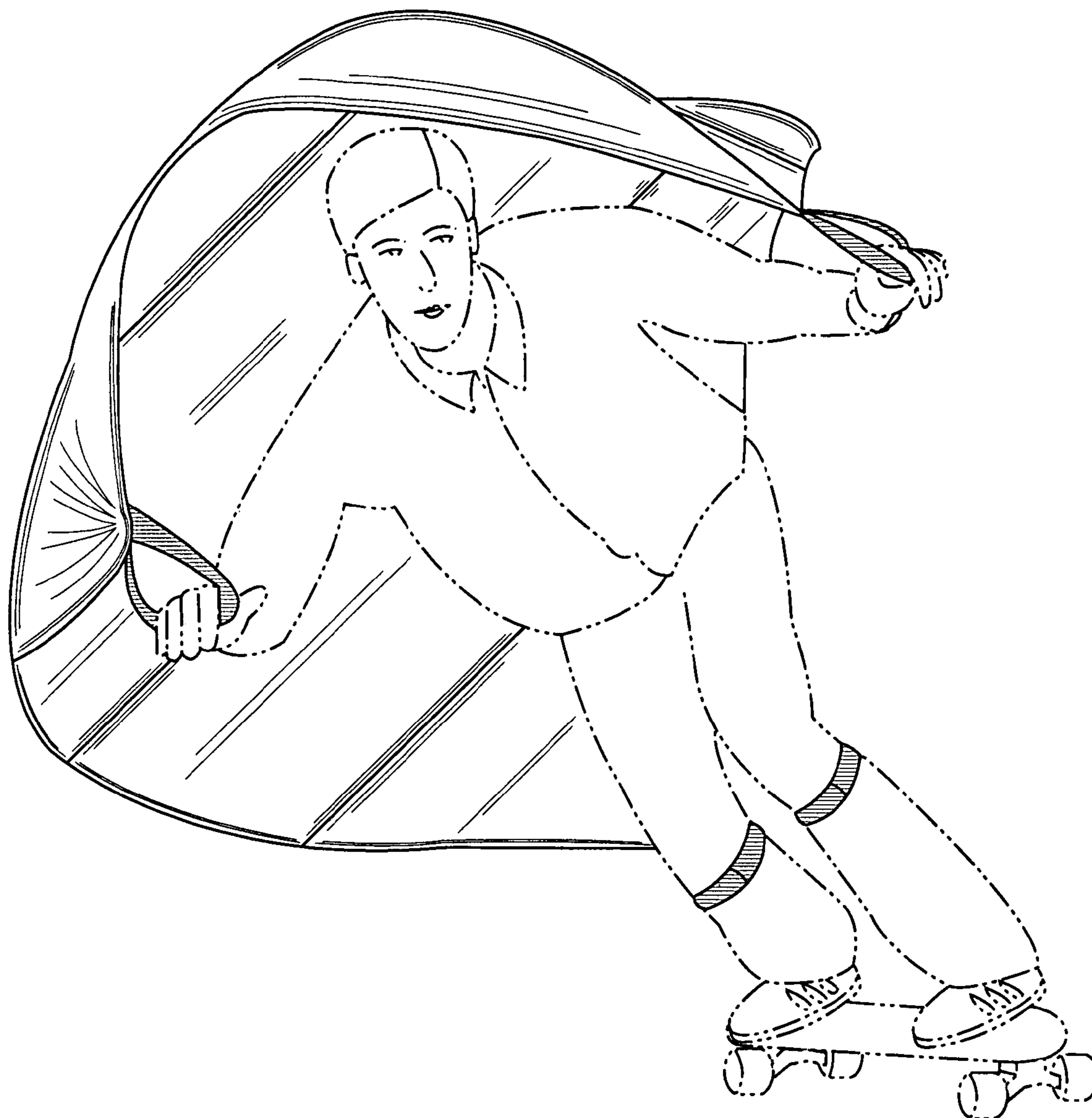

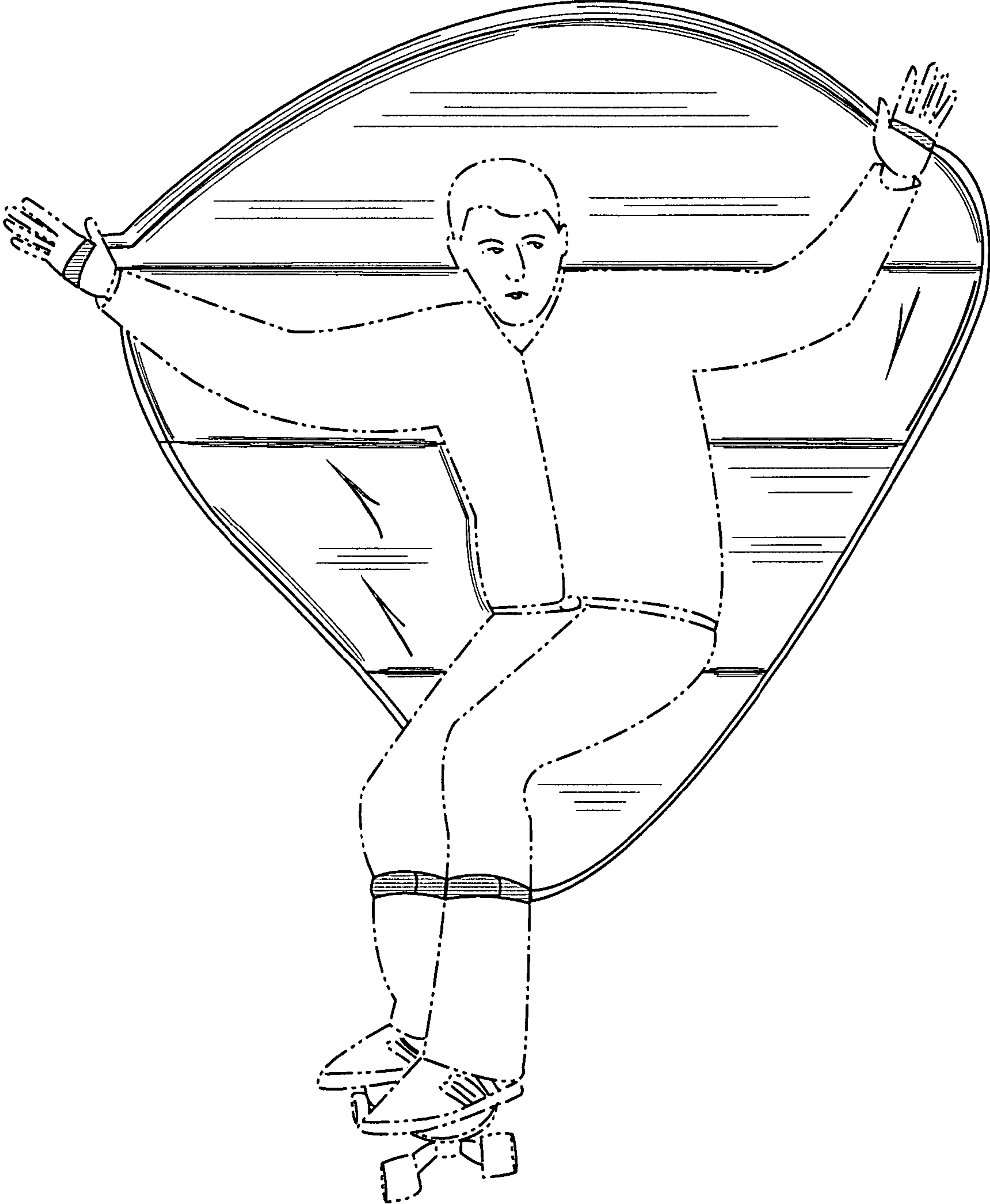

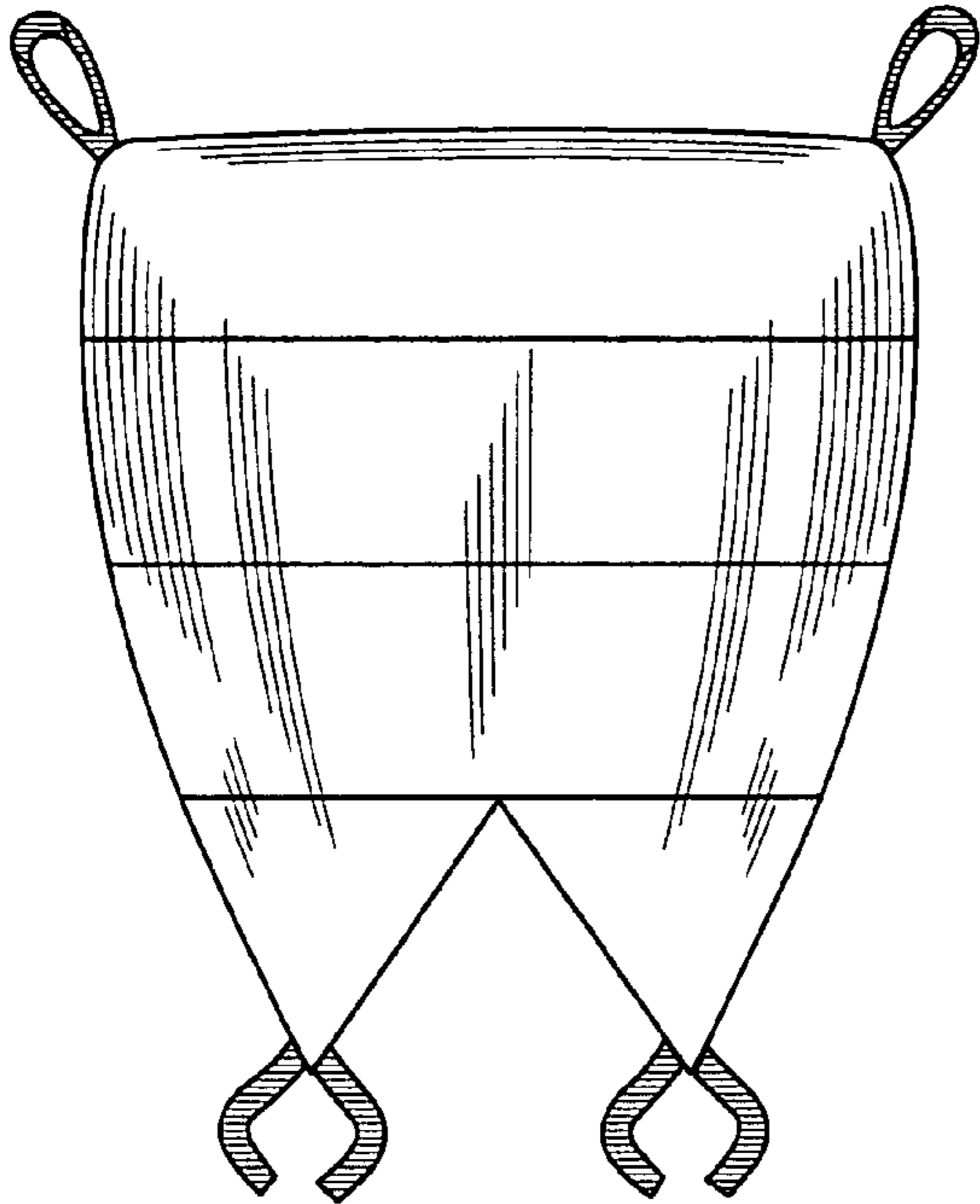

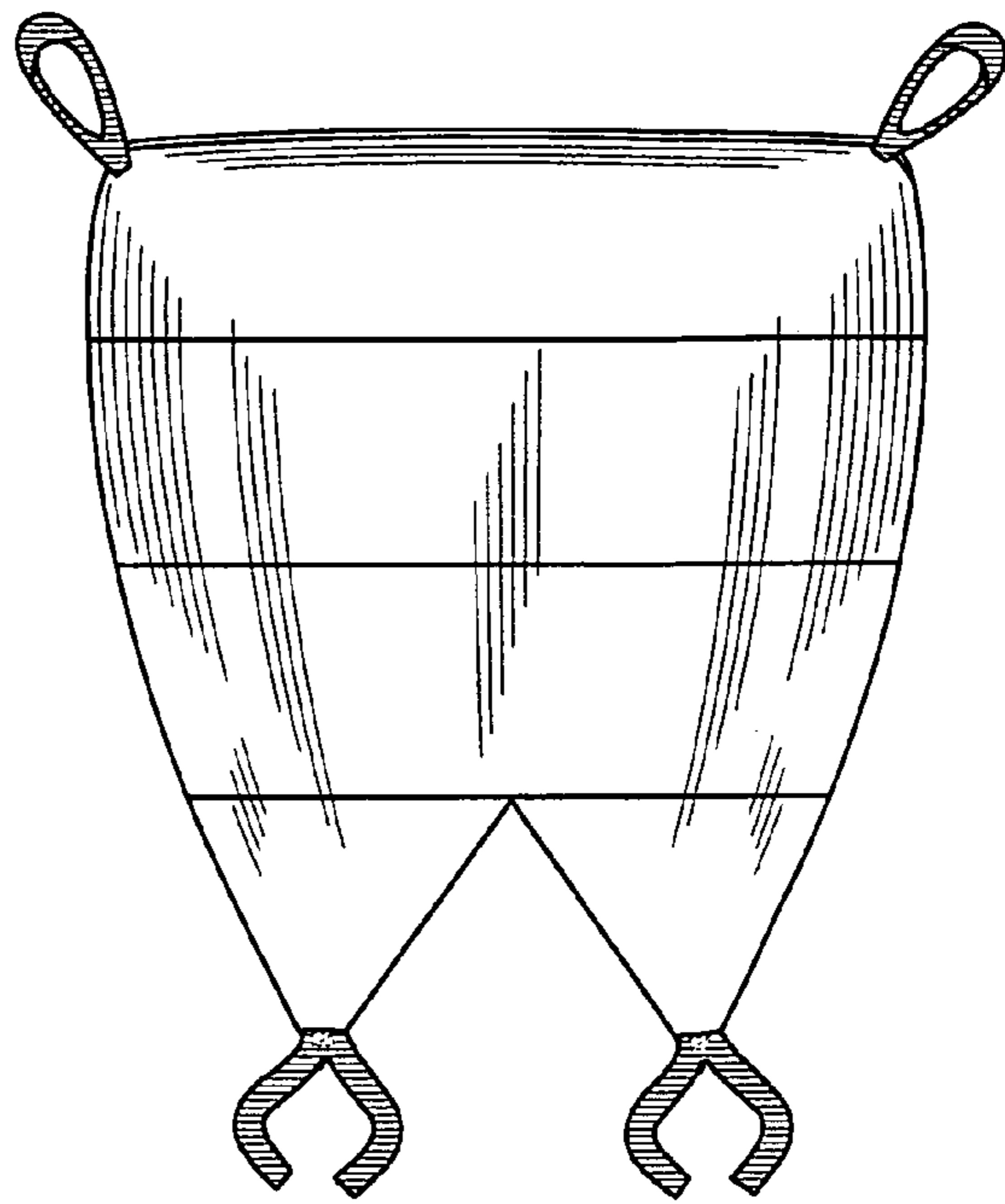

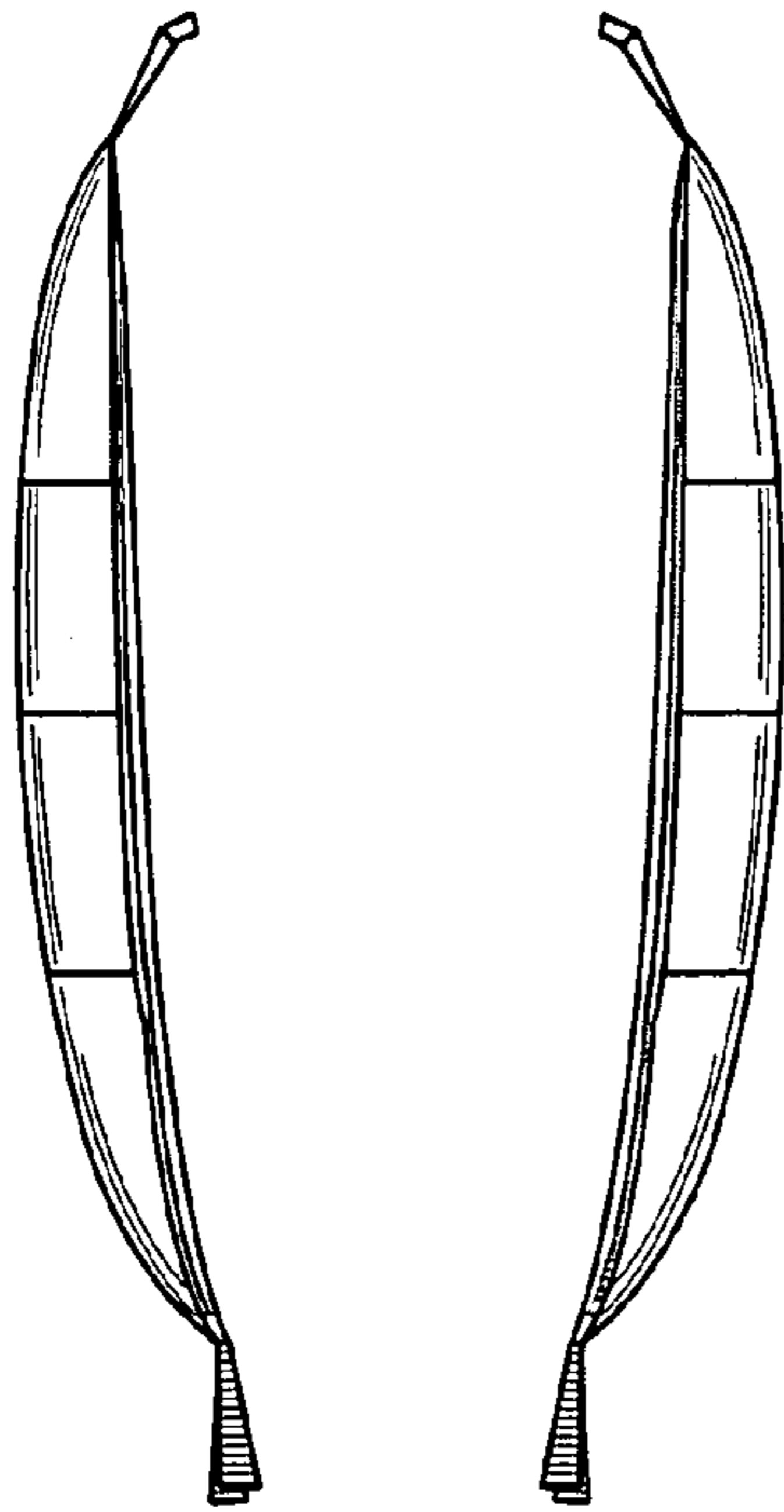

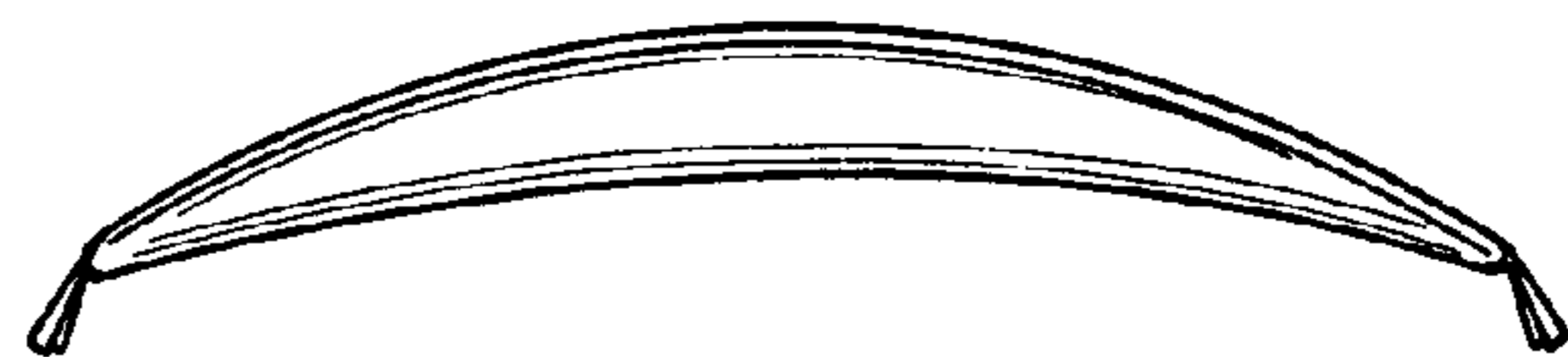
