(57) **CLAIM**

The ornamental design for a hose valve, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hose valve showing my new design;

FIG. 2 is a left side elevational view showing the design for the hose valve of FIG. 1;

FIG. 3 is a right side elevational view showing the design for the hose valve of FIG. 1;

FIG. 4 is a rear elevational view showing the design for the hose valve of FIG. 1;

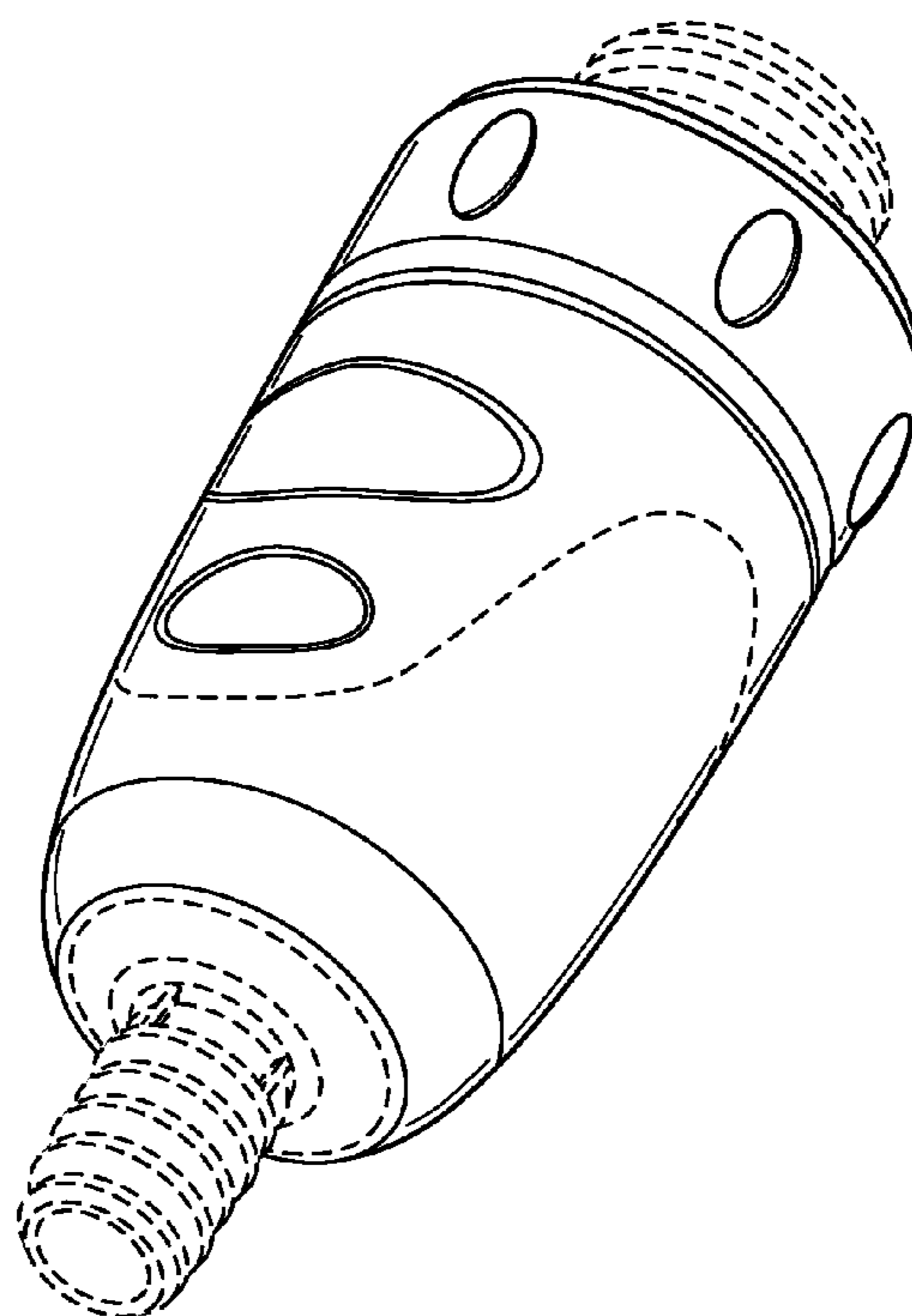
FIG. 5 is a front elevational view showing the design for the hose valve of FIG. 1;

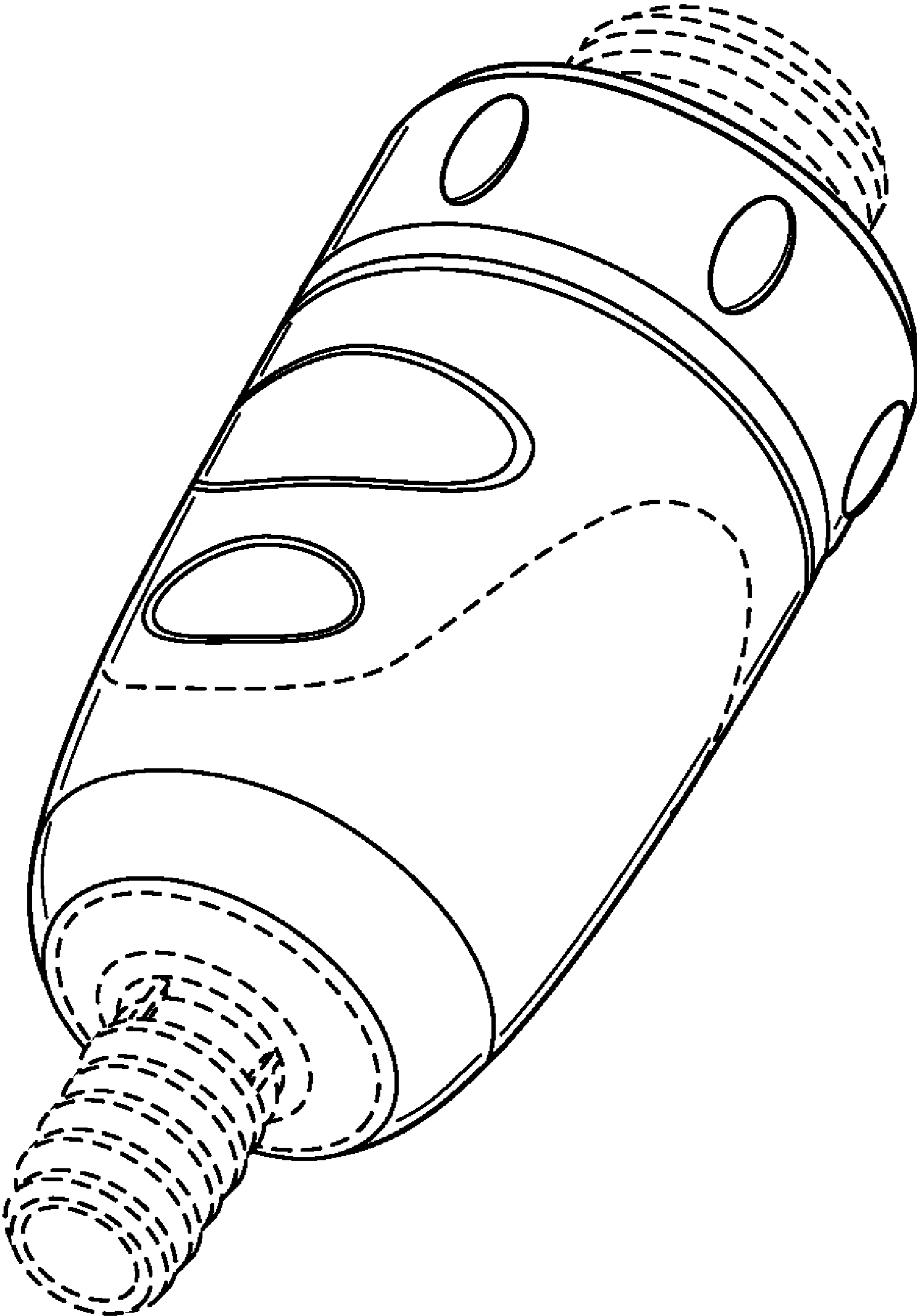

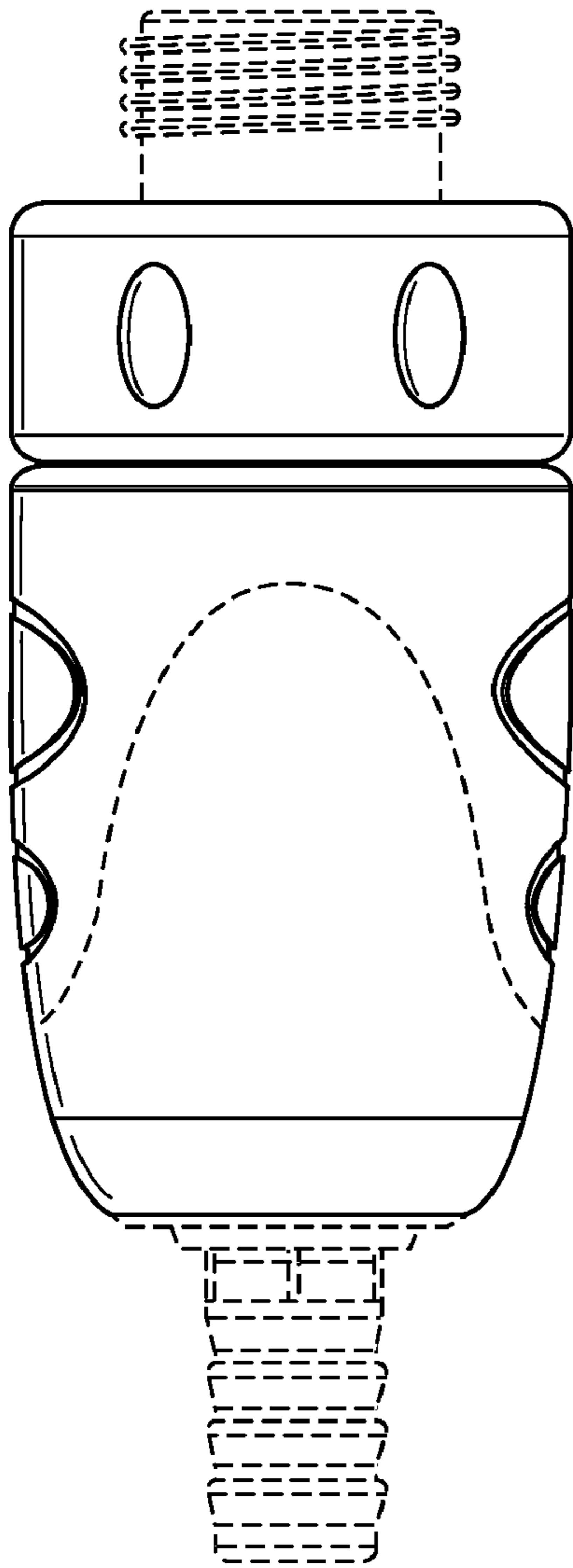

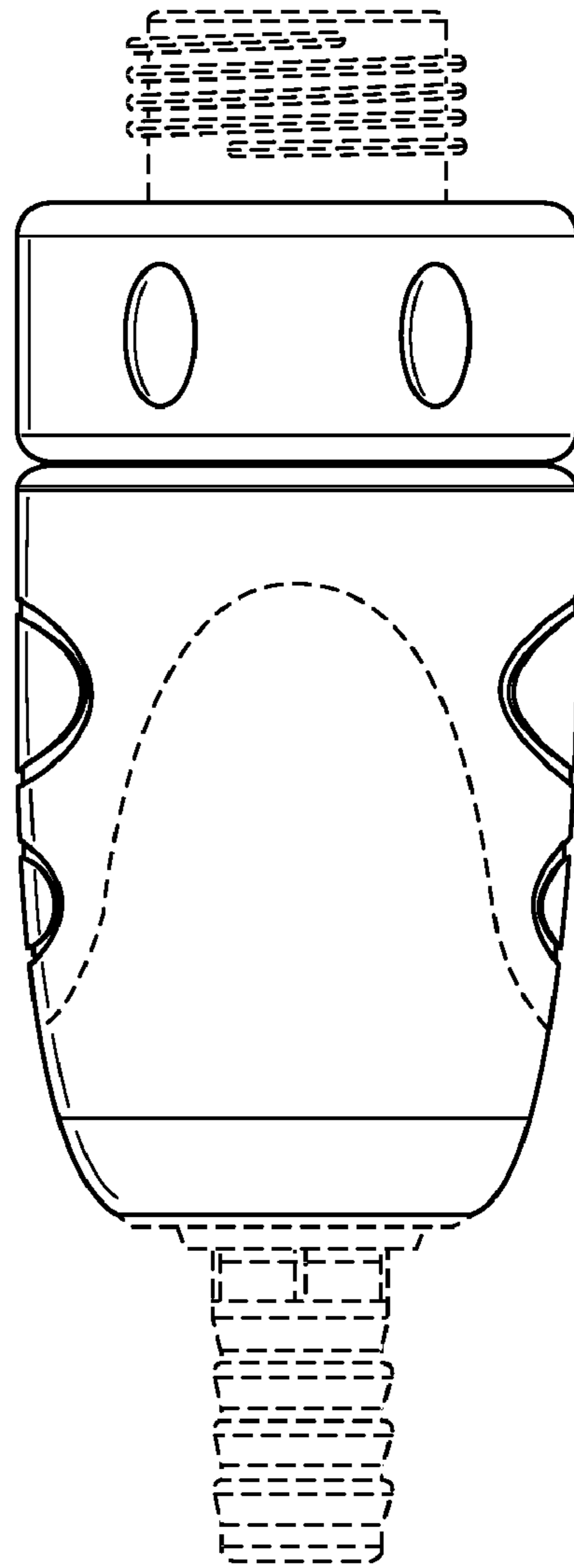

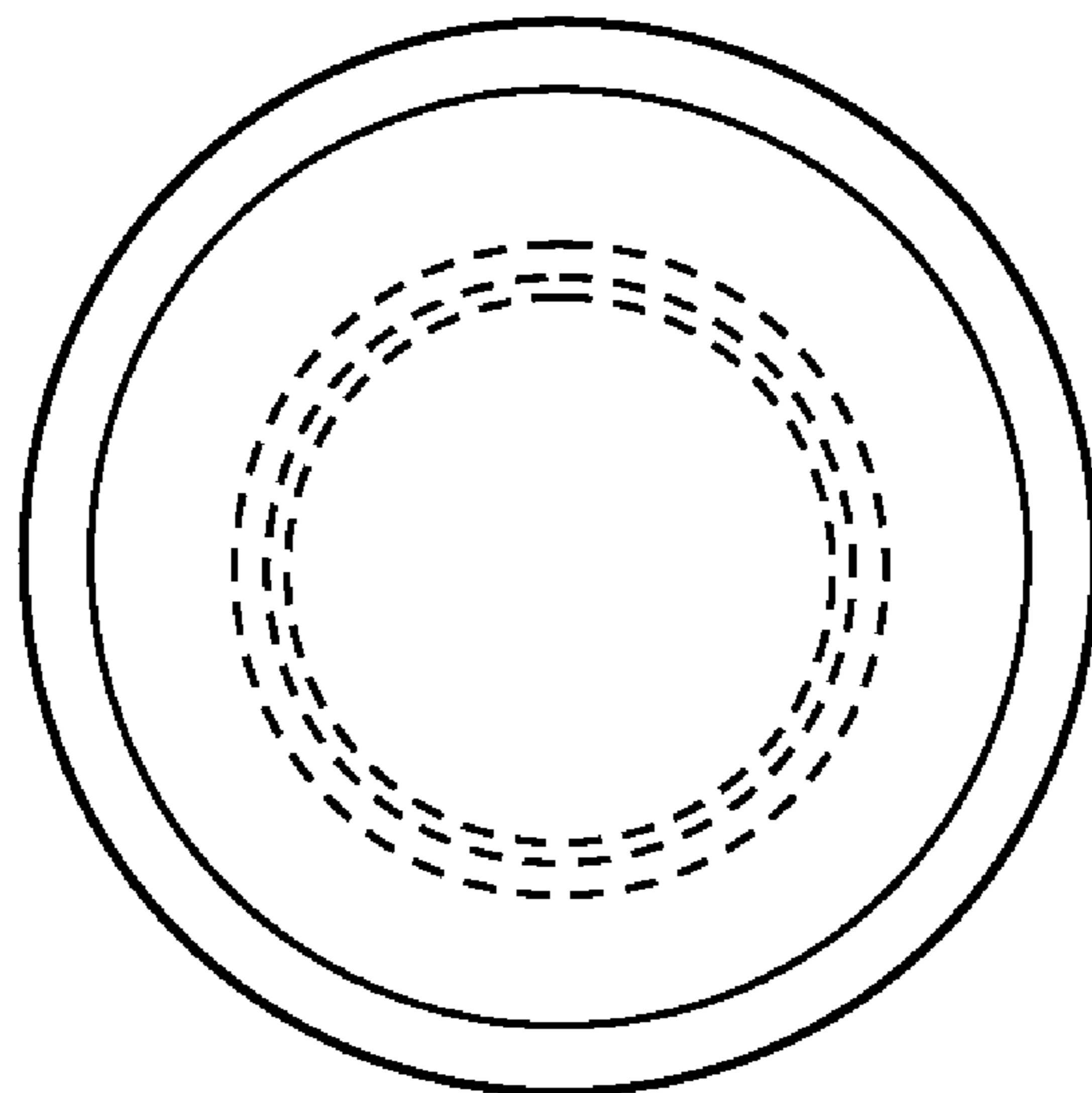

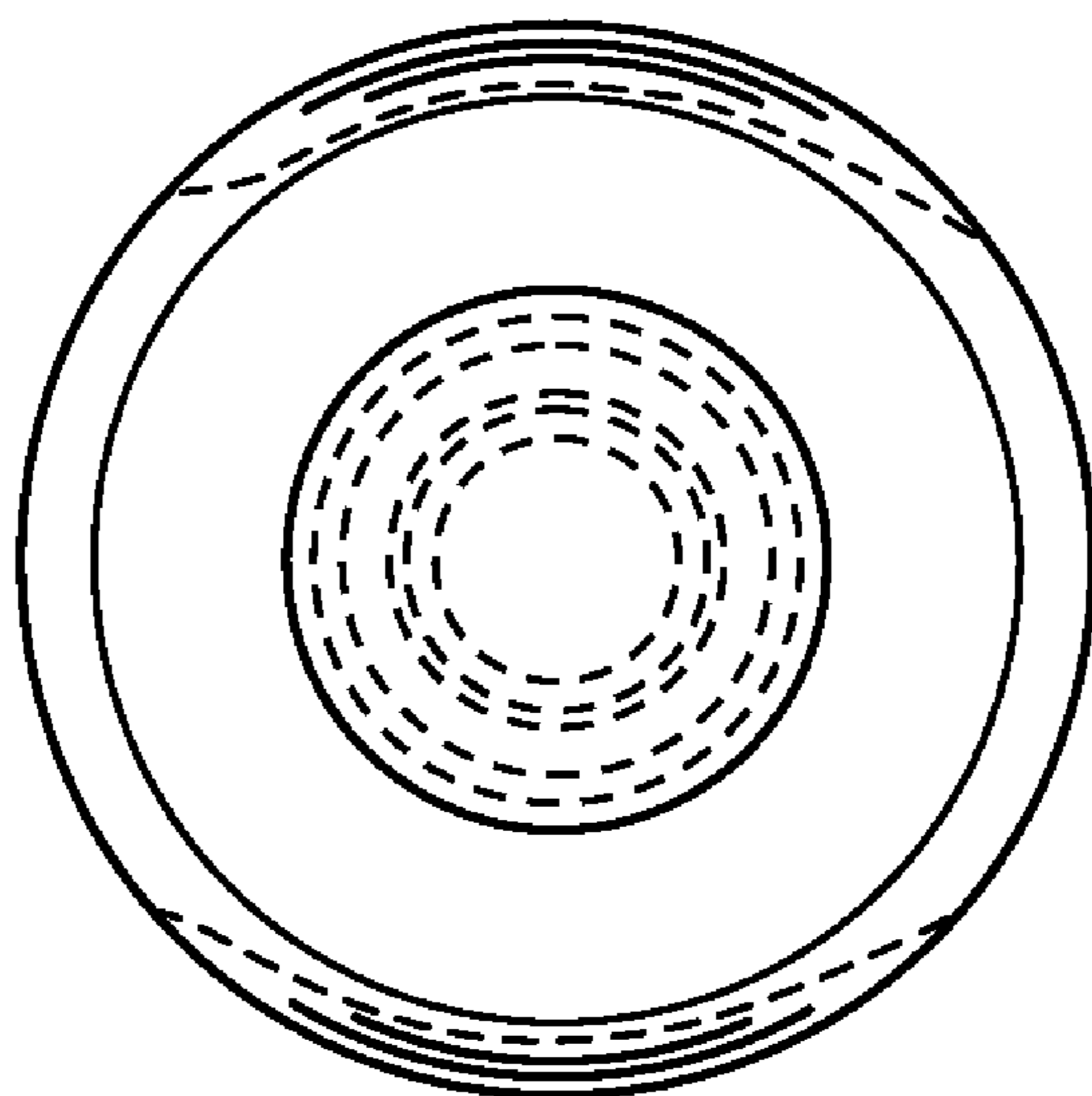

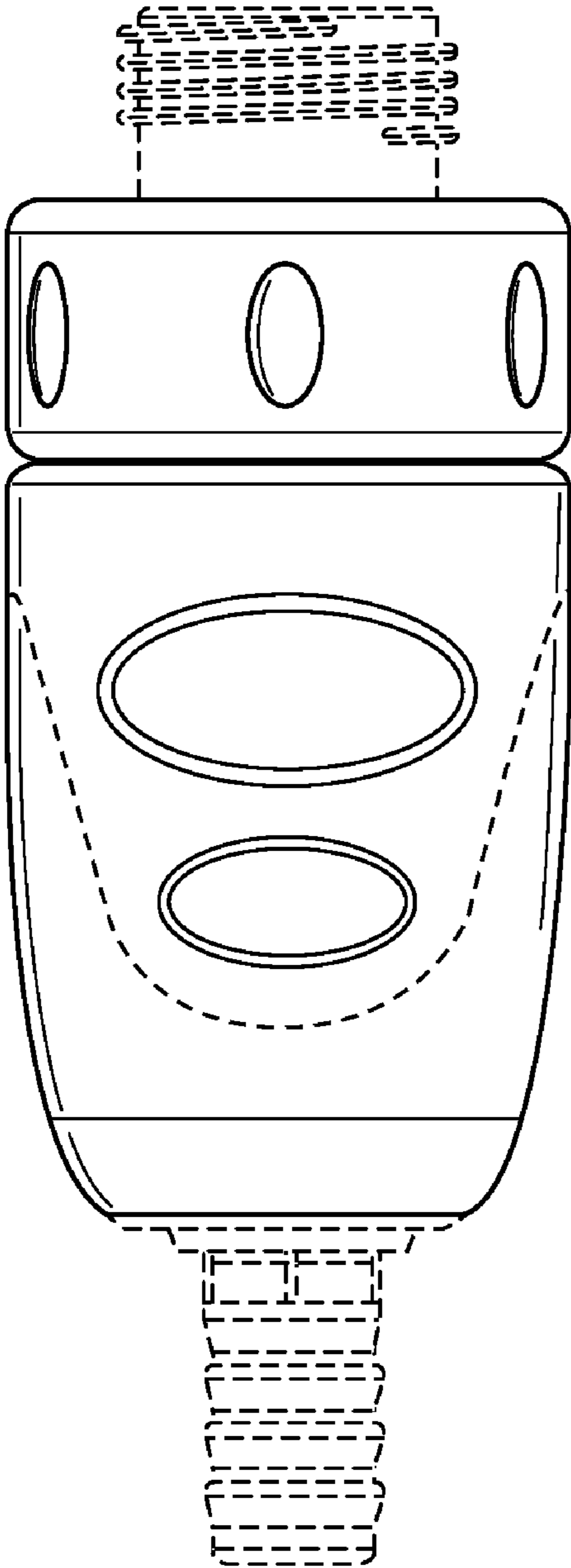

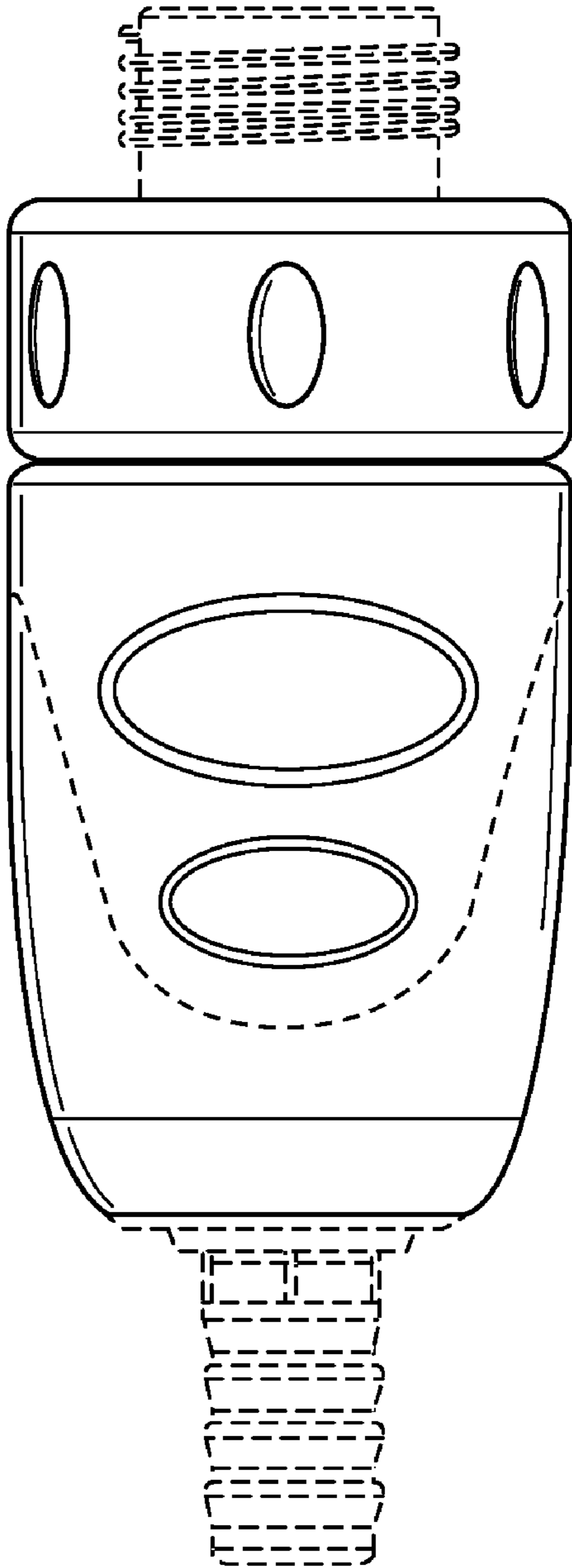
