thereof.

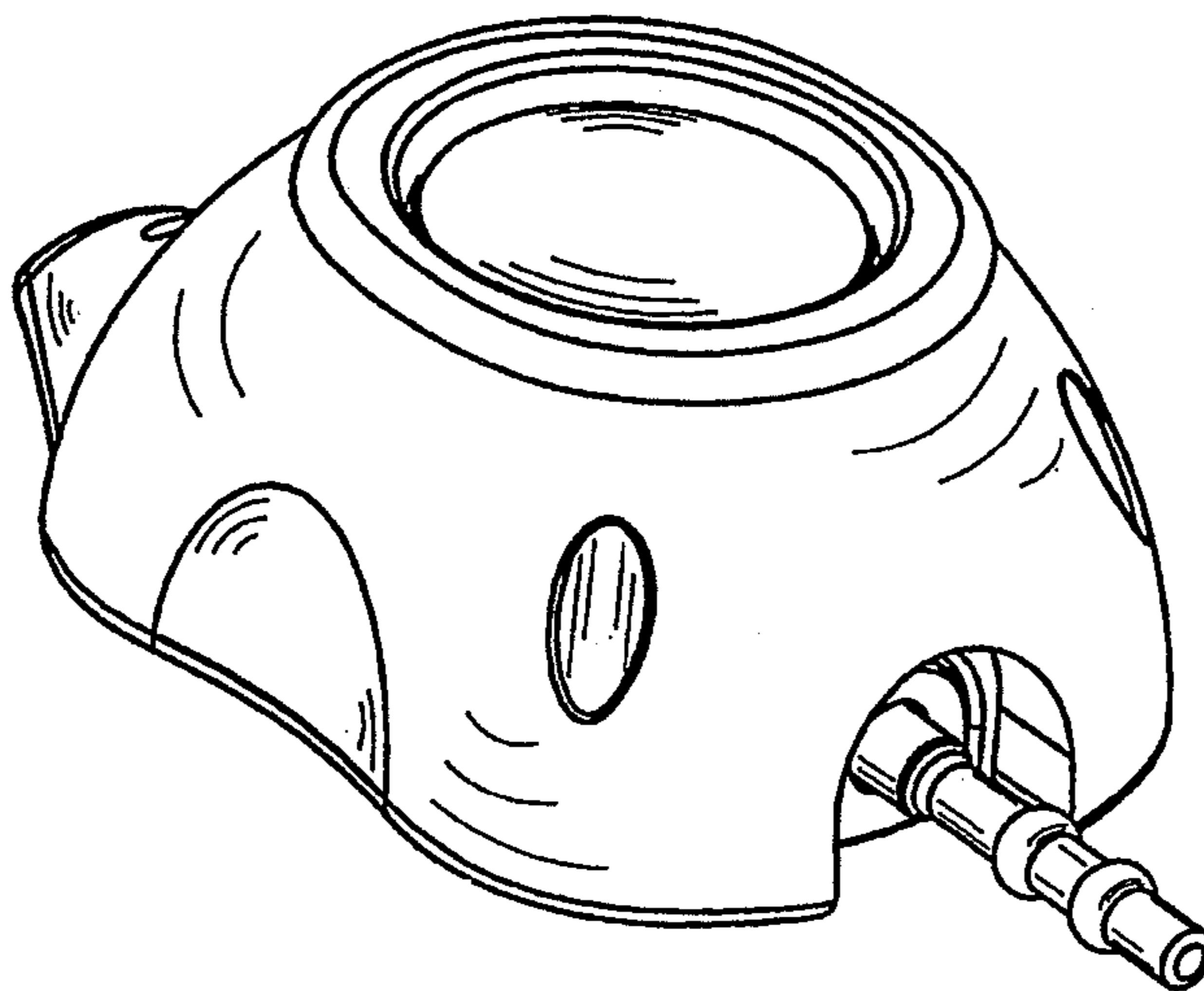
FIG. 3 is a top view of the venous access port assembly shown

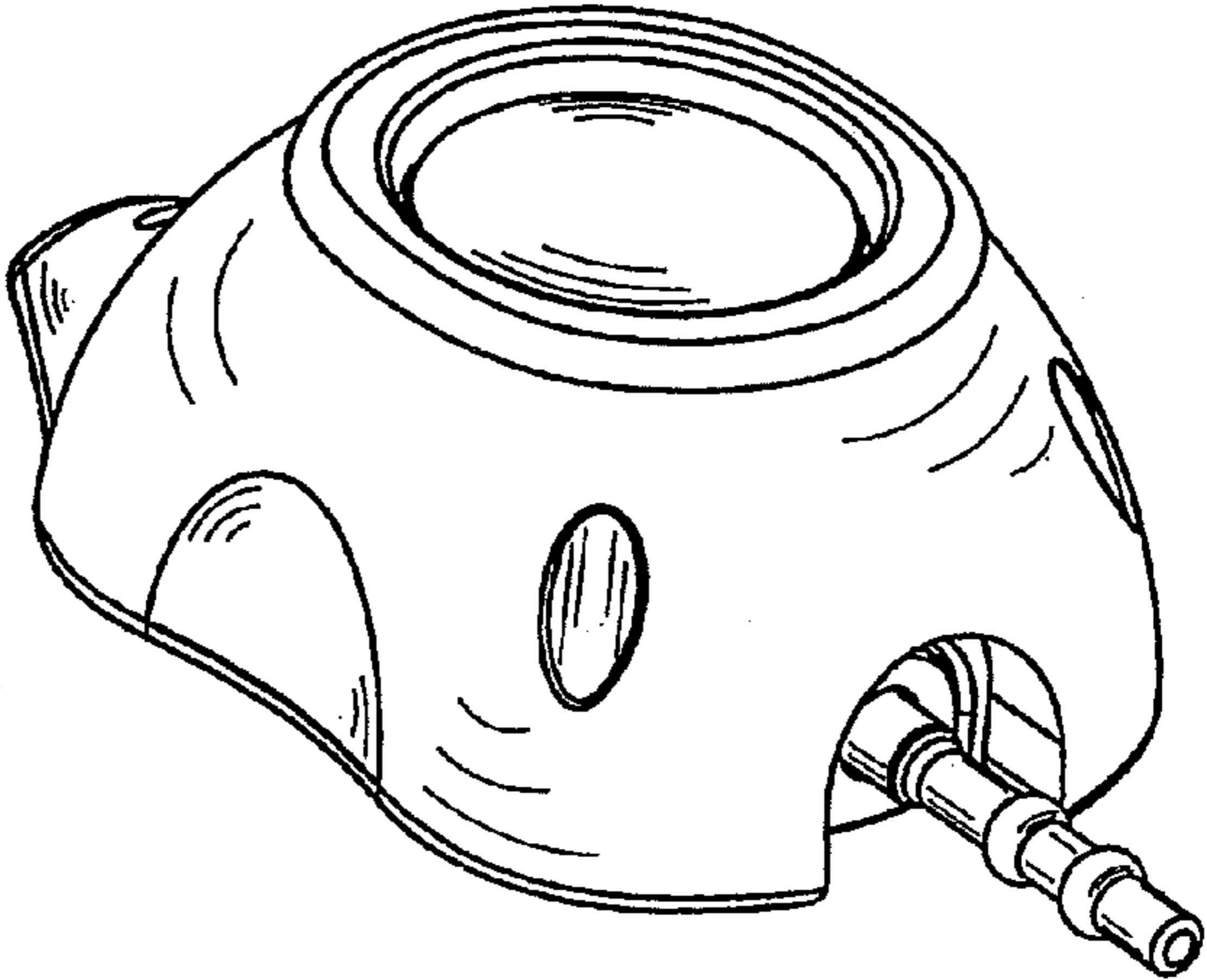

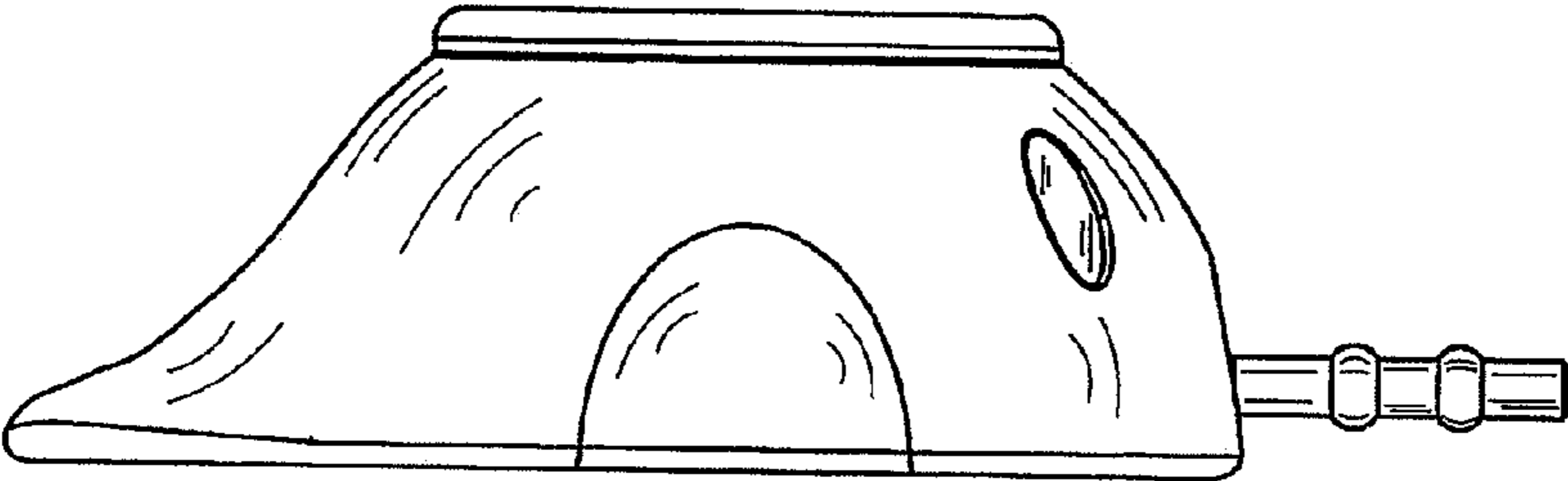

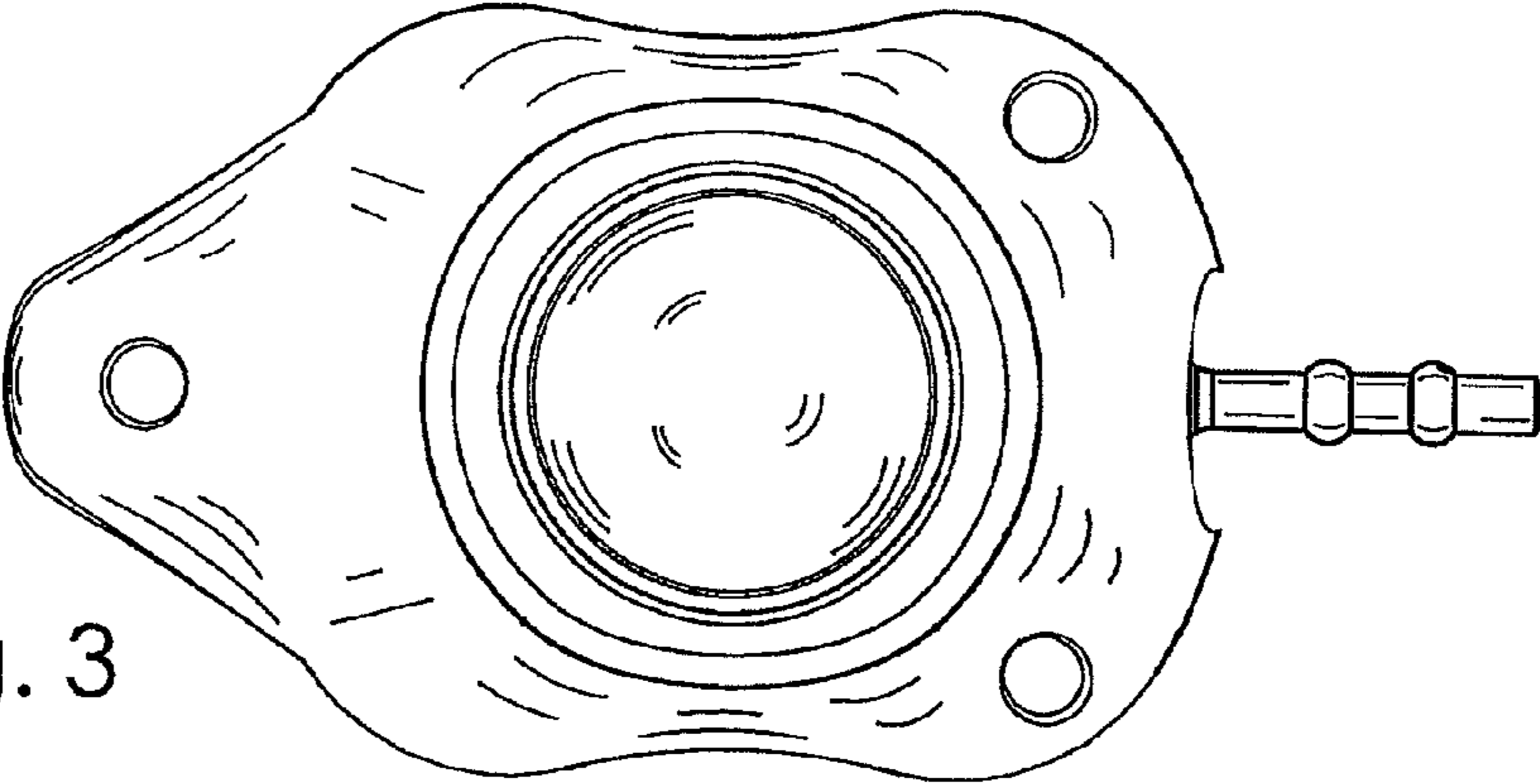

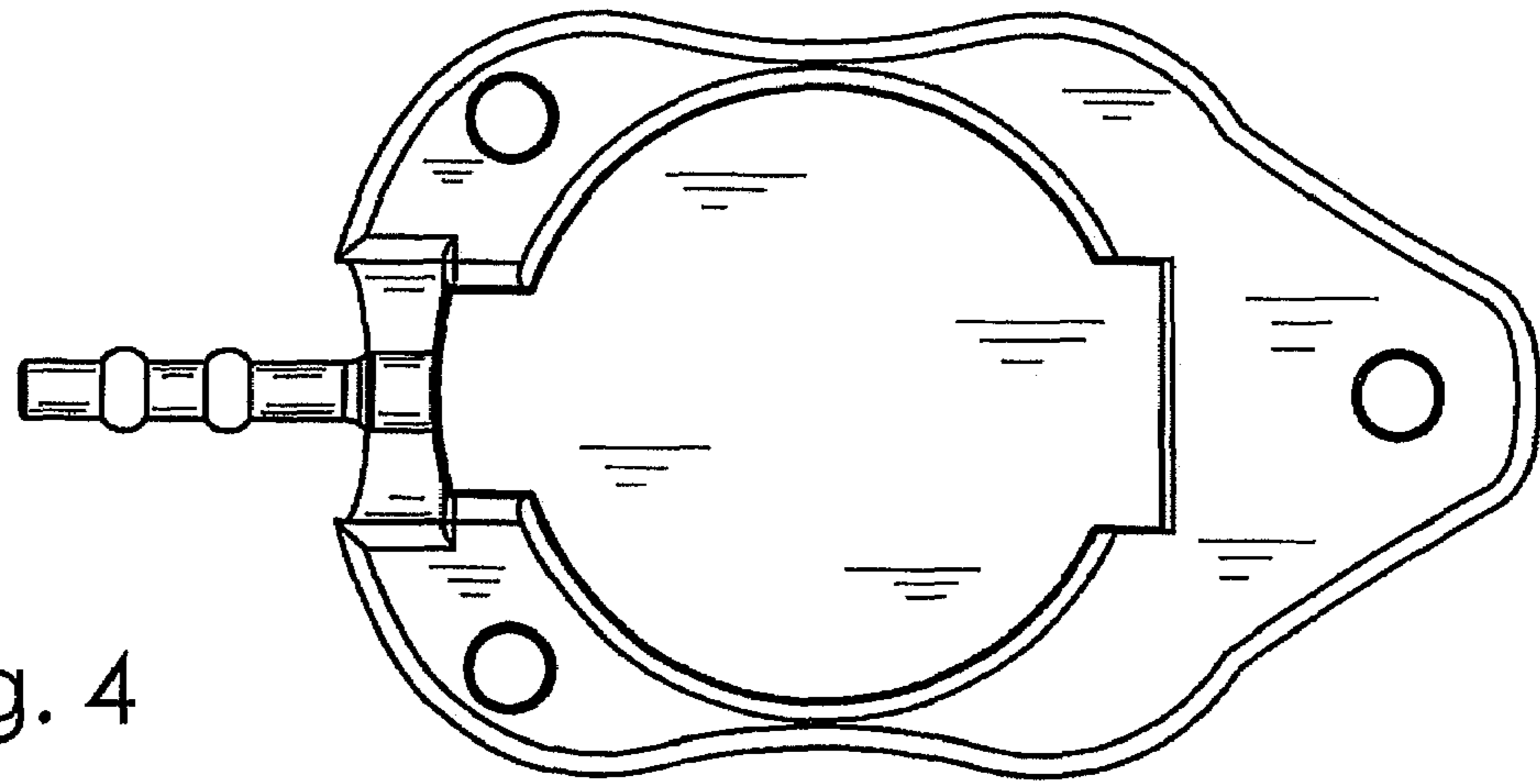

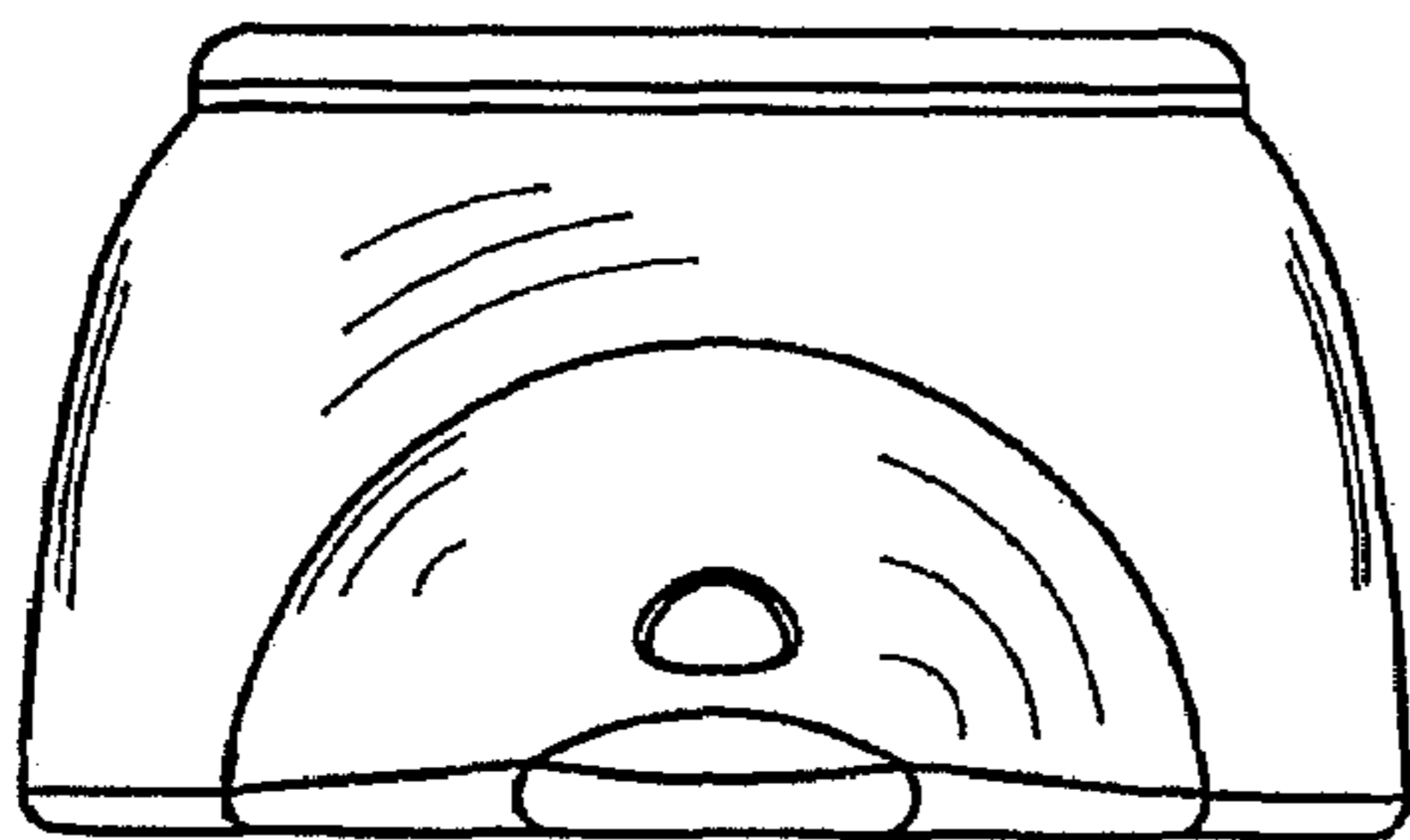
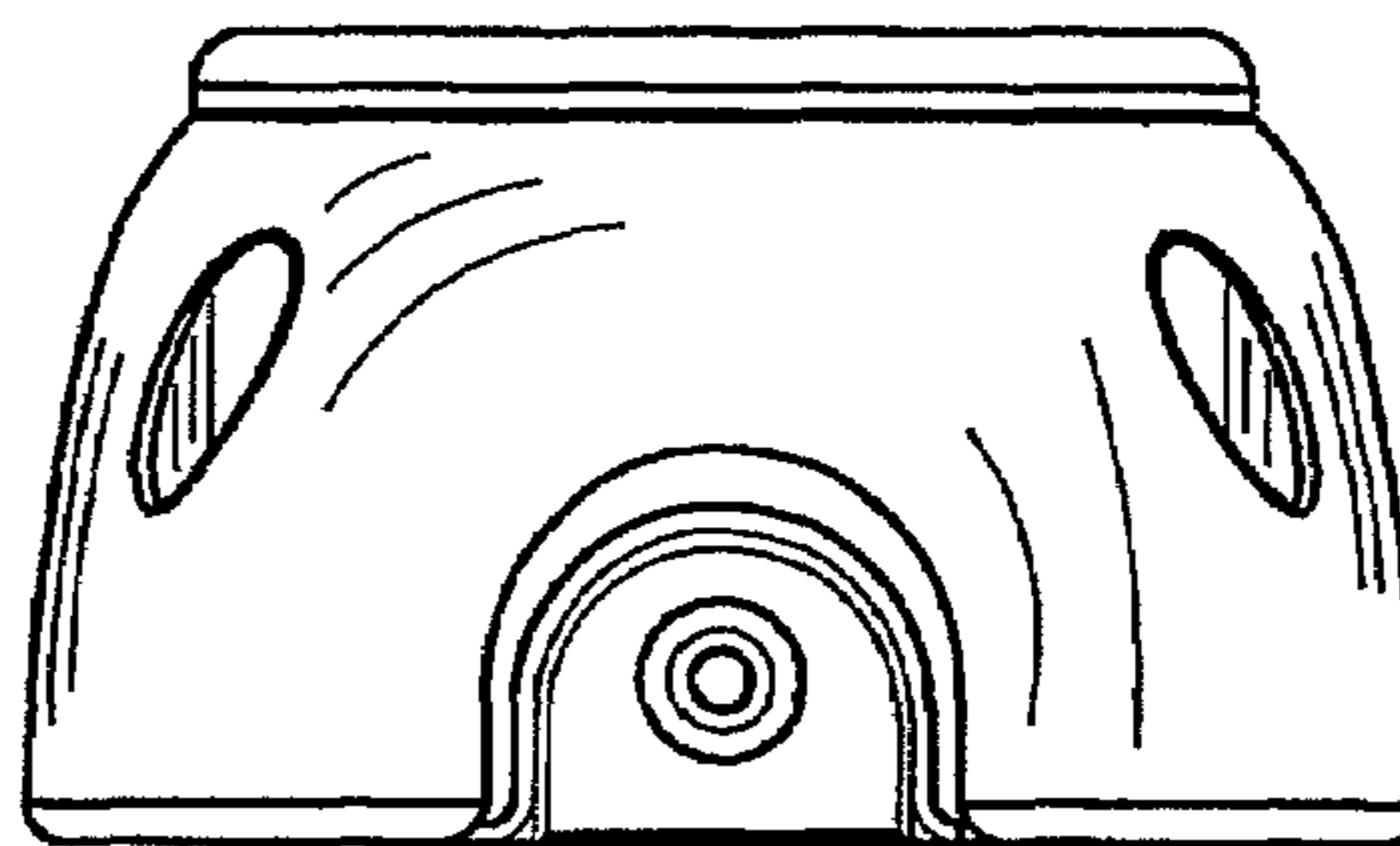
