(57) **CLAIM**

The ornamental design for massage couch, as shown and described.

**DESCRIPTION**

FIG. 1 is the top, front and side perspective view of a massage couch showing my new design;

FIG. 2 is a side elevational view thereof, the appearance of the side opposite that shown in FIG. 2 being the mirror image thereof;

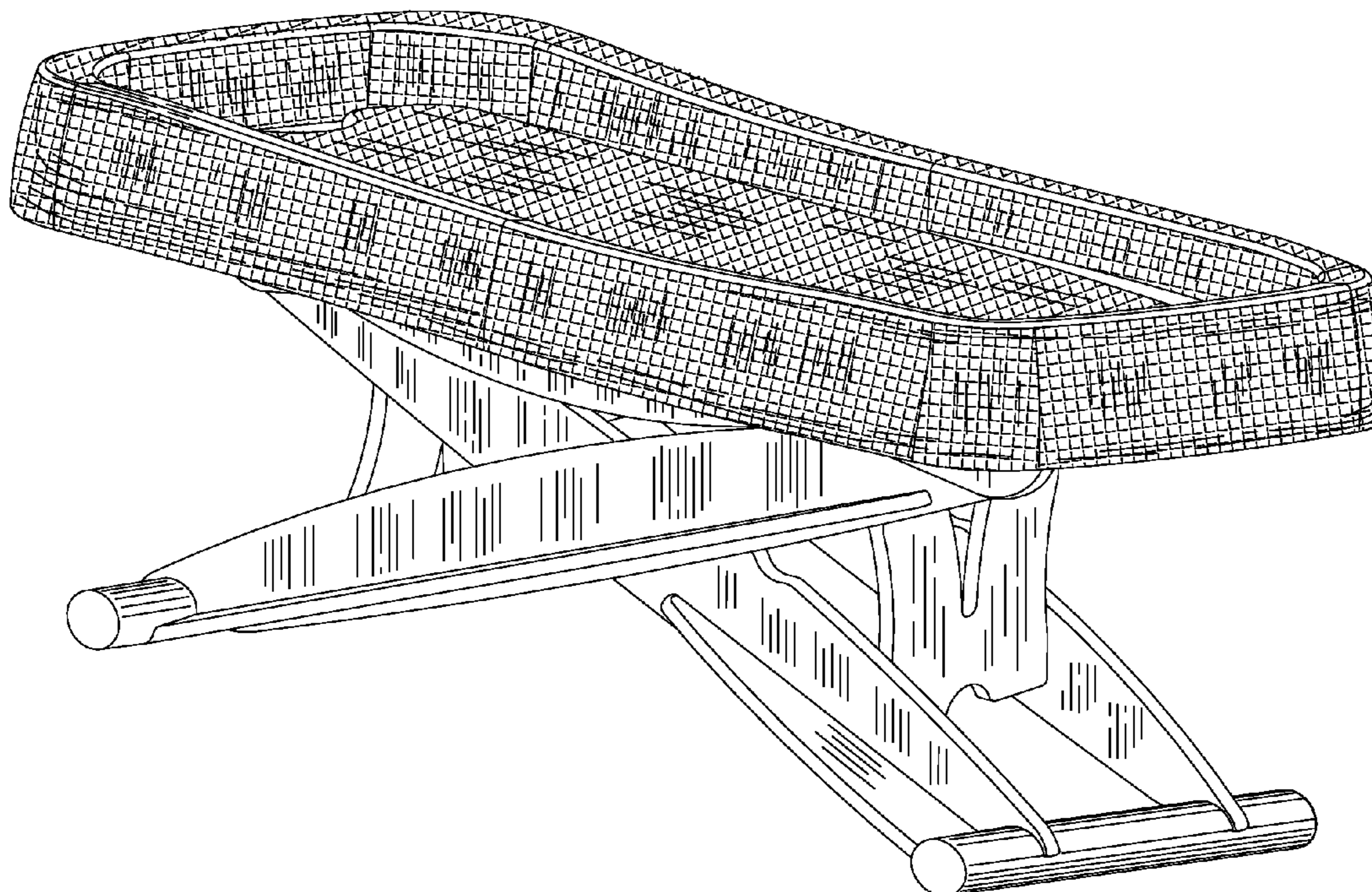
FIG. 3 is an end elevational view from the right of FIG. 2;

FIG. 4 is an end elevational view from the left of FIG. 4; and,

FIG. 5 is a top plan view thereof.

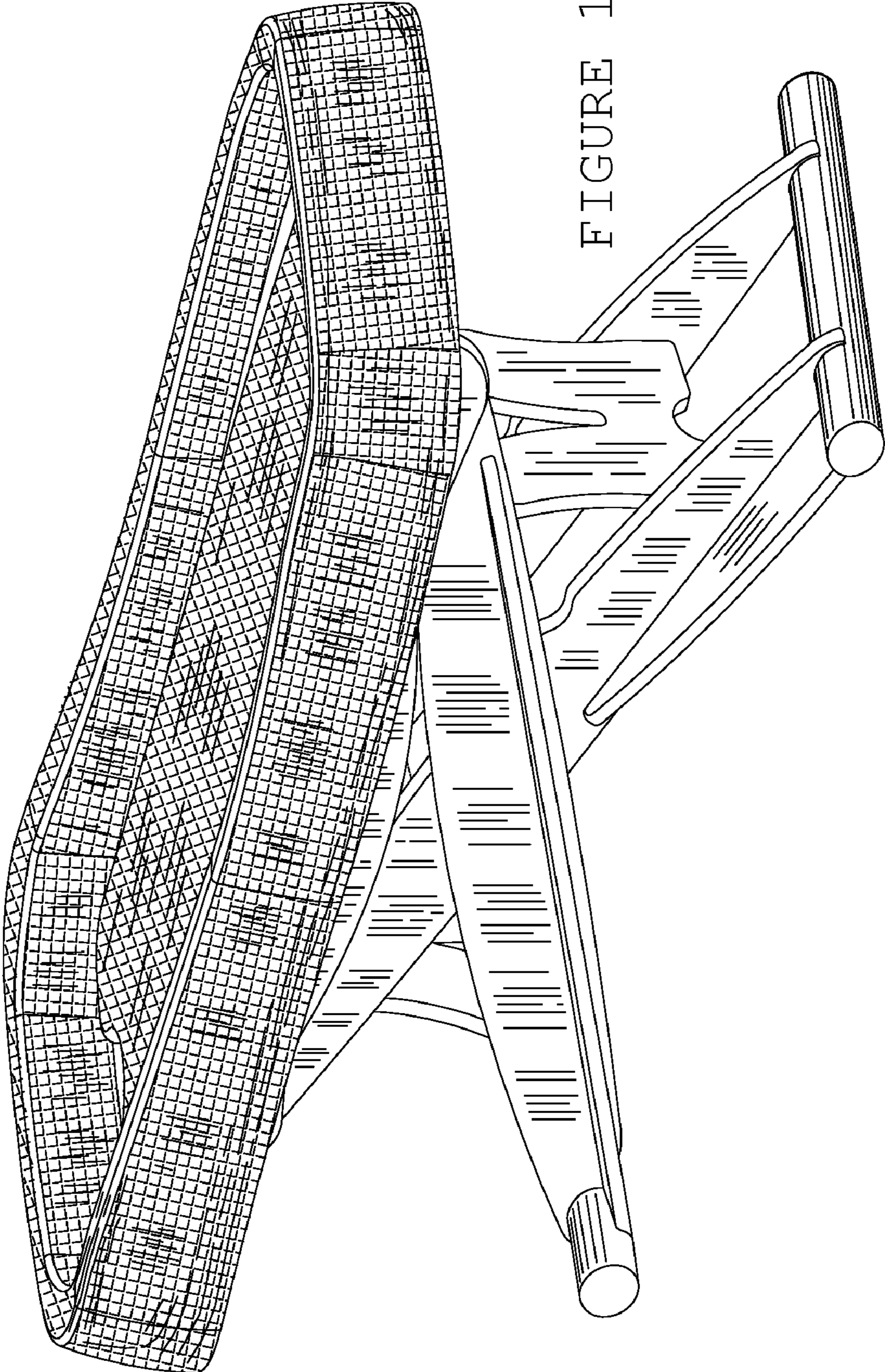

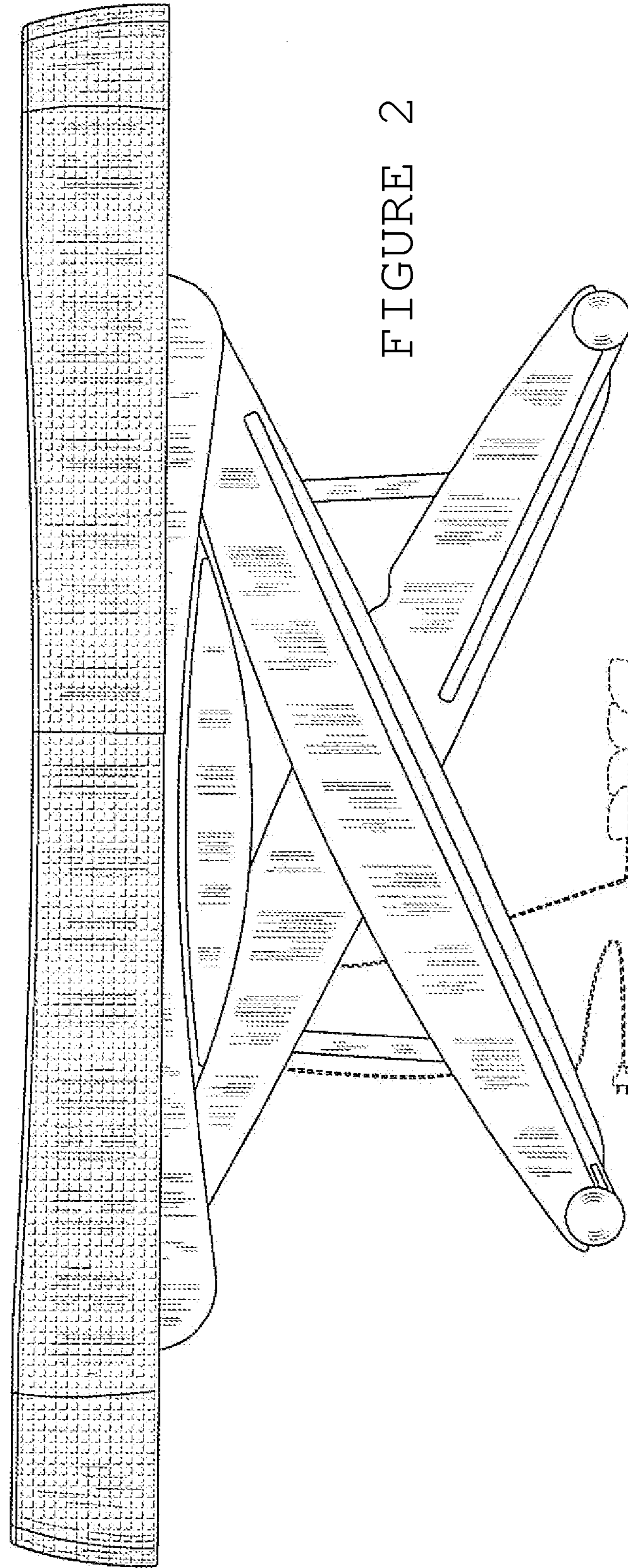

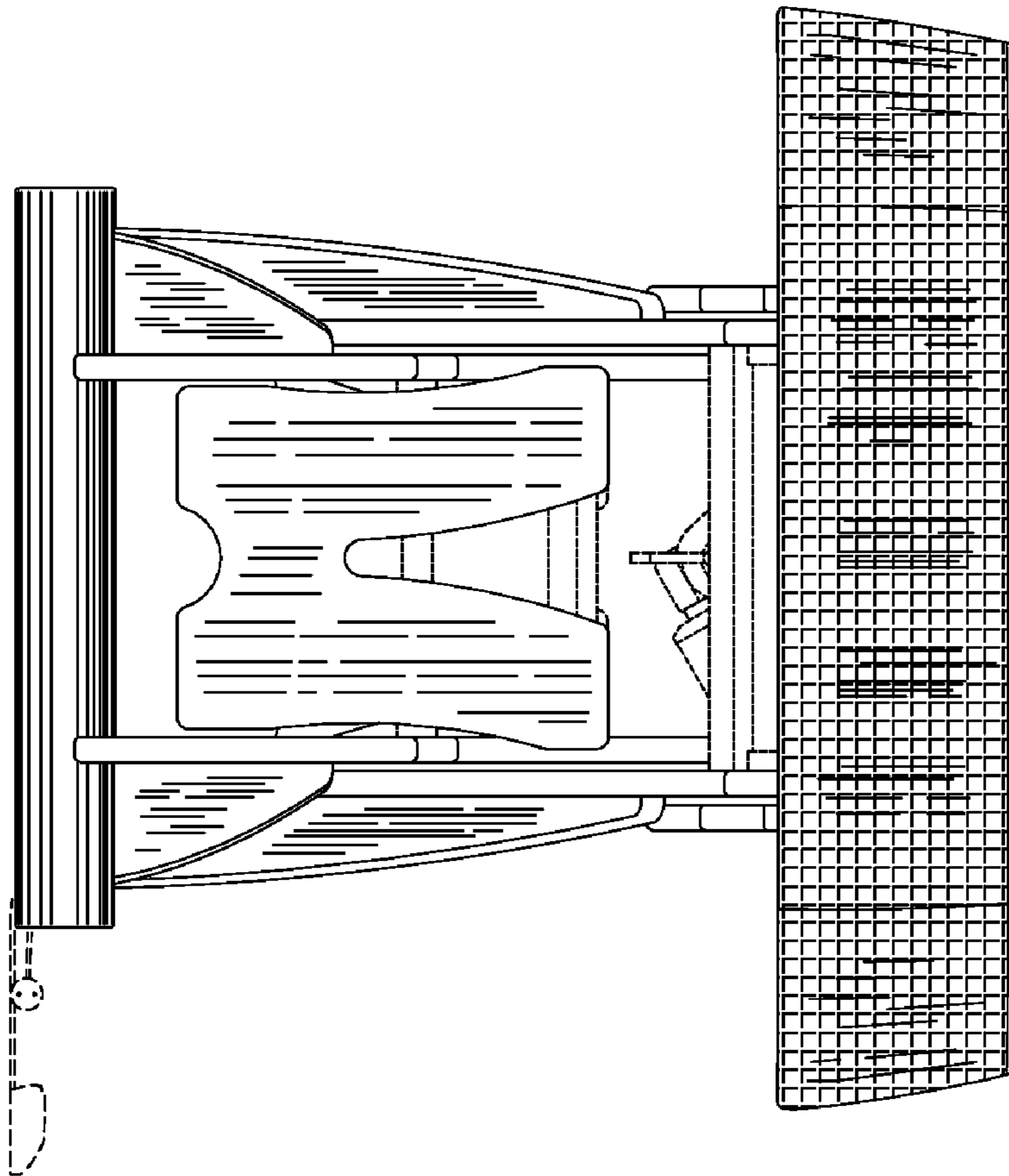
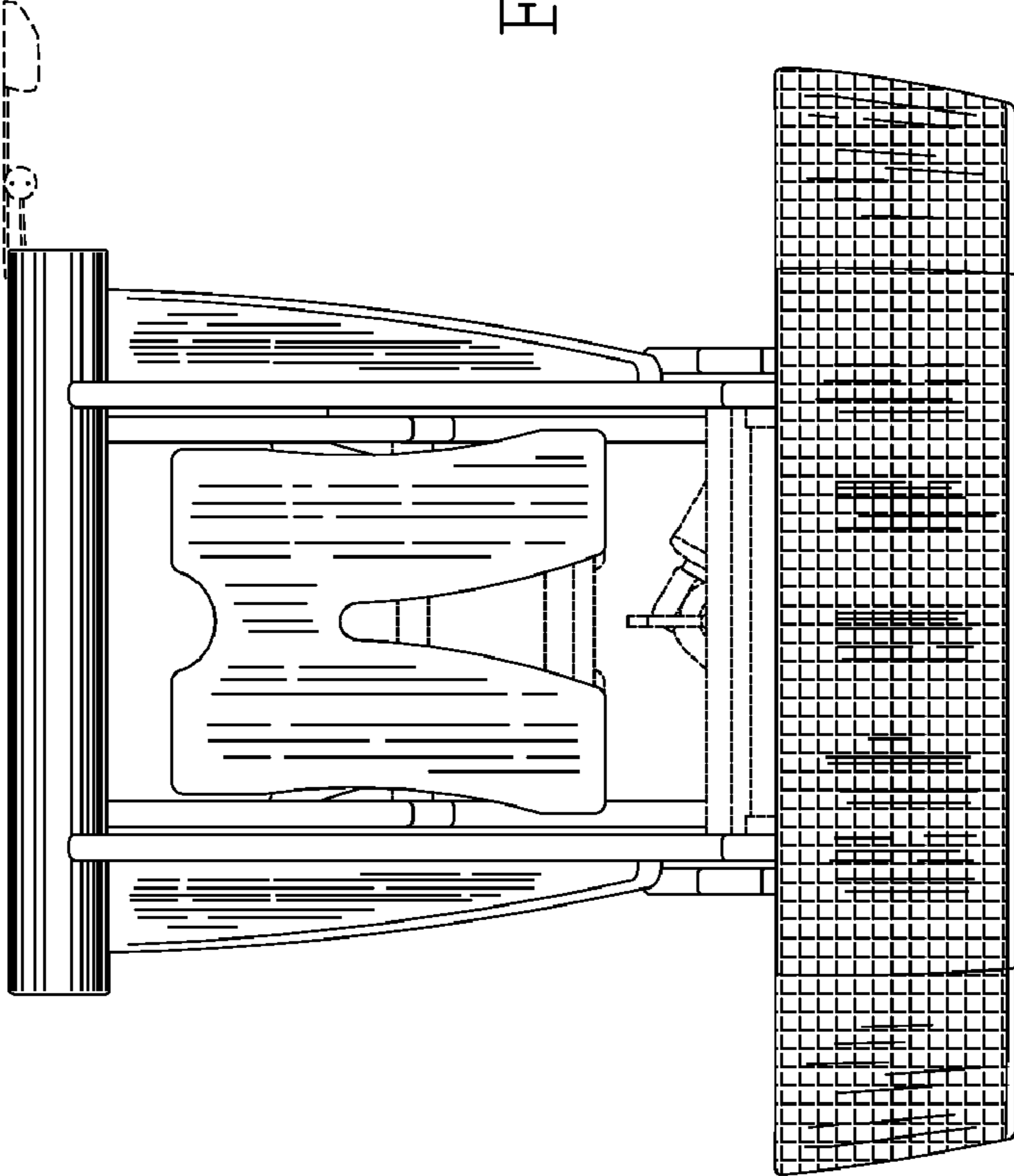

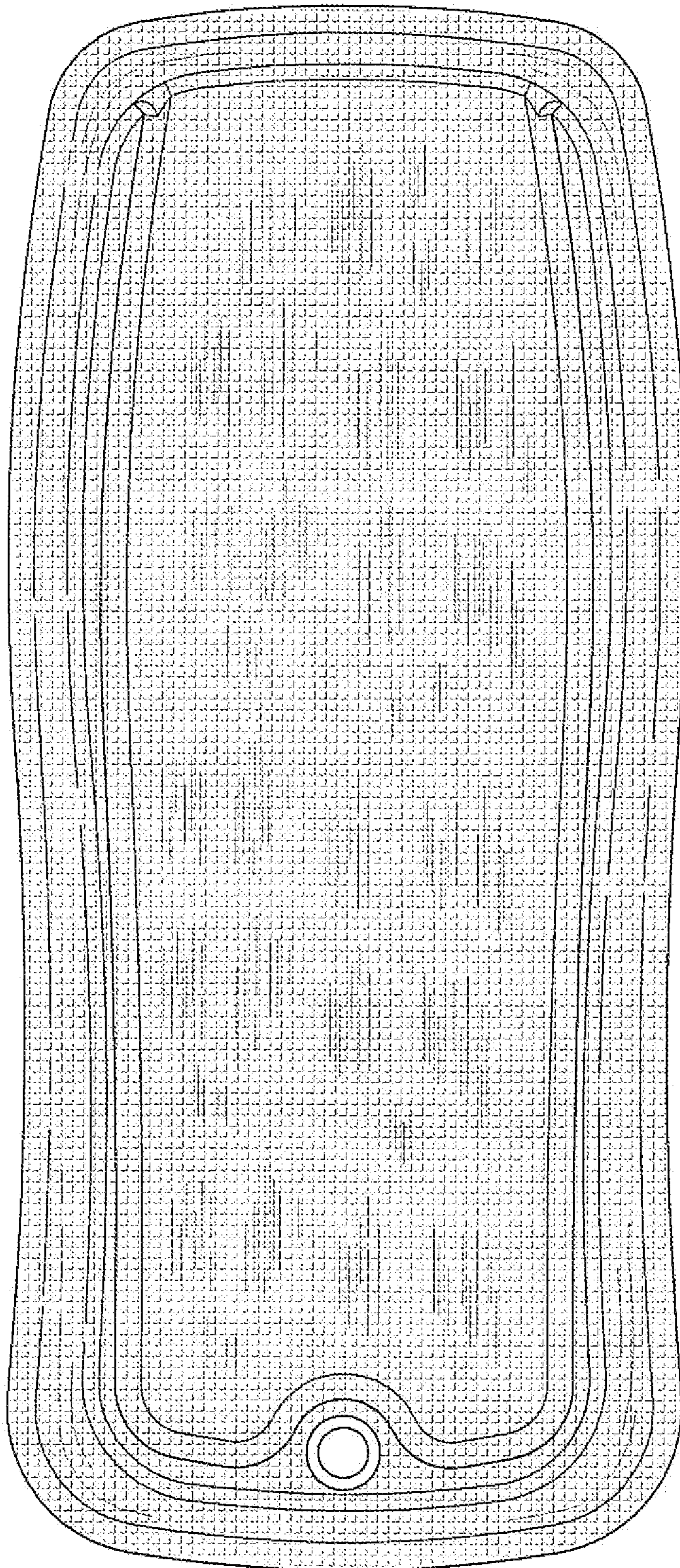
