FIG. 6 is a perspective view of a second embodiment of the gate panel frame;

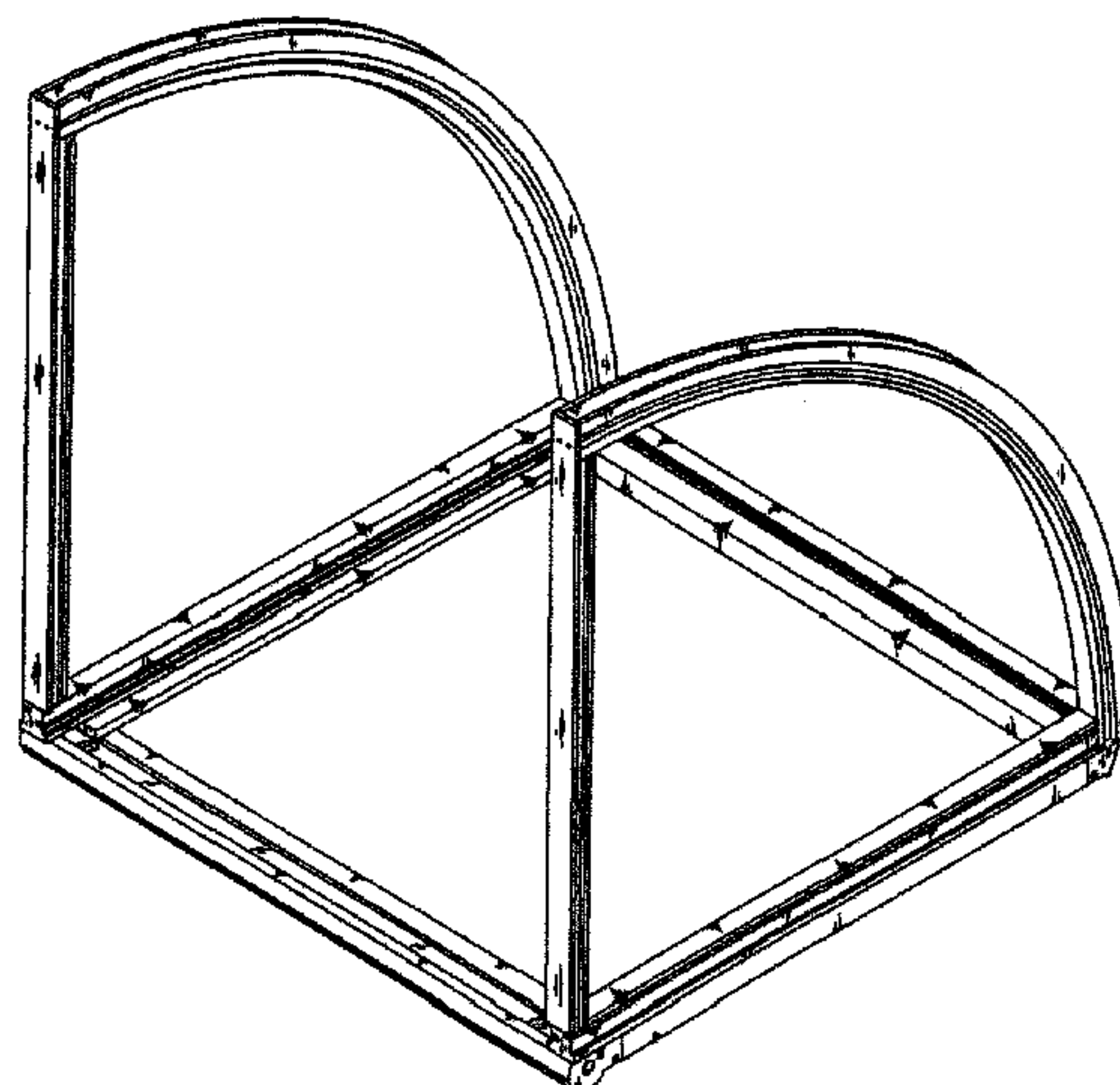
FIG. 7 is a rear left perspective view;

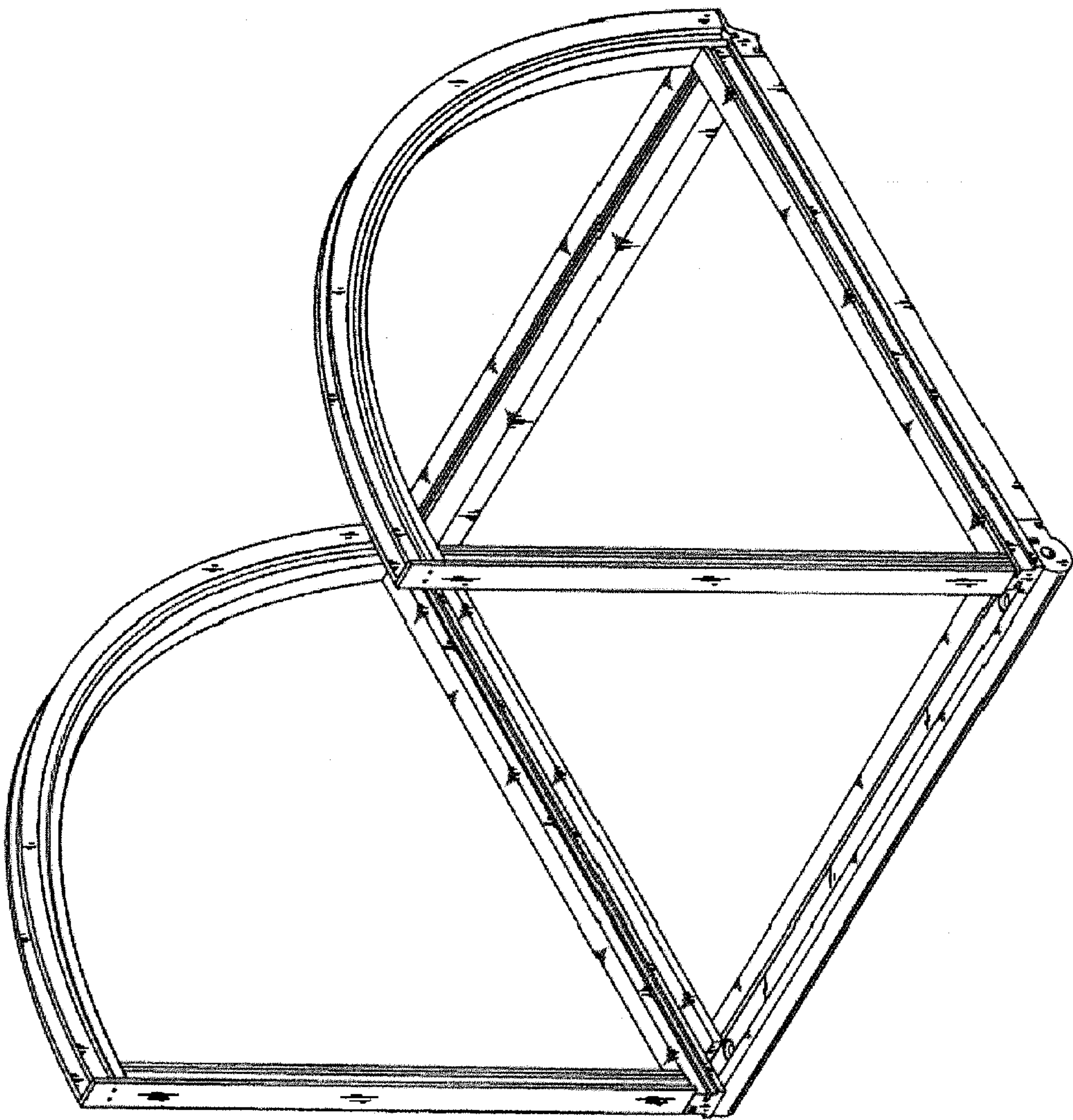

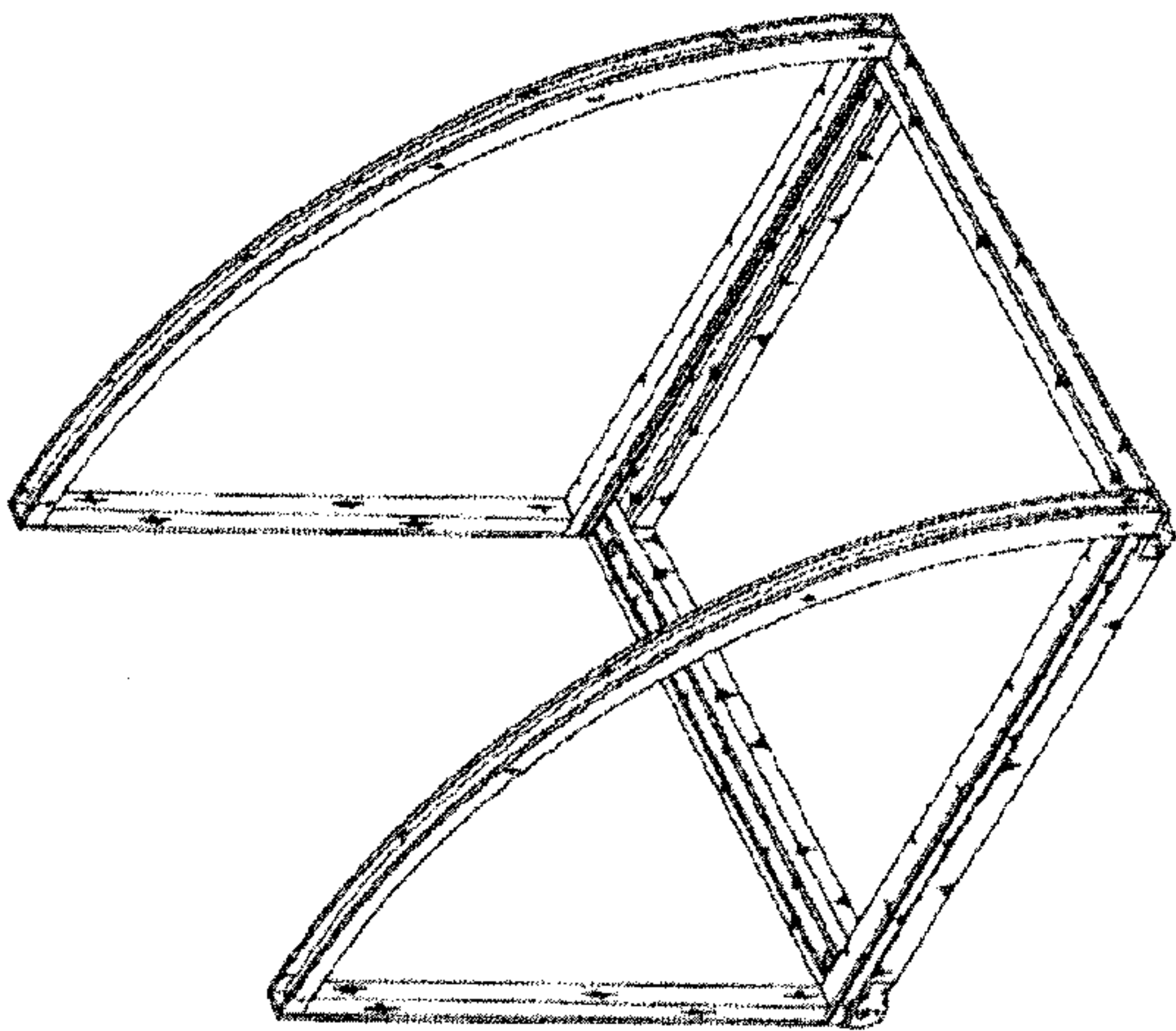

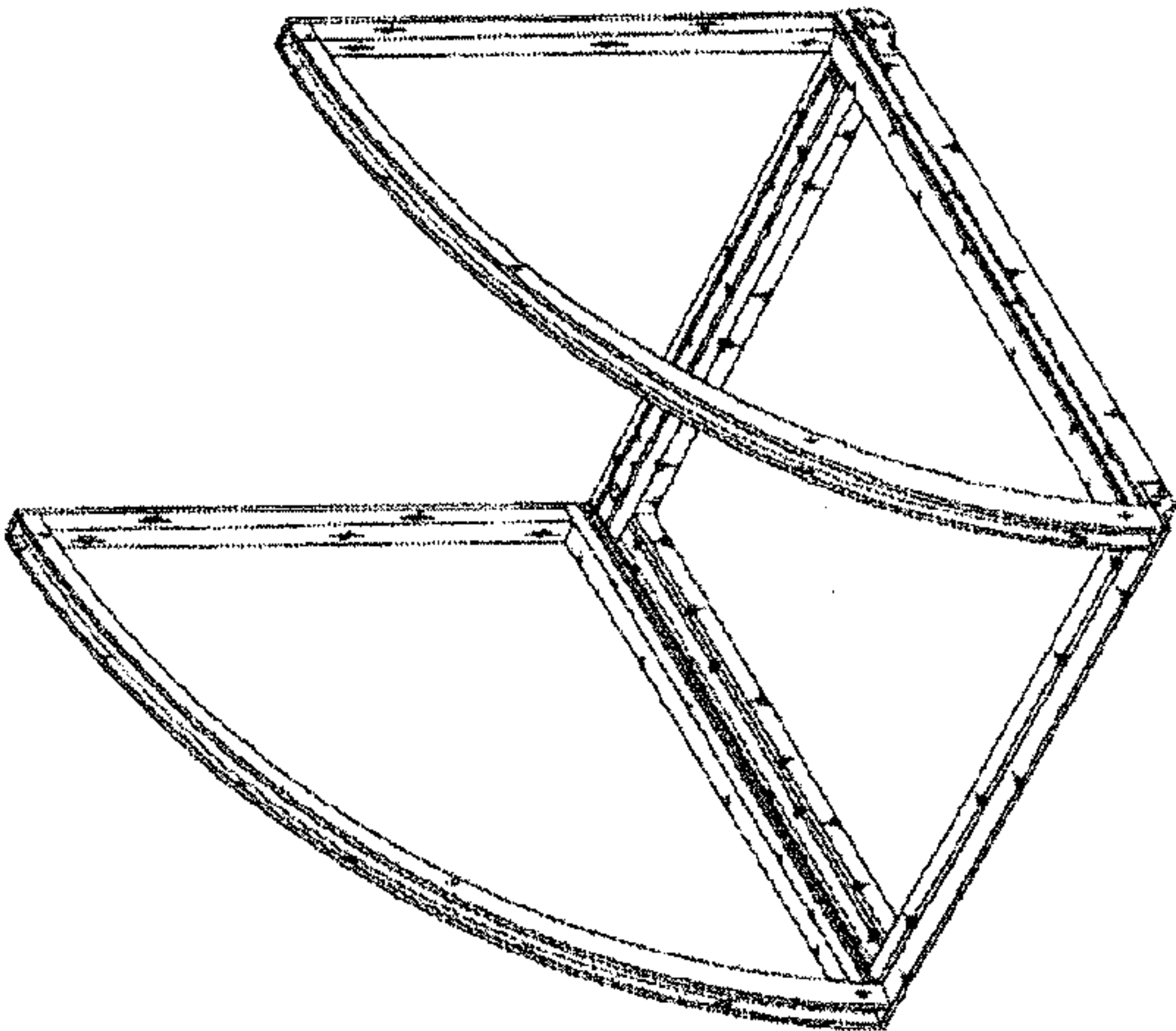

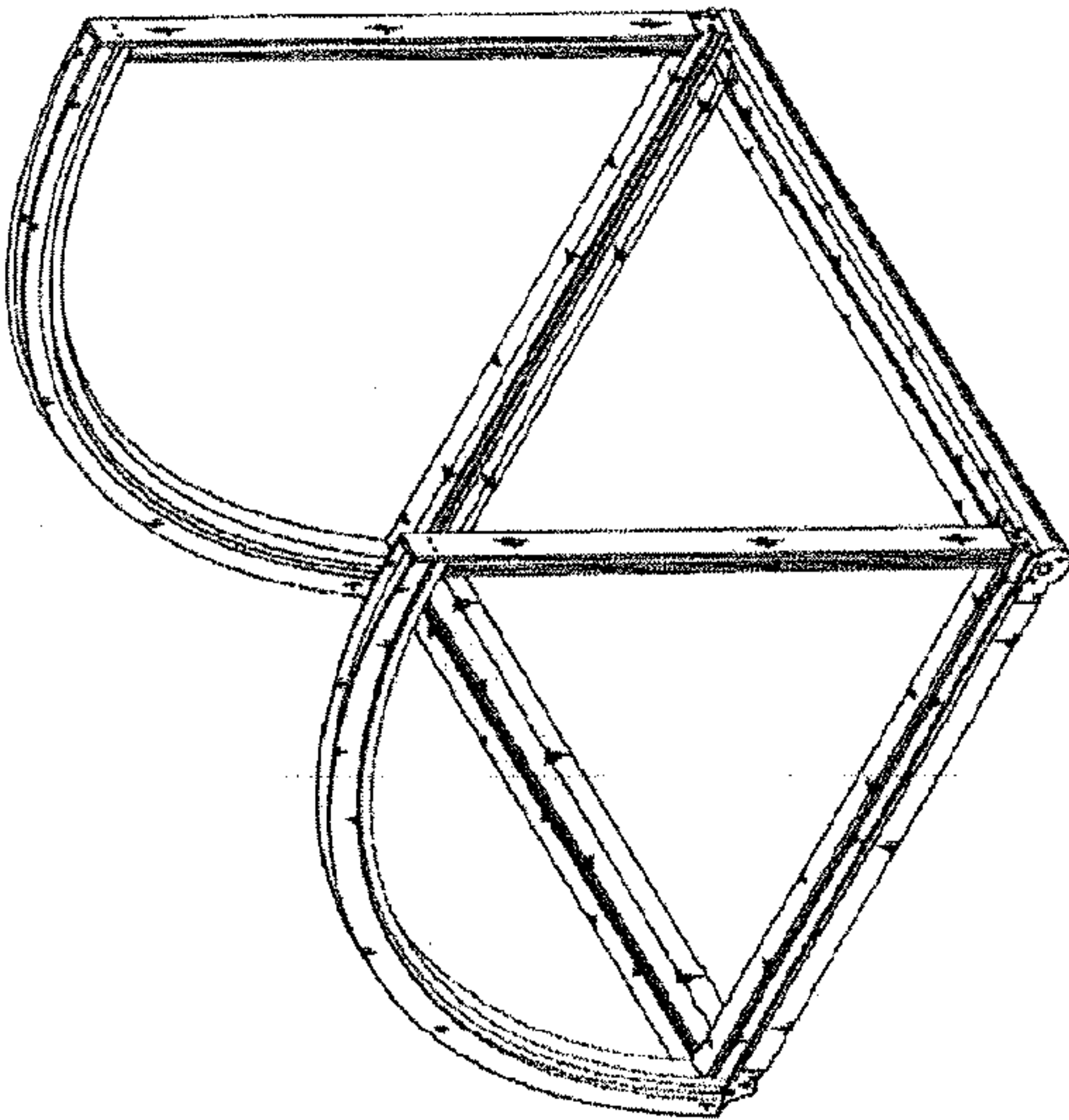

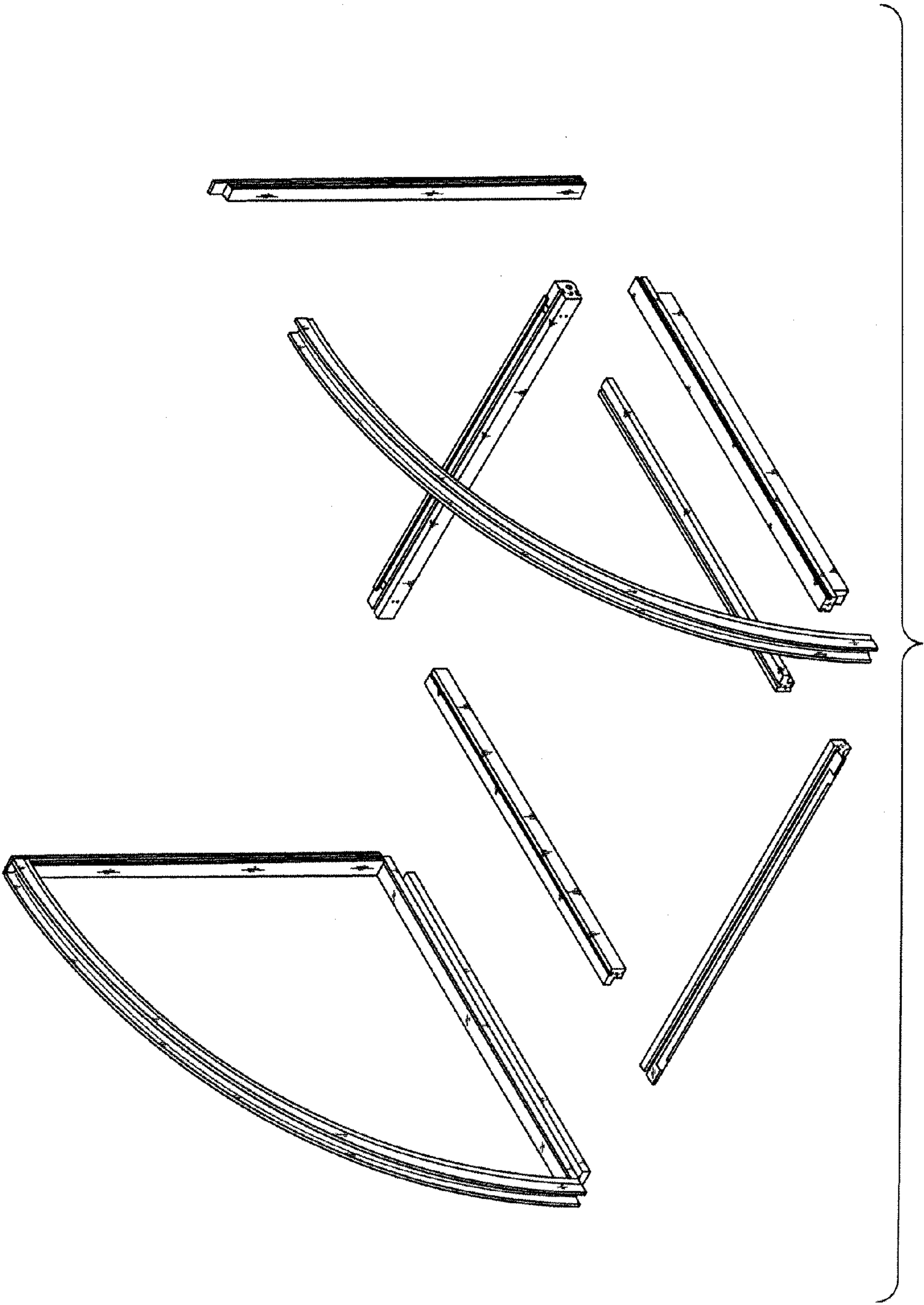

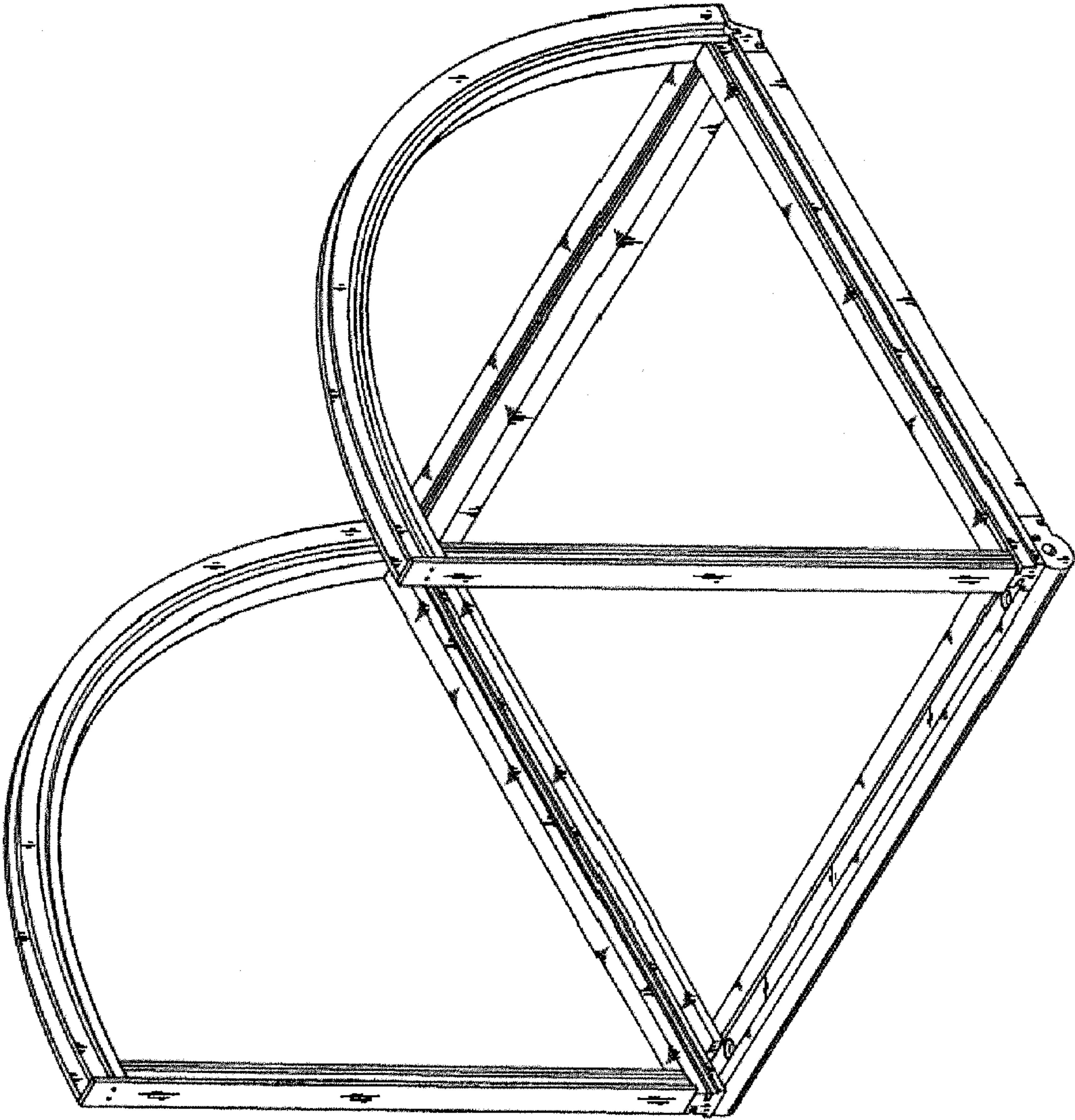

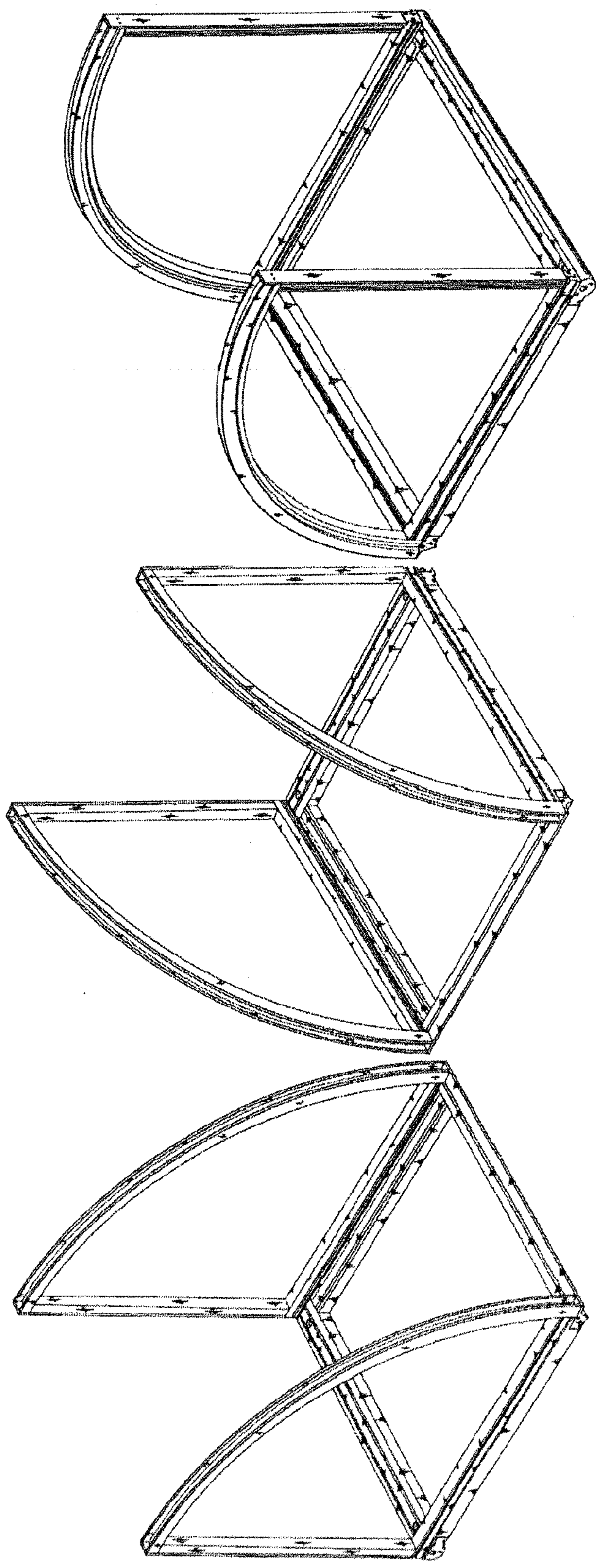

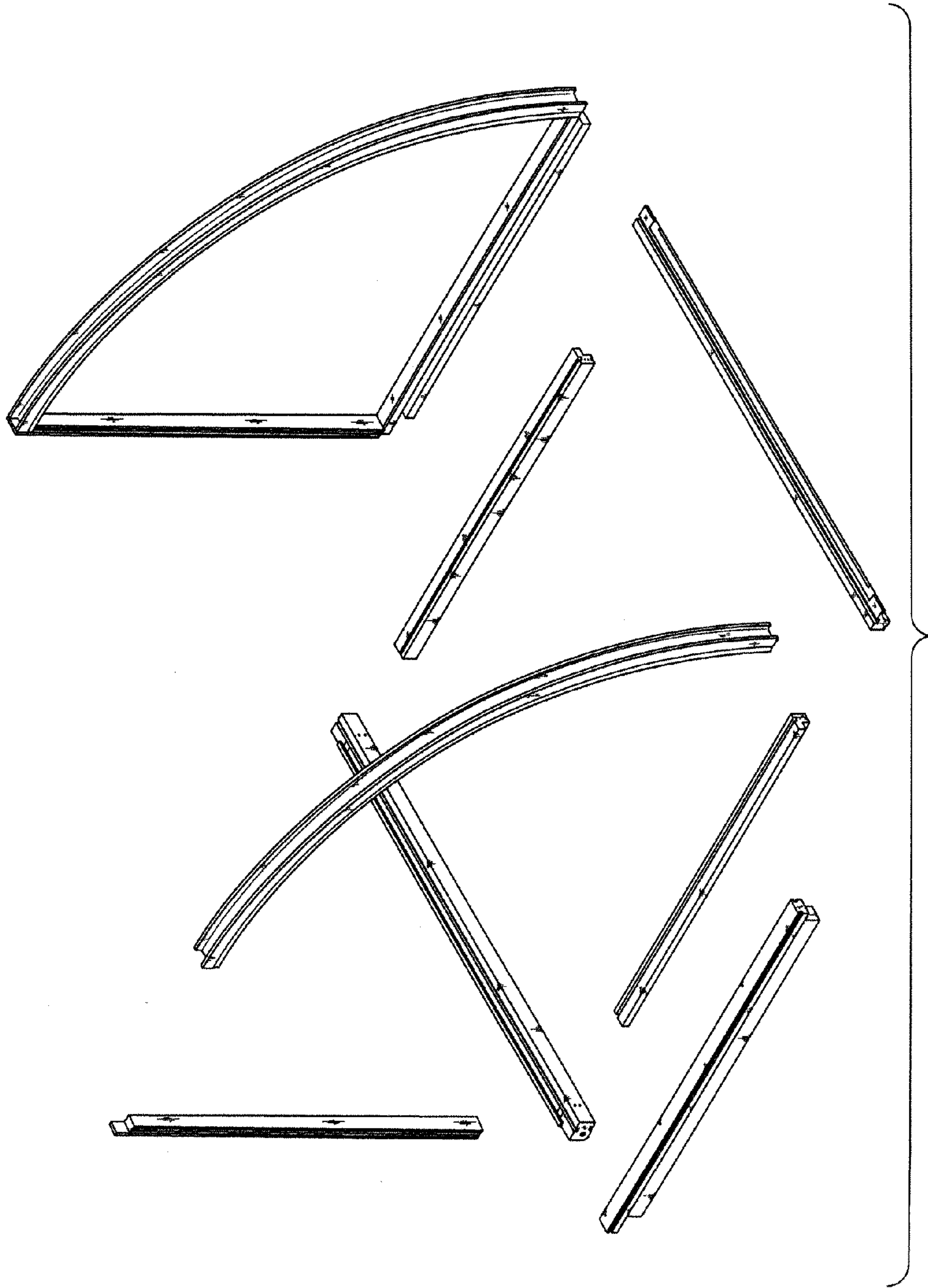
