FIG. 13 is a perspective view showing the new design for the soap.

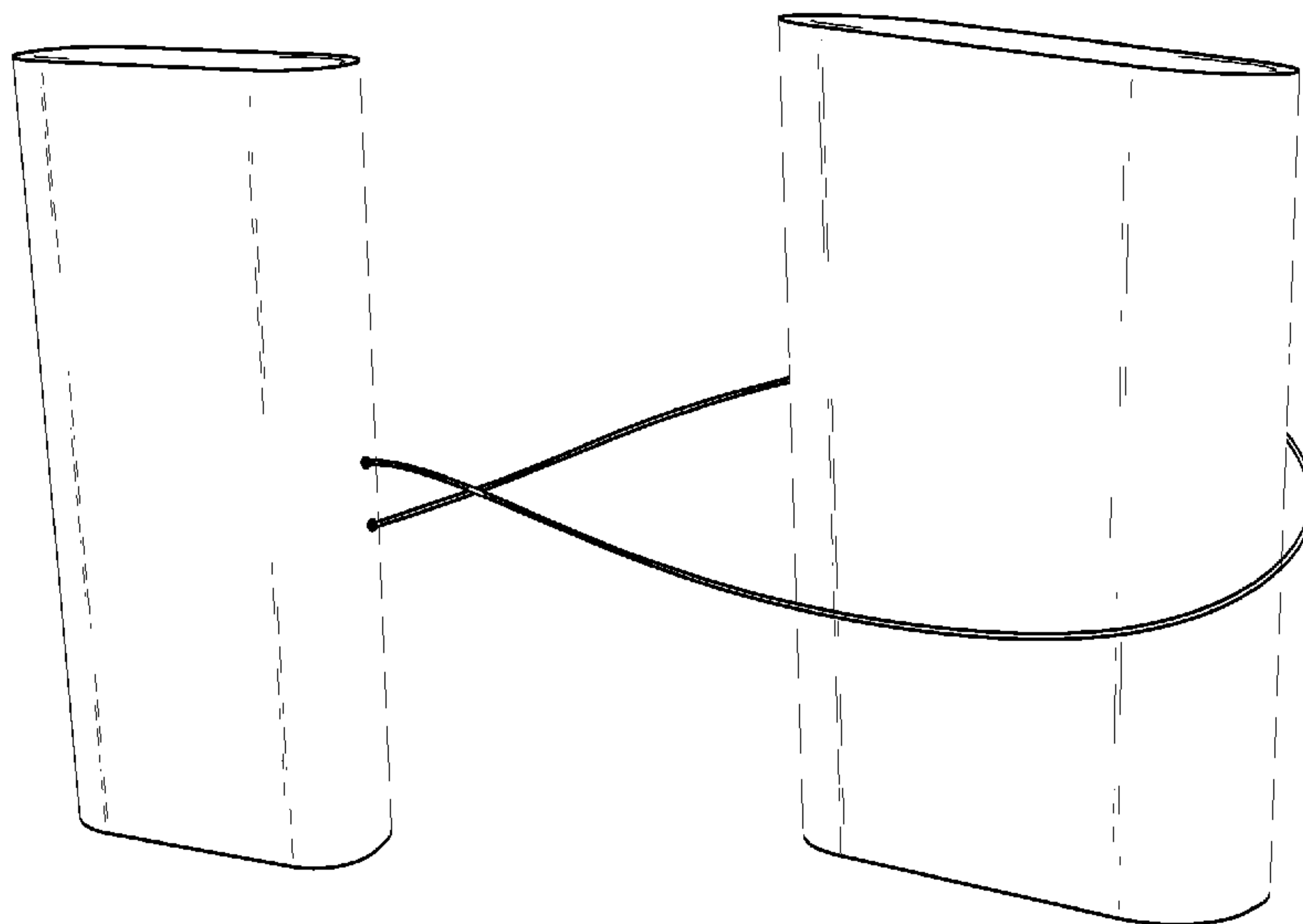
FIG. 14 is a top view thereof.

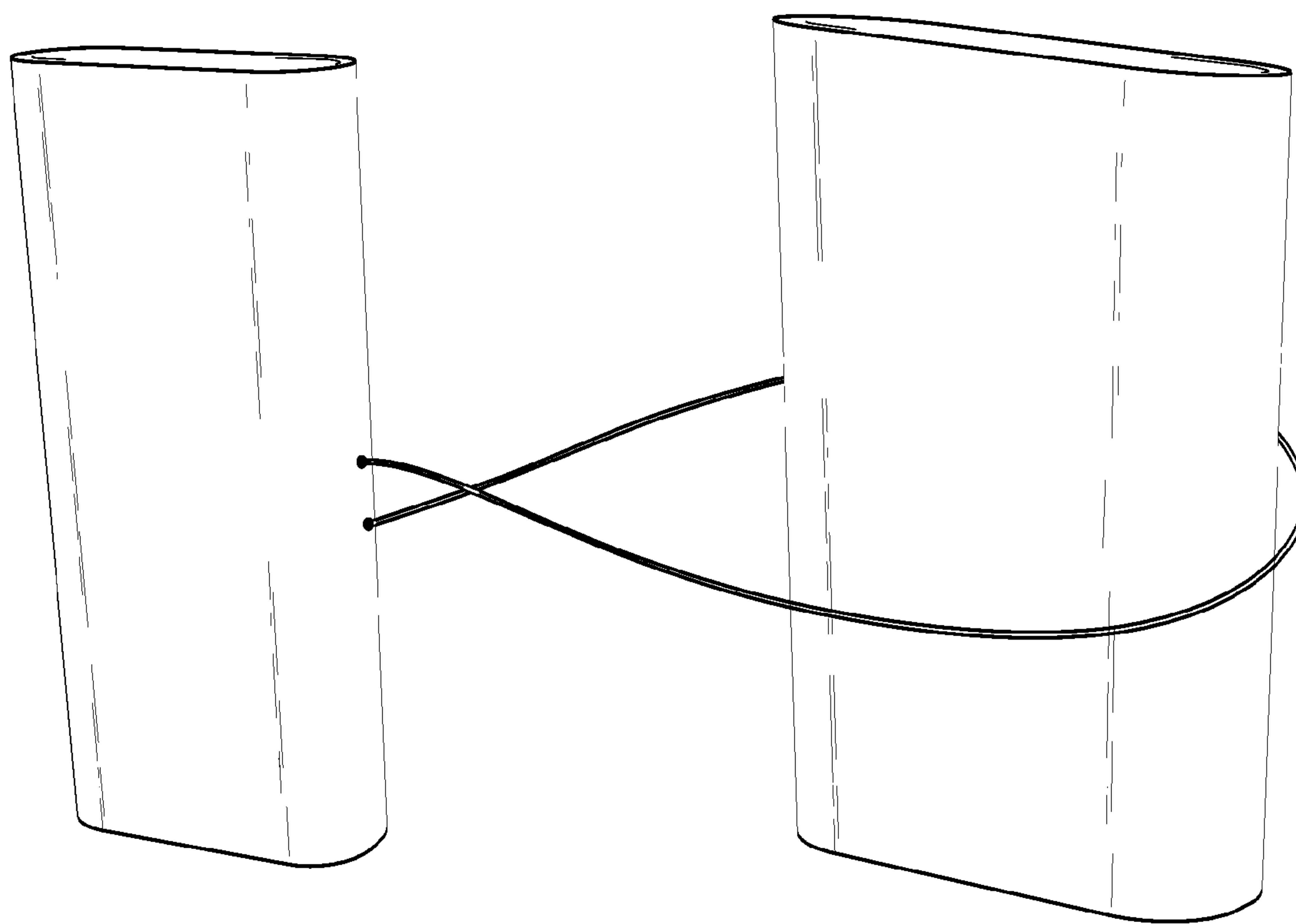

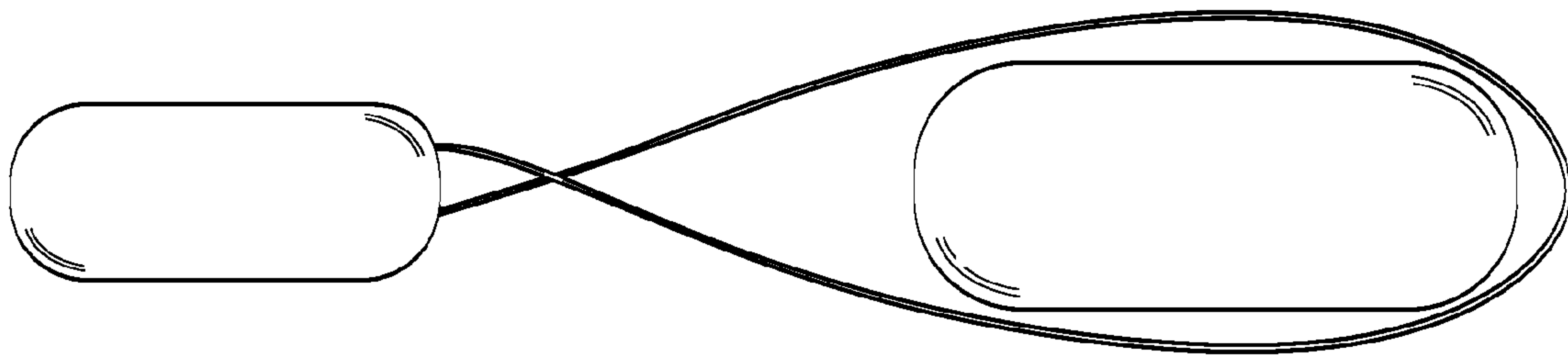

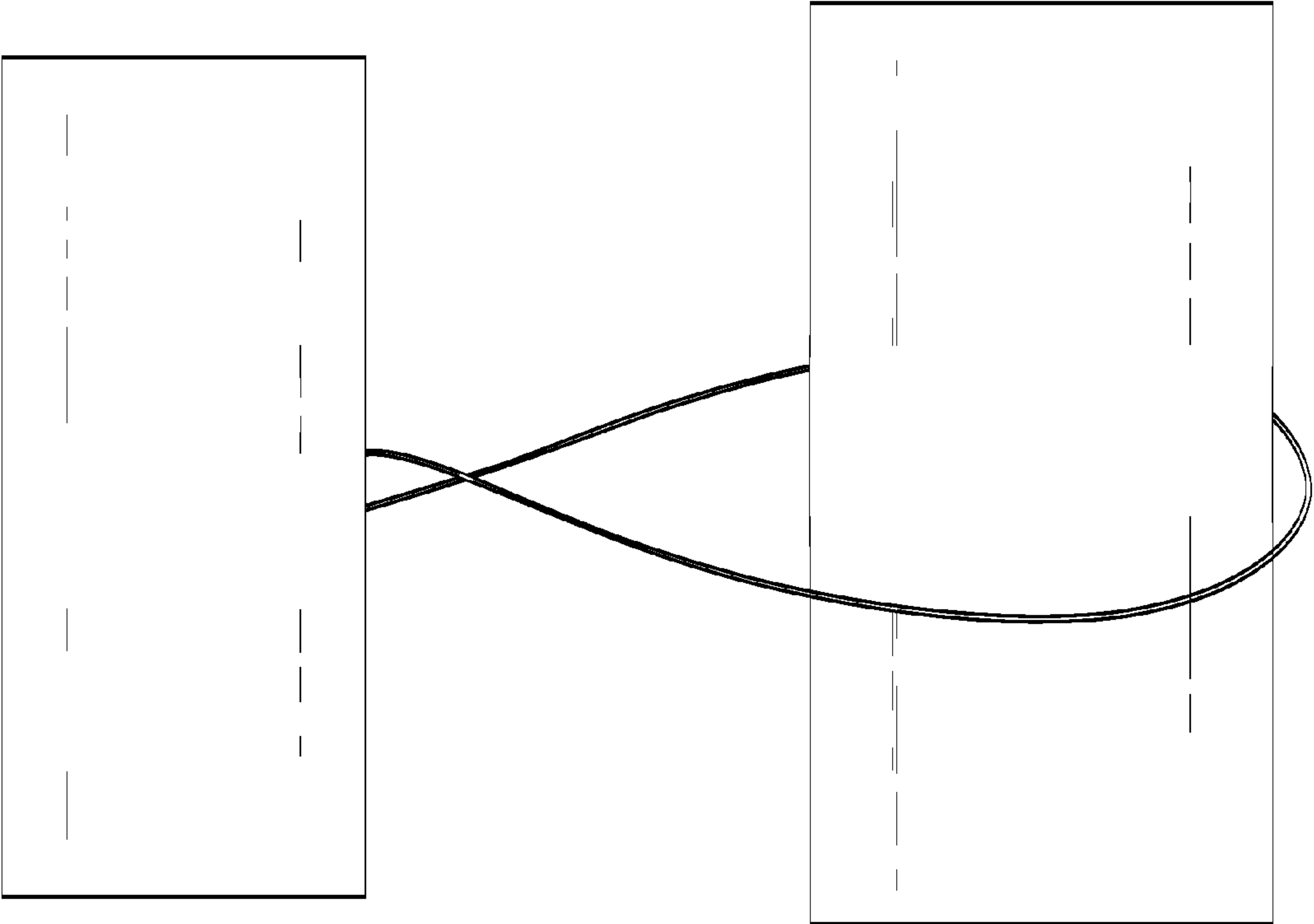

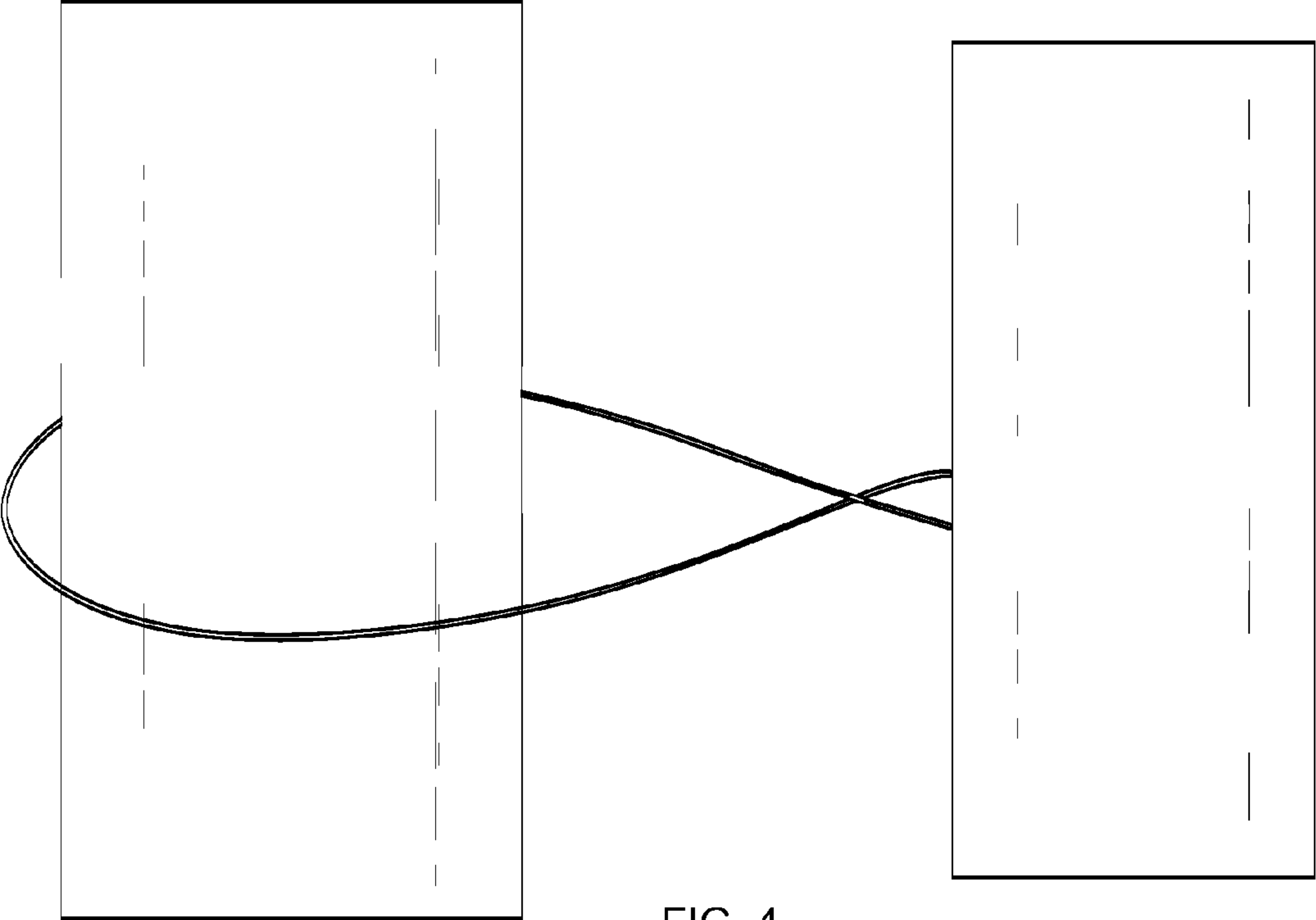

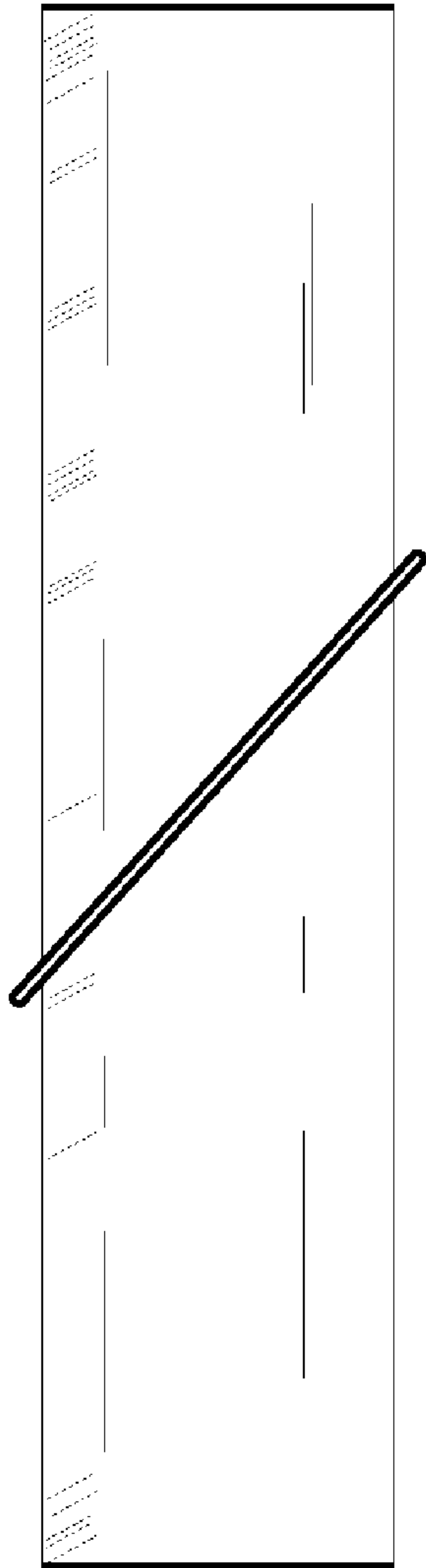

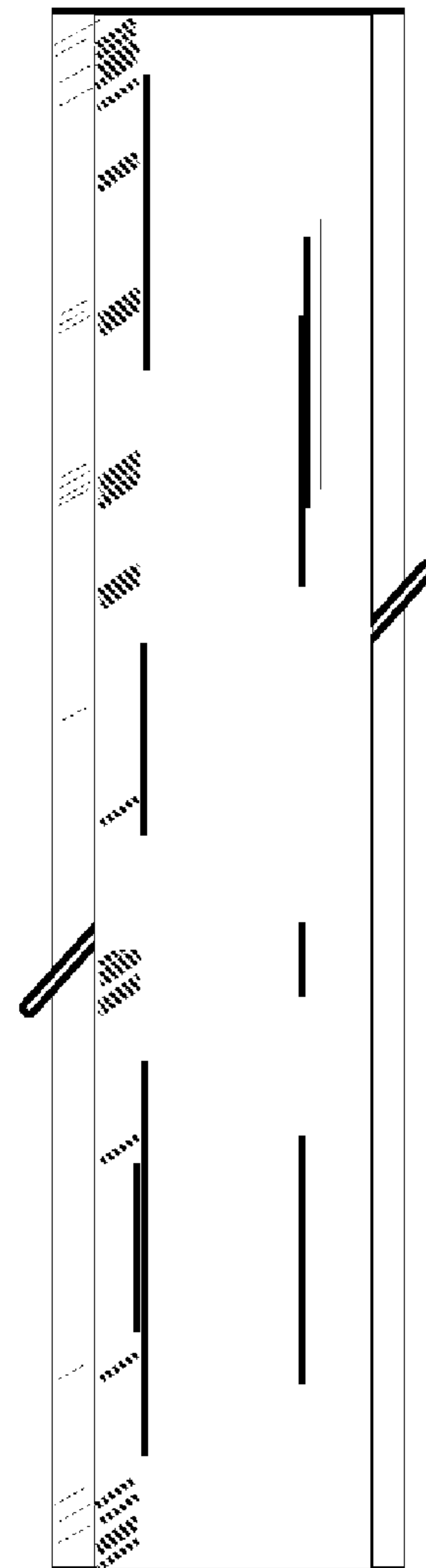

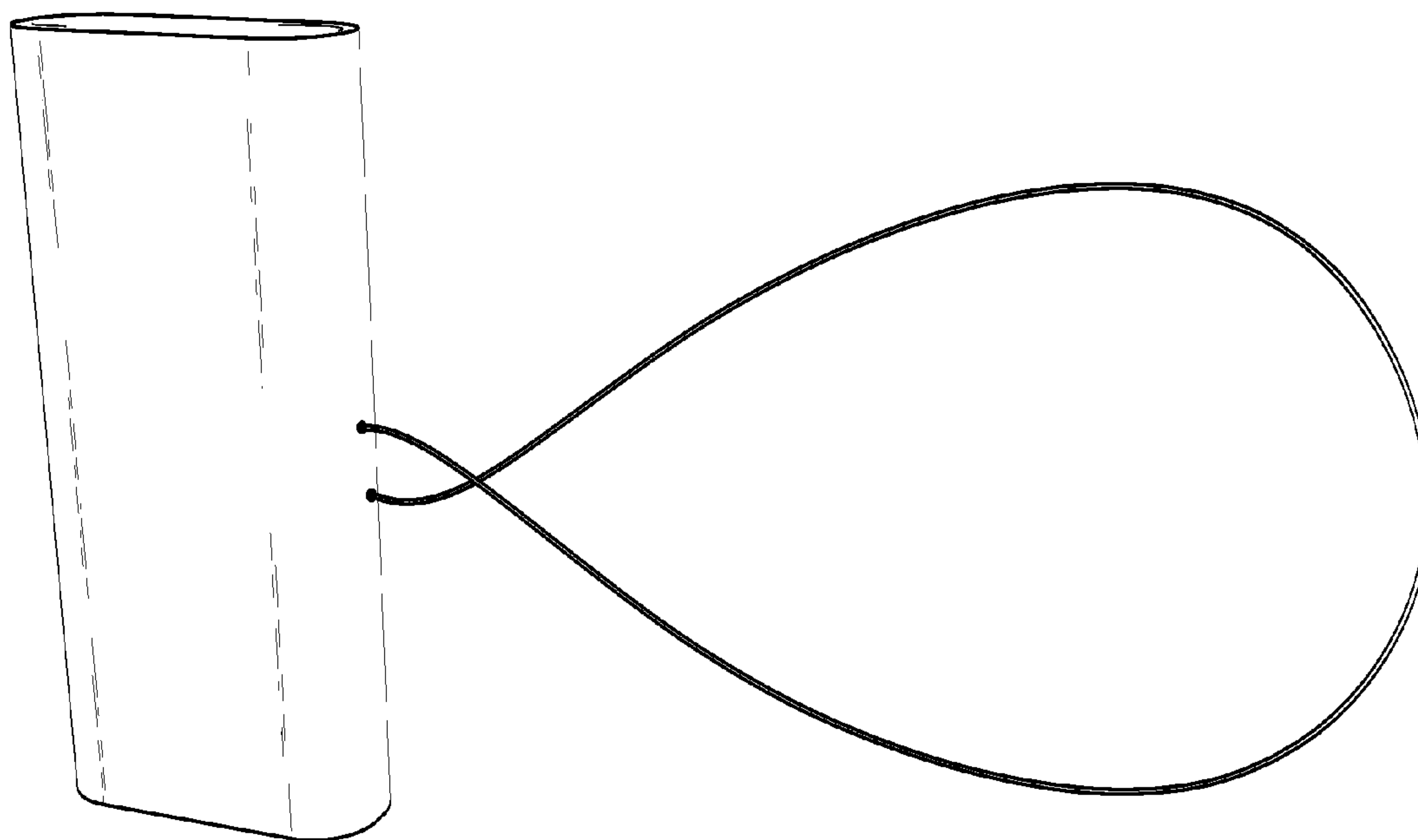

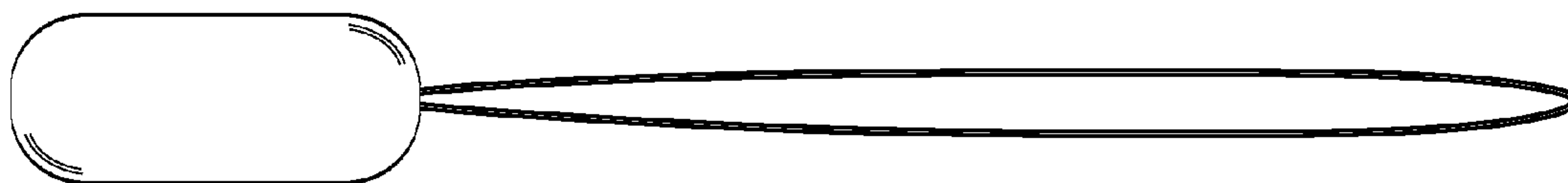

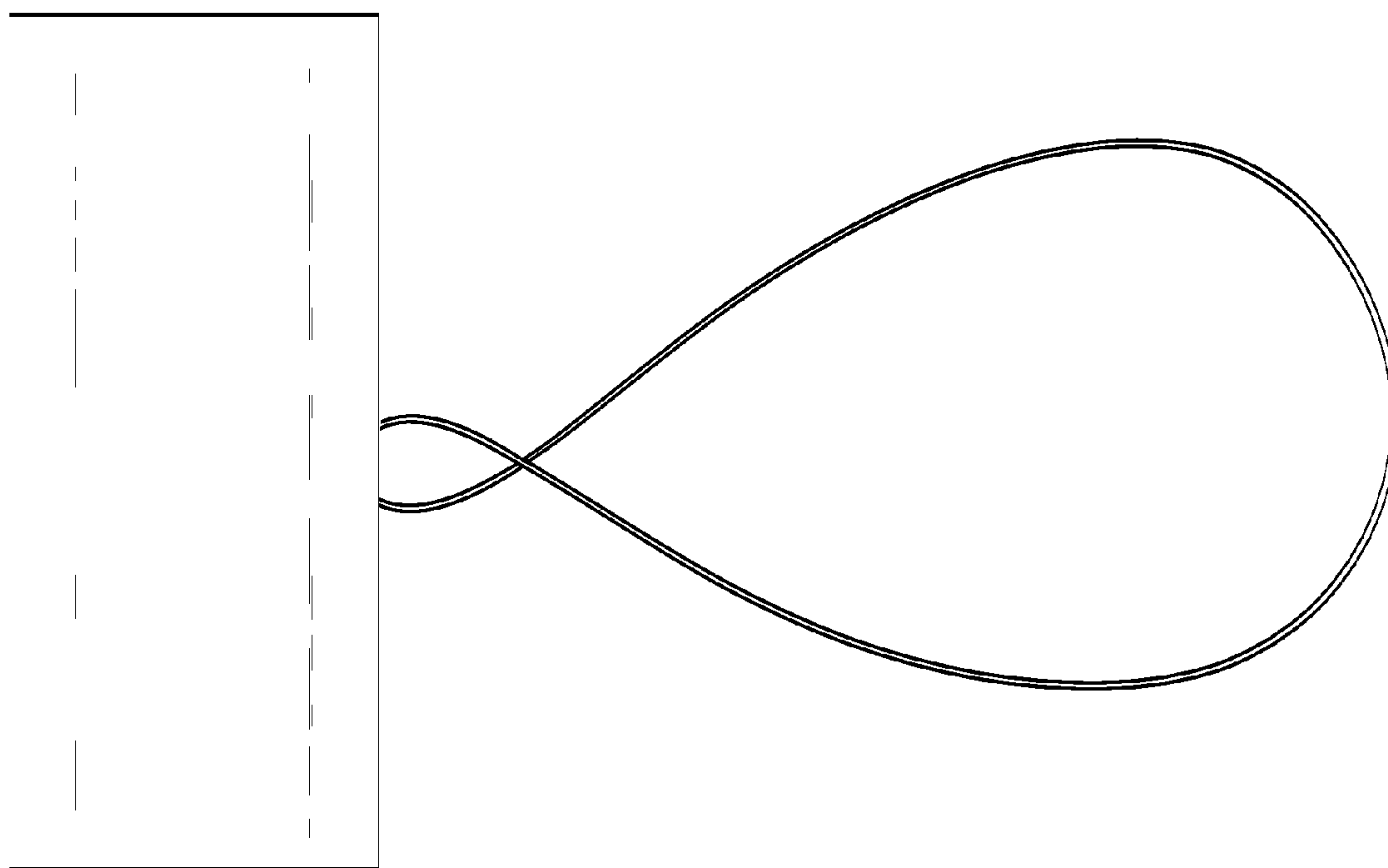

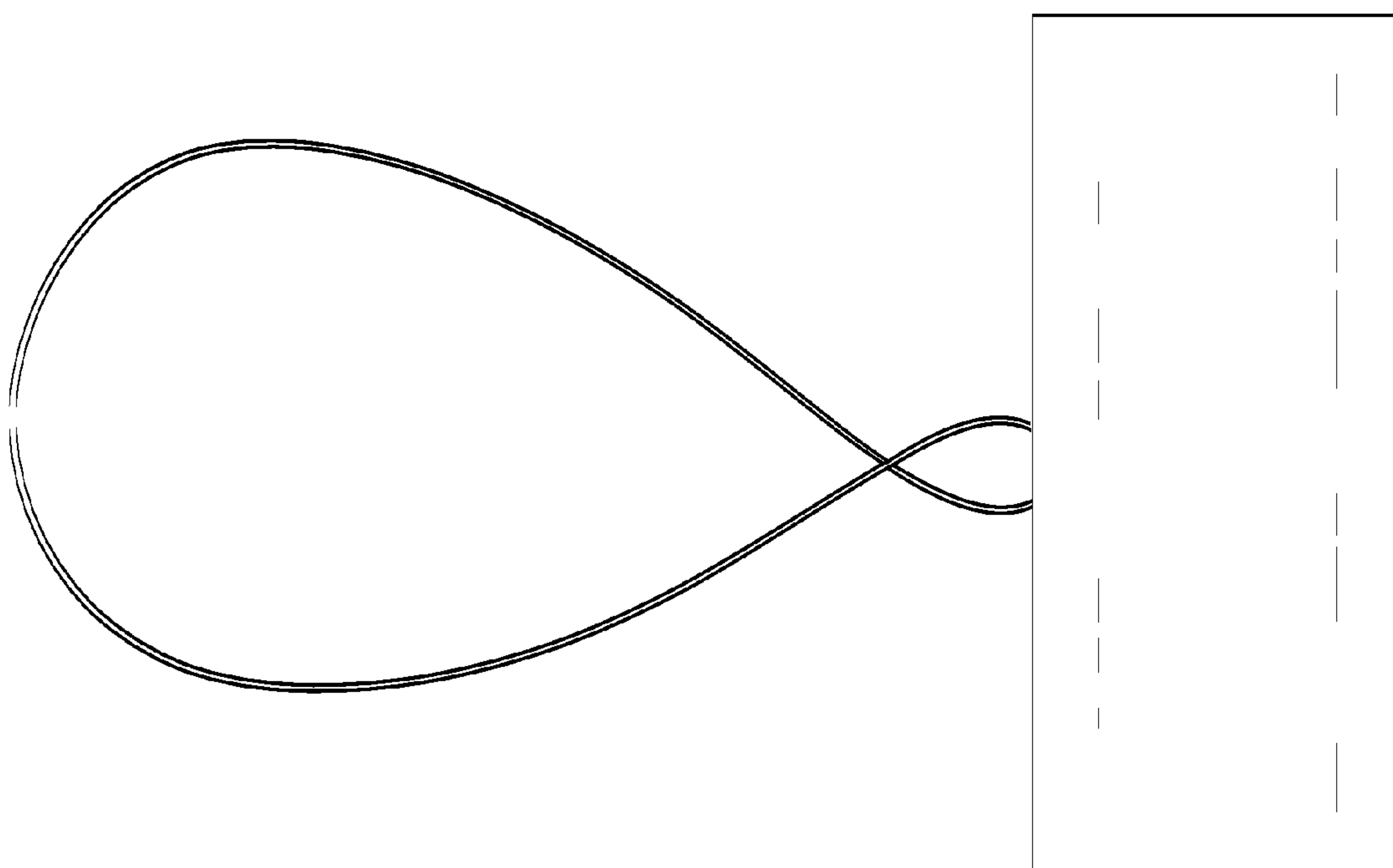

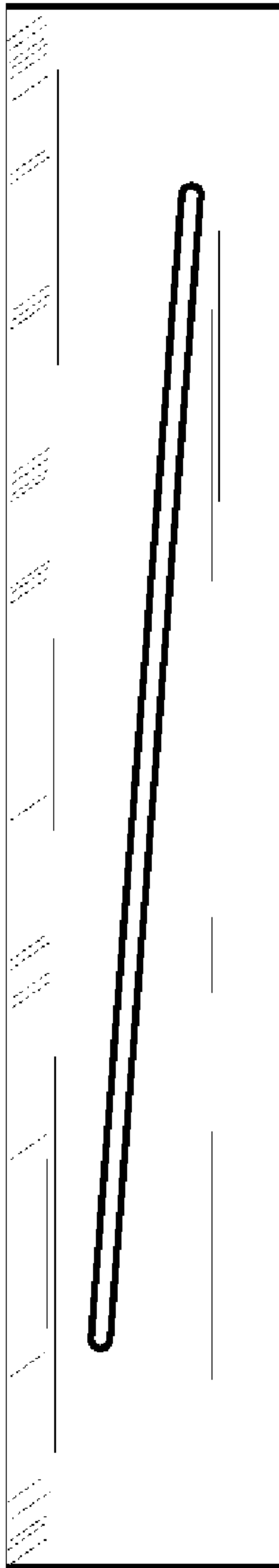

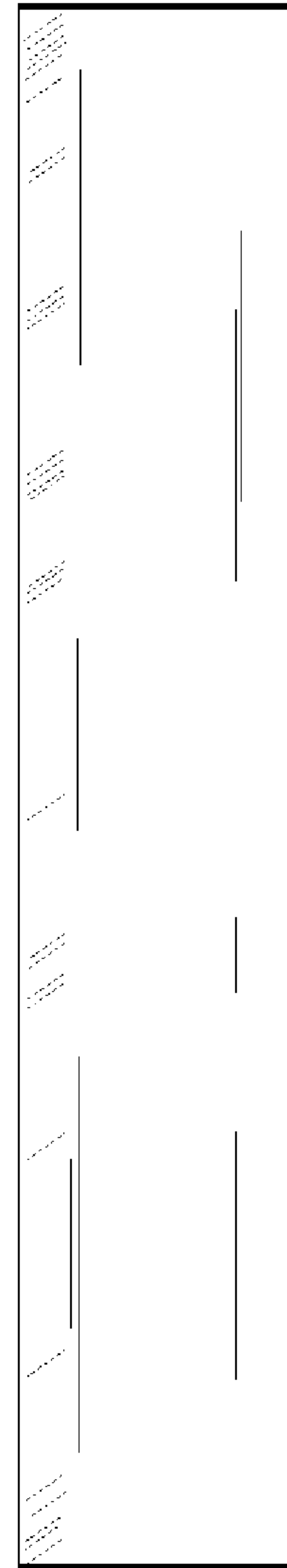

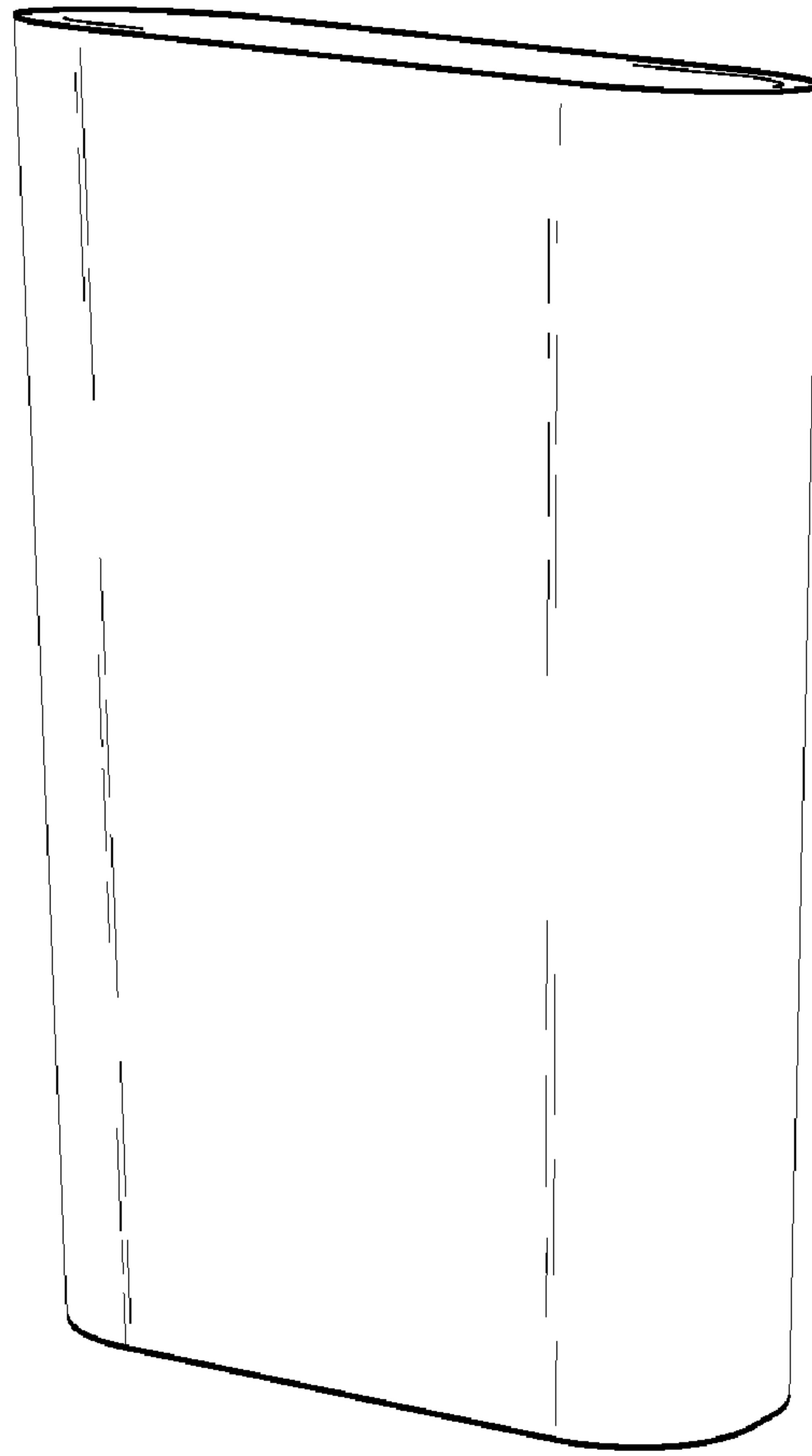

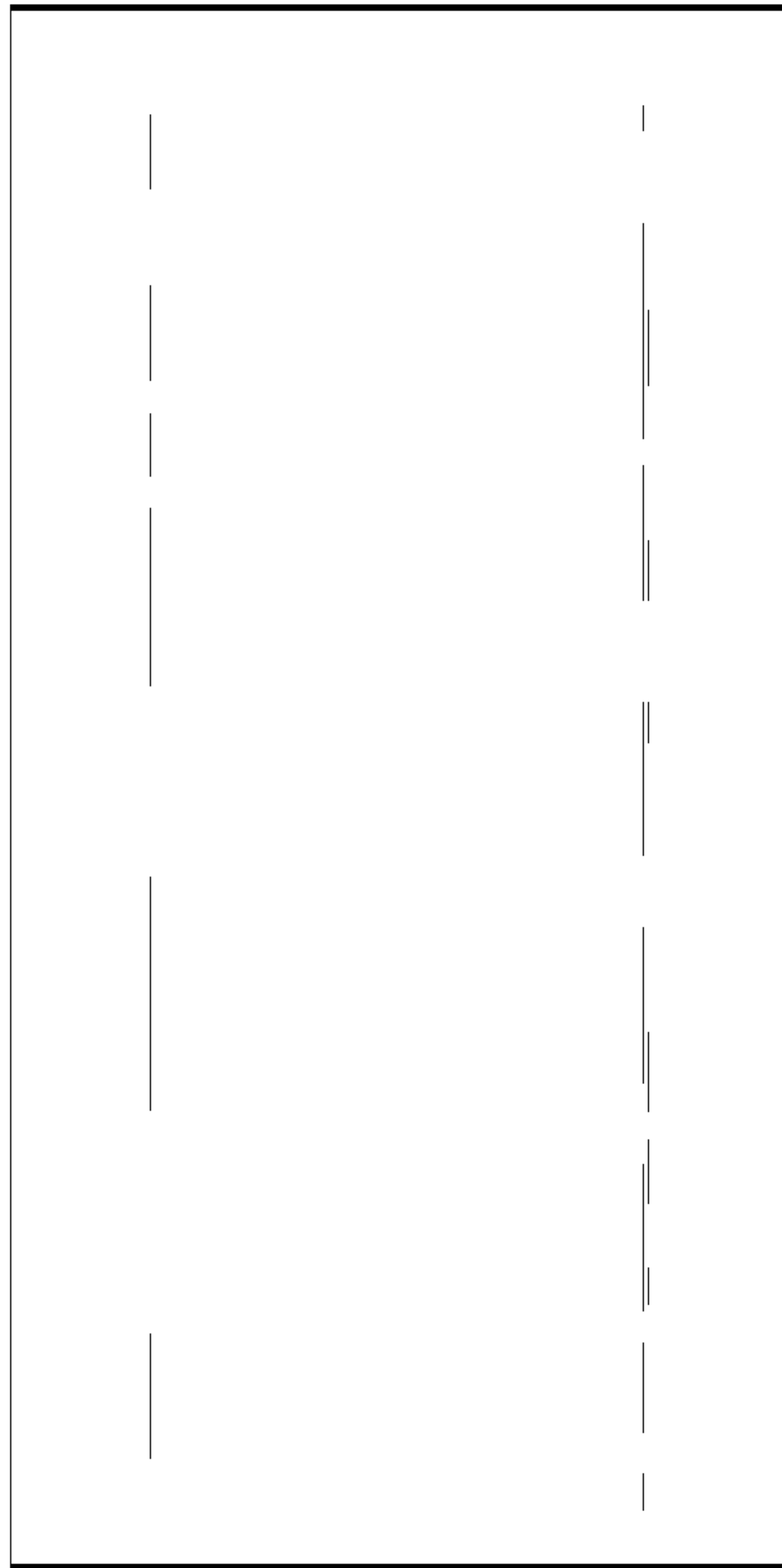

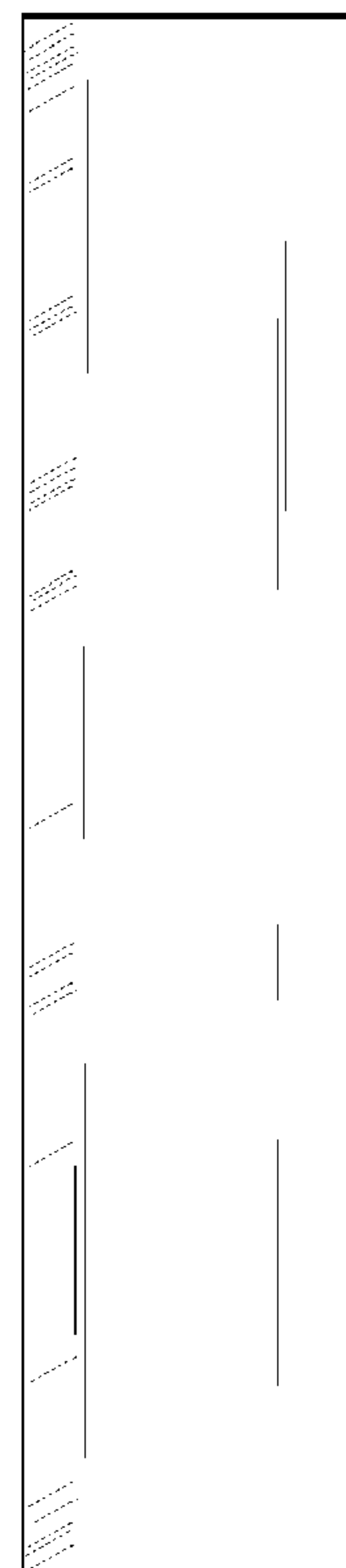
