FIG. 3 is a front side view of the device.

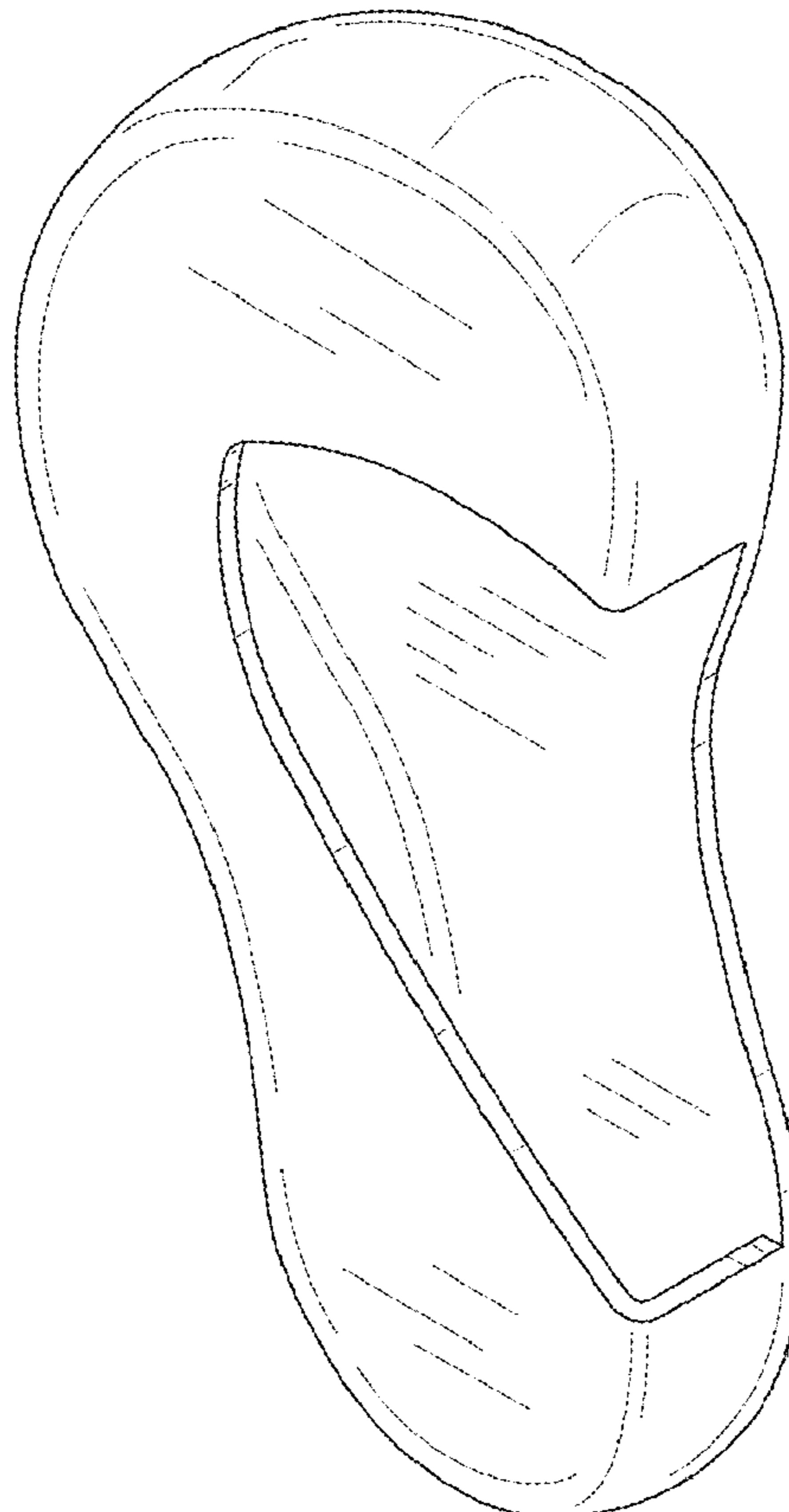
FIG. 4 is a rear side view of the device.

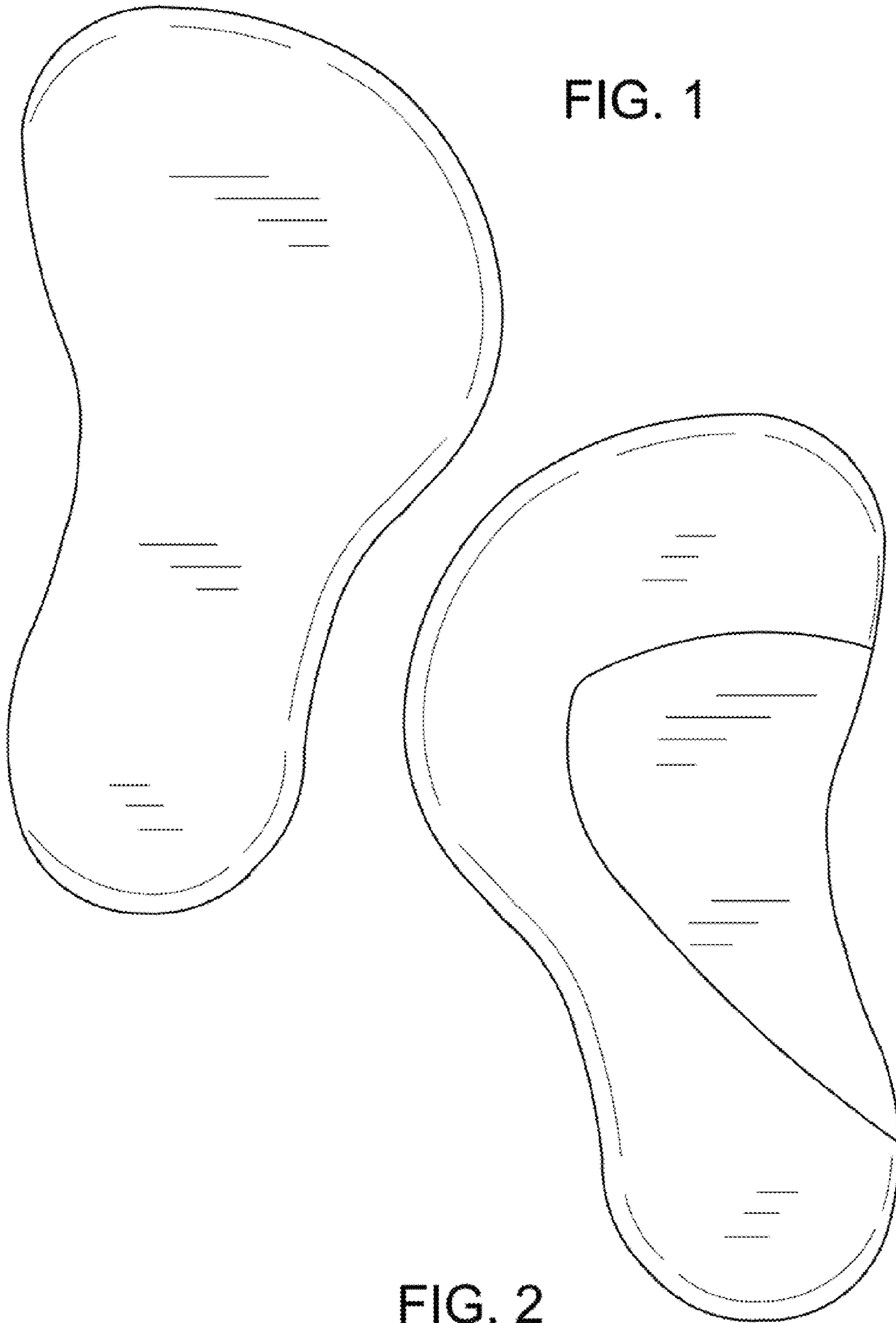
FIG. 5 is a top view of the device.

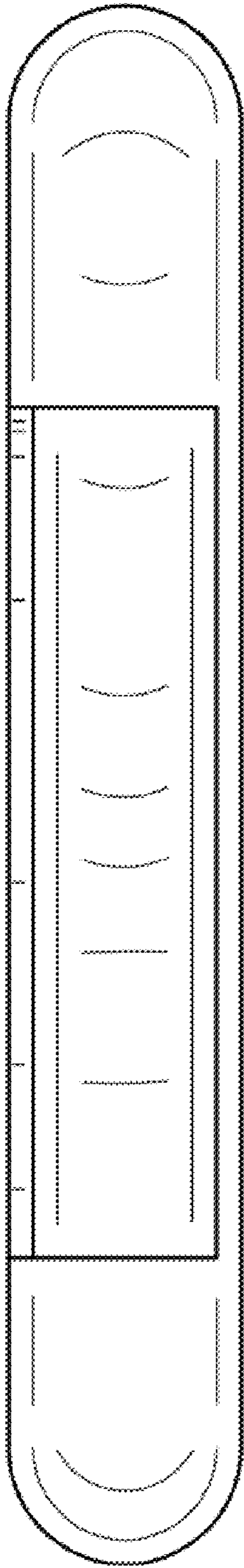

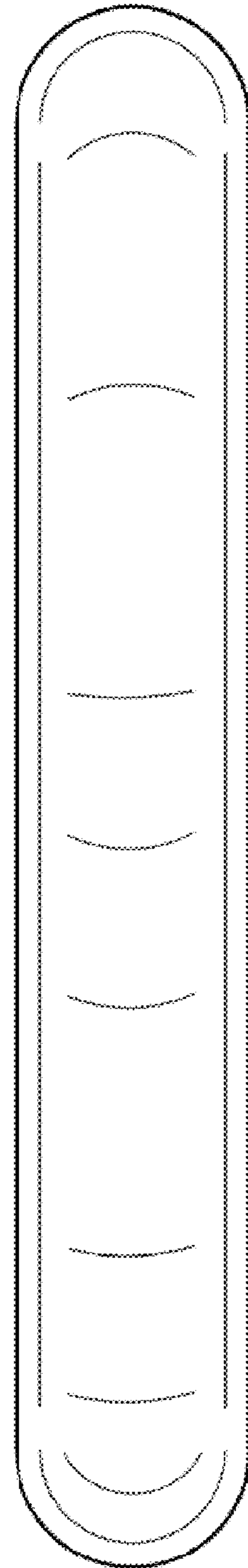

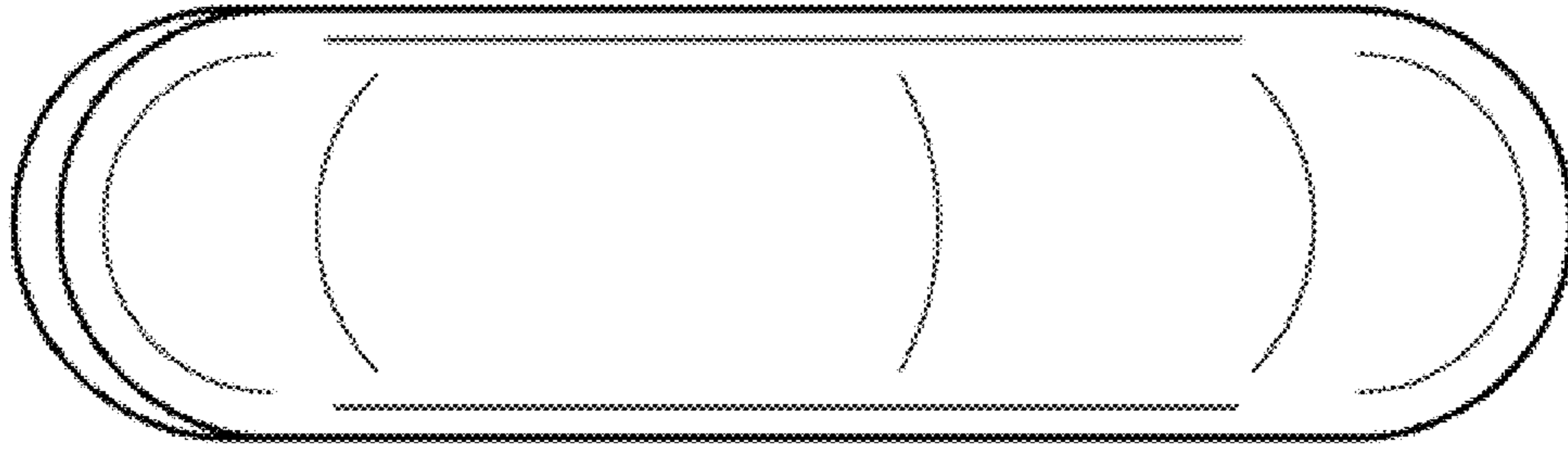

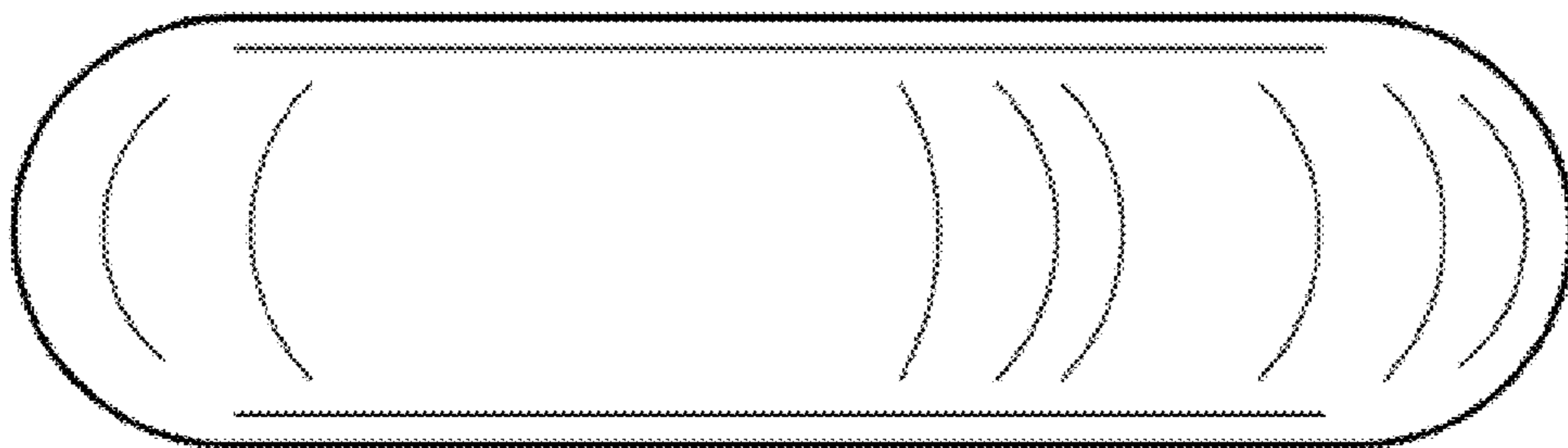
