(57) **CLAIM**

We claim the ornamental design for a sink plunger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sink plunger of the present invention,

FIG. 2 is a right side elevation view of the sink plunger of FIG. 1, the left side elevation view being identical to the right side elevation view;

FIG. 3 is a front elevation view of the sink plunger of FIG. 1;

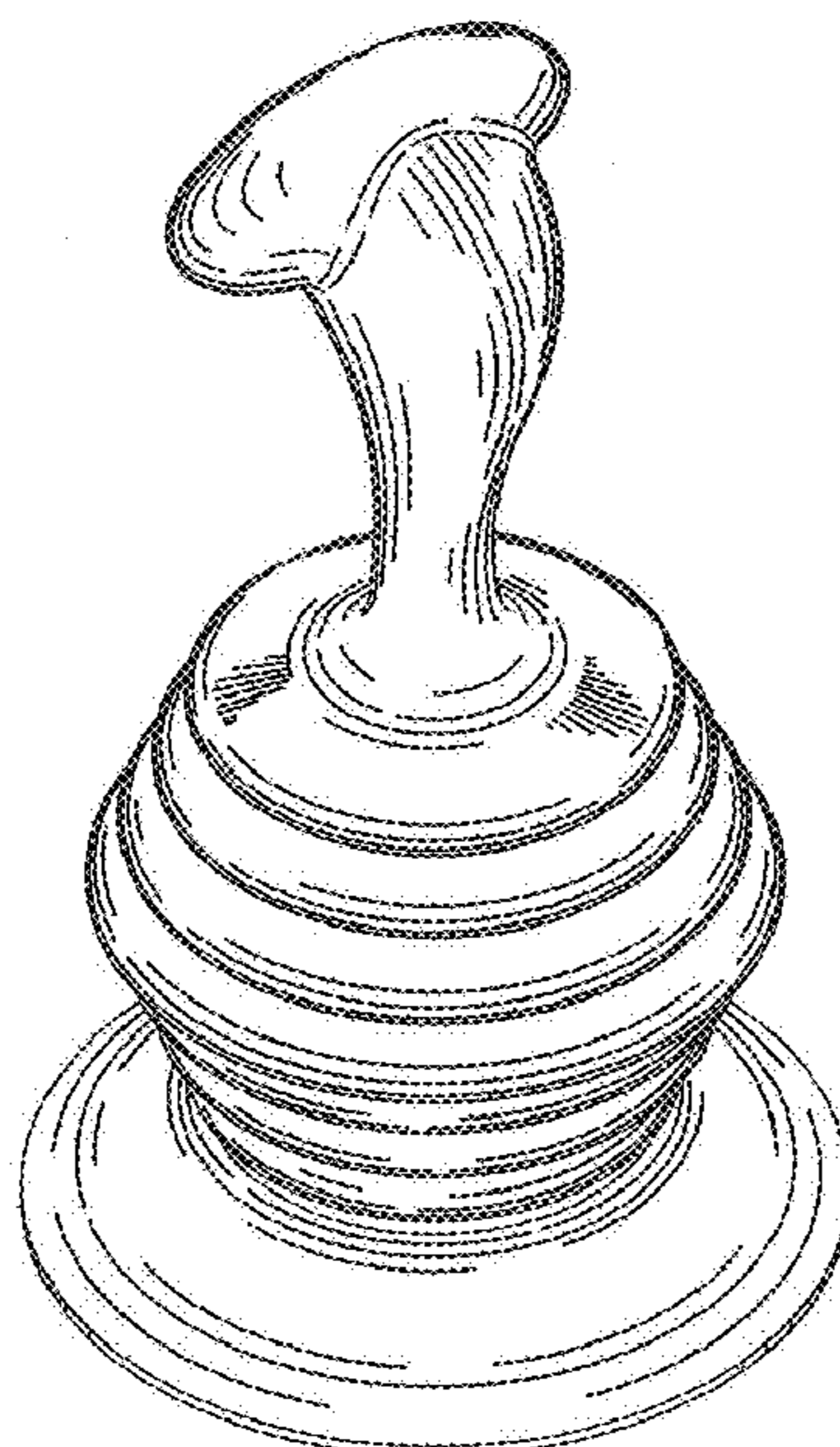
FIG. 4 is a back elevation view of the sink plunger of FIG. 1;

FIG. 5 is a top plan view of the sink plunger of FIG. 1; and,

FIG. 6 is a bottom plan view of the sink plunger of FIG. 1.

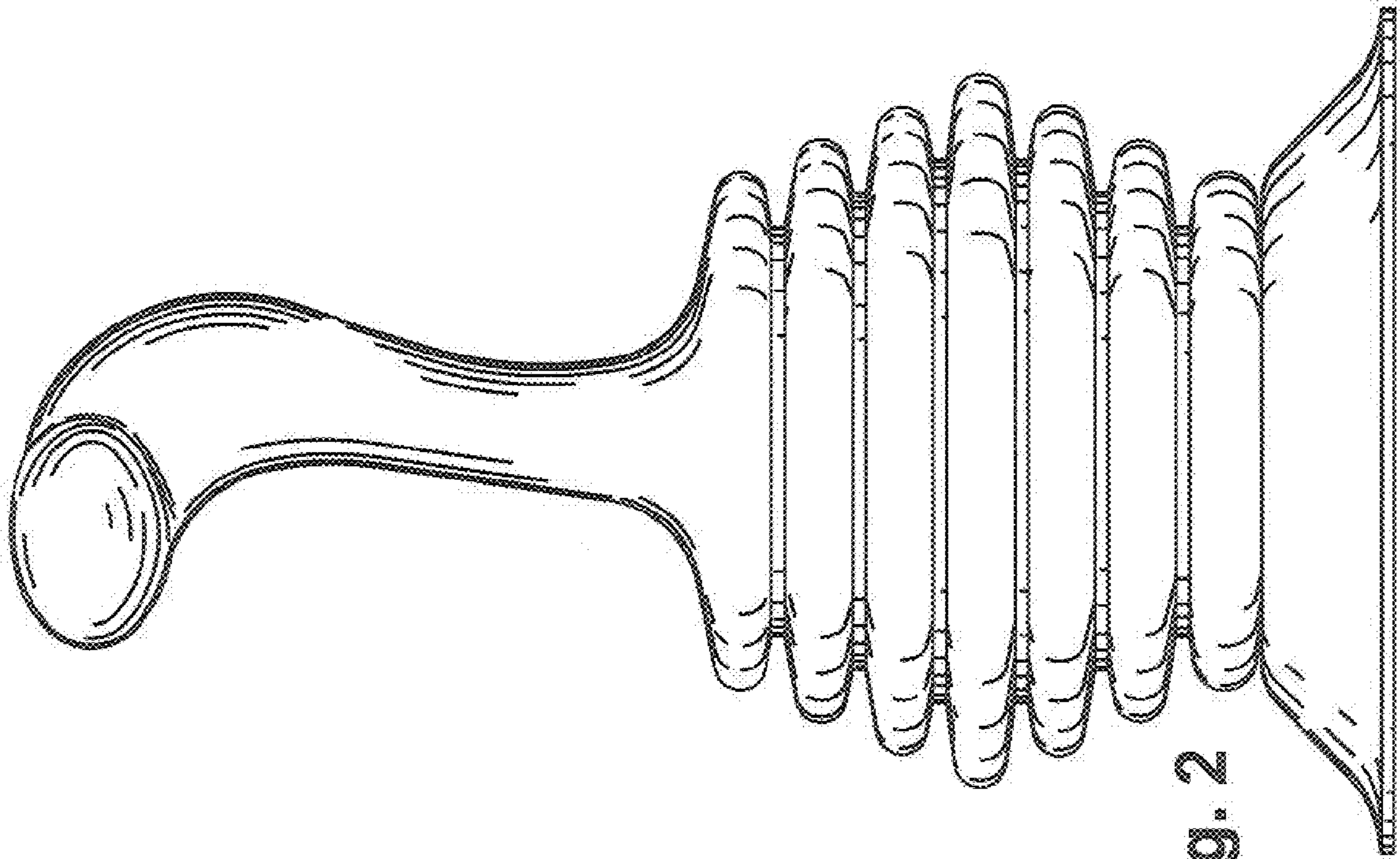

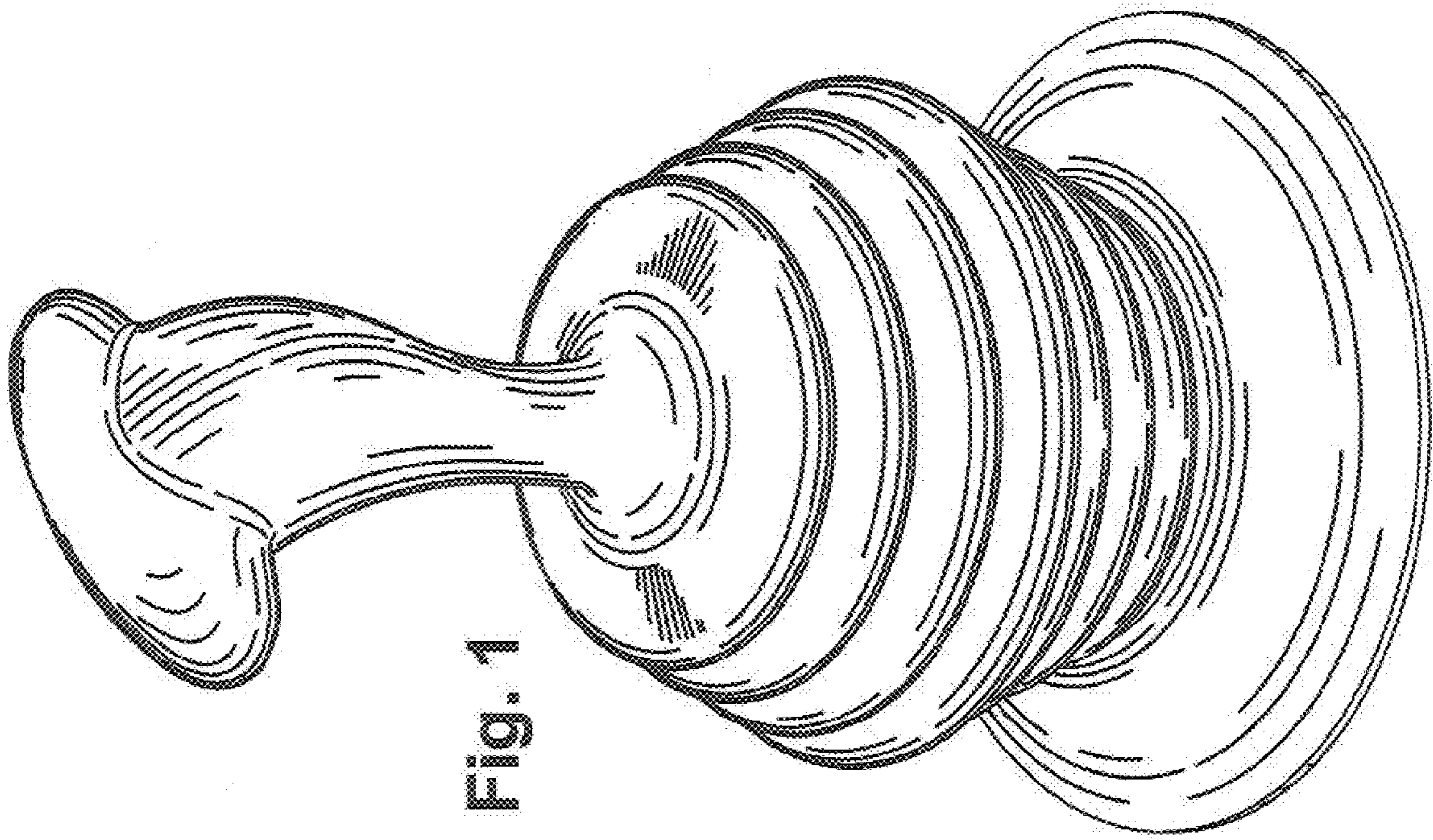

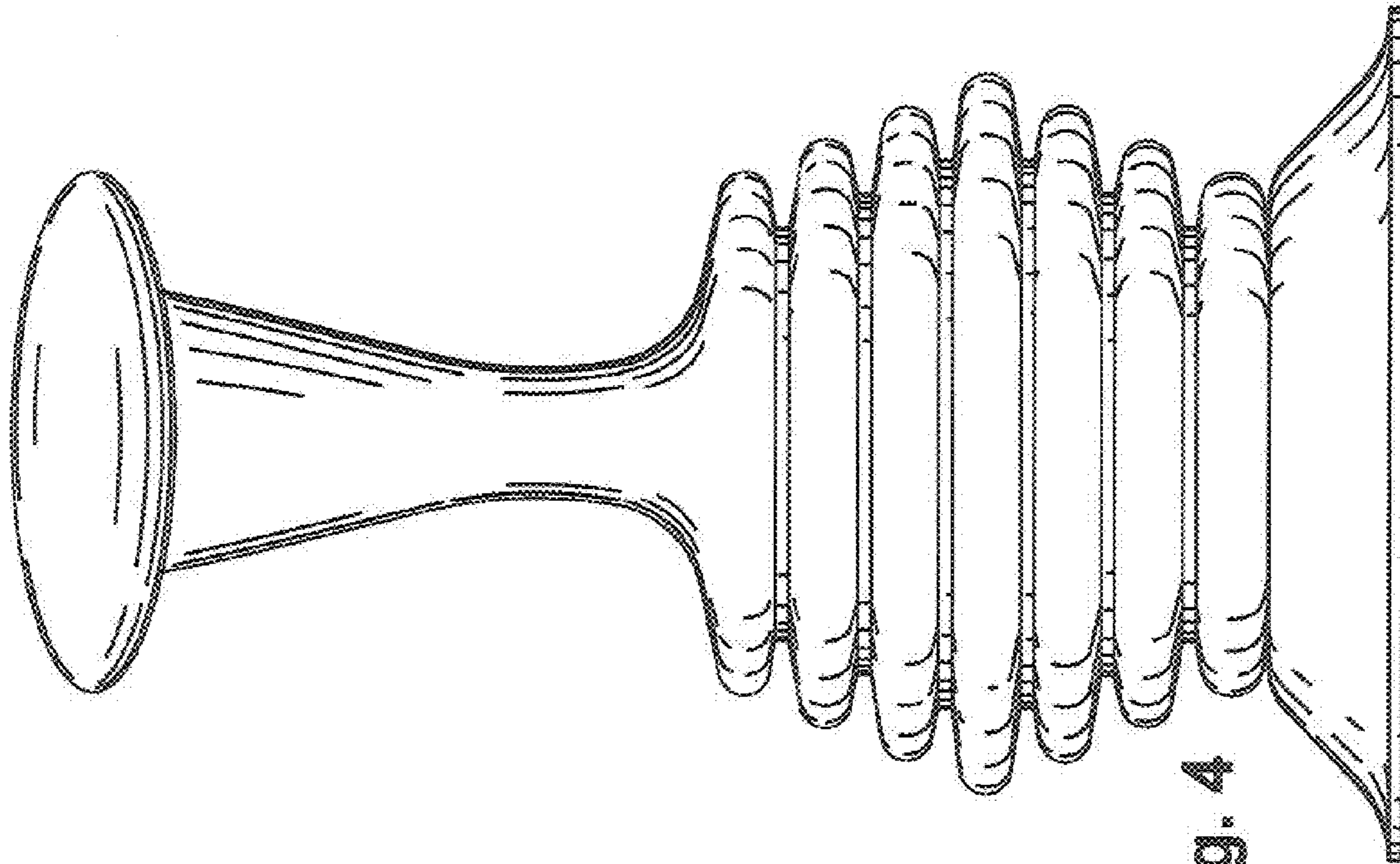

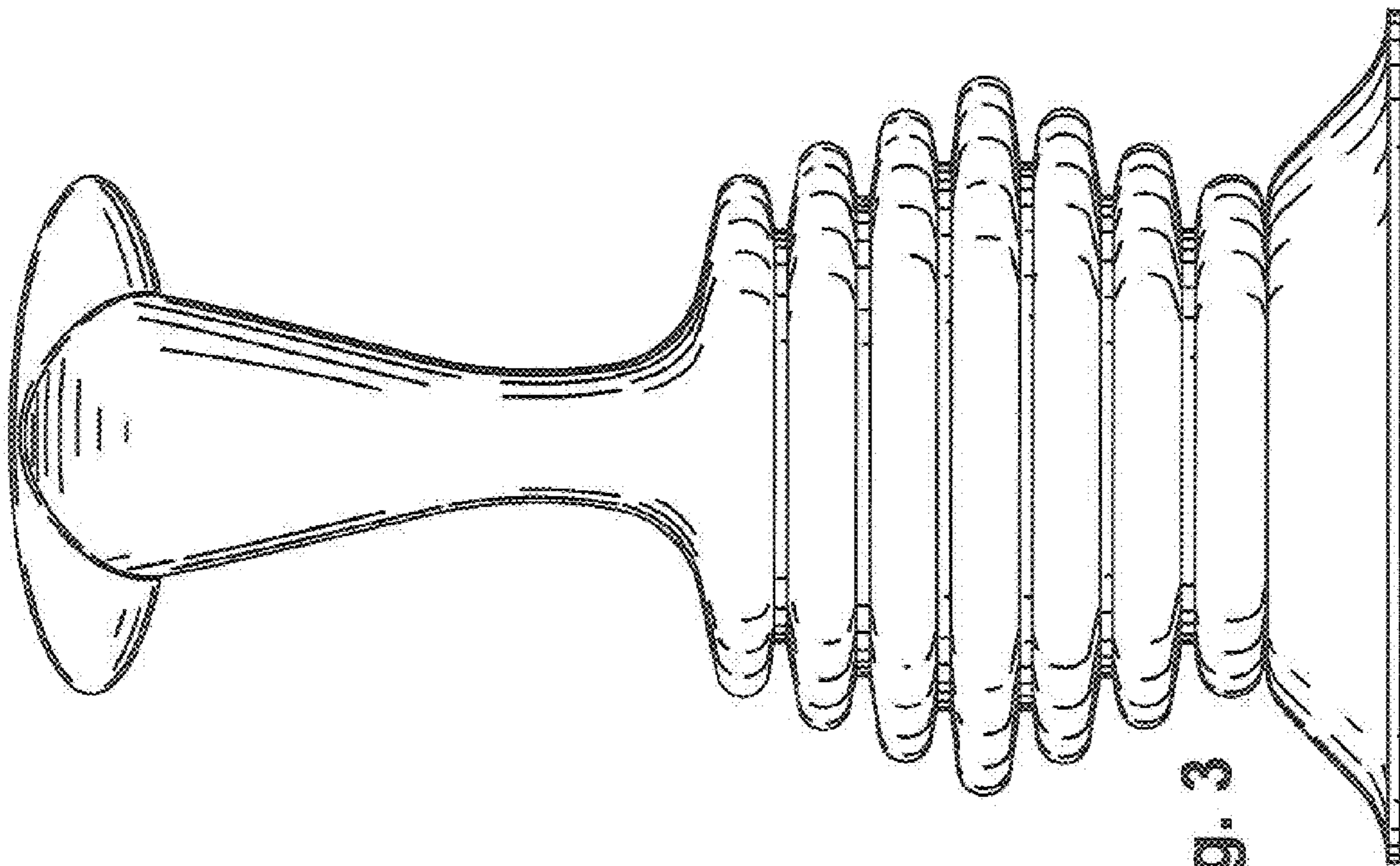

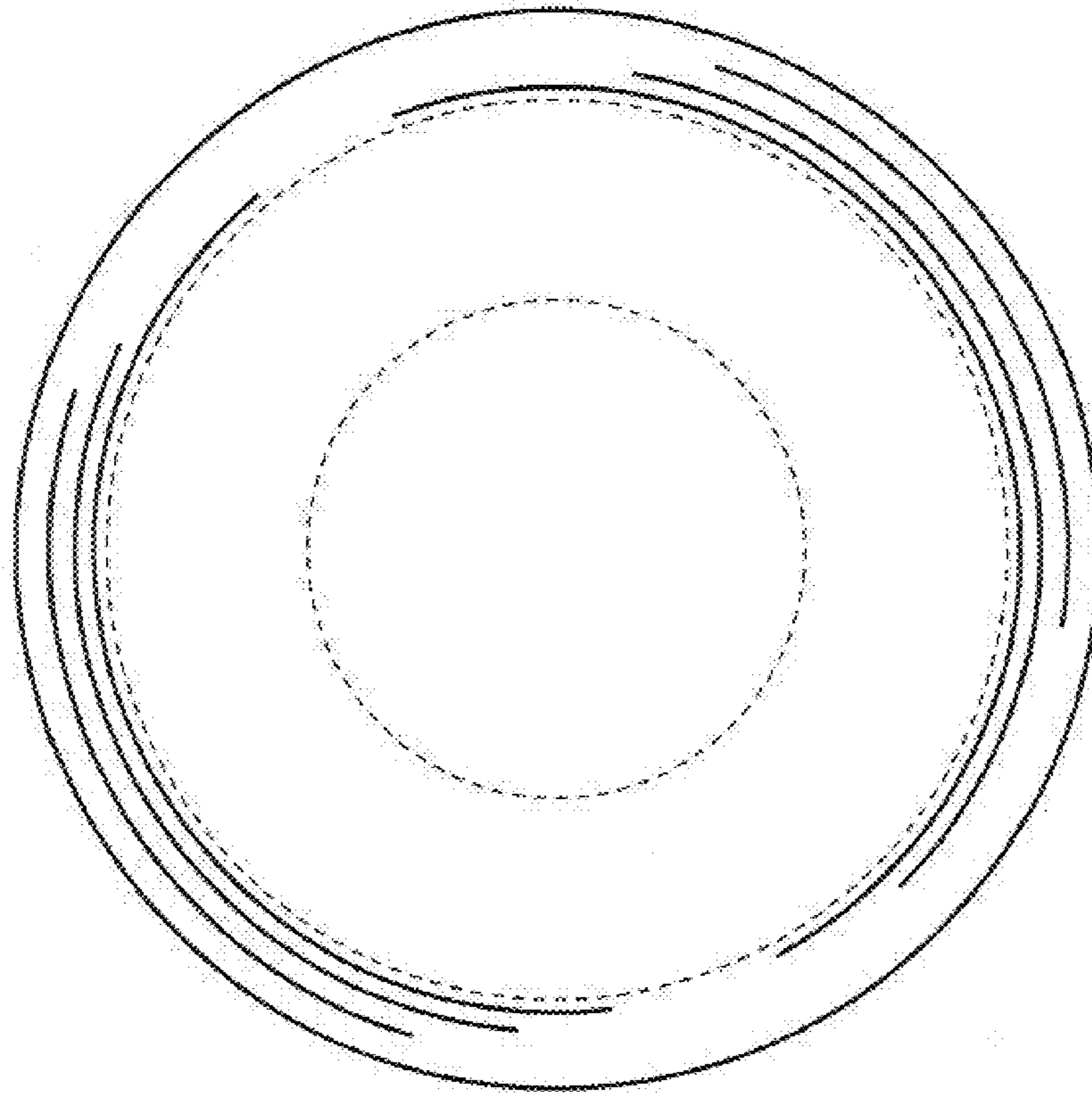

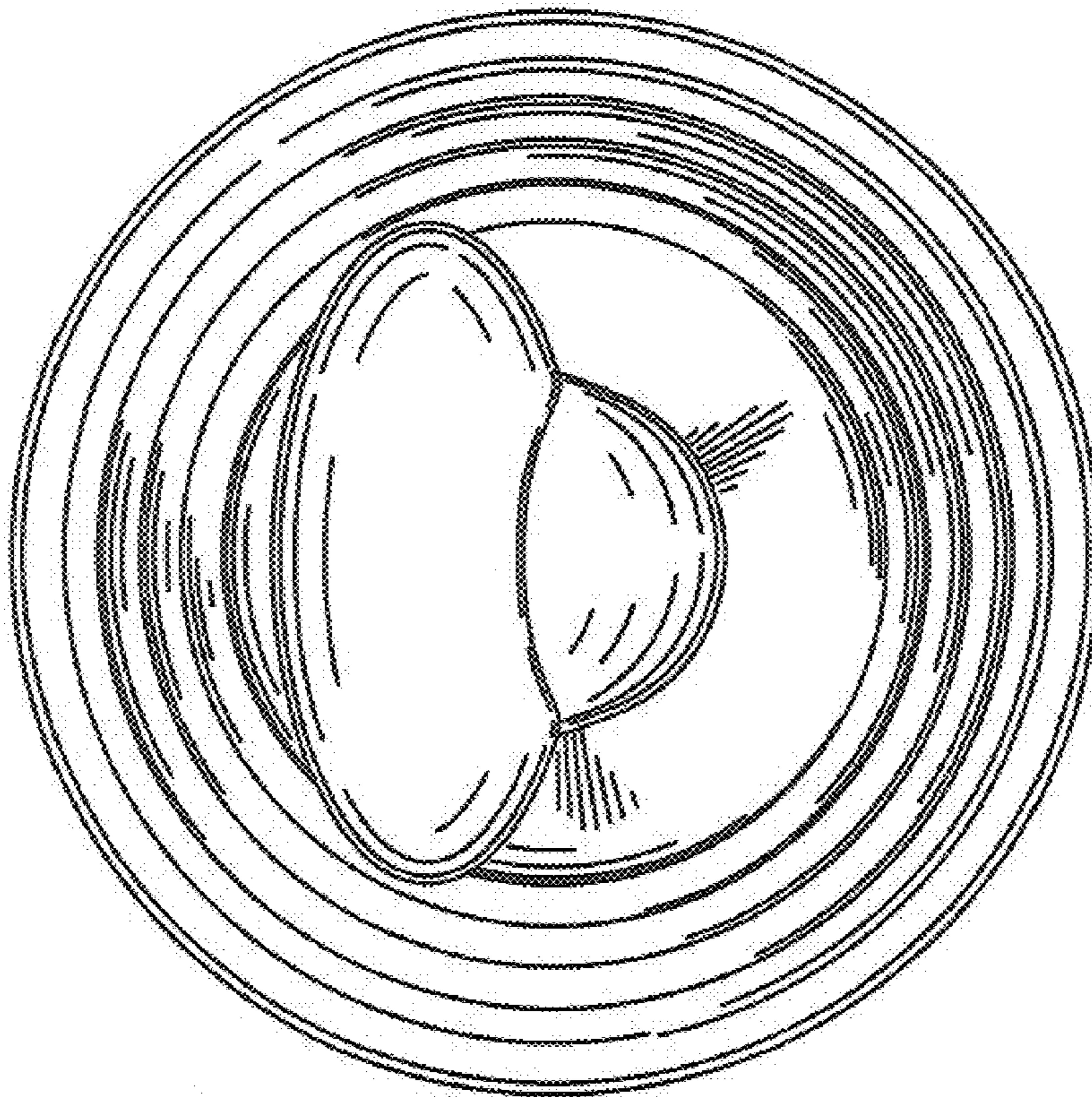
