FIG. 5 is a left side elevational view thereof.

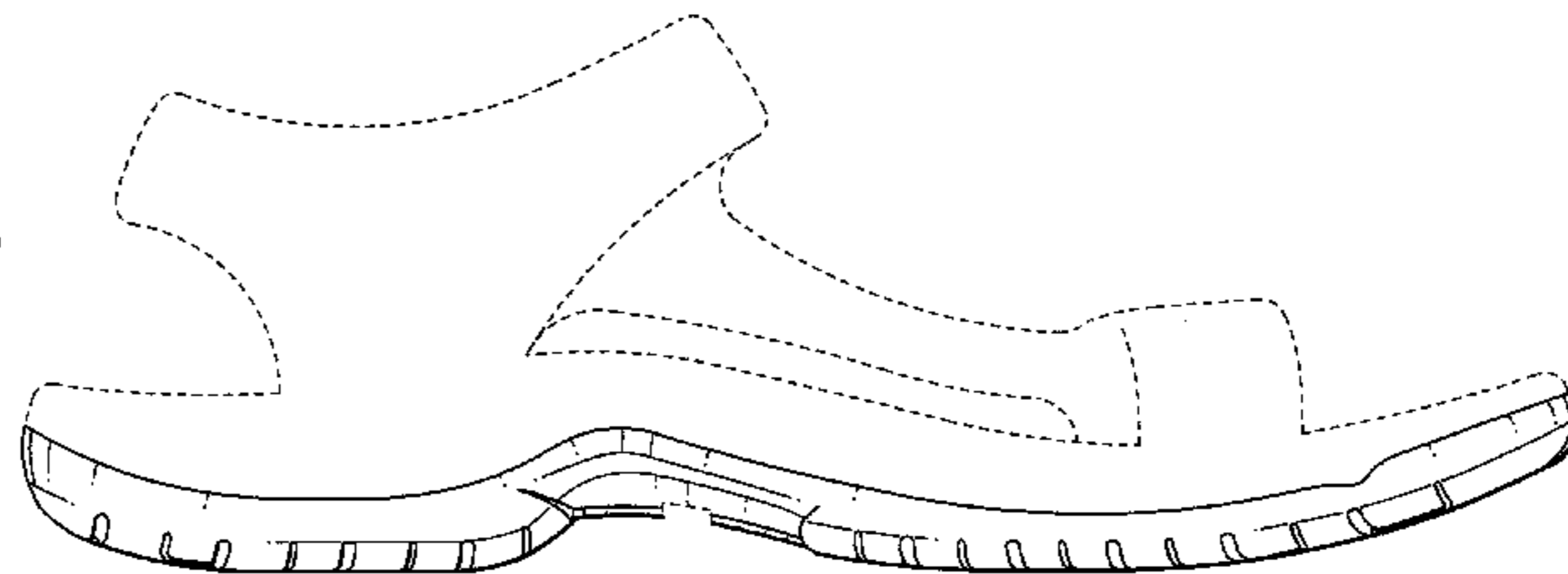
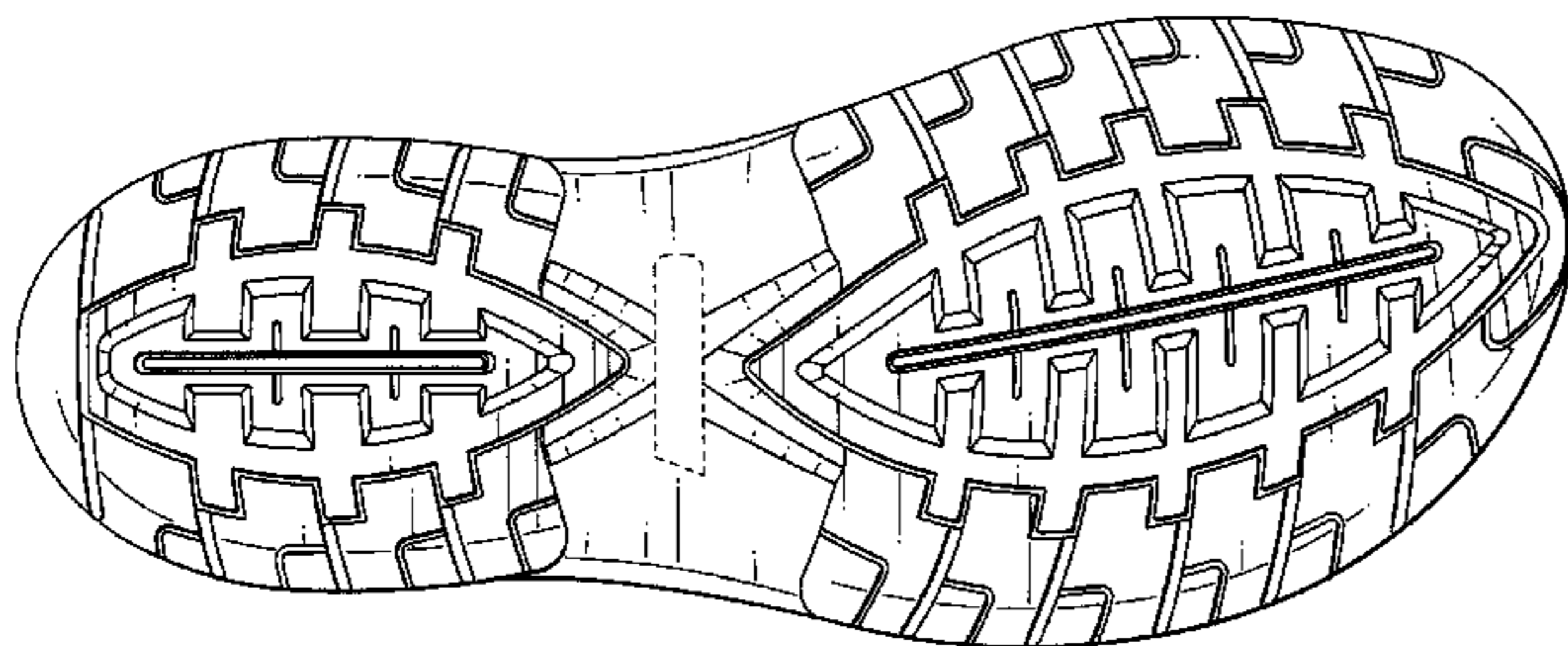
FIG. 6 is a front elevational view thereof; and,

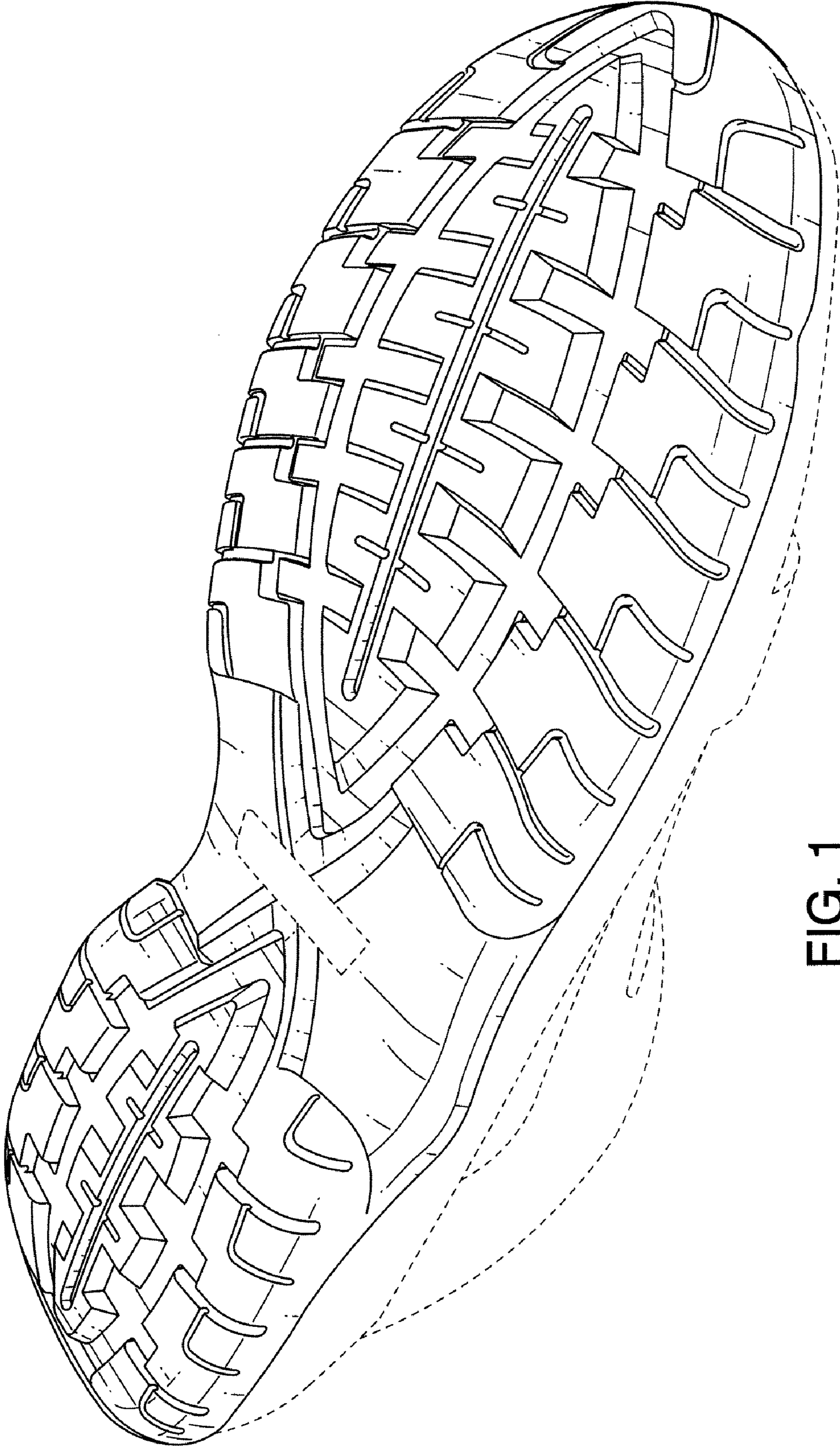

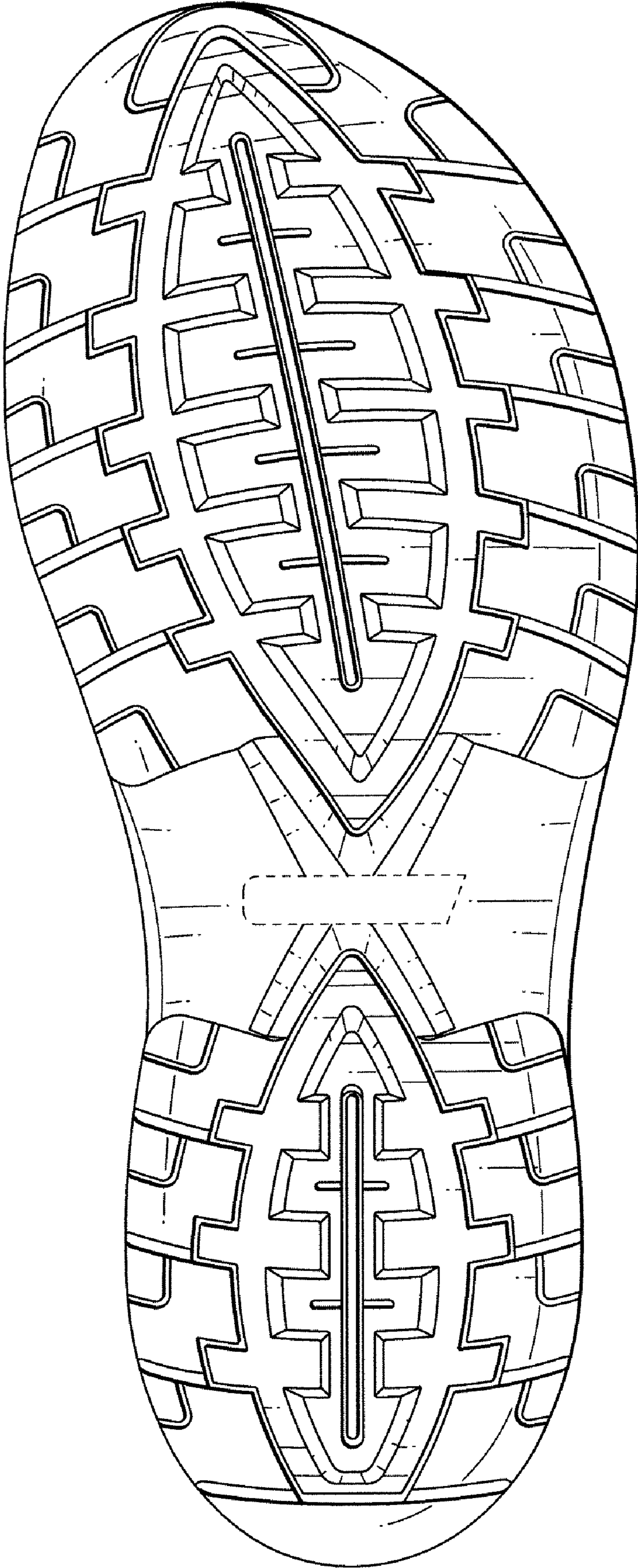

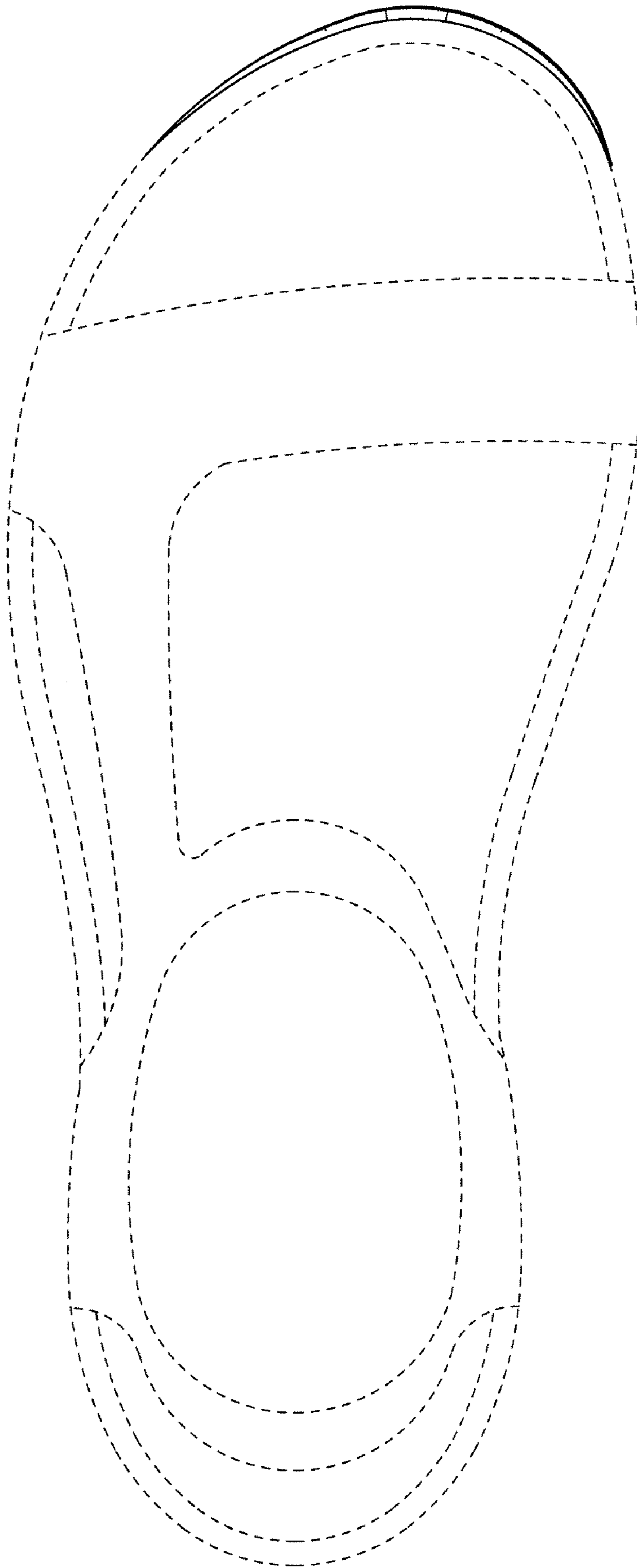

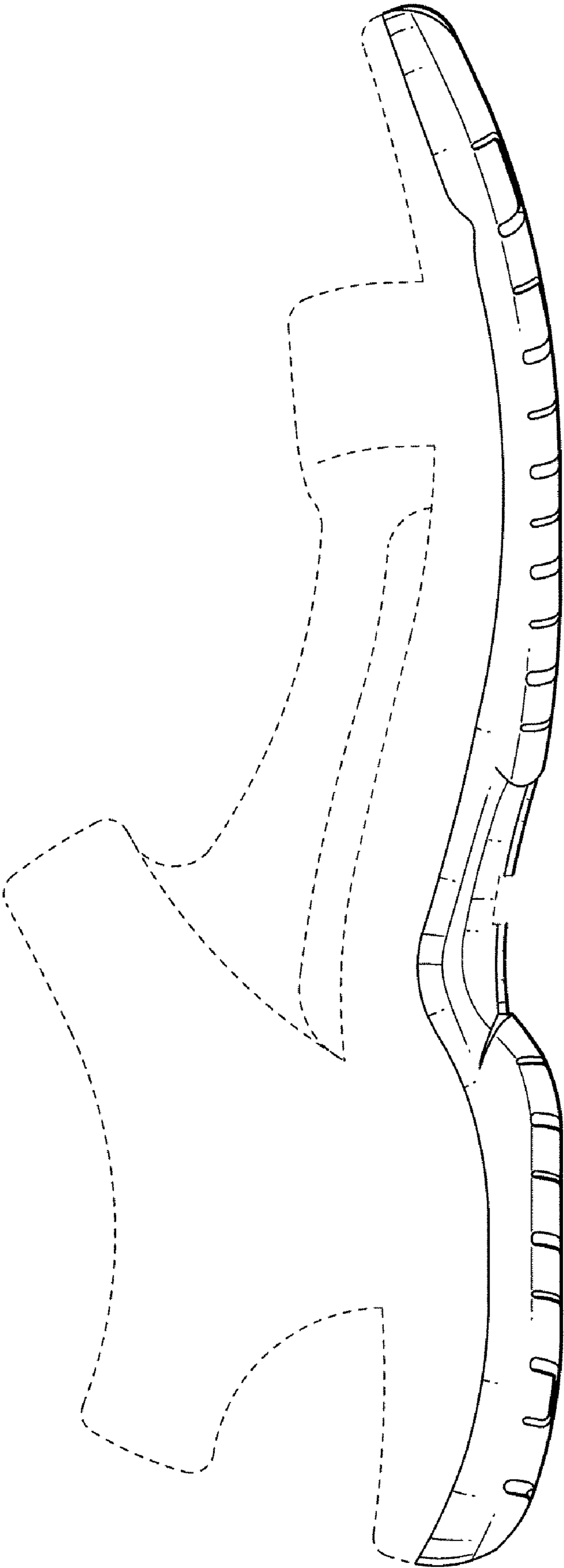

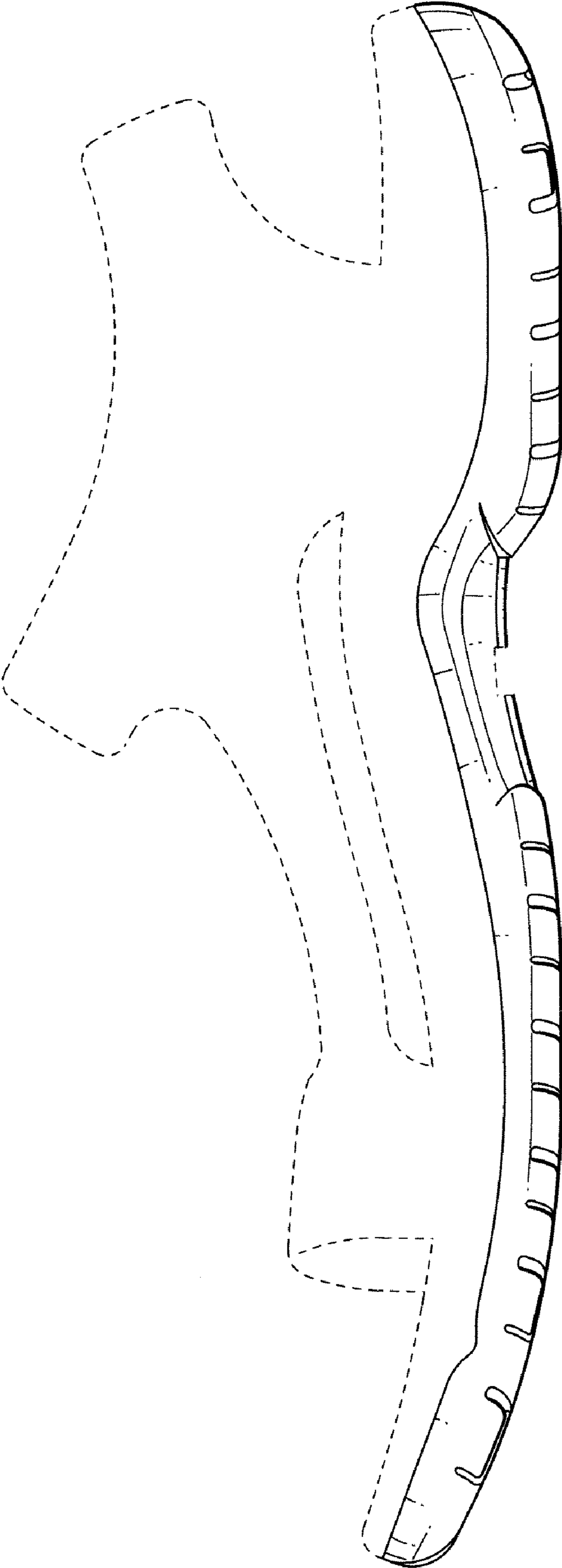

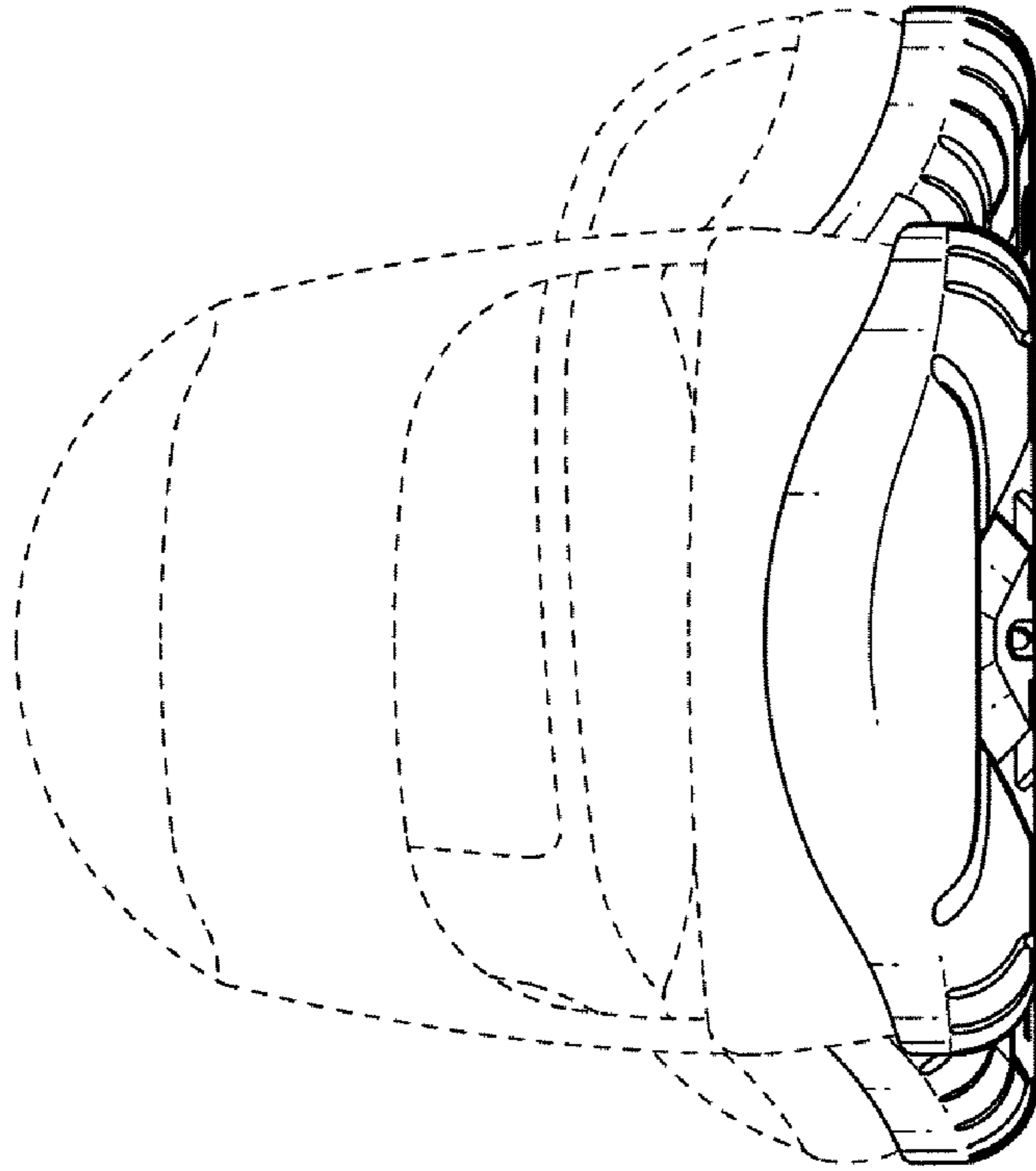

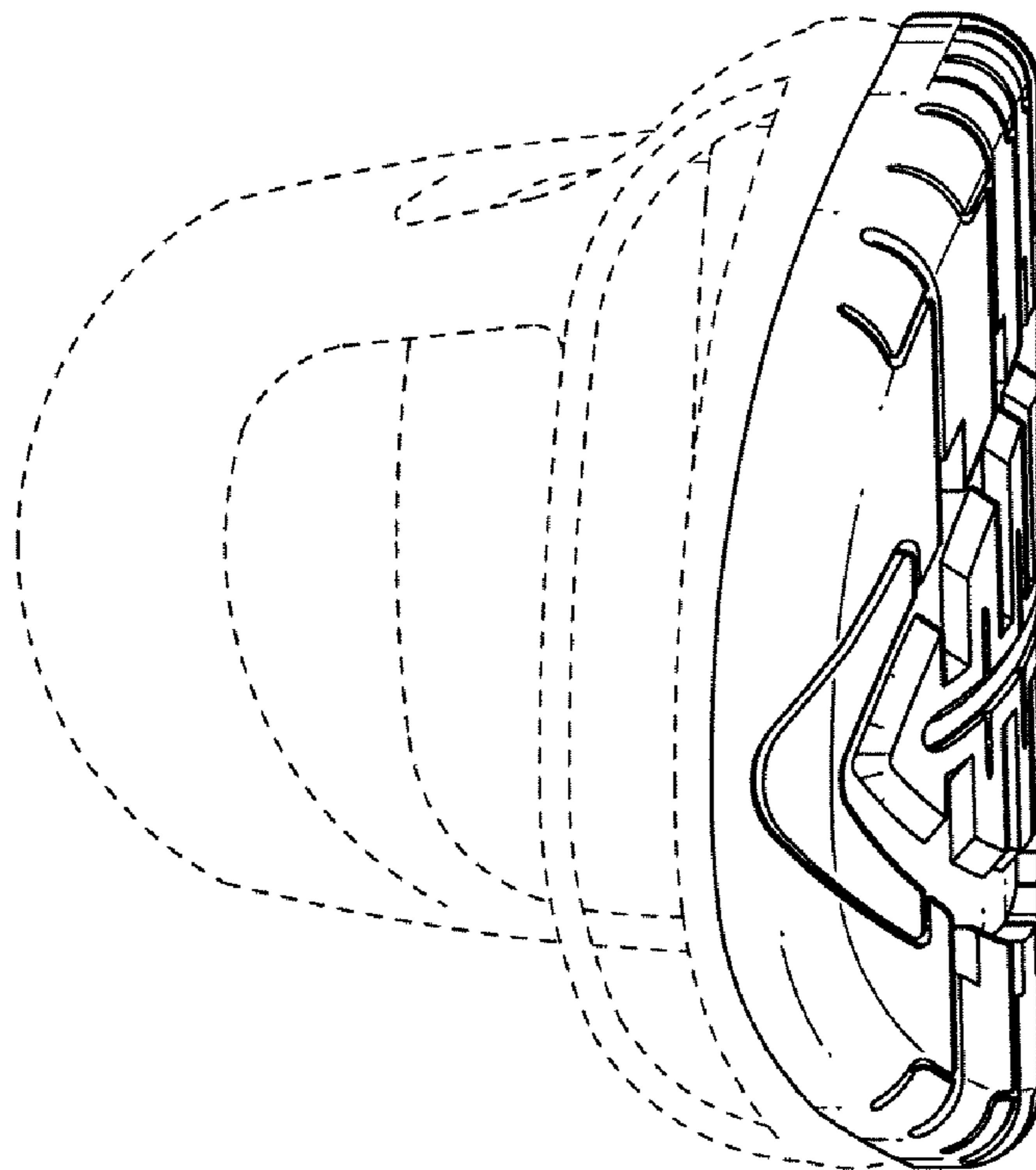
