(57) **CLAIM**

I claim the ornamental design for a fanciful fabric panel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fanciful fabric panel showing inventor’s new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, the left side being a mirror image thereof;

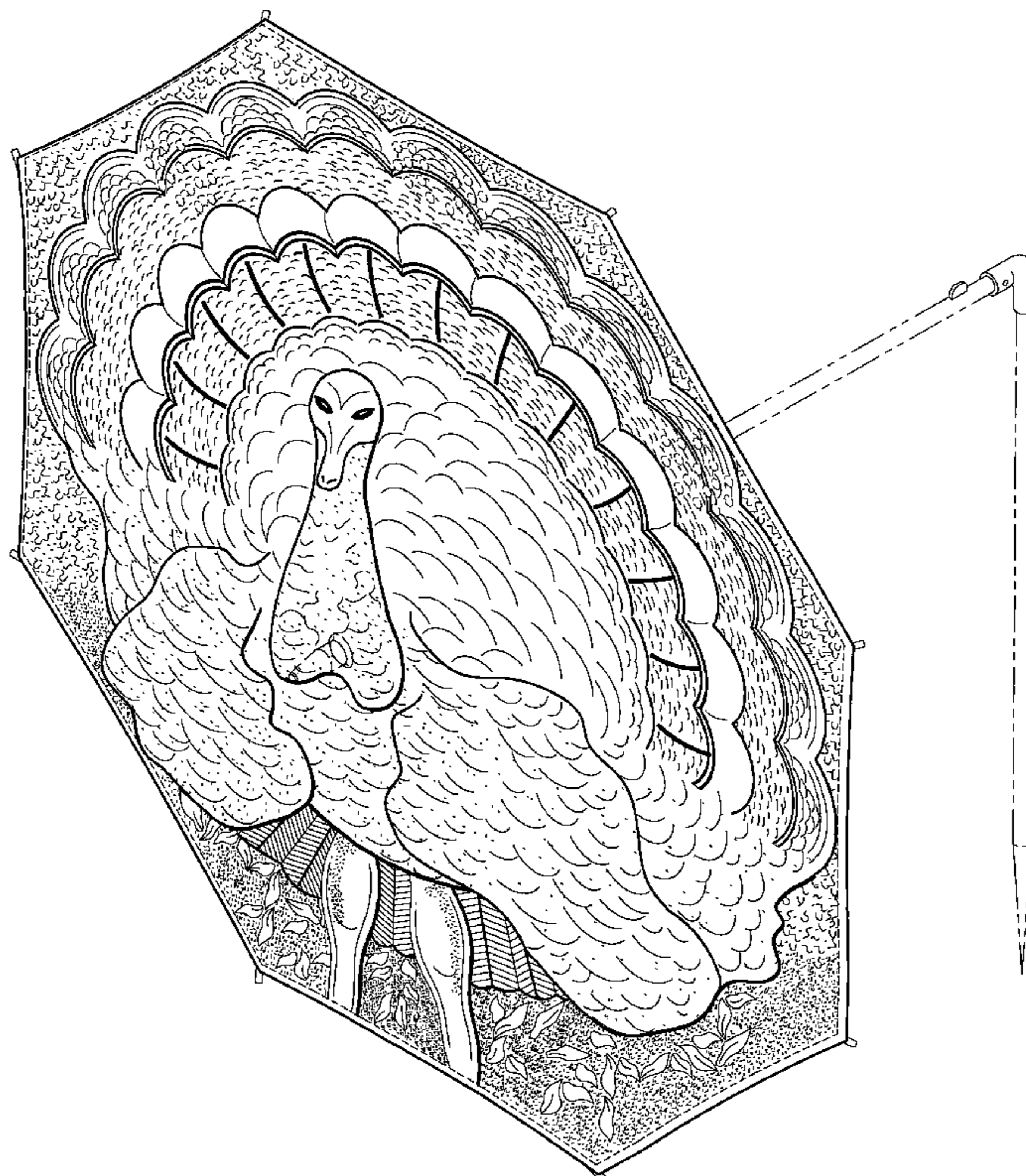
FIG. 4 is a top plan view thereof;

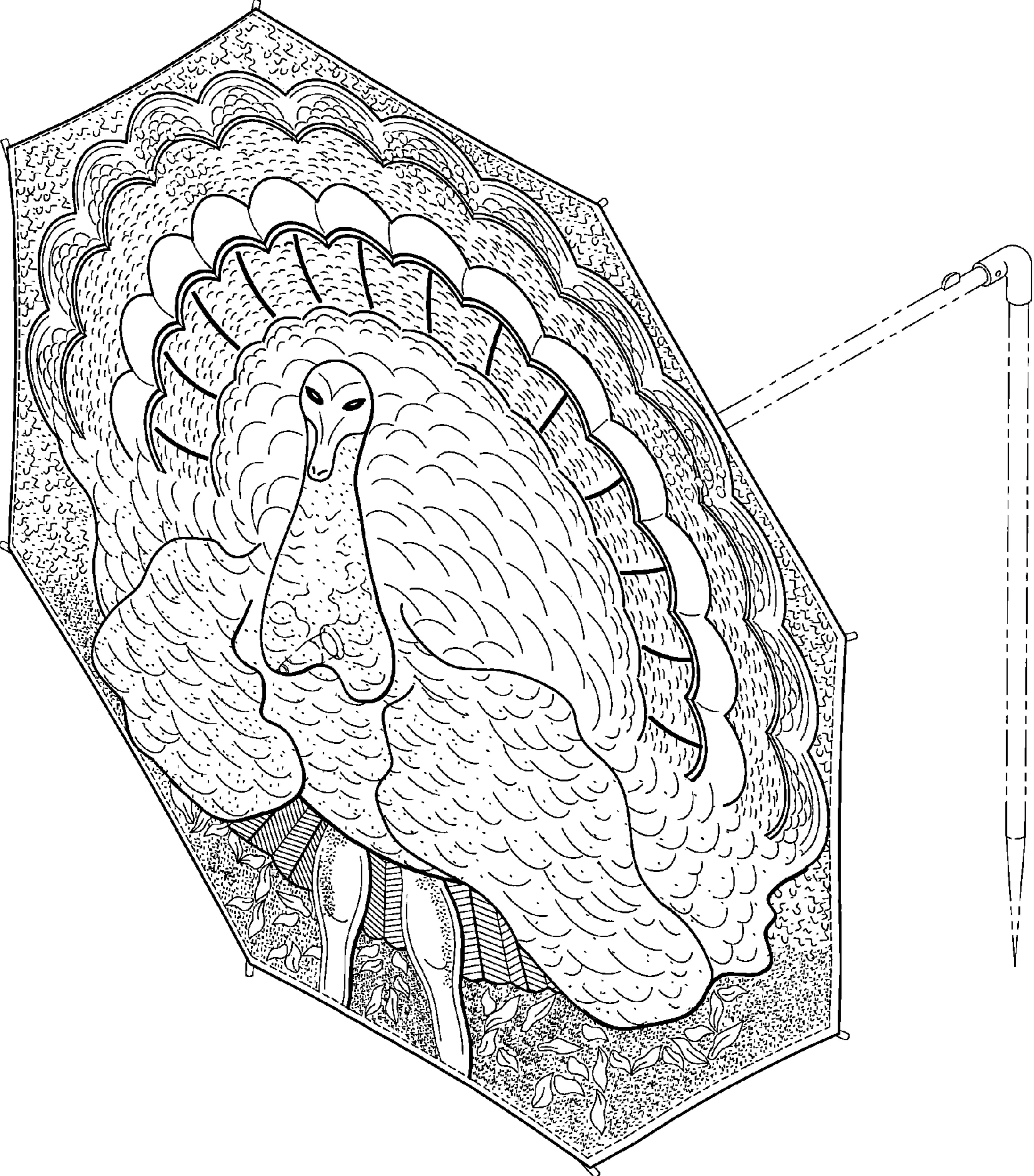
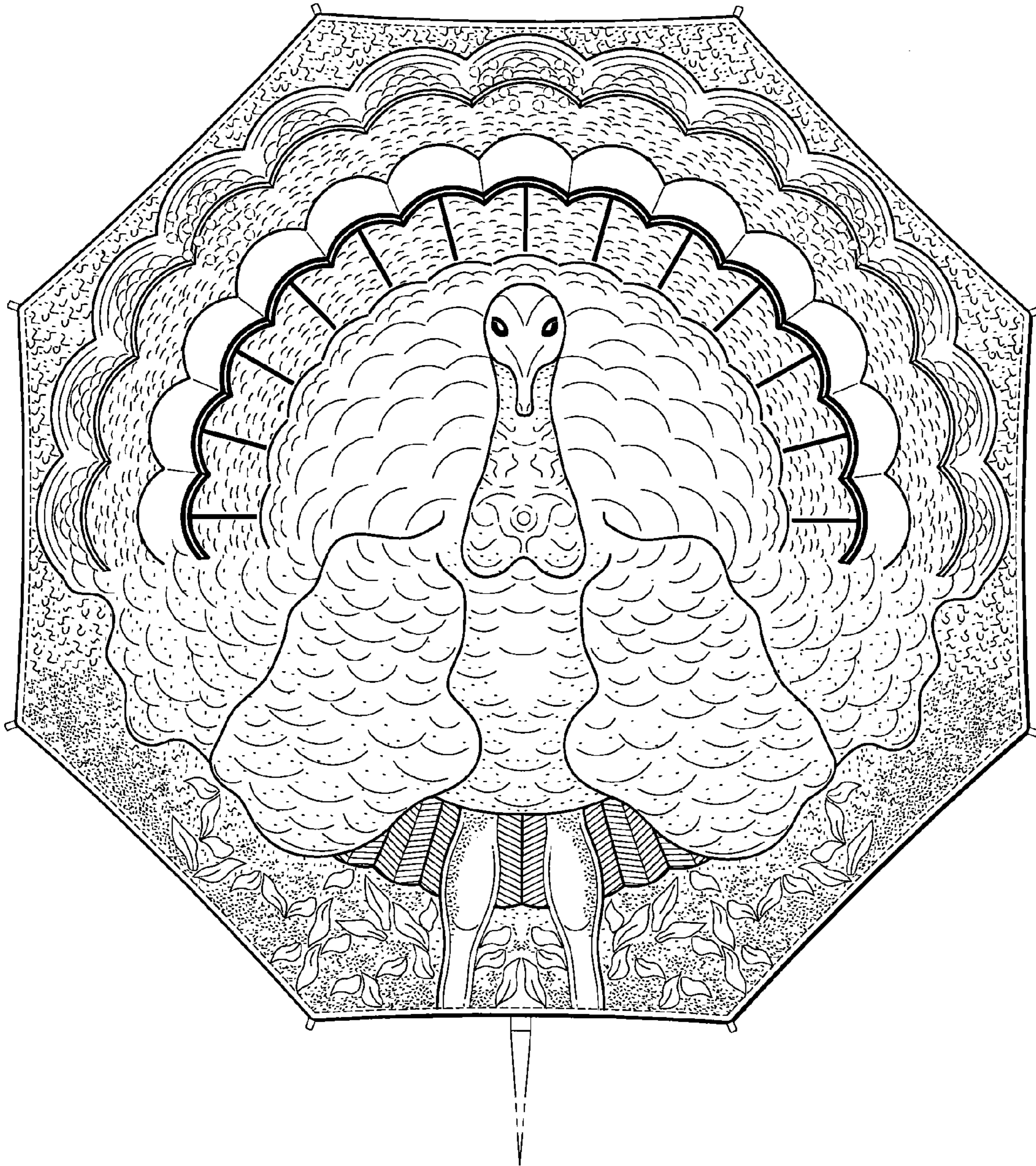
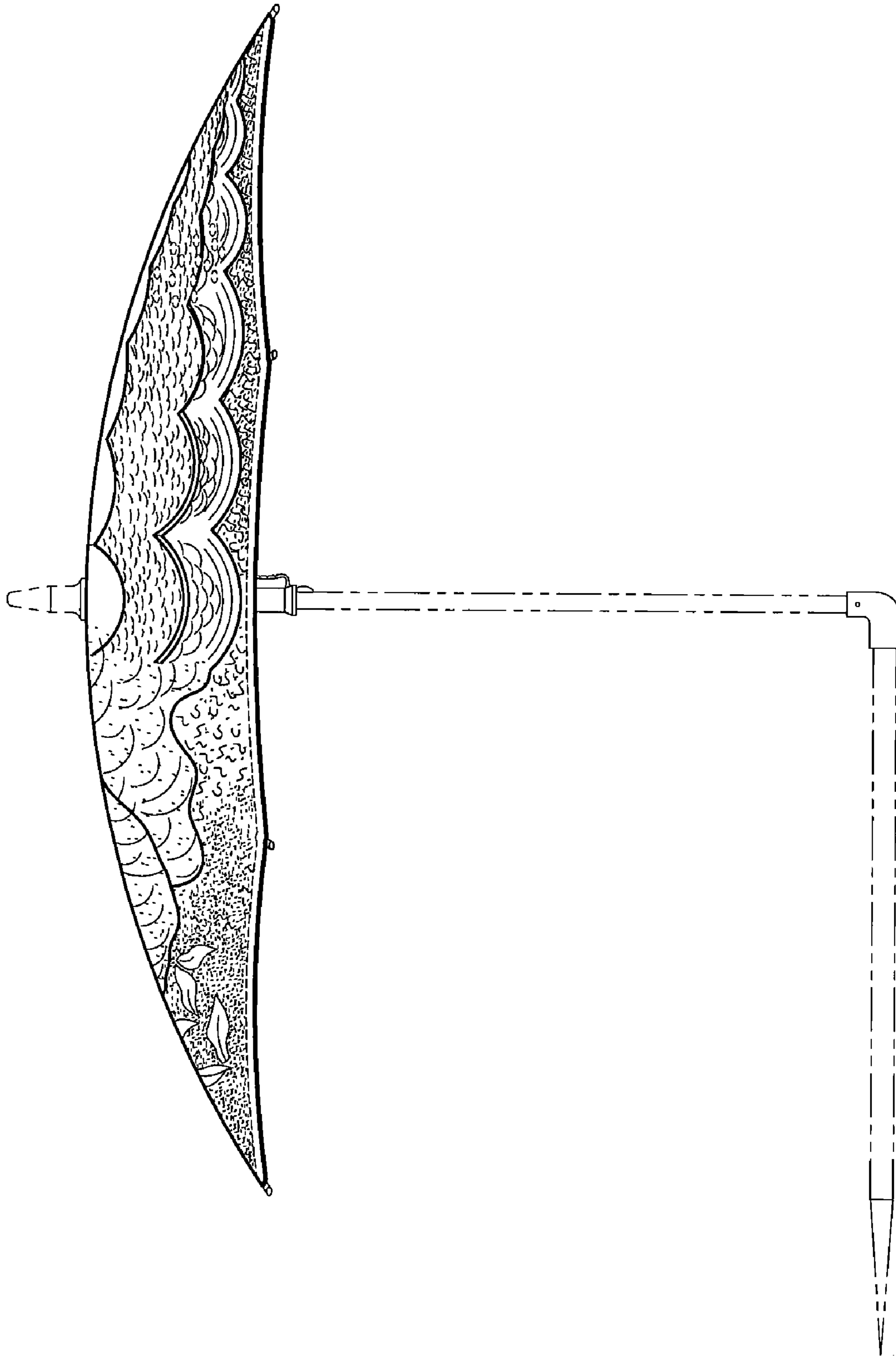

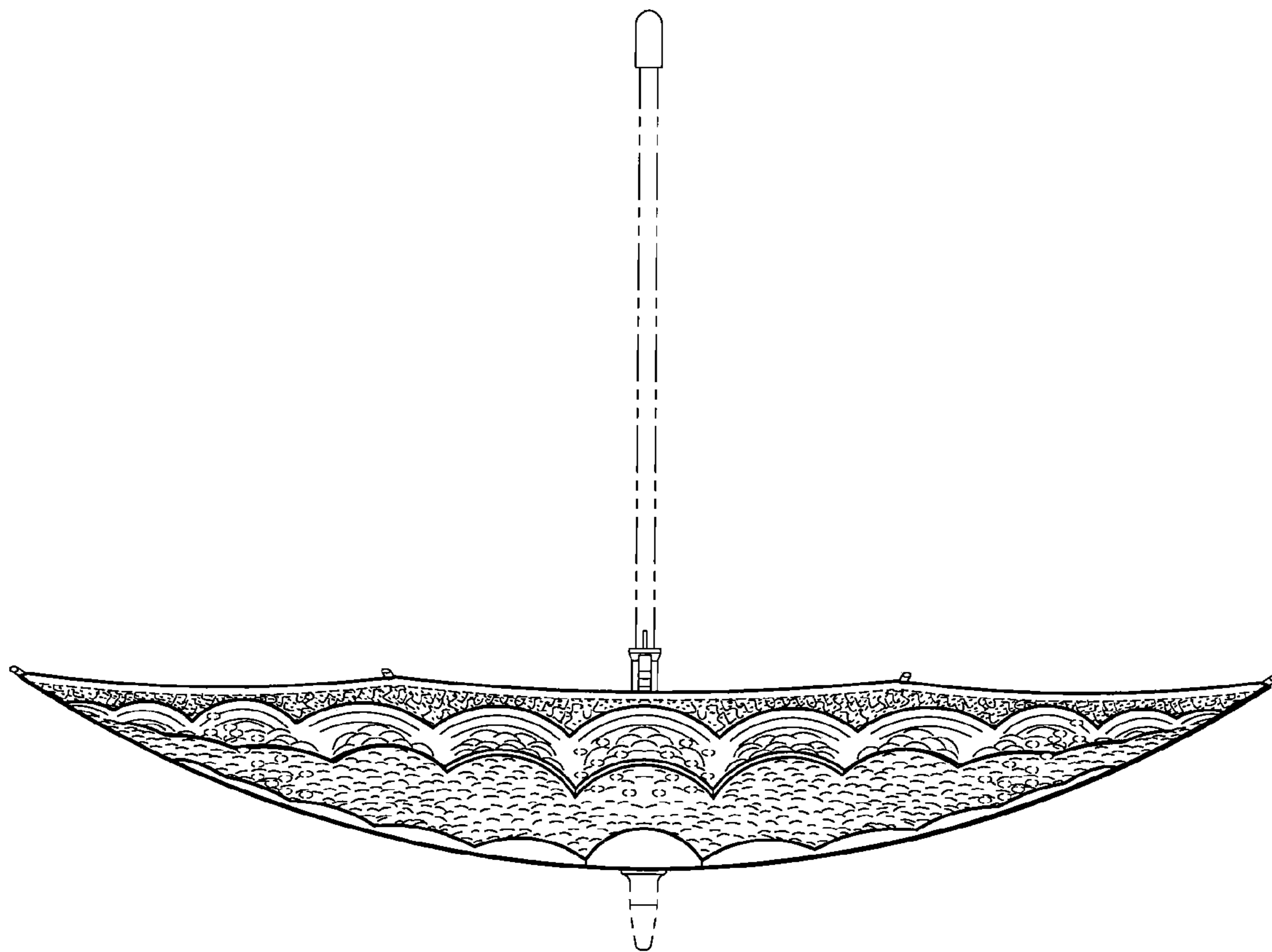
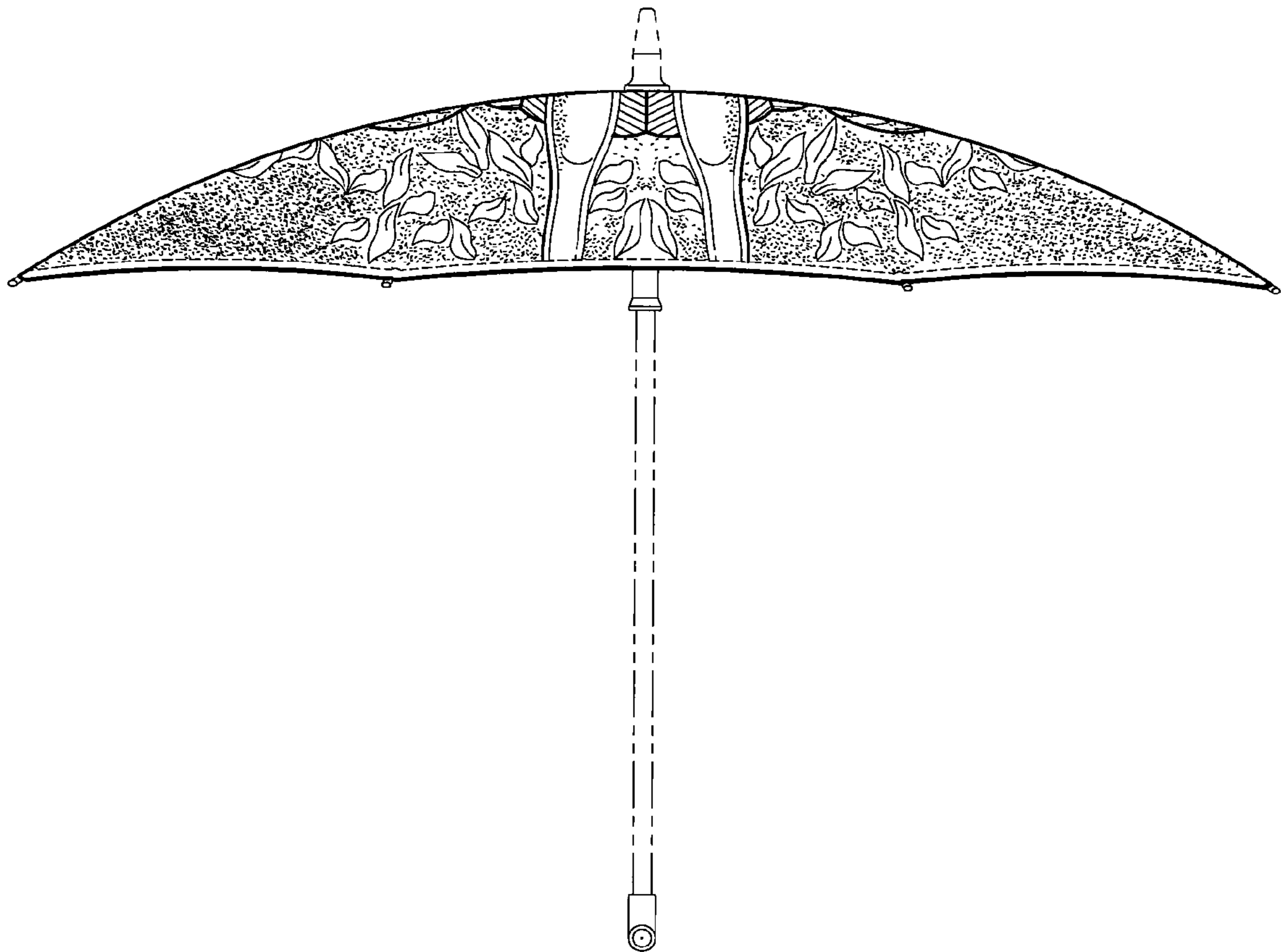

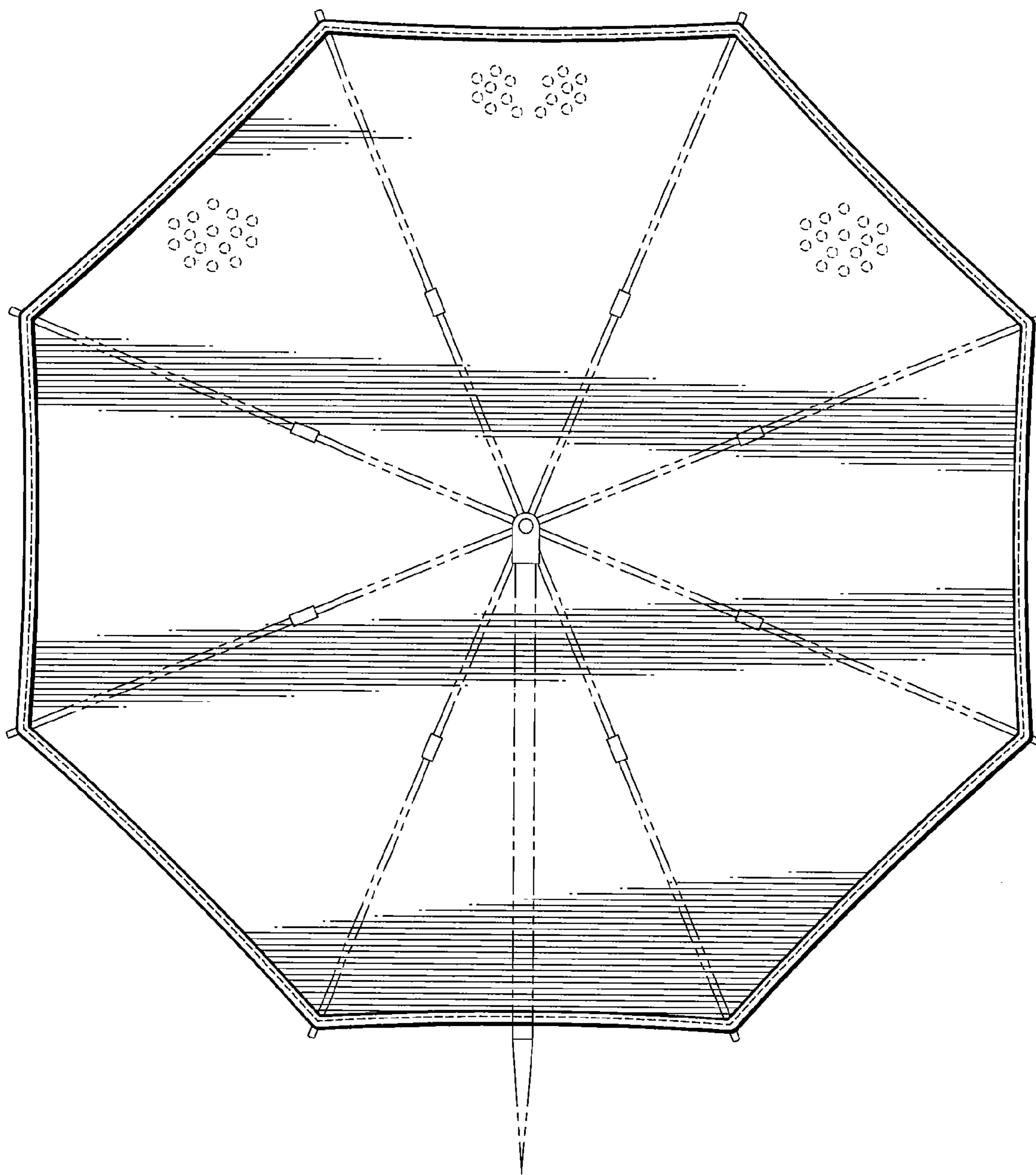
