(57) **CLAIM**

I claim the ornamental design for a combination roller bag and hand bag, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the roller bag of my new combination design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof, the right side being a mirror image;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof; and

FIG. 6 is a perspective view thereof.

FIG. 7 is a front elevational view of the expandable hand bag of my new combination design;

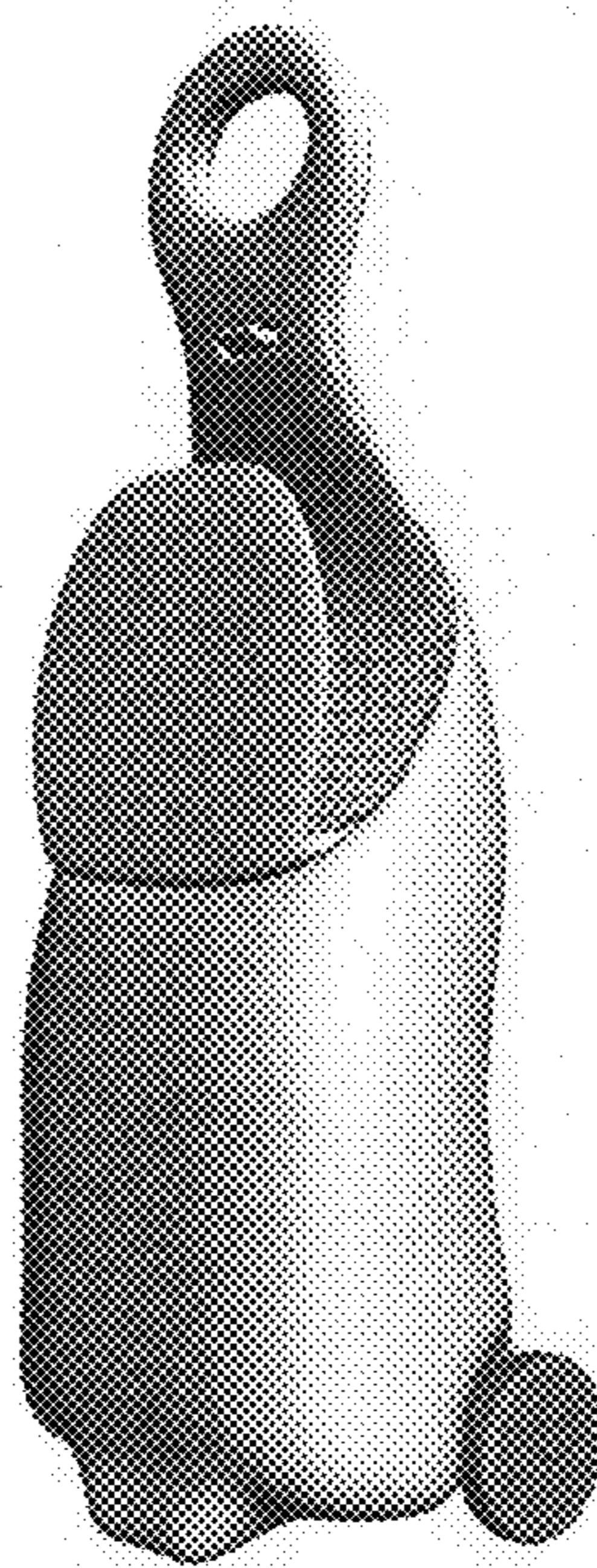
FIG. 8 is a rear elevational view thereof;

FIG. 9 is a left side elevational view thereof, the right side being a mirror image;

FIG. 10 is a left side elevational view of the hand bag mounted on the roller bag and thereby forming a cover for it; and,

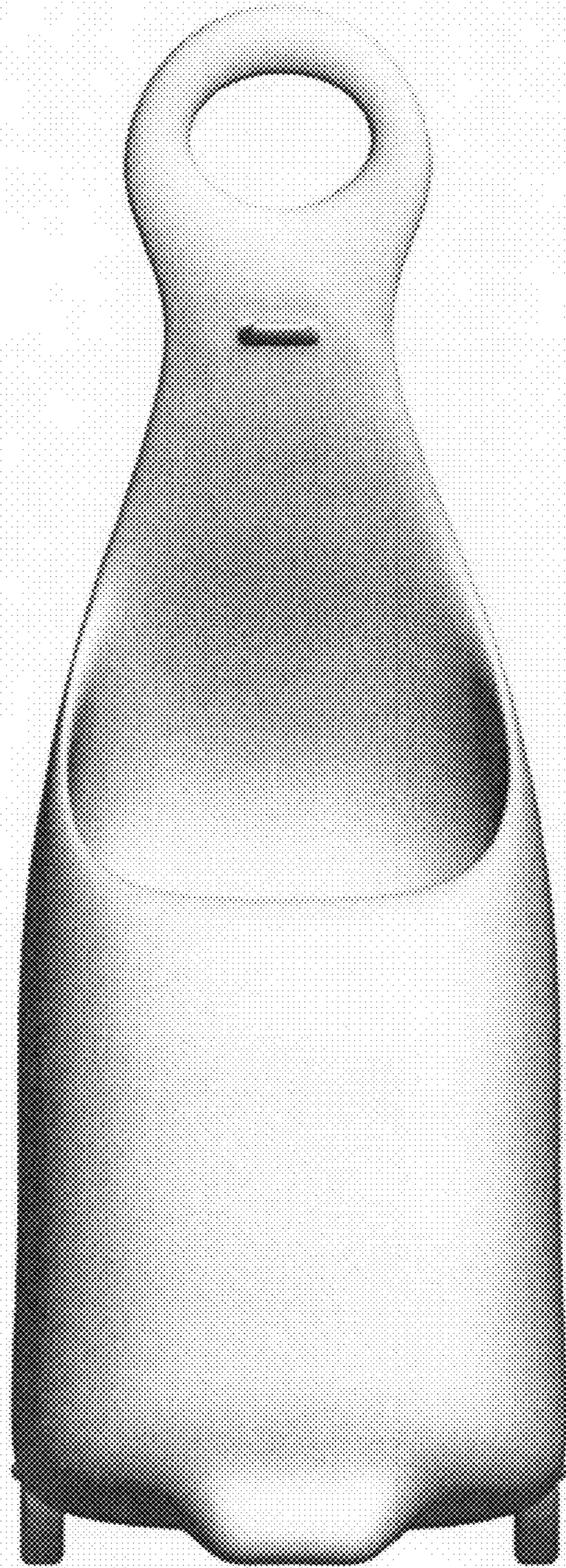

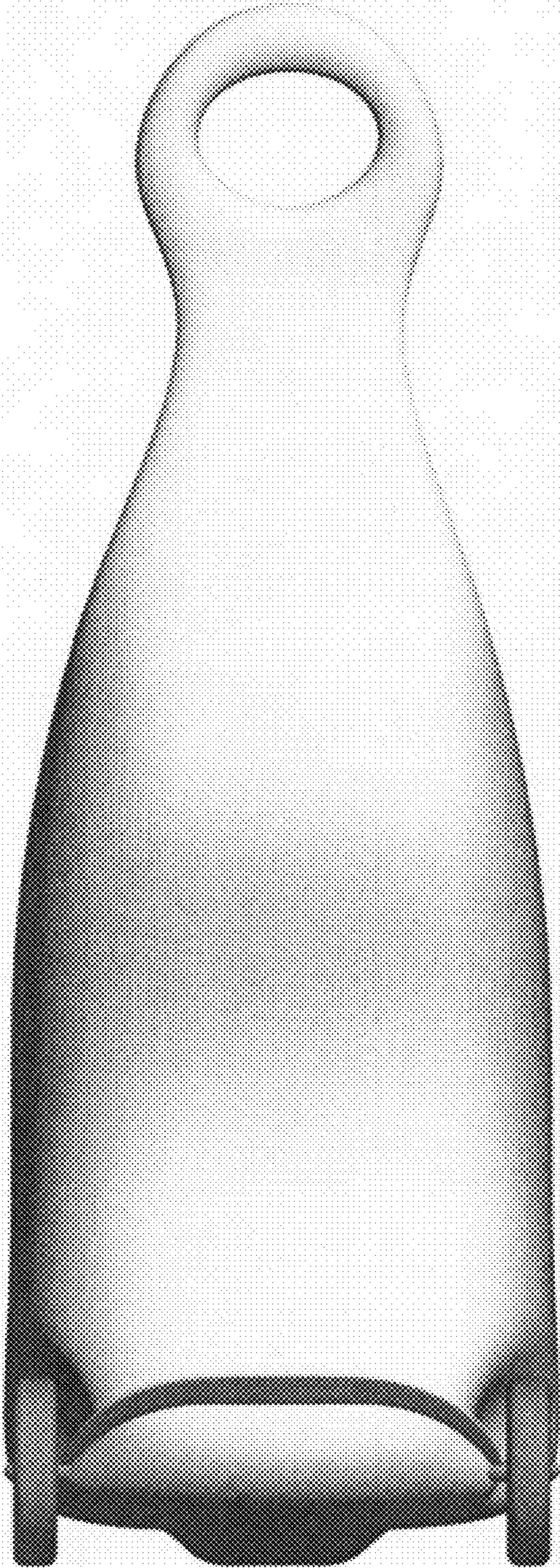

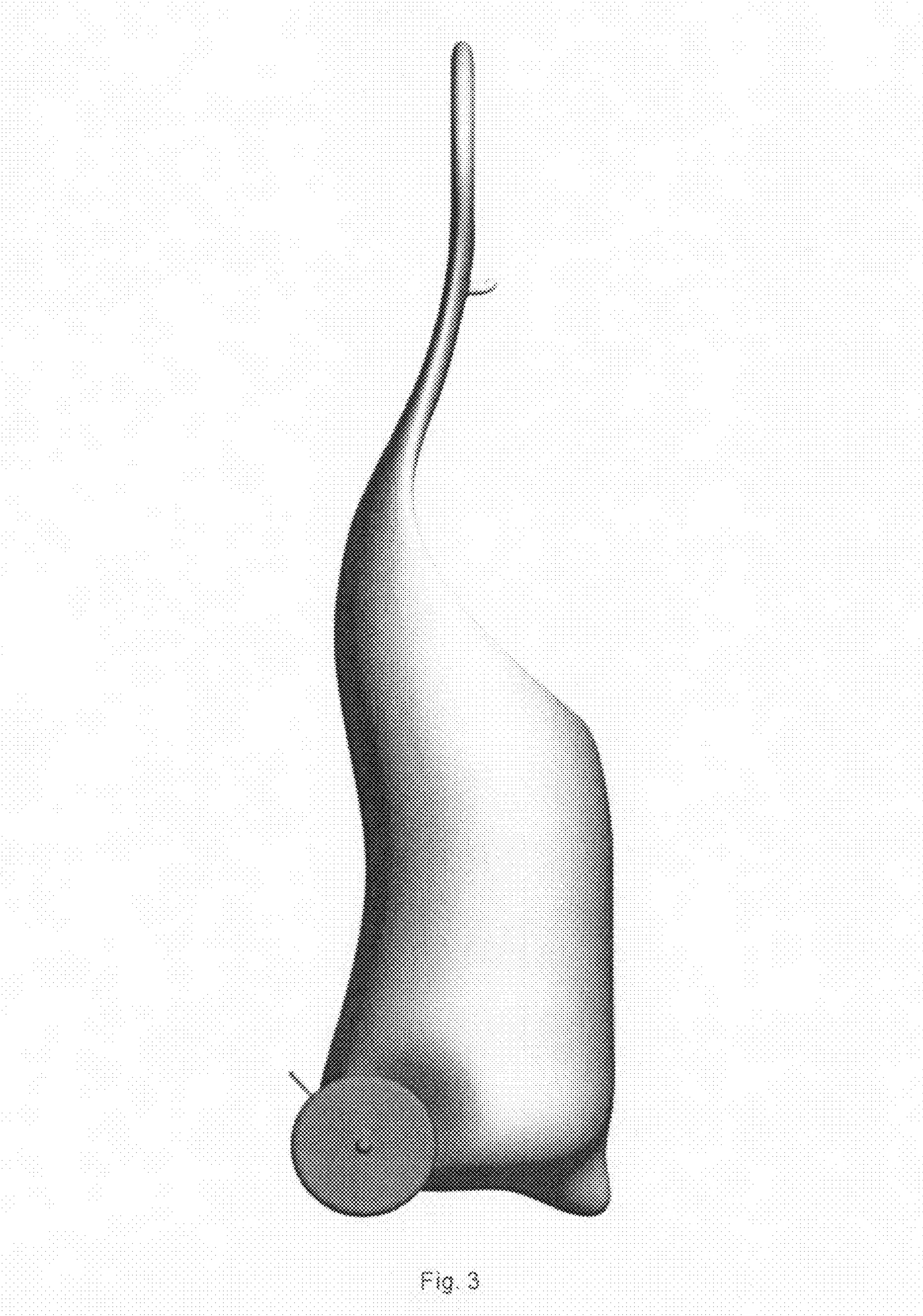

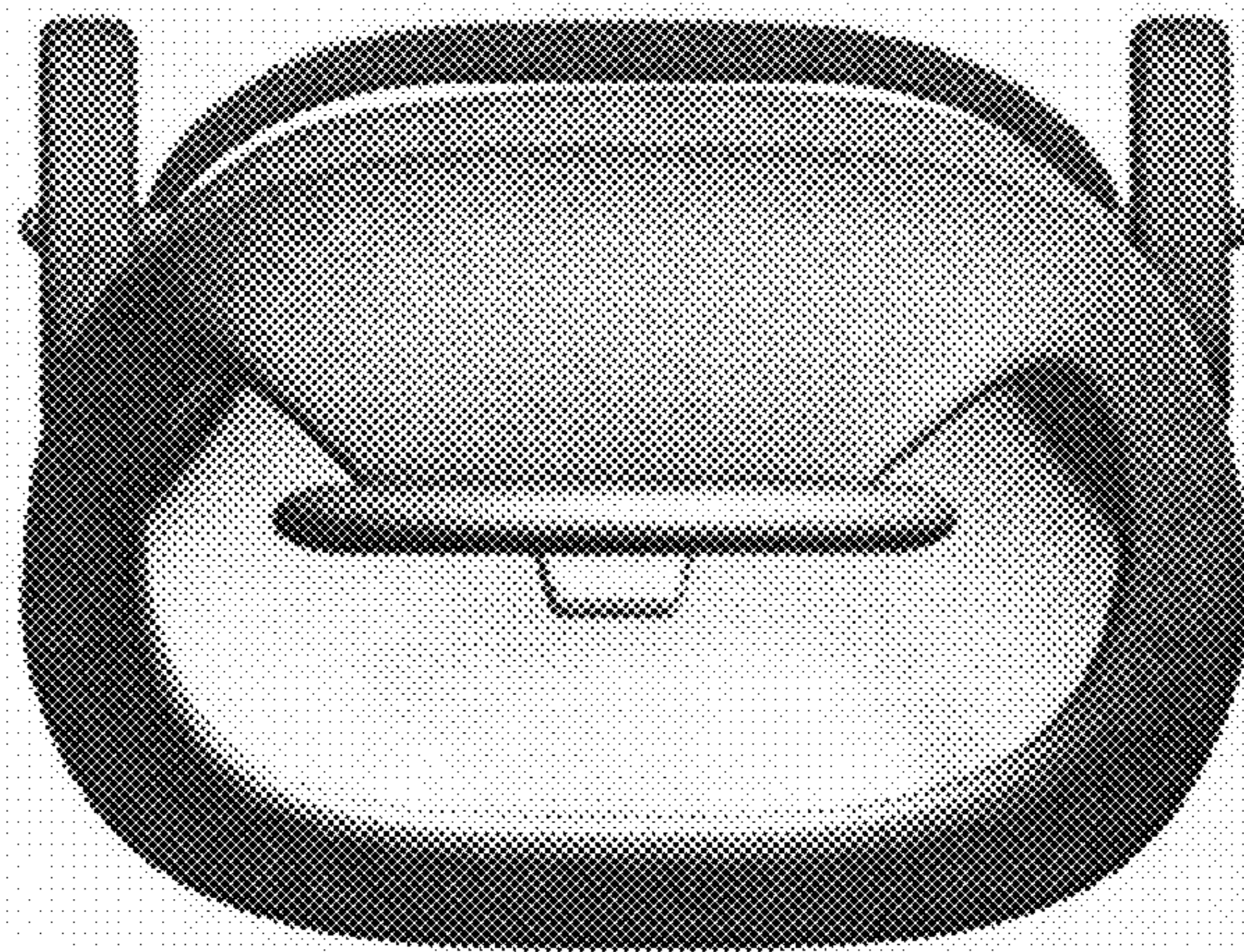

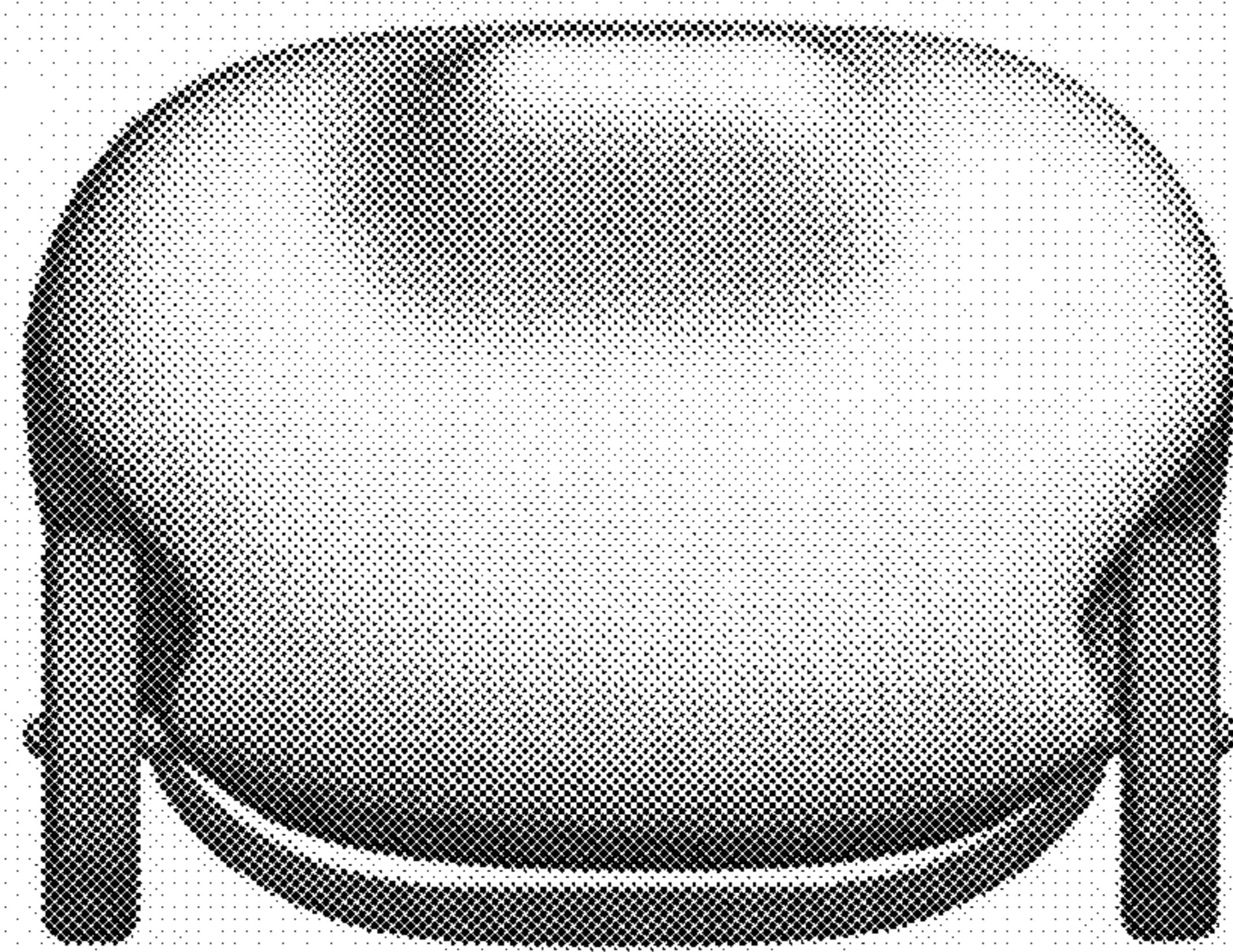

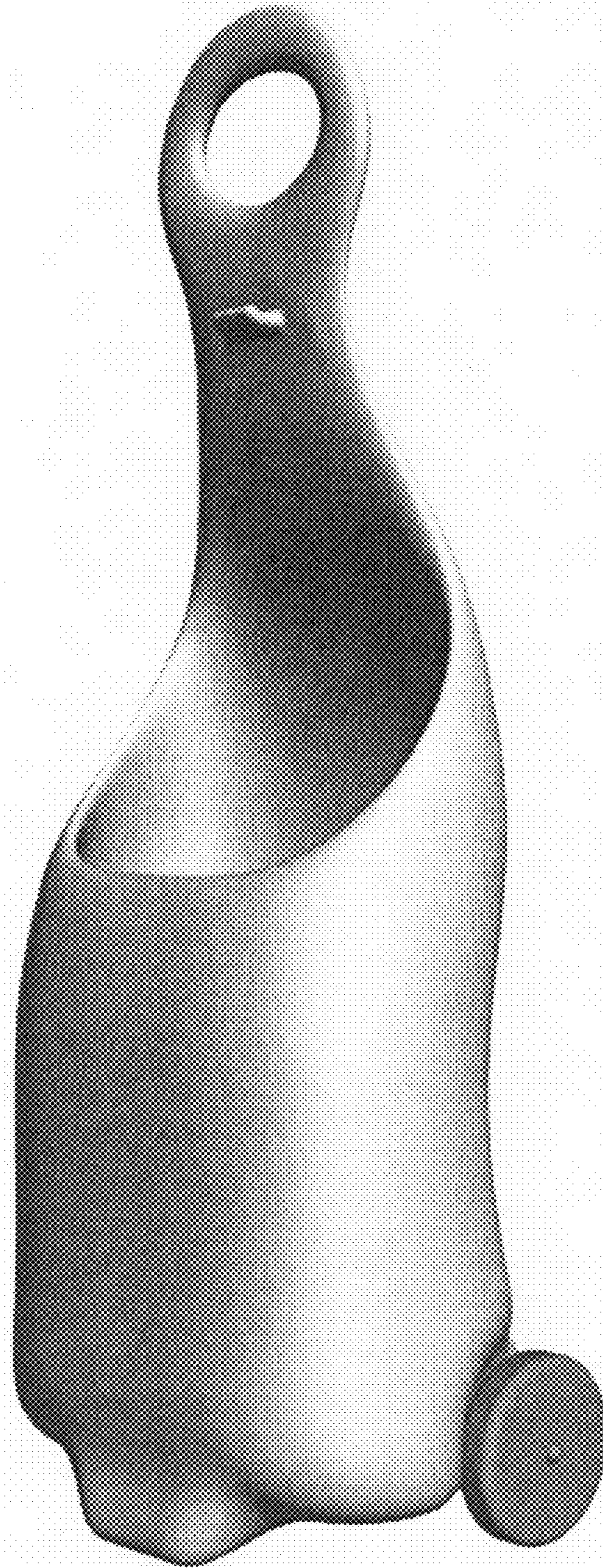

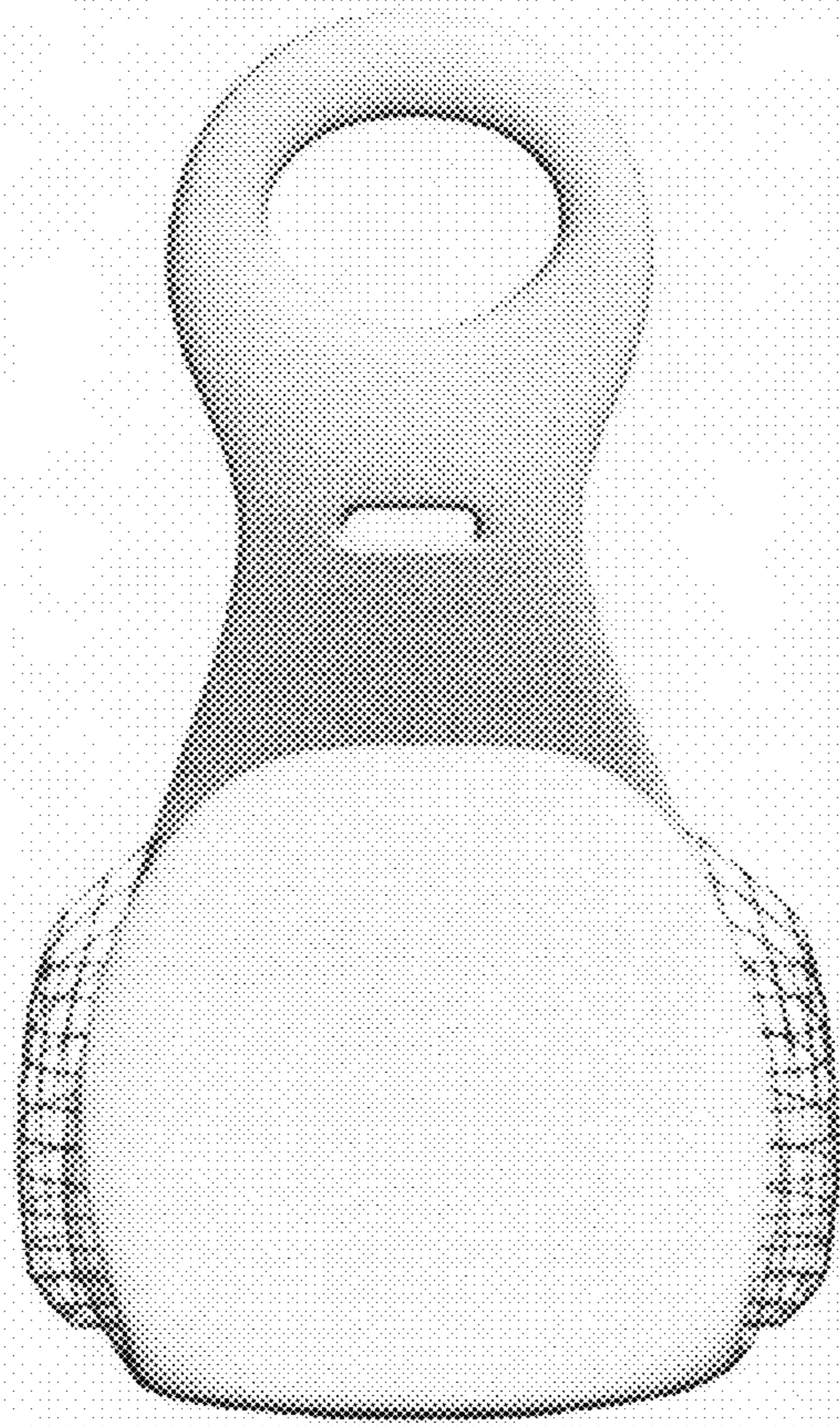

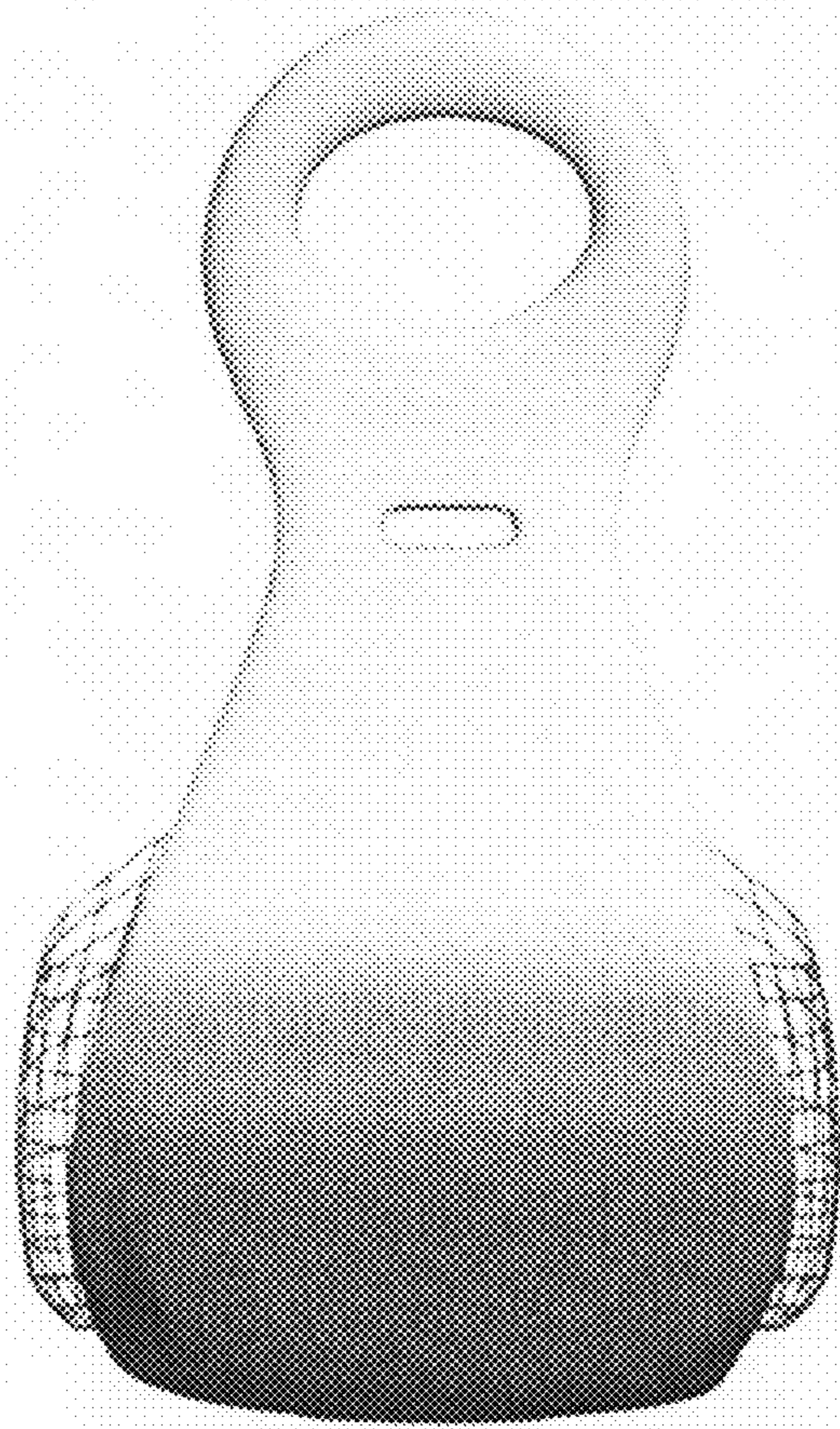

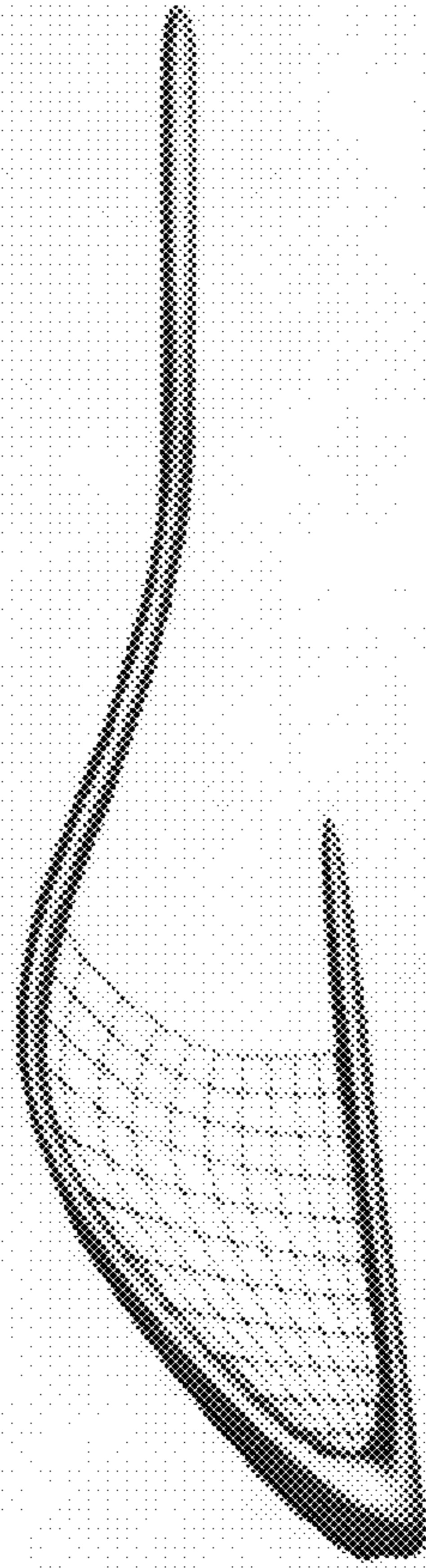

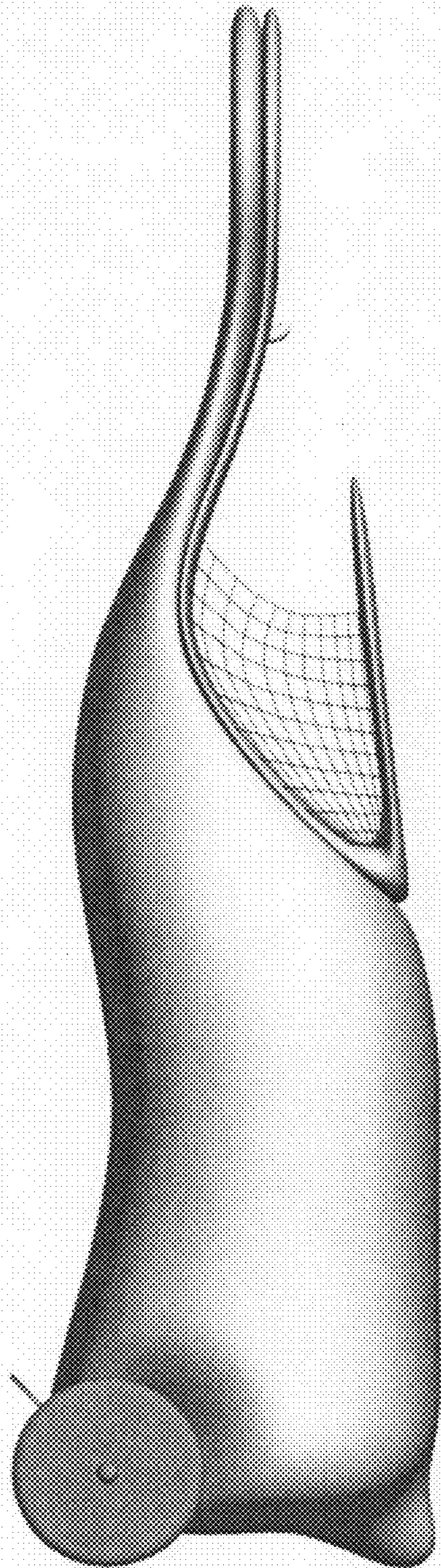

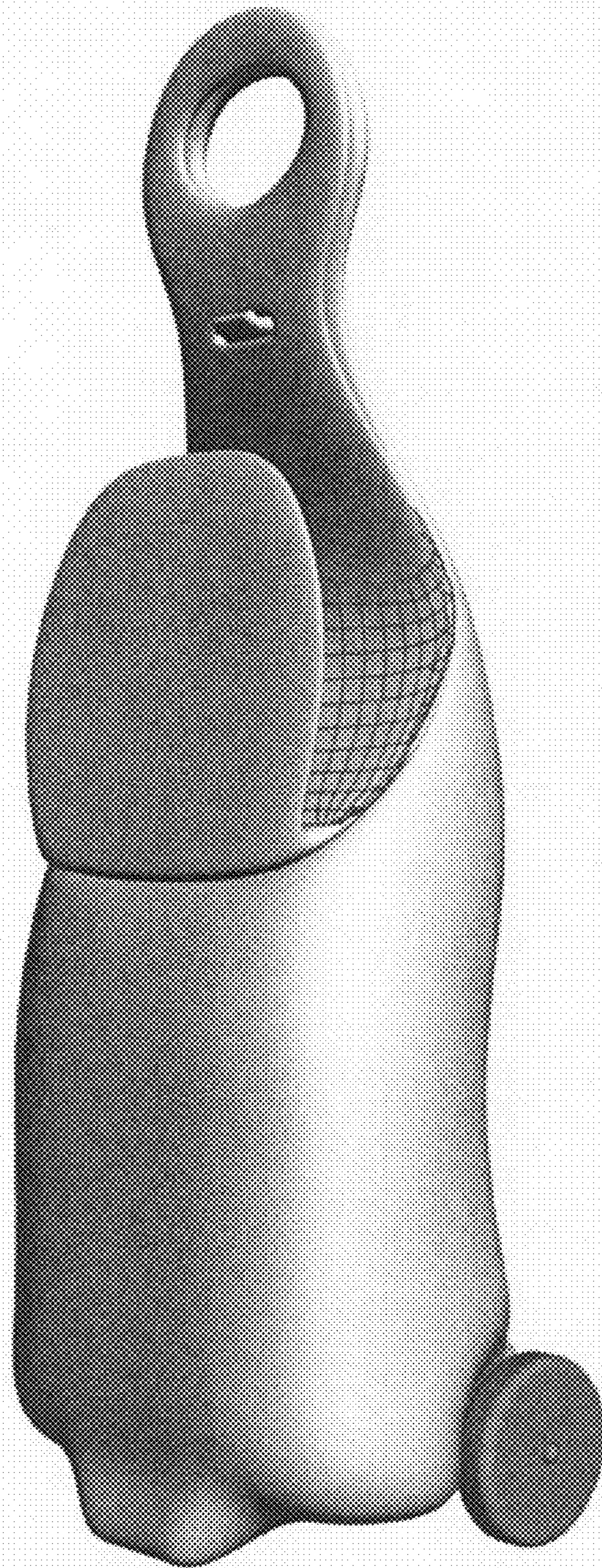
