FIG. 4 is a left elevation view thereof;

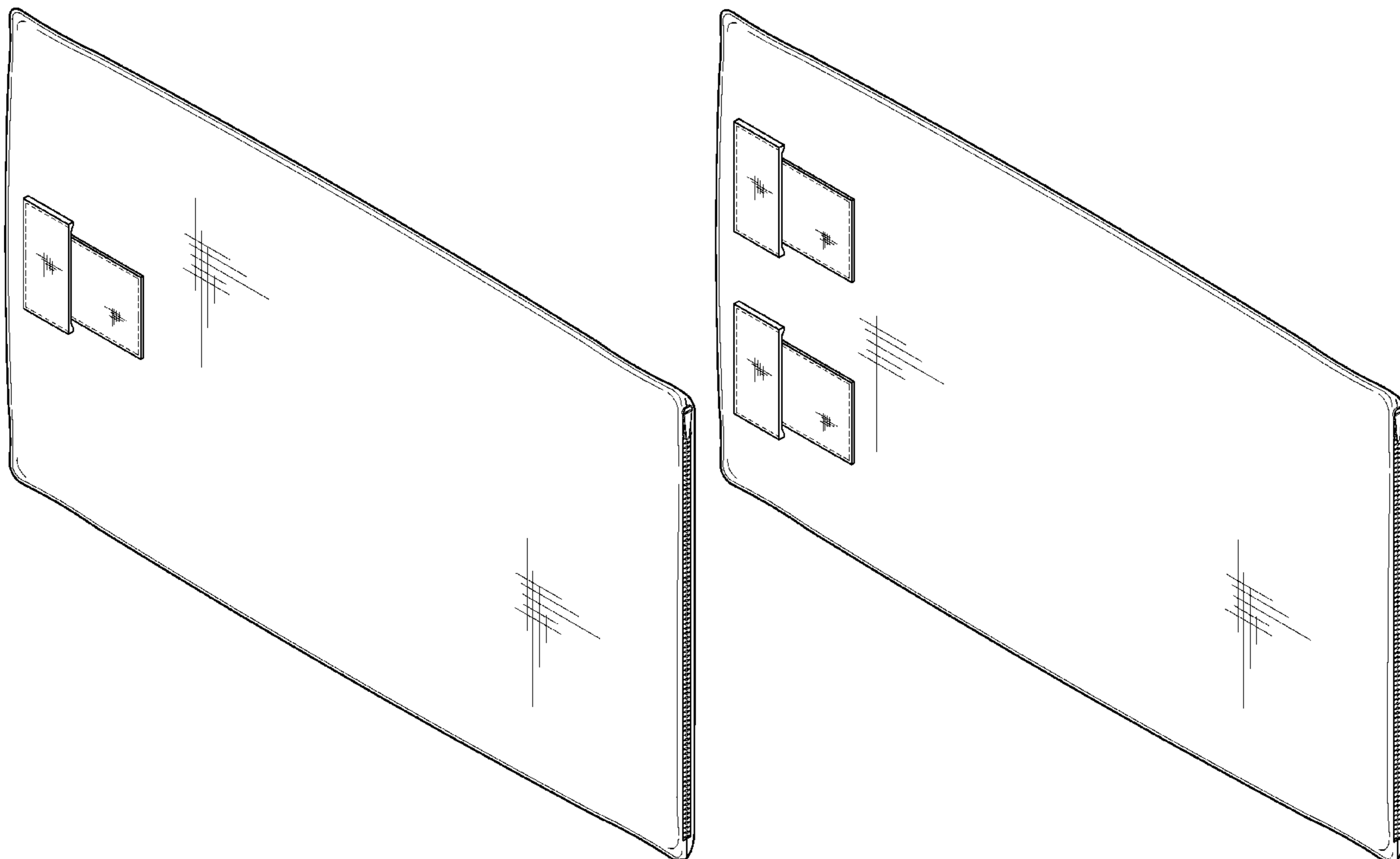
FIG. 5 is top plan view thereof;

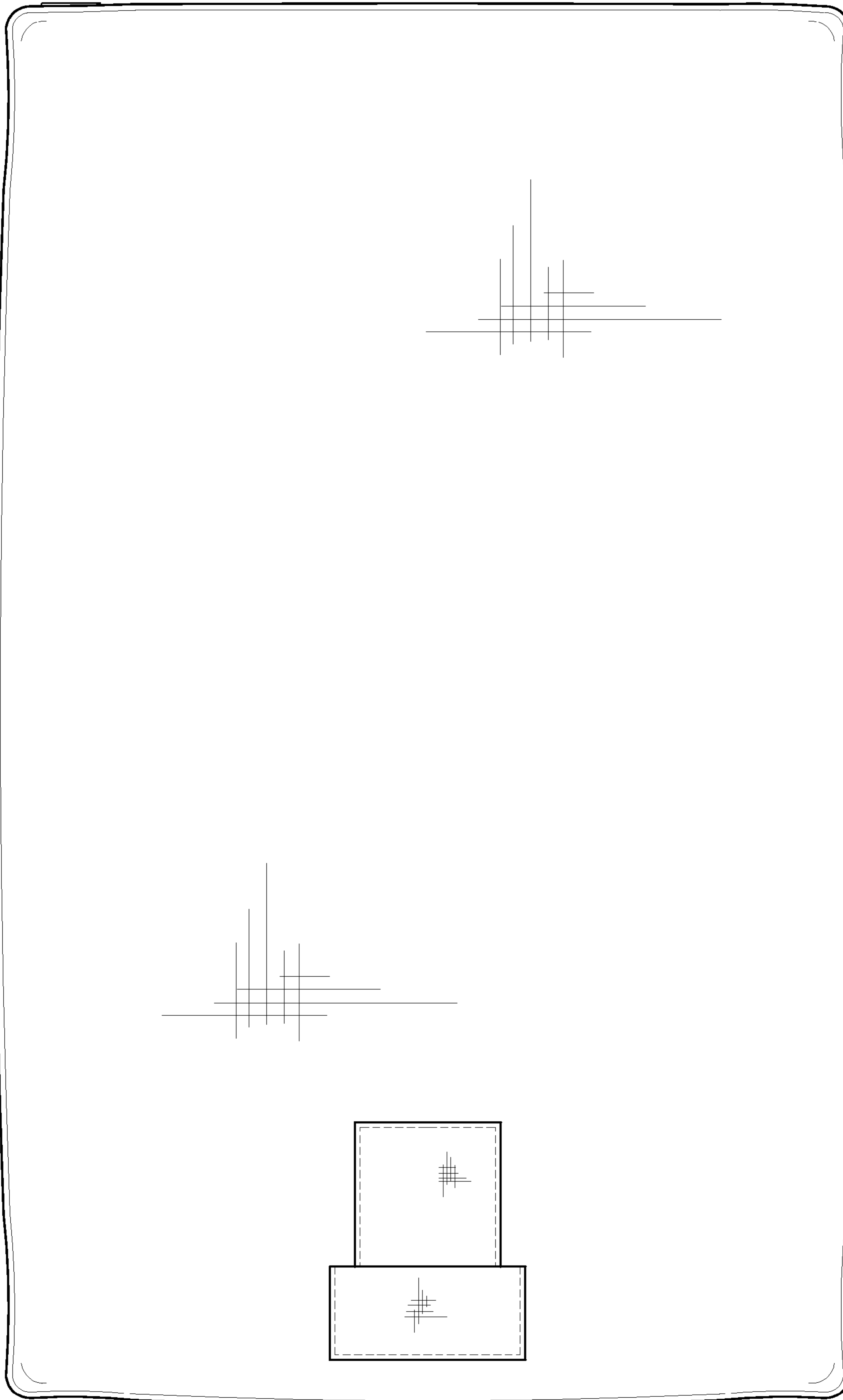

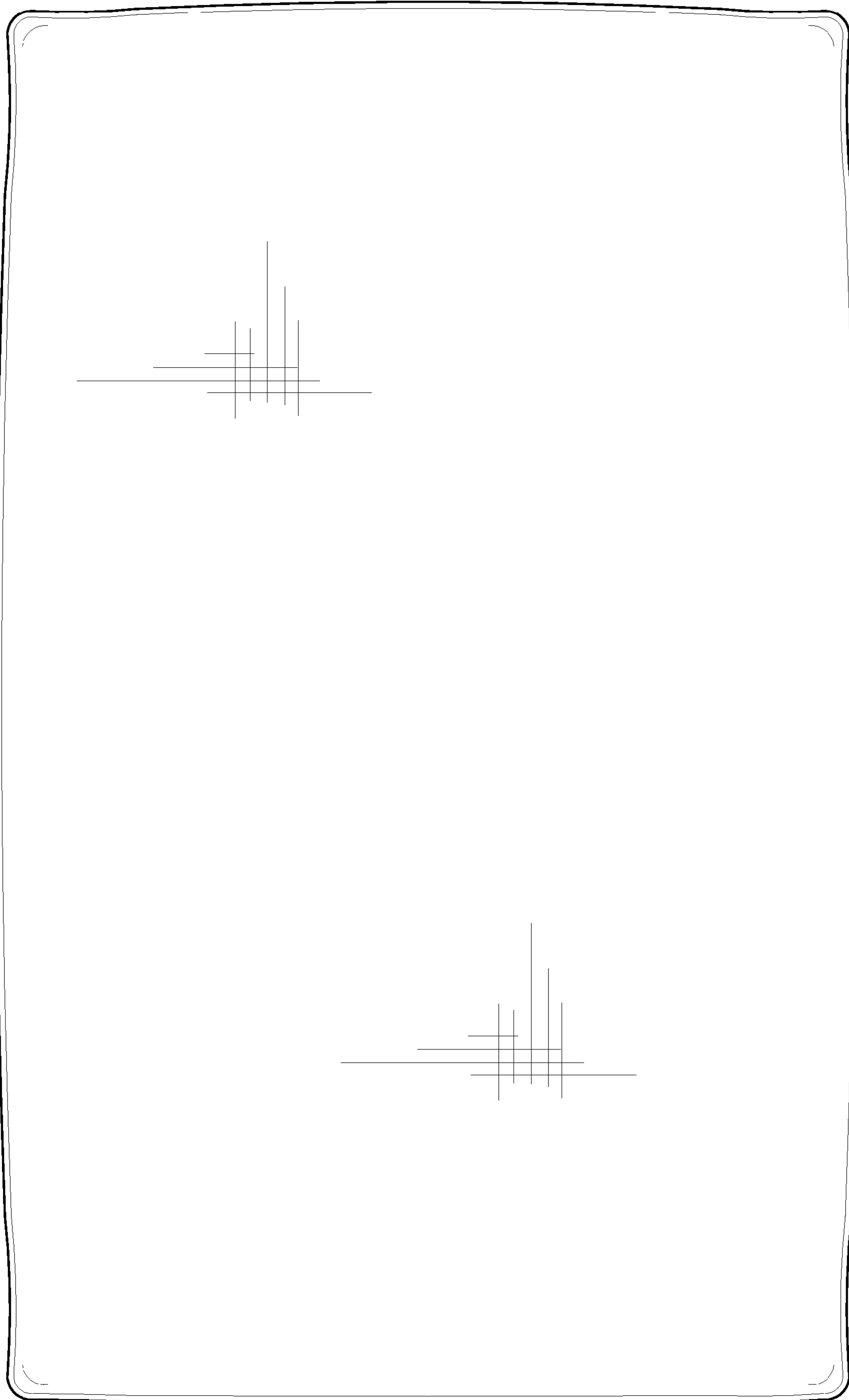

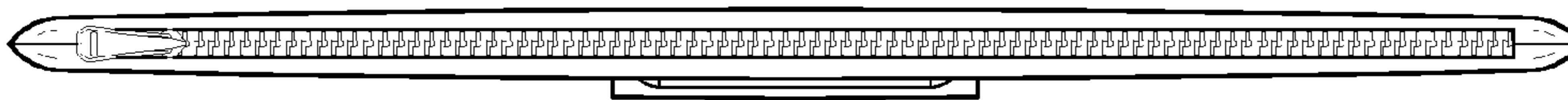

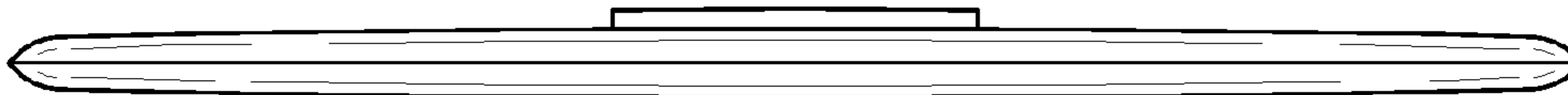

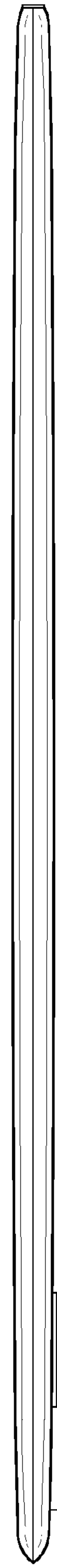

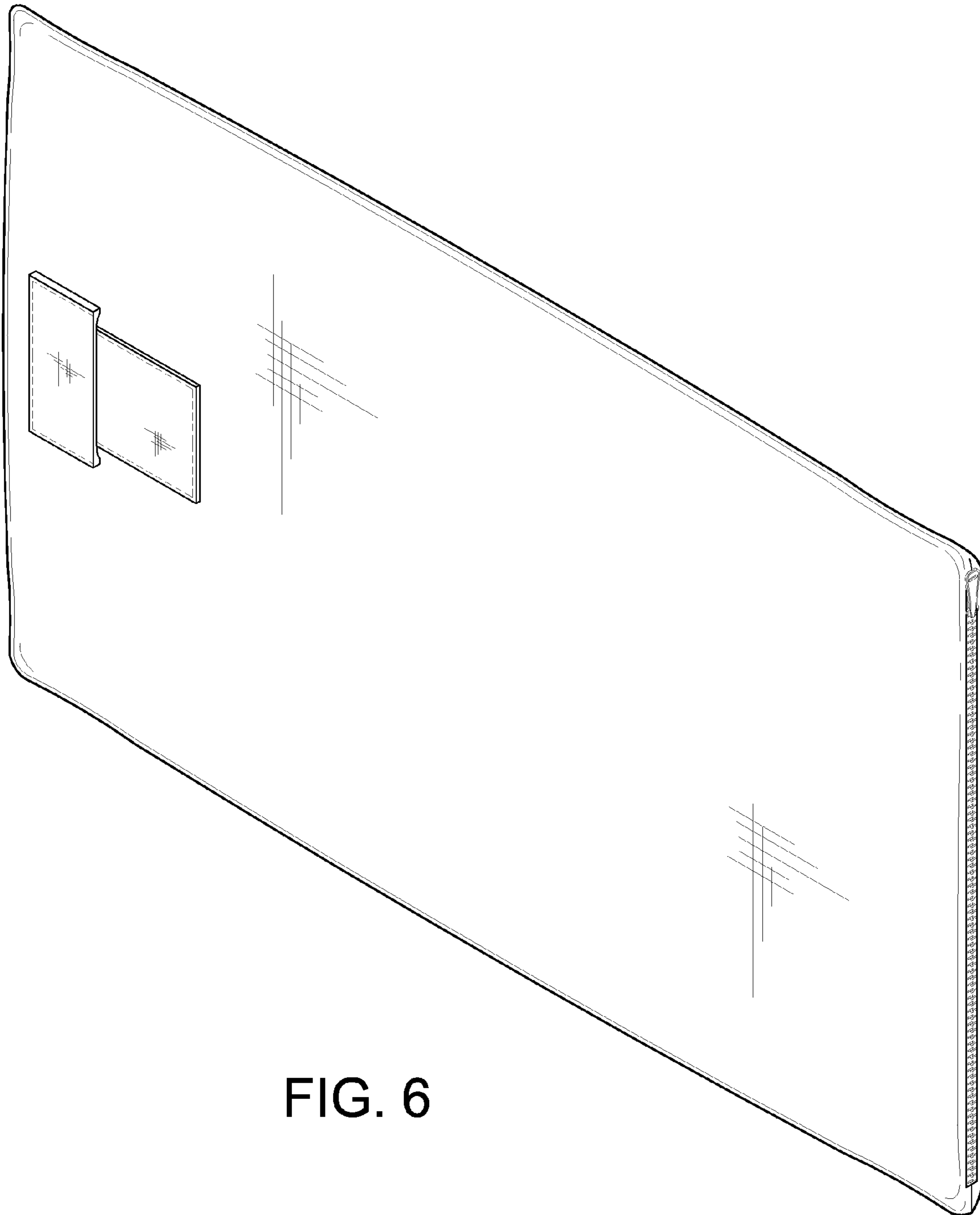

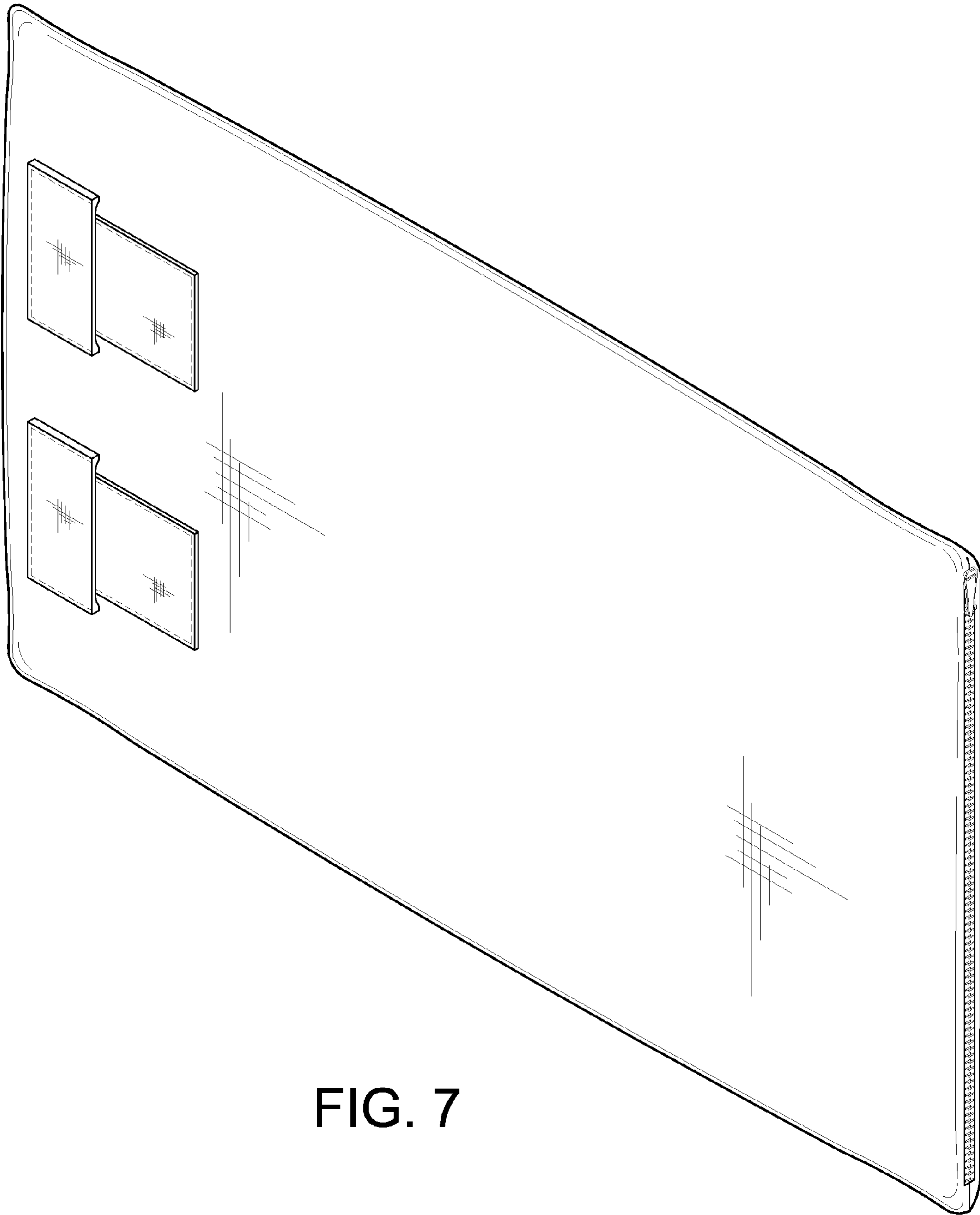
